Rain, Snowfall In Kashmir Likely From Today

Srinagar: The minimum temperature in most parts of the Kashmir Valley remained above the 2 degrees Celsius-mark for the second day on Tuesday due to the impact of a Western Disturbance, officials said.

The improvement in the temperature has brought relief to people in this region of Jammu and Kashmir, which otherwise was in the grip of intense cold. Thick fog was reported from several parts of the Valley.

The officials, however, said there is a possibility of light to moderate snowfall in the higher reaches over the next three days. The ski resort of Gulmarg in

north Kashmir was the only weather station in the Valley where the minimum settled below the freezing point at minus 0.2 degrees Celsius in the night, they said.

However, the temperature was a degree up from the previous night, the officials said.

Srinagar, the summer capital of Jammu and Kashmir, recorded a minimum of 3.9 degrees Celsius, while in Qazigund, the gateway town to the Valley in south Kashmir, it was 3.8 degrees Celsius.

Kokernag town registered a low of 2.8 degrees Celsius, according to the More on P10

Govt Avails 'Shakti' Power To Meet Electricity Demand

Srinagar: The electricity crisis in Jammu and Kashmir is likely to ease from next week as the Union Territory administration has reached out to the central government to procure an additional 500 MW power supply under Shakti policy.

Principal Secretary of Power Development Department (PDD) H Rajesh Prasad told Kashmir Observer that the process is in its final stage and will come into effect from the first week of December.

"In December we have the peak load and we are in the final stage of procuring the additional power supply from the central government under Shakti policy," Prasad said,

"The act on the part of the officer tantamount to a violation of Rule 3 of J&K Employees (Conduct) Rules, 1971," it said.



Jammu: The Jammu and Kashmir administration has suspended a land department official for violation of rules in connection with transfer of officials in the Union Territory.

"Pending enquiry into his conduct, Abdul Hafiz Shah, Regional Director, Survey and Land Records, Anantnag, is hereby placed under suspension, with immediate effect in terms of Rule 31 of Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956." Commissioner-Secretary, General Administration Department, Sanjeev Verma said in an order issued on Monday.

Shah during suspension will remain attached to the office of Divisional Commissioner in Kashmir, he said.

The order did not give any specifics on his acts which led to his suspension.

According to official sources, Shah was suspended on the di-rection of the Chief Secretary for violating rules in transfer of some officials.

WORLD CUP ROW **Students Booked Under Softer Provision Of UAPA: Police**

Srinagar: After it faced flak from a section of politicians, the Jammu and Kashmir Police on Tuesday defended booking under UAPA seven university students who had raised objectionable slogans after the Indian cricket team's in the World cup final, saying it had invoked a "softer provision" of the anti-terror law.

Several politicians, including the former J-K chief ministers Mehbooba Mufti and Omar Abdullah, have condemned the action by police, alleging that it will disaffect the youths with such an extreme punishment.

In a statement on Tuesday, police said that the boys have been booked under section 13 of Unlawful Activities Prevention Act. or UAPA, and added "in contrast to other provisions of the Act, it is a softer provision of the Act."

Section 13 of the UAPA deals with the inciting or advising of any unlawful activity and is punishable with seven years' jail.

The students have also been slapped with provisions of 505 and 506 which deal with public mischief and criminal intimidation of the Indian Penal Code, under which, if convicted, the jail term can go up to five years. Police said More on P10

Prehistoric Women Engaged In Hunting, Their Anatomy Suitable For It: US Researchers

rehistoric women not only engaged in the practice of hunting, but their anatomy and biology would have also made them intrinsically better suited for it, scientists have claimed.

Drawing their conclusions from both archaeological and physiological evidence, the researchers from US universities found that "hunting belonged to everyone, not just to males.'

They said that through their studies, published in the journal American Anthropologist, they were "trying to correct the history that erased women from it," instead of erasing or rewriting history.

Their archaeological findings regarding the women's injuries and the women being buried with their hunting weapons suggested that no "strict sexual division of labour existed," especially in prehistoric societies, where survival was an all-handson-deck activity.

"There weren't enough people living in groups to be specialised in different tasks. Everyone had to be a generalist to survive," said Cara Ocobock, an assistant professor in the Department of Anthropology at the University of Notre Dame.

The researchers found injuries in the women resulting from close-contact hunting, akin to what is attributed to Neanderthals' "up-close-andpersonal style of hunting," which meant that the hunters would often have to get up underneath their prey in order to kill them.

"As such, we find that both males and females have the same resulting injuries when we look at their fossil records," said Ocobock, adding, they found the patterns and rates of wear and tear equally in both women and men.

Further, in Peru, they found evidence of early female hunters of the Holocene period buried with hunting weapons.

"You don't often get buried with

something unless it was important to you or was something that you used frequently in your life," said Ocobock.

"Furthermore, we have no reason

to believe that prehistoric women abandoned their hunting while pregnant, breastfeeding or carrying children," she added.

The physiological findings told so long," Ocobock said.

They found that the female body was both metabolically and structurally advantageous in terms of endurance and effectiveness for prehistoric hunters.

Metabolically, the hormones estrogen and adiponectin, which are typically found in greater amounts in women than in men, enabled efficient burning of fat for energy and protecting the muscles from breaking down, they said.

The hormones helped the women to endure, "which would have been critical in early hunting because they would have had to run the animals down into exhaustion before actually going in for the kill," according to the researchers.

Structurally, the typical "wider hip structure of the female" enabled them to rotate their hips and lengthen their steps, eventually helping them get farther faster, Ocobock explained.

"When you look at human physiology this way, you can think of women as the marathon runners versus men as the powerlifters (or weightlifters)," she said.

All these revelations together find importance in the current political moment where sex and gender are in the spotlight, she said.

"And I want people to be able to change these ideas of female physical inferiority that have been around for





'DON'T BE SO NARROW MINDED'

SC Trashes Plea Seeking Ban on Pakistani Artistes in India

NEW DELHI: The Supreme Court on Tuesday dismissed a plea seeking a complete ban on artistes from Pakistan to perform or work in India, and asked the petitioner not to be "so narrow-minded".

A bench of justices Sanjiv Khanna and SVN Bhatti said it was not inclined to interfere with the Bombay High Court order which junked the plea filed by Faaiz Anwar Qureshi, who claims to be a cine worker and artiste.

'You should not press this appeal. Do not be so narrowminded," the bench said.

The top court also refused the submission to expunge certain remarks made by the high court against the petitioner.

The petition had sought the court's direction to the central government to impose a complete ban on Indian citizens, companies, firms and associations from employing or soliciting any work or performance, taking of any services, or entering into any association and so on with any Pakistani artiste, including its cine workers, singers, musicians, lyricists and technicians.

The Bombay High Court had dismissed the petition, saying the reliefs it seeks is a retrograde step in promoting cultural harmony, unity and peace,

and has no merit in it. 'One must understand that in order to be a patriot, one need not be inimical to those from abroad especially, from the neighbouring country," the court had said.

"A true patriot is a person who is selfless, who is devoted to the cause of his country, which he cannot be unless he is a person who is good at heart. A person who is good at heart would welcome in his country any activity which promotes peace, harmony, and tranquillity within the country and across the border," it had said. Arts, music, sports, culture, dance and so on are the activities which rise above nationalities, cultures and nations, and truly bring about peace, tranquillity, unity and harmony in nation and between nations, the high court had said in its order. It had noted that in the Cricket World Cup, Pakistan was a participant. This hap-

pened only because of appreciable positive steps taken by the Indian government in the interest of overall peace and harmony in consonance with Article 51 of the Constitution of India which is about promotion of international peace and security, the high court had said.

hildren played on a Gaza beach as displaced families left their cramped shelters for a short break during the truce between Israel and Hamas, but amid the laughter, their parents could not forget the hardships of war and homelessness. As children splashed in the

shallow water, jumping over small waves, adults in bare feet watched from the shore. Asmaa al-Sultan, a displaced woman from northern Gaza, sat on the sand with her arm around her mother. The older woman was crying quietly. More than 30 members of the al-Sultan family are shelter-

ing in a UN school in the town of Deir Al-Balah with hundreds of other displaced people. "We came to the beach to

take a breather, to escape from the feeling of the crowded schools and from the depressing and polluted environment we are in," said Asmaa.

"People come to the beach to relax, to swim, for their children to have fun, they take food with them. But we are so depressed. We are on the beach but we want to cry." Hundreds of thousands of

people have left their homes in northern Gaza, which has borne the brunt of Israel's military assault, to seek refuge in tents, schools or the homes of friends and relatives in the southern part of the strip.

The gruelling conditions in the tent camps and schools, with overcrowding, a dearth of toilets and showers, and long daily queues for small rations of food and water, have been compounded by the psychological impact of bombardment and displacement. The beach at Deir Al-Balah

has a row of fishermen's huts at the back, towards the bottom of a slope strewn with rubbish. Some displaced people had taken up residence in the flimsy huts, clothes hanging on strings outside.

Waleed al-Sultan, one of Asmaa's younger relatives, was trying to untangle a net near the huts as he prepared to go out fishing in a small boat, hoping the truce would mean he could do so without danger.

"I brought nothing with me when I was displaced, so I thought I would make a living from fishing, but the (Israeli) guards stopped me and started shooting at us," he said. The war began when Hamas

militants burst out of Gaza on October 7 and rampaged through southern Israel, killing 1,200 people, including babies and children, and seizing 240 hostages. Israel responded with an all-out assault on Gaza which has killed 14,800 Palestinians, four in ten of them children under 18, according to health officials in the Hamas-controlled territory.

While some displaced people have seized the opportunity to check on their homes, others have been too fearful to return to the north.

SC Orders Dignified Burial Of Manipur Violence Victims

NEW DELHI: The Supreme Court on Tuesday issued directions for ensuring burial or cremation of bodies lying in mortuaries in Manipur, where ethnic clashes had claimed several lives in May. A bench headed by Chief Jus-

tice D Y Chandrachud noted that a report filed by the apex court-appointed all-woman committee of former high court judges, headed by justice (retd) Gita Mittal, has indicated the position of the bodies that are lying in mortuaries in the northeastern state.

The bench, also comprising justices J B Pardiwala and Manoj Misra, said the report indicated that 169 of the 175 bodies have been identified while six have not

been identified. It noted that of the 169 identified bodies, 81 have been claimed by the next of kin while 88 have not been claimed.

The bench observed that the state government has identified nine sites where the burial or cremation can take place. "Bearing in mind the fact

that violence in the state of Manipur had taken place in May 2023, it would not be either appropriate or proper to keep the bodies which have not been identified or claimed indefinitely in the mortuaries," it said.

The apex court is seized of a batch of pleas, including those seeking court-monitored probe into cases of violence, besides measures for relief and rehabilitation.

During the hearing on Tuesday, the bench directed that last rites can be done by family members for identified and claimed bodies at any of the nine sites without any hinderance by any other parties.

It said state authorities will intimate the next of kin of the identified bodies, which have already been claimed, about the sites.

The bench said this exercise must be carried out on or before December

"As regard the bodies which have been identified but which have not been claimed, the state administration shall

issue a communication to the next of kin on or before Monday intimating the next of kin that they are permitted to carry out the last rites together with requisite religious observances within a period of one week thereafter at any of the identified nine burial/cremation sites," it said.

It said the collector and the superintendent of police (SP) would be at liberty to take all appropriate steps for maintenance of law and order so as to ensure that the burials or cremations take places in an orderly manner.

Marriage Does Not Eclipse Right to Privacy: Karnataka HC

BENGALURU: Marriage does not do away with the procedural rights of a person to divulge his personal information, a Division Bench of the High Court has said. Setting aside the order of a single judge, the Division Bench comprising Justice Sunil Dutt Yadav and Justice Vijaykumar A Patil, said the procedure under Section 33 of the Aadhaar Act has to be followed even if the person seeking information is the wife.

As per Section 33(1), the power of passing an order to divulge the information is conferred on a Court not inferior to that of a Judge of the High Court. But the HC noted that the single judge order had directed an authority lower than that to divulge the details The "learned Single Judge has grossly erred in directing the Assistant Director General, Central Public Information Officer (UID-AI) to issue notice to a person whose information sought to be divulged and to decide whether such information is to be divulged. It is a settled principle that, if the Act provides that a particular act is to be made in a particular manner, it should be done in such manner or not at all," the Division Bench said. The woman, from Hubballi in

KOTA: A 20-vear-old NEET aspirant from West Bengal was found hanging in his rented accommodation here but no suicide note has been recovered from his room, police said on Tuesday.

Faureed Hussain (20), a native of West Bengal's Birhum district, had been preparing for the medical entrance exam NEET at a coaching institute in Kota for around a year. He had been living in the rented accommodation in Wauf Nagar since July this year.

Some other students of coaching institutes also lived in the same house.

Hussain was last spotted in the afternoon hours of Monday. When he did not come out of his room till 8 pm, his friends called him but he did not open

the door. Following this, they informed the house owner, who called the police, Circle Inspector at Dadabari police station Rajesh Pathak said.

Police rushed to the spot and broke the door open to find the youth hanging, he said, adding, No suicide note was found in the room and the reason behind the extreme step is yet to be ascertained.'

Post-mortem will be done after his parents arrive, the police officer said.

This is the 25th case of suicide by a coaching student here this year. On September 18, a 16-year-old girl from Uttar Pradesh, preparing for NEET in Kota, ended her life by consuming a poisonous substance. It was the second suicide case that month. In August, six coaching students had committed suicide.

ing her accent whilst doing so. SA heard these comments and made a report to Tell MAMA," it said.

Harrison accepted that his behaviour was "unacceptable and inexcusable" and that it breached the standards of professional conduct.

Tuberculosis Cases On Decline In Kashmir

Region Aiming To Be TB-Free By 2025

SRINAGAR: In a significant development, Tuberculosis (TB) cases across the Kashmir region are on the decline due to concerted efforts by the health department, public awareness campaigns, and improved healthcare facilities, officials said.

Official data indicates a decreasing trend in TB cases across Kashmir, with the region aiming to be TB-free by 2025.

According to the data, in 2020, 2,841 cases were reported in the Kashmir division, with fewer screenings due to the COVID-19 pandemic. The numbers increased to 3,439 cases in 2021, followed by 3,396 in 2022, and 2,638 cases reported so far this year.

Officials said that the target for this year was to have cases below 3,500, and they are confident of achieving this goal.

They said the Anantnag and Pulwama districts were declared tuberculosis-free under the sub-national certification for TB elimination in India earlier this year, while Budgam received this designation in 2021.

Officials said that patients receive the utmost attention, with regular data updates and a team of watchdogs at the block, district, state, and federal levels. Screenings of patients' relatives are also being conducted.

Under the Nikshay Poshan Yojna, patients receive Rs 500 for the duration of their therapy, they said, adding that the decline in cases is attributed to targeted prevention campaigns and enhanced diagnostic capabilities. They also stressed the need for continued vigilance to sustain and build upon these gains.

Officials further said that robust surveillance along with public awareness campaigns will continue to make Kashmir TB-free by 2025.

The government in Kashmir has introduced an AI-based system to identify potential TB cases, and testing has been increased to detect cases in the initial stages.


There are four categories of recognition for achieving reduction targets, with the top spot being TB-free status, indicating an



"Budgam, Anantnag, and Pulwama fall into the TB-free category, with Baramulla categorised as bronze, Kupwara as gold, and Srinagar already awarded gold. Overall, three districts in Kashmir are free of TB, with two receiving gold awards and one a bronze award," the officials said.

They said that claims of TB state units are being verified by four national agencies on the ground. Four national agencies assess TB status and provide certification based on perfor80% reduction. Other categories include gold medal (over 60% reduction), silver medal (over 40% reduction), and bronze medal (over 20% reduction).

Budgam was the first district to be declared TB-free. Sub-national certification, initiated in 2020, marks progress towards TB-free status, with the goal of achieving a TB-free India by 2025. The process rewards well-performing states/ districts when specific milestones in TB elimination are achieved—(KNO)

Baramulla Woman Dies After Delivering Baby, Family Alleges Murder

SRINAGAR: A woman died after giving birth at District Hospital Baramulla in north Kashmir, with her family alleging medical negligence. However, the Medical Superintendent has assured a thorough investigation, saying that those responsible will not be spared.

The family of the deceased woman, Dilshada Akhter (32), a resident of Khadniyar, said that she passed away after delivering a baby. They claim that despite repeated requests, doctors at the district hospital ignored Dilshada's condition after she gave birth at 10:30 am on Monday.

Alleging that she was not properly cared for, the family said that Dilshada fought for her life from 10:30 am until 1

o'clock midnight. They alleged that the hospital staff remained engrossed in their cell phones instead of attending to her. "It was a murder," alleged the

deceased woman's sister, who witnessed the entire distressing incident. She urged authorities to investigate the matter to prevent further loss of lives. Expressing shock, she called on

the authorities to address negligence issues and "prioritise the welfare of society". Many people fear visiting government hospitals due to perceived safety concerns, she said. The Medical Superintendent of GMC Baramulla, Dr Parvaiz Masoodi said that a thorough investigation would be conducted. "If anyone is found responsible for any wrongdoing, they will face strict legal consequences," he assured—(KNO)

Bridging Power Shortage

The stark reality of reduced electricity availability during winter months, primarily due to lower hydroelectric output, has perennially been a bane of the Valley. The belated move, however, comes as a proactive step to address the imminent power scarcity.

The Union Territory's heavy reliance on hydropower makes it vulnerable to seasonal variations in water discharge, consequently affecting electricity generation. This impacts the lives of residents, with power shortages causing disruptions across domestic, commercial, and industrial sectors.

The approval of a fresh Power Purchase Agreement (PPA) between J&K Power Corporation Limited and the NTPC is an initiative to bridge the gap between demand and supply. Singrauli-III power station's inclusion in this agreement, being a thermal power station, proves critical in meeting the escalated winter demand when hydro-generated power undergoes a significant decline.

The decision is timely, considering the compounding annual growth rate of energy demand in Jammu and Kashmir, pegged at 10 percent. This underlines the pressing need for augmenting the existing power supply infrastructure to sustain the region's development and livelihoods.

While this move is commendable, it's equally crucial to address underlying issues contributing to power scarcity. The Kashmir Power Distribution Corporation Limited (KPDC) blames power pilferage, defaulting consumers, and damaged infrastructure for being a factor in the existing state of power situation. According to the corporation, the pilferage primarily results in outages and damage to transformers, thus causing hardships to genuine consumers. The consequent crackdown launched by the corporation has fetched it around Rs 30 crore in just four days. And this massive amount may not have been recovered only from the power pilferers. This goes on to prove that people have been paying for the electricity consumed by them. But despite that they don't get adequate electricity. Even with this responsible payment behavior, the Valley faces a persistent struggle with power shortages, especially during the winter when hydroelectric output diminishes substantially. While power pilfering has certainly been a fact of life in J&K, as elsewhere in the country, it is something that generally doesn't happen without the connivance of the KPDC staff. So, the corporation needs to look within also.

That said, the decision to secure additional power from the Centre is a timely intervention, acknowledging the region's vulnerability during this crucial period. Here's hoping that the power situation only improves from hereon.

Garbage is Choking Wullar Around Bandipora

Even after Supreme Court's intervention ULB has failed to set up scientific waste management plant


t has been more than a year now since a matter related to unscientific waste disposal into Wullar lake by Municipal Council Bandipora was taken up in Supreme Court and a two-member bench of Justices Ajay Rastogi and C T Ravikumar castigated the municipal council for playing with the lives of people. As a stakeholder in this case, I was of the firm belief that within some months the Directorate of Urban Local Bodies Kashmir would set up scientific waste management plant in the Bandipora town to address this menace but even after one year, we see Wullar being choked around the Bandipora town as untreated solid and liquid waste continues to be dumped on the banks of this lake which is a Ramsar site of international repute.

On October 19th 2022, the SC double-bench dismissed an appeal filed by Chief Executive Officer (CEO) of the Municipal Council Bandipora against the imposition of environmental compensation of Rs 64.21 lakh for unscientific dumping and disposal of solid waste. The compensation was earlier imposed by the J&K Pollution Control Board (now known as JK Pollution Control Committee) on February 9th 2021. The Municipal Council Bandipora had moved an appeal before the National Green Tribunal (NGT) against the said order. They sought exemption from paying the fine but the Tribunal on 21.10. 2021 dismissed the appeal and directed the municipal body to pay the penalty money. After this, the Municipal Council Bandipora went to Supreme Court of India but the apex court dismissed the appeal outrightly. The compensation money was paid as per sources but the unscientific waste continues to be dumped near the Wullar and other places of Bandipora town.

Bandipora which was supposed to enforce the MSW Rules 2016 on ground.

In addition to the municipal waste dumping in Wullar lake around Bandipora, I also raised the issue related to waste dumping and illegal encroachment of Hokersar and Kreechu Chanhara wetlands as well before the NGT in the same petition.

On August 27th 2020, the NGTs Principal Bench issued a detailed order asking the National Wetlands Committee to compile data of status of compliance of environmental norms in respect of all significant wetlands in the country to ensure remedial action. The Divisional Commissioner Kashmir was asked to ensure scientific solid waste management near wetlands and utilization of SBM Gramin funds for the same which was in-fact my suggestion to the NGT.



Municipal Council Bandipora went to NGT to challenge the PCB's order. The NGT's fourmember Principal Bench headed by Justice A K Goel on October 21st 2021 dismissed the appeal with the following observations:

"In view of the above, no interference is called for with the above order. However, the amount recovered may be utilized for restoration of the environment by preparing an action plan with timelines by a joint Committee comprising State PCB and District Magistrate, Bandipora. The plan may be prepared within two months and executed within the stipulated timeline. The plan may take into account plans already prepared for protecting the water bodies/wetlands in compliance with the order of the Tribunal dated 22.07.2021 in O.A. No. 351/2019, Raja Muzaffar Bhat v. State of Jammu and Kashmir & Ors. The appeal is disposed of"

Failing to get any relief from NGT the Municipal Council Bandipora filed an appeal before the Supreme Court of India. The Supreme Court bench of Justices Ajay Rastogi and CT Ravi Kumar in the order said that court finds no ground to interfere with the impugned order passed by the National Green Tribunal. While

et, the four-day window for desperately needed aid, medical supplies and essentials for the thousands of civilians suffering the consequences of the conflict between Hamas and Israel, is welcome. Since Hamas's attack on October 7, and Israel's brutal response, many countries — including big powers like China and Russia — have indulged in lofty rhetoric about the need for peace. That the cessation of hostilities, even if brief for now, was brokered by countries with stakes and roots in the region — and not necessarily those engaged in rhetorical displays of moralpolitik — is worth noting. The US has open channels of communication as well as leverage with both Israeli and Palestinian decision-makers. Qatar has influence with Hamas and Egypt, as a regional power that shares a border with Palestine and is a refuge for Palestinians. The role that the three countries have played — the lives they will undoubtedly save — must be commended. As humanitarian operations begin, India must do all it can for those suffering in Gaza — in terms of aid, supplies, as well as help to broker a solution.

The coming humanitarian pause also offers space for regional leaders to think of a way forward. The road map suggested by India's External Affairs Minister S Jaishankar at the BRICS summit on Tuesday may be useful. First, humanitarian aid and a cessation of hostilities. Second, both terrorism and military attacks on civilians must stop. Finally, a two-state solution that ensures security for Israel and sovereignty of Palestinians. What is needed in this moment of death and suffering is leadership that looks beyond the pain, that can clear a path to peace. Israeli Prime Minister Benjamin Netanyahu's statement, just before his cabinet approved the pause, is disturbing: "We are at war and we will continue it until we achieve all the objectives," he said. Rather than take a maximalist position, Israel should try reports indicate that sections of the coalition government are amenable to this — to negotiate the return of more hostages for a longer cessation of violence. Rs 6 crore to be spent on SWM plant

In August last year, the Chief Planning Officer (CPO) Bandipora, Imtiyaz Ahmad, had said that a scientific waste management plant had been sanctioned at the cost of Rs 6 crores. However, even after 15 months, the work on this plant is yet to start. Infact, the expression of interest -EOI was invited last year as per media reports but work has not been taken up at all. A few days back, another news report circulated in the media, wherein it was said that District Administration Bandipora was going to start waste management on scientific lines around Zalwan site near Wullar lake but these are only the statements and nothing substantial is happening. I have been following this case for the last 4 ½ years in the National Green Tribunal -NGT but it seems that the local administration in Bandipora, especially the Urban Local Bodies Kashmir, have not prioritized this work.

Background of the case

In March 2019, this author moved a formal petition in the National Green Tribunal (NGT) against unscientific dumping of municipal solid waste by Bandipora Municipal Council at Zalwan Nussu area in the outskirts of the town. I had visited the area several times and found lots of waste being dumped in violation of MSW Rules 2016. Ironically, the waste was being unscientifically dumped by the Municipal Council

As the order was not implemented in letter and spirit, the J&K Pollution Control Board on 9.2.2021 issued a penalty notice directing MC Bandipora to pay Rs 64. 21 lakhs under Polluter Pays Principle as per approved guidelines of the Central Pollution Control Board and the National Green Tribunal (NGT)

The Order reads:

"Whereas, on continuous failure on part of the Executive Officer Municipal Committee Bandipora to dispose of solid waste in a scientific manner a show cause notice for levying of Environmental Compensation, in light of the directions of the Hon'ble National Green Tribunal was served upon Executive Officer Municipal Committee Bandipora vide No. PCB/ LSK/489/020/124-130 dt. 26.06.2020, calling upon him there to show reasons within fifteen (15) days as to why Environmental Compensation be not levied upon him for these blatant violations of Environmental Laws. Now, therefore, in view of foregoing back ground Environmental Compensation under Polluter Pays Principle as per approved guidelines of the Central Pollution Control Board and the Hon'ble National Green Tribunal, to the tune of the Rs.64,21,000/- is hereby levied upon Executive Officer Municipal Committee, Bandipora for violation of Solid Waste Management Rules, 2016 for the period commencing from the date show cause notice dated 26.06.2020 to 25.09.2020 i.e. the date of latest report of Regional Director, PCB, Kashmir'

castigating the Municipality the SC in its order said:

"Is it the way you deal with matters? Is it the consciousness of your state? You cannot play with the lives of the people. Deposit the fine."

Misleading NGT with wrong information

The officials of Urban Local Bodies (UBLs) have failed to comply with scientific waste management rules across J&K. I don't see even a single municipal body where waste is managed as per MSW Rules 2016. In Chadoora town, almost 100% door to door collection of waste is undertaken after NGT penalized them with Rs 50 lakhs penalty last year. The waste management plant is also operational and I appreciate the work done by the local President of the Municipality and his staff but when it comes to collecting the waste in a segregated manner that hasn't been achieved.

Infact, the Housing and Urban Development Department J&K filed an inaccurate affidavit before NGT in my case, on November 21st 2023, claiming that 92% waste is being collected from Chadoora town in a segregated manner. This is not true, as per my information.

Conclusion

Wular is our identity and is an important constituent of Kashmir valley's collective biodiversity. The solid and liquid waste is choking it from different sides and the silt and solid waste transported via Jhelum is also impacting its health.

In the past too, I have written extensively on Wullar lake and sought judicial intervention for the same. The Wullar is still getting choked from its east shore which needs to be addressed. Waste from Bandipora town is largely impacting Wullar which needs urgent action.

Islamophobe Greet Wilders, The New Dutch PM?

Last week, veteran Dutch anti-Islam politician Geert Wilders vowed to be prime minister of the Netherlands eventually, following an election in which his party won the most seats. Wilders vowed on X, "I will be prime minister."

In a long post on X, he expressed frustration at other parties for their apparent unwillingness to cooperate with his Freedom Party (PVV), Wilders said he would "continue to moderate" his positions if necessary to gain power.

Although Wilders' party finished well ahead of rivals in the November 22 vote on an anti-immigration platform, his party won only 37 seats in the Dutch parliament. That means he will have to cooperate with at least two more moderate parties in order to form a government.

Earlier, the conservative VVD Party, of caretaker Prime Minister Mark Rutte, which shares many of Wilders' views on immigration, said it would not participate in a cabinet with him. However the VVD's new leader, Dilan Yesilgoz, did not rule out offering outside support to a Wilders-led government.

Pieter Omtzigt, who leads the centrist reform NSC Party and is also seen as a likely partner in a Wilders' government, has said cooperation will be difficult due to extreme positions Wilders has voiced that appear to violate Dutch constitutional protections on freedom of religion.

Wilders' stand on Islam

Geert Wilders is known for his radical anti-immigration and Islamophobic politics and his staunch Euro-scepticism.

In 2007, Wilders sent a letter to the Dutch newspaper de Volkskrant calling the Qur'an a "fascist book" just like Mein Kampf. The newspaper put the letter on the front page but in an editorial suggested that the PVV leader had gone too far with the comparison, which was deeply hurtful and offensive to many. This letter and other comments led to Wilders being prosecuted for inciting hatred and discrimination. He denied any wrongdoing. In 2011, he was acquitted and his comments ruled acceptable within the context of public debate.



In a 2008 interview with the Observer, Wilders said that Islam is not a religion; it's an ideology, the ideology of a retarded culture. The interview coincided with him creating a short film entitled Fitna, an Arabic word meaning "strife". In the film he again criticises the Holy Qur'an as a "fascist book" and intersperses images of the September 11 attacks with quotations from the Islamic holy book. It was screened on the internet and sparked violent protests in the Muslim world. In February 2009, Wilders was refused entry to Britain to screen the film on the grounds of it being a threat to public order. Wilders, who denied any wrongdoing, appealed, and a court later said the decision was wrong. The Dutch public prosecutor stated that statements made in it were "hurtful and offensive to a large number of Muslims" but not punishable by law. The

episode subsequently became part of the 2011 case.

Wilders coined the word "Head Rag" to describe the headscarves worn by Muslim women. In the Netherlands' annual political debates in September 2009, Wilders suggested an annual tax of €1,000 on headscarves, provoking a scandalised reaction. His position on headscarves, and talks on Turkish accession to Europe, had led him to break with the People's Party for Freedom and Democracy (VVD) and set up the PVV, or "Party for Freedom", in 2005.

On immigration, Wilders stands for decreasing and clubs it with Moroccans, whom he describes as "scum" migrating to Netherlands and delivered a speech at The Hague in 2014 condemning migration. In a lengthy prosecution, which he claimed was politically motivated; this speech was eventually ruled as unlawful discrimination in terms of insulting a group. It resulted in a criminal record for Wilders but he was acquitted of inciting discrimination and given no other penalty.

From calling Moroccans "scum", to holding competitions for cartoons of the Prophet Mohammed, Wilders has built a career based on his self-appointed mission to stop an "Islamic invasion" of the West.

Wilders also condemns the Dutch democracy and has stated that there is an enormous gap between this fake Dutch parliament and common people at large. Talking in the 2015 budget debates, Wilders argued for a closure of the borders and questioned Dutch democracy because MPs did not agree with him. He also wants The Netherlands to leave the EU, just like the UK.

Moreover, Wilders pledges to close the

Dutch representation in Ramallah, home to the "corrupt Palestinian Authority." He also describes Israel as the only true democracy in the Middle East and has stated that once in power he'll ensure Dutch relations with Israel are strengthened and will move the Dutch embassy to Jerusalem.

Dutch politics

The Netherlands is known for low corruption, press freedom and moderation, but for the past two decades it has witnessed a rising support for far-right parties. Prof Tom Louwerse of Leiden University's Institute of Political Science, told The Guardian that the Dutch far right has polled on average 15% to 20% votes in the past decade. Prof Matthijs Rooduijn of Amsterdam University told a Dutch news website localnews.com that he sees the election as a "breeding ground for right-wing populism". Although Wilders is extremely right wing

Although Wilders is extremely right wing on immigration, he has populist policies on healthcare, pensions, the minimum wage and social housing. "The electorate of the PVV in general consists of people who experience more difficulties," said Rooduijn. "They feel they are being neglected. They have tough lives, economically but also culturally. And that is one of the reasons they vote for a party that promises radical change."

But will this radical change happen? Wilders has won the most seats and been invited to try to form a coalition. But the Dutch representative democracy and the process of electing a coalition PM is very complicated. And it could take months for him to be chosen the prime minister.

Overall, the Dutch elections may serve as an indication of the increasing right-wing sentiments in Western Europe. The far right has grown throughout much of Europe in the past decade. Giorgia Meloni of Brothers of Italy rode to power last year, the National Rally led by Marine Le Pen came second in the 2022 French presidential election polls, and the Alternative for Germany party is currently polling second.

Why You Reveal More

Than You Know You Should

I t was late last night. You'd had a rough day at work, and you'd come home exhausted, both physically and mentally. You were still upset about that incident in the office, so you had a couple of drinks and went onto social media to unwind. While you were there, you let your friends know just what you think about your boss and coworkers.

It felt so good at the time to let out all that pent-up frustration. But now, in the cold light of morning, you've got that sinking feeling of regret. You know you revealed more than you should have, and now you're afraid it's going to come around to bite you.

We think we prize our privacy—and yet people frequently disclose personal information that may not be in their best interest. This is a fact of human behavior that psychologists have struggled to explain.

The Costs and Benefits of Revealing Private Information

According to traditional views on privacy-related behaviors, people should carefully consider each piece of personal information, only revealing it if the benefit of doing so outweighs the cost. Since people often disregard costs and benefits when revealing personal information, there's obviously a problem with the traditional explanation. Perhaps, Carnegie Mellon University psychologists Erin Carbone and George Loewenstein suggest, people do in fact weigh the costs and benefits, but not in the way psychologists have assumed.

In an article they recently published in the journal Current Directions in Psychological Science, Carbone and Loewenstein



argue that we all have a drive to disclose that works just like other drives, such as those for hunger, thirst, and sex. In other words, we have a fundamental need to reveal information about ourselves to others. That means that when people decide to disclose something private on a given occasion, the costs and benefits center on satisfying that drive in the moment rather than long-term consequences.

The Carrot and the Stick of Drives

According to Carbone and Loewenstein, drives work by the stick-and-carrot approach. The stick is the unpleasant feeling that we experience when a drive is not met. When we're hungry, thirsty, or horny, we feel uncomfortable, and we can think only of satisfying that need.

The carrot, then, is the pleasure we experience when we do satisfy a drive. Orgasm may be the greatest pleasure we humans can experience, but the satisfaction of a good meal is a close second. Of course, drives care only about the here and now and not the future, and we may soon regret that particular sexual encounter or the kind of food we ate.

Disclosing personal information works the same way, Carbone and Loewenstein argue. Holding back secrets can be troubling, and, in fact, doing so can lead to long-term physical and psychological health problems. There is also the pleasurable sense of relief we feel when we can finally get something off our chest.

When we open up to a trusted friend or counselor, we can gain the benefits of disclosure while incurring no social costs. But when we reveal private information to strangers on the internet, we may feel relief in the moment, but the long-term social costs are quite likely going to outweigh that momentary pleasure. In this way, disclosing too much on social media is a lot like ill-advised drunken sex or gorging on junk food—such acts may satisfy a drive, but not in a healthy way.

The Drive to Disclose in Our Evolutionary Past, And Now

The evolutionary rationale behind most

drives is obvious. We need to eat and drink to survive, and we need to have sex to get our genes into the next generation. But why would we have evolved a drive to disclose?

For most of human existence, our ancestors lived in small groups of 100-150, in which everyone knew everyone and many people were related to each other. When individual survival depends on coordinating group activities, candor is essential. Besides, when you spend your whole life in the same small group, there really are no secrets anyway, so it's best to be open.

But nowadays we live in a world of strangers, and we never know for sure who we can trust and who wants to take advantage of us. In other words, privacy is a need that arises from our modern, anonymous lifestyle, and as such, evolutionary psychology suggests that we have no innate cognitive mechanisms for dealing with it. Instead, we have to exercise willpower to keep from making personal disclosures that would have been appropriate in the days of our hunter-gatherer ancestors but are totally inappropriate in modern society.

Even though our drives are often a mismatch for our lifestyle today, there's no way we can curb them entirely. If we want to live a healthy life, we need to choose nutritious foods to satisfy our hunger drive, and we have to find dependable mates to meet our sexual needs. Likewise, we have to acknowledge our drive to disclose, but we should also find safe channels for meeting that need to reveal ourselves to others.

Talking To Children About Body Safety And Teaching Them To Say No To Secrets

How empowering kids can help protect them from abuse

eeping kids safe from abuse isn't about teaching stranger danger or tricky people. It's far less simplistic.

If you grew up in the 1970s, '80s and '90s in Australia, you might recall being warned about "stranger danger".

Parents, teachers and even the media used the phrase to warn children about talking to unfamiliar adults to reduce the chance of child abduction or abuse. But child protection experts now suggest a different approach to reflect that strangers' are not the main perpetrators of child abuse.

These days, rather than focusing on stranger danger or even the concept of "tricky people", which has been doing the rounds of parenting websites researchers suggest parents talk to children about body safety and empowerment, and teach them to say no' to secrets.

Where did stranger danger' come from?

The widespread fear of "stranger danger" may have been prompted by media coverage of unknown male perpetrators abducting and abusing children.

But it may also stem from our fear of recognising that abuse is going on much closer to home.

Keeping the focus on the rare, and exceptional event helps the majority of Australians to distance themselves from the problem ,to imagine it as a random event that happens to others'.

Since the 2017 report of the Royal Commission into Institutional Responses to Child Sexual Abuse exposed the abuse of children and young people by people in positions of power, we understand more about the need for a shift in the culture of child safety in organisations.

The Royal Commission shifted the conversation, recognising that abuse goes on in organisations at the hands of those who are known and trusted, involving a process known as grooming'.

We now understand that most child sexual abuse occurs at the hands of someone a child knows.Of people who experienced sexual abuse before they were 15, about 79 per cent were abused by a relative, friend, acquaintance or neighbour.

Only 11 per cent were abused by a stranger. (Other perpetrators included trusted figures such as teachers, recreational leaders, religious leaders, doctors, staff in a children's home, or corrective services personnel.)

According to recent findings from the Australian Child Maltreatment Study of 8500 people, that figure is even lower: only 4.9 per cent of all respondents experienced



sexual abuse by an unknown adult (or about 18 per cent of those who experienced child sexual abuse).

What's more, around one-third of childhood sexual abuse is perpetrated by another child or young person, which sometimes includes siblings.

The uncomfortable truth is that children are abused and groomed not only in institutional settings but also within the family.

What about the tricky people' concept?

Some child safety advocates have recently steered the child safety conversation towards "tricky people" teaching kids to recognise dangerous people who may be trying to trick them.

The concept was conceived by Pattie Fitzgerald, founder of educational company Safely Ever After, and has been circulated by publications in the US, Australia and beyond.

But the "tricky people" concept has limitations because in reality, child abusers are often difficult to recognise as "tricky".

Those who sexually offend against children may appear to be upstanding members of their communities, well liked and respected by others. They can be charming. They are often the last person you would suspect.

After all, child abusers don't just groom their child targets; they groom everyone to create an entire ecosystem of abuse that allows

them to operate unchallenged in plain sight.

It is often only with hindsight that we can see who is grooming and who is just a trustworthy and wholesome person.

Instead of trying to identify who are "tricky people", researchers now call us to focus on the environment, and looking out for situations or context that are tricky and place children and young people at risk.

In organisations, policies and code of conduct call out these situations (such as private communication between a sports coach and team member via a personal social media platform, rather than from a club account that is monitored by other adults).

We need to recognise and modify tricky places' or tricky processes' those situations that allow grooming and abuse to occur.

What actually works

Apart from minimising situations that may enable grooming and abuse, the best defence against child abuse is talking, to overcome the shame, secrecy and silence that enables the behaviour.

Parents, carers and teachers are encouraged to talk to children and young people about body safety and empowerment.

They can focus on teaching children how to speak up when they have concerns, and say no' to secrets (this involves differentiating between unsafe secrets and surprises).

Eating Beef, Dairy Can Boost Immune System To Fight Cancer: Study

urns out eating beef and dairy may bolster your body's immune response against cancer, according to a study.

Trans-vaccenic acid (TVA), a long-chain fatty acid found in meat and dairy products from grazing animals such as cows and sheep, improves the ability of CD8+ T cells to infiltrate tumours and kill cancer cells, revealed the study by researchers from the University of Chicago.

The study, published in the journal Nature, also shows that patients with higher levels of TVA circulating in the blood responded better to immunotherapy, suggesting that it could have notential as a



metabolites derived from food, we begin to see how they influence physiology and pathology," said Jing Chen, Professor of Medicine at University of Chicago in the US.

"By focusing on nutrients that can activate T cell responses, we found one that actually enhances anti-tumor immunity by activating an important immune pathway,' Chen added. However, Chen cautioned that there is a growing body of evidence about the detrimental health effects of consuming too much red meat and dairy, so this study shouldn't be taken as an excuse to eat more cheeseburgers and pizza.

For the new study, the team started with a database of around 700 known metabolites that come from food and assembled a "blood nutrient" compound library consisting of 235 bioactive molecules derived from nutrients.

They screened the compounds in this new library for their ability to influence anti-tumour immunity by activating CD8+ T cells, a group of immune cells critical for killing cancerous or virally-infected cells.

After the scientists evaluated the top six candidates in both human and mouse cells, they saw that TVA performed the best. TVA is the most abundant trans fatty acid present in human milk, but the body cannot produce it on its own.

Maruti Suzuki, M&M, Audi Plan **Price Hikes In January**

NEW DELHI: Automakers Maruti Suzuki, Mahindra & Mahindra and Audi India on Monday announced plans to hike prices of their passenger vehicles in January 2024 citing reasons, including cost pressure driven by overall inflation and increased commodity rates

Besides, Tata Motors and Mercedes-Benz India are mulling increasing the prices of their models from January.

The country's largest carmaker Maruti Suzuki India, which sells a range of vehicles from entry-level small car Alto to multi-utility vehicle Invicto, priced between Rs 3.54 lakh and Rs 28.42 lakh (ex-showroom Delhi), on Monday said the price hike would vary from model to model.

In an interaction with PTI, Maruti Suzuki India (MSI) Senior Executive Officer (Marketing and Sales) Shashank Srivastava said the price hike would would be "substantial" in some models.

"There is an inflationary pressure all around, including volatility in commodities, so that is the reason we have decided to increase the prices in January," he noted.

MSI had last hiked vehicle prices by 0.8 per cent in April this year. It had effected a total price increase of 2.4 per cent

last fiscal. "There is no choice left for us now but to enhance the prices. We are yet to figure out the exact quantum of the increase," Srivastava said.

Earlier, in a regulatory filing, MSI said the company has planned to increase the prices of its cars in January 2024 on account of increased cost pressure driven by overall inflation and increased commodity

prices "While the company makes maximum efforts to reduce cost and offset the increase, it may have to pass on some increase to the market. This price increase shall vary across models," it said

Mahindra and Mahindra CEO (Automotive Division) Nalini-

kanth Gollagunta said in that based on the inflation and commodity prices outlook, "we intend to take a price increase for our automotive products effective January 2024

The details for which will be announced closer to the time, he said in a statement.

Meanwhile, Tata Motors said it is also considering increasing prices of its passenger and electric vehicles in January 2024. The company, which sells a range of passenger vehicles starting with hatchback Tiago to premium SUV Safari priced be-

tween Rs 5.6 lakh and Rs 25.94 lakh, also did not specify the quantum of the proposed hike. "We are considering a price hike across our passenger and electric vehicles in January 2024.

The extent of the hike and exact details will be announced in a few weeks," a Tata Motors spokesperson said.

Earlier in the day, German luxury car maker Audi said it will hike prices of its vehicles in India by up to 2 per cent from January next year, citing rising input and operational costs.

Gen AI Likely To Have More **Impact On White Collar Jobs Than Blue Collar Roles: Report**

MUMBAI: Generative AI is likely to become a much greater threat for white-collar roles, such as accounting and book-keeping, rather than blue-collar jobs, a report said on Monday.

Many administrative roles involve repetitive tasks such as scheduling appointments or answering and directing calls, which can easily be replicated by generative AI, according to global learning company Pearson's Skills Outlook report --'Gen AI Proof Jobs'

The report cited that in India around 30 per cent or more time spent on some white-collar tasks every week can be performed by generative AI.

However, generative AI can do less than 1 per cent of a blue collar workers' job in a week, it said.

"As employees look to the future, understanding which jobs are at risk from AI allows them to prepare. They should also consider where new roles might be created by Gen AI," Pearson Workforce Skills President Mike



Howells said.

"Workers and employers should look at how they can ride this wave of change by using the best of AI and the best of human skills together," he said.

Pearson's Skills Outlook series looks at 'Gen AI Proof Jobs', based on an analysis of impact of generative AI on more than 5,000 jobs in five countries --Australia, Brazil, India, the US, and the UK.

As per the report, in India, the most impacted white-collar jobs are accounting and bookkeeping clerks (46 per cent), word processor and related operators (40 per cent), administrative secretaries and related associate professionals (38 per cent), stall and market salespersons (30 per cent), and accountants (28 per cent).

American Chip Maker AMD Inaugurates Its Largest Global Design Centre In India

New Delhi: Chief Justice of India D Y Chandrachud Tuesday said top judges of several countries agree that the right to legal aid has to begin "at the earliest," even before arrest of an accused.

He said judges need to educate not just students but the masses also about it.

The CJI was speaking at the valedictory session of the two-day 'Regional Conference on Access to Legal Aid: Strengthening Access to Justice in the Global South' organised by the National Legal Services Authority (NALSA) here.

The conference was attended by President Droupadi Murmu, Vice President Jagdeep Dhankhar, and Law Minister Arjun Ram Meghwal.

Besides them, more than 200 delegates including Chief Justices of Bangladesh, Cameroon, Equatorial Guinea, Eswatini. the Maldives, Mauritius, Mongolia, Nepal, Zimbabwe and the ministers of justice from Kazakhstan, Nepal, Palau, Seychelles, South Sudan, Sri Lanka, Tanzania, and Zambia took part in the meeting.

"The right to legal aid, all Chief Justices have concluded, has to begin at the earliest stage, even before arrest," CJI Chandrachud said.

"There is a need for judges to publicise schemes and edu-cate not just students but the

Justice Chandrachud also referred to the use of celebrated Indian judgements by courts of nations like South Africa, Sri Lanka, Bangladesh and other countries and termed it a "transjudicial communication."

He said that in the Chief Justice's round table he discussed several other avenues for collaboration including the use of technology to make courts more accessible.

"At the end of the round table, we successfully adopted the New Delhi principles on the role of the judiciary in ensuring equal access to justice for all in the Global South. which lays great emphasis on legal representation, legal aid,

by doing away with the legal requirement of "locus standi" (a right to appear in a court) in a court case.

"Our court removed procedural barriers to access the Supreme Court and allowed all citizens to approach the court for the alleviation of socioeconomic injustice...the South African Constitutional Court has on several occasions relied on Indian jurisprudence in that regard," he said.

Using the expression "transjudicial communication," he said in recent years, the decisions of constitutional courts in several global south jurisdictions such as South Africa, India, Bangladesh, Nepal, and Kenya, have become the primary catalysts of comparative constitutional law.

"Mutual inspiration is increasingly drawn from the case law of peer courts of other countries and even other continents, which gives rise to the cross fertilisation of legal ideas," he said.

He also named certain judicial decisions on such issues as basic structure doctrine, right to privacy, the rarest of rare doctrine for awarding the death penalty, the public trust doctrine, and environmental law where other nations' courts followed Indian judgements.

"A seven-judge bench of Kenya's court of appeal has

also applied the basic structure doctrine to place limits on the amending powers of Parliament and foster responsive constitutionalism," he said.

"Further, the Sri Lankan Supreme Court discussed as many as 20 Indian cases that involved Article 14 of the Indian constitution in a case about equality of opportunity in university admissions," he said.

And the Indian Supreme Court has also greatly benefited from the "creative jurisprudence emerging from several nations in the Global South," he said, adding, the region "has in many ways become a North Star for all nations around the globe.'

Besides judicial decisions, courts across world have also learned from each other on the administrative side to facilitate access to justice, he said.

In his inaugural address, the CJI on Monday said access to justice cannot be secured only by crafting pro-people jurisprudence in judgments, but requires active progress on the administrative side of a court, such as improving infrastructure and enhancing legal-aid services.

President Murmu, Law Minister Meghwal, and SC judges Justices Sanjay Kishan Kaul and Sanjiv Khanna-- also spoke at the valedictory session of the conference.

Wealthiest 10% in developing nations emit less emissions than regular earners in rich nations: Study

New Delhi: In rich countries, even regular earners produce more carbon dioxide than the wealthiest 10 per cent of people in developing countries like India, Brazil, and others in Asia and South America, according to a new study.

Released ahead of the UN climate talks in Dubai, the study by the New Delhi-based climate think tank Council for Energy, Environment, and Water (CEEW) shows that the richest 10 per cent in the developed countries and China produce 22 per cent more CO2 than all the developing countries studied combined

The study highlights that carbon emissions of an individual in the bottom 10 per cent income bracket of Saudi Arabia, the US, or Australia are 6 to 15 times more than an individual in the poorest decile of India.

Database and the World Bank. These countries, taken together, account for 81 per cent of global emissions, 86 per cent of the world's GDP, and 66 per cent

of the global population. Arunabha Ghosh, CEO, CEEW, said the study clearly shows that not everyone is equally responsible for increasing global carbon emissions.

"The top 10 percent in many developing countries emit less than the average per capita emissions in developed countries. This, once again, drives home the scientific basis for 'common but differentiated responsibilities', especially as COP28 holds up a mirror to past pledges and broken promises," he said.

Minister Narendra Prime Modi has been championing the Lifestyle for Environment (LiFE movement), urging countries to adopt planet-friendly living practices and move away from deeply consumerist behaviours. Recognising the criticality of this decade (2021-2030) for climate action, there's a call for rebalancing consumption patterns between the Global North



and the Global South.

representing 18 per cent of the world's population, has contributed only 5 per cent of greenhouse gas emissions to date.

in 2015. The CEEW study also found that encouraging the adoption of low-carbon lifestyles among

than 3.4 billion tonnes of CO2 annually. Moreover, a carbon tax on the richest 10 percent of developed countries and China could shore up USD 500 billion and discourage highly carbonintensive consumption patterns, the researchers said.

These funds could be used for climate change mitigation, research and development, derisking clean technology, and building resilience.

This is crucial since another recent CEEW study showed that developed countries are not on track to meet their 2030 emission reduction targets and will overshoot their Nationally Determined Contributions (NDCs) or national plans to limit global warming to 1.5 degrees Celsius by 38 per cent.

Pallavi Das, Programme Lead, CEEW, said, 'Inequity in the climate debate has a longstanding history, and the rich in developed countries are primarily responsible for carbon emissions. Our study shows that while the emission intensity of income has reduced for the highest earners (top 10 per cent) in most countries

between 2008 and 2018, overall emissions are increasing because of the rise in incomes. With the carbon budget depleting to keep the world below the 2 degrees Celsius threshold, the rich must be held accountable and nudged to pursue sustainable lifestyles.

The CEEW study also highlighted that the carbon emissions across both developed and developing countries reveal significant inequities between the wealthiest and poorest income brackets. The difference in the carbon footprint between the top and bottom income 10 per cent ranges between 8 and 22 times for the countries studied. This makes it clear that high earners must make concerted efforts to adopt low-carbon lifestyles and practice responsible consumption.

In this study, 'developed countries (or regions) and China' include Australia, Canada, China, European Union, Japan Russia, Saudi Arabia, Turkey, the UK, and the US, and 'developing countries (or regions)' include Argentina, Brazil, India, Mexico, South Africa, and ASEAN.

The T20 World Cup will be played in the West Indies and the USA from June 4-30 next year.

The ICC informed that five wins in as many matches have not only taken Namibia to the top of the points table, ensuring their third straight appearance in the tournament.

A few days ago, Uganda had stunned Zimbabwe by five wickets to earn two crucial points in the Qualifiers.

The next edition of the showpiece will feature 20 teams divided into four groups consisting five sides each, while 12 teams have already qualified for the event. This includes the cohosts West Indies and the USA, followed by top eight teams in the last T20 World Cup in Australia alongside Afghanistan and Bangladesh, who were the next two best teams on the cut-off date of November 14, 2022.

Current solar cycle intensity to peak in 2024, may impact Earth's satellites, find researchers

he current ongoing solar cycle is likely to peak its intensity in 2024 and can potentially impact Earth's space weather, according to researchers at the Indian Institute of Science Education and Research (IISER), Calcutta.

It is known that roughly every 11 years, the intensity of solar activity reaches its peak, which manifests as violent disturbances in space weather such as solar magnetic storms or coronal mass ejections, impacting Earth's satellites and telecommunications.

"During intense solar storms, the Earth's upper atmosphere expands outwards, thereby introducing friction on the low-Earth satellites. The friction can lead to a decay in the satellites' orbits and reduce their lifetime. Thus, they are able to live in space for a much shorter time than they were originally supposed to," Dibyendu Nandy, the study's corresponding author and Professor of Physics and Head. Center of Excellence in Space Sciences India, IISER, Calcutta, told PTI.

The researchers also said that the most intense of these storms can cause serious damage to orbiting satellites, electric power grids and telecommunications when directed at Earth.

In their study appearing in the journal Monthly Notices of the Royal Astronomical Society Letters, the researchers discovered a new relationship to help predict the occurrence of peaks in solar cycles, which are produced by an internal dynamo mechanism, harnessing energy from plasma flows inside the Sun.

Using decades-old data archives from ground-based solar

observatories worldwide, they found that the ongoing solar cycle 25 is related to the Sun's magnetism activity, which they said manifests as sunspots cycle and recycling of the large-scale solar dipole magnetic field.

The sunspots, or dark spots on the Sun, are comparable to the size of the Earth and their magnetism intensity is about 10,000 times stronger than the Earth's magnetic field.

The research team found that the solar dipole magnetic field stretching from one pole of the Sun to another in a way similar to the Earth's - waxed and waned in strength, flipping its polarity periodically, with the ongoing sunspot cycle.

Specifically, the rate of decrease in the Sun's dipole magnetic field is related to the rate of rise of the ongoing solar cycle, the researchers said in their study. Swiss astronomer Max Wald-

meier had discovered in 1935, that quicker the rise of a solar cycle, the greater its strength. This meant that stronger cycles would take lesser time to reach their peaks.

This discovery complemented the Waldmeier effect, the researchers said.

Their findings connecting the two primary components of the solar magnetic field support the theory that the evolution of sunspots are integral to the functioning of the solar dynamo process rather than being a mere symptom of it, they said.

Their findings open up a new window for forecasting the timing of the peak of solar cycles when the most intense activity and most frequent space weather disturbances are expected, they said.

17-Day Ordeal Over; All Trapped Workers Rescued From Uttarakhand Tunnel

erupted outside the underconstruction Silkyara tunnel in Uttarakhand on Tuesday night as rescue workers successfully brought out all the 41 labourers trapped inside for the last 17 days. The extraction process be-

gan in the evening after a team of five-six rat-hole miners finished the drilling work and pushed a 700 mm rescue pipe

towards the trapped workers. A few personnel from the National Disaster Response Force (NDRF) had first gone down the pipe to assess the condition and guide the work-

ers through rescue protocols. Uttarakhand Chief Minister Pushkar Singh Dhami and Union Minister V.K. Singh, who were at the site to oversee the rescue mission, met the workers who were brought out on specially modified stretchers.

Dhami was seen distributing sweets to officials and rescue personnel. Those rescued were given the initial first aid at the tem-

porary medical facility set up at the site and later shifted to a nearby hospital. "I am completely relieved

and happy as 41 trapped laborers in the Silkyara Tunnel Collapse have been successfully rescued," Road Transport Minister Nitin Gadkari posted on X. 'This was a well-coordinat-

ed effort by multiple agencies,

marking one of the most significant rescue operations in recent years. Various departments and agencies complemented each other despite facing numerous challenges., he said

The workers were trapped inside the tunnel being between Silkyara and Dandalgaon following a landslide at the site on November 12.

Following is a timeline of the disaster and the rescue efforts:. November 12: The labourers

get trapped as portions of the Silkyara-Dandalgaon underconstruction tunnel on the Brahmkhal-Yamunotri highway collapse following a landslide at around 5.30 am on the day of Diwali.

Arrangements made to supply oxygen, electricity and eatables to the trapped labourers through air-compressed pipes as multiple agencies, including the NDRF, SDRF, BRO, project executing agency NHIDCL and ITBP, begin rescue efforts. November 13: Contact is



established with the trapped workers through a pipe meant to supply oxygen to them and they are reported to be safe. Fresh rubble keeps falling from above due to which the debris accumulated in an area of around 30 metres spreads to 60 metres.

November 14: Steel pipes of 800- and 900-millimetre diameter are brought to the tunnel site to be inserted through the rubble with the help of an auger machine for horizontal digging.

However, when more rubble falls from the cavity created by the cave-in, two labourers sustain minor injuries.

November 15: Dissatisfied with the first drilling machine, the NHIDCL asks for a state-ofthe-art auger machine, which is airlifted from Delhi to speed up the operation. November 16: The drilling

machine is assembled and installed. It starts working past midnight.

November 17: The machine

Info From Social Media Can't Be Part Of Petitions, Says Bombay High Court

Mumbai: Information gathered from social media cannot be part of the pleadings in a public interest litigation, the Bombay High Court said on Tuesday while hearing a petition claiming that 1,500 to 2,000 people lose their lives in unsafe water bodies in Maharashtra every year.

A division bench of Chief Justice D K Upadhyaya and Justice Arif Doctor refused to hear a PIL filed by advocate Ajitsingh Ghorpade seeking a direction to the Maharashtra government to take measures to safeguard waterfalls and water bodies in the state.

Ghorpade's lawyer Manindra Pandey claimed that around 1,500 to 2000 persons lose their lives at such unsafe waterfalls and water bodies every year, and the bench sought to know from where the petitioner had got the information on the deaths. Pandey then said they had procured the information from newspapers and social media posts. The court then said that the petition was vague and did not contain many details.

filing PILs. You are wasting judicial

time," CJ Upadhyaya said. The bench noted that such petitions could not be entertained as it was a "sheer wastage" of time.

"Somebody goes for a picnic and accidentally drowns, therefore a PIL? Someone drowns in an accident, how is it a violation of fundamental rights under Articles 14 and 21 (equality and life)," the court said.

Pandey then said that the state government should be directed to take steps to ensure the safety and protection of people who visit such water bodies and waterfalls.

The bench, however, noted that most of the accidents were because of "reckless acts".

"What do you expect from the Maharashtra government? Can each and every waterfall and water body be manned by the police?" the bench asked.

To this, the lawyer pointed out that many times when there is a drowning accident, there is no rescue team, because of which the body of the victim is recovered two to three days later.

The court then sought to know if the petitioner had visited any such waterfall or water body or if he had ascertained which one was more dangerous or unsafe.




