#### **Mercury Drops By Few Notches** In Kashmir

Srinagar: The minimum temperature decreased by several degrees in Kashmir but settled above the freezing point at most places as the higher reaches of the valley brace for light to moderate snowfall, officials said on Wednesday. The twin resorts of

Gulmarg and Pahalgam were the only weather stations which registered sub-zero minimum temperatures last night, with night temperature in Gulmarg in north Kashmir settling at a low of minus 1.8 degrees Celsius, they said.

Pahalgam, which also serves as one of the base camps for the annual Amarnath yatra, in south Kashmir's Anantnag district recorded a low of minus 1.5 degrees Celsius -- down from 1.2 degrees Celsius the previous night, they said.

Srinagar recorded a minimum of 0.8 degrees Celsius -- over three degrees down from 3.9 degrees Celsius the previous night, they said.

New Delhi: The government on Wednesday listed 18 bills, including two to extend provisions of the women's reservation act to Jammu and Kashmir and Puducherry and three to replace the criminal laws, during the Winter Session of Parliament beginning next week.

According to a bulletin issued by the Lok Sabha Secretariat, the government also plans to bring a bill that seeks to increase the strength of the Jammu and Kashmir Assembly from 107 to 114 in a bid to provide representation to Kashmiri migrants, displaced persons from Pakistan-occupied Jammu and Kashmir and Scheduled Tribes.

Besides the bills, the government has listed the first batch of supplementary demands for grants for the year 2023-24 for presentation, discussion and voting during the session.

The Winter Session of Parliament begins on December 4 and continues till December 22.

### **HC Upholds Withdrawal Of 45 Physiotherapists' Posts**

Srinagar: The High Court of J&K and Ladakh has upheld a verdict by Central Administrative Tribunal (CAT) in July last year regarding withdrawing of 45 posts of Junior Physiotherapists despite recommendations by the J&K Service Selection Board in 2015.

The posts according to the government were inadvertently referred on 17 August 2015 by the Health and Medical Education Department to IKSSB and the latter proceeded with the recommendations despite being subsequently informed not to go ahead. "The fundamental question

# YouTube Rolls Out Over 30 'Playables' **Mini-Games For Premium Users**

n an effort to lure users to subscribe to its paid Premium service, Googleowned YouTube has rolled out a collection of mini-games called "Playables", offering more than 30 mini-games that can be played instantly, without the need for any downloads.

The games can be played on Android, iOS and desktop.

To begin, users can navigate to a "Playables" shelf by scrolling on Home or by clicking a "Playables" link in the Explore menu on desktop and mobile, reports TechCrunch.

The games available are Daily Solitaire, The Daily Crossword, Angry Birds Showdown, Merge Pirates, Farm Land, Words of Wonder, Endless Siege, 8 Ball Billiards Classic, and Brain Out.

The games may not be available at all times, as YouTube stated that they are only playable until March 28. This limited-time access might be used

by YouTube to gather feedback from its Premium subscribers before making any further choices about expanding its gaming capabilities. Meanwhile, YouTube has said it is testing new generative AI features that'll let people create music tracks using just a text prompt or a simple hummed tune.

# Srinagar Export Hub To Be Operational Soon, Say DC Srinagar

Approves DPAP For Silk Carpet. Pashmina And Paper Mache Products

Srinagar: District Administration Srinagar is estab lishing Srinagar Export Hub at Kashmir Haat with the vision to give a fillip to the Export volume and to boost the local Economy, particularly focusing on promoting specific products or industries within the District that have good export potential, thereby likely enhance production, improve quality, and facilitate marketing and export of these products.

The idea is also to enable holistic socioeconomic growth of the local Artisans and Exporters of the District. The Initiative' is being run by the Department of Commerce (DoC) with the Department for Promotion of Industry and Internal Trade (DPIIT) as a major stakeholder.

A meeting of District Level Export Promotion Committee (DLEPC) was held under the Chairmanship of Deputy Commissioner (DC) Srinagar, Mohammad Aijaz Asad here at Conference Hall of the DC Office Complex to finalize the Draft Export Action Plan aimed to enhance the Export of Goods from Srinagar District to boost the local Economy and institutionalize the Export Ecosystem through establishment of Srinagar Export Hub.

At the outset, the Deputy Commissioner held an extensive discussion with all the stakeholders present in the meeting on the proposed Draft District Export Action Plan.

The DC, who is also the Chairman of DLEPC also held a detailed deliberation on the comprehensive Export Plan placed before the Committee under which 3 products have been identified/finalized having good export potential viz Silk Carpet, Pashmina and Papier Mache in Srinagar District.

On the occasion, the DC was apprised that Rs 10.65 crore plan has been earmarked under Silk Carpet having different components including Strengthening of Indian Institute of Carpet Technology(IICT), Srinagar, Setting up of Raw Material Banks, Replacement of Old worn-out Carpet Looms, Skill Up-gradation and Capacity Building Training, Publicity and Promotion of Gl Tagging of Carpets, Marketing and Promotion, Market Research/Study, Setting up a Common Facility for Carpet Washing and Drying

### **Spontaneous Power Cuts Poses Threat To Patients On Oxygen Support**

#### **Observer News Service**

Srinagar: Unscheduled power outages in Kashmir pose a serious threat to the well-being of patients relying on oxygen support at home. In Srinagar City, unreliable

power supply has left patients in perilous situations, while those living in rural areas face many more challenges.

Patients across various areas of Srinagar claimed that the frequent and unscheduled power disruptions have transformed their lifeline—oxygen supply—into a source of anxiety.

Shakeel Ahmad, the son of a patient from the Barzulla area in

Srinagar, said continuous power is crucial for oxygen concentrators which are vital for supporting those with respiratory conditions.

Despite the city setting, Ahmad said he faces hurdles in ensuring a constant oxygen supply for his father. "I have to travel to Batamaloo every alternate day to fill an oxygen cylinder, which costs around Rs 500 including fare," he said.

Another patient from Wantpora, Srinagar, echoed similar concerns, saying there is an imperative need for a 24x7 oxygen supply, which becomes unattainable due to power outages.

Highlighting the severity of the situation, the patient said any disruption exceeding half an hour can lead to deterioration in their health. Patients and their families

in other areas of Srinagar said they are grappling with the challenge of managing power backup solutions and ensuring the safety of their loved ones. While some have resorted to alternative power sources, these solutions come with their own set of challenges, and not everyone can afford generators or backups, they said.

Expressing the financial constraints faced by many, they revealed that patients from financially weaker sections rely on concentrators provided by NGOs, but managing daily refills for oxygen cylinders remains a daunting task.

# **Ceasefire Now**

he extension of the truce between Israel and Palestinians offers a ray of hope in the midst of conflict and suffering. The further two-day extension has seen the release of hostages, a crucial step towards restoring a semblance of normalcy in the region. However, what is required now is not just a pause in hostilities but a firm commitment to a lasting peace. And this means not just prolonging the ceasefire but also working for a two-state solution.

The extension of this truce, now in its fifth day, is a fragile yet significant opportunity for both sides to prioritize dialogue over violence. It has enabled the freedom of hostages and prisoners. The gesture, though commendable, must not be a temporary respite but a foundation for sustained peace efforts.

The hostage releases, while an important development, represent only a fraction of those impacted by the conflict. Civilians, caught in the crossfire, have borne immeasurable suffering. The staggering toll of Palestinian lives, with over 15000 of them dead so far, demands an end to the cycle of violence.

The humanitarian crisis in Gaza, with its dire shortage of essentials like food, fuel, and medical supplies, calls for urgent and sustained attention. The truce extension has allowed aid to trickle in, but the needs of the 2.3 million people in Gaza far exceed the current relief efforts. A longer-term ceasefire would facilitate the unimpeded flow of humanitarian aid, alleviating the plight of countless civilians.

The images of families reuniting with their loved ones bring fleeting moments of peace, but there remains a pressing need for a comprehensive resolution. It is heartening to witness the efforts of mediators like Qatar and Egypt in facilitating talks. However, the international community including India must put their weight behind these initiatives, advocating not just for the extension of the truce but for a permanent cessation of hostilities.

The tragedy of this conflict is not confined to the physical destruction; it permeates the lives of countless individuals, leaving scars that extend far beyond the visible ruins. The trajectory of this war must shift from destruction to reconstruction, from hostility to healing.

The international community, including influential stakeholders like the United States, must intensify efforts to support this prolonged ceasefire and facilitate talks for a durable resolution. Diplomacy, empathy, and a genuine commitment to lasting peace should guide every step forward.

The extension of this truce must not be merely a reprieve from violence but a catalyst for a future where the children of this region no longer live in fear, where families are not torn apart, and where hope triumphs over conflict.

# India's G20 Presidency and the Dawn of a New Multilateralism **Towards a Brighter Tomorrow**



Oday marks 365 days since India assumed the G20 Presidency. It is a moment to reflect, recommit, and rejuvenate the spirit of 'Vasudhaiva Kutumbakam, 'One Earth, One Family, One Future.'

As we undertook this responsibility last year, the global landscape grappled with multifaceted challenges: recovery from the Covid-19 pandemic, looming climate threats, financial instability, and debt distress in developing nations, all amid declining multilateralism. In the midst of conflicts and competition, development cooperation suffered, impeding progress.

Assuming the G20 Chair, India sought to offer the world an alternative to status quo, a shift from a GDP-centric to human-centric progress. India aimed to remind the world of what unites us, rather than what divides us. Finally, the global conversation had to evolve - the interests of the few had to give way to the aspirations of the many. This required a fundamental reform of multilateralism as we knew it.

Inclusive, ambitious, action- oriented, and decisive these four words defined our approach as G20 president, and the New Delhi Leaders' Declaration (NDLD), unanimously adopted by all G20 members, is testimony to our commitment to deliver on these principles.

Inclusivity has been at the heart of our presidency. The inclusion of the African Union (AU) as a permanent member of the G20 integrated 55 African nations into the forum, expanding it to encompass 80% of the global population. This proactive stance has fostered a more comprehensive dialogue on global challenges and opportunities.

The first-of-its-kind 'Voice of the Global South Summit,' convened by India in two editions. heralded a new dawn of multilateralism. India mainstreamed the Global South's concerns in international discourse and has ushered in an era where developing countries take their rightful place in shaping the global narrative. Inclusivity also infused India's domestic approach to G20, making it a People's Presidency that befits that world's largest democracy. Through "Jan Bhagidari" (people's participation) events, G20 reached 1.4 billion citizens, involving all states and Union Territories (UTs) as partners. And on substantive elements. India ensured that international attention was directed to broader developmental aims, aligning with G20's mandate.

2030 Agenda, India delivered the G20 2023 Action Plan to Accelerate Progress on the Sustainable Development Goals (SDGs), taking a cross-cutting, action-oriented approach to interconnected issues, including health, education, gender equality and environmental sustainability.

A key area driving this progress is robust Digital Public Infrastructure (DPI). Here, India was decisive in its recommendations, having witnessed the revolutionary impact of digital innovations like Aadhaar, UPI, and Digilocker first-hand. Through G20, we successfully completed the Digital

Public Infrastructure Repository, a significant stride in global technological collaboration. This repository, featuring over 50 DPIs from 16 countries, will help the Global South build, adopt, and scale DPI to unlock the power of inclusive growth.

For our One Earth, we introduced ambitious and inclusive aims to create urgent, lasting, and equitable change. The Declaration's 'Green Development Pact' addresses the challenges of choosing between combating hunger and protecting the planet, by outlining a comprehensive roadmap where employment and ecosystems are rity Council, that will ensure a more equitable global order.

Gender equality took centre stage in the Declaration, culminating in the formation of a dedicated Working Group on the Empowerment of Women next year. India's Women's Reservation Bill 2023, reserving one-third of India's Parliament and state legislative assembly seats for women epitomizes our commitment to womenled development.

The New Delhi Declaration embodies a renewed spirit of collaboration across these key priorities, focusing on policy coherence, reliable trade, and ambitious cli-



complimentary, consumption is climate conscious, and production is planet-friendly. In tandem, the G20 Declaration calls for an ambitious tripling of global renewable energy capacity by 2030. Coupled with the establishment of the Global Biofuels Alliance and a concerted push for Green Hydrogen, the G20's ambitions to build a cleaner, greener world is undeniable. This has always been India's ethos, and through Lifestyles for Sustainable Development (LiFE), the world can benefit from our age-old sustainable traditions.

Further, the Declaration underscores our commitment to climate justice and equity, urging substanmate action. It is a matter of pride that during our Presidency, G20 achieved 87 outcomes and 118 adopted documents, a marked rise from the past.

During our G20 Presidency, India led deliberations on geopolitical issues and their impact on economic growth and development. Terrorism and the senseless killing of civilians is unacceptable, and we must address it with a policy of zero-tolerance. We must embody humanitarianism over hostility and reiterate that this is not an era of war.

### Not above board

B oards of companies should be fiercely independent and must have the power to fire a CEO whose actions are not in alignment with the best governance practices. In that sense, the OpenAI board consisting of reputed scientists and technology entrepreneurs has made full use of its freedom by getting rid of a star CEO who they felt was no longer fit to lead the company effectively. The official position highlighted Sam Altman's "lack of consistent transparency in communications with the board of directors", implying a trust deficit. The board, of course, hastened to add that the firing was not the result of "malfeasance or anything related to our financial, business, safety, or security/privacy practices". Prima facie, it seemed that the board did what it was empowered to do.

The problem, however, is that the Open AI board perhaps forgot that freedom brings with it certain responsibilities. And this is where it slipped, big time. For example, it kept an important shareholder of the company in the dark about its decision to fire the CEO. No board, however independent it may be, can treat so casually a shareholder with 49% stake in OpenAI and who has put \$13 billion into the company. Besides, Microsoft, the shareholder, is also the exclusive provider of computing power for OpenAI's research, products, and programming interfaces for developers. No one seems to know why the board chose to be so secretive, raising doubts over its actual motive. The CEO himself reportedly was informed about his firing just hours before the public announcement was made.

This is certainly not how a company should treat a founder-CEO who last month announced Open AI's accomplishments under his stewardship: two million customers, including "over 92% of Fortune 500 companies." Under Altman, OpenAI leapfrogged rivals like Google and Amazon in certain categories of cloud computing, reinvigorated its Bing search engine, and put the company in the leading position in the hottest software category. The board perhaps was not in sync with the CEO's rapid expansion plans, and maybe even found it dangerous. Whatever the reason, the fact is that the board should have initiated a discussion with the CEO and Microsoft about its concerns. And the least it could have done is to set up a seamless transition process.

The COVID-19 pandemic has drastically altered the perception to the extent that companies globally are willing to extend the 'work from home' concept, and this 'new normal' has become the 'accepted normal' ever since the outbreak of Coronavirus. When employees work from home, companies benefit on costs in terms of rent, water, electricity and fuel allowances. Work stations worldwide are generally crowded. There may be a situation of an asymptomatic employee who could potentially infect the whole office, and hence it is better to err on the side of caution.

Though it is a real challenge to work remotely, it also gives an opportunity for one to acquire and hone many new skills like planning, forward-thinking, coordination in times of distress, and so on. Also talking to friends and relatives can be helpful as they may give some insights into how you can reduce your stress during the pandemic days.

# **BOOKER PRIZE 2023:** What Paul Lynch's Win Means And Why We're In A 'Golden Age' Of Irish Writing

rish author Paul Lynch won the 2023 Booker Prize for the dystopian novel Prophet Song. But he wasn't the only writer from Ireland nominated. Paul Murray (The Bee Sting) was also on the shortlist and, on the long list of 13 novels, Elaine Feeney's How to Build a Boat and Sebastian Barry's Old God's Time made the cut.

While Barry and Murray have previously been listed for the Booker Prize, Lynch and Feeney are new additions to the catalogue of Irish Booker Prize nominees which includes Claire Keegan, Anne Enright, and Colm Tóibín. Both Murray and Lynch are part of what Barry, an Irish Laureate for Fiction, calls a "golden age" of Irish writing. Irish writers have benefited from structural factors in recent years, including a strong Arts Council, legislation which since 1969 has exempted artists from income tax, an artist's three-year basic wage pilot and the sheer proliferation of excellent literary journals at the moment.

Irish writers have been overrepresented on other prize lists, too, with three Irish writers winning the Sunday Times Audible short story award in the last few years.

However, ask them in person and Irish writers are more likely to highlight impediments to producing work. The housing crisis has been taken up by former Booker Prize long-listee Sally Rooney, for example. The closure of arts spaces in Dublin given over to short-time lets is also a common cause for concern.

The nominated novels Murray's The Bee Sting is a tragicomedy of epic proportions. Clocking in at 656 pages, it follows the Barneses – mother, father, 17-year-old daughter and 12-year-old son – as the aftermath of the 2008



financial crisis places unbearable strain on an already tense family dynamic. Lynch's slimmer offering, Prophet Song, takes place in a dystopian Ireland hurtling towards authoritarianism. It is both recognisable and unknown – Ireland, but "under some foreign sky". Its main character is a stalwart of Irish literature: a mother and wife named Eilish. Her attempts to protect her family in a world not of her making is resonant back through the canon while taking on a new and eerie prescience in Lynch's portrait of an Irish police state.

The Bee Sting and Prophet Song deal with one of the abiding themes of Irish literature – the trickiness of memory, both personal and collective. This literary preoccupation with the past has sometimes come under fire. In 2001, Irish Times journalist Fintan O'Toole alleged that Irish writers were struggling to analyse the times in which they were living, instead reverting to old tropes and themes and depicting an Ireland that "most competent writers can do [...] with their eyes closed". Both Murray and Lynch seem to speak directly to O'Toole's concern. In one instance in Prophet Song, Eilish muses: "All your life you've been asleep, all of us sleeping and now the great waking begins."

Indeed, both novels deal with wake-up calls. Murray revisits the financial crash – a moment in recent Irish history whose trauma remains, it could be argued, partially suppressed. Meanwhile, Lynch takes aim at Irish political "stability" and complacency. In Murray's depictions of personal, buried histories and in Lynch's concern with the vulnerability of consensus and humanity, these novels reflect how we can simultaneously know so much and so little of the people and

places closest to us.

Both writers masterfully reveal the strangeness of familiarity and the familiarity of strangeness. They both question the extent to which we know the depths of our own capabilities, for good and for bad, and sketch the intersection of existential crises with normal, individual lives.

Writing in The Stinging Fly magazine, Stephen Cox wryly notes that Murray's back catalogue could be summarised as "We Don't Know Ourselves" à la Fintan O'Toole's 2021 memoir of the same title.

It has historically been the job of Irish writers to reflect the worst elements of their society back at itself. In Prophet Song and The Bee Sting, Lynch and Murray are continuing this tradition. Ireland should pay attention.

### J&K Attains Feat, Crosses 75% **Coverage Of Rural Households**

Also Ranks 3rd In Quality Monitoring At National Level

SRINAGAR: In an effort to achieve 100 percent saturation of rural areas in tap water connectivity in J&K, 14.03 lakh (75%) out of 18.69 lakh rural households have so far been covered under Tap Water Connections by the J&K Jal Jeevan Mission (JJM).

The Mission has been working overnight to achieve the targets and so far out of 6596 work components, more than 5600 components (85%) like Tube wells, Bore Wells, Rapid Sand Filtration Plants, Over Head Tanks, Ground Service Reservoirs and pipe networks have started with completion of 1376 works as on date.

Similarly, more than 3000 schemes are under execution across all the districts of the UT with involvement of about 1700 contractors executing the works which has resulted in massive employment generation in rural areas. At least 350 Water Supply Schemes have been completed as on date.

Under Water Quality Monitoring & Surveillance, during the current fiscal, about 1.75 lakh tests have been conducted through 98 Water Testing laboratories set up all across the UT to ensure the constant maintenance of quality of the water

being supplied to the general public. Further, about 7500 Field Testing Kits (FTKs) have been

distributed among 6630 Panchayat Pani Samitis and more than 33000 Women have been trained for use of FTKs in checking the quality of water and reporting the results online through WQMIS Portal.

The Mission has conducted massive public outreach and awareness campaigns across J&K during this year which includes capacity building sessions, debates, painting competitions at schools, holding of special Gram Sabhas, distribution of field kits etc.

JJM, it may be mentioned, is a flagship programme of national importance aimed to provide each and every rural household with Functional Household Tap Connection (FHTC) within the premises, capable of supplying water at a minimum service level of 55 liters per capita per day and quality conforming to BIS 10500.

At an estimated cost of Rs. 13000 crore, the programme involves creation of a sustainable water infrastructure and to build the capacities of the local communities and involve them in the management of the water supply assets on a long term and sustainable basis.

### **Govt Appoints DCs, ADDCs To Look After ULBs**

SRINAGAR: In a significant development, the administration of Jammu & Kashmir Union Territory on Wednesday appointed deputy commissioners (DCs) and additional district development commissioners (ADDCs) as administrators of the urban local bodies, as the five-year term of elected representatives of these bodies came to an end.

The Housing & Urban Development Department (H&UDD) today appointed DCs and AD-DCs as administrators of 71 municipal councils and municipal committees in the UT. While respective DCs have

been appointed as administrators of municipal councils, the respective ADDCs would look after the administrative and financial functioning of municipal committees.

According to a notification issued by the H&UDD, DCs have been appointed as administrators of 17 municipal councils, while ADDCs of 54 municipal committees.

As per the notification, they have been appointed as administrators for a period not exceeding six months or until the municipality is established, whichever is earlier.

The administrators have been appointed due to delay in holding municipal elections. The terms of elected representatives of almost all municipal bodies in J&K have come to end.

With the end of their tenure, the mayors, presidents, vicepresidents, corporators/ councilors of urban local bodies are no longer entitled to perks, privileges and honorarium–(KNO)

### **Div Com Asks PDD To Keep Strict Vigil On Power Theft**

'Discourage People From Using Crude Electric Devices'

SRINAGAR: Divisional Commissioner Kashmir, Vijay Kumar Bidhuri on Wednesday ordered power development department (PDD) to strictly adhere to the power curtailment schedule and keep strict vigil on power theft.

He passed these directions in a review meeting with Deputy Commissioners, here on Wednesday, an official spokesperson said. Bidhuri reviewed the current power scenario in the valley and availability of electricity to consumers in all districts.

"He directed concerned officers to strictly adhere to the power curtailment schedule to avoid any crisis. Div Com enjoined concerned officers of PDD to keep strict vigil on power theft and discourage people from using crude electric devices," the spokesperson said.

In view of inclement weather, he said, the Div Com reviewed the exigency plan of KPDCL for restoration of electricity in case of heavy snowfall. Bidhuri, he said, also reviewed the buffer stock of transformers, electric poles and functionality of

workshops. According to the spokesperson, Div Com said that with the procurement of additional electricity, the overall scenario of power in the valley will im-

prove significantly. Besides, he also chaired a meeting to deliberate over revision of market value guidelines & rules and revision of rate for upcoming calendar year.

Earlier, Bidhuri said that the ongoing campaign of Viksit Bharat Sankalap Yatra in the panchayats promises transformation of rural lives.

He maintained that mobilization of the general public to encourage them to participate in the Viksit Bharat Sankalap Yatra to familiarize them with the welfare schemes of the government is the moot objective of the ongoing campaign.

SRINAGAR: Families of the seven agricultural university students arrested under UAPA for allegedly raising objectionable slogans after the Indian cricket team's loss in the World Cup final on Wednesday appealed to police and Jammu and Kashmir administration for leniency as their career was at stake.
