Centre Steps In To Resolve Power Crisis In J&K

Allocates 293 MW Power To PDD To Meet Winter Demand

Srinagar: The government of India has stepped in to diffuse the electricity crisis in Jammu and Kashmir by increasing power allocation to the Union Territory by about 293 MW, by transferring electricity from distant power houses in West

Bengal, Bihar and even Bhutan. Regarding new power allocations made on Thursday by centre, a spokesperson for the Jammu

& Kashmir Power Development Department (JKPDD), said that J&K being primarily dependent on hydroelectric power, faces significant fall in generation during winters due to low water level in rivers and therefore, around 85% of power supply during winters is sourced from thermal plants to compensate for the deficit during winters.



Election Uncertainty

ith no signs of restoration of statehood in sight, the political parties in Jammu and Kashmir have been demanding an Assembly election. April Party president Syed Mohammad Altaf Bukhari in a statement on Tuesday has sought holding of state polls without delay. While expressing his readiness to fight polls, Bukhari said the core agenda of his party is to ensure statehood is returned to J&K. Earlier, J&K parties were sore when the government celebrated the Union Territory Day on October 31 with some pomp and show. The National Conference leader Omar Abdullah had said that the celebration was akin to rubbing salt into our wounds. He also challenged the Centre to conduct elections to see the "sankalp (resolve)" of the people of J&K.

But it is true that Assembly elections in J&K are unlikely to be held in the near future. It will be safe to presume now that there is no chance of elections until general elections being held in May next year. And it will depend on the priorities of the successor national government whether polls in J&K are held immediately after that or not. State polls could in all likelihood be further delayed should the BJP return to power, which it is favourite to do.

The pending verdict on Article 370 in the Supreme Court will also be a decisive factor. Whatever be the verdict of the Supreme Court, it could pave the way for, at least, the Assembly elections in J&K. But when? No one is sure about the timing. More so, when general elections are just six months away. During the hearings of the Article 370 case in the Supreme Court, the union government told the Supreme Court that it cannot give any exact timeframe and it would take "some time" for restoration of statehood in J&K while reiterating that the union territory status is "temporary".

But, for now, all eyes are fixed on the apex court's verdict on Article 370 which might come in the near to medium future. And that would determine J&K and Ladakh's future trajectory. In case of the SC's endorsing the withdrawal of Article 370 and the bifurcation of the former state into two union territories, the discourse will decisively shift towards Assembly elections and the subsequent grant of statehood - truncated or otherwise - as promised by the union home minister Amit Shah himself on the floor of parliament. Until then, both political parties and people of J&K have no choice but to wait.

Time for action

he next fortnight will see world leaders, industrialists, activists, and indigenous peoples converge at the 28th edition of the Conference of the Parties (COP). This annual affair is an attempt to inch ahead on getting at least 190 countries, all members of the United Nations climate framework, to act on weaning their economies off fossil fuels. The current goal is to make good on a collective commitment made by countries in Paris, in 2015, to strive to hold global temperatures to no higher than 1.5°C above pre-industrial levels by the end of the century and definitely below 2°C. Despite countries unanimously agreeing that humanity will collectively bear a huge price if these limits are breached, and nearly all major economies framing grand national plans to show how they are doing 'their bit', the science says that instead of being cut 8% annually, emissions have grown 1.2% from 2021-22. At this rate, the world will warm 2.5-3°C by the end of the century. There have already been 86 instances just this year of global temperatures breaching the dreaded 1.5°C threshold.

In the nearly three decades of COP meetings, the major economies have agreed on three broad principles. Countries that rapidly industrialised in the 20th century have disproportionately emitted more carbon than their 'fair share' given the population sustained. Economic growth premised on fossil fuel consumption, while cheaper per unit than renewable energy, spells disaster. And developing countries and those with minimal industrial infrastructure today must be compensated for adopting costlier, but cleaner, nonfossil fuel sources for growing their economies. There is also a consensus that the countries already weathering climate disasters must be compensated and also paid to bolster their infrastructure. However, getting all countries to actually act on these principles is onerous given the mutual suspicion, the spirit of de-globalisation, and the fear of political reprisal that heads of governments face within their constituencies. These themes are expected to play out this year too. Two major issues are expected to take the stage: the conclusion of the Global Stocktake and the operationalisation of the Loss and Damage Fund. However, there is no clarity on the size of the fund and the individual contributions by countries. While COPs, by nature, are self-congratulatory when all they deliver are agreements with elaborate caveats, COP28 must strive to live up to its declared goal of being a conclave that compels its signatories to take definitive action.

Electoral Déjà Vu

Defeat in the upcoming state polls may not necessarily impact the BJP's 2024 prospects, as 2019 electoral pattern points out

Losses in a majority of these states, as seems likely, could further affect the BJP's 2024 chances. But at the same time. not necessarily so. As the record of the past over nine years shows, the reverses at regional level haven't dented the BJP's national popularity. 2019 could very well play out again

In the run up to the 2019 parliamentary election, Congress put up a stiff resistance to the BJP. Towards the end of 2018, the party won Assembly elections in Chhattisgarh, Madhya Pradesh and Rajasthan. As a result, the saffron party didn't appear to be a favourite to win the general election. Most optimistic prediction was that the BJP would return with a reduced tally, forcing it to stitch together a weak coalition government, a throwback to the one run by Atal Bihari Vajpayee.from 2002-2007.

But the Pulwama attack on February 14, 2019 that killed 40 CRPF personnel changed everything. The subsequent military strike on Balakot by the Indian airforce that followed soon after followed by the dog-fight hurtled the BJP back to the centre stage. The party swept to victory in the general election held in May that year.

As India heads into five state elections, one can't help but feel a deep sense of de javu. Congress once again looks favourite to win in the majority of them except in Rajasthan. Should the results play out as expected, the BJP would once again find itself in a difficult spot, a la December 2018. But many people believe that the party could still pull it off in the national polls. And it could very well do it.

The reasons are not far to seek. Despite almost a decade in power, the party has skillfully evaded significant anti-incumbency backlash. Understanding this phenomenon could serve as a masterclass in electoral politics. True, media has played a major role in burnishing the BJP's image by zealously protecting it from all criticism, there are other factors at work. On the face of it, Hindutva, the party's ideology, seems to trump everything. It kills all political competition without even a fight. In fact, there is no alternative political ideology in the country at the moment. The opposition no longer sees secularism as an electorally beneficial proposition and would rather buy into the Hindutva narrative as it resonates with the majority of the people. Congress has been the first to abandon its ideological space. It doesn't champion secularism, nor does it dare to woo Muslims, once its loyal vote bank. The reason for this is that, under the existing circumstances, the party sees secularism as its bane. In 2018, the UPA chairperson Sonia Gandhi said that the BJP was winning the polls as it had managed to convince the people that the Congress is a Mus-

Similarly, Arvind Kejriwal once a proponent of the so called post-ideological politics in the country, has chosen to rebrand himself as a Hindu leader. In 2020, he observed Lakhsmi Puja on Diwali together with his entire Council of Ministers, with his spouse by his side. Kejriwal was also the first to support revocation of Article 370. He didn't speak against the Citizenship Amendment Act. And as the AAP, Kejriwals' party, expands its footprint and looks set to step into the position of a national opposition party, his nods to the BJP's ideological vision have become more conspicuous.

Is there now a tacit consensus on Hindutva in the country? It does appear so. And this makes the BJP even stronger as the party remains the sole authentic purveyor of the ideology. And no matter how much other parties hew closer to the BJP creed, they will always be seen as counterfeit, opportunistic copies of the original.

Another existing political reality of the country that goes to the advantage of the BJP is the extinction of the parties adhering to socialist and communist philosophies. These parties were doggedly secular in their politics and had a national vision. Other than in Kerala, where communists run the

government, they are no longer a political force anywhere else in the country. They are not even the distant opposition in West Bengal, a former communist stronghold. So, the BJP has faced little political resistance during its tenure.

The saffron party offers a deft blend of a hardcore ideology and welfare governance. It has Modi as its overarching leader. And considering its electoral machinery, it has become all-encompassing. So, it would seem that the party has nothing to fear.

But the advent of the INDIA Alliance and with it the revival of caste politics is seen as a challenge to the saffron party. The alliance represents a diverse array of regional and national parties, which have historically been rivals but have set aside their differences for a common cause: to address the pressing issues affecting the country and challenge the BJP's nationalist platform. Other than the Congress, it boasts of some major regional parties and the leaders who command massive public following. Already, the opposition's wins in Punjab, Himachal Pradesh and Karnataka have put some wind in the sails of political resistance to the BJP. And it is in this context that the upcoming state polls assume their significance. Losses in a majority of these states, as seems likely, could further affect the BJP's 2024 chances. But at the same time, not necessarily so. As the record of the past over nine years shows, the reverses at regional level haven't dented the BJP's national popularity. 2019 could very well play out again.

RECOGNIZE: The first facet of the RULER technique, "Recognize," is the foundation for emotional intelligence. It requires individuals to conscientiously acknowledge and identify their emotions. This involves a heightened self-awareness, a

deliberate effort to discern the subtle nuances of one's emotional state-whether it be joy, sadness, anger, fear, or surprise. Recognizing emotions goes beyond superficial acknowledgment; it entails delving into the intricate tapestry of feelings, understanding the triggers and contexts that give rise to each emotional response. This initial step lays the groundwork for a more profound emotional understanding, setting the stage for the subsequent components of the RULER technique. By developing the skill to recognize emotions accurately, individuals gain a crucial insight into their inner world, fostering the ability to navigate and manage their

emotional responses effectively. **UNDERSTAND:** The second step of the RULER technique is "Understand," urging individuals to delve into the intricacies of their emotions. This involves a reflective exploration into the origins and catalysts behind specific emotional responses. By questioning what triggers a particular emotion and examining its connection to past experiences or current circumstances, individuals gain profound insights into the roots of their feelings. Understanding is not just about surface-level recognition but entails a deeper, more nuanced comprehension of the emotional landscape. This step encourages a mindful examination of the context, fostering self-awareness and allowing individuals to make informed decisions about how to navigate and respond to their emotions effectively. In essence, "Understand" serves as a crucial bridge between raw emotional experiences and the thoughtful comprehension that is vital for emotional intelligence and well-being.

LABEL: The third step in the RULER technique is "Label," where individuals are encouraged to articulate and name their emotions. This seemingly straightforward act holds profound significance in emotional intelligence. By assigning a name to one's feelings, whether it be joy frustration or sadness individuals gain clarity about their emotional state. This clarity, in turn, facilitates better internal understanding and communication. When emotions are labeled, they become more tangible and manageable, allowing individuals to navigate their internal landscapes with increased self-awareness. Moreover, the act of labeling provides a foundation for effective communication with others, as it al-

lows individuals to express their emotions more precisely, fostering empathy and understanding in interpersonal relationships. In essence, the "Label" step serves as a linguistic bridge connecting the intricate realm of emotions to the conscious mind and the world beyond.

EXPRESS: The fourth element of the RULER technique is "Express." This facet encourages individuals to find constructive outlets for the articulation of their emotions. Recognizing that emotions are a fundamental aspect of the human experience, the Express component emphasizes the importance of externalizing these feelings. Whether through the written word in journaling, the creative expression found in art, or the spoken language of verbal communication, this step serves as a pivotal tool in processing and comprehending emotions. By encouraging individuals to articulate their feelings through various mediums, the Express aspect of RULER promotes selfawareness and introspection. It enables individuals to navigate the intricate terrain of their emotions, fostering a deeper understanding of their inner selves and facilitating effective communication with others. **REGULATE:** The culminating

aspect of the RULER technique, 'Regulate,' marks the pinnacle of emotional intelligence mastery. This phase underscores the imperative need to navigate and govern intense emotions effectively. It invites individuals to cultivate a repertoire of personalized strategies tailored to their emotional landscape. Whether through the practice of mindfulness, fostering a conscious awareness of the present moment, employing deep breathing techniques to restore equilibrium, or seeking support from trusted confidants, the art of regulation becomes paramount. This step transcends the mere acknowledgment and understanding of emotions, urging individuals to actively influence and modulate their emotional responses. By embracing diverse regulatory mechanisms, individuals empower themselves to pavigate the complexities of their emotional terrain, fostering resilience and equilibrium even in the face of turbulent emotional storms.

availability throughout the year. He said in today's digital era, modern tools and software enable power transfer and management in an automated manner without requiring any human intervention, depending upon the demand, availability, and of course the network feasibility.

"In this direction, during the current financial year, the UT has entered into historic Power Purchase Agreements (PPAs) for 1600 MW of Solar power, 900 MW from Hydro, and an additional 500 MW from thermal plants, currently in progress following the decision of the UT Administrative Council under the Shakti policy," he said

"This will not only lead towards resource adequacy for the region, but will also provide an optimal mix of Hydro, Thermal, Solar generation, while the efforts are underway to harness wind power as well so that the strength behind renewable energy is utilized to the maximum," he added.

Addressing concerns raised in a recent news item published in one of the local news dailies on Thursday highlighting a surge in interruptions in J&K, the spokesperson reiterated that a persistent issue contributing to these interruptions is the non-disclosure of actual electric load by consumers.

Regarding the hours of power supply to consumers, he conveyed that smart metering is under implementation in mission mode and focus is on ensuring uninterrupted and regular power supply in areas saturated with smart meters, while also curbing losses.

"In areas without smart metering, the department is sustaining the same number of power supply hours as maintained during the previous year. Moreover, there is a curtailment schedule in effect which is diligently being published to prevent any inconvenience to the public," the spokesperson said.

He further emphasized that contrary to the mention of Hammams in the news item, electricity remains the primary and preferred source for heating, with people using crude nichrome wires or non-thermostat fitted heaters which remain operational throughout the day.

Recognizing the urgency, the spokesman emphasized on discontinuing the use of obsolete and environmentally unfriendly electric heating systems. He also mentioned that numerous crude heaters which have been banned by the department were recovered by the enforcement squads of KPDCL in the recently conducted inspection drives.

"In addition to maintaining reliable power supply amidst extreme weather conditions, the Power Development Department (PDD) is proactively engaged in eradicating instances of illegal hooking. In the last seven days itself, inspection teams of KPDCL have conducted 7585 number of inspections in different districts of Kashmir region and imposed a fine of Rs.68 Lakhs on the defaulters," the spokesperson said.

have suffered productivity losses worth crores.

The unscheduled power cuts ranging from 4 to 8 hours a day have badly affected the houseboat industry in Dal Lake which is one of the iconic tourist attractions in Srinagar.

"We are tirelessly working to promote the tourism sector in order to draw more and more tourists to Kashmir, but how could a tourist stay on a houseboat in the middle of a very cold climate? Unfortunately, our objective has been severely hampered by the escalating power issues," Manzoor Pakhtoon, President Houseboat Owners Association, told Kashmir Observer.

We promise visitors with contemporary amenities, but when they arrive, they tremble from the cold and feel frightened by the complete darkness. This is what a houseboat owner has been dealing with for more than a month, he added.

Although tourists visit other wellknown tourist destinations in Kashmir in addition to Dal Lake, the HBOA president said it is challenging to figure out the exact number of visitors who visited Kashmir up until the end of this month.

The administration, he claimed, continues to boast about the growth in tourism in Kashmir, but in reality, tourists tend to shorten or postpone their trips amid worsening power crises.

Revealing the specific number of tourists may not be possible, he said, as houseboats in Srinagar's Nigeen Lake and Jhelum River also carry tourists, and guest houses also accommodate a sizable number of visitors during the high season

"I can state with authority that power outages have had a major negative influence on our clients in the houseboat sector. Since the valley started to experience power outages, there have been reports of tourists cancelling their trips to Kashmir," Pakhtoon said, adding our associate travel agents keep cancelling the scheduled trips to Kashmir citing extreme power crises.

Besides Dal Lake, Pakhtoon said, other popular tourist spots including Gulmarg, Sonmarg, and Pahalgam have also been impacted by the situation brought on by the worsening power crisis.

He, however, hoped that the electricity situation in Kashmir will improve before the two important events, Christmas and New Year's, adding that if the administration does not make coordinated efforts in this respect, the situation would worsen.

"Visitors never come alone as they are accompanied by their families, including kids. They feel better when the houseboat has all the facilities they need, such as internet, heating and entertainment. And all this is possible when there will

be a consistent power supply," he said. Farooq Ahmad Kathoo, president Travel Agents Association of Kashmir (TAAK), claimed that spontaneous power outages have had a detrimental effect on the tourism industry in the region and that the visitors who had made reservations in advance have begun to cancel their planned trips to Kashmir.

"Tourists visiting Kashmir belong to tropical areas where the occasional high is above 45 degrees Celsius, how are they going to survive the bitter cold here? Is it possible for them to endure below freezing temperatures? If there had been a sufficient supply of electricity for both commercial and domestic users, the circumstances would have been different," Kathoo told Kashmir Observer.

The government should at least learn from the past experiences, he said, since the lack of necessary facilities for customers during their stay negatively affects the business.

Speaking to Kashmir Observer, President Small Scale Industries Association of Kashmir, Fazal Illahi, said the unscheduled power cuts, ranging between two to three hours a day, have cost the unit holders crores of rupees.

It has become difficult for the unit holders to manage the 800 personnel that work at various units, according to Illahi. He said in addition to machinery break-down, unit holders also lose 20% of their earnings every hour in absence of electricity.

"Would a typical firm be able to pay its employees' wages under these conditions? When the Industrial Estate's electricity is cut off, the unit holders incur 20 percent losses per hour," he said, adding that the machinery breaks down and the production is damaged.

In addition to the problems with electricity, the increased power tariffs, Illahi claimed, has broken the back of the small-scale industrialists in Kashmir.

"We would like to know how we could increase our production and create jobs in this situation. The Industrial Estate Baghi-Ali Mardan Khan has been facing annoying power outages that last between two and three hours every day," Illahi added.

He said the administration, especially KPDCL, is duty bound to provide round the clock electricity to the industrial estate, as the 107 unit holders pay monthly electricity bills on time.

"We suffer because the Industrial Estate has seen significant losses in productivity and output as a result of the unplanned power outages. Our workers and machines break down, and we are unable to manufacture stuff as a result of the unscheduled power cuts," he added.

"Whether they are terrorists, separatists, or anti-national elements, posting such messages and videos will be a crime as per the law," Swain told reporters in

The DGP said before the law is enacted it will be placed in the public domain for feedback

He added that those forwarding and sharing such content will also face legal consequences. Swain urged people to report such content to the nearest police

"People who post videos, including those aimed to harm the respect of the Prophet (Muhammad), and those who forward it will be committing a crime,"

"We will index such people, ensuring they face disadvantages for having done such a thing," Swain said.

Highlighting the "disruptive impact" of such content, the DGP said it causes "fear" that leads to the closure of colleges and schools.

Swain said that Pakistani social media handles generate and post content that are "shared by some elements locally to create trouble and harm peace".

He said that the police would work with the people of Kashmir to "isolate such miscreants".

Says Conspiracy

conspiracy or a collusion with certain elements to further increase the circle of violence -- is something which will be a matter of investigation," Swain told

He further said, "It can be found out, the communication can be traced, discussions and meetings can be investigated -- if it has happened backdoor -- to forward it."

Swain was replying to a question about statements by various political leaders, including People's Democratic Party (PDP) chief Mehbooba Mufti.

He also spoke on the protests that erupted at NIT-Srinagar on Tuesday over a student's alleged social media post that hurt religious sentiments. The protesters demanded stringent action against the non-local student, who has since been sent home on leave.

"All I can say is that the wheels of law will operate in the sense that if the particular action has been done deliberately with the malicious intent to further a certain falsehood and (whether) that falsehood leads to loss of life, property, further violence and attacks on individual citizens, fear, terror and intimidation, the law itself makes it very clear that they will be held responsible," Swain

The Jammu and Kashmir Police chief pointed out that the correlation between statements and violence has been established in some National Investigation Agency (NIA) cases and the court accepteď it.

"I clearly remember in one of the NIA cases, the honourable judge accepted this as evidence," he said.

Referring to freedom of expression in such situations, Swain said public figures have to see whether there is truth in it when making the statements.

"There are many nuisance statements. Even if it is true, but the statements have the potential to deteriorate the situation and create an environment for violation or increase violence, there should be reasonable restraint as per law. The aim is to stop violence," he said.

He said those who make innocent remarks about a particular situation as a viewpoint are different and that will not be part of any police investigation.

Swain said, "We want to make it clear between freedom of expression and right to dissent -- statements based on falsehoods and half-truths and out of context or designed to further violence will not fall in that category. We will make a distinction with the powerful tools of investigation and intelligence

The Union Territory's police chief also appealed to the public to maintain calm and not get misled by those trying to foment trouble.


The police will also ensure respect for all religions and protect the dignity of the majority community in the Valley, Swain said on the NIT-Srinagar incident and assured action against the accused.

Court Rejects Bail To Man For Creating Fake Govt Website

SRINAGAR: A court in Srinagar on Thursday rejected the bail application of a person, accused alongwith others, of creating a fake website in the name of Health and Medical Education Department and uploading fake orders to deceive unemployed youth in J&K.

"Taking note of all the facts and high magnitude of the case and the fact that the investigation in the matter is at its initial stage, I opine, that if at all the accused is released on bail at this stage the same would frustrate the investigation as well as shake the confidence of general public in the judicial system," said Ms. Fozia Paul, City Magistrate Srinagar, while rejecting bail plea for the accused, Sajad Hussain Zargar of Hamdania Colony Bemina Srinagar.

"Keeping in view, the entire factual matrix and the material on record, the accused person at this stage is not entitled to the concession of bail and as such instant bail application is

"Undoubtedly, it is the most consequential threat to a nation's economy at large and law in particular," the court said, adding, "In the instant matter, the act of the accused person in connivance with other persons seems to be a well planned and cultivated act, which hampers the well being of a society since such crimes have the effect of alluring innocent people who fall victims into the hands of such fraudsters on the pretext of employment.

Virat Kohli's request for a break from limited-overs games too has been accepted as Suryakumar Yadav and KL Rahul will lead the national team in T20Is and ODIs respectively.

However, it is understood that Hardik Pandya is no longer an automatic choice for T20 captaincy in the T20 World Cup next year if Rohit decides to play the shortest format.

"Rohit has been offered T20 captaincy but he is in UK on a holiday and wants an extended break after four months of gruelling season till end of the World Cup. But as captain, he has the highest respect for the dressing room and if he agrees to lead India in T20 World Cup,

he will lead," a BCCI source told PTI on condition of anonymity.

After the T20 World Cup in 2022, Rohit had actually been reluctant to play the shortest format as he focused on 50-over

Interestingly, most of the players selected for ODIs don't feature either in Tests or T20Is.
