Promising Treatment Target For Heart Arrhythmias: Study

The most common cause of sudden cardiac mortality is ventricular fibrillation. Although ageing is a known risk factor for the development of cardiac arrhythmia, the mechanisms behind this link have been difficult to pinpoint, impeding progress towards the development of

specific treatments. The heartbeat is a series of regular contractions of the cardiac muscle that efficiently pumps blood

throughout the body. A highly coordinated contraction of the heart muscle cells in a painstakingly choreographed pattern is required to achieve this. When an arrhythmia develops, the heart cycle accelerates and becomes erratic, potentially resulting

in death. The CNIC researchers established a link between the development of ventricular fibrillation and the activation of two critical signalling proteins, the stress kinases p38 and p38, using animal models. The

On International Day of Persons with Disabilities

Memoirs of Specially-Abled Person

In this personal narrative essay, KO columnist jots down a remarkable journey of feat in the face of physical disability, social apathy and institutional struggles

The problem of the most important work and converse normally with people, a tunnel of infinite darkness opened before me in which I found myself lost. By the time I was three, only a few things had dawned upon me, of which, one of the most important were about my bodily challenges – my inability to walk, talk, write, eat, sit, run and transact with a hundred other activities which constitute life. My family did realise these problems but didn't make me feel different, inferior, dependent or less worthy.

The moment I managed to pass the threshold of my house and moved towards the playfield, I wasn't allowed to play - "you will hurt yourself", they'd typically reply. I would keep watching my relatives, friends and neighbours playing, playing in that playfield which then appeared to me as vast as the universe itself – Taba'el, that's what this ground situated in Chattabal is called. But playfields aren't the places where we are supposed to spend all our time - School, it was schooling which worried my parents and family the most. They were convinced that I wouldn't be able to attend school and even if I did, I wouldn't be any good in academics. What better could have been expected of someone who is dependent in multiple ways on others and who is neither able to talk nor hold things properly?

As destiny would have it, two of my elder sisters used to teach in a nearby school and it was decided that I be enrolled in the same school. I attended the school but my physical impairments hampered my learning and evolution in a number of ways. As a result I spent a good amount of time in nursery class. With the relentless efforts of my sisters, who happened to be my teachers as well, I somehow picked up the art of writing but writing with two hands. I used to write with my right hand and give it support with my left hand. My handwriting was so pathetic that it was considered almost impossible for anyone to read my papers. However, as God would have it, he compensated for my physical fragility with a good supply of mental acumen. To everybody's surprise, I topped my class when the annual exams were held.

While the journey in my school continued, I was loved, taken care of and not bullied by any of my classmates but the challenges for me in society kept growing. The moment I used to go to the market and ask for something, the shopkeeper would fail to understand my tattered words. Unwittingly, he would pass derogatory and demeaning comments. The same ordeal repeated when it came to public transport, where I had to make a lot of effort to communicate where I needed to go. The whole process was so exhausting that sometimes I wouldn't even dare to ask the bus conductor to give my remaining money back for the fear that he might bully me. This social stigmatization had deep scars on my heart and mind, many of which have still not healed. Even today, when I have secured for myself a niche of sorts, I continue to receive foul comments targeting my bodily disabilities both on social media and otherwise. God had blessed me with this maniac obsession with my studies and from very early in life. I used to take my studies extremely seriously, to the point of sacrificing everything for my academics. This saved me fortuitously from the dark and depressing comments I used to receive erstwhile while going out. There was always an element of suspicion associated with me topping the class and my relatives and friends often used to tell me that I topped only at the behest of my sisters, who used to be my teachers. Nothing could have been more disarming as the remark discredited all my hard work and ignored all my toil I used to pass through despite my ill health. All this changed in a transformative manner as I entered my 8th standard. My sisters left the school and by this time I was able to make it to my school on my own. I had this burning passion to challenge my physical boundaries and was desperate to learn cycling and despite my friends teasing me, I took upon myself the challenge and after hundreds of fouls and injuries, I drove the bicycle. This was no ordinary experience; this was no mere learning a new skill but opening new windows in my life, feeling liberated, equal to others and in a sense less and less dependent. The same year, I got myself a bicycle and used to cover a distance of almost six kilometres. All this may sound trivial and senseless to say, but this is the journey of a boy struggling to walk to somebody cycling amidst the jammed, crammed and risky roads. My mother was reluctant to my cycling to begin with, but a little bit of convincing did the job and my cycling and the passion for it continue to this day. Here lie some lessons for those who are raising children with disabilities. They need to understand that sometimes extra care and unnecessary restrictions take over the original disability. Parents need to give their children wings, not cages. It was in the 8th standard itself that few other

things happened which changed the course of my life and the mention of which is important to set the future course in context. I have earlier spoken of my speaking disability, though it has improved by now, it used to be acute and severe in my childhood to the point that very few people could understand my speech. It was in the midst of this that our school announced intra-school debate on "Water - The Elixir of Life" and against all odds I decided to participate in the debate. My reservoir of knowledge had given me enough confidence that I knew the subject well but what was challenging was to stand up and speak in front of a hundred odd students and the jury. I had this habit of speaking extempore and without the help of any notes and the habit continues to this day. I reached the stage, started in the name of God almighty. I took the audience by surprise and left them as well as myself awestruck for the next five minutes. I concluded my speech with the words "I feel tired and can't speak more". Applause pierced my ears. I could see tears rolling down some of my friends' eves who knew how difficult it was for me to speak. In the 8th standard itself I got enrolled in a tuition academy where I got to interact with students from other schools – the Biscoes, Convents and Burnhalls of the valley in particular. These schools were far more reputed and advanced than the school I was coming from. More importantly, these students were bright students of their respective institutions and this gave me an unprecedented opportunity to evaluate myself and to gauge my merit against those of some of my brightest contemporaries. If any of my friends from those days is reading this piece, he will vouch for the fact that I always outperformed others, despite my attendant health complications. This grabbed my mentors' attention and they started guiding me in extraordinary ways, providing books, recommending video lectures that helped me extend my canvas of understanding and imagination. I recall reading Devan-i-Ghalib and "The Brief History of Time " during the same days but understanding very little of these books. I appeared in a scholarship test conducted by KVEI and topped the list and this was the moment of true realisation for others that whatever I have been achieving in my school has been the result of my own efforts and not the aid and assistance of my sisters. When the time came for the annual examination, which used to be conducted by DIET, I happened to top the complex in which were stationed students from no less than ten schools. This not only fuelled my confidence but assured me of my abilities to do the impossible. Yet, my academic excellence had no telling upon how people treated me outside school, in markets, buses, shops and other places - theirs was a typical derogatory attitude peppered by senseless comments and irresponsible remarks. Rarely do people realise that their words can ruin somebody forever and what is a joke to them is the question of life and death for others.

selfless guidance and brotherly care honed my literary skills and I started making intermittent ventures into literature, now writing a ghazal, then a Nazam and then something else.

I kept scaling my academics and now comes my matriculation, the class where all eyes were fixed and given my previous performance, more eyes were looking at me and expecting something big. But to achieve that big, I needed a little legal favour from the Board of School Education. I approached the authorities, requested them to give me an extra half an hour, as was enshrined in the law. I explained to them that I can't take the help of a scribe as it is impossible for me to dictate. The hardships I faced to convince the authorities and the amount of time it took is beyond expression and even today as I write these lines, the experience brings deep sadness and melancholy received during this time deserves a mention that all my teachers – Mr. Muneer Alam in particular made me realise that my bodily limitations don't make me inferior to anyone; instead my mental gifts placed me beyond others. The classmates, friends and acquaintances were empathetic and I had to face not an iota of insult or bullying from any of my batch-mates.

But this has not been everyone's experience, many persons with disabilities I talk to report bullying from their batch mates and fellow students and this is so ruining that it can push someone into perpetual desperation and depression. Having spoken so much about my personal experiences, I leave out my experiences in my professional life for some future occasion, but here I would live to divert your attention to a few important aspects of the issues.

The challenge of restoring a life of dignity to persons with disabilities - the dignity I have myself been struggling for and of which I have spoken above, has to have at least a bilateral approach - ethical and legal. It seems almost a universal preconception and a deep rooted human bias that persons with disabilities aren't full humans and are, in one way or the other inferior to able bodied persons. This bias seems to be rooted in the notion that individuals are to be evaluated in terms of their delivering capacities and their potential to "contribute". Our civilizations, both Eastern and Western have made the delivering capacity of an individual the sore measure and criteria of his/her worth, dignity and right to live. The mechanised, rather technological society which we have found ourselves in has drawn a dictum on the stone that only those are entitled to a life of dignity who can be active agents of material generation, who can generate wealth and material resources, who aren't meek to rely on others' helping hand, but who, personifying power and strength can mould the world and tailor it to their needs, thereby proving themselves to be "fruitful individuals for the society"

This perspective of understanding people in terms of their utilitarian merit has not only overshadowed the concept of humanity as such, but exposed people with disabilities to vulnerabilities and discriminations of all sorts. It is extremely difficult for people, who are otherwise able-bodied, to understand the problems of and empathize with people with disabilities, for the psycho-social dimensions of these problems are so broad that only people with disabilities face them first hand and are rattled and broken by the same. The challenges which people with disabilities face are augmented and multiplied by discouraging social framework, lack of logistical support and prevalence of social

This was also the time that I came under the influence of Rouf Rahat and Saleem Salik, now well known names in our literary landscape, whose nee bringe deep eddieee did meranenery.

We were stationed at the board – almost 36 of us, specially-abled students who faced one problem or the other. But the people who were supervising us were so unkind and rough that the trauma they inflicted during that exam session continued for a long time – and the irony wasn't lost on me that they claimed to be specially trained in dealing with persons with disabilities.

This is the general complaint and the maltreatment and misbehaviour against persons with disabilities continues unabated, something which our society deeply needs to reflect upon.

With the fear of making this narration unnecessarily long, suffice to say that after passing my matriculation in the first division, I joined a nearby higher secondary – the much hailed SP Higher Secondary and my teachers were so caring and affectionate that their confidence which they confided in me helped me to good. The private tuition I

> I reached the stage, started in the name of God almighty. I took the audience by surprise and left them as well as myself awestruck for the next five minutes. I concluded my speech with the words "I feel tired and can't speak more". Applause pierced my ears. I could see tears rolling down some of my friends' eyes who knew how difficult it was for me to speak

mores that deteriorate and aggravate their situation further.

This economization of values and the sheer determination of people's worth in terms of their ability to contribute to the economic produce has had detrimental consequences to the reception of persons with disabilities, hampering their claims to equality and a life of dignity. A basic revision of outlook is needed on this front and people are to be respected on the pure grounds of sanctity and dignity of life irrespective of their economic outcomes and their abilities to contribute to the society in general. These insights stem from my first hand observation - as somebody suffering from cerebral palsy, life has been like an uphill task and despite securing for myself a niche in academic and social circles based purely on hard work and determination, a life of dignity is nowhere in sight. On a daily basis, I have to witness the occasions of maltreatment and marginalisation, whereby people, who are unable to understand my words, go on passing vulgar and demoralising remarks. I often contemplate the plight of those, who are still lesser privileged, have no space to vent the maltreatment and lack of courtesy meted out to them. The psychological repercussions of such happenings are so destructive that it takes a long time for a victim to recover from these episodes and sometimes the victim doesn't recover at all. If the academic excellence, fighting against all odds to secure for oneself a place of recognition doesn't help a person to secure for himself/herself a life of general social dignity, one is left wondering, what else needs to be done to secure one's right to life of dignity and respect - something which is so basic and inviolable a right that it should require no qualifications. When people with disabilities are disrespected, maltreated and given a realisation that they don't belong to the normal lot, the detrimental consequences can well be figured out and these consequences corner people with disabilities into helplessness, insecurity, depression and a feeling of pervasive meaninglessness of life.

Making Disability-friendly Provisions, Disabled-friendly

A while back, the government issued an order related to the specially-abled persons to get their document of disability re-verified. The purpose of this order was to expose the corrupt elements. Basically, there was a large proportion of people who had registered themselves as persons with disabilities when in reality they were physically fit and healthy.

On one hand, it was a good initiative to expose those masquerading as persons with disabilities. On the other hand, it was the beginning of a hectic process for those suffering from the slings and arrows of damaged body parts. They were made to wander from pillar to post to get their documents verified like Unique Disability Identity card (UDID), which a person could get only at certain places; a document to be verified at the concerned Bank authorities; an affidavit from a first class magistrate; and an e-ticket from food and civil supplies department - and the list is endless.

Another major problem faced by them was that they could not send anyone to help them out; they had to do it themselves. The burden of the biometric lay on their head much like everything else. They had to visit each department multiple times to get their documents verified. The time-gap between the appointments (visits) was in itself frustrating. For example, to get a UDID card, specially-abled persons had to first visit the concerned department to get the appointment. Almost a week or two later, they were again supposed to visit it to get their biometric done. The third time, they had to visit the local computer operator to get it downloaded or printed out. Similarly, they were to get an e-ticket from the food and civil supplies department. They had to submit the documents on the first visit and almost ten to fifteen days later, the e-ticket was issued in their favour.

The sufferings of specially-abled people did not end here. Not only



did they have to wait for about half a month to get the documents verified but they also had to navigate their way through the buildings of these institutions or departments which were not disability-friendly. This, despite recent legislations like Rights of Persons with Disabilities Act, 2016 and recent campaigns like the Accessible India Campaign. With no disability-friendly infrastructure in place, persons with disabilities had to struggle to get to different floors of government offices and THE SUFFERINGS OF SPECIALLY-ABLED PEOPLE DID NOT END HERE. Not only did they have to wait for about half a month to get the documents verified but they also had to navigate their way through the buildings of these institutions or departments which were not disability-friendly

had to rely on the help of people to physically lift them to various chambers for documentation. After completing the formalities of reverification documentation, their ordeal was far from over. They had to again rely on other people waiting in line to get them downstairs as well. They were left to the goodwill of onlookers who may or may not have helped them. The whole ordeal accentuated their sufferings instead of making anything more accessible and easy for them. The entire process of making the world more democratic and accessible fell flat as they were reminded of their disability again and made to suffer because of it despite the fact that it was the infrastructure's disability in the first place and not theirs. The government needs to ensure that no one is left behind.

It is not only the fault of those various institutions, but the state too is responsible. Changing the name of disability to specially-abled is not enough. Delivering speeches on disability day won't improve their condition. No doubt the state took this step to bring transparency and allow the real beneficiaries to avail benefit. But the manner of its implementation was not disabledfriendly.

It is the collective responsibility of society to not let them feel that they have any disability. The state must restructure the pattern of their buildings, shifting the main office to the ground floor or making special arrangements so that the speciallyabled person will not suffer to get their work done. The state may also provide an increment in their pension. The criteria to avail various documents must be made simple and easy. Their work must be given a top priority to avoid frequent visits. A separate department apart from the social welfare department must be there that would have a link with all the concerned institutions or departments, so that speciallyabled people need not visit various departments to get their work completed. No doubt there are numerous NGOs who tirelessly work for improving the standard of specially-abled persons. Still, there are deficiencies and loopholes about their policies – and it requires immediate attention.

PEOPLE WITH DISABILITIES

Perception, Policies And Possibilities

There are two perspectives, two paradigms and two incidents to reckon with and to take account of before venturing into the heart of this article. The books of Hadith and Seerah report thus that once while the Prophet (PBUH) was delivering a sermon to his assembly of companions, he was hinted at by a woman who was well known to be suffering from mental ailments. The Prophet (PBUH) left his pulpit and went down to the old woman who kept commuting to the Prophet (PBUH) and kept telling him I want to tell you something there, and then there and then there, till they covered a good distance and the women left bursting in laughter. On seeing the entire scene, Hazrat Umar (RA), went to Prophet (PBUH) and said "Our master did we not tell you not to pay any heed to this mad woman", to which Prophet (PBUH) replied "Umar, if I don't listen to him who else will". This is the Prophetic exemplar of approaching people, who are otherwise intellectually incapable, which is expected of any Muslim and for that matter any individual, irrespective of religious denomination, who has any claims to civility, mannerism and adherence to minimal set of human values. Now let's look at another precedent and stream of behaviour which is spreading like wildfire on social media these days and that is people, who otherwise claim to be sane are seen posting disturbing (and in their opinion entertaining visuals) of people with mental ailments, we as audience (Necessarily not all) derive sadistic pleasure from these disturbing, heartwrenching and inhuman visuals. Though the two contrary models of behaviour and approach have been cited vis a vis people with mental health issues, but it applies to and defines the entire range of behaviour people usually adopt towards the spectrum of people with disabilities,



be the disability physical or mental – now fashionably called special ability, without any effect on ground realities.

Some three thousand odd years ago, Plato committed it to writing that he wanted his utopian state purged of people with disabilities, for they don't fulfil utilitarian and productive ends of a state. Three thousand years later, we had a frail and meek and disabled body housing the mind of one of the most celebrated intellectuals of all times, Stephen Hawking, not only proving Plato wrong, but turning him on his head. The three millennia that separate us from Plato also saw a host of people from different walks of life, who were otherwise disabled in one way or the other, but made permanent and immense contributions to society and civilization. The necessity to draw attention to the "contributions" of people with disabilities, because our civilizations, both Eastern and Western have made the delivering capacity of an individual as the sore measure and criteria of his/ her worth, dignity and right to live. The mechanised, rather technological

society which we have found ourselves in has drawn a dictum on the stone that only those are entitled to a life of dignity who can be active agents of material generation, who can generate wealth and material resources, who aren't meek to rely on others' helping hand, but who, personifying power and strength can mould the world and tailor it to their needs, thereby proving themselves to be "fruitful individuals for the society".

To begin with, social construction and perception of people with disabilities is so ill fashioned and misconstrued that at the very outset people with disabilities are seen in the frame of reference of "Other" and such a strict impermeable line of distinction is drawn between able bodied persons and people with disabilities that no room of coexistence or mutual celebration and adoration is left open. Instead, people are divided into two boxes whereby people with disabilities/special abilities are left helpless at the receiving end of stereotyping, bullying, marginalization and social injustice. How do these recurrent episodes of bullying, namecalling and discrimination engender and erode the mental health of people with disabilities goes without saying. Then accompanying this discouraging and debilitating social construction and social perception of people with realities comes the role of structural/government policies in addressing issues specific to people with disabilities and their failure to achieve the same. It starts with the stark absence of a comprehensive policy about people with disabilities which could have guaranteed and restored to them a life of dignity and included them in the holistic participation of society. Policies, even if they are in place, are inefficient and do not attend properly to the needs and necessities of persons with disabilities. Institutes supposed to mitigate the problems of and refine the social identity they could celebrate and organically assimilate are either dysfunctional or have fallen into oblivion of turning people with disabilities into dependable creatures, instead of restoring to them their degrees of mental and physical freedom. Our schools, colleges, universities and other educational institutions, which should have instilled in students the

spirit of empathy and etiquettes of proper behaviour towards people with disabilities, are seen themselves promulgating and legitimizing discrimination against people with disabilities in more than one ways. What all this amounts to is the culmination and accumulation of difficulties and blockades for people with disabilities, their exclusion from social structure on the whole and an environment of injustice and exploitation of these people.

Having underscored some of the reasons and thereby the implicit solutions to mitigate and address the problems confronted by people with disabilities, let it also be noted that the religion of Islam is very particular and scrupulous in defending and advocating the rights and dignity of people with disabilities and vehemently discourages the attitude of stereotyping and Otherisation of people with disabilities. There are various eschatological and theological explanations as to why God creates people who suffer because of their bodily and mental limitations, but that's not the subject of debate of this article. What this whole line of argument, as has been followed in this article precipitates at is that people with disabilities, like able bodied persons command an intrinsic life of dignity, honour, participation and inclusion. To leave them out of the social fabric or enclose them in hard drawn social boundaries amounts to decapitating limbs from human body and as Sa'adi said "Humanity is a body of which individuals are parts". It is only is recognising the specific role played by a specific part that the dignity of humanity can be restored and reclaimed.

Sharing details, he said, rampant hooking of lines on bare conductors in metered areas and exceeding energy use beyond agreed load by flat-rated consumers across Kashmir Division.

"During inspection overdrive, penalies of Rs.1.03 crore was imposed on consumers found involved in power theft across all 6 O&M Circles in last 10 days of November. As many as 995 connections were regularised and 2120 KW load added," he added.

Crediting KPDCL patrolling teams for moving out in sub-zero temperature to expose power pilferage, the spokesman shared details of 11,238 consumers disconnected in the last 10 days of November, who had pending energy dues exceeding three months. This included 7,828 domestic, 2,979 commercial and 346 industrial consumers.

He assured the consumers of strict adherence to power curtailment schedule following additional allocation of power to UT of Jammu & Kashmir by the Central Government. "We need to clarify that taking over the possession need not be taking over actual physical possession and it would suffice, if acquiring authority or indenting department formally takes over the possession evidenced by record and some activity thereon is undertaken," the court had said, adding, "The possession of land losers even after payment and tendering of 80% of the estimated compensation and formal take over by the acquiring authority/indenting department shall be treated as trespassers."

However, the applicability of Section 11-B of the 1990 Act, the court had said, shall not stand excluded by mere resort to Section 17 of the 1990 Act unless the procedure provided therein and prerequisites contained in Section 17-A were scrupulously complied with.

"In the instant case, we have found that Section 11-B of the 1990 Act is attracted in view of the failure of the Collector to strictly comply with the provisions of Section 17-A," the court had said, adding, "We have found no evidence on record as to the assessment of estimated compensation and its tendering and payment to the persons interested and entitled thereto. Ordinarily, we could have declared the proceedings as having lapsed, however, being guided by the judgment of Supreme Court in Delhi Airtech Services Pvt. Ltd..... we also deem it appropriate to mould the relief and instead of holding the acquisition proceedings as having lapsed, we direct the respondents (authorities) that the final award dated 11th August, 2020 insofar as it pertains to the petitioners is set aside."

Also it had held that the Collector Land Acquisition, Budgam shall pass fresh award qua the petitioners only and for that purpose shall construe 11th August, 2020 (date of final award) as the relevant date for determination of market value but shall apply the yardsticks for assessment of compensation provided under the

He also warned to file FIRs against those persons who physically assault KPDCL staff for performing official duties.

Emphasizing judicious use of power, KPDCL spokesperson also warned consumers to avoid hooking, bypassing of meters and exceeding overload, failing which KPDCL will file criminal charges under relevant provisions of the Electricity Act.

The spokesman also warned commercial consumers including hotels, malls and other business outlets, who have been found involved in tampering with meters and have been caught red-handed by the Central Inspection Squad of KPDCL.

"We have taken cognizance under law and penalised them. These penalties for power theft have been confirmed by the First Appellate Authority under Sections 126 & 127 of the Electricity Act. KPDCL will ensure the fines are deposited, otherwise we will act tough and initiate legal proceedings against them," he said, adding the lists of all such defaulters is lying with KPDCL and will be made public soon.

Confirming positive outcomes of accelerated inspection and disconnection drives, the spokesman said such drives aimed at preventing energy losses and enhancing revenue collection from defaulting consumers, will continue.

"There have been many positive takeaways from such drives. This will help us in adhering to power curtailment schedule and extending comfort to the genuine consumers," he said.

In an attempt to combat largescale power pilferage and improve bill deposits by defaulting consumers, KPDCL, the spokesperson said, conducted a whopping 10,465 inspections and disconnected over 11,000 consumers in the last 10 days of November 2023.

The corporation, he said, also realized revenue of Rs.85.24 crore, including power receipts, in the same

an offer to sell their land measuring 51 marlas (2.5 kanal) at Birpur for Rs 51 lakh on the pretext that the land was coming under acquisition.

They allegedly told Manmohan Singh that if he paid each brother Rs 17 lakh, he would be authorised to receive the compensation amount at the end of the acquisition proceedings.

JAMMU: The BJP and the Election Commission are equally responsible for the delay in holding assembly polls in Jammu and Kashmir, National Conference vice Omar Abdullah president said on Saturday, alleging that the Centre does not want democracy to flourish in the Union territory.

He defended the party's India-Pakistan stand on dialogue but said the onus also lies on Islamabad for creating an atmosphere conducive for the start of parleys.

"As long as the Election Commission is concerned, we are repeatedly asking for reasons why (assembly) elections are not taking place. Some months back, the chief election commissioner himself said there is a vacuum in J-K and that needs to be filled. Mostly they say they need to discuss the situation with the home ministry and the J-K government.

"If the Election Commission is not holding the polls that means it is not getting the approval and if that is the case, it means the BJP is not willing to hold the elections in J-K. We are holding both the BJP and the Election Commission guilty as they have responsibility to

hold the elections here," the former chief minister told reporters after addressing a public rally at Nowshera in Rajouri district. Asked about his party's stand

on talks with Pakistan, he said, "We have not asked for the talks but it was BJP's tallest leader (and former prime minister) A B Vajpayee who asked for maintaining friendship with Pakistan by saying that 'you can change friends, not neighbours'." Abdullah said he has always said that the onus for resumption of dialogue between the two countries lies with both of them. "Pakistan has to address our concerns for creating an atmosphere for the dialogue. What is wrong in saying this? We are not going for a sell-out." He said his party is repeating only what Vajpayee had said. "We are talking about democracy, humanity and Kashmiriyat. When we talk about democracy, we are repeating what Vajpayee left as inheritance with us. I don't see any wrong in repeating Earlier, addressing the public meeting, the NC leader alleged that democracy is being muzzled in Jammu and Kashmir.

"This is for the first time that I am seeing a government at the Centre which does not democracy to flourish want

in J-K..." he said, adding that this government does not want the people to exercise their franchise and form a government of their choice.

He said Jammu and Kashmir assembly was over in 2018 and 2023 is also at its fag end but "democracy is nowhere to be seen" and added that much talked about grassroot democratic institutions like the panchayats and urban bodies have either finishing their tenure or completing by next month.

Highlighting the role of the NC, Abdullah said the party has always favoured flourishing of democratic institutions even at a time when Pakistan-sponsored terrorists were making all out attempts to finish the party by targeting its cadre.

"What is our fault that we did not fell for your slogans, not got divided on the name religion, kept alive the chants of 'Hindu-Muslim-Sikh' unity and did not allow the hatred to take its roots," he said, adding "our fault is that we believe that India is strong as long as different communities are united".

He took a dig at the JK administration for keeping around 6,500 posts vacant in police and thousands in other government departments and said "the reality is that this government has not benefited anyone
