'Ready For J&K Polls': Govt Puts **Ball In EC's Court**

New Delhi: The government is ready to hold Assembly polls in Jammu and Kashmir whenever the Election Commission (EC) takes a final decision in the matter, Union minister Jitendra Singh said in the Lok Sabha on Tuesday.

Intervening in the discussion on the Jammu and Kashmir Reservation (Amendment)

Bill and the Jammu Kashmir and Reorganisation (Amendment) Bill, the minister of state in the prime minister's office (PMO) said "whenever the EC announces it (Assembly election in Jammu and Kashmir), we are ready".

He said this in response to a demand from opposition parties for holding early Assembly polls

in the Union Territory. "The EC has its own mechanism of gathering inputs according to its requirements and it will take a final call. Let us all

trust the wisdom of the EC and not appear to be interfering in its functioning," Singh added.

He further said democracy must reach the grass-root level and in the future, "we will do" what is in the best interest of the people of Jammu and Kashmir.

Singh blamed Jawaharlal Nehru, the first prime minister of independent India, for the Kashmir problem. He further said the

Congress should be grateful to Prime Minister Narendra Modi for the abrogation of the provisions of Article 370 of the Constitution that provided a special status to the erstwhile state of Jammu and Kashmir. Singh said

a series of measures have been taken to ensure development in the Union Territory.

No Infiltration Along IB In Jammu In Past Year: BSF

Jammu: Inspector General (IG) of the BSF D K Boora affirmed on Tuesday that the force successfully maintained peace along the International Border (IB) in the Jammu frontier and said no infiltration was reported along the border with Pakistan in the past year.

He said there has been a significant decrease in the number of drone-dropping incidents.

'There was no infiltration

along the IB in the past one year. There have been two to three attempted infiltrations, all neutralised in successful operations. Vigilant troops thwarted three Pakistani smugglers attempting to violate the IB to smuggle narcotics into the Indian territory," Boora told reporters here.

Gaza Horror Resumes

fter the seven day humanitarian truce, the Israeli invasion of Gaza has resumed, leading to further loss of civilian lives, most of them women and children. Israel has refused a permanent ceasefire, saying its goal is to eliminate Hamas. Talks on the release of more Israeli hostages and Palestinian prisoners have stalled. This calls for the international community to step in and bring an end to the harrowing suffering of Palestinians.

Israel's blockade in the occupied Gaza Strip has cut off vital supplies like food, medicine, water, and fuel for 2.3 million Palestinians, leading Oxfam to accuse Israel of using starvation as a weapon of war in this situation. United Nations experts have referred to it as a potential genocide, a fact echoed by hundreds of scholars globally. Despite these warnings, much of the world, especially the global north, appears to be turning a blind eye to this crisis. Although the global south wants the invasion to stop, Israel, helped by its western backers, has refused to listen.

Meanwhile, the tragedy continues to unfold in Gaza. A World Health Organization official in Gaza described the situation on Tuesday as deteriorating by the hour after Israeli bombing intensified in the south of the territory around the cities of Khan Younis and Rafah. Israel has justified its invasion of Gaza and the subsequent disproportionate civilian death toll to October 7 attacks by Hamas which killed 1200 Israelies. But ongoing war crimes committed by Israel cannot be excused by the horrific murders of Israeli civilians by Hamas. It is now rightly argued by well-meaning people across the world that genocide can never be considered self-defense or a proportionate response. More so, when October 7 attacks themselves didn't happen in a vacuum, as rightly stated by the UN chief Antonio Guterres. It's important to acknowledge that these events occur within the larger context of Palestinians enduring oppressive conditions for decades, which Amnesty International has characterized as an apartheid regime.

Amid these dire circumstances, the imperative for a ceasefire cannot be overstated. Every passing moment without intervention adds to the mounting humanitarian catastrophe. Moreover, the repercussions of this conflict extend far beyond Gaza's borders. It risks further regional destabilization and fuels broader tensions, emphasizing the critical need to contain the conflict's

A sustainable resolution demands a multifaceted approach. While an immediate ceasefire is the immediate necessity, long-term peace hinges on robust diplomatic initiatives, which means a serious global effort for a twostate solution within 1967 borders whereby sovereign Israel and Palestinian states live side by side. For now, we need establishment of humanitarian corridors to ensure the unimpeded flow of aid to the affected population. Considering the horrific situation in Gaza, the aid can no longer wait for the humanitarian pauses to resume.

Prime Minister Narendra Modi summed up the country's standpoint in his speech at the UNFCCC meet on Friday: "For global good, it is important that the rights of everyone are protected, and everyone has equal participation.' India achieved its emission intensity-related target 11 years ago and is on track to achieving its Nationally Determined Contribution (NDC) towards the Paris Pact, he said. Prime Minister Modi also reiterated the country's renewable energy commitments. At the same time, the government has been unequivocal about coal's important role in the country's economy.

"Coal is and would remain an important part of India's energy mix," Foreign Secretary Vinay Mohan Kwatra said on the eve of the PM's visit to Dubai. These statements send an important message that India will not buckle under pressure to raise its climate ambition — certainly not at the cost

of its development priorities. Eliminating the use of coal is sure to be among the contentious issues at the Dubai COP. Two years ago at Glasgow, a last-minute push by India, China and other emerging economies led to a change in the final text of the COP26 declaration — from a "phase out" of coal to a "phase down" of the fossil fuel. growing populations. The share of renewables in India's energy basket, for instance, has been increasing for at least five years. However, coal provides more than 70 per cent of the country's energy needs. With the economy bouncing back from the Covid-induced crisis, power demand in the country has been growing at a healthy pace. Their natural gas reserves allowed the US and several European countries to move away from coal.

In her quest, she revealed a torn fiverupee note, clearly distressed by the loss of something precious. Touched by her plight, I stepped up to cover her fare, acting on my empathetic impulse.

As I observed this poignant moment unfold, A whirlwind of questions engulfed my thoughts. What trials and tribulations had she faced?Did Her husband abandon her with a mere five Rupee note and their child? Were their Circumstances truly dire? Were they plunged Into abject poverty? What was the story behind That torn note? To both her and me, it appeared Nothing short of a wondrous miracle that the Bus conductor didn't even asked for fare As fate would have it, when the bus came to a halt. She gracefully exited without the conductor Even asking for fare, leaving me in a state of Bewilderment and an insatiable thirst for Understanding.What I understood by all this is that the economic plight of the valley's Inhabitants continues to deteriorate with each passing year. Even with all family members contributing, middleclass households find themselves plagued by financial vulnerability, unable to satiate their evermounting needs and aspirations. Once a bastion of self-sufficiency, Kashmir now finds itself tethered to imports, with prices escalating incessantly, particularly for everyday essentials such as food items and beverages.

Inflation has exacerbated

the situation in Kashmir, inflicting a severe blow on the common man. Essential items witness an unrelenting ascent in prices, with daily revisions that seem to reach new heights. The common narrative unfolds as the public contends that shopkeepers hike prices, while the merchants assert that post-GST and CST implementation, profit margins are elusive. Numerous shopkeepers have permanently shuttered their establishments, seeking fresh narratives, as the struggle to meet their daily needs insurmountable.The paradox of personal earnings is that as one's income increases, so do the exigencies of life. The intricate nature of credit, fostering a sense of dishonesty, has strained relationships between shopkeepers and distributors, exacerbating

the challenges in this economic slowdown.When I posted about the very incident of economic instability on my Facebook feed a noted columnist of valley rayees ahmad kumar commented that kashmir has lost it's sheen day after another. In a poignant recount, he shared an encounter at a xerox shop, where the shop-keeper, elated by the rare customer in the evening, revealed the stark reality-scarcity of patrons mirrored the prevailing economic downturn in the valley

Meanwhile, yesterday brought tidings from Jammu and Kashmir, unveiling a decline in the retail inflation rate to a favorable 3.4 percent in October, as meticulously reported by the Ministry of Statistics and Programme Implementation.The soaring unemployment rate in the valley has left the educated youth reluctant to engage in either farming or business, further exacerbating the prevailing challenges.We now can only hope and pray May the benevolent guidance of Almighty Allah alleviate the burdens we bear And graciously bestow upon us abundant increments in all aspects of

Afghan Tragedy Unfolds in Pakistan

The deportation of Afghan refugees from Pakistan back to Afghanistan, as per a government directive is causing untold suffering and miseries to the Afghans living in Pakistan for the last 20 years or so. It seems that the decision is based on financial woes currently faced by Pakistan yet it involves other elements too

For the last two months the international attention has been focussed on the continuing Gaza crisis, yet in its background another human tragedy has been unfolding in Pakistan, noticed by few except the humanitarian agencies.

Reportedly, more than 370,000 Afghans have fled Pakistan since 1 October, after Pakistan vowed to expel more than a million undocumented refugees, mostly Afghans.

However, in a significant ruling the Supreme Court of Pakistan observed on 2 December 2023, that Pakistan is a signatory to United Nations' conventions safeguarding the rights of refugees and these agreements bind Pakistan.

Earlier, an apex committee, chaired by Caretaker Prime Minister Anwaar ul Haq Kakar, on 3 October 2023 had issued a deadline for foreign nationals to depart voluntarily or risk deportation by Pakistan by 31 October.

Reportedly, this was to affect some 1.7 million Afghan refugees in Pakistan but also members of other persecuted communities including China's Uyghurs and Myanmar's Rohingvas.

While the majority of the over 4 million Afghans living in Pakistan has been in the country since the Soviet occupation of Afghanistan, between 600,000 and 800,000 Afghans are believed to have arrived in Pakistan after the Taliban 2.0 took over power in 2021.

Pakistani Crackdown

As per media reports, Police and other officials have carried out mass detentions, night raids, and beatings against Afghans. They've seized property and livestock, and bull-dozed homes. They've also demanded bribes, confiscated jewellery, and destroyed identity documents. Pakistani police have sometimes sexually harassed Afghan women and girls and threatened them with sexual assault.

Among those being deported or coerced to leave are people who would be at a greater risk of persecution in Afghanistan, includ-

ing women and girls, human rights defenders, journalists, and former government employees who fled Afghanistan after the Taliban takeover in August 2021.

Some of those at risk had previously been promised resettlement in the US, UK, Germany, and Canada, but resettlement processes are not proceeding quickly enough.

The UN High Commissioner for Refugees has said that the arrival of hundreds of thousands of people into Afghanistan "couldn't have come at a worse time," as the country faces a prolonged economic crisis that has left two thirds of the population in need of humanitarian assistance, and now, winter is setting in.

The new arrivals often come with almost nothing, because Pakistani authorities have prohibited Afghans from taking out more than 50,000 Pakistani rupees (US\$ 175) each. Humanitarian agencies have described shortages of tents and other basic services for those arriving.

The area of Torkham - the crossing point between Pakistan and Afghanistan -, lies just outside the city of Jalalabad. The Taliban government has converted this area into a massive tent city, bereft of civic amenities, to accommodate the influx from Pakistan.

Souring of Pak-Afghan Relations

Since 2021, Islamabad has attempted to close its border with Afghanistan with little success. Apparently, as expected the bilateral relationship between the two countries after the Taliban's takeover of power in Afghanistan didn't worked out on expected lines.

out on expected lines.
The Taliban 2.0 were not the same

lot as the earlier Taliban. This time around they were surer of themselves and instead of following Pakistani diktats through ISI, the Taliban charted a new course of their own.

The relationship even soured more, once the new Taliban government started fencing along the border on the Durand Line. Added to that was the issue of free trade between the two countries, which stopped flow of goods into Afghanistan via Pakistan twice over the last two years. Pakistan has also implemented several measures to tighten the Afghanistan-Pakistan Transit Trade Agreement (ATTA), which critics say has been misused, for smuggling goods back into Pakistan.

Additionally, over the past year, there has been a surge of militant attacks inside Pakistan, with most claimed by Tehreek-e-Taliban Pakistan (TTP), a close ally of the Afghan Taliban. Pakistani authorities have blamed Afghan migrants in part for the rise in attacks.

Only last week, an air force base was attacked in Mianwali, the capital of the Punjab province, though most attacks take place near the long border with Afghanistan, where Islamabad says the TTP has safe-havens.

When the decision to deport refugees was announced, Interim Minister Sarfraz Bugti had stated that out of the 24 suicide bombings in Pakistan this year, Afghan nationals carried out 14.

The Taliban government in Kabul has denied involvement and has done little to allay Islamabad's security concerns. Refusing to take back any refugees, Kabul also disapproves of Islamabad's repatriation plan.

As tempers rise, the Afghan interim Prime Minister Mullah Mohammad Hassan Akhund has criticised Pakistan's decision to expel refugees, saying that Islamabad had violated international laws, while his deputy Sher Mohammad Abbas Stanikzai has warned Pakistan "not to force their hand to react over the move".

Hostility is so deeply entrenched against Afghans that Jan Achakzai, caretaker minister in Balochistan province, has said that the expulsion of refugees would continue, "no matter which political government comes to power after the elections." The tenure of the current caretaker government ends in February 2024.

Though the current situation may have arisen due to Pakistan's own economic woes, in addition to its souring relationship with the Taliban 2.0, yet, the major sufferer in this case is the common Afghan. In this backdrop it becomes the duty of international humanitarian agencies and western governments to take cognisance of the issue and start a slew of measures to ensure care of Afghan citizens and also try to get relations patched up between the two neighbouring countries.

Teaching Kids The Art Of The Comeback

"You don't know what is in the ice cream flavor Moose Tracks? I can't believe you have never had it. That's so weird."

"Eew—a purple dress makes you look like a grape."

"I was watching you during swim class and you didn't swim in a straight line at all, even after the teacher told us to."

Starting in elementary school, children often make hurtful thoughtless comments to one another—even to good friends. Some children are aware they are being mean when they spout off; others don't even recognize they are being rude.

The remarks may be a way to displace distress (financial, emotional, academic or physical) onto a peer. The frontal lobe (the part of the brain that provides impulse control) is not fully developed during childhood, which increases the likelihood of spewing insensitivity.

Of note, I'm not talking about cruel exacting putdowns that make a child feel unsafe and/ or bullying. Bullying requires repeated physical or emotional harm and increased fear, while creating an overall hostile environment. These situations may cause significant psychological harm and require direct intervention by adults.*

Intermittent inane statements are a different beast. That said, these remarks may still cause distress to children who are sensitive. The words truly hurt and the child may feel helpless in response.

As a caring adult, your first job is to validate the feelings. It is important to call a nasty comment a nasty comment. You understand why the child is fired up about it.

It's useful not to lambast the character of the offender. The



annoying peer might become a good friend within a week. Comment on the comment, not the

Sometimes adults try to understand the point of the view of the provoker ("I hear their parents are getting divorced—so maybe that is why they are being mean".) This is generally not helpful. Empathizing with the perpetrator doesn't help the child feel seen or understood.

Next step if the child is interested: It can be empowering to learn how to respond independently to unkind judgments rather than immediately involving an adult. The old adage "teaching one to fish" applies to

playground shenanigans as well. Some recommend ignoring the mean statement. If the instigator doesn't interact with the child often, if the off-hand remark is in passing, or if the individual in question has a history of escalating any confrontation, the best strategy may be to ignore the provocation. It may not make sense to engage with unpredictable children just as adults may hesitate to engage an irate driver on the road.

The calculation changes if the quips are coming from a peer whom the child interacts with often. In this situation, ignoring comes at a cost—because rude remarks without any pushback

may continue, or even escalate. In kid world, it can feel amusing to harass someone who doesn't respond.

Humor or a response that is unexpectedly agreeable may be effective ("Well, I love grapes and couldn't be prouder to represent this fruit" or "Thank you very much!") but it requires verbal agility and the ability to think on one's feet. For a child who might otherwise freeze and go blank in response to verbal insensitivity, a prepared response can be empowering. In role play with a trusted adult, the child can take a turn playing both the aggressor and the responder. It is useful to learn comebacks that work in multiple situations. The adult involved in rehearsal can encourage direct eye contact and an assertive tone. Confidence will increase with practice.

Some classic comebacks that work in multiple scenarios

"Why do you care?"

"So what?"

"What's your point? "

"That's your best point?"

"What's your problem?"

"Who says that? Seriously, Who does that?"

"I don't comment on your ____."

If these don't work, the targeted child can go on offense. "Why are you obsessed with talking about my purple dress? What's going on with you?"

How it may play out in rehearsal:

"Umm, that dress makes you look like a grape—it is so purple!" "Why do you even care?"

"It's just weird."

"So what?"

Vell if you want to look like

"Well, if you want to look like a grape..." "Well, I don't comment on your

clothes. "
"It's just strange. You look strange"

"Why are you obsessed with purple dresses? You don't have anything else better to do? " "Never mind, just forget it"

These simple comebacks have a lot of power. First, the instigator wants to feel powerful, but with pushback, the interaction won't feel as fruitful. The final retort, if all else fails, creates a boomerang effect. All of a sudden, the provoker is in the spotlight. The child is no longer a soft target, which can be protective in the future as well.

Over the years, I have found that a child doesn't even need to say the comebacks to feel a bit better with an annoying peer. They just need to think them. The power of fighting back, even in one's own head, provides a sense of agency. The child who has rehearsed a defense may have a change in facial expression; sometimes the aggressor senses the change, and move on to bother someone else instead.

Empowering the child and giving them agency is helpful in numerous ways. With emotional support, the child no longer feels alone. With validation, they learn to trust their internal experience. Add in some comebacks to hold in their back pocket, and they may feel emboldened, rather than discouraged when dealing with the inevitable immature communications that are part of childhood.

He said the government should tell the truth to the country and not spread the illusion of normalcy in Jammu and Kashmir.

Masoodi also claimed that unemployment is increasing in the Union

Supriya Sule of the Nationalist Congress Party (NCP) too demanded early polls and said the government oring a comprehensive bill on reservation to meet the aspirations of the people of different states.

Janata Dal-United's Kaushalendra Kumar also demanded the holding of Assembly polls in Jammu and Kashmir.

Oppn Seeks Timeline

Union Territory. Home Minister Amit Shah will respond to the debate on the Jammu and Kashmir Reorganisation (Amendment) Bill and the Jammu and Kashmir Reservation (Amendment) Bill, taken up together, on Wednesday. One bill seeks to nominate not more than two members, one of whom shall be a woman, from the community of "Kashmiri Migrants" and one member from the "Displaced Persons from Pakistan-occupied Jammu and Kashmir" to the legislative assembly of the Union Territory.

The other seeks to change the nomenclature of "weak and underprivileged classes" to "Other Backward Classes" in Jammu and Kashmir.

The Union Territory, which has the provision for a legislative assembly, is currently under central rule.

Singh said Shah should assert that the election in Jammu and Kashmir will be held, with security forces ready to deal with any situation.

He said while a provision is being made to provide reservation for two members from the community of "Kashmiri Migrants" and one from the "Displaced Persons from Pakistanoccupied Jammu and Kashmir" to the legislative assembly of Jammu and Kashmir, a representative from the Punjabi community from Jammu should also be provided. He said the "Punjabi" should not necessarily be a Sikh.

Jugal Kishore Sharma of the Bharatiya Janata Party (BJP), who represents Jammu in the Lok Sabha, said the bill to change the nomenclature of "weak and underprivileged classes" to "Other Backward Classes" in Jammu and Kashmir will benefit people in getting reservation in other parts of the country for the first time.

Saugata Roy of the Trinamool Congress (TMC) said the government should announce a time-frame for

holding polls in the Union Territory. He said providing reservation and similar issues are state subjects and should be dealt with by the state legislatures. The hurry, he said, is to pass bills, but it should be for holding the Assembly polls.

Roy claimed that the abrogation of the provisions of Article 370 of the Constitution has brought no changes in the lives of the people of Jammu and Kashmir. He said this was the first time that a state was converted into a Union Territory.

He said the government tells tourists that everything is fine in Jammu and Kashmir but in reality, that is not the case.

Speaker Om Birla intervened to say after the abrogation of Article 370, most of the MPs have been to Jammu and Kashmir and the region is at it was earlier.

The TMC leader said it was a matter of opinion.

He also said the people of Jammu and Kashmir and not the lieutenant governor should rule the Union Territory.

Roy's remarks on the LG drew protests from the BJP members.

the high court had issued notice to Malik on NIA's plea seeking death penalty for him in the terror funding case and sought his presence before it on the next date.

Subsequently, the jail authorities had filed an application seeking permission for his virtual appearance on the grounds that he was a "very high risk prisoner" and it was imperative to not physically produce him in court to maintain public order and safety.

The request was allowed by the high court.

A trial court here had awarded life sentence to Malik in the case on May 24, 2022 after pronouncing him guilty of various offences under the stringent Unlawful Activities (Prevention) Act (UAPA) and the IPC.

Malik had pleaded guilty to the charges, including those under antiterror law UAPA.

Appealing against the sentence, the NIA has emphasised that a terrorist cannot be awarded life sentence only because he has pleaded guilty and chosen not to go through trial.

While seeking enhancement of the sentence to death penalty, the NIA has said if such dreaded terrorists are not handed capital punishment only because they pleaded guilty, there will be complete erosion of the sentencing policy and terrorists would have a way out to avoid capital punishment.

A life sentence, the NIA asserted, is not commensurate with the crime committed by terrorists when the nation and families of soldiers have suffered loss of lives and the trial court's conclusion that Malik's crimes did not fall within the category of the "rarest of the rare cases" for grant of death penalty is "ex-facie legally flawed and completely unsustainable".

The agency has emphasised that it has been proved beyond reasonable doubt that Malik spearheaded terrorist activities in the Valley and, with the help of dreaded foreign terrorist organisations, had been "masterminding, planning, engineering and executing armed rebellion in the Valley in an attempt to usurp the sovereignty and integrity of a part of

"Not giving capital punishment to such dreaded terrorist will result in miscarriage of justice, as, an act of terrorism is not a crime against society but it's a crime against the entire nation; in other words it's an act of 'external aggression', 'an act of war' and an 'affront to the sovereignty of nation'," the plea has said.

The trial court, which had rejected the NIA's plea for capital punishment, said the crimes committed by Malik struck at the "heart of the idea of India" and were intended to forcefully secede Jammu and Kashmir from the Union of India.

It had, however, noted that the case was not the "rarest of rare", warrant-

ing death penalty. The maximum punishment for such an offence is death penalty.

Malik was awarded life term for two offences - section 121 (waging war against government of India) of IPC and section 17 (raising funds for terrorist act) of the UAPA.

According to the Supreme Court, life imprisonment means incarceration till the last breath, unless the sentence is commuted by the authorities.

The court had also awarded Malik 10-year jail term each under sections 120 B (criminal conspiracy), 121-A (conspiracy to wage war against the government of India) of IPC and sections 15 (terrorism), 18 (conspiracy for terrorism) and 20 (being member of terror organisation) of U

The Warden also informed that the Demarcation of the Wular Lake has been carried out and 1159 concrete boundary pillars have been fixed all over the periphery of the Lake. "An area of 4.35 Sqkm of critically silted area of lake stands restored by removing 72.80 Lac cum of silt from Wular Lake." He said that the present dredging operations are carried out using modern and hi-tech machines such as Cutter Suction Dredgers for efficient, fast, and quality dredging from Wular lake. "Under Willow Action Plan 1.20 Lac willows have been removed from Lake for its eco-restoration generating a revenue of 24.35 crore."

Besides this, the Warden said, the choked feeder channel (Naaz Nallah, having a total length of approximately 6.00kms) stands completely de-silted. cleaned, and restored back to its original course, thus restoring hydrological connectivity between Wular Lake and MalgamRakh

Regarding afforestation of badly degraded catchment areas, the Warden said that approximately 16.76 lac saplings (both conifer and broadleaved species) for mass greening of the denuded hill in Erin and Madhumati Watersheds. "Fodder development and energy plantations too have been raised in the target areas falling under the catchment areas besides largescale vegetative and engineering measures stand taken to prevent and control soil erosion in these areas."

For biodiversity conservation, he said, focus has been given to conservation of wildlife within and outside the Wular lake.

The High Court, following the directions by the Supreme Court on 3 April 2017, had treated an affidavit filed by the petitioner M K Balakrishnan before the apex court regarding certain wetlands which were covered under the Ramsar Convention on Wetlands

The Top Court had asked the Chief Justices of the concerned High Courts to treat the affidavit as a suo moto PIL and, if necessary, appoint an amicus curiae to assist the court so as to ensure that the Ramsar Convention sites within their jurisdiction were properly maintained.

The High Court pursuant to the directions registered the affidavit as PIL on its own motion and in its first order on the PIL on 28 August 2018, underlined that the "importance of preservation of Wetlands and Water Bodies cannot be sufficiently emphasized as well as the need to set up a regulatory mechanism for all wetlands so as to maintain their ecological character and ultimately support their integrated management in the three regions of the (then) State (Kashmir, Jammu and Ladakh)."

"A big gang connected with dronebased smuggling was busted earlier this year. There is almost nil activity of drones along the IB in Jammu. There has to be someone to collect the material dropped by drones from across the border. "The year 2023 witnessed manifold challenges ... like drone activities, unprovoked firing and smuggling attempts. But true to its tradition, the BSF-Jammu thwarted all attempts of the adversary and foiled its nefarious designs," he added.

On the implementation of the projects of smart fencing and an antidrone set up, Boora said those are almost complete.

Responding to questions on tunnels, he said there were no reports of tunnels being used by terrorists in the past year. He emphasised the use of manual and technological measures to prevent such possibilities.

Asked about the possibility of aerial attacks on the lines of those perpetrated by Hamas on Israel, Boora affirmed that any such mischief would receive a befitting reply.

Regarding cultivation along the IB, he said 20 per cent of the land ahead of the border fence is being cultivated by farmers.

NIA Raids In

Jammu and Kashmir in connection with the terror conspiracy hatched and operationalised by the offshoots of the banned Pakistan-backed terrorist organisations, such as Laskhar-e-Toiba (LeT), Jaish-e-Mohammed (JeM), Hizb-ul-Mujahideen (HM), Al-Badr, Al-Qaeda, etc", the agency said in a release.

Teams of NIA cracked down on eight locations in the seven districts of Poonch, Shopian, Pulwama, Baramulla, Ganderbal, Kupwara and Srinagar of the Union Territory of J&K, it said.

The locations raided today were residential premises of hybrid terrorists and Overground Workers (OGWs) associated with the newly-formed affiliates and offshoots of the banned terrorist outfits, it added.

"Extensive searches were also conducted at the premises of the cadres and sympathisers of these newly floated organisations, which included The Resistance Front (TRF), United Liberation Front Jammu & Kashmir (ULFJ&K), Mujahideen Gazwat-ul-Hind (MGH), Jammu & Kashmir Freedom Fighters (JKFF), Kashmir Tigers, PAAF, among others," the NIA

The searches led to the seizure of several digital devices containing large volumes of incriminating data and documents by the NIA, which has been investigating the conspiracy of the recently launched offshoots of the banned terror outfits to destabilize J&K through violent terrorist attacks and activities, the agency added.

NIA had registered the case (RC-05/2022/NIA/JMU) suo moto on 21 June 2022 to probe the involvement of the cadres, OGWs and other suspects of the new outfits in the collection and distribution of sticky and magnetic bombs, IEDs, funds, narcotic substances and arms/ammunition to spread terror, violence and subversion in J-K.

NIA investigations so far have revealed that Pak-based operatives were using social media platforms to promote terror, and were also using drones to deliver arms and ammunition, explosives and narcotics to their operatives and cadres in the Kashmir

These activities were "being carried out as part of the terror conspiracy hatched by the banned outfits, backed by their masters in Pakistan. The conspiracy also involved radicalisation of local youth and mobilisation of OGWs to carry out violent and disruptive activities in J-K", the agency said.

4 Kashmiris Among **Five Chargesheet Over ISKP Links**

AHMEDABAD: The National Investigation Agency (NIA) on Tuesday filed a chargesheet in the special court here in Gujarat against five persons, including a woman, for their alleged links with terror outfit Islamic State of Khorasan Province (ISKP).

The chargesheet against Ubaid Mir, Hanan Shawl, Mohammad Hajim Shah, Zubair Ahmed Munshi, and Sumerabanu Hanif Malek was submitted in the court of special judge Kamal Sojitra by NIA special public prosecutor Amit Nair.

The ISKP is a UN-designated terrorist organisation.

Investigations by the NIA revealed that the accused had planned to "train themselves and carry out terror attacks" in Afghanistan after reaching the war-torn country via Iran as directed by their handler, the chargesheet stated.

On June 9, the Gujarat Anti Terrorist Squad (ATS) busted this ISKP module and arrested Mir, Shawl, and Shah from Porbandar city in Gujarat. A day later, the ATS nabbed Sumerabanu from Surat and Munshi from Srinagar. All four men hail from Srinagar in Jammu and Kashmir.

They were booked under relevant sections of the Unlawful Activities Prevention Act (UAPA) and section 120 B (Punishment of criminal conspiracy) of the Indian Penal Code.

The NIA had found a video clip in which the accused can be seen pledging their allegiance to ISKP while flashing sharp weapons sitting under the flag of the outfit, as per the chargesheet.

The interrogation of the accused by the ATS had revealed that all of them were part of the ISKP module and radicalised by their handler Abu Hamza, officials had said.

Mir, Shawl and Shah had reached Porbandar to work as fishermen on boats with the given GPS coordinates as directed by Abu Hamza. They had planned to cross the International Maritime Boundary Line and reach Afghanistan via Iran to join ISKP, the ATS had said.

From Porbandar, they were to be taken to Iran on a dhow and were provided with fake passports for Afghanistan and to reach Khorasan via Herat, as per

The ATS had found mobile phones, tablets, and sharp weapons in the bags of the accused.

It was revealed that their handler had planned to release the pre-recorded videos and photographs of their 'sacrifice' in Afghanistan. In a video clip, they can be seen pledging their allegiance to ISKP while flashing sharp weapons.

The ATS had found copies of various publications promoting radicalisation, including ISKP's mouthpiece "Voice of Khorasan" during the search of the house of

Sumerabanu Hanif Malek in Surat. Malek had "admitted" to having been in touch with Abu Hamza and being "close" to

Munshi, the ATS had said. The case was transferred to the NIA by the Ministry of Home Affairs on June 28.

Crime Branch Charges Couple In Jammu For Duping Lecturer

JAMMU: The Crime Branch of Jammu and Kashmir Police on Tuesday filed a charge sheet against a couple for allegedly cheating a lecturer of Rs 6 lakh on the promise of arranging a plot of land from the Jammu Development Authority (JDA), an official said.

Bangladesh Looking To Secure First Test Series Win Over New Zealand

MIRPUR: Bangladesh head coach Chandika Hathurusingha wants his players to guard against complacency as it tries to secure a first series win against New Zealand in the second and final test.

Bangladesh won the first test in Sylhet by 150 runs to close in on a landmark series victory. The only toplevel teams that Bangladesh has ever beaten in a twomatch test series are Zimbabwe and West Indies.

"I can't see complacency in the team. If I see any action of complacency, I will have one to one chat," Hathurusingha said ahead of Wednesday's opening day.

"We had a good chat inside the dressing room yesterday. Strong and experienced leaders like Mushy (Mushfiqur Rahim) and Mominul (Haque) spoke very emotionally. They



spoke in Bengali. I can see there's no tall poppies in the dressing room."

The Sylhet test victory was only Bangladesh's second against New Zealand in 18 meetings, and it came courtesy of captain Najmul Hossain Shanto's secondinnings century. In doing so, Shanto became the first Bangladeshi cricketer to hit a century on his debut as

captain.

"Captaincy and leadership are two things," Hathurusingha "(Shanto's) captaincy was excellent. He was tactically on the mark. He was step ahead of the game most of the time. Very impressive field placings as well.

Sometimes unorthodox, but very effective. "(His) leadership was

excellent. He led from the front with his performance. He was commanding respect, and demanding the standard. I think he has a long future ahead."

Left-arm spinner Taijul Islam, who took 10-184 in the first test, will be a Bangladesh's most crucial weapon in Mirpur, which traditionally has a slow wicket with unven bounce.
