Despite increasing Srinagar: reports of molestation cases in schools across Jammu and Kashmir, the Department of School Education is yet to frame a comprehensive child protection policy. This was revealed by the school education department of J&K in response to a Right to Information (RTI) application filed by Advocate Naveed Bukhtiyar.

Advocate Bukhtiyar, a resident of North Kashmir's Uri, sought the information under the RTI Act of 2005. According to him, rule 3(5) of the Protection of Children from Sexual Offences Rules, 2020 states, "The respective Governments shall formulate a child protection policy based on the principle of zerotolerance to violence against children, which shall be adopted by all institutions, organizations, or any other agency working with, or coming in contact with children."

I asked the officials to provide



the child protection policy adopted by the government for all education institutions within [&K," he told Kashmir Observer. However, the government's response clearly stated that they don't possess such information.

The response, a copy of which lies with Kashmir Observer, reads, "Kindly refer to your RTI application No. J&K/RTI/MOU/ OHS/768 dated 08-11-2023. In this context you are informed that no such information is available in the department."

Ladakh: Sudden Water Surge In Hot Springs In Chumathang Region, Expert Panel Set Up

Jammu: There has been an alarming rise in the water levels of hot springs in the Chumathang area of Leh district's Nyoma sub-division recently and a mechanism will be put in place to monitor it, officials said on Wednesday.

The Geological Survey of India (GSI), the Wadia Institute of Himalayan Geology and other expert teams will formulate a white paper on the rise in the water levels and share the same with all stakeholders, especially the Ladakh administration, they said.

Gaza Needs Ceasefire

he UN General Assembly vote, a resounding 153 countries including India in favor of a humanitarian ceasefire in Gaza, speaks volumes about global opinion on the ongoing conflict. Despite this overwhelming support, the US and Israel, among a mere handful of dissenters, stood in opposition. This non-binding resolution, while lacking legal enforcement, serves as a significant gauge of international sentiment.

The consequences of this decision extend beyond a mere diplomatic gesture. They underline a poignant ethical dilemma: the humanitarian crisis unfolding in Gaza. The toll of this conflict is harrowing—more than 18,000 lives lost, a majority of whom are women and children. Displacement has affected over 80 percent of Gaza's 2.3 million inhabitants, rendering living conditions dire.

Amidst relentless airstrikes which has leveled neighbourhoods and a suffocating siege, Gaza has acquired the air of a graveyard. The Israeli offensive has stopped essential resources—food, fuel, water, and electricity compounding the misery of its inhabitants. The situation, deemed by UN officials as "hell on earth," demands urgent intervention and cessation of hostilities. The failure of the UN Security Council's resolution,

The failure of the UN Security Council's resolution, vetoed by the US with the UK abstaining, has let the tragedy drag on. Unlike the non-binding UNGA resolution, UNSC decisions hold authoritative weight. The deadlock in the Security Council amplifies the urgency for a unified global response to alleviate the suffering of innocent civilians.

The rejection of the ceasefire resolution serves as a litmus test for international institutions' credibility and commitment to humanitarian principles. The amendments introduced by the US and Austria, seeking to condemn a specific Hamas attack, were seen by many as attempts to politicize an issue that transcends geopolitical interests. Their failure to pass underlines the need for a focused, impartial approach in resolving the crisis.

The divergent narratives presented by stakeholders reflect the struggle to balance geopolitical alliances with humanitarian imperatives. The Biden administration's unwavering support for Israel's military actions has sparked debates about double standards in foreign policy. The administration's recent acknowledgment of Israel losing international support highlights the evolving global stance on this issue.

As the conflict perpetuates, the world is watching, struggling with ethical quandaries and the imperative to act. The urgent need for a ceasefire persists, transcending political allegiances and demands immediate attention from global leaders. And it is time that the world comes together and ends the tragedy playing out right before us in broad daylight.

J&K's Power Quandary: From Potential to Darkness

Winter's icy embrace, already formidable, becomes an arduous battle when compounded by sub-zero temperatures during these power interruptions

he Union Territory of Jammu and Kashmir has enormous potential for producing hydel power despite not being well known for its energy resources like coal, gas, or petroleum. The UT of Jammu and Kashmir is widely known for its numerous turbulent streams that burst down precipitous mountains. Both the topography and the flow are ideal for the state's hydroelectric power production. The UT's projected hydel power generation capacity is 2000 MW, but some more recent studies dispute this number by putting the capacity at 3500 MW. Only 10% of this enormous potential has been harnessed thus far, leaving the remaining 90% unrealized. A significant portion of the overall tapped potential goes into the kitty of National HydroElectric Power Corporation (NHPC), leaving just a little portion or peanuts to the other state.Delving into NHPC's power projects, the Salal hydroelectric power project, nestled along the Chenab stream in the Reasi region of Jammu division, stands prominently. Boasting an installed capacity of 690 MWs, this endeavor commenced in 1970, achieving a milestone with its inaugural phase in 1987. The subsequent stages unfolded in 1993, 1994, and 1995, consecutively. Operational under NHPC since its inception, the project significantly contributes to the northern power grid, showcasing the transformative potential of sustainable energy initiatives

Dulhasti Hydroelectric Power Project, spanning the Chenab in Kishtwar district, melds the distinct locales of Dul and Hasti, each housing a dam and powerhouse. Commencing construction in 1985, this marvel culminated in 2007 with a total installed capacity of 390 MW. Operated by NHPC, its power surges into the northern grid.

Uri Hydroelectric Power Project, nestled along the Jhelum near Uri in Kashmir division, boasts a phase I capacity of 480 MW. A powerhouse in the energy landscape, it channels a substantial share into the Northern Grid under NHPC's watchful operation.

The grandeur of the Baglihar Power Project unfolds along the Chenab near Batote. Sporting a colossal 900 MW installed capacity, its first phase initiated in 1999, achieved operational brilliance in 2008, and fully concluded in November 2015. Despite public and PDC opposition, this state-owned venture succumbed to NHPC after an impressive three-month stint.

Transitioning to JKPDD's domain, the Mohra Hydroelectric Power Project, born in 1907, stands as a testament to history, nestled on the Jhelum River in Baramulla. With a vintage 9 MW capacity, it holds the honor of being the second hydroelectric power project on the Indian subcontinent. The Lower Sindh Hydroelectric Power Project, established in 1956, harnesses Nallah Sindh's flow in Ganderbal, with a 15 MW capacity. The Lower Jhelum Hydroelectric Power Project in Warikhwal taps into the Jhelum River's energy, contributing to the region's power needs. Sumbal and Kangan unveil their prowess through Upper Sindh Hydroelectric Power Project (22.60 MWs) and Upper Sindh Hydroelectric Power Project (105 MWs), respectively, showcasing the diverse hydroelectric landscape of the region. The collective output from 24 hydroelectric projects exceeds 3500 MW annually in Jammu and Kashmir. Although Kashmir generates around 2500 MW, the umbilical connection to NHPC's northern network necessitates power purchases, an ironic predicament for the UT.

sumers find themselves grappling with soaring electricity bills, a bitter aftermath of the Joint Electricity Regulatory Commission (JERC) of Jammu and Kashmir's sanctioning of an 8 to 22% surge in residential, commercial, industrial, and agricultural power tariffs across the Union Territory. This fiscal shockwave has stirred unrest among the people of J&K in the districts of Ganderbal and Doda, the District Administration in the year 2022 has wielded its authority, imposing constraints on the sale of electric appliances. Store owners, under governmental urging, are compelled to withhold the sale of crucial heating equipment from desperate clients. Section 144 further tightens the grip, enforcing restrictions on the purchase of heaters, geysers, electric blankets, and other indispensable electric appliances. Imagine braving the bitter winter without essentials like heaters and warm water for bathing in the minus temperature abyss. It's a daunting scenario, emphasizing the critical impor-tance of timely payment of electricity bills by consumers. Yet, the onus lies squarely on the government to fulfill its duty of providing an uninterrupted supply of electricity. The Kashmir Valley, which has the potential to generate about 3500 megawatts of hydel power now finds itself shrouded in complete darkness during the unforgiving winter, underscoring the urgency for a luminous resolution.

As was expected, the monetary policy committee of the Reserve Bank of India voted unanimously to keep interest rates unchanged in its December meeting. The repo rate currently stands at 6.5 per cent. Alongside, the MPC also voted 5-1 to remain focused on the withdrawal of accommodation. In his statement, RBI Governor Shaktikanta Das stated that policy has to be "actively disinflationary" to ensure that inflation aligns with the central bank target of 4 per cent, and reiterated the committee's readiness to take appropriate policy actions if warranted.

In recent months, there has been a steady decline in inflation. Retail inflation, as measured by the consumer price index, fell to 4.87 per cent in October, after touching 7.44 per cent in July. The decline has been largely driven by food inflation which fell from 11.51 per cent in July to 6.61 per cent in October, as food prices, especially of vegetables, moderated. Alongside, there has also been a steady decline in core inflation, which excludes the more volatile food and fuel components. However, the near-term inflation outlook is uncertain. There is the possibility of an uptick in food prices in the months of November and December — as supply and demand in major commodities like cereals, pulses and sugar are in fine balance, climate related uncertainties over the rabi crop raise questions over the trajectory of food prices.

RBI Governor Shaktikanta Das also acknowledged this, noting that high frequency indicators do point towards an increase in prices of vegetables which may push up inflation. The central bank has thus projected inflation to ease slowly from 5.6 per cent in the third quarter (October-December) to 5.2 per cent in the fourth quarter (January-March). Inflation is expected to trend towards the central bank's target next year, averaging around 4.3 per cent in the second and third quarters.

On growth, the central bank remains optimistic, saying that the economy shows remarkable resilience. While concerns over private consumption persist, the RBI sees urban demand as durable, and projects a gradual turnaround in rural demand. It notes that investment activity continues to be aided by government spending and expects the drag from external demand to moderate as exports turn around. After the second quarter GDP estimates surpassed expectations, the RBI has raised its forecast for the full year to 7 per cent, up from 6.5 per cent earlier.

How To Foster The Value Of Generosity In Your Children

Besides nurturing your child's cognitive development so that they can be successful in school and beyond, many parents also want to cultivate softer qualities in their children. Generosity is an important one, as it strengthens the relationships and communities in which your children participate.

It might surprise you to learn that while older individuals tend to be more generous than younger ones, we can start to see expressions of generosity in very young children. One recent study found that children as young as 15 to 18 months of age were willing to share a toy with another child they did not know. Interestingly, people living in less industrialized countries tend to be more generous than those in more industrialized countries, and, on average, women tend to be more generous than men.

Being on the receiving end of acts of generosity naturally feels good, but research also suggests that the act of giving can have a positive effect on the giver as well. It appears that many humans are actually wired to feel good when they give, indicating a biological component to human generosity. While not everyone is as naturally inclined to get the same degree of positive emotion from their acts of kindness, there is evidence to suggest that the value of generosity can be learned. And since this quality strengthens



both personal relationships and larger communities, it is never too early to nurture a child's capacity to give.

So how can we cultivate and encourage generosity in children? Here are a few suggestions:

TEACH EMPATHY AND TALK ABOUT EMOTIONS

A good starting place is

helping children understand and label the emotions of other people. Ask them which behaviors might signal certain feelings. Have them describe the body language that accompanies specific emotions. Point out the impact of your children's actions on others. The empathy you are cultivating in these conversations will lay the foundation from which your children's own acts of generosity will spring.

Discuss with your children the positive impact on both the giver and the receiver. Ask them to imagine and identify the emotional rewards of receiving help or kindness and of helping others.

MODEL THE BEHAVIOR YOU'RE TRYING TO ENCOURAGE

Don't underestimate the power of modeling the behaviors you want to see in your children. Children learn by observing and copying the behavior of those around them. Those of us who work with children can tell countless stories about children who imitate their parents or relate what parents probably thought were confidential conversations from home. Be aware of the messages you are sending your children through your own actions.

You can demonstrate generosity through your own behavior, whether by helping others, sharing, or showing kindness. Volunteering in your community can show your children how giving your time is an act of generosity. When you model what you want to see in your children's behavior, you can comment on both the impact your actions may have on those you help and the positive feelings that your helpfulness generated in you. It's also important to highlight that it can be enough just to know you have done something thoughtful; you don't always need affirmation or accolades from the recipient to feel good. You are trying to avoid creating the expectation of reciprocity

ENCOURAGE SHARING AND INCLU-SION DURING PLAY

Inclusion during activities can take the form of sharing time with a favorite toy or a turn at a fun activity. Sharing can mean temporarily forgoing one's own enjoyment so that someone else can have a turn at a positive experience. It could mean inviting or allowing a less skilled or less mature child to join in a game, or a peer who may want to play by different rules, but who will, as a result, feel a sense of acceptance and validation. Help your children recognize and understand how inclusion promotes a feeling of belonging in others and how it can elicit feelings of joy for themselves through their positive connection with others.

REWARD GENEROSITY IN YOUR CHILDREN AND IN OTHERS

Acknowledge and praise your children when they demonstrate generosity. As with anv other behavior, positive reinforcement helps emphasize the value of their actions - in this case, of giving - and it makes it more likely that they will repeat this kind of behavior in the future. Psychologists who study this phenomenon in children specifically suggest that reinforcement in the form of verbal praise rather than tangible rewards better encourages them to continue these behaviors. You can also selectively draw attention to generosity in others, whether in real life or fiction (for example, when watching TV shows, movies, or reading books together).

Remember that fostering generosity will be like teaching any other skill that you hope to see integrated into your children's engagement with the world. You will need to model it, value it, and sometimes be patient with its development. If it is something they encounter over and over again, they will come to see it in more nuanced ways over time and it will become an essential part of who they are and how they behave.

Police said the two detained outside Parliament were identified as Neelam (42), of Haryana's Hisar, and Amol Shinde (25), of Maharashtra's Latur area.

Narrating the LS incident inside Parliament, Congress leader in Lok Sabha Adhir Ranjan Chowdhury said, "One person was seen leaping over the benches of the Lok Sabha while another was seen dangling from the public gallery spraying some tear gas when Zero Hour was in progress." They were overpowered by the Lok Sabha members and the watch and ward staff.

Police sources said the security breach was a "well-planned and wellcoordinated" incident carried out by six people, all of whom were in contact with each other over social media platforms.

The incident in the Lok Sabha chamber took place at around 1:01 pm when BJP member Khagen Murmu was raising an issue during Zero Hour. While one started crossing the benches in a bid to approach the Speaker's chair, the other was seen dangling from the railing of the visitor's gallery before jumping into the chamber, according to several MPs present in the House.

including Alarmed members, Hanuman Beniwal, Malook Nagar and Gurdip Singh Aujla, overpowered and thrashed the intruders, who had come to the gallery with visitor passes facilitated by two-term Lok Sabha member from Mysuru Prathap Simha of BJP, before handing them over to the security personnel.

`crying spells', `suicidal tendencies': One in every 7 new mothers suffer from "postpartum depression' in Kashmir'

The story was published on November 17, 2022. It brings to the light the plight of new mothers in the cloud of stigma impeding access to mental health in Kashmir.

"SCARF (1) proudly recognizes the outstanding efforts of Hirra Azmat for her engaging report on post-partum depression. Her article titled, "Hallucinations', `crying spells', `suicidal tendencies': One in every 7 new mothers suffer from `postpartum depression' in Kashmir", published in Kashmir Monitor (November 17, 2022, brings to the light the plight of new mothers in the cloud of stigma impeding access to mental health in Kashmir," the citation presented to her reads.

Scarf, the Schizophrenia Research Foundation, a non-governmental organization works on mental health issues and recognizes media reportage on mental health with awards.

The organization received 52 entries, including news items, articles and stories in English and Hindi. The media awards event was held online on December 12 Hirra, who is currently working as a reporter for Kashmir Observer has previously bagged several awards for her work and that includes'Project Siren' and Laadli Media Awards.

Trinamool Congress leader Sudip Bandyopadhyay called the security breach the worst since Independence as the attackers had managed to reach the Lok Sabha chamber with smoke canisters which could have been lethal.

opposition members Several sought to link the incident to the threats issued by Khalistani terrorist Gurpatwant Singh Pannun, to attack Parliament on or before December 13, the anniversary of the terror attack.

As the proceedings resumed at 2 pm, Lok Sabha Speaker Om Birla said a comprehensive security review of Parliament House would be carried out and at the same time made it clear that the preliminary inquiry did not indicate any links to Pannun.

Lok Sabha officials said the issuance of passes for the visitors' gallery in the Parliament House has been suspended with immediate effect.

The Lok Sabha Secretariat has also written to the Union home ministry, seeking a review of the security measures at the Parliament building.

Top police officers including Commissioner Sanjay Arora rushed to Parliament House after the incident.

After opening the gas canisters that emitted the smoke outside the Parliament building, Shinde and Neelam also raised slogans such as "Tanashahi Nahi Chalegi", police

"One of the two was raising slogans 'Tanashahi nahi chalegi'," Mandal said.

"Suddenly there was a commotion in the House. One person was seen jumping from one bench to another. It was a very tense moment, anything could have happened. I thought, what if he has a bomb or fire equipment in his pocket? It is a serious security lapse," Sudip Bandyopadhyay, Trinamool Lok Sabha leader, said.

"Two people jumped from the public gallery, there was smoke and everyone ran. They have been caught by some MPs and security personnel. One of them is Sagar. He was the guest of Mysuru member Prathap Simha," Lok Sabha member Danish Ali said.

"It is a big security lapse. It is the anniversary of the Parliament attack. This is a matter for probe," said Ali.

Karti Congress member Chidambaram said the two persons pulled out canisters that were emitting yellow smoke. "The smoke could have been poisonous. It is a serious security breach," he added.

"They started advancing and rushing towards the well of the house and they lit up smoke sticks. Security was compromised," DMK member D N V Senthil Kumar said on X.

"Certainly, there is a loophole. At first, I thought a person might have fallen but when the second person started coming down, all of us became cautious," BJP member Rajendra Agrawal said.

"Home Minister Amit Shah gives big speeches but can't maintain security in Parliament, he must resign," TMC MP Kalyan Banerjee said.

In a post on X, Congress leader Gaurav Gogoi said, "Saw two young men unleash foul smelling yellow coloured gas from canisters inside Parliament gallery. MPs rushed to grab these men. One person was raising some slogans. This raises serious questions on another aspect of the new Parliament building- security."

Security has been beefed up in the area following the incident.

Pakistan-based Lashkar-e-Taiba and Jaish-e-Mohammed outfits attacked the Parliament complex on this day in 2001, killing nine people.

According to the 'handbook for Lok Sabha members' uploaded on the Lower House's website, in the application form submitted by MPs for visitors, they need to provide details such as visitor's name in full, age, father's or husband's name, nationality and passport number (for foreigners only) and details of occupation, among other things.

Details of occupation of the husband (in the case of housewives only), full permanent address and state, and full Delhi address are also required.

According to the handbook, the members have to provide a certificate on the application form for the visitor card stating, "The above-named visitor is my relation/personal friend/ known to me personally and I take full responsibility for her/him." Visitors' cards for the public gallery are issued for the guests of Lok Sabha members on the day before the visit on applications from members on vellow forms available in the Centralised Pass Issue Cell.

The application for visitors' card should contain the name of not more than four guests of a member and the application should reach the Centralised Pass Issue Cell not later than 4 pm on the working day before the date for which the card is required.

The petitioners pleaded that they came to be engaged in terms of the respective engagement orders, when one year of contractual engagement of the petitioners came to an end in the year 2022, when in terms of communication No. ME-Gztd/198/2022 dated 08.08.2022, addressed by the Health and Medical Education Department of J&K Government, to the Principal Government Medical College Srinagar, on the approval of Administrative Department, providing for the grant of extension in the tenure of the engagement of the staff, actually on the rolls/ working in the 500 bedded Covid Hospital at Khunmoh Srinagar, which was accorded upto 31.12.2022.

The petitioners had also sought direction from the court to release Avushman incentives as well as Covid incentives in terms of the Notification No. 01-HME of 2019 dated 19.01.2019 in favour of them.

"So far as the other reliefs, the respondents be directed to release Ayushman as well as Covid incentives in terms of the Notification No. 01-HME of 2019 dated 19.01.2019 in favour of the petitioners," the court said.

A close associate of Kashmiri, Majid Aziz Lawey, was arrested in the terror funding case in November with Rs 5 lakh.

'Not Political': Khawaja To **Fight Gaza Message Ban**

ustralia batsman Usman Khawaja believes the statements he wrote on his shoes in support of the people of Gaza were not political and said he would fight the International Cricket Council (ICC)'s ruling that he cannot display them while playing.

Khawaja had the messages "Freedom is a human right" and "All lives are equal" written on his boots in the colours of the Palestinian flag in Tuesday's training for the first test against Pakistan. Australia captain Pat Cummins said on Wednesday that the Pakistanborn opener had agreed not to display the messages during the match when it started on Thursday, but Khawaja later

posted an emotional video on the social media site X. 'The ICC have told me I can't wear my shoes on the field because they believe it's a political statement under their guidelines," he said. "I don't believe in this though. It's a humanitarian appeal. I

will respect their view and

decision, but I will fight it and seek to get an approval. Freedom is a human right."

Israel's ongoing assault on Gaza in response to the deadly Oct. 7 cross-border attacks by Hamas has killed at least 18,205 Palestinians, according to the Gaza health ministry. The ICC Code of Conduct forbids players wearing, displaying or conveying messages through arm bands or other items on clothing or equipment without prior approval. Messages related to politi-

cal, religious or racial activities or causes are not allowed. When asked for comment on Wednesday, the ICC directed reporters to the relevant regulations which make clear that the global governing body is the final arbiter of what is allowed and what constitutes a "political, religious or racial cause'

England batsman Moeen Ali, who like Khawaja is a Muslim with Pakistani heritage, was banned by the ICC in 2014 from wearing wristbands featuring the slogans "Save Gaza" and "Free Palestine". The ICC did, however, allow players to "take the knee" before international matches in support of the 'Black Lives Matter' movement in 2020 and 2021.

"What I've written on my shoes isn't political. I'm not taking sides. Human life to me is equal," Khawaja added. "One Jewish life is equal to one Muslim life is equal to one Hindu life, and so on. I'm just speaking up for those who don't have a voice."

Cricket Australia said in a statement that Khawaja had a right to express his opinion but they expected him to conform to the ICC rules banning displays on his playing equipment. Australia's Sports Minister Anika Wells gave Khawaja her full backing.

"Usman Khawaja is a great athlete and a great Australian. He should have every right to speak up on matters that are important to him," she said. "He has done so in a peaceful and respectful way. He has done so as an individual and expressed an individual opinion that does not compromise the Australian cricket team's obligations to the ICC.'
