65% Kashmir's Teen Students Suffering From Academic Stress: Study

Srinagar: A new study conducted by the Institute of Mental Health and Neurosciences (IMHANS) has shown widespread academic stress prevalent among students in Kashmir, with health experts advising parents and guardians to closely monitor the children and take preventive measures to address any emerging mental health concerns they may face.

The study shows that at least 60-65% of school-going adolescents are suffering from academic related stress in Kashmir.

The study, titled "Prevalence of psychiatric morbidity among school-going adolescents in the age group of 13–19 years," asserts that there is a very high prevalence of psychiatric morbidity (anxiety combined with depression) of any kind among adolescents in Kashmir, many of which are unidentified and thus untreated.

The study found depression as the most common



psychiatric illness among prevalence in males, while adolescents with a higher anxiety disorders are more common among females. The study was carried out on 16 schools in the twin districts

of Srinagar and Ganderbal. 'Stress plays an essential role in the development of various illnesses. Academic stress, stresses from personal life and environment, as well as the ones arising from conflict may be important," the study says.

Dr. Ubaid Rasool, one of the authors of the study, told Kashmir Observer that they wanted to carry out the study in rural and urban areas and thus chose Srinagar and

Ganderbal for the purpose. 'Even though there were similar disorders in Srinagar and Ganderbal, but the academic stress is more predominant in Ganderbal district which is a rural area," Dr. Rasool said.

The reason, Dr. Rasool said, is that the kids in urban areas go for more outdoor activities than children from rural areas. The results of the study highlight a worrying pattern of academic stress affecting students of classes 9 to12, re-

Rs 1.88 Cr Chit Fund Fraud Two Women Cops Charge-Sheeted By Crime Branch

Srinagar: Two policewomen, involved in swindling Rs 1.88 crore from their colleagues, were chargesheeted before a court in Jammu on Friday for judicial determination

The Economic Offences Wing – Crime Branch, Jammu produced 382 page chargesheet against selection grade Constables Nirmal Kour Saini of IRP 15th battalion and Arti Sharma of 4th Security PID, before the Court of law for judicial determination for hatching criminal conspiracy and cheating the complainant along with other co-employees of IRP 15th battalion of Rs 1, 87, 64,000.00 after luring them on the pretext of hefty returns for investing money and gold with them.

The chargesheet was produced in the case 23/2014 U/S 420, 406, 120-B RPC registered at the police station EOW, Jammu in 2014.

The case surfaced when the Crime Branch, now EOW. received an enquiry re-

Right To Property Falls Within Realm Of Human Rights: HC

Directs Payment Of Rs 2.49 Cr **Rentals To Displaced** Persons For 224 Kanal Land In Jammu **M** Ahmad

Srinagar: Underlining that the right to property is now considered to be not only constitutional or statutory right but falls within the realm of human rights, the High Court of J&K and Ladakh has directed government to pay rental compensation amounting to Rs. 2.49 Crore to displaced persons of 1947 to whom over 224 kanals land was



allotted in 1953. The rentals were assessed by the State Government from 01.01.1978 to 31.03.2009 for the land measuring 224 Kanals and 10 Marlas in Chatha Jammu which is under Army, according to a petition filed before the court on behalf of all descendents of 24 displaced persons. According to the petitioners, they are displaced persons

of 1947 from Tehsil Bagh Village Dhare, Pak, and the erstwhile State of Jammu and Kashmir in its policy to rehabilitate the refugees of 1947 allotted the land to them. ...the Army has been in occu-

pation of the land in question since long and also that the land owners are not being paid the rental compensation in time," a bench of Justice Wasim Sadiq Nargal.

"It further transpires that land of the petitioners are being formally acquired not by the respondents (Union of India) by having resort to Right to Fair Compensation and Transparency in Land Acquisition Rehabilitation Act, 2013," the court said, adding, "This court finds | More on P6

JKSCB Loan Fraud Case **ED Attaches Land Worth Over Rs 193 Cr In Srinagar**

New Delhi: A land in Srinagar worth more than Rs 193 crore has been attached by the Enforcement Directorate under the anti-money laundering law as part of an investigation into a loan fraud involving the Jammu and Kashmir State Cooperative Bank (JKSCB).

A provisional order has been issued under the Prevention of Money Laundering Act (PMLA) to freeze the asset, which measures 257.19 kanal and is located in the Shivpora area of Srinagar, the federal agency said in a statement.

Rs 193.46 crore, it said.

The agency, earlier this month, had arrested former JKSCB chairman Mohammad Shafi Dar and Mohammad Hilal A Mir, the chairman of the River Jhelum Cooperative House Building Society, a "fictitious firm", as part of the investigation. They are in judicial custody till December 20.

The PMLA case pertains to an alleged fraud in sanctioning of a loan to the tune of Rs 250 crore (disbursement amount Rs 223 crore) in 2019 to the River Jehlum Co-operative House Building Society by Dar. The Enforcement Directorate (ED) took | More on P6

'Climate Change Could Melt Frozen Methane From Deep Ocean Waters'

limate change could melt the frozen methane trapped under oceans, releasing the potent greenhouse gas, methane, into these water bodies, researchers have found.

They said that as frozen methane and ice melted, methane moved from the deepest parts of the continental slope to the edge of the underwater shelf.

The researchers led by Newcastle University, UK, also discovered a pocket of the released methane, which they said had moved about 25 miles, or 40 kilometres.

This meant that more methane could potentially be vulnerable and released into the atmosphere as a result of climate warming, the researchers said in their study published in the journal Nature Geoscience.

Frozen methane refers to the compound methane hydrate, an ice-like structure found buried in the ocean floor. As the oceans warm, these structures thaw, thereby releasing the methane into the oceans and the atmosphere as dissociated methane and contributing to global warming. Methane is the second most abundant human activity-driven greenhouse gas after carbon dioxide (CO2).

"Scientists had previously thought this hydrate was not vulnerable to climatic warming, but we have shown that some of it is," said lead author Richard Davies, Newcastle University.

Previous studies have shown bottom water temperature changes near continental margins to affect the release of methane from the frozen structures.

However, these studies mainly focused on areas where only a small portion of global methane hydrates are located, the researchers said.

Their study was one of those few which investigate the release of methane from the base of the hydrate stability zone, which is deeper underwater, they said.

"This is an important discovery. The new data clearly show that far larger volumes of methane may be liberated from marine hy-

drates and we really have to get to the bottom of this to understand better the role of hydrates in the climate system," said Christian Berndt, Head of the Research Unit Marine Geodynamics, GEOMAR, in Kiel, Germany.

The scientists examined the portion of the hydrate that dissociated under warming climate off the coast of Mauritania in Northwest Africa using seismic imaging techniques.

They found that the dissociated methane had migrated over 40 kilometres and was released through a field of underwater depressions, known as pockmarks, during past warm periods.

"It was a Covid lockdown discovery, I revisited imaging of strata just under the modern seafloor offshore of Mauritania and pretty much stumbled over 23 pockmarks.

"Our work shows they formed because methane released from hydrate, from the deepest parts of the continental slope vented into the ocean," said Davies.

The researchers said that the study findings could help in predicting and addressing the impact of methane on our changing climate.



Div Com Chairs Meeting On Allotment Of Land For Graveyards

Inspects Progress Of Work On Barzulla Bund Road

Srinagar: Divisional Commissioner Kashmir Vijav Kumar Bidhuri today chaired a meeting regarding allotment of land exclusively for graveyards to various societies, Mohalla's & communities in Bemina area.

The meeting was attended by Vice Chairman Srinagar Development Authority, Director SDA, ACC with Div com and ADC Srinagar.

The meeting deliberated over the allotment of 34 kanals of land to various societies, adjoining Mohalla's of Bemina, Christian community, people from remote areas who are unable to shift dead bodies during winters and reserved patch of graveyard to be utilized during exigencies.

The land will be given against the premium to be paid by societies, Mohalla & communities. The land allotted falls under transmission lines and is considered as no construction zone.

The graveyards shall be developed through a layout design to be prepared by Srinagar Development Authority with due consideration to be given to the aesthetics, greenery and plantation.

To put an end to the traffic congestion and recurring traffic jam on Natipora road, the Div Com during his spot visit impressed upon the R&B

officers to make Barzulla Bund Road functional by the end of December.

The Div Com was accompanied by senior officers of R&B, Traffic Police and revenue officials.

It is worth mentioning here that a road is being constructed from Natipora to Barzulla Bridge to divert the traffic during peak hours to ease the traffic flow on the main road.

Div Com while walking the entire length of the road inspected the completed as well as ongoing works on the road. He instructed for removal of encroachments from the road and expedited the completion of pending work.

He was informed that half of the road has been completed while another half is being developed and shall be completed within fifteen days.

The locals on the occasion expressed gratitude to the Divisional Administration for addressing their long pending demand of putting an end to recurring traffic jams at Natipora by the development of parallel Bund Road.

The Div Com also inspected the ongoing works of development of walkway and cycle track on the left bank of Barzulla Canal.

On the occasion, he was briefed about the beautification and development projects being executed by SSCL.

Govt To Replace Faulty Transformers Within 4 Hours From Twin Cities

Srinagar: Amid surge in damage to electric transformers, the government is mulling to replace damaged transformers in four hours in city areas of both Jammu and Kashmir regions.

However, in case of damage to electric transformers in rural areas, authorities said that they will replace it within 24-hours.

Principal Secretary Power Development Department (PDD) H. Rajesh Prasad said "We want damaged transformers to be maintained and replaced at earliest because when there would be no transformer in the area, there will

not be electricity.' The Principal Secretary however said that it may take more than 24 hours for PDD to replace the transformers in far flung places.

When asked about the installation of smart meters, Prasad said, "Out of 21 lakh consumers, as of now we have already installed 4.27 Lakh smart meters in Jammu and Kashmir.'


About the unscheduled pow-

er cuts, the principal secretary said that the government has already instructed the concerned authorities to stick to the prescribed schedule.

"We have also instructed that there shall not be any unscheduled power cuts unless that is required for the maintenance purposes," he said.

On asking about the complaints of ongoing unscheduled power cuts in various areas of Kashmir region, Prasad said, "We will streamline everything and will not keep any gap.³

"In some areas the unscheduled power cuts may occur due to technical difficulties," he said. Meanwhile, locals of various parts of South, north and Central Kashmir are facing unscheduled cuts during day time especially during evening hours. They sought the LG Manoj Sinha's intervention to end the pesky power cuts during bone chilling cold.

Unveiling The Enigma Why Private Schools Trump Government Schools in J&K

The scenario **is** complex – with parents grappling with various socioeconomic challenges, educational priorities might not always be at the forefront of their concerns. This lack of vigilant parental involvement inadvertently creates an environment where some teachers become lax in their commitment to imparting education competently

espite government schools boasting wellequipped facilities and highly qualified teachers, private schools continue to be the preferred choice for students in J&K. Government teachers, despite being well-trained and receiving competitive salaries, struggle to attract students. The Annual Status of Education Report (ASER)-2022, released in New Delhi by Pratham Education Foundation Chairman, shed light on a concerning trend in Jammu and Kashmir's education landscape. The report revealed that a substantial 43.6% of children in the region are enrolled in private schools, significantly higher than the national average. Meanwhile, government school enrollment has fallen to 55.5%, a stark contrast to the 72.9% national figure.

In the Valley, there are approximately 10,780 government schools. Despite the presence of qualified teachers and substantial salaries, government schools are unfortunately perceived as institutions primarily catering to the underprivileged. The challenge for government school teachers lies in convincing parents, including themselves, that government schools are capable of providing quality education. Parents are willingly paying hefty monthly fees to private schools, where teachers earn relatively modest salaries ranging from Rs 8,000 to Rs 10,000. In contrast, government schools, which offer education without charging any fees, struggle to gain the trust of parents, even when their teachers earn more substantial monthly salaries ranging from Rs 50,000 to Rs 70,000.

If truth be told, government school teachers themselves often lack confidence in the institutions where they work. Rather than entrusting their children's education to the very schools they teach in, they opt for private alternatives. This inclination suggests a prevailing mindset among educators that they should earn from government schools but invest in private education for their own children. This perception raises concerns about how others can be expected to trust and invest in these schools when even the educators choose private alternatives.

When it comes to education, the focus has often been on the perceived advantages of private schools – better infrastructure, quality teaching, and a more conducive learning environment. However, amidst this narrative, the untapped potential of government schools often goes unnoticed. Contrary to popular belief, in many cases, the infrastructure in government schools is on par with or even surpasses that of private schools. Quality of teachers in government schools is apodictically better than private schools. Therefore, it is not a lack of resources or dedicated teachers that plagues these institutions, but rather the persistent mindset and stigma and improper utilization of available resources.

The need of the hour is a paradigm shift – a collective effort to change the narrative surrounding government schools. It is crucial for the government to initiate a positive campaign promoting government schools as the primary choice for children. This campaign should not merely focus on the aspect of free education but highlight the myriad of facilities and opportunities these schools offer. Rather than limiting policies to the provision of free education, the

government should aim at elevating standards across the board. This involves implementing measures that ensure a high-quality learning experience, making government schools not just a viable but a preferable choice for students.

To bridge this gap, government teachers also have a role. They should take the lead by enrolling their own children in the schools where they teach. This move could serve as a powerful example, encouraging others to trust and have faith in government schools. It is a call for government teachers to believe in the sector they are a part of and demonstrate this belief by making a personal investment in the education it provides.

In government schools, where a majority of students hail from underprivileged backgrounds, it is essential for educators to rise above the challenges and deliver quality education. Unfortunately, a portion of teachers succumbs to complacency, influenced by the perception that parents are less likely to scrutinize their children's academic progress.

The scenario is complex – with parents grappling with various socio-economic challenges, educational priorities might not always be at the forefront of their concerns. This lack of vigilant parental involvement inadvertently creates an environment where some teachers become lax in their commitment to imparting education competently.

Policymakers need to implement measures that foster stronger connections between schools and parents. This could include regular parent-teacher meetings, awareness campaigns, and initiatives to engage parents in their child's educational journey. By creating a culture of accountability, where teachers are held to high standards and parents actively participate in their child's education, the cycle of apathy can be broken.

Additionally, introducing performance-based incentives for teachers can serve as a catalyst for renewed dedication. Recognizing and rewarding educators for their efforts in creating a positive impact on students' lives can inspire a sense of responsibility and commitment.

The key to success lies in a comprehensive approach that goes beyond the rhetoric of free education. It involves fostering a positive mindset, eradicating stigma, and actively promoting the strengths of government schools. The time is ripe for the government to spearhead this transformation and unlock the true potential of these institutions, paving the way for a brighter future for the next generation.

The conundrum of private versus government school enrollment in Jammu and Kashmir highlights a pressing need for a shift in perception. Government teachers must lead by example, trusting in the sector they serve and enrolling their children in government schools. Only through such personal investment can faith be restored in government education, paving the way for a more equitable and robust educational system in the region.

Winter: A Season of Merry or Misery?

J EHANGIR'S "Firdaus" and "Behisht" of all poets and philosophers, blanketed in a thick layer of snow, illuminating the brightest colors of nature is undoubted, a sight for sore eyes. Starting the day with the delicious Kashmiri delicacy "Harisa", warming yourself up using "Kangris" or the "Hammam", and listening to the melody of nature while spending time with your loved ones, is a sugarcoated glance of Winters in Kashmir.

The reality is, that the envelope of snow, other than beauty brings with it an unwelcomed state of misery, and struggle for Kashmiris, one short glimpse of which was recently shared with us via different social media platforms. Two pregnant women, in different cities of Kashmir, were carried on cot for several Km's to the neighboring hospitals, one of them delivered a baby midway. Locals asserted that the lax attitude of the administration towards de-icing of roads is the cause of the problem.

De-icing of roads has never been given the required importance. For almost half of the winter, the roads remain blocked, the Srinagar-Jammu highway remains closed for vehicular traffic, therefore, bringing the lives of people to a standstill. The poor and in-efficient drainage system has added fuel to the fire. A few inches of snow leads to waterlogging in all of the major roadways of Srinagar, water from drains overflows into the roads, therefore, turning them into a "cesspool". People have made Innumerable requests and protests to the administration, demanding a modern drainage system, however, the current administration as well as all the preceding governments turned a blind eye towards the issue. In 2019, a senior official at SMC stated that the carrying capacity of drains has decreased considerably due to the silt accumulation during the 2014 floods. He further stated that tenders were issued in this regard however, SMC received no proper response.

Draining out of clogged water from roadways comes with collateral damage i.e., "damaging of roads". A few inches of snow or rain drastically damages the roads and the government dubiously argues that the "macadam" used is incapable of withstanding elements of rain or snow. Thereby, contradicting their boastful statements about the "excellent quality" of material used in the construction of roads.

The subzero temperature of Kashmir accompanied by unprecedented power cuts, continuous blackouts, shortage of essentials and traffic snarls is not a favorable combination. The issue of power cuts is one of the longest unsolved crises of the valley. Despite having the potential to produce 20,000 megawatts of hydropower, currently, the state only produces 3,263 MW, of which 2900 MW is generated by the NHPC (National Hydro Power Corporation). Merely 13% of the power generated by the NHPC is shared with Kashmir, and the power requirements of the state are met by purchasing electricity at sky-high rates from the northern grid of India. Nonetheless, Kashmiris are left with less than 9hrs of electricity per day.

Even though everyone in Kashmir is affected by the same difficulties, the upper class still manages to keep a safe dis-



tance from them. Poverty fuels the hardships faced by people, some struggles in winters are poor-centric and "Government initiatives", are not strong enough to prevent the harsh weather from reaching the poor families. Winters highlight the abyss of gulf between different classes, an exorbitant difference of perspectives between various social groups becomes evident. While an elite enjoys the chilly weather, the poor living on boulevards of Dal Lake struggles due to waterlogging and freezing temperatures. When forecasts predict harsh weather, people begin stocking up essentials ahead of time. But, if resources are scarce, the option of hoarding is not available to people. Furthermore, the

snowfall extensively damages the apple orchards, uproots and damages trees as a result, jeopardizing the livelihood of people living in the outskirts of Kashmir. Last year, untimely snowfall led to extensive damaging of apple orchards, the government decided to compensate however, many haven't still received any reimbursement. The government fixed a modest compensation rate of Rs. 2800 per Kanal, and surprisingly, failed to pay it.

In the olden times, winters were welcomed and celebrated by people. However, since the '90s, winters have marked the inception of a loop of miseries and struggle for the Kashmiri people. The arrival of winters is no more marked by

the foliage of autumn leaves instead, it has been replaced by frequent power outages. Day in and out, the valley plunges into blackouts and residents are forced to endure long, harsh winter days without electricity. The government usually flaunts about the developments in Kashmir or about the construction of roads, however, on the realistic ground, nothing really has changed. A drizzle of rain makes Kashmir vulnerable to floods, snowfall disrupts normal life, causes fatalities, accidents and whatnot. The unpreparedness of government, their lackadaisical attitude towards miseries of people worsens the already harsh condition faced by people. Kashmiris still live in a time where developments are rare, connections are scarce and facilities uncommon.

With time, it seems like the idea of Winters being a "season of merry and blessings" will only remain constricted to poets and philosophers. The onset of winters cannot be celebrated until and unless the grievances and concerns of people are heard. Truly, Winter is a season of blessings, a season that displays the true beauty of nature and has a magical effect of resurrecting our dead spirits. In the words of Agha Shahid Ali,

"Snow gleams as if a lover's gaze has fallen to earth. How the season whitens! Even the evergreens are peppered with salt, and only love can take the place of the mountain".

unknowingly get ourselves drowned into more self-pity and self-hate at the same time and that is what makes us chaotic inside out.



New Delhi: The Defence Ministry on Friday said a successful flight trial of an indigenous high-speed flying-wing unmanned aerial vehicle (UAV) was carried out in Karnataka's Chitradurga that propelled India into an elite club of nations to have the technology to produce such a platform.

The autonomous flying wing technology demonstrator has been developed by the Defence Research and Development Organisation (DRDO).

"The DRDO has successfully carried out a flight trial of autonomous flying wing technology demonstrator, an indigenous high-speed flying-wing Unmanned Aerial Vehicle (UAV) from the aeronautical test range in Chitradurga," the ministry said.

successful flying The demonstration of this autonomous stealth UAV is a testimony to maturity in the technology readiness levels in the country, it said. "With this flight in the tail-

less configuration, India has joined the elite club of countries to have mastered the controls for the flying wing technology," the Defence Ministry said.

Defence Minister Rajnath Singh has complimented the DRDO, the armed forces and the industry for the successful flight trial of the system. He said the successful development of such critical technologies indigenously will further strengthen the armed forces.

Parliament security breach accused Sagar Sharma talked about 'dying for nation' in his diary

Lucknow: Sagar Sharma, one of the two men who had jumped into the Lok Sabha chamber and set off smoke canisters, maintained for some years a diary in which he often wrote "Inquilab Zindabad" on top of the page and at one stage talked about "dying for the nation".

'I have given my life to the nation. I have taken a step towards freedom. Now the turn will come to die for the nation. I have already rested a lot," he wrote in Hindi on June 13, 2015. Sharma (28), a resident of

Ramnagar in Lucknow, maintained the diary from 2015 to 2021, keeping it along with his books that included crime novels and a Hindi translation of Adolf Hitler's Mein Kampf, police officials said.

Family members of Sharma gave the diary to the local police who then handed it over to their Delhi counterparts investigating Wednesday's security breach in Parliament.

The diary entries are not regular. It included his thoughts on society, poems and couplets by revolutionaries and freedom fighters. In one such entry, Sharma

wrote "Sarfaroshi ki tamanna ab hamaare dil mein hai, dekhna hai zor kitna baazu-e-qaatil mein hai" -- a couplet that was made famous by Ram Prasad Bismil as a war cry during the British rule.

On February 6, 2021, Sharma wrote, "Ghar se vida lene ka samay najdik aa gaya hai (It's almost time to bid adieu to home). On one hand, there is a fear and on the other the fiery determi-

nation to go through anything." "I have waited every moment of five years for the time when I will move towards my duty. The



strongest person in the world is not one who knows how to snatch but the one who can give up everything," he added.

In a diary entry on June 12, 2015, Sharma wrote, "The modesty of daughters is being looted in the open here. Then why are we sitting patiently with folded hands?

The very next day, he wrote about giving his life for the nation.

Police sources, quoting the family members, said that Sharma studied till class 12 and tried to join the army but failed despite several attempts. He later moved to Bengaluru for a few years. After returning home a few months ago, Sagar began driving an e-rickshaw.

According to the family members, while leaving home on Monday, Sagar told them that he was going to Delhi to take part in a protest. His kin claimed that were unaware of his involvement in the Parliament security breach.

Satyam Singh, a friend of Sagar said that he wanted to study more after class 12 and talked about financial constraints.

"He wanted to do something for his family. He talked of

earning an honest living without harming anyone. I find it hard to believe that he took such an extreme measure of causing a ruckus inside Parliament," he said.

According to the police, Sagar's father Roshan Lal is a carpenter while his mother Rani is a homemaker. The family hails from the Unnao district of Uttar Pradesh but has been living in a rented accommodation in Lucknow for over a decade.

In a major security breach on the anniversary of the 2001 Parliament terror attack on Wednesday, Sagar Sharma and Manoranjan D jumped into the Lok Sabha chamber from the public gallery during Zero Hour, released yellow smoke from canisters and shouted slogans before being overpowered by MPs.

Around the same time, two others, including a woman, raised slogans and released yellow smoke from canisters outside the Parliament premises, prompting police to round up the duo.

The four persons have been arrested and slapped with terror charges under the Unlawful Activities (Prevention) Act.

8 years after project sanction, Asia's biggest ice skating rink in Shimla awaits its implementation

Shimla: Nearly eight years after it was sanctioned, Asia's biggest natural ice skating rink in Shimla awaits its conversion into an artificial rink so that skating sessions could be held throughout the year.

Members of the ice skating club the capital city expressed apprehension on the lack of "concrete steps" taken on the project and the shrinking skating season.

The all-weather ice skating rink would be constructed at a cost of Rs 40 crore, members said citing the detailed project report (DPR). An all-weather ice skating

rink would be a tourist attraction in Shimla and could help tackle drug abuse among the youth, club members said addressing mediapersons on

Friday. Absence of sports and other activities is one of the reasons youth take to drugs, they said.

Under the project, a covered artificial rink would be constructed with facilities for parking, changing rooms, a restaurant, among others so as to be able to organise national and international events, according to Rajat Malhotra and Sudeep Mahajan both executive members of the club.

championships National for speed skating and figure skating were organised in Shimla till 2010, club secretary Manpreet Singh Sambhi told mediapersons.

In 2016, the project was sanctioned at a cost of Rs 13 crore project Atal Mission Rejuvenation for and Transformation (AMRUT) project but the Covid pandemic stalled its implementation, said Abhay, an executive



member of the ice skating club.

Later the project came under the Asian Development Bank (ADB), was then part of the smart city project and now the project is being funded by the ADB and implemented by the tourism department, he said. The project is still at the tendering stage, he added.

Club members also expressed apprehension that the skating season has not yet begun this year. Last year, the season began on December 14 later than the expected November-end and only had 35 sessions.

In 1972, the least number of sessions were held at 12 sessions. Most sessions were held in 1996-97 at 118 sessions.

Climate change, felling of trees, construction in the vicinity of the existing rink, the demolition of Rivoli Theatre above the rink that used to block direct sunlight on the rink coupled with pollution caused by the nearby bus stand, temperatures have in-creased and the ice skating

season is shrinking. Unusual rise in maximum temperatures has delayed the commencement of the season as clear sky and low temperature are a prerequisite for a good season, said Pankaj Prabhakar, another club member.

SC to hear plea of Indian detained in Czech Republic for foiled plot to kill Sikh separatist in US

New Delhi: The Supreme Court on Friday deferred the hearing for January 4, 2024 on a habeas corpus plea moved by a family member of Indian national Nikhil Gupta, who has been accused of plotting an assassination attempt on Sikh separatist Gurpatwant Singh Pannun on American soil.

Gupta was arrested in the Czech Republic on June 30. He has alleged grave human rights violations in solitary confinement, including being forced to consume beef and pork. He has also alleged that he was denied consular access, the right to contact his family in India and the freedom to seek legal representation.

and S V N Bhatti described the matter as an "extremely sensitive issue for the Ministry of External Affairs" and told senior advocate C A Sundaram, representing Gupta, to approach a court in the Czech Republic, where his client is lodged in a jail.

Sundaram told the bench that he is not pressing his habeas corpus prayer at this stage, but only seeking consular access and a direction to the Indian envoy in the European country to find out about the status of the case as his

client is not being told anything. The bench asked the senior

friend" of the detenu.

Justice Khanna said since he got the case file late, he was not able to go through it. "We will take up the matter on January 4, after the winter break," he said. Sundaram requested that the mat-

ter be taken up in-camera as several sensitive issues are involved.

"We will see that on January 4." Justice Khanna said and allowed Sundaram to serve a copy of the case file to Attorney General R Venkataramani.

On November 29, Gupta was charged by federal prosecutors in the United States in connection with his alleged participation in a foiled plot to assassinate Pannun on American soil. The 52-year-old was charged with murder-for-hire, which carries a

maximum sentence of 10 years in prison, and conspiracy to commit murderfor-hire, which carries a maximum sentence of a 10-year jail term.

US authorities had said Gupta agreed to pay an assassin USD 100,000 to kill the Sikh separatist leader living in New York City.

The prosecutors had said Czech authorities arrested and detained Gupta on June 30, pursuant to the bilateral extradition treaty between the US and the Czech Republic.

Gupta was arrested in the Czech Republic at the request of the US in connection with his alleged participation in the plot to kill Pannun.

Moreover, he alleges that he was denied consular access, the right to contact his family in India, and the freedom to seek legal representation," the plea save

substantial portion experiencing depression, anxiety, and various other mental health challenges.

"Almost all of the students report high academic stress. The teachers need to change their attitude towards the students," Dr. Rasool added.

The study reveals that 13.7% major depressive disorder is prevalent among school-going adolescents, obsessive compulsive disorder 4.0%, panic disorder 1.4%, self-harming behavior 2.5%, generalized anxiety disorder 2.5%, social anxiety disorder 2.2%, dysthymia 1.7%, and adjustment disorder 0.8%

The study found that the panic disorder and borderline personality disorder as a group were more commonly found among females compared to males. Also, 34% from urban and 28% from rural areas met the criteria for any psychiatric disorder, it noted.

The study says children and adolescents represent a tender part of the human life cycle and they may be at a higher risk of psychiatric disorders.

Dr. Rasool who is also consultant, Psychiatry, IMHANS-K said many children whom they examined were disturbed and stressed due to certain events like encounter, killings or any other untoward incidents in their locality.

He said while many were stressed due to their issues in family like parental discords and divorces.

"Poverty, academic stress and trauma after a killing in the locality was prominent among the children," Dr. Rasool added

He further said that the team wasn't expecting such a high rate of psychological issues among the kids.

"...The most surprising thing was they didn't know about their disease, like depression and anxiety and many of them were living without any treatment." he added.

The study said there is a need for further research in this age group and teachers and parents need psycho-education for identification of such children.

"The parents should be sensitive enough to understand that their child is under stress and any negative happening at home or outside will impact their mind," Dr. Rasool added.

Dr Yasir Hassan, Professor at IMHANS told Kashmir Observer that if these mental health issues aren't addressed in teenage, the patients can develop suicidal tendencies in future.

"This is the age where maximum mental health issues including depression and anxiety start," he said, adding that IMHANS witnesses overwhelming cases of "self-cutting/selfarming" cases nowadays.

"This was not common earlier .However, today it is prevalent and it means a cry of mental health," he added.

Notably. Jammu and Kashmir ranked highest in attempted suicides across the country in 2022, as per the National Crime Records Bureau (NCRB). Out of the 1769 instances reported throughout India during the year, 497 were specifically recorded in Jammu and Kashmir.

PCB Signs Hosting Agreement For 2025 Champions Trophy

KARACHI: Pakistan Cricket Board (PCB) on Friday said it signed the hosting rights agreement of the 2025 Champions Trophy with the International Cricket Council (ICC) in Dubai.

The agreement for the 2025 mega event was signed by Zaka Ashraf who heads the Cricket Management Committee running the PCB affairs at the moment.

"Chairman PCB Management Committee Mr Zaka Ashraf was joined by ICC General Counsel Jonathan Hall in the signing of the hosting rights to Pakistan at the ICC headquarters," the PCB said in a statement.

Pakistan last hosted an ICC event in 1996 -- the ODI World Cup.

Pakistan was guaranteed to host the 2009 Champions Trophy and also matches of the 2011 World Cup at home but the terrorist attack on the Sri Lankan team in March 2009 in Lahore led to both events being moved from the country due to security concerns. The biggest challenge sur-

rounding Pakistan hosting the Champions Trophy remains whether the Indian government would allow its team to travel to Pakistan for its matches.

The PCB had to agree to a hybrid model of the Asia Cup in August-September and share matches with Sri Lanka after the BCCI said its team would not play in Pakistan due to security concerns.

Pakistan did host the 2008 Asia Cup in entirety and that was the last time India played in Pakistan.

The PCB said in a statement that it has already conveyed to the government to provide foolproof security to visiting international teams for the Champions Trophy.

"The PCB in its capacity has already intimated the government to provide foolproof security to visiting international teams for the Champions Trophy," the PCB statement added.

''Caretaker Prime Minister Anwaar-ul-Haq Kakar in a recent meeting with Chairman PCB Management Committee assured the security agencies' cooperation in the successful hosting of the ICC Champions Trophy 2025.

Another logistical problem facing the PCB would be to get its existing international venues renovated and ready for the matches of the mega event. Presently, only Karachi, Lahore and Multan have stadiums capable of hosting Champions Trophy games.
