Among 17 Die In **Two Years In J&K Doctors Recommend** Secure Heating Practices

Srinagar: Over the past two years, seventeen individuals have tragically lost their lives in Jammu and Kashmir due to asphyxia-an alarming phenomenon that predominantly surfaces during the winter months in Kashmir.

According to doctors, as-phyxiation is caused by lack of oxygen, which can quickly lead to brain hemorrhage, unconsciousness, and even death. The primary causes of winter-related fatalities are often linked to asphyxiation stemming from inadequately vented heating sources, or heart attacks due to overexertion while shoveling snow.

News reports reveal that six children and eleven adults have succumbed to asphyxiation since | More on P6

Srinagar: A senior CRPF officer on Monday said terrorism in Jammu and Kashmir is no longer fashionable but considered a "dirty word" now.

3 Earthquakes Hit Ladakh, Another **Jolts Kishtwar** Press Trust Of India

Jammu: A 5.5-magnitude earth-quake followed by two aftershocks of lower intensity struck the Union Territory of Ladakh within 15 minutes, while a mildintensity tremor was felt in Jammu and Kashmir's Kishtwar on Monday, officials said.

There were no immediate reports of any casualty or damage, they said.

According to the National Centre of Seismology (NCS), the 5.5-magnitude earthquake occurred at 3.48 pm and its epicentre was Kargil.

The depth of the tremor was 10 km below the surface at a latitude of 33.41 degrees and longitude of 76.70 degrees, it said.

It was followed by two aftershocks of 4.8 and 3.8 intensity at 4.01 pm, the NCS said.

HC Allows Man To Open Windows Of His Home After 5 Yrs

Srinagar: A family in Budgam has been allowed by the High Court of J&K and Ladakh to construct windows of their house, more than five years after being restrained to do so by a civil court upon a suit by their neighbour.

A bench of Justice Atul Sreedharan also rejected the contention by the neighbour about infringing upon the privacy, underling that it was for them to take necessary steps to ensure the same.

"Undoubtedly, the petitioner has a right of opening of windows on his property even if they are facing towards the house of the plaintiff/respondent (neighbour)," the Court said while allowing plea from a resident of Yarikhah area of Khansahib Budgam, seeking court's permission to allow him construct window facing towards his neighbour after being restrained by a civil court in July 2018.

Respiratory Illness Surges Demand Of Öxygen Cylinders In Kashmir

Srinagar: Kashmir valley is experiencing a heightened demand for oxygen cylinders this winter - a surge linked to an uptick in pulmonary issues among its residents.

SRO Kashmir Foundation, an NGO based in Srinagar dedicated to addressing pulmonary needs, has reported a substantial rise in the demand for oxygen throughout the valley.

Javed Ahmad Dar, the Chairperson of SRO Kashmir Foundation, told Kashmir Observer that a large number of patients are flocking to the NGO's office in Batamaloo seeking oxygen cylinders and other essential medical equipment.

"We have a stock of around 850 oxygen cylinders and we would refill them once a week as part of our routine.



However, with the onset of winter, there has been a drastic change and now the need to refill cylinders on a daily basis has become imperative." Javed said. Alongside the increased

demand for oxygen cylinders,



Integrated Approach Needed

In the goal of "zero infiltration, zero terror recruitment, zero smuggling of arms and ammunition." The DGP Swain revealed that the number of local militants has diminished to fewer than 20, the looming specter of foreign militants, continues to cast a shadow over the Valley. Other measures highlighted by the DGP to finish the remaining local militancy include neutralizing "the narrative, an ideology, which justifies, glorifies and supports this (militancy), endorses this, legitimizes this."

However, it is also true that the challenge of foreign militancy remains very much real. According to the BSF Inspector General, Ashok Yadav, there are intelligence inputs that 250-300 militants are waiting at launchpads across the border. So, the presence of militants along the PoK side of the border, poised to breach the region's security barriers, is a stark reminder of the persistent threats that loom large. The vigilance and preparedness of the security forces, including the J&K Police, BSF and the Army, remains the key.

However, the challenge of tackling militancy in Kashmir transcends mere security measures. It necessitates a nuanced and mult-dimensional approach that interlaces security-centric initiatives with a political outreach. The decision by the Supreme Court upholding the abrogation of the Jammu and Kashmir special status and directing the Election Commission of India to conduct elections by September 2024 signals a step in this direction. It underlines the importance of a political roadmap to restore stability and address the aspirations of the region's inhabitants. True, security agencies have intensified efforts to curtail infiltration, recruitment, and arms smuggling. Yet, the challenges persist, primarily stemming from the steady influx of foreign militants.

That said, we need a combined approach—one that amalgamates robust security measures with astute political maneuvering. Political dialogue, community engagement, and socioeconomic development are indispensable facets that complement stringent security measures. It can be an integrated strategy, one that combines robust security measures aimed at thwarting external threats and a nuanced political approach focused on dialogue, inclusion, and development. Achieving lasting peace in the Valley necessitates not just silencing guns but also addressing the undercurrents that fuel the cycle of violence. It's a collective endeavor that requires a concerted security and political effort to build a future where the echoes of conflict fade, allowing Kashmir to flourish in peace and prosperity.

'Ur-lish' Tongue, A Fusion Transforming Conversations

du-speaking environment, a fusion of my mother's roots in the Sher-e-Khaas area of Srinagar and my father's heritage from South Kashmir. Our home embraced Urdu wholeheartedly, where the love for this language was so profound that it led to a ban on any other languages. Speaking Urdu became a necessity for my siblings and me, shaping the linguistic ambiance of our household.

Fortunately, my aunt's proficiency in Urdu and Persian facilitated our immersion in the language. However, our Urdu pronunciation and intonation differed from the typical Kashmiri Urdu, leading people, especially at school, to perceive us as Hindus.

Although I could understand Kashmiri very well,however, when it came to speaking, I always found myself at a loss.I could barely utter a word in Kashmiri, and my attempts often turned me into a source of laughter. In those days Kashmiri dominated as the primary language in schools, with English and Urdu less prevalent though the schools were English mediums.

As time progressed, our cousins and extended family, both close and distant, also embraced Urdu as their primary language. Similar shifts were occurring in societal dynamics during that period, witnessing the passing on of Urdu linguistic traditions to the younger generation.

Delving into history, it wasn't until 1889 that Dogra rulers adopted Urdu as the language of administration in Kashmir. Prior to this, Persian served as the court and commercial language, exclusive to the learned and elite class.

The advent of television and other mediums played a pivotal role in reshaping people's lifestyles and furthering a preference for Urdu. The way there was a trend among people in Kashmir to shift from local shops to supermarkets and departmental stores, a similar trend started between the Kashmiri language and the Urdu language. People began giving Urdu language precedence over the Kashmiri language ,because speaking Urdu is seen as prestige and that it gives social mobility to people.

Furthermore, the rise of Urdu in Kashmiri households was influenced by Punjabi families who migrated to Kashmir from ken throughout the J&K region, Kashmiri's dialects and accents vary across different areas, much like regional accents within other languages. For example the regional accents and dialects differ greatly even within the United Kingdom –an Irish person sounds quite different from someone from the North of England. For many of us, when we think of UK English we think of 'the Queen's English'. However, it is actually only used by 2% of the population. United States English is the variant of English spoken in the United States. US English is the preferred variant in Latin America and East Asia (i.e. China, Japan and the Philippines). Just like British English, American English var

adds a musical tone to the conversation. This mixture sometimes involves stretching words, creating a distinctive musical sound. Sometimes, it becomes challenging to distinguish whether they are speaking Urdu or Kashmiri. For instance, it is very common to hear words like "kanduroo" (baker), "Kakil," "treth," "tawun," etc., like words ,when someone is conversing in Urdu.

However, a recent linguistic trend has caught on among the youth, aptly termed "Urlish" – a fusion of Urdu and English. This trend is gaining substantial popularity, particularly among social media influencers, users, RJs, and individuals involved in the media. Urlish is becoming a



ies widely from state to state, and there are lots of regional differences in vocabulary and accents.

Interestingly, upon their arrival in Srinagar, South Kashmir people (not all)prefer not to be identified by their accent. Consequently, they choose to converse in Urdu or English. The unfortunate fact that Srinagarites oftenly disparage the Kashmiri spoken in the south and other parts of Kashmir, labeling them as rustic while they regard the Kashmiri spoken in Srinagar as superior and correct. Consequently, many people for this reason, avoid speaking in Kashmiri when interacting with Srinagarites. This convolution between the people of South Kashmir and Srinagar is another compelling reason for many people from other districts to equip their children with Urdu or English skills rather than emphasizing the use of Kashmiri.

By virtue of these reasons, Urdu has become the preferred language for most people. It is no longer considered alien or a seclinguistic sensation, with individuals effortlessly conversing in two languages.

Notably, parents have embraced this linguistic fusion, especially when communicating with their children in public places. It has become commonplace to observe parents engaging in Urlish conversations with their children. For instance, in a departmental store, a young parent advised her little one, 'toy break mat karna varna shopkeeper beat karey ga'(Don't break the toy, otherwise, the shopkeeper will scold you). This amusing yet concerning sight left me guffawing coupled with a sense of unease, as I could sense the child's confusion. One can imagine the blend of English and Urdu words flawlessly inserted into this single sentence creating a delightful linguistic hotchpotch.

rom a rare upward swing this October, India's goods exports retreated into contraction last month, dipping 2.8% from 2022 levels to touch \$33.9 billion. Imports dropped 4.33% to \$54.5 billion, cooling the merchandise trade deficit to \$20.6 billion, almost a third below October's record high. Sequentially, the decline in imports was sharp, despite the Commerce Ministry lowering October's import bill by \$1.6 billion from the initial \$65 billion estimate. On the other hand, though exports contracted in November, they were higher than October's tally, which was the lowest in 12 months, yet denoted a year-on-year uptick unlike in November. Such statistical noise may be hard to listen through, but it is clear that exports have recorded their weakest values in a year, over the last two months. Similarly, the significant dip in imports in November can be attributed to factors like a decline in discretionary demand for high-value goods such as gems and jewellery and the global dip in prices of key items like petroleum products. Economists expect the deficit to stay range-bound between \$20 billion and 25 billion through the remaining four months of the year. But it is difficult to be certain — one may recall that imports had hit an 11-month high of \$60.1 billion in August before easing over 10% in September and resurging in October.

Making sense of such divergences, with a yo-yo effect of sorts every other month, is hazardous, and is exacerbated by significant data corrections that have returned after a few months of relative certainty. August's goods trade deficit was moderated by nearly three billion dollars, with the overall export-import tally seeing revisions of \$5 billion. The magnitude of upward revision in the monthly merchandise trade deficit has averaged around \$1.5 billion since July compared to an average of \$0.5 billion in the first quarter of 2023-24, a QuantEco research note has flagged. At the risk of repeating the obvious, the government must get a better grip on the data it bases its decisions on. Officials hope for an uptick in exports in the final quarter of the year, citing similar trends in recent years. With the World Trade Organization expecting global trade flows to strengthen in 2024 and the US Federal Reserve signalling interest rate cuts that other central banks would take a cue from, global demand may perhaps look up more consistently. But to capture that, India needs to do more to compete with rivals. For instance, a rough government-commissioned study on logistics costs indicates they dropped a little over the past decade. Ongoing infrastructure spends may gradually lower them further, but reducing petroleum prices for users, in tandem with global trends, would boost competitiveness far more effectively. The Hindu

Pakistan and other parts of India. Inter-religious marriages also played a role in the increased use of Urdu among the local population. It's worth adding that Kashmir has historically been a center of knowledge for Persian and Urdu. The region has produced brilliant minds that have enriched the literature of these languages.

The Kashmiri language, has taken a backseat and remained associated mainly with the older, illiterate, or those with no exposure to Urdu. Despite being spoond language (after Kashmiri), but is widely spoken across the length and breadth of the valley . On the contrary the perception that Kashmiri is spoken by 100 percent of the population may not be true, similar to the misconception about 'Queen's English.

Engrossingly, Urdu considered as first language and spoken in Kashmir is a unique blend of Urdu and Kashmiri, making it distinct from original Urdu. In contemporary times, it has evolved into what can be termed as 'Urkash,' a mix of Kashmiri and Urdu, akin to Hinglish, a combination of Hindi and English.

Urkash is a fascinating linguistic blend, often spoken by locals, even by those unfamiliar with Urdu, in social gatherings or crowds. It allows individuals to showcase their language prowess, with a unique intonation that veals that it is distorting our rich linguistic heritage passed down from our forefathers.

While multilingualism is undoubtedly valuable in our globalized world, distorting a language can lead to a loss of its richness and sweetness. It is the bottom line for our youngsters to be fluent in the languages they speak, maintaining the integrity of each. Encouraging our children to speak various languages is beneficial, but they should strive for mastery in at least one language while being proficient or at least acquainted with others. In this way, we can appreciate linguistic diversity without compromising the purity of each language.

New Resolve to Tackle Climate Change

The Dubai COP 28 summit, started a fortnight ago with little promise of any major breakthrough on climate rules. However, the governments and delegates this time proved their critics wrong and the final agreement announced that for the first time the world has agreed to move away from the coal, oil and natural gas that are the principal causes of global warming

hough right from the start or even before it started, the vibes from the Dubai Summit were not positive. However, as the jamboree ended, 198 countries announced that they are committed to phase out fossil fuels as they pose the main climate change accelerators.

ENDING FOSSIL FUELS

The countries agreed to contribute to a transition "away from fossil fuels in energy systems in a just, orderly and equitable manner, accelerating action in this critical decade, so as to achieve net zero by 2050 in keeping with the science."

This could be counted as some progress as just a few years ago it was inconceivable that fossil fuels, which in fact still fulfil almost every country's energy needs to a large extent will be shamed and might be banned.

the announcement However, doesn't mean anything, as there is no mandate behind it, but it could help build momentum for more action from governments. The Paris climate agreement's commitment that countries would pursue efforts to limit global heating to 1.50 C, above pre-industrial levels staged a version of this in 2015.

In fact, the agreement doesn't underline the urgency required to avoid worsening climate destruction, and it includes language, which may fuel further delay or non-action.

A NEW CULPRIT IDENTIFIED

While oil and gas companies have not yet committed to producing less fossil fuel, their pledge to cut emis-sions from their own operations is noteworthy.

In the agreement, instead of highlighted the harmful effects of Carbon Dioxide - CO2, the delegates were somehow influenced to focus more on Methane-CH4.

Methane, an odourless gas is produced by virtually every oil and gas project worldwide. When it is not cost effective to capture it, companies often release methane into the atmosphere via venting or burn it through flaring, which ironically converts it into Carbon Dioxide.



The gas also leaks into the atmosphere from facilities via innumerable small, undetected or unreported leaks in pipelines or other equipment, or through large-scale releases called "super-emitter" events.

Scientists say methane has been responsible for up to 30 percent of global warming since the industrial era began, so the Dubai agreement offers a win for the climate, even if the 50 signatories account for less than a third of the industry's total operational emissions.

Oil companies may choose to shut some production because that is the most cost effective answer to the target of zero flaring of methane.

THIS MEANS THAT MEETING THE GOAL WILL BE DIFFICULT, BUT ACHIEVABLE. This is also supported by the fact that solar and wind are now the cheapest sources of new energy generation in most countries, but the growth of renewables is being held back by a range of bureaucratic and regulations bottlenecks that many authorities are struggling to unblock

Some of the biggest oil companies have already promised zero routine flaring and near-zero methane, and a number have shown that big progress can be made on the latter.

RENEWABLE ENERGY

A second COP 28 commitment could affect demand for fossil fuels by tripling the world's renewable energy generation capacity to at least 11,000 Gigawatts -GW by 2030. More than 120 countries signed up to this pledge, which will require a big leap in effort from what has been done before. It took 12 years

from 2010 to 2022 to achieve the last tripling of renewable capacity. This one has to be done in the space of eight years.

This means that meeting the goal will be difficult, but achievable. This is also supported by the fact that solar and wind are now the cheapest sources of new energy generation in most countries, but the growth of renewables is being held back by a range of bureaucratic and regulations bottlenecks that many authorities are struggling to unblock.

GENERATING MORE EFFICIENT ENERGY

The third COP 28 commitment with implications for hydrocarbons is aimed at boosting energy efficiency.

More efficient and smart use of energy is widely referred to as the "first fuel" in clean energy transitions because it offers some of the quickest and most cost-effective options for cutting emissions, lowering energy bills and bolstering energy security.

The countries that signed up to the 2030 renewables pledge agreed to collectively double the global average annual rate of energy efficiency improvements from around 2 percent to more than 4 percent every year until 2030.

However, all this could translate into real achievement only when the world leaders who attended COP 28 are focussed to turn these words into real ground action by creating plans for implementation of the summit's goals.

This certainly leaves much to be desired, given the sway of the oil and petrochemicals giants on various governments, an example of which is the manner in which they have been able to turn the attention from CO2 to MH4 at the recent summit. Thus, a resolve coupled with sincere and active policymaking, should pave the way forward but it may also invite political opposition and industry resistance.

Do You Find Yourself On An Emotional Rollercoaster?

Then you think of day-to-day your emotions, how much on an even keel do they seem to be?

Are you able to let a bad experience keep from affecting your mood, or does something going wrong drag your emotions down with it?

Perhaps you're typing away on your laptop, and all of a sudden, one of the keys stops working properly. You've got too much to do, and having to pause to figure out what's wrong is going to cost you precious minutes if not hours. Although you felt pretty happy and confident ten minutes ago, the glow vanished from your mood, and you feel utterly dejected and hopeless. Why do these things have to happen at the worst possible time?

Mood swings like this can take their toll on a day-to-day basis. Short of having a diagnosable mood disorder, it's very easy to fall into the trap of the emotional rollercoaster that such little incidents can provoke. Of course, it's nice when the rollercoaster is on the way up, and you're full of joy and optimism. However, life eventually is likely to get in the way and cause some of that happiness to take a tumble.

EMOTION GLOBALIZING AND LIFE SATISFACTION

You may be familiar with research on life satisfaction, often publicized in the media when the yearly Happiness Reports come out with the scores for different countries. But did you realize these reports are based on very simple (some may say simplistic) measures? The only question people are

asked is to rate their satisfaction with life on a 0 or 1 to 10 scale. There are no in-depth interviews, not even multifactor scales going into detail on specific aspects of life—just a single number.

If you try to do this for yourself right now, do you feel that the number you arrive at is based on a momentary estimate, or does it capture your life in general? According to Washington University in St. Louis psychologist Emily Wilroth and colleagues (2020), it's important to take into account the way that people's life satisfaction varies over time, at least in some individuals. People who engage in "emotion globalizing" allow their current mood to drift on into their life satisfaction estimates.

Apart from creating a lot of noise in the world's happiness data, this globalizing tendency can lead some people's life satisfaction estimates to become hitched onto the emotional rollercoaster. But who is more likely to hitch that ride? A new study headed by Wilfrid Laurier University's Meaghan Barlow (2023), which includes collaboration with Wilroth and others, suggests that it's people who are older and have had more life experiences who seem to find a way to ride more steadily throughout each day's challenges and delights. In summarizing previous research, the authors note that this "could impart older adults with a greater understanding of the limited informational value of their current emotions in the broader landscape of their life as a whole and thus reduce their levels of emotion globalizing." In other words, they don't sweat the small stuff.



DOES AGE MATTER IN EMOTION **GLOBALIZING?**

Across two studies comparing samples of older and younger women divided into two age groups, the Laurier research team tested the extent to which each age group would engage in emotion globalizing as it contributed to emotional rollercoasters. Again, they defined this as occurring when a person's life satisfaction is hitched to current emotions. The research team also took into account the "boundaries" of emotion globalizing, meaning that the tendency to globalize might vary according to the extent to which actual stressful events occurred. On a stressful day or after a stressful event, there could be a reason for people to let their bad mood seep into their life satisfaction.

Turning to the methods, participants completed a daily

diary recording of their emotions, their level of life satisfaction, and the extent to which they found their days stressful. You can try this method yourself.

FINALLY, RATE THE EMOTIONS AS-SOCIATED WITH THAT EXPERIENCE ON A 0-4 SCALE:

Excited

- Calm Proud
- Sad
- Anxious
- Angry
- Lonely

Imagine doing this exercise every day for five days (as did the participants) and recording your responses. You might see a trend occur in which your life satisfaction ebbed on very stressful days and soared on the good ones. Or, if you've become seasoned over time, maybe those stressful events have little bearing on your basic level of satisfaction with life.

The actual studies conducted by Barlow and her colleagues separated "day" satisfaction from "life satisfaction" and "current" from "stressorrelated" emotions, so there were several nuances in the method itself. However, the overall results showed that, when it came to negative (vs. positive) emotion globalizing, older adults were indeed able to brush off the impact of a bad day on their emotions and avoid stepping on the emotion rollercoaster. Of course, these were age

"differences" and not "changes," so there is no ability to measure how people changed over time. Also, comparing the two extreme age groups minimizes the potential to study more precisely age's relationship to emotional control. Nevertheless, the finding supported the main point, suggesting that there's something about the outlook that older people take that may be lacking from the emotion globaliz-

ERCOASTER What if you're not at that point in life yet where you've learned, through your experiences, to keep your emotional ride a steady one? Returning to the daily rating scales, consider whether you've allowed your current mood to color your sense of where your life is going. Are there ways you can reduce, while going through

a stressful event during your day, your tendency to extrapolate from there to your entire sense of well-being? What if your laptop gave way when you needed it most? Can you reframe the experience as having some sort of silver lining? (Maybe you're reacquainting yourself with the joys of paper and pencil).

The findings that the older women in this study could keep their negative emotions at bay are interesting in and of themselves as a study on aging. The Barlow et al. study adds to a growing body of literature showing how and why older adults show a more positive outlook on life. Furthermore, the findings suggest indirectly that those people who keep their views on the more optimistic side live longer and are the ones still around to be tested in their later adult years.

To sum up, if you thought you couldn't control your emotion rollercoaster, this study's methods show that it's possible to step from there to a moving walkway that will bring you closer to the path of

fulfillment.

Some members urged the central government to hold elections in Jammu and Kashmir at the earliest.

The Government of Union Territories (Amendment) Bill stipulates that nearly one-third of the total number of seats to be filled by direct election to the Legislative Assembly of the union territory of Puducherry (including the number of seats reserved for women belonging to the Scheduled Castes) shall be reserved for women in such manner as the Parliament may by law determine.

and Kashmir The lammu Reorganisation (Second Amendment) Bill stipulates that seats shall be reserved for women in the legislative assembly of the Union territory of Jammu and Kashmir.

It states that as nearly as may be, "one-third of the seats reserved under Sub-Section (7) of Section 14 (of the Jammu and Kashmir Reorganisation Act, 2019) shall be reserved for women belonging to the Scheduled Castes or the Scheduled Tribes in the Legislative Assembly of the Union territory of Jammu and Kashmir".

These provisions shall be inserted in the Jammu and Kashmir Reorganisation Act 2019

Jammu district president of DSSP, Vijayant Pathania, said his party supports extension of the Article 371 of the constitution to J&K to safeguard the land and jobs rights for the local

populace. "We attended the meeting which decided to form a committee to ensure that all the points on the agenda are highlighted for their implementation on the ground," he added.

Social activist Anna Durani said the eight points discussed and deliberated upon in the meeting include safeguarding the Dogra culture and heritage, and inclusion of Punjabi in the list of official languages.

The participants highlighted the need for unity and a sustained struggle to achieve the eight-point agenda, she said.

On February 24, 2022, tragedy struck in Doda district of Jammu as an 18-year-old youth, employed as a cook in a hotel, succumbed to suffocation, while his colleague was discovered in an unconscious state. A couple from Noorbagh area in Baramulla district, located in north Kashmir, also lost their lives due to asphyxiation on November 10, 2022,

In another unfortunate incident, on December 28, 2022, four members of a family, including three minors, were found dead under mysterious circumstances at Chopanpora in Chaknarwa village, situated in Banihal in the Ramban district.

Leading Pulmonologist and Head of the Department at the Government Chest Diseases Hospital Srinagar, Dr Naveed Nazir Shah cautioned people against excessive use of Kangri, gas heaters and other electronic heating gadgets during Chilai-Kalan, saying all these heat sources, including Kangri, might cause asphyxia, which can result in unconsciousness or even death from suffocation.

"People would sit in a common room without ventilation throughout the winters, using traditional kangris, gas heaters and other electric heating appliances, which releases toxic gases. resulting in unconsciousness or even death from suffocation," Dr Naveed told Kashmir Observer.

Electronic heaters or even Kangri, Dr Naveed said, reduce the amount of moisture in the air, making it dry. As a result, those who already have respiratory conditions may feel uneasiness and asphyxiation.

"Electric hamam's are completely safe since they don't emit any toxic gases into the atmosphere as electronic heating gadgets and Kangri's do. Even during power shortages, its warmth lasts for more than four hours," he added.

there is a rising demand for oxygen concentrators and non-invasive ventilation devices such as BiPAP and CiPAP machines

"Even before the onset of harsh winters, we have already depleted their entire stock of BiPAPs. Recognizing the unexpected demand, we are currently in the process of procuring an additional 40 BiPAP units," he told Kashmir Observer.

"Typically, there is a spike in demand during winters, but this time around, the spike is enormous. Many patients with a history of coronavirus are reaching out to us.

Javed pointed out a notable shift in the age group of individuals requiring oxygen support. Traditionally, about 80 percent of individuals within the age bracket of 70 to 80 required oxygen support. However, he said that there is a notable departure as individuals in the age range of 50 to 60 are now requiring oxygen.

He opined that this shift is attributed to a dual factor - a history of COVID-19 and a significant prevalence of smoking, elucidating the intricate interplay of health determinants in shaping the current respiratory landscape.

Tak, Medical Dr. Saleem Chest Superintendent, Diseases Hospital, also said that this year, there is an unprecedented surge in flu cases due to the intense cold. However, Saleem added that at the CD Hospital, every bed is equipped with oxygen supply. "Despite the higher-than-usual number of patients visiting the hospital, we are managing the situation effectively," he said.

"There is a rise in flu cases, viral illnesses, and respiratory diseases. Another reason is that the patients, who have inflicted coronavirus in the past, have damaged their lungs, which aggravates health issues for them. They are more vulnerable to diseases and are getting illnesses more frequently." Saleem said.

Responding to a question about why the need for oxygen increases during winters. Saleem said, "once the lungs are involved, there is a constant need for oxygen, and this demand tends to increase during the winter months.

India's first case of COVID-19 subvariant JN.1 was detected in Kerala on December 8. Earlier, a traveller from Tamil Nadu's Tiruchirapalli district tested positive for the JN.1 variant in Singapore.

Considering the upcoming festive season, Pant said, states should put in place requisite public health measures and other arrangements to minimise the risk of transmission of the disease. States have been urged to ensure effective compliance of the detailed operational guidelines for revised surveillance strategy for COVID-19 as has been shared by the Union Ministry of Health and Family Welfare.

They have asked to monitor and report district-wise cases of Influenzalike Illness (ILI) and Severe Acute Respiratory Illness (SARI) in all health facilities regularly for early detection of rising trend of cases.

States were also advised to ensure adequate testing in all districts as per COVID-19 testing guidelines and maintain the recommended share of **RT-PCR** and antigen tests.

In his letter, Pant also stressed the need to increase the number of RT-PCR tests and send positive samples for genome sequencing to Indian SARS COV-2 Genomics Consortium (INSACOG) laboratories to enable timely detection of new variants, if any, in the country.

The states were asked to promote community awareness to seek people's continued support in managing COVID-19, including adherence to respiratory hygiene.

Stating that the first case of JN.1 (BA.2.86.1.1) has been detected in India, Pant attached details about the variant in an annexure.

It stated that JN.1 (BA.2.86.1.1) emerged in late 2023 and is a descendant of the BA.2.86 lineage (Pirola) of SARS COV2.

The BA.2.86 lineage, first identified in August 2023, is phylogenetically distinct from the circulating SARS-CoV-2 Omicron XBB lineages, including EG.5.1 and HK.3.

BA.2.86 carries more than 30 mutations in the spike (5) protein, indicating a high potential for immune evasion.

There is also no indication of increased severity from JN.1

At this time, there is no evidence that JN.1 presents an increased risk to public health compared to other currently circulating variants, the annexure said.

The existing treatment line for COVID-19 is expected to be effective against JN.1 infection and updated vaccines are expected to increase protection against the variant, it said.

"Despite repeatedly telling him, he continued to established a physical relationship with me. I protested as that everything is wrong and he must wait until we were married. He paid no heed and took me to his residence as well, where I meet his parents," read the FIR.

She also told the police that the accused had lied to her about his marital status and family.

"I got to know about the truth about the accused on November 6 when I saw some photographs of him with another woman and two children on social media. I tried to contact him and his parents, but I was blocked from everywhere and no one responded to my calls. I visited his house in Ambala on November 16 where he raped me again and threatened me with dire consequences," the complainant told the police.

The issues discussed in detail at the meeting include the restoration of statehood and extension of special status under Article 371 to I&K besides holding of the assembly elections, deportation of illegally settled immigrants from Myanmar and Bangladesh and return and rehabilitation of Kashmiri migrants," he added.

Sahni said the meeting also demanded immediate lifting of all toll plaza from Jammu-Pathankot highway given the heavy rush of the pilgrims to the Mata Vaishno Devi shrine and regularisation of daily wagers.

A migrant worker died of suffocation at his rented accommodation in Bijbehera area of South Kashmir's Anantnag on Monday morning. Another non-local laborer from Nepal succumbed to suffocation in the Nowgam area of Srinagar, while his colleague was hospitalized after they fell unconscious on November 26 of this year.

On January 28, 2023 three members of a single family, including a couple and their daughter, tragically died of suffocation in Balihat, Ramban district. Later on February 8, a newborn was among the five members of a non-local family who tragically died

privacy, does not hold water as that is an issue for the defendant/respondent to take necessary steps to ensure their own privacy."

The Court said the neighbour can protect privacy "by placing curtains on their windows or by raising a wall on their property which would make their house invisible from the property of the petitioner."

In his plea, the Budgam man had submitted that the construction is being carried out on his own property and that the same is not in violation of any of the local laws. The directions given by courts below with regard to manner of construction of roof and the facing away of the drain pipes have been complied with by him, ensuring that snow does not cascade down or the rain water flow into the property of the neighbour.

The court below in July 2018 had restrained the man from opening the windows facing the neighbour's house.

He was also directed to ensure that the roof is constructed in such a manner that snow does not cascade on the property of the neighbour as well place the pipes in such a manner that water does not fall into the others property.

Before the High Court, the man submitted that there was no allegation of violation of any law as a result of the construction.

Despite notice, the neighbour did not enter an appearance in this case. The Court thus proceeded ex-parte in the matter.

"The petitioner is granted permission to construct windows of his house. The orders below stands modified only to that extent," the High Court said.




