# **Crackdown Launched On Rohingyas** In Jammu, Over 50 Detained

About A Dozen FIRs Registered During Day-Long Drive: IGP

Jammu: More than 50 people, including seven married couples, were either detained or arrested on Tuesday in a major crack-down against those harbouring Rohingya immigrants and facilitating their stay with illegal papers in Jammu, police said.

About a dozen FIRs were registered during the day-long drive aimed at ensuring national security and safeguarding the interests of the residents of Jammu and Kashmir, Inspector General of Police, Jammu zone, Anand Jain told reporters here this evening.

"Certain elements have been involved in facilitating the illegal settlement of Rohingyas, posing potential threats to the security and socio-economic



fabric of the UT of J&K. The presence of undocumented and unauthorised individuals not only poses security challenges but also has the potential to strain local resources," the IGP said.

"The actions taken are in accordance with the law and are aimed at maintaining law and order in the region. The facilitators, once apprehended, will be subject to legal proceedings,

# Investors 'Duped' Of Rs 59 Crores By Private Firm, Police Files Case

Srinagar: A major scam involving financial fraud worth Rs 59 crores has surfaced in Kashmir Valley after investors alleged that they were duped of their hard earned money by a private company based in the Valley.

According to reports, some investors today held a protest in Srinagar, alleging that they were duped by a private investment firm of their hard earned money. "We were lured to invest money in the company stating that the money you invest will get doubled within 15 days. This prompted us to invest money in the firm and in the first few months they received the money as promised, however, after sometime they didn't get any response from the firm, which created doubt in their minds," said one of



## **Risk Of Glacial Lake Outburst Floods** In 'Third Pole' Increasing: Study

#### **Press Trust Of India**

There has been an increase in the occurrence of glacial lake outburst floods (GLOFs) from an average of 1.5 events annually during 1981-1990 to 2.7 during 2011-2020 in the Third Pole region, a study has found.

The Third Pole, which spans the Tibetan Plateau and the surrounding Himalayas, Hindu Kush, and Tianshan Mountain ranges, is extremely vulnerable to the effects of climate change,

the researchers said

The expansion of glacial lakes and the appearance of new ones will likely lead to an increase in the number of GLOFs per year in the future, underscoring the need for developing better analytical methods and datasets to stay one step ahead of potential disasters, they said.

The findings, published in the journal Nature Communications, are concerning for countries exposed to GLOFs in the region, especially China, Kazakhstan, Nepal, India, and Pakistan. Warming temperatures and al-

tered rainfall patterns have caused more than 10,000 glaciers in the region to retreat over the past three decades, facilitating the formation of thousands of glacial lakes, the researchers said. Though they appear harmless, these

water bodies have tremendous destructive potential, particularly due to their ability to cause GLOFs. When triggered by events like glacier collapse, snow avalanches, landslides, or the collapse of natural dams, glacial lakes can release vast volumes of water swiftly, leading to destructive GLOFs.

# **Srinagar Teen Develops Robotic Arm Controlled By Head Movements**

Srinagar: A class 12th student from Gulabagh area of Srinagar has developed a special robotic arm controlled by head movements, taking everyone by surprise. Hazik, a class 12th student said since his childhood, he has been very passionate about engineering and electronic stuff

"I learned about robotics and mechatronics in the 10th standard and was thrilled by what it can do. I wanted to do something for people with the help of robotics and at that point of time. I saw a bionic (robotic) arm and got attracted towards it," he said, adding that "I wanted to create a bionic arm that would stand out from others so that it could reach a broader audience and help those handicapped who cannot afford a bionic arm. He said that the innovative project

took him one-and-a-half years. He said, "In European countries, an advanced bionic arm costs 30k\$-80k\$, and in India, a simple bionic arm costs a minimum of 4 lakhs. But the one I created cost me just 1300 rupees, making it 'The Most Affordable Bionic Arm Ever Made." He said the technology used in to-

dav's bionic arm is called 'Electromyography,' in which it senses the movement of muscles or nerves and uses them as signals to control the bionic arm accordingly


However, the problem with this is that if a person has any movement left in the nerves of their arm or is paralyzed, they cannot use this bionic arm. "This is where my bionic arm stands out, as it can be used by far more people. The one I created simply works on the movement of a person's head and sends those signals to the bionic arm wirelessly, allowing them to use it even if only their head is left in their body. These movements are detected by a hairband-like device on the head received by the bionic arm, and for this reason, I named it a Gyro Arm.

On the specifications of the Gyro

Arm, Hazik said, "It is very easy to use. For example, if a person wants to close their bionic hand, they just have to tilt their head forward; to open it, they tilt their head backward from a straight position. To rotate it right or left, they simply rotate their head right or left, respectively.

He said that the Gyro Arm features a rechargeable battery pack in both the transmitter (hairband) and receiver (GyroArm), which can be charged with any simple mobile phone adapter. On its lightweight design, Hazik said, "The best part about this arm is that we can set how much tilt our head should do for the Gyro Arm to work. In short, we can customize its movements by simply connecting it to our PC/laptop.'

The primary motivation behind these innovations, according to Hazik, is to inspire the youth of Kashmir to engage in technology and address societal issues instead of resorting to negative actions like drugs and suicides, which are unfortunately common in the region.

## Snowfall Boosts Tourism

S nowfall in upper reaches and the scenic spots has come as a boon for tourism in Kashmir. Gulmarg, a famous hilly resort, was blanketed by snow on Sunday. The resort is drawing both locals and tourists, who are arriving in the Valley from the different parts of the country to witness snow, a novelty for a majority of people in the rest of the country. Tourism scene is already booming in the Valley. Just this year until September, a whopping 1.68 crore tourists visited. Last year, it was 1.88 crore. The Amarnath pilgrimage saw more people too. Last year, 3 lakh people visited the cave shrine. This year, it was 4.5 lakh.

The tourism officials say it's, in part, to the active advertising they've been doing. True, the tourism department has been promoting events across the country to attract tourists to the Valley. But the influx of tourists is largely due to the peace prevailing in the union territory over the last few years. Yes, militancy remains very much present and, in fact, this year the violence has witnessed some bump in summer but this hasn't detracted from the larger drift of normalcy.

COVID-19 actually helped Kashmir's tourism. When international travel was tough, tourists flocked here. Since it wasn't heavily hit by the virus, it became a great place to visit. For Kashmir, more tourists mean more jobs.Tourism forms 6.8 percent of Kashmir's GDP and employs over two million people. The region, as a result, has witnessed a boon in hospitality, with hotels reporting handsome occupancy rates, and local businesses, including homestay facilities in rural areas, gaining momentum. This has a spillover effect on the larger economy.

The effort by the administration to turn Kashmir into a coveted wedding destination in 2024, building on the success of the current tourism wave, is certain to further increase the tourist traffic. The government has ambitious plans to transform the valley into a yearround tourist haven, embracing cultural, religious, and adventurous aspects. Once again, Kashmir's scenic beauty has brought Bollywood back in a big way. The administration has issued permissions to around 150 films and web series to be shot in the Valley.

That said, while thriving tourism is needed to give a leg up to the Valley's economy, we have to also ensure that the activity is not indiscriminately encouraged at the cost of the Valley's fragi; eecology. The Valley can only accommodate only a certain number of tourists annually and the administration should take this fact on board in its plans to boost tourism in the union territory, both in Jammu division and Kashmir Valley.

# Acceleration foretold

OMMENTSSHAREREAD LATER November's resurgence in headline retail inflation, while clearly not unexpected after the RBI just last week predicted a likely 'uptick', is a stark reminder of the risks volatile food prices pose. While the National Statistical Office's provisional reading of headline inflation shows the Consumer Price Index rose by 5.55% yearon-year to a three-month high, from October's 4.87%, food price gains measured by the Consumer Food Price Index accelerated by a steep 209 basis points to 8.7% last month. Propelling the upsurge in food prices were cereals and vegetables, constituents of the 'food and beverages' subgroup, that logged 10.3% and 17.7% inflation, respectively. Cereals, that account for almost one-tenth of the CPI and logged double-digit inflation for a 15th straight month, also saw a month-on-month acceleration in inflation with rice, wheat, and the coarse cereal of jowar, a rural hinterland staple, all registering palpable sequential price gains. Vegetable prices were back on a boil with the year-on-year inflation rate surging by almost 15 percentage points from October's 2.8%. While price gains in the perishable tomato swung from two straight months of sizeable deflation to a more than 11% year-on-year rate of inflation last month, the extent of increase could be truly gauged from the fact that prices surged a steep 41% from the preceding month's levels, as per data aggregated on the Centre for Monitoring Indian Economy's website. And the key masala essentials of ginger and garlic registered more than 100% rates of inflation for the seventh and third months, respectively. From the TOP or tomato, onion and potato triumvirate of India's most widely consumed vegetables, onion prices remained the biggest source of concern as year-on-year inflation ballooned to 86%, from October's 42% pace, and the sequential pace swelled to 48%. With reports that inclement weather and depleting groundwater are likely to cause a near 25% shortfall in onion output during the key rabi season, the outlook for prices of the nutrient-dense bulb moderating in the near future appears bleak, the government's move to impose a ban on its exports notwithstanding. Only potato prices, which continued to remain in deflationary territory, offered some respite. Pulses and sugar are other areas of concern, with the first witnessing more than 20% inflation and the sweetener also experiencing an uptick in the pace of price gains to 6.55%. With sugar production also expected to take a hit due to lower rainfall, the number of supply-related challenges policymakers face to rein in price gains is rising. With the RBI having opted to refrain from raising rates for now, the onus is squarely on the government to help temper inflation, or risk suffering an erosion in broader consumption and economic growth. # Gulmarg Needs Sustainable & Responsible Tourism

a time when governments and tourism players across the world are striving hard to strengthen the tourism industry, we need to understand that tourism also plays a role in greenhouse gas emissions. Scientific studies and reports have revealed that tourism accounts for over 5% of the greenhouse gas emissions (GG emission). Of this, the transportation involved in tourism accounts for over 90%. By 2030 there will be a 25% increase in CO2 emissions from tourism when compared with 2016.

A golf course of 150 acres requires at least 200 million gallons of water annually which is equivalent to more than 75 crore liters. This huge amount of water can suffice at least 7000 Indian families living in rural areas. The average golf course also requires a minimum 2000 kgs of chemical fertilizers which has a huge environmental impact as well. In 1950, there were 25 million tourist arrivals in the world in different countries. In 1970, this number went up to 166 million and by 1990 this was 435 million. Between 1990 to 2018, the number of tourist arrivals in the world became three times higher and it went up to 1.442 billion and by 2030 1.8 billion tourist arrivals are projected. Let us now relate this with India. 30 years back the number of tourist arrivals in Goa, Uttarakhand, Rajasthan, Himachal or J&K was very less but now the rush is huge. Before 1990, few thousand pilgrims would visit Amarnath, Kedarnath or Badrinath but now this number has also increased. This is posing a great threat to our ecology and environment. In Sonamarg, Pahalgam or Gulmarg we had very few concrete hotels in the past but now with the huge influx of tourists we have constructed a large number of hotels in these tourist destinations and these places now look like small cities rather than hill stations. This is going to have a negative impact on our ecology and environment as these practices will cause depletion of our natural resources. Managing waste in tourist places across the world has become an arduous task and this is more challenging in hilly areas like Gulmarg, Pahalgam and Sonamarg in Kashmir. The day isn't far when things will go out of control and all our tourist places will be choked with trash and our tourism industry will collapse. To address this,

the only way out is to adopt sustainable and responsible tourism practices and all the stakeholders in tour and travel trade need to understand these practices.

#### Ecotourism Conclave at Gulmarg

On December 16th, the Ecotourism Society of Kashmir in association with Gulmarg Development Authority -GDA organized an ecotourism conclave at Gulmarg to discuss and deliberate on overcoming irresponsible tourism practices. The newly posted CEO of Gulmarg Development Authority -GDA Mr Raja Waseem sought cooperation from tourism players to make Gulmarg a sustainable tourist destination. He said that illegal constructions and unscientific waste management are two big challenges which he wants to address in the coming months.

Chairman Ecotourism Society of Kashmir Sameer Boktoo welcomed the participants who were mostly hoteliers, travel agents, media persons and Govt officials and urged upon them to join hands in preserving Gulmarg.

The Vice Chancellor of Central University of Kashmir (CuK) Prof A Ravindernath, who was chief guest on the occasion, laid emphasis on strengthening sustainable tourism practices and assured that CuK would collaborate with GDA and other stakeholders on building capacities of the students vis a vis ecotourism. He said that CuK already has a separate department of Tourism studies which works under the school of business studies. He said the department can work in collaboration with GDA, tourist players and NGOs and send their students for internships as well. Executive Member Kashmir Chamber of Commerce and Industry -KCCI and past president Travel Agents Association of Kashmir, Farooq Kuthoo, Perzada Fayaz Past President TAAK, Nadeem Qadri legal advisor Ecotourism Society of Kashmir, Zahoor Qari Past Chairman Travel Agents Association of India-TAAI JK Chapter, Akram Siah President Travel Agents Society of Kashmir-TASK, Shamim Shah Travel Agents Federation of India JK Chapter head , Noor Mohammad Shangloo JK Tourism Alliance Chairman and officials from Army also spoke on the occasion and voiced their concern about Gulmarg.

#### Suggestions

Responsible tourism practices cannot be achieved in Gulmarg or in Kashmir valley unless we become responsible citizens. Tourists, hoteliers, cab drivers, restaurant owners, shopkeepers and all other tourism players as well as the Government have to show the awareness of responsibility towards green tourism.

To make Gulmarg a better tourism destination we as responsible citizens or tourists also need to make sure we don't carry any plastic with us to Gulmarg. The lo cal shopkeepers and hoteliers must also minimise the use of plastic and all the food waste should be processed at a centralized place by GDA and converted into compost. If small organic waste composters-OWCs are installed in the hotels that will be more useful to convert food waste into compost. Battery operated ATVs & cabs need to be introduced in Gulmarg. Govt must provide additional staff to GDA and volunteers and interns from colleges as well as universities can also be asked to handhold GDA' work. A massive Information Education and Communication -IEC campaign has to be initiated in Gulmarg which will hold street plays, stage shows in the Gulmarg bowl and create awareness on responsible tourism in Gulmarg. The GDA also has to make sure the waste management plant set up in Gulmarg around 2017 is made operational and all the waste is carried in a segregated manner to this site as mandated under MSW Rules 2016. This needs frequent deliberations and discussions between GDA and other stakeholders and I am sure under the leadership of present CEO Gulmarg will be an example for Responsible Tourism in the country.

## Responsible Tourism & Cape Town Declaration

Responsible tourism practices are now discussed and debated across the world since the last few decades. It focuses on respecting the tourism destination's environment, community, and culture.

The Cape Town conference on Responsible Tourism was organised by the Responsible Tourism Partnership and Western Cape Tourism as a side event preceding the world summit on Sustainable Development in Johannesburg

in 2002, and attended by 280 delegates from 20 countries. It grew out of the South African work on responsible tourism guidelines and involved delegates field-testing the South African Guidelines on sites in and around the city. The 2002 Cape Town declaration agreed that responsible tourism minimises negative economic, environmental and social impacts. generates greater economic benefits for local people and enhances the well being of host communities. This is an internationally recognised event, supported by the United Nations World Tourism Organisation, that highlights how tourism can make the world a better place.

The Cape Town declaration is now widely accepted and was adopted by the World Travel Market in 2007 for World Responsible Tourism Day which is celebrated on November 7th every year.

The participants in the Gulmarg Ecotourism Conclave were fully focussed on responsible tourism as it aims to correct the adverse effects caused by irresponsible mass tourism.

# **PSALMS OF PEACE - III** The Lyricist's Voice

Versatile Urdu poet, Sahir Ludhianvi remembered through his selected verses

hen I started selecting verses of the anti war poem, for my writeup, titled PSALMS OF PEACE, , deep inside I remembered the Punjabi poetess Amrita Pritam, as well, because she shared a special relation with the Piscean born on 8 March 1922, as Abdul Hai; better known as Sahir Ludhyanvi . Some more selected verses of his poetry I intend to present todaywithout any attempt to translate, just to refresh your memory. As is fairly known Sahir was the estranged son of wealthy 'zamindaar' who suffered financial deprivation; was expelled from Govt College Ludhiana for his non-conformist behaviour. Some people link his expulsion to the ardent fan, Amrita- who, it is said, puffed away with his cigarette butts and openly acknowledged her relation with Sahir.

Remember his verses: *Tu aaj bhi hai mairay liye jannate* 

khayaal, Hain tujh main daffan meri jawani kay

chaar saal, Nagma nishaate rooh ka gaaya hai baar

ha, Geetoon main aansovoon ko chupaya hai baar ha, Masoomiyoon kay jurm main

badnaam bhi howay, tairay tufail mooride ilzaam bhi hovay,

Laykkin hum in fizavoon kay paalay howay to hain,

ghar yaan nahi to yahaan say nikalay howay to hain

(Nazzere College-1943). He settled in Lahore to publish *Talkhi-yaan* in 1945 that depicted the personal pathos of this eternal bachelor whose passionate affair didn't solemnize into marriage.

saadah se nazzer,

Abhi daykha nahi hai jee barr kay, Mairay mehboob na ja, aaj ki raat na ja. Singing praise of beloved he spoke eloquently: Hoanth hain ya kisi shayir ki dovawoon

ka jawaab, Zulf hai ya kisi sawan kay talubgaar ka khawaab.

Simple words expressed his sensuous facet: Chho laynay say hoota hai tera jism

jawaan aur; Her waqt teray hussn ka hota hai samma aur.

Yet Sahir was alive to the issues of the day. He identified himself with commoners and his leftist beliefs found expression even from his early days in poems like Taj Mahal: Mairi mehboob kaheen aur mila ker muih sav. His poetry is an honest depiction of his time and the plight of people: Mann wa salva ka zamana ja chukka, Bhook aur aaftab ki baatain karain ...Faaqakash jamhoor ki batain karain. He dedicated his poetry to the working class: Aaj say ai mazdoor kissano, mairay raag tumharay hain, ,...maira fun maire omeedain aaj say tum ko arpan hain, Aaj say mairay geet tumharay dukh aur such ka darpan hain .... aaj say mairay fun ka maqsad zanjeerain pighlana hai. He was pained to see the degradation of women:

Sana khwaane Taqdees e mashrik kahaan hain (\_\_chuklay.) He had the courage to speak out :

Hum jo insaano ki tehzeeb liye phirtay hain, Hum sa vehshi koye jungal kay darindoon

*main nahi.* He was honest enough to voice his disgust:

Yeh insaan kay dushman samajoon ki duniya, Yeh dowlut kay bhookay rivajoon ki

duniya, Yeh basti hai murdah parastoon ki basti, Yahaan per to jeevan say hai moat sasti, Yeh duniya agar mil be jaye to kya hai, Tumhaari hai tum he sambhalo yeh

....jab aik anookni auniya ki buniyaa uthaye jaiyegi ....Seenay kay dehktay dozakh main

In fact it was'nt a vague hope but faith in our capacity to bring about a positive change :

Bay ghar bay der bay bus insaan, tareek biloon say niklaingay, Duniya aman aur khush hali kay phooloon say sajayee jayeigi ....iss subeh ko hum he layaaingay,

Who subeh hummein say aayegi. He invested hope in new generation; to whom he addressed thus:-

...wattan kay imaam... kal jahan mai tha. Aaj tu hai wahaan, aay nayee nasl tujh ko mera salaam.

From Lahore Sahir had moved to Bollywood in the neighbourhood of Gulzaar to become an essential component of S.D Burman compositions till Piyaasa & of Yash Chopra till Kabhi Kabhi, 1976, bagging the prestigious Padam Shri Award.

Mai nay jo geet teray pyaar ki khatir likhay,

*Aaj in geetoon ko bazaar main lay aya hoon,* 

Aaj chandi kay tarazo main tulay gi her cheez,

Meray ufkaar meri shairri mera ehsaas(\_ Fankaar ).

Sincerity, spontaneity and unaffected style together with rich thought content are the hallmarks of Sahir.

He left for the next world in Oct 1980, after giving scores of sensitive yet melodious lyrics- that have intellectual as well as progressive colour, & find place in the hearts of people even today.

To conclude I would like to narrate the story believed to have been told by Amrita Pritam when she heard about Sahirs death; that speaks volumes about genuine sentiments and honest & bold expression of uncensored feelings - very few are capable of.

It is said that the news of his death first left her speechless- the most profound response. Later in the day she narrated an incident of bye gone days when both of them, along with some other men of repute were invited to a function, organized to honour them with robes. Engrossed in tete tete they had to be goaded to hurry and don the cloaks as the time of function was approaching fast. As they were last to enter the green room, Sahir and Amrita hurriedly put on the cloaks only to discover on the dais that the one carrying the name badge of Amrita was donned by Sahir and vice versa – triggering mischievous smiles from spectators. Relating this, Amrita Pritam is said to have expressed thus on the day of Sahir's demise: probably the Angel of death read the name, Sahir Ludhianvi, on the cloak; not knowing the wearer was actually Amrita, whom death has come, today.

outside a Rohingya settlement here. Pathak, who was supervising the crackdown, said some 30 locations under seven police stations were searched in the Jammu city.

The IGP said all cases are in primary stages of investigation and a full picture will emerge as the probe moves forward, and may lead to more arrests.

"Our primary focus was to identify the aiders and abettors who are helping the illegal immigrants to settle and also providing them necessary support to acquire basic services. They have taken it as a business," Jain said.

He said an official was detained for questioning in Poonch for his role in helping Rohingyas to get certain documents.

Jain said police will be looking into several angles, including that of human trafficking, in the matter.

The searches led to the recovery of a lot of documents like Aadhaar cards, ration cards, voter ID cards, revenue records, rent deeds and passbooks besides mobile phones and SIM cards, he said.

Earlier, a police spokesperson said that seven FIRs were lodged at Satwari, Trikuta Nagar, Bagh-e-Bahu, Channi Himmat, Nowabad, Domana and Nagrota police stations against people accused of providing shelter to the foreign immigrants.

The searches were conducted in the presence of the magistrates, police said.

"Investigation into the matter has started and other details will be shared subsequently," the spokesperson said.

Six men and their Rohingya wives were among 13 persons arrested from Kishtwar's Dachhan area.

"The arrests were carried out on the basis of credible evidence, and the individuals are being investigated for their alleged involvement in activities contrary to law and public order," the official said.

A couple was among four persons were booked at Dharamkund Police Station in Ramban district and arrested, while three persons were arrested for helping a Rohingya at Dhargloon village of Poonch district with a fake Aadhaar card and ration card.

The arrested persons included Nazir Ahmad Gujjar, who had married off his daughter, Farzana Kosser, to Mohd Numaan, a Rohingya Muslim, in 2016, and managed to get a fake Aadhaar card and ration card for his son-inlaw, police said.

Numaan, who was arrested on November 30, is presently in judicial custody, they said.

The spokesperson said that another facilitator, Lal Din, was arrested from his Laam-Nowshera residence in Rajouri district following investigation into a case registered in October after the arrest of a Myanmar-born woman named Haleema, who is currently out on bail.

The spokesperson said the police have registered three FIRs in Doda district against 10 foreign immigrants, mainly Rohingyas and Bangladeshi nationals, and their facilitators, for illegally procuring Indian identity

### **Consumers Grapple**

Barzulla, Goripora, Bemina, Gagribal, Boulevard Road, Jawahar Nagar, Wazir Bagh, Lal Mandi, Karan Nagar, Nishat, Shalimar and Harwan have voiced similar concerns over the intermittent power cuts.

Principal Secretary, PDD J&K, Rajesh Prasad said that the overall power supply in Kashmir has improved and the disruption in power supply in metered areas might be attributed to faults in the feeders.

"No, this shouldn't happen in metered areas at least. The department does not resort to power cuts, but this might happen due to the fault in feeders. I will look into the issue, and people in the smart metered areas who face power cuts can forward their locations for early redressal of the problem," Prasad told Kashmir Observer.

In rural districts such as Pulwama, Shopian, Anantnag, and Kulgam, where power consumption has considerably dropped following the installation of smart meters, residents have appealed to the government to ensure sufficient supply of electricity.

"Smart meters in Kashmir did not work, I think, which is why the authorities frequently resort to power cuts. We endure annoying power outages and the PDD continues to make tall claims of having improved the supply," Mohammad Sidiq Bala, a consumer from Devsar area of Kulgam district said.

He said that the government had promised them of a 24 -hour power supply after the installation of smart meters.

"However two years have passed and the situation has worsened since then," Bala said, adding "This is sheer injustice to consumers who pay their monthly bills on time and use power judiciously,"

## **No Distress Cuts**

The IMF in its annual report recommended that policy priorities should focus on replenishing fiscal buffers, securing price stability, maintaining financial stability, and accelerating inclusive growth through comprehensive structural reforms while preserving debt sustainability.

India's economy has rebounded strongly from the pandemic to become an important driver of global growth. After surging during FY2022/23, headline inflation has, on average, moderated although it remains volatile. Employment has surpassed the pre-pandemic level and the informal sector continues to dominate while formalisation has progressed, it said. "The financial sector has been re-

silient, largely unaffected by global financial stress in early 2023. While the budget deficit has eased, public debt remains elevated, and fiscal buffers need to be rebuilt. Globally, India's 2023 G20 presidency has demonstrated the country's important role in advancing multilateral policy priorities," it said.

"On the political front, general elections are expected in April 2024. Macroeconomic policies have been partly in line with the past IMF staff advice," the report said.

India has the potential to experience higher growth contributed by additional labour and human capital if comprehensive reforms are implemented. Furthermore, the country's foundational digital public infrastructure has significant potential to raise total factor productivity by fostering innovation and competition, accelerating financial inclusion, and boosting public sector efficiency.

Observing that GDP growth reached 7.2 per cent in fiscal 2022/23, moderating from 9.1 per cent in FY2021/22, the IMF said growth has been supported by robust consumption stemming from pent-up demand of households and strong investment, with historically high levels of public capital expenditure.

Strong global demand for outsourcing induced by the pandemic pushed up service export growth to a decade high in FY2022/23, raising net exports. Services exports lost some momentum in early FY2023/24, largely reflecting demand slowdown in partner countries, but GDP growth remained strong at 7.8 per cent in FY2023/24Q1, supported by robust domestic demand, it said.

Responding to a question, Choueiri noted that political stability is important for investment and growth.

"We have not done any quantitative analysis around that to be able to put a number but there is a lot of research that points to the importance of having, political stability and a clear policy environment, not just at the politics level, but in terms of policies for businesses to know what the taxes are going to be what the procedures are going to be So this kind of transpar21 of the Constitution of India which states that no person shall be deprived of his life or personal liberty except according to procedure established by law," the court said, adding, " 'Life' under Article 21 of the Constitution is not merely the physical act of breathing. It does not connote mere animal existence or continued drudgery through life. It has a much wider connotation; it includes the right to live with human dignity."

Under the umbrella of Article 21, the court said, various rights like right to free legal aid, right to speedy trial, right to fair trial, etc. have been included.

'Similarly, protection against double jeopardy is also included under the scope of Article 21 of the Constitution of India," the court said, adding, "Prosecuting a person for the same offence in same series of facts, for which he has previously either been acquitted or has been convicted and undergone the punishment, affects the person's right to live with dignity."

According to the Hong Kong-based South China Morning Post, a woman, who lives 90 km from the epicentre, said her house collapsed and she escaped being buried because she was still awake.

Videos and photos circulating on social media showed firefighting crews trying to pull out residents buried under rubble and others showed quake victims taking shelter on the road while wrapped in quilts amidst biting cold.

The quake has destroyed some rural roads, leading to power outages and telecommunication failures. The maintenance crew has been working overnight to repair the damaged infrastructure.

safety check of railway tracks. Meanwhile, a second quake struck the neighbouring Xinjiang Uygur Autonomous Region hours later on Tuesday.

The third and fourth earthquakes measuring 2.9 and 2.8 jolted the places at 11:18 Am and 11:28 AM respectively.

The experts have, however, asked the people to take precautionary measures, saying that there was no need to panic.

Assistant Professor at Senior Department of Earth Sciences Kashmir University, Dr Rakesh Chandra said that the tremors felt since yesterday is a normal phenomenon as the earth has to release its energy. "Zanskar, Kargil and Kishtwar in J&K is in zone five and considered as the most vulnerable areas of the earthquake, thus these earthquakes and aftershocks witnessed since last afternoon are guite normal." he said.

He added that the earthquakes are unavoidable as the earth has to release its energy and even if the energy is getting released through low intensity shocks, it is a good sign as it will help in avoiding a major earthquake, which would release the accumulated energy in it.

"We need to see the earthquake and aftershocks in a positive aspect and there is no need to panic, but we need to take precautionary measures like constructing our houses on seismically approved design to prevent the losses," he said.

Professor Shakil Moreover, Romshoo, an earth scientist and Vice Chancellor of Islamic University of Science and Technology (IUST), said that "keeping in view our historical vulnerability to earthquakes, we all need to be conscious about our role and responsibility as far as disaster

We also see more medium-term risks from climate change. Although it's a slow-moving phenomenon, the impact of climate change, we are seeing them every day through erratic weather patterns. India is significantly impacted by that.'

These are important risks that need to be heeded and managed properly, the IMF official said. "India is doing well. It has tremendous potential. Several important policies need to be addressed to harness that potential," Choueiri said.

According to the China Earthquake Networks Centre, the shallow quake jolted Gansu and Qinghai provinces at 11:59 pm on Monday, with a focal depth of 10 kilometres.

The epicentre of the earthquake Liugou township is about 8 km from the county seat of Jishishan Bao'an, Dongxiang, Sala autonomous county in Linxia Hui autonomous prefecture in Gansu.

The earthquake damaged 155,393 houses in Gansu.

The epicentre of the earthquake in Gansu was only 5 km away from the boundary between the two provinces. Within 50 km of the epicentre, there are 22 townships in Qinghai, Xinhua reported.

Wang Wen, vice mayor of Haidong city in Qinghai, told the media that local departments will carry out safety checks on infrastructure like the supplies of power, water and gas, as well as communications to ensure that people's basic necessities are met.

Chinese President Xi Jinping and Premier Li Qiang have ordered all-out rescue efforts to minimise casualties after the earthquake.

Xi asked local authorities to rescue and treat the injured people promptly, and closely monitor the earthquake situation and weather changes to prevent secondary disasters.

Monday night's quake was China's deadliest since an earthquake killed 617 people in Yunnan province in 2014

Residents interviewed by Shanghaibased media outlet The Paper on Tuesday said many people were asleep when the quake struck and did not have time to take shelter.

She further gave out that 208 Minor Mineral Leases (RBM) have been granted by the Department through e-auctioning. The department has real-

ized an amount of Rs 10185 lakhs during the current financial year and has also issued 3643 short term or disposal permits for extracting RBM/ Ordinary earth to facilitate execution of projects of national importance/government works in J&K w.e.f. January 2020 to November 2023, the meeting was informed.

It was further apprised that the Department has taken several reforms likes witching from first come first serve basis to e-auctioning, constitution of single window clearance system, steps to ensure ease of doing business, introduction of e-challan, e-market web portal.

**DUBAI:** Australia's Mitchell Starc became the most expensive player in the history of the Indian Premier League (IPL) after attracting an eye-watering \$2.98 million bid from Kolkata Knight Riders in the players' auction on Tuesday.

Australia captain Pat Cummins briefly held that honour after Sunrisers Hyderabad agreed to splash \$2.46 million for his service before Starc bettered that mark.

Barely a month after leading Australia to the 50-overs World Cup title in India, Cummins entered the auction with a base price of 20 million Indian rupees (\$240,473).

IPL heavyweights Mumbai Indians and Chennai Super Kings were initially interested in him but both dropped out as a two-way bidding war ensued.

Royal Challengers Bangalore doggedly pursued Cummins but 2016 champions Hyderabad had the

# Rs 24.75 Cr Bid Was Beyond My Wildest Dreams: Mitchell Starc

NEW DELHI: Australian pacer Mitchell Starc on Tuesday said he did not even dream of getting sold for Rs 24.75 crore in the IPL auction and admitted that the huge price tag would bring in some pressure on him.

Starc became the costliest player in the history of IPL when Kolkata Knight Riders defeated Royal Challengers Bangalore in an intense bidding war to add the 33-year-old to their roster.

"It was a shock, of course. Noth-ing I could have dreamt of. But no doubt, there will be some pressure that comes with the territory. But having the extra experience I have from my last IPL, hopefully, helps," Starc told Jio Cinema.

"Few ups and downs I've had before but this comes with the territory and I try to be successful and have as much impact as possible.'

The 33-year-old left-arm speedster said the intense bidding for his services came as a humbling experience.

"Humbling to still feel like I'm wanted or needed. My gameplay hasn't changed much across formats except a few things here and there. Hopefully, the experience can translate to some success," he said.

Starc's Australian teammate Pat Cummins was bought by Sunrisers Hyderabad for Rs 20.50 crore, Rs 4.25 crore less than his price.



Starc said both him and Cummins will have to throw a party to their Australian teammates.

"Pat has gone to Sunrisers, but that's where he was at KKR, and I hope to fill his shoes there. Our Test squad Whatsapp group has been going off to say it's our shout to get dinner next. Something to do ahead of the Boxing Day Test.

"My wife Alyssa (Healy) is with the (Australia) women's (cricket)

team in India. So, she was getting updates quicker than what I was seeing on screen," Starc chuckled.

This will be Starc's first IPL since 2015 and he was understandably excited to return to the high-profile league.

"It has been a while. I've been involved with RCB in 2014-15, then picked up by KKR in 2018 but got injured. But I've been prioritising international cricket and Test cricket for Australia.'

Rizvi too shared his excitement about the chance to play for the Super Kings but admitted that he was nervous when his name came up in the auction.

"I noticed that 4-5 players before me went unsold. I was nervous at that time. But he (Dhoni) has always been my idol. I am very excited, yet nervous about the prospect of meeting him. I have never seen him in front of my eyes," Rizvi told the Jio Cinema.

So, what has prompted the CSK and other teams to go on a bidding war for this Uttar Pradesh lad.

Rizvi caught the eyes of IPL talent scouts for the first time during the UP T20 League while playing for Kanpur Super Stars.

He hammered 455 runs from nine matches including the fastest hundred in the tournament off 47 balls.

Rizvi carried that form into the state Under-23 tournament where he smashed 454 runs from seven matches.

But more than those runs, it was Rizvi's ability to clear the ropes by miles that fascinated the scouts. The young batter smoked 72 sixes across 16

matches in those tournaments.

"It is his natural game. He has been a big-hitter from a young age. He has interacted and played with seasoned players like Nitish Rana and Rinku Singh (in UP T20 League) and they have also told him to play his natural game. It helped him a lot," said Akhtar.

Rizvi was skeptical of getting an IPL contract once he missed trials with a few teams because of his state commitments.

"I told him don't worry and the opportunity will come to you. You keep performing on the field. SG (Sanspareils Greenlands, the cricket gear manufacturer) helped him a lot through sponsorship of equipments.

The uncle doesn't want his nephew to just make waves donning 'Canary Yellow' but realise his ultimate goal of wearing the 'India Blue'.

"Now, we are happy that our efforts have borne fruits, and finally it (IPL contract) has come his way. There are tears in the eyes of everyone at home. Hopefully, he will go and play for India one day," said Akhtar, who is also his childhood coach at the Gandhi Bagh Cricket Academy.
