## Govt's Crackdown Leads To Significant Drop In Substance Abuse Cases

GMC Srinagar's Drug De-Addiction Center Received 1560 Patients In 2023, Compared To 3395 In 2022

Srinagar: The government's crackdown on drug peddlers in the valley appears to be yielding results, as the drug de-Addiction center, Government Medical College (GMC), Srinagar has experienced a notable decline in the number of individuals seeking treatment for substance abuse

Figures from the Institute

of Mental Health and Neurosciences (IMHANS) reveal that 1560 patients visited the center in the year 2023,

compared to 3395 in 2022.
Last year, 1909 patients
were from Srinagar district only while the rest came from other districts of the valley. However in 2023, only 728 such patients from the city visited the centre for treatment.

"The outpatient department (OPD) at IMHANS has



seen a significant drop in the current year as compared visitors seeking assistance in

The 1266-page chargesheet was filed by the economic offences wing of Crime Branch, Jammu against six affiliates of Swarn Bhavya Gold Pvt Ltd, including its Managing Director Balwinder Kumar of Haryana, under various sections of the Indian Penal Code, a spokesperson of the agency said. A case on the matter was registered in 2020.

The official said the accused hatched a criminal conspiracy to induce the complainants and other people to invest their money in the company by promising to provide bonus income on their deposits after every | More on P6

# J&K Panchayati Raj Act Amended To Incorporate OBC Reservation



Jammu: The Jammu and Kashmir administration has

amended Panchayati Raj Act to incorporate reservation for Other Backward Classes (OBC), an official spokesperson said on Thursday. The amendments to

the Jammu and Kashmir Panchayati Raj Act proposed by the administration led Lieutenant Governor Manoj Sinha aim at making the statute more effective ensuring transparency in the functioning of the panchayati raj institutions (PRIs), constitutional alignment and consistency with the practices in other states where reservation has been provided to the OBC, apart from the Scheduled Castes (SCs) and Scheduled Tribes (STs), the spokesperson said. He said the administra-

tive council, which met here under the chairmanship of the LG, approved amending the Act to incorporate the definition of the OBC in it to ensure their reservation in these grassroots democratic institutions.

Earlier, the draft Jammu and Kashmir Panchayati Raj (Amendment) Bill, 2023 was submitted to the Union Ministry of Home Affairs (MHA). #### **CHEOUE BOUNCE CASE**

#### **Court Sentences Man To** 2 Yrs Jail, Fines Him Rs 82.5L

Srinagar: A court here has sentenced a man from Srinagar to two years in jail and directed him to pay fine of Rs 8250000, one and half of the dishonoured amount, in three cases of cheque bounce.

According to the complainants, dealing in the sale of golden items and ornaments, the accused person had golden purchased items from their shops and issued various cheques against the amount. However all the cheques came to be dishonored and returned to the complainant without payment by the concerned bank.

Consequently, the complainant filed complaints interms of Section 138 of the N.I. Act in 2015. "The complainant has been

able to prove the commission of offence under section 138 by the accused Hilal Ahmad Khan R/O Hussani Public School, Industry Area H.M.T Batamaloo, Srinagar for which the accused is hereby convicted," said Third Additional Munsiff, Moneer Ahmad, add-

ing, ".. by commission of the offence the accused person has dragged the complainant to litigation which is pending for the last more than seven years. Consequently

#### **J&K Parties To Move Review Petition Before SC**

Srinagar: The Awami National Conference (ANC), one of the petitioners who had challenged the abrogation of Article 370 of the Constitution before the Supreme Court, on Thursday said it is considering filing a review petition before the court as legal experts maintain that its verdict in the matter was "full of flaws".

"Legal and constitutional experts say the Supreme Court judgment was full of flaws. It remained silent on many basic issues. A review petition is being prepared and once it is ready, we will put it before our legal teams and the 23 petitioners. Most likely, we will file the petition in the apex court," ANC's senior vice-president Muzaffar Shah told a press conference here.

He said it is a matter of

discussion as to what shape the course of legal action would take.

"One thing is definite that since the judgment is full of flaws according to legal and constitutional luminaries, we will knock the doors of the Supreme Court again. Whether a review petition will be filed or some other route taken, we will discuss that," Shah added.

The ANC leader expressed hope that those who believe in history and the Constitution will stand together in this legal battle.

"We also hope that the Supreme Court will restore Article 370," he said.

Shah said the issue would also be discussed at the next meeting of the People's Alliance for Gupkar Declaration (PAGD), which was formed in 2019 to fight for the restoration of Jammu



#### NC Closes Ranks In Fear Of Gul Shah's Raid

Faroog, party brass hold lengthy meetings

'ammu- The recent convention by -National Conference adversary, the Awami National Conference led by G. M. Shah in Srinagar has sent alarm bells ringing in the ruling party with the NC president, Farooq Abdullah other top functionaries in the party for a meeting to review the political situation in the state.

The NC President, Farooq Abdullah this afternoon held a detailed discussion with his senior party colleagues at his private office to take stock of the political situation in the state. The meeting, sources said, went into the evening hours also.

The meeting assumes significance in the wake of open threat by CM's brother-in-law, G. M. Shah that he would go all out in removing Farooq Abdullah from the seat of the power in the state.

Sources said that there are fears among the NC top brass that Shah like in 1984 may engineer defections in the ruling party as there was growing dissension among some of the ministers. They are reportedly unhappy over Dr. Farooq Abdullah's move of cutting them to size in the last reshuffle. They include Ghulam Mohi-ud-Din Shah and Abdul Rahim Rather.

The Chief Minister, sources said, who is under tremendous pressure to drop at least six ministers for their reported poor performance has dropped the idea of a fresh cabinet reshuffle in view of the latest threat by G. M. Shah. The CM had earlier made-up his mind in consultation with his senior colleagues to drop some ministers, including Ifthikar Hussain Ansari for his alleged tax-evasion, Bashir Ahmad Kitchloo for his son's alleged involvement in timber-smuggling and Ajat Shatru for his reported illegal construction in green belt.

Nothing will be done that annoys anyone in the party for the time being," a source, close to those who attended the meeting this evening said. The meeting also discussed possible changes in the state administration on large scale.

The police is also to witness large scale reshuffle by the state cabinet. The changes will affect almost all the senior police officers of the rank of IGPs in the state, besides shifting of all the district police chiefs. Three IGPs, sources said are being promoted as additional director generals of police, while three senior officers are being sent to Centre on deputation.

#### Towards justice

efense minister Rajnath Singh's visit to Jammu in the wake of the killings of five soldiers in an ambush by the militants underlines the union government's seriousness to take on the escalating militancy in the twin districts of Poonch and Rajouri. The defense minister's presence in the region to review security measures is not merely a ceremonial gesture but an indication of acknowledging the severity of the situation. Since the summer of 2021 and especially throughout this year, Jammu has witnessed a conspicuous spike in violence, which now warrants an urgent attention by the union government. A few days ago, the Army chief also made a visit to the region. Besides the need to take stock of the evolving security situation in Poonch and Rajouri, both defense minister Singh and the Army chief reached out to the families of the three civilians allegedly killed in the custody of the army. They had been rounded up for questioning along with over a dozen others after the killings of five soldiers. The welcome outreach will go a long way to address the alienation among the Gujjar community, whose support is seen as critical to combat the rising insurgency in the twin districts of Poonch and Rajouri.

However, the government will have to go beyond meeting the families to win their hearts and minds. The demand for a fair and impartial investigation has reverberated not only among locals but also among political parties and humanitarian organizations. And to be fair to the Army, it has quickly moved to conduct its own inquiry, coupled with the police's registration of a murder case against unidentified individuals. It is a step in the direction of fixing accountability. Now, the army must ensure that the investigations are conducted meticulously, with full cooperation among all stakeholders. The families of the victims deserve not just words of solace but concrete steps towards ensuring justice, accountability, and preventing such tragic incidents in the future.

In 2020 also, the Army had moved with alacrity to hold its personnel accountable following the killing of three youth killed in an encounter at Amshipora in Shopian. However, the armed forces tribunal recently suspended the life sentence of the army Captain who was found guilty of killing these youth, something that has come as a setback to the families of the victims. But considering the seriousness with which the union government and the Army has taken up the killings of the three civilians in Poonch, the investigation will be taken to its logical conclusion and justice delivered to their families.

#### Cricket and commerce

ast week's Indian Premier League's (IPL) auction in Dubai reiterated the sporting brand's enduring value and financial muscle. The T20 league, which many years ago Rahul Dravid famously referred to as 'a domestic tournament with an international flavour', has come a long way since its launch on a glitzy April night at Bengaluru's M. Chinnaswamy Stadium in 2008. The championship has survived a betting and fixing scandal, team suspensions and ownership issues, and become an irreplaceable element of the Indian summer and a much-watched fixture in the annual cricket calendar. The latest auction with its overseas tryst had an obvious recency bias as evident in the World Cup winning Australian squad's trio of skipper Pat Cummins, Mitchell Starc and Travis Head eliciting competitive bids. The first two also scaled the 20 crore peak, which had remained unscaled so far in the IPL's history. Kolkata Knight Riders picked Starc at 24.75 crore and Sunrisers Hyderabad latched onto Cummins at 20.50 crore. In all the club against country debate that affects sports like football and cricket, what a player achieved for his nation adds immense value to his or her credentials, and that in turn means better money with clubs vying for the star athlete's presence. The Aussies reaped their rewards and many others too were recognised.

The build-up to the auction had its share of drama, as Mumbai Indians took Gujarat Titans skipper Hardik Pandya. He was subsequently appointed as the Mumbai Indians' captain and that meant Rohit Sharma's chequered history as an IPL captain had perhaps drawn to a close. There were cryptic social media posts from Jasprit Bumrah and Suryakumar Yadav, and that added to the speculation within the Mumbai Indians' ranks. And since the IPL is seen as a mirror to the Indian team's fortunes in T20, the presumption is that Pandya will continue to lead India in the shortest format. With the West Indies and the U.S. hosting next year's ICC T20 World Cup, the latest auction and the 2024 IPL edition will have a lot of layered meanings attached to them. Seen in that light, unsung Indian players, plying their wares in domestic cricket, being picked by various franchises, is also a reflection of a young crop that may don the Indian blue sometime in the future. Players such as Sameer Rizvi, Kumar Kushagra, Shubham Dube, Swastik Chhikara and Ramandeep Singh found eager buyers. But the way Pakistan cricketers have been kept away from the IPL is also a pointer that sport cannot stay immune to geopolitical tensions

However, the article appears to be built on assumptions, a trend prevalent in discussions of contemporary social issues ,resulting in generalised solutions susceptible to selective application. My aim is to underscore the importance of inclusivity in addressing grassroots causes, directing our focus towards genuine solutions for a society that is both balanced and just.

#### Overlooked factors in dual working parents struggle

As we navigate the challenges of dual working parents, the focus turns to women. Society's weighty expectations often dissuade women from embracing the role of a working parent. ## **Cat in Distress**

## The Dramatic Unravelling of a Failed Rescue Operation

The absence of an animal rescue centre amplifies the challenges faced by injured animals in dire need of timely intervention and care.

tiny one-week-old kitten, A seeking warmth, inadvertently found itself in the bonnet of a neighbour's car. Unaware of the feline stowaway, a heart-racing 500-metre journey unfolded, concluding with a distressing scene in the rearview mirror—the kitten's accidental fall, resulting in an injured

Promptly pulling over, the man retrieved the injured kitten, drove back home, and discovered the mother cat playing with her other offspring. Placing the wounded kitten among its siblings, the little one, despite its injury, managed to drag itself and nestled close to its mother for much-needed warmth.

Though the man could have taken the kitten to animal rescuers for her leg treatment, placing it with its family was the extent of what he could all do.

Several months have elapsed, and the once-tiny kitten has blossomed into a fully grown, exquisite cat. It explores the neighbourhood in quest of sustenance and refuge, frequently seeking shelter in the subterranean section of our house. Her paw remains contorted, and the crimson hue of the blood indicates that her injury has not fully healed. Each time she ambulates on her paw, a section of it rubs against the wrong side, reopening the wound repeatedly, leaving a trail of blood.

The thought of capturing the kitten and getting her paw treated never crossed my mind. Instead of taking responsibility, I chose to share her plight through a social media post probably to score Brownie points that I was some kind of a wildlife buff who cared for the injured animals more than the rest. However, the reality is that I fell short.

Fortunately, my two sons, Mehran and Muntasir, exhibit a higher level of responsibility. Having extensively watched Animal Planet together, their commitment to safeguarding life surpasses that of their ageing father.

I've instilled in them the value of kindness toward all life forms. Their favourite activity is capturing spiders alive and setting them free in nature. They've consistently followed this practice, and each time they release an animal, I feel a sense of accomplishment, knowing that my dedication to imparting a deep respect for life has not been futile.

A memorable incident occurred when we suddenly discovered that our attic had been raided by over half a dozen rodents. They had climbed the bathroom pipe and sought refuge on the second floor. They had already caused significant damage, gnawing into everything within their reach, including pillows, blankets, and quilts, before we detected their presence.

I promptly acquired a rodent trap from the nearby market. Using dried fish as bait, I successfully captured nearly nine rodents.

After each capture, I transported the trap about two kilometres away to release them into an open piece of land. Thankfully, there have been no further rodent visits.


Mehran, upon his return home after the third semester at IIT Kharagpur, expressed his strong disapproval for not having her paw treated. He contacted an NGO dedicated to rescuing injured animals and informed them about the cat.

The volunteers responded positively, asking if we could capture the cat before their arrival. Mehran, fortunately, lured the cat into the underground section of our house and locked it in. However, just before the rescue team could arrive, a friend of his called him, and Mehran delegated the remaining responsibility to his proud dad. The dad willingly took on the task.

Meanwhile, two young boys from the rescue team, guided by a shared location on WhatsApp, reached the spot. However, their appearance, attire, and behaviour didn't align with their professional role-they lacked uniforms, IDs, cat traps, gloves, or any visible indicators of commitment to the task

Before attempting to capture the cat, they requested if I could provide them with a cardboard box and duct tape, which I promptly did. With a picking basket in hand, they proceeded to the underground dungeon where the cat was shut in. Despite their efforts, they struggled to secure the cat. The cat had most likely lost trust in humans, making it substantially hostile and challenging

After approximately fifteen minutes, they caught the cat, though the method of grabbing her neck caused significant discomfort to her. The poor creature displayed distress



with a gaping mouth and poppedout eyeballs, indicating the duo's suboptimal handling.

While assisting them in sealing the box with duct tape, the cat managed to find a weakness and wriggled out vigorously, prompting the duo to allow her to escape. I quickly grabbed her, preventing her escape, and urged the volunteers to cover her with a cloth. However, they remained motionless, allowing the cat to turn aggressive towards me. Despite tightening my grip, her feline instincts prevailed, and she scratched my right hand, leading to the failure of the rescue.

The rescue team blamed me for mishandling the operation, leading me to question their qualifications and why they allowed my involvement from the start.

I was the one who suffered the most, and I realized that I needed to go to the hospital to find out whether I required an anti-rabies vaccine. Stray cats can carry the virus easily transmittable through scratching or biting.

Surprisingly, the cat reappeared on the southern wall of our house, seemingly mocking us for the failed mission. However, the duo was unable to capture her, even though she presented several opportunities when I fed her again with some pieces of meat. The dejected team left, promising to return if we managed to trap her again. After their departure, I hurried to

the SMHS hospital, where the paramedics informed me that I needed a series of injections along with a tetanus toxoid.

Meanwhile, the cat continues to visit us, but displays considerable reluctance to freely enter our premises now. She has perhaps lost all her trust in humans, unaware that her

capture was for her own well-being.

During one of her visits, I observed blood dripping from her paw, tugging at the strings of my heart once more. Determined to catch her again, I made several unsuccessful attempts until I finally managed to trap her in the underground room again. When I called the rescue team, they were occupied with bandaging an injured dog and instructed me to contact their office instead.

I knew a volunteer, Miss Sanna, based in Lucknow, who worked with Ms. Maneka Gandhi on establishing a dog sterilization centre in Kashmir. However, the project reportedly faced indifference from the Srinagar Municipal Corporation (SMC) and was stalled.

Sanna provided me with a string of numbers to contact, although I had already spoken to Mr. Dawood Muhammad, whose number the rescuers had forwarded to me. Sanna informed me about Dawood's organisation, "Animal Rescue Kashmir," established with limited resources in 2015 after returning from London.

Surprisingly, Dawood also blamed me for the initial failure in capturing the cat when the rescuers first visited our house. He began arguing without addressing the urgency of the situation. Despite informing him about the cat's serious bleeding, his response was not professional.

Meanwhile, the trapped feline found a small gap in the room and escaped once again.

When I informed Dawood of the cat's escape, he sounded as disheartened as I was. The mission was

The cat continues to appear intermittently, perching on her favourite spot on the wall but refusing to be lured into the underground space. Her ongoing ordeal continues with the untreated wound leaving a trail of blood wherever she goes.

One certainty is that Dawood stands as a lone warrior amid the prevailing situation where animals suffer daily without a proper animal rescue centre. Without sufficient funds, infrastructure and other allied items, his frustration is justified. No wonder, stray dogs or cats struck by vehicles face further torment as passing vehicles trample them until they meld with the road, leaving remnants of skin and a few hairs. The level of regard for life here in Kashmir is minimal

## Winter Depression or Seasonal Affective Disorder

Then the long dark days of winter approach, do you feel slowed down? Does it feel more difficult to wake up early in the morning? Do you face difficulty in concentrating on work; feel demotivated and sad for most part

You may be one of the many people who get psychologically affected by change in the season. This condition is known as SAD- seasonal affective disorder. Though most of the people with this condition never seek professional help but they complain about feeling less cheerful, creative, energetic and productive during the winter season compared to the rest of the year.

In Kashmir, the cold weather lasts for more than six months, which leads to most of the people having significantly low levels of vitamin D due to less exposure to sunlight. A number of studies have shown a relationship between Vit D levels and depression, which to some extent explains why people living in cold regions have a higher risk of developing seasonal affective disorder. You might have heard many people around you saying

"ye wande shikas chu mae kharaan; wandas manz chu mae souri kharaan, beh chus/ches na hekaan kih thi karith: mae chu nebar wuchun tuth kharaan, souri chu manhoos baasaan"

#### **WHAT IS SEASONAL AFFECTIVE DISORDER?**

As per APA- American Psychological Association Seasonal affective disorder is a form of depression also known as SAD, seasonal depression, or winter depression. In the Diagnostic Manual of Mental Disorders (DSM-5), this disorder is identified as a type of depression – Major Depressive Disorder with Seasonal Pat-

Seasonal affective disorder (SAD) was first described as a syndrome of recurrent episodes of depression that occur annually (usually in the winter season at same time each year) by Rosenthal et al. in 1984. People with SAD experience mood

changes and symptoms similar to depression. The symptoms usually occur during the fall and winter months when there is less sunlight and usually improve with the arrival of spring. The most difficult months for people with SAD tend to be January and February. While it is much less common, some people experience SAD in the summer as well.

SAD is more than just "winter blues." The symptoms can be distressing and overwhelming and can interfere with daily functioning. However, it can be treated. It is more common among women than men. SAD may begin at any age, but it typically starts when a person is between ages 18 and 30.

SAD has been linked to a biochemical imbalance in the brain prompted by shorter daylight hours and less sunlight in winter. As seasons change, people experience a shift in their biological internal clock or circadian rhythm that can cause them to be out of step with their daily schedule. SAD is more common in people living far from the equator where there are fewer daylight hours in the winter.

#### **SYMPTOMS AND DIAGNOSIS**

Common symptoms of SAD include fatigue, even with too much sleep, and weight gain associated with overeating and carbohydrate cravings. SAD symptoms can vary from mild to severe and can include many symptoms similar to major

- depression, such as: Feeling sad or having a de-
- pressed mood Loss of interest or pleasure in
- activities once enjoyed. Changes in appetite; usually eating more, craving carbohy-
- Change in sleep; usually sleep-



ing too much.

- Loss of energy or increased fatigue despite increased sleep
- Social withdrawal (feeling like "hibernating") Increase in purposeless physical
- activity (e.g., inability to sit still, pacing, handwringing) or slowed movements or speech (these actions must be severe enough to be observable to others).
- Feeling worthless or guilty Difficulty thinking, concentrat-
- ing, or making decisions. Thoughts of death or suicide

Remember that the symptoms associated with SAD could be a result of some other underlying medical causes. Physical examination and some blood tests can help to confirm the diagnosis and rule out the presence of any other causal factor. Some specific illnesses that need to be considered are:

Hypothyroidism, hypoglycaemia, chronic viral illnesses, chronic fatigue syndrome etc.

#### **HOW IS SAD DIAGNOSED?**

If you think you may be suffering from SAD, talk to your family doctor or a mental health professional. To be diagnosed with SAD, an individ-

- ual must meet the following criteria: They must have symptoms of depression (as mentioned in list above)
- The depressive episodes must occur during specific seasons (i.e., only during the winter months or the summer months) for at least 2 consecutive years. This means there must be a temporal relationship between the onset of the symptoms and a particular time of the year.
- Full remissions also occur at a characteristic time of the year (e.g., depression disappears in spring).

#### **CAUSES OF SAD:**

The exact cause of SAD has not been fully understood yet, but it's often linked to- reduced exposure to sunlight during short winter days.

Lack of sunlight might stop a part of the brain called the hypothalamus from working properly; this may in turn affect-

- Production of melatonin melatonin is a hormone that makes you feel sleepy; in people with SAD, the body may produce it in higher than normal levels
- Production of serotonin serotonin is a hormone that affects your mood, appetite and sleep; a lack of sunlight may lead to lower serotonin levels, which is linked to symptoms of depres-
- Body's internal clock (circadian rhythm) - your body uses sunlight to time various important functions, such as when you wake up, so lower light levels during the winter may disrupt your body clock and lead to symptoms of SAD

It's also possible that some people are more vulnerable to SAD as a result of their genetic predisposition, as mood disorders appear to run in

#### **WHO IS AT MORE RISK?**

- Females
- Young adults
- Individuals living in cold regions with long winter season.
- Individuals with personal or
- family history of depression. Individuals diagnosed with depression or bipolar disorder.
- Females in post-partum phase

SAD can be effectively treated in several ways which includes- light therapy, antidepressant medications, talk therapy or some combination of these. Although symptoms generally improve with the change of season, symptoms can improve

more quickly with proper treatment. The main treatments are:

- Making lifestyle changes –getting natural sunlight, eat a healthy and balanced diet, and paying extra attention to stress management. Keeping yourself engaged in pleasurable activities and doing physical exercise for at least 30minutes- 3-4 times a week can prove to be quite helpful. Regulation of your sleep cycle is also important. Taking vacations in sunnier regions can also help one cope with SAD.
- Light therapy where a special lamp called a light box is used to simulate exposure to sunlight. It usually requires 20 minutes or more per day, typically first thing in the morning, during the winter months. Most people see some improvements from light therapy within one or two weeks of beginning treatment. To maintain the benefits and prevent relapse, treatment is usually continued through the winter. Because of the anticipated return of symptoms in late fall, some people may begin light therapy in early fall to prevent symptoms.
- Consulting a Clinical Psychologist (for CBT sessions) or a Psychiatrist, who will prescribe some antidepressant medicinesuch as selective serotonin reuptake inhibitors (SSRIs).

# PM Modi to inaugurate multiple development projects, flag off trains in Ayodhya on December 30

New Delhi: Ahead of the consecration ceremony at the Ram temple in Ayodhya, Prime Minister Narendra Modi will inaugurate a slew of development projects in the Uttar Pradesh city on December 30, including an airport and a redeveloped railway station, and flag off two new Amrit Bharat and six new Vande Bharat trains, his office said on Thursday.

Official sources said the airport will be named "Maharishi Valmiki International Airport, Ayodhyadham", after the saint who wrote the epic "Ramayana". Valmiki also enjoys a large following, especially among Dalits.

Modi will launch projects worth more than Rs 11,100 crore to revamp civic facilities and develop world-class infrastructure in Ayodhya and projects worth over Rs 4,600 crore for other parts of Uttar Pradesh.

A statement issued by the Prime Minister's Office (PMO) said Modi's vision is to develop modern, world-class infrastructure in Ayodhya, improve connectivity and revamp its civic facilities, which also conform to the rich history and heritage of the city where devouts believe Lord Ram was born.

"In realisation of this vision, a



new airport, a new redeveloped railway station, newly redeveloped, widened and beautified roads and other civic infrastructure are being inaugurated in the city. Further, foundation stones for many new projects will be laid that will contribute to the beautification and revamp of civic facilities in and around Ayodhya," the statement said.

The first phase of the state-ofthe-art airport has been developed at a cost of more than Rs 1,450 crore. Its terminal building will have an area of 6,500 square metres, equipped to serve about 10 lakh passengers annually.

The building's facade depicts the architecture of the Ram temple while its interiors are decorated with local art, paintings and murals depicting Lord

It is also equipped with various sustainability features, such as an insulated roofing system, LED lighting, rain-water harvesting, landscaping with fountains, a water treatment plant, a sewage treatment plant, a solar power plant and many other facilities, to meet the fivestar GRIHA (Green Rating for Integrated Habitat Assessment) ratings, the statement said.

The airport will improve connectivity in the region, leading to a boost in tourism, business activities and employment opportunities.

The first phase of the redeveloped Ayodhya railway station -- named Ayodhya Dham Junction -- has been developed at a cost of more than Rs 240 crore. The three-storey modern station building is equipped with all modern features, such as elevators, escalators, food plazas, shops for puja needs, cloak rooms, child-care rooms and waiting halls, the statement added.

Referring to the Amrit Bharat trains, it said these new superfast passenger trains have locomotives at both ends for better acceleration. The trains will provide improved facilities for the passengers, such as beautiful and attractively-designed seats, better luggage racks, mobile phone charging points with suitable phone holders, LED lights, CCTV cameras and a public information system.

Modi will also dedicate to the nation three railway projects worth Rs 2,300 crore to strengthen the rail infrastructure in the region.

To enhance accessibility to the upcoming Ram temple, the prime minister will inaugurate four newly-redeveloped, widened and beautified roads in Ayodhya -- Rampath, Bhaktipath, Dharampath and Shri Ram Janmabhoomi Path.

Lord Ram's idol will be consecrated at the under-construction temple in Ayodhya on January 22.

# India planning to launch 50 satellites for intelligence gathering in five years: ISRO chief

Mumbai: India is aiming to launch 50 satellites in the next five years for geo-intelligence gathering which will include the creation of a layer of satellites in different orbits with a capacity to track the movement of troops and image thousands of kilometers of area, Indian Space Research Organisation (ISRO) chairman S Somanath said here on Thursday.

Speaking at 'Techfest', an annual science and technology event organised by the Indian Institute of Technology Bombay, he said it is important to improve the ability of satellites to detect changes, to bring in more of AI-related and datadriven approach to analyse data, reduce data downloads and get only the necessary information.

Spacecrafts are capable of observing a country's borders and neighbouring regions, he noted.

"All of it can be seen from satellites. This capability gives us enormous potential. We have been launching satellites to handle this, but there is a different way of thinking now and we need to look at it in a much more critical manner because the power of (any) nation is the ability to understand what is happening



around it," Somanath said.

"We have already configured 50 satellites to be realised in the next five years and this is going to be launched for India for supporting this par-ticular geo-intelligence over the next five years plus (period)," the ISRO chief added.

If India can launch satellites at this scale, threats to the country can be better mitigated, Somanath said.

"We have found out a way by which a layer of satellites can be launched starting from GEO (geostationary equatorial orbit) to LEO (lower earth orbit) and also very low earth orbit where we need very critical assessment of some situation," he said.

This is a new domain which is coming up not only in optical, but also in SAR (synthetic aperture radar), thermal and various other technologies, Somanath pointed out.

"We will have communication between satellites, so that if some satellite detects something, which is at GEO at 36,000 kms, it can have a large view. If you find some activity happening, you can task another satellite in the lower orbit (to check) much more carefully and then give more information," he said.

"We are also looking at imaging, not a very small area (but) thousands of kilometers of area and we would like to cover entire borders in everyday cycles. This is a tremendous capability that we are building if we are able to launch these satellites in the next five years," he said.

cases seeking treatment in 2023, a decrease from 1555 in 2022.

Notably, the government has launched a massive awareness campaign throughout the union territory to curb the drug menace.

The efforts of the UT administration was even lauded by Prime Minister Narendra Modi in July this year for tackling the menace of drugs including organizing musical nights and bike rallies in high altitudes in the Union

The UT administration has implemented a strict zero-tolerance policy and has initiated a campaign known as "Nasha Mukt Abhiyaan" to combat the issue of drug abuse. Under this initiative, the government of J&K has launched a campaign aimed at creating drug-free communities, including cities and villages.

'The main objective is to increase awareness among the youth and Panchayati Raj Institutions (PRIs) within the Union Territory, encourage ing them to detach themselves from this detrimental issue," said an official from the divisional commissioner

He further said that by employing a united and preemptive strategy, members from every sector of society will work closely with the administration to guarantee that villages and communities stay clear of the menace of drugs.

Dr. Yasir Rather, overseeing the drug de-addiction center at GMC, Srinagar, informed Kashmir Observer that the combined efforts of the government, medical practitioners, members of civil society, and journalists are yielding results, which is evident in the significant decrease in the number of patients seeking drug de-addiction treatment at IMHANS.

"I must say since the authorities have launched a massive crackdown on supply of heroin and are trying to break its chain, the number of heroin abusers have reduced significantly due to its non-availability," Dr. Rather

He, however, added that the drug addicts are shifting to other drugs that need to be looked-into.

'There is a huge reduction in supply of drugs, and the aggressive awareness campaign by the government is yielding positive results," he added.

"Decline in addiction magnitude seems to be good news for now, the news would be better if we are able to sustain our collaborative efforts and continue with this reduction in the number of cases for the next few months to years to achieve the goal of drug free society," Dr. Rather added.

In order to keep a tab on substance abuse, authorities in Jammu and Kashmir conduct District Level meetings on Prevention of Drug Abuse & Narcotics Trade (NCORD) in every district of the union territory. During these meetings, deputy commissioners review the measures taken and the progress achieved in combating drug abuse within their respective

The J&K police have also launched a massive crackdown on drug peddlers and their handlers, resulting in the booking of hundreds of peddlers under PITs-PSA and other Acts. The police have also started to attach the properties of drug peddlers across the

Additionally, the police also launch special drives in every district to destroy wild bang (poppy straw) grown illegally by the smugglers.

Dr Abdul Majid, HOD psychiatry SKIMS Medical College Bemina told Kashmir Observer that even the statistics are a positive sign but it will be too early to celebrate and a lot of work is yet to be done.

He argued that a considerable number of drug addicts are from the transport and student community, who travel to other states in winter and don't seek treatment here.

"Obviously, we need to applaud the government agencies for doing a wonderful job but there are many observations that we need to keep in mind. There is a lot of work yet to be done," he told Kashmir Observer.

He said the government's initiative of starting the Addiction Treatment Facility Centres (ATFCs) in every district in the UT is proving to be a game Notably, the government has set-up

Centre abrogated the provisions of Article 370 on August 5, 2019 and bifurcated the erstwhile state of Jammu and Kashmir into Union territories. The apex court upheld the decision earlier this month.

Shah, however, asserted that the isue is not dead vet.

"I want to tell those celebrating the verdict and using it to score political points that the issue is not dead yet. The people of Jammu and Kashmir will give a befitting reply to you that they have not accepted the August 5, 2019 decision and the December 11. 2023 verdict of the Supreme Court,"

On three civilians allegedly killed in the Army's custody in Jammu and Kashmir's Poonch last week, Shah said the "armymen involved in the torture and killings should be court-martialled".

Meanwhile, CPI (M) leader M Y Tarigami also said various stakeholders are contemplating moving the Supreme Court with a review petition over its December 11 judgment.

A review petition must be filed within 30 days from the judgment or order of which a review is being sought and placed before the same bench that had delivered the decision.

'The Supreme Court has the authority but as a citizen, I have my views too, according to the Constitution and guidelines of the apex court. Our opinion is that the people of Jammu, Kashmir and Ladakh have not received justice and all the stakeholders, including the petitioners (in the matter), are exploring options so that we can get justice," Tarigami told reporters here.

He said consultations are going on among the petitioners who had moved the top court challenging the abrogation of Article 370 and "we are contemplating filing a review petition within the time-frame".

Asked if they are planning to move the court under the People's Alliance for Gupkar Declaration's (PAGD) banner, the Left leader said different parties and individuals moved the court separately in the past and the same route could be taken again.

'The window is open and why should we believe that this window will not open with good news for us? When we first moved the court, some people expressed hopelessness. But as a student of politics, a human being and a citizen, we have to move forward in the direction where we can see a ray of hope and justice. The opportunity is there and we have to avail it, as suggested by several former Supreme Court judges," he said.

In an apparent reference to the ruling Bharatiya Janata Party (BJP) at the Centre, Tarigami said misleading narratives are being built to justify the abrogation of Article 370, which was a "bridge between Jammu and Kashmir and the rest of the country".

He alleged that the abrogation of Article 370 was not just an "ordinary mistake", but an "assault on the basic constitutional rights of the people of Jammu, Kashmir and Ladakh".

The Communist Party of India (Marxist) leader also referred to Lieutenant Governor Manoj Sinha's statement at a function in Jammu on Tuesday that had Article 370 remained in Jammu and Kashmir, the Anand Marriage Act would not have become a reality and said misleading narratives are persistently being propagated in order to convince people about the benefits of abrogating the special constitutional position of the erst-

"There has been a long list of mendments made to Article 370, allowing the application of central laws to Jammu and Kashmir. The passage of the GST Act in 2017 by the Jammu and Kashmir Assembly was one of such instances in recent times," he said.

The former MLA said there were 42 Constitution (Application to Jammu and Kashmir) orders, extending the scope of central intervention, which were not envisaged at the time of the adoption of Article 370.

"Additionally, the extent of the misuse of Article 370 to encroach on the State's powers can be seen from one of the measures taken in July 1986, when the president issued an order under Article 370, extending Article 249 of the Constitution to the state. This empowered Parliament to legislate on matters on the State List on the basis of a resolution passed by the Rajya Sabha.

"Pertinently, it received the approval from the centrally-appointed governor, Jagmohan. Such overriding of the State List is unique to Jammu and Kashmir and not applicable to other states," he said.

Tarigami said a narrative is being built in the country that Jammu and Kashmir had to deal with terrorism due to the presence of Article 370 and that tourism has flourished in the region after its abrogation.

"Article 370 was a bridge between the Muslim-majority region and a secular India. I want to tell those who want to distort history and make false claims that terrorism raised its ugly head in the most peaceful region after governments were formed from Delhi and the trust of the people here was shattered. Tourism is nothing new for a region that received visitors from abroad in the past as well," he

The Left leader said a recent terror attack on the Army in Poonch and the subsequent alleged custodial killing of three civilians were "unfortunate" and asserted that terrorism cannot be

defeated by creating lawlessness. "Do not push people to the brink. Uphold their trust in the system. Create jobs for the unemployed youngsters," he said, questioning the claims of Jammu and Kashmir attracting massive investment after the abrogation of Article 370.

BARAMULLA: The District Consumer Disputes Redressal Commission (DCDRC) Baramulla/ Bandipora on Thursday imposed a penalty of Rs. 30,000 on the Power Development Department (PDD) Baramulla for an administrative oversight regarding an inflated electricity bill of a consumer.

A complaint was filed by a consumer at the court who had been charged a huge amount for their electricity bill due to an administrative oversight whereby the department had generated two consumer IDs for a single connection, resulting in the inflated billing. Despite the complainant's prior attempts to

rectify the error through official channels, the authorities failed to provide a resolution.

Upon receiving the complaint, the DCDRC swiftly initiated cognizance under the leadership of Peerzada Qousar Hussain, serving as the President of the Commission.

A thorough proceeding found the concerned authorities culpable for the oversight. As a consequence, the Commission held the officials negligent, accountable and levied a penalty of Rs. 30,000. This amount, signifying compensation for the distress and mental anguish caused to the complainant, is to be deducted from the officials' salaries and are directed to make the payment.

#### 3 Men Get Life Sentence In **Handwara Murder Case**

**SRINAGAR:** A local court in north Kashmir's Handwara on Thursday pronounced life sentences to three accused in a 14-year-old murder case.

The Additional & Sessions Court Handwara pronounced the conviction of these accused in case FIR No. 128/2009, under sections 148, 149, and 302 RPC, Police Station Handwara. "After thorough hearings

"Also, they face a 3-year imprisonment term under sections 148 and 149 RPC, coupled with a fine of Rs. 10,000 each," the official said.

"Other accused involved in the case have been handed down varying sentences," he said, adding that the remaining accused parties are subjected to 2 years of imprisonment with a fine of Rs. 1000 under sections 147 and 149 RPC, while accused 8 and 9 received a punishment of 1 year for the offense under section 323 RPC. "All sentences are set to run concurrently," he added.
