Behind the Digital Curtain

### The Hidden Plight of Elderly Isolation in Kashmir

Srinagar: In a snug living room, adorned with lace curtains, Atiqa Begum sits in one corner, her legs draped by a quilt. A gas heater, positioned at the center, exhales comforting warmth that counters the crisp chill seeping through the windowpanes. Surrounded by family, the room is filled with the murmur of distant conversations — not among the family

members sharing the space, but emanating from the digital devices held by each one.

Amid the quiet tapping of fingertips on phone screens, Atiqa's eyes wander from one family member to another, a subtle longing in her gaze. Atiqa, who is in her early 80s, remains a silent observer - a poignant silence echoing the unspoken reality of a generation experiencing a unique form of isolation, one that exists amidst the company of loved ones.

"I feel a bit lost, even when everyone's around. I miss the days when we would talk face to face, share stories, and feel the closeness. It's not the same, just being in the same room but lost in devices." Atiqa said.

"I don't know how am I supposed to pass my time. Ever since he left, I feel lonely," she added, while looking at the picture of her late husband that hung prominently on a wall.

As social interactions have increasingly migrated to virtual spaces, older individuals may feel left behind, struggling to navigate a realm that seems foreign and impersonal. The prevalence of social media, video calls, and online platforms becomes a stark reminder of a technological and generational gap prevalent in our society.

Studies define loneliness as the emotional state or

subjective experience of feeling isolated, disconnected, or lacking meaningful social connections. A report from the National Academies of Sciences, Engineering, and Medicine (NASEM) points out that more than onethird of adults aged 45 and older feel lonely, and |

**VULNERABILITY TO CLIMATE CHANGE** 

### **J&K Ranks 3rd Among IHR States**

Over 11 Districts Require Immediate **Adaptation Measures: Study**

Srinagar: Jammu and Kashmir figures at the third slot among Indian Himalayan Region (IHR) states with a vulnerability index of 0.62, as revealed in a comprehensive study conducted by the Department of Ecology, Environment, and Remote Sensing, Government of Jammu & Kashmir.

report, to titled Inherent Assessment Vulnerability to Climate Change in Jammu & Kashmir," a copy of which lies with Kashmir Observer, highlights the vulnerability status of I&K at the national level and within the context of the Indian Himalayan Region (IHR).

The study identified and categorized the most vulnerable districts in I&K with respect to India and IHR along with the major drivers of vulnerability. A team of scientists led by Dr. Majid Farooq along with Dr. Fayma Mushtaq, Mudasir Dada, Ubaid Yousuf and Zubair Malik

carried out the study in all the districts to know the climate vulnerabilities

Based on this assessment, over eleven districts of Jammu and Kashmir are under high risk of climate vulnerability, and require immediate adaptation and interventions to mitigate risks.

Among the eleven districts, eight belong to the Kashmir region, while three are from the Jammu region. The districts. namely Kupwara, Bandipora, Baramulla, Budgam, Ganderbal, Pulwama, Anantnag, Kulgam, Kishtwar, Ramban, and Doda, fall under the high category (0.49-0.59) of climate vulnerability.

The report reveals that in terms of agricultural vulnerability of the districts, Bandipora, Ganderbal, Srinagar, Pulwama, Anantnag, Shopian, Kulgam, and Reasi fall under relatively high vulnerable categories (0.47-0.53).

Prime Minister Narendra Modi will interact with the country's top police officers before addressing them at a formal session. Union Home Minister Amit Shah will be present throughout the conference that will span several sessions.


On December 6 last year, the Northern Railways successfully conducted the first trial run of an electric train

#### **Smart City Bus Conductors Accused of Ticket Refusal**

Srinagar: In a recent development, passengers have accused a number of smart city bus conductors of refusing to issue tickets. This breach of protocol has sparked concerns among authorities and commuters alike.

However, the Srinagar Corporation Municipal (SMC) Commissioner and CEO Smart City, Athar Amir Khan, has taken swift notice of the issue and has assured the public that necessary actions will be taken against the erring conductors.

According to passengers, they have faced inconvenience as some smart city bus drivers allegedly declined to issue tickets after collecting the fare, raising questions about the effectiveness of the smart ticketing system implemented as part of the smart city project.

"I took a bus ride from Hawal in the old city to Lal Chowk but I was not offered a ticket by the bus conductor. It was my first ride on the bus and I was not even aware of it," a female commuter, wishing anonymity, said.

"It is sad to learn that the money has gone straight to the conductor's pocket. I hope authorities take note of the situation," she added.

This issue was also reported by veteran journalist Yusuf Jmaeel on X (Twitter), sparking a debate on the microblogging site.

gers. When asked about it, he said, they don't pay the fare in full," Yusuf Jameel wrote, tagging C.E.O smart city Athar Amir Khan.

"Also, the driver would pick up & drop off passengers at any place. Are there no designated bus stops for this service or route? Needless to say, cleanliness & maintenance are very important. Found this particular bus lacking the former. Thought to tell you about all this" Jameel added.

In a reply to the tweet, SMC Commissioner Athar Amir Khan assured action, saying they have a very strict policy with respect to this and replied that the case was verified and action initiated accordingly.

"We have a very strict policy with respect to this. It will be verified and action initiated accordingly!"

"There are 4 cameras inside the bus. We can easily see and count at any point of time or on any stretch. That gets cross checked with the tickets issued using the Electronic Ticketing Machines! We do this audit on a regular basis. There is a technical team which does the job." Athar Amir wrote.

### **Once Famed, Kashmir's Anchar Lake Fights For Survival**

'Pollution, Encroachment Threaten Its Pristine Waters'

Srinagar: Once renowned for its fish, Nadru, and lush vegetable gardens. Anchar Lake in the Soura area of Srinagar was now struggling for survival as unauthorized disposal sites have been established on its coastline, causing it to become a victim.

The lake, linked to Dal Lake through the Nallah Amir Khan water channel, has faced a drastic reduction in size as

well, nearly half of its original area, over the past few decades due to administrative neglect, rampant pollution, siltation, and encroachment.

Formerly a sought-after tourist destination, Anchar Lake is losing its allure as the nearby residents continue to dispose of solid waste directly into its waters on a daily basis. The lake, once famous for high-quality fish, Nadru, vegetable gardens, and chestnuts, no longer exhibits these features, according to locals.

According to locals, the current state of the lake has taken a toll on aquatic life, impacting the 93,000 residents who rely on fishing and other sources of income. The lake's size has dwindled from 19.4 sq. km to just 6.8 sq. km, transforming

and various pollutants. Fareeda Begum, residing on the lake's shores, expresses concern as her area, along with other low-lying areas, is

sewage, residential trash,

being used as a dumping site for domestic and commercial waste. "The lake, once crystal clear and a source of drinking water, is now heavily contaminated," she said. Migratory birds have vanished due to growing pollution, according to Fareeda's daughter, Shafeeqa.

Local fisherman Mohammad Ashraf laments the decline in Nadru production, attributing it to pollution, encroachments, and the lake's fast shrinkage.



### **Security Review Meet**

he recent surge in violence in Poonch and Rajouri and also killing of a former senior police official serves as a stark reminder of the persistent threat posed by the militancy. The tragic loss of lives, including security personnel and civilians, highlights the urgency to adopt measures, both security and political, that ensure a durable peace in the region.

Firstly, combating militancy demands a concerted effort on multiple fronts. Strengthening counter-terrorism operations, as highlighted by Union Home Minister Amit Shah, in Tuesday's meeting. This necessitates enhancing the capabilities of security agencies and ensuring coordination among them. The review of the area domination plan will entail concentration of troops in areas affected by militancy.

However, a sustainable solution goes beyond military strategies. Addressing the disillusionment and alienation among segments of the population is crucial. This involves socio-economic development initiatives that empower local communities, offering them opportunities for growth and progress. Investing in education, skill development, and job creation can significantly help ameliorate the situation.

Simultaneously, ensuring transparency and accountability in security operations is imperative to maintain public trust. Instances of alleged civilian casualties or human rights violations must be thoroughly investigated, as the recent incident in Poonch underlines. The administration was quick to reach out to the families of the three civilians who allegedly lost their lives in Army custody and institute probe. Upholding the rule of law and respecting human rights not only upholds ethical standards but also strengthens the credibility of security forces.

Moreover, constructive dialogue with stakeholders, including regional leaders, community representatives, and youth, is instrumental in addressing grievances and channeling aspirations through democratic means. This inclusive approach acknowledges the diversity of perspectives within the region and aims to find common ground for reconciliation.

The withdrawal of Article 370 in 2019 was a significant policy decision of the union government. However, the journey toward stability demands a comprehensive approach that amalgamates security measures with inclusive governance and socio-economic progress. The commitment to addressing the complex challenges in Jammu and Kashmir requires a cohesive and sustained approach, transcending short-term remedies to pave the way for a peaceful and prosperous future for the region.

While the Valley has come a long way over the last four years, much work remains to be done. As things stand, security forces have done their job to usher in the prevailing calm by reigning in the militancy. It is time that politics and political outreach moves to the foreground and gives people a sense of involvement in the decisions affecting them. This alone can give them a stake in Naya Kashmir.

### What INDIA needs

s the new year takes the baton from the old, and with the parliamentary contest only months away, three images of the country's Opposition seem resonant. In no particular order: AAP and Congress, two prominent members of the joint anti-BJP front, INDIA, are locked in an impasse over seat-sharing in Delhi and Punjab, and one of them, Congress, is also up against the Shiv Sena wall on the same issue in Maharashtra.

In West Bengal, festering tensions between the so-called old and new guards within Mamata Banerjee's TMC spilled into the open, with factions loyal to state president Subrata Bakshi and general secretary Abhishek Banerjee exchanging taunts on the occasion of the party's Foundation day.

And the fog is yet to lift within the Opposition front on the question of whether to go to Ayodhya for the inauguration of the Ram temple on January 22, or not, with the CPM its only prominent member so far to clearly rule out its participation. The three images point to three Opposition challenges that will become more and more urgent in 2024.

Of course, it won't be just three. INDIA must deal with more than conflicts of interest between constituent parties, turbulence within them, and the difficulties of framing and coordinating responses to issues thrown by the dominant BJP. What it will also have to find answers for, as the election countdown grows louder, are questions that involve not just parties but also the people.

After all, when all the calculating and negotiating and compromising within and between parties is done, the crucial task of convincing and persuading the people will still remain. Why will the supporters of the AAP or SP or TMC, for instance, vote for the Congress, and will they, really, just because the parties have firmed up a bargain on poll-eve? Are the Opposition's arithmetic sequences and sums reason enough? Why will voters prefer INDIA if it offers them a reactive or BJP-lite position on important issues, as it seems to be currently doing, instead of articulating an agenda that is more imaginative and affirmative?

As much as it constantly projects a confident and optimistic vision, the Modi agenda also counts on an accumulated voter pessimism and cynicism vis a vis Opposition parties.

# **2024: Global Election Fest**

2024 will be a historic election year, when democracy will undergo a major test with elections in approximately 70 countries including the United States, India, Mexico and South Africa. More than 3.7 billion voters will head to the polls, and their results may have global impact and ramifications

he current year will be the greatest year for democracy and democratic institutions worldwide. The greatest power in the world (the United States), the most-populous country (India), the biggest trading bloc (the European Union), the largest Muslim country (Indonesia), the largest Spanish-speaking country (Mexico) and the territory that is the most contentious one between the two superpowers of this century (Taiwan), all will hold elections in 2024.

A total of more than 3.7 billion inhabitants around 70 countries - or almost half of the global population – will head to cast their votes in either presidential or legislative elections in the coming year. The verdict of these polls may have profound consequences on the lives of people and on a world that is going through a turbulent time, with on-going brutal wars in Ukraine and Gaza, as the West seems falling into decline, with no clear alternative.

On a geopolitical level, this electoral jamboree might have a major impact. Major disruptive results include the return of Donald Trump to the White House, a third consecutive victory in Taiwan by candidates that Beijing considers hostile, or a consolidation of the extreme right in the European Union, all of which could lead to far-reaching consequences.

In addition to these, other elections to watch out for include the potential presidential elections in Venezuela to those in Ukraine, from Indonesia to South Africa and Mexico, besides the United Kingdom – where a substantial change of course would not be expected regardless of the outcome.

#### Test for Democracy

However, what might be the worrisome aspect of these elections is the litmus test which democracy will undergo. Surveys by different international think tanks and institutes indicate dissatisfaction with the present-day working of democratic institutions - a sentiment common throughout the nations of the west – meaning, the US and Europe – even though they see themselves as democracy's home ground. A recent Ipsos opinion poll in western countries found a widespread belief that current democratic systems favour the rich and powerful and ignore everyone else.

Freedom House, the independent, US-based watchdog concluded in its 2023 report that the Global Freedom Index declined for the 17th consecutive year. The principle of free speech, essential to a fully functioning democracy, is also under attack.


Paradoxically, this unprecedented vote-fest comes at a moment when classic forms of liberal democracy are under existential attack from authoritarians and dictators such as China's Xi Jinping and Russia's Vladimir Putin, far-right nationalist-populist parties such as in Austria, Hungary and Scandinavia, and military coup plotters and Islamists from Venezuela to Chad.

Yet the report said while 35 countries experienced declines in political rights and civil liberties, 34 saw overall gains. Autocrats were neither infallible nor unbeatable.

The geopolitical and economic impacts of so many ballot box battles, occurring more or less at once, may combine to further destabilise an unstable world – for good or bad.

#### Rise of the Far Right

The European continent will see elections in

Austria, Belgium, Croatia and Finland, as well as for the European Parliament in June. The pervasive fear is that they may accelerate advances by nationalist-populist, anti-migrant, xenophobic parties of the far right, matching those seen recently in Italy, the Netherlands and Slovakia. The results will shape the new chamber, with possible new legislative majorities that will influence the leadership of the EU. One wonders how high the far-right wave may rise.

The average of polls compiled by Politico magazine indicates a rise of the two far-right blocs and a decline in support of the traditional European conservatives, social democrats, liberals and greens. Even so, the latter groups might retain a comfortable majority. The crux of the question is to see if an eventual coalition between populist and far-right groups could form an alternative majority. At the beginning of December, in the seat projection put out by Politico, the distance between extremists and moderates was only about 20 seats, out of a total of 720.

#### India and Its Neighbours For India, which

For India, which itself will be holding the general elections, in which the incumbent Prime Minister N Modi is expected to score a hat trick, will closely watch elections in its neighbourhood i.e. in Pakistan and Bangladesh which may have a major regional and strategic impact.

Pakistan is plagued by a serious economic crisis and high political tensions, including arrests and attempted assassinations of political leaders. Following the dissolution of Parliament back in August, elections should have been held within 90 days, but have been postponed twice. They are now scheduled for February. The country-with some 240 million inhabitants-has enormous strategic depth, not only due to its nuclear arsenal, but also due to its close relationship with China. The Beijing-Islamabad axis is New Delhi's biggest concern.

The first election of 2024 could be one of the most contentious. Prime Minister Sheikh Hasina and the ruling Awami League -AL have dominated Bangladeshi politics for the past fifteen years. Over that time, they have increasingly eroded Bangladesh's democracy. As Freedom House puts it, the AL "has consolidated po-

litical power through sustained harassment of the opposition and those perceived to be allied with it, as well as of critical media and voices in civil society." The United States has been pressing Sheikh Hasina for months to hold free-andfair elections, that pressure has yet to pay off.

#### Major Elections

At the global level the US elections and those of the EU may have a major bearing on India's foreign and defence policies, with some overlap on its internal politics, too.

The US presidential elections next November have immense disruptive potential. The possibility that Trump will be the Republican candidate and return to the White House is still not ruled out. A Trump-return to the White House would represent a major shake-up with associated risks. It would be a step towards American isolationism at a time when rival powers are questioning the world order that Washington has created.

Trump would embody a break with 'America for the world' scenario, his "America first" doctrine means limiting efforts and expenses in distant horizons. It's doubtful whether he would commit to supporting Taiwan if it comes under attack, or whether he would maintain financing and security guarantees made to Ukraine and NATO. New trade wars would be likely, as would a withdrawal of commitments against climate change.

In addition, the elections in 2024 will further highlight the manner in which our lives have become slaves to social media and this will have an impact on the election processes too. As Kay Spencer, program director of elections at the Washington-based National Democratic Institute (NDI) puts it, the year 2024 is a big year for social media platforms and it will be important to monitor how they will manage all the elections that are coming up.

Indeed 2024 might prove to be a year, which consolidates the liberal democratic principles and institutions, or lead to their further erosion.

# How A Man's World Systematically Neglects Women

The existence of "women's issues" reflects the simple fact that we live in a man's world. Over the course of centuries, research and policies focused on men became the default, whereas initiatives that account for women are "womencentred." But if men are treated as the default, virtually no aspect of women's lives ends up being built or optimized for them. Research that excludes women is not simply "gender-neutral" – it is "incomplete."

The consequences can be deadly. For example, women are 73% more likely to be injured, and 17% more likely to die, in vehicle crashes than men. One reason for this is that the crash-test dummies used in vehicle-safety trials are designed to mimic the body of an average man. "Female" dummies were not even developed until last year, and regulators still do not require that they be included in vehicle-safety research.

Personal protective equipment, like that used by health-care workers, is also optimized for male bodies, with dimensions staying the same even as items are scaled down for women users. In a 2020 survey of British health-care workers, 44.7% of women found PPE overalls ill-fitting, compared to just 15.3% of men. In a recent survey in Canada, more than 80% of women respondents reported issues with PPE.

Similarly, the "unisex" body armor used by police officers is designed for men, leaving women both uncomfortable and potentially more vulnerable to attack, especially around the armpit and neck. In the United Kingdom, where 50,000 women now serve as police officers, women-specific body armor was not introduced until this year.

While women are no longer excluded from clinical-drug trials, they continue to be underrepresented, particularly in the



trials' early phases. As a result, women still face a higher risk of adverse side effects from medication, not least because recommended doses are not optimised for women. An analysis of studies in which women were given the same drug dosage as men showed that, in more than 90% of cases, women experienced stronger side effects and more adverse reactions.

That analysis arose from the observation that women taking Ambien, a sleep medication, were experiencing severe side effects, including a higher rate of traffic accidents the morning after. As it turned out, researchers found, the recommended dose produced much higher blood concentrations and drug-elimination times in women than in men. The US Food and Drug Administration now recommends that women receive half the

"standard" dose.

Making matters worse, when it comes to health issues that primarily affect women, research tends not to be funded at all. In nearly 75% of cases where a disease primarily affects one sex, the pattern favours men: "men's diseases" are overfunded, and "women's diseases" are underfunded

Women's needs also take a backseat to men's when it comes to tackling sexual violence. Because women are overwhelmingly the victims of such crimes, preventing sexual violence is treated entirely as a "women's issue" – one that has no consequences for men, even though they comprise the majority of perpetrators. Policies are so focused on the victims – for example, improving outdoor lighting, establishing helplines, and creating "safe spaces" – that the

source of the violence is never addressed.

Likewise, health-related data have been collected primarily from men, which poses serious risks as artificial intelligence trained on such data is applied in health care. For example, if a man reports pain in his left arm and back, a medical app - trained on data establishing cardiovascular disease as a predominantly male issue - will recommend that he seek help for a potential heart attack. That same app might suggest that a woman is experiencing depression and thus does not need urgent care, even though women are hardly immune to heart attacks.

Al has the potential to harm women in other ways, too. In 2015, Amazon scrapped its Al recruiting tool for exhibiting bias against women. Having "learned" to assess applications

by observing patterns in resumes submitted over the previous decade – resumes that had come overwhelmingly from men – the computer model rated male candidates more highly. This should not be surprising, given women account for only 12% of AI researchers and 6% of software developers. Several other companies that continue to use AI software for recruitment do not monitor it for bias.

Despite considerable evidence showing that advances toward gender equality play an important role in driving economic progress, analysis focusing solely on macro aspects of growth disregards gender. Ignoring the fact that government spending, taxation, and monetary policy have different consequences for men and women can lead to flawed economic assessments, undermining the effectiveness

of policies and the accuracy of forecasts.

For example, women's unpaid labour as primary caregivers is unaccounted for in macroeconomic policy. Tasks like cooking, cleaning, fetching water, and caring for children and the elderly have substantial economic value, accounting for between 10-60% of GDP. As a result of genderblind analysis, women are overworked and underpaid. Increasing the share of women in the workforce needs to be accompanied by policies that reduce and redistribute this unpaid labour.

Consider the debate over India's economic prospects. With India having recently overtaken China in population, some analysts predict that it will also surpass China in economic growth. But, as Ashwini Deshpande and Akshi Chawla explain, this works only if the population increase is reflected the workforce, and in India, low female labour-force participation limits the effect.

Gender plays a crucial role in countless other policy areas, including the single biggest challenge of our time: climate change. Like most of the other issues addressed by the Sustainable Development Goals, the effects of global warming, including climate-related disasters, disproportionately affect women.

When half the global population is treated as an afterthought, research is less accurate, policy is less effective, and human welfare is diminished. That will not change until accounting explicitly for women becomes the norm in every sphere of research, product design, tech, and policy.

#### The Hidden Plight

nearly one-fourth of adults aged 65 and older are considered to be socially isolated. Older adults are at increased risk for loneliness and social isolation because they are more likely to face factors such as living alone, the loss of family or friends, chronic illness, and hearing loss

In Kashmir, there is a saying, "bed'eh te shur gow hyuwuy," which suggests that there are similarities in the needs and care required for both young children and elderly individuals. In a broad sense, it emphasizes the vulnerability and dependence that can be present in both groups. But when it comes to reality, there may be disparities in how society treats older individuals.

A recent study published in the Indian Journal of Psychiatry, examining the prevalence of loneliness among India's elderly population, revealed that Jammu and Kashmir had the highest prevalence of loneliness among the elderly. Another research titled, "Marginalized and Alienated Elderly of Kashmir: Contesting Their 'space' in the Family and Society," found that the recent advancements within the society and the lack of preparedness to deal with the subsequent challenges have further marginalized and alienated the elderly in and outside the family setting.

side the family setting.

Sociologist Dr Farah Qayoom also feels that there has been a shift in societal attitudes towards aging and older adults. "In present times, families have become more isolated and this has a direct impact on the elderly. With every other member of the family well equipped with technology, the elderly feel isolated and irrelevant. This impacts their relationship with children and grandchildren and their psychosocial well being as well," Dr Farah said.

The Interplay of Health and Isolation

In south Kashmir's Kulgam, 87-year-old Rehman Sofi (name changed) often hints at his health concerns, dropping fragmented comments about aches, fatigue, and his eye-sight. He attempts to communicate the intricacies of his well being, seeking acknowledgment and understanding from his family. However, his words often fall on deaf ears as "the family members dismiss these repetitions as mere quirks of age," Sofi said.

"Mya kya shokh chuma (which roughly translates to 'I don't do this for fun')," Sofi said, adding, Sometimes I feel like I am a burden. It is not that they don't care for me, but the sense of belonging is lost."

Sofi said that the decline in his health has exacerbated his sense of isolation, and conversely, his isolation has played a role in the deterioration of his health. "It's a cyclical situation," he said.

The World Health Organisation (WHO) has recognized loneliness as a pressing health threat, with serious consequences for the health and mental well-being of the elderly and young people worldwide. A study published in the Journal of the American Medical Association Psychiatry revealed that loneliness is associated with early Alzheimer's disease.

Healthcare practitioners in Kashmir also say that social isolation and loneliness have a serious impact on older people's longevity, their physical and mental health, and their quality

Dr Zubair Saleem, senior Geriatric Consultant and Gerontologist, said that social isolation has been associated with a weakened immune response in seniors, making them more susceptible to illnesses.

"Seniors who experience social isolation may be at higher risk for various health issues, including diabetes, obesity, and cardiovascular problems. Loneliness can diminish overall life satisfaction and lead to a sense of purposelessness," Dr Zubair said.

"Physical ailments or chronic conditions can limit seniors' mobility, making it challenging to engage in social activities. Issues like arthritis or balance problems can restrict seniors' ability to go out, affecting their social interactions. Besides, death of spouses or close relatives can lead to social withdrawal," Dr Zubair said, adding that shifting away from familiar surroundings and communities can sever social connections, contributing to isolation.

emphasizing

Stressing on the need of intergenerational bonding by connecting seniors with younger generations through open communication, the geriatrician said, "Teaching seniors to use technology can facilitate virtual connections with friends and family, especially if in-person interactions are limited."

According to Dr Zubair, one of the most significant factors contributing to social isolation among seniors in Kashmir is neglect and abandonment by their adult children. "It is crucial to emphasize the importance of respecting and caring for parents. Involving them in decision-making at home, facilitating their social commitments, and addressing them with utmost respect and care are essential steps towards fostering meaningful connections and preventing social isolation among the elderly."

"Elderly people can suffer from emptiness syndrome, which is associated with feelings of loss, sadness, anxiety, grief, irritability, and fear. It impacts both men and women. However, mothers are susceptible to this as they have dedicated precious years of their lives bringing up their children," Dr Umer Jan, a Neuropsychiatrist said.

#### **Cop Among**

following investigation in a hawala case involving former minister and chairman of Nature-Mankind Friendly Party Jatinder Singh alias "Babu Singh".

Singh was arrested in April 2022 after one of his worker's Mohammad Shareef Shah, a resident of south Kashmir's Kokernag, was held along with hawala money of Rs 6.90 lakh in Jammu.

The SIA had already filed a charge sheet against 12 accused, including the former minister in the instant case. While nine accused are lodged in Central jail, three absconders are in Pakistan.

A team of SIA raided the house of the policeman in the Belicharana area here on Tuesday and seized some electronic gadgets, the officials said, adding further investigation is in progress to dismantle the ecosystem of narcotics supplies to fund anti-national activities.

Earlier also, the officials said the policeman was booked under Narcotic Drugs and Psychotropic Substances (NDPS) Act when he was arrested with 200 grams of heroin from Shahpur Kandi area of Pathankot.

The role of the policeman and the former sarpanch came to light following the arrest of key accused Mohd Sharief Chechi, also a resident of Uri, in September last year.

After taking over the investigation of the case, the official said SIA unearthed the modus operandi adopted by the accused, including Chechi who used to collect narcotics from across the Line of Control to generate proceeds for terror funding.

The case was initially registered at Police Station Gandhi Nagar in Jammu following arrest of Shah on specific information that he along with the former minister were working under the directions of Pakistan's ISI and their agents to fund Jammu-based separatists to carry out subversive activities, the officials

the study reads.

A set of 14 indicators of vulnerability was used in the assessment capturing both 'sensitivity' and 'adaptive capacity' of districts.

The report further revealed that people with extremely low incomes are among the most vulnerable, as they have little to no financial capital; so, they have the least capacity to adapt to the impacts of climate risks.

According to the experts, assessing vulnerability to climate change is important as it helps to understand climate risks and provides information on the location specific measures to be taken to adapt to climate change.

"Hence, a vulnerability assessment is the first step in adaptation planning," the experts said, in the study, adding that this project was initiated to inform the policymakers of J&K on the vulnerability profiles of different districts using a common assessment framework.

"The present assessment has used the Intergovernmental Panel on Climate Change (IPCC) 2014 'Risk and Vulnerability Framework' as the base of such a common framework, which is a clear improvement over the IPCC-2007 framework," the experts said.

The report emphasized that the excessive utilization of natural resources will result in climate variability.

"Climate variability and change directly affect the productivity of natural resources. Any alteration in the quality and availability of natural resources will have far reaching implications on resource users and the extensive social and economic systems they support. Thus, higher dependency on natural resources for income generation increases vulnerability,"

It further highlights that Horticulture trees are hardy and more resilient to climate variations compared to agricultural crops.

"They provide alternative income sources to agriculture. Once established, they are far less sensitive to the impacts of climate risks, particularly rainfall variability and droughts (IHCAP, 2019)," it says.

is buried. Soleimani is considered a martyr by the 'Axis of Resistance' which is engaged in war against Israel in and around Gaza.

Thousands of people had gathered at Soleimani's gravesite to commemorate his fourth anniversary. According to IRNA, the first explosion occurred some 700 meters from the grave of General Soleimani and the second one about one kilometer away. The first explosion occurred at 14:50 local time, and the second took place 15 minutes later. A delayed second explosion is often used by terrorists to target emergency personnel responding to the scene and inflict more casualties.

The attack comes a day after top Hamas leader Saleh al Arouri was assassinated in a drone strike in Beirut and a week after a top Iranian commander in Syria Brigadier General Seyyed Razi was killed in a similar attack. Both attacks have been carried out by Israel, it is widely believed.

Israel has earlier conducted targeted assassinations of Iranian scientists inside Iran while extremist groups including Daesh have conducted large-scale attacks in the past that killed civilians.

Soleimani, Iran's iconic military general, was assassinated in a US drone strike during a visit to Baghdad in 2020 to meet the thenprime minister reportedly to discuss Iran-Saudi rapprochement.

Soleimani was the architect of Iran's regional military alliances called "Axis of Resistance" spreading from Yemen to Gaza to fight the US dominance and defeat the Daesh terror group in the region, particularly in Iraq and Syria.

He has been instrumental in helping build military capabilities of Palestinian factions against Israel.

On Tuesday, long queues of motorists were witnessed at many places in Punjab and a few parts of Haryana over fears that stocks would run dry soon in the wake of truckers' strike. The situation was normalising at petrol pumps on Wednesday in Punjab where fuel supplies were being replenished with fresh stocks.

### Virat Kohli Surges Into Top 10 In ICC Test Rankings

**DUBAI:** Indian batter Virat Kohli started the new year on a good note as he re-entered the top 10 in the ICC Test rankings, climbing to ninth position, the International Cricket Council (ICC) announced the latest ranking update on Wednesday.

"Former India captain Virat Kohli has returned to the top 10 of the ICC Men's Test Player Rankings while South Africa opener Dean Elgar has made a huge jump after his Player of the Match effort in the first Test of the two-match ICC World

Dean Elgar is certain to retire as a top-20 batter after his efforts in the first Test in Centurion, jumping 19 places to 17th (680) ahead of his last appearance.

Following his comeback to Test cricket, Jasprit Bumrah reentered the bowlers' rankings, finishing fifth (767), just behind compatriot Ravindra Jadeja (774). Marco Jansen's efforts resulted in a three-place climb to 22nd (618), but a five-place jump to 8th in the all-rounder standings, with a career-best rating of 268.

The latest weekly update also considers performances in the second Test between Aus-



Test Championship series in Centurion, which the home side won by an innings and 32 runs to take a 1-0 lead," ICC announced in a official statement.

Kohli, a previous top-ranked batter who fell out of the top 10 in mid-2022, has moved up four spots to ninth place with scores of 38 and 76, but is still 103 rating points behind top-ranked Kane Williamson of New Zealand (864 points). Joe Root comes in second with 859 rating points, while Steve Smith comes in third with 820.

Meanwhile, India skipper Rohit Sharma dropped four places to 14th position in the Test rankings. On the other side, South African veteran tralia and Pakistan. Australia's Marnus Labuschagne has risen one spot to seventh after scoring a half-century in the first innings, while Alex Carey (up four places to 41st) and Mitchel Marsh (up 16 places to 52nd) have also risen.

Pakistan hitters Saud Shakeel (up one spot to 13th), Abdullah Shafique (up three spots to 21st), and Mohammed Rizwan (up four spots to 27th) advanced following the Melbourne Test, which Australia won by 79 runs to take a 2-0 lead in the three-Test series.

After Siraj's career-best 6/15 decimated South Africa for their lowest postapartheid score of 55, Îndia were 153 for 4 before losing six wickets without addition of single run in a space of 11 deliveries to end with a 98-run lead. There were six Indian batters, who failed to open their accounts and one who remained not out also didn't trouble the scorer, making it a statistician's

nightmare. Lungi Ngidi (3/30) and Kagiso Rabada (3/38) got five of those six wickets keeping the lead below 100 and gaining the necessary psychological advantage as 23 wickets fell on the opening day.

South Africa were more cautious despite being aggressive as they scored 62 for three in their second innings at stumps to bring down the deficit to 36 runs. Aiden Markram (32 batting) looked solid in the middle.

The maximum number of wickets lost on Day 1 of a Test is 25 and that happened in an Ashes Test back in 1902. Dean Elgar, in his last Test match, would like to forget that he got out twice in a day's play while Mukesh Kumar (2/0 and 2/25) was rewarded for consistently pitching the ball in right areas, getting enough movement against southpaws.

Any chance of the match going into the third day looks remote. On a Newlands track that offered steep bounce and would certainly come under the ICC match referee Chris Broad's radar, the red Kookaburra ball took off like jumbo jet from the length making it impossible for batters to survive.

Between shoulder blades to lower abdomen, batters got hit everywhere as the bounce became variable towards the end of the day.

Rohit Sharma (39 off 50 balls) lived dangerously but smacked seven delicious fours, knowing that surviving won't get him anywhere. Ditto for Virat Kohli (46 off 59 balls) and Shubman Gill (36 off 55 balls), who also showed right intent.

The talented duo of Yashasvi Jaiswal (0) and Shreyas Iyer (0), from the famed "Khadoos School of Mumbai Cricket" didn't trouble the scorers, after once again being exposed for technical ineptitude.

### **Cummins Takes 5 But Pakistan Rallies On Day 1**

**SYDNEY:** Australia captain Pat Cummins took 5-61 for his third consecutive five-wicket haul as Pakistan's brittle top order was again exposed before a combative lower order rally helped the tourists to 313 on Day 1 of the third and final cricket test.

At 96-5 shortly after lunch on Wednesday, Pakistan was in grave danger of being bundled out cheaply after it had won the toss and chose to bat under bright, blue skies at the Sydney Cricket Ground.

But an enterprising counterattack led by wicketkeeper Mohammad Rizwan with a brisk 88, followed by a halftaking a wicket in the first two overs, before Cummins, coming off a ten-wicket haul in the boxing day test at Melbourne, snared two wickets including the prize scalp of Babar Azam as Pakistan batters crumbled.

From 4-2, Babar and Massood started the rebuild for Pakistan, with Babar attacking the Aussie quick bowlers.

But the rally was short-lived as Cummins removed Babar (26) with a ball that came back at the right-hander and struck him on the pad. Umpire Michael Gough turned down the initial Australian appeal, but the TV umpire overturned the decision.

Saud Shakeel was Cummins second wicket, edging behind



century from Agha Salmon and a stunning maiden test half-century by Aamer Jamal helped Pakistan recover to a respectable total.

Australian pair David Warner, playing his final test, and Usman Khawaja had to survive one over from spinner Sajid Khan under fading light before stumps.

Warner (6 not out) in characteristic style smashed the first ball for four, but was lucky later in the over as he survived the ball bouncing over the stumps from a defensive shot. Australia was 6 without loss at stumps.

Much of the pre-match attention may have been on Warner's last test for Australia, but it was the pace bowlers who stole the spotlight early.

Mitchell Starc and Josh Hazlewood set the tone with each to Carey to leave Pakistan's first innings in tatters at 47-4

Captain Shan Masood (35) and Rizwan shared a 49-run stand either side of the lunch break to steady Pakistan. Mitchell Marsh (1-27) ended that partnership by teasing an edge from Masood which flew through to Smith.

Rizwan went on the attack and made an enterprising halfcentury off 74 balls. He continued to play his shots, but eventually holed out to Hazlewood as Cummins' brought himself back in to the attack to take his third wicket.

The Aussie skipper got his fourth when he had Sajid caught at midwicket by Nathan Lyon for 15 and a deserved fifth shortly after with Hasan Ali (0) picking out Starc in the deep.
