Srinagar: In recent weeks, the valley has seen a significant rise in forest fire in-Influence promptauthorities to place men and machinery on high alert. At least 15 forest fire in-

The fire extended to the forest area along the Line of Control (LoC) in Poonch district of Jammu and Kashmir. The UT is richly endowed

Kashmir can be traced back to the prolonged absence of precipitation.

"Over the last 40 days, no active Western Disturbance has affected the region, resulting in a dry atmosphere. This ex-

tended dry spell has deprived the vegetation of essential moisture, leaving it highly susceptible to ignition," he explained.

What triggers forest fire?

Snowless Winters Spark Concerns Over Water Resources

New Delhi: High mountain passes with barely any snow, skiers hoping to slalom down white slopes disappointed and tourists calling off trips to hill destinations, the El Nino effect is playing out across the northwest Himalayas with an unusually dry winter and no immediate relief in the offing.

According to the World Meteorological Organisation (WMO), 2023 was the warmvear and the est-on-record warming El Nino event is likely to further fuel the heat in 2024.

The El Nino phenomenon occurs when sea surface temperatures (SSTs) are higher than average in the eastern tropical Pacific. and there is a simultaneous

weakening of trade winds. The absence of snowfall is not a onetime thing but affects the annual cycle of snow.

"If it continues longer, it can have a huge cascading effect on socio-economic benefits. If you don't get (enough) snow, you don't get replenishment of water, it will impact agriculture, your health and can, in turn, impact your economy," glaciologist and Himalayan researcher A N Dimri told PTI.

And so it is that the Border Roads Organisation (BRO) which struggles with snow clearance operations in tough weather conditions to keep the strategically located 11,800 feet altitude Zojila Pass open has had it easier this year.

Goal Is To Ensure That Govt. Schemes Reach All Eligible People: PM

New Delhi: Asserting that the Viksit Bharat Sankalp Yatra has not only become the journey of a government but of the country, Prime Minister Narendra Modi on Monday said when the poor, farmers, women and youth are empowered, the nation will become powerful.

Addressing the Yatra in various parts of the country via video conferencing, the prime minister said that under earlier governments, the scope of discussions on agricultural policy was only limited to production and sale, neglecting the various issues faced by farmers daily.

"Our government has made all-out efforts to ease every difficulty of the farmers," Modi said.

In his remarks, Prime Minister Modi also talked about the transfer of at least Rs 30,000 to every farmer through PM Kisan Samman Nidhi, promotion



of cooperation in agriculture with organisations like

PACS (Primary Agricultural Credit Society) and Farmers

Organisation (FPO), increase in storage facilities and the "boost" to food processing industry.

The prime minister said that Toor or Arhar dal farmers can now sell their produce directly to the government online, ensuring purchase at MSP and

better prices in the market. The scope of this scheme will be extended to other pulses also, he added.

"Our effort is that the money we send abroad to buy pulses should be available to the farmers of the country," he said.

He reiterated that the main goal of the Yatra is to ensure that no deserving beneficiary of the government schemes is left out.

Night Curfew Imposed Along IB In Jammu

Jammu: Night curfew has been imposed along the International Border (IB) in Jammu and Kashmir's Samba district to ensure better area domination by BSF troops and to foil any nefarious activities close to the borderline, according to an official order.

The step was taken to prevent crossborder infiltration and smuggling of weapons through drones in the extreme foggy weather conditions prevailing along the Indo-Pak border line, said the order issued by District Magistrate Abhishek Sharma on Sunday.

According to the order, the movement of civilians has been stopped from 9 pm to 6 am in a one kilometrelong strip from the IB in Samba district.

"No person or group of persons shall move in the area up to one kilometre along the International Border in district Samba from 2100 hours to 0600 hour during the night," the DM said in the order and invoked Section 144 of the Criminal Procedure Code to impose a night curfew along the IB.

DRUGS SEVER RELATIONSHIPS

Agony of Families Caught in the Grip of Addiction

Srinagar: Fehmeeda (name changed), a cancer-stricken mother from Dalgate is battling not only her illness but also the harsh blows inflicted by her own son under the influence of drugs. In the dim glow of her tear-streaked face, Fehmeeda's eyes mirror the silent storms raging within.

"He doesn't give a damn about who I am, always remains high on drugs, goes insane, and beats and abuses me. I am battling with cancer and spend my monthly salary of Rs 9000 on my treatment. My son treats me badly rather than showing sympathy for his sick mother," Fehmeeda said in a video that went viral

on social media. Despite filing a report against my son at the concerned police station, she said that the authorities outrightly



refused to take any action, saying 'there was nothing they could do about a drug addict.'

"What happens if he murders me or injures me? Several accounts of sons in the valley killing their mothers have surfaced over the years. Who will be responsible, if the police act as a mute spectator? He fractured my arm this morning and doused my back with scalding tea. To satisfy his drug craving, he also took my phone and other belongings," she added. Fehmeeda's heart-wrenching

story is just one among the many "ticking time bombs" chronic drug abusers - whose aggressive tendencies rupture the very fabric of familial bonds.

Experts claimed that drug abusers emotionally mistreat people around them since they put too much emphasis on drugs. Long-term substance abuse can lead to several mental illnesses such as bi-polar disorder or schizophrenia in victims, which can cause them to act violently against themselves or those around them, they added.

"The close family members are constantly at risk because the abuser may attack them under the severe influence of drugs, or may become violent out of a desire for money or craving for drugs," Dr Fazl-e-Roub, DM Addiction | More on P6

HC Upholds PSA Detention Of Accused In 2022 HSHS Blast

Srinagar: The High Court of J&K and Ladakh has dismissed a petition, challenging detention order under Public Safety Act against a 26-year-old youth, one of the accused in a grenade blast at Hari Singh High Street here in which two civil-

ians were killed and 37 people including some security personnel injured on 6 March 2022.

The youth— Mohammad Bariq Magray (26), a resident of Khanyar Srinagar, has filed a petition through his friend against the PSA detention order (DMS/PSA/95/22) dated 30 August 2022.

Magray had claimed that he is a peace loving and lawabiding citizen of India and has never indulged in any activity which could be termed

as "prejudicial to the security of the State". He submitted that on 6 March 2022 some unknown persons hurled a hand grenade at Hari Singh High Street Srinagar, which claimed the life of two civilians and left thirty-seven other persons injured. Subsequently police had filed a case (FIR

No. 18/2022) under Sections 307, 302 IPC, 7/27 Indian Arms Act and 16, 23 of the Unlawful Activities (Prevention) Act in the Police Station Shaheed Gunj Srinagar. On the basis of suspi-

cion, Magray said that he was picked up and arrested in the FIR. He said that the competent Court of TADA/POTA at Srinagar granted him bail on 26th September last year.

Snowless Winter

his winter, plains in Kashmir have so far received no snow. The familiar, picturesque blanket of snow that usually swathes the Valley during the harsh Chilai Kalanis is absent, although high-altitude areas like Gulmarg have witnessed snowfall more than once. But it has been far less than in 2022. Data from the India Meteorological Department shows precipitation of 17.6 mm was recorded in Gulmarg in December 2023 compared with 255.2 mm in 2020, which is a significant drop.

The impact of this uncharacteristically snowless winter extends far beyond aesthetics. The intricate balance of nature in this region heavily depends on the timely replenishment of glaciers. The stark decline in snowfall translates to reduction in the glaciers' volume, a critical source for the Valley's rivers and streams. The depletion is a looming crisis for agriculture and horticulture, the lifeblood of Kashmir's economy.

Scientific voices resonate with concern, attributing this phenomenon to the creeping global climate change. Over the past few decades, the once-reliable snowfall has dwindled significantly. The evidence of glaciers retreating at an alarming rate, exemplified by the Kolahai glacier's unsettling retreat, starkly illustrates this grim reality.

While the complex nature of Kashmir's weather system is often cited as a contributing factor, meteorologists highlight the atypical behavior of the western disturbance—a critical source of precipitation—remaining stationed in the North, depriving the Valley of its muchneeded snow.

The implications stretch beyond mere inconvenience. The ramifications touch every facet of life in Kashmir. Winter tourism is a critical source of revenue. Thankfully, however, tourism has so far not been impacted. In fact, throngs of visitors continue to arrive in the Valley. But less snowfall does have an impact. Skiing activities, a cherished attraction, are restricted to higher altitudes due to inadequate snow cover in lower regions.

The snowfall, however, is important not merely for tourism but as a lifeline for the glaciers which keep our rivers and streams flowing and agriculture fields irrigated. High-altitude areas retain their sub-zero temperatures, enabling the snow to endure throughout the year. Kashmir witnesses its heaviest snow during chilai kalan and the snowfall progressively reduces in February and March when spring sets in. This keeps glaciers replenished. Alarmingly, the experts fear a drastic reduction in snowfall by the century's end, and this can have horrific consequences not just for Kashmir but the region.

Here's hoping that snow does bless the plains in the remaining period of the winter. Snowfall is a boon for tourism and the Valley's economy. There's still time for snow as we are only halfway through chillai Kalan.

A new high

n January 6 evening, a stream of commands transmitted by scientists and engineers of the Indian Space Research Organisation (ISRO) were translated by a computer onboard the Aditya-L1 spacecraft into manoeuvres that guided it into orbit around an imaginary point in space. Thus, Aditya-L1 reached its destination, around the L1 Lagrange point, from where it will have an unfettered view of the sun for its expected lifetime of five years. Aditya-L1 is an observatory-class solar mission that will study the sun with seven instruments: VELC, a coronagraph to study the uppermost layer of the sun's atmosphere; SUIT, an ultraviolet imaging telescope; SoLEXS and HEL1OS, to study solar flares and coronal mass ejections; ASPEX and PAPA, to study the solar wind and plasma; and a set of digital magnetometers to measure properties of the magnetic field around the spacecraft. ISRO picked the L1 Lagrange point — 1.5 million km from the earth in the earth-sun direction and one of five Lagrange points in the earth-sun system — because the gravitational influences of the two bodies interact such that a smaller body here will not experience a net tug towards either. So, Aditya-L1 can stay at L1 while expending little fuel. Its scientific mission will begin in a month or so, once its thrusters' emissions drift away.

As such, Aditya-L1 supplements India's storied history of observing the sun — dating back to the Kodaikanal Solar Observatory, which commenced operations in 1901 — by lofting it into space. It also follows the XPoSat mission, launched on January 1 to become only the world's second X-ray polarimetry satellite, and eight years after AstroSat, which reached several highs of its own. An important issue with such achievements is public perception. For example, while Aditya-L1 and AstroSat are big strides from India's point of view, they pale in comparison to the imaging abilities of the James Webb Space Telescope, which is operated by three space agencies. Yet, many continue to expect the Indian spacecraft to capture hi-res photographs of the cosmos and are disillusioned when it does not. This is not fair (setting aside the fact that not all instruments are imagers). ISRO can do more, too, by expanding its own and its collaborating institutes' public outreach efforts, such as by hosting open days focused on specific missions and commissioning science communication on new results at regular intervals. Everyone should be able to celebrate a new high, but especially the people at large, so ISRO should also consider including components on missions that feed public interest. All these efforts will require funds, but considering the love ISRO has been getting from the government of late, it may just be a matter of asking.

Protect Your Bones An Orthopaedic Doctor's Prescription for a Safe Winter

In anticipation of snowfall and freezing temperatures causing icy conditions on roads, noted Orthopaedician **Dr. Fiaz Dar** warns against running or taking shortcuts, emphasizing the potential for serious injuries. Dr. Dar, expressing a cautious stance on Traditional Bone Setting (TBS), notes the risk of inadvertently worsening injuries, which can result in complications and potential long-term disabilities due to the lack of standardized training and adherence to modern medical principles. In a comprehensive interview with **Faroog Shah**, Dr. Dar delves into various aspects of bone health.

If we pay a casual visit to the Bone and Joint Hospital, there is a substantial uptick of bone-related accidents during the winter months. What factors are responsible for such a sudden escalation of bone-related issues?

Various orthopaedic issues tend to increase during winter, primarily due to slips and falls on icy surfaces such porches, and sidewalks, resulting in ankle, wrist, hip, and back fractures. Snow-covered roads decrease friction and vehicle manoeuvrability, elevating the risk of road accidents, exacerbated by poor visibility and reduced daylight. Shovelling ice to clear roads commonly leads to back strains and disc problems. Winter's low physical activity, atmospheric pressure changes, and reduced sunlight contribute to a rise in arthritis cases. Insufficient Vitamin D from reduced sunshine and intake further increases bone and joint ailments.

As an orthopaedic attending to patients daily, what are the prevailing bone-related challenges frequently encountered by the Kashmiri population, and are there distinct factors contributing to these issues?

In my clinical experience, bone-related issues among the general Kashmiri population align with global patterns, but conditions like Knee Osteoarthritis and Osteoporosis appear to be more prevalent. This heightened occurrence can be attributed to cultural practices such as sitting cross-legged and a notably low intake of calcium and minerals, particularly among females.

Are there specific factors that render females more susceptible to spine damage, and what proactive measures can be undertaken to mitigate these risks?

these risks?
Females are generally more susceptible to orthopaedic conditions like some fractures and arthritis-related ailments. The cause seems to be low bone mineral density seen in this group because of hormonal changes seen after menopause. Arthritis related ailments seem to be immune mediated and genetic factors are believed to be the most likely factor of this disease being

more common in females, I think proper diet, good in calcium and minerals , adequate amount of vitamin D3 and good physical activity seem to be the way forward to deal with osteoporosis. In addition hormone replacement therapy and some medications used in post-menopausal women have brought a dramatic decline in osteoporosis seen in this population.

In what ways does an improper diet contribute to bone health issues, and what dietary guidelines do you propose to enhance and preserve skeletal well-being?

Consuming a diet abundant in empty calories, processed foods, and high-fat meals, coupled with a low intake of green leafy vegetables, heightens the risk of various health problems, including issues related to bones and joints. Adopting a balanced diet that includes ample fibre, proteins, minerals, and vitamins can significantly decrease the occurrence of skeletal-related ailments. Regular, brief exercises each day also prove beneficial in reducing orthopaedicrelated issues.

How significant is weight management in preventing orthopaedic complications, and what advice would you offer to individuals grappling with concerns related to weight and joint health?

The consensus is widespread that the increased burden on the skeletal system observed in the obese population changes body mechanics, adversely impacting joint function. Obesity stands out as a primary risk factor for the onset and advancement of joint-related issues, particularly in weight-bearing joints such as the knee, hip, and ankle. Obesity

is believed to induce a chronic, low-grade pro-inflammatory state, contributing to heightened joint pain. Addressing obesity in orthopaedics requires a multidisciplinary approach. Regular physical activity for a few minutes each day and adherence to a well-balanced, healthy diet have demonstrated significant efficacy in managing orthopaedic issues related to obesity.

Could you elaborate on the consequences of calcium deficiency on bone health and outline practical steps for addressing and preventing such deficiencies?

Calcium is a crucial mineral within the body, playing a key role in the formation of robust bones and teeth. Its significance extends to the proper functioning of the heart and other muscles. Insufficient calcium intake elevates the risk of disorders like osteoporosis, osteopenia, and other conditions related to calcium deficiency. Inadequate calcium in children may hinder their full growth potential.

Ensuring the recommended daily calcium intake is essential, achievable through dietary sources, supplements, or vitamins. Women, in particular, should prioritize increased calcium intake earlier than men, with meeting the necessary calcium requirements becoming especially crucial as women approach menopause.

For the elderly population, what are the prevalent bone-related issues such as deterioration, desiccation, orthopraxis, and osteoarthritis, and what strategies can be employed to manage these conditions effectively?

As individuals age, their joints

undergo the aging process, leading to a condition known as Osteoarthritis. The advancement of this ailment can be effectively decelerated through appropriate physical exercises and weight control. Additionally, the adequate consumption of calcium, minerals, and vitamins plays a supplementary role in reducing the occurrence and progression of such conditions.

What proactive strategies would you advise to forestall the onset of osteoarthritis, particularly in populations exposed to challenging environmental conditions?

Osteoarthritis is a condition affecting the cartilage in joints and can be addressed through preventive measures and early treatment. The disease typically begins to manifest over a span of 10 to 15 years, impacting daily activities and work capabilities. Unfortunately, healthcare providers often delay intervention until joint degeneration necessitates hip or knee replacement. Alternatively, osteoarthritis should be regarded as a chronic ailment where preventive and comprehensive early care align with established practices for other chronic diseases. Modifiable risk factors like joint injury, obesity, and impaired muscle function can be targeted through primary and secondary preventive strategies. Choosing interventions that are likely to be acceptable to the patient is essential for optimizing adherence and persistence with the treatment regimen.

How does regular exercise contribute to maintaining robust bone health, and could you suggest specific exercises tailored for individuals residing in hilly terrains?

Bone, as a living tissue, exhibits a strengthening and densifying response to physical activity. Exercise enhances the generation of cells constituting bone tissue. Weight-bearing exercises, specifically advantageous for fostering robust bones, exert stress on the skeletal system. Examples of such exercises encompass walking, jogging, running, and stair climbing. Additionally, weight-bearing exercises offer benefits in strength training, incorporating the use of weights and resis-

tance bands.

We've likely all been advised to stand or sit up straight at some point. While it may have seemed somewhat bothersome in the moment, the guidance was surely given with good intent. The fact is, posture does matter for back health. Maintaining good posture is crucial for the health of many structures in the back and spine by keeping them properly aligned. Correct posture, along with adequate back support, helps reduce the incidence of back and neck pain. For a healthy back, it's important to keep the chin parallel to the floor, with knees and feet facing straight ahead. Ideally, a straight line should be drawable from the earlobes through the shoulders, back, hips, and knees, extending all the way to the middle of the fingers.

Why do certain individuals experience heightened joint pain during cold weather, and what measures can be adopted to alleviate discomfort and maintain joint functionality?

In my practice, I frequently encounter patients who report stiffness, aches, and pains, particularly when the weather changes, especially in the winter months. However, I acknowledge that these effects are not universal. The Bone & Joint pains during winter appear to lack a singular explanation. One theory suggests a correlation with the drop in barometric pressure, causing the expansion of tendons, muscles, and other soft tissues, leading to increased pain. Additionally, adverse weather conditions can influence an individual's mood, with a tendency to feel more depressed in cloudy

and cold weather compared to a normal sunny day. To mitigate these risks, individuals are advised to dress in layers for warmth, engage in muscle and bone-strengthening exercises, and maintain a healthy weight. Staying active indoors, ensuring a good night's sleep, following a nutritious diet, and maintaining a positive outlook are also recommended strategies.

Considering the heightened crisk of falls on icy roads, what specific precautions can individuals take to minimize the likelihood of slipping and sustaining injuries, especially when the snow freezes?

Consider your route to the destination and allocate some extra time for travel. Avoid running and taking shortcuts over areas with snow or ice. Choose suitable footwear, steering clear of heeled shoes. Utilize handrails whenever available. Take small steps to maintain your centre of balance. Refrain from carrying heavy shopping bags. Keep both hands free for balance instead of placing them in your pockets. Ensure the path is clear of debris to minimize risks.

Done setters with questionable qualifications claim expertise in addressing bonerelated problems. To what degree is it prudent to seek their aid for conditions like fractures, dislocated joints, or sprained ankles?

Our observational study underscores the need for educational and social awareness to convey potential risks associated with traditional bone setting. Rather than outright criticism, there's a call to educate and encourage bone setters to follow basic fracture management principles. Proposals include integrating Traditional Bone Setting (TBS) into primary health care, offering basic training for safe splint application, and encouraging their role as orthopaedic assistants in rural trauma departments through programs designed by medical regulatory bodies.

Having said that, TBS may inadvertently exacerbate injuries, leading to complications that render individuals temporarily or even permanently handicapped. The lack of standardized training and adherence to modern medical principles can contribute to adverse outcomes.

forest from jungle smugglers and other miscreants, leading to the outbreak of such incidents.

Shabir Ahamd, a lawyer from Srinagar, underscored that human activity remains a key driver of the forest fires, particularly due to the uncontrolled cutting of trees to produce charcoal during the dry season. This practice often leads to incomplete extinguishing of fires, ultimately resulting in forest fires.

"This could be prevented by the government but who facilitates them into the forests. It needs to be investigated," Shabir said.

"The valley's forests boast abundant flora and fauna, including valuable medicinal plants. Any fire incident would bring catastrophic consequences to this biodiversity hotspot," he added.

Irfan Rasool, Chief Conservator of Forests, North Circle, acknowledged the traditional occurrence of forest fires during the autumn season but highlighted the elevated incidence during winters in alignment with the ongoing dry spell.

"The department has mobilized forest protection forces to address these incidents. The locals are also helping us," he said.

However, Irfan argues that fire has been an integral part of the functioning of numerous forest ecosystems since decades. He said that forests are classified into two parts—Northern and Southern part, and most of the fire incidents are reported in the southern part of forests.

"The northern part of the forest, rich with forest crops, is shaded from direct sunlight, preventing damage. However, the southern part, being drier, is more susceptible to forest fires," he elaborated.

Notably, the fire incidents were reported just a week after the Forest Survey of India's (FSI) alarm predicting forest fires across Jammu and Kashmir.

The Forest Survey of India holds a pivotal role in monitoring and evaluating the nation's forest reserves.

A concern

Forest fires are recognized as one of the most serious environmental hazards causing huge damage to forest fauna and flora, including soil inhabitants.

Forest fire incidences can also adversely affect human health. Forest fires release huge amounts of pollutants such as particulate matter, carbon monoxide and oxides of nitrogen, sulfur dioxide and organic compounds.

Experts say that the particulate matter has potentially detrimental health effects as they penetrate deep into the human lungs causing respiratory and cardiovascular diseases.

Lately, forest fires in Kashmir have become a recurring issue that raises concerns about environmental conservation and ecological balance. According to official data, the UT has reported around 1700 forest fires for the last six-years.

The officials of the forest department maintain that most of the fire incidents occurred due to manmade activities, where least fire incidents have occurred by nature.

Roshan Jaggi, Principal Chief Conservator of Forest and Head of Forest Force in UT told Kashmir Observer that they have put forest protection forces on alert and measures are being taken to stop the forest fire.

However sources from the forest department told Kashmir Observer the department lacks a good infrastructure to tackle forest fire and many forest guards got injured while dozing off the fire.

Rasool, acknowledged that the dozing-off of the fire is challenging but maintained that their men are experienced enough to tackle any forest fire, even though the terrain is tough.

"They have fire extinguishers, hand equipment have made fire rings to control the fire," Rasool

Dr. Akhlaq Amin Wani, Professor and Head, Division of Natural Resource Management, Faculty of Forestry SKUAST-K argues that increase in human settlements near the forests is the main reason for the spike in forest fires.

"The fire chances remain high in those areas falling in vulnerable zones, where the accessibility of the human is high," he added.

Notably, in 2021, the Department of Ecology, Environment & Remote Sensing in a study highlighted that with global changes in climate taking place, factors such as low and irregular winter precipitation, dry autumn and spring seasons create an environment conducive for the forest fires to take place.

The report titled as "Forest Fire Vulnerability of Jammu and Kashmir" mapped and defined the actual incidence of fire reported during 2012-2018. In the study area total numbers of forest fire

incidents reported were 4392 during the period under study, (2002-2018) in 6795 compartments. The total numbers of 30 forest divisions comprising 102 ranges.

The study analyzed that in the Jampur region

The study analyzed that in the Jammu region, three divisions are highly vulnerable namely Jammu, Nowshera and Reasi, showing the highest number of fire incidents.

In Kashmir region, division Bandipora shows highest numbers of forest fire incidences.

Snowless Winters

for maintaining the supply chain logistics for the troops posted in forward areas in Ladakh. Generally, it has a minimum of 30-40 feet of snow around this time but there is barely six-seven feet of snow now," said Lt Gen Rajeev Chaudhry, former BRO director general.

"It is possible the pass will remain open for traffic for a week more because of less snow," he said.

The picture is no different in Kashmir, Himachal Pradesh and Uttarakhand. In Kashmir, popular tourist destinations such as Gulmarg and Pahalgam have received almost no snow while the hills have below-average snowfall disappointing tourists and locals in equal measure.

"Bizarre dry winters so far over hills due to prolonged dry spell & nothing major expected from upcoming Western Disturbance on 9-10th Jan," amateur meteorologist 'Weatherman Shubham' posted on X on Saturday along with a photo of Kedarnath temple and surroundings sans any snow.

The unusually long dry spell has meant that places that would ideally have a minimum of four-to-six feet thick snow by now hardly have any snow. After the initial winter precipitation in November, and at some places in the first few days of December, there has been no precipitation at all

Attributing it to the absence of Western Disturbances (WDs), the India Meteorological Department (IMD) said almost no major snowfall is likely till mid-January with even the expected January 9-10 WD not likely to help much.

WDs are a series of cyclonic storms that originate in India's west (and therefore, western) at faraway Mediterranean region.

Though the northwest plains, Punjab, Haryana and Delhi-NCR, have seen their share of foggy 'cold' and 'severe cold' days, there have been no 'cold wave' conditions yet.

"Since December, there has been no active WD over northwest India... this resulted in less than normal precipitation," explained IMD Director

General Mrutyunjay Mohapatra.
Temperatures, he added, are above normal during the El Nino period. "But more than that, the absence of WDs meant that there was no clouding and that led to increased temperatures (in the

higher reaches of the Himalayas)."
According to an April 2015 study "Western Disturbances: A review" published in the Review of Geophysics, WD snowfall in December, January, and February is the dominant precipitation input to establish and sustain regional snowpack, replenishing regional water resources.

Spring melt is the major source of runoff to northern Indian rivers and can be linked to important hydrologic processes from aquifer recharge to flash floods, it said.

Drawing a connection between WDs and El Nino, climate scientist Raghu Murtugudde from the Indian Institute of Technology-Bombay said, "WDs have had a trend for a while, so the low precipitation is consistent with that (trend). During an El Nino, the cold winds come from the northwest and the cold temperature remains over northern and north-central India. This means, dry cold winds and thus less precipitation."

Elaborating on the "trend", he said, "The WDs have been decreasing and bringing less precipitation for a couple of decades. That means, there will be more years with below-normal precipitation than years with above-normal precipitation. El Nino exacerbated this."

Glaciologist Dimri also spoke about a distinct pattern shift in WDs over the last few years. "One, there has been a decrease in WDs, then, there has been decreased precipitation, and third, most importantly, precipitation has changed from solid to liquid, which means, there is rain in winters instead of snowfall."

The replenishment of water sources for the southern Himalayan region will bear the brunt. "The water system will collapse. We are drifting towards living in a dryer system," he warned.

On average, India receives four to six intense WDs each month between December and March. Except for a one-off event, December had no WD and there is no sign of it till mid-January.

"The unknown thing is that the El Nino pattern is different this year because of a strong superimposition of El Nino and global warming. This happened back in 2009, which too was a dry year," Murtugudde said.

Murtugudde was a co-author in a January 2012 study, "Is a global warming signature emerging in the tropical Pacific?" published in the journal Geophysical Research Letters. It demonstrated that the unprecedented basin-wide warming in the Tropical Pacific (TP) during the year 2009 was associated with an increasing global warming trend in the TP SSTs.

Kashmir Shivers

a minimum temperature of 4 degrees Celsius on Sunday night, slightly down from the previous night, they said.

Pahalgam in south Kashmir's Anantnag district, which serves as one of the base camps for the annual Amarnath Yatra, recorded a minimum temperature of minus 5.3 degrees Celsius, up from the previous night's minus 6.5 degrees Celsius, the officials said.

The minimum temperature in Kokernag town settled at minus 2.1 degrees Celsius and in Kupwara at minus 5 degrees Celsius, they added.

Kashmir is currently under the grip of "Chilla-i-Kalan", a 40-day harsh winter period, when a cold wave sweeps the region and temperatures drop considerably leading to the freezing of water bodies as well as water in pipes.

The chances of snowfall are the highest during this period and most areas, particularly the higher reaches, receive heavy snowfall.

A thin layer of ice formed on the surface of the Dal Lake here on Monday and other water bodies in Kashmir due to the intense cold wave that is gripping the region, the officials said.

People who live in houseboats in Dal Lake had a tough time breaking the layer of ice over the water body to reach its banks. Water in pipes also freezed in several parts of the Kashmir valley.

Kashmir has been going through a prolonged dry spell and a 79 per cent deficit in rainfall was recorded for December.

No snowfall was noted in most of the plain areas of Kashmir, while the upper reaches of the valley have received lesser than usual amounts of snow. The meteorological department has forecast mainly dry weather till January 12.

Agony of Families

Medicine Faculty, Institute of Mental health and Neurosciences (IMHANS) told Kashmir Observer.

Parents, spouses, and kids may be affected by the negative impacts of drug addiction, he added, since they may witness a loved one suffer from drug side effects or lose control when high.

Dr Shaheen Shora, Consultant Psychiatrist and Medical Lead, Hertfordshire University while speaking to Kashmir Observer also said the aggression and violence is common among the people misusing drugs. Over the years, several incidents of drug-addicted children violently abusing their parents have been reported in Kashmir.

In March last year, a drug addict son, accused of killing his mother in a cold-blooded murder of his mother, was arrested in Sopore town of Baramulla district in north Kashmir.

Since October 2022, there have been three instances of sons killing their mothers in Kashmir. On December 22, 2021, a man assaulted his family members and neighbors with a wooden log, killing three people—including his mother—and wounding seven more in south Kashmir's Anantnag district.

A boy hailing from Kehribal area in south Kashmir's Anantnag district killed his mother in October 2021 with intention of robbing his deceased mother's money.

Following the murder, the suspect concocted a lie with his friend in order to confuse the public and the authorities into believing him that his relatives had committed the murder.

According to Dr. Fazl, family members may have physical and mental health problems as a result of their relative's addicted behavior.

"Tensions run high and conflict becomes the

norm. Without appropriate treatment, addiction can destroy your home, work and family life," he said.

He said the drug users' aggressive behavior may have a negative impact on their family and rela-

tives if appropriate action is not taken promptly. As such, he added, the police cannot act as a mute spectator and watch idly while this happens.

"Police can refer drug abuse victims to rehab centers for treatment instead of putting them in custody, which would allow the victim to re-

cover and his family members to feel relieved," he

Winged Visitors Turn Jammu's Gharana Wetland **Into 'Bird-Watching Paradise'**

GHARANA (R S PURA): In a spectacular annual phenomenon, thousands of migratory birds, ranging from the bar-headed geese to egrets, have descended upon the Gharana Wetland Conservation Reserve near the International Border in Jammu in the outskirts of Jammu capital city.

The wetland, located approximately 35 kilometres from Jammu, has become a 'haven for bird enthusiasts' as over 6,000-bar-headed geese and various other species from the northern hemisphere migrate to the region during winter annually.

"Every year, over 6,000 migratory birds of many species, the majority of them bar-headed geese, arrive at the Gharana Wetland. This year so far over 3,000 to 4,000 such birds have arrived here from the northern hemisphere. Their number is expected to increase." Simple Singh, in-charge at Gharana Wetland Conservation Reserve (GWCR), told PTI. He said the number of migratory birds at this winter habitat increases every year.

"The department of wildlife is making all arrangements here for visitors. Schools undertake visits to the Gharana with their students," Singh added. Hundreds of people, mostly students and photography enthusiasts, throng the wetland during the winter to have a glimpse of the migratory birds.

"It is an ideal place for wildlife photography as you get the oppor-



rian cranes," Asvina, a student of Institute of Music and Fine Arts said.

"I love to photograph birds, animals and nature. I am very happy to be here as it is a paradise for bird lovers," Asvina said.

Similarly, Jammu University student Sakshi goes on to say that coming here is an opportunity to learn about various aspects of nature and birds. "A good footfall of visitors was

seen here. It has provided us an opportunity to come close to nature and shoot and learn about various aspects of photography,"

The GWCR surrounded by wetlands of Makwal, Kukdian, Abdullian and Pargwal, has more than 170 residents living in the Gharana village and is home to migratory bird species such as bar-headed geese, gadwalls, common teals, purple swamp hens, Indian moorhens, black-winged stilts, cormorants, egrets and green shanks flock during the winter, officials said.

see such a large number of bird species here. My maternal uncle had told me about migratory birds flying to Gharana so we came here to watch them," he said.

Resultantly, he said, in addition to the existing 27,870 cadets, the strength in J&K and Ladakh will increase by 12,860,

Rohit, Kohli Get Final Shot At T20 Glory, But....

NEW DELHI: The selectors have clearly gone for the status quo rather than addressing the elephant in the room by picking Rohit Sharma and Virat Kohli for their first T20 series in 14 months. Will it have a bearing on India's chances in another T20 World Cup? Only time can tell.

Having endured a heartbreak in the previous two editions of the T20 World Cup, the two greats of the game can't be faulted for wanting a final shot at glory in the format. But the same can't be said about the selectors, who picked a fresh bunch of players to take the team forward since the crushing semifinal loss to England in November 2022.

Now that Rohit and Kohli have been picked for the home series against Afghanistan beginning on January 11, it is a given that the famed duo will be a part of India's squad for the ICC showpiece in the US and Caribbean in June.

It also means that India,



who have been guilty of playing conservative cricket at the top of the order, are also back to square one as far as their planning for the T20 mega event is concerned.

The two superstars played a massive role in taking India to the ODI World Cup final but can they step up to the demands of the shortest format where one needs to go after the bowlers from ball one? Rohit, who did not score tons of runs in the recently held ODI showpiece but yet managed to make a compelling impact with his high risk game, will most likely carry on in the same vein when the Afghanistan

series begins in Mohali. On the other hand, Kohli's game is tailor-made for the 50-over format but he has also managed to maintain more than a decent strike rate of 137.96 over 148 T20s. Rohit strikes at almost 140 in T20s but he too will need to bat at a higher clip to keep up with the fast changing demands of the modern game.

In contrast, their teammate and world's best T20 batter, Suryakumar Yadav, bats at a 170 plus strike rate.

The likes of Yashasvi Jaiswal and Ruturaj Gaikwad showed promise in the opportunities they got in the absence of senior players but there is no substitute to experience at an ICC event.
