

## CROSS-BORDER SMUGGLING

### LG Calls For A Comprehensive Strategy



**Jammu:** Lieutenant Governor Manoj Sinha emphasized the need for a comprehensive strategy for crackdown against drug smugglers, drug hot-spots and cross border smuggling in a meeting concerning development and security in Jammu Division.

Sinha held the meeting with the senior officers, Deputy Commissioners, SSPs and discussed various issues. The LG also took appraisal of the status of the key infrastructure projects and the steps taken by the District Administrations to facilitate industries, saturation of government schemes, implementation of Holistic Agriculture Development Programme and promotion of tourism. He directed the district administrations to ensure saturation of schemes in all border villages and to connect youth of all Panchayats to self-employment and entrepreneurship opportunities.

LG further instructed the officials to prepare regular outcome reports of Block Diwas, Thana Diwas and other Jan-Abhiyan programmes. Quality disposal of grievances and effective delivery of public services should be the priority of the administration at all levels, he said.



**Srinagar:** A dry and snowless winter in Kashmir has resulted in freezing nights and warmer than usual days as Srinagar's day temperatures were over eight degrees above the normal for this time of the year, officials said on Wednesday. Jammu, the winter capital of the union territory, has been

colder than Srinagar for the past couple of days, recording a high of 9 degrees Celsius on Wednesday, which was nine degrees below the normal.

Jammu is currently under a cover of dense fog which has resulted in colder days.

Srinagar city recorded a minimum temperature of minus 5.0



degrees Celsius on Wednesday night, same as the previous night, the officials said.

Jammu recorded the 5th all-time lowest maximum temperature in January, Faizan Arif, an independent weatherman from Kashmir said.

As the Kashmir Valley experiences an unprecedented absence of significant snowfall, an unexpected challenge looms over the region's vital tourism sector. Tourism players in the valley said that with each passing day without snowfall, the tourist footfall is set to decline. Akib Chaya, President of Gulmarg Hoteliers Club, expressed concern over the situation and said that in the early days of January, Gulmarg was sold out but the numbers are coming down rapidly.

"The issue has gained national attention, with people creating memes and drawing comparisons from previous years," Chaya said.

### PMSSS Students Allege Delay In Fund Disbursement

**Srinagar:** Students from Jammu and Kashmir enrolled under the Prime Minister Special Scholarship Scheme (PMSSS) have alleged that the All India Council for Technical Education (AICTE) is delaying the disbursement of scholarship funds, with many of them contemplating to quit their courses midway.

The aggrieved students said the delay on the part of the AICTE in releasing scholarship funds not only causes issues with housing but also occasionally leaves them hungry.

"The scholarship was aimed at benefiting students from weaker sections of the society. Initially the funds were released well in time, however the AICTE disburses funds after six months," Kifayat Ahmad, an engineering student told Kashmir Observer.

"Ninety percent of students from J&K face the same problem, while many have left courses midway, some are following suit. From food to clothing and accommodation,


our scholarships cover everything. Without food, how could we ever live outside? he questioned.

An AICTE's top official, wishing anonymity, told Kashmir Observer that students enroll in two courses, however, the scholarship is granted for only one course and that is the reason for the delay in releasing scholarship funds.

He said the scholarships of many students were cancelled in the past for enrolling in two courses, which is not only illegal but unethical as well.

Refuting the allegations, Sana, who is pursuing nursing course under PMSSS said the authorities are free to check the records of the students, and if anyone was found involved in any such activities is entitled for disciplinary action.

"Causing delay in releasing scholarship funds is collective punishment for every student availing PMSSS. How could they say so? Most of the students here complain of delay in releasing scholarships. Not every student has registered | [More on P6](#)



### Terror Activities In Poonch, Rajouri An Issue Of Concern: Army Chief

**New Delhi:** The situation in Jammu and Kashmir's Rajouri-Poonch region is a matter of "concern" and enhancing deployment of troops, boosting intelligence apparatus and reaching out to local people are part of measures being initiated to contain terrorist activities in the area, Chief of Army Staff Gen Manoj Pande said on Thursday.

At a press conference, he also said he has conveyed an unambiguous message to the soldiers and commanders that there will be "zero tolerance" to human rights violations and they must operate in a professional manner.

Three civilians were killed in Poonch last month allegedly during questioning by the

### Crackdown on Banned Separatist Groups Centre Orders Seizure of Assets of TeH, Muslim League

**Srinagar:** The Centre on Thursday directed the Jammu and Kashmir administration to seize all assets and freeze bank accounts and finances belonging to the pro-Pakistan separatist amalgam Tehreek-e-Hurriyat and Muslim League Jammu Kashmir headed by separatist Masarat Alam.

Both the organisations were recently banned by the government. Tehreek-e-Hurriyat was founded by late separatist leader Syed Ali Shah Geelani.

Issuing two identical notifications, the Union Home Ministry said the Muslim League Jammu Kashmir (Masarat Alam faction) was declared unlawful outfit on December 27, 2023 under the Unlawful Activities (Prevention) Act, 1967 and the Tehreek-e-Hurriyat, Jammu and Kashmir (TeH) was banned on December 31, 2023 under the same law.

"Now, therefore, in exercise of the powers conferred by section 42 of the Unlawful Activities (Prevention) Act, 1967, the central government hereby directs that all powers exercisable by it under section 7 and section 8 of the said Act shall be exercised

also by the state governments and the Union Territory administration in relation to the above said unlawful association," the notification read.

The Section 7 of the UAPA is related to power to prohibit the use of funds of an unlawful association and the Section 8 is related to power to notify places used for the purpose of an unlawful association.

While declaring the TeH outlawed for five years, the home ministry had said it was fomenting terrorism and spreading anti-India propaganda in the Union Territory.

The objective of the TeH is to separate Jammu and Kashmir from India and establish Islamic rule in Jammu and Kashmir, it said.

The group was founded by Geelani, who was succeeded by Masarat Alam Bhat. Bhat is also known for his anti-India and pro-Pakistan propaganda. Bhat is currently in jail.

Bhat's outfit Muslim League Jammu Kashmir, which he heads, was also declared a banned organisation by the government for its involvement in anti-national and secessionist activities in Jammu and Kashmir. The home | [More on P6](#)

I started selling e-rickshaws in 2021 after the government gave the green signal to the services in December 2020, and since then, the demand has increased manifold," "Till now, I have sold around 200 e-rickshaws since the beginning and the demand is very high. My order book is filled with advance bookings," he added. Moreover, a local resident Zahoor Ahmad, who frequently uses e-rickshaws for daily commuting said, the number of e-rickshaws has increased in different routes. "Earlier, there were only 10 to 20 e-rickshaws present in our locality, but now the number has increased," he said, adding that the services have provided a heave of relief to the people.

## Tough Security Environment

The Army Chief General Manoj Pande on Wednesday attributed the escalation in militancy related violence in Rajouri-Poonch region over the last 5-6 months to the attempt by adversaries to disrupt the prevailing normalcy in Jammu and Kashmir. Speaking to media in the run up to Army Day on January 15, General Pande said that between 2003 and 2017-18, militancy in the Rajouri and Poonch districts had been effectively curtailed, and peace had prevailed. However, the recent spike in terrorist activities indicates a resurgence of unrest. He pointed out that the Pakistan Army is actively involved in fuelling militancy in the area, attempting to amplify instability.

The situation certainly became worse in Jammu 2023 with security forces losing over twenty personnel in ambushes by militants. That said, the security situation improved remarkably last year, despite some conspicuous rise in violence. According to data, around 121 persons including 21 local militants, 52 infiltrators, 29 soldiers, 4 policemen, 14 civilians, and a BSF personnel were killed in Jammu and Kashmir in 2023.

At the same time, there has been an 80 percent decrease in the recruitment of local youth in the militant ranks in 2023. The figures put the number of local youth who took up arms last year at just 22 compared to around 100 in 2022. There are now just 31 local identified militants active across Jammu and Kashmir. "27 local active terrorists belong to Kashmir zone while 4 from Jammu areas."

Army chief in his interaction also highlighted the positives in the situation. He emphasized the continuation of the ceasefire along the Line of Control (LoC) despite the infiltration attempts, many of which the Army has successfully thwarted. General Pande also highlighted the robust anti-drone mechanism along the border to counter the use of drones for smuggling weapons and narcotics.

Army, according to the Army chief, has signed contracts worth Rs 12,000 crore with private Indian firms. These contracts encompass major projects, including the development of light tanks and future-ready combat vehicles which will go a long way to boost indigenous defense capabilities. More so, at a time, when India faces an increasingly tough security environment, both along the LoC with Pakistan and the LAC with China. Even Army chief termed the situation along the Northern border stable but "sensitive".

Going forward, India has to not only be prepared for the evolving regional threats but also find a way to fashion a peaceful regional environment by repairing ties with its neighbours, especially Pakistan and China. The strong government at the Centre under prime minister Narendra Modi is best positioned to make this a reality.

## A change for the worse

The rapid decline in ties between India and the Maldives, just a month after Prime Minister Narendra Modi met with the newly elected Maldivian President Mohamed Muizzu, should set alarm bells ringing. The trigger came from tweets by three Maldivian Ministers, attacking Mr. Modi for promoting the Lakshadweep islands during his recent sojourn there at a perceived cost to the Maldives and for his close ties with Israel; the Ministers also made derogatory remarks about Indians. The tweets have been deleted, the Ministers suspended, and the Maldivian government has distanced itself from them, but the damage has been done. The respective Ambassadors were summoned. Hurt Indians have crowded social media sites calling for an economic "boycott" of the Maldives — Indian tourists make up the most arrivals post-COVID-19. However, the underlying reasons run deeper, and could have a broader impact on India-Maldives relations and the neighbourhood, accruing to the change in government in Male. Mr. Muizzu rode to power on the back of the PPM's "India Out" campaign. Despite its disappointment with the win of 'anti-Indian forces', given the warm relationship it shared with his predecessor Ibrahim Solih, the Modi government sent a Minister to his swearing in, and there was a Modi-Muizzu meet at the COP28. However, Mr. Muizzu chose Turkey as his first bilateral destination, and is now visiting China — becoming the first President not to make India his first priority. Even President Yameen, who began the "India Out" movement and cozied up to Beijing, visited Delhi first in 2014. Mr. Muizzu has continued to press India on the withdrawal of its military personnel, even though India has clarified their role.

With the calls for boycotts and rising hypernationalistic rhetoric, Delhi and Male need to take a step back and reassess their responses. Mr. Muizzu can ill-afford to antagonise India, given its proximity, economic might and historical position as a net security provider in the Indian Ocean, something Maldives has relied on. India too must see the futility of muscling in a much smaller neighbour, however egregious the provocation. The last few years of ties between the Solih government and Delhi show the benefits of a stronger relationship: India's infrastructure forays and development projects in the islands, an intense strategic partnership, support during the COVID-19 pandemic, and cooperation on the international stage. For India, in a region that sees several elections this year, it is paramount to ensure that domestic political changes in the neighbourhood do not change the basic structure of bilateral ties, or affect regional stability.

# The Biggest Threats to Global Economic Stability

NEW YORK — The International Economic Association (IEA) recently concluded its 20th World Congress in Medellin, Colombia. This triennial event brings together scholars from all over the world to share and discuss the latest developments in economic thinking. This year's edition underscored the urgency of re-evaluating some of the field's core assumptions. The rapidly escalating debt crisis in the Global South, while not a direct focus of the conference, cast a shadow over it.

The IEA was founded in 1950, with Joseph Schumpeter chosen to be its first president. Since then, the organization has been led by some of the world's most renowned economists, including Paul Samuelson, János Kornai, Kenneth J. Arrow, Amartya Sen, and Joseph E. Stiglitz. With the world economy increasingly strained by supply-chain disruptions related to the war in Ukraine, the lingering consequences of the COVID-19 pandemic, and the cloud of uncertainty hanging over the fighting between Israel and Hamas, this year's Congress has thrown these daunting challenges into sharp relief.

As the global economy undergoes a fundamental transformation, some of the deeply held assumptions economists have relied on to model it must evolve, too. Unsurprisingly, many of the presentations during this year's Congress focused on the impact of digital technologies and social media on labor, wages, and inequality. Others focused on the changing nature of globalization, the shift from a unipolar to a multipolar economic order, and the erosion of democratic institutions amid the rise of populist nationalism.

Danny Quah's lecture underscored the speed with which the global economy is changing. Building on earlier studies by Jean-Marie Grether and Nicole A. Mathys, as well as his own previous research, Quah illustrated the world economy's shifting center of gravity, which he defines as the "average location of economic activity across geographies." In 1980, he showed, this center was located in the middle of the Atlantic Ocean, reflecting the dominance of North America and Western Europe during that period.

As East Asian economies took off, the global center of economic gravity began to shift eastward. Quah estimates that by 2008, it had moved close to zmir, Turkey, and kept moving east, driven by the Indian and Chinese economies' rapid growth. He projects that by 2050, the world's economic center will settle between India and China, unlocking opportunities but also stoking geopolitical tensions and giving rise to new threats.

Rising authoritarianism, in particular, remains a major driver of global economic uncertainty. The growing appeal of populist movements, Sergei Guriev argued (based on some of his earlier writings with Elias Papaioannou), could pose an "existential threat" to democratic governance, civil liberties, and the liberal world order.

To be sure, the populist surge is partly an understandable response to rising within-country inequality and reduced social mobility, as Adam Szeidl pointed out in his Congress presentation. Disillusioned Western voters' tendency to favor right-wing leaders is puzzling, however, given that these politicians' favored policies will likely exacerbate the problems they purport to address.

A financial crisis could provide far-right authoritarianism with the momentum they need to

dominate Western politics.

Despite the grim predictions of a prolonged economic downturn, the global economy successfully dodged a recession in 2023, buoyed by unexpectedly robust GDP and job growth in the United States. While this has led some economists to adopt a cautiously optimistic outlook for 2024, I believe that such complacency is misguided.

The new optimism can be attributed to ana-

lysts' tendency to focus on rich countries when assessing the state of the global economy. A more granular analysis yields a bleaker picture of the world's economic landscape. Unlike the Great Recession of 2008-09, which was triggered by the collapse of the US housing market, the biggest threat to global economic stability today comes from the developing world.

During the COVID-19 pandemic, virtually every country in the world was forced to increase public spending. But while developed and middle-income countries had the resources to purchase vaccines, drugs, and equipment, low- and lower-middle-income economies borrowed massively to cope with the pandemic and subsequent food and energy crises. That left dozens of countries in debt distress or at high risk of it, underscoring the need to look specifically at the developing world.

According to the World Bank's latest International Debt Report, the world's poorest countries have been hardest hit by the sovereign-debt crisis. Their external debt service, which reached an all-time high of \$88.9 billion in 2022, is projected to surge by 40% in 2023-24. Ghana and Zambia have already defaulted, Ethiopia will likely default by 2024, and domestic debt levels in countries like Argentina and Pakistan are alarmingly high.

Not enough is being written about this, but urgent international intervention is necessary to prevent the situation from escalating. While the current crisis may not have the immediate global impact of the 2008 collapse of the US subprime mortgage market, its potential long-term effects could be far-reaching. Notably, it could exacerbate the migration crisis, further fueling the surge of right-wing populism across the developed world.

While the IEA's five-day Congress in Medellin felt like a breath of fresh air, tackling the developing world's debt crisis requires more than cutting-edge research. The international community, especially multilateral institutions like the World Bank, must act decisively before the situation spirals out of control.

# Why Marriages Are Failing in Kashmir

*The pulpits that hold the utmost responsibility for addressing societal evils have failed to address this serious matter, choosing instead to remain silent.*

In recent years, late marriages and failed marriages are the worst of the evils that have enveloped our society and significantly contributed to our moral, mental, and social degeneration. If late marriages are a result of several cultural taboos such as caste, dowry, unemployment, poverty, costly weddings, and government jobs, failed marriages reflect our collective hypocrisy, if not shame.

On the ninth day after her divorce, Asma, 33, sits on a balcony in despair, gazing at her thirteen-month-old baby. Her face has grown pallid, with evident dark circles around her

lashes the main door.

Asma holds a PhD in Zoology and was married two years ago. She recounts her dreadful tale of marriage at her home in Kulgam. Her marriage to Aftab ended a week ago after she discovered his extramarital affair.

During pregnancy, due to her husband's and in-laws' neglect, she lost one of her twins in the womb, and the other baby was born with mental disabilities. She faced all the criticism and was blamed for giving birth to an unhealthy and disabled child, who spent his first 8 months in ICU.

"Kashmir is a male-dominated society where men decide the future of a relationship," Asma says.

"I have lost faith in the institution of marriage. I'll never consider remarrying. My only concern is..." She pauses, referring to her child who is surrounded by toys in the corner.

## WHY MARRIAGES FAIL

According to the 2011 census, Jammu & Kashmir has a divorced population of 0.34% but experts believe that divorce cases in the region have seen a significant surge in recent years.

Shahnawaz Ahmad Khanday, a sociology professor at the J&K Higher Education Department, attributes this rise to the faster pace of life, population growth, and longer life expectancy.

Infertility, often unfairly attributed to female partners, is also a key contributor to unsuccessful marriages. Sabreena, 28, got divorced a year ago when her in-laws in Srinagar accused her of being unable to conceive a child, despite medical evidence proving the contrary.

Forcing wives to prioritize their in-laws' needs over their own well-being also leads to marriage failure. Yusra, 30, whose primary responsibility was to care for her two children, was compelled to look after her husband's parents.

"I did my best but fell short of my husband's expectations. I was abused and eventually divorced for failing the role of caretaker for my husband's parents." She says

Jozey, 28, who married in 2021 in Shopian, narrates her harrowing experience of an arranged marriage

that turned into a nightmare. "The problem was getting married to someone I had never met before," She says. Her spouse worked in the fruit industry. She has taken refuge at her brother's home for a year waiting for her husband to divorce her, who seeks Rs. 500,000 in exchange for declaring the divorce.

"Arranged marriages are scary. He would come every night between 12 and 2 a.m., and when I protested, he would abuse and beat me." She says, "My marriage was a disaster. He would make fun of me for coming from a middle-class family."

When asked why they don't seek legal assistance, she responds, "We are kind people, they have all the wealth and approach." "My brother will now sell a house our father built for us to compensate for my divorce", she adds.

Moreover, domestic violence, family interference, incompatibility, and drug addiction are cited as additional factors contributing to marital breakdowns in the region

Prof. Shahnawaz stresses the importance of understanding that marriage entails both ups and downs and requires compromise. "There is glitz and glamour connected with our youth. The romanticized notion of love and compatibility, perpetuated by the media and the virtual world, leads them to believe that marriage is solely based on passion and infatuation."

He says, "Our youth is avaricious, always on the go, making sure that all of his needs are met. Marriage is a process of making concessions."

Sajad Ahmad Mir, a prominent advocate at J&K High Court highlights the increase in matrimonial disputes in courts in 2023.

"Couples bring minor concerns to court, yet due to emotional manipulation, ego issues, or unnecessary meddling from in-laws, these minor issues escalate into major disputes."

He said that a major cause of these disputes among working people is the husband's refusal to let his wife work and wife's refusal to live in a joint family with her in-laws. "What's surprising is that before marriage, couples don't discuss these matters, which subsequently become big marital feuds."

"We have to be realistic," Prof. Shahnawaz recalls, "because our marriage expectations are different." Maintaining a strong marriage needs commitment, understanding, compromise, and continuous



effort from partners. We forget that once we're in it, it's the responsibility of both parties to keep things smooth, not complicated.

## SEEKING RESOLUTION

In today's fast-paced society, couples often struggle to find the time and energy to work out their differences amicably.

"Women tend to be more motivated than men to resolve their marital issues," Prof. Shahnawaz says, adding that, for men, the patriarchal mindset always creeps in.

Advocate Sajad observes that before entering into a marital bond, couples must sit down and discuss the key aspects such as whether the girl wants to work after marriage or not, or whether she wants to live in a joint family after marriage or not. Is this marriage the result of both part-

ners' agreement, or of some family pressure? What are their mutual preferences, and how often do they use social media?

"There are extremely few chances that a marital conflict would emerge in their relationship in the future if they discover satisfying answers to these questions at the right moment." He says

Sajad adds "Couples should consider seeking marriage counseling to identify the root cause of their problems and work on improving their marital relationship instead of opting for separation."

## POST DIVORCE

A study conducted by Muzamil Jan and Asma Hyder at Kashmir University revealed that divorce brought about numerous social, eco-

nomical, cultural, and psychological challenges for women in Kashmir. The survey included 600 divorcees from rural and urban Kashmir. The study finds, 38.3% of divorcees in rural regions and 37.4% in urban areas felt sad about their current marital status, while only 13.3% in rural and 15.3% in urban felt proud. Similarly, 51.7% of divorcees

in rural regions and 51.3% in urban areas felt a sense of carelessness.

Remarriage remains tough because of prejudices against a divorcee. "Marriage in our society is a proper enterprise. A lot of passion, money, and social capital are put into this venture. Remaining in a relationship cannot be enforced. Ultimately, it is an emotional bond," Prof. Shahnawaz says. We should make sacrifices where they are justified and worth it. If, despite efforts, it doesn't work, we should let it go.

Jozey continues, "Even after divorce, my ex-husband can dream of a good wife who is unmarried and from a well-to-do family, but I have to face the social stigma of being a divorced lady." To achieve a second marriage, I must sacrifice my ideals.

## WAY AHEAD

Marriage is not a hurried decision; it's a lifelong commitment, a devotional act, not a mere civil contract. Choosing a life partner in haste may be a half-hearted suicide attempt. It is important to take time to understand ourselves and our potential partners.

"It is better to remain single than to enter into a failed marriage that disrupts our peace and, in some cases, our lives. A financially secure marriage does not ensure a happy marriage. Rushing into marriage without knowing our partners and the responsibilities involved leads to innumerable failed marriages, impacting the entire societal fabric and contributing to rising mental health issues. It turns precious lives into misery and damages families irreparably." Says Prof. Shahnawaz



## Tit for Tat: Iran Navy Seizes US Oil Tanker in Sea of Oman

Iran confirmed that its navy was behind the seizure of the Marshall Islands-flagged oil tanker near Oman's coast on 11 January, which it said was taken in line with an Iranian court order.

"The Iranian Army Naval Forces seized an American oil tanker in the waters of the Sea of Oman by judicial order," the public relations office of Tehran's navy announced on Thursday afternoon.

Citing UK maritime sources, Reuters had initially reported that an oil tanker had been boarded by unidentified armed men off the coast of Oman on 11 January and redirected towards Iran.

The tanker was identified by UK maritime security firm Ambrey as the Marshall Islands-flagged St Nikolas ship. The ship was boarded at around 7:30am at approximately 50 miles from the Omani city of Sohar, and redirected towards the city of Bandar-e-Jask in Iran.

According to the security firm, Ambrey, "the individuals covered



the vessel's cameras" and that an officer "reported hearing unknown voices over the phone along with the master's voice."

"The armed suspects are reportedly wearing military-style black uniforms with black masks," the security firm added.

According to the MarineTraffic tracking website, the St Nikolas was sailing from the Iraqi port of Basra and was en route to Turkey. AP said that the tanker was loaded with oil at the Iraqi port.

Ambrey said that the St Nikolas, formerly known as the Suez Rajan, is the same tanker seized by the US in April 2023 for carrying Iranian crude oil.

Washington seized the Suez Rajan in April 2023 in what was described by the Pentagon as "a sanctions-enforcement

operation." Washington also charged the ship owner with "sanctions evasion" and directed the cargo to waters 65 miles off Galveston, Texas.

Greek tanker management firm Empire Navigation pleaded guilty to smuggling sanctioned Iranian oil, and agreed to pay a \$2.4 million fine, US court documents show.

According to the Wall Street Journal (WSJ), the Suez Rajan came under Washington's radar after an anti-Iran organization, the New York-based United Against Nuclear Iran, provided information about the ship's cargo to government officials.

WSJ reported in July last year that US oil firms were "reluctant" to unload the oil because they were "too worried about Iranian reprisal."

9.3°C below the normal level. The all-time lowest maximum temperature is 5°C recorded in 1986," Faizan posted on X.

"Same region, with one recording all-time highest and another recording one of the all-time lowest," he added, comparing the weather patterns of Jammu and Srinagar. "One with cold, one with heat, one without snow, one with fog."

Interestingly, this year, January has brought an unprecedented temperature surge to Banihal as well, breaking all the previous records.

"Banihal today recorded a maximum temperature of 23.4 degrees Celsius, which is 13.1 degrees Celsius above normal," Faizan said. The previous all-time record was 22.6°C recorded on 18 January 2003.

Qazigund recorded a low of minus 4.6 degrees against minus 4.4 degrees Celsius, while in the ski resort of Gulmarg in north Kashmir it was minus 3.5 degrees Celsius, up from minus 5.0 degrees Celsius recorded the previous night.

Pahalgam in south Kashmir's Anantnag district, which serves as one of the base camps for the annual Amarnath Yatra, recorded a minimum temperature of minus 6.3 degrees Celsius.

The minimum temperature in Kokernag town settled at minus 2.4 degrees Celsius while it was minus 5.3 degrees Celsius in Kupwara.

Kashmir is currently under the grip of "Chilla-i-Kalan", a 40-day harsh winter period, when a cold wave sweeps the region and temperatures drop considerably leading to the freezing of water bodies as well as water in pipes.

The chances of snowfall are the highest during this period and most areas, particularly the higher reaches, receive heavy snowfall.

Kashmir has been going through a prolonged dry spell and a 79 per cent deficit in rainfall was recorded for December while there has been no precipitation in the first week of January.

There has been no snowfall in most plain areas of Kashmir, while the upper reaches of the valley have received lesser than usual amounts of snow.

The meteorological department has forecast mainly dry weather till January 20 but added that a feeble Western Disturbance would affect Jammu & Kashmir after January 16.

### Snowless January

barren slopes of Gulmarg in January. Last year, Gulmarg was completely packed with tourists at this time, but this year, despite a similar initial demand, tourists are cancelling plans.

Chaya, who runs Hotel Hilltop in Gulmarg said that the tourists check weather forecast sites like "accuweather" and plan their visits based on predicted snowfall.

"Around 20 to 30 percent of bookings for January have been canceled and without significant predictions this month, the situation may worsen," Chaya said.

"The hotel industry alone may suffer losses of up to 30 percent. However, the impact extends beyond hotels, affecting local people, tourist guides, sled drivers, and skiers. When there is no snow, it poses a significant challenge for these individuals to sustain their livelihoods."

"As there is prediction for snowfall at the end of the month of January, hopefully the situation will change," Chaya said.

A skier wishing anonymity said, "The absence of snowfall in Gulmarg has left all of our skilled skiers jobless. Snow means everything to us and unfortunately it is nowhere to be seen."

Chairman Houseboat Owners Association, Manzoor Pakhtoon, voiced similar views saying that Kashmir is known as an all-weather tourist destination and the lack of snowfall is putting a big question mark on it.

"In January 2023, there was almost 60 to 70

percent occupancy in houseboats. However, this year the things are completely different. This year the occupancy is around 15 to 20 percent, so the bookings have come down by almost 50 percent," Pakhtoon said.

Pakhtoon painted a grim picture for the month of February as well.

"Houseboat bookings for February are quite low, and there is also a noticeable trend of cancellations," he added.

"A lot of people would visit Kashmir for winter activities that have been hit because of the lack of snowfall. Foreign tourists especially Malaysians would visit Kashmir for snow purposes but they have avoided Kashmir."

Chief Executive Officer, Gulmarg Development Authority, Waseem Raja said, "Snow is one of the USPs of Gulmarg and it offers much more than just snowfall. Visitors engage in activities such as Gondola rides and other leisure pursuits."

"The repercussions of a lack of snow can be severe for other sectors as well. Without snowfall, essential resources like water and electricity will be scarce," Raja added.

Rauf Trambo, President of the Travel Agents Association of Kashmir (TAAK) also said, "The delay in snowfall is global this year. Some tourists having wedding plans here have cancelled their visit due to the absence of snowfall."

He said that winter sports at Gulmarg will be the most hit if the situation continues for more weeks. "The tourists who come to Kashmir to spend their leisure time are coming in good numbers. However, there has been a decline in winter sports and recreational tourism at Gulmarg," said Trambo, who is also the President of Winter Games Association of J&K (WGAKJ).

"Due to the deferred snowfall, hoteliers, skiing guides at Gulmarg have been hit, it is worrisome but it is all about nature."

He added that some skiing groups from foreign had to visit Kashmir but given the situation they chose to travel to Kazakhstan.

period is vital for these resources to get recharged, otherwise it will have a long term impact not only on drinking water but on electricity as well," Malhotra said.

While appealing people to use the drinking water judiciously, Malhotra said there can be a severe water crisis if the dry spell continues.

When asked about the reports of scarcity of drinking water pouring in from different areas of Kashmir with people blocking the roads to press their demands, Malhotra reiterated that the shortage of water is inevitable where surface water sources are not adequate.

"I mean to say, this is something that I can't produce in a factory. People need to understand it. But as of now, wherever people complain of shortage of drinking water, we press water tankers to meet the demands," he added.

Malhotra, however, acknowledged that "people are feeling the pinch" because the water they were using for different purposes including kitchen garden, car washing, house cleaning etc. isn't there. "For drinking, we have sufficient supply," he said.

When asked about the plans to meet the demands through-out the year, if these conditions persists, Malhotra said, "as of now we have no plans but if there is water scarcity, we have to supply drinking water through tankers."

The top engineer, however, was quick to add that they can't provide water meant for other purposes but only drinking purposes.

He further said if the situation demands, they can go for dredging for collection of water and go for pumping in rural areas. He said the department also has reservoirs in every division.

"But let's hope it snows during the Chillai-Kalan period only," he added.

### ICJ Begins Hearing

had breached Article II of the Genocide Convention, which included the "mass killing" of Palestinians in Gaza.

"Israel deployed 6,000 bombs per week... No one is spared. Not even newborns. UN chiefs have described it as a graveyard for

children," she said.

"Nothing will stop the suffering, except an order from this court," she added. South Africa has demanded that the ICJ order Israel to suspend its military campaign.

Also called the World Court, the ICJ is the highest UN legal body that can adjudicate issues between member states.

Alanna O'Malley, a professor of UN and international history, told Al Jazeera that South Africa's case was a "historic" one.

"We see from the invocation of the various articles of the Genocide Convention by the South African legal team the ways in which they are going to structurally present this case," she said outside the court in The Hague, calling it "extremely compelling."

South African President Cyril Ramaphosa said his nation was pursuing the case of what it called "the ongoing slaughter of the people of Gaza".

Israel will respond to the allegations made by South Africa on Friday.

'Genocidal intent' Tembeka Ngcukaitobi, another lawyer for South Africa, tackled the issue of Israel's "genocidal intent" against the Palestinians in Gaza, usually the most difficult thing to prove in a case of this kind.

"Israel's political leaders, military commanders and persons holding official positions have systematically and in explicit terms declared their genocidal intent," he said.

"These statements are then repeated by soldiers on the ground in Gaza as they engage in the destruction of Palestinians and the physical infrastructure of Gaza."

Ngcukaitobi brought to the court's attention Israeli Prime Minister Benjamin Netanyahu's comments on October 28, 2023, urging ground troops preparing to enter Gaza to "remember what Amalek has done to you".

"This refers to the Biblical command by God to Saul for the retaliatory destruction of an entire group of people," the lawyer said.

"The evidence of genocidal intent is not only chilling, it is also overwhelming and incontrovertible," he added.

Israel has rejected the accusations of genocide as baseless, with President Isaac Herzog calling the case "preposterous" and saying it constitutes a "blood libel".

On Thursday, Israel's foreign ministry spokesman, Lior Haiat, called the case "hypocrisy" and accused South Africa of being the "legal arm" of Hamas.

'Stop genocide' Gaza resident Aya Daloul said she hoped for a favourable decision and for the ICJ to help "stop the Israeli genocide against the Palestinians".

"The war must come to an end. We need to go back home and live in freedom and peace," she told Al Jazeera.

Outside the ICJ, a large number of demonstrators gathered to express solidarity with Palestinians and call for an end to Israel's war, with people holding Palestinian flags and chanting occasionally: "Stop, stop genocide," "We are all Palestinians" and "Boycott Israel". "I'm here because we just can't assist this genocide every day on social media and not do anything," said Kim Wouters, a demonstrator who travelled from Brussels.

Meanwhile, South Africans are feeling "a lot of pride" over the legal action taken by their country, said Al Jazeera's Fahmida Miller, reporting from Pretoria. "What is happening in Gaza resonates very deeply with many South Africans because of their own history of apartheid, subjugation, oppression, institutionalised racism and the challenges South Africans have had to overcome," she said.

In a sign of how seriously Israel is taking the accusation, it has sent a strong legal team to defend its military operation launched in the aftermath of the Hamas attacks. Israel often boycotts international tribunals or U.N. investigations, saying they are unfair and biased.

for two separate courses in order to get benefits," she said.

Saksham Scholarship, Pragati Scholarship, AICTE PG Scholarship, Prime Minister Special Scholarship Scheme, and National Doctoral

"Actually PMSSS was launched in the year 2020, and the government was mulling to discontinue the same, however the scheme was later extended for five years. So far as PMSSS is concerned, this scheme except MBBS covers all courses," Khuehami told Kashmir Observer.

He added that the issue of delaying disbursement of scholarship funds by AICTE was taken up with the authorities in the past as well following complaints by many students.

### Terror Activities

Rajouri-Poonch sector. The terror infra continues to thrive across the border, in an apparent reference to Pakistan's support to various terrorist groups, added.

It is learnt that the terrorists operating in the Rajouri-Poonch area are very well-trained in carrying out terror attacks and ambushes.

The Army Chief said his force is focusing on strengthening the human intelligence which includes synergising the Army's efforts with other agencies, adding having support of the locals is also "extremely crucial" in anti-terror operations.

"We have already taken follow up action," he said.

The Chief of Army Staff said the Army is also looking at strengthening the ability to use technology to gather intelligence.

"We have enhanced our deployment and also reoriented some of the units," he said.

At the same time he said the troops have been told to operate professionally.

"My guidance to soldiers and commanders is unambiguous -- in terms of respect for human rights, there will be zero tolerance for any actions on that account," he said.

"We have clearly laid out guidelines spelling out what you (Army personnel) must do and what you must not do in those areas and for the soldiers to be able to (operate) in a professional manner," Gen Pande said.

He said there has been an increase in terrorist activities in Rajouri-Poonch region in the last five-six months.

"In the last five to six months, in Rajouri and Poonch, there has been an increase in terrorism. Terrorism in that area was eradicated in 2003 and peace was there till 2017-18," he said.

"Because of the situation in the valley getting normal, this is one area, our adversaries have been active in, in terms of abetting terrorism, encouraging proxy tanzeems in operating in this area," he said.

"Under Operation Sadbhavna, we are engaging with the local community (in Rajouri-Poonch). I personally interacted with the local community there and the army has already adopted the affected village (in Poonch)," he said.

The Army Chief said 45 terrorists were killed in Jammu and Kashmir in the last three years.

### 'Situation Around

continues to be at a high level, he said, noting that the Indian Army is maintaining adequate reserves to confront any security challenge in the region.

Indian and Chinese troops are locked in an over three-year confrontation in certain friction points in eastern Ladakh even as the two sides completed disengagement from several

The search operation has been widened and adjoining areas are being searched as the Poonch-Rajouri region has seen a spurt in terrorist activities by Pakistani terrorists over the last over two years, a senior officer said. The Centre has inducted CRPF units in this area to strengthen the security grid. Operational units of the Army and the Rashtriya Rifles (RR) are also deployed here.

## CCTV Cameras Installed To Check Poaching Of Migratory Birds In Wular Lake

**SRINAGAR:** Authorities have taken the help of technology to check the poaching of migratory birds in the Wular lake in Jammu and Kashmir's Bandipora district during the peak winter months when more than a million avian visitors arrive here.

The Wular lake, India's largest and Asia's second largest fresh-water lake, is spread over a total area of around 200 square km and is spread over two north Kashmir districts - Baramulla and Bandipora. The lake provides 60 per cent of the valley's fish produce and is home to millions of local and

migratory bird species. However, owing to poaching, with an increased threat in recent years, and encroachment, the lake saw a decreasing footfall of the avian visitors over the last few years.

The authorities, including the Wular Conservation and Management Authority (WUCMA), launched a campaign against poachers over the last few years, arresting many of them and seizing arms, including punt guns. However, to keep 24-hour surveillance around the lake, especially in the areas where the migratory population resides, the authorities have installed CCTV cameras at strategic

places around the lake, along with taking some other counter measures to restore the lake to its "pristine glory", officials said.

"CCTV cameras have been installed along the lake in Suderkote and Baniyar areas. The cameras are high-definition and are controlled by mobile phones," coordinator, WUCMA, Irfan Rasool Wani, told PTI. Wani said taking advantage of the technology was the need of the hour as the staff cannot monitor every area

round-the-clock. "Wular is an open area and so the cameras are the best surveillance device. We can monitor it round-the-clock using our mobile devices. Their movement can be

controlled with mobile phones. The cameras are interactive as well and we can send a message through them to the other end," he said. He said the cameras have acted as a deterrent as there has been no incident of poaching or movement of poachers in these areas since their installation. The officer added that more cameras are being installed this month to effectively cover 10 square km area of the lake.

He said the department is also conducting a drone survey in the area, especially for

boundary encroachment. "We are also monitoring the boundary of the lake for encroachment or damage," he said. There is a scope for eco-tourism in the area as well and steps are being taken to develop it so that the Wular-dependent community, which consists of 30 villages, gets opportunities to earn livelihood which would also help in checking poaching, Wani said. Showkat Maqbool, a forest guard with the WUCMA, said the CCTV cameras were an added protection for the winged guests. "Thousands of birds have arrived here this year as well. The installation of CCTV cameras has added to

their safety. We can even keep surveillance in the area even from our homes now," Maqbool said. Ghulam Nabi Dar, a local, said the CCTV cameras have not only helped in protecting the birds, but have also increased the footfall of avian visitors this year. The Wular lake is known for water chestnuts and lotus stems and is the lifeline of the 30 villages surrounding it. It was designated as a wetland of international importance under the Ramsar Convention in 1990.

## People Of Kashmir Suffering Because Of Discrimination: Congress

**'There Have Been 'Grave Injustices In Every Field Under BJP's Rule'**

**SRINAGAR:** The Congress on Thursday said the last ten years of the BJP rule have been a period of "injustice" and party leader Rahul Gandhi's 'Bharat Jodo Nyay Yatra' is to fight for the economic, social and political justice in the country.

"Gandhi is undertaking the yatra again and it is called as 'Bharat Jodo Nyay Yatra'. He will take the yatra from Manipur to Maharashtra and travel 6,713 km across 15 states and 110 districts in 66 days. It will culminate at the Azad Maidan in Mumbai," Congress national spokesperson Meem Afzal told reporters at a press conference here.

Afzal said that Gandhi had after the 'Bharat Jodo Yatra',

which culminated here in January last year, promised to undertake the yatra again and it would start on January 14 from Imphal.

"This yatra is to fight for justice, including economic, social and political justice in the country. We have given a slogan that 'pichle das saal, anyak kaal' (Last ten years, period of injustice). The last ten years have been an example of injustice. There have been grave injustices in every field," the Congress leader said.

He said the Bharatiya Janata Party (BJP) government has tried to "destroy democracy and the Constitution" in the country.

Escalating his attack on the ruling BJP, Afzal said the back-breaking inflation has "de-

stroyed" savings of the poor and middle class, adding this government has become a "puppet" in the hands of few rich businessmen.

Afzal said the poor people in the country "are being discriminated upon".

"The people of Kashmir are suffering because of discrimination. They are facing it every day. The government is also fooling the people on the China issue," he said.

When asked whether the Enforcement Directorate (ED) summon to National Conference president Farooq Abdullah was a part of pressure tactics on the opposition leaders before the general elections, the Congress leader said that "there was no second thought about it".

## Panel To Probe Pregnant Woman's Death At SDH Banihal

**Another Committee Formed To Investigate Inadequate Medicine Supplies At District Hospital**

**SRINAGAR:** The Jammu and Kashmir government on Thursday established two distinct committees to investigate allegations of negligence which resulted in the death of a pregnant woman at Sub District Hospital (SDH) Banihal and complaints of inadequate medicine supplies at the District Hospital Ramban.

According to an official order, the inquiry into alleged medical negligence will be led by the District Programme Officer, Poshan Ramban. The investigation into reports of medicine unavailability at DH Ramban will be spearheaded by the Assistant Commissioner Revenue (ACR) Ramban.

The order stated, "Sanction is hereby accorded to the

constitution of a committee to conduct an in-depth inquiry into the death of a lady, namely Afroza Begum, Wife of Zakir Hussain, Resident of Neel, due to the alleged negligence of Doctors and Hospital Staff at Sub District Hospital (SDH) Banihal."



The committee, chaired by Jahangir Hashmi, JKAS District Programme Officer, Ramban Poshan, will include Zaheer Abass Bhat, JKAS Sub Divisional Magistrate, Banihal, Dr Kamal Jee Zadoo, Chief Medical Officer, Ramban, Nasir Javeed, Tehsildar, Pugal Paristan, and Dr G.L. Manhas as its members. The committee has been mandated to submit a comprehen-

sive report along with recommendations within four days of its formation.

The move follows the circulation of a viral video on social media in which an individual claimed that his wife experienced pain while travelling from Srinagar to Jammu and was admitted to the District Hospital Ramban. The complainant alleged that he had to procure medicines outside the hospital due to the unavailability of drugs within the facility.

A separate committee has been instituted to investigate these claims, as per the order.

Giasul Haq, JKAS Assistant Commissioner, Revenue, Ramban, will serve as the committee's Chairman, with Dr Kamal Jee Zadoo, Chief Medical Officer, Ramban, Deepak Kumar, District Treasury Officer, Ramban, and Dr Varinder Trisal, MS DH Ramban, as members.

The committee has been directed to submit a detailed report, along with specific comments and recommendations, to the office within a week (KNO)

## FCIK Urges For Liberation Of Agro-Wood Based Industry From 'License Raj'

**SRINAGAR:** The Federation of Chambers of Industries Kashmir (FCIK) on Thursday urged for liberation of agro-wood based industry from "License Raj" in order to foster growth and development of this vital activity.

In a statement, the apex industrial chamber while terming the "License Raj" as an oppressive system to keep wood based enterprises of J&K in chains has demanded for its banishment in order to provide fresh gust of liberalized environment to the activity particularly to those industrial units that have had no impact on the nationalized forests.

FCIK has sought intervention of the Financial Commissioner, Department of Forest, Ecology and Environment, Dheeraj Gupta in early removal of anomalies in the guidelines issued under SRO 321 of 2022 which contradicted with the guidelines issued by Ministry of Environment, Forest and Climate Change (MOEFCC) under S.O 3000 (E) at many places.

"Notwithstanding the fact that GOI was contemplating to further amend their guidelines in order to promote sustainable development of wood-based industries in the country to its potential on the persistent demand from business chambers across the country including FCIK, J&K forest officials wish to pursue archaic rules to whip the entrepreneurs," an FCIK spokesperson said.

FCIK, he said, has constantly been receiving complaints of heavy intervention in the op-

eration of wood based industrial units across Kashmir valley which was stifling this economic activity and hampering the smooth operations of concerned units.

While acknowledging the difficulties faced by wood-based industry, the President FCIK Shahid Kamili intimated to the concerned that FCIK was vigorously following the issue for a meaningful resolution and in this regard has held two formal meetings with Financial Commissioner and other top authorities of forest department in recent months.

"Whereas many decisions to remove anomalies in the guidelines and easing out the renewal of license mechanism were taken in a meeting of 21st October, 2023, the formal orders were still awaited despite the record note of minutes having been issued on 13th of November", Kamili said.

He said that the matter was again taken up with Financial Commissioner with a fresh reminder and it was expected that formal orders would be issued at the earliest as per the verbal assurances given by him.

According to FCIK, the issues resolved in previous meetings but awaiting formal orders included removal of anomalies in exempted list of industries, approval of clusters of 5 or more units at par with industrial estates, introduction of auto renewal mechanism for licenses after self-attested declarations and making licenses transferable upon sale, succession or change of constitution of the unit.
