A Temperature Twist Again!

Srinagar Outshines Lucknow in Winter Warmth

Srinagar: Continuing its unusual turn of events, Srinagar has once again defied winter norms, this time showcasing warmer temperatures than Lucknow. In an unexpected twist, the Kashmiri city is experiencing milder weather this winter compared to other regions.

The maximum temperature in Lucknow was recorded at 11.8°C, while in Srinagar the maximum temperature was 12.4°C.

"The temperature in Lucknow was 10°C below normal. In Srinagar, the maximum temperature was 6°C above normal," Faizan Arif, an independent meteorologist said.

"Luckow city has been engulfed in low level fog for the past two days. As a result of the snowless winter, Kashmir continues to remain engulfed in warm temperatures. This

situation can end if Western Disturbance brings snow to the Himalayas," he added.

Srinagar also recorded a warmer day than the winter capital, Jammu. Jammu City has recorded a maximum temperature of 10.3°C.

Similarly, some other parts including Qazigund, the gateway of Kashmir, Kupwara in north Kashmir and Kokernag in South Kashmir also recorded a warmer day than Jammu today as a maximum temperature of 11.6 °C, 12.5 °C. and 11.4 °C were recorded in these areas respectively.

Tamil Nadu 's Ooty district is also experiencing an unusual cold spell as temperatures have dropped to zero degrees Celcius. Frost-covered lawns and dense fog had led to reduced visibility.



To fulfil the requirements of this contract, the Contractor will inevitably be required to present documentary

proof in support of contractor owned or leased vehicles. The company name must be prominently displayed on both sides of any vehicles used by the Contractor to carry out this contract. All vehicles used in the performance of this contract shall be in operable condition and meet the safety require

ments. The Department may inspect the Contractor's vehicles at any time and direct the removal of any unsafe or non-functional vehicles. All vehicles shall be registered, licensed, having Department of Transportation numbers visible and insured and operated by a licensed driver as required by law; and follow all regulations related to parking, driving, and licensing.

The Department may inspect the Contractor's equipment and tools at any time The Contractor will be required to procure its own attachment compatible with JCB machines and/or use snow plough attachments provided by the DEPARTMENT. The Department will provide the attachment on a nominal rental basis based on the cost of procurement and the functional life of the attachments to be fitted on the Machine/JCB listed on the snow clearing equipment submitted with this bid, and the Contractor must acknowledge receipt of it. The Department may ask the equipment to be returned at the end of the winter season. All equipment shall be subject to inspection, retrieval, repair or maintenance at the end of each snow fall and at any time during this contract period. In the event of any negligence or carelessness in the use and maintenance of the provided equipment, the DEPARTMENT will determine the amount of the loss or value of the damaged equipment, for which the contractor will be charged the replacement cost of the equipment less appropriate depreciation that will be billed to the contractor or deducted from due claims.

All required snow plough apparatus shall be properly installed on the Machines, and the Machines will have to espond to a snow callout by October 15th of each contract year. During each winter season in which this contract is in effect, the equipment shall be installed continuously from October 15th to April 30th of the following year. Seizure Of Masjid Bank Account Sparks Protest At Nowshehra

Srinagar: Protests erupted in Nowshehra area in Srinagar on Saturday after the authorities seized the bank accounts of Khawaja Habibullah Nowsheri (RA) Masjid here following the allegations of misappropriation of funds.

The local inhabitants expressed resentment and stated that some people for their vested interests have been putting their efforts to take over the Masjid and thus simultaneously have been making false allegations to create ruckus.

Showkat Ahmad, president of the Masjid, said such is the interference that the prayer leader, who served for 25 year now, is being asked to vacate.

"We have kept the details of each and everything. There is no misappropriation of funds at all," he said, adding that

some people with vested interests have been making false allegations in this regard.

Another local said the Masjid is not Waqf notified, but some people are trying to create disturbances by claiming that the issues of misappropriation have taken place. "The Masjid in which the people from almost 10 areas offer prayers on a regular basis have never raised the voice against the Imam (prayer leader), but the voices of only a few vested interests are being heard and the majority is being neglected. Even the bank account has been seized on their interference," he said.

Moreover, Board Chairperson, when contacted said the Masjid is not Waqf notified, but they have got a complaint about the misappropriation of funds following which the local administration was directed to investigate the matter.

Forest Fires in Jammu & Kashmir

Roles, Responsibilities and Legal Commitments

he prolonged and unprecedented dry spell in the Himalayan region is attributed to the absence of active strong western disturbances, prevailing El Niño conditions, and a robust jet stream. This has transformed the once snow-covered mountains and plains into a brown and barren landscape, creating a dry, desolate, and visually depressing scene. The altered weather pattern is impacting various aspects, ranging from hydrology to the agro-economy of the valley, and has also contributed to a recent surge in forest fires in Jammu and Kashmir. Fortunately, the reported forest fires have primarily been ground fires or surface fires without causing any major

According to numerous research articles, approximately 1-2% of the world's forested areas are engulfed by forest fires annually. Some forest fires are beneficial for ecological renewal, nutrient recycling, control of Alien invasives, pests and diseases but the vast majority of fires are associated with their destructiveness. These fires contribute to an annual carbon emission ranging between 2.5 to 4.0 billion tons of CO2, resulting in significant losses in both flora and faunal diversity. Moreover, the repercussions extend to long-term effects on human health and well-

In technical terms, the occurrence of any fire necessitates what is referred to as the combustion or fire triangle. This triangle comprises three essential components: air/oxygen, fuel and ignition or heat. The fuel in forests of J&K comprises dry broad leaves, debris of pine needles with highly flammable resins/oleo-resins, fallen branches and twigs, dry grasses, and shrubs

In our forests, air is omnipresent and fuel is abundant, with the initiation of a fire dependent on the third element: ignition or heat. This ignition or heat source can originate either naturally or through human activities, categorizing forest fires as either naturally.

Addressing forest fires involves a dual approach: the response from the relevant forest department and the proactive stance of citizens, marked by environmental awareness and responsible behaviour. Preventing forest fires hinges on the environmental consciousness and responsible actions

ral or man-made. According to reports from the Forest Survey of India (FSI), approximately 95% of forest fires are of anthropogenic origin i.e., attributed to human activities. Natural forest fires result from occurrences such as lightning, rolling stones, or the friction of dry grasses and shrubs. Conversely, human-induced fires can be attributed to carelessness or intentional actions. Deliberate fires are often set for charcoal production, as acts of hostility and retribution against forest officials, or to eliminate evidence by setting fire to stumps of illegally felled trees. Additionally, intentional fires may be employed as a modus operandi to encroach on forest land by setting nearby vegetation ablaze. Unintentional forest fires may arise from neglected campfires, the disposal of burning matchsticks and cigarette butts, or unattended fires caused by graziers.

- During-fire season strategy (forest fire detection based on SMS based alerts by FSI, near real time monitoring of

forest fires based on MODIS and SNPP-VIIRS, rapid response teams and forest fire suppression measures)

 Post-fire season strategy (investigation, assessment of loss and ecological restoration measures).

The lack of precipitation due to prolonged dry spell has rendered the forests of Jammu and Kashmir exceptionally dry, making them susceptible to major fires from even a single spark. In light of this, it is imperative to refrain from entering wildlife protected areas in particular, and forests in general, during this period. Additionally, it is crucial to avoid starting campfires near vegetation, choose open locations for campfires, ensure campfires are completely extinguished before leaving, and refrain from smoking cigarettes while navigating through forests.

It is pertinent to mention that forest fires in the valley are occurring in challenging terrains, necessitating considerable time and a substantial workforce to reach and extinguish the fires. This stands in contrast to fires in the plains, which are easily accessible to humans and fire service vehicles.

Legal provisions and penalty -

Besides various provision in IPC and CrPC, the Indian forest act, 1927 and wildlife protection act, 1972 provides legal protection to the floral and faunal diversity of India. Section 26(1)(c) of IFA,1927 provides that any person who kindles, keeps or carries any fire except at such seasons as the Forest-officer may notify in this behalf with in a reserved forest shall be punishable with imprisonment, or with fine, or with both. It makes the offence a non-bailable cognisable one. similarly, section 33(1)(d) and 33(1)(e) of IFA, 1927 provides for the same with respect to the protected forests.

Duties of the citizens and concessionists

Article 51-A of the Indian Constitution mandates every citizen to fulfill the responsibility of safeguarding and enhancing the natural environment, encompassing forests, lakes, rivers, and wildlife, while also fostering compassion for living creatures. Aligned with the Forest Rights Act, Section 5(a) of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, imposes an obligation on holders of any forest rights to actively participate in the protection of wildlife, forests, and biodiversity.

The Maharaja era Kashmir Forest Notice of 1912 extends concessions to legitimate users, particularly those whose village boundaries are within three miles from the demarcation line of the designated forest. Simultaneously, it outlined specific duties and responsibilities for these concessionists. Rule 21 of the Kashmir Forest Notice stipulates that concessionists are obligated to promptly inform relevant officials about forest fires. They are also expected to assist in extinguishing forest fires or fires outside the forest that could potentially spread into forest areas they are also required to provide information about individuals involved in forest fire offenses. It is emphasized that individuals failing to provide such assistance are subject to legal consequences. Upon conviction by a magistrate, they may face fines, imprisonment, or both.

In conclusion, forest fires can be effectively prevented and managed through the implementation of proactive strategies by the Forest department and the active involvement of citizens, especially forest concessionists.

electronic ones fail to appreciate that it is the content and not the material that matters. In the words of Douglas Adams, "Lovers of print are simply confusing



AC authorises JKPTCL to take up projects worth Rs 1190 Cr through TBCB route

JAMMU: The Administrative Council (AC) which met here under the Chairmanship of Lieutenant Governor, Manoj Sinha authorized the Board of Directors (BoD) of Jammu & Kashmir Power Transmission Corporation Ltd. (JKPTCL) to take up the Critical Intra-State Transmission Projects estimated cost of Rs1190 Cr through Tariff Based Competitive Bidding (TBCB) route in the UT.

Rajeev Rai Bhatnagar, Advisor to the Lieutenant Governor; Atal Dulloo, Chief Secretary; Mandeep Kumar Bhandari, Principal Secretary to LG attended the meeting.

These projects include Grid Station at an estimate cost of Rs. 99.20 Crores at upcoming Industrial Estate of Bhagthali, DisttKathua. Besides Bhagthali, the other two projects approved

for execution under TBCB route are Laying of Downstream Transmission Network from upcoming 400 /220 kV Grid Sub-station Siot, Rajouri (ISTS) with an estimated cost of Rs. 790 Crores and construction of Grid Sub-Station at Wahipora and Sallar, Kashmir and allied transmission system within estimate cost of Rs. 300 Crores. Union Power Ministry officials in various review meetings have advised the UT Government to execute transmission projects through TBCB/ JV mode.

Moreover, in the draft of new Electricity Policy, it has been mentioned that all future intrastate transmission projects shall be developed through competitive bidding process except for the projects having an estimated capital expenditure below a threshold limit, and projects of

strategic importance as decided by the State Government.

Finance Department has also advised PDD to utilize PMC for 2 of the 3 projects and execute 1 project using the model TBCB document on its own. This will help in building internal expertise.

AC also authorized JKPTCL to engage Power Finance Corporation Consulting Limited (PFCCL) or any other CPSU authorized by Ministry of Power as Bid Process Coordinator (BPC) on nomination basis for undertaking the above said transmission projects through TBCB route.

Professional charges payable to the CPSU engaged as BPC may be decided by JKPTCL through limited tender enquiry amongst eligible CPSUs while adhering to the guidelines of TBCB issued by Ministry of Power.

AC approves revamping of ICT set-up & VC project for High Court

Srinagar city recorded a low of minus 3.7 degrees Celsius, up from minus 4.9 degrees Celsius the previous day, they said.Qazigund recorded a low of minus 4 degrees and the ski resort of Gulmarg in north Kashmir minus 4.6 degrees Celsius, the officials said. They said Pahalgam in south Kashmir's Anantnag district recorded a minimum temperature of minus 5.5 degrees Celsius, Kokernag town minus 2 degrees Celsius and Kupwara minus 4.7 degrees Celsius.Kashmir is currently under the grip of "Chilla-i-Kalan", a 40-day harsh winter period when a cold wave sweeps through the region and temperatures drop considerably, leading to the freezing of water bodies as well as water in pipes. The chances of snowfall are the highest during this period. This time, however, Kashmir is witnessing a prolonged dry spell and a 79 per cent deficit in rainfall was recorded for December while there has been no precipitation in most parts of the Valley in the first 20 days of January.

A dry and largely snowless winter has resulted in freezing nights and warmer-than-usual days. The maximum temperatures recorded on Friday across Kashmir were 4.7 to 7 degrees above the normal for this time of the season.

The meteorological department has said there is a possibility of light snow and rain in the Valley next week which would bring an end to the prolonged dry spell. It also said that while the dry weather is likely to continue till January 24, there is a possibility of light snow at isolated places in the higher reaches of Jammu and Kashmir on January 25.

From January 26-28, light rain or snow is likely over scattered places in J-K, while from January 29-31, as per the indications of different models, the possibility of light to moderate rain or snow at many places is very likely, the Met office said

The court ordered that the petitioner shall furnish registered postal covers within a period of seven days 'whereupon the Registrar Judicial, Srinagar to issue notices to the respondents'.

"In the meantime, the respondents (BOSE Chairman) are sounded a caution to consider the compliance of the writ court direction as it obtains with respect to the future of the students undergoing their education in the petitioner's schools," it reads.

Pertinently, the Jammu and Kashmir Board of School Education (JKBOSE) earlier this year has given a nod to enroll secondary and senior secondary level students of sixty private schools to nearby government institutions in view of 'land and affiliation expiry issues'.

The officer in the order had said that the order was accorded with regard to the expiration of affiliation of such private academic institutions of Kashmir Division, in October 2021-2022, coupled with the failure of the concerned managements to submit requisite case files for further extension with necessary certificates and safety documents.

The board authority had also said that the concerned private schools shall remit a tagging fee equivalent to periodical inspection fee for the current academic session viz. 2023-2024, as prescribed by the JKBOSE.

"The defaulter schools are admonished not to enroll any students in classes from 9th to 12th, from the next academic session Viz 2024-2025, without securing formal affiliation and recognition from the board and Government School Education Department respectively," it reads.

The board authorities however had said that the orders shall be subject to the outcome of writ petitions, if any, pending before the competent courts of law.

Meanwhile, the officials of JKBOSE had said, "Under Statutory Order (SO) 177, in the case of those private schools who are running their institutions from the state land and are defaulters, their number is around 200."

The official had said that those owners or functionaries of such private schools were supposed to get their title cleared from the revenue department. "We only need a NOC from them."

In April-2022, the government had notified conditions under SO-177 for private school registration, recognition, and affiliation.

During investigation, the SIA conducted five rounds of extensive searches at 32 locations across the valley, during which evidence in the shape of mobile devices, incriminating documents viz Bank Documents and a Pistol magazine and live cartridges were seized," he said.

The investigation revealed that the accused were acting on instructions from terror handlers across the border and maintaining communication via encrypted online messaging platforms, the officials said.

They said Jazim Farooq Wani, who pulled the

trigger, received weapon handling training from Nassir Farooq Shah on the directives of Pakistani handler Khalid Kamran.

The investigation will continue and the SIA is committed to ensure all the accused who have been a part of the crime in any way are brought to justice, the officials said.

SRINAGAR: J&K Bank Net Profit rose 35% yearon-year (YoY) to Rs 421.08 Cr for the October-December Quarter (Q3FY 2024) when compared to Rs 311.59 Cr registered for the same period last fiscal. The bank's profit for 9-months has jumped 57% in Q3 to Rs 1128.60 Cr from Rs 721.05 Cr clocked during nine-months of the last financial year.

KARACHI: Pakistan's former captain Shoaib Malik announced on Saturday that he has married a second time to the country's popular actor Sana Javed in Karachi after getting divorced from Sania Mirza.

The cricketer who was previously married to Indian tennis star, Sania, with whom he has a son, released a photograph on a social media platform with his new wife, with the words "And We created you in pairs".

Their five-year-old son Izaan lives with Sania.

Sania's father Imran Mirza told PTI that "it was a 'khula'", which refers to the right of a Muslim woman to unilaterally divorce her husband.

There have been strong rumours since 2022 about differences between Shoaib and Sania leading to a split, and they have rarely been seen together in the last couple of years.

Just a few days back Malik also unfollowed the Indian star on Instagram.

Shoaib and Sania had got married in Hyderabad in the Indian player's hometown Hyderabad in April 2010 and they used to live in Dubai.

BLOEMFONTEIN: Left-arm spinners Saumy Kumar Pandey and Musheer Khan headlined a dominant Indian performance as the defending champions outclassed Bangladesh by 84 runs in their opening game of the ICC U-19 World Cup here Saturday.

While the total of 251 for 7 didn't look big, the two Indian spinners choked the run-flow, shooting out 'Tiger Cubs' for a meagre 167 in 45.5 overs.

Skipper Uday Saharan (64 off 94 balls) and left-handed opener Adarsh Singh (76 off 96 balls) hit half-centuries after Bangladesh invited the holders to take first strike.

Saumy (4/24) was economical and bowled the lethal arm ball with a skiddy action while all-rounder Musheer (2/35) tossed it up and got enough drift to tighten the noose around Bangladeshi batters.

Musheer, younger brother Mumbai's domestic stalwart Sarfaraz Khan, was a livewire on the field. He also effected a run-out.

What was impressive to see was no overt celebrations from



either Saumy or Musheer, who carried on their job like thoroughbred professionals.

It was a fairly ill-tempered match with players from both sides indulging in sledging as the two teams have history of tension across senior men. senior women and U-19 level.

For Indian team, it was a sweet revenge after losing the Asia Cup semi-final to Bangladesh. While the Indian batters found it difficult to get

boundaries, the target was never below par as average score of teams batting first in Youth ODIs (U-19 ODI) at this ground was 201, and the highest successful chase being 243.

In fact, India's 251/7 on the day was the third highest score at this ground.

The team's designated finisher Sachin Dhas showed admirable technique and temperament during death overs with a nice little unbeaten cameo of 26 off 20 balls that took the score past 250-run mark. The pulled six off seamer Rohanat Doullah Borson was a treat for the eyes.
