TERROR FUNDING CASE ED Files Prosecution Complaint Against 3

Srinagar: Directorate of Enforcement (ED) has filed a prosecution complaint against three persons in a terror funding case in Jammu and Kashmir.

According to a statement issued to the news agency-Kashmir News Observer (KNO), the complaint was filed under the provisions of Prevention of Money Laundering Act (PMLA), 2002 against Mudasir Ahmad Sheikh, Mushtaq Ahmad Kambay and Mohd. Iqbal Khan before the special court Srinagar.

The statement reads that the court has taken cognizance of the complaint and issued notices to the accused persons for further trial.

Srinagar: Police have busted a terror module operating from Pakistan-occupied Kashmir by arresting five terrorist associates in Jammu and Kashmir's Kupwara district, officials said on Saturday.

The Commission has decided to hold a camp sitting and open public hearing on grievances about human rights violations in Jammu & Kashmir Union Territory from February 7 to 9. This is the first such hearing by the NHRC in Jammu & Kashmir after it was empowered to deal with human rights issues of J&K

following abolition of the State Human Rights Commission.

According to a public notice issued by the NHRC, a copy of which is in possession of the news agency KNO, the complaints about alleged rights violations can be submitted to the commission by speed post or email by January 29.

Children Born Preterm Linked With Higher Risks Of Mental Disorders: Study

New Delhi: Children born prematurely have been associated with higher risks of having adverse neurodevelopmental outcomes, which can affect their behaviour and learning abilities, according to a study of over a million children.

Researchers compared the long term neurodevelopmental effects of children born at different gestational ages, particularly 32-33 weeks (moderately preterm) and 34-36 weeks (late preterm), compared with 39-40 weeks (full term).

The team of researchers, including those at Karolinska Institutet, Sweden, found that the highest relative risk for moderately preterm-born children was for motor impairment (nearly five-fold increased



risk), followed by epileptic impairment pertains to a disimpairment (nearly two-fold order of the central nervous increased risk), compared to system. full term-born children. While est level of risks for neurodevelmotor impairment refers to a physical disability and could opmental impairments appeared result in muscle weakness, poor from 32 weeks and then gradually declined until 41 weeks, with stamina, reduced balance, or

poor co-ordination, epileptic

findings are published in The British Medical Journal (BMJ).

While previous studies have shown that children born early have higher risks of neurodevelopmental and behavioural disabilities throughout childhood and adolescence compared with children born at full term, few population-based studies have investigated the long term neurodevelopmental outcomes of these children, the researchers said.

As the children they studied comprise about 80 per cent of all preterm births, these neurodevelopmental risks should not be underestimated, they said.

For the study, the researchers used the Swedish national registry to include more than 12.5 lakh single-born children without birth defects born in Sweden at 32 | More on P6

How rapid technological changes could impact our future

ewilderingly rapid changes are happening in the technology and reach of computer systems. There are exciting advances in artificial intelligence, in the masses of tiny interconnected devices we call the Internet of Things and in wireless connectivity. Unfortunately, these improve-

ments bring potential dangers as well as benefits. To get a safe future we need to anticipate what might happen in computing and address it early. So, what do experts think will happen, and what might we do to prevent major problems?

To answer that question, Our research team from universities in Lancaster and Manchester turned to the science of looking into the future, which is called forecasting. No one can predict the future, but we can put together forecasts: descriptions of what may happen based on current trends.

Indeed, long-term forecasts of trends in technology can prove remarkably accurate. And an excellent way to get forecasts is to combine the ideas of many different experts to find where they agree.

We consulted 12 expert futurists for a new research paper. These are people whose roles involves long-term forecasting on the effects of

changes in computer technology by the year 2040.

Using a technique called a Delphi study, we combined the futurists' forecasts into a set of risks, along with their recommendations for addressing those risks.

Software concerns

The experts foresaw rapid progress in artificial intelligence (AI) and connected systems, leading to a much more computer-driven world than nowadays. Surprisingly, though, they expected little impact from two much hyped innovations: Blockchain, a way to record information that makes it impossible or difficult for the system to be manipulated, they suggested, is mostly irrelevant to today's problems; and Quantum computing is still at an early stage and may have little impact in the next 15 years.

The futurists highlighted three major risks associated with developments in computer software, as follows.

AI Competition leading to trouble

Our experts suggested that many countries' stance on AI as an area where they want to gain a competitive, technological edge will encourage software developers to take risks

in their use of AI. This, combined with AI's complexity and potential to surpass human abilities, could lead to disasters.

For example, imagine that shortcuts in testing lead to an error in the control systems of cars built after 2025, which goes unnoticed amid all the complex programming of AI. It could even be linked to a specific date, causing large numbers of cars to start behaving erratically at the same time, killing many people worldwide.

Generative AI

Generative AI may make truth impossible to determine. For years, photos and videos have been very difficult to fake, and so we expect them to be genuine. Generative AI has already radically changed this situation. We expect its ability to produce convincing fake media to improve so it will be extremely difficult to tell whether some image or video is real.

Supposing someone in a position of trust a respected leader, or a celebrity uses social media to show genuine content, but occasionally incorporates convincing fakes. For those following them, there is no way to determine the difference it will be impossible to know the truth. **The Conversation**





Women's Health Care in Kashmir A Story of Biases and Challenges

omen in Kashmir, as with most parts of the eastern world, have been living in a male dominated society, in patriarchal families where a joint family system pre-existed. Traditionally, there was already a weak health care system, which was administratively centralized in nature.

It is now more than established that women's health problems were not treated properly, punctually and entirely. This may be explained partly in terms of illiteracy, poverty, ignorance, non-availability of doctors, facilities and medicines and partly be cultural lag, cultural ethos and cultural practices. In that situation, if men fell ill, they received medical attention immediately. On the other hand, if a woman fell ill, she did not receive medical assistance with the same promptness. The latter's cases were often dismissed, delayed or ignored which deteriorated their condition. It was only when their health deteriorated exponentially that they were deemed deserving of seeing a doctor.

The justification for such gender bias was attributed to factors such as women's significant economic reliance on the eldest male family member, absolute male authority, unequal roles and statuses between males and females, cultural constraints, and finally, the least prioritized concern was gender health.

Reproductive Health and Cultural Practices

Reproductive Health was totally affected by the cultural phenomena such as cultural notions, concepts, orientation, values, norms and practices. Even superstitions played a role and were practically detrimental to the ideals of women's health. It was observed that conscious and organized negation of women's health facilities were justified and legitimized on the basis of cultural notions and views which were practiced through the application of related values and norms. Even value oriented words like 'mouj ', 'beni', 'kour', 'khandryn' and' noush' revealed differential treatment of healthcare to them.

In this context difference can be observed from this cultural practice:

i. When women fall ill, they usually go to their parent's home and get the treatment there on their expenses.ii. Women usually go to a parent's home voluntarily before the time of delivery and stay there till she gets

perfectly well.

iii. When women feel tired or overburdened at her in-laws' home, they usually go to their parent's home for relaxing and entertaining.

This practice is still prevailing in a majority of the households in Kashmir.

Role of Folk Religion

Folk Religion played a role in addressing gender health care in Kashmir, either directly or indirectly, employing various methods and techniques. Gender health treatment in the region encompasses both conventional and non-conventional approaches. Non-conventional methods involve religious, psychological, and folk healing, while conventional methods encompass traditional and modern medical treatments. Within the cultural context of Kashmir, women have predominantly relied on non-conventional methods for treating various diseases and health issues. The result is that their health has suffered as these non-conventional methods were not fully effective and realistic.

The most common non-conventional method of gender health treatment was "Peer-Faqir Illaj" or spiritual healing which has strong cultural and religious currency in the region. It has been observed that this treatment is strongly approved in many cases. A considerable number of women patients go for these non-conventional ways of treatment, especially if modern medical facilities are not available fully.

Women's Health and Cultural/Religious Restrictions

Culture, with the support of folk religion, created an environment in the Kashmiri society which had clear negative implications for women's health. This reflects in the common cultural-religious attitude to avoid and to resist/oppose the exposure of their bodies in front of unknown and unrelated doctors. Consequently, they are not able to get proper and timely treatment of their diseases and other health problems in the absence of female doctors and other concerned professionals. This type of attitude in its extreme form hurts women at large, especially at the time of their delivery.

The intricate issue exacerbates the health condition of women in a scenario marked by a shortage of female doctors and para-medical staff, particularly nurses, specializing in gynecology and obstetrics across all healthcare centers and for all women.

Consequently, the culturally imposed restrictions on male-female interaction have created several structural and functional limitations for women in their medical treatment.

Conclusion

Addressing women's health has posed challenges in various societies, and the same holds true for Kashmiri society. In traditional social structures, girls were treated distinctively compared to boys. The health of these girls was significantly influenced by their parents' attention to their food and nutrition. Upon marriage and integration into new families, these women assumed subordinate positions and faced additional burdens of strenuous labor, leading to a further decline in their health. Gynecological issues added to the health challenges faced by females. The adherence to family norms in traditional societies often resulted in an environment that was historically unfriendly to women.

Modernization has ushered in numerous healthcare facilities, yet their accessibility remains geographically unfeasible in many parts of Kashmir. Gender-related health issues predominantly find resolution in centrally located places, leaving the majority without access to these benefits. Additionally, while health care centers have emerged in the private sector, only economically affluent families can afford to avail themselves of these services. In essence, the majority comprising the poor, those residing in remote areas, and those lacking immediate access are compelled to resort to nonconventional practices for gender-related issues, as well as common health problems, due to these limitations

What Next For India's Fintech Revolution?

With AI, cyber-risks will pose a significant threat. But the challenges can spur agile and proactive regulatory resposes to safeguard users while fostering innovation.

he BFSI sector has grown by leaps and bounds within the last two decades, transitioning India from a primarily cashdriven economy to one that is now highly digitised. Fintech, when it emerged as a nascent phenomenon in the early 2009, drew scepticism that it would not take-off in a market like India. Today, it has entered the mainstream and has begun its middle phase, focusing on increasing profitability and curtailing risk.

As India gallops towards becoming a \$5-trillion economy, fintech companies will play a defining role in the dynamics, with over \$400 billion worth of businesses to be created over the next seven years, a fourfold growth from current levels, in addition to tapping into a revenue pool of \$70 billion out of the total of \$620 billion by 2030.

The rise of fintech in India, like other digital phenomena such as e-commerce, is largely attributed to increased smartphone penetration and the fall in data prices. Fintech would not be where it is today if it was not backed by the foundation of increased internet penetration. The majority of Indians (759 million) now are active internet-users, and this figure is set to rise to 900 million by 2025, according to an IAMAI report.

In addition to this, the diversity in consumer demographics will also catalyse the adoption and proliferation of digital financial services in India. Data from Pew Research Centre shows that currently more than 40% of India's population consists of people under the age of 25. We will see a surge of Generation Z consumers entering the job market, who will boldly invest their earnings predominantly via digital platforms.

Through generative AI, there will not only be highly personalised solutions taking into account user context and history, we will also see conversational interfaces that support a range of regional languages. The evolution reflects a more interactive and accessible approach across the country, further bridging the digital and financial divide.

We could also expect voice-activated technology for KYC use cases that can prevent fraud. However, a concern arises: the advancements in generative AI to detect a user's voice with a high degree of accuracy can be counteracted with deepfakes. Smartphone addiction, sometimes colloquially known as "nomophobia" (fear of being without a mobile phone), is often fueled by an internet overuse problem or internet addiction disorder. After all, it's rarely the phone or tablet itself that creates the compulsion, but rather the games, apps, and online worlds it connects us to.

Addiction to social networking, dating apps, texting, and messaging can extend to the point where virtual, online friends become more important than real-life relationships. We've all seen the couples sitting together in a restaurant ignoring each other and engaging with their smartphones instead. While the internet can be a great place to meet new people, reconnect with old friends, or even start romantic relationships, online relationships are not a healthy substitute for real-life interactions. Online friendships can be appealing as they tend to exist in a bubble, not subject to the same demands or stresses as messy, realworld relationships. Compulsive use of dating apps can change your focus to short-term hookups instead of developing long-term relationships.

Compulsive web surfing, watching videos, playing games, or checking news feeds can lead to lower productivity at work or school and isolate you for hours at a time. Compulsive use of the internet and smartphone apps can cause you to neglect other aspects of your life, from real-world relationships to hobbies and social pursuits.

Online compulsions, such as gaming, gambling, stock trading, online shopping, or bidding on auction sites like eBay can often lead to financial and job-related problems. While gambling addiction has been a welldocumented problem for years, the availability of internet gambling has made gambling far more accessible. Compulsive stock trading or online shopping can be just as financially and socially damaging. eBay addicts may placing the winning bid.

While you can experience impulsecontrol problems with a laptop or desktop computer, the size and convenience of smartphones and tablets means that we can take them just about anywhere and gratify our compulsions at any time. In fact, most of us are rarely ever more than five feet from our smartphones. Like the use of drugs and alcohol, they can trigger the release of the brain chemical dopamine and alter your mood. You can also rapidly build up tolerance so that it takes more and more time in front of these screens to derive the same pleasurable reward.

Heavy smartphone use can often be symptomatic of other underlying problems, such as stress, anxiety, depression, or loneliness. At the same time, it can also exacerbate these problems. If you use your smartphone as a "security blanket" to relieve feelings of anxiety, loneliness, or awkwardness in social situations, for example, you'll succeed only in cutting yourself off further from people around you. Staring at your phone will deny you the face-to-face interactions that can help to meaningfully connect you to others, alleviate anxiety, and boost your mood. In other words, the remedy you're choosing for your anxiety (engaging with your smartphone), is actually making your anxiety worse.

Smartphone or internet addiction can also negatively impact your life by increasing loneliness and depression. While it may seem that losing yourself online will temporarily make feelings such as loneliness, depression, and boredom evaporate into thin air, it can actually make you feel even worse. A 2014 study found a correlation between high social media usage and depression and anxiety. Users, especially teens, tend to compare themselves unfavorably with their peers on social media, promoting feelings of loneliness and depression.

One researcher found that the mere presence of a phone in a work place tends to make people more anxious and perform poorly on



given tasks. The heavier a person's phone use, the greater the anxiety they experienced.

Using a smartphone for work often means work bleeds into your home and personal life. You feel the pressure to always be on, never out of touch from work. This need to continually check and respond to email can contribute to higher stress levels and even burnout.

The constant stream of messages and information from a smartphone can overwhelm the brain and make it impossible to focus attention on any one thing for more than a few minutes without feeling compelled to move on to something else. The persistent buzz, ping or beep of your smartphone can distract you from important tasks, slow your work, and interrupt those quiet moments that are so crucial to creativity and problem solving. Instead of ever being alone with our thoughts, we're now always online and connected.

Excessive smartphone use can disrupt your sleep, which can have a serious impact on your overall mental health. It can impact your memory, affect your ability to think clearly, and reduce your cognitive and learn-

ing skills.

A UK study found that people who spend a lot of time on social media are more likely to display negative personality traits such as narcissism. Snapping endless selfies, posting all your thoughts or details about your life can create an unhealthy selfcenteredness, distancing you from real-life relationships and making it harder to cope with stress.

There are a number of steps you can take to get your smartphone and internet use under control. While you can initiate many of these measures yourself, an addiction is hard

Patna: All eyes were trained on Bihar Chief Minister Nitish Kumar on Saturday, with the JD(U) president appearing to be inching towards his second political volte face in less than 18 months.

For Kumar, who has maintained a deafening silence over the turmoil in the 'Mahagathbandhan', ignoring pleas from allies RJD, Congress and the Left to clear the confusion, it was business as usual.

The longest-serving CM began the day by flagging off a number of new fire brigade engines at the city's veterinary college ground, which saw him address a mammoth party rally earlier this week.

He followed it up with a visit to Buxar, for inauguration of a beautification project of a renowned temple, a project of the tourism department that is held by his deputy Tejashwi Yadav, who remained conspicuous by his absence.

The attendees included senior BJP leader and Union minister Ashwini Kumar Choubey, who is the local MP. Choubey declined to comment on the ongoing upheaval.

tend a meeting, also kept cards close to the chest, but blamed the Congress for the imminent "break up" of Nitish Kumar with the opposition INDIA bloc, of which he was seen as the veritable architect.

Leaders of the RJD also gathered at the residence of national vice-president and former chief minister Rabri Devi, who shares her government bungalow with Tejashwi Yadav, her son, and husband Lalu Prasad, who is the

party president.

All party leaders were made to deposit their mobile phones outside the gates of 10, Circular Road, the house situated at a stone's throw from the chief minister's residence.

Sources claiming to be in the know of things said the deliberations were about the course of action to be followed in the event of Kumar calling off the alliance.

While some RJD leaders are said to be in favour of staking claim to form the new government, hoping to cobble-up support of eight MLAs the 'Mahagathbandhan' requires to go past the majority mark, others, including Tejashwi Yadav, appear to be not impressed with the idea since the JD(U) and the BJP together have more than 122 members in the 243-strong assembly.

Northern Railways Set **For Drone Survey**

'District Admin grants conditional permission for survey, Rail line to come up on 33.7 kms between Sopore to Kupwara'

KUPWARA: In a major feat for the northern district of Kupwara, the border district will get connected with the rail line as the Northern Railways is set for a drone survey after a go ahead by the district administration.

Officials told news agency, that the permission for con-ducting Drone Survey for FSL work of New Rail Line between Sopore to Kupwara has been granted which aims to facilitate the connection of the border district Kupwara through the railway network.

The railway alignment from Sopore to Kupwara spans 33.7 kms and the survey is anticipated to yield crucial insights and data for a project of great importance, contributing to the enhancement of transportation infrastructure in the region, the officials said.

However, the permission is subject to specific conditions designed to ensure the safety and security of the area.

According to an official communique accessed by KNO, Northern Railways is required to cooperate with local police, PMF and sister agencies, assuming personal responsibility in case of any eventuality.

The further conditions for the NRs include that they will cooperate with the local police/ PMF and other sister agencies and in case of any eventuality they will be personally responsible. "That they will report at the concerned police station police posts before their travel, journey in the said areas. That they will not cause obstruction in free flow traffic," the permission read, adding that "there shall not be annoyance to the general public/educational institutes/religious places and important establishother ments. That they will not use drones near LoC and sensitive areas.'

The permission issued by the DC Kupwara also stated that the organisers of the survey should follow the guidelines issued by the Supreme Court or any other court of competence. "That the photographer should use drone during day time i.e.

MELBOURNE: Rohan Bopanna became only the third Indian to win a men's doubles Grand Slam title, taking the Australian Open crown with partner Matthew Ebden following a commanding win over Simone Bolelli and Andrea Vavassori, here on Saturday.

In a high-quality game of tennis, second seeded Bopanna and Ebden won 7-6(0) 7-5 against the Italian team in the final that lasted one hour and 39 minutes.

Only the iconic Leander Paes and Mahesh Bhupathi have won Major titles for India in men's tennis while trailblazer Sania Mirza did it in women's tennis.

For Bopanna it is his second Grand Slam title, having won the French Open mixed doubles trophy with Canada's Gabriela Dabrowski in 2017.

At 43, Bopanna also became the oldest Grand Slam champion in men's tennis. He bettered the record of Jean-Julien Rojer who, at age of 40, had lifted the French Open men's doubles trophy in 2022 with Marcelo Arevola.

Bopanna was playing his third men's doubles final at Grand Slam events, having ended runner-up at US Open twice (2013, 2023).

India Sense Victory Despite Big Pope Hundred



Agencies HYDERABAD: England vicecaptain Ollie Pope produced an unbeaten 148 but India remained on course for victory in the opening test at the end of day three at Rajiv Gandhi International Stadium on Saturday. The tourists had risked a defeat inside three days after India, having built a lead of 190, reduced England to 163-5 in their second innings in the second session

of the day. But Pope dug his heels in, hitting 17 fours in a 274-minute masterclass to produce arguably his finest knock even though India are confident of going 1-0 up in the fivematch series. Rehan Ahmed was keeping Pope company on 16 with England finishing the third day on 316-6, putting them 126 ahead with

four wickets in hand. India, who have not lost a test series on home soil since 2012, amassed 436 in their reply to England's first innings 246. That left England with a mountain to climb and the touring batters did not retreat into any defensive shell.

Openers Zak Crawley (31) and Ben Duckett (47) scored freely, frequently employing the sweep shot -- both traditional and reverse -- to negate India's spinners. Crawley motored along at a run-a-ball rate but could not convert the start and edged a Ravichandran Ashwin ball to lone slip Rohit Sharma.

Duckett, then on 39, was lucky when Jasprit Bumrah's lbw appeal was turned down and India did not review that decision. Replays confirmed the ball would have hit the leg stump. Not that it mattered in his next over, Bumrah uprooted Duckett's off-stump and let out a roar.

The ball had started revers-

ing and Bumrah was looking particularly threatening. A length ball from him rapped Root on his front pad and the batter challenged the lbw decision against him but could not get it overturned. Root, who excelled as a parttime spinner claiming 4-79, walked away for two.

Ravindra Jadeja foxed Johnny Bairstow (10) by first spinning one past the bat and then following it with a delivery that pitched on the same spot but went straight. Bairstow, expecting it to turn, did not offer any shot and looked in horror as the ball went on to disturb his stumps.

Ashwin dismissed Ben Stokes for the 12th time in tests, for six, with a flighted delivery that beat the pad and hit the off-stump. Pope, dropped on 110 by Axar Patel, combined with Ben Foakes in a century stand for the sixth wicket.



Man United Won't Sign Striker Due To FFP: Ten Hag

Manchester United have no scope to sign a striker in the January transfer window due to financial fair play (FFP) restrictions, manager Erik ten Hag said on Friday. United, who visit Newport County in the FA Cup fourth round on Sunday, lost forward Anthony Martial until April due to injury, leaving them with limited options in attack. Forward Rasmus Hojlund, who

was signed for 72 million pounds (\$91.47 million) in the close season, has only scored two goals in the Premier League so far, while Marcus Rashford has four.

"I looked but there is no space. There is no space for FFP to do something about this lack of quantity in the striker position," Ten Hag told reporters. "Of course, Rashford can play as a striker. We have some other alternatives but it's clear that Anthony is out for a couple of months and it's a gap in our squad."

The club signed midfielder Mason Mount and goalkeeper Andre Onana for big money in the close season and have spent more than 400 million pounds in the last two seasons. Midfielder Casemiro and defenders Luke Shaw and Lisandro Martinez are available for Sunday, however, and goalkeeper Altay Bayindir will make his debut in the absence of Onana, who is away at Africa Cup of Nations.
