Snow Relief To Continue: IMD Forecasts Heavy Snowfall On January 30-31

Srinagar: For those looking forward to a snowy start to 2024 in Jammu & Kashmir, January was an even bigger disappointment compared to December 2023. 'Chillai kalan' – the 40-day-long period of bitter cold – also failed to deliver any precipitation. Lack of snow and rain left the residents freezing amid the dry cold spell, while the tourists turned back home in dismay from the snowless ski resorts.

And just as hope turned to hopelessness, a series of strong Western Disturbances, as if held back by some invisible force, began rushing in since the weekend. Fresh bouts of snow reportedly graced places like Gulmarg, Sonmarg, Gurez, Keran, Tangdhar, among others. In fact, tourists were seen frolicking in the snow at Gulmarg's ski resort on Sunday, January 28.

Now, two more successive systems will be impacting Northwest India from January 30 and February 3, respectively. According to the India Meteorological Department (IMD), these western disturbances will spark up to moderate, fairly widespread rainfall/



snowfall over Jammu & Kashmir, Ladakh, Gilgit, Baltistan, Muzaffarabad and Himachal Pradesh during the next seven days, until February 4.

Further, isolated heavy showers or snowfall (64.5 mm-115.5 mm) is also likely over Kashmir on Tuesday and Wednesday, January 30-31, and Himachal Pradesh on Wednesday, January 31.

A yellow watch, meaning 'be prepared', has been issued over these regions for the forecast period owing to the possibility of intense snowfall activity.

Roads in higher reaches and important passes, like the Sinthan Pass, Mughal Road, Sadhna and Razdan Pass and Zojila, have been temporarily closed off amid inclement weather. And travellers have been asked to plan their trips accordingly. The MeT department has also advised farmers to withhold irrigation and fertiliser application and drain out excess water from orchards and fields during this period.

As for the mercury levels, the cloud cover over the region has caused the night temperatures to soar across Kashmir. Srinagar witnessed | More on P6

RS Elections For 15 States On Feb 27

J&K's Seats Lying Vacant

Srinagar: The Election Commission of India on Monday announced that polls for 56 Rajya Sabha seats will be held on February 27.

According to the details available, the election for 56 seats will be held in 15 states.

The elections are being held as 50 incumbent RS members will conclude their term on April 2 while the remaining six members will retire on April 3.

The election for RS would be held in Andhra Pradesh, Bihar, Chhattisgarh, Gujarat, Haryana, Himachal Pradesh, Karnataka, Madhya Pradesh, Maharashtra, Telangana, Uttar Pradesh, Uttarakhand, West Bengal, Odisha, and Rajasthan.

Interestingly, Jammu and Kashmir continues to be unrepresented in Rajya Sabha for the second consecutive year as four members from the erstwhile state of Jammu and Kashmir had completed their term in February 2021.

Since then, the four RS seats of J&K lie vacant in the Parliament. "The union territory will continue to remain unrepresented in Rajya Sabha for some more time because elections to four vacant seats from Jammu and Kashmir are not possible as the union territory is without | More on P6

Says Education Sector Had Witnessed Stagnation For More Than Three Decades



CBI Conducts Searches In Delhi, Jammu

New Delhi: The CBI has conducted searches at eight locations in Delhi and Jammu in connection with alleged corruption in awarding of civil works worth Rs 2,200 crore of the Kiru Hydro Electric Power Project, officials said on Monday.

The searches were conducted recently at the premises of Rajiv Dahiya, Surender Kumar Gupta, Saurabh Gupta, Arun Kumar and Reshi Kumar Sharma, they said.

They are suspected to have converted bribe money into

white through money laundering, the officials said.

Satya Pal Malik, who was the governor of Jammu and Kashmir between August 23, 2018, and October 30, 2019, had claimed that he was offered a Rs 300-crore bribe for clearing two files, including one pertaining to the project.

"The case was registered on allegations of malpractices in award of a contract worth approximately Rs 2,200 crore of civil works of Kiru Hydro Electric Power Project (HEP) to a private company in the year 2019," the More on P6

Expedition Of Hydro Electric Project In J&K Govt Diverts Chenab River Water

New Delhi: The government on Monday announced diversion of Chenab river water through diversion tunnels at Drabshalla in Kishtwar district to expedite the 850-MW Ratle Hydro Electric Project in Jammu & Kashmir.

"A major milestone has been achieved at the 850 MW Ratle Hydro Electric Project in Jammu & Kashmir with the diversion of Chenab river through diversion tunnels at Drabshalla in Kishtwar district, at 11.30 AM on January 27, 2024," the power ministry said in a statement.

The diversion of river flow

will enable isolation of dam area, paving way for the excavation

and construction works, it said.

The move will expedite construction activities and help in minimising delays so as to facilitate all efforts to meet the scheduled commissioning deadline of May 2026, the ministry said.

Ratle Project is being executed by Ratle Hydroelectric Power Corporation Limited (RHPCL), a joint venture of NHPC Limited and the government of J&K, with shareholding of 51:49 per cent, respectively.

14 HA Of Land Encroached In Jammu's Wildlife Sanctuaries

Srinagar: Nearly 14 hectares of forest land from two wildlife sanctuaries in Jammu region have been encroached by different individuals, groups and agencies till 2023.

According to the official figures at least 6.35 hectares of forest land from Ramnagar and 7.50 hectares of forest land from Nandini wildlife sanctuaries have been encroached.

This information was revealed by the Public Information Officer (PIO) of the regional wildlife warden of the department in reply to the Right to Information (RTI) application filed by the activist M M Shuja.

The official record reveals

that there is a total of 3150

hectares of land in Ramnagar

wildlife sanctuary and 3334 in Nandini sanctuary respectively. The PIO in a reply said that the encroachments are prior to the notification of the areas as protected areas.

"However, the department has taken up the matter with the concerned revenue authorities for settlement of rights, so that further course of action can be initiated," it said.

On inquiring about the details of forest land which has been encroached, the PIO said that in 2012, under the government proposal, Four Lanning of National Highway in Ramnagar WLS was made in which 7.97 hectares of land was transferred.

Building Activity Without Permission 'Unauthorized': HC

Srinagar: The High Court of J&K and Ladakh on Monday said that if a building activity is undertaken regarding which there is no permission, it would constitute an "unauthorized building".

A bench of Justice
Sanjay Dhar made
the observation
while setting aside
an order with regard to a structure in
Srinagar's Hari Singh
High Street by Special
Tribunal which had held once
a building permission has been
issued and is valid even if the
building is raised in contravention of the building permission, the same would not

qualify to be an unauthorized

building. The High court termed the reasoning by the Tribunal as "flawed".

"If we have a look at Byelaw No. 2.1.1, it defines "unauthorised building" as a building undertaken after a building permit has lapsed or after a building permit

has been revoked,"
the court said, adding, "What byelaw
No. 2.1.1 conveys is
that unauthorized
building is a building
which is undertaken
without grant of per-

mission, meaning thereby if a building activity is undertaken regarding which there is no permission, it would constitute an unauthorized building."

Srinagar: About 2.40 lakh consumers including Domestic, Commercial, Industrial, Agriculture and Government Department are registered with KPDCL in Srinagar District through a connected load of 674.88 MW, Deputy Commissioner (DC), Srinagar, Dr. Bilal Mohi-ud-Din Bhat was informed on Tuesday.

The DC during a review meeting on the progress on implementation of Revamped Distribution Sector Scheme (RDSS) in the District laid emphasis on reducing AT&C losses so that the expected revenue is generated and power supply is provided as per the expectations of the consumers

He urged to ensure that quality power supply is provided to consumers and also called for responsible behavior on part of both DISCOMS

and Consumers. The DC asked the Department to strengthen the IEC activities in order to develop good consumer behavior so that consumers themselves give up the means of consuming power by hooking etc.

At the outset, the Deputy Commissioner took a division wise review about the progress achieved under the RDSS and other measures to reduce AT&C losses (Target of 43% for 2023-24) and decreasing gap between ACS (Average Cost of Supply) and ARR(Average Revenue Realized)(target of Rs 1.8 per unit for 2023-24).

120-Bed B&J Hospital In Srinagar To Be Ready By Year End

Srinagar: The orthopedic treatment facilities in Kashmir are set to receive a big boost as a 120-bed block at Bone and Joint Hospital Barzulla Srinagar will be ready by the end of this financial year. The hospital suffered massive damage due to a fire in March 2022.

A top health official said the valley's largest orthopedic hospital is all set to get a big infrastructural push with the construction of the state-of-the-art additional 120-bedded hospital block. He said the block is being constructed under the component of Strengthening of the Critical Infrastructure of the World Bank-funded JTFRP (Jhelum Tawi Flood Recovery Project).

The work on the project began in 2019 and was approved in 2015. The hospital had suffered major damage in the 2014 floods, with one of its buildings declared unsafe. The infrastructure was damaged further due to a fire incident last year.

"The state-of-the-art building has a G+5 structure with modern earthquake-resilient technology. The hospital building has modular operation theatres, laminar flow system, TSSU (Theatre Sterile Supply Unit), ICU, Pre & Post Operation care wards, CSSD (Central Sterile Supply Department), specialized laundry, pneumatic tube system, and waste collection system," the official said.

He further said that the main features of the hospital building include IGBC (India Green Build-

The biomedical system designed will cater to the biomedical generation of 140 kg per day, which will be disposed of on scientific lines since it also has the provision for the construction of STP/ ETP (Sewerage Treatment Plant & Effluent Treatment Plant) as part of the sub-project," he said.

According to officials, it will be the first time in Jammu and Kashmir that a hospital building will have a pneumatic transit system in place.

They said that pneumatic tube systems, which are widely adopted in hospitals globally, facilitate the efficient transport of medical items such as blood samples and supplies between floors or departments. This, they said, minimizes costs and risks associated with manual handling

The work on the sub-project has been allotted to NPCC (National Projects Construction Corporation) at a cost of Rs 88.94 crores, the official said, adding that various modern concepts in healthcare infrastructure, including environmental designs, patient wellbeing, macro/micro level zoning scope for futuristic development, and optimal area utilization have also been taken into account.

'The design of the hospital has been finalized after several rounds of consultations with leading national health infrastructure experts, health department, and hospital administration, and their inputs have been incorporated into the final design," he added.

The official informed that the work on the main superstructure is almost complete, with finishing works in progress. "These include the installation of HVAC (Heating Ventilation & Air Condition ing), firefighting and other equipment," he said, adding that the hospital will be ready by the end of this financial year.

Doctors of the hospital said since the 2022 fire incident, they have been facing problems in catering to the huge rush of patients.

"But with the completion of the new building with modern facilities, the patients along with doctors will heave a sigh of relief," they said, adding that the OPD receives around 1000 patients on average, from different corners of Jammu & Kashmir and even Ladakh.

INDIA Alliance in crisis

he resignation of Nitish Kumar as Chief Minister of Bihar has sent shockwaves through the political landscape, particularly with the dissolution of the Mahagathbandhan, leaving the INDIA Alliance in disarray. Kumar's swift departure from the coalition, which he had joined less than 18 months ago, has not only marked a significant shift in Bihar's political dynamics but has also raised questions about the viability of a credible opposition against the BJP in the upcoming parliament polls.

Nitish Kumar's political journey, characterized by frequent shifts between alliances, reached a turning point as he resigned and returned to the BJP-led NDA. Ironically, he had played a key role in stitching together the opposition bloc INDIA. His collaboration with the RJD, led by his former arch-rival Lalu Prasad, in August 2022 was aimed at countering the BJP's influence in the region.

The unraveling of the INDIA Alliance comes at a crucial juncture when political opposition unity was seen as a key strategy to challenge the dominance of the BJP. Nitish Kumar's efforts to bring together diverse parties to form this bloc now face a setback, as the chief architect himself departs, leaving a void in the coalition. The alliance, which included various regional players, had hoped to present a formidable front against the BJP in the upcoming elections. Now it finds itself weakened and adrift

The impact of Kumar's resignation extends beyond Bihar, resonating at the national level. The INDIA Alliance now faces the challenge of regaining its footing and presenting a united front.

The BJP, seizing the opportunity, has formed a new government in Bihar with the support of Nitish Kumar's JD(U). The political landscape, once marked by a delicate balance of alliances, is now witnessing a significant realignment. The power dynamics in Bihar have undergone a transformation that could have far-reaching consequences on the national political scenario.

In the aftermath of Nitish Kumar's resignation, the INDIA Alliance must grapple with internal dissension, credibility challenges, and the urgent need to find a charismatic leader capable of rallying diverse parties. This seems easier said than done. Since its formation in the middle of last year, the INDIA Alliance has failed to get its act together. The alliance has so far been unable to conclude even the seat-sharing arrangement. Similarly, there has been little progress on formulating a cogent political narrative to combat the BJP's overriding Hindutva plank. The urgency for such a narrative can't be underestimated after the inauguration of Ram Mandir which has generated a groundswell in favour of the BJP. Time is running out fast.

Endless war

ne crash of a Russian plane with Ukrainian prisoners of war on board has once again shown how delicate the situation between the two countries that have been at war since February 2022 is. Russia says Kyiv downed the plane, which had 65 Ukrainian soldiers, in Belgorod, a Russian border town, that has seen repeated Ukrainian shelling in recent months. Kyiv has slammed Russia for spreading propaganda, but has not ruled out its possible role in the downing. The incident comes at a time when Ukraine's troops are struggling to keep up the fight on the front line amid Russia's incremental advances. Russia, which suffered humiliating setbacks in 2022, has since retaken the battlefield momentum. Last year, Ukraine's top general said the counteroffensive, which began in June 2023, aimed at recapturing Russia-held territories in the south and east, had failed. Russia has made territorial gains in the east, capturing Mariinka and making advances towards Avdiivka and Kupiansk. With its huge losses on the battlefield, Ukraine's generals are calling for the mobilisation of up to 5,00,000 soldiers — which would be hugely unpopular. Worse, the changing mood in Washington has sent an alarming message to Kyiv.

Volodymyr Zelensky's government has vowed to uncover the truth behind the plane crash. If it has been downed by a Ukrainian missile, it would pose a political challenge to Mr. Zelensky. But a bigger problem he is facing is the future of the war. Until now, he has put up a brave face, saying Ukraine would fight until victory — which is, recapturing all the territories Russia has taken. While Russia's annexation of Ukraine regions and its war are a violation of international laws, Ukraine does not seem to have a practical path towards victory. Israel's war on Gaza, which has the Biden administration's full support, has also distracted global attention from Ukraine. If Donald Trump, the U.S. Republican leader, is re-elected in November — he has vowed to end the war in days — Ukraine could come under heavy pressure. The war cannot be sustained without uninterrupted support from the U.S. and its NATO partners. When pressure increases on the battlefield, what Ukraine is doing is to carry out missile and drone attacks inside Russia. Ukraine's possession of advanced weapons, supplied by the West, has enhanced its fire power. Last week, a fuel export terminal on Russia's Baltic coast came under attack. There is suspicion, deep mistrust and misinformation on both sides, which could lead to more violence and accidents. Russia, Ukraine and NATO should take a more practical assessment of the progress of the war and be ready for talks, instead of continuing an endless war which is hurting all sides

Infosys co-founder Narayana Murthy's recent suggestion for "70-hours-work-a-week" among Indian youngsters will no doubt boost productivity, but it will certainly affect the balance of work-life approach, which is equally important. Unsurprisingly Mr. Murthy's comments have evoked a nationwide controversy, with many have criti-

cised his idea. In fact, a Bengalurubased Cardiologist wrote in his X (formerly Twitter) account saying, "such an inhumane working hours can create a whole generation with a host of heart-related comorbidities." The Cardiologist's comment gains prominence, as WHO says that India accounts for at least one-fifth of the 17.9 million cardiovascular disease-

related deaths globally, especially in the younger generation. Currently, India's labour codes mandate that workers put in 8-hours of work a day, capping the weekly work hours at 48. Despite this, global data shows that India ranks fifth in the world among countries with long working hours. Research has revealed that productivity falls sharply after 50 hours per week, and drops off a cliff after 55 hours. Rather than extended working hours, a streamlined approach with set working hours will work for large enterprises that have plentiful resources.

Why Random Memories Flash Into Our Heads

uring my 20-minute commute to work this morning, I passed a house with a purple glass gazing ball in the front vard and was suddenly transpor ed back to the tiny public library in the town I lived in when I was a little boy. In my mind's eye, I was sitting at a table near the circulation desk flipping through a large Tom and Jerry picture book—a favorite of my five-year-old self while the kindly librarian snacked on saltine crackers, wrapping her lips around them before biting in order to maintain a library-appropriate hush.

I puzzled over the inexplicable memory flash until I "saw" the page to which I was turned, where a mischievous Jerry hurls a large juicy plum at Tom's face. The plum in the picture was exactly the same distinctive shade of purple as the gazing ball, the sight of which had spontaneously triggered the memory.

As unexpected as that particular memory was at that particular moment, the experience of flashing on some random episode from the past during my daily commute was by no means unprecedented. I frequently experience such spontaneous memories while I'm on the road, finding them to be a source of passing interest and occasionally even enjoyment (depending on their content, of course), but thoughts about the work day ahead usually edge them out of my attention before I've given them any serious thought. A psychologist in the UK gave his commute-associated memories some serious thought, however, and even made them the subject of a study recently published in the journal Memory.

Involuntary Autobiographical Memories on the Morning Commute

Reflecting on the substantial body of research on "spontaneous cognitions" that has been conducted in recent decades, Andrew Laughland from the University of Hertfordshire, Hatfield, saw his daily commute to and from work as a possible source of data to fill in "several gaps" in the research on involuntary autobio-



graphical memories (IAMs). The most common source of

The most common source of prior research on IAMs has been the use of diaries, where participants manually recorded IAMs as they occurred, and Laughland noted that the rates reported in these studies seemed to be lower than those he personally experienced while driving. Reasonably assuming his experience to be fairly typical of the average person's, he hypothesized that the discrepancy was a result of the methods used to gather data in previous studies.

To test this hunch, Laughland designed an experiment in which his own car driving could be used as a "naturalistic activity" during which IAMs could be monitored via audio recording. Wearing a tie-clip microphone connected to a digital recorder, he recorded his entire 37-minute journey from the time he pulled out of his driveway—recording a sentence or two about what had happened immediately prior to leaving—to the moment he pulled into a parking space at the university.

This continuous audio recording format was designed to capture

"free-flowing thoughts" that would otherwise likely be forgotten by the journey's end. His experiment lasted a year and a half and included a total of twenty commutes.

The Frequency of IAMS in Everyday Life

At the conclusion of the experiment, Laughland discovered that he had, indeed, recorded more IAMs than had previously been reported.

Earlier studies in which participants used diaries to record IAMs reported rates of about two to five per day. Other studies using clickers to record the occurrence of IAMs without describing their content reported rates of between 22 per day and 10 per hour. Laughland's audio recordings of his daily commutes, on the other hand, produced IAMs at a rate of nearly one per minute, supporting his hypothesis that IAMs occur far more frequently in real life than formal research has suggested.

"Dynamic" vs. "Static" Cues of IAMs

In addition to allowing Laugh-

land to record IAMs at a greater frequency than in previous studies, the continuous audio recording method also allowed him to record them in far greater detail, providing some "novel and important" insights into the way involuntary autobiographical memories are triggered.

The first of these insights involved the types of cues that trigger involuntary memories. Laughland's recorded observations about what was going on around him as the memories popped into his head revealed that "dynamic" rather than "static" environmental cues are more likely to trigger IAMs.

In other words, new or unexpected details encountered on his trips (e.g. varying weather conditions, or songs on the radio) were far more likely to trigger memories than those details that were always present (e.g. buildings or road signs). This finding highlights the somewhat ironic role that novelty plays in triggering autobiographical memories in our daily lives, with new details in our environment eliciting old memories from our past.

Memory "Chains"

Another interesting finding of the study involved memory "chaining," in which memories are triggered by a preceding memory rather than by some other internal or external cue. Such memories can often be perceived as new occurrences, but Laughland's retrospective examination of his audio recordings revealed that many of the IAMs that he perceived to be independent had actually been cued by a prior memory (or memories).

In fact, as many as 23 percent of the IAMs he recorded were chained memories, suggesting that memory chaining is more common than has previously been reported.

IAM "Priming"

IAM "Priming"
Yet another insight provided by the study has to do with the "priming" of IAMs. Very often, an autobiographical memory will unexpectedly pop into our heads, seemingly out of nowhere. Laughland's review of his audio recordings, however, revealed that many of the spontaneous memories that he recorded dur-

ing his commutes were not, in fact, spontaneous at all, but had been triggered by cues that he had encountered several seconds or even minutes earlier.

At the moment, the time gap between the cue and the memory it triggered initially prevented him from perceiving a connection between the two events. But the recording revealed that the environmental stimulus had actually "primed" a memory or memories that he recalled later, seemingly out of the blue.

Laughland's study, and the novel method he employed to gather data, provides evidence that involuntary autobiographical memories are a far more regular occurrence in our daily lives than previous research has suggested. It also gives new insight into how these memories actually occur, indicating that far fewer of them are truly spontaneous than appear to be, getting triggered by cues in our environment rather than simply popping into our heads out of nowhere.

One general point that the study makes clear is what a good opportunity our daily commute offers for experiencing involuntary autobiographical memories. Research on IAMs and related phenomena has shown that "spontaneous thoughts and memories occur more often when people are engaged in undemanding, habitual activities" such as driving.

In other words, when not focused on some task that requires focused attention, our minds tend to wander—and as this study shows, it is very often our autobiographical pasts to which they wander. And if we pay attention to these mind-meanderings during our morning commute, instead of tuning to NPR or cueing up a podcast, we never know where they may take us.

Indeed, given the right environmental cue, they might just lead us back to a cozy little library from our childhood—a brief mental vacation in our distant past to prepare for the busy day in our immediate future.

Kupwara 1.7 degrees Celsius.
Gulmarg registered a low of minus

place in the valley that registered subzero night temperature.

the need for a balanced diet and emphasised the importance of regular exercise and physical activities for fitness.

He cautioned parents against treating their children's report cards as their own visiting card, while asserting that it is crucial to instill resilience in children to help them cope with pressures and parents and teachers should collectively address challenges faced by them.

The prime minister suggested that students should compete with themselves and not others and parents should never sow the seeds of competition and rivalry between siblings.

"It is crucial to instill resilience in our children and help them cope with pressures... We cannot just switch off and the pressure is gone. One must become capable of bearing any kind of pressure. They should believe that pressure keeps on building and one has to prepare oneself," he said during the two-hour interaction.

Prime Minister Modi suggested students to "always make friends who are more intelligent and work harder". "You must be inspired by such friends. Don't let the pressure of studies and examinations overpower you," he said.

Modi said that even though competition and challenges act as inspirations, competition must be healthy.

"A lot of parents keep on giving examples of other children to their children. Parents should avoid doing these things... never sow the seeds of rivalry and competition among students," he said.

"We have also seen that those parents who have not been very successful in their lives have nothing to say or want to tell the world about their successes and achievements, make the report card of their children their visiting card.

"Whenever they meet someone, they will tell them the story of their children," he said at the seventh episode of his outreach programme with students ahead of examinations.

The prime minister explained that the stress faced by students is of three types - induced by peer pressure, by parents and self-induced.

"At times, children take pressure on themselves that they are not performing up to the mark. I suggest that you should set small goals during preparation and gradually improve your performance, this way you will be completely ready before exams," he said.

"We have to make ourselves capable of facing any sort of pressure. Students need to make themselves ready to go through any condition. If we visit any cold place, we make up our minds, and accordingly, we keep ourselves ready... (in the) same way you have to be ready for exams," Modi said.

The prime minister said that the challenges faced by students must be addressed collectively by parents and teachers. He also encouraged teachers to forge strong connections with their students.

"The bond between educators and learners is the foundation for a bright future. If teachers start working on building a relationship with their students from the first day of the year, there won't be any question of tension building up among students at the time of examinations," he said.

"Teachers must expand their connections with students much beyond their subject syllabus so that students can reach out to their teachers even for the smallest of problems. Music teachers can not only help their own students deal with tensions, they can do so for students of the entire school," Modi said.

Replying to questions on balancing studies with a healthy life, Prime Minister Modi said many students use mobile phones and some do it for many hours. He advised students not to use their sleep time for watching reels.

"I get into deep sleep within 30 seconds of lying on the bed on all 365 days. When I am awake, I am fully awake, but I am totally asleep while

sleeping. Nutrition is also necessary. Our body must get the required nutrition. A good balance of food and regular exercise for fitness are also necessary," Modi said.

"They should understand that even mobiles need recharge to be used, and similarly, our body also needs to be recharged. On the other hand, some students keep playing all the time, but it is necessary to strike a balance. A healthy body is necessary for a healthy mind. Good and sound sleep is also a must for good health. Don't use your sleep time for watching reels," he said.

Emphasising the need to avoid mistakes due to the over-enthusiasm of parents or over-sincerity of the students, the PM asked the parents not to over-hype the exam day by new clothes, rituals or stationery.

He also asked the students not to keep preparing until the last moment and approach exams with a relaxed mindset.

The prime minister suggested that students read the question paper and plan with time allocation to avoid panic at the last moment. Modi also advised students to practice writing.

"In this age of mobile phones and laptops, students are losing the practice to write while exams are supposed to be handwritten. Of the time dedicated to studies, you should devote at least 50 per cent of time to practise writing with pen and paper" he said.

Asked how he keeps a positive mindset amid the challenges of his job, Modi said it is in his nature to "challenge every challenge" and asserted that he looked for a way to deal with poverty in the country instead of just sitting on the issue like others.

Describing students as the shapers of India's future, Modi said the Pariksha Pe Charcha programme is like an examination for him too. He also said that students have become more innovative than ever.

Many students whom Kashmir Observer spoke expressed their satisfaction over the programme and urged the government to start such initiatives in every school, college and university.

"In Kashmir, parents often subject their children to pressure, pushing them to achieve higher scores in annual examinations compared to their neighbors' children. This, in turn, leads to increased stress for the children" said Mohammad Rasib, a student of NIT, srinagar.

Rasib said the government should ensure such programs are happening in every nook and corner of the country.

Another student, Aehsan-ul-Haq, a resident of North Kashmir's Bandipora district said that he watches the programme on YouTube every year and also shows it to his parents.

"The idea is to sensitize them about the mental health of their kids if put under pressure," he said.

Tariq Ahmad, a teacher from Srinagar said that they empathize with the mental stress students experience but express their inability to guide students in overcoming the "phobia of needing higher grades."

"The student comes with this mentality from home. The parents need to understand it but yes the government should also have a holistic policy to help the students to carry on their studies without any competition," he added.

an example, saying if there is a building permission for raising a three storeyed building and the person concerned constructs an additional fourth floor, the additional 4th floor would constitute "unauthorized building".

"Any deviation from the building permission would always constitute an unauthorized construction," the court said, adding, "The Tribunal by adopting flawed reasoning which is against the logic and common sense has termed the "unauthorized construction" of the private respondents (owners of the building at HSHS) as authorized one and thereafter set aside the sealing order (by SMC)."

The ground on which the Tribunal

has quashed the order of sealing is absolutely "perverse and liable to be set aside."

Subsequently, the court disposed of the petitions by giving liberty to the owners of the building at HSHS to approach the Commissioner, Srinagar Municipal Corporation with a petition for compounding of the deviations. "If and when such a petition is made by the private respondents before the Commissioner, the same shall be considered by the said authority in the light of the building permission granted in favour of the private respondents, the relevant building byelaws, the zonal plan and all other relevant statutes and guidelines on the subject," the court said, adding, "The offending portion of the building constructed by the private respondents shall be sealed by the petitioner corporation (SMC) till such time a decision is taken by the Commissioner, Srinagar Municipal Corporation with regard to the question of compounding of deviations.'

In case the deviations are not compounded or regularized by the Commissioner, the court said, the private respondents shall ensure that the offending portion of the building is demolished or, in the alternative, the SMC shall undertake demolition of the offending portion in accordance with law.

Govt Allocates Rs 94 Cr. To Enhance Air Quality In **Srinagar And Jammu**

CS takes stock of measures to improve air quality in JK cities

JAMMU: In the UT Apex Committee meeting of National Clean Air Programme (NCAP), Chief Secretary, Atal Dulloo on Monday took stock of all the measures taken to improve the overall quality of air in the twin cities of Jammu and Srinagar here.

The meeting was attended by ACS, Forest Department; Divisional Commissioner Kashmir/Jammu; PCCF; Secretary Transport; Commissioner SMC/JMC besides other concerned officers.

During this meeting the Chief Secretary impressed upon the concerned city administrations to take all the measures to improve the air quality in our cities as envisaged under this national programme.

He asked them to show more commitment toward this significant matter and ensure that the targets set for the two cities are met without fail.

Dulloo further took note of the expenditure made till date under this national programme and the works carried out to make quality of air better here. He stressed on making strenuous efforts to complete all the ongoing works

within this financial year. He also directed for accelerating the pace of tendering and other preliminary processes to execute other projects taken up under this programme.

The Chief Secretary maintained that clean air is one of the basic parameters of determining quality lifestyle in urban areas. He observed that



ways are going to have a great impact on our health and prosperity. He called for coordinated efforts to implement this programme here in letter and spirit.

It was given out by the ACS, Forests, Dheeraj Gupta that the National Clean Air Programme is a comprehensive time bound action programme launched by MoEFCC, Govt of India in January 2019 with an objective to improve air Quality especially for Non-attainment Cities.

He said that a baseline has been given for each identified city and Target set to be achieved for the concerned city administration to improve the air quality there. He further made out that 124 NACs(132 NACs as on now) have been identified in the country for the coverage in this program on the basis of non-conforming to National Ambient Air Quality Standards (NAAQS) for 5 consecutive years.

The meeting was also apprised that funds to the tune of Rs 94.60 Cr have been received by the Municipal bodies of twin cities for making meaningful intervention in this regard. It was said that 19 Air Quality Monitoring-Manual Air Quality Monitoring Stations have been set up in Jammu and Srinagar for providing the real time updates.

Moreover the data for the air quality of 19 different parameters monitored by the CAAQMS installed at Rajbagh Srinagar is displayed on the screen for information of the general public. India Fifth In World Test C'ship Rankings

DUBAI: India have dropped to fifth behind Bangladesh in the World Test Championship (WTC) standings after their shock 28-run defeat to England in the first Test in Hyderabad.

India were briefly on top after drawing the two Test series with South Africa before being overtaken by Australia following their victory over Pakistan. Rohit Sharma's men have suffered in terms of accumulated percentage points, going down from 54.16 after the South Africa series to 43.33 currently.

The rare defeat at home took Rohit Sharma's side down to fifth spot in the latest WTC rankings with 55 percentage points.

Australia's sensational eight-run defeat to the West Indies in Brisbane on Sunday did not have much impact on them as they continued to lead the WTC rankings.

South Africa, New Zealand and Bangladesh-all with 50 percentage points-are at second, third and fourth spots, respectively. Below India are Pakistan, West Indies,

England and Sri Lanka.
