# Households Will Save Up To 18K Annually Under Rooftop Solar Scheme: FM

1 Cr Families To Get 300 Units Of Free Electricity Every Month

#### **Press Trust Of India**

New Delhi: Finance Minister Nirmala Sitharaman on Thursday said Pradhanmantri Suryodaya Yojana will enable one crore families to get up to 300 units of free electricity every month and help them save up to Rs 18,000 annually. Prime Minister Narendra Modi had announced the 'Pradhanmantri Suryodaya Yojana' with the target of installing rooftop solar earlier in January. "I have taken my first decision after returning from Ayodhya that our government will launch 'Pradhan Mantri Suryoday Yojna' with the aim to install rooftop solar systems in one crore houses," Modi had said on X.

Sitharaman in her interim Budget speech said through rooftop solarisation, one crore households will be enabled to obtain up to 300 units of free electricity each month.

Srinagar: Jammu and Kashmir has been allocated Rs 37,277.74 crore in the interim union budget for 2024- 25, which was unveiled by Union Finance Minister Nirmala Sitharaman in the Lok Sabha on Thursday

According to details, Rs 37277. 74 crores have been allocated to J&K for the next fiscal year.

Of this, Rs 35,619.30 crore alone have been kept for bridging resource gap in the Union Territory. Rs 279 crore have been allocated to the Union Territory Disaster

Response Fund. The UT Disaster Response Fund would be utilized to meet the expenditure on account of mitigation of disasters caused due

Rs 130 crore and Rs 476. 44 crore and Rs 171.23 crore grants have been respectively allocated to equity contribution for 624 MW Kiru, 800 MW Ratle and 540 Kawar hydroelectric power projects.

In the budget, Rs 500 crore have been earmarked for Jhelum-Tawi Flood Recovery Project, whose deadline for completion was recently extended by the World Bank by one more year. | More on P6

# **Drug Addiction On Decline In Srinagar As 'Heroin' Prices Rise**

Srinagar: The number of drug addicts in Srinagar has declined due to a drop in the availability of "Heroin," a highly addictive opioid substance derived from morphine that majority of substance abusers snort and inject in this summer capital, health experts claimed.

Another factor influencing the decline in substance abuse amongst youngsters in the summer capital, they claimed, is strict monitoring of identified drug hotspots and the crackdown against the drug peddlers.

Intravenous (IV) drugs are the drugs of choice for the majority of substance abusers in Srinagar, after the priciest but most lethal substance known as 'heroin', price of which has doubled in the last one year.

Besides, they linked the decrease in the number of drug addict's and admissions at drug de-addiction facilities to the ongoing district-wide awareness initiatives, indicating the administration's commitment to combat the threat.

### **186 Drug Peddlers Arrested** In Srinagar In 2023

Srinagar: Two of the 186 people who were arrested in connection with illicit drug trafficking have been charged under the stringent Public Safety Act (PSA), and 16 more under the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act 1988 (PIT NDPS) in Srinagar.

Official data revealed that 107

Yasir Hassan Rather said that 728 patients were admitted to the facility in 2023—which is more than 50 percent of the total patients admitted there in 2022.

"The number of drug addicts in Srinagar is declining, and the district's decreased heroin supply is to be credited for the dip. The majority of substance abusers consume heroin in Srinagar, which has a gram cost of Rs 6000," Dr Yasir told Kashmir Observer.

Dr Yasir said the drug-abusing

cases of illicit drug trafficking have been registered by the police in the summer capital since January 2023 till date.

A senior police official said that a huge haul of contraband substances has also been recovered from those arrested in connection with drug peddling in Srinagar. A cash amount of Rupees 25 lakh has also been recovered from the drug peddlers, he said.

"All the patients have received effective care, and the rate of recovery has also been satisfactory. It now relies on whether a person having received treatment will resume drug addiction or give it up. The environment in which we live also has an impact,' said Dr Yasir.

# Lonely Elders In A Digital World

ike elsewhere in the world, the elderly in Kashmir are becoming the victims of the migration of social interactions to virtual spaces. As recently reported by this paper, this has inadvertently left them struggling to navigate a world that seems foreign and impersonal. Recent studies have revealed an alarming reality: more than one-third of adults aged 45 and older feel lonely, and nearly one-fourth of adults aged 65 and older are considered socially isolated. The elderly in Kashmir, in particular, face a high prevalence of loneliness, that demands immediate attention.

Societal attitudes toward aging have played a significant role in exacerbating the isolation experienced by the elderly. Families, equipped with communications technology, unintentionally contribute to this problem by leaving their elderly members feeling isolated and irrelevant. The rapid advancements in society, coupled with a lack of preparedness to address the challenges faced by the elderly, have marginalized and alienated this vulnerable population. This echoes a broader concern for the overall well-being of society, as the consequences of loneliness can manifest in both mental and physical health issues.

Strengthening social infrastructure is crucial, involving the development of programs, policies, and structures that support healthy relationships. This includes initiatives to bridge the technological gap for the elderly, ensuring they can participate in the digital age without feeling excluded.

Elderly care homes are also a need of the hour. Last year, the Valley opened its first residential care homes for the elderly. The move, aimed at addressing the growing need for elderly care, was not without controversy. For generations, the prevailing cultural norm has been for the elderly to live with their children, surrounded by extended family support. However, the changing dynamics of modern life have prompted a shift in attitudes, giving rise to concerns about the potential erosion of traditional family values.

Renegotiating our relationship with technology is another vital aspect of the solution. Creating space in our lives without constant device engagement allows for more meaningful inperson interactions. The recommendation is particularly pertinent in the context of the elderly, who may feel left behind in an era dominated by screens and virtual communication.

Small acts of kindness, reaching out to neighbors, and fostering community engagement can go a long way in alleviating loneliness. This is especially relevant for the elderly, who may face barriers to social interaction due to physical limitations or unfamiliarity with technology.

To address the specific challenges faced by the elderly, there is a need for targeted interventions. Community outreach programs, local support networks, and initiatives that encourage intergenerational connections can help bridge the gap between the elderly and the rapidly evolving digital society.

### Interim budget makes no leaps, keeps a calm head

his is in contrast to the last interim budget for 2019-20 which saw the launch of the Pradhan Mantri Kisan Samman Nidhi (PM-Kisan) programme, delivering direct income support of Rs 6,000 per year to all farm households in the country. In fact, the scheme was implemented with retrospective effect from December 2018, thereby translating into a huge pre-election sop. Also, the tax liability on individuals with annual income of up to Rs 5 lakh was completely waived off, along with an increase in the standard deduction for salaried persons. This interim budget, by contrast, has not witnessed any increase in the PM-Kisan transfer — there was wide expectation of its going up to Rs 9,000 per year — or any tinkering with income tax rates or slabs. In short, it has been a simple vote-on-account exercise, seeking Parliament's approval for routine expenditures till the next full-fledged budget is presented. The Modi government has not seen the need for any populist measures ahead of Lok Sabha polls in 2024, unlike in 2019, when it was perhaps more uncertain of the outcome, especially after losing assembly elections in three major Hindi heartland states. A POSITIVE offshoot of the apparent political confidence is the Modi government's renewed emphasis on fiscal consolidation. Not only has the Centre's gross fiscal deficit in the revised estimates for 2023-24 fallen below the budget target, both in absolute terms (from Rs 17,86,816 crore to Rs 17,34,773 crore) and relative to GDP (5.9 to 5.8 per cent), it is expected to decline even more sharply to 5.1 per cent in the coming fiscal year. More encouragingly, this is coming largely from a cut in the revenue deficit — from 3.9 per cent in 2022-23 to 2.8 per cent in the revised estimates (RE) for 2023-24, and to a budgeted 2 per cent in 2024-25. On the other hand, the Centre's capital expenditure, which rose by 28.4 per cent in 2023-24 (RE), is budgeted to grow further by 16.9 per cent in 2024-25. This focus on the quantum as well as quality of fiscal consolidation - redirecting spending away from subsidies and other current outlays towards asset-creating capital expenditure - is welcome. It is especially so, ahead of elections. # Is AI Paving the Way for Smarter Thinking?

n the 14 months since the launch of ChatGPT in November 2022, generative AI has been a hotly discussed topic, with many critics cautioning that AI has the potential to destroy critical thinking, education, and potentially even society as we know it. And it does. But it also doesn't. Ultimately, it is rare for the worst-case doomsday to come to pass, and typically, the consequences will land somewhere in the middle of the two extreme views.

At the World Economic Forum meeting in Davos, Switzerland, this month, a panel of experts and educational leaders took the alternative stance: that the advent of AI will enhance rather than destroy education, as long as we prepare ourselves to embrace the changes needed. Their point is that AI cannot do many of the things that humans do, be originally creative for example, and positively it can actually be employed to challenge thinking and make humans even better at natural human skills. Indeed, as the panel highlighted, AI is going to become ever more pervasive; it is essential to embrace it as a learning medium, to ensure continued educational relevance and capability.

How do we embrace education and critical thinking in the age of superintelligence? Humans are fallible. We have several psychological predispositions which make it easier for us to survive, but make it inherently more difficult for us to think critically. AI has no such qualms; given its algorithmic, process-based programming, its fallibility comes not in logical processing, but in how it is employed. If employed in the right way, it has the potential to counterbalance and combat human fallacy, while humans can counterbalance the AI fallacy in turn.

According to the Center for Countering Digital Hate, their report on AI found that it can be pushed to produce misinformation in 78 percent of inquiries if asked to do so. The key point is that it was asked to do so. Generative AI is reliant on data to produce a narrative, and it produces that narrative based on how it is queried. Employed positively, AI can be a useful tool; but employed by threat actors, there are, currently at least, ways to circumvent its safeguards and use it for nefarious means. There is much to be done to add guardrails, but in the medium term, if we can secure AI to utilise legitimate, verified data sources, and have correct oversight and safeguards to protect users, then there is the likelihood of using AI as a robust, beneficial resource.

AI shortcomings aside, the forum at Davos discussed a matured and safeguarded model of AI and looked at the positive use cases, for example in tackling climate change, or in enhancing education. The conclusion drawn by the education panel is that the future of teaching should focus on old-fashioned skills, including

Jeffrey Tarr, CEO at Skillsoft commented "How we teach is also changing at a dramatic pace." Meanwhile Hadi Partovi, CEO of Code.org. commented, "When it comes to



differentiating between true and false; having meaningful conversations; and thinking critically. It is here that AI has the opportunity to also enhance human education they argued, utilising it to challenge your thinking, and therefore bias, there are many biases, but these are things that we can help teach people to recognise. Even without AI, the internet has bias. When you Google, you are not always getting unbiased results. You are getting many different results fluent, and these are skills that are relevant pre-AI, but even more relevant in a world where we rely more and more on technology for education." Artificial intelligence systems

are not inherently good or bad, and when employed proac-

tively can be an innovative and interesting resource. The argument should perhaps focus not on AI specifically, but on how we need to adapt education to suit the modern era. AI is an inevitable part of that, so educators must focus on teaching the right skills, and enhancing human capability, to ensure it can harness the advantages and avoid the pitfalls of emerging and maturing tech. As Michael Spend, president and provost of University College London highlights, "There's things the machines can't do that we need to be really good at teaching our students.'

Considering the reality of generative AI in education, alongside other AI applications, it is interesting to ponder the potential for improving education. Critical thinking improves an individual's ability to differentiate between fact and fiction, true and false, information and mis- or disinformation. It is an essential life skill, and it is an imperative skill for inoculating your brain against nefarious threat actors. Indeed the World Economic Forum Global Risks Report 2024 highlights misinformation-disinformation as the biggest global risk for the next two years, falling to fifth for the decade only behind extreme weather and climate change events. The report states "perceptions of reality are likely to also become more polarized, infiltrating the public discourse on issues

ranging from public health to social justice. However, as truth is undermined, the risk of domestic propaganda and censorship will also rise in turn." Continued development of critical thinking skills is an essential means to withstand and undermine these challenges and will gain ever-increasing relevance in the modern world.

Returning to AI, it is interesting to consider how the technology can be employed to help safeguard societal norms and protect against global risk. Aside from the practical application of AI in identifying and removing propaganda, for example, AI can potentially be employed to educate and test skills in people. For example, humans are at risk from confirmation bias. truth bias, groupthink, and the illusory truth effect, any or all of which make us susceptible to believing what we read and hear, and to aligning our views to the views of those around us. AI can be more impartial, in theory, so there is the potential that it can be employed as an educator and counterbalance our psychological predispositions, encouraging debate, challenging thinking, supporting lateral reading, and even playing devil's advocate. It will be interesting to see the gains that can be made.

# 1500 Gujjar-Bakkarwal Out of School Students Enrolled In Govt Schools At Kishtwar Under "Back 2 School" Initiative

Kishtwar: Once grappling with a significant number of Out-of-School Children (OoSC), particularly from the Scheduled Tribe community, the success of the first phase of the Back to School initiative has played a pivotal role in elevating the literacy rate among the ST population in the district Kishtwar.

In 2021, a survey conducted by SAMAGRA Shiksha Jammu and Kashmir identified thousands of OoSC across J&K UT, including 2,469 OoSC in district Kishtwar, marking the highest number in the Jammu Division. This was a problem that demanded urgent attention by the authorities, The district administration in Kishtwar took proactive steps to bring back all the OoSC to school.

It is pertinent to mention that the term "Out of School Children" is a collective term encompassing dropouts, students who have left their education midway, and those who have never enrolled and never

experienced formal education. În December 2022, verification of 2469 Out-of-School Children (OoSC) in Kishtwar was conducted, revealing that approximately 1600 students in the age group of 6-14 years were not attending school. The Gujjar and Bakkarwal population were more susceptible to low enrollment due to relatively poor socio-economic conditions, migratory nature, dependence on livestock, and less emphasis on higher education because of early marriage etc. To enroll these students, the

Back to School initiative was launched. The first step involved convincing parents and galvanizing public opinion through Gram Sabhas presided over by senior officers, including the Deputy Commissioner Kishtwar, ADDC, ADC, SDMs, and Tehsildars.

A 3-month Bridge Course, initiated with the help of DIET Kishtwar in January 2023, prepared these students to join schools. Following the completion



of the Bridge Course, admissions for 1376 Out-of-School Students were done in various Government Schools, with 95 percent belonging to the ST Gujjar and Bakarwal population. Sustainability is crucial in such initiatives, and for this,

community support was mobilized. A Tribal Samaj Sudhar Committee, comprising Gujjar and Bakerwal volunteers, encouraged parents to re-enroll their kids in schools and monitored already enrolled students. Additionally, School

Committees Management were restructured in collaboration with the India Education Collective NGO. In these restructured committees, parents took on the role of Chairman and became active partners with the Education Department

for School Improvement. A visible result of these activated School Management Committees was the "My School My Pride" campaign, a bottom-up initiative culminating on January 26, Republic Day 2024. Parents in 50 percent of schools donated their money for Building as Learning Aid (BaLA) paintings, minor repairs, and kitchen gardens in respective schools. Well-performing SMCs were awarded during the Republic Day Ceremony 2024.

School Education The Department Kishtwar, led by CEO Kishtwar Prahlad Bhagat, played a proactive role and launched commendable incentives for Outof-School students, including additional Dhok seasonal centers, winter ST centers, stipends, and zonal level libraries in schools.

Overall, due to the Back to School initiative, major indicators in Kishtwar district have improved. The Gross Enrollment Ratio has jumped from 89% to

97.49%, while the dropout rate has decreased from 11% to 2.5 percent.

The total number of Out-of-School Students has been reduced from 1600 to only 57 in the district, with an improved transition rate of 98%. Since Gujjar and Bakerwal are nomadic groups, the number of seasonal units increased from 79 to 121 in 2023. Additionally, 80 new winter ST centers were opened, and a stipend of Rs 500 is provided to each ST student as an incentive.

In Back to School 2.0,additional 200 OoSC have been identified for enrollment in schoolsin January 2024 for 100 percent Saturation. The Back to School initiative is a success story that can be replicated in all backward and remote areas. It requires active participation and collective efforts from the district administration, education department, scheduled tribe community, and, most importantly, parents of outof-school children.

#### Ayodhya, she said.

Talking about the benefits, she informed the House that there will be "savings up to Rs 15,000-18,000 annually for households from free solar electricity and selling the surplus to the distribution companies.'

The scheme will also aid charging of electric vehicles; entrepreneurship opportunities for a large number of vendors for supply and installation and employment opportunities for the youth with technical skills in manufacturing, installation, and maintenance.

Talking about India's commitment for 'net-zero' by 2070, she announced a viability gap funding for harnessing offshore wind energy.

"Viability gap funding will be provided for harnessing offshore wind energy potential for initial capacity of 1 GW," she said.

According to the Central Electricity Authority data, India has a solar energy-installed generation capacity of over 73 GW.

Similarly, the data showed that wind energy capacity in the country stood around 45 GW while large hydro (over 25 MW capacity each) is 47 GW.

The biomass power/cogen capacity is about 10 GW and that of small hydro (up to 25 MW) is around 5 GW, while the waste-to-energy capacity stood at 583 MW.

India has set a target of having 500 GW of renewable energy by 2030 and has 50 per cent of installed power generation capacity from non-fossil fuel sources. President Droupadi Murmu on Wednesday said in her joint address to the Members of Parliament that in 10 vears, non-fossil fuel-based energy capacity has increased from 81 GW to 188 GW. "During this period, solar power capacity has increased 26 times. Similarly, wind power capacity has doubled. We are placed at fourth in the world in terms of renewable energy installed capacity. We are ranked fourth in wind power capacity. We are at fifth position in solar power capacity," she said.

"Coming to 2024-25, the total receipts other than borrowings and the total expenditure are estimated at Rs 30.80 lakh crore and Rs 47.66 lakh crore, respectively. The tax receipts are estimated at Rs 26.02 lakh crore," she said.

income-tax-related cases through this initiative, where the taxpayer only needs to pay the disputed tax to settle the matter.

This means the taxpayer is only required to pay disputed the disputed tax amount, without interest and penalty. Anyone facing a tax demand can pay the tax liability raised to settle the matter. The Income-tax department will pass a conclusive order when payment is made and the matter is settled. The immunity from interest and penalty in a disputed case is a notable benefit.

To alleviate the burden of such issues, the finance minister announced the relief.

day harsh winter period, when the chances of snowfall are maximum and most frequent -- remaining dry. While some areas in the higher

reaches had received light snowfall, most of the upper reaches experienced moderate snowfall at the fagend of the Chilla-i-Kalan.

The snowfall at the end of Chilla-i-Kalan brought cheers to the tourists as well as the locals associated with the tourism sector.

Thursday's snowfall shut down the Srinagar-Jammu national highway as it was blocked due to shooting stones between Ramsoo and Banihal. The alternate Mughal road and the Srinagar-Leh highway are closed for traffic due to snow accumulation.

However, the snowfall brought cheer to the residents.

"Finally, there is snow in the plains of Kashmir. We thank God for this blessing," Mehraj Ahmad, a resident of

the city here, said. He expressed hope that the coming days will see more snowfall in the

vallev. Irfan Ahmad, a resident of Ganderbal, said while the snowfall was the need of the hour for the valley as it was essential for sustenance.

"We witnessed prolonged dry weather. Our glaciers have melted, there was hardly any snow left on the mountains before the recent snowfall. Snow is really important for our sustenance. Without it, our water resources would have dried up, it could have hit our

horticulture especially fruit produce, and the dry spell resulted in many respiratory ailments. So, it is essential we have a good snowfall," he said.

The valley's orchardists also expressed happiness over the snowfall.

"We thank God as the long wait is finally over and it is snowing across Kashmir. The snow is very beneficial for the farmers and orchardists. People in Kashmir were under distress because there was no snow in the plains which could have meant doom for the horticulture produce.

"However, the snowfall now has infused a new life into it and we hope there is more snow in the days to come," a farmer in Kulgam said.

The MeT Office has said the weather would remain cloudy with light snow at few places till the afternoon and there would be a gradual improvement thereafter.

On Friday, the weather is likely to remain dry with a possibility of very light snow at isolated higher reaches.

There is a possibility of light to moderate snow/rain (in Jammu) at many places of J-K on February 3-4, and the weather is likely to remain dry thereafter till February 12, the weather office said.

Srinagar city recorded a minimum temperature of 0.2 degrees Celsius --down from 2.2 degrees Celsius on the previous night.

Pahalgam recorded a minimum temperature of minus 4.1 degrees Celsius, Qazigund minus 0.4 degrees Celsius, Kokernag minus 1.4 degrees Celsius and Kupwara minus 0.7 degrees Celsius.

Gulmarg registered a low of minus 7.6 degrees Celsius and was the coldest place in the valley.

tax returns has been reduced from 93 days in FY14 to 10 days; and refunds have been made faster, she said.

The government continues to be on the path of fiscal consolidation to reduce fiscal deficit to 4.5 pc in 2025-26. She added that the tax base of Goods and Services Tax (GST) has more than doubled since FY14.

Finance Minister Nirmala Sitharaman also announced a significant relief for taxpayers involved in tax disputes. She said that a considerable number of disputed cases are pending, and some even dates back to 1962.

To remove the "anxiety of honest taxpayers", Sitharaman proposed to withdraw outstanding tax demands up to Rs 25,000 in disputed cases pertaining to the financial year 2009-10 and up to Rs 10,000 from FY2010-11 to FY2014-15. She said it will benefit about a crore tax-payers and will help reduce the backlog of disputed tax cases significantly.

Disputed tax is the income tax (including surcharge and cess) payable by the taxpayer in a financial or assessment year, as demanded by the tax department under the Income-tax Act, 1961. In 2020, the government launched the tax dispute resolution scheme "Vivad Se Vishwas 2020" in an effort to address the pending

villages and cities, and the government is now aiming to build 2 crore more.

The rooftop solar programme will enable 1 crore families to not only get free electricity but earn an additional

15,000 to 20,000 a year by selling the surplus power to the government, he added.

# **Div Com reviews post-snowfall situation in Kashmir**

#### **CIRCULAR**



Drug abuse continues to be an area of serious concern for all of us, as it has far reaching socio-medical & economic consequences. Addiction to Drugs not only affects the individuals involved but also disrupts the family & society. The role of drug regulatory agencies is to protect & promote public health. In our endeavor to achieve this objective we are under obligation to protect end-users against ineffective or harmful drugs.

The Policy of the Government has to be broadly based on promotion

of use of such substances for medical and scientific purposes while preventing their diversion from licit sources and prohibiting illicit traffic and abuse. It has been observed in the recent times that since the legal channels of distribution have been regulated through a strict enforcement, the availability of such medicinal preparation through unregulated channels continues to pose a serious challenge to the public machinery empowered to take cognizance of violations related to such offences.

The Government of UT of J&K has issued administrative directions to curb the menace of drug abuse vide minutes of meeting issued bearing endorsement No. CHQ/NCORD/14/21717-29 dated 24.11.2023. As a matter of abundant precaution, it has been made compulsory for retail pharmacies to install CCTV cameras and to adopt computerized billing system in their pharmacies.

All licensing authorities and inspecting officers have been impressed upon to include below provisions in the existing checklist before grant of license(s) for retail / wholesale as also for subsequent renewals:

Mandatory installation of Full HD CCTV cameras with 1080p resolution and having adequate 1. data storage capacity for at least 6 months within the respective premises.

All records of purchase and sale shall be maintained in a computerized manner ( obtain invoices of computer & Printer at the time of grant / renewal of licence).

It requires to be ensured that sale of drugs is carried out strictly against the prescriptions of a Registered Medical Practitioner and all the legal provisions mandated under the Drugs & Cosmetics Act, 1940 and Rules there under read with IPC 188 are adhered to in letter and spirit.

# Hurt India Look To Rebound In 2nd Test Vs England

VISAKHAPATNAM: An underpressure and under-resourced India will need to think out of the box to counter England's fearless bunch of 'Bazballers' in the second Test beginning here on Friday.

India are seldom stretched at home but following a dramatic loss in Hyderabad, they have plenty to ponder and the absence of injured Ravindra Jadeja and K L Rahul has made their task tougher.

Three years ago, the mighty hosts found themselves in a similar situation having lost the opening Test to England at Chennai but bounced back to win the series.

However, the Joe Root-led side was a different breed then and this time India plan to fightback against a team that has redefined the way Test cricket is played and defied all probability to win the series opener after conceding a 190run lead on a turning track.

England batters, led by Ollie Pope, swept and reverse swept their way to success in the first Test, taking Rohit and his bunch by surprise, while making the most potent spin trio in the world look ordinary.

India won't have the luxury of fielding Jadeja in this game

but Ashwin, four shy of the 500-wicket milestone in Tests, and Axar will need to redraw their plans to come back hard at their uber-aggressive opponents who are sure to employ the sweeping tactics irrespective of the conditions.

#### JADEJA, SHAMI SET TO MISS **REMAINDER OF TEST SERIES**

India all-rounder Ravindra Jadeja will need more time to recover from his hamstring injury and along with pacer Mohammed Shami could miss the remainder of the five-match Test series against England.

Jadeja, who pulled his hamstring following his run-out during India's fourth-innings chase in the series opener in Hyderabad, was initially ruled out of the second Test beginning here from Friday.

Jadeja returned with figures of 3/88 and 2/131 and also scored 87 and 2 in the first Test that India lost by 28 runs.

A hamstring injury normally takes at least four weeks to heal and it is likely that Jadeja could be ruled out of the entire series. The final Test of the series is in Dharamsala from March 7-11.

Pacer Shami, sidelined with an injury after a sterling show in last year's ODI World Cup in India, has gone to England to take special injections for

his left ankle problem and also consult a surgeon. He was initially not consid-

ered for the first two Tests, but it is now learnt that he could be ruled out of the entire series. India will also miss KL Rahul

# Lewis Hamilton Set For Shock Switch To Ferrari In 2025: Reports

LONDON: times Seven Formula One world champion Lewis Hamilton is set for a shock switch from Mercedes to Ferrari in 2025 as replacement for Spanish driver Carlos Sainz, according to multiple media reports on Thursday. Mercedes and Ferrari declined to comment on speculation that would be by far the most sensational driver move of the so-called 'silly season'.

Sky Sports television said it understood Mercedes principal Toto Wolff would brief the team before a formal announcement later on Thursday. Hamilton, 39, has been with Mercedes since 2013 and won his first title with McLaren in 2008. His current contract is due to expire at the end of next year and a move to Ferrari would surely extend that into the sport's new engine era in 2026.

The Briton has been linked with Maranello repeatedly during his career, particularly when his contract has been up for renewal, but he signed a

## **Inter Aim To Take Command In Derby** d'Italia Clash With Juventus

MILAN: This weekend's Derby d'Italia may not decide who wins the Serie A title, but defeat for Juventus would put Inter Milan firmly in the driving seat. The top two meet at the San Siro on Sunday, with Inter just one point ahead in the standings, but they do have a game in hand and a win over Juve would give them a healthy advantage at this stage of the season.

Juventus slipped up last weekend with a 1-1 draw at home to struggling Empoli, which allowed Inter take back top spot after their 1-0 win away to Fiorentina. When the sides met in November, Dusan Vlahovic and Lautaro Martinez were the scorers in the 1-1 draw, and the two strikers come into this game in top form, with both finding the target last weekend.

Vlahovic has six goals in the last four league games for Juventus, with 12 Serie A goals this season, while Martinez has six in his last five in Serie A, and the Inter forward leads the scoring charts with 19 goals in his 19 games. Inter's goal threat is much greater, scoring 50 in the



league compared to 36 for Juventus. Forward Marcus Thuram has eight goals, with midfielder Hakan Calhanoglu netting nine times, and he returns for this one after missing the Florence trip through suspension.

Federico Chiesa has been struggling with injuries of late. and missed four of Juve's last six league games, but his return to training this week means he is likely to at least take his place on the bench, but Arkadiusz Milik is suspended. Back in September, Juventus lost at Sassuolo and four days later Inter were defeated at home by the same side, and since then both clubs have gone undefeated in the league. A second defeat for either team on Sunday won't put an end to any title hopes just yet, but a loss could prove much more costly for Juventus. AC Milan's four-game winning run came to an end last weekend in a 2-2 draw with Bologna, leaving them eight points behind Inter, and they travel to face Frosinone on Saturday.

Defending champions Napoli are out of the title race this season, down in ninth place, and they host relegation battling Hellas Verona on Sunday. Napoli are still in the battle for fourth place, a fight which involves at least five other clubs. Atalanta took over fourth spot last weekend and on Sunday they welcome a Lazio side who are unbeaten in five and are two points behind in sixth.
