Kashmir Welcomes Snow Once More With Fresh Flurries

Srinagar: Several parts of Kashmir, including Srinagar city, witnessed fresh snowfall on Saturday as the MeT department has forecast moderate top-heavy snowfall in the valley over the next 48 hours.

While it started snowing early in the morning in the higher reaches of Kashmir, the plains of the valley also witnessed snowfall as the day progressed, officials said.

They said the day temperatures are likely to stay between zero and three degrees Celsius at most places in Kashmir.

Sadhna Top has received a snowfall of more than 10 inches today while Gulmarg and famous ski-resort recorded four inches of fresh snowfall today.

In Gurez, 4-6 inches of fresh snowfall were recorded today while some other parts including Zojila, Sonamarg, and adjoining areas also recorded several inches of snowfall. More than half a foot of fresh snowfall was recorded at Razdan Pass.

Authorities have issued avalanche warnings in hilly and mountainous areas.

Meanwhile, Director Meteorological department (MeT), Dr Mukhtar Ahmad, said that there is a possibility of light to moderate snow and rain at many places till 4th February evening with chances of heavy snowfall over isolated higher reaches. "Middle and | More on P6

Srinagar: Despite the muchanticipated snowfall in Kashmir since last week, which ended a two-month-long dry spell, environmental experts argue that the snowfall following 'Chillai Kalan' will have a diminished impact, as it may not provide sufficient replenishment to address the prolonged water scarcity and environmental concerns in the region.

Kashmir witnessed the record-breaking driest Chillai Kalan this year, experiencing warmer days than ever. However, on the last day of this 40-day-long most severe part of winter, western disturbances hit, and the region received

Srinagar: The prolonged dry spell during this winter, Kashmir valley grappled with far-reaching consequences in different water dependent sectors including agriculture and electricity. This promoted both the locals and authorities to reflect on the necessity for a resilient mechanism to tackle future water crisis.

Significantly, the Union Territory grapples with a significant issue of soil erosion primarily stemming from its hilly terrain, undulating topography, delicate ecosystem, climatic conditions, and the depletion of vegetal cover caused by excessive grazing, lopping, unauthorized felling, and encroachments.

The situation of land degradation is exacerbated by events such as landslides, earthquakes, and various development

including road constructions, railway lines, and the establishment of hydroelectric projects. Maintaining a robust vegetal cover in catchments is imperative for the sustained and effective operation of hydroelectric

projects in the long term.
Notably, the recent snowfall prompted the Srinagar-Jammu national highway to remain shut for about 40 hours due to landslides at several places.

The government sensed the multi-dimensional loss due to soil erosion resulting in decrease of agricultural/horticultural production, power production due to siltation of dams and reservoirs, sedimentation of lakes and other water bodies having scenic beauty and tourism potential, flash floods, degradation of forest soil, frequent disruption of communication system etc.

4 Held With Forged Tickets At Srinagar Airport

Srinagar: Four persons who allegedly entered the heavily guarded Srinagar International Airport with fictitious tickets were detained by airport security this evening.

After preliminary questioncurity, the ng by the airport se arrested individuals were handed over to the concerned police station for further inquiry, sources told Kashmir Observer.

Confirming the arrest, a police official said the four had allegedly gained their entry to the heavily guarded Srinagar Airport using fictitious tickets and are presently lodged at the Humhama police station.

As soon as the airport

authorities sent out a signal regarding the detention of four people, a police squad was dispatched to the Srinagar airport, he added.

He, however, claimed that no formal case has been filed against them as of yet.

"Actually the four had just accompanied their parents, who had to depart for Umrah; this is what the preliminary investigation revealed. No FIR has been

registered against them as of now as the matter is under investigation," he told Kashmir Observer.

Rise of Cryptocurrency And Cyber Threats Posing New Challenges: PM

Says Need To Make Justice Delivery System More Flexible

New Delhi:Noting that criminals have been using the latest technology for funding Prime Minister Narendra Modi on Saturday pitched for expanding cooperation between countries for investigation and justice delivery.

He also said cooperation can happen even while respecting each other's jurisdiction and asserted that when nations work together, jurisdiction becomes a tool to deliver justice, not delay it.

The rise of cryptocurrency and cyber threats presents new challenges and there is a need for making the justice delivery system more flexible and adaptable, he said.

Speaking



Commonwealth Education Association (CLEA) Commonwealth Attorneys Solicitors General Conference (CASGC) here, he said countries already work

with each other in the domain of air traffic control and maritime traffic, and advocated extending this to investiga-

tion and justice delivery. "When we work together then jurisdiction becomes a tool to deliver justice and not to delay it," he said, adding that the nature and scope of crime have seen radical changes.

Sometimes ensuring ius in one country requires working with other countries, he said.

He expressed hope that the conference works to ensure that everyone has access to timely justice and no one is left behind.

SC Seeks Details Of Persons Regularized Under SRO-520 In J&K

New Delhi: The Supreme Court of India has sought an affidavit from the J&K government regarding the individuals who have so far been regularized in terms of SRO-520 of 2017 which deals with regularizing engagement of casual/seasonal/ need-based and other workers in Jammu and Kashmir.

'Let the state give a further affidavit disclosing therein the particulars of the individuals who have so far been regularized in terms of SRO-520 of 2017. This affidavit shall be filed within four weeks," said a bench of Justices Aniruddha Bose and Sanjay Kumar.

The top court was hearing a petition, challenging 2020 judgment by a division bench of J&K and Ladakh High Court which had partly allowed the erstwhile government's appeal



in which the State had said that someone engaged as a casual labourer against a "nonsubstantive post" had absolutely no claim, in law, to seek regularization.

The petitioner had claimed regularization of his services after having been engaged as a casual labourer in the year 1997, had filed a writ petition in 2002 which was disposed of by the order of the writ court on June 2008, by providing that the authorities would consider the petitioner, who is

continuing in service, for regularization under law, if he is similarly situated with them in all respects.

"True that the casual labourer cannot seek regularization as no vested right accrues in his favour for such claim," the division bench of High Court had said. But if the employer comes up with any scheme for the benefit of such employgoverning their engagement, the service of the casual labourers have to be, in such eventuality, dealt with under the provisions of such scheme and the benefit, if any, getting accrued as such to them cannot be arbitrarily denied to them, the Division Bench had said. Shopian Terrorist Attack

SIU Files Chargesheet Against Six Accused

Special Srinagar: The Investigation Unit (SIU) on Saturday filed a charge sheet against six people in a case relating to a terror attack on labourers in Shopian district of Iammu and Kashmir last year.

The SIU Shopian produced a comprehensive charge sheet in the attack on non-local labourers that took place in Gagran last July.

The charge sheet has been produced before the Court of Special Judge (NIA Court) Kulgam today, against the six

accused persons," a police spokesman said.

He said the accused in the case are Adnan Shafi, Zahid Ahmad Shah, Hanzil Yaqoob (deceased), Hameed Thoker alias Muslim Bhai (deceased), Hazim Rashid Sheikh, and Midhat Ahmad Dar.

During investigation, the accused were found involved in the heinous attack on labourers living in a rented accommodation in Gagran area of Shopian, causing serious injuries to three of them.

Beyond individual savings, the rooftop solar initiative is poised to stimulate economic growth by creating a myriad of entrepreneurship opportunities in the supply and installation of solar systems. It also promises to open up new job avenues for the youth, particularly in technical fields related to the manufacturing, installation, and maintenance of solar panels. This aligns with broader national objectives of promoting sustainable energy sources, reducing carbon emissions, and contributing to global environmental goals.

Second, the announcement to provide viability gap funding (VGF) for 1 GW of offshore wind energy capacity is a pivotal move for the country's renewable energy ecosystem. This funding aims to mitigate the financial gaps that have historically deterred the development of offshore wind projects, due to their high initial costs compared to more established renewable sources like onshore wind and solar energy. With an extensive coastline and significant offshore wind potential, especially in states like Gujarat and Tamil Nadu, this initiative is poised to unlock a substantial clean energy source capable of powering millions of homes, aligning with India's broader objectives of enhancing energy security and sustainability.

The VGF is designed as a financial mechanism to make economically justifiable projects commercially viable, thereby attracting private investment into a sector that is crucial for achieving India's ambitious targets of 500 GW renewable energy capacity by 2030 and net-zero emissions by 2070. By reducing the investment risk and incentivizing the development of offshore wind farms, the government's approach is expected to catalyze significant advancements in India's renewable energy infrastructure. This strategic investment not only diversifies the country's energy portfolio but also marks a critical step towards a sustainable and green economy, underscoring the nation's commitment to combating climate change and promoting sustainable development.

The third announcement regarding the setup of coal gasification and liquefaction capacity of 100 MT by 2030 is significant as it aligns with the National Coal Gasification Mission. This initiative aims to reduce reliance on imports of natural gas, methanol, and ammonia by utilizing domestic coal resources for gasification purposes, promoting energy self-sufficiency, and supporting India's energy transition goals. Coal gasification converts coal into syngas (a mixture of hydrogen, carbon monoxide, and carbon dioxide) through high-temperature reactions with steam and oxygen. This process enables more efficient energy extraction and the possibility of capturing CO2 before it is emitted, offering a pathway to cleaner energy. Coal liquefaction, on

the other hand, involves converting coal into liquid hydrocarbons, mimicking natural petroleum formation but at accelerated rates and controlled conditions. Both processes contribute to reduced carbon footprints by enabling cleaner combustion, higher efficiency, and the integration of carbon capture and storage technologies.

Fourth, mandating the phased blending of Compressed Biogas (CBG) into CNG and PNG will technically promote green energy in India by enhancing the utilization of renewable biogas, derived from agricultural waste, organic waste, and other bio-resources. This approach not only reduces carbon emissions by substituting fossil fuels but also encourages the development of biogas infrastructure, contributing to a circular economy and improving waste management practices. It aligns with sustainable energy goals and supports India's commitments to reducing its carbon footprint. Further, providing financial assistance for the procurement of biomass aggregation machinery will facilitate the efficient collection of agricultural and organic waste.

On the whole, the impetus towards green energy in India in the interim budget is expected to have multiple benefits. These include job creation in renewable sectors, enhanced energy security through reduced fossil fuel dependence, fostering innovation in green technologies, environmental improvements by reducing pollution and greenhouse gas emissions, and expanded access to electricity in underserved regions, collectively contributing to sustainable economic growth and energy equity.

In a world where budgets often sound as dry as a desert afternoon, this interim budget is a monsoon of green energy initiatives, promising to sprinkle sustainability across its landscape.





Meanwhile, there was respite from intense cold conditions last night but the minimum temperature stayed several degrees below the normal for this time of the year.

Gulmarg skiing resort in north Kashmir recorded a low of minus 10.6 degrees Celsius, up by 1.4 degrees from the previous night's minus 12.0 degrees Celsius, the officials said.

Pahalgam tourist resort in south Kashmir, which serves as the base camp for the annual Amarnath yatra, recorded a low of minus 8.3 degrees Celsius, up from minus 11.9 degrees Celsius the previous night.

Kokernag and Qazigund towns in south Kashmir both recorded a low of minus 5.4 degrees Celsius, the officials

On Friday, the mercury had nosedived across Kashmir with unofficial data suggesting that Larnoo town in south Kashmir Anantnag district had recorded minus 17.1 degrees Celsius followed by Sonamarg resort on the Srinagar-Leh highway which recorded a low of minus 15.1 degrees Celsius.

Although 'Chilla-i-Kalan' -- the 40-day harshest winter period -- ended earlier this week, the cold wave has continued in Kashmir.

The valley is currently going through a 20-day-long 'Chilla-i-Khurd' which shall be followed by a 10-day 'Chilla-i-Bachha'.

hydropower generation, and associated sectors, could be affected in the upcoming summer.

"This would also mean early snow melt of the scanty snow that is near/ on glaciers and would expose glacier ice to an earlier melt (April) than usually happens (June-July)," said Irfan Rashid, Assistant Professor at the Department of Geoinformatics, University of Kashmir.

He further said that the glacier ice will get exposed and start melting earlier than usual. "This would mean higher ice loss this year," he said.

"Pertinent to mention that glaciers have already been experiencing ice loss since the 1990s/2000s."

Earth scientist Shakil Romshoo, the vice-chancellor of the Islamic University of Science and Technology (IUST) told Kashmir Observer that snowfall during peak of the winter stays for a longer period of time as the temperature remains in minus while as post Chillai Kalan, the snow starts melting in fast speed as the temperature increases.

"It's good that snow has finally started but it's watery (snow with a good amount of water) not dry. That means it will melt quickly as the snowfall in Chillai Kalan is dry and therefore remains for a long time," he

He however said that it is too early to make predictions; if the valley receives ample snowfall in February, there is a possibility of compensation

Lately, climate change is making a significant impact in the Himalayan region, which is witnessing extreme weather events, prolonged dry spells in both winter and summer. The unusual weather patterns are making a significant impact on groundwater, electricity, fish production and agriculture.

Rashid said that this change in the weather pattern is driven by global climate change which affects distribution and development of the pressure belt.

"Since a low pressure system hasn't yet developed over Kashmir this winter, we experienced a dry spell," he added.

Director of Meteorological Centre, Srinagar, Mukhtar Ahmad however contends that this is not the first occurrence; rather, it has been a recurring pattern in the Union Territory for the past few decades.

government launched a project titled Vision Document-2023 back in 2016,for soil and water conservation in Jammu and Kashmir.

"In order to have a macro-level planning in future, a need for a vision document has been felt by the Soil & Water Conservation Department. Accordingly, this Vision Document-2030 has been devised reflecting; Introduction, Land Degradation and Soil Erosion problem, Land & Soil Management, Water scenario and Vision by 2030," reads the

Since then, the department actively participated in formulation and implementation of various site-specific treatment plans. So far, a significant portion of the work has been completed, according to officials who asserted that all the targets will be achieved by 2030.

Asaf Mahmood, who holds additional charge of Director, Soil & Water Conservation, J&K told Kashmir Observer that over 70 percent of the work has been completed and rest will be covered by 2030.

55,000 hectares of soil treated, 382 projects completed and 723 Water harvesting structures completed, these are the works that the department of soil and water conservation has achieved so far.

Subsequently, the department started taking care of 70,000 hectares for Soil & Water Conservation activities by 2030.

The projected area, according to the document, undertaken in different programmes under State Plan Centrally Sponsored programmes and other aided programmes.

While sharing the status of the work so far, an official of the department said that total number of 578 Project / works were proposed by the department during 2023-24, out of which 382 projects have been completed upto ending January 2024 and rest 196 project are likely to be completed by ending March 2024.

He further said so far 723 Water Harvesting Structures in the shape of Water Tanks / Ponds have been constructed and restored.

In addition to this, he said over 3.79 lakh cum DRSM structure, 54325 number of crates, 1710 Crib Structures and 14 Khuls have been constructed by the department so far to aid in conserving soil, water harvesting and ground water recharge in the catchment areas.

The department, according to the vision document also took up the scheme of Artificial Recharge of Ground Water fully funded by the Ministry of Water Resources under Artificial Recharge of Ground Water by Constructing Dams etc. and under the scheme, the department was able to construct 2- RCC Check Dams at Phangeri and Dhabbie villages in Hiranagar / Dinga Amb Tehsil of Kathua District.

Notably, RCC Check Dam Phangeri impounds 67.50 lakh liters water per year and Dhabbie impounds 1.35 crore liter water per year and the anticipated recharge to groundwater, as per Central Ground Water Board study reports is 50.62 lakh liter in Phangeri and 1.01 crore liter for Dhabbie Check

Moreover, over 9 RCC Check dams are being constructed in Kandi Belt of Jammu Region, out of which 05 RCC Check Dams have been completed and 04 RCC Check Dams are under progress which will enrich the water regime in their respective command areas.

Asaf Mahmood told Kashmir Observer that most of the work has been done in "drought prone areas" of the UT

Out of 70,000 hectares to be taken care of for Soil & Water Conservation activities by 2030, the department has been able to treat over 55,000 hectares of area so far.

"Each District caters to more than 200 Hectares rehabilitation of degraded forest/year through establishment of S.C.Closures, DRSM, Crates, Crib Structures etc in the catchment area," the official said.

He further added that during the next seven years, approximately 40,000 hectares will be treated at this present pace.

In addition to this, some new

India, Modi noted, has used technology as a tool to reduce litigations which eases burden on the justice delivery system.

In the last few years, India has used drones to map places and provide clear property cards to rural people, thereby reducing disputes and possible litigations.

J&K Reports 1640 New Cancer Cases in 2023

SRINAGAR: Cancer continues to emerge as a serious health concern globally, with Jammu and Kashmir witnessing an alarming surge in cases.

Renowned oncologists in the Union Territory, the news agency, spoke with, expressed deep concern over the rising numbers and called for an urgent need for preventive measures and awareness.

Dr Zahoor, a leading oncologist at SKIMS Soura, said there is a widespread impact of cancer. He, however, said that nearly 40 to 50 percent of cases are preventable through simple lifestyle changes like quitting smoking, maintaining a healthy balanced diet, regular physical activity and avoiding excessively processed foods.

Dr Sheikh Aijaz, another prominent oncologist in Kashmir, called for addressing the issue through epidemiological, scientific and molecular approaches, with a focus on prevention, screening and cost-effective measures. He also stressed lifestyle and dietary changes, especially quitting smoking.

The treatment, especially in the blood and lymphoreticular malignancies, deserves instant attention and recognition," Dr Aijaz said, adding that formidable treatment facilities are available in Kashmir which can be galvanised with support.

Prof Manzoor Ahmad, Head of the Department of Radiation Oncology at GMC Srinagar, said that World Cancer Day is observed to create awareness about this dreaded disease. He said there is a sharp increase in new cancer cases in J&K, with the department registering a record number of 1640 cases in 2023, out of which 911 were males and 729 were females.

"The most common tumour in males was lung cancer and in females breast cancer. This scenario looks very grim as far as lung being the most common tumour in males is concerned because this cancer has a direct bearing and relation with tobacco use," he said. "This indicates the magnitude of tobacco products in our society and how much awareness we have to make among the general public

regarding the use of tobacco." As far as breast cancer in females is concerned, one of the major reasons is the lack of physical activity and obesity. "So both the common cancers, whether it is lung in males or breast in females, could be easily avoided if we make some lifestyle changes," Prof Ahmad said.

He called for public education through signs and symptoms of cancer, preventive measures and timely medical evaluations. On the treatment facilities available, Prof Manzoor said, "We are self-sufficient con-

cerning different modalities

that particular cancers need for eradication. If we could prevent cancers from developing at the first place by adhering to healthy lifestyle practices, then obviously we could avoid all the pains and hassles that these patients and their accompanying attendants have to go through. Prevention is better than cure.'

Dr Shabnam, Kashmir's first female organ-specific Oncosurgeon, described cancer as a new-age epidemic with a global burden costing around \$1.16

"There are over 100 different forms of cancers. Around 18 million new cases are being detected across the globe, with 9.6 million deaths per year (1 in 4 deaths due to cancer)," she said, "Unfortunately 70 percent of these deaths from cancer occur in lowmiddle income countries."

Dr Shabnam added, "Currently there are 50.55 million 5-Year Cancer Survivors Worldwide and around 8 lakh new cases are being detected in our country every year (currently around 25 lakhs are living with cancer). and we have around 7-8 lakh deaths due to it every year in our country alone.'

"Good news is that 30-50 percent of cancers are preventable and early-stage cancers are curable. Cancers are conquerable only if we decide to stay aware and follow the preventive measures and seek help at the earliest," she added.

Iran Eliminate Japan From Asian Cup **After Jahanbakhsh Nets Late Penalty**

AR-RAYYAN: Iran knocked fourtimes champions Japan out of the Asian Cup with a 2-1 victory in their quarter-final clash after skipper Alireza Jahanbakhsh converted a penalty in stoppage time at Education City Stadium in Ar-Rayyan, Qatar on Saturday.

With the match between Asia's top-two ranked sides tied at 1-1, Iran won a penalty in the fourth minute of added time and Jahanbakhsh stepped up to blast the ball into the top corner, drawing a loud roar from the Iranian fans in the arena.

The victory also saw Iran avenge their 2019 semi-final loss to Japan and when the final whistle blew, the Iranian bench emptied onto the pitch and an emotional Jahanbakhsh dropped to the turf in relief while many players wept tears of joy.

Iran, who are seeking a recordequalling fourth Asian Cup title, had not beaten Japan in 19 years while their victory also extended Amir Ghalenoei's unbeaten streak to 16 matches since he took charge in March.

"Iran should be proud of their sons, they gave everything they had for their people. I think the result can be a turning point for Iranian football," Ghalenoei told reporters.

Iran will find out their semi-final opponents later on Saturday when defending champions Qatar take on Uzbekistan. Jordan play South Korea in the other semi-final.

After a cagey start to a physical contest, Japan had taken the lead through Hidemasa Morita who made a run past four defenders before beating Alireza Beiranvand in goal to silence the Iran fans in the stadium. But the volume went up when Iran equalised 10 minutes into the second half with a sublime move where Sar-



dar Azmoun played the ball through to Mohammad Mohebi, who ran around his marker before slipping his shot past Suzuki into the bottom corner.

Japan had dominated possession in the first half but it was Iran who controlled proceedings after the equaliser as they pressed hard in defence and initiated wave after wave of attacks and the pressure finally paid off in second-half added time.

Japan's Ko Itakura made a mess of a clearance in the 94th minute and as he tried to recover, he tripped Hossein Kanani in the box and the referee immediately pointed to the spot, with Jahanbakhsh converting to whip their fans into a frenzy.

"I'd like to congratulate Iran. Unfortunately we have to leave the tournament now at the quarter-final stage. I feel sorry for our fans and everyone involved in Japanese football," Japan coach Hajime Moriyasu said. "I regret I couldn't give the earthquake victims a happier moment. I feel responsible for the result.

"We have to improve in many aspects, we conceded a goal in all five matches in this tournament. If you don't keep a clean sheet you can't win... We couldn't handle the pressure they put on our defence."
