New Delhi: Finance Minister Nirmala Sitharaman on February 5 proposed an Interim Budget of Rs 1.18 lakh crore for fiscal 2024-25 for the Union Territory of Jammu & Kashmir.

The interim budget of Jammu and Kashmir for 2024-25 provides for the ongoing measures and schemes as follows - 2959 Cr have been provisioned for tap-water connectivity for rural areas under Jal Jeevan Mission with Rs 532 crore as UT Share; 934 Cr for transforming agriculture and allied sectors of the UT through the Holistic Agriculture Development Programme (HADP), including provisions for IFAD funded J&K Comprehensive Investment Plan (JKCIP); 1907 Cr for rejuvenating school education infrastructure and services through funding under Samagra Shiksha Abhiyan;Provision of improving road connectivity with 1683 Cr for PMGSY roads, 300 Cr for CRF roads, and 1000 Cr NABARD scheme;1313 Cr for strengthening decentralized governance by providing for local area works of panchayat and urban local bodies;1271 Cr for strengthening infrastructure and services in the health sector under National Health mechanism;1093 Mission Cr for rural housing under PMAwasYojana-Grameen scheme; and 1000 Cr for comprehensive social security

New Delhi: The Centre on Monday introduced a bill in the Lok Sabha to provide reservation to Other Backward Classes in local bodies in Jammu and Kashmir.

Currently, there is no provision for reservation of seats for Other Backward Classes (OBCs) in panchayats and municipalities in the Union territory.

The aim of the Jammu and Kashmir Local Bodies Laws (Amendment) Bill, 2024 is to uphold principles of fairness and inclusivity in local governance, thereby addressing longstanding disparities and ensuring justice for OBC citizens.

"With this,...justice will be ensured to the citizens of Other Backward Classes of Jammu and Kashmir for the first time after 75 years of independence," according to the statement of objects and reasons of the bill.

The bill says that in future all local body polls will be

conducted by a State Election Commission consisting of a State Election Commissioner, instead of the Chief Electoral Officer of Jammu and Kashmir. The bill says the State Election Commissioner shall not be re-

moved from his office except in like manner and on the like grounds as a judge of a high court and the conditions of service of the State Election Commissioner shall not be varied to his disadvantage after his appointment. "The Jammu and Kashmir Local Bodies Laws (Amendment)

Bill, 2024 seeks to amend certain provisions of the Jammu and Kashmir Panchayati Raj Act, 1989, the Jammu and Kashmir Municipal Act, 2000 and the Jammu and Kashmir Municipal Corporation Act, 2000 in consonance with the provisions of the Constitution," according to the statement of objects and reasons of the bill. Writing By Hand Found To Enrich Brain **Connections More Than Typing On Keyboard**

tudents learn more and remember better when taking handwritten notes than using a keyboard as brain connectivity patterns were found to be far more elaborate while writing than typing on a keyboard, a new research has found.

Researchers said the findings suggested that the precisely controlled hand movements when writing with a pen helped obtain visual and movement information that contributed extensively to the brain's connectivity patterns, known to be crucial for memory formation and learning.

better when taking handwritten lecture notes, while using a computer with a keyboard may be more practical when writing a long text or essay," said Audrey van der Meer, a brain researcher at the Norwegian University of Science and Technology and co-author of the study published in the journal Frontiers

in Psychology. For the study, the researchers recorded the electrical activity of the brains of 36 university students, who were repeatedly prompted to either write or type a word that appeared on a screen. When writing, they used a digital pen to write in cursive directly on a touchscreen. When typing they used a single finger to press keys on a keyboard.

brain regions increased when participants wrote by hand, but not when they typed.

On the contrary, the researchers found that repeating the simple movement of hitting a key with the same finger was less stimulating for the brain.

"This also explains why children who have learned to write and read on a tablet, can have difficulty differentiating between letters that are mirror images of each other, such as 'b' and 'd'. They literally haven't felt with their bodies what it feels like to produce those letters," said van der Meer.

Even though the study participants used digital pens for handwriting, the researchers said the results are expected to be the same when using a real pen on paper.

"We have shown that the differences in brain activity are related to the careful forming of the letters when writing by hand while making more use of the senses," explained van der Meer.

The findings demonstrated the need to give students an opportunity to use pens, rather than having them type during class, they said.

Guidelines to ensure that students receive at least a minimum of handwriting instruction could be an adequate step, they said.

However, the team also cautioned that it was important to keep up with continuously developing technological advances, which they said included an awareness of which way of writing - handwriting or typing - was advantageous under what kind of circumstances.

Sof Srinagar: Accusing the higher-ups of Srinagar Smart City Ltd (SSCL) of turning a blind over their plight, suspend service on all routes, in case the 'harassment' meted out to them by the passengers is not immediately stopped. Shouting slogans "LG admin wake up,

want justice", dozens of the e-bus drivers and conductors staged a protest in Srinagar against the harassment meted out to them by the passengers

Pertinently, a video of a passenger attacking an e-bus operator in the Batamalloo area of the city went viral on social media, sparking protests by his fraternity.

'We have been facing a series of issues ever since the e-bus service was started in Srinagar. However the higherups of the SSCL despite being well aware of our problems have never been serious enough to address the same," Gulzar

Ahmad, a protester said.

Despite our honest efforts to put travelers at ease and accomplish our jobs, the daily animosity we encounter has a detrimental effect on our lives, he added.

"We receive a paltry amount of Rs 9000 a month, and are abused by the passengers frequently. One of our colleagues was severely beaten by a passenger in Batamalloo; however the officials of SSCL did not react," Gulzar said. The e-bus drivers and conductors

threatened to suspend the service on all routes in Srinagar, in case the harassment meted out to them by the passengers was not immediately stopped.

We are all highly educated, but the unemployment issue has forced us to work as drivers and conductors. We cannot risk our lives and appeal to the Lieutenant Governor to take serious note of the problems we face or else we will be forced to halt services on all routes.' they threatened.

Attack On Syrian US Base Kills Kurdish Fighters As Regional Tension Simmers

∧ drone strike on a United **A**States base in eastern Syria overnight has killed several fighters from Kurdish-led forces.

The United Kingdom-based Syrian Observatory for Human Rights (SOHR) said on Monday that seven fighters were killed and at least 18 others injured.

The attack follows US strikes on targets in Iraq and Syria over the weekend. Iran-aligned armed groups said they had also struck US bases in Syria as well as western and northern Iraq, as a low-level war with Washington simmers.

"This attack in the first response by the Iranian militias to American bases after American airstrikes on militia positions in various areas within areas they control," the observatory said of Monday's incident.

The SOHR added that since October 19, "108 attacks" were carried out on bases of the USled Combined Joint Task Force across Syria. The US-led coalition was set up in 2014 to fight ISIL (ISIS).

ISLAMABAD: Pakistan's former prime minister Imran Khan and ex-foreign minister Shah Mahmood Qureshi despite being high-profile prisoners will have to perform their prison labour inside the compound, according to a media report.

Both the leaders were convicted by a special court for a 10-year jail term in the cipher case and have been imprisoned in Rawalpindi's high-se-curity Adiala Jail, where their trial was held.

Khan, 71, and Qureshi, 67, are being kept separately as high-profile prisoners - in their capacity as a former prime minister and foreign minister, The Express Tribune newspaper reported.

Khan is the founder chairman of his Pakistan Tehreeke-Insaf (PTI) while Qureshi is the vice chairman of the party. Both the leaders are availing the facilities provided to inmates in a better-class prison

Addressing reporters in Chandigarh, Mr Dallewal alleged that the Centre had made a commitment for giving legal guarantee to Minimum Sup-port Price (MSP) when the farmers protested against the three now-repealed farm laws. But the government is not fulfilling its promise because

of pressure from the corporate sector, Mr Dallewal claimed.

He said preparations for the march have been going on with farmers taking out tractor rallies at many places.

"Not only from Punjab, farmers from other states, including Haryana, will be participating in the march," said Mr Dallewal. The farmers will head to Delhi from the Shambhu, Khanauri and the Dabwali borders, he added.

Sarwan Singh Pandher, general secretary of the Kisan Mazdoor Sangharsh Committee, said besides legal guarantee for MSP, the farmers are also demanding implementation of the Swaminathan Commission's recommendations, pension for farmers and farm labourers, farm debt waiver, withdrawal of police cases and "justice" for victims of the Lakhimpur Kheri violence.

Farmers mainly from Punjab, Haryana and Uttar Pradesh held a year-long protest on Delhi's border points -- Singhu, Tikri and Ghazipur -- against the three now-repealed farm laws.

Marriage Dissolution Does Not Efface Status Of Child's **Parents: Delhi High Court**

NEW DELHI: Dissolution of a marriage does not efface the parental status of the mother and father of a child, the Delhi High Court has observed while allowing a man's plea to have his name reflected in the school records of his minor son.

The high court said when the man was alive, there was no justification for his ex-wife to remove the father's name in the school admission form of their son and replace it with the name of her second husband.

It said while the woman has every right to have her name reflected in the school records as the mother of the minor, that cannot authorise her to refuse the man's right to have his name also entered in the documents as the child's father. "The dissolution of a marriage does not efface the parental status of the mother and father of the child borne out of the said marriage," Justice C Hari Shankar said. The court said the prayer of the man to have his name reflected in the school record as the father of the child cannot be refused. "In these circumstances, this court deems it appropriate, while allowing the prayer of the petitioner to have his name reflected in the record of (school) as the father of (child), to direct the school to reflect. alongside, the name of (wom-

an) as his mother. The school is directed to take necessary corrective steps within a period of two weeks," it said.

The court was deciding the man's plea seeking a direction to the school to correct its records and reflect his name as the father of the child.

The child was born in March 2006 and was first admitted to a school in 2012. In the two schools where he studied till March 2016, the man's name was recorded in the documents as the boy's father.

The grievance of the petitioner was that his name was not reflecting in the school records where his son has been studying since 2016 and instead the name of the woman's second husband was appearing as the guardian of the child. The court noted that certain matrimonial disputes arose between the estranged couple resulting in annulment of their marriage by a divorce decree granted in June 2015 by a famly court. In her counter affidavit, the woman did not dispute that the petitioner was the child's father but stated that her relations with the man were so acrimonious that she does not 'want to carry the legacy of the name of the petitioner to be linked with her minor son" as her present husband has accepted the boy as his own son and showers fatherly love and affection upon him.

Pakistan's Lingering Instability

he recent spate of court judgments against former Pakistani Prime Minister Imran Khan and his wife Bushra Bibi has sent shockwaves through the nation just days before the crucial general elections on February 8. The latest verdict, a shocking seven-year jail term for violating Islamic law in their 2018 marriage, has sparked debates about the state of justice and the political landscape in Pakistan.

The case, initiated by Bibi's former husband Khawar Maneka, alleges a violation of the Islamic requirement for a three-month waiting period after divorce before remarrying. Maneka asserts that he divorced Bibi in November 2017, while Khan announced his marriage to her in February 2018, months before becoming the prime minister of Pakistan. The civil court, situated within the Adiala Jail where Khan is currently imprisoned, not only sentenced the couple to seven years but also imposed a fine of one million rupees (\$3,560).

This judgment marks the third legal setback for Khan in the same week. Earlier on January 30, he and his aide Shah Mehmood Qureshi were sentenced to 10 years for allegedly leaking a confidential cable. Khan contended that the document contained evidence of a conspiracy involving the Pakistani military, his political rivals, and US officials to remove him from power in April 2022—a charge both Washington and the Pakistani army vehemently denied. The following day, Khan and Bibi received a 14-year imprisonment and a hefty fine in a case related to the illegal sale of gifts received during Khan's tenure as prime minister.

The speed with which these judgments were delivered has raised concerns about the fairness and impartiality of the legal proceedings in the neighbouring country. Critics within Khan's party, the Pakistan Tehreek-e-Insaf (PTI), argue that the haste in these trials undermines the integrity of the judicial process and raises questions about the upcoming elections.

The series of convictions against the former prime minister have also cast a long shadow over the upcoming elections, where Khan is barred from contesting, and the PTI faces significant restrictions, including being stripped of its election symbol.

Despite these legal challenges, most surveys continue to indicate Khan as the country's most popular leader. The ongoing legal battles and political restrictions on the PTI have prompted concerns about the democratic process in Pakistan, with some questioning the motives behind the swift legal actions against Khan. As things stand, the establishment in Pakistan has ensured that Khan does not return to power and his party is dismantled. This doesn't bode well for the country's fragile democratic system, and in the long run for the country itself. If no corrective measures are taken, Pakistan seems headed for more turmoil in future.

ccording to a report in this newspaper, the Central Board of Secondary Education (CBSE) has proposed a major overhaul in the academic framework for secondary and higher secondary education. Students will be required to study three languages instead of two — till Class X, at least two of which must be native Indian languages. At the higher secondary level, students will have to study two languages instead of one, at least one of which must be a native Indian language.

Secondary-level students will now have to clear 10 subjects, as opposed to the current requirement of five. Graduating from high school will require clearing six subjects, instead of five. The shift is in accordance with NEP 2020's objective of doing away with the rigid separation between academic and extracurricular streams. A credit bank system will ensure that the student is rewarded for skills obtained outside the classroom.

The CBSE's plan gives the learner the space to combine academic training with vocational education. It is, therefore, a welcome departure from pedagogic strategies that have contributed to the country's skill deficit by devaluing hands-on training. The examination authority must, however, make sure that the new system does not impose an extra burden on already stretched students.

A wealth of scholarship has underlined that knowledge of multiple languages improves learning outcomes and helps skill acquisition. At the same time, the threelanguage formula remains a politically fraught issue, especially in South India, which has a long history of languagebased sub-nationalism. The Tamil Nadu government, for instance, has opposed the NEP even though the policy does not require non-Hindi-speaking states to include the language in school curricula.

Linguistic activists in the state fear the implementation of the three-language formula could push schools to teach Hindi because of the scarcity of teachers in other languages. When it was first framed in 1968, the formula envisaged teaching a modern Indian language, apart from Hindi and English till Class VIII in schools in North India. But Hindi-speaking states have never had more than a handful of schools with teachers who can teach Malayalam, Kannada or Tamil - or, for that matter, Bengali, Marathi or Gujarati. The CBSE's proposal should occasion conversations on finding a greater play for the country's linguistic diversity in school curricula.

BACK TO BASICS | PROPHETIC MEDICINE

My Hijama experience

I've always been fascinated by the concept of healing through exploring inner strength. Whether the journey is physical, mental, emotional or spiritual, I find it inspiring to see how we can uncover our God-given potential to bring about positive change. There came a time in my life when I recognized the need to prioritise my health holistically, encompassing the mind, body and spirit. I had formed a deeper connection with my faith, and wanted it to be the anchor in all aspects of my life. My pursuit to be a better Muslim was also the driving force behind my journey in seeking wellness.

Initially I had to sift through a lot of the pop culture junk: "read this or that, eat this or that, follow this workout routine ..." There's no denying that many people find success in following those ideas. However, I was looking for something with its roots in cultivating a higher level of deen. So I turned to the source where we can find many answers: the sunnah of Prophet Muhammad [®]. As an adult, I now appreciate the inspiration and guidance that we find within the sunnah on a deeper level.

I came across Prophetic medicine (al-tibb al-nabawi), a particular part of the sunnah that consists of remedies, treatments and therapies recommended by Prophet Muhammad ³⁶, with the fundamental understanding that Allah is the ultimate Healer, Ash-Shaafi. This knowledge gave me comfort and hope.

"There is a remedy for every malady, and when the remedy is applied to the disease it is cured with the permission of Allah, the Exalted and Glorious." [Sahih Muslim 2204]

A mind-body-spirit approach to healing is especially emphasised in Islamic tradition. These are basic elements of one's being that influence worldview, actions and experiences. It's crucial to nurture each aspect.

Within the gold mine of Prophetic medicine, I learned about Hijama. The sunnah practice of Hijama involves wet-cupping therapy (WCT), during which a certified practitioner makes minor superficial incisions in the top layer of the skin and uses suction cups to draw out "bad blood" that contains toxins and buildup. If the idea of small cuts to your skin sounds scary, don't worry – WCT has been practised for centuries around the world. And you can find comfort in the knowledge that Prophet Muhammad [@] regularly practised Hijama.

"The best medical treatment you apply is cupping." [Sunan Abi Dawud 3857]

The Arabic word Hijama means to "suction out" or "to return to a natural state." Contrary to modern medicine, which introduces chemicals to the body, "alternative" methods like Hijama

withdraw harmful substances in order to let the body heal within itself. Hijama cleanses your bloodstream of toxins and buildup and encourages fresh blood circulation, helping to restore your body to homeostasis, where all body systems are functioning stably and in balance.

According to research, Hijama is said to improve Acute pain conditions, as well as chronic pain conditions, such as fibromyalgia, rheumatoid arthritis, carpal tunnel syndrome, inflammation and other painful joint-related conditions

Female infertility and hormonal conditions like endometriosis or polycystic ovary syndrome (PCOS) that disrupt the reproductive system

Mood disorders, such as depression, stress and anxiety

For many women, the go-to treatment from their doctor is medication that isn't always as effective as needed, or just doesn't align with their health goals. This wellness journey is an ongoing process for me because I'm not fixated on a particular goal. My focus is more on the growth throughout, one that involves mental, physical, emotional and spiritual aspects. It's important to find ways to ground and nurture ourselves in a busy world. If you try Hijama, make sure to share your experience with family and friends as it not only adds to your personal well-being, but also helps revive a beautiful sunnah practice!

Every Year Spent In School Or University May Improve Life Expectancy: Lancet Study

The research identified data from 59 countries and included over 10,000 data points collected from more than 600 published articles.

The team, including researchers at the Norwegian University of Science and Technology (NTNU), found that education saves lives regardless of age, sex, location, and social and demographic backgrounds.

They found was that the risk of death drops by 2 per cent with every additional year of education. That means those who completed six years of primary school had a lower risk of death by an average of 13 per cent.

After graduating from secondary school, the risk of dying was cut by nearly 25 per cent, and 18 years of education lowered the risk by 34 per cent. according to the study.

Researchers also compared the effects



of education to other risk factors such as eating a healthy diet, smoking, and drinking too much alcohol, and they found the health outcome to be similar. For example, the benefit of 18 years of education can be compared to that of eating the ideal amount of vegetables, as opposed to not eating vegetables at all, they said.

Not going to school at all is as bad as drinking five or more alcoholic drinks per day or smoking ten cigarettes a day for 10 years, the researchers said.

"Education is important in its own right, not just for its benefits on health, but now being able to quantify the magnitude of this benefit is a significant development," said study co author Terje Andreas Eikemo from NTNU.

While the benefits of education are greatest for young people, those older than 50 and even 70 years still benefit from the protective effects of education, the researchers said.

They found no significant difference in the effects of education between countries that have reached different stages of development. This means that more years of education is just as effective in rich countries as in poor countries.

"We need to increase social investments to enable access to better and more education around the globe to stop the persistent inequalities that are costing lives," said Mirza Balaj, co-lead author and postdoctoral fellow at NTNU. "More education leads to better employment and higher income, better access to health care, and helps us take care of our own health. Highly educated people also tend to develop a larger set of social and psychological resources that contribute to their health and the length of their lives," Balaj said.

Most of the studies reviewed for the study were from high-income settings, highlighting the need for more research in low- and middle-income countries, particularly from sub-Saharan and north Africa where data are scarce.

"Closing the education gap means closing the mortality gap, and we need to interrupt the cycle of poverty and preventable deaths with the help of international commitment," said Claire Henson, co-lead author and researcher at Institute for Health Metrics and Evaluation (IHME) at the University of Washington's School of Medicine, US.

"In order to reduce inequalities in mortality, it's important to invest in areas that promote people's opportunities to get an education. This can have a positive effect on population health in all countries," Henson added.

Various Measures Taken **To Reduce Debt Burden**, **Strengthen Economy: FM**

NEW DELHI: To bring down the debt burden, the government has taken various measures like increasing the tax revenue buoyancy, enhancing the public expenditure effectiveness, commitment to reducing fiscal deficit and augmenting the productive efficiency, Finance Minister Nirmala Sitharaman said on Monday.

In addition to strengthening the financial system, the government has more than doubled its effective capital expenditure from Rs 6.57 lakh crore in 2020-21 to Rs 13.71 lakh crore and Rs 14.97 lakh crore in 2023-24 (BE) and 2024-25 (BE), respectively, to crowd in private investments, she said in the Lok Sabha.

The government's emphasis on increasing capital expenditure will not only boost the investments, but also return a higher GDP growth to lower the debt burden, she said.

Simultaneously, she said, the state governments have been incentivised to increase their capital spending through measures like 50-year interest-free capex loans and front-loading of tax devolution instalments.

Various other measures like reduction of the corporate tax rate, liberalisation of foreign direct investment, and enhancement of ease of doing business have created support-

Unfortunately, many agents prioritize their own requirements over those of their clients, focusing more on making a sale rather than providing the best possible solution. India's Jan Services PMI Hits 6-Month High

NEW DELHI: The services sector growth in India rose to a six-month high in January as new business expanded at a faster pace amid buoyant demand from domestic and external clients, a monthly survey said on Monday.

The seasonally adjusted HSBC India Services PMI Business Activity Index rose to 61.8 in January, up from 59 in December, pointing to the sharpest rate of expansion in six months.

In Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion while a score below 50 denotes contraction.

The survey is compiled from responses to questionnaires sent to a panel of around 400 service sector companies.

"India's services PMI rose to a six-month high in January. New business expanded at a faster pace and managers' expectation for future activity was strong. The new export business index accelerated, signalling that India's services exports remained robust," Ines Lam, Economist at HSBC, said.

New export sales rose at the fastest pace in three months. Monitored firms signalled gains from clients across the globe, including



Afghanistan, Australia, Brazil, China, Europe, the UAE and the US

On the prices front, companies noted a further increase in their overall expenses at the start of the 2024 calendar year, with food, labour and freight identified as the key sources of cost pressures. However, with the vast

majority of panellists opting to leave their charges unchanged and only 6 per cent hiking them, output prices rose to the least extent in 11 months.

According to the survey, business confidence strengthened further. has Besides demand strength, firms expect investment and productivity gains to induce output growth in the year ahead.

Meanwhile, the HSBC India **Composite PMI Output Index** rose from 58.5 in December to 61.2, indicating the sharpest upturn since mid-2023. Composite PMI indices are weighted averages of comparable manufacturing and services PMI indices. Weights reflect the relative size of the manufacturing and service sectors according to official GDP data.

"January data highlighted a further acceleration in growth of Indian private sector output, amid quicker increases at both goods producers and service providers," the survey said.

Service providers led the upturn, although both segments recorded faster rates of expansion in new business, the survey added.

India Bounce Back Against England, Level Series 1-1

VISAKHAPATNAM: Indian bowlers won an engrossing battle against England's firebrand batting for a series-levelling 106-run victory in the second Test here on Monday, blunting 'Bazball' with their resilience in a roller-coaster contest.

England began day four at 67 for one, chasing a record target of 399. They were bowled out for 292 in the extended afternoon session.

2026 World Cup Final To Be Played At **MetLife Stadium In New Jersey**

NEW YORK: The 2026 World Cup final will be played at MetLife Stadium in New Jersey, beating out Texas and California for soccer's showcase game.

FIFA awarded the July 19 championship to the \$1.6 billion venue, which opened in 2010, the culminating match of an expanded 48-nation, 104game tournament that will be spread across three nations for the first time.

Located about 10 miles from Manhattan, MetLife

was promoted by both New York and New Jersey, where the stadium was built in the Meadowlands marshes. The land of Bruce Springsteen, Jon Bon Iovi and Frank Sinatra will be the focal point of the globe on that Sunday, when either Lionel Messi's Argentina will try to win its second straight title or a

successor will emerge. FIFA made the announcement Sunday at a Miami television studio, allocating the opener of the 39-day tournament to Mexico City's Estadio Azteca on June 11 and the finale to the home of the NFL's New York Jets and Giants. Dallas Cowboys owner Jerry Jones had lobbied for the final to be at his AT&T Stadium in Arlington, Texas. All games from the quarterfinals on are being played in the United States. Semifinals are on July 14 at AT&T and the following day at Mercedes Benz Stadium in Atlanta.

Quarterfinals are at Gillette Stadium in Foxborough, Massachusetts, on July 9, at SoFi Stadium in Inglewood, California, the following day, and at Arrowhead Stadium in Kansas City, Missouri, and Hard Rock Stadium in Miami Gardens, Florida, on July 11. The third-place game will be at Hard Rock on July 18. Seventy-eight of 104 matches will be played in the U.S., with 13 games each in Mexico and Canada, and there as many as six matches a day.

FIFA officials did not publicly explain their site-decision process. FIFA expanded the World Cup from 32 to 48 nations, increased matches from 64 and announced the 16 sites in 2022.

He informed that the Apex Body formed committee has been tasked to prepare for the hunger strike of both Thupstan Chewang and Sonam Wangchuk in case there is no positive response from HPC.

He said that no matter what, the hunger strike will continue until their demands are not met.

"If there is a proper positive response from HPC, then further course of action shall be deliberated upon and shared accordingly. In case of no positive response, then the strategy already discussed shall be implemented and walked upon," the Chairman said.

To a query, he said that if there is any positive commitment from HPC,
