### 2 Punjab **Residents Shot** At By Terrorists In Srinagar

One Dead, Another Injured

Srinagar: In the first targeted killing of the year, terrorists on Wednesday shot dead a worker from Punjab while another sustained injuries in Habba Kadal area of the city, officials said here.

Amritpal Singh, a resident of Amritsar, was shot by the terrorists from point blank range at Shalla Kadal locality in Habba Kadal quarter of the city around 7 pm, the officials said.

They said Amritpal died on the spot while his co-worker, identified as Rohit Mashi, aged 25,

sustained injuries in the incident. Rohit also hails from Amritsar. He was hit by the bullets in the abdomen and is undergoing treatment at SMHS hospital here.

The police have taken cognisance of the incident and cordoned off the area to track down the assailants, officials said.

A police official told Kashmir Observer that investigation into the attack was on at the moment. The victims, he said, had travelled from Amritsar to Srinagar for work.

### **ED Arrests Bharat Papers Director**

Jammu:The Enforcement Directorate (ED) has arrested the director of Bharat Papers Limited, Anil Kumar Aggarwal, in connection with an ongoing probe into a money-laundering case in Jammu and Kashmir, officials said on Wednesday.

Aggarwal, a resident of Kathua district in Jammu and Kashmir, was arrested on Tuesday night as a follow-up action to the investigation into an alleged loan fraud amounting to Rs 200 crore perpetuated on a consortium of banks, with the State Bank of India (SBI) as the lead bank and the other banks being Jammu and Kashmir Bank, Punjab National Bank and Karur Vysya Bank, the officials said.

The ED moved an application through special public prosecutor Ashwani Khajuria in the court of the special judge, anticorruption (CBI cases) in Jammu, Bala Jyoti, on Wednesday and got seven days' remand of the

### J&K Registered Over 1000 Financial Fraud Complaints Last Year

Srinagar:Over 1000 complaints of financial fraud cases amounting to more than Rs 780 lakhs have been registered by Citizen Financial Cyber Fraud Reporting and Management System in Jammu and Kashmir last year.

As per the figures accessed by the news agency-Kashmir News Observer (KNO), 1046 cases of financial fraud have been registered in the Union Territory last year. These



complaints amount 786.56 lakh.

'Citizen Financial Cyber Fraud Reporting and Management System' was set

up under the 'Indian Cyber Crime Coordination Centre' by the Ministry of Home Affairs to report financial fraud. Data further reveals that 253

cases of financial frauds were put on hold with a lien amount of Rs 62.55 lakhs. Figures further reveal that

a total of 1.13 million cases of financial cyber fraud were reported in 2023 in India.

Uttar Pradesh was at the top with around 200,000 cases, the highest across 36 states and union territories. Next was Maharashtra with 130,000 complaints reported, followed by Gujarat (120,000), Rajasthan and Haryana (80,000 each). Lakshadweep was at the bottom with 29 cases.

Officials said that frauds including UPI, Digital Banking and Credit Card and QR Code are some of the commonest financial frauds registered in Jammu and Kashmir.

"In Jammu and Kashmir, we witnessed that a lot of people fall

prey to financial frauds. Apart from these frauds, scams related to employment and social media are also being registered in Jammu and Kashmir," they said.

Officials said they have been constantly raising awareness among the public through various mediums to protect themselves from such frauds.

### **J&K Residents Were Deprived** Of Progressive Laws' Benefits: Centre

Srinagar: The Centre on Wednesday said that before abrogation of Article 370, J&K residents were deprived of the benefits of a number of progressive laws but now they are enjoying rights available to citizens of other parts of the country.

In a reply to a question in the Rajya Sabha, Minister of State of Home Affairs Nityanand Rai said that after abrogation of Article 370 and application of all the provisions of Constitution of India, the Central Laws which

were earlier not applicable to erstwhile State of Jammu and Kashmir, were made applicable and are implemented in the Union territory.

"After abrogation of Article 370 all the progressive laws such as the Right of Children to Free and Compulsory Education Act, 2009, the Right to Fair Compensation Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights)

Act, 2006, the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989, the WhistleBlowers Protection Act, 2014, the Juvenile Justice (Care and Protection of Children) Act, 2015, the National Commission for Minorities Act, 1992, The National Commission for Safai Karmacharis Act, 1993 etc. have been extended to Jammu and Kashmir," he said.

The minister said that now. residents of J&K are enjoying rights which are available to citizens in other parts of the country.

Srinagar: Mohammad Shafi, a resident of Srinagar, seems confused as he wanders from one vendor to another, attempting to purchase vegetables along the stretch from Amira Kadal to Lal Ded Hospital road. The reason for the confusion,

according to Shafi, is the disparity in prices among grocers within a radius of no more than 200 meters. "I have checked the rates of

each vendor, and they are all sell-

ing vegetables at different prices," Shafi said. "At Amira Kadal grocers sell onions for Rs 40, capsicums for Rs 120 and tomatoes for Rs 70 per ki-

logram," he said, adding that the

prices set by vegetable vendors differ from those found at Maharaji Bazar and LD Hospital Road.

"There is no fixed pricing on vegetables. Rates fluctuate by 50 to 100 percent between markets located within a stone's throw of each other," Shafi said, adding, "The government seems to be inactive. There is rampant exploitation happening in the market."

He said it was becoming difficult for the common man to purchase essential commodities from the market.

Sania Nabi, another consumer, said she was surprised at seeing radishes being sold at Rs 40 by one greengrocer and Rs



### **Alienated Ladakh**

he recent shutdown and widespread protests in Ladakh signal a deep-seated discontentment stemming from the constitutional changes brought about by the reading down of Article 370. . Thousands of protesters, braving the intense cold, gathered at the Polo Ground in Leh. The speeches at the gathering, including those by prominent Ladakhi leaders and activists like Sonam Wangchuk, emphasized the promises made by the Union government. The Leh Apex Body (LAB) and Kargil Democratic Alliance (KDA) who are spearheading the agitation, are demanding special rights and statehood for Ladakh, which was downgraded to a Union territory without a legislature in 2019. These protests underline the urgent need for a comprehensive dialogue to address the grievances of the people in the region.

The demands put forth by LAB and KDA include tribal status for Ladakh, inclusion in the constitution's Sixth Schedule, job reservation for locals, and a parliamentary seat each for the Leh and Kargil districts. These demands reflect the aspirations of the people who feel a sense of disempowerment and marginalization following the constitutional changes. The call for statehood and democracy echoes the sentiment that Ladakh's people seek not just constitutional safeguards but also active participation in decision-making processes that affect their lives.

Over the past four years, Ladakh has been nursing a deepening sense of grievance against New Delhi. Following the revocation of Article 370 on August 5, 2019, and which incidentally was celebrated in Leh district, the region has sought constitutional protections from the central government to ensure its land and jobs were reserved only for local residents. Before the reorganization of Jammu and Kashmir, Ladakh had four MLAs and two MLCs in the then state Assembly, providing a stronger voice for the region. Now, one Member of Parliament democratically represents the region.

The committee formed by the Union home ministry held talks with LAB and KDA on December 4, but the lack of significant breakthroughs reveals the complexity of the issues at hand. The upcoming second round of talks on February 19 in Delhi provides an opportunity for the government to engage in a meaningful dialogue and address the genuine concerns of the people of Ladakh.

It is crucial for the Union government to work towards a solution that ensures their constitutional rights and preserves their cultural identity. The demand for tribal status, inclusion in the Sixth Schedule, and statehood is not extraneous but a rightful claim that deserves attention and consideration. As Ladakh faces economic and political challenges in the aftermath of the constitutional changes, it is imperative to find a middle ground that respects the region's unique circumstances.

Nothing else can explain the persistent non-compliances and continued supervisory concerns about PPB, which was put on notice by the banking regulator in March last year and directed not to onboard new customers.

Inexplicably, the management did nothing despite repeated warnings on falsified compliances, irregularities in KYC norms, and rules pertaining to related-party transactions. That left the regulator with little option but to bar PPB from key operations. What will be a crippling blow to the bank, which has 50 million account holders, and for a group which has 300 million wallets and a leader in the FASTag units segment, is the diktat that it will have to terminate the nodal accounts of the parent firm and Paytm Payment Services. Nearly a quarter of all Unified Payments Interface (UPI) transactions on Paytm end up credited to a PPB account. But now, all that would have to change as the regulator felt that there was no wall between Paytm and the bank — money and data flowed easily even when they shouldn't have.

Paytm's biggest challenge will be to tie up with other banks for UPI transactions, necessitating a sea change in its business model. That's easier said than done. Lending partnerships are based on trust and few banks would be willing to enter into a partnership with an entity which is not only under the strict lens of the regulator but also of the government. Revenue secretary Sanjay Malhotra told a news agency on Saturday that PPB would be probed if any fresh charges of fund siphoning are found. Global brokerages Jefferies and Macquarie are both worried that these dark clouds over the group could end up spooking some of Paytm's lending partners, and they might even limit the business they do with the fintech. One feels sorry for Paytm's investors. Last November, Paytm completed a year as a publicly traded company and its performance has been an embarrassment. The latest episode would only add salt to investors' injuries.

There has been criticism in some quarters over the RBI's "harsh" action against PPB. Payment banks are justifiably concerned over their steep profitability path because of the restrictions on their operations by the RBI and have been arguing for permission to start lending, albeit in a small way. The regulator must consider this in view of the contributions made by the differentiated banks and fintechs to a segment outside of mainstream banking. But there is absolutely no basis for the accusation against the regulator of killing them through aggressive actions. Nothing can come in the way of a credibility test when millions of depositors' money is concerned. The fintech industry should rather relook its own internal systems to ensure the highest compliance standards. Entities such as Paytm have to pay the price for being reckless in their actions.

## How Not To Get Hired For A Govt Job In J&K

How long must unemployed youth bear the costs of court cases? Is this a dignified way of life? Is the system not corrupted? Were 3 years 11 months and 12 days not enough for a Government's Services Selection Board to conduct a transparent exam?

fter the abrogation of Article 370 in Jammu and Kashmir, the UT Government swiftly moved to address vacancies across various departments. Among these efforts, the Jammu and Kashmir Services Selection Board (JKSSB) advertised 972 vacancies for Finance Accounts Assistant on December 16, 2020. However, 486 posts, constituting 50% of these vacancies, were reserved across different categories, a matter warranting separate discussion due to its flaws.

The written exam for these vacancies took place after a prolonged gap of 1 year, 2 months, and 21 days, specifically on March 6, 2022. According to the Times of India, "Out of a total of about 2 lakh candidates (who collectively paid approximately Rupees 7 crore as registration fees to the board), approximately 1.36 lakh candidates participated in the examination."

In this fiercely competitive environment, candidates harbored diverse aspirations upon securing a government job. Some sought to support their families financially, while others aimed to defy social stigmas associated with their chosen fields or the fields in which their interests lie. Some aspired to enhance their eligibility for marriage, while others struggled to align their interests with the limited scope of our education system. The motivations behind these endeavors varied greatly, with many opting for the disturbance free environs in urban setup for exam preparation, given the absence of additional selection criteria such as interviews. Some turned to online courses to study from the comfort of their homes, while others faced constraints in securing accommodations near libraries or their peers in cities.

The results for this exam were declared on April 21, 2022. However, amidst a plethora of complaints, the Central Bureau of Investigation intervened in a

case related to irregularities in the examination for Accounts Assistant of the Finance Department. The CBI registered a case on November 28, 2022, and subsequently, the selection list was invalidated. For those candidates selected who were not involved in any corruption, all their hard work, aspirations, and desires to secure a government job went in vain. The feeling of many selected fellows at that time can be summed up by a beautifully sung ghazal by Jagjit Singh:

"zindagi tu ne lahu le ke diya kuch bhi nahi, tere daaman mein mere vaste kya kuch bhi nahi.

mere in haathon ki chaaho toh talashi le lo, mere haathon mein lakiron ke siva kuch bhi nahi.

hum ne dekha hai kayi aise hudaon ko yahan saamne jin ke vo sach-much ka huda kuchh bhi nahi"

While many cases challenging the re-exam were either unheard or pending in court, the Jammu and Kashmir Services Selection Board conducted a re-examination for the post of Accounts Assistant. Finance Department, on January 28, 2024. Yet again, the government's Services Selection Board dishonored the hard work and desires of the candidates by altering the marks weightage scheme of the paper without prior notice and releasing an erroneous answer key, with many claiming that about 15-20 questions were either ambiguous or incorrect. Candidates are frustrated with this apparent hegemony and injustice, and there is a confident candidate with whom I have conversed regarding the wrong or ambiguous questions. He informed me that using the prescribed format and including supporting documentary proof, candidates can submit objections or representations for specific questions. However, he expressed his inability to afford the fee of Rs. 200 per question for 15-20 questions,

along with additional expenses for traveling to submit hard copies of objections at the JKSSB Office in Srinagar. Furthermore, the requirement to make the demand draft payable to the J&K Services Selection Board is seen as a disgrace in the digital age.

I came across a YouTube video related to wrong questions in the FAA exam, where someone commented that "Hardworking aspirants must assemble... 5000 aspirants are enough to file a case in the high court... Filing a case will be the perfect answer and will build a strong case." This injustice has persisted for too long. How long must the youth suffer burdened by years of conflict? How long must unemployed youth bear the costs of court cases? Is this a dignified way of life? Is the system not corrupted? Were 3 years 11 months and 12 days not enough for a Government's Services selection Board to conduct a transparent exam?

Plato once said, "The worst form of injustice is pretended justice." In the face of hopelessness, I implore the Arbabe Ikhtiyar/ The Authorities to address the real problems faced by the youth. While 5G may be deemed important, it pales in comparison to the struggle of those who cannot afford bread for themselves or their families. At the same time I implore my brethren that It's time to break free from the shackles of the faulty education system and societal expectations what Akbar Allahabadi summed up as, "hum kya kahein ahbab kya kaar-e-numaya kar gaye, B.A hue naukar hue pension mili phir mar gaye" Let's have the courage to stand up and pursue our true interests, emancipating ourselves from this imaginary chain.

With a sense of despair, I raise these questions, hoping for change.

Excerpt from Khutba about Masjid al-Aqsa and Palestine, with a focus on the incredible night journey, 'Al isra wa al mi'raj':

### Surah al-Isra

Glory be to He Who did take His Servant for a Journey by night, from the Sacred Mosque (in Makkah) to the Farthest Mosque (Masjid al-Aqsa), Whose precincts We did Bless, in order that We Might show him some Of Our Signs: for He Is the One Who heareth And seeth (all things). (Quran 17:1)

The blessed Masjid al-Agsa has been referred to in the Quran and hadith, as a land which Allah (swt) placed special blessings upon. In our search for knowledge and our desire to follow in the footsteps of the righteous and rightly guided, the land of Palestine and the sanctuary of the al-Aqsa cannot be stressed enough.

Abu Dharr reports that the Messenger said, "One night I was asleep, in the Makkan Sacred Precinct (al-Haram) near the Ka'bah when I was woken by Jibra'il. He informed me of the divine will and took me to the well of Zamzam, where upon he opened my chest and poured wisdom and faith into it. Then he sealed it. I was then presented with the beautiful Buraq. This is an animal larger than a mule but smaller than a horse. I mounted it...

Anas Ibn Malik reported that the Messenger of Allah said: "He (the Buraq) puts its hoof wherever its eyesight ends." He said, "I rode it (and started the journey) until I arrived at Bayt al-Maqdis." He continued, "Then I tied it to a ring that the Prophets used to tie their animals on." He said, "Then I entered the Masjid, and I prayed two units of prayer, then I went out, so Jibra'il brought me a cup of wine and a cup of milk. I chose the milk, so Jibra'il said, 'You chose the fitrah (natural goodness, good instinct),' then we

## MASJID AL-AQSA The Incredible Night Journey

were raised to heaven...'

The Night Journey (al-Isra') of Prophet Muhammad from Makkah to Jerusalem and the subsequent Heavenly Ascent (al-Mi'raj) was one of the most incredible and fantastic events in the history of humanity. This journey represented both a turning point in the prophethood and challenged conventional science.

Allah swt, with His Might and Majesty folded time and space into one plane and took the Prophet through it while the time on Earth stood still. The Prophet then journeyed the earth whilst mounted on the Buraq, a horse-like creature capable of travelling cosmic distances in short periods of time. The Prophet journeyed through space, and again time stood still. He witnessed heaven and hell, and saw the future and past, experiencing phenomena beyond anything of this world. While such events are undoubtedly beyond scientific comprehension, for Allah swt, the Creator of the universe and of time itself, this was His will and He made it happen through His power.

Ibn Kathir states, "As for the report of al-Isra', all Muslims unanimously concur upon it and only heretics and

atheists have denied it." By acknowledging the journey the believer (mu'min) testifies to the will and limitless power of the Almighty, making firm their faith in Him. As for recognizing the experience of the Prophet in al-Mi'raj, one testifies to the life of the hereafter

and the Day of Judgement. Al-Isra' and al-Mi'raj, therefore,

holds fast the faith of a person and consolidates the very central tenet of Islamic teaching - that we are here for a temporary period; created by the Lord, whose powers are limitless; and after death we will be resurrected and judged according to our deeds.

The greatness of al-Isra' thus goes beyond the narrow confines of breaking physical barriers and transcends into believing that the Creator is "He, Allah the One and Only; He is the Eternal and Absolute, He begets none, nor is He begotten, and there is nothing that could be compared to Him."; and thus facilitates one's submission to the greatness of

### The significance of Masjid al-Aqsa in the Night Journey

All-Knowing, the Creator, mentions both Masjid al-Haram in Makkah and Masjid al-Aqsa in Jerusalem, by name in the first verse of Surah al-Isra'. In this way, Allah swt honors them, and calls them both His 'Masjid'.

These "Masajid" were not physical buildings but rather it is the land on which they stand which Allah has blessed. Thus, with or without any buildings, they can be regarded as a Masjid. When al-Isra' and al-Mi'raj took place, there were no complete buildings within the Noble Sanctuary of al-Aqsa; the only building present was the surrounding wall and perhaps a few ruins.

Muslims consider al-Aqsa to have been built first by Prophet Adam (as). Abu Dharr reported that he asked

the Prophet (saw), "O Prophet of Allah, which Masiid was built first on earth?" The Prophet replied, "The Sacred Masjid of Makkah." Abu Dharr again asked, "Which was next?" The Prophet said, "The Masjid al-Aqsa." "How long was the period between them?" Abu Dharr asked. The Prophet said, "Forty years. Apart from these, offer your prayers anywhere when it is time to pray, although excellence is in praying in

these Masajid." Imam al-Qurtubi (Allah have mercy on him) says, "There are different opinions regarding the construction of Masjid al-Aqsa. Some assert that Adam (as) established Masjid al-Haram in Makkah and then proceeded to build Masjid al-Aqsa forty years later. Others assert the angels laid the foundation of Masjid al-Haram and after forty years established Masjid alAqsa. There are a lot of pos-

sibilities and Allah knows best." Allah swt has designated Masjid al-Aqsa and its surrounding area as "blessed". The "blessed land" under the Islamic ethos means land associated with barakah - the land over which Allah swt has endowed spiritual and physical blessings from which all of humanity and Allah's creation can derive benefit. This barakah also extends to the people residing within this land, on the condition that they abide by the commands of Allah swt and more specifically, that they practise Islam.

### The Night Journey

Anas ibn Malik narrates, "The

Prophet (saw) was offered a drink of water, milk, or wine... Then Adam and all the other Prophets were resurrected and the Messenger of Allah led them (in prayer) that night."

Ibn Kathir (Allah have mercy on him) narrates a hadith, "Then I left and it was not more than a little while when a lot of people gathered, and someone called for the prayer and the prayer was established." He (the Prophet ) continued, "So we stood in lines waiting for someone to come and lead us, then Jibra'il took my hand and asked me to lead the prayer, and I did. After the end of the prayer Jibra'il asked me, 'O Muhammad, do you know who prayed behind you?' I said, 'No'. He said, 'Every Prophet sent by Allah swt prayed behind you.' Then Jibra'il took my hand and we ascended to heaven."

The Prophet's praying in al-Aqsa consolidates this bond between the first two places of worship built on earth. It also provides al-Âqsa with special significance as this is the only place known to us on earth where all the Prophets of Allah prayed together at one given time led by the final Prophet Muhammad (saw). The fact that all the Prophets were assembled together in al-Aqsa on this special night indicates the inclusive nature of Islam attested to by the Qur'an; "Say (O Muslims!), 'We believe in Allah and in that which has been revealed to us; in that which was revealed to Ibrahim, Isma'il, Ishaq, Ya'qub, and their descendents; in that which was given to Musa and 'Isa; and in that which

was given to the Prophets from their Lord'; We do not make any distinction between any of them..." (Quran

The fact that Prophet Muhammad (saw) led all of the other Prophets in prayer is a clear indication of his being a leader of all the Prophets and therefore a salient call to all humanity and the People of the Book to now come under the guidance of the final Prophet, Muhammad (saw).

For Muslims, the prayer by Prophet Muhammad (saw) in al-Aqsa declares the connection, firstly, between the Ka'bah and al-Aqsa, and secondly, between the Prophet (and thereby all Muslims) and al-Agsa. Leading the Prophets in prayer in al-Aqsa further signifies inheriting the legacy of the other Prophets, and the leadership of humankind.

### Praying in Al-Aqsa

Abu Darda' relates that the Prophet said, "A prayer in Makkah is worth 100,000 times; a prayer in my Masjid (in Madinah) is worth 1,000 times; and a prayer in al-Aqsa is worth 500 times more than anywhere else." [Al-Tabarani, al-Bayhaqi

and al-Suyuti] Anas ibn Malik relates that the Prophet said, "The prayer of a person in his house is a single prayer; his prayer in the Masjid of his tribe has the reward of twenty-five prayers; his prayer in the Masjid wherein the Friday prayer is observed has the reward of five hundred prayers; his prayer in Masjid al-Aqsa has a reward of five thousand prayers; his prayer in my Masjid (the Prophet's Masjid in Madinah) has a reward of fifty thousand prayers; and the prayer in the Sacred Masjid at Makkah has a reward of one hundred thousand prayers." [Tirmidhi and Ibn Majah]

### Internet Suspended

in Jammu and Kashmir.

In an order issued here this eve-Jammu district magistrate Sachin Kumar Vaishya ordered immediate imposition of prohibitory orders under Section 144 of the Code of Criminal Procedure that prohibits gathering of four or more people.

"Whereas, it has been made to appear to me by the inputs received from police authorities and also otherwise, that there is a likelihood of serious breach of peace and order and disturbance of public tranquillity which might cause grave danger to human lives and properties because of the disinformation that is being spread on social media platforms by posting/ sharing of derogatory, discriminatory and provocative messages.

"Whereas, it is desirable that any breach of peace and order and disturbance of public tranquillity which might cause grave danger to human lives and properties should be immediately prevented," the order read.

Exercising his powers, Vaishya prohibits individuals and social media platforms and portals operating in the district from posting or sharing any such post or message that has the potential to disturb the communal harmony, cause breach of peace and disturbance of public tranquillity.

"The order shall come into force with immediate effect and any violation of this order shall invite punitive action under Section 188 of Indian Penal Code," the order said.

While the Pahari community welcomed the Central government's decision to grant the community Scheduled Tribe status, a section of the Gujjars and Bakerwals have expressed their resentment against the move, claiming that the Paharis are

not scheduled tribes. Security has been beefed up in both Rajouri and Poonch districts having major concentration of Guijars and Bakerwals besides Paharis to maintain law and order, the officials said.

The federal agency had conducted searches at the premises of Bharat Papers Limited and various other locations on the basis of the material in its possession, including documents available on record, such as a copy of the FIR, an analysis of bank accounts and the company's directors.

The forensic audit report available on record has given strong reasons to believe that Aggarwal was involved in the process or activity connected with proceeds of crime and had committed an offence of money laundering, the officials said.

They said the investigation prima facie revealed that the company misused the sanctioned loan amount in a well-designed manner with a wellknitted conspiracy by siphoning off funds meant for business purpose for personal use and wrongful gains.

They said Aggarwal, one of the main directors of Bharat Papers Limited, was looking after the operations and finance of the company, as deduced from the statements given by other directors.

He was actively involved in perpetuating a fraud of Rs 200 crore on the consortium of banks and committed the offence of money laundering by siphoning off a part of the loan amount through bogus entities and illegal sale of machinery by raising bogus invoices, the officials said.

During the course of the investiation, the statements of Aggarwal were recorded on February 1 and February 6, wherein he chose to give evasive replies, which showed his non-cooperation in the investigation, they added.

The officials said the accused was involved in the process or activity connected with the proceeds of crime acquired through entering into a criminal conspiracy and cheating for siphoning off funds availed from the consortium of banks in the form of term loan and cash credit limits.

Notably, Paharis have been fighting for more than three decades for their inclusion in the Schedule Tribe (ST) category. The Lok Sabha on Tuesday also

passed a bill to provide reservation to Other Backward Classes in local bodies in Jammu and Kashmir. The bill seeks to provide reserva-

tion to Other Backward Classes in panchayats and municipalities in Jammu and Kashmir and bring consistency in the local body laws of the Union territory with the provisions of the Constitution.

"Even the sub-divisional police officer (SDPO) accompanied me to the (party) office like a criminal is being escorted. This is for the first time that the SDPO accompanied me from my house to the office to personally see that my vehicle does not take any other turn,"

reiterated his earlier assertion that democracy is not allowed to reach Jammu and Kashmir.

"We'll just keep our fingers crossed and hope that he can be out there and play. Even if it's not all the games, if we can manage him through 10 of the 14 games or whatever that might be then whatever games you can get out of him will be a bonus."

In case Pant is not able to fulfil wicketkeeping duties,

the 26-year-old could play as a pure batter or could be used as an Impact Player in the upcoming IPL, expected to begin in March.

"But I'll guarantee if I asked him now he'll say, 'I'm playing every game, I'm keeping every game and I'm batting at No.4.' That's just what he's like, but we'll keep our fingers crossed.

"He's such a dynamic player. He's obviously our captain. We missed him incredibly last year. If you understand the journey he's been on the last 12-13 months, it was a horrific incident. One that I know he feels very lucky to have even survived, let alone have the chance to play cricket again."

David Warner led the Capitals last season and Ponting confirmed that star Australian batter would be captain if Pant is unavailable to do the job.



### 2024 T20 WC Chief Promises Fans A Time To Remember

**NEW YORK:** The Twenty20 World Cup in June will be an unforgettable party with strong Caribbean flavours that will help plant cricket firmly in the US sporting land-scape, tournament director Fawwaz Baksh said.

Six Caribbean countries will cohost the tournament along with the United States, a market which cricket's powerbrokers see as crucial if it is to flourish beyond Commonwealth countries and become a truly global game.

New York, Miami and Dallas will host a combined 16 matches and Baksh is convinced the best way to inject cricket into a packed U.S. sports market is by making the global showpiece a grand party.

"When you pair up West Indies and USA, it's a recipe for success," the Guyanese sports administrator told Reuters. "We in the West Indies are known for a great time, we're

known for the party atmosphere. When fans come here and watch the games, they should expect that. "So come here to watch great cricket, but come here also to have

a great experience." Demand for tickets has been en-

couraging. Since the public ballot was launched last week more than 1.2 million applications from 126 countries were received within the

first 48 hours, Baksh said. That included 900,000 from the US and West Indies.



"Introducing cricket into the US, which is a new market to us, we weren't quite sure what the re-

sponse would be," he added. "We know there are quite a lot of expats in the United States and people from all across the world are interested in cricket.

"But to see this kind of response, it's very encouraging.'

The ninth edition of the T20 World Cup will be the biggest yet, with the increase to 20 teams from 16 opening up a wider pool of expatriate fans in the United States.

Poor attendance figures marred the 50-overs World Cup when it was staged in West Indies in 2007 but Baksh said Caribbean administrators had learned their lesson.

Ticket prices for this year's tournament start at only \$6. "If you want to introduce the sport in the US, if you want to revitalise cricket in the West Indies, you

have to get the fans here," he said. "And the only way you can

get the fans here is by making

tickets attractive, making them accessible.'

The 43-year-old believes the World Cup can set the standard for future global tournaments.

'We all wanted this tournament here, and we all want to capitalise on it," Baksh said. "When the tournament is over,

people all across the world will say T20 World Cup should only be hosted in the West Indies and the U.S.'.

"That's our goal and that's what we're going to make it.'

### Messi Plays In Tokyo Friendly, **But Inter Miami Lose**

**TOKYO:** After leaving fans disappointed in Hong Kong, Lionel Messi put in a 30-minute appearance in Tokyo on Wednesday in Inter Miami's latest exhibition match in Asia — although he still left some

supporters wanting more. Messi came off the bench for the final half hour, energized his teammates and probably had the best chance of the match in the 80th with two point-blank shots that were both stopped by the Vissel Kobe defence.

After a 0-0 draw in regulation, the match went to penalty kicks and

Vissel won the shootout 4-3. Messi did not take a penalty, however, which brought jeers from the crowd of 28,614 in Tokyo's National Stadium, which seats 68.000.

But, it wasn't close to the level of booing that broke out in Hong Kong after Messi stayed on the bench for the entire game with a groin injury. Some fans demanded refunds.

The Argentina star was contrite in a rare press conference in Tokyo on Tuesday as he addressed the public relations disaster. He had said he wasn't sure whether he would be fit enough to play in Tokyo and left fans guessing until he started warming up in the second half — drawing loud cheers from the crowd. Vissel hit the post twice in the first half and had by far the best chances in a match it largely dominated.

The match in Tokyo wrapped up Inter Miami's global promotional tour stretching from El Salvador to Dallas into Saudi Arabia and Hong Kong and ending in Tokyo.

Inter won only one of the six games. The Miami pre-season wraps up on February 16 in Florida against Newell's Old Boys, Messi's boyhood club from Rosario, Argentina. Many expect him to finish his career there.
