Every Year Spent In School Or University May Improve Life Expectancy: Lancet Study

■ very year spent in school or university may improve life expectancy, while not attending an educational institute could be as bad as smoking or heavy drinking, according to a study published in The Lancet Public Health journal.

The research identified data from 59 countries and included over 10,000 data points collected from more than 600 published articles.

The team, including researchers at the Norwegian University of Science and Technology (NTNU), found that education saves lives regardless of age, sex, location, and social and demographic backgrounds.

They found was that the risk of death drops by 2 per cent with every additional year of education. That means those who completed six years of primary school had a lower risk of death by an average of 13 per cent.

After graduating from secondary school, the risk of dying was cut by nearly 25 per cent, and 18 years of education lowered the risk by 34 per cent. according to the study.

Researchers also compared the effects of education to other risk factors such as eating a healthy diet, smoking, and drinking too much alcohol, and they found the

health outcome to be similar. For example, the benefit of 18 years of education can be compared to that of eating the ideal amount of vegetables, as opposed to not eating

vegetables at all, they said. Not going to school at all is as bad as drinking five or more alcoholic drinks per day or smoking ten cigarettes a day for 10 years,

the researchers said. "Education is important in its own right, not just for its benefits on health, but now be-

ing able to quantify the magnitude of this benefit is a signifi-cant development," said study co author Terje Andreas Eikemo

While the benefits of education are greatest for young people, those older than 50 and even 70 years still benefit from the pro-

tective effects of education, the researchers said.

They found no significant difference in the effects of education between countries that have reached different stages of development. This means that more years of education is just as effective in rich countries as in poor countries.

'We need to increase social investments to enable access to better and more education around the globe to stop the persistent inequalities that are costing lives," said Mirza Balaj, co-lead author and postdoctoral fellow at NTNU.

"More education leads to better employment and higher income, better access to health care, and helps us take care of our own health. Highly educated people also tend to develop a larger set of social and psychological resources that contribute to their health and the length of their lives," Balaj said.

Most of the studies reviewed for the study were from highincome settings, highlighting the need for more research in low- and middle-income countries, particularly from sub-Saharan and north Africa where data are scarce.

"Closing the education gap means closing the mortality gap, and we need to interrupt the cycle of poverty and preventable deaths with the help of international commitment," said Claire Henson, co-lead author and researcher at Institute for Health Metrics and Evaluation (IHME) at the University of Washington's School of Medicine, US.

"In order to reduce inequalities in mortality, it's important to invest in areas that promote people's opportunities to get an education. This can have a positive effect on population health in all countries," Henson added.

Writing By Hand Found To Enrich Brain Connections More Than Typing On Keyboard

Students learn more and remember better when taking handwritten notes than using a keyboard as brain connectivity patterns were found to be far more elaborate while writing than typing on a keyboard, a new research

Researchers said the findings suggested that the precisely controlled hand movements when writing with a pen helped obtain visual and movement information that contributed extensively to the brain's connectivity patterns, known to be crucial for memory formation and learning.

"There is some evidence that students learn more and remember better when taking handwritten lecture notes, while using a computer with a keyboard may be more practical when writing a long text or essay," said Audrey van der Meer, a brain researcher at the Norwegian University of Science and Technology and co-author of the study published in the journal Frontiers in Psychology.

For the study, the researchers recorded the electrical activity of the brains of 36 university students, who were repeatedly prompted to either write or type a word that appeared on a screen. When writing, they used a digital pen to write in cursive directly on a touchscreen. When typing they used a single finger to press keys on a keyboard.

The researchers found that the connectivity between different brain regions increased when participants wrote by hand, but not when they

On the contrary, the researchers found that repeating the simple movement of hitting a key with the same finger was less stimulating for

This also explains why children who have learned to write and read on a tablet, can have difficulty differentiating between letters that are mirror images of each other, such as 'b' and 'd'. They literally haven't felt with their bodies what it feels like to produce

those letters," said van der Meer.

Even though the study participants used digital pens for handwriting, the researchers said the results are expected to be the same when using a real pen on paper.

"We have shown that the differences in brain activity are related to the careful forming of the letters when writing by hand while making more use of the senses," explained van der Meer. The findings demonstrated the

need to give students an opportunity to use pens, rather than having them type during class, they said. Guidelines to ensure that stu-

dents receive at least a minimum of handwriting instruction could be an adequate step, they said. However, the team also cautioned

that it was important to keep up with continuously developing technological advances, which they said included an awareness of which way of writing - handwriting or typing - was advantageous under what kind of circumstances.

Polarized Pakistan Goes to Polls

Islamabad: Counting was underway Thursday after millions of Pakistanis voted in an election marred by rigging allegations and a shutdown of mobile phone services, while the country's most popular politician Imran Khan languished in jail.

Pollsters predicted a low turnout from the country's 128 million eligible voters following a lacklustre campaign overshadowed by the jailing of former Prime Minister Khan, and the hobbling of his Pakistan Tehreek-e-Insaf (PTI) party by the military-led establishment.

The Pakistan Muslim League-Nawaz (PML-N) is expected to win the most seats following Thursday's vote, with analysts saying its 74-year-old founder Nawaz Sharif has the blessing of the generals.

Adding to concerns about the integrity of the vote, authorities announced just before polls opened that they had suspended mobile telephone services across the country "to maintain law and order" after two blasts on Wednesday that killed 28 people.

Nighat Dad, a lawyer who runs the not-for-profit Digital Rights Foundation, said the outage "is an attack on the democratic rights of Pakistanis".

"Shutting down mobile phone services is not a solution to national security concerns. If you shut down access to information you create more chaos".

As per the documents, Jammu and Kashmir has a potential to produce 111050 MW of solar energy.

Throughout India Rajasthan ranks at the first place for having a potential to produce 142310 MWs of solar energy.

Jammu and Kashmir is followed by Maharashtra, Madhya Pradesh and Andhra Pradesh, which as per the document has a potential to produce 64320, 61660, and 38440

MWs of solar energy. Currently, Jammu and Kashmir has 27.25MW of installed capacity of solar power.

Pertinently, Ministry R e n e w a b l e Energy has embarked on a mission to install 175 GW of renewable energy capacity, which includes 100 GW from solar, 60 GW from wind, 10 GW from bio-power, and 5 GW from small hydro-power.

Dogs, Dogs Everywhere

e Valley continues to witness an alarming increase in dog bite cases. The surge in incidents has been attributed to the unchecked growth of the stray dog population and unscientific garbage disposal practices. In Srinagar alone, over one lakh stray dogs roam the streets, contributing to over 5,000 reported cases of dog bites in the last 10 months, with the numbers being particularly large in the summer capital.

The issue is not just about the physical harm caused by dog bites; it extends to the psychological and economic toll on the victims. A qualitative study conducted by the Department of Community Medicine at GMC Srinagar revealed the profound impact on dog bite victims, describing feelings of psychological and emotional instability, economic losses, and social detachment. The implications are clear - this is not just a public health crisis but a multi-faceted problem affecting the well-being of the community.

One of the root causes of this crisis is unscientific garbage $\,$ disposal practices and the unchecked growth of the canine population. Open dumping sites in Kashmir, combined with the absence of waste segregation and scientific disposal, have become breeding grounds for stray dogs. The lone garbage dumping site in Srinagar at Achan is overloaded, emitting pungent smells that make the lives of residents in Downtown Srinagar miserable. The proposed waste-to-energy plant, which could alleviate the burden, has yet to materialize despite six years passing since its announcement.

The situation is dire, and urgent measures are needed. The government must expedite the establishment of waste management facilities, ensuring proper segregation and disposal. There is a pressing need for the swift sterilization of stray dogs, particularly in areas with a high incidence of dog bites. Authorities in Srinagar are struggling to cope with the sterilization efforts due to a lack of infrastructure and manpower. It is imperative to address these logistical challenges promptly to control the burgeoning canine population.

The scenario in Kashmir mirrors a larger national issue, prompting the Supreme Court to take note and schedule hearings on the stray dog menace in February. The pending petition by the Animal Welfare Board of India challenges a 2006 judgment empowering local self-government institutions to cull stray dogs. The court must consider various perspectives, including the rights of animals and the concerns raised by local authorities regarding the increasing incidents of dog attacks, especially against children.

Addressing the menace of stray dogs in Kashmir requires a comprehensive and coordinated effort from the government, local authorities, and the community. Immediate steps must be taken to implement scientific waste management practices, expedite sterilization programs, and strike a balance between public safety and animal rights. The Supreme Court's involvement signals the need for a nationwide approach to this issue, emphasizing the urgency of finding sustainable solutions that protect both human and animal welfare.

High Tide Of Youth Unemployment

Joblessness among the youth cannot be addressed through fiat or mandating the filling of government jobs ahead of important assembly and national elections. lthough India is the world's fastest-growing large economy, it faces a serious challenge of dealing with joblessness, especially among the youth. Nothing illustrated this better than a cartoon in the Times of India pointing to good news on the jobs front as after UP and Haryana, five more states sought to join Israel's recruitment drive.

This pertains to 10,000 temporary jobs on offer in Israel's construction industry—facilitated by the Indian government—that has seen thousands of young men from the Hindi-speaking heartland scrambling for this lucrative opportunity with salaries of 1.4 lakh a month despite working in a war zone. "It is better to die working than perishing due to hunger," stated an applicant who is a post-graduate.

It is possible to interpret this drive as Indian nationals exploring opportunities in the global workplace due to shortages of semi-skilled and skilled labour. But this desperation to get out reflects a push factor stemming from the limited jobs in the government and private sector in the country. This can also take place illegally.

As many as 96,917 Indians were apprehended seeking to enter the US between October 2022 and September 2023, per United States Customs and Border Protection data. A better description of this reality is jobless growth. An adequate number of jobs for the youth are not being generated, despite economic growth projected to accelerate to 7.3% in FY 24. In other words, growth is not employment-intensive enough.

Unemployment is the biggest concern for educated youth who prefer to wait for better opportunities, unlike the poor who take up whatever is available. But this cannot be an indefinite wait and can erupt into violence, as has happened with the Agnipath scheme for recruitment into the army couple of years ago. That year also witnessed rioting in Bihar due to anger over the nontransparent and problematic hiring process in the railwaysmore than 10 million aspirants signed up for 35,000 openings. Six years ago, the state government of Uttar Pradesh received as many 2.3 million applications for 368 job openings as peons, including from doctoral and post-graduate candidates. These bleak prospects have also been observed in other states.

In urban India, the latest unemployment rate for those between 15-29 years of age is almost three times higher at 17.3% than the overall rate of 6.6%, according to NSSO's quarterly Periodic Labour Force Survey for July-September 2023. This is a current weekly status estimate that captures those who sought or were available for work during the reference period of a week preceding the survey. A growing reserve army of unemployed youth portends serious strains on the country's social fabric. As the electorate that swept the Narendra Modi-led Bhartiya Janata Party into power in 2014 and 2019 was predominantly young. from villages and small towns, the regime must expeditiously address the challenge of youth unemployment.

However, joblessness rarely figures in public discourse as some employment is being generated, even if such jobs are largely in the self-employment sector or pertain to casual wage labour in the urban informal sector. Much has been made of a steady rise in female labour participation—the share of those above 15 years of age who had a job or sought onein the latest official review of the Indian economy. In urban India, this is true for 2022-23 and July-September 2023, when it nudged up to 24% after remaining stable at 22% since 2019-20. There was a similar uptick in female employment rates that resulted in a lower unemployment rate of 8.6%. But these jobs have been largely of the self-employment kind, including as helpers in household

Back to the 15-29 age group, the quarterly PLFS data on males in urban areas hints at a discouraged worker effect of sorts, as some of them are opting out of searching for employment opportunities due to the paucity of suitable jobs. Estimating the real number of discouraged workers, however, is far from easy, as official surveys do not ask probing questions like whether workers are willing to seek work again it if were made available. Labour force participation rates have drifted down in July-September 2023 compared to July-September 2018. While there has been an increase in employment rates, there has been a sharper fall in the joblessness rate, suggesting that fewer young men are seeking work or are available for work to count as unemployed.

Joblessness among the youth cannot be addressed through fiat or mandating the filling of government jobs ahead of important assembly and national elections. There is a need for generating employment-intensive growth, besides labour reform and incentivizing India Inc to invest more to generate employment. More flexible labour markets through reform will help in a big way. There is evidence that states which reformed labour laws saw an increase in average plant sizes and higher employment in the organised manufacturing sector. This is the sustainable way forward to enable millions of people to shift from agriculture to manufacturing and services jobs in urban India and ensure they do not desperately seek temporary opportunities abroad, even in war zones, or enter countries like the US illegally.

Why Old School Writing is Better

housands of people now speak to their smart devices to make their grocery lists. Students are more likely to type out notes in class than write them down. And we often type or dictate calendar reminders into our smartphones instead of writing them on a wall calendar. In short, people across the globe and in a wide variety of settings primarily use digital devices to record the things they want to remember.

It turns out, that may not be a good thing. A substantial body of evidence demonstrates that handwriting stimulates different and more complex brain connections that are essential in encoding new information and forming memories.

The most recent study supporting this idea was published last month in the journal Frontiers in Psychology. Researchers in Norway asked university students to write individual words either using a digital pen on a touchscreen or using a single finger to type all while measuring electrical activity in their brains using a high-density electroencephalogram (EEG).

They found that brain con-



nectivity patterns were far more elaborate and widespread for participants who wrote by hand compared to those who typed. This suggests that the precisely controlled hand movements that

occur when writing lead to spatial and temporal patterns in the brain that promote learning.

This study adds to a large body of previous research that finds handwriting activates the brain

in ways that other forms of recording information do not.

A 2022 systematic review conducted by a doctoral student at the University of Louisville combined data from 33 studies to evaluate whether taking notes by hand versus typing affected how students performed on tests. The review found that students who took handwritten notes scored significantly higher on quizzes

about that material compared to students who typed notes.

But you don't have to be a student to benefit from handwriting. A 2021 study by Japanese researchers found that participants who recorded calendar event information on paper calendars demonstrated more brain activity than subjects who recorded the same information onto a smartphone when they tried to remember details about the information later. In addition, the participants who wrote in their calendars recalled the information 25% faster than those who typed it into a smartphone.

In addition, earlier research demonstrates that handwriting is essential in children's brain development. This study asked five-year-old, preliterate children to write, type, and trace letters while undergoing functional MRI scanning. The students who wrote by hand were the only ones who demonstrated brain activity in a circuit of the brain used in learning to read.

The take-home message: If you need to remember something, write it down! There is clear evidence that the act of writing helps us to learn and remember.

CRACKS DOWN ON DRUG PEDDLERS

Police Seizes Properties Worth Millions

SRINAGAR: Jammu and Kashmir police has tightened its noose on the drug peddlers by booking the big sharks under Narcotic Drugs and Psychotropic Substances (NDPS) act as it has seized movable and immovable properties of those involved in drug trade besides freezing a large amount of cash. The police move has evoked a great response from all sections of the society with people hailing the move widely.

Figures available with the news agency, suggest that 15 vehicles and gold coins worth Rs 10.66 lakh were recovered and seized in 2023. "Of this, four vehicles were seized from the Jammu region with cash worth Rs 28. 10 lakh was also freezed," the figures reveal.

Similarly, while continuing its war against narcotics, seven houses and 21.5 malras of land was seized in Kashmir where Rs 238 lakh were also freezed. "Anti-Narcotics Task Force (ANTF) also seized one house and four malras of land in Kashmir last year," the figures reveal.

In total, 15 vehicles and gold coins worth Rs 10.66 lakh were seized under NDPS in 2023 besides eight houses and 21.9 malras land also attached under NDPS. "In total, cash worth Rs 296 lakh were recovered and freezed," the figures reveal.

A senior police official said that

along with the NDPS, police are acting tough against big fish involved in supplying and distributing drugs among youth in J&K. "Special police teams have been constituted to crack the gangs and nexus among suppliers and dealers. Focus is to ensure stern punishment those involved in spreading this poison among vouth of J&K," he said, wishing not to be named.

From seizing the properties including movable or immovable and freezing the cash earned out of the sale of narcotics, NDPS act is coming handy in dealing with the narcotics dealers, suppliers and distributors. "We want to set an example by ensuring the stern punishment to those involved in this drug trade so that it is rooted out from the society forever," he officer said.

After last year's success, police teams continue their efforts of reaching out to the big fish to crack the whip on the narcoterrorism in J&K. Meanwhile, locals have hailed the police action against drug abuse in J&K stating those involved in the supply chain should be booked under NDPS and sternly punished. "As far as this action is concerned, we are with the police every time. Our support is for the police as drug menace is eating our young population. Youth are falling prey to drugs at a great speed. Booking big fish under NDPS is a great move," a group of people from Srinagar's downtown told KNO.

J&K Witnessed Driest, Warmest January In 43 Years

SRINAGAR: Several parts of Jammu and Kashmir, including Srinagar city, witnessed the warmest January in 43 years, the Meteorological Centre Srinagar's data said.

In terms of snowfall or rains, Srinagar city witnessed the second driest January in the past four decades, recording a mere 3.0 mm of precipitation in the month this year, it said.

The lowest precipitation in the summer capital of Jammu and Kashmir was recorded in January 2018 when only 1.2 mm of rainfall or snow took place.

According to data, the mean Tmax (maximum temperature) recorded in January over Sri-nagar station was 11.9 degrees Celsius while for Gulmarg in north Kashmir and Banihal in Ramban district, it was 5.7 degrees Celsius and 16.9 degrees Celsius respectively.

Jammu city recorded the lowest mean maximum tempera-



ture for the first month of the year in over four decades, it said. This is the highest mean

maximum temperature for the month of January for these stations in the past 43 years, the MeT centre said in a post on X.

"2024 January was one of the driest and warmest January in the last 43 years for most of the stations of J-K except the stations of plains of Jammu (Jammu, Samba and Kathua)," it added.

It said Jammu station, on the

other hand, observed a mean maximum temperature of 13.4 degrees Celsius in January which is the lowest since 1983.

The mean minimum temperature for January observed over Srinagar, Jammu, Gul-marg and Banihal were minus 3.2 degrees Celsius, 5.5 degrees Celsius, minus 3.9 degrees Celsius and 0.1 degrees Celsius respectively. "The 2024 mean Tmin is one of the highest for Gulmarg in the last 43 years," the MET centre said.

GMC Srinagar Receive Around 7,000 Cancer Patients Since 2017

'1,640 Cases Registered In 2023 Alone'

SRINAGAR: The number of cancer patients is on the rise in Jammu and Kashmir as around 7,000 patients have been registered alone at the Department of Radiation Oncology, SMHS Hospital GMC Srinagar since 2017.

Official statistics revealed that 1640 cases of cancer were reported at the Radiation Oncology Department in 2023, which is the highest in the last several years.

491 new cancer patients were registered at the radiation oncology department, SMHS in 2017; 1,032 in 2018, 801 in 2019, 650 in 2020, 1,010 in 2021, 1,169 in 2022 and 1,640

in 2023. Officials said that around 5 to 6 new cancer patients are being registered at the depart-

As far as breast cancer in females is concerned, one of the major reasons is the lack of physical activity and obesity. 'So both the common cancers, whether it is lung in males or breast in females, could be easily avoided if we make the change in lifestyle," Prof Ahmad said.

He called for public awareness through signs and symptoms of cancer, preventive measures and timely medical evaluations.

He said that the OPD of the department remains functional for six days (Monday-Saturday) from 10 am to 4 pm where the consultant along with senior resident and PG student remains available.

"After checking the relevant reports in the OPD, patients are registered and data is digitized," he said, adding that there are two separate units where patients are being admitted and four consultants along with senior residents remain available in each of the wards.



Girona Still Believe Ahead Of Top-Of-The-Table Clash With Real Madrid

MADRID: When Real Madrid lorded it over Girona with a 3-0 win at the snug Estadi Montilivi in September it looked as though the Catalan upstarts had been firmly put in their place and that their audacious LaLiga title hopes had been fantasy all along.

Scroll forward more than four months from that defeat, however, and the club many thought would most likely be in a relegation battle are still toe-to-toe with Carlo Ancelotti's starstudded Real side, who they trail by two points.

Girona have gone 15 league games unbeaten since that setback, winning 11, and on Saturday can dislodge Real from top spot if they pull off a famous win at the Bernabeu Stadium. Girona manager Michel has been at pains to play down his side's chances of shattering the status quo in Spanish football by winning the title only seven



years since the humble club first played in LaLiga.

After all, the last club other than Real Madrid, Barcelona or Atletico Madrid to finish top was Valencia 20 years ago and they were hardly regarded as underdogs. But for neutrals, and those desperate for a new narrative, Girona's challenge to the elite has been a breath of fresh air.

Girona may be part of the same City Football Group stable as English and European champions Manchester City but they operate in another universe in terms of financial firepower. Michel has constructed a youthful squad with an attacking style that is easy on the eye.

GOALS GALORE

Ukraine striker Artem Dovbyk, badly missed in last week's 0-0 home draw with Real Sociedad but likely to play, has a league-leading 14 goals this term, the same as Real's Jude Bellingham, while Girona's total of 52 is

unmatched in LaLiga. Brazilian winger Savio has also been earning rave reviews and will be off to

Manchester City at the end of the season, but Girona's main strength is their unity and team spirit -- fitting for a club from a fiercely patriotic Catalan city. They have earned 22 points from losing positions this season and whatever happens on Saturday, Michel's intrepid side will not be throwing in the towel.

A sense of injustice could also fuel their desire this weekend after some controversial decisions against Sociedad. They had a Yangel Herrera goal ruled out for offside by VAR even though the offence took place 37 seconds earlier.

Midfielder Herrera was also booked, meaning he misses Saturday's clash along with experienced defender Daley Blind, while Michel will be absent from the touchline after being sent off for expressing his frustration. Near the end of the draw, Girona's fans chanted 'Asi, asi, asi gana Madrid' which translates as 'That's how Madrid win'.

Man City Eye Top Spot In Three-Horse Title Race As Everton Trip Looms

MANCHESTER: chester City can top the Premier League for a few hours at least if they beat Everton at home on Saturday and Pep Guardiola's side are firm favourites to end the season there.

But a record fourth successive English league title is perhaps not the foregone conclusion some are predicting. Phil Foden's hat-trick inspired City to a 3-1 victory at Brentford on Monday -- City's fifth league win in a row - to put them two points behind Liverpool with a game in hand.

It all feels ominously familiar with City looking capable again of the long winning streak that ultimately grinds down those seeking to end their domination of the top flight. "It does feel at the moment as though Manchester City winning the title is a formality," former Arsenal striker Alan Smith said.



"But Pep Guardiola and City certainly won't be taking anything for granted.

"Anything can happen and injuries could always knock them off balance but maybe that is wishful thinking!" According to entertain-

ment data experts Gracenote, however, City are still only 57% likely to win the title.

The reason being is that this time there appears to be a genuine three-horse title race after Arsenal's superb victory over leaders Liverpool last weekend. Only on nine occasions since the formation of the Premier League in 1992 have two points separated the top three at least 23 matches into a season. And the way all three

clubs are playing -- assuming Liverpool's belowpar display in London was just a blip -- it could stay tight at the top right into the climax of the season. Liverpool will hope that relegation-haunted Everton can throw a spanner in City's works on Satur-

"It's important that we get back on track straight away. We have to try to do that," Andy Robertson, who is fully aware of the small margins for error in a title chase with City, told Liverpool's website on Thursday.

"We've got to show everyone it was a one-off and hopefully we kick on for the rest of the season.' Arsenal celebrated loudly after their defeat of Liverpool, earning some scorn from pundits.

But there is no doubt that after a loss of form at the start of the year, the Gunners looked back in the groove and capable of staying with City and Liverpool. The pressure will ramp up on a weekly basis though and playing last of the three this weekend away at London rivals West Ham United -- will be a test of their nerve.
