New Delhi: Lieutenant Governor Manoj Sinha on Saturday praised Prime Minister Modi's vision of making the country future ready and said his administration has evolved its own version of good governance under the broad guiding principles and strategy called "future-ready governance".

"I like to sum up in just three terms of two words each making a total of six words - future driven, tech assisted and human centric - and we have developed powerful conceptual framework clearly specifying what each of these terms mean and how they are integrated creating a futuristic model for good governance," he said.

### **Raids At 15 Locations**

Srinagar: National Investigation Agency (NIA) on Saturday conducted raids at 15 locations across Jammu and Kashmir as part of its crackdown on the proscribed Jamaat-e-Islami (Jel) in a terror funding case, an official said.

The raids in the twin capitals of Srinagar and Jammu along with Budgam in central and Kulgam and Anantnag in south Kashmir led to the seizure of incriminating documents and digital devices connected with the activities of JeI and its related Trusts and more than Rs 20 lakh, a spokesperson of the federal agency said.

However, official sources said two persons were also detained in Jammu for questioning during the raids targeting a private school and its functionaries including chairman at Gujjar Nagar and Shaheedi



chowk in Jammu.

They said the residences of former Jamaat chief Sheikh Ghulam Hassan and another leader, Sayar Ahmad Reshi, in Kulgam district were among those raided.

The Jamaat-e-Islami Jammu and Kashmir was banned by the Centre for five years in February 2019.

The spokesperson said NIA teams swooped down on the premises of various suspects at five locations in | More on P6

### PM Modi to Visit UAE To Open First Hindu Temple

New Delhi: Prime Minister Narendra Modi will pay a two-day visit to the United Arab Emirates (UAE) beginning Tuesday during which he will hold wide-ranging talks with President Sheikh Mohamed bin Zayed Al Nahyan and inaugurate the first Hindu temple in Abu Dhabi.

It would be the prime minister's seventh visit to the UAE since 2015, the Ministry of External Affairs (MEA) said on Saturday, announcing the trip.

Modi and Al Nahyan will discuss ways to further deepen, expand and strengthen the strategic partnership between the countries and exchange views on regional and international issues of mutual interest, it said.

### **Pakistan: Elections Fail To End Political Instability**

New Delhi: The February 8 elections have failed to end the political turmoil that has plagued Pakistan for almost two years.

Pre-election opinion polls had predicted a clear win for former Prime Minister Imran Khan's Pakistan Tehreeke-Insaf (PTI) party in the 342-strong National Assembly, Pakistan's lower house of parliament. But the incarcerated ex-premier's party failed to secure a simple majority, according to unofficial results.

PTI-backed candidates are projected to win a little over 100 seats, while Khan's main rival and three-time former Prime Minister Nawaz Sharif's Pakistan Muslim League is likely to bag around 80.

The Pakistan People's Party, headed by Bilawal Bhutto-Zardari, has outperformed expectations by securing 50 to 60 seats and will likely be able to get the prime minister of its choice.

In the coming days and weeks, the Muslim-majority South Asian country will see intense political negotiations for a coalition government.

As Khan's candidates contested the polls as independents because the Supreme Court decided to take away their electoral symbol, their loyalty to their leader will now be tested. | More on P6

## Beyond Basics ASER 2023 Unveils Urgent Challenges in Indian Education System

he Annual Status of Education Report (ASER) 2023, unveiled on January 17, 2024 by Pratham Education Foundation, has become a crucial benchmark in assessing the elementary educational landscape of India. This report, conducted across 28 districts spanning 26 states, has brought to light some staggering revelations that demand immediate attention. While the ASER 2023 reports a commendable

increase in the enrolment ratio for children aged 14-18, standing at 86.8%, it is imperative to acknowledge that this figure falls significantly short of the 100% target. Moreover, the focus should extend beyond sheer enrolment numbers to address the glaring concerns regarding the quality of education imparted.

#### Some staggering revelation

The report reveals that a substantial 25% of students within this age group struggle to read a standard II level text fluently in their regional languages, indicating a critical gap in foundational literacy skills.

Moreover, only 57.3% of students demonstrate proficiency in reading sentences in English, with nearly three-quarters of them unable to comprehend the meaning of the text. The deficiency in basic mathematical skills is equally concerning, as demonstrated by the fact that only 39% of youth can accurately measure length using a scale when the starting point is not zero. A mere 43.3% can successfully solve division problems involving three digits by one digit. These revelations underscore the urgent need for a comprehensive overhaul of the educational framework to ensure a holistic and effective learning experience.

Compounding the challenges identified in the ASER 2023 is the disconcerting gender gap, particularly among 18-year-olds, reaching an alarming 32.6%. This discrepancy in educational opportunities between genders is not only an affront to the principles of equality but also poses a significant hurdle in achieving a more inclusive and equitable society. Addressing gender disparities in education is crucial to harnessing the full potential of the nation's human capital.

The ASER 2023 report sheds light on another critical issue – the lack of interest or viable avenues for vocational courses. Merely 5.6% of students in the 14-18 age group opt for vocational training or related courses. Recognizing the pivotal role of vocational education in preparing students for practical skills and employability, there is an urgent need to expand and promote vocational training programs, fostering a symbiotic relationship between education and industry needs.

A disconcerting trend highlighted in the report is the pervasive use of phones for entertainment activities among the youth. Nearly 80% of students in this age group use their phones primarily for non-educational purposes such as listening to music and watching movies. While technology can be a powerful educational tool, its overuse for entertainment detracts from academic pursuits. It is crucial to instill responsible and educational

#### Career aspirations of Kashmir youth

The Annual Report has shed light on the aspirations of the youth in Anantnag district, surveying 1200 households across 60 villages. The comprehensive study, encompassing 1410 youths aged 14-18, reveals a diverse spectrum of career ambitions and future goals. With 353 males and 483 females surveyed in the 14-16 age group, and 231 males and 343 females in the 17-18 age group, the findings provide a holistic understanding of the youth's aspirations.

The survey uncovered a myriad of career aspirations among the youth, offering valuable insights into their dreams and ambitions. Notably, a significant percentage of youths aspire to enter public service, with 5.9% of males and 7.4% of females aiming for the prestigious Indian Administrative Service (IAS), and 1.6% of males and 2% of females eyeing the Indian Police Service (IPS). Furthermore, aspirations for careers in teaching, medicine, and the military were prominent, with 8.8% of males and 11.6% of females aspiring to become teachers, and a substantial 31.3% of males and 41.7% of females

males and 7% of females aiming for positions in the Army, 4.1% of males and 3.6% of females expressed a desire to join the police force. Additionally, aspirations for engineering careers were evident, with 8.1% of males expressing interest.

#### The way forward

To overcome the challenges illuminated by the ASER 2023 report and pave the way for a Viskat Bharat by 2040, strategic interventions must be employed. The ASER 2023 report underscores pressing issues in India's education system, and overcoming these challenges requires strategic interventions. To pave the way for a Viskat Bharat by 2040, the following strategies can be implemented:

Quality Improvement Initiatives: Teachers are the bedrock of education. Only well trained teachers can lay foundation for a robust education system. Teacher training programs should be implemented, focusing on innovative and student-centric pedagogies aligned with the NEP 2020's emphasis on competency-based education. Continuous professional development ought to be introduced to keep educators abreast of the latest teaching methodologies and technological advancements. Teachers should be encouraged to integrate critical thinking, problem-solving, and creativity into the curriculum, fostering holistic learning experiences. with the NEP 2020's vision, emphasizing foundational literacy and numeracy skills. Interdisciplinary learning modules ought to be introduced to promote a comprehensive understanding of subjects. A learner-centric approach should be fostered, providing flexibility in choosing subjects and encouraging a well-rounded education.

Remedial classes should be launched for students facing challenges in foundational literacy and numeracy. Peer learning and collaborative activities should be promoted to address individual learning gaps. Technology ought to be utilized for personalized learning, offering adaptive content to cater to diverse learning needs.

Gender-Inclusive Education Policies: Policies should be implemented that actively promote gender equality, aligned with the NEP 2020's commitment to education for all. Girls' education initiatives ought to be established, providing targeted support to bridge the gender gap among 18-yearolds. Communities should be sensitized on the importance of gender parity in education, fostering a culture of equality. Revitalizing Vocational Education: Voca-

Revitalizing Vocational Education: Vocational training programs should be expanded in accordance with the NEP 2020's emphasis on promoting vocational and skill-based education. Collaboration with industries should be prioritized to design relevant and updated vocational courses that align with emerging job market needs. Also, digital literacy should be integrated into the curriculum, empowering students to use technology responsibly for educational purposes.

Community Engagement: Active involvement of parents in their children's education should be encouraged through community-driven initiatives. Partnerships between schools and local communities ought to be established to address specific educational challenges.

Moreover, a robust monitoring and evaluation system should be implemented. The impact of interventions should be regularly assessed, and strategies ought to be adjusted based on feedback. Transparency should be promoted by sharing progress reports with stakeholders, fostering a culture of accountability.

ot very long ago, the Republican presidential race in the US looked packed with four frontrunner candidates: Donald Trump, Nikki Haley, Ron DeSantis and Vivek Ramaswamy. In the last few weeks, the US presidential race has gradually entered a more decisive phase.

Although neither the Democratic nor the Republican camp has finalised their presidential candidate, the Iowa Caucus, the New Hampshire Republican primary, and the most recently-held Nevada Caucus may have imparted some perspicuity. Trump is leading as the Republican presidential candidate on the back of his victory in all the three.

Trump's win over Haley in New Hampshire is widely seen as the end of the road for the latter, quite in line with the political trend associated with New Hampshire. In 1968, a poor show in the New Hampshire primary forced president Lyndon Johnson to quit his presidential campaign.

Since 2001, the New Hampshire Republican primary has correctly predicted the Republican candidacy for the president every year. The South Carolina primary on February 24 will be critical for Haley, that being her native state where she has served as Governor from 2011 to 2017.

In the Democratic camp, Pre sident Joe Biden may be facing little resistance from his Democratic peers but a latest 345-page special counsel report from the Department of Justice has not only raised questions about Biden's 'poor memory' but his handling of classified documents. Robert F Kennedy Jr and Cornel West running as Independents and Jill Stein from the Green Party have not yet been able to make any mark.

A Biden-Trump rematch seems the most likely outcome of the primaries and caucuses which are lined up running up to the national elections in November this year.

# A Trump Reprise?

Trump needs 1,215 delegates to secure his nomination from the Republican Party and he looks on his path to secure it without much difficulty, leading with 62 delegates. Not for the first time, the Republican party has rallied behind Trump who now commands support of his loyal voters as well as Republicans in the Congress. Perhaps, his legal hurdles might be the only impediment preventing his nomination or his victory.

However, polls have indicated that Trump's support has soared despite his numerous indictments. In fact, there is growing pressure on Haley to drop out of the presidential race before the primary in her home state of South Carolina on February 24.

The New Hampshire voting pattern, however, revealed that a section of independent voters, college-educated voters, and Republicans who see the January 6 Capitol riots as an act of insurrection by Trump and believe he should be legally answerable for the same. This faction voted for Haley. It remains to be seen whether this chunk of voters will shift their votes or skip voting altogether should Trump secure his nomination.

The Republicans are confident that a majority of the voters from their party will vote for Trump.

Among Trump's advantages is the fact that he is a known entity for American voters and they know what to expect should he come to the helm.

A major swing in Trump's support has come

from rural America, where his candidacy is being seen as a factor for against immigration, making them turn their backs on the Democrats. Although this trend may be a nationwide phenomenon, perhaps the shift in Iowa is the most stark—it turned from a swing state to a Republican stronghold.

Meanwhile, President Biden has laid out his reason to run against Trump entirely on the latter being his opponent by saying, 'we cannot let him win.' In a recent speech, he underscored that democracy is a 'central cause' of his presidency. While his democracy vs autocracy trope remains a primary pivot of his campaign and distinction from Trump, that the latter presents an existential threat to US democracy in his second term may not have resonated with the voters in the same way that the Democratic party wanted it to.

Biden's political campaign may not have gathered the momentum and uproar that it should have and appears blunted by various factors. These range from his age, casting doubts over his ability to act as President for the next term to a seemingly failed immigration strategy. As much as 6.3 million incidents of migrant encounters have been reported since Biden took office in January 2021. In both Iowa and New Hampshire, voters have rated immigration at par with economy in its importance as an election issue. Trump has left no stone unturned in ensuring that he paints Biden as a president who is responsible for an unprecedented flow of migrants to the US. In his campaign, Trump has taken his 2016 narrative centred on building a wall on the US-Mexico border to another level by saying that immigrants are 'poisoning the blood of our country'.

Trump vs Biden is a rematch that most Americans do not want, but they have little choice. In one of the recent polls, Biden is trailing Trump by 6 percentage points in a 34-40 tally. Political pundits have pointed out that Biden's campaign should look beyond Trump. Biden's latest plan is to launch an offensive campaign by attacking Trump and his central campaign themes such as abortion rights, attack on personal freedom and rely on social media, influencers and celebrities, including Taylor Swift, to turn the polls in his favour.

A politically ascendant Trump has engendered a range of concerns and feelings both domestically as well as externally. Globally, a Trump presidency would significantly change the course of US foreign policy from the trajectory it has followed under the Biden administration. Of particular interest would be how a Trump presidency deals with the ongoing wars in Europe and the Middle East, a consolidating China-Russia-Iran-North Korea axis and the resultant fractured world order. If his campaign speeches and past presidency are anything to go by, Trump would curb US aid to Ukraine, weaken the trans-Atlantic alliance and enfeeble its global alliance network, all in the name of 'Make America Great Again'. And predictably, the unpredictability associated with his last term will return to haunt an already battered global geopolitical landscape.

## **Connoisseur of Tradition** Zulfiqar Ali's Effort to Preserve Kashmir's Art and Heritage

**B**orn into a family steeped in the rich tradition of pa-pier mâché crafter pier mâché craftsmanship, it was only obvious for Zulfigar Ali to become a connoisseur of Kashmiri heritage arts. Particularly renowned for his collection of exquisite Kashmir shawls and timeless artifacts, he has a deep connection with Kashmir's heritage, education and the pursuit of artistic excellence.

In a freewheeling chat with Kashmir Observer's reporter Syed Mohammad Burhan, Baba recounts the trials and triumphs of carving his own path and commitment to preserving and promoting the artistic legacy of his homeland.

Transitioning from his early vears in Kashmir to embarking on a transformative adventure in the United States, with meticulous attention to detail, he offers a glimpse into the intricate history and craftsmanship behind each treasured piece in his collection, ranging from opulent Kashmir shawls to finely engraved silver and copper artifacts.

#### PLEASE TELL US ABOUT YOURSELF AND YOUR LIFE

I was born and raised in Hassan Abad, as the youngest child of Mohammad Qasim Baba. My near-ancestors were papier mache artists and my father, had through years of relentless struggles and hard work, built a very successful Papier Mache business, which was called M. Qasim and Brother. Sadly, the business no longer exists but its impact hasn't faded from the memory of those who were associated with it.

I started my schooling in Burn Hall School, which was followed by Islamia College and then the University of Kashmir, where I graduated with a master's degree in Commerce. Unlike the children of most businessmen at the time, I was very dedicated to my education and was fortunate to be recognized with five gold medals for academic excellence. After finishing mv Master's Degree, I was offered a lectureship in the University. I was offered a Lectureship at the University's Commerce Department but I could not continue beyond two semesters because I left for the US to pursue

with business transformation initiatives.

On a personal level, life in the US has been a life altering experience - and in a positive way, without requiring me to compromise my identity. I have always lived in small

towns in Washington State (not Washington DC) where I first landed, primarily because its environment, geography and climate are similar to that of Kashmir.

#### WHAT HAS BEEN YOUR STORY WITH **HERITAGE ARTS?**

Historically, the collection of antiques and artifacts is a luxury that is indulged in, by a privi-leged few, who take a fancy to the arts of far-off 'exotic' lands and have the means to acquire and store it. I acknowledge that it is through the efforts, contributions and generous museum donations of such collectors, that these antiquities and art forms were saved for posterity and continue to be a source of education and wonder to our generation. With that said, I do consider myself as a member of that group because, for me, my collection is a part of my own heritage, my connection with it is very personal and my goal is not limited to its preservation and display. Besides, I have relied on my own research and education to curate and speak to the age, history, design elements a n d

materials of m



early 1900s, as well as a selection of etchings capturing the essence of Kashmir's scenery, people, artisans, and significant events from the 19th century, found within English and French newspapers.

#### WHAT IS THE INSPIRATION BEHIND **YOUR COLLECTION?**

Well, as I mentioned, I have always had an interest in history and in art. Not surprising, growing up, I was keenly aware of the quality of my father's Papier Mache and was sensitive to the craftsmanship involved in the various art forms of Kashmir. Once I came to the US that appreciation only

I recall seeing a Kashmir shawl in a museum in Seattle, Washington and being mesmerized by it. Shortly thereafter, I bought a book called Pashmina, from a bookstore called Kashmir Bookshop on my visit to Kashmir. With that, began my journey of researching and studying the history of the heritage arts of Kashmir, particularly the Kashmir shawl. And the more I studied, the more my interest and fascination grew because I became more and more aware of the extraordinary skill, imagination and artistic excellence required to produce the art forms of Kashmir, particularly, the of pre-1870s Kashmir shawls. As my research revealed the miseries inflicted upon the poor shawl weavers by successive dynasties that ruled Kashmir, I felt an obligation to share with the world the wonders that they had produced, despite their suffering. I felt drawn to give a voice to these voiceless heroes of Kashmir's artistic past. I asked myself - if I don't preserve whatever little is left of Kashmir's artistic legacy, who will? So, when I got my first real job, I started to pour every cent into collecting and continuing my research on the various art forms of Kashmir. It has become my greatest passion and I continue to collect and learn, as I continue on this journey.

wonders. These include the artist who envisioned and painted the design, the person who converted the design into a talim from which the weaver could weave, the dyer whose dyes were so rich that 250 years later, they still retain their brilliance. the darners who joined several pieces together to make a shawl without letting the slightest hint of the seam show on the face of the shawl, the Purzagur who finished the shawl and the washerman who washed the shawls without the aid of chemicals and softeners - all of which culminated in a textile that fascinated the likes of King Akbar, the Deccan emperors in India and the wife of Napoleon and members of royal courts across Europe. I must add here that I am re-

ferring to the shawls that were made in the 1800s, which are near-impossible to reproduce in

tion with a close family member who, when I shared these sentiments with, said, "Well, he provided those craftsman with rizq" and I responded, "No, it was the craftsman who were the source of his rizq. Without them, there would be no business". And today, when I speak to any of his craftsmen, I express my sense of gratitude for their immeasurable contribution to my life.

Having said that, I don't claim to be a social activist and can't really comment on the current situation of craftsmen in Kashmir. You can judge me on this subject if I ever start a commercial venture with Kashmir crafts.

#### WHAT ARE YOUR GOALS WITH **REGARD TO YOUR COLLECTION?**

The endeavor to educate individuals about the Kashmir (Cashmere) shawl and its rich history is not merely a quest for knowledge but a journey into the intricate tapestry of human narratives interwoven with threads of tradition and craftsmanship. It aspires to elevate the Kashmir shawl from its understated status to its rightful place among the world's most exquisite textiles, rekindling appreciation for its unparalleled beauty and artistry. In doing so, it seeks to not only showcase the splendor of Kashmiri art but also to foster a renewed sense of pride and inspiration among the present generations in Kashmir, India. encouraging them to explore these art forms as viable career

Unfortunately, in Kashmir or in other parts of India, I have not received any support or even encouragement to share my collection. After all, the art belongs to this country and my fellow countrymen, should have the first privilege to see and admire their heritage. And this is not for lack of trying. I have made several attempts to reach the right authorities in Kashmir and also reached out to institutions in other cities including the National Museum in New Delhi but they have shown little interest or support.

It has been very disheartening but my struggles have made me even more determined to realize my vision. But, as Ghalib, ever so eloquently said-

#### COULD YOU SHARE SOME INSIGHTS INTO THE HISTORY AND **CRAFTSMANSHIP BEHIND KASHMIRI** SHAWLS AND OTHER ITEMS IN YOUR **COLLECTION?**

When I talk about Kashmir shawls, I am talking about the shawls that were made before the end of the 19th century (1870 or so). These Kashmir shawl were a luxury textile that was largely limited to the royal courts of India, the Middle East, Russia, the UK and Europe and later to the wealthy landed class of India and the West. There were many reasons for that. The foremost reason, of course, was the extraordinarily fine fiber (pashmina) that these were made from, giving them a softness and drape that surpasses the finest silks of the world. Second, the Kani weaving technique, which is unique to Kashmir and required years of training and skill, allowed the weaver to create highly complex patterns that would be near-impossible to be executed on a geometrical loom.

Finally, the knowledge and techniques of several highly skilled craftsmen had to align in perfect harmony to create these

**AS THE SON OF A PROMINENT BUSINESSMAN IN THE KASHMIRI** ART INDUSTRY, HOW DO YOU NAVIGATE ADVOCATING AGAINST THE EXPLOITATION OF ARTISANS WHILE STILL HONORING YOUR FAMILY'S LEGACY?

The only way to answer this question is to be honest and avoid the exaggerated deification of those who are no longer in this world. While I am very proud of my father's legacy and humanity and consider myself fortunate that I imbibed some of his values, I also recognize that he was part of the business system that existed at his time. He paid the craftsmen well and dealt with them with fairness and honesty but the system was such that the financial advantages leaned heavily in favor of the businessman veralternatives. This endeavor is a pivotal step towards the revival of the originality, quality, craftsmanship, and sincerity that once epitomized the artistic legacy of Kashmir, ensuring its legacy continues to flourish in the modern world.

#### WHAT HAS YOUR JOURNEY **TOWARDS YOUR GOALS BEEN?**

Trying to share my collection and the story associated with it has been a struggle. However, I have been able to share a sample of my collection and deliver a lecture, especially on Kashmir shawls in several institutions in the US, including the Museum of Fine Arts in Houston and The Textile Museum in Washington DC. I am also scheduled to deliver a lecture at the Smithsonian and a few other institutions during the fall of this year.



I am fighting a one-man-war to elevate the status of the Kashmir shawls of the 19th century and before, to its rightful place, as one of the finest, if not the finest textile of the world. And this is not based on an emotional assessment but is firmly rooted on years of research and objective analysis. Further, this was no accident. Rather, it was the culmination of artistic and technical excellence achieved over centuries and practiced with a deep sense of relevance by a people who did not compromise the excellence of their skills, despite the suffering they endured, ironically, for these very qualities.

The other, even more important message that I want to convey to the world is that the story of India (and of other colonies of UK and Europe), has mostly, if not always, been told by the colonists. Same is largely true of its history and the arts. This trend continues to this day where most of the 'experts' on Kashmir shawls are European, American or English - with a few exceptions. I am truly grateful to them, because it is only due to their efforts and hard work that I was able to learn about the history of my own heritage. reason for the increasing frequency of avalanches," Romshoo said.

He further pointed out that areas like J&K and Ladakh have witnessed numerous casualties, both civilian and military, due to avalanches in recent times.

Last year in February, two Polish nationals died and 19 others were rescued after a group of tourists were hit by a massive avalanche at Gulmarg. On January 29, 2023 a woman and a teenage girl were killed after they came under an avalanche in the Kargil district of Ladakh.

While research specifically examining changes in avalanche patterns in Kashmir remains limited, broader global studies say that the repercussions of these changes are manifold and varied, from retreating glaciers to an increase in the frequency and intensity of snow avalanches.

The third pole, in May last year reported that less and wetter snow leads to more avalanches in the Himalayas. "When snow accumulates to form snowpack in the Himalayas, this creates a natural 'glue' that prevents fresh snow from sliding off the mountain slopes in an avalanche. A decrease in snow in the region has reduced this 'glue' leading to an overall increase in the frequency of avalanches," the report quoted a researcher.

Scientists have established that temperature and precipitation patterns in the Indian Himalayas have changed significantly over the past 100 years. With its steep mountain slopes, the Himalayan region is naturally avalanche-prone.

Studies suggest that climate change is a major driver of permafrost degradation. Permafrost is the ground that remains frozen for a longer time, sometimes upto 2 years. Warmer air temperatures would mean less winter season snow cover insulating the ground. This exposes permafrost to more heat transfer. As permafrost thaws, it causes destabilization of steep mountain slopes and terrain.

According to the Indian Meteorological Department, December recorded an unprecedented 79 percent deficit of rainfall in Jammu and Kashmir and January 2024 was one of the driest and warmest January in the last 43 years for most of the stations of Kashmir.

Speaking to Kashmir Observer, Dr Parvaiz Ahmed Head of Department, Geography and disaster Management also said that due to global warming, melted snow penetrates deep within, causing the mountain slope to move rapidly.

"Under climate change, we observe more avalanches. Global warming results in more snow melting, initiating movements that can lead to disastrous avalanches," Dr. Parvaiz said.

He said that the impact of global warming is evident in Kashmir, with mean minimum and mean maximum temperatures increasing over the decades and additionally, there is a decrease in precipitation, both in terms of rainfall and snowfall.

"Global warming and climate hange has changed the way it used to snow," he said, adding, "The biggest impact is seen in the form of shorter winters and early springs. The seasonal shift affects snowfall, reducing its sustenance and freezing potential. Glaciers are receding, and the snow no longer transforms into ice masses due to early melting." He added that decades back, it used to be snowfall even in the months of March April, in higher reaches it used to be huge. When snowfall used to take place in upper reaches it used to sustain and freeze. Now all that has changed. While acknowledging the challenge of long-term avalanche prediction, Dr. Romshoo emphasized the feasibility of short-term forecasting. He explained that while it's difficult to predict avalanches over extended periods, forecasting for shorter timeframes, ranging from days to weeks, is possible with advancements in avalanche and weather forecasting technologies. "In long term, the prediction of avalanches is uncertain. The longer the time period the uncertainty of forecasting the avalanches increases. Overall, it has been seen that there is an increase in frequency of avalanches," Romshoo said. As climate change continues to influence weather patterns in Kashmir, experts stress the urgency of research and preparedness to address the growing risks associated with avalanches in the region. Dr. Ahmed emphasized the need for Early Warning Systems (EWS) to mitigate the risk of avalanches. "Developing advanced EWS involving ground sensors sensitive to environmental changes is crucial. Placing these systems in hazardous regions can provide early warnings about avalanche initiation, ultimately saving lives.

generations to feel proud of the country's values.

"These five years have been of reform, perform and transform. It is rare that we reform, perform and also see transformation. The country will keep blessing the 17th Lok Sabha," he said. The government has been a source

of reassurance for people living on the margins of society, he said, highlighting the measures taken to empower the transgender community. A transgender person was also given Padma award, he added.

India got the presidency of G20 during this period and every state presented the country's strength and its identity in front of the world, he said.

"We can proudly say that this country might have lived under 'penal code' for 75 years but now we live under 'Nyay Samhita'," the prime minister said in reference to the new criminal laws which replaced British era acts.

Noting that the next Lok Sabha polls, expected in April-May, are not far away, he said it might make some people apprehensive but it is an essential feature of democracy. He expressed confidence that the upcoming elections will enhance the glory of Indian democracy.

The prime minister thanked MPs and Lok Sabha Speaker Om Birla.

"You (Birla) always had a smile on your face no matter what happens. You led this House in a balanced and impartial manner and I laud you for it. There were times of anger and accusations but you handled these situations with patience and ran the house wisely," Modi said, praising Birla.

Referring to the Covid pandemic, Modi said that during the last five years, the "biggest crisis of the century" was seen, and Birla made arrangements so that parliamentary work is not hampered while ensuring the dignity of the House.

The country's work was not allowed to stop, Modi said, praising parliamentarians for relinquishing their annual constituency development fund and 30 per cent of their salary during the pandemic. He also praised the Speaker for removing subsidized canteen facil-ities for the MPs as it often drew criticism in different parts of the country. There used to be talk of the need for having a new building in earlier times but the decision of the speaker made this a reality during the 17th Lok Sabha. He said the 17th Lok Sabha saw 97 per cent productivity. "We are moving towards the end of the 17th Lok Sabha and we resolve that productivity should ensure 100 per cent in the 18th Lok Sabha," Modi said He also hailed the passage of the Women's Reservation Bill and the criminalisation of instant triple talaq. He hailed the Speaker's decision to make the Sengol, a sceptre symbolising ancient traditions, a part of the annual ceremony and said that it will connect future generations with the moment when India achieved independence while being a source of inspiration.

Throwing light on the significance of the next 25 years for the nation, he said the country has resolved to accomplish its dreams and he can sense it

He said the passage of the Digital Personal Data Protection Act has safeguarded the data of the present generation and given it a tool to make its future.

He said thousands of cumbersome compliances were removed in the last five years to make the lives of common citizens easier. Reiterating his belief in "minimum government and maximum governance", he said the capabilities of any democracy can be maximized by ensuring minimum government intervention in citizen's lives.

On the timing of a white paper tabled by the government in Parliament, Shah said it was necessary as the country has full right to know what mess the Congress-led United Progressive alliance (UPA) left behind when it lost power in 2014.

"At that time (2014), the economy was in a bad shape. There were scams everywhere. Foreign investment was not coming. Had we taken out a white paper at that time, it would have given a wrong message to the world.

"But after 10 years, our government has revived the economy, brought foreign investment and there is no corruption at all. So it is the right time to publish the white paper," he said.

On the Ram temple in Ayodhya, the home minister said the people of the country believed for 500-550 years that the temple should be built at the place where Lord Ram was born.

"However, due to the politics of appeasement and citing law and order, the construction of the Ram temple was not allowed," he said.

On the Citizenship (Amendment) Act (CAA), Shah said the law, enacted in 2019, will be implemented before the Lok Sabha polls after issuing the rules in this regard.

Modi and Al Nahyan will discuss ways to further deepen, expand and strengthen the strategic partnership between the countries and exchange views on regional and international issues of mutual interest, it said.

"The prime minister will also meet with Sheikh Mohammed bin Rashid Al Maktoum, the vice president, prime minister and defence minister of the UAE," the MEA said.

"At his invitation, the prime minister will participate in the World Government Summit 2024 to be held in Dubai as the guest of honour and deliver a special keynote address at the summit," the MEA said in a statement.

It said Modi will also inaugurate the BAPS Mandir, the first Hindu temple in Abu Dhabi, adding he will also be addressing the Indian community in the UAE at an event in Zayed Sports City.

"India and UAE enjoy warm, close and multi-faceted relations underpinned by strong political, cultural and economic linkages," the MEA said. Following the landmark visit of Modi to UAE in August 2015, bilateral relations between the two countries were elevated to a Comprehensive Strategic Partnership.

Both countries signed

Comprehensive Economic Partnership Agreement (CEPA) in February 2022 and a Local Currency Settlement (LCS) System in July 2023 to promote the use of Indian Rupee and AED (United Arab Emirates Dirham) for cross-border transactions.

The two countries are among each other's top trading partners with a bilateral trade of about USD 85 billion in 2022-23, according to official data.

The UAE is also among the top four investors in India in terms of foreign direct investments in 2022-23.

"About 3.5 million strong and vibrant Indian community forms the largest expatriate group in the UAE. Their positive and well-appreciated contribution in the development of the short term.

Pakistan is reeling from a grave financial crisis, high inflation, unemployment and environmental catastrophes, with many Pakistanis struggling to make ends meet and disillusioned by political leaders.

Saira Khan, a schoolteacher in Islamabad, said, "It doesn't matter who comes to power."

"Anybody who comes to power needs to bring political stability to the country, and it is not possible without developing trust among the public. So, elections are important, but I don't think it will make much difference," Khan told DW.

According to Maliha Lodhi, Pakistan's former representative to the United Nations, "Voters have delivered a split mandate."

"This is not good news for political stability," she added. "With no party able to secure an overall majority, the government formation will likely be a difficult affair."

Khan's supporters left frustrated At the heart of Thursday's polls was a popular ex-premier who is challenging the military generals' iron grip on

power. In 2018, Khan's opponents had accused the military establishment of paving his path to office. But by the time an April 2022 no-confidence vote saw Khan ousted from the government, there was growing tension between him and the generals. Khan blamed the military – which has ruled Pakistan collectively for over three decades – for orchestrating the vote.

Khan also alleged that the US colluded with the military and his rival political parties to remove him from the premiership, a claim Washington has categorically denied.

After a yearlong confrontation with the military, Khan's supporters took to the streets across the country to protest his arrest. The protests turned violent. Some rioters began attacking military facilities and rampaging through army residential areas.

In the months following the riots, authorities started trying suspected protesters, including PTI members, in military courts. Droves of PTI senior and mid-level party officials announced their resignations and declared their backing for the military.

Khan's supporters hoped a "sympathy vote" for their imprisoned leader would see the PTI sweep the Thursday polls. It did not happen, and as the election commission delayed announcing election results, PTI officials and supporters cried foul and accused the authorities of rigging the vote in Sharif's favor.

Some PTI supporters told DW in Karachi that their party would have won an absolute majority had the election body not "changed results" overnight. Authorities reject these accusations as baseless.

Challenges for the next administration

Whoever forms the next government will face huge challenges. The most pressing of these is fixing the economy. The failure to bring down inflation and increase employment opportunities will likely make it unpopular.

Pakistan heavily depends on the International Monetary Fund's (IMF) bailout packages. The next IMF-Pakistan negotiations are scheduled to take place after the new government takes charge. The financial body's tough terms will force the next premier to increase taxes and undertake reforms that will likely further burden the public.

"If a weak coalition government emerges, it won't be able to launch the economic reforms that are urgently needed to put the country back on the trajectory of growth and investment," Lodhi underlined.

Another substantial challenge for the next government will be dealing with a spike in violent attacks along Pakistan's border with Afghanistan and Iran. The country's Balochistan and Khyber Pakhtunkhwa provinces have seen a rise in militant attacks in the past few months. To tackle this threat, the next premier may need to empower the security forces and launch a military operation in these areas.

The current political scenario is far from conducive for the next premier to carry out these measures.

**PULWAMA :** Residents of Sonzwatter village in Pulwama district have demanded potable water in the area.

The residents of the area told the news agency that the area has been facing a water crisis for a long time now but no steps are being taken in this regard.

They said that since years the residents of the area have been facing inconvenience due to unavailability of pota-



ble water in the area. Muzzafar Ahmed, a local, said that they have been consuming contaminated water for years as they don't have access to potable water yet.

He said that the government on the one hand is putting emphasis on sanitation while on the other hand the

government has failed in providing potable water to people.

Mohammad Shafi, another local said that the government had earlier started a water pump but that was later left midway giving locals a very tough time.

Locals said that they have brought this issue in notice of higher ups several times but to no avail.

Executive Engineer Jal Shakti department Pulwama Nisar Ahmad told news agency Kashmir News Observer KNO that they had explored a tube well in the area but chemical contamination was found in it due to which they are unable to provide water to the area.

He said that Deputy Commissioner Pulwama is providing funds under capex funds in the coming financial year and residents will very soon get potable water—(KNO)

Kohli had missed the first two Tests and that he could be unavailable for the remaining three matches was reported by PTI on February 3.

"Virat Kohli will remain unavailable for selection for the remainder of the series due to personal reasons. The Board fully respects and supports Mr. Kohli's decision," the BCCI said in a release. **KOHLI IS CURRENTLY ABROAD FOR**

The series is locked 1-1 with India bouncing back with win the second Test in Vizag after the visitors took the series-opener in Hyderabad.

known but BCCI brass wanted to check one final time if it could avail his services for the final Test in Dharamsala from March 7-11.

"The selection committee always knew that Virat won't be available for the series and accordingly the contingency plan was kept ready. Everyone in BCCI wants Virat to fulfil his family commitments and then come back with a free mind as and when he deems fit," a senior BCCI source told PTI on conditions of anonymity.

#### **KL RAHUL IS FULLY FIT AND JADEJA IS GETTING THERE**

The national selection committee included senior players Ravindra Jadeja and KL Rahul in the squad but their inclusion will be subject to clearance by the BCCI's medical team.
