Draft Proposal/Report on Delimitation of Municipal Committee Watergam

In compliance with the order No: 02/DCB/2024 dated: 18/01/2024, we, the constituted members after field survey of 13 wards of Municipal Committee Wa ergam, present this draft report regarding the delimitation of Municipal Committee Watergam. The report contains our rationale for the rationalization of the wards within the Mumcipa Committee Watergam for delimitation.

**Rationalization of Wards:** After carefully examining the population distribution and considering various factors viz demography and natural barriers, we propose that rationalization of the wards

could not be made for the delimitation of Municipal Committee Watergam on the following grounds: (i) Rehmatabad, Ward No: 10 has a population of 841 souls which is highest among the wards, while Gundmalraj Ward No: 11 is adjacent to the said ward with a population of 610 souls. However, no proportionate rationalization can be made for the reason that there is natural barrier of Nallah Hamal between these two wards.

(ii) In respect of least populated ward viz Ward No: - 04 Syedkirman, the population cannot be rationalized as the ward has natural barrier of Nallah Hamal separating it from nearby ward No: - 05 Dangerpora "A" and Ward No: - 06 Malpora. No rationalization of other wards seems required as of now. Hence the report is submitted for your kind perusal and further necessary action at your end (iii)



Sharing their journey, Sadia said, "I got married in Kashmir and now live in Harwan, Srinagar with my in-laws. While searching for jobs, it was always in my mind to be an entrepreneur. I thought of this idea about establishing a trout farm here in the Harwan area, and my husband and in-laws helped me in doing that.'


The road was frequently filled with water, creating problems for the people, he added, which is why a pipe culvert was constructed next to the shrine to facilitate the water flow.

# House, Cowsheds Gutted In Separate Fire Incidents In Srinagar

Srinagar: Twin fire incidents in Srinagar district damaged seven shanties, four cowsheds, and a three-storey residential house partially in Zonimar, Soura, and Nowhatta areas of Srinagar, officials said.

Officials said two fire incidents in the last 24 hours damaged one room of a three-storey residential house partially, along with seven shanties and four cowsheds at different locations in Srinagar.

Sharing details about the first incident, an official from F&ES told KNO that four cowsheds, single-storey house, and seven shanties were damaged in a fire incident, adding that the roofing, ceiling, and dry grass stored in attics of all cowsheds were damaged, while all shanties were severely damaged in the blaze at Zonimar.

About the second incident, the official added that one room on the ground floor of a three-storey residential house was damaged while the rest of the structure was saved.

The number of rejected ballots was greater than the margin of victory in at least 24 National Assembly constituencies, according to an interesting sta-tistical nugget from Pakistan's recent general elections. The difference potentially opens doors for legal battles as several losing candidates have flooded the courts with peti tions to review the results. According to a report in the Dawn newspaper, 22 constituencies with a greater number of rejected votes than the margin of victory fell in Punjab, with one each in Khyber Pakhtunkhwa and Sindh province. The Pakistan Muslim League-Nawaz (PML-N) won the electoral race in 13 of these constituencies, five were claimed by the Pakistan People's Party (PPP), four by the Pakistan Tehreek-e-Insaf (PTI)backed independents and two by other independents. # **Petition In Court Against Sealing Of Borders, Internet Suspension**

**CHANDIGARH:** A petition was filed in the Punjab and Haryana High Court on Monday against the sealing of borders and suspension of mobile internet services by the Haryana government in the wake of farmer outfits calling for a protest march to Delhi on February 13. The petitioner, Uday Partap Singh, sought directions from the court to stay all "obstructive" actions by the governments of Haryana and Punjab and the Centre against the farmers' protest, alleging that they infringe on the fundamental rights and are "unconstitutional".

The matter is expected to come up for a hearing on Tuesday.

The Samyukta Kisan Morcha (Non-Political) and the Kisan Mazdoor Morcha have announced that they would head to Delhi on February 13 to press the Centre to accept several demands, including the enactment of a law to guarantee a minimum support price (MSP)

for crops. In the plea, Mr Singh, who is from Haryana's Panchkula, alleged "unlawful" sealing of the border between Haryana and Punjab, particularly at Shambhu near Ambala, by the Haryana authorities with an "apparent objective of preventing farmers from exercising their constitutional right to assemble and protest peacefully".

The petitioner contended that the actions of the Haryana authorities, including the suspension of mobile internet services and bulk SMS in Ambala, Kurukshetra, Kaithal, Jind, Hisar, Fatehabad, and Sirsa, further exacerbates the situation, depriving the citizens of their right to information and communication.

"The road blockade not only inconveniences residents but also hampers the movement of ambulances, school buses, pedestrians, and other vehicles. "This obstruction has resulted

in increased traffic on alternative routes, causing delays and difficulties for including professionals like advocates, doctors and emergency services who are unable to reach their workplaces and attend promptly," according to the plea.

The imposition of Section 144 of the Code of Criminal Procedure (CrPC) in Ambala and Kaithal districts, along with the placement of cemented barricades, spike strips, and other obstacles on various roads, demonstrates a concerted effort by the state authorities to "suppress dissent and stifle democratic expression", the plea alleged The actions not only infringe upon the fundamental rights guaranteed under Articles 19(1)(a) and 21 of the Constitution of India but also undermine the principles of democracy and the rule of law, said the plea.

Britain's King Charles attended church on Sunday in his first public outing since announcing last week he had been diagnosed with cancer and would postpone some engage ments to undergo treatment.

The king, wearing a brown overcoat and carrying an umbrella, waved as he arrived with his wife. Camilla. at St Mary Magdalene church in Sandringham in eastern England.

Buckingham Palace announced on Monday that Charles, 75, had been diagnosed with an unspecified form of cancer. The king has been on the throne for less than 18 months following the death of his mother Queen



#### Elizabeth.

Charles, who is spending time at his rural Sandringham estate, issued a message on Saturday expressing gratitude to well-wishers following his diagnosis.

While undergoing treatment, Charles has postponed public engagements but is planning to continue with much of his private work as monarch including having his weekly audience with the prime minister and dealing with state papers.

The cancer was discovered when Charles stayed three nights in hospital last month, undergoing a corrective procedure for a benign enlarged prostate. Beyond confirming t was not prostate cancer, the palace has not given any further details.

# **Retired IAF Officer Accuses Army Officer Husband Of Forging Papers, Passing Benefits To Live-In Partner**

KANPUR: A retired woman officer of the Indian Air Force has filed a complaint at Kanpur Cantt police station against her husband, a lieutenant colonel, accusing him of staying with another woman and giving her the benefits reserved for an army man's wife.

The woman, a resident of Lucknow's Rajajipuram, told police that she married the army officer in 2001, and they have a son and a daughter who live with her.

The husband is currently posted as Additional Officer in Kanpur Headquarters of the Army and resides in Kanpur Cantonment.

The complainant said that on May 7, 2023, when she reached

her husband's official residence, she found a woman, a resident of Dwarka, Delhi, staying with him. It came to light that she had even forged documents to establish her identity as the army officer's wife to avail of all benefits which army wives were entitled to.

The retired IAF officer accused her husband of supporting his female friend to forge certain documents. She said that when she protested, her husband's female friend threatened her with dire consequences.

Cantt police station in-charge Braj Mohan Singh said a case had been registered.

"The matter is being investigated and action will be taken on the basis of evidence and other findings," he said.

# Imploding INDIA Alliance

hen INDIA Alliance was formed in June 2023, it held the promise of offering a tough political challenge to the dominance of the ruling BJP led by the overarching figure of the prime minister Narendra Modi. Apart from Rahul Gandhi's Congress Party which continues to enjoy a national footprint - albeit drastically shrunken in the last decade - the regional parties with their committed support bases made the alliance a force to reckon with. But with the exit of Nitish Kumar, one of the alliance's key architects, and the growing rumblings over pre-election seat-sharing the alliance has started unraveling

The AAP's decision to contest all 14 Lok Sabha seats in Punjab and Haryana independently signals a further rupture in the INDIA Alliance. The fragmentation of the alliance in this crucial region raises questions about its ability to present a united front against the BJP. While the alliance's unraveling in Punjab and Chandigarh may not be representative of its overall status, it underlines the challenges it faces in maintaining cohesion across diverse regional landscapes. As it has turned out, the internal discord and disagreements over seat allocations have further strained the alliance's unity, threatening to weaken its collective strength in the face of a formidable opponent like the BJP.

Recent opinion polls, such as the Mood of the Nation survey conducted by the India Today Group, paint a contrasting picture of the alliance's fortunes in different regions. In Tamil Nadu, the poll predicts a resounding victory for the DMK-Congress combine, projecting a clean sweep with all 39 Lok Sabha seats. The alliance is estimated to secure an impressive 47% vote share, leaving the BJP-led NDA trailing with only a 15% share. This substantial lead shows the alliance's potential to make significant gains in the southern state, further reinforcing its position as a force to be reckoned with. But not so in most other states, particularly in north India.

As the Lok Sabha elections approach, the INDIA Alliance finds itself at a crossroads. The initial optimism surrounding its formation has given way to internal discord, with the departure of key figure like Nitish Kumar and disputes over seat-sharing threatening to undermine its collective strength. The regional variations in the Mood of the Nation poll hint at a complex political landscape, where success in one state does not guarantee triumph in others.

The coming months will be crucial for the alliance as it navigates internal tensions, seeks to address regional concerns, and strives to present a united front against the BJP. The challenges ahead will test the resilience of the INDIA Alliance and determine whether it can overcome internal strife to emerge as a potent political force in the upcoming elections.


Intersection Between Technology and Education

ne process of education in the 21st century has seen dramatic shifts and repositions in the delivery of education. The thinking of educational thinkers shifted towards the pros and cons of digitization of education. The Pedagogues and educationists started thinking about the impact of new technology on the teaching and learning process. They find this new change cultural, social, and political as well. The significant questions that arose due to the advent of technology were mainly concerned with digital inequalities. However, the impact of information and communication technology can be seen in wide spectrums of education. In the 21st century, technology has already changed various dimensions of one's culture and society. Moreover, the idea of technological integration into education was much debated in the context of providing education to the masses. On one side, digital inequality was considered as one of the major hindrances that could hamper the purpose of the integration of technology in education, on the other, thinking about education without technol ogy in the 21st century cannot be a rational approach towards addressing the modern needs of students.

The Idea of de-schooling seems to become real in the context of the digitization of education, however, though arguable. Policymakers seem to prescribe and recommend the inculcation of technological culture within the schools. The recommendations seem pertinent because the methods of accessing information and knowledge have changed to a great extent in the 21st century. However, the emerging focus on digital technology poses a challenge to educationists about socio-economical landscapes. In the aforementioned context, Saettler's (1968) argument seems interesting, that "Books will soon be obsolete in the schools. Scholars will soon be instructed through the eye. It is possible to teach every branch of human knowledge with the motion picture. Our school system will be completely changed in ten years". The importance of books

In this regard, Marshal and Katz (2003), argue that "what the user knows about ICT affects the quality and quantity of the learning with ICT. The features of ICT that aid learning include interactivity and provisionality. To exploit interactivity, the user must know how to respond to screen prompts from the software. In order to ex-



The process does not stop here, as there are other stakeholders in the process of education. What about the society, culture, and more importantly family of a child? The experiences that children have due to their cultural capital affect the learning performances within schools. A family which is well acquainted with digital technology can facilitate their children smoothly in accessing digital resources, which may later, help these children in schools as well. On the other side, there may be hindrances for the poor children who lack the capital. There is always the possibility that those schools that have more material resources shall have more access to digital platforms than the schools with fewer resources and located in far-flung areas. Infusing technology in the classroom can be one of the ebullient steps but there is the possibility of utilizing technology by have's strengthening already existing inequalities. That problem will again strengthen what Kahn and Kellner (2007) call 'technocapitalism'. In this way, there are chances of technology impeding the desired ends instead of achieving them. This factor must be taken into consideration by the authorities. In India, there are 14.89 lacks schools, out of which 10.12 lakhs are Govt. schools. The total number of students reaches 26.52 crores and that of the total teachers is 95 lakh. Looking at this huge education structure, the integration of technology needs an epimethean approach keeping the digital inequalities into consideration. Indian Inequality Report (2022) highlights that "The proportion of students having access to a computer with internet was higher in urban area (21 percent) than rural (4 percent) in India. Furthermore, access to the internet was much better in urban India (44 percent)

than in rural (17 percent) India". The report further highlights that "The currently enrolled students from advantaged socio-economic groups have relatively better access to digital infrastructure". The scenario becomes even worse after looking at caste and gender dimensions into consideration. The inequality in digital infrastructure was also highlighted by UDISE (2021-22), it highlights that "the overall percentage of schools in India with digital library availability is relatively low... there are about 14,89,115 schools in India, and only 32,762 schools have had a digital library in 2021-22.' The variations were also found in different categories of schools, government schools were found to have only 1.2 percent of digital libraries availability in India. This percentage is lower compared to government-aided schools and Private unaided schools, which are 3.2 percent and 5.1 percent respectively. Besides this, the intention of turning modern schools into techno-hubs seems progressive but not viable simultaneously. The cut-throat competition, inadequate textbooks, and syllabi guided by ideological dogmas are a few other concerns of our education system in India. The question arises, is the new technology only the means for infotainment which is guided by 'techno-capitalism' or does it have epimethean character? This way technology can be said to have an ambivalent nature, which may swing both ways of the line and may lead to the Moloch dilemma.



The RBI's Monetary Policy Committee (MPC) has prudently opted to persist with its objective of 'ensuring that inflation progressively aligns to the target' by keeping benchmark interest rates unchanged, and sticking with its stance of 'withdrawal of accommodation'. With a 5-1 majority, it has committed to keeping monetary policy unambiguously disinflationary so as to anchor inflation expectations, especially at a time when 'large and repetitive price shocks are interrupting the pace of disinflation'. On the rationale to leave the repo rate unchanged at 6.5% for a sixth straight meeting, Governor Shaktikanta Das observed that while domestic economic momentum remained strong, uncertainties in food prices continued to impinge on the headline inflation trajectory. The tangible risk that food price pressures could become more generalised and impact broader headline inflation was the main consideration, he explained. That the majority of the MPC was aligned in prioritising the battle against inflation needs to be seen in the backdrop of the recent trends in retail inflation. Headline retail inflation, which had eased from July's 15-month peak of 7.4% to 4.87% in October, however, rebounded to a fourmonth high of 5.69% in December, with food price gains gauged by the Consumer Food Price Index racing ahead to 9.53%, a sizeable 292 basis points faster than October's 6.61%.

That the uncertainty surrounding food price gains has begun to vex policymakers is reflected in a recent RBI Bulletin article that pointedly sought to find an answer to the question, 'Are Food Prices the 'True' Core of India's Inflation?'. Concluding that there is enough empirical evidence to support an assertion that 'there are times when food inflation mimics core inflation', the officials caution that given food's substantial share in the consumption basket, large and repeated food price shocks have the potential to ripple outward and undermine the goal of price stability by de-anchoring inflation expectations. The MPC's downward revision of its projection for average retail inflation in the January-March quarter to 5.0%, 20 basis points lower than its December forecast, reflects the small comfort policymakers have taken from the improvement in rabi sowing as well as a seasonal correction in vegetable prices. Still, the Department of Consumer Affairs' daily price monitoring dashboard shows the average retail price of more than two-thirds of the key food items it tracks remained higher on a year-on-year basis as on February 8. Policymakers need to stay steadfast in their resolve to durably slow price gains towards the 4% target or risk dampening consumption and thereby undermining the growth momentum.

# Work Life Imbalance

Infosys co-founder Narayana Murthy's recent suggestion for "70-hours-work-a-week" among Indian youngsters will no doubt boost productivity, but it will certainly affect the balance of work-life approach, which is equally important. Unsurprisingly Mr. Murthy's comments have evoked a nationwide controversy, with many have criticised his idea. In fact, a Bengaluru-based Cardiologist wrote in his X (formerly Twitter) account saying, "such an inhumane working hours can create a whole generation with a host of heart-related comorbidities." The Cardiologist's comment gains prominence, as WHO says that India accounts for at least one-fifth of the 17.9 million cardiovascular diseaserelated deaths globally, especially in the younger generation. Currently, India's labour codes mandate that workers put in 8-hours of work a day, capping the weekly work hours at 48. Despite this, global data shows that India ranks fifth in the world among countries with long working hours. Research has revealed that productivity falls sharply after 50 hours per week, and drops off a cliff after 55 hours. Rather than extended working hours, a streamlined approach with set working hours will work for large enterprises that have plentiful resources.

# FROM AIRWAVES TO PODCASTS The Evolution of Radio in the 21st Century

Radio has been the most powerful mass media that has shaped societies in every corner of the world ever since its invention. World Radio Day is a perfect platform to think about how this traditional medium has undergone an unbelievable metamorphosis through podcasts in the digital era.

Radio first appeared in the late 19th century thanks to innovators including Nikola Tesla and Guglielmo Marconi. # **AI Model Could Predict Onset Of Psychosis Using Brain Scans**

esearchers have developed a new artificial intelligence (AI) model that can predict the onset of psy-■ chosis in people using brain scans. They said that the model, trained on brain scans from people globally, could be helpful in clinical settings, as earlier intervention typically leads to better outcomes with less negative impact on people's lives, even as most experiencing psychosis recover fully.

Psychosis is a mental state characterised by being out of touch with reality and symptoms can include delusions, hallucinations or radical changes in behaviour and thinking. The condition has no single cause, but can be triggered by trauma, drug or alcohol use, or a genetic predisposition.

"At most only 30 per cent of clinical high-risk individuals later have overt psychotic symptoms, while the remaining 70 per cent do not," said associate professor Shinsuke Koike from the Graduate School of Arts and Sciences at the University of Tokvo. Japan. and the corresponding author of the study published in the journal Molecular Psychiatry.



"Therefore, clinicians need help to identify those who will go on to have psychotic symptoms using not only subclinical signs, such as changes in thinking, behaviour and emotions, but also some biological markers," said Koike.

For developing the model, the international team of researchers enrolled close to 2,200 adolescent and young adult participants, over half of whom were clinically identified to be at high risk of developing psychosis.

Recruited from 21 locations worldwide, the "diverse" group was divided into four groups - those who later developed psychosis, those who didn't develop psychosis and people with uncertain follow-up status, and

#### healthy controls.

Using their magnetic resonance imaging (MRI) scans, the researchers trained a machine learning algorithm - one that learns from past data to make predictions - to discern patterns in the anatomy of the participants' brains. Previous studies have shown the onset of psychosis to be accompanied by structural differences in the brain.

On the training data, the researchers found that the AI model was 85 per cent accurate in differentiating between those at high risk who went on to develop overt psychotic symptoms later and those healthy. On new data, however, the model showed a 73 per accuracy in predicting which participants were at high risk of psychosis onset.

Research of psychotic disorders using MRI can be challenging, according to Koike, owing to variations in brain development and MRI machines, that can make it difficult to get accurate, comparable results.

Further, with young people, it can be difficult to distinguish between typical developmental changes and those occurring due to a mental illness, said Koike.

However, this was the first time that differences in the brains of those at high risk but have not yet experienced psychosis have been identified, the researchers said.

# Your Unique Smell Can Provide Clues About How Healthy You Are

Hundreds of chemicals stream from our bodies into the air every second. These chemicals release into the air easily as they have high vapour pressures, meaning they boil and turn into gases at room temperature. They give clues about who we are, and how healthy we are.

Since ancient Greek times, we've known that we smell differently when we are unwell. While we rely on blood analysis today, ancient Greek physicians used smell to diagnose maladies. If they took a whiff of your breath and described it as fetor hepaticus (meaning bad liver), it meant you could be headed for liver failure.

If a person's whiff was sweet or fruity, physicians thought this meant that sugars in the digestive system were not being broken down, and that person had probably diabetes. Science has since shown the ancient Greeks were right liver failure and diabetes and many other diseases including infectious diseases give your breath a distinctive smell. In 1971, Nobel Laureate chemist Linus Pauling counted 250 different gaseous chemicals in breath. These gaseous chemicals are called volatile organic compounds or VOCs. Since Pauling's discovery, other scientists have discovered hundreds more VOCs in our breath. We have learned that many of these VOCs have distinctive odours, but some have no odour that our noses can perceive. Scientists believe that whether a VOC has an odour that our noses can detect or not, they can reveal information about how healthy someone is.

# **Researchers Find How Fatty Acids Plays Key Role In Creating Memories**

Researchers at the University of Queensland have demonstrated the vital role that saturated fatty acids play in the brain's storage of memories.

A new cure for neurodegenerative illnesses may now be possible, thanks to research conducted by Dr Isaac Akefe of the Queensland Brain Institute at the University of Queensland. He has also discovered the genes that underlie the process of memory creation. The findings were pub-

lished in the EMBO Journal. "We've shown previously that levels of saturated fatty acids increase in the brain during neuronal communication. but we didn't know what was causing these changes," Dr Akefe said.

"Now for the first time, we've identified alterations in the brain's fatty acid landscape when the neurons encode a memory.

"An enzyme called Phospholipase A1 (PLA1) interacts with another protein at the synapse called STXBP1 to form saturated fatty acids." The brain is the body's fattiest organ, with fatty compounds called lipids

making up 60 per cent of its weight. Fatty acids are the building blocks of a class of lipids called phospholipids.

The work done in Professor Frederic Meunier's laboratory has shown that STXBP1 controls the targeting of the PLA1 enzyme, coordinating the release of fatty acids and directing communication at the synapses in the brain. "Human mutations

in the PLA1 and STXBP1 genes reduce free fatty acid levels and promote neurological disorders,' Professor Meunier said. "To determine the

importance of free fatty

tion, we used mouse models where the PLA1 gene was removed. We tracked the onset and progression of neurological and cognitive decline throughout their lives. We saw that even before their memories became impaired, their saturated free fatty acid levels were significantly lower than control mice. This indicates that this PLA1 enzyme, and the fatty acids it releases. play a key role in memory acquisition." The research has important implications for understanding of how memories are formed.



# **Inflation Falls To Three-**Month Low Of 5.1% In January **On Subdued Food Prices**

**NEW DELHI:** Retail inflation declined to a three-month low of 5.1 per cent in January, mainly due to subdued prices of vegetables, fruits and other food items, according to government data released on Monday. The fall indicates that retail

inflation is inching towards the Reserve Bank's comfort level of 4 per cent. The Consumer Price In-

dex (CPI) based inflation was on the rise for two straight months after touching a trough of 4.9 per cent in October 2023. In December, it stood at 5.69 per cent.

In January, inflation in the food basket eased to 8.3 per cent from 9.53 per cent in the preceding month. It was at 6 per cent in January 2023, as per the data released by the National Statistical Office (NSO).

Food inflation was lower in rural areas at 7.91 per cent compared to 9.02 per cent in the urban centres of the country. The latest data showed

that inflation in 'oils and fats', 'pulses and products', spices, fruits, and vegetables segments was lower in January 2024 compared to December 2023

However, inflation was



'meat and fish', and eggs segments on a month-on-month basis.

As per the data, inflation was more than the national average of 5.1 per cent in Assam, Gujarat, Haryana, Karnataka, Maharashtra, Odisha, Puniab. Rajasthan, Telangana, and Uttar Pradesh. The lowest reltail inflation

in January this year was in Delhi at 2.56 per cent.

Aditi Nayar, Chief Economist at rating agency Icra, said while rabi sowing has caught up with last year's level, reservoir storage remains well below the year-ago levels in most regions, continuing to imbue caution in terms of the outlook for the rabi harvest.

"We project the CPI inflation to ease below 5 per cent in February-March 2024, and average at 5.3 per cent in FY2024.

"Thereafter, we estimate the CPI inflation at 4.6 per cent in FY2025, broadly in line with that of the MPC (Monetary Policy Committee), based on the assumption of a normal monsoon," she said.

The government has mandated the Reserve Bank of India (RBI) to ensure CPI remains at 4 per cent with a margin of 2 per cent on the

either side. Last week, RBI projected a lower inflation of 4.5 per cent in the next financial year, compared to 5.4 per cent in 2023-24, provided there is normal monsoon.

NSO collects price data from selected 1,114 urban markets and 1,181 villages covering all States/UTs on a weekly basis. In January 2024, NSO collected prices from 99.8 per cent villages and 98.5 per cent urban markets.

## **RBI Rules Out Review Of Action Taken Against Paytm Payments Bank**

NEW DELHI: Reserve Bank of India Governor Shaktikanta Das on Monday ruled out any review of the central bank's action against Paytm Payments Bank Ltd (PPBL), saying that its decisions are well thought out. RBI, he said, is not against any fintech but its prime objec-

tive is to protect the interest of customers and depositors. Observing that RBI is always supportive of the fintech sector, Das said it is the endeavour of the central bank to ensure

rapid growth of the sector. With regard to action taken against PPBL, he said directives against any regulated entities are taken whenever it finds that they don't take any action even after they are told to comply with the regulations.

"We have taken action against PPBL after due consideration and soon FAQs (Frequently Asked Questions) will be issued for the benefit of its customers," Das said after the 606th meeting of the Central Board of Directors of RBI.

The meeting was addressed by Finance Minister Nirmala Sitharaman.

In a major action against PPBL, the central bank, on January 31, directed it to stop accepting deposits or top-ups in any customer accounts, wallets, FASTTags and other instruments after February 29. Ruling out any relaxations, Das on Monday said, "at the



moment, let me say clearly, there is no review of this (PPBL) decision. If your are expecting a review of the decision, let me very clearly say there is (going to be) no review of the decision".

"FAQs which we are proposing to issue is targeting the inconvenience or issues faced by the depositors and customers wallet users, FASTag holders. Whatever is in the customers' interest that we are dealing in FAQs. Regarding review of decision, there is nothing on the table," he said.

While announcing the action against PPBL, RBI had said the direction follows persistent non-compliances and continued material supervisory concerns.

On March 11, 2022, RBI had barred PPBL from onboarding new customers with immediate effect.

In its latest action, RBI has asked the PPBL not to take deposits/ credit transactions/ top-ups in any customer accounts, prepaid instruments, wallets, FASTags, and NCMC cards, among others, after February 29.

### **DGCA Issues Circular To Prevent Runway Incursions** After Haneda Airport Incident

NEW DELHI: To prevent instances of runway incursions at airports, aviation watchdog DGCA has asked stakeholders to put in place a runway safety team at all airports and adopt technologies to improve situational awareness, among other measures.


The Directorate General of Civil Aviation (DGCA) has issued a circular in view of the collision of planes due to runway incursion at the Haneda airport in Japan last month.

Another recommendation is adoption of technological interventions to improve situational awareness, thereby assisting Air Traffic Control (ATC) and other stakeholders to identify the traffic within the manoeuvering area.

recommendations Other include ensuring adherence to standard procedures by all involved personnel/stakeholders, and recognising the influence of human factors on performance, which may contribute to runway incursions.

As per the latest data, the manufacturing sector's output growth accelerated to 3.9 per cent in December 2023 as against 3.6 per cent a year ago.

However, the power gen-eration growth slowed to 1.2 per cent in December 2023 from 10.4 per cent growth in the year-ago period. The mining output growth

also declined to 5.1 per cent in the month under review from 10.1 per cent in the same period a year ago. Aditi Nayar, Chief Economist at rating agency Icra, 2.4 per cent in November 2023, led by an improvement in the performance of manufacturing sector.

"In terms of the use-based categories, only primary goods reported a sequential moderation in December 2023, with all five other categories reporting an improvement," she said.

With the available high frequency data for January 2024 appearing promising,

Nayar said, "we anticipate a modest rise in the IIP growth to 4-6 per cent in that month". As per use-based classification, the capital goods segment growth decelerated to 3.2 per cent in December 2023 compared to a growth of 7.8 per cent in the year-ago period.

# **Unemployment Rate Declines** To 6.5% In Oct-Dec: PLFS

NEW DELHI: India's unemployment rate in urban areas for persons aged 15 years and above decreased during October-December 2023 to 6.5 per cent from 7.2 per cent in the year-ago period, as per government data released on Monday.

Considering the importance of the availability of labour force data at more frequent time intervals, the NSSO launched the Periodic Labour Force Survey (PLFS) in April 2017.

"For male, UR (Unemployment Rate) decreased from 6.5 per cent in October-December 2022 to 5.8 per cent in October-December 2023, while for female UR decreased from 9.6 per cent in October-December 2022 to 8.6 per cent in October-December 2023," the Periodic Labour Force Survey (PLFS) quarterly bulletin stated.

PLFS further said the Worker Population Ratio (WPR) for persons aged 15 years and above in urban areas increased from 44.7 per cent in Octo-



ber-December 2022 to 46.6 per cent in October-December 2023.

For male, it increased from 68.6 per cent to 69.8 per cent during this period and for female, it increased from 20.2 per cent to 22.9 per cent during this period.

Labour Force Participation Rate in urban areas increased from 48.2 per cent in October-December 2022 to 49.9 per cent during the period under review for persons aged 15 years and above.

# **MFIs Seek More Penetration In Terms Of Household Coverage**

KOLKATA: Micro-finance Institutions (MFIs) have sought more penetration in terms of household coverage to increase their portfolio of disbursements, an official said on Monday.

CEO and director of Microfinance Institutions Network (MFIN) Alok Misra said there are 7.3 crore low-income borrowers in the country at present with an outstanding portfolio of Rs four lakh crore.

Misra told reporters here that the potential for the MFI sector is to have an outstanding of Rs 13 lakh crore, adding that there is a huge scope for growth.

In West Bengal, the total outstanding of the MFIs is around Rs 35,000 crore covering 65 lakh borrowers.

Nine per cent of the overall outstanding portfolio is from West Bengal, he said. MD of Arohan Financial Ser-

vices Manoj Nambiar said that there is under-penetration of MFI coverage in the country at present.

This penetration needs to grow, he said.

Kuldip Maity, MD of VFS Capital, said that historically the average levels of NPAs in the MFI sector is less than one per cent.

Maity said MFIs will play an important role in the sustainable growth of the economy.

Misra said the MFI sector is seeking a guarantee scheme for the loans for which the individual entities will pay a small premium.

The sector is also looking for a financial institution to be dedicated only for refinancing small MFIs.

The 8th Eastern India Microfinance Summit to be organised by the West Bengal chapter of the Association of Microfinance Institutions (AMFI) will be held on February 22.

# **Qatar Releases**

Prime Minister Narendra Modi himself constantly supervised all the developments in the case and has never shied away from any initiatives that would ensure the return of the Indians. The seven Indian nationals reached Delhi by a private airline at around 2:35 am.

The foreign secretary, without elaborating, said New Delhi continues to work with the Qatari government to ensure the return of the eighth Indian quickly.

In an early morning statement, the Ministry of External Affairs (MEA) said India appreciates the decision by the Emir of Qatar Sheikh Tamim bin Hamad Al-Thani for enabling the release and home-coming of the Indians. It is learnt that the Emir ordered the release of the eight Indians.

The Navy veterans apparently faced charges of espionage, but neither the Qatari authorities nor New Delhi made the charges against them public. "The Government of India welcomes

the release of eight Indian nationals working for the Dahra Global company who were detained in Qatar," the MEA said.

"Seven out of the eight of them have eturned to India. We appreciate the decision by the Emir of the State of Qatar to enable the release and homecoming of these nationals," it said in a brief statement. The eight nationals are: Captains Navtej Gill and Saurabh Vasisht. Commanders Purnendu Tiwari, Amit Nagpal, SK Gupta, BK Verma, and Sugunakar Pakala, and sailor Ragesh. Commander Tiwari could not return due to some pending paper work, people familiar with the matter said. "We are grateful to the government and the prime minister Narendra Modi as it would not have been possible without his intervention," said one of the returnees. The Navy veterans were on October 26 given death sentences by Qatar's Court of First Instance. The Court of Appeal in the Gulf nation on December 28 commuted the capital punishment and sentenced them to jail terms for varying durations. The Court of Appeal had also given 60 days time to appeal against the prison terms. In December, Prime Minister Modi had met the Oatari Emir on the sidelines of the COP28 Summit in Dubai and discussed the "well-being of the

It is learnt that National Security Adviser Ajit Doval played a key role in the negotiations with the Qatari authorities in securing the release of the Indians as he paid a number of quiet visits to Doha.

The Indian nationals, who worked with private company Al Dahra, were arrested in August 2022 reportedly in an alleged case of espionage. The charges were filed against the eight Indian navy veterans on March 25 last year and they were tried under Qatari law. In May last year Al-Dhara Global closed its operations in Doha and all those working there (primarily Indians) have since returned home. The foreign secretary said India is grateful to Qatar for the return of the Indians. "We are gratified on their return. We deeply appreciate the de-

cision of Qatar's government and the Emir to release them," Kwatra said. "We are happy to have seven of those Indian nationals back. Eighth Indian national has also been released and we continue to work with the Qatar government to see how quickly

Australia broke their winless streak against India in the U19 title clashes as its pace attack helped defend 254 against Men in Blue, winning their first title since 2010 and overall their fourth title on Sunday.

gan Abhishek (42) waged a battle during their time on the crease;

however, it wasn't enough to get India across the finishing line. India was bundled out for 174. Besides Beardman, Raf MacMillan also took 3/43 while Calium Vidler took 2/35. Tom Straker and Charlie Anderson got one wicket each. Mahli was the star for Australia, taking 3/15 in his seven overs, getting key wickets of Adarsh, Indian skipper Uday and Musheer.

Earlier in the innings, after winning the toss, Hugh Weibgen's Australia skipper decided to bat first and set a target of 254 runs in the final match. Harjas Singh (55), skipper Hugh Weibgen (48) and Oliver Peake (46) delivered notable contributions for Aussies. Raj Limbani (3/38) and Naman Tiwari (2/63) were the pick of the bowlers for India. # Section 144 Imposed In Delhi; Traffic Restrictions In Place At **Borders, Security Beefed Up**

New Delhi: Delhi Police have imposed Section 144 across the national capital in view of widespread tension and "social unrest" due to the farmers' Delhi Chalo March on Tuesday. The order will be in place for a month. The order issued by Delhi Po-

lice Commissioner Sanjay Arora on Monday prohibited any type of rally or procession and blocking of roads and passages. Delhi Police order has im-

posed a ban on tractor rallies trying to cross the borders of the national capital. Meanwhile, traffic restrictions

have been put in place and security arrangements intensified at the Singhu, Ghazipur and Tikri borders in the national capital. The borders have been fortified with concrete blocks and iron nails to prevent vehicles carrying protesters from entering the city.

The measures affected traffic movement in the border areas of Delhi on Monday morning, causing inconvenience to commuters.

Several farmer associations, mostly from Uttar Pradesh, Haryana and Punjab, have called for the march on February 13 to demand a law guaranteeing MSP for their produce, one of the conditions they had set when they agreed to withdraw their agitation in 2021.

Delhi Police Commissioner Sanjay Arora visited the city's borders with Haryana and Uttar Pradesh on Sunday to check the security arrangements.

According to an advisory issued here, traffic restrictions have been imposed for commercial vehicles at the Singhu border since Monday. Tuesday onwards, the restrictions apply to all types of vehicles, it said.

Police have deployed more than 5,000 security personnel while cranes and earthmovers carrying large containers to block the road were also at work.

Multiple security barricades have already been installed at the borders to stop the farmers from entering the national capital. Nails have been erected on roads so that if the protesting farmers try to enter the city on vehicles, their tyres can be punctured, the officials said.

# **Mild Heat Waves Prove Deadlier** Over Time In India, Study Reveals Urgent Need For Revised Heat Warnings

NEW DELHI: While the most extreme heat waves have the greatest short-term impact on mortality, it is the mildest ones that kill most over time because they are more common, according to a study conducted in India. As heat waves are projected

to become more common as the Earth's climate warms, the health risks of temporarily elevated temperatures must be investigated

team of researchers from A Mass Eye and Ear has de-veloped a smartphone app called "All\_Aboard" to assist individuals who are blind or visually impaired (BVI) in finding their bus stops. The app focuses on improving micro-navigation, which involves finding the exact locations of bus stops and destinations. It aims to complement mainstream GPS systems, which provide macro-navigation for planning routes using public transportation.

The All\_Aboard app utilises the phone's camera to detect street signs from a distance of 30 to 50 feet. It then provides auditory cues to guide the user towards their destination, with the frequency of the sounds changing as they approach the bus stop. The app is powered by artificial intelligence, using a deep learning neural network trained on approximately 10,000 images of bus stops collected in various cities and regions around the world.

A recent study evaluated the effectiveness of the All\_Aboard app compared to Google Maps in helping BVI individuals navigate a set route with 10 bus stops in both urban (Boston) and suburban (Newton, Mass.) locations. The study measured the localization error (gap dis-

tance) and the rate of successful localisation. The researchers found that the All\_Aboard app had a success rate of 93 percent, while Google Maps had a success rate of 52 percent. Additionally, the average gap distance with Google Maps was 6.62 meters, compared to 1.54 meters with All\_Aboard.

"Our findings suggest that the All\_Aboard app could help travelers with visual impairments in navigation by accurately detecting the bus stop, and therefore greatly reducing their chance of missing buses due to standing too far from the bus stops," said Gang Luo, of the Schepens Eye Research Institute of Mass Eye and Ear. "This study indicates that computer vision-based object recognition capabilities can be used in a complementary way and provide added benefit to purely mapping-based, macro-navigation services in real-world settings.

The study's findings suggest that the All\_Aboard app could greatly assist travellers with visual impairments in accurately detecting bus stops, reducing the chance of missing buses due to standing too far away from the stops. ### **AI Model Could Predict Onset Of Psychosis Using Brain Scans**

Researchers have developed a new artificial intelligence (AI) model that can predict the onset of psychosis in people using brain scans.

They said that the model, trained on brain scans from people globally, could be helpful in clinical settings, as earlier intervention typically leads to better outcomes with less negative impact on neonle's

associate professor Shinsuke Koike from the Graduate School of Arts and Sciences at the University of Tokyo, Japan, and the corresponding author of the study published in the journal Molecular Psychiatry.

"Therefore, clinicians need help to identify those who will go on to have psychotic symptoms using not only subclinical signs, such as changes in thinking, behaviour and emotions but also some biological

waves, those that were hotter than 99 per cent of days and lasted at least five days, increased mortality the most–by over 33 per cent, they said.

The study found that heat waves that were hotter than 95 percent of all days and lasted only one day increased mortality the least—by just over 10 per cent.

The mildest heat waves were surprisingly the deadliest and the number of deaths was more or less inversely proportional to the intensity and duration of the heat waves, the researchers said. "This is because the milder

heat waves were so much more common than the hotter ones. In the end, the most extreme heat waves turned out to cause the lowest number of deaths because they were so infrequent," said de

"One consequence of this may be that heat warnings may need to be triggered at lower temperature thresholds to protect more people," the researcher said.
