5-day Wet Spell To Begin Today: MeT

Srinagar: Jammu and Kashmir is likely to experience a fresh wetspell as the weatherman here has forecasted light to moderate snowfall from February 17 to 20th.

In the meantime, the government has also started readying arrangements to avert disruption of utilities due to snow.

Director Meteorological department (MeT), Dr Mukhtar Ahmad said that there is a possibility of heavy to very heavy snowfall over middle and higher reaches of Kupwara, Baramulla, Bandipora, Ganderbal, Budgam and South Kashmir districts from February 19-20.

In Kashmir, Ahmad said on Feb 17, weather conditions are expected to remain partly to generally cloudy with possibility of light snow at isolated higher reaches towards late night.

On Feb 18, he said there is a possibility of light to moderate rain and snow at most places with heavy snowfall over isolated higher reaches of North, Northwestern, Central and South Kashmir

Security Heightened In J&K Ahead of PM's Visit

Srinagar: Security has been heightened in Kashmir valley ahead of Prime Minister Narendra Modi's visit to Jammu next week.

A top police officer told GNS that the security arrangements across Jammu and Kashmir have been tightened to ensure there is no untoward incident ahead of February 20when the Prime Minister arrives.

"Besides upgradation of vigil on the borders, the security forces are patrolling the highways and other vulnerable spots, from the security point of view", the officer said, adding, "frisking has also been intensified in many south districts including Kulgam." Udhampur

He said that naka checking has been increased in Kulgam and vehicles and bikes without number plates are being seized.

Pertinently, Prime Minister Narendra Modi is scheduled to visit Jammu on February 20 and will inaugurate various projects including AIIMS Jammu, world's highest railway bridge over Chenab, and north India's first river rejuvenation project — Devika river project — in Udhampur.

Private Schools In J&K Flout Admission Fee Ban

Srinagar: Despite authorities' strict ban on private schools charging admission fees from parents, numerous complaints persist, indicating that many schools continue to impose such fees under various guises like de-

velopment fees or capitation fees. In December 2023, the committee for fixation and regulation of fee of private schools (FFRC) warned school administrators not to charge admission fees during the ongoing admission process in Jammu and Kashmir in violation of the established statute.

However, as the admission process for the new academic session has started, the parents haven't got any relief as the schools heads have found ways to charge the fee.

On Thursday, a picture of Doon International School's admission/registration form along with a break-up of the charges went viral on social media. The school had asked the parents to pay Rs one lakh as "development charges".

Besides, it mentioned Rs 4200 as tuition fee and Rs 4070 as annual charges. Directorate of School Education Kashmir (DSEK), while taking note of the violation of the provisions under RTE Act and circular instructions issued by the directorate and FFRC in this regard, issued a notification asking Doon School to explain its position within three days.

"It is pertinent to mention here that capitation fee means any kind of donation, admission fee or contribution or payment other than the fee notified by the school," the notification reads.

50 Held In Srinagar Ahead Of Protests In Farmers' Support

Srinagar: The Jammu and Kashmir Police on Friday detained 50 trade union leaders and activists who were planning to hold a protest at Lal Chowk here in support of the demands of agitating farmers.

The protest was planned in response to the Samyukta Kisan Morcha's call for a 'Bharat Bandh' to press the government to accept the agitating farmers' demands, including a legal guarantee of minimum support price (MSP) for crops.

The leaders and activists were detained by police near Pratap Park on Residency Road as they were assembling for protests and taken to Kothibagh police station, officials said.

CPI(M) leader M Y Tarigami condemned the police action.

"Condemning in no uncertain terms the use of forces against the peaceful protest of Apple Farmers' Federation of India, scheme workers and CITU leaders organised in response to Grameen Bharat Bandh," Tarigami said in a series of posts on X.

He claimed that scores of leaders, including Kulgam District Development Council (DDC) chairman Mohammad Afzal, Apple Farmers' Federation of India president Zahoor Ahmad Rather, general secretary Abdul Rasheed, were "unjustly arrested after being bundled into police vehicles".

"The use of brute force against peaceful protesters is an affront to democracy and a violation of fundamental rights," he added.

Satellite Photos Show Egypt Building A Wall Near Gaza Strip As Israeli Offensive On Rafah Looms



DUBAI: Egypt is building a wall and levelling land near its border with the Gaza Strip ahead of a planned Israeli offensive targeting the border city of Rafah, satellite images analysed Friday by The Associated Press

Egypt, which has not publicly acknowledged the construction, has repeatedly warned Israel not to forcibly expel the over 1 million Palestinians now displaced in Rafah across the border into its territory while it battles the militant group Hamas for a fifth month.

However, the preparations on the Egyptian side of the border in the Sinai Peninsula suggest Cairo is preparing for just that scenario, something that could threaten its 1979 peace deal with Israel that's been a linchpin for regional security.

The Egyptian government did not respond to requests for comment Friday from the AP. The Egyptian Foreign Ministry issued a statement on Feb. 11 warning Israel over its possible Rafah offensive and its "displacement of the Palestinian

The satellite images, taken Thursday by Maxar Technologies, show construction ongoing on the wall, which sits along the Sheikh Zuweid-Rafah Road, some 3.5 kilometres (2 miles) west of the border with Gaza.

The images show cranes, trucks, and what appear to be precast concrete barriers being set up along the road.

Those satellite images correspond to features seen in a video released by the Londonbased Sinai Foundation for Human Rights on Feb. 12.

The video shows a crane lifting concrete walls into place along the road. Nearby as well, construction crews appear to be levelling and clearing ground for an unknown purpose.

That can also be seen in the imagery from Planet Labs PBC of the area.

The Wall Street Journal, quoting anonymous Egyptian officials, described "an 8-square-(20-square-kilometer) walled enclosure" being built in the area that could accommodate over 100,000 people.

Hard-line officials within Israeli Prime Minister Benjamin Netanyahu's government have raised the possibility of pushing Palestinians out of the Gaza Strip, something strongly opposed by Israel's main ally, the United States. The Gaza Strip and the occupied West Bank are lands the Palestinians hope to have for their future state.

What Law Panel Said About "Worrisome Trend" In NRIs, **OCIs Marrying Indians**

NEW DELHI: Describing as a "worrisome trend" the "rising" cases of fraudulent marriages between NRIs and Indian citizens, the Law Commission has recommended a comprehensive law to deal with the situation and compulsory registration of such alliances.

While presenting the report "Law on Matrimonial Issues Relating to Non-Resident Indians and Overseas Citizens of India" to the law ministry, panel chairman Justice (Retd) Ritu Rai Awasthi said the Commission is of the opinion that the proposed central legislation should be comprehensive enough to cater to all facets involving marriages of NRIs as well as foreign citizens of Indian origin with that of Indian citizens.

"The rising occurrence of fraudulent marriages involving Non-Resident Indians (NRIs) marrying Indian partners is a worrisome trend. Several reports highlight an increasing pattern where these marriages turn out to be deceptive, putting Indian spouses, especially women, in precarious situations," Justice Awasthi said in his covering letter to Law Minister Arjun Ram Meghwal on

Haryana Police Use Tear Gas On Farmers At Shambhu Border; Talks With Centre Again On Sunday

CHANDIGARH: Haryana Police on Friday fired tear gas shells to disperse protesting farmers when they moved towards the barricades at the Shambhu border near Ambala, a day after talks between Union ministers and farmer leaders remained inconclusive.

The fresh confrontation comes on the fourth day of the farmers' 'Delhi Chalo' march, called by the Samyukta Kisan Morcha (Non-Political) and the Kisan Mazdoor Morcha, to press the government to accept their demands, including a legal guarantee of minimum support price (MSP) for crops.

Amid the impasse, the Union ministers and farmer leaders will meet on February 18 for the fourth round of talks. The two sides met on February 8, 12 and 15 as well but those talks remained inconclusive.

The farmers from Punjab began their march to the national capital on Tuesday but were stopped by security personnel at Shambhu and Khanauri points on Punjab's border with Haryana. The protesters have stayed put at the two border points since then.

On the fourth day of the protest, a 63-year-old farmer, who was among the protesters at the Shambhu border, died of a heart attack on Friday. According to officials, Gian

Singh, who hailed from Punjab's Gurdaspur district, complained of chest pain in the morning and was taken to



the Civil Hospital in Punjab's Rajpura. From there, he was rushed to Rajindra Hospital in Patiala, where doctors declared him brought dead.

Besides a legal guarantee of MSP, the farmers are demanding the implementation of the Swaminathan Commission's recommendations, pension for farmers and farm labourers, farm debt waiver, no hike in electricity tariff, withdrawal of police cases and "justice" for the victims of the 2021 Lakhimpur Kheri violence, reinstatement of the Land Acquisition Act, 2013. and compensation to the families of the farmers who died during a previous agitation in 2020-21.

Union Agriculture and Farmer Welfare Minister Ariun Munda. Commerce and Industry Minister Piyush Goyal and Minister of State for Home Affairs Nityanand Rai represented the Centre at Thursday's meeting. Punjab Chief Minister Bhagwant Mann and Finance Minister Harpal Singh Cheema also joined the meeting.

After the five-hour-long talks, Munda said, "We will find a solution by sitting together." Mann said he raised with the Centre the issue of suspension of internet services in certain areas in Sangrur, Patiala and Fatehgarh Sahib, and that of Haryana security personnel using a drone to drop tear gas shells on protesters inside Punjab's territory.

Farmer leader Sarwan Singh Pandher said a detailed discussion was held on their demands. including a legal guarantee for MSP and a debt waiver. "They (Union ministers) said they need time," he said.

"We want that there should be a positive result and any confrontation should be avoided. Otherwise, our programme to go to Delhi stands." Responding to a question on whether farmers will stay put at the Puniab-Harvana borders, Pandher said, "Yes".

Pandher said they also raised the issue of tear gas shelling by the paramilitary forces on farmers at the Shambhu and Khanuri borders. He said they showed the shells to the ministers during

Haldwani Violence Culmination Of Long-Brewing **Communal Tension: Fact-Finding Team Report**

NEW DELHI: A civil rights groups-led fact-finding team has claimed that the violent clashes that shook Haldwani on February 8 was not an isolated incident but rather the culmination of escalating communal tensions fuelled by divisive rhetoric and policies.

Violence broke out on February 8 over the demolition of an illegally built madrassa in the Banbhoolpura area, with locals hurling stones and petrol bombs at municipal workers and police, forcing many police personnel to seek refuge at a police station, which the mob then

In the clashes, six "rioters" were killed and more than a 100, including police personnel and medianersons, were injured. the police.

A look-out notice has been issued against Haldwani violence key accused Abdul Malik and his son Abdul Moid, while five more rioters have been arrested, police said on Friday.

A civil society fact-finding team comprising members of the Association for Protection of Civil Rights and Karawan-e-Mohabbat had visited Haldwani on Wednesday.

The team's report claimed that despite the matter being sub judice, authorities moved to demolish the sealed mosque and madrasa, triggering anguish in the Muslim community. The situation quickly escalated with clashes erupting between residents and law enforcement.

The report cited witnesses' testimony and alleged excessive use of force by police, including indiscriminate firing and brutality during searches and detention.

The report criticized the prolonged imposition of curfew and internet shutdown, exacerbating the hardships faced by the already vulnerable residents, particularly women and

Because the area directly affected by violence on February 8 continued to be under curfew, it was not possible for the team members to directly meet and talk to the affected people, it said.

"We also reached out to members of the district administration however they either did not respond or informed us that they were very busy and therefore unable to meet us.

"Therefore, this is an interim report based on the conversations with a large number of members of civil society, journalists, writers and lawyers; and telephone conversations with a few affected persons who spoke to us on the condition of anonymity," the report said.

Riot Convict Extradited From UAE Within 4 Months **Of Red Corner Notice**

NEW DELHI: A most wanted criminal was extradited from the UAE on Friday after he was "geo-located" in the Gulf by Interpol channels. Narender Singh, who was wanted by the Haryana Police for murder and rioting, also faced a Red Corner Notice.

Singh was convicted in 2009 and jailed for life. Interpol had issued a Red Corner Notice against him on November 7 last year following a request from India.

The Red notice was then circulated to all Interpol member countries to identify his location.

He was geo-located in the UAE through a close follow-up by the Central Bureau of Investigation (CBI) via Interpol, the central agency said. Geo-locating someone means identifying the geographic location of an individual based on data collection mechanisms.

The CBI's Global Operations Centre coordinated with its National Central Bureau for In-



terpol in Abu Dhabi, the Indian embassy, the foreign ministry, and the Haryana Police to secure his extradition.

"The Red Notice subject was returned today from UAE to India with a security detail from STF of Haryana Police," said the CBI.

The CBI serves as the National Central Bureau for Interpol and coordinates with all local law enforcement agencies in the country for assistance. The central agency issued around 100 Red Corner Notices in 2023 and extradited 29 fugitives

Elections Sans Democracy

he election results in Pakistan have brought a mix of surprise and predictability. While there was anticipation for the success of the PTI, led by the imprisoned Imran Khan, many doubted its chances after being barred from contesting as a party and losing its bat symbol. However, against all odds, PTI-backed independents with symbols like eggplants, lions, and hookahs secured the highest number of seats.

Khan's pursuit of power in Pakistan has hit a roadblock as the authorities anticipated and prevented party-less independents from forming the government. The irony lies in the fact that the party with a significant share of seats, despite electoral irregularities, will now sit in the opposition, while those benefiting from irregularities will govern.

What was the point of this elaborate exercise then? A more pertinent question would be what is the point of democracy if it can be so effortlessly and blatantly compromised. And this isn't just true of Pakistan but of most third world countries. And there are several forms this rigging can take. It can start with pandering to the base instincts of a substantial section of a people, comprising pentup prejudices, hatreds, a will to dominate minorities etc to playing to imagined historical resentments or harking back to a mythical glorified ancient past. It can also take the form of subsidy or token freebies extended to a vast majority of poor people as a welfarist measure, who then vote for the benefactor party purely out of consideration to retain the help, which they otherwise are made to fear they will lose. Similarly, the ruling parties can also resort to suborning of the media and subverting of the institutions to ensure peddling of helpful narratives and myths as well as silencing of the opposition.

In Pakistan's case, the attempt to rig the system has been brazen and direct, with little nod to any subtlety A leader who obviously commands the support of a vast majority of people and who, therefore, should have been presiding



over the destiny of the country in a democratic set up has been jailed, and his party taken apart, deprived even of its symbol. Its leaders took part in the election as independent candidates under different symbols and despite credible allegations of interference with the voting process, still won the largest number of seats. But the party doesn't get the invite to form the government on technical reasons - since it has been reduced to a group of independent candidates. The unpopular parties who won many of their seats largely through institutional help are getting to form the government.

This reveals a sordid reality about the operation of democracy outside the west, its birthplace: a powerful ruling party or a powerful institution as in the case of Pakistan can take a country through the motions of a democratic operation only to ensure a premeditated outcome. Advancing communications technology has made it even easier. Far from empowering masses which it was earlier billed to have done, it has disproportionately empowered the governments, almost enabling them to act God-like. Public opinion can now be shaped or manipulated on a far greater scale than ever before through misinformation and disinformation peddled systematically on formal and social media. So much so that the governments can now hone

a public opinion according to their conveniences. This, in turn, influences the public reaction to day to day events. And in its most consequential fallout, even the outcome of elections. Former US president Donald Trump's election as the US president in 2016 is believed to have similarly been maneuvered remotely by Russia. However, in a highly literate society such as the US, people have a higher ability to see through fake information, a factor that played a decisive role in Trump's defeat in the 2020 election, despite his violent effort to overturn the outcome.

But this is generally not the case in our part of the world, where closely networked elites acquire a vice-like grip over the power structure and go on perpetuating it by fair means or foul. And swathes of the deprived and poor don't understand the language of rights, and are too weak to take the elites on. Another factor is that the people have lived for centuries under feudal systems and consider elites as their benefactors.

Crisis of democracy has only become deeper, and as Trump's advent in the US shows, its repercussions are being felt in the west also. One conspicuous feature of this failing is that it has increasingly come to disempower minorities. In their short-cut pursuit of power, leaders seek to forge the majority community into a monolithic community by directing their anger against the minorities. This state of affairs is only getting worse by the day, with brazen attempts being made to make the minorities' way of life subservient to that of the majority community. This needs urgent addressing if democracy is to survive as a form of government that gives both the individuals and the communities a say and a stake in the governance.

he Supreme Court on Thursday struck down the validity of the electoral bonds, a controversial political funding instrument, terming it as unconstitutional. We examine the key issues, and whether this will have any bearing on the Bharatiya Janata Party, which is believed to be the key beneficiary of the bonds, ahead of the general election.

What is the electoral bonds scheme?

The bonds allow corporations and individuals to anonymously donate money to political parties by purchasing electoral bonds from the State Bank of India (SBI). Notably, the SBI has sole access to the details of those who purchased electoral bonds. The Supreme Court has now ordered SBI to stop rolling out such bonds and submit details of bonds purchased since April 2019 to the Election Commission by March 6. By March 13, all the data has to be posted on the EC's website.

According to the scheme, the proceeds from any bonds, which are not encashed within 15 days of being issued, are to be deposited in the Prime Minister's National Relief Fund. It was first mentioned in the 2017 Budget speech by then finance minister Arun Jaitley. The scheme was pushed as a solution to the issue of opacity in political parties' funding. According to the Centre for Media Studies, the 2019 elections cost about Rs 60,000 crore, a large chunk of which came from electoral bonds.

Why was it challenged in court?

Petitions were filed by the Communist Party of India (Marxist), and non-governmental organisations Common Cause and ADR. Advocate Prashant Bhushan argued that citizens have a right to information about the parties and candidates seeking their votes. Bhushan pointed out that there are roughly 2.3 million registered companies in India. Figuring out how much each company had donated using this method would not be possible for an ordinary citizen. The argument also was that the scheme would distinctly favour the ruling government of the time, as the guarantee of anonymity would allow the government to provide favours in various forms.

Senior advocate Kapil Sibal drew the court's attention to how the scheme could result in companies failing their duties towards their shareholders.

Axe On Electoral Bonds: A Case Of Too Little, Too Late?

Allowing companies to "funnel money" to political parties without any oversight from shareholders denies the owners the ability to decide how their company should act in the political sphere.

How did the axe fall?

The Supreme Court raised several issues in its verdict, one of which was that the scheme violates the right to information under Article 19(1)(a), which guarantees the freedom of speech and expression. The court held that information on the funding of political parties is essential for voting. It also held that the RTI can only be restricted based on Article 19(2), which speaks of the reasonable restrictions

to freedom of speech and expression. It does not include curbing black money as a restriction. Even assuming curbing black money is a legitimate purpose, it is not proportional to the restrictions posed by this scheme.

The court said the ability of companies to influence the political process through contributions is much higher compared to individuals. The most crucial aspect the court considered is whether the encroachment on fundamental rights is proportional to the objection sought to be achieved. Chief Justice D Y Chandrachud said the state did not adopt the least restrictive method. As an example of the least restrictive methods, he cited the Rs 20,000 cap on anonymous donations.

Will the decision affect the BJP?

The Bharatiya Janata Party's (BJP) defence was that political parties earlier received most of their funds through anonymous donations which were shown in cash. An effort, therefore, required to be made to cleanse the system of political corruption; the party also said that donors had the right to privacy. In the six years through 2022, the BJP earned Rs 5,271 crore via this funding tool, accounting for 57% of the Rs 9,200 crore raised through these bonds, according to a report by the Association for Democratic Reforms (ADR), based on data from the Election Commission. The share of the Congress, was 10%.

However, political pundits say the court decision may do little to damage the BJP, the main beneficiary of the funding, so close to the polls. Yogendra Yadav, a political activist and founding member of political party Swaraj Abhiyan, said while the court's action was welcome, the decision was "unduly and extraordinarily" delayed, and it is too late now as the ruling party may already have taken advantage of the bonds. BJP, in any case, doesn't have a paucity of funds, has deep pockets and collects its funding from multiple sources. Opposition parties were anyway not getting much donation through these bonds.

ChatGPT's Tryst With Short Story Editing

Writers have been using Al tools for years – from Microsoft Word's spellcheck (which often makes unwanted corrections) to the passive-aggressive Grammarly. But Chat-GPT is different.

ChatGPT's natural language processing enables a dialogue, much like a conversation – albeit with a slightly odd acquaintance. And it can generate vast amounts of copy, quickly, in response to queries posed in ordinary, everyday language. This suggests, at least superficially, it can do some of the work a book editor does.

We are professional editors, with extensive experience in the Australian book publishing industry, who wanted to know how ChatGPT would perform when compared to a human editor. To find out, we decided to ask it to edit a short story that had already been worked on by human editors – and we compared the results.

THE EXPERIMENT: CHATGPT VS HUMAN EDITORS

The story we chose, The Ninch (written by Rose), had gone through three separate rounds of editing, with four human editors (and a typesetter).

The first version had been rejected by literary journal Overland, but its fiction editor Claire Corbett had given generous feedback. The next version received detailed advice from freelance editor Nicola Redhouse, a judge of the Big Issue fiction edition (which had shortlisted the story). Finally, the piece found a home at another literary journal, Meanjin, where deputy editor Tess Smurthwaite incorporated comments from the issue's freelance editor and also their typesetter in her correspondence.

We had a wealth of human feedback to compare ChatGPT's

recommendations with. We used a standard, free Chat-

GPT generative AI tool for our edits, which we conducted as separate series of prompts designed to assess the scope and success of AI as an editorial tool.

We wanted to see if ChatGPT could develop and fine tune this unpublished work – and if so, whether it would do it in a way that resembled current editorial practice. By comparing it with human examples, we tried to determine where and at what stage in the process ChatGPT might be most successful as an editorial tool.

The story includes expressive descriptions, poetic imagery, strong symbolism and a subtle subtext. It explores themes of motherhood, nature, and hints at deeper mysteries.


We chose it because we believe the literary genre, with its play and experimentation, poetry and lyricism, offers rich pickings for complex editorial conversations. (And because we knew we could get permission from all participants in the process to share their feedback.)

In the story, a mother reflects on her untamed, sea-loving child. Supernatural possibilities are hinted at before the tale turns closer to home, ending with the mother revealing her own divergent nature – and looping back to offer more meaning to the title: pinching the skin between my toes ... Making each digit its own unique peninsula.

ROUND 1: THE FIRST DRAFT

We started with a simple, general prompt, assuming the least amount of editorial guidance from the author. (Authors submitting stories to magazines and journals generally don't give human editors a detailed, prescriptive brief.)

Our initial prompt for all three examples was: "Hi Chat-GPT, could I please ask for your editorial suggestions on my short story, which I'd like to submit for publication in a literary journal?"

Interestingly, ChatGPT did not pick up that the story was now

Interestingly, ChatGPT did not pick up that the story was now published and attributed to an author. Raising questions about its ability, or inclination, to identify plagiarism. Nor did it define the genre, which is one of the first assessments an editor makes.

ChatGPT's suggestions were: to add more description of the coastal setting, provide more physical description of the characters, break up long paragraphs to make the piece more readerfriendly, add more dialogue for characterisation and insight, make the sentences shorter, reveal more inner thoughts of the characters, expand on the symbolism, show don't tell, incorporate foreshadowing earlier, and provide resolution rather than ending on a mystery.

ALL GOOD, IF STOCK STANDARD, ADVICE.

ChatGPT also suggested reconsidering the title – clearly not making the connection between mother and daughter's ocean affinity and their webbed toes – and reading the story aloud to help identify awkward phrasing, pacing and structure.

While this wasn't particularly

nically wrong.
ChatGPT picked up on the major themes and main characters.
And the advice for more foreshadowing, dialogue and description, along with shorter paragraphs and an alternative ending, was generally sound.

helpful feedback, it was not tech-

In fact, it echoed the usual feedback you'd get from a creative writing workshop, or the kind of advice offered in books on the writing craft.

They are the sort of suggestions an editor might write in response to almost any text – not particularly specific to this story, or to our stated aim of submitting it to a literary publication.

STAGE TWO: AI (RE)WRITES

Next, we provided a second prompt, responding to ChatGPT's initial feedback – attempting to emulate the back-and-forth discussions that are a key part of the editorial process. We asked ChatGPT to take a

more practical, interventionist approach and rework the text in line with its own editorial suggestions: Thank you for your feedback

about uneven pacing. Could you please suggest places in the story where the pace needs to speed up or slow down? Thank you too for the feedback about imagery and description. Could you please suggest places where there is too much imagery and it needs more action storytelling instead?

That's where things fell apart.

ChatGPT offered a radically shorter, changed story. The atmospheric descriptions, evocative imagery and nods towards (unspoken) mystery were replaced with unsubtle phrases – which Rose swears she would never have written, or signed off on.

Lines added included: "my daughter has always been an enigma to me", "little did I know" and "a sense of unease washed over me". Later in the story, this phrasing was clumsily suggested a second time: "relief washed over me".

The author's unique descrip-

tions were changed to familiar cliches: "rugged beauty", "roar of the ocean", "unbreakable bond". ChatGPT also changed the text from Australian English (which all Australian publications require) to US spelling and style ("realization", "mom").

In summary, a story where a mother sees her daughter as a "southern selkie going home" (phrasing that hints at a speculative subtext) on a rocky outcrop and really sees her (in all possible, playful senses of that word) was changed to a fishing tale, where a (definitely human) girl arrives home holding up, we kid you not, "a shiny fish".

It became hard to give credence to any of ChatGPT's advice.
Esteemed editor Bruce Sims once advised it's not an editor's job to fix things; it's an editor's job to point out what needs fixing. But if you are asked to be a hands-on editor, your revisions must be an improvement on the original – not just different. And certainly not worse.

It is our industry's maxim, too, to first do no harm. Not only did ChatGPT not improve Rose's story, it made it worse.

WHAT DID THE HUMAN EDITORS DO?

ChatGPT's edit did not come close to the calibre of insight and editorial know-how offered by Overland editor Claire Corbett. Some examples:

There's some beautiful writing and fantastic themes, but the quotes about drowning are heavy-handed; they're given the job of foreshadowing suspense, creating unease in the reader, rather than the narrator doing that job.

The biggest problem is that final transition – I don't know how to read the narrator. Her emotions don't seem to fit the situation.

For me stories are driven by choices and I'm not clear what decision our narrator, or anyone else, in the story faces.

It's entirely possible I'm not getting something important, but

our readers won't either.

Freelance editor Nicola, who has a personal relationship with Rose, went even further in her exchange (in response to the next draft, where Rose had attempted to address the issues Claire identified). She pushed Rose to work and rework the last sentence until they both felt the language lock in and land.

I'm not 100% sold on this line. I think it's a little confusing ... It might just be too much hinted at in too subtle a way for the reader.

Originally, the final sentence read: "Ready to make my slower way back to the house, retracing – overwriting – any sign of my own less-than more-than normal prints."

The final version is: "Ready to make my slower way back to the house, retracing, overwriting, any sign of my own less-than, more-than, normal prints." With the addition of a final standalone line: "I have seen what I wanted to see: her, me, free."

Claire and Nicola's feedback show how an editor is a story's ideal reader. A good editor can guide the author through problems with point of view and emotional dynamics – going beyond the simple mechanics of grammar, sentence length and the number of adjectives.

In other words, they demonstrate something we call editorial intelligence

Editorial intelligence is akin to emotional intelligence. It incorporates intellectual, creative and emotional capital – all gained from lived experience, complemented by technical skills and industry expertise, applied through the prism of human understanding.

Skills include confident conviction, based on deep accumulated knowledge, meticulous research, cultural mediation and social skills. (After all, the author doesn't have to do what we say ours is a persuasive profession.)

How The Weird And Wonderful Microbes In Wastewater Can Make Our Cities More Sustainable

ovid-19 showed us how useful monitoring wastewater can be. But the genetic material in our wastewater, namely DNA and RNA, is a treasure trove of other useful information. It reveals the presence of thousands of different types of weird and wonderful wastewater microbes.

The diversity of these microbes can talk to us and tell us how to get more renewable energy out of our wastes. If only we could listen to them. Soon we can.

How will that work? It all starts with our poo. These types of microbes have been used since the 19th century to treat and reduce the ever-increasing volumes of sewage sludge arriving at our wastewater treatment plants, especially in urban areas. Two-thirds of the world's people are expected to live in urban areas by 2050, hence sewage treatment will be in high demand.

Yet most people today have little idea how vital microbes are for sustainable growth of cities. We need them to treat our

We also need sources of renewable energy. Thanks to naturally occurring microbes, our water utilities can produce renewable biogas from human waste. By reducing our reliance on fossil fuels, their poo biogas can help to mitigate climate change.

So we need to learn more about these microbes to ensure they are doing the best possible job of processing our waste. One way of doing that is by monitoring DNA in human waste sludge.



A living sludge mass

First of all, this promising waste-to-energy technology, which fully relies on microbes, is called anaerobic digestion.

Operating anaerobic digesters is expensive. It requires intense monitoring strategies and frequent interventions. That is because microbes can be unpredictable.

On the face of it, the process is really simple. Wastewater sludge is pumped into large vessels without oxygen, where microbes are left alone for a few days to practically eat the sludge and breathe out biogas. Sludge goes in, treated sludge plus gas goes out.

The process reduces overall sludge mass and the number of pathogens. This ultimately makes it a safer material, while also generating renewable energy. Bril-

liant, right?

But there is a catch. This process is only effective if these living, breathing treatment vessels behave. Unfortunately, sometimes they get out of control without warning, making them difficult to manage.

These sludge microbes are similar to those in our gut. Once we know this, we might intuitively understand how sensitive they can be, given our experience of gastrointestinal disorders linked to our gut microbes.

So microbial happiness is not only important for our own health, it is crucial for the health of the large digester vessels managed by wastewater treatment plants. To make it cheaper to run these facilities, we urgently need to learn more about life in our sludge.

We also need sources of renewable energy. Thanks to naturally occurring microbes, our water utilities can produce renewable biogas from human waste. By reducing our reliance on fossil fuels, their poo biogas can help to mitigate climate change.

DNA, a window on an invisible world

At the ARC Biosolids Training Centre we want to make anaerobic digestion easier for water utilities by developing routine DNA-based monitoring tools. Essentially, we are looking for a way to predict the process to manage it better.

DNA tells the story of thousands of different types of microbes that work together to treat our sludge. To optimise the wastewater treatment process we need to identify them, the troublemakers and the do-gooders.

But sludge life is complex. Before it can tell us its story, we require empirical stud-

ies. We have to be able to relate microbial DNA to the process.

To show how that works we produced a review of the role of microbes for monitoring anaerobic digestion. This includes some of the diversity metrics that ecologists use to assess the health of the whole system based on the composition of microbes.

The weird and the wonderful

The microbes that are used to treat sludge consist of a diverse range of ancient, weird, at times alien-like bacteria and archaea (another form of single-celled organisms). They can metabolise materials that no other lifeform can.

Amazingly, some of them existed 3.5 billion years ago the Earth formed 4.5 billion years ago. There is even a chance some have existed on Mars.

And sludge life is a very active community of microbes: some are bullies, some collaborators. Through their DNA, we count them to learn how many different types of microbes there are and how often they appear. This counted diversity can then tell us if a system is healthy or not.

For a healthy, productive system, we need diversity as many different microbes as possible to provide stability. If a particular organism somehow starts to grow faster or slower, it means something is getting out of control.

We can exploit that knowledge to develop risk scores for the operators of treatment facilities. And that is what we try to do.

We will keep working so that someday we can properly listen to our sludge-eating microbes and get more value out of our poo.

A Simple Blood Test To Predict Risk Of Heart Attack Within Six Months

simple blood test can help detect several important biological processes that are active during the months before a heart attack, suggests a study.

Heart attacks are the most common cause of death in the world and are increasing globally. Many high-risk people are not identified or do not take their preventive treatment.

Now, researchers at Up-

ple who will soon suffer their first heart attack," Sundstrom said, in the paper published in the journal Nature Cardiovascular Research.

The research group had access to blood samples from 1,69,053 individuals without prior cardiovascular disease in six European cohorts. Within six months, 420 of these people suffered their first heart attack. Their blood was then compared with blood from 1,598 healthy members of the cohorts.

"We identified around 90



psala University in Sweden have found that the blood test can predict if you are at an increased risk of having a heart attack within six months.

The problem, according to the researchers, is that risk factors have previously been verified in studies involving five to ten years of follow-up, where only factors that are stable over time can be identified.

"However, we know that the time just before a heart attack is very dynamic. For example, the risk of a heart attack doubles during the month of a divorce, and the risk of a fatal heart event is five times as high during the week after a cancer diagnosis," said cardiologist and professor of epidemiology Johan Sundstrom.

"We wanted to develop methods that would enable the health services to identify peomolecules that were linked to a risk of a first heart attack. However, the samples that are already taken in health care now are enough to predict the risk. We hope that this will increase people's motivation to take their preventive medicine or stop smoking, for example," Sundstrom said.

The researchers have also developed a simple online tool in which anyone can find out their risk of having a heart attack within six months.

"This was one of the aims of the entire study since we know that people feel relatively low motivation to follow preventive treatments. If you find out that you happen to have an increased risk of suffering a heart attack soon, perhaps you will feel more motivated to prevent it," Sundstrom said.

POLIO CAMPAIGN

Every Child Under 5 Must Receive Vaccine from March 3: Govt.

SRINAGAR: Secretary Health and Medical Education, Dr Syed Abid Rasheed Shah on Friday underscored that every child under 5 years of age must be administered Oral Polio Vaccine (OPV) on National Immunization Day (Pulse Polio) on March 3.

He said that India maintains polio free status since 2011 and to ensure that the country stays free of polio, all stakeholders must redouble their efforts. He called upon all stakeholders, including the general public to wholeheartedly participate in the National Immunization Day (NID) to ensure maintenance of polio free status of the country and Jammu & Kashmir.

He made these remarks during the State Task Force meeting regarding National Immunization Day to discuss the planning & implementation of activities for Pulse Polio schedacross Jammu & Kashmir.

The health department will administer OPV to all children in the age group of 0-5 in the arranged booths throughout the UT on 3rd March followed by house to house activity on 4th and 5th March while transit sites and special areas will be covered throughout the three days of immunization programme. In Jammu and Kashmir, around 19 lakh children will be inoculated during the three days from March 3 - 5.

The meeting was attended by Mission Director, National Health Mission, J&K, District **Development Commissioners** of J&K , Director School Education Kashmir, Director School Education Jammu, Director AYUSH J&K, Director Health Services, Jammu, Director Health Services, Kashmir, Chief Medical Officers, State Immunization Officer, J&K, Deputy CMO's of J&K, District Immunization Officers (DIOs)

Dr Abid Rasheed took a detailed review from every district about the preparations made and the steps taken by them for the NID activities among the target population, including the details of number of booths, vaccine availability in far-off places.


While chairing the meeting, Secretary Health & Medical Education said that maintaining polio free status is a prime responsibility for all stakeholders. He said that effective implementation of pulse polio immunization programme is necessary to safeguard our future generations from this

He called upon all the concerned departments to ensure active indulgence and take leadership roles in making this immunization programme successful so that no eligible child is left behind without vaccination.

He said that some districts have peculiar geographical challenges and they should put in place a meticulous and in-depth plan in this regard. He said that slum areas brick kilns, construction sites, hard to reach areas and other vulnerable areas should be given utmost attention during the immunization day and proper surveillance must be maintained in such areas.

Secretary Health also directed the DIOs to maintain adequate supply of vaccine at all locations while emphasising the criticality of cold chain maintenance.

He said that Chief Medical Officers/District Immunization Officers Shall ensure all vaccinators and supervisors have undergone orientation as and when required. He said that they should make supervisory visits to sub district levels to review preparedness and monitor implementation.



Ton-up Duckett Propels England To 207/2 On Day 2

RAJKOT: Opener Ben Duckett led England's strong response with a scintillating hundred as the visitors raced to 207/2 at stumps after bowling out India for 445 on the second day of the third Test here on Friday.

At stumps, Duckett was batting on 133 and his teammate Joe Root was 9 not out as England scored their runs in only 35 overs to trail by 238 runs.

Ashwin become only the second Indian bowler to take 500 wickets in Test cricket, with the wicket of Zak Crawley (15).

Duckett got to his century in just 88 balls, the fastest by an Englishman against India.

Earlier, in his first international outing, wicketkeeper-batter Dhruv Jurel batted very well for a neat 46.

India resumed the second day on their overnight score of 326/5 with ladeia and night-watchman Kul-The day also saw Ravichandran deep Yadav (1) at the crease.

Both Jadeja and Kuldeep, however, got out quickly as India slipped to 331/7. Ashwin and Jurel then steadied the innings.

Ashwin Looks Beyond Kumble's Record After Conquering Mount 500

RAJKOT: R Ashwin is a content man after becoming only the second Indian to take 500 Test wickets and has no interest in chasing Anil Kumble's national record of 619 scalps. Ashwin dismissed England opener Zak Crawley in the final session on day two and became only the ninth bowler to scale 'Mount 500' in Test history. The 37-yearold Ashwin said he has no particular aim of pushing for more and try and get to Kumble's record.

"The very simple answer is 'no'... 120 wickets away. Every day is what I want to live for, and, I'm 37 years old. I don't know what's in store next," Ashwin told the media here after stumps on the second day. "What's in store for the next two months? You play this series and then what lies ahead, you really don't know.

"I don't want to really jump the gun. I've kept it this way for the last 4-5 years and it's been very simple and it's worked for me. Why change anything that's working for you?' Ashwin added.

Recalling his journey on one of the most memo-

Kishan Skips Ranji Game To Play DY Patil T20 Before IPL

JAMSHEDPUR: Ishan Kishan's absence from Ranji Trophy continued as the wicketkeeper-batter, who plays domestic cricket for Jharkhand, skipped the final round of matches that started on Friday, a move that might not go down well with BCCI especially after the diktat from secretary Jay Shah.

Jharkhand are playing Rajasthan in Jamshedpur and even Deepak Chahar, who is currently training with the Chennai Super Kings, skipped the last round Ranji game.

It is learnt that Kishan was asked by a senior member of the Indian team think-tank to play Ranji Trophy in order to make a comeback to the Test team but the flambovant keeper-batter has reportedly said he was "working on certain technical aspects" of his game and was

not ready for red-ball cricket. The 25-year-old from Patna, who is currently training with his Mumbai Indians skipper Hardik Pandya in Baroda, is set to make a comeback to competitive cricket for his employers Reserve Bank of India in Mumbai's DY Patil T20 tournament.

DY Patil T20 is a tournament there most of the office teams take part and a lot of players tune up for the cash-rich IPL by playing in the event.

It is Kishan's reluctance to play first-class cricket and focus only on the IPL that forced the BCCI to make a minimum number of Ranji Trophy games mandatory for players in order to be eligible for the cash-rich league's lucrative auction pool.

"If you are fit then no excuse will be entertained," BCCI secretary Jay Shah recently told the media in Rajkot.

Kylian Mbappe Tells PSG He Will Leave At The End Of The Season: Report

PARIS: Kylian Mbappe has told Paris Saint-Germain he will leave the club at the end of the

The France international informed PSG President Nasser Al-Khelaifi he would not stay at the club when his contract expires, two people with knowledge of the situation told The Associated Press.

Both people spoke on condition of anonymity because Mbappe hasn't made his decision public yet.

One person said Mbappe who has previously been pursued by Real Madrid — did not indicate which club he would ioin next.

PSG declined to comment, but a second person with knowledge of Mbappe's decision said the terms of his departure were still being worked out with the club and an official statement would not come until that has been finalized.

Mbappe - widely considered to be one of the best players in the world — will be a free agent at the end of the season after seven years with

He informed the club last

year that he would not trigger an extension to the contract he signed in 2022.

When he signed that last deal, PSG paraded him at Parc des Princes holding up a jersey with 2025 written on it - even though the actual contract was until 2024, with an option for an extra year. That episode reportedly irked Mbappe, who then also felt let down by the club for failing to sign enough top-class players — other than Lionel Messi – after they pledged to do when he penned the deal.

While Madrid seems like the most probable destination for Mbappe, his departure from PSG is likely to spark a bidding war between a host of other clubs eager to sign the former World Cup winner.

The 25-year-old Mbappe has been at PSG since 2017 after signing from Monaco in a transfer worth a reported \$190 million. He arrived at the same time as Neymar, who cost PSG a world record \$222 million from Barcelona.

In 2021, PSG turned down a bid of \$190 million from Real Madrid for the forward, who went on to sign his current

a high by winning European club soccer's biggest prize this season. He scored in PSG's 2-0 win on Wednesday over Real Sociedad in the first leg of the round of 16, taking his

record-extending club tally to 243 goals in just 290 games, including 38 in the Champions League.

He also has 93 assists for PSG, third on the club's alltime list.

Mbappe's decision brings an end to a drawn-out saga that has overshadowed his final year at the club.

His PSG career could have ended last summer amid a tense transfer standoff. After

telling the club he would not extend his contract for an extra year, he was left off a preseason tour to Japan and South Korea and forced to train with fringe players. PSG said it would rather sell him than let him leave for free in 2024, but Mbappe rejected a 300 million euro move to Saudi team Al-Hilal.

PSG left Mbappe out of the team's opening league game of the season as the standoff continued - a dull 0-0 home draw which he watched from the stands — but then quickly relented and let him return to the lineup.

Even before that, Mbappe had sometimes let his evident frustration with the club show

on and off the field. After a 0-0 draw early last season, he posted a sarcastic message seemingly in reference to his displeasure at being used as a lone center forward, when he prefered to play behind a striker like France teammate Olivier Giourd. His Instagram post with the hashtag pivotgang – a pun on the word pivot (tar-

get man) — was then deleted. Despite his brilliant scoring record, Mbappe has not always been a fan favorite at

Some fans questioned why he staved at all given his stated ambition to win the Champions League and Ballon d'Or trophy multiple times. He was won neither with PSG.

PSG may have sensed this moment was coming, since it has already made moves to shift its focus over the past 12 months in light of the exits of Messi and Neymar.

After years of problems with soccer violence and falling short on the field, PSG's fortunes improved after being taken over by Qatar Sports Investments in June 2011. PSG largely dominated French soccer with some of the biggest names in the sport, including Zlatan Ibrahimovic, Mbappe, Neymar and Messi. But it has begun to shift away from that model with signings like Randal Kolo Muani and Bradley Barcola last year.

Mbappe has long been viewed by Madrid as the ideal successor to Karim Benzema, who left the Spanish giant for Al Ittihad in Saudi Arabia last

Whether PSG can find a successor to Mbappe remains to be seen, as he will leave a giant void.
