The experience of these women is a stark illustration of the misogyny lurking within Kashmir's social media landscape. While these platforms offer opportunities for expression and connection, they also provide a breeding ground for toxic behavior and

gender-based violence.

Experts say the alarming rise in cyber misogyny poses a significant challenge to the safety and well-being of women in Kashmir, amplifying the need for comprehensive strategies to address this pressing issue.

# **New Power Curtailment Schedule Likely** For Ramzan

**Srinagar:** The Kashmir Power Development Corporation Limited (KPDCL) is mulling to improve the power curtailment schedule in the holy month of Ramzan.

The department said that it will improve and reduce the power curtailment especially at Suhoor and fast breaking time (Iftar).

Chief Engineer KPDCL (Distribution), Sandeep Seth, said that the organization was formulating a plan and mechanism to address the power curtailment issues during the month of Ramzan.

"We are working on it and most likely, the new curtailment schedule will be implemented from the first day of Ramzan," he said.

When asked about the improvement of power curtailment at peak hours, the Chief Engineer said, "In the month of Ramzan, the peak hours will be pre-dawn and dusk. We are mulling to improve the power curtailment especially at Sahoor and Iftar."

# Over 1000 Road, Bridge Projects Worth 4,550 Cr Sanctioned Since 2019

PMGSY Drives Rural Connectivity In J&K, 99% Target Achieved

Srinagar: Since the transition of Jammu and Kashmir to a Union Territory, significant strides have been made in enhancing the region's infrastructure, particularly in road and bridge connectivity.
Official data reveals that

since 2019, a total of 1,057 road and bridge projects, valued at over Rs 4,550 crores, have been sanctioned.

According to the data, 290 bridges, with an investment exceeding Rs 880 crores, have been completed, while an additional 338 bridges, valued at over Rs 1,785 crores, are currently under construction. These developments are poised to not only improve connectivity but also stimulate economic growth and employment opportunities across the Union Territory.

The Pradhan Mantri Gram Sadak Yojana (PMGSY) has been instrumental in this infrastructure transformation, achieving over 99 percent of its



sanctioned program by March 2023. Under PMGSY I, II, and III, a remarkable 21,407 kilometres of roads have been constructed, linking 2,140 rural habitations and significantly enhancing accessibility.

Moreover, the Central Road and Infrastructure Fund (CRIF) has played a crucial role in bolstering infrastructure development, with 294 major road and bridge projects sanctioned since 2000, amounting to Rs 4,315 crores.

Notably, 163 projects have been completed, marking significant progress in the region's infrastructure landscape. "The focus on macadamization programs has ensured the upkeep and renewal of road surfaces, with over 16,807 kilometres of roads macadamized from 2020 to 2023 alone," an official said,



# **Uniform Civil Code: Neither Necessary Nor Desirable**

India is a mosaic of various cultures, religions, and ethnicities, each with its distinct set of customs, traditions, and personal laws. The Constitution of India recognizes the diversity and grants religious communities the right to govern their personal affairs

he Seventh Schedule of the Constitution provides that both the Centre and state legislatures can legislate on matters pertaining to family laws. In pursuance of this power, on February 7, the Uttarakhand Assembly passed the Uniform Civil Code (UCC) Bill, becoming the first legislature in independent India to pass a law that proposes common rules on marriage, divorce, inheritance of property, and live-in relationships for all citizens, irrespective of their

The recent passage of the Uniform Civil Code (UCC) Bill by the Uttarakhand Assembly has ignited concerns that other states may follow suit, potentially paving the way for a nationwide implementation. The fear looms that the central government might also consider enacting UCC legislation. It's crucial to initiate a timely discussion on the feasibility of the UCC in India.

India, known for its rich diversity and cultural tapestry, has always grappled with the idea of implementing a Uniform Civil Code (UCC) in post-independence era. The UCC proposes a common set of laws governing personal matters such as marriage, divorce, inheritance, and adoption, irrespective of an individual's religious affiliation. While the concept may seem appealing from a standpoint of equality and secularism, the intricate social fabric and unique historical context of India present significant challenges that make the implementation of a UCC

While proponents argue that it would promote equality and secularism, a closer examination reveals that the introduction of a UCC could have disastrous consequences for the nation. The complexities of India's diverse society, the potential erosion of minority rights, and the threat to social harmony are just a few reasons why the adoption of a UCC should be approached with extreme caution.

India is a mosaic of various cultures, religions, and ethnicities, each with its distinct set of customs, traditions, and personal laws. The Constitution of India recognizes the



diversity and grants religious communities the right to govern their personal affairs. Attempting to impose a uniform code across such a vast and heterogeneous population would be an affront to the principles of pluralism and secularism upon which the nation is founded.

India is a land of diverse religions and cultures, each with its unique set of personal laws. Introducing a UCC would necessitate the imposition of a uniform set of laws that will potentially erode the rights of religious minorities. Personal laws are deeply ingrained in religious customs and beliefs, and any attempt to subsume them under a common code will infringe upon the rights of individuals to practice their religion freely. Preserving the rights and autonomy of religious minorities is crucial for maintaining a pluralistic and inclusive society.

The Indian Constitution provides religious communities with the freedom to manage their religious and personal affairs. Article 25 guarantees the right to practice and propagate religion, while Article 26 recognizes the right of every religious denomination to manage its own affairs. The Constitutional framers, while aiming for a secular nation, deemed it necessary to accommodate diverse religious practices and personal laws. Any attempt to enforce a UCC would require significant amendments to the Constitution, which could undermine the delicate balance between individual rights and state intervention.

Though the Supreme Court In various judgments has called for the implementation of a UCC, but a 185page report published in 2018 by the Law Commission clearly said that a UCC "is neither necessary nor desirable at this stage",

The introduction of a UCC would be met with resistance from various religious communities, resulting in heightened social tensions and divisions. India's cultural and religious fabric is intertwined with personal laws that have evolved over cen-

turies, reflecting the customs and traditions of different communities. Forcing a common code upon these communities disregards their unique identities and can lead to cultural homogenization. Respecting and preserving the cultural and religious sensitivities of all citizens is essential for maintaining social

History has shown that attempts to tamper with personal laws can ignite widespread protests and social unrest. Very rightly terming the prospect of Uniform Civil Code difficult to implement, in 2017 former Law Commission Chairman Justice Balbir Singh Chauhan said "UCC is not possible and not even an op-

Uttrakhand Uniform Civil Code (UCC) Bill, which created more confusion than solutions, made it clear that implementing a UCC requires a comprehensive understanding of various personal laws and extensive legal reforms. The existing personal laws in India are deeply rooted in religious texts, customs, and traditions, developed and refined over centuries. Harmonizing these diverse laws into a single code would be a herculean task, fraught with practical difficulties.

And lets' not forget India faces several pressing challenges that warrant immediate attention, including poverty, illiteracy, healthcare, and gender inequality. Redirecting resources and energy towards implementing a UCC is nothing but diverting attention from more urgent social and economic issues. India's strength lies in its diversity, and any attempt to impose a UCC risks undermining this diversity and fracturing the social fabric of the nation.

# Securing India's Water Future

While access to water improves, the focus should now be on maintaining the infrastructure.

he importance of drinking water cannot be emphasised enough in a country like ours. The central government's Jal Jeevan Mission (JJM) has been the umbrella scheme to provide access to tap water in rural India. It is heartening to see that the government is giving due attention to water and sanitation - a fact reflected in recent Union Budgets. The Budget for fiscal year 2023-2024 had allocated `70,000 crore for the JJM, while the Interim Budget for 2024-25 has announced `70,163 crore for the same. The money has clearly been used to good effect, with the JJM having successfully provided tap water connections to 142.5 million rural households (almost 74%) of a total of 192.6 million till date, as per government data.

In fact, both the JJM and Swachh Bharat Mission (SBM) give us a stellar opportunity to push the needle on the coverage of infrastructure with their huge public investment and high political will. However, challenges persist in some states, and while the current Budget will undoubtedly advance the implementation of these programmes, there is a need to improve the operation and maintenance (O&M) of the infrastructure being created under the programmes, while also creating a future-proof mechanism for delivery of quality services.

Encouraging community engagement

While the JJM's aim is laudable and, in all likelihood, India will achieve universal coverage at some

point, the concern will shift towards ensuring that water flows continuously through these taps. However, what is to be borne in mind is that taps and pipes will eventually break and will need repairs. Besides, groundwater that supplies water for most of these schemes may dry up or get contaminated.

The geological and demographic diversity of our country challenges the notion of a centralised management system to keep these schemes running. Hence, a decentralised, community based approach is needed for local ownership and sustainable management of water for ensuring sustainable and equitable access to services. Despite the involvement of private operators, without community engagement, it is a challenge to ensure accountability. Also, since the impact of climate change is very contextual, having a localised response mechanisms helps in agility as well as developing context specific responses.

For this, we need to shift from a project/mission mode to setting up utilities for ensuring access to sustainable water and sanitation services. Identifying and skilling the right service providers, giving them the right incentives to perform and making them accountable to some institutions for support and oversight, needs to be developed. This will entail tasks for operations and maintenance of assets, tariff collection, grievance redressal, and sharing relevant information and knowledge

To emphasise and encourage a sense of community ownership, the JJM asks the local communities to contribute 5-10% of the total capital cost toTo emphasise and encourage of community ownership, the JJM asks the local communities to contribute 5-10% of the total capital cost towards the water supply infrastructure in the village, depending on the terrain and the social demographics. The communities are then awarded with a revolving fund, after the successful implementation of the scheme, to meet any unforeseen expenditure and to ensure long-term sustainability of the scheme

Training water user committees and developing a network of 'Jalabandhu' mobile mechanics has already proven to be effective in maintaining and repairing water points across the country. Art and theater can be used to promote safe water, sanitation, and hygiene practices. It is also a good idea to encourage school children to participate in community-level awareness initiatives and take ownership of water and sanitation facilities.

Last, but not the least, private organisations should partner with local leaders, communities, and governments to find ways to ensure that water, sanitation, and hygiene services are used responsibly and sustainably.

Managing access to groundwater

Tap water is mostly sourced from groundwater, but the major chunk of groundwater in India is used for agriculture. The dependence on groundwater for supplying drinking water is very high (> 90% in rural). The same groundwater (aquifer) supplies for agriculture as well (> 70%). The piped water schemes through JJM can fail if aquifers run dry. There is thus an urgent need for manging groundwater as a common pool resource for fair and transparent allocations for multiple

Preserving freshwater ecosystems is crucial for maintaining the water balance and supporting biodiversity. A budget allocation for the rejuvenation of water bodies and afforestation around catchment areas can enhance water availability and quality, which needs to be ensured to have positive health outcomes. There is a need to strengthen the surveillance infrastructure and use the water quality testing data for empowering and informing citizens and authorities alike for taking preventive or mitigating measures. There is also a need to democratise water testing and incentivise solution building. The private sector can play

an important role for providing these services under a common standards framework

#### Collective and collaborative onus

Water, however, is not the responsibility of governments, local bodies, or private organisations alone; everyone can and should contribute to achieving this mission. All it takes is simple precautions such as disposing chemicals safely; using fertilisers judiciously; turning off taps after use; checking for leaky taps and getting them fixed; and acquiring and spreading water educa-

There is also a dire need for our infrastructure to be climate-resilient given the environmental vagaries. It is critical for services to be adaptive and to protect our freshwater ecosystems that are our first line of defence. We need to focus on resilience building and adaptation, keeping in mind how rainfall and temperature play out in specific geographies and demographies. Having this as a risk mitigation strategy will help in reducing the vulnerabilities of many communities and our investments in assets.

These seemingly simple and obvious water management practices are valuable investments that will help us create a water-secure tomorrow for ourselves and future generations.

# Disgruntled Father Worried Over Survivor Daughter's Fate

Srinagar: Nisar Ahmad Chiloo, the father of the Srinagar acid attack survivor, was grieving over his daughter's permanent scars from the horrific attack, rather than being joyous about the rigorous punishment of life imprisonment handed to the prime accused for his act.

With tears streaming down his wrinkled cheeks, Chiloo 60 was regretfully glancing at her partially crippled daughter, who was seated on one side of the room with her face hidden by a scarf.

"I am not unhappy with the court verdict, but how can a father whose young daughter was left bruised and defaced rejoice? The scars my daughter suffered at the hands of the accused may not heal, even though he faced the repercussions of his act," Chiloo told Kash-

mir Observer.

She was quite beautiful and equally obedient to her parents, so her mother and I had always longed to see her in a wedding gown. Don't know whether we could see her become a bride or not, he said.

Accompanied by a minor, the prime accused Sajid Altaf Rather, a resident of Srinagar, splashed acid on a then 24-years-old girl at Hawal area in the old city on February 1, 2022, after she turned down his marriage proposal.

Police arrested Rather, his juvenile aide and Mohammad Saleem Kumar, the man who sold the abrasive chemical to the main accused, a day after the attack.

After two years of rigorous trial, Principal Sessions judge, Srinagar, Jawad Ahmed convicted Rather under Sections 326 A (voluntarily causing grievous hurt by use of acid) and 34 (common

added.

intent) of the Indian Penal Code (IPC) and awarded him life imprisonment. When he was at his very last, Chiloo said, he sold his family's ancestral property to pay for his daughter's medical expenses, but the suffering didn't end there; he had to shell out a hefty sum for his daughter's surgery.

"Nobody in this world could possibly be as unfortunate as me, I believe, since I am really an unlucky person. As a father, there was nothing I could do to help my daughter because her chances of getting her eyesight back are very less," he added.

For my daughter's medical care, I spent almost 80 lakh rupees till date, of which Syed Mohammad Altaf Bukhari paid 22 lakh all at once. I am really grateful to him for the favor.

Recalling the fateful day when he came across the shocking news, Chiloo said he was crestfallen to see her daughter lying on a hospital bed in an unconscious state.

Of course, we don't have the requisite numbers It is not because we don't have people's support but may be due to inadequate effort on our party, he said, adding that was why the party would have to take the support of allies.

Vajpayee's name was proposed by party president L.K Advani and seconded by senior leaders Sikander Bakht and Murli Manohar Joshi.

When Advani suggested to vice president S S Bhandari to elicit if there was any other candidate, all the MPS rose in their seats with a show of hand to approve the election of Vajpayee.

While maintaining that hate was not on BJP's agenda, he said his party government would ensure security, prosperity and happiness of all sections which had been its mission right from the beginning.

Vajpayee said there had been no discrimination in the country on the basis of religion and respect for religions had been the national creed. "We don't consider deferent religions as obstacles but as symbols of our cultural richness and that which represented unity in diversity, we should take them all together. This is challenge for me," he said.

The party's prime ministerial candidate said BJP has now reached geographically and socially each and every corner of the country.

Elaborating on the apprehensions about BJP, Vajpayee said the party had dispelled them in whichever state they had governments. Now the party has got an opportunity to pass this test at the centre also and it was 'confident of succeeding, he said.



### **Govt Empowers** States, UTs To Act **Against Three Banned J-K-Based Groups**

New Delhi: The Centre on Friday authorised all states and Union Territories to take action against three banned Jammu and Kashmirbased groups under the UAPA.

The three groups are the Muslim Conference Jammu and Kashmir (Sumji faction), Muslim Conference Jammu and Kashmir (Bhat faction) and Jamaat-e-Islami, Jammu and Kashmir.

In three identical notifications, the Union Ministry of Home Affairs said the Centre directs that all powers exercisable by it under Section 7 and Section 8 of the anti-terror Unlawful Activities (Prevention) Act (UAPA), 1967, shall be exercised by state governments and Union Territory administrations in relation to the three unlawful associations.

On February 27, the home ministry extended the ban on Jamaat-e-Islami, Jammu and Kashmir, for five years for continuing activities against the security, integrity and sovereignty of the nation.

A day later, it announced that the Muslim Conference Jammu and Kashmir (Sumji faction) and the Muslim Conference Jammu and Kashmir (Bhat faction) were also declared as banned groups for their anti-India and **Online Misogyny** 

are not socialized to accept gender equality. We don't inculcate a gender sensitive approach in our children. Boys are made to believe that they are superior and girls are inferior. Dr Shazia Malik, Assistant Professor in the Department of Gender Studies, Kashmir University shared similar views saying that cyberspace violence against women is a clear manifestation of violence against women that happens offline. She said that the anonymity of the web becomes a cloak for some to unleash a torrent of harassment on women.

"Our rapidly changing world can be confusing, particularly for young people. The imbalance between traditional cultural beliefs and the demands of modern life is evident. While individuals might treat women they know with respect in person, encountering them online in unfamiliar situations can sometimes trigger judgmental attitudes based on patriarchal norms predefined rules for women in general," Malik said.

'I personally believe that it also serves as a deterrent for women using social media platforms in a way that they remain non-existent. For example, women usually keep profiles anonymous and share less or no pictures at

In highlighting the potential role of clerics, she underscored the importance of their influence being directed towards promoting gender equality and empowering women, rather than reinforcing harmful patriarchal norms.

Naireen, a psychologist at the Institute of Mental Health and Neurosciences (IMHANS), Srinagar said that trolling, particularly in Kashmir, can have a deep psychological effect

"Online trolling makes them doubt themselves, they feel insecure and question their value. This cyberbullying can have a huge impact on their self-esteem, body image and mental well-being leading to anxiety and even depression," Naireen said.

She further said that cyberbullying can also have lasting emotional effects, even after the bullying stops and can leave deep scars and impact a person's overall well-being.

'It's crucial that we address this issue and work towards creating a more positive and inclusive online space," Naireen added.

Naireen advised to deal with online trolls by not responding, but blocking or reporting them instead. Netizens, especially girls should surround themselves with positivity, take breaks, and prioritize mental well-being. Shine bright and don't let trolls dim your sparkle!

Clinical Psychologist, Wasim Kakroo said that trolling can most affect the person with low self-esteem. People's validation is of utmost importance to people with less esteem and when they are trolled, they bear the brunt

"We need to understand that we cannot make all the people happy all the time even if you have done something with good intentions. Some people agree with respect and some turn to trolling and harassing the person" Kakroo said.

Kakroo said that the Kashmiri society suffers from gender bias wherein people think that the women folk have no right to be opinionated and should be silenced.

"Some males feel threatened when someone from the female folk voices her opinion on any issue. Whenever we appear on a public platform we need to be prepared to get trolled, we can or cannot get trolled. We need to be strong enough and muster courage to deal with trolls and while we appear on public platforms we need to expect and accept the trolls and that is the only way to deal with the trolls."

"One may get into depression, anxiety and develop paranoia or can even lead to suspi-ciousness about people's feelings and trust

As Kashmir grapples with the repercussions of cyber misogyny, experts say it is imperative for the Kashmiri society to collectively condemn such behavior and work towards fostering a culture of respect, empathy, and equality in both virtual and real-world spaces.

# Encroachments, Official Neglect Threaten Hygam Wetland

**SRINAGAR:** The once pristine Hygam Wetland, a designated Ramsar Site in the Sopore area of north Kashmir, is now grappling with illegal encroachments and neglect, which has led to its degradation over the past two decades. The lack of conservation efforts has severely impacted its delicate ecosystem, resulting in decreased migratory bird arrivals and pollution.

The Hygam-Wetland, once internationally known as Maharaja Protected Wetland, is now losing its sheen, as illegal encroachment, unabated pollution and lack of conservation measures are taking a heavy toll on its fragile ecosystem, which leads to a decrease in the arrival of migratory birds to the water

Speaking with the news agency, Aijaz Ahmed Dar, a social activist and a member of the Environmental Policy Group (EPG) said the wetland is in a deteriorated condition. "It has been reduced to a big pond as the concerned authorities as well as the successive governments have miserably failed to protect it," he said.

He said the authorities had earlier identified the encroached land of at least 2,300 kanals and illegally occupied 1200 kanals which have been converted into crop cultivation but are vet to be retrieved.

Dar also questioned the wetland's fencing, saying it has "no sense at all". The fencing didn't follow the demarcation done by the authorities earlier. It has no line and length, he said.

The water siltation of about 15 feet and the diminishing area, which is forcing the migratory birds to find an alternative habitat, speaks to the deterio-



rated conditions of the wetland, Aijaz said, adding that the wetland's main source Nallah Khalri, originating from Wagila, too has been encroached.

The diversion of other Nallahs to the source is the major reason for siltation in the wetland area, he said.

Dar said Hygam Wetland has been encroached upon at many places including Haritar, Hygam, Lolipora, Gohul, Goshbug, etc, and scores of structures have come up over the past several years while hundreds of kanals of land were being used by encroachers illegally for cultivating paddy.

The Hygam Wetland is spread over 7.25 kilometres and has around 1,400 hectares of land. The area was once dominated by extensive reed beds and was home to many migratory birds including White Heeled Duck, Shoveller, Red-Crested Pochard, White-Eyed Pochard, Pintail, Mallard, Gadwall, Coot and

Tariq Ahmed Rather, a local of Hygam, said the official inability to act in time has encouraged more and more people to grab the land.

The wetland supporting a wide range of biodiversity is shrinking with each passing day and the administration must intervene as soon as possible, he said, adding that though scores of cases are registered against the encroachers, there have not been any concrete attempts so far to evict the land from the encroachers.

The wetland is an asset and provides a significant livelihood to hundreds of people in and around. It used to yield fish, nadur, water chestnuts and a renowned bird sanctuary; however, it is now devoid of such

characteristics, Tariq added. Till 1987, the wetland used to draw the attention of both foreigners and domestic visitors just to have a glimpse, but the apparent neglect" by the authorities has led to a situation where there is nothing to witness in this once-thriving and bustling wetland, Rather added.

Dr Raja Muzaffar Bhat, an environmental activist and a member of the Environmental Policy Group (EPG), lamented over the deteriorating situation of the wetland. "Wetlands hold significant importance in the ecosystem, akin to the kidney's function in a human body, but unfortunately, pollution (solid waste and liquid waste), illegal encroachment, the construction of new structures and the silt deposition have significantly impacted it and its ecological balance." he said.

Unfortunately, over the last 20-25 years, human encroachment has led to significant change, threatening the ecologtem, Dr Muzaffar said.

"While we are making efforts from our end by filling cases in NGT, the government holds a prime responsibility in preserving it alongside the local populace. The government should take strong notice of the deteriorating conditions of the wetland," he stressed.

Bilal Ahmed Dar, a cinematographer, lamented, "I used to capture the beauty of the wetland through my lens, but it is disheartening to witness the deteriorating situation here. Now, most of the areas of the wetland are dry or have little water due to pollution."

Locals urged the administration to take steps towards restoration and development of the wetland. "We hope the government restores the wetland to its former glory," said a local.

Wildlife Warden, Wetlands, Altaf Hussain, responding to queries, said, "I have recently joined, and at this initial stage, I won't be able to comprehend it correctly. After comprehensive understanding, I will be able to answer the query."

It's worth mentioning that earlier an official from the department listed eight new bird species observed in Kashmir, with Falcated Duck at Hokersar Wetland, while Smew Duck, Horned Grebe, Western Reef-Heron, Long-tailed Duck and Broad-billed Sandpiper at Wular Lake in north Kashmir besides Northern Wheatear at Pahalgam.

In 2022, the government included the Hygam wetland along with Shalbugh on the Ramsar Site list. Ramsar is an inter-governmental treaty conceived in 1971, which helps in the better conservation of wetlands on an international scale—(KNO)

Kane returned Musiala's earlier favor for the 21-year-old Germany midfielder to score in the 61st and Bayern still pushed for more.




