ECI To Announce Poll Dates Today

New Delhi: The Election Commission of India (ECI) has said that the schedule for the 2024 general elections to Lok Sabha and some state assemblies would be announced on Saturday, March 16, at 3 p.m. The ECI will hold a press conference in New Delhi, which will be livestreamed on social media.

The ECI had completed its national survey of poll preparedness in every State, ending its survey with a tour of Jammu and Kashmir this week.

The term of the present Lok Sabha ends on June 16 and a new House has to be constituted before that.

The term of the assemblies in Andhra Pradesh, Sikkim, Arunachal Pradesh and Odisha is coming to an end on various dates in June. Last time the Lok Sabha polls were announced on March 10 and held in seven phases beginning April 11. Votes were counted on May 23.

In 2014 also, the EC had sent invites for its poll schedule press conference a day in advance. The invite was sent in the evening for the presser to be held early the next day.

Nearly 97 crore people are eligible to cast vote in the upcoming polls at over 12 lakh polling stations. In the last | More on P1



The Administrative Council which met here under Lieutenant Governor, Manoj Sinha approved the proposal of Social Welfare Department to amend the Jammu and Kashmir Reservation Rules, 2005 in light of Jammu Reservation Kashmir (Amendment) Act, 2023 dated 15.12.2023, Constitution (Jammu & Kashmir) Scheduled Castes Order (Amendment) 2024, Constitution

Petitioner Zahoor Hussain has moved the court seeking regularisation of his services as Junior Professional Assistant (JPA) in the Kashmir University, along with other service and financial benefits,

IAF Airlifts 348 Stranded Ladakh Passengers

Jammu: The Indian Air Force (IAF) carried 348 passengers in its aircraft between Ladakh and the Union territory of Jammu and Kashmir in view of the closure of the Srinagar-Leh national highway owing to heavy snowfall, an official said.

The IAF's AN-32 aircraft, also known as Kargil Courier, was operated to airlift 171 passengers between Jammu and Kargil and 177 more between Srinagar and Kargil, officials said.



The SSKM director on Thursday evening said that Banerjee had "a fall within the vicinity of her home due to some push from behind".

Dr Bandypadhyay's "push from behind" theory sparked large-scale confusion and speculations over the cause of the Trinamool Congress su-

She underwent three stitches on her forehead and one on her nose and was discharged following necessary medical tests, including radio imaging of her brain and ECG, at the hospital.



SC Raps SBI For Not Disclosing Bond Numbers, Issues Notice To Bank

New Delhi: The Supreme Court said on Friday that the State Bank of India (SBI) should have disclosed the unique alpha-numeric numbers of the electoral bonds received by political parties and sought the bank's response.

A five-judge Constitution bench headed by Chief Justice D Y Chandrachud, which was hearing an application filed by the Election Commission (EC) seeking a modification of the operative portion of its March 11 order in the electoral bonds

case. directed its registrar (judicial) to ensure that the data filed earlier by the poll panel before it in a sealed cover be scanned and digitised.

It said this be preferably carried out by 5 pm on Saturday and once the exercise is completed, the original documents be returned to the EC.

During the hearing, the bench, also comprising justices Sanjiv Khanna, B R Gavai, J B Pardiwala and Manoj Misra, took note of the submissions made by senior advocate Kapil Sibal and lawyer Prashant Bhushan, who appeared in the matter on behalf of the petitioner,

It issued a notice to the bank and posted the matter for hearing on March 18.

In its application filed in the apex court, the poll panel said the March 11 order had noted that the copies of the documents submitted by it to the court in a sealed cover during the course of the hear ing be maintained at the office of the EC.

The EC said it did not keep any copy of the documents and added that those may be returned so that it can comply

Farmers Resolve To Intensify Protest, Continue It During Lok Sabha Polls

New Delhi: Thousands of farmers on Thursday participated in the 'Kisan Mazdoor Mahapanchayat' at Delhi's Ramlila Maidan where a resolution was passed to intensify the protest against the Centre's policies regarding the farming sector and to continue the stir during the upcoming Lok Sabha polls.

SC Says SBI 'Duty Bound' To Disclose Electoral Bond Number, Issues Notice To Bank

The State Bank of India is "duty bound" and has to disclose the unique alpha numeric numbers of the electoral bonds received by political parties, the Supreme Court said on Friday while seeking a response from the bank for not doing so.

A five-judge bench headed by Chief Justice D Y Chandrachud said the apex court in its verdict on electoral bonds case had directed the disclosure of all the details of bonds, including the purchaser, amount and date of purchase.

All details have to be furshed by the SBL the CJI observed a day after the Election Commission put out the entire list of entities that have purchased electoral bonds for making political donations. The bench, also compris-

ing Justices Sanjiv Khanna, B R Gavai, J B Pardiwala and Manoj Misra, issued notice to the SBI and posted the matter for hearing on March 18.

'Who is appearing for the SBI? Because in our judgement, we had directed disclosure specifically of all details of the bonds including the purchaser, the amount and the date of purchase. They have not disclosed the bond numbers. That has to be disclosed by the SBI," the CJI said, pulling up the bank. The



unique alpha numeric numbers would match those who had purchased the electoral bonds to the parties they were donating to.

"They (SBI) have not disclosed the bond numbers. That has to be disclosed by the SBI," the CJI said. "But really speaking, we can take exception to what they have disclosed because they were duty bound," he added.

The apex court was hearing an application filed by the Election Commission seeking a modification of the operative portion of its March 11 order in the electoral bonds case. It directed the registrar (judicial) to ensure that the data filed earlier by the poll panel before it in a sealed cover be

scanned and digitised. The EC's counsel said they have filed an application for a minor modification of the March 11 order, which also directed that the poll panel shall

upload on its website the data furnished to the court.

He said the EC had not retained any copy of the data which was earlier filed in the court since it was placed in sealed cover.

"While issuing this direction, the court had presumed that a copy of the data which was lodged before the registry of this court would be available with the EC," the bench said.

In its application, the EC requested the apex court that the documents be returned to it so as to enable it to comply with the March 11 order for uploading the documents.

"The registrar (judicial) of this court shall ensure that the data which has been filed by the ECI in pursuance of interim orders of this court is scanned and digitised," the bench said. It added that this exercise may preferably be carried out by 5 pm on Saturday.

Ex-Navy Chief Ramdas Was Proponent Of 'Much More With Much Less

ew Delhi, Mar 15 (PTI) Former Navy Chief Admiral Laxminarayan Ramdas, who passed away on Friday, was one of the architects of making the Indian Navy a preeminent regional force as he fiercely believed that greater maritime power was key for India to make a claim at the global high-table.

Known for his sharp tactical acumen and farsightedness, Admiral Ramdas played a very crucial role in the 1971 Indo-Pakistan war in his capacity as commander of the gunnery ship INS Beas.

The INS Beas had blocked the strategic sea lanes from the Pakistani Navy with aggressive maneuvering and foiled Islamabad's attempts to evacuate over 90.000 troops from then East Pakistan.

A communication specialist, Ramdas became the 13th chief of the Indian Navy on December 1, 1990 and retired from service on September 30, 1993.



Admiral (retd) Ramdas passed away on Friday at the age of 90. He is survived by his wife Lalita Ramdas and three daughters. "Admiral L Ramdas was a strong proponent of the philosophy of 'much more with much less' as under his leadership, the Indian Navy achieved a lot with limited resources," former Navy spokesperson Capt D K Sharma told PTI.



Vajpayee Is The Prime Minister

▼ RINAGAR- The soft spoken and moderate face of the right wing Bhartiya Janata Party, Atal Behari Vajpayee is the next prime minister of India. The president K Narayanan, late to-night formally appointed Vajpayee as the prime minister, after Con-gress president Sonia Gandhi expressed her inability to stake claim to the power as the party didn't have the requisite number to form a government on its own, though "informal consultations" were going on with the like-minded parties. However what seems to have prompted the president to invite Vajpayee to form the government was the statement made by United Front leader and president of Tamil Manila Congress (TMC) GK Moopanar, that the UF had "no role to play in the formation of the government at the center" as the Congress decided against staking the claim for the same.

"Right now OF has virtually no role" Moopanar told newsmen after an hour long meeting of the OF leaders held at prime minister IK Gujral's residence, 7, Race Curse Road. The swearing in ceremony of Vajpayee led government is

scheduled to take place on Thursday, March, 19, the prime minister designate told reporters after his meeting with the president. The president has asked Vajpayee to prove his majority within 10 days of being sworn in. Last time Vajpayee was given 13 days' time to prove his majority, which he failed to do and had to resign in a huff. Vajpayee said he would consult his party colleagues and allies on composition of his cabinet and its size.

The number of MPs supporting BJP led coalition comes to just 264, which is short of the half way mark in the house of 539. However when seen in the context of the decision taken by Telgu Desam Party (TDP), to remain neutral when the heads will be counted, the number of 264 does cross that limit required for a simple majority for the BJP led coalition.

Meanwhile, in a volte-face, AIADMK and two of its allies today decided to join a BJP-led coalition ministry at the Centre clearing any last minute hitch which may come in the way of President K.R. Nayaranan inviting A.B. Vajpayee to head the next government.

BJP prime ministerial candidate Vajpayee's special emissary Jaswant Singh, who air dashed to Chennai successfully persuaded AIAD-MK general secretary Jayalalitha to change her mind about not joining the government and extending unconditional support to the BJP.

Congress tonight "accepted" President K.R. Narayanan's decision to invite BJP leader Atal Bihari Vajpayee to form the government but made it clear that it would attempt to defeat the coalition during the confidence motion.

Asked to comment on the development, party spokesman V.N. Gadgil said the president has gone by the text-book and as per Supreme Court judgement of inviting the single largest party to

"We accept the president's decision. But we will try to defeat the government during the confidence motion.'



ECI bonds' disclosure

Why transparency isn't enough to fix crisis of party funding in India

With the release of electoral bonds data, the Supreme Court's task may be concluded (for now), but the journalists' job has just begun. At the moment, the data does not provide a clear link between the donors and the donee parties. Even if we can connect all the donations to the corresponding parties, it is likely to produce an incomplete picture of Indian parties' sources of income. This is because parties do not disclose the amount (let alone the identity of donors) of a large portion of their total income, of which, electoral bonds are likely to be a relatively small part. The end of electoral bonds, therefore, should not be seen as the solution to the crisis of party financing in India. Doing so would be like missing the forest for the trees.

Instead, the story of electoral bonds should be the excuse to look into questions about the present and future of the relationship between money, business, and arguably, the most important institution of Indian democracy – po-

litical parties. Three issues merit attention.

The first problem is the financial arms race caused by the eyewatering-ly expensive elections in India. You may not know anything else about Indian politics, but you are likely to notice the obnoxiously large sums parties spend on elections. It should not be surprising, then, that from the day the party comes into power at the centre or any state, it needs to start raising money for subsequent elections.

In India, there is no limit on how much a party can spend on its propaganda as long as it does not spend that money on the campaigning of any specific candidate. An immediate response may be to introduce a national/ state expenditure limit on parties. We can go further by restricting (or even banning) highly expensive campaign methods. Such regulation should be accompanied by an independent audit of political party accounts. Whatever the specific form of regulation, the bottom line should be to address the demandside issue of expensive elections, even if it comes at the cost of reducing the temperature of the much-romanticised Indian electoral campaigns.

Curbing expenditure may go a long way, but it is no magic bullet. The second underlying problem in India is the unfair and targeted extortion of businesses. The fundamental motivation behind the schemes of Electoral Bonds and Electoral Trusts (recognised by the UPA government in 2013) was to enable large businesses to make anony-



mous donations to parties. In 2012, M V Rajeev Gowda and E Sridharan conducted confidential interviews with various CEOs. These revealed that the government's discretionary powers often become "pressure points for extorting payments from businesses". Often, it takes the form of withholding discretionary permits or using police or investigating agencies. It is not surprising, then, that the immediate response of many after the release of electoral bonds data was to match the dates of bonds purchased with the dates of the ED raids on those donors. Businesses that feel vulnerable to such discretionary "extortion" perceive confidentiality as the most important safeguard against reprisals from political parties, even if such secrecy comes

at the cost of giving up tax exemptions. The solution to the pathology of secret corporate donations, then, is unlikely to emerge from a political funding framework. It may require broader reforms that undo the abuse of discretion against businesses — a remnant of the license-permit raj.

The third problem is the prevalence of "cash" donations. While electoral bonds made it legal to make opaque donations, they did not introduce opacity to the Indian party funding regime. In India, cash may still be the best disclosure-proof technology. Even if we design a regulatory framework that institutes complete transparency, donation limits, and expenditure limits, enforcing those rules requires money to be traceable. The prevalence of cash

undermines the ability to trace the flow of money. Whatever formal rules we may frame, a cash-based system makes it easier to subvert formal regulation. Since we are still far from adequate formalisation of the Indian economy, even a progressive regulatory framework, if it does not address the predominance of cash, is likely to yield unsatisfactory results.

While the Supreme Court rightly recognised the value of transparency, the legal disclosure requirement does not, by itself, translate into actual transparency. In any case, transparency only reveals the pathologies of the relationship between money and politics; it does not resolve the deeper causes. The financial arms race between parties, the prevalence of cash in the Indian economy and the heightened anxieties of government retribution among large businesses are the underlying causes of the pathologies of party funding in India. Political finance is, almost always, rooted in the deeper forces of the political economy. If so, the party funding framework cannot be fixed in a vacuum. It is time to enlarge the conversation from partyfunding laws to these larger themes if we want to achieve a fair and workable relationship between money, business and politics.

Fasting or Feasting

Tt is often seen in the month of Ramadan that South Asian countries, ■the Muslim majority countries in particular, witness the ripples of surcharging, shortage, money minting and excessive profit gains. "It is common that during the festive seasons, prices of daily commodities, from onion to beef, cosmetics and accessories, clothing items etc rise exceptionally taking these out of the reach of lower-middle income groups of people. We observe this trend the most in the month of Ramadan. Even the government struggles to control the skyrocketing prices. We often generalise that this is due to maleficent intentions of merchants and businessmen who try to make more profit during this month. Although this explanation seems fit to the general eye, there exist other explanations may sound more logical". This is one of the many issues faced by people in the holy month of Ramadan forcing people to economic bottlenecking, food insecurity and people's inability to meet their basic ends. But this lack of access to basic amenities by the majoritarian poor population is followed by the ironic trend of food wastage in Ramadan and the amount of food wasted is both unprecedented and enough to cater to the needs of the starving lot. "A major factor in the amount of food waste being produced is the mindset of diners, who expect nothing less than a tanta-



lizing feast-like iftar – the meal taken by Muslims after sunset to break their daily fast during Ramadan. But much of this food goes uneaten. Around 25-50% of the food prepared in the Arab world during Ramadan is wasted, according to the United Nations Environment Programme's 'The State of Food

Waste in West Asia' 2021" report. The basic problem with our understanding of Ramadan is to think of it as the month of feasting instead of fasting. While we continue to observe the scruples of Shariah during the day, our Suhoor and iftars are literally the singular events of gluttony, hyper-consumerism and acrobatics of show off and the race of spendthrift to leave others behind. Lavish iftar parties being thrown open and the means and methods followed are very much antithetical to the spirit Ramadan, inverting its purpose and creating an opposite binary. These praxis need to be amended to bring them in accordance with the spirit of Ramadan and the larger vision of Islam to avert the ills being incurred and to make Ramadan what has been truly defined as the month of blessings, healing and balance. The fact needs to be emphasised that our excess at Suhoor and iftar not only undo the physical and medical benefits of Ramadan earned during the day but these activities in excess also undo the spiritual merits of fasting and instead of bringing us any good heighten the chances of being caught in divine wrath for our conduct and unbridled consumption.

The problem of inflation and scarcity of goods and food items pitched

up above also bounces back on the face of people on deeper scrutiny. It is observed that the demand for food items and other goods soars up and the items which are otherwise scarcely used are seen to be in huge demand during the month of Ramadan. This reinforces our premise that people, instead of harvesting the month of Ramadan for physical and spiritual control, let themselves loose upon eatables and the daily food intake and the diversity of food items increases without reason and rhyme. This is not to say that people aren't allowed to eat whatever is permissible, but to caution ourselves and the readers of the threat of gluttony and stomach worship in an otherwise month of fasting. This month, as scholars have pointed out, raises our consciousness to the plight and misery of those who can't otherwise afford two square meals a day. But can this end be achieved when we indulge in gluttony and excess at dawn and the time of fast breaking at dusk? What petrifies religion is the danger of transformation of living religious practices into rituals lacking meaning and rationale - and in this case with Ramadan, the threat of ossifying a living religious praxis into a dead ritual is at hand. What is needed is to reclaim Ramadan, consciously and conscientiously and to shred away the false accretions attached to it to realise its spirit and to wake up to its true call.

ENSURING ECONOMIC JUSTICE

The Imperative of Transparency and Accountability in Zakah Distribution

not only empathized with النافية the poor; he "loved the poor and sat with them," and taught us the prayer: "Lord God, grant us love for the poor [hubb almasakin]."1 While today we may question whether the Ummah is doing enough for the oppressed, it is commendable that our willingness to support the impoverished with Sadaqah persists. A report published by the Muslim Philanthropy Initiative in 2021 found that although Muslim-Americans account for 1.1% of the population, they account for 1.4 % (nearly 4.3 billion dollars) of charity.2 Despite common stereotypes about where Muslims put their money, the same report notes that a sizable portion of charity goes towards domestic non-faith causes, including the COVID-19 pandemic response.

In his book Traveling Home, a treatise on Muslim integration in Europe (reviewed here), Shaykh Abdal Hakim Murad ends with a chapter discussing the power of charity in reviving Muslim consciousness.1 While Murad marvelously details the potential of those in a position to give donations, from the high net-worth Muslims in London to the Emirati billionaires living off of petrodollars, the recipients remain conspicuously unaddressed, particularly in the case of zak h.

There is no doubt that we live in a predatory financial system, where banks and institutions salivate at the prospect of exploiting those on the lower rungs of society so they may further perpetuate and maintain the imbalance of societal wealth. Riba (here we are loosely referring to interest and usurious practices) is explicitly prohibited in Islam, due to its exploitative nature and end result of vampirically usurping the financially desperate to fill the pockets of the increasingly rich. Allah warns us that engaging in usury is a lossmaking proposition on the cosmic scale, as is stated in the Quran:

Whatever loans you give, only seeking interest at the expense of people's wealth will not increase with Allah. But whatever zak h you give, only seeking the pleasure of Allah – it is they whose reward will be multiplied.

Qur'an, 30:39

This ayah beautifully contrasts the parasitic nature of riba with the beautiful iustice of zak h. The institution of zak h is the antonym of riba, in that it serves as redistributive economic justice, creating harmony within the socio-economic system. Allah informs us that zak h is a positive-sum game: We purify our wealth,



the poor are empowered, and on the cosmic scale our reward is multiplied exponentially with Allah.

There is also a deeper meaning to this ayah that further reveals the justice of Allah. Even though zak h is the wealth of Allah and does not belong to us in principle. Allah rewards us in a multiplicative manner, in direct contrast to how riba works — a true positive-sum game instead of a zero-sum rat race. The importance of zak h in Islam and as an institution for Muslims should not be underestimated; it is an ummah-centric system that forces wealthy Muslims to empathize with the plight of their less wealthy brethren.

Zak h is a foundational pillar of Islam, considered integral to the foundation of Islamic civilization to such an extent that the first Caliph Abu Bakr رضي الله عنه waged wars against those who rejected giving zak h. It is a grave mistake to consider zak h as merely another form of charity; zak h is an institution and a system, unlike Sadagah, which is a form of spontaneous charity.3 It is so fundamental to a Muslim that Allah mentions salah and zak h 28 times in conjunction within the Qur'an. As the great Hanafi scholar Badr ad-Din al-Ayni wrote, "Zak h is the partner of Salah." 4 Mulla Ali al-Qari states, "Salah and zak h are the foundations of all worship."5

To this end, Shaykh Yousef Wahb has written an essay, "The Use and Misuse of Zak h Funds by Religious Institutions in North America," discussing how North American practices regarding zak h distribution depart from the rules of Figh Islamic law).6 While a fighi analysis of Wahb's essay is beyond the scope of this article, in brief, he highlights how contemporary fatawa and practices expand zak h eligibility to an unprecedented and almost dubious level. In addition to detailing equitable distribution among the eight specified categories of recipients in the Sh fi school, Wahb spends time breaking down three specific categories where modern-day distribution proves inconsistent: fi sabilillah or "In the path of Allah"; zak h workers; and "mending of the hearts.'

O, believers! Indeed, many rabbis and monks consume people's wealth wrongfully and hinder others from the Way of Allah. Give good news of a painful torment to those who hoard gold and silver and do not spend it in Allah's cause.

Qur'an, 9:34-35 The lack of transparency in zak h allocation is dire, an issue plaguing many popular Muslim-American non-profit and advocacy organizations. As Wahb writes, "The European Council of Fatwa and Research allows zak h-focused organizations to take up to one-eighth of the collected zak h for 'operational fees' without explicating what these fees entail."6 Ahmed Shaikh, an Islamic estate planning attorney, runs the "Working Towards Ehsan" newsletter that regularly provides overviews of such institutes, including Emgage, IR-USA, and Launchgood. In one post, he notes, "The practi-

cal effect of much zak h in the United States is the affluent recirculating wealth amongst themselves." Without delving into the legal minutiae of zak h, he provides practical examples where Muslims paradoxically stand to benefit directly from the very zak h they give, such as giving to local masajid, political advocacy organizations, and certain da'wah groups. He also highlights a concerning example of an Islamic scholar being prominently featured on a nonprofit's website without a corresponding explanation of the scholars' role (beyond branding) and if said Al m actually vets the organization's

zak h policies. Wahb's article underscores the dangerous lack of consistent boundaries or vetting mechanisms available for categories of eligible zak h recipients in the United States. It is imperative that Muslim nonprofits collectively raise the bar in how they develop zak h policies and work with qualified Islamic finance experts and scholars to ensure respect for a pillar of our religion that necessitates absolute

Beyond the obvious spiritual importance of zak h, expecting a high degree of transparency is a reasonable ask, standard for any modern organization. One can simply go online to find out the salary of any professor or football coach at a public university, the dollar amount and frequency of political donations (and party recipient) made by ordinary individuals, the exact value of food and travel payments shelled out by pharmaceutical

companies to all physicians since 2016, and even the minimally and maximally negotiated-price of any hospital service, lab or procedure on a hospital website due to a relatively recent law. Even with inevitable legal differences on who is qualified to receive zak h, the average Muslim should know if his or her zak h is footing the bill for a speaker's business class flight and hotel the election financing for a Muslim-sympathizing non-Muslim candidate running for office, administrative overhead, flashy influencer endorsements, the local masjid's basketball court and multi-purpose hall, or "intellectual efforts" (as legitimized by the Assembly of Muslim Jurists of America).

In his article, Wahb aptly remarks, "[throughout] history, classical fiqh has never been viewed as impeding da wah but seems to be perceived as one in today's community work." 6 He goes on to provide a creative example of how zak h can potentially be utilized for debt relief among refugees, two-thirds of whom come from Muslim countries.7 Wahb's work makes abundantly clear that zak h is not to be conflated with charity and that the zak h you pay may be utilized for different purposes based on which organization you give it to. While the scope of zak h is fuzzy in the modern world, it does not legitimize a free-for-all within the Muslim nonprofit industry where organizations can make a blanket claim of "zak h eligibility" without strictly defining what that entails (and who signed off on that claim).

A Muslim who entrusts an organization with zak h effectively makes that organization his agent. While the duty of fulfilling zak h ultimately rests with the individual, the agent is given a trust and accepts it on behalf of the individual. Given the importance of zak h, there is a duty of transparency not only for the sake of the recipients and economic justice but for the afterlife, where we will all be held to account. Muslims must be able to place conviction and trust in the agent, reassured by the knowledge that their zak h is not misused, and is righteously delivered to the legitimate categories Allah prescribes for us. The Muslim community is well within its right to demand accountability and transparency from its agents. After all, zak h is not just charity, it is an Ummatic institution that creates positive sum games for all, paving the way for success in this world and the next.

S.O. 354(E).—Whereas the Students Islamic Movement of India (hereinafter referred to as the SIMI) has been indulging in activities, which are prejudicial to the security of the country and have the potential of disturbing peace and communal harmony and disrupting the secular fabric of the country;

And whereas, in exercise of the powers conferred by sub-section (1) of section 3 of the Unlawful Activities (Prevention) Act. 1967 (37 of 1967), the Central Government declared the SIMI as an anlawful association, vide, notification numbers, (i) S.O. 960 (E), dated the 27° September, 2001, (ii) S.O. 1113 (E), dated the 26° September, 2003, (iii) S.O. 191 (E), dated the 8° February, 2006, (iv) S.O. 276(E), dated the 7° February, 2008, (v) S.O. 260 (E), dated the 3° February, 2010, (vi) S.O. 244 (E), dated the 3° February, 2012, (vii) S.O. 299(E), dated the 1° February, 2014, and (viii) S.O. 564(E), dated the 31° January, 2019;

And whereas, the Unlawful Activities (Prevention) Tribunal (hereinafter referred to as the Tribunal) constituted under section 5 of the Unlawful Activities (Prevention) Act, 1967 for the purpose of adjudicating whether or not there is sufficient cause for declaring the SIMI as an unlawful association and the Tribunal by its orders published, vide, notification numbers, (i) S.O. 397 (E), dated the 8th April, 2002, (ii) S.O. 499 (E), dated the 16th April, 2004, (iii) S.O. 1302 (E), dated the 11th August, 2006, (iv) S.O. 1990 (E), dated the 12th August, 2010, (v) S.O. 1745 (E), dated the 6th August, 2012, (vi) S.O. 2050(E), dated the 12th August, 2014 and (vii) S.O. 3083(E), dated the 27th August, 2019, has confirmed the declaration so made:

And whereas, the duration of ban under sub-section (1) of section 6 of the Unlawful Activities (Prevention Act, 1967 shall cease on the 30th day of January, 2024;

And whereas, the Central Government is of the opinion that SIMI is indulging in the activities which are prejudicial to the integrity and security of the country on the basis, *liner alia*, of the following grounds, namely:

- Case Crime No. RC-31/2022/NIA/DLI has been registered by the National Investigation Agency (NIA) against Athar Parvej and Molid. Jalaluddin of Phulawari Sharif. Patna relating to conspiracy of disrupting the visit of Hon'ble Prime Minister in July 2022. Both the accused were arrested and charge-sheeted under various provision including section 17, 18, 18A, 18B 38 and 39 of the Unlawful Activities (Prevention) Act, 1967.
- Case Crime No. RC-29/2023/NIA/DLI has been registered by the National Investigation Agency (NIA) against Saquib Nachan, ex-National General Secretary of SIMI. He was main conspirator and radicalising Mustims for violent Jihad or Hijarat. He was giving 'Baith' (Piedge and Allegiance to ISIS) to Muslim youths. Further, he motivated other persons to take 'Baith' of ISIS. He is alleged to have established 'Al Sham' like area in Padga village, wherein sharia law is followed:
- Case Crime No. RC-04/2020/NIA/DLI has been registered by the National Investigation Agency (NIA) against Case Crime No. Re-04/2020/NA/OL1 has been registered by the National Investigation Agency (NIA) against Shihabudeen @ Strajudeen @ Khalid @ Rajesh, ex-SIMI member. In May 2019, he met Khaja Mohideen and others in a rented house at Annan Ninaivo Nagar. Puzhal and joined the terrorist gang formed by Khaja Mohideen for establishing Khilafat or Islamic Rule in India, as part of furthering the objectives of the proscribed terrorist organisation ISIS/Daish in India. He has received funds from Khaja Mohideen for procurement of fire arms and ammunition. He was charge-sheeted on 9th March. 2021:
- Case Crime No. RC-28/2023/NIA:DLI has been registered by the National Investigation Agency (NIA) against T. Naseer, ex-SIMI member, later joined Lashkar-e-Taiba (LeT), a proscribed terrorist organisation. He used to select newly lodged Under Trial prisoners and got them transferred to his bearack. He further convert, radicalise and recruit them for furthering the activities of LeT in Central Prison, Bengalury from 2017 convards. In furtherance to their conspiracy and on the instructions of T. Naseer, co-accused arranged arms and amnumitions and explosives in collusion with other accused. He was involved in raising funds in the Prison for furthering their activities of proscribed terrorist organisation. The accused has been charge-sheeted in the case under the provisions of the Unlawful Activities (Prevention) Act, 1967. He has been charge-sheeted on 12th Innurary, 2024:
- Case Crime No. RC-16/2019/NIA/DLI has been registered by the National Investigation Agency (NIA) against Mohammed Ibrahim @Ibrahim Jamali, who is an ex-State Secretary of the proscribed organisation SIMI, was the main leader of the pro-jihadi jamaat formed in UAE with the intention of propagating violent extremist ideology of proscribed terrorist organisations including Al-Qaeda and ISIS. He has subscribed and disseminated pro-1515/ Daish material advocating violent jihad and establishment of Islamic Khilafat, while delivering lectures on such topics during the meetings and classes organised by the unlawful jamaat in United Arab Emirates. The accused has been charge-sheeted in the instant case on 1° January, 2020 before the NIA Special Court, Chennai;

- Case Crime No. RC-02/2019/NIA/KOC has been registered by the National Investigation Agency (NIA) against ex-SIMI cadre Sheik Hidayathullah Y @ Firoze Khan @ Firozy. Sheik Hidayathulla was a part of conspiracy in propagating the ideology of proscribed terrorist organisation ISIS/Daesh, and also recruiting vulnerable youths with a view to carry out terrorist attacks in South India especially in the cities of Kerala and Tamil Nadu. During the search conducted in his premise, various documents relating to SIMI were seized. He has been charge-sheeted in the instant case under section 38 and 39 of the Unlawful Activities (Prevention) 4ct. 1967:
- Case Crime No. RC-06/2020/NIA/DLI has been registered by the National Investigation Agency (NIA) which pertains to the murder of Shri SSI Wilson on 8th January. 2020. During investigation serious involvement of @S. Shahabudeen @Shihabudeen @Sirajudeen @Khalid was revealed which resulted in his arrest on 6th January. 2021. It was also revealed that this accused has been continuing with covert anti national activities as the former SIMI member having association with hard core ISIS cadres. He was also involved in publication of provocative and highly objectionable material inciting others to commit terror acts:
- Case Crime No. RC-02/2022/NIA/KOC has been registered by the National Investigation Agency (NIA) against ex-SIMI leader Mohammed Ali @Kunhappu Haji @Kunjappu Sahib @Kunjappukka. The accused is an ex-SIMI member and former state vice-president of Popular Front of India (PFI). Kerala. He used to arrange and supervise arms training conducted at Periyar Valley campus Aluxa on various occasions. He propagated violent jihad to the cadres of Popular Front of India and also justified the terrorist activities in Popular Front of India meetings. He has been charge-sheeted under various provisions including section 16. 18A, 18B, 38 and 39 of the Unlawful Activities (Prevention) Act, 1967:
- Case Crime No. RC-14/2022/NIA/DLI has been registered by the National Investigation Agency (NIA) against E.M. Abdul Rehman, ex-National Secretary, SIMI, E. Abduacker, ex-State President SIMI and founding E.M. Abdul Rehman, ex-National Secretary, SIMI. E. Abubacker, ex-State President SIMI and founding chairman of Popular Front of India, P. Koya, ex-SIMI member and founding member of PFI. A. S. Ismail, ex-SIMI member and State President of PFI, Tamil Nadu. Accused were, conducted meetings for expansion of PFI (banned organisation) through radicalising and recruiting Muslims, providing weapons training classes across the country under the garb of 'Beginners Course' and other seemingly innocuous programs, collection of funds and facilitating funds to persons for commission of unlawful activities and was involved in conspiracy to mit violent unlawful and terrorist act. All the aforesaid accused were charge-sheeted on 18th March, 2023;
- Case Crime No. RC-01/2023/NIA/DLI has been registered by the National Investigation Agency (NIA) against
 ex-SIMI cadre A. R. Qureshi. He along with his associates hatched the conspiracy to join the ISIS for the
 cause of Islamic Jihad and targeted killing in India. He has been charge-sheeted in the instant case under the
 Unlawful Activities (Prevention) Act. 1967;
- 11. Case Crime No. ECIR/RPSZO/05/2020 dated 27th February. 2020 has been registered by the Directorate of Enforcement under the Prevention of Money Laundry Act, 2002. Umair Siddiqui and Others. Umair Siddiqui a suspicious activist of SIMI, used to give shelter to various members of the banned organisation SIMI and Indian Mujahiddin terrorist organisation from the year 1999. Umair Siddiqui and his group organised a camp of SIMI in forest of Barnawapara and the purpose of the meeting was to strengthen the organisation SIMI and collect funds for aiding the terrorist of Indian Mujahiddin and SIMI:
- 12. Case Crime No. ECIR/STF/17/2022 has been registered by the Directorate of Enforcement against the office bearers. Ev-SIMI members and cadres of PFI (now banned), along with others, for conspiring and raising or collecting funds within India and abroad through banking channels, Hawala, donations, etc. for committing or getting committed, terrorist acts across India These cadres and members are also involved in activities supporting and furthering the proscribed terrorist organisations like SIMI and ISIS:
- 13. Case Crime No. 203/2022 has been registered at Padgha Police Station, Thane (R) under sections 153(a), Padgha, Borivali, Thane to create a communal rift between two religions or communities and lead a viole and increase enmity between the two groups and disrupt social harmony. The case is pending trial in court:
- 14. Indian Market Has Maintained Certain Level Of Sanity, Says FM

NEW DELHI: Finance minister Nirmala Sitharaman on Friday said despite huge fluctuations globally, the Indian stock market has maintained "a certain level of sanity" and the market should be allowed to play on its own.

The statement from the Finance minister comes days after Sebi chairperson Madhabi Puri Buch had said that there are pockets of froth in the small and midcap stocks and the regulator is looking into the same to come out with a possible consultation paper.

Speaking at India Today Conclave, Sitharaman said, "I allow the markets to play on their own...we should leave it to the wisdom of the market because all of us have seen that despite huge fluctuations globally, the Indian market has maintained a certain level of sanity. It hasn't really gone too violent this way or that way. So, I place a lot of trust in the market."

Earlier this week, the capital



markets regulator had raised concerns about over valuations of small and midcap stocks, indicating possible market manipulation and the risk of a market bubble.

"There are pockets of froth in the small and midcap space in the equity markets that have the potential to become a bubble and burst affecting investors," Buch had said.

Domestic Air Traffic Rises 4.8 Pc To 126.48 Lakh In Feb

NEW DELHI: Domestic air traffic rose 4.8 per cent on an annual basis to 126.48 lakh in February, while more than 1.55 lakh passengers were affected by flight delays during the same period, according to official data released on Friday.

In February, Air India's market share rose to 12.8 per cent from 12.2 per cent while that of IndiGo marginally dipped to 60.1 per cent from 60.2 per cent in January.

The domestic air traffic climbed to 126.48 lakh in February compared to 120.69 lakh in the year-ago period, the Directorate General of Civil Aviation (DGCA) said.

However, the traffic was less than 1.31 crore reported in January.

"Passengers carried by domestic airlines during January - February 2024 were 257.78 lakh, as against 246.11 lakh during the corresponding period of the previous year thereby registering an annual growth of 4.74 per cent and monthly growth of 4.80 per cent," DGCA said.



As many as 1,55,387 passengers were affected due to flight delays in February and scheduled carriers shelled out Rs 222.11 lakh towards facilitation.

The DGCA also said that 29,143 passengers were impacted by cancellations and airlines spent Rs 99.96 lakh towards compensation and facilities.

Last month, a total of 917 passengers were affected due to denied boarding and the amount spent by the airlines for compensation and facilities in this regard was Rs 78.19 lakh.

A total of 791 passengerrelated complaints were received by the scheduled domestic airlines in February and the number of complaints per 10,000 passengers

carried was around 0.63.

The data showed that 37.8 per cent of the passenger complaints were about flight problems, followed by baggage (19 per cent), refund (16.3 per cent) and customer service (11.1 per cent), as per the data.

Last month, the domes-tic market share of SpiceJet dropped to 5.2 per cent from 5.6 per cent, Vistara and Akasa Air managed to maintain their share at 9.9 per cent and 4.5 per cent, respectively.

AIX Connect (formerly AirAsia India) cornered a market share of 6.1 per cent in February, unchanged from the previous month, and similarly Alliance Air's share remained the same as the previous month at 1 per cent.

HSBC Holdings Plc and Julius Baer Group Ltd. are ramping up their client advisory in the world's most populous country as they seek to manage a greater share of the nation's wealth. Mitsubishi UFJ Financial Group Inc. is also expanding and DBS Group Holdings Ltd. continues to grow, the analyst wrote.

Investment bankers can already earn more in India's major urban centers such as Mumbai and GIFT city, the nation's free market zone, than in Singapore and Hong Kong. The average base salary is 4.5% higher than in Hong Kong and 7.7% more than in Singapore, according to Bloomberg Intelligence's analysis of a survey by recruiter Michael Page. Private bankers' pay, however, lags behind by 50% to 78% in non-executive roles. As India's wealth industry grows, that gap will narrow.

"Salaries will continue to rise given the large demand-supply gap at senior levels, as will talent for compliance, risk assessment and technology," in India, said Amit Agarwal, managing partner at search firm Stanton Chase. Banks are paying more for heads of businesses, and salaries of over \$1 million are common for senior leaders, he said.

While India has higher income tax rates and weaker infrastructure than Singapore and Hong Kong, the lower cost of living is a benefit, according to the report. The average monthly rent in upscale Bandra, Mumbai is \$1.76 per square foot, compared with \$5.29 in Hong Kong and \$5.09 in Singapore, according to government statistics, the report found.

COMBATING KASHMIR'S DIABETES SURGE

Ramazan Can Be A Turning Point For Health: Expert

SRINAGAR: Jammu and Kashmir is witnessing an alarming rise in diabetic cases, posing a significant health concern for its residents.

According to figures, over the past three years, more than 2 lakh cases of diabetes have been detected in the valley, with men, women, and even children falling prey to the dis-

Health experts attribute diabetes to sedentary lifestyle, obesity and peculiar food habits that fuel the diseases.

However, a benefit emerges in Ramazan. Doctors say

month of fasting presents a favorable chance to manage diabetes and modify lifestyle habits that worsen health con-

Kashmir Observer engaged in a candid chat with Dr. Mohammad Ashraf Ganaie, Professor of Endocrinology & Metabolism at Sher-e-Kashmir Institute of Medical Sciences, Soura. The endocrinologist asserted that the diabetes can be better managed during the

Ramazan, if the patients follow the precautions of doctors and modify their life-

"Fasting is some diabetic patients," Dr. Ganaie explained, "depending on the severity and type of diabetes.

There are patients who require frequent insulin injections or those with hypertensions, kidney and liver issues, it's not possible for them to go for fasting," Dr. Ganaie said, adding, "however those patients who conditions aren't severe, they can go for fasting but with precautions,"

Dr. Ganaie who was awarded "Subhash Mukherjee Memorial" Oration-2023 by the Endocrine Society of India (ESI) in 2023, said that the patients need to check the sugar level continuously and be in touch with their doctors.

He said fasting is beneficial for those with mild diabetes severity.

"They will lose weight, their sugar level will be normal and the fatty liver will also come to normal level," he added.

Dr. Ganaie, however, cautioned those patients not to take oily and junk food while

breaking the fast.
"They should avoid heavy meals and take more fluids," he said. Adding "Patients should do regular testing of blood glu-

Regarding fruits suitable for diabetic patients during Ramadan, he said, "Patients can take every fresh fruit including dates. Avoid dried fruits as they can cause sugar spikes,"

Dr. Ganaie advised people to increase their physical activity during the month in order to

"People can do regular exercises including, jumping, indoor aerobics, yoga, climbing the stairs a few times and light housework can provide the desired benefit," he added.

The expert further said that

"We are compiling the data for I&K but it's a little higher here." he added.

The Chief Secretary also took stock of the performance made by the Department in PMAY(G), IWMP and Himayat schemes. He enjoined upon the concerned to meet the targets set under each scheme. He asked them to cover all the beneficiaries eligible under such housing and livelihood generation schemes.

Regional and national parties have already begun announcing their candidates for the elections to the 543 Parliamentary constituencies. The BJP has so far released two lists of 267 candidates for the Lok Sabha polls, while the Congress announced the names of 82 candidates over two lists.

Meanwhile, the ECI on March 14 made public the data on electoral bonds it received from the State Bank of India and has also sought the return of the electoral bonds' documents handed over to the Supreme Court in sealed cover/sealed boxes.

"Only because of PM Modi, it was possible to rescue 22,500 students trapped in Ukraine in around four hours," he said.

ment in 10 years," he said. "No one can point fingers at the BJP government over corruption unlike previous Congress regimes... We are completing 10 years in power but not a single person in the world can level charges of corruption on government

Development Department Kralgund Handwara for demanding & accepting bribe from complainant for processing/preparing his Bill & putting demand for remaining labour payments case FIR No 02-2024 U/S 7 of Prevention of Corruption Act 1988 (as amended in 2018) & section 120-B IPC was registered at PS ACB Baramulla & investigations were initiated," the statement said.

During the course of investigation a trap team was constituted which laid a successful trap and caught the accused JE red handed while demanding and accepting a bribe of Rs 5000 from the complainant. The bribe money was later recovered from possession of the accused as well as one shopkeeper to whom he has given the money in presence of independent witnesses .The accused public servants was arrested on the spot after completing all legal formalities. Many of them are also in touch with their Pakistani handlers and active terrorists, operating from across the border, through their mobile phones and using different applications, the official said.

Will AI Save Humanity? US Tech Fest Offers Reality Check

Austin, United States: Artificial intelligence aficionados are betting that the technology will help solve humanity's biggest problems, from wars to global warming, but in practice, these may be unrealistic ambitions

"It's not about asking AI 'Hey, this is a sticky problem. What would you do?' and AI is like, 'well, you need to completely restructure this part of the economy'," said Michael Littman, a Brown University professor of computer science.

Littman was at the South By Southwest (or SXSW) arts and technology festival in Austin, Texas, where he had just spoken on one of the many panels on the potential benefits of AI.

"It's a pipe dream. It's a little bit science fiction. Mostly what people are doing is they're trying to bring AI to bear on specific problems that they're already solving, but just want to be more efficient.'

"It's not just a matter of pushing this button and everything's fixed," he said.

With their promising titles ("How to Make AGI Beneficial and Avoid a Robot Apocalypse"), and the ever presence of tech giants, the panels attract big crowds, but they often hold more pragmatic objectives, like promoting a product.

At one meeting called "Inside the AI Revolution: How AI is Empowering the World to Achieve More," Simi Olabisi, a Microsoft executive, praised



the tech's benefits on Azure, the company's cloud service.

When using Azure's AI language feature in call centers, "maybe when a customer called in, they were angry, and when they ended the call, they were really appreciative. Azure AI Language can really capture that sentiment, and tell a business how their customers are feeling," she explained.

'Smarter than humans The notion of artificial intelligence, with its algorithms capable of automating tasks and analyzing mountains of data, has been around for decades.

But it took on a whole new dimension last year with the success of ChatGPT, the generative AI interface launched by OpenAI, the now iconic AI startup mainly funded by Microsoft.

OpenAl claims to want to build artificial "general" intelligence or AGI, which will be "smarter than humans in general" and will "elevate humanity," according to CEO Sam Altman. That ethos was very pres-

"when" AGI will become a reality, rather than "if." Ben Goertzel, a scientist who heads the SingularityNET Foundation and the AGI Society, pre-

ent at SXSW, with talk about

dicted the advent of general AI by 2029. "Once you have a machine that can think as well as a smart human, you're at most a few years from a machine that can think a thousand or a million times bet-

ter than a smart human, because

this AI can modify its own source

code," said Goertzel.

Wearing a leopard-print faux-fur cowboy hat, he advocated the development of AGI endowed with "compassion and empathy," and integrated into robots "that look like us," to ensure that these "super AIs" get on well with humanity.

David Hanson - founder of Hanson Robotics and who designed Desdemona, a humanoid robot that functions with generative AI - brainstromed about the plus and minuses of AI with

Al's "positive disruptions... can help to solve global sustainability issues, although people are probably going to be just creating financial trading algorithms that are absolutely effec-

Hanson fears the turbulence from AI, but pointed out that humans are doing a "fine job" already of playing "existential roulette" with nuclear weapons and by causing "the fastest mass extinction event in human his-

tory."

But "it may be that the AI could have seeds of wisdom that blossom and grow into new forms of wisdom that can help us be better," he said. 'Not there yet'

Initially, Al should accelerate the design of new, more sustainable drugs or materials, said believers in Al.

Even if "we're not there yet... in a dream world, AI could handle the complexity and the randomness of the real world, and... discover completely new materials that would enable us to do things that we never even thought were possible," said Roxanne Tully, an investor at Piva Capital.

Today, AI is already proving its worth in warning systems for tornadoes and forest fires, for example.

But we still need to evacuate populations, or get people to agree to vaccinate themselves in the event of a pandemic, stressed Rayid Ghani of Carnegie Mellon University during a panel titled "Can AI Solve the Extreme Weather Pandemic?"

"We created this problem. Inequities weren't caused by AI, they're caused by humans and I think AI can help a little bit. But only if humans decide they want to use it to deal with" the

No Smartphone Or **Internet? AI-Backed Phone Has You Covered**

Visually-impaired Kehinde Olutubosun is a geography and animal enthusiast who struggled to find information because he has no smartphone. But that is changing, thanks to an Artificial Intelligence-powered mobile phone that works offline.

The service, launched by Canada-based Viamo in Nigeria last month, allows anyone - even in the middle of nowhere without the inter-

net - to access AI technology. Viamo uses a traditional handset to tap into local mobile phone networks to send commands or requests for information through SMS or voice calls.

It works like other AI chatbots and can be used by illiterate persons since it can be prompted by voice. It is also cheaper.

"For people who are not that financially buoyant, they still have this opportunity to use even as little as 10 naira to ask lots of questions that will actually benefit them, I am so happy,"

said Olutubosun. Viamo said the device was targeted at the world's poorest and remotest communities and is being expanded to Pakistan, India and Tanzania after being first launched in Zambia.

Viamo is supported by development agencies in the United States and the United Kingdom, among others. UNICEF has partnered with Viamo to provide information on HIV, tropical diseases, nutrition, water, sanitation and hygiene.

US Approves First Drug For People With Severe Form Of Fatty Liver Disease

Washington: The US Food and Drug Administration (FDA) on Thursday approved the first medication for people with a severe type of nonalcoholic fatty liver disease.

Madrigal Pharmaceuticals' Rezdiffra was shown to improve liver scarring in a clinical trial involving hundreds of people with non-alcoholic steatohepatitis (NASH), the worst form of the condition caused by a buildup of fat in the liver.

"Previously, patients with NASH who also have notable liver scarring did not have a medication that could directly address their liver damage," said the FDA's Nikolay Nikolov. "Today's approval of Rezdiffra will, for the first time, provide a treatment option for these patients, in addition to diet and exercise."

NASH affects approximately



6-8 million people in the United States and is often associated with other health problems such as high blood pressure, type 2 diabetes, obesity, and high blood

Its symptoms include weakness, severe tiredness, yellowing of the skin or eyes, spider-like

blood vessels and more. NASH that progresses to cirrhosis -- the latest form of scarring -- will lead to liver failure over time, necessitating a transplant.

Rezdiffra, also kn molecule name resmetirom, is an oral drug that targets the underlying causes of NASH.

In a trial of 966 people, liver biopsies taken at 12 months showed that a greater proportion of subjects treated with Rezdiffra achieved resolution of their condition or an improvement in liver scarring as compared with those who received the placebo. The results were published in February in the New England Journal of Medicine.

Side effects included diarrhea and nausea.

'The accelerated approval of Rezdiffra is a culmination of more than 15 years of research from our founder Dr. Becky Taub and a small R&D team that took on one of the biggest challenges in drug development," said Bill Sibold, Madrigal CEO.

The American Liver Foundation's Lorraine Stiehl also hailed the "groundbreaking" treatment Madrigal said the drug is set

India's First Underwater Metro Service Opens For Public In Kolkata

Kolkata: The newly-inaugurated India's first underwater metro line began public operations in West Bengal's capital Kolkata today with commuters seen queueing up for the first ride on the country's firstever train ride under water.

People were seen clapping and raising 'Vande Bharat' and 'Bharat Mata ki Jai' slogans as they travelled in the country's first underwater metro train, an engineering marvel.

A train began its journey from the Howrah Maidan station on the East-West metro corridor of Kolkata at 7 am today. Simultaneously another train started from Esplanade station at the

The Howrah Maidan-Esplanade section of the Kolkata's metropolitan transportation network is situated beneath the Hooghly River. The under-river section of the tunnel is 520 metres long.

Metro Railway Kolkata post-ed on social media platform X, "First commercial #Metro service entering newly inaugurated #Majerhat station of #Purple-Line this morning.. A placard held by one com-

muter said, "Thank you very much Modi ji for making India proud.'

Another passenger said, "I am so excited to travel in India's first underwater metro train. It hardly took 10 minutes to get the tickets.'

The tunnel of the underwater metro is decorated with blue LED lights to mark the lower part of Hooghly River. The Kolkata underwater metro is scheduled to run on weekdays every 12 to 15 minutes in this section. The last metro of the day is available at 9.45 pm in both directions.





PM Narendra Modi had inaugurated metro operations in Kolkata on March 6. After the inauguration, he also took a metro ride with school students. During the journey, he engaged in conversations with them and the metro staff.

In addition to the underwater metro, the Prime Minister also inaugurated the Kavi Subhash -Hemanta Mukhopadhyay Metro section and the Taratala - Majerhat Metro section, which is part of the Joka-Esplanade line.

Health conditions linked to heart disease found in adults in low-income nations

Adults living in extreme poverty in low- and middle-income countries, or LMICs, have health conditions like hypertension and diabetes that can lead to heart disease, according to new research published in the journal Nature Human Behaviour. Researchers examining the relation-

ship between poverty and cardiovascular diseases (CVD) discovered that CVD risk factors were highly prevalent in LMICs regardless of income, and could increase in prevalence as LMICs continue to develop economically. Specifically, the team found that these

risk factors - hypertension, diabetes, smoking, obesity, and dyslipidemia (abnormal lipid levels in blood) - were present among 17.5 per cent, 4 per cent, 10.6 per cent, 3.1 per cent and 1.4 per cent of adults in extreme poverty, respectively.

Yet, most of these adults were not treated for the CVD-related conditions,

they said. The international study, led by Stanford University in the US, analysed survey data from over 100 nationally representative household surveys across 78 countries. Including data from over 3 million individuals, the researchers estimated it to cover 53 per cent of the global population and 64 per cent of that living

in LMICs, including India. The dataset also represented 85 per cent of individuals living in extreme pov-

erty worldwide, they estimated. "Our study provides a crucial empirical foundation for future work in improving health outcomes for those living in the poorest sections of global society," said corresponding author Pascal Geldsetzer, Assistant Professor of Medicine at Stanford University.

The findings contradicted a common assumption that environmental factors



like food scarcity and lifestyles involving physical labour of those living in extreme poverty in LMICs protect against CVD risk factors, the team said.

"Understanding how an assumption of low prevalence of CVD risk factors among those in extreme poverty holds true is important for setting priorities within health policy and care delivery, both for equity and effectiveness," said study author Till Baernighausen, from

Heidelberg University, Germany. Despite being limited by possible measurement errors and potentially overestimating CVD risk in adults living in extreme poverty, the study could inform equity discussions for resource allocation and design of effective interventions, the researchers acknowledged.

"Further research into mechanisms of CVD risk specifically affecting individuals living in extreme poverty is essential - uncovering the different pathways that may predispose various groups to CVD risk will be vital in reducing that risk," said study author Sebastian Vollmer, Professor of Development Economics, University of Gttingen, Germany.
