LS Polls For 3 Seats Of Kashmir Valley

Over 1.13 Lakh **Migrants Eligible To Vote**

Jammu: Over 1.13 lakh Kashmiri migrants are registered to cast their votes for the upcoming Lok Sabha elections for three seats in the Valley, officials said.

The Jammu and Kashmir administration will hold special awareness camps for Kashmiri migrants in Jammu and Udhampur districts from April 3 to 14 to ensure their participation in the Lok Sabha elections.

"We have 1.13 lakh registered Kashmiri migrant voters as of now. The updated voter list is being prepared as per the election process," Relief and Rehabilitation Commissioner

Karwani told PTI.

Karwani, who is looking after the arrangements for the polling of migrants, said that polling will be held in three phases in the Valley.

"In Anantnag, polling will be held on May 7, followed by Srinagar on May 13 and Baramulla on May 20. It will be held in three phases, and polling stations for each constituency will be the same," Karwani said.

A total of 26 polling stations have been set up for the migrants, out of which 21 polling stations have been set up in Jammu, four in Delhi and one in Udhampur, Karwani said.

Emergency Landing Strip On Jmu-Sgr Highway

5 IAF Helicopters Conduct Overnight Trial

Srinagar: Five IAF helicopters, including the recently inducted US-manufactured landed on a stretch of the Jammu-Srinagar National Highway as part of an Emergency Landing Facility drill, the first such exercise in Jammu and Kashmir, of-

ficials said on Tuesday. With this, Jammu and Kashmir became the first Union territory to operationalise an Emergency Landing Facility (ELF). Andhra Pradesh, Uttar Pradesh and Rajasthan are the three states where these

emergency landing strips are currently operational.

According to the officials, two US-manufactured Chinook, one Russian-made Mi-17 and two Advance Light helicopters (ALH) of the Indian Air Force (IAF) landed on the Wanpoh-Sangam stretch of the national highway linking Kashmir with the rest of the country in the early hours of Tuesday.

The entire drill ended by 2.50 am, during which the helicopters landed at the stretch and carried an exercise of picking up troops lying on the ground, the officials said, | More on P6

6 Genes Found To Control One's Personality, Affect Health, Well-Being

Six genes have been found to be at the heart of emotional response and meaning perception, in turn making up one's personality, including their outlook and functioning, according to new research.

These genes were also found to be "highly preserved" throughout evolution, from single-celled organisms to modern humans, a finding that researchers said confirms their crucial role in the functioning of all forms of life on Earth.

The study examined how personality regulates an individual's gene expression and hence, affects their health and well-being. Gene expression happens at the fundamental level of one's being where genes translate into observable traits and behaviour.

The researchers said the findings shed new light on the "long-standing mystery" behind how the mind and body interact.

The international team of researchers, including genetics and psychology specialists, led by the Uni-



versity of Grenada, Spain, employed artificial intelligence in analysing data of 459 adults in Finland collected over four decades.

Data was collected on participants' health, physical condition and lifestyle, along with their personality assessments regarding habits and emotional response (temperament), and goals and values (character).

"In our research, we made two key discoveries about the expression and organisation of genes according to the personality profiles of these individuals," explained Coral del Val, a researcher at the University of Grenada, and colead author of the study published in the journal Molecular Psychiatry.

The researchers discovered a network of 4,000 genes expressed in specific brain regions, and some of which have been previously linked to the inheritance of human personality. They found these genes to be clustered into

several modules, involved in regulating gene expression and helping an individual adapt.

The modules turned on and off in a flexible manner, facilitating adaptation to the everyday challenges we all face, and choreographing our development," said del Val.

"What's most remarkable is the fact that the networks for emotion and meaning (and controlling these modules) are coordinated by a control centre made up of six genes," said Elisa Diaz de la Guardia-Bolivar, University of Grenada, the other co-lead author of the study.

"It is particularly interesting that we found that the six genes of the control hub are highly preserved throughout evolution, from singlecelled organisms to modern humans. This finding confirms their beneficial role in regulating the functioning of all forms of life on Earth," she said.

The researchers also found that while certain outlooks on life are conducive to a healthy, fulfilling and long life, others lead to a stressful, unhealthy and short life.

Srinagar: Mirwaiz Umer Farooq, the chief cleric of Kashmir on Tuesday appealed for harmony and togetherness across all sects, saying those propagating hate should be explicitly pulled down from pulpits.

Addressing the sermon organized in connection with the martyrdom anniversary of Hazrat Ali (A.S) at Astaan Aliya Dastgeer Sahib (RA) Sarai Payeen, Mirwaiz said regretfully, attempts are being made to fan sectarian strife rather than nurturing the flame of unity and consensus.

"Is there any room for sectarian animosity when we our creator is one, one Prophet, and one Qur'an? He questioned, invoking religious unity above sectarian strife," he said.

He said that Hazrat Ali (RA)'s profound ethics and wisdom, which are evident in his perceptive sermons collected in his book 'Nahjul Balagha', are proof of his brilliance and in-depth knowledge of a wide range of disciplines.

Instead of encouraging sectarianism, Mirwaiz stated that mosques, seminaries, shrines, Imambargahs, and other religious institutions should be used to promote religious unity.

The chief cleric of Kashmir, also that Jumat-ul-Vida, or the last Friday of Ramadan, will be observed in Kashmir as Yaum-e-Dua (Day of Prayer) with a large number of devotees from across the valley anticipated to swarm the historic Jamia Masjid on the occasion.

"A gathering of all religious organizations will be held after Eid-ul-Fitr to address a number of concerns, such as the drug problem and the hate speech given by religious clergy against one another," Mirwaiz told reporters after reviewing arrangements at Jamia Masjid here.

Invoking the support of the government to guarantee the smooth execution of these significant religious events at Jamia Masjid. Mirwaiz said that all necessary arrangements for energy, water supply, and cleanliness had been finalized in this direction.

RINAGAR - Apple growers of Kashmir have sent a gift of 12 cartons of apples to Pakistani and Indian leaders with a message "From Kashmir with Love. Pakistan President Pervez Musharraf. Pakistan Prime Minister Shaukat Aziz, Indian Prime Minister Dr. Manmohan Singh and Congress party president and

Chairperson of the National Advisory Council, Sonia Gandhi will be among the recipients. Apple growers are sending mix cartons of the world

famous apples to Pakistani leaders as a thanksgiving gesture for starting the bus service' between Srinagar and Muzaffarabad on April 7, which will link divided parts of Kashmir for the first time in 58 years. Six other cartons are being sent to New Delhi for Dr.

Singh and Mrs.Gandhi before both leave for Srinagar to inaugurate the historic bus service next week The bus service is being seen as one of the most

tangible signs of a fledgling peace between the nuclear rivals after decades of enmity. It will travel 170 km on the highway between Srinagar and Muzaffarabad in the Pakistani sector.

Apple growers say a carton each will be gifted to Musharraf and Aziz, while the other four will be given to other political leaders.

Ghulam Rasool, the President of Fruit Growers Association here, said with the opening of the bus service, there it hope it would revive trade links.

"Kashmir is known in, the world for its fruits. So this time we will gift baskets of apple to Pervez Musharraf, Shaukat Aziz and the Indian High Commissioner in Pakistan. When we had a good trade in apples 1947 the wholesale market was in Rawalpindi and we used to send apples to Amritsar. Delhi Karachi etc front there and when we heard about this (the bus service), we decided then itself that we will gin six basket of apples to Pakistan and seven basket of apples for our Prime Minister Manmohan Singh and other leaders which includes Ghulam Nabi Azad and Sonia Gandhi." he said India had said on Friday it hoped free trade with its

Around 600000 families' arc directly involved in the valley's fruit business and if the market opens for their produce in Pakistan, growers are optimistic that both the countries could overtake Gulf countries. Ghulam Mohammed, a senior member of Fruit Growers Association, said fruit trade via Pakistan could also solve the unemployment problem.

"Ā lot of unemployment problems will also be solved. More youths will be engaged in the work as there is no other viable industry and only Fruit industry is the living industry." said Rasool. With 1.2 million metric tonnes of apple production. Kashmir is the biggest producer of apples in India. Barriers to commerce cemented by more than a half-century of hostility mean companies selling everything from wheat to tyres to Pakistan arc forced to make costly detours into countries like Afghanistan and the United Arab Emirates. Trade is on course to rise more than 150 percent in the

financial year which ended in March to about \$500 million, but businessmen predict it could reach 10 billion dollars within five years of signing a free trade agreement.

Pakistan, with 66 million dollars worth of exports to India in the eight months to November, were dwarfed by imports of 315 million dollars. (ANI)

Refining Reservation

Balancing Equity With Meritocracy

hile one can't be against the concept of 'reservation' per se, for it is mandated by constitution in its part 3rd, but the manner in which it is being now implemented raises questions about their effectiveness and impact.

Reservation was envisioned by our constitutional framers to rectify past and historical injustices against backward classes in India and not to uproot the meritocracy. When a community is given reservation well beyond the backwardness and disadvantages, the idea of reservation dies.

The recent decision to increase the Scheduled Tribe (ST) quota by 10% and the Other Backward Classes (OBC) quota by 4% in Jammu and Kashmir, enhancing the total reservation to 70%, is one such example. This move, announced on 16th March, comes amidst the inclusion of four new tribes into the Scheduled Tribes category. While purported to be for inclusivity and emancipation of the four tribes, the decision raises critical concerns

The proposed 10% reservation for Paharis and other three tribes is utterly disproportionate, both in terms of their backwardness as well as their demography. Without clear evidence of widespread disadvantage and systemic discrimination faced by the Pahari community and the other three tribes, the rationale behind the 10% reservation remains questionable.

The new reservation rules added 15 new castes in the already long list of OBC castes and they were increased to a 4 percent quota and here we see 10% reservation for merely four tribes. Why this preferential treatment to these four tribes? The justification for a 10% reservation raises legitimate concerns about the criteria used for determining reservation quotas

The decision overlooks the principle of proportionality and balance in the new reservation policy. The allocation of 70% reservation in Jammu and Kashmir, where the open merit population constitutes approximately 69% population, raises

questions of arbitrariness and violates equality under Article 14 of the Const people in power must also consider the opportunities of the general population

of the Indra Sawhney judgment emphasizes the need for prudence and caution when considering any breach of the 50% cap. The absence of compelling evidence justifying the expansion of quotas beyond this limit undermines the foundational principles of equality and fairness enshrined in the Constitution.

The judicial response to similar instances of exceeding the 50% reservation cap underscores the importance of upholding constitutional principles. In cases such as the Maratha reservation in Maharashtra and the reservation laws in Chhattisgarh, Orissa, and Rajasthan, the courts have consistently struck down attempts to surpass the prescribed limit.

I understand, reservations are essential for promoting inclusivity and addressing historical injustices but they must not come at the expense of merit-based selection processes. The Indra Sawhney judgment rightly emphasized the importance of striking this balance, ensuring that reservations do not undermine the



ney v Union of India case in 1992. The judiciary has consistently emphasized the need for reservations to be confined within the 50% limit, barring exceptional circumstances. The Indra Sawhney judgment acknowledges the possibility of breaching this ceiling only in extraordinary situations, such as for remote and marginalized communities. However, the recent decision fails to demonstrate the existence of such extraordinary circumstances, thereby raising concerns regarding its consti-

tutional validity. The judiciary's interpretation

pen this open letter to LG Manoj Sinha. With utmost respect & reverence, I hope this letter finds you in good health and high spirits. I am writing to your good self today as a Rehbar e Khel teacher, a position I hold with great pride and dedication. However, I find myself in an excruciatingly difficult situation that compels me to reach out to you with a heavy heart. I am not just a teacher; I am a parent responsible for three young children and elderly parents who depend on me for their well-being. The honorarium I receive for my service, a mere Rs. 4000 per month, is barely sufficient to cover the cost of commuting to work. Unfortunately, this leaves my family in a state of constant hunger and deprivation. My children and aging parents go to bed hungry, unable to have a decent meal, and

it breaks my heart. I am left feeling broken, hopeless, and overwhelmed by despair, with thoughts of desperation and even suicide haunting my mind. Witnessing the suffering of my loved ones, especially my children and elderly parents, is a torment I

cannot bear. I acknowledge the recent decision by the administrative council to increase the honorarium of Rehbar e Khel teachers in J&K by 50%, as per Order No. 09- JK (YSS) of 2024 dated 26-02-2024. However, the previous monthly honorarium of 4000 rupees, with the recent 50% increment, brings the total to 6000 rupees per month, which we find unjust and inadequate. 

PERFECTIONISM A Common Result of Childhood Trauma

mar grew up one of ten siblings in a crowded Milwaukee apartment complex. He remembers having to fight, sometimes literally, for attention from his parents, both of whom were often stressed and overwhelmed. He learned quickly to minimize emotional struggles or needs, as these seemed to annoy his parents. Instead, good grades, making varsity letters at school, and being the first in his family to master English earned him the praise that his developing soul craved.

In adulthood, Omar was known as a "workaholic" among his friends and coworkers, and his wife jokes that "I never have to pick up his socks because he's never home anyway!"

His work had become his identity, and the accolades that came from that were the sustenance that sustained him. He did not know how to feel OK with himself unless he was achieving—and achieving perfectly. Any mistake was met with ridicule and self-loathing. This was unrealistic for anyone, but to someone who grew up without the message that they are worthy just for being themselves, it's a common result.

Despite so many professional and personal achievements, Omar always felt incomplete and defective. "I will feel OK for a little bit after finishing a project or getting an award, but then I'm back to just feeling, it's hard to explain, like I am not good enough. I know that sounds weird coming from me."

In truth, it doesn't. In fact, some of the highest-achieving and perfectionistic individuals are hiding their inner shame. While this does not mean all perfectionism comes from inner shame, there is a common link (Howard et al., 2023).

Perfectionism often emerges as a coping mechanism in response to the shame that comes from childhood trauma, as individuals strive to gain a sense of control and security in their environment. Rooted



in fear of failure or abandonment, perfectionism becomes a way to avoid criticism, rejection, or further trauma by striving for flawlessness in every aspect of life. However, this relentless pursuit of perfection can lead to high levels of stress, anxiety, and selfcriticism, ultimately hindering emotional well-being and preventing individuals from experiencing genuine satisfaction or fulfillment. Recognizing and addressing that perfectionism is often a response to childhood trauma can help in fostering self-compassion, resilience, and developing healthier coping strategies.

Perfectionism often stems from inner shame, especially in the aftermath of childhood trauma (Maté & Maté, 2022). Driven by a deep-seated belief of unworthiness or inadequacy, individuals may strive for perfection as a way to counteract or conceal their perceived flaws and vulnerabilities. This relentless pursuit of flawlessness becomes a coping mechanism to manage feelings of shame and self-doubt, as individuals seek external validation and acceptance to quell their inner turmoil. However, perfectionism ultimately perpetuates a cycle of self-criticism and anxiety, reinforcing the underlying shame and preventing authentic self-acceptance. Recognizing perfectionism as a response to inner shame is crucial in fostering self-compassion and healing from past traumas.

Healing from perfectionism involves cultivating selfawareness and self-compassion and adopting healthier perspectives on success and failure. Here are several strategies to support this process:

• Start by considering

- whether you have realistic goals: We often compare ourselves to others, and then, when we fall short, assume we are inadequate. But this is not only unrealistic, it is unfair. Although it can feel very uncomfortable at first, slowly start to allow yourself to embrace vulnerability and authenticity. Admitting shortcomings is not only a normal part of being human but can also be seen as a sign of maturity.
- Practice self-compassion: Cultivate kindness and understanding toward yourself, recognizing that imperfection is a natural part of being human. Treat yourself with the

same empathy and compassion you would offer to a friend facing similar challenges.

Start small: Slowly start to become OK with recognizing that you make mistakes occasionally and that this is OK. By shifting your perspective, you can start to become more comfortable with the idea of making occasional mistakes and recognize that it does not diminish your worth or value as a person.

value as a person.
Reach out to trusted friends, family members, or mental health professionals for support and guidance. Therapy can provide valuable tools and strategies for navigating perfectionism and healing from underlying emotional wounds, but it is not for everyone. There are many tools along the path to healing.

By implementing these strategies, individuals can gradually shift away from perfectionism and toward a healthier and more compassionate relationship with themselves and others.

Terror Module Busted In Rajouri, Poonch

Jammu: Jammu and Kashmir Police busted a module of Lashkar-e-Toiba (LeT) in the twin border districts of Rajouri and Poonch, arresting three out of seven identified members involved in receiving and distributing arms, ammunition, explosives, cash and narcotics dropped through drones from across the border, officials on Tuesday said.

Police issued a poster with a Rs 10 lakh award for the mastermind of the module, Mohmmad Qasim of LeT based in Pakistan.

"In a planned manner, Zone police and CIB have identified individuals involved in receiving arms, ammunition, IEDs and narcotics dropped through drones from across the border in Rajouri," Director General of Police (DGP) R R Swain told reporters here.

"Cases were registered against them and their premises were searched. During the past 24 hours, ten places were searched and seven persons were identified. Three of them were already arrested." he added.

The DGP said it was proven through evidence that they have received consignments of arms, ammunition, IEDs, cash and narcotics dropped through drones from Pakistan

and distributed them further to forward linkages.

Both CID and police worked well in coordination and performed the best groundwork together to bust this module, he said.

Those arrested include notorious OGW in jail under UAPA, Talib Shah's wife Gulshan Naaz, Imtiyaz Ahmed (both from Kotranka) and Abid Shah of Budhal area, he said, adding that they were involved in receiving material dropped from Pakistani drones.

"We have digital and electronic evidence against them. They were in touch with the mastermind in Pakistan. They have also distributed to forward linkages. Forward linkages, to whom they distributed money, are also being investigated," he said.

The money has come in lakhs and was distributed to several people in small amounts, Swain said, adding that they are categorized as over ground workers (OGWs). The DGP said that their mastermind is Mohmmad Qasim alias Salman alias Sulliman of Mahore (Reasi) currently based in Pakistan.

"He is a LeT leader. He has been declared a designated terrorist by the Government of India. We have announced a Rs ten lakh award on Qasim. A poster has been released in this regard," he said. Gulmarg Gondola Breaks Records

'Demanding Admission Fee'

FFRC Summons Pvt School Principal

Srinagar: Following the 'non-compliance' of Fee Fixation and Regulation Committee (FFRC) orders, the committee Tuesday directed a principal of a private school to appear before the committee.

FFRC said this while taking a suo-moto cognizance of a concerning video circulating on social media wherein serious allegations have been made against management of Kashmir Haward school Naseem bagh Srinagar.

FFRC Chairperson in an order said that It has been alleged that the school is demanding Rs 85,000 as admission fee for the admission of her child which, if proven true, warrants immediate action.

It said that charging of admission fee has been barred by statute and any fee charged in contravention of FFRC directives is strictly prohibited by law.

"No educational institution is authorized to impose any fees without prior approval from the FFRC. Such actions not only raise moral and ethical concerns but also violate legal statutes," it reads,

The FFRC order further reads that during the investigation, it has come to fore that the school has failed to submit the requisite documentation and file for the regulation of fee structures for the academic session 2024-25.

"As per the established timeline, the school was obligated to submit this documentation to the Fee Fixation and Regulation Committee (FFRC) by or before December 31, 2023," it reads.

FFRC chairperson further said that the school is not authorized to unilaterally enhance its fee structures without the necessary approvals from the FFRC.

"The failure to adhere to the submission deadline for fee regulation documentation raises serious concerns regarding compliance with regulatory requirements," it reads.

FFRC said that following the serious allegations, the Chairman or Principal of the school is hereby directed to appear at the Fee Fixation and Regulation Committee (FFRC) office in Hyderpora on April 3, 2024, at 12:20 pm along all factual details and information pertaining to the matter for thorough examination.

The Anantnag-Rajouri parliamentary seat, formed post-delimitation, encompasses Rajori and Poonch and is slated for voting in the third phase on May 7. As the election fervor picks up, political parties are gearing up for an intense battle, with nominations set to commence on April 12 and conclude on April 19.

While the NC has declared its intention to contest three Lok Sabha seats in the Kashmir Valley, including Anantnag-Rajouri, the PDP is expected to field candidates for two of the three seats. However, formal announcements from both parties are pending, along with the BJP's candidate revelation.

The Anantnag seat has historically been a key battleground, witnessing significant electoral contests. Former MP Mehbooba Mufti's victory in 2014 and subsequent resignation in 2016 triggered prolonged vacancy, with elections delayed for security reasons. In 2019, Hasnain Masoodi clinched victory amidst subdued voter turnout, marking a turning point in the political landscape of the region. (with inputs from PTI)

Earlier, Bharatiya Janata Party (BJP) candidate Jugal Kishore Sharma filed his nomination papers. Sharma is seeking re-election from this constituency for the third consecutive term. He was elected to the Lok Sabha from this constituency in 2014 and 2019. The constituency goes to vote on April 26 in the second phase.

Jugal is in the fray to reclaim this seat, straight for the third time. In 2019, he had defeated the Congress candidate Raman Bhalla with a margin of 3,02,875 votes as NC and PDP had not fielded their candidates. In 2014, Jugal had won this seat again defeating Congress candidate Madan Lal Sharma, with a victory margin of 2.57 lakh votes.

Congress has also repeated its nominee i.e., former minister Raman Bhalla, who is a common candidate of I.N.D.I. Alliance of which both National Conference (NC) and Peoples Democratic Party (PDP) are constituents. He will file his nomination paper on April 2.

Following delimitation, Jammu parliamentary constituency comprises 18 assembly constituencies which include 11 from Jammu; three from Samba and Reasi district each and one Rajouri's Kalakote assembly constituency. Total electors are 17.66 lakh.

As per the notification, nomination papers can be filed by candidates or their proposers not later than April 4, 2024. Scrutiny of the nomination papers will take place on April 6, 2024 at 11 am at Deputy Commissioner's Office Jammu. The candidates have the option to withdraw their candidature on April 8, 2024 until 3 pm. The polling on April 26 will be conducted from 7 am to 6 pm—(KNO)

"We are asking a direct question. The companies constructing projects here be it Ratle or Zojila tunnel for what purpose did they pay the electoral bonds," he added.

On Delhi Chief Minister Arvind Kejriwal's arrest, Abdullah said that the world has taken notice of it.

"Not only us but the powerful countries of the world have taken note of how the opposition leaders are being singled out for targeting. Kejriwal is the second CM who has been arrested," he said.

Abdullah said that arresting sitting chief ministers is a "very dangerous situation for democracy" and the country "will have to pay a price for it for a long time".

"We hope that the SC and EC will not ignore it and stop the use of investigation agencies during elections," he added. PTI

Apprehension of less voting percentage in Muslim dominated Chenab Valley

DODA: As the campaigning for the Udhampur-Doda parliamentary constituency is in full swing with political parties trying to get people on their side, people of Chenab valley have some reservation towards the polling day which is falling on Friday, April 19.

Talking to the news agency people of Chenab valley expressed that they will be losing time on the polling as it falls on Friday.

"On Friday from 12.30 pm to 2.30 pm, all Muslims head towards Masjids (Mosques) for prayers and they even close all of their business establishments. There will be very few people in polling stations during this time which will have



an impact on the voting percentage as well," said Bashir Ahmed, a shopkeeper told KNO.

The Udhampur-Doda Lok Sabha constituency comprises five districts of Jammu region including Kathua, Udhampur, Ramban, Kishtwar and Doda and out of these five districts, Doda, Ramban and Kishtwar (part of Chenab valley) are Muslim majority areas. This constituency is going to poll during the first phase on April 19, which falls on Friday.

Even the non-Muslims of the area feel that it will certainly have an impact on the voting percentage as most of the Muslims will not be able to vote during the prayer time.

"Muslims mostly go for prayers on Friday and polling stations are certainly going to give a deserted look. The polling should have been on any other day except Friday. As the date has already been notified, people will have to adjust accordingly," said Rishi Kumar, a resident of Kishtwar district.

The Udhampur-Doda Lok Sabha seat is going to witness one of the biggest rivalry between Bharatiya Janta Party's (BJP) sitting Member Parliament (MP) Dr. Jitendra Singh (MoS in PMO) and former MP and Congress leader Choudhary Lal Singh. Both the leaders will be eyeing to get maximum Muslim votes from Chenab valley and secure the win but apprehensions of less voting percentage due to polling day falling on Friday will have a negative impact

CPI(M) Opts Out Of LS Polls To Consolidate Votes Against BJP: Tarigami

SRINAGAR: Senior CPI(M) leader in Jammu and Kashmir M Y Tarigami on Tuesday accused the BIP of resorting to dictatorship and said his party would not contest in the Lok Sabha seats in the Union territory to consolidate votes and get rid of "tyrants".

He sought to downplay the reported bickering within the Peoples Alliance for Gupkar Declaration (PAGD) constituents over seat sharing for the Lok Sabha polls, saying it is not an electoral alliance and every constituent has their own political interests.

"We will not contest (the Lok Sabha polls in Jammu and Kashmir) directly. Our political approach in today's times would be to defeat the BJP, to stop them from forming government. They have already done a lot of damage to Jammu and Kashmir," Tarigami told PTI-Video in an exclusive interview here.

"We also appeal to other political parties to ensure that votes do not get divided. We hope we get rid of the tyrants soon," he said.

Asked about reports suggesting the coming together of the Ghulam Nabi Azad-led Democratic Progressive Azad Party, Altaf Bukhari's Apni Party and Peoples Conference headed by Sajjad Lone, Tarigami questioned the move and said, "We should have been loyal towards our people."

this alliance aimed at raising the genuine concerns of the people such as our statehood, and our land rights. What the present government did with us does not have a precedence in the history of Kashmir.

He said it was unfortunate that Jammu and Kashmir has always been in the crossfire and there has been restlessness among its people.

"Pakistan has been making its own claims and our country, India, has been making its own claims. There has been a restlessness among people. The successive governments have also not been loyal towards the people of Kashmir.

"Today's government left no stone unturned to demolish the very foundation of the pact between the Centre and the people. We have always been deprived of our constitutional rights. They (BJP) eroded Article 370 also," Tarigami said.

The CPI(M) leader said, "If

BJP had a clear roadmap, they would not have resorted to dictatorship. They downgraded Jammu and Kashmir into a Union territory. Look at the plight of government employees here. They are not even allowed to protest... Do you think people will show support to-

Tarigami, who is also spokesperson of the PAGD, said it is not an electoral alliance and every constituent has their own political interests.

PAGD is an alliance of five political parties -- National Conference, PDP, CPI(M), Awami National Conference and CPI seeking the restoration of the special status to Jammu and Kashmir which was revoked with the abrogation of Article 370 in 2019.

"The DDC (District Development Council) elections were fought together despite the differences... Jammu and Kashmir had its own constitution but that's gone now. Our flag is gone, our land rights are gone, our permanent residency rights are gone. Statehood is also gone.

"Jammu and Kashmir is the only place where assembly elections have not taken place in the last 10 years. A state was divided without taking into consideration the aspirations of the people. Whatever statements the constituents have given do not change the very idea of PAGD. It will always be relevant," he said.

"ED Srinagar has provisionally attached movable and immovable properties worth Rs 1.56 Crore in the form of land, measuring 01 Kanal, 03 Marlas, situated in Srinagar, Jammu & Kashmir along with a Two-storey residential house made thereon and a vehicle of Niamat Ali Bhat in a case related to Hakeem Imtiyaz, Junior Engineer of R&B Department, J&K under the provisions of PMLA, 2002," the ED posted on X.

"Shah had said that first there would be delimitation, then elections and then statehood. What happened to that chronology? If the environment (in J-K) is feasible for Lok Sabha elections, then why not for assembly polls? You must be knowing about the Pathribal, Machil and Shopian (fake) encounters. IT Dept Warns Of Strict Action On TDS Violations In Govt Offices

SRINAGAR: The Income Tax Department has issued a stern warning against the misuse of Tax Deducted at Source (TDS) mechanism within government offices.

As per the news agency, concerns have been raised regarding instances where private individuals, engaged by government bodies for assistance in taxation matters, have exploited the system to claim fraudulent refunds.

In response, stringent guidelines have been outlined to safeguard against such deceptive practices, emphasising the crucial role of government officials in ensuring the integrity of TDS deposition. As such a circular has been issued by the Finance Department Directorate General of Accounts and Treasuries.

The Commissioner of Income Tax (TDS)-1, Chandigarh vide above referred communication has informed that there have been some unrelated instances of the misuse of AIN (Account Office Identification Number) and TAN (Tax Deduction Account Number) by private persons whose services have been taken by some unrelated Government Offices for help in taxation mat-

ters at their respective ends, it reads. It has been further brought into the notice that the TDS mechanism has

been misused by such unscrupulous persons with an intention of claiming bogus refunds. An entire chain of bogus/false claims in Form 24G statements filed under the AIN are created, false TDS quarterly statements are filed and ultimately ITRs claiming bogus refunds are filed. These frauds are serious in nature, it added.

In this context, the Income Tax



department has shared a brief note on the mechanism of TDS deposit by Government Offices and checkpoints for exercising due diligence and due care by the AIN holders and TAN holders which is as follows:-A. Mechanism of TDS deposition for Government Offices: The Income Tax Law provides that where tax is deducted/collected by a Government office, the Tax so deducted/collected at source can be remitted to the Central Government without production of income-tax challan (ITNS 281). "Government Accounting System,

each DDO who is responsible for tax deduction at source (TDS) is allotted a TAN and he is responsible for filing of TDS Statements like Form 24Q and Form 26Q," it said. Each DDO reports to a Pay and Accounts Officer (PAO)/District Treasury

Officer (DTO)/ Cheque Drawing and

Disbursing Officer (CDDO) (hereinafter mentioned as 'Accounts Officer'). These persons are allotted AINs (Account Office Identification Numbers). The information regarding TDS de-

ducted against payments is passed on by the DDO who holds the TAN to the Accounts Officer who holds the AIN. The Accounts Officer makes a book entry for the transfer of TDS credit to

the account of the Central Government by filing Form 24G every month as per ITD Notification no. 41/2010 dated 31 May 2010 using the Accounts Office Identification Number (AIN).

After filing of Form 24G, Book Adjustment Identification Number (BIN) is generated for each DDO. Using the BIN (Book Adjustment Identification Number), the DDO files quarterly TDS/TCS statements in Form Nos. 24Q/26Q/27Q/27EQ (as may be applicable).

IPL: New Skipper Pandya Under Fire From Rohit Fans As Mumbai Slump

MUMBAI: Hardik Pandya has been facing the wrath of jeering fans in the Indian Premier League this season, with the Mumbai Indians struggling since he took charge from the much-loved Rohit Sharma.

Five-time winners Mumbai replaced Rohit, who leads India in all formats, as captain before the IPL season started last month after the India all-rounder Pandya returned from Gujarat.

The homecoming has been tough for Pandya, who has been booed incessantly as his side slumped to three consecutive defeats, the latest at Mumbai's Wankhede Stadium on Monday.

In contrast, the Chennai Super Kings have reported a "seamless transition" of leadership after their old warhorse Mahendra Singh Dhoni handed over the captaincy to Ruturaj Gaikwad on the eve of the IPL's 17th edition.

Pandya's reception could not have been more different.



After being traded from Gujarat back to Mumbai for \$1.8 million, his immediate elevation as captain

went down badly with the legions of Rohit fans.

Rohit, 36, remains an icon in

Mumbai after leading the team to five IPL titles since taking over from Australia's Ricky Ponting in 2013.

Mumbai's winless record with Pandya in charge this season has done nothing to win over the fans in the cricket-mad country.

Pandya began with a loss at Ahmedabad, home of Gujarat Titans, who won the title in their inaugural season in 2022 under the Indian all-rounder's dynamic lead-

The 30-year-old had another forgettable evening on Monday against Rajasthan Royals, even being jeered at the toss by home fans, prompting presenter Sanjay Manjrekar to call on them to "behave".

But the crowd kept up their hostility towards Pandya throughout, with Rohit gesturing to the fans to stop at one point.

Man United's Varane Blames Heading For Health Issues

PARIS: Manchester United defender Raphael Varane has said concussions have damaged his body as he stressed the importance of creating more awareness among players around the dangers of heading. The Frenchman said he had suffered a concussion a few days before playing in France's 1-0 defeat to Germany in the quarter-finals of the 2014 World Cup, as well at his former club Real Madrid when they lost to Manchester City in the last 16 second leg of the 2020

Champions League. The 30-year-old retired from international football

after a 10-year career with Les Bleus, during which he won the World Cup in 2018 and was a runner-up four years later.

"My seven-year-old son plays football and I advise him not to head the ball. For me, that's essential," Varane told French daily L'Equipe.

"Even if it doesn't cause any immediate trauma, we know that in the long term, repeated shocks can have harmful effects.

"Personally, I don't know if I'll live to be 100, but I do know that I've damaged my body. The dangers of headers need to be taught on all amateur football pitches and to young people."

quite up for it when it comes to bowling.
"The recent Test tour of India highlighted how far behind I was from a bowling point of view after my knee surgery and nine months without bowling.

"I'm looking forward to playing for Durham in the County Championship before the start of our Test summer. I wish Jos (Buttler), Motty (Matthew Mott) and all the team the best of luck in defending

England will be defending the title in the Caribbean having triumphed in the last edition of the tournament in Australia in 2022, with Stokes hitting the winning run in the final for a five-wicket victory over Pakistan at the MCG.

However, he has only played two T20 matches since, both at last year's IPL.
