### **Extra Power Curtailment In Kashmir**

Srinagar: In the existing 'unscheduled power cuts and power outages' Kashmir Power Distribution Corporation Limited (KPDCL) Monday said that there will be further increase in power curtailments.

The DISCOM said that the step has been taken in view of limited power availability. Taking to microblogging site X, KPDCL said, "Due to limited power availability, there has been an unavoidable increase in power curtailment. These restrictions will be eased once power availability improves. Please bear with us & ensure judicious use of power, especially during peak hours. Avoid exceeding sanctioned load/hooking." (SIC)

In the meantime, people from across Kashmir have raised concerns about the power schedules. "Adding the extra curtailment to the existing power schedule will be a mockery of the power availability," locals said.

"The power supply is already at the worst level and adding more curtailment will be nothing but a mockery of the power availability and to the people," they said.

The locals from many areas of north and south Kashmir said that they are facing frequent power outages and distress cuts.

Meanwhile, KPDCL Chief Engineer (Distribution) Sandeep Seth said that the company was yet to chart out the final schedule.

"We are charting out the final power curtailment schedule and will take a call accordingly," Seth said.

In anticipation of the elections, a substantial deployment of paramilitary forces has been mobilized across key districts including Jammu Samba, Reasi, and Rajouri. Police authorities have issued directives mandating the presence of Station House Officers (SHOs) in their respective areas for the next four days.

The security apparatus, comprising approximately 40,000 personnel, are tasked to ensure a smooth and secure voting experience for the electorate. Against the backdrop of heightened tensions along the border, an alert has been sounded, underscoring the imperative of safeguarding the electoral process from external disruptions. Meanwhile, po-



# NIA Raids 9 Locations In Kashmir

The National Srinagar: Investigation Agency Monday carried out raids at nine locations in Kashmir, including Srinagar, in a terror conspiracy case, officials said here.

The case relates to a terror conspiracy involving plans by terrorist organisations and their newly floated offshoots to unleash violence in Jammu and Kashmir by using sticky bombs, improvised explosive devices and small arms, they said.

"In a massive crackdown in the Jammu and Kashmir terror conspiracy case involving Pakistan-backed banned terrorist organisations and their offshoots, the NIA raided nine locations across Kashmir," a spokesman of the National Investigation Agency (NIA) said He said digital devices

containing large volumes of



incriminating data and documents were seized during the raids conducted on the premises of hybrid terrorists and Overground Workers (OGWs) linked to the newly formed offshoots and affiliates of proscribed outfits such as the Laskhar-e-Toiba, Jaish-e-Mohammed, Hizbul-Mujahideen, Al-Badr and Al-Qaeda among others.

The premises of sympathisers and cadres of these organisations were also searched extensively, the spokesperson added. The NIA said | More on P6

### Rising Airfares Stir Concerns Ahead Of Peak Tourist Season In Kashmir **Syed Mohammad Burhan**

Srinagar: As Kashmir gears up for the peak tourist season, the issue of rising airfares during the peak tourist season has stirred concern among both tourism stakeholders and locals alike.

According to tourism players, as the summer season approaches, the airfares between Srinagar and other major Indian cities witness a significant surge, casting a shadow over travel plans and financial considerations of tourists.

Speaking to Kashmir Observer, Abbas Kashmiri, a ticket broker, highlighted the annual surge in ticket prices during every summer season.

"Last month, a one-way ticket from Srinagar to Delhi used to cost around Rs 3,500-4,000. Now, those prices have skyrocketed to Rs 7,000, with fares often reaching a staggering Rs 13,000-14,000 during peak tourist season," Abbas said.



The situation isn't any better for flights to other major cities. Mumbai, for example, saw ticket prices jump from Rs 7,000 just a month ago to a hefty Rs 11,000."

Manzoor Ahmad Pakthoon, chairman of the Kashmir Houseboat Owners' Association, said that tourism players in the Kashmir Valley have repeatedly raised the issue of airfare escalation during peak tourist season with authorities, but no action has been taken.

"Tourists mostly from south India complain of the rising airfares. Travel to outside India is turning out to be cheaper to them than visiting Kashmir. So, the government should increase the number of flights so that ticket prices are kept in check." Pakhtoon said.

Pakhtoon added that the issue of unilateral fare hike of air tickets hurts the locals and tourists alike. | More on P6

### **Polls Apart**

he ongoing general elections, touted as the largest democratic exercise in the world, have gotten underway with the first phase held on April 19, witnessing millions of enthusiastic voters exercising their franchise. With Prime Minister Narendra Modi seeking a third term and a combined opposition trying hard to unseat him, the atmosphere has become charged with the competitive rhetoric and election promises.

The seven-phase election process, covering 102 constituencies across 21 states and territories, began with remarkable enthusiasm. The sheer scale of the exercise is staggering. With approximately 969 million registered voters, including 18 million first-time voters and 197 million individuals in their 20s, the magnitude of participation eclipses even the combined population of the 27 European Union member states.

The diversity of issues at play reflects the vibrancy of India's democratic process. While Prime Minister Modi's BJP emphasizes growth, welfare, and Hindu nationalism, the opposition alliance stresses affirmative action, welfare measures, and the preservation of democratic institutions. Besides, concerns ranging from unemployment and inflation to rural distress and minority rights are finding resonance. # Lessons from Taiwan for Kashmir

Are we far behind securing life from earthquake hazards?

major earthquake of magnitude 7.4 struck the eastern parts of Taiwan on April 2nd and caused less than 100 casualties. In contrast, the magnitude 7.6 earthquakes of 2005 in Muzaffarabad, Pakistan, caused more than 80,000 deaths, indicating that Taiwan was well prepared and Pakistan was not. Since the devastating earthquake of 2005, urbanization and population growth have increased, particularly near vulnerable zones such as unstable mountainous slopes, riverbeds, and other water bodies

Taiwan offers many lessons and opportunities for Kashmir. It has a similar tectonic setting, with a prominently developed mounland, etc. All these nations started a campaign long ago to secure life from earthquakes and related hazards by following strict building codes, which have minimised losses and damages during major earthquakes, which we have observed over the decades of their scientific and engineering progress. That campaign has yet to start in Kashmir. Delaying tactics are extremely dangerous and paint a grim picture of the region during an impending quake of magnitude seven and above.

I have been writing articles on earthquake hazards for more than a decade now, as many other scientists and researchers do, and most of it is published by Kashmir Observer, which has taken a leadis a huge problem, and the current norm ought to be replaced by professional engineering design and construction.

The government must adopt a resolution to carefully monitor the competence of engineering design and construction patterns to allow systematic replacement procedures for the greater good. The recently concluded 6th World Congress on Disaster Management (WCDM) in Dehradun also recognized the need to change the existing practices for good. The world's scientific community and people from diverse backgrounds emphasized the need to reevaluate the existing norms in preparation for a better future to effectively combat the risks posed

The exact timing is impossible because available knowledge and technological advancement do not allow that. 

# Are Tomorrow's Engineers Ready To Face AI's Ethical Challenges?

chatbot turns hostile. A test version of a Roomba **\**vacuum collects images of users in private situations. A Black woman is falsely identified as a suspect on the basis of facial recognition software, which tends to be less accurate at identifying women and people of color.

These incidents are not just glitches, but examples of more fundamental problems. As artificial intelligence and machine learning tools become more integrated into daily life, ethical considerations are growing, from privacy issues and race and gender biases in coding to the spread of misinformation.

The general public depends on software engineers and computer scientists to ensure these technologies are created in a safe and ethical manner. As a sociologist and doctoral candidate interested in science, technology, engineering and math education, we are currently researching how engineers in many different fields learn and understand their responsibilities to the

Yet our recent research, as well as that of other scholars, points to a troubling reality: The next generation of engineers often seem unprepared to grapple with the social implications of their work. What's more, some appear apathetic about the moral dilemmas their careers may bring - just as advances in AI intensify such dilemmas.

Aware, but unprepared As part of our ongoing re-

search, we interviewed more than 60 electrical engineering and computer science masters students at a top engineering program in the United States. We asked students about their experiences with ethical challenges in engineering, their knowledge of ethical dilemmas in the field and how they would respond to scenarios in the future

First, the good news: Most students recognized potential dangers of AI and expressed concern about personal privacy and the potential to cause harm - like how race and gender biases can be written into algorithms, intentionally or unintentionally.

One student, for example, expressed dismay at the environmental impact of AI, saying AI companies are using "more and more greenhouse power, [for] minimal benefits." Others discussed concerns about where and how AIs are being applied, including for military technologv and to generate falsified information and images.

When asked, however, "Do you feel equipped to respond in concerning or unethical situations?" students often said no.

"Flat out no. ... It is kind of scary," one student replied. "Do YOU know who I'm supposed to go to?"

Another was troubled by the lack of training: "I [would be] dealing with that with no experience. ... Who knows how I'll react."

Other researchers have similarly found that many engineering students do not feel satisfied with the ethics training they do receive. Common training usually emphasizes professional codes of conduct, rather than the complex socio-technical factors underlying ethical decision-making. Research suggests that even when presented with particular scenarios or case studies, engineering students often struggle to recognize ethical

grams are required to "include topics related to professional and ethical responsibilities" in some capacity.

Yet ethics training is rarely emphasized in the formal curricula. A study assessing undergraduate STEM curricula in

the U.S. found that coverage of ethical issues varied greatly in terms of content, amount and how seriously it is presented. Additionally, an analysis of academic literature about engineering education found that ethics is often considered nonessential training.

Many engineering faculty express dissatisfaction with students' understanding, but report feeling pressure from engineering colleagues and students themselves to prioritize technical skills in their limited class time.

Researchers in one 2018 study interviewed over 50 engineering faculty and documented hesitancy - and sometimes even outright resistance - toward incorporating public welfare issues into their engineering classes. More than a quarter of professors they interviewed saw ethics and societal impacts as outside "real" engineering work.

About a third of students we interviewed in our ongoing research project share this seeming apathy toward ethics training, referring to ethics classes as "just a box to check off."

"If I'm paying money to attend ethics class as an engineer, I'm going to be furious,"

These attitudes sometimes extend to how students view engineers' role in society. One interviewee in our current study, for example, said that an engineer's "responsibility is just to create that thing, design that thing and ... tell people how to use it. [Misusage]

issues are not their concern.' One of us, Erin Cech, followed a cohort of 326 engineering students from four U.S. colleges. This research, published in 2014, suggested that engineers actually became less concerned over the course of their degree about their ethical responsibilities and understanding the public consequences of technology. Following them after they left college, we found that their concerns regarding ethics did not rebound once these new graduates entered the work-

force.

When engineers do receive ethics training as part of their degree, it seems to work.

Along with engineering professor Cynthia Finelli, we conducted a survey of over 500 employed engineers. Engineers who received formal ethics and public welfare training in school are more likely to understand their responsibility to the public in their professional roles, and recognize the need for collective problem solving. Compared to engineers who did not receive training, they were 30% more likely to have noticed an ethical issue in their workplace and 52% more likely to have taken action.

Over a quarter of these practicing engineers reported encountering a concerning ethical situation at work. Yet approximately one-third said they have never received training in public welfare - not during their education, and not during their career.

This gap in ethics education raises serious questions about how well-prepared the next generation of engineers will be to navigate the complex ethical landscape of their field, especially when it comes to AI.

To be sure, the burden of watching out for public welfare is not shouldered by engineers, designers and programmers alone. Companies and legislators share the responsibility.

But the people who are designing, testing and finetuning this technology are the public's first line of defense. We believe educational programs owe it to them - and the rest of us - to take this training seriously.

"It is not only tourists who are troubled by the rising airfares. The students studying Kashmir valley and those going out of Kashmir valley for medical emergencies also suffer because of the rising airfares."

Rauf Tramboo, President of the Travel Agents Association of Kashmir (TAAK) voiced similar views saying the issue of rising airfares is a burning issue which affects the Kashmir tourism Industry and expensive family packages can discourage tourists from travelling to Kashmir.

"Unlike foreign tourists who mostly travel as couples, Indian tourists travel with all of their families and most of them cannot afford expensive packages to Kashmir which can hold them back from visiting Kashmir," Tramboo said.

"We have been raising the issue from the last many years and till now all our pleas have been falling on deaf ears. I hope authorities look into the matter," he added.

He further said that compared to Dubai, Hong Kong, and Singapore, Kashmir has become a costly choice for Indian tourists. It is time for the government to step in and to regulate airfares akin to major cities like Delhi, Mumbai, Bengaluru, Kolkata, and "Implementing a mech. to cap prices during peak demand is essential for Kashmir's tourism sustainability."

Notably, in March 2023, a parliamentary panel urged the civil aviation ministry to establish price limits for airfares, preventing airlines from using predatory pricing strategies under the guise of a free-market economy.

The panel emphasized the need to strike a balance between the commercial interests of private airlines and the welfare of passengers. They highlighted the importance of enabling the growth of private airlines while ensuring passengers are not exploited in the name of commercialization.

However, the government made it clear that they aren't in favor of interfering in a free-market economy by putting caps on airfares.


# GMC Jammu and Srinagar Gears Up for Robotic Surgery

**DODA:** As the polling for the first phase of General Election on Udhampur Parliamentary Constituency was held successfully and peacefully, it brought misery to two families in Doda district as one official died and another suffered injuries.

A clerk in Project Office (PO) ICDS in Bhagwah Tehsil of district Doda Ghulam Qadir died after a cardiac arrest whereas another Teacher in school education department Firdous Ahmed Gattu suffered two fractures on his ankle.

According to the news agency, Ghulam Qadir died on Saturday morning after he got exemption from deputy commissioner Doda from election duty a day prior to polling whereas Gattu slipped from a hilltop while returning from a polling station in Gundoh area cial informed. of the district.

office (DEO) Doda told KNO that on April 19 evening his pain in-Qadir was deputed to election duty to 51 Assembly segment (Bhaderwah) and reached to the town on April 17. "Ghulam Qadir was kept in reserve list of the polling staff and was being



sent to polling station number 36 Bajja in 51 Assembly segment. After spending April 17 night with a friend in Bhaderwah, he felt some pain in the leg and was not able to walk properly," the official said.

'Meanwhile District Electoral Officer (DEO) Doda Harvinder Singh visited Bhaderwah and Qadir asked for exemption on the basis of his health condition. The DEO immediately exempted him from the duty and appointed some other person on his place," the offi-

Qadir reached home at Bhagwah on April 18 evening ar creased and was shifted to the associated hospital of Government Medical College (GMC) Doda where he suffered a massive cardiac arrest on April 20 morning and breathed his last.

On the other hand, Firdous Ahmed Gattu, a resident of Doda town, was part of a polling party deputed to Khatasoo polling station (89) on a hilltop in Gundoh area of 51 Assembly segment. "It was raining heavily throughout the day and in the evening when the polling party was returning. The polling party had to walk several kilometers to reach the nearest road and board the vehicles to return to Bhaderwah. While returning, Gattu slipped and fell down resulting in two fractures near his ankle and he was helped by security forces and other members of the polling party towards the vehicle and from where he was shifted to associated hospital GMC Doda in an ambulance," a relative of Gattu told KNO.

He has been now taken to Amritsar in neighbouring state of Punjab for the treatment where he has to be operated by the doctors.

An order issued by Sanjeev Verma, Commissioner Secretary to the Government, reads that "With a view to streamline the Human Resource Management System across various departments of Jammu and Kashmir, detailed instructions regarding up dation of service details on JKHRMS by the employees and their subsequent verification by concerned DDOs were 35-JK(GAD) of 2022 dated 12.10.2022 read with Circular No. 40 dated 28.10.2022. Pursuant to these instructions respect of those employees, who did not register themselves on the JKHRMS system due to non-availability

of initial appointment order." The matter regarding nondisbursement of salaries in respect of those employees in whose case the initial appointment order was not traceable/ missing, has been thoroughly

examined in the General Administration Department. After consideration of the matter, it is enjoined upon all the Administrative Departments to release the salary of the officials, for the present, in whose cases the first initial appointment orders are not available, after verification by the concerned HoD in every single case, it reads.

However, it shall be incumbent upon the concerned HoD

to place on record within a period of next 03 months. The Select list issued by the J&K Service Selection Board or J&K Public Service Commission which contains the name of the official as having been duly selected, it further reads. The copy of the advertise-

# Players Voice Concerns Over 'Impact Player' Rule, While Coaches Offer Differing Perspectives

**NEW DELHI:** Axar Patel believes that his batting position has been affected by 'Impact Player' rule while Mukesh Kumar wants it abolished if there isn't some meaningful alternate help for the bowlers but Sourav Ganguly thinks that in a 12-a-side game, only the best all-rounders will survive.

With Rohit Sharma making it clear that he is not a big fan of 'Impact Player' which is a glorified 12-a-side contests which hampers the growth of Indian all-rounders, more and more top national team players are expressing their displeasure.

The 'Impact Player' rule, introduced in 2023, allows all IPL teams to substitute a player batter or bowler -- during their respective innings as per the demands of the match, but it has raised eyebrows in the ongoing season.

Axar, who sees himself as an all-rounder admitted that because of the rule, his batting position has been affected.



"Whosoever is making the rules, they are thinking that everything will work as per batter's convenience. Obviously, it has been difficult (for the bowlers). According to me, it's difficult but obviously you will have the opportunity as well that you can perform well in that situation, if you have the skills then how you can use them," Axar told PTI during a select media interaction.

"Because of the Impact sub rule, everyone gets one more batsman so they think that they will use the batsman in case, the batting unit doesn't go well. And whosoever comes to play, they don't take much time and starts from the first ball because they know that they have a player in seventh or eighth place," he said.

"That is why I am not a big fan of impact player rule, because as an all-rounder I know that they will either take a proper batsman or a bowler, not an all-rounder."

Axar said he had already aired his views with DC skipper

Rishabh Pant on the rule.

"We (Rishabh), Dada (Sourav Ganguly) and Ricky (Ponting) have talked about it. I can play early, but if you want to give the chance to young player, then you have to give them their position, but because of that (Impact Sub rule) I have to come down the order."

Australia great David Warner feels the 'Impact Sub' rule has diminished the role of an allrounder to some extent from T20 cricket.

"Well, the game is evolving, right. So I think people are just trying different things. If you got 15-16 people on the bench, you know you want to maximise as much as you can. Is the game going to change a lot in the next 10 years? It probably will.

"I feel like it's taken the all round option out now. We are adapting as cricketers, so we're enjoying that and and it's also tactically when you're sitting on the bench, you know, if you're not scoring runs, then you can put that batsman in,"
