## Over 800 Govt Schools Report Zero Enrollment



#### Agencies

Srinagar: In Jammu and Kashmir, hundreds of government-run schools are with zero student enrolments. Besides, the majority of the institutions have less than 50 student enrolments.

Moreover, the official documents and latest figures state that more than 18 percent of government schools at elementary level here have an adverse Pupil Teacher Ratio (PTR).

The officials from Jammu and Kashmir in 2023 had said that the count of overall public schools had reduced by nearly 19 percent owing to the 'zero or low enrolment of students in government schools'.

However, the Ministry of Education (MoE) in the latest figures regarding the school size and single teacher schools in Jammu and Kashmir has said that, "Out of the total 23,173 schools in the UT, there are 848 schools with zero enrolment."

It also said, "16,179 schools are with less than 50 enrolments. Further, there are 2413 single teacher schools in the UT."

percent," it reads.

Pertinently, in 2023, it was reported that the count of overall public schools in Jammu and Kashmir have reduced by nearly 19 percent owing to the 'zero or low enrolment of students in government schools'.

The officials of the department had said that it had some government schools wherein the student enrolment was very low or even some with less than five. "We had merged them with the nearby government schools."

It also said that such schools were being reflected on UDISE as separate schools. "Earlier we used to have 23,117 government schools as per UDISE but in the updated database, we have only 18,820 schools," an official said.

The concerned official at that time had also said, "We had nearly 4300 government schools wherein the student enrolment was 1

### Girl's Death Due To Falling Tree In 2012

## HC Rejects Families Compensation Plea

Srinagar: The High Court of J&K and Ladakh dismissed the plea of a family from Pattan, Baramulla seeking Rs 30 lakh compensation along with 18% interest for the death of their 18-year-old daughter who died after a poplar tree fell on her during a wind-storm in 2012. The HC stated that the poplar trees growing on the roadside are not hazardous and the falling of the tree was due to an act of God (natural calamity) and not due to negligence on the part of the Public Works Department (PWD).

"The trees growing on roadside are not in 'non natural use



of the land or a hazardous activity' to attract the principle of strict liability," the High Court held.

In its plea, the family from Pattan in Baramulla district had submitted that their 18-year-old daughter was walking on the road on 20 March, 2012 when, due to heavy winds, a poplar tree fell on her and injured her critically along with some other

persons. She was shifted to hospital (SKIMS) by the relatives but succumbed to words three days later, they said.

They had submitted that the Public Works Department (PWD) failed in maintaining the trees, which were old and also in a half-broken condition. They claimed that due to "negligence and carelessness", the rule of "Strict Liability", which envisages that many activities which are hazardous and may constitute a constant danger to person and property of others may be allowed to be carried on but subject to the safety measures, is attracted.

The project, outlined in a status report submitted to the National Green Tribunal (NGT) by the Housing and

Urban Department of J&K, will be taken-up in a phased manner and is expected to be completed by 2025.

According to the report, the action plan for the implementation of sewage projects has been taken and the tenders will be floated on 30 April 2024.

However, the tribunal, in an order dated April 3, 2024 said, in that action plan, the capacity of STP, number of household connections to the STP and the


## Congress Cradled Art 370 Like A Baby For 70 Yrs: Shah

Maharashtra: In an unsparing attack on the Congress over its alleged handling of the Jammu and Kashmir issue and not settling it decisively during its decades in power at the Centre, Union Home Minister Amit Shah on Tuesday said the grand old party held on to Article 370 and "cradled" it like a baby on a mother's lap till the Centre, under the leadership of Prime Minister Narendra Modi, revoked it on August 5, 2019.

Addressing an election rally at Akola in Maharashtra, Shah also came down heavily on Congress national president Mallikarjun Kharge for questioning PM Modi's invocation of the scrapping of Article 370 from the erstwhile state during a rally in Rajasthan. "Kharge-ji questioned what the people of Maharashtra and Rajasthan have to do with Kashmir. Kharge Saheb, perhaps, does not know that every youth of Akola cares as much about Jammu and Kashmir as the people in the Union Territory themselves, and are even prepared to lay down their lives for it.

## Mir Behri Residents Demand Bridge Repairs After Gandbal Tragedy

Srinagar: In the aftermath of a boat capsizing incident at Gandbal, Srinagar, which claimed the lives of six people with three still missing, the residents of Mir Behri Dal find themselves engulfed in frustration and anger over the lack of maintenance of bridges.

The locals residing in the interiors of Saida Kadal said that the tragedy has reignited concerns about the precarious state of bridges in the area, prompting locals to demand immediate action from authorities.

A video shared on social media by Abbas Kashmiri, a social media user, revealed the alarming condition of a bridge in Mir Behri Dal. The footage depicted disjointed wooden planks, highlighting the perilous state of infrastructure in the locality.

"We urge the government to get these bridges repaired so that Gandbal like incidents

do not take place," Abbas said. Abbas emphasized on the urgency of preventing a recurrence of the Gandbal tragedy by addressing the dilapidated condition of bridges across the region.

Imran Renu, a local of Runi Mohalla, Mir Behri said the people are deeply troubled by the conditions of wooden bridges. He voiced concerns about the frequent accidents involving vehicles and pedestrians due to the unsafe bridges.

"There have been instances where E-Rickshaws and two-wheelers had plunged into the lake, fortunately people survived but people won't be lucky all the time," Imran said.

He added that despite repeated pleas from local residents and advocacy efforts, their grievances seem to have fallen on deaf ears.

"There is a dire need for immediate intervention to repair and reinforce the wooden bridges for the safety and well-being of the community," he said.

## Cyber Police Unearth Major Mule Account Racket; Case registered

Srinagar: The Cyber Police Station Kashmir Zone, Srinagar Tuesday claimed to have investigated a new modus operandi, where individuals are involved in setting up mule bank accounts.

These accounts serve as channels for the receipt and transfer of unlawfully obtained funds on behalf of cyber fraudsters, a statement reads. Such activities are pivotal to organized fraud operations targeting vulnerable segments of the society, including homemakers, the economically disadvantaged, auto-rickshaw drivers, laborers, and local vendors, it said.

"The funds, often acquired through online fraudulent means such as investment scams, online gaming apps and phishing or identity theft are discreetly shuffled between multiple accounts to evade detection. Perpetrators, operating from outside the UT of Jammu and Kashmir, lured potential victims through emails, chat rooms or social media, offering inducements in exchange for renting out their bank accounts. Once trapped, victims unknowingly help in illegal transactions through mule bank accounts, sending the money to the criminal's main accounts," it said.

Acting upon the matter, Cyber Police Station Kashmir Zone, Srinagar, has filed a case under FIR number 10/2024 under relevant legal provisions and initiated a comprehensive investigation.

"Subsequent inquiries have revealed numerous mule accounts operating in various Districts of Kashmir Zone, with transactions totaling crores of rupees. Four individuals from Srinagar city have been identified in orchestrating and managing these mule bank accounts, as well as enticing unsuspecting individuals to participate in these illegal activities," the

statement added.

Consequently, these four accused persons identified as Sajad Ahmad Rah son of Mohammad Maqbool Rah residing at Chinar Colony Mehjoor Nagar, Srinagar, Tawqair Ahmad Bhat son of Tariq Ahmad Bhat residing at Banpora Nowgam, Srinagar, Ubaid Ahmad Rah son of Mohammad Ayoub Rah residing at Hamdaniya Colony Bemina, Srinagar and Amir Rah son of Mohammad Maqbool Rah residing at Chinar Colony Mehjoor Nagar, Srinagar have been arrested, the statement reads.

Meanwhile, Cyber Police Kashmir urged the public to remain vigilant and guard against falling victim to such fraudulent schemes. Fraudsters often exploit unsuspecting individuals through personal or social media platforms, dangling promises of rewards, incentives, or 'work from home' opportunities. Participation in money mule activities is unlawful and carries severe legal ramifications, including imprisonment. Should you suspect being victimized by money laundering or inadvertently engaging as a money mule, prompt reporting to the authorities is imperative, the statement said—(KNO)

## Sayed, Mangat Clash At Cabinet Meeting

JAMMU - Deputy Chief Minister Mangat Ram Sharma snubbed Chief Minister Mufti Mohammed Sayeed at a cabinet meeting here Tuesday, telling him he was not a "headmaster" who could dictate terms to his seniors in politics.

Sharma walked out of the cabinet meeting in a huff, the second time he has done so in the past 16 months. He later flew to New Delhi, telling reporters he would apprise the Congress party leadership about Sayeed's "dictatorial behaviour".

Cabinet meeting was later postponed to April 22. On Jan 24, almost in similar circumstances, Sharma walked out of a cabinet meeting on being overruled on the appointment of Kashmir's senior most Indian Administrative Service officer KB. Pillai as chairman of the State Public Service Commission.

Ultimately, Sharma had to relent and reconcile to the choice of the chief minister.

Tuesday's walkout followed a verbal duel between the two over the use of "improper" language by Sharma while conversing with Chief Secretary Sudhir S Belloria.

The meeting was to discuss a major administrative and police reshuffle in the state.

Sayed termed Sharma's conversation with the chief secretary as 'improper.'

"You should not use such language with the chief secretary," Sayeed told Sharma in the presence of the entire cabinet and some top officials.

Sharma allegedly told Belloria 'kar do Ji' (do it) instead of 'kar deejie' while marking the agenda for the day.

Sayed corrected him in front of the cabinet after which the deputy chief minister replied that he did not have to be taught how to deal with the bureaucracy.

Sharma told Sayeed: "I am senior to you in politics by 11 years. You cannot treat me like a headmaster, and I am leaving."

Sharma then burst out of the meeting Sayeed, the sources said, rubbed salt into Sharma's wounds by saying: "If you want to go, no one is going to stop you." He suggested that Congress President Sonia Gandhi should be informed about this incident. Chief Minister was quoted as saying: "How can the govt run amid this indiscipline?"

## Hope for Assembly Polls

The assurance by the union minister Jitendra Singh that the Assembly elections in Jammu and Kashmir will be held soon has generated a fresh hope about the restoration of democratic process in the union territory. Singh's assurance follows Prime Minister Narendra Modi's similar promise during an election speech in Udhampur last week. The prime minister reiterated the commitment of his government to reinstate the statehood of Jammu and Kashmir, thereby allowing its people to once again have a more direct say in the governance.


Ever since the abrogation of Article 370 in August 2019, Jammu and Kashmir has been under direct central rule. While this move was aimed at integrating the region more closely with the rest of the country, the absence of a democratically elected government has been a concern. Should the promise of the early Assembly elections be kept, there is now hope for the people of Jammu and Kashmir to choose their representatives and have a government that truly reflects their aspirations.

Jitendra Singh's said that normalcy has been restored in the union territory, an assertion that should naturally lead to early holding of Assembly polls. A local government and a restored statehood will only strengthen the process of normalization. The people of Jammu and Kashmir have waited long for the return of normalcy and democratic governance. It is now incumbent upon the central government to fulfill its promise and ensure that the aspirations of the people of Jammu and Kashmir are realized at the earliest.

J&K has not had an elected government since June 2018 when Governor's rule was imposed after the PDP-led coalition government lost its majority following the withdrawal of support by the BJP. The last five years have witnessed a drastic political makeover of the state-turned-union territory, so much so that in many aspects, the current J&K bears little resemblance to what it was pre-August 2019.

When in December last year, the Supreme Court urged the Election Commission to facilitate assembly polls in J&K by September 30, 2024, it stressed the constitutional imperative to uphold the democratic rights of the people in the region. However, the union government is yet to show any urgency on this score. And it is time the centre does.

The prolonged delay in Assembly elections prolongs the absence of a locally accountable government, which does impact the implementation of policies tailored to address the unique challenges faced by Jammu and Kashmir. Like the rest of the country, the people of Jammu and Kashmir deserve a democratic government for voicing their grievances and aspirations through elected representatives who can engage in legislative processes and policymaking.



# Election and Advocacy

Maximum participation from J&K in the upcoming elections holds the potential to rejuvenate faith in the fundamental institutions of the country

The commencement of India's monumental national elections, regarded as the most significant in decades, with the power to influence the country's future trajectory are on. With approximately 968 million eligible voters, surpassing the combined populations of the United States, the European Union, and Russia, these elections stand as the largest in the world.

Of particular importance is the context surrounding Kashmir, as India's Prime Minister, Narendra Modi, has hinted at the potential restoration of statehood to Jammu and Kashmir.

During a rally in Udhampur, Jammu on April 12, Friday, Modi expressed that the time is approaching when Assembly elections will be conducted in Jammu and Kashmir. He assured that Jammu and Kashmir will regain its statehood status, allowing residents to communicate their aspirations to their elected representatives.

This region was downgraded to the status of a union territory following the revocation of Article 370 and 35A of the Indian Constitution on August 5, 2019. Modi's announcement adds a layer of significance to these elections, as they may impact the ongoing political dynamics and future developments in the region.

The instability of sorts in Kashmir has been manipulated by vested interests on multiple occasions, who have incited discord among its peace-loving in-

habitants. This discord escalated into an armed rebellion in 1989 against India's control, notwithstanding at least three attempts by Pakistan to seize the region.

This undoubtedly led to a monumental tragedy, including the displacement of a community that has been deeply ingrained in Kashmir for generations. Without delving into specific statistics, both communities endured significant suffering, leading to a complex situation that plunged the former princely state into a seemingly insurmountable abyss.

While the wounds of these tragedies may remain etched in the Kashmiri psyche for a long time, dwelling on the past, harboring grievances against the Indian state, or waiting for a miraculous solution are not aligned with the current demands of the situation.

Amidst the height of the unrest, certain political parties opted to retreat from the forefront rather than confronting the challenges head-on. This made room for less desirable parties and groups to seize control of the narrative. Their lack of political foresight only exacerbated the situation, prolonging the conflict and adding to the burdens faced by the common people. By making promises they couldn't fulfill and advocating for poll boycotts, they inadvertently instilled a sense of apathy among the masses, where participation or abstention from voting held equal weight.

However, this emotional stance, unjustifiable by any measure, has had significant consequences.

# How to Handle Difficult People Like a Stoic

On a recent road trip with my wife and kids, I found myself being tailgated by an apparently angry and impatient driver. I was going a few miles per hour over the speed limit as I passed a semi on a long downhill stretch through the mountains; when I pulled into the right lane, the driver accelerated past me, blowing his horn for about 10 seconds.

I felt my sympathetic nervous system turn on, and resisted the urge to give him the finger or to passive-aggressively honk a "friendly" beep-beep in return. For several minutes afterward, I was silently seething. It felt like he had gotten away with something, as if I had lost and he had won. Each time I replayed the prolonged honk I felt angry and humiliated. Part of me really wanted to chase down his car and pay him back somehow, but I knew nothing good would come of it.

You no doubt have had similar encounters with obnoxious or pushy people, whether on the road or elsewhere. These episodes are a perfect opportunity to practice the principles of Stoicism.

### 1. Judgments, Not Events, Disturb People

As I ruminated on what had

happened, I had to wonder—what had that pushy driver actually done to me? The idea that he had "humiliated" me or "won" was based on multiple layers of interpretation. The facts were much simpler:

- A driver wanted his car to go faster than mine was going.
- He drove close to my bumper when my car was blocking his way, apparently angry and annoyed.
- As his car passed mine, he pressed on his horn for several seconds before speeding away.


The powerlessness and sense of victimhood that I felt were not part of the events themselves. Nothing says that honking without retribution equals "winning."

As the Stoic philosopher Epictetus wrote in *Enchiridion* nearly two millennia ago:

"It is not events that disturb people, it is their judgments concerning them."

A few pages later he says: "Another person will not hurt you without your cooperation; you are hurt the moment you believe yourself to be."

It wasn't the driver's actions that upset me, it was the meaning I gave to them. When someone does something that offends you, ask yourself what is fact and what is interpretation.



### 2. Don't Give Your Peace of Mind to Others

The judgments you make drive your emotional reactions. If you want to "win" against others, guard your equanimity. The only way I would lose to that honking driver was by losing my peace of mind.

Why give difficult people power over how you feel and what you do? Your emotional equilibrium is not to be entrusted to the actions of others. You can let people be rude or unreasonable, without acting as if your only recourse is to get upset and respond in kind.

Remind yourself that no one else is responsible for your emotions. "So when we are frustrated, angry, or unhappy," wrote Epictetus, "never hold anyone except ourselves—that is, our judgments—accountable." When you do, you'll discover true freedom in how you choose to respond.

### 3. Focus on What You Can Control

The Stoics recognized that peace of mind is found by focusing on what you actually are responsible for. Epictetus advised asking yourself:

"Is this something that is, or is not, in my control? And if it's not one of the things that you control, be ready with the

reaction, 'Then it's none of my concern.'"

That means the things other people think, feel, and do are excluded from your concerns. It doesn't mean you're indifferent to other people, but if you make their responsibilities your own, you'll multiply your misery.

Unfortunately, we often practice anti-Stoicism. We give most of our energy to what others are doing, stewing in our outrage ("They said what?!") and trying hard to force them to change. In the process, we neglect the responsibility we have for ourselves, as if other people are making us behave in a particular way.

If you wish to suffer less, practice treating irritating people like a Stoic would. Recognize that the person is irritating only to the extent that you allow them to be. "Irritating" is a judgment, and your judgments belong to you. Own your reactions. No one can force you to feel or act in ways that you're not willing to.

The battle that really matters is internal. Make a determination to wrestle only with the things you're free to control, and let go of the rest.

Anantnag-Rajouri constituency. While rival National Conference has focused on holding mega election rallies in the constituency, Mufti who rose to prominence in the mid-1990s by visiting victims of conflict in the deepest of militancy-infested areas of Kashmir has fallen back on old tactics. Her campaign so far has mainly been to hold road shows in rural areas of the constituency which had whole-heartedly supported the PDP till the 2019 Lok Sabha elections.

Hugging the women folk and exchanging pleasantries with the men at every stop in the roadshow, Mufti makes it a point to highlight the absence of support for her during the last election. "I know you did not vote against me in the last election, you stayed away, but this time it is not about bijli, sadak or paani. This time it is about our dignity, our identity and our resources which are under threat. If you want these issues to be raised in the highest forum of the country, you will have to support the PDP," Mufti tells the people.

She learned the art of politics from her father Mufti Mohammad Sayeed, one of the most shrewd and astute politicians to have come out of Jammu and Kashmir. And it seems she wants to change an adverse situation to her advantage. The PDP president carries a bag of candies and toffees in her car and gives away to every child she sees at the stops over. Perhaps, it is an atonement for her. "Toffee, milk" remarks she made as the chief minister when defending the death of young children in security forces action during the 2016 summer agitation in the valley.

Mehbooba Mufti, who is part of the INDIA bloc but decided to contest the elections against the National Conference -- a fellow member of the anti-BJP alliance -- has been able to generate some sympathy among the electorate. "She is fighting a lonely battle. Every other candidate has support from one national party or the other but it is anybody's game. Anyone can win as this constituency formed after delimitation is so unnatural," Rafiq Ahmad, a resident of Panchpora village, told PTI.

Nazir Ahmad, a resident of Marhama village, takes the conspiracy theory a notch higher. Pulling out a smartphone, he shows a photograph of National Conference leader Omar Abdullah and BJP leader Ravindra Raina, taken at some public function, as proof that the two parties have a covert understanding on the Anantnag-Rajouri seat.

"The BJP has not fielded its candidate and the Congress is supporting the National Conference openly. It's all against one person that is the PDP leader (Mehbooba Mufti)," Ahmad added.

How does the PDP president feel about being on her own, especially after the 2018 exodus of leaders from her party, including former ministers and legislators.

"I am a daughter of Mufti Mohammad Sayeed and I have faith in my people. The good thing that happened was that my workers did not leave me when those people (leaders) left. The majority of my workers remained with me and that gave me new energy, enthusiasm. New people have traction with the PDP. They do not join other parties, they come to us and that has infused a new lease of life into our party," she said.

She said that when her father started his political career, he also faced a lot of conspiracies. "There was a social boycott against him. He was called a 'gandi naali ka keeda'. There were many conspiracies against him, he was accused of being anti-Islam, anti-Muslim and anti-Kashmir. But he survived and I am his daughter," she added.

Mufti said that no other party in Jammu and Kashmir has been subjected to what her PDP was made to go through.

"The PDP and Mehbooba Mufti are on the target of the BJP. My party was broken, our leaders were snatched either through lure or blackmail. Then I was thrown out of (government) house in winter. Everyone (leader) has a house, I do not want to name them. I was summoned to the ED office, even my mother was. Our passports were not issued, even my mother's and daughter's, even my brother was summoned by the ED. Many of my workers from Bijbehara are in detention. Arrests are against the PDP only. Attempts are being made to snatch the

rest of the leaders from my party. The PDP is the only target, no other party is," she said.

The PDP president said that she was all for a united fight against the BJP and was prepared to concede all three valley seats to the National Conference.

"But the way Omar called a press conference and made the announcement there saying the PDP had vanished. That hurt my workers and sympathizers and that became a question of their prestige. I think the people have to decide who raised the issues of people, prisoners, oppressed ones in the last five years. The NC had three members in the Parliament, they have to see their performance. Do we have to repeat that or send those people who talk about the people of J-K?" she said. While there are 21 candidates in the fray for PDP President Mehbooba Mufti who is contesting from Anantnag-Rajouri seat.

news agency, Kashmir News Observer, Mufti's earnings have fluctuated over the years. In the financial year 2018-19, her total income amounted to Rs 8.63 lakh, which reduced to Rs 84.75 thousand in the subsequent financial year. However, in 2020-21, her earnings surged to Rs 19.98 lakh, followed by a decrease to Rs 12.44 lakh in 2021-22, and further down to Rs 9.85 lakh in 2022-23.

In terms of liquid assets, Mufti has declared possessing Rs 45 thousand in cash and has deposited Rs 23.74 lakh in three bank accounts. Additionally, she has disclosed holding an insurance policy worth Rs 11.94 lakh. Her movable property includes an SNK ISUZU bus valued at Rs 5 lakh, with no jewelry or precious items mentioned.

On the immovable property front, Mufti owns a residential house in Bijbehara, Anantnag district, with a current market value of Rs 35 lakh. Combining her movable and immovable assets, the former Chief Minister's total property amounts to Rs 75.69 lakh.

Mufti's primary source of income, as per her affidavit, is salary/pension. (KNO)

poison across the country, people should only look towards candidates of the INDIA bloc -- National Conference candidates on three seats of Kashmir and Congress candidates on two seats in Jammu."

The National Conference, People's Democratic Party (PDP) and the Congress are constituents of the opposition INDIA bloc. However, the PDP is contesting the Lok Sabha elections independently while the Congress and the National Conference have joined hands for the polls.

Abdullah further said, "The rest have connections with the BJP somewhere -- be it B-team or A-team who hold late-night meetings with (BJP leader) Tarun Chugh or the PDP. (BJP leader) Mushtaq Bukhari has openly announced to cast his vote in favour of (PDP chief) Mehbooba Mufti."

The National Conference vice-president said he understands the PDP chief will put pressure on the BJP to make Bukhari change his statement.

"I take it that Mehbooba Mufti will put pressure on the BJP to get Mushtaq Bukhari to change his statement but the cat is out of the bag now. After the A-team and the B-team, the PDP has now joined as the C-team of the BJP," Abdullah added.

Mehbooba joined the electoral fray from the Anantnag-Rajouri seat after the National Conference refused to accommodate the PDP chief, citing its victory from all three Lok Sabha constituencies in the Kashmir Valley in 2019.

Asked about the BJP not fielding incumbent Ladakh MP Jamyang Namgyal, Abdullah said it does not concern him.

"It is an internal matter of the BJP. I am only concerned that the Congress should field the right candidate from Ladakh as we are contesting there together. There should be no room for a BJP win there," he added.

Earlier, once the bullet-ridden body of Razaq reached his home, the pall of gloom descended in the area as everybody was heading towards his house to pay their respect to the departed soul. According to the locals, he was a kind hearted and helpful person who was always ahead of others in reaching out to the people whenever they were in need.

Locals said that terrorists had reached his home by enquiring from locals without ascertaining their identity. They were hiding in his house and once Razaq entered after completing prayers, he was fired upon by the terrorists and injured him critically. He was shifted to the nearby hospital where he was declared dead on arrival.

They believed that terrorists were probably after Razaq's brother Tahir Khurshid, who is working in the Territorial Army, but there was no confirmation from police and administration.

While Razaq succumbed to his injuries, Choudhary escaped unhurt, they said.

The police, army, and CRPF launched a cordon and search operation (CASO) soon after the incident and intensified the searches in the area with the support of sniffer dogs and aerial surveillance to track down the terrorists, they said.

According to the officials, Tahir could have been the target but his brother got shot.

Vehicles are being thoroughly checked, and people are being subjected to frisking at various checkpoints in the district, they added.

A criminal case has been registered in FIR under sections 302 (murder), 120A (conspiracy to commit an offence), 121B (waging war or attempting to wage war against the Government of India), 122 (collecting arms with the intention of waging war against Government of India), 458 (lurking house-trespass or house-breaking by night after preparation for hurt, assault, or wrongful restraint), the Arms Act, and sections of the Unlawful Activities (Prevention) Act (UAPA) at the Thanamandi Police Station, officials said.

Razaq's father, Mohammad Akbar was also killed by terrorists 19 years ago in the same village. Akbar worked in the Social Welfare Department, and

Razaq was given a job by the government on compassionate grounds in the same department, they said.

Meanwhile, the security forces busted a terrorist hideout in the village of Azmatnagar in Rajouri district last week. They recovered eight Improvised Explosive Devices (IEDs), two wireless sets, and some ammunition, officials said.

Rajouri and Poonch districts have witnessed targeted attacks by terrorists on the army and civilians in the past few years, they added.

fear and unrest. Pakistan-based operatives were allegedly handling the accused, the DGP said. "Acting swiftly in an intelligence-based operation, Counter Intelligence (of Punjab Police) #Jalandhar averts target killings planned by cross-border operatives. According to a Punjab Police statement, the arrested accused has been identified as Lovepreet Singh alias Picho of Udho Nangal village in Amritsar.

Police teams have also recovered one .30-bore automatic Chinese pistol along with a magazine and four live cartridges from his possession, it said.

The statement quoting DGP Yadav said that acting swiftly on intelligence inputs, Punjab police teams from Counter Intelligence, Jalandhar laid a special 'naka' (check barrier) in the area of Rama Mandi, Jalandhar, and arrested the accused after recovering the sophisticated automatic pistol from his possession.

Sharing more details, Senior Superintendent of Police, Counter Intelligence, Jalandhar, Navjot Singh Mahal said that the accused has received money in his bank account via Dubai and procured the pistol along with ammunition from Samba in J&K.

A case was registered on Monday under relevant sections of the IPC and under the Arms Act at State Special Operations Cell police station in Amritsar, he said, adding further investigations are going on.

## Congress Cradled

It was Modi-ji, who paved the way for making Kashmir an integral part of the country after making Article 370 history. The Congress, as we all know, kept cradling and safeguarding Article 370 for the last 70 years and it wasn't until you elected Modi-ji as PM for the second time, that it was consigned to history," Shah said, invoking the landmark scrapping of the Article, as part of which certain constitutional safeguards and privileges were vested in the erstwhile state.

In a veiled counter to Opposition claims that the BJP-led NDA will bring changes to the Constitution if elected for a third time by a brute majority, Shah said despite securing a decisive mandate in the 2019 Lok Sabha elections, the Centre used it to remove Article 370 from the erstwhile Jammu and Kashmir state as opposed to ring-fencing changes to the country's salient statute book.

Through the passage of the Jammu and Kashmir Reorganisation Act, 2019 in Parliament, Article 370, which gave special constitutional privileges to the erstwhile state, ceased to exist.

The state of Jammu and Kashmir was split and reorganised into two UTs--Jammu and Kashmir and Ladakh in August 2019.

Also taking aim at the Congress over its approach to dealing with external security threats while in power, the Union Home Minister said the grand old party chose not to respond to misadventures from across the border, in Pakistan, for the sake of safeguarding its 'vote bank'.

"Under the Sonia-Manmohan Singh government, Pakistan would carry out

attacks against us every day and they remained unmoved for the sake of advancing their vote bank politics. When Pulwama and Uri were attacked, after the BJP came to power, we responded in 10 days. Under the leadership of PM Modi, we crossed over into Pakistan and launched surgical and air strikes on terror launch pads and hideouts in Pakistan. Modi-ji also eliminated the threat of Naxalism from Maharashtra," he said.

He said while India ranked 11th among major economies under the Congress, PM Modi made it the fifth-largest major economy. "If you bring him back as PM for a third time, he will make us the third-biggest global economy," Shah added.

Eight Lok Sabha constituencies of Maharashtra will go to polls in the second phase on April 26. In the first phase on April 19, polling was held in Ramtek, Nagpur, Bhandara - Gondiya, Gadchiroli - Chimur, and Chandrapur.

In the second phase, voting will be held in Buldhana, Akola, Amravati, Wardha, Yavatmal-Washim, Hingoli, Nanded, and Parbhani.

The NDA-BJP and the undivided Shiv Sena-won 7 of these 8 seats in 2019. The BJP bagged Akola, Wardha, and Nanded, while the Sena won Buldhana, Yavatmal-Washim, Hingoli, and Parbhani.

Navneet Rana, who is now with the BJP, won Amravati in 2019 as an Independent and is seeking a fresh term from the seat this year on a safe ticket. (ANI)

contention was that the poplar trees at the roadside were being managed in a negligent manner by PWD as "there was no pruning and removal of the dry, dead and half broken trees which resulted in the accident."

On the other hand, the authorities said that on the fateful day, there was a huge storm which resulted in uprooting and breaking of many trees throughout the Kashmir Valley, therefore, the damage caused was due to natural calamity i.e., an act of God.

The authorities said that trees were on the road side and did not fall within the dangerous activity or non-natural use of land and as such the liability on them in this regard was very limited.

According to the authorities, the sudden act of nature which could not be foreseen had resulted in falling of the trees which would not make them liable to pay compensation

"The trees which were growing on the side of the road are not in non natural use of the land or an hazardous activity to attract the principle of strict liability," a bench of Justice Sindhu Sharma said, adding, "The wind storm was an act of nature and negligence is not attributable to the respondents (authorities). This apart, the court said, the issue whether there was wind storm on the fateful day and same resulted in falling of the tree on the girl and whether the authorities were negligent in maintaining these trees and had not removed the dead and half broken tree, "are all questions of fact which cannot be considered by this Court in these proceedings." Subsequently, the court dismissed the petition.

connection status have not been disclosed.

"In column no. 5 of the tabulated information, the date of AAA (end date) is disclosed as 15.03.2024, but on enquiry, Mr. Narinder Khakuria, Special Secretary, Housing & UD Deptt., appearing virtually, has admitted that the said end date has not been adhered to," the order reads.

NGT has also come down heavily on the Municipal Corporation of Srinagar, Municipal Committee Budgam and Municipal Committee Chadoora for not taking serious efforts in restoring the river.

Earlier, in 2022, the Principal Bench of National Green Tribunal imposed a penalty of Rs 35 Crore on the Jammu & Kashmir administration for failing to prevent the discharge of untreated

sewage into the Doodh Ganga, and Mamath Kull (stream) in Srinagar and Budgam districts.

The report that was submitted by the Housing and Urban Department of J&K states that the legacy waste existed at Mamath Kull under Municipal Council, Budgam has been lifted and processed at Tral under the on-going biomining work contract. However, the NGT raised concerns about a separate Rs 32.94 lakh DPR created for an unclear purpose after claiming waste removal completion.

The NGT order, a copy of which lies with Kashmir Observer, reads, "We also find that along with the report are the minutes of meeting held on 17.02.2024 regarding compliance of direction issued on 07.02.2024 and the said minutes of meeting records the stand of representative of PCB in respect of pollution of river as under:

The representative of Pollution Control Board has expressed that the 2 rivers are still polluted and measures need to be taken to arrest the drainage of garbage and untreated sewage in Doodh Ganga and Mamath Kull due to which water quality is deteriorating day by day."

Dr Raja Muzaffar Bhat, RTI activist had filed an objection to the report along with the proof to the government's report on February 2, 2024 stating that the waste is still dumped on the bank of rivers and there is no progress at the end of the authorities.

Dr Bhat pointed out that sewage is being discharged in the river and the same polluted water from the river is pumped for drinking purposes which is creating health hazards.

The NGT order acknowledges the lack of significant progress despite previous directives and the seriousness of the situation. It warns of imposing environmental compensation on violators for breaching environmental norms.

"The above sequence of events clearly revealed that though substantial time has lapsed after passing of initial order by the Tribunal and bringing it to the notice of local authorities, the gravity of the situation, yet no serious efforts have been made by the local bodies," the order reads, adding, "Hence, the only option left is to impose Environmental Compensation (EC) on the violators for continuous violation of environmental norms."

The matter has been adjourned to the next date giving opportunity to the government to argue on the issue of imposition of EC on the next date of hearing.

The NGT order said the government may file their response in this regard at least one week before the next date of hearing.

Notably, Dr. Raja Muzaffar Bhat in his application has submitted that a large amount of discharge of sewage and solid waste is being dumped in rivers Doodh Ganga and Mamath Kull.

He further stated that no STPs has been established by the Srinagar Municipal Corporation or any other Government Body in the entire stretch around river Doodh Ganga as a result of which all the untreated sewage from residential, commercial establishments, shopping malls, butcher houses, poultry shops, laboratories, diagnostic centres and domestic sewage are directly discharged into the river without any scientific treatment.

He submitted that a large number of Municipal Solid Wastes are unscientifically dumped on the banks of river Doodh Ganga and during the present rainy season there is a grave danger of the entire waste to be flowing into the river which is a tributary to River Jhelum.

"SMC is continuously discharging untreated sewage in river Doodh Ganga from 13 dewatering pumping stations installed at various locations on the banks of river Doodh Ganga," Bhat had submitted.

"There is a grave danger of the entire waste flowing into the stream which eventually meets River Jhelum, thereby causing major environmental degradation."

The Tribunal had passed an order on August 18, 2021, taking note of grievance, and repeatedly took up the matter, but "till now, no improvement at the ground level has been noticed," NGT said in the order.

# Army Commander Reviews Counter-Terror Training Of J&K Police

Another PSI said that what we have learned here has really boosted our confidence, especially at the beginning of our careers. "Besides this, the joint training with the Army will surely help us work in synergy with the Army and coordinate better to help bring peace in Jammu and Kashmir," he added.

# RTI Reveals Increase In Criminal Activities In J&K In Last 5 Years

**SRINAGAR:** There has been a surge in various criminal activities, including cases of police corruption, crimes against women, suicides and cyber fraud, data reveals.

According to the data, obtained through a Right to Information (RTI) request filed by M M Shuja in 2019, and available with the news agency—Kashmir News Observer (KNO), the number of cases registered against police personnel in the district Srinagar has seen variations over the years.

In 2019, 8 cases were reported, which increased to 12 in 2020, dropped to 3 in 2021, rose again to 6 in 2022, and declined to 4 in 2023.

Similarly, under the category of Crimes Against Women (CAW), there has been a steady increase in reported cases. In 2019, 48 cases were registered, followed by 47 in 2020, 41 in 2021, 70 in 2022, and a spike to 113 in 2023. Five cases were reported up to January 31, 2024.

The RTI data also reveals other categories of criminal activity. Regarding suicide cases, there were 15 cases registered in 2019, which increased

to 26 in 2020, further rose to 51 in 2021, and decreased to 41 in 2022 and 34 in 2023. In the current year, 3 cases were reported up to January.

Similarly, the number of murder cases varied over the years, with 6 cases reported in 2019, 13 in 2020 and 2022, 24 in 2021, and 6 in 2023.

In 2020, 27 cyber fraud cases were reported, resulting in 7 arrests and recovery of Rs 80 lakh. The figures increased in 2021, with 27 cases reported, 39 arrests made, and Rs 1.60 crore recovered. In 2022, 56 cases were registered, leading to 44 arrests and recovery of Rs 3 crore. In



Only 1 case was reported up to January this year.

Kidnapping and rape cases have also shown variations, with 98 cases reported in 2019, 21 in 2020, 100 in 2021, 128 in 2022, 100 in 2023, and 8 cases reported up to January this year.

The data further shows the prevalence of cyber fraud cases, with variations in the number of cases registered and arrests made over the

2023, 56 cases were reported, 42 arrests were made, and Rs 2 crore was recovered. Up to January 2024, 1 cyber fraud case was reported, with recovery exceeding Rs 50 lakh.

Since 2019, 33 policemen have been implicated in corruption cases in Srinagar, resulting in the recovery of Rs 7.9 crore stolen through cybercrime. A total of 235 policemen have retired during this period—(KNO)

# Transport Dept Issues Comprehensive Advisory For Tourists, Taxi Unions, Others

**SRINAGAR:** In a bid to enhance tourist experiences, the transport Department of Jammu & Kashmir has issued a comprehensive advisory for the visitors, taxi unions and cab drivers in Kashmir.

The advisory, as per the news agency—Kashmir News Observer (KNO) asked that taxi unions and individuals to refrain from obstructing or restricting vehicles with valid permits, leaving such actions to the authority of local administration or traffic, tourist police.

"Taxi Unions or any person representing such unions or any individual driver especially at popular tourist destinations like Pahalgam, Sonmarg, Gulmarg, and Dodhpathri etc. shall ensure that no tourist vehicle that carries an all India/J&K permit is obstructed or restricted in any manner or force any tourist to alight from the vehicle before the conclusion of the journey. Only an authority of the local administration or traffic/tourist police shall be competent to do so," states the advisory.

The advisory, a copy of which also lies with KNO, encompasses various facets of responsible and professional conduct expected from taxi operators, aimed at providing tourists with a hassle-free and enjoyable journey.

According to the advisory issued, transport department has outlined specific guidelines and protocols that taxi drivers must adhere to at all times:

**Documentation:** Drivers are required to carry essen-



tial documents, including a valid driving license, vehicle registration certificate, fitness certificate, vehicle insurance policy, permit copy, PUC certificate, and a list of tourists.

**Display of Information:** Clear display of registration number plates and permit type on vehicles is mandated to ensure transparency and accountability.

**Vehicle Standards:** Vehicles must be well-maintained, clean, and regularly serviced. Neat seat covers and a first aid kit are obligatory.

**Uniforms:** Drivers must wear prescribed uniforms while on duty, as specified by the Transport Department.

**Queue Management:** Drivers are expected to follow queue systems at airports and other designated places without manipulation or jumping queues.

**Fair Pricing:** Overcharging is strictly prohibited, and drivers must adhere to the legal fare without imposing additional charges.

**Refusal and Alighting:** Refusal to carry tourists or asking paid passengers to alight prematurely is forbidden without valid reasons.

**Contingency Measures:** In case of mechanical breakdowns

or unforeseen circumstances, drivers must arrange alternative transportation for tourists to reach their destination.

**Lost Items:** Drivers are obligated to conduct a thorough search for any items left by tourists in their vehicles at the end of each journey.

**Customer Interaction:** Politeness and respectful behavior towards customers are mandatory, fostering a positive and welcoming atmosphere for tourists.

**No Smoking Policy:** Smoking while on duty is strictly prohibited.

**Complaint Handling:** Drivers must provide tourists with complaint books upon request and periodically submit them to permit issuing authorities.

**Mobile Connectivity:** Drivers should ensure their mobile phones are charged and have internet connectivity enabled whenever possible.

**No Cell Phone Use While Driving:** Cell phone usage while driving is prohibited, and if necessary, drivers must pull over to the left and halt before talking calls.

**Avoid Overloading:** Vehicles must not be overloaded with passengers or luggage, ensuring passenger safety and comfort—(KNO)

Favourable conditions and the much-debated 'Impact Player' rule have helped batters rule the roost in the ongoing IPL, with teams such as Sunrisers Hyderabad piling up scores in excess of 260 on three occasions.

But Miller feels it won't be the same in the T20 World Cup, to be held in the United States and West Indies from June 2.

"It would be hard to say whether the World Cup will produce high-scoring games because the conditions will be very different. The Caribbean might be on the slower side compared to Indian wickets. It's all about assessing the conditions on the day and playing



accordingly," Miller said.

"We are not concerned about that (crossing 200-run mark). We played Sunrisers,

we beat them. I think it's different conditions for different grounds. At the end of the day we have 4 wins from 8, so we

are very much there.

"We don't want to get caught up in what other teams are doing. We are sticking to our

strength," he added.

India captain Rohit Sharma has made it clear that he is not a big fan of the 'Impact Player' rule as it is hampering the growth of all-rounders. A few other top players, including Miller, have also voiced their opposition to the rule.

The 'Impact Player' rule, introduced in 2023, allows all IPL teams to substitute a player -- batter or bowler -- during their respective innings as per the demands of the match.

"Everyone has got their opinions about it but for me I am not a massive fan of the rule. The game of cricket has 11 players and it would be nice to stick to that.

"Rohit said that international cricket is not like that and I feel it's better to keep it the same as international cricket.

"It's creating 6 bowlers and 8 batters, taking all-rounders out of contention. At the end of the rule is there so we have to play according to the rule," he said.

## Rishabh Pant's Captaincy Under Lens As DC Play GT

**NEW DELHI:** Rishabh Pant's leadership skills will be under scrutiny as a struggling Delhi Capitals would seek a much-improved performance from their bowlers when they take on an inconsistent Gujarat Titans in the IPL here on Wednesday.

It was not an ideal homecoming for Pant as after two consecutive wins, DC slumped to a 67-run loss against a marauding Sunrisers Hyderabad at home on Saturday.

The loss saw DC slip to the eighth position with three wins and five defeats. They very well know they can't afford to falter if they want to keep their play-off hopes alive.

Against SRH, Pant erred in his decisions a few times, starting from the toss as he misjudged the dew factor at the Arun Jaitley Stadium and decided to bowl first.

Pant's decision to hand the second over to Lalit Yadav, was even more contentious as SRH were off to a blazing start, scoring a record 125 for no loss in the powerplay.

To chase a target of 267, a team needs its openers to fire from ball one but Prithvi Shaw and David Warner haven't been too successful.

Young Jake Fraser-McGurk smashed 65 off just 18 balls to

keep DC in the hunt but he lacked support from the other end, even though Abhishek Porel (42 off 22) tried his best.

Left-arm seamer Khaleel Ahmed's, whose career has been dogged by inconsistency, decision to employ short stuff in the opening over completely backfired.

Pace spearhead Anrich Nortje has been completely off-colour this season and DC would be desperately hoping veteran Ishant Sharma returns after missing the last game due to a back spasm.

Kuldeep Yadav has been DC's best bowler in the season so far with 10 wickets from five games.

GT have also been equally inconsistent under new skipper Shubman Gill. But the three-wicket win over Punjab Kings in their last game has helped the former champions move up slightly in the pecking order at sixth spot from four wins and as many losses.

The likes of Sai Sudharsan, David Miller and Azmatullah Omarzai also need to let their willow do the talking while Rahul Tewatia would look to continue his pyrotechnics towards the end stage of their innings.

On the bowling front, the likes of veteran Mohit Sharma, Noor Ahmad and Rashid Khan will be expected to deliver the goods.

## Ten Hag Says Reaction To Man Utd FA Cup Win A 'Disgrace'

**LONDON:** Erik ten Hag says the media reaction to Manchester United's performance in the FA Cup semi-final against Coventry was "a disgrace", robustly defending his side's achievement in reaching a second straight final.

United surrendered a 3-0 lead at Wembley on Sunday and were saved from a humiliating exit in extra time only by a VAR intervention, which ruled out a goal for offside in the final moments.

They eventually scraped through against the Championship side on penalties to set up a re-match of last year's final against City.

Ten Hag admitted after the match his team had "got away with it" but played down any notion of embarrassment.

But he has been widely criticized, adding to speculation he is on borrowed time at Old Trafford.

Former Premier League



striker Chris Sutton said the performance would "cement his sacking".

But Ten Hag was in defiant

mood on the eve of United's Premier League match against bottom side Sheffield United on Wednesday.

"You asked the question: 'Is it embarrassing?' No, the reaction from you was embarrassing," he told reporters on Tuesday.

"It is the comments. Top football is about results. We made it to a final and we deserved it not only by this game but also the other games.

"We lost control for 20 minutes, we also had bad luck, 3-2, 3-3. We were very lucky in the end, it is clear. Penalties was very good and we made it to the final, it is a huge achievement. Twice, in two years, is magnificent. For me as a manager, four cup finals in four years.

"The comments are a disgrace."

United, winless in their past four Premier League games, are in danger of missing out on a European spot next season after a poor campaign.

They are already realistically out of the race to qualify for the lucrative Champions League but still have the Europa League and the Europa Conference League to aim for.

"We have to win every game, we know that," said Ten Hag. "That's what United stands for and that is our approach, go from game to game but we have to qualify for Europe and we now have two opportunities -- in the league and the FA Cup final."

Ten Hag said he would work closely with newly appointed technical director Jason Wilcox to determine the future direction of the club.

Wilcox, 53, has left second-tier Southampton to take up the job at Old Trafford with immediate effect.

"We have to form a partnership, which is very important," said Ten Hag. "We are a little bit behind in the process so we have to catch up and we will go and speed up the process." (AFP)
