Srinagar: The lifeless body of the second missing minor boy of Gandbal was found from River Jhelum near Noorbagh, Srinagar, on Saturday morning.

With the recovery of the body of Farhan Parray, the death toll in the Gandbal tragedy rises to eight, while one person - the father of little Hazik whose body was found on Friday from Jhelum near Rajbagh - remains missing.

Azad Dismisses Pre-Poll Alliance With April Party, PC



Srinagar: DPAP Chairman Ghulam Nabi Azad has categorically ruled out the possibility of entering into any pre-poll alliance with Apni Party's Syed Altaf Bukhari or Peoples Conference Chairman Sajad Gani Lone.

In an interview with a news channel, Azad highlighted the inherent disparities in political agendas and regional influences as significant impediments to such partnerships.

"They have their agendas, and everyone has their own area of influence," Azad said. "Let me tell you a political thing... alliances happen when the influence of the two parties are the same in a particular area. When one's influence is in the south and the other's is in the north, how could an alliance happen?"

"If I have influence on 40 homes and you have on 60, and if we make an alliance, the



number will surge to 100. But f I don't have influence on any home, and you have no influence in my area, how could we join hands?," Azad asked.

The veteran politician urged further against allowing emotions to govern decision-making processes, cautioning that unchecked emotional responses could lead to societal decline and turmoil. "This is why Allah has given us brains, so that we think and then accordingly decide what is | More on P6

LAND SINKING **IN RAMBAN**

Over 500 Relocated To Safer Places

Jammu: More than 500 people have been relocated to safer places after over 58 houses were completely damaged due to land sinking in a village in Jammu and Kashmir's Ramban district, officials said on Saturday.

An official said the assessment of damages due to the land subsidence in Pernote village over the past three days has also started on war-footing to facilitate speedy release of compensation to affected families under the State Disaster Response Force (SDRF) norms.

The natural calamity hit the village on Thursday evening, also damaging four transmission towers, a power receiving station and a section of the road connecting the Gool subdivision with Ramban district headquarters.

The Ramban district administration under the supervision of Deputy Commissioner Baseer-Ul-Haq Chaudhary, who is also Chairman of the Chaudhary, District Disaster Management Authority (DDMA), has relocated all the affected families, the official said.

Mughal **Road Shut After Fresh Snowfall**

he Mughal Road was closed for vehicular traffic on Saturday following fresh snowfall in the higher reaches, including Peer Ki Gali, along the alternative route connecting Jammu's Poonch and Rajouri districts to south Kashmir's Shopian district, officials said. More than six inches of fresh snow has been recorded at the 11,433-feet high Peer Ki Gali, also known as the Pir Panjal pass, on the Mughal Road, prompting authorities to suspend vehicular traffic as a precautionary measure, they said. It is still snowing from Dubjan to Peer Ki Gali, a distance of 45 kilometres, and there is apprehension of landslides and shooting stones from the hillock overlooking the road, they said. Srinagar: Challenging the abrogation of Article 370 in the Supreme Court might have been a mistake but not doing so would have made things worse politically for the mainstream parties of Jammu and Kashmir, Peoples Conference chief Sajad Lone

apex court December last year upheld the Centre's August 5, 2019 decision to abrogate Article 370, which bestowed a special status on the erstwhile state of Jammu and Kashmir.

In an interview with PTI, Lone said the Centre could have propped up anyone to take the case to the apex court had the mainstream parties stayed away from taking legal recourse.

Man Commits Suicide Over 'Police Harassment'

Jammu: A 47-year-old man allegedly committed suicide here, officials said on Saturday, as a purported video of the deceased and a suicide note accused police of harassment. The concerned station

house officer (SHO) was attached and an inquiry was ordered into the incident. Rajesh Kumar was found

hanging from a ceiling fan at his Janipur residence in the city late on Friday evening, the officials said.

They said the family of the deceased staged a protest outside the Janipur police station after a suicide note was allegedly found from the deceased's possession, claiming that he was ending his life due



to "police harassment". Later, a video clip, which the deceased had allegedly shot before taking the extreme step, also went viral, claiming that he was fed up with his life as the police were harassing him even though he was acquitted by a court of law in a "false case" registered against him more than 19 years ago.

Bereft Of Manpower, LCMA Unable To Prevent Greenbelt Infractions

Several Illegal Structures Dismentled In Shalimar

Srinagar: Insufficient resources, lack of manpower and required backing from allied departments, make it difficult for the enforcement wing of Jammu and Kashmir Lake Conservation and Management Authority (LCMA)—an autonomous body entrusted with monitoring, managing water bodies, to address infringements in Dal Lake.

Delays in demolition drives within the greenbelt, according to officials, are caused by allied departments, such the police, being reluctant to offer support to the LCMA demolition squad, consisting of 10 members.

"Without manpower, we may not be able to stop illegal constructions in the Greenbelt. How on earth can a team of ten people stop infractions? When it comes to demolition drives, we never get support from the police," Abdul Rashid, In-Charge demolition, told Kashmir Observer.

"Because there is always a fear for law and order, demolition drives are conducted in presence of a magistrate and the We are attacked,

Station House Office (SHO) in question. Thus, it's virtually difficult to execute such drives with a handful of staff," he added.

Meanwhile, a demolition drive was conducted in the Shalimar area from Syed Meerak Shah Road to Foreshore Road, during which a number of illegal structures, including fences and tin sheds, were dismantled.

"The drive would continue throughout the upcoming week and that the department hopes to receive appropriate police support," the official said.

Zahid Hassan Samoon, the Deputy Superintendent Enforcement wing, said they seldom receive police backup during demolition drives.

"We lack the manpower and equipment necessary to address the issue of unlawful constructions. The police at the moment are preoccupied with the elections, which makes it difficult for us to carry out demolition drives well on time," Samoon told Kashmir Observer.

He said those running small enterprises on government property seldom bother to obtain LCMA authorization for fencing, which frequently leads to the demolition.

"Who would touch them if they had authorization, but instead of obeying rules, they accuse the department of rendering the poor jobless. Public awareness regarding conservation of lands is necessary to stop encroachments in the notified areas," he added.

The LCMA Enforcement wing head said that an extensive demolition drive will be carried out in the Shalimar area next week and every single illegal structure will be demolished.

"Since the weather was not favorable, we couldn't conduct a drive in the interiors of Shalimar, but as soon as the weather improves, a massive drive will be carried out in the area." Samoon added.

The KTA's criticism comes amid growing frustration among Kashmiri's over the erratic power supply, despite assurances from authorities on improved infrastructure and metering systems.

he 127-year-old story of the Rs 1.76-trillion Godrej business conglomerate as a unified family business that lasted five generations has ended. The group was vertically split across two family branches headed by Adi and Nadir Godrej on one side and cousins Jamshed and Smita Crishna-Godrej on the other. Not long ago, in 2020, the highly-diversified TVS group, with a Rs 70,000 crore revenue, also split branch-wise, ending its 113-year-old legacy built across five generations. In 2016, the Munjal family that built up the Rs 35,000-crore Hero two-wheeler company announced a split across family branches, thus ending its 40-year-old history across three generations. These three wellknown Indian family businesses practised sound governance and maintained cordial relationships among family members while managing their businesses professionally. They innovated and built multiple businesses competitively. Then why did they all split, making each branch much weaker in several ways? Is this a signal that business empires are no longer stable and are prone to break up? More fundamentally, can't Indian family businesses be built as lasting institutions or is a split inevitable?

There are several common features across the three cases discussed above. We can draw important lessons from a closer look at some of them.

Strong entrepreneurial leadership

The survival and growth of any venture is a certificate of the entrepreneurial acumen of the founders and their ability to take their start-up through the early growth stage. Many of them build their organisations further and manage the later growth stages through professionalisation. That involves not only the introduction of organisational structure, systems and processes, but also building a team to implement the strategies. All along, the founder entrepreneur is committed to the success of the organisation, whether it has one or more businesses. They consider them all equally as their children and give attention and care as they require. As a result, there is a unified and synergistic decision-

making at the top across the businesses that may be related or unrelated from a product-market angle. Resource allocation is also balanced with passion shared across businesses

Operational leadership always with family

Most successful Asian family businesses allow the younger generation to step into the operational leadership of their preceding generation. Alternatively, children are encouraged to pursue their entrepreneurial ideas, often in unrelated areas, partly to make them independent, and partly to avoid possible fights among them. In any case, the next-generation leaders build their own constituency that they fiercely protect. Over a period of time, their loyalty, commitment, and involvement get restricted to their own fiefdoms. With the younger generation concerned mostly with their "own" businesses, there is none like the founder to think synergistically about the group and its corporate strategy. The challenge gets harder when each family member's performance is measured against the goals specific to the individual business he or she manages. In many families, next-generation champions do not have goals and targets fixed at the group level. While the founder was a great integrator of the various businesses of the group, later generations do not have a group-level champion to think comprehensively. Slowly, the vacuum thus created grows bigger and individuals fiercely try to pro-

tect their operational territories (strategic business units). This is akin to states flexing muscles at the cost of the federal governance entity.

Absence of group-level strategy and governance The split gains momentum when the third

generation ascends and cousin bonding wanes compared to that of siblings. The casualty is the absence of a strong group-level strategy that was the hallmark of the founder leader's entrepreneurial leadership. The implicit presence of a group and shared family governance principles gradually evaporate, leading to simmering differences among family units that may end up in a gridlock and split. In fact, the need for explicit policies and processes of governance is much greater at this stage to keep the growing flock together and united.

Avoiding the gridlock trap

Visionary family businesses set clear expectations from family members, especially from the second or third generation onwards, when economic factors outweigh emotional bonding. In general, families define themselves as the custodians of the wealth of the entire unit and limit their role to strategy and governance. In some cases, families expect the next generation to drive entrepreneurship by spotting opportunities and initiating ventures with clear policies for funding. Those who join operations never become the CEOs of any one vertical. In any case, family members do not steer operational responsibilities and ensure practice of merit and professionalism. It never becomes an employment exchange or a platform to meet the ego needs of family members. In the process, the individuals do not become myopic. They recognise that their surnames alone do not make them the most competent to manage the business competitively.

Family members always remain custodians of their inherited wealth. Across the world, leaders with stewardship values have built and preserved institutions, business or otherwise. Such families know that several silos do not add up to a great lasting structure.

Nearsightedness Is At Epidemic Levels And The Problem Begins In Childhood

yopia, or the need for corrected vision to focus or see objects at a distance, has become a lot more common in recent decades. Some even consider myopia, also known as near-sightedness, an epidemic.

Optometry researchers estimate that about half of the global population will need corrective lenses to offset myopia by 2050 if current rates continue – up from 23% in 2000 and less than 10% in some countries.

The associated health care costs are huge. In the United States alone, spending on corrective lenses, eye tests and related expenses may be as high as US\$7.2 billion a year.

What explains the rapid growth in myopia?

I'm a vision scientist who has studied visual perception and perceptual defects. To answer that question, first let's examine what causes myopia – and what reduces it.

HOW MYOPIA DEVELOPS

While having two myopic parents does mean you're more likely to be nearsighted, there's no single myopia gene. That means the causes of myopia are more behavioral than genetic

Optometrists have learned a great deal about the progression of myopia by studying visual development in infant chickens. They do so by putting little helmets on baby chickens. Lenses on the face of the helmet cover the chicks' eyes and are adjusted to affect how much they see.

Just like in humans, if visual

input is distorted, a chick's eyes grow too large, resulting in myopia. And it's progressive. Blur leads to eye growth, which causes more blur, which makes the eye grow even larger, and so on.


Two recent studies featuring extensive surveys of children and their parents provide strong support for the idea that an important driver of the uptick in myopia is that people are spending more time focusing on objects immediately in front of our eyes, whether a screen, a book or a drawing pad. The more time we spend focusing on something within arm's length of our faces, dubbed "near work," the greater the odds of having myopia.

So as much as people might blame new technologies like smartphones and too much "screen time" for hurting our eyes, the truth is even activities as valuable as reading a good book can affect your eyesight

OUTSIDE LIGHT KEEPS MYOPIA AT

Other research has shown that this unnatural eye growth can be interrupted by sunlight.

A 2022 study, for example, found that myopia rates were more than four times greater for children who didn't spend much time outdoors – say, once or twice a week – compared with those who were outside daily. At the same time, kids who spent more than three hours a day while not at school reading or looking at a screen close-up were four times more likely to have myopia than those who spent an hour or less doing so.



In another paper, from 2012, researchers conducted a meta-analysis of seven studies that compared duration of time spent outdoors with myopia incidence. They also found that more time spent outdoors was associated with lower myopia incidence and progression. The odds of developing myopia dropped by 2% for each hour spent outside

Other researchers have reported similar effects and ar-

gued for much more time outdoors and changes in early-age schooling to reduce myopia prevalence.

WHAT'S DRIVING THE EPIDEMIC

That still doesn't explain why it's on the rise so rapidly. Globally, a big part of this is due to the rapid development and industrialization of countries in East Asia over the last 50 years. Around that time, young people began spending more time in classrooms

reading and focusing on other objects very close to their eyes and less time outdoors.

This is also what researchers observed in the North American Arctic after World War II, when schooling was mandated for Indigenous people. Myopia rates for Inuit went from the single digits before the 1950s to upwards of 70% by the 1970s as all children began attending schools for the

Countries in Western Eu-

rope, North America and Australia have shown increased rates of myopia in recent years but nothing approaching what has been observed recently in China, Japan, Singapore and a few other East Asian countries. The two main factors identified as leading to increased myopia are increased reading and other activities that require focusing on an object close to one's eyes and a reduction in time spent outdoors.

The surge in myopia cases will likely have its worst effects 40 or 50 years from now because it takes time for the young people being diagnosed with nearsightedness now to experience the most severe vision problems.

TREATING MYOPIA

Fortunately, just a few minutes a day with glasses or contact lenses that correct for blur stops the progression of myopia, which is why early vision testing and vision correction are important to limit the development of myopia. Eye checks for children are mandatory in some countries, such as the U.K. and now China, as well as most U.S. states.

well as most U.S. states.

People with with high myopia, however, have increased risk of blindness and other severe eye problems, such as retinal detachment, in which the retina pulls away from the the back of the eye. The chances of myopia-related macular degeneration increase by 40% for each diopter of myopia. A diopter is a unit of measurement used in eye prescriptions.

But there appear to be two sure-fire ways to offset or delay these effects: Spend less time focusing on objects close to your face, like books and smartphones, and spend more time outside in the bright, natural light. Given the first one is difficult advice to take in our modern age, the next best thing is taking frequent breaks – or perhaps spend more time reading and scrolling outside in the sun.

Grandson Laid

Days have turned into weeks, and Tajaa's gaze remains fixed on the unforgiving Jhelum. Her eyes, clouded with desperation, search for any sign of her dead son. "Showkat," she rasps. "My heart aches for a final goodbye, my son."

The tragic incident occurred when the boat they were travelling in capsized in the river on April 16. In that incident, six people lost their lives, and three went missing.

The publisher has also said it is committed to reviewing and revising their content to ensure accuracy, fairness, and sensitivity in their representations.

"Additionally, we will be issuing a formal correction and apology in our upcoming publications and online platforms," it said. Pertinently, the publisher had drawn wide-

spread condemnation for its portrayal of Imam Khomeini in negative light.

The Indian Muslim community, particularly Shia Muslims in Kashmir had expressed outrage over 'the disrespectful depiction of Imam Khomeini. People in Budgam town and Zadibal quarter of the capital city took to the streets demanding action against the publisher.

Leaders from the Shia Muslim community had vehemently condemned Qconnect Books for its insensitive portrayal of Imam Khomeini, stating that it not only undermines the significance of his contributions to Islam but also deeply hurts the sentiments of millions of his followers worldwide.

Leading Shia cleric Maulana Masroor Abbas Ansari expressed his anger and demanded cancellation of the publisher's license. Masroor smacked the conspiracy behind the move alleging that such misleading books were being included in the curriculum to hurt the sentiments of Muslims. Idara-e-Falah-e-Aam, an NGO alleged that

Imam Khoemini's negative portrayal was as a dangerous trend of using the sacred sector like education as a weapon for the impure agenda of strengthening religious hatred.

Former Srinagar Mayor & Apni Party leader Junaid Azim Mattu took to the social media platform X and condemned the move.

"In the strongest of terms I condemn the unjust, intolerable and unacceptable misportrayal of Ayatollah Imam Khomeini (RA) by QConnect books. An FIR should be registered against those responsible for this shameless and intolerable act," Junaid wrote.

All Jammu & Kashmir Shia Association issued

a statement stating the "reckless characterization not only disregarded historical accuracy but also perpetuated harmful stereotypes".

Meanwhile legal experts here said the act was detrimental to the public law and order of India and comes under the ambit of reasonable restrictions as enumerated in the constitution of India.

Mudasir Ahmad, an Advocate at J&K High Court, said that the derogatory depiction of Ayatollah Khomeini was clearly an attempt to hurt the religious sentiments of a prominent religious community in India.

"It looks like the publishers of the textbook have willfully done this act and can attract various penal provisions of law. The constitution of India clearly safeguards the religious sentiments of citizens of India," he said.

Ahmad further said the act of publishers clearly violates section 153-A and section 295-A of Indian Penal Code, as it was a deliberate act to insult the religious belief and religious sentiments of a class/prominent community of Indian citizens.

Meanwhile, the School Education Department J&K issued a statement saying that there was some objectionable content from a book being circulated on social media.

"As verified, from the textbooks prescribed and developed by JKBOSE, there is no such content in JKBOSE textbooks. Moreover, no book having such content has been developed by NCERT, nor has it been prescribed in any of JK schools. We are verifying the source of this video so that the law enforcement authorities can take strict action."

The Chief Secretary asked for devising an effective strategy to deal with flood like situations in the valley. He maintained that floods are disasters which require prior preparedness to alleviate the damage caused by them. He called for evolving proper SoPs to deal with the Floods as like the 'Code Blue' being followed in hospitals, where every concerned individual is fully acquainted with his/her role and responsibility in the times of emergency.

The Chief Secretary called for having a detailed flood mapping/inundation map of each area in the districts to act accordingly. He exhorted upon the DCs and Divisional Commissioner to have proper planning in place to deal disasters.



Admin Reviews Agriculture Scenario, Amid inclement Weather

SRINAGAR: Amid prevailing inclement weather conditions in the region, the Director Agriculture Kashmir, Chowdhury Mohammad Iqbal today reviewed the agriculture scenario in Kashmir division.

He suggested mapping of mobile towers so that customized messages to people in case of emergencies can be sent. He also asked for identification of rescue centres in all flood prone areas having all the requisite amenities. He also asked for working out a proper backup strategy to augment the efforts of administration in case of any possible

emergency. The Chief Secretary also asked making training and exercises an important part of the preparedness plan. He took stock of the functionality of dewatering stations in Srinagar City and asked for periodically checking them for

He reviewed the working of the Emergency Operation Centre and the vital installations present in the flood prone areas. He called upon the Divisional administration to carry out an exercise of creating backup for such installations.

During the meeting, ACS Jal Shakti, Shaleen Kabra, threw light on all the measures taken by the department to deal with such kind of natural calamities in J&K. He said that the UT besides increasing the carrying capacity of the River Jhelum and Flood Spill Channel has adopted other state of the art technologies to have better information and coordination to mitigate its effects.

He revealed that the Department has installed the Early Warning System and automatic water sensors besides carrying out audits of embankments to deal with floods effectively. He said that the 'Kashmir Flood Watch' mobile app and website gives updated information about the water levels in rivers. He also revealed that other requisite information is also transmitted to the public through both traditional and social media handles simultaneously.

The meeting was apprised of the works carried out, so far, by the Department. It also laid out the future plans of the department besides the contingency plan it has devised for the eventuality. The meeting also presented the stock position of different flood mitigation items available with the Department in its stores.

The meeting was informed that the central flood committee is being headed by the Divisional Commissioner, Kashmir while the District Coordination Committees are headed by respective DCs. The meeting discussed the river capacity, first overflow, danger level of water and level for declaration of flood as per the gauge readings at Sangam, Ram Munshibagh and Asham.

Homestay Owners In Kashmir Accuse StayVista For Booking Cancellations, Financial Losses

SRINAGAR: One of India's leading homestay aggregators Stay-Vista has come under scanner after being accused of malpractice by owners of homestays from Kashmir.

One of the accusers, Babar Mian, the owner of Nazm Villa which features a cottage and a villa, has accused StayVista of malpractice.

Mian claims to have listed his property with StayVista in December 2022, seeking to tap into the platform's extensive network of travelers. However, what initially seemed like a promising partnership soon turned sour.

Mian revealed a pattern of grievances he has experienced since partnering with StayVista.

"The first six months went smoothly, thereafter, guests encountering minor issues at the property were abruptly relocated by StayVista, leaving us with vacant accommodations and lost revenue," Mian said.

Mian further said that he entered into this partnership with StayVista with high hopes of boosting his property's visibility and bookings. However, their actions have only led to losses and frustration.

"StayVista frequently can-celed bookings at the last minute, causing significant financial setbacks for me and my business. I have incurred losses up to Rs lakh rupees. I have also sent legal notices to them."

Another Homestay owner levelled similar allegations say-

ing that he is not in a position to lodge a complaint because of the contract policy but he will speak to the media once the contract ends.

Speaking to Kashmir Observer, Amit, Co-founder of StayVista, denied all these allegations. He attributed the disruptions to maintenance issues plaguing the property and ongoing customer complaints, particularly concerning the quality of food services.

"While we strive to maintain positive relationships with all our property partners, there are persistent concerns regarding the upkeep of Nazm Villa. Our primary focus remains on ensuring a seamless experience for our guests" Amit said.

Amit further said that the customers were refunded so the question of paying money to homestay owners does not

Pertinently, the homestay scene in Jammu and Kashmir has exploded, boasting 1,485 homestays registered in Jammu & Kashmir and over 13,000 rooms up for grabs. This boom owes its thanks to the government's push to broaden lodging options by urging locals to turn their homes into tourist hotspots.

"What I feel about Hardik Pandya is that Indian cricket needs to make it clear that they should not give him that much priority as they have given him so far, because we still haven't won the World Cup," Pathan said on Star Sports Press Room Show, Ticket to World Cup.

"If you think you are a primary all-rounder, you need to make that kind of an impact at the international level. As far as the all-rounder is concerned he hasn't made that impact at the international level, we are only thinking about the po-

The former India left-arm seamer observed that there is a "big difference" between performance in the IPL and international cricket, and advised Pandya to play throughout the year instead of "picking" tournaments.

"We are getting confused between the IPL performances and the international performances. That's a big difference. First of all, he needs to play throughout the year. He cannot pick and choose.

"Indian cricket needs to stop doing that. Stop giving preferences to individuals, if you do that, you will not be winning major tournaments.

"What Australia has been doing for many years is that they are actually preferring the team game. Making everyone a superstar. Not



one superstar, everybody is a superstar in the squad. If you don't do that, you will not win big tourna-

Pathan also opined on problems around finishers and the team's pace bowling unit.

"This is what I'm really scared about when it comes to the World Cup. Look, my worry is with the T20 World Cup, we are pretty much sorted as far as the top-order batting is concerned. We are pretty much sorted in the middle-overs as well.

"If we're thinking Ravindra Jadeja is a number seven batter, you need a good finisher. His numbers are not that great as far as the strike-rate is concerned at the international level. So, there is a worry for me there and the fast bowling.

"Apart from Bumrah, if I look at the guys playing in IPL, played before the IPL in the South Africa series, their numbers are not that great -- be that it's Arshdeep, be that it's Mohammed Siraj, you know, the guys who played last.

"So these two departments, it really makes me worry. These are the departments that are going to be very, very crucial," Pathan said.
