J&K Braces For Week-Long Scorcher

Srinagar: Srinagar, the summer capital of Jammu & Kashmir and Qazigund, the gateway of Kashmir have recorded the heat wave on Tuesday while the weatherman here has predicted increase in the maximum temperature for the next one week, saying that the most areas of J&K are expected to record the heat wave for the next seven days. Srinagar recorded a maximum temperature of 30.0 degree Celsius while Qazigund recorded 30.8 degree Celsius on Tuesday.

The departure in Srinagar was recorded 5.2 degree Celsius while Qazigund recorded 6.8 degree Celsius today, the Meteorological department in its report said. The other station of Kashmir also recorded a rise in the maximum temperatures. In Pahalgam, the mercury settled at 26.2 degree Celsius while in Kupwara, it settled at 28.7 de-

gree Celsius.

As per MeT, Kokernag and Gulmarg, a famous ski-resort, have recorded a maximum temperature of 28.6 degree Celsius and 19.8 degree Celsius respectively today.

Jammu division has also recorded a rise in the mercury while most of the areas simmer at above 30 degree Celsius.

HC Asks Govt To Provide Funds To J&K SFC

Srinagar: The High Court of J&K and Ladakh on Tuesday directed J&K State Forest Corporation to release entire withheld dues on account of Cost-of-living adjustments (COLA), leave salary and 6th Pay arrears alongwith interest in favour of a number of petitioners or their predecessors-in-interest.

Disposing of a bunch of petitions filed by former employees of the Corporation, who retired around 14-15 years ago, or their predecessors-ininterest, a bench of Justice M.

A. Chowdhary observed that the petitioners are raising a just and reasonable issue for consideration, and that the authorities, in principle, "also appear to be in such agreement."

Millions Join Iran President's Funeral Procession

Tehran: Millions turned up to bid farewell to President Ebrahim Raeisi and his companions as funeral events began Tuesday in Iran with investigators looking into the helicopter crash that killed them late on Sunday and the country grappled with the shock of losing two of its most prominent leaders at a volatile moment.

Supreme leader, Ayatollah Sayvid Ali Khamenei, has announced five days of mourning for the president Raisi, 63, and the foreign minister, Hossein Amir Abdollahian, 60, who died when their helicopter plunged into a mountainous area near the Iranian city of Jolfa on Sunday. The state news media said the crash had resulted from a "technical failure." Iran's Armed Forces said it had begun an investigation

and sent a team to the site. Mourners in black began gathering Tuesday for days of funerals and processions and a series of ceremonies aimed at both honoring the dead and projecting strength in an unsettled Middle East. | More on P6

"Having perused the review petitions, there is no error apparent on the face of the record. No case for review under Order XLVII, Rule 1 of the Supreme Court Rules 2013. The review petitions are, therefore, dismissed," a bench, headed by CJI

J&K Govt Okays 4% Hike In DA **For Employees**

The Finance Srinagar: Department of Jammu and Government on Kashmir Tuesday announced a 4% increase in Dearness Allowance (DA). This decision, detailed in Government Order No. 8-F of 2024, will be effective from January 1, 2024.

The order, signed by Principal Secretary Santosh D. Vaidya, stated that the revised DA rate will now be 50% of the basic pay per month. This increment is applicable to all government employees working in regular pay levels as recommended by the 7th Pay Commission.

Achan Landfill Under NGT Scanner

High-Profile Committee to Probe Pollution, Seek Solutions

Srinagar: The National Green Tribunal (NGT) has constituted a high-profile committee headed by Secretary Central Pollution Control Board (CPCB) to ascertain the "correct factual situation" in Achan dumping site in Srinagar city.

For decades, residents of the vicinity, including those in the downtown area of Srinagar, have complained about the "unscientific" dumping of waste in the former wetland. This dumping has resulted in a persistent foul smell emanating from the site, causing several health issues.

The Srinagar city generates around 600 metric tons of garbage, which is collected by the Srinagar Municipal Corporation (SMC) and deposited at Achan.

ACB Files FIR Against Mirwaiz, IAS Officer



Srinagar: The Anti-graft body of Jammu & Kashmir Police has booked Mirwaiz Umar Faroog and a serving senior bureaucrat among seven people for allegedly encroaching Custodian land in convenience with revenue officials in summer capital Srinagar.

According to the FIR copy, a preliminary inquiry of the Anti-Corruption Bureau revealed that a lady, Dil Rafiqa, was "unlawfully granted evacuee land by the Custodian Department without proper government sanction and an open auction, violating

established provisions.' "The inquiry uncovered that land belonging to Imam-u-Din, located at Saderbal Hazratbal under survey number 640, was allocated to several individuals, including Dil Rafiqa, in gross violation of rules," reads the FIR.

"The illegal allotment involved 07 Kanal 19 Marlas 97 sqft of land, encroached upon

BJP Hit Streets In Srinagar, Seeks Probe Against DC Shopian

Shouting anti Pakistan slogans, the protesters also set effigy of the Prime Min-

ister of Pakistan on fire, claiming the militant's carryout such acts at the behest of their masters from across the border.

The protesting BJP workers also accused the Shopian district administration of ignoring repeated pleas to provide safe accommodation and security to the vulnerable BJP workers in Shopian district.


Despite repeated requests, the Deputy Commissioner (DC) concerned, they alleged, did not bother to provide security to the slain BJP worker, making him a soft target for militants.

The protesters demanded a thorough inquiry against the DC Shopian for allegedly refusing to provide security to Aijaz Ahmad Sheikh.

"The aim of holding this protest is to show solidarity with the family of the deceased Sarpanch. We at the same time demand an inquiry against DC Shopian. The party had intimated him about some key functionaries facing militant threats; however, he did not take any measure to avert the threat" BJP district president, Ashok Bhat told reporters.

Sheikh, he said, was not just a dedicated party worker but a true patriot who persisted in his efforts to strengthen the party in the Shopian district despite being confronted by extremist forces.

'In case the administration did not hold an inquiry, the party workers from across Srinagar would march towards Shopian soon. We will take all necessary steps to drive extremist elements off Kashmir and won't let terrorism to thrive in J&K again," he added

Venting Your Emotions at Work: Helpful or Harmful?

isappointment, frustration, anger — these are just some of the negative emotions you are liable to feel at some point at work. When you experience an intense undesirable emotion, you might choose to express it to a coworker. People talk about the need to "vent" the emotion, meaning taking the time to express it with the goal of lessening its intensity. "Blowing off steam" is a phrase sometimes used.

Venting is a common practice, but does it result in more harm or good? Like many questions in psychology, the most accurate answer is probably, "It depends." In this case, it's important to consider such factors as how, who, when, where, and with what goal.

How and With What Goal

Emotions are physiological experiences that are caused by perceptions or thoughts. If you somehow immediately shut off the thoughts, the physiological emotion, or bodily experience, would subside in a matter of seconds to minutes. What keeps an emotional experience alive is continued thinking about it. So one risk of venting is continually reliving the undesirable emo-

tion. This is particularly likely if venting consists of simply repeating the events, focusing on the "wrongness" of what

happened, and so forth. If this kind of thinking perpetuates the negative emotional experience, why do we do it? We all like to be right, and having a prime example to feel self-righteous can be tempting bait. If we've been wronged, being the victim has its privileges, such as sympathy, and focusing attention on the negatives of others rather than ourselves.

What might more productive venting look like? It might be helpful to share with coworkers what happened, and how you feel about it, with the aim of examining your perspective. Often when we vent to coworkers we are seeking validation of our perspective; that we're right for feeling this way. Supportive coworkers may oblige, either out of sincere empathy or a sense of pressure to agree. Instead, look for alternative interpretations, and ask your coworkers for the same. It's not that you need to agree with alternative views, but even considering them helps break the grip of the belief that your interpretation or experience is necessarily 100% right, that the wrongdoers are

100% evil, and so forth.



When and to Whom

Typically the need to vent is when the emotion is hottest. That makes sense. The risk is that in the heat of the moment you may say things that you later regret, or that at least might be taken out of context if shared later by your coworkers. Taking any amount of time to calm yourself, even just a few minutes, may be beneficial in giving you more conscious control over what you share and how it comes across.

In the heat of the moment. there may be a temptation to vent to the first available ear. However, can that particular coworker be trusted? Do you

expect confidentiality? What is their relationship to the person, people, or situation about which you're venting? Might your sharing your negative emotions about these affect your relationship with this

particular coworker?

be within earshot. That might include coworkers, supervisors, customers, clients, or patients. Of course the ripple effects of the lack of privacy vary and are impossible to predict, but they seem almost guaranteed to be more negative than positive. As difficult as it may be in the moment, it's worth the effort to gauge the level of privacy, especially when your voice is liable to be a bit louder due to the emotional charge behind the venting.

There is no right or wrong answer. Hopefully, by considering the issues raised above, you can make decisions that increase the likelihood of beneficial venting while minimizing the risks. One entirely different option is to write or journal as a means of venting. Doing so eliminates many of the risks noted above, but lacks some of the benefits of venting in person with a supportive coworker. In the end, being self-aware and intentional in your choices is the ultimate goal.

SC Rejects Review

The review petition, filed under Article 137 of the Constitution, against the decision rendered on December 11, said that the impugned judgment should not have left open the question of whether the Parliament can extinguish the character of statehood by converting a state into one or more Union Territories.

In its verdict delivered on December 11, a Constitution Bench, headed by CJI Chandrachud had upheld the status of Ladakh as a Union Territory under Article 3(a) read with Explanation I of the Constitution, which permits the formation of a Union Territory by separating a territory from

However, it did not deal with the question of whether the Parliament could extinguish the character of statehood by converting a state into one or more Union Territories.

"In view of the submission made by the Solicitor General that statehood would be restored of Jammu and Kashmir, we do not find it necessary to determine whether the reorganisation of the State of Jammu and Kashmir into two Union Territories of Ladakh and Jammu & Kashmir is permissible under Article 3," the top court had said.

Further, the SC held that the President has the power to issue a notification declaring that Article 370 ceases to exist even after the dissolution of the Constituent Assembly of Jammu and Kashmir. It added that Article 370 was a temporary provision, considering the historical context in which it was included in the Constitution of India.

In its verdict, the top court had also asked the Election Commission of India to take steps to conduct elections to the Legislative Assembly of Jammu and Kashmir by September 30, 2024.

Generally, review petitions are tested on very narrow grounds like mistakes of law, an error apparent on the face of the record, etc., and are often dismissed in chambers and are rarely given open court hearings.

The matter was taken up with the LPG marketing companies as well who have assured to the department that such complaints and any underweight distribution of LPG will be dealt with strictly as per their company policies.

Earlier, the directions were issued by Controller Legal Metrology Department J&K, Majid K.A Drabu wherein the field executives of LMD were directed to conduct the special inspection drives against LPG Dealers in terms of the provisions of the Legal Metrology Act, 2009 and LPG Regulation (Supply and Distribution Order) 2000.

Moreover, the Department has requested consumers to remain vigilant while purchasing LPG and has asked them to insist on payment receipt while receiving the delivery.

The weight is written on every LPG Cylinder and every customer should insist on checking the weight of the cylinder by using the weighing scale lying with the delivery van. Any instance of refusal for conducting the weight or overcharging by LPG delivery person may be brought into notice of the Department so that the proper legal action can be taken.

Jel Helped

BJP views the increased participation as a rejection of past governance under the Congress, regional parties like the National Conference and the PDP interpret the historic turnout as a denouncement of the Centre's policies towards Jammu and Kashmir.

JeI was part of the separatist amalgam of Hurriyat Conference which spearheaded poll boycott campaigns after its formation in 1993.

However, the socio-religious outfit, which was

said to be the parent organisation of the pro-Pakistan terror outfit Hizbul Mujahideen, remained neutral after the division of Hurriyat between

moderates and hardliners in 2003. Former Jel chief Ghulam Qadir Wani recently said his organisation will participate in assembly elections if the Centre revokes the ban imposed on the outfit.

"We are holding talks with the Centre. We want to get our ban removed and we want to play our role in society. If the ban is removed, we may take part in the elections," Wani had said.

Unlike the past when the voters mostly used to stay indoors, especially in pockets having separatist and terrorist influence like Sopore township which has not crossed single-digit voting in the past decades, the May 20 poll witnessed a completely different scene with brisk voting reported from all polling stations since the start of

Baramulla district led the voting turnout with 3,93,566 voters casting their ballots followed by Kupwara (3,38,495 voters), Bandipora (1,53,006) and Budgam (1,22,569), according to the figures issued by poll officials.

In seven assembly segments of Baramulla, Uri recorded the highest 62.94 per cent turnout, followed by Pattan (60.01 per cent), Gulmarg (57.87 per cent), Rafiabad (57.38 per cent), Baramulla (52.15 per cent), Wagoora-Kreeri (49.77 per cent) and Sopore (44.21 per cent).

Similarly, in six segments of Kupwara, Handwara recorded the highest turnout of 72.04 per cent followed by Langate (63.60 per cent), Trehgam (62.56 per cent), Karnah (61.86 per cent) and Lolab (58.77 per cent).

Sonawari segment in Bandipora district was at the top with 62.32 per cent polling followed by Bandipora (59.20 per cent) and Gurez (ST) (40.81 per cent), while two segments of Budgam and Beerwah recorded 52 per cent and 58.80 per cent

The polling on Monday sealed the fate of 22 candidates, including National Conference vice president and former chief minister Omar Abdullah, separatist-turned-former minister Sajad Lone and two-time former MLA and jailed Awami Ittehad Party chairman Sheikh Abdul Rashid, alias Engineer Rashid

Abdullah attributed the high voter turnout in the constituency to the electorate's identification with his party's stance on the developments post the abrogation of Article 370 and unaddressed issues during the absence of popular governance since 2018.

PDP president Mehbooba Mufti saw the high voter turnout as an expression of Kashmiri people's discontent with the revocation of the special status of Jammu and Kashmir and the erstwhile state's reorganisation into two Union territories -- highlighting a shift towards using ballots to voice dissent instead of resorting to violence.

Meanwhile, BJP leader Jahanzaib Sirwal said the record-breaking turnout in Baramulla following a notable 38 per cent polling in Srinagar, underscores a significant political awakening in the region, signalling a shift towards embracing democratic values and rejecting past misgovernance.

"We strongly commend the nearly 59 per cent turnout on the Baramulla Lok Sabha seat, which serves as a powerful endorsement by the people of Kashmir for the democratic values championed by the prime minister's visionary leadership.

'This historic turnout is a resounding rebuke to those political parties that have acted as brokers for years and a decisive rejection of Congress's disastrous policies in New Delhi," Sirwal said.

He said the turnout reflects the people's trust in the BJP's leadership and their desire for a peaceful, progressive Kashmir.

"The days of manipulation and misrule are over. Democracy has prevailed," he said, adding the people of Kashmir have spoken loud and clear, embracing democracy and rejecting the misgovernance of the past.

Sirwal said this turnout is not just evidence but an order of validation passed by the people of Kashmir for the establishment of democratic values under the leadership of Modi.

Millions Join Iran

For Islamic Republic, mass demonstrations have been crucial since millions thronged the streets of Tehran to welcome Grand Ayatollah Ruhollah Khomeini in 1979 following the triumph of the Islamic Revolution, and also attended his funeral 10 years later. Millions turned out in 2020 for processions for the late Revolutionary Guard Gen Qassem Soleimani, who was assassinated by the US in a drone strike in Baghdad.

Live images from Iran broadcast worldwide showed massive crowds of mourners jostling to touch coffins of the dead leaders through the streets of Tabriz city and later in Qom, the religious capital of the country.

A procession Tuesday morning led by a semi truck carrying the caskets of the dead slowly moved through the narrow streets of downtown Tabriz, the closest major city near the site of the crash Sunday. Thousands in black slowly walked beside the coffins, some throwing flowers up to them as an emcee wept through a loudspeaker for men he described as martyrs.

The caskets later arrived in Tehran to an honor guard at the airport and then went onward to the holy seminary city of Qom. There, a semi truck surrounded by soldiers in fatigues at one point was swarmed by a crowd of mourners. Some beat their chests and wailed. The truck later picked up speed while others stood alongside the road, watching.

The bodies will return to Tehran on Tuesday night for services Wednesday.

It remains unclear what international presence that funeral will draw, as Raisi faced US sanctions for his role while leading the country's judiciary in early days of revolution. On Thursday, Raisi's hometown of Birjand

will see a procession, followed by a funeral and burial at the Imam Reza shrine in the holy city of Mashhad, the only imam of the Shia faith buried That shrine has long been a center for pilgrims and sees millions visit each year. Over the centu-

ries, its grounds have served as the final burial site for heroes in Persian history. It's an incredibly high, rare honor in the faith. Iranian President Mohammad-Ali Rajai, the only other president to die in office when he was

killed in a 1981 bombing, was buried in Tehran. No cause has yet been offered by Iran's government for the crash, which took place in a foggy mountain range in a decades-old helicopter. Iranian presidents including Ahmadinejad and Abolhasan Banisadr both survived their own helicopter crashes while in office.

fundamental right, getting due to every employee for the service rendered against it, feels that denying such benefit to the petitioners, obviously, is bound to cause great inconvenience and prejudice to their rights.

One thing is clear that the authorities do not at all dispute the entitlement of the petitioners to receive either the arrears of COLA, leave salary or gratuity. But the only dispute is with regard to the inability of the Corporation to pay the same, the court noted.

"It is said that the Corporation is financially dependent wholly on the support of the Government extended to it from time to time and, therefore, the Government ought to be directed to provide the amount, which is payable to the petitioners," the court said and subsequently directed the Corporation to calculate the amount within a period of four weeks positively, and forward a proposal, seeking financial assistance, to the Government.

"...it is made clear that, whatever, amount is calculated as arrears by the respondent-Corporation shall be provided by the Government under a separate "Head". The said amount shall be made available in addition to the wages bill, which generally is provided by the Government to the Corporation," the court said.

High-Profile Committee

The court also directed them to suggest remedial measures including setting up of waste processing facilities to zero down landfill and submit the report before the Tribunal within eight weeks.

The committee comprises representatives from the Central Pollution Control Board (CPCB), the National Wetland Committee of the Ministry of Environment, Forest and Climate Change (MoEF&CC), the Deputy Commissioner of Srinagar, and the Member Secretary of the J&K Pollution Control Committee (JKPCC). The Deputy Commissioner of Sringgar will serve as the node agency, as per the order.

In his petition, Dr. Bhat, through his counsel Advocate Itisha Awasthi, has raised the grievance against "illegal and unscientific" dumping of municipal solid, bio-medical and plastic waste at the Achan landfill site.

As per the disclosure the said landfill site is the only dumping ground in the city of Srinagar and adjoining area.

"It has been pointed out by the learned counsel for the applicant that a canal passes by the side of landfill and it joins the Achan lake which ultimately forms part of the Dal Lake," Bhat submitted.

He further pleaded that almost 450 metric tons of waste is dumped every day at landfill site, which is spread over an area of 75

acres and which is located in close proximity to human habitation.

Bhat claims that dumping of waste at the landfill site is done in violation of Solid Waste Management Rule, 2016, the timeline set in the Action Plan for Municipal Solid Waste Management, Jammu and Kashmir, 2018, the Bio-Medical Waste Management Rules, 2016, and the Plastic Waste Management Rules, 2016.

Notably, as per Bhat, NGT has passed several orders earlier in 2015 and 2017 but they weren't implemented in letter and spirit.

The next date of hearing has been set for 30 August 2024.

ACB Files

If the charges are proven against the accused, the land and house in which Mirwaiz Umar is living shall be confiscated. 
