Model Code Of **Conduct Lifted: EC**

New Delhi: The model code of conduct that came into force on March 16 with the announcement of the Lok Sabha election has been lifted.

In a communication to the Union Cabinet Secretary and state chief secretaries, the Election Commission said as results of Lok Sabha elections and assembly polls in Arunachal Pradesh, Sikkim, Odisha and Andhra Pradesh, along with some assembly bypolls have been declared, "model code of conduct has ceased to be in operation with immediate effect".

The model code of conduct is a set of conventions agreed upon by all stakeholders and imposed during elections. Its objective is to keep the campaigning, polling and counting process orderly, clean and peaceful and check any abuse of state machinery and finances

by the party in power. While it does not enjoy any statutory backing, the Supreme Court has upheld its sanctity on several occasions. The Election Commission is fully authorised to investigate any violation of the code and pronounce punishment. The poll code | More on P6

Srinagar: Nearly 90 percent of the candidates vying for the five Lok Sabha seats in Jammu and Kashmir lost their security deposits, unable to garner onesixth of the votes polled in their respective constituencies.

The voters gave a decisive mandate to the eventual winners on all but one Lok Sabha constituency in the union territory, the Election Commission data revealed.

Out of 100 candidates in the fray, 89 lost their security deposits, the data showed. Sheikh Abdul Rashid, an

Independent contender who defeated political heavyweights -- former chief minister Omar Abdullah and People's Conference president

winning candidate who secured less than 50 per cent of the total votes polled, with a vote share of 45.70 per cent.

Baramulla is the only constituency in Jammu and Kashmir where the third placed candidate -- Sajad Gani Lone --" was able to save his security deposit.

Lone had polled 16.76 percent votes against the require-ment of 16.34 percent for saving the security deposit.

While National Conference leader Aga Roohullah Mehdi got the highest percentage of votes at 52.85, BJP's Jugal Kishore who made a hat-trick win from Jammu Lok sabha seat, garnered 52.80 per cent of the votes.

New Delhi: If payment of compensation becomes a consideration for reducing a sentence, it will have a "catastrophic" effect on the criminal justice administration, the Supreme Court has said.

The object of payment of compensation to the victim in a criminal case, it said, is to rehabilitate those who have suffered loss or injury by the offence and it cannot be a ground to reduce the sentence imposed upon the accused.

The court said it will result in criminals with a purse full of money to buy their way out of justice, defeating the very purpose of criminal proceedings.

Section 357 of the CrPC empowers a court to award compensation to victims while passing a judgment of conviction.

A bench of Justices J B Pardiwala and Manoj Misra said the idea of compensation is based on the theory of victimology which recognises the harsh reality that victims are unfortunately the forgotten people in the criminal justice delivery system.

"Payment of victim compensation cannot be a consideration or a ground for reducing the sentence imposed upon the accused as victim compensation is not a punitive measure and only restitutory in nature and thus, has no bearing with the sentence that has been passed which is punitive in nature," the bench said. MeT Predicts More Rains In J&K

Srinagar: The weatherman here on Thursday forecast rain and thundershower at most places in Jammu and Kashmir during a few days. Also, rainfall at scattered places during the last 24 hours led to drop mercury during night across J&K and barring Pahalgam and Kupwara, all places recorded below normal temperature.

A meteorological department official said that there is a possibility of rain/thundershower at most places with moderate to intense showers at few places for a brief period towards late afternoon and evening today. He said that there is a possibility of thunder/lightning accompanied by gusty winds during the time.

From June 7-8, he said, there is a possibility of light rain/ thunder at a few places towards afternoon.

Partly cloudy to generally dry weather has been forecast from June 9-15.

He said in last 24 hours till 0830 a.m., Srinagar received 5.8mm, 14.6mm, Pahalgam 8.8mm, 5.9mm, Kokernag Kupwara 14.4mm, Gulmarg 15mm, Jammu 9.2mm, Banihal 17.2mm, Batote 17.6mm, Katra 12.7mm and Bhaderwah 17.7mm.

Regarding temperature, he said, Srinagar recorded a low of 12.2°C against 12.6°C on the previous night and it was 1.2°C below normal for the summer capital of JK for this time of the year.

Qazigund recorded a mini-mum of 11.8°C against 11.0°C on the previous night and it was 0.2°C below normal for the gateway town of Kashmir, he said. | More on P6

Won't Allow Anyone To Hurt Religious Sentiments: IGP

Urges People To Maintain Peace, Communal Brotherhood

Srinagar: Inspector General of Police (IGP) Kashmir V K Bhirdi Thursday said that police have taken strong note of the posting of sensitive content against religious sentiments at Government Medical College (GMC) Srinagar and strict action will be taken against those found involved in hurting the religious sentiments of any community.

IGP Kashmir said that J&K police respects all religions and people belong to various sects and faiths. "We have taken strong note of the GMC incident. An undergraduate student enrolled in the college has been charged with sacrilege,"



the IGP said.

The provincial police chief urged people to maintain peace and communal brotherhood and resist giving in to the cunning plans of miscreants

who seek to sow hatred among various communities.

"Strict actions shall be initiated against anyone found involved in violating directives and indulging in any activity that leads to law and order issue in the valley," Birdi said addressing media here. IGP Kashmir said the Jammu

and Kashmir police instantly took cognizance of the matter and registered a case against the accused. "Since religious matters are

sensitive, police become more considerate when it comes to the religious sentiments of any community. We will not allow anyone to harm religious feelings of any community," Birdi said.

Earlier in the day, Srinagar

police on X said that a criminal case has been registered against the accused student at police station Karan Nagar and investigation into the instant matter, which led protests at GMC Srinagar, are on.

A formal case FIR no 13 of 2024 under sections 153/153A, 295A and 505(2) of Indian Penal Code (IPC) was registered in this regard following protests by fellow students against the 'disrespectful' display of Prophet Muhammad's (SAW) name on social media messaging app 'WhatApp'.

New Delhi: The National Testing Agency (NTA) on Thursday clarified that the increase in cut off and number of toppers in the NEET-UG reflect the competitive nature of the exam and maintained that the test's integrity has not been compromised.

The clarification came amid allegations of irregularities in the medical entrance exam NEET (National Eligibilitycum-Entrance Test) -- conducted on May 5 at 4,750 centres in 571 cities, including 14 abroad -- and inflation of marks.

'The increase in cutoff reflects the competitive nature of the examination and the higher performance standards achieved by the candidates this year," a senior NTA official said.

"The number of candidates who appeared in 2023 was 20,38,596 while the number of candidates who appeared in 2024 increased to 23,33,297. The increase in candidates naturally led to an increase in high scorers due to a larger pool of candidates," the official added. On the grace marks awarded

'Warming Climate Affecting Snowfall, Raising Risk Of Summer Droughts'

cross the Northern Hemisphere, declining snowfall is affecting seasonal river flows, thereby increasing the risk of summer droughts, a new research has found.

Researchers explained that this could threaten water and food security, ecosystems and hydropower generation. The team, led by researchers from the University of Bristol, UK, found that as the planet warms, snowy regions in the Rocky Mountains of North America, the Alps in Europe, along with those in northern Europe, are thawing prematurely.

Further, seasonal stream flows in less snowy areas are delayed as winters are becoming drier and warmseason rain arrives later in the year becoming a more dominant source of river flow, they explained.

"The increased (year-onyear) variability of streamflow seasonality implies greater uncertainty in sea-

sonal streamflow patterns, posing challenges for water resource planning and management." said Ross Woods from the University of Bristol and lead author of the study published in the journal Nature.

"Water managers need different strategies to adapt to this, depending on their location. Future planning for water infrastructure will need to take account of these changes in seasonal river flow," said Woods.

For the study, the researchers looked at climate and river flow data from 1950-2020 for more than 3,000 river basins across the northern hemisphere. For every year, they calculated the amount of precipitation falling as snow, how this amount changed with time, along with its

timing in every season, and river flows. The team then compared these values with observed during those two ten-year periods - one with the highest snowfall amount, and the other with the lowest snowfall amount

Noor Jahan Bridge Draws Online Satire Over Slow Construction

Srinagar: The Qamarwari Bridge, famously known as the Noor Jahan Bridge, has become a subject of widespread online satire due to its slow construction progress. Netizens have taken to social media, creating memes and posting satirical comments to troll the authorities over the delay of the bridge's construction. A Facebook page, Mukhtar

A Facebook page, Mukhlar The Speaker, posted a video referring to the bridge as the "8th wonder of the world," humorously suggesting that its 'grandiosity' is the reason for the prolonged construction period. The video has garnered more than two lakh views and sparked a wave of satirical comments.

Another social media page on Facebook, Speaking Mirza, shared a meme with the caption, "I saw two people working on the bridge, I think it will take another 250-300 years for the administration to complete the bridge." The post invited numerous comments from frustrated commuters and residents. Umar Sheikh, a social media user sarcastically

commented, "These two people have been there for decades; their dedication must be appreciated." His comment highlighted the public's frustration with the lack of visible progress.

Ashiq Bhat, another social media user, pointed out the disparity in construction speed between the Noor Jahan Bridge and other infrastructure projects in the area. "The work on the nearby flyover in Bemina and Sanat Nagar is about to get completed in a span of two years, whereas this bridge hasn't seen much progress."

The Noor Jahan Bridge project, intended to ease traffic congestion and improve connectivity in the Qamarwari area, has faced multiple delays since its inception. The slow pace of construction has led to mounting public frustration, with many calling for increased accountability and transparency from the authorities.

Earlier, speaking to Kashmir Observer, Chief Engineer R&B, Sajad Naqib had said the construction of the bridge was ongoing and traffic would ply on the bridge soon.

For city dwellers and visitors to Srinagar, the ride on the 'Cement Bridge'—the currently used bridge adjacent to the Noor Jahan Bridge—is tiring and bumpy. Commuters report that the pivotal bridge has developed potholes, which not only affect

vehicular movement but also cause damage to vehicles." Ashiq Shagoo, took satire to another level by referencing the Cement Bridge is the first concrete bridge in city Kashmir's and the Noor Jahan bridge is the last bridge in Kashmir is being

constructed in its vicinity." Pertinently, the Noor Jehan Bridge is spread over 127 meters and connects Noorbagh with the Qamarwari side over river Jhelum. Once completed, the bridge will lessen traffic on the already existing 'Cement Bridge' which over the period of time has served as an important link between Shahr-e- Khaas and other areas of North Kashmir.

The construction of the Noor Jahan Bridge started in 2011. Initially, the bridge was scheduled to be completed in the year 2014. Later, the deadline was extended to March 2017 and then


upto December 2018. In March 2022, a senior official told Kashmir Observer that it would be completed by the end of 2022; however, it missed that deadline as well.

After missing several deadlines, authorities in 2022 said the work on the much-awaited Noorbagh-Qamarwari Bridge was going to get completed by March 2023.However that promise has not been fulfilled.

Kashmir Observer has done a series of stories over a period of more than 13 years highlighting the negligent attitude of officials towards the completion of the bridge.

Throughout the passage of time since its inception, many senior officials from the R&B department, entrusted with the oversight of its construction, have retired, leaving behind a legacy of unfulfilled potential in the form of the Noor Jahan Bridge.

As the online trolling continues to gain momentum, it remains to be seen how the administration will respond to the growing public outcry and whether the pace of construction on the Noor Jahan Bridge will finally accelerate.

PM Modi's Coalition Challenge

Three days after the outcome of the national elections, the political repercussions are still playing out across the country. The result has brought the unpredictability back in Indian democracy, which many people have welcomed. Prime Minister Narendra Modi, despite securing an unprecedented third term, saw his BJP fall short of the parliamentary majority they sought. This has somewhat dented his dominant image, but the remarkable turn of events has also demonstrated the free and fair nature of India's electoral processes.

The BJP's weakened position means it will rely more heavily on coalition partners, like the JD(U) and TDP, which have a history of shifting alliances. This could lead to a more consensus-driven approach in policymaking. Upcoming state elections in Maharashtra, Jharkhand, and Haryana will be critical in shaping the BJP's priorities o=in near future.

Ultimately, this election reaffirms the faith in India's democracy. It demonstrates that even dominant political forces are subject to the will of the electorate. The outcome offers a balance of stability and continuity, while restraining the BJP's ability to pursue its nationalist agenda.

Going forward, it remains to be seen how the top BJP leadership adjusts to coalition dharma, which has so far been alien to them. Over the past decade, the party has been in a commanding position with the allies at its mercy. Now, reverse is the case with the allies such as TDP headed by N Chandrababu Naidu and JD(U) led by Nitish Kumar, calling the shots. What is more, the ideological clash between the BJP on one hand and the TDP and JD(U) on the other couldn't be starker. But the beauty of democracy is for the ideologically divergent parties to work together and act in the best interest of the country.



The High Cost of NEET Obsession

Mental Health and Career Counseling as Remedies

he National Eligibility cum Entrance Test (NEET) stands as a pivotal examination for students aspiring to enter the medical profession in India. The stakes are undeniably high, but what exacerbates the pressure is the toxic culture fostered by many coaching institutes. These institutes often instill a detrimental belief in students that their entire future hinges on cracking NEET, leading to severe psychological repercussions. This narrative not only undermines the diverse potential of students but also grossly simplifies the concept of success in life.

THE TOXIC CULTURE OF COACHING INSTITUTES



Want to Be Happy? Help Other People

e all want to be happy. This is the driving force behind so much of what we do in life. But it's not always intuitive what types of activities and situations lead to happiness. Predicting how we are going to feel in a given circumstance is what psychologists refer to as affective forecasting. All of us make such predictions every day without thinking, and it shapes how we prioritize our lives. Unfortunately, we are surprisingly poor judges of what makes us happy. This is one of the reasons why life is so complicated. We end up spending loads of time investing in pursuits that don't necessarily lead to deep and enduring happiness.

As a case in point, if you were asked whether you would prefer to win the lottery or suffer a terrible accident that left you paraplegic, your answer would be obvious. Of course, you would be much happier as a lottery winner than an accident victim. Such a study was done, by the way. In the 1970s, Philip Brickman and his colleagues compared happiness and well-being between

paraplegic accident victims and lottery winners. Surprisinglyand as a testament to our collective inability to predict how we will feel in a given situation-in terms of their abilities to enjoy everyday pleasures, there was no difference between the lottery winners and the accident victims. If anything, the lottery winners had a bit less ability to enjoy things (though this difference wasn't statistically significant).

Why are we so bad at predicting what will make us happy?

Part of the answer is that our brains evolved in a time of relative scarcity. Because of this, our intuitions often lead us to believe that more material possessions (which, at one point in our distant past, helped us survive) will make us happier. We are psychologically wired to believe that if we can just obtain more material goods or get that promotion with higher pay, then we will finally be happy. But nature hasn't prepared us to live in a time of relative abundance. We aren't equipped with a psychological gauge that indicates when we have enough for our happiness. As social philosopher Adam

Smith rightly observed: "The desire for food is limited in every man by the narrow capacity of the human stomach; but the desire of the conveniences and ornaments of building, dress, equipage, and household furniture, seems to have no limit or certain boundary."

Modern psychological studies have repeatedly made clear that, beyond having what is sufficient to meet our basic needs, more wealth does not lead to more happiness.

Here's another example of how we're bad at predicting what leads to happiness: a long list of experiments has shown that helping others leads to deep feelings of reward and satisfaction, sometimes more so than when we help ourselves. Yet most of us don't walk around thinking: If I could only find more people to help today, then I could be happier. (Can you imagine how different the world would be if we intuitively realized that helping others will increase our happiness?) However, the evidence suggests that such thinking would be more psychologically accurate than the natural intuitions that we actually have.

Experiments confirm that altruism is rewarding

In one study published in the journal Science, university students were given some money in an envelope. Half of the students were instructed to spend the money on themselves-either on a bill, an expense, or a personal gift-by the end of the day. The other half were told to spend it on someone else or donate it to a charity. Surprisingly to most people (including the students themselves), those who spent the money on others were happier by the end of the day. Similar experiments have confirmed the finding that altruism is rewarding.

Encouragingly, the happinessinducing characteristic of generosity may even be hard-wired into human nature. Evidence for this comes from the observation that this phenomenon seems to emerge quite early in childhood. Among toddlers younger than two years of age, those who give away treats are happier than those who receive treats. And, curiously, what researchers refer to as "costly giving" seems to lead to more happiness than non-costly giving. Giving away something that is yours (which requires sacrifice), as opposed to giving away something that isn't yours, brings more emotional reward.

None of this is to say that we shouldn't spend time on self-care. We all need time for relaxation and recreation. But if we're not careful, our brains unwittingly lead us in the direction of overinvesting in ourselves and our careers and under-investing in helping others—which can be a recipe for loneliness, and hence unhappiness.

If you're considering enhancing your altruistic footprint to maximize your happiness, it's important to note that not all giving is created equal.

Here are a few rules to keep in mind:

1. Unpaid service is generally more emotionally rewarding than if you are compensated for your time and labor. (Remember the finding that service that requires sacrifice is more rewarding than service that doesn't.) Why is this the case? It seems that extrinsic rewards, such as money, can paradoxically undermine our intrinsic motivations and rewards for helping. Relatedly, being compensated

for service may make the interaction more transactional and less about the goodwill of giving.

2. Begrudged service isn't very rewarding. It could lead to resentment and, therefore, less happiness. This doesn't mean it's a bad idea to lovingly coax your teenage children into doing chores or volunteering at a rest home. It just means that they (and you) will maximize the emotional reward reaped from service by having a good attitude.

3. Face-to-face giving seems to be the gold standard. Serving others in a way you can interact with them and experience their gratitude produces more emotional rewards than virtual or anonymous service. This likely has to do with the fact that we evolved in relatively small, nonvirtual communities where face-to-face interactions were the norm. It's not that virtual or anonymous types of service aren't important, but if you're trying to maximize the bang for your buck, try to find opportunities to help in your backvard.

4. To be happier, political activism (even if it's unpaid) is not the same as helping others. Spending time in the service of a political cause is often a zero-sum game. When the side you're on wins, it can be elating. But when you lose, you can be left with feelings of deep disappointment and nihilism. On top of this, as Arthur Brooks has noted, so much of modern political activism breeds deep feelings of "anger and contempt for people on the 'wrong side' of the issue." These sorts of feelings can take a psychological toll on our happiness. This isn't to say there aren't important causes to rally behind. But if you spend all your discretionary time as an activist and none of it in other kinds of service, your mental health will suffer.

The next time you find yourself with some unexpected time that you're not sure how to fill, remember that you're not very good at predicting what will make vou happy. Your brain will tell you that you should catch up on a work assignment, check your email, or engage in some other activity to "get ahead." But if you want to maximize vour happiness, try doing something for someone else.

494 marks out of 500. "I worked hard and I expected good results," Adeeba said. She attributed her success to the support of her teachers and the effectiveness of the test series she attended.

"I was consistent and my parents were supportive, I am thankful for that, my teachers also helped me a lot."

Aamina Rashid of Govt Higher Secondary School Chadoora and Aisha Riyaz of Govt Girls Higher Secondary School Khanyar Srinagar both earned 493 marks, securing 2nd position in the Science stream.

"I scored similar marks in past years as well. One needs to study from the beginning. Studying only after the exam date sheet is announced is completely wrong and not the right thing to do," Aisha said.

The arts stream was aced by Basna Shah (495 marks) of Govt Girls Higher Sec School Kothi Bagh Srinagar. Hoor Sajid of Green Valley Educational Institute Ellahibagh Srinagar and Seidra Mukhtar from Govt Higher Secondary School Arihal followed closely behind with 494 marks.

Home Science was no different, with Ainain Niyazi (494 marks) clinching the top position.

BOSE said that a total of 93,340 candidates were enrolled for the exams in which 69,385 successfully qualified it.

Stating the overall performance of the candidates, BOSE said that a total of 46,500 male and 46,786 female candidates were enrolled for the examination out of which 74 percent qualified it.

In the exams, a total of 25,435 students have registered distinctions, 33,437 secured first divisions, 10,318 bagged second division and 195 candidates registered third division.

BOSE further said that in the examination, 1034 students couldn't qualify the exams while 22,921 have been asked to reappear in the exams.

Pertinently, the annual regular examination of class 12th commenced from April 8 in hard zone areas while the examination in the soft zone areas commenced from March 6.

Following the implementation of Uniform Academic Calendar, JKBOSE has classified regions via soft and hard zone areas keeping in view the different weather conditions.

BOSE had said that the annual regular examinations held by the board for classes 10th, 11th and 12th shall be held in the month of March in both the divisions of Union territory of JK and Union Territory of Ladakh excluding hard zones.

The Board however had said that the annual regular examination of hard zone areas of Union territory of JK and Union territory of Ladakh shall be held in the month of April.

The board had further said that the results of annual regular examination of Kashmir division and Jammu division and Union territory of Ladakh including hard zones shall be declared simultaneously in the month of June. (With inputs from agencies)

Cooperation) countries attended Modi's first swearing ceremony when he took the reins as the prime minister after a massive electoral victory for BJP.

Leaders of the BIMSTEC countries attended Modi's swearing-in ceremony, in 2019 when he became prime minister for the second consecutive term.

Though the BJP could not get a majority on its own in the polls, the party-led alliance secured 293 seats out of 543. The majority mark in the lower house is 272.

which has won 16 seats, Nitish Kumar's JDU (12), Eknath Shinde's Shiv Sena (7) and Chirag Paswan's Lok Janshakti Party-Ram Vilas (5).

N Chandrababu Naidu and Nitish Kumar, both coalition-era veterans, have emerged kingmakers in this election and are learnt to have demanded plum roles at the Centre for their support.

TDP, it is learnt, has also sought the Lok Sabha Speaker's post, while JDU sources said they may press for a Common Minimum Programme for the NDA government and hope that a coordination committee formed for its implementation is led by Nitish Kumar.

The BJP, sources said, is not ready to give away the Speaker's role and TDP may be offered a Deputy Speaker post. JDU holds the Rajya Sabha Deputy Chairman post anyway.

There is another big change. The Narendra Modi governments formed after the 2014 and 2019 elections had only symbolic representation of allies because the BJP had absolute majority on its own. But this time, the BJP may have to distribute ministerial berths in proportion to seats won by each ally.

The BJP, however, is not keen on accommodating allies in four key ministries that come under the Cabinet Committee on Security -- defence, finance, home affairs and external affairs.

The BJP will also not want to let go of portfolios that are critical to its infrastructure push, such as road transport and highways, or its welfare agenda. Among the BJP's promises in the run-up to the election was support to four "castes" identified by Prime Minister Modi -- the poor, women, youth and farmers. The BJP will be looking to retain control in portfolios relating to these groups.

Construction of roads and highways in the past 10 years of Narendra Modi government has received appreciation. Led by Nitin Gadkari, this push has enhanced connectivity to remote areas. The BJP would not want to lose momentum by giving charge to one of its allies, sources said.

Another key portfolio is the Railways. While JDU sources have said they are keen to get the Railways ministry charge, held by Nitish Kumar in the past, voices in the BJP argue that key reforms are underway in this sector and any disruption may stall them.

In the past two Narendra Modi governments, allies received roles in relatively low-key portfolios such as food processing and heavy industries.

But this time, the BJP may have to agree to some of its allies' demands, as they do not have a majority on their own. The high court had also said the convicts need not undergo even the four-year sentence, if they paid Rs 2.50 lakh to the victim.

The apex court noted that 12 years have gone by since the incident occurred and the convicts have already deposited Rs 5 lakh.

The bench said, "We are not inclined to direct them to undergo further sentences of four years".

"I didn't agree with Rashid's detention in the first place and I don't agree with it now but that's neither here nor there because it shouldn't be just about one man but about the 1000s in jail, including the anonymous ones outside Jammu and Kashmir," he said.

Detailing the reason behind inflation of marks, the NTA said it received representations on the matter.

"Such cases and representations were considered by the NTA and the normalisation formula, which has been devised and adopted by the Supreme Court, vide its judgment dated 13.06.2018, was implemented to address the loss of time faced by the candidates of NEET (UG) 2024."

"The loss of examination time was ascertained and such candidates were compensated with grace marks. So, there marks can be 718 or 719 also," it said in a statement.

On allegations of unclear implementation of grace marks, the NTA official told PTI that the question paper was prepared using a new NCERT textbooks. However, some students had old NCERT textbooks.

"We received a representation on this issue as well due to which NTA had to assign five marks to all students who had marked one of the two options. Because of this reason, marks of a total of 44 students increased from 715 to 720, which resulted in an increased number of toppers," the official said.

After several court cases and representations raising concerns over loss of time during exam were received, a committee was formed to look into the matter, the official said, adding that the committee went through everything and the loss of time was ascertained.

"Such candidates were compensated with grace marks. Therefore, the marks of students at some centres are high because it is likely they all benefitted from grace marks," the official added.

According to experts, the mark inflation in NEET UG 2024 result is expected to make securing a spot in medical school this year more difficult. Some aspiring students have turned to online platforms to demand the cancellation of the results and a re-examination.

"Several students are raising some valid points. How come students with same sequence roll number scored the same marks. This is a serious issue.

"We don't want such doctors to serve our country. This must be investigated," said Anubha Shrivastava, a lawyer and president of India Wide Parents Association.

An aspirant took to X and said, "67 students scoring 720 out of 720 marks in the results released after the NEET exam paper leak raises suspicion. This is playing with the future of lakhs of candidates of the country, due to which there is anger among the students. The government should conduct a high-level investigation".

Another X user Nitish Rajput said NTA awarded grace marks according to the court order but the students argue this sudden decision is unjust as the agency has not mentioned any methodology to award these 'grace marks'.

"Calls for transparency in the process have only grown louder. The controversy for the NTA is brewing as lakhs of students demand re-examination citing lack of clarity in NTA's explanations and have even pushed for the Supreme Court's intervention. Grace marks given for lost exam time have raised concerns of fairness" he added

No project or scheme that may have the effect of influencing the voter in favour of the party in power can be announced, and ministers cannot use official machinery for campaign purposes when the poll code is in effect.

Compensation To

(CrPC) is intended to reassure the victim that they are not forgotten in the criminal justice system.

It is a constructive approach to crimes based on the premise that mere punishment of the offender may not give solace to a victim or their family, it said.

"As such, when deciding the compensation which is to be paid to a victim, the only factor that the court may take into consideration is the convict's capacity to pay the compensation and not the sentence that has been imposed. In criminal proceedings the courts should not conflate sentence with compensation to victims," the bench said.

The top court's observation came while hearing a plea filed by a man named Rajendra Bhagwanji Umraniya challenging an order of the Gujarat High Court which reduced the five years sentence imposed upon two men to four years jail in a criminal case. On analysing CCTV camera footage, it was ascertained that the integrity of the examination was not compromised, the official asserted.

Several aspirants of the medical entrance exam have alleged inflation of marks which led to a record 67 candidates bagging the top rank, including six from the same exam centre in Haryana.

Denying the allegations, the NTA said the changes made in NCERT textbooks and grace marks for losing time at the examination centres are some of the reasons behind the students scoring higher marks.

In a post on X, the Congress said, "After the NEET exam, now the NEET result is also in controversy. After the NEET results were declared, questions are being raised on six students from the same centre getting 720 out of 720 marks. Apart from this, many other irregularities related to the NEET exam have also come to light."

"First due to paper leak and now due to result error, the future of lakhs of youth of the country is getting ruined. It is clear that this government cannot get any paper done without leaking it. The NTA had on May 5 claimed that the distribution of wrong question papers at an exam centre in Rajasthan led to some candidates walking out with the papers. The agency had denied any leak of the question paper.

A day later, the NTA had reiterated that the reports claiming question paper leak in the medical entrance exam NEET-UG are "completely baseless and without any ground", and every question paper has been accounted for.

Won't Allow Anyone

The blasphemous act evoked condemnation by several unions including Jammu and Kashmir Students Association (JKSA) and Resident Doctors Association, demanding exemplary punishment to the accused.

The police had urged people to refrain from spreading rumors and false information and ask them not to fall prey to false propaganda of anti-social elements.

"Legal action shall be taken against those who are found to be involved in provocative act/instigation." Police said.

Meanwhile, in view of the incident, Govt Medical College (GMC) Srinagar, Govt. Medical College (GMC) Baramulla and National Institute of Technology (NIT) Srinagar on Thursday ordered the suspension of classwork for students.



MADRID, SPAIN: After Spain recognised Palestinian statehood, Pedro Sanchez met with his Palestinian counterpart, Prime Minister Mohammad Mustafa, and leading officials from several Middle Eastern countries in Madrid.

Saudi Arabian Foreign Minister Prince Faisal bin Farhan Al Saud, Qatari Prime Minister Sheikh Mohammed bin Abdulrahman Al Thani, and the foreign ministers of Turkey and Jordan were among the group that later posed for a photo on the steps of the Moncloa Palace in the Spanish capital.

"On behalf of President [Mahmoud] Abbas and the government of Palestine, the people of Palestine, we warmly welcome Spain's recognition of the state of Palestine," Mustafa said of Spain's historic move. "This recognition strengthens our resolve to continue our struggle for a just and lasting peace.

Ireland, Norway and Slovenia have also joined Spain in the push that has been roundly condemned by Israel.

Israeli Foreign Minister Israel Katz sent a furious direct message addressed to Sanchez on X, writing: "Hamas thanks you for your service," along with a 17-second video that flipped between images of flamenco dancers and apparent scenes

of the Palestinian group's incursion into southern Israel on October 7.

"It is the year 2024, the days of the Inquisition are over. Today the Jewish people have a sovereign and independent state, and no one will force us to convert our religion or threaten our existence - those who harm us, we will harm them in return," said Katz, a member of Prime Minister Benjamin Netanyahu's Likud party.

For months, diplomatic relations between Israel and Spain have descended to new lows. Each side has summoned ambassadors as the war in Gaza rages.

After Spain's landmark move, Israel ordered the Spanish consulate in Jerusalem to halt services to Palestinians in the occupied West Bank as a "punitive" measure. And tensions are certain to

rise further, as Spain on Thursday announced it would join South Africa's genocide case before the International Court of Justice against Israel's actions in Gaza.

Spain is the first European nation to back the case.

Long a supporter of Palestinian rights, Spain led the push towards recognition hoping to pave a pathway to peace and a two-state solution.

Sanchez said the "historic decision ... has a single goal and that is to help Israelis and Palestinians achieve peace".



According to some observers, pressure from Sumar, a far-left party and the junior partner in Spain's coalition government, had an impact on the final decision by Sanchez, who also reportedly plans to host an international peace conference in Madrid.

But Manuel Muniz, dean of the School of Politics, Economics and Global Affairs at the IE University in Madrid, said Israel may oppose Spain's involvement in future peace talks. "In terms of the impact on

Spain-Israel relations, it is quite evident that the short-term effects are significant," he told Al lazeera.

"What has made the difference now is the war in Gaza and the pressure of Sumar to recognise the Palestinian state," he told Al Jazeera.

Barrenada said since the death of the dictator General Francisco Franco in 1975, all Spanish governments of differing political colours have supported Palestine's right to a state.

Away from the political arena, popular opinion in Spain appears to favour backing a Palestinian state.

A survey for the Real Elcano Institute, a think tank based in Madrid, found 78 percent of Spaniards favoured the recognition of Palestine, while 18 percent were against and 4 percent did not know.

Jorge Hernandez, 42, a car company executive from Barcelona, believes Spain had to act. "The United States and Brit-

ain are doing nothing but the killing on both sides goes on. Other countries must do something. I don't know if recognising Palestine will make any difference, but we have to put some pressure so the fighting stops," he told Al Jazeera.

But among Spain's small Jewish population, estimated to number about 50,000, some say the atmosphere has worsened since October 7.

On that day, Hamas led an incursion into southern Israel

that sharply escalated the his-toric Israel-Palestine conflict, during which 1,139 people were killed and 250 were taken captive.

Israel's onslaught of Gaza since, by far its deadliest war on the besieged enclave, has killed more than 36,000 Palestinians to date, according to health officials.

Israel's justification for its military campaign of crushing Hamas remains elusive.

Ruth Timon, 57, a Jewish lawyer from Madrid, says she avoids conversations about Gaza in case they blow up into a row.

She said her son has faced verbal abuse at the Madrid university where he is a student.

She believes that Sanchez's decision to recognise Palestine was motivated by domestic political factors.

Spain's left-wing coalition government depends on smaller regional parties for a majority but has failed to pass this year's budget and other laws.

"Politically in Spain we are in a complicated situation. No laws have been passed. The government cannot do anything, so it concerns itself with international politics," Timon told Al Jazeera.

"Sanchez is focusing on Palestine and Ukraine ahead of the European elections. [His] Socialist party, I think, believes supporting Palestine may bring support in the European elections.

93% Of Lok Sabha Poll Winners Are Millionaires: Report

NEW DELHI: A staggering 93 per cent of the candidates who won the 2024 Lok Sabha elections are millionaires, up from 88 per cent in 2019, according to an analysis by poll rights body Association of Democratic Reforms (ADR).

The top three wealthiest candidates are TDP's Chandra Sekhar Pemmasani from Andhra Pradesh's Guntur constituency with assets worth ₹5,705 crore, BJP's Konda Vishweshwar Reddy from Telangana's Chevella with total assets amounting to ₹4,568 crore and BJP's Naveen Jindal from Haryana's Kurukshetra with assets worth ₹1.241 crore

In 2019, 475 (88 per cent) winning candidates were millionaires and 443 (82 per cent) in 2014.

The trend indicates a steady climb since 2009 when only 315 (58 per cent) MPs were millionaires.

It found ity of a millionaire candidate clinching victory in the 2024 Lok Sabha elections stood at 19.6 per cent, compared to a meagre 0.7 per cent for candidates with assets less than a crore.

The analysis also provides a breakdown of wealth distribution among the winning candidates.

The data showed that 42 per cent of the candidates possess assets totalling ₹10 crore and above.

While 19 per cent of the candidates fall within the bracket of ₹5 to 10 crore, 32 per cent hold assets ranging between ₹1 and 5 crore.

Only about 1 per cent of the winning candidates have assets worth less than ₹20 lakh.

More Women Voted Than Men In Seventh Phase Of **Polls: Poll Body Data**

NEW DELHI: The women voter turnout was more than that of men in the seventh phase of the Lok Sabha elections held on June 1, according to data released by the Election Commission (EC) on Thursday.

The women voter turnout was 64.72 per cent while that of men was 63.11 per cent. The turnout of persons of the third gender was 22.33 per cent, the data showed.

Similar trends were witnessed in the fifth and sixth phase of the polls held on May 20 and May 25 respectively. In the fifth phase, the women voter turnout was 63 per cent and that of men was 61.48 per cent. In the sixth phase, 61.95 per cent men and 64.95 per cent women voted, according to EC data.

The overall voter turnout of the 2024 general election



was 65.79 per cent, it said In the seventh phase, Himachal Pradesh, Jharkhand, Odisha and Uttar Pradesh were among the states that had a higher women voter turnout.

In Himachal Pradesh, the turnout of women voters was 72.64 per cent while that of men was 69.19 per cent, it was 73.75 per cent for women and 68.10 per cent for men in Iharkhand and it was 76.50 per cent for women and 72.42 per cent for men in Odisha.

In Uttar Pradesh, the women voter turnout was 58.56 per cent compared to 53.47 per cent for men.

2 Former Punjab Police **Officers Convicted In 1993 Fake Encounter Case**

NEW DELHI: A special CBI court in Mohali has convicted the then DSP, city, Dilbagh Singh and the then SHO Gurbachan Singh of Tarn Taran on Thursday for the extra-judicial killing of a fruit seller after abducting him from his residence in 1993

Gulshan Kumar was abducted from his residence on June 22, 1993, kept in illegal detention for a month, and was killed in a staged encounter on July 22 that year, officials here said.

The special court found Dilbagh Singh, who retired as DIG, and Gurbachan Singh, who retired as Deputy SP, guilty. Three other charge-sheeted police officers -- ASI Arjun Singh, ASI Devinder Singh, and SI Balbir Singh -- died during the trial. The court will announce the quantum of the sentence on Friday.

The case was handed over to the CBI in 1995 on the orders of the Supreme Court. The agency filed its charge sheet in 1999. After 21 years, charges were framed against the accused on February 7, 2020.

9 Indian Trekkers Killed **After Getting Trapped During Blizzard In Himalayas**

NEW DELHI: At least nine Indian trekkers died in the Himalayas after getting trapped during a blizzard, authorities said on Thursday, as rescue teams airlifted their bodies and five survivors to safety.

The Indian Air Force shared footage on Thursday that showed rescue teams working near a helicopter in the snow-covered mountains.

The group of climbers from the southern state of Karnataka were hit by heavy snowfall in the remote mountains of Uttarakhand state in north India, said Krishna Byre Gowda, a top Karnataka

'Snow intensified into blizzard. By 6 PM, 2 trekkers succumbed to bad weather. Snow and wind made movement impossible. Visibility dropped to nil. They huddled together for the night on the

route. Some more succumbed in the night," Gowda wrote in a social media post on Wednesday.

A guide with the group alerted rescuers about the situation on Tuesday evening after trekking for a while to find mo-bile network connectivity, and teams reached the spot early on Wednesday, the minister added.
