NEET Exam Row

Grace **Marks To Be Reviewed: NTA**

New Delhi: Amid allegations of inflation of marks in the NEET-UG medical entrance exam, the National Testing Agency (NTA) announced on Saturday that the education ministry has set up a four-member panel to review the grace marks awarded

to more than 1,500 candidates. The NTA also denied any irregularities and said the changes made in the NCERT textbooks and grace marks for losing time at the examination centres were some of the reasons behind the students scoring higher marks.

The issue also took political turn with several parties raising concerns about the authenticity of the national exam for medical courses. The AAP demanded a Supreme Court-monitored SIT probe while the Congress alleged that paper leaks, rigging and corruption have become an integral part of many examinations. The party also accused the BJP of cheating youngsters and playing with their futures.

The Maharashtra government sought immediate cancellation of the exam, alleging that its results have caused injustice to the students from the state. The Akhil Bharatiya Vidyarthi Parishad (ABVP), the student wing affiliated to the RSS, de-

manded a CBI inquiry.

60 Trucks Of Sheep Enter Kashmir Daily

Srinagar: With Eid-ul-Azha approaching, the Kashmir Valley is witnessing a substantial arrival of sacrificial animals, with daily truckloads of sheep making their way into the region. This inflow began days ago and is expected to continue until two days before the festival.

Merajudin, General Secretary of Mutton Dealers Association Kashmir, said, "This year, we have a variety of high-quality breeds from outside the state, including Rajasthani, Marwadi, Kaju Walla, Jaisalmiri among others. Currently, these out-ofstate varieties are known for providing the best quality meat for buyers."

Sharing details about live-stock arrival in the valley, he said that on average, 50 to 60 trucks loaded with sheep are arriving in the valley daily. The supply from outside the state remains strong and will continue up to two days before Eid.

Regarding market conditions, Mehraj said there is a discrepancy between supply and sales. "Sales have not met our expectations so far, but the true level of consumption will become clear after Eid," he said.

As the festival approaches, both mutton dealers and consumers are closely observing market trends, anticipating a potential rise in demand days before Eid.(KNO)

Tourists Filmed Drinking Alcohol In Dal Cause Stir

Srinagar: A video circulating on social media that shows tourists consuming alcohol while taking a ride on a shikara in the iconic Dal Lake.has sparked controversy in Jammu and Kashmir.

Netizens and religious scholars have condemned the act and are demanding action from the authorities.

"Permitting Dal Lake is a blatant disregard for the cultural and religious principles of Kashmiri people. This is not acceptable at all," a user posted on X.

The Muttahida Mailise-e-Ulama, an amalgam of religious scholars headed by Mirwaiz Umar Farooq, on Saturday

urged the Jammu and Kashmir administration to strictly implement laws banning drinking in public places.

The group asserted that the people of Kashmir are hospitable and respect tourists, but any "un-Islamic" or "unethical" act will not be tolerated.

"The MMU expresses serious concern over a viral video on social media, in which a group of tourists are openly alcohol on a shikara in the Dal Lake. The MMU strongly condemns this act and the fact that it has been allowed to take place in Kashmir," the amalgam said in a statement. Tough Action Against Those Disrupting Peace:DGP Says We Are Moving From Resident To Foreign Terrorism

Srinagar: Law enforcing agencies have to act tough against some unscrupulous elements to ensure that the atmosphere of peace in Iammu and Kashmir is not disturbed, Director General of Police RR Swain said on Saturday.

"When there will be peace, elections can take place and, when there is no fear, then only people can vote without fear. That's the atmosphere we want to maintain. Sometimes, we have to face brickbats as well (while doing so)," Swain told reporters after holding a public darbar in Pulwama district.

"To ensure that the streets remain peaceful, please accept that we have to be tough against some people. Police, by definition, is law



enforcement," he added.

Swain said everyone was satisfied that the recent Lok Sabha elections were held peacefully and witnessed a high voter turnout in Jammu and Kashmir.

"We all are satisfied that the elections were peaceful and the turnout was high. It is a good beginning and we would like to see this trigger a positive change by pushing forward a security cycle where everyone is free and without fear," he added.

Asked about terrorists operating in Jammu and Kashmir, the police chief said while the number of local terrorists is dropping, there are 70 to 80 foreign terrorists operating in the Union

"We are moving from resident terrorism to foreign terrorism. Resident terrorism means when local boys join the ranks. Their number has come down. Our effort has been to ensure, with the help of the community, that no local boy joins the terrorists ... due to these efforts, the number of local terrorists has dropped, resulting in lives | More on P6

"Security Of State" No **Longer Valid Ground For Preventive Detention: HC**

Srinagar: The High Court of Jammu & Kashmir and Ladakh has nullified a preventive detention order, deeming it flawed and invalid for citing "security of the State," a term that is no longer applicable following the reorganisation of Jammu and Kashmir into a Union Territory.

The court determined that when the petitioner was informed of his detention, he was led to believe it was to

prevent actions threatening the security of the former State of Jammu & Kashmir. However, since this state no longer exists, using its security as a basis for detention under the J&K Public Safety Act, 1978, is

erroneous. The court declared the preventive detention of the petitioner to be highly questionable. It pointed out that the District Magistrate of Baramulla (respondent No. 2)

'High Salt Intake Could Raise Chances Of Skin Inflammation'

igh levels of sodium, commonly consumed through salt, could increase the risk of eczema, an inflammatory condition of skin marked by dry and itchy patches, a new study has found.

Previous studies have found the sodium present in skin to be linked with autoimmune and chronic inflammatory conditions, including eczema. They have also showed that consuming fast food, known to contain excessive dietary sodium, is associated with increasing chances of eczema, including its severity, among teenagers.

The new study found that eating even one extra gram of sodium than the daily recommendation could increase the chances of eczema flares by 22 per cent. One gram of sodium is roughly the amount present in half a teaspoon of table salt or in a Big Mac, a hamburger sold by McDonald's, the

international fast food chain. While the World Health Organization recommends less than two grams of sodium intake in a day, according to the UK's National Health Service, the recommended sodium intake is 2.3 grams a day.

The study's researchers of the



University of California San Francisco (UCSF), US, said the chronic skin condition has become more common in recent years, especially in industrialised countries, implying that environmental and lifestyle factors such as diet had a role to play.

Limiting sodium intake could, therefore, be an easy way for eczema patients to manage their disease, they said. The findings are published in The Journal of the American Medical Association (JAMA) Dermatology.

"Eczema flares can be difficult for patients to cope with, especially when they are unable to anticipate them and don't have recommendations on what they can do to avoid them," said the study's corresponding author Katrina Abuabara, an associate professor of

dermatology at UCSF.

For the research, the team used data of more than 2 lakh people aged 30-70 years old from the UK Biobank, including urine samples and electronic medical records.

The team analysed the urine samples to find out each participant's sodium intake. From the medical records, they could see if the participant was diagnosed with eczema, or atopic dermatitis, along with its severity.

The researchers found that consuming one gram of sodium more than that recommended raised the chances of developing the skin condition by 22 per cent.

Future research could look at restricting sodium in daily diet as an intervention for eczema, they added.

City Hosts Exhibition On Architectural Epigraphy

Srinagar: A week long exhibition "Naqsh-i-Dawaam" focusing on the historical writings found on buildings in Kashmir commenced at the Kashmir Arts Emporium in Srinagar on Saturday. Organisers said the event is an organized effort to document, translate, and map these writings on Kashmir's religious structures.

The inaugural ceremony saw prominent figures including Islamic University Vice-Chancellor Dr. Shakil Romshoo, who pledged collaboration for future initiatives in architectural epigraphy.

The exhibition shows detailed drawings, photos, and translations of the carvings, engravings, and paintings. Dr. Hakim Sameer Hamdani, who led the project, said he was happy about the exhibition of these calligraphic inscriptions in Kashmir.

Speaking to Kashmir Observer, Dr Sameer Hamdani said the exhibition is based on the work that has been done over the period of one year, the grant came from the grant from the Barakat Trust in London, which looks into the art, architecture and history of Islamic world.

"This is a project based on the time period from 14th to 19th century and it looks into the texts, calligraphy on Khanqas, Imambaras, Mosques Overall it gives you an idea about Kashmir. I am delighted to present the first open exhibition of calligraphic inscriptions on historic buildings in Kashmir."

The project is led by principal investigator Mehran Qureshi, the project highlights important inscriptions from the 14th century Sultanate rule to the present. These inscriptions, spanning over four centuries, offer deep insights into

Kashmir's rich heritage.

"The exhibition is an attempt to bring to light the hidden masterpieces of Kashmir history writings that are otherwise ignored by larger academia and masses. Studying such inscriptions lead to clarification in history. I foresee a lot more of such unique undocumented work happening in coming years that needs institutional and academic support to recreate pages of the otherwise lost Heritage," said Ilyas Rizvi, an oral historian and participant in the exhibition.

Organisers say the exhibition aspires to resuscitate these manuscripts, many of which succumbed to the ravages of time. The exposition also exhibits chronicled locales, erudite translations, photographic evidence and reconstituted illustrations, thereby offering an exceedingly rarefied glimpse into the rich heritage of Kashmir.

RINAGAR - The much-hyped Kashir channel of Doordarshan is poised for 'relaunch' for the umpteenth time on Friday. A neat Rs five crore is likely to be spent to mark the occasion

Reliable sources told Observer News Service two chartered planeloads of senior government officials from the union minis¬tries of home and information and broadcasting besides scores of Bollywood celebrities were expected to descend on this capi¬tal city, otherwise resonant with screams and shrieks emanating from the unabated violence. The VVIP guests, who include Amitabh Bachan and Shahrukh Khan, would be lodged in Grand Palace hotel.

Sources said the Doordarshan authorities would organise a 2-day extravaganza at the world famous rendezvous, SK International Convention Centre. It will be marked by sev¬eral cultural pageants and musical concerts. A team of Doordarshan officials is-already in town lining up the arrangements for the big occasion.

It may be recalled the Kashir channel is being re-

at may be recalled the Rashii channel is being relaunched for the fifth time, ostensibly by way of commissioning of a new transmitter. It was first launched during the erstwhile Congress government in 1996 by the then minister, K P Singh Deo, from Delhi as a satellite channel. A year later, Sushma Swaraj of the BJP government performed its fresh inaugura—tion as a terrestrial channel to facilitate direct reception with—out cable or dish antenna.

Again, in 1999, Pramod Mahajan launched the channel with enhanced power transmit—ter. And, for the fourth time, on tins year's Republic day, the gov-ernor and the chief minister launched the channel with great fanfare only to extend the dura—tion of its telecasts to 16 hours.

Sore Defeat

he 2024 general elections in Kashmir witnessed seismic shifts in political dynamics, notably with the surprising defeats of prominent figures. Former Chief Ministers Mehbooba Mufti and Omar Abdullah both faced unexpected losses. Mufti, representing the People's Democratic Party, was ousted by National Conference candidate Mian Altaf Ahmed in the Anantnag-Rajouri constituency. In Baramulla, what began as a tight race between Peoples Conference candidate Sajad Lone and Omar Abdullah took a dramatic turn with the entrance of independent candidate Er Rashid, who rallied considerable support and clinched a decisive victory. This electoral upheaval underscores the fluid and evolving nature of Kashmiri politics.

Adding to the political culture, Omar Abdullah's statement following the results has stirred controversy. He suggested that Er Rashid's victory would embolden secessionists and revitalize Kashmir's defeated Islamist movement. This remark has been widely criticized as both arrogant and condemnable, further underscoring the intense and evolving nature of Kashmiri politics.

Demonising Kashmiri Voters

Omer Abdullah's statement reflects his desperation for power.

The voters of Baramulla chose Er Rashid for several reasons. They wanted to express their dissatisfaction with the central government's approach and legistlations since 2019. Additionally, they were drawn to Er Rashid's simplicity and authenticity—he had connected with the grassroots, wearing traditional Salwar Kameez, sporting a bald face, and donning plastic chappals. His son, Abrar, was an ordinary student using public transport like any common man

public transport like any common man. When it comes to public rallies, all political parties, including the National Conference (NC), spent substantial sums on campaigns, flooding the streets with posters and pamphlets. In contrast, Er Rashid's rallies stood out for their grassroots approach. Instead of expensive promotional materials, his supporters used organic tools, such as pressure cookers—the symbol of his campaign. This unique and resourceful method resonated deeply with the electorate, reflecting a campaign genuinely rooted in the community.

The National Conference (NC) and its leader, Omer Abdullah, faced a significant challenge in appealing to voters in Baramulla. Abdullah's legacy as a chief minister with instances of violence and general policy dissatisfactions were well-remembered by the voters. The resentment had sustained over the years. This resulted in his disconnect with voters in the region. Similarly, the People's Democratic Party (PDP) faced backlash for previously allying with the BJP. The People Confer-

ence leader, Sajad Lone and his allies were also an unpopular choice as voters had lost faith in mainstream political leaders who they thought were BJP proxies - a party which still does not enjoy people's trust in the valley.

The New Voters' Preference

The voter turnout in Baramulla also saw a remarkable increase, reaching 10 lakh votes, compared to previous turnouts that hovered around 5-6 lakh. This surge can be attributed to approximately 4 lakh new voters who participated in the election. These new voters were not necessarily young in age but were politically engaged for the first time. The absence of an organic, educated, and relatable leader in the past prevented these individuals from voting. However, Er Rashid's candidacy provided a fresh perspective that resonated with these voters. In the 2019 Parliament election, Er Rashid garnered over 1 lakh votes, further solidifying

his appeal among the electorate.

The "Common Man" Appeal

Er Rashid's appeal lies in his grounded approach and authentic connection with the people of Kashmir. His simplicity, use of local language, and rejection of VIP culture struck a chord with voters, making him relatable and trustworthy in their eyes. This genuine connection and understanding of the grassroots issues are the primary reasons why people associate themselves with him. Abrar, Er. Rashid's son was quite accessible and relatable to the general masses as well.

The people of Kashmir are tired of religious and dynastic elites who exploit them for political gains.

Participation in democratic process after years

After years of boycotting elections, now when people set aside their disillusionment and returned to the polling booths, politicians should not demonise Kashmiri voters.

Defeat should be accepted gracefully and respect should be shown to political opponents. They seem to believe that if people do not support their party, the people must be turning towards separatism.

Kashmir's participation in the electoral process is a victory for democracy. It is seemingly giving hope to people here. People were fed up with boycott politics and, for the first time, wanted to experiment with the electoral process to choose their own representative. They had apprehensions about possible rigging and doubted Er Rashid's chances of winning. However, thanks to the Election Commission of India, which demonstrated its credibility, the result was in Rashid's favor. This victory has given Kashmiris renewed hope in Indian institutions and fostered respect for the ECI.

The people of Uttar Pradesh too chose the INDIA Alliance over the BJP, driven by their dissatisfaction with the current government and a desire for change. Defying the predictions of exit polls, they delivered an unexpected result that has been widely praised. This outcome has made the ruling government recognize the importance of embracing diversity and curbing exclusive, hate-driven politics.

Similarly, the people of Kashmir demonstrated their maturity by electing their preferred leader.

An Ally Or A Double-Edged Sword?

Al should be seen as a transformative ally in taxation; but given that it is nascent and evolving, its responsible use with humans in the loop is necessary

o ChatGPT passing bar exams with flying colours took many by surprise. Artificial intelligence's (AI) ability to come up with suggested diagnosis in the field of medical sciences has also opened several new paradigms to transform healthcare.

Another knowledge-led profession, taxation, cannot be immune to the impact of the newest AI avatar, generative AI (GenAI). We are seeing several use cases emerging at a fast pace, helping legal and tax professionals in their daily lives; they not only help improve productivity but also improve quality of work. However, with the impact of AI also comes the need for careful consideration. Will AI challenge the ways of working of tax professionals, or it will challenge the core competencies of an average tax professional?

Al as an innovative partner

Across the spectrum of a typical tax function, there are multiple areas where GenAI is showing promising impact; these areas cut across compliance, research, and litigation for activities such as data handling, smart analysis, document reviews, and summarisation.

Tax compliance typically involves collecting data from various sources, processing it, and then filling a form template like a tax return or similar document. Conventional tools automate this process to a great extent, but many qualitative tasks are still performed manually. AI can reduce these manual tasks by providing insights and analy-

sis from the data and results. For example, reading and analysing general ledgers or purchase registers and identifying specific events/triggers having an impact on computation of income, blocked input tax credit, or reverse charge transactions under the goods and services tax law.

The function of tax research and litigation is attracting interest in GenAI for its ability to do several tasks better than humans. For example, when a company receives multiple tax notices, AI can help the tax team by quickly reading and validating these notices, and even drafting responses to review and finalise in near-real time. Similarly, GenAI solutions can read and analyse thousands of annual reports and other information and convert it into an insightful output in a matter of minutes.

AI is also transforming courtrooms with the eCourts project, where live video streaming is just the start. Soon, digital records and virtual participation will be common. Imagine AI recording and storing court transcripts for future analysis and providing analytics about the arguments taken and the observations of a bench. Tools like this, which can transcribe meetings, exist today.

Recently, the Chief Justice of India, DY Chandrachud, also commented: "This proves that AI has the potential to enhance the efficiency of court proceedings by automating routine tasks such as document review, case management, and scheduling. By leveraging AI-powered tools, courts can streamline administrative processes, reduce paperwork, and expedite the resolution of legal disputes. This not only saves time

and resources but also improves access to justice by reducing delays and backlogs in the court system."

Furthermore, AI chatbots can help users 24/7, predictive analytical models can tap into historical data to forecast tax trends, and automation of tax calculations can simulate different scenarios and help to optimise tax strategies, demonstrating AI's crucial role in modernising tax practices and guiding strategic decision-making.

AI as a complex ally

GenAI is useful, but it also comes

with privacy concerns. We need to think carefully about how we use it. So, what are the challenges? GenAI uses large language models and learns from

vast data, but its accuracy isn't guaran-

teed. In the tax landscape, the margin of

error is minimal, and output should be

highly accurate.

GenAI can also make up its own answers, which may sound correct but are wrong. "Hallucination" effects can happen for different reasons, like if there's too much data or if the AI wasn't trained well. Hence organisations may explore developing their own pre-

trained model for specific tasks on their proprietary data or partnering suitably. Yet the necessity of maintaining a human oversight, often referred to as the "human-in-the-loop" approach, will remain critical till this technology is nascent and evolving.

Another complex question arising due to advent of GenAI is learning and skilling of next-generation tax professionals; academia as well as young professionals need to find new frameworks of learning, and not fall into the trap of "ChatGPT" shortcut.

While at one level, the tax function is progressively pressured with multi-level policy changes, increased controversy, tighter budgets, talent issues etc., there is tremendous opportunity to see how to use GenAI to suitably tackle these challenges. As a catalyst for change, AI is poised to propel the tax profession in a new era.

However, the future of AI in taxation involves balancing technological advancements with risk mitigation. AI should be seen as a transformative ally in taxation, boosting efficiency and aiding strategic decision-making as tax plays a greater role in C-suite discussions. Yet given that GenAI as a technology is nascent and evolving, its responsible use with humans in the loop is necessary. The revolution is here, and it is time to embrace AI's transformative potential.

Rohit has fallen to Shaheen three times in four international games, while Shaheen has conceded 52 runs against him. In two T20 games, Rohit has scored paltry 4 runs against Shaheen. If Rohit survives the initial intimidation from Shaheen, he can make a difference then. Amir has undoubtedly given nightmarish vibes to the Hitman in the past but the former is not at his best. His dwindling pace and penetration to torment the openers upfront, is a cause of concern for green shirts. And his poor run against the USA will haunt him for many days.

Indian run machine - Virat Kohli has been at his best in the recently concluded IPL, where he amassed 741 runs including a triple figure mark and five fifties with an impressive strike rate of 154.70. His record against the Pakistan team is quite spectacular. India's dominance over Paki-

stan during the last two decades has been spearheaded by Virat Kohli. He can topple any bowling attack of the world. He has piled up more than 1000 runs in 23 international matches against Pakistan. He too has been a bit jittery against Shaheen Afridi. The tall pacer has scalped him a couple of times in four encounters. But, Virat can single handedly take the game away from green shirts. K L Rahul is a good batsman but hasn't been at his best during the recent times. Talented lad like Yashisvi Jaiswal, Sanju Samson might sit in the Indian dugout as spectators. Rishabh Pant may be prioritised over Samson for his experience in the game.

Hardik Pandya, Axar Patel and Ravindra Jadeja provide multiple options to the Indian captain. Pandya's berth in the side is confirmed. He shone in the match against Ireland, in which he scalped three wickets. Kuldeep might be preferred over Jadeja, because the latter is going through the lean patch of his career. Left-arm armoury from Kuldeep may trouble Pakistan middle order. Contrary to the past, India has an indomitable fast bowling attack, spearheaded

by Jasprit Bumra. Siraj and Arshdeep Singh can trouble the Pakistan fragile batting order. Bumra and Siraj can hit the deck hard to intimidate Pakistan batters with short pitch stuff. Drop-inpitches are assisting fast bowlers substantially. Indian pacers unnerved Irish batsmen, and South African pacers perturbed Srilankans. Is toss going to be crucial

in the game, time will tell.

Now, let's delve deep into Pakistan batting. The green shirts rely on the trio of Babar, Rizwan and Fakhar. They are good enough to pulverize any good bowling attack, but they can't flex their muscles freely because of the conditions and behaviour of pitches in the USA. They were rusty against the USA in their first match. Given their poor run against the USA, they might be under tremendous pressure. Saim Ayoob is looking frustrated. He has miserably failed to repeat his PSL heroics at international level. Pakistan might go with Babar and Rizwan at the top, because the duo has brought laurels to Pak sides on many occasions in the past. But, this time around, it won't be a cakewalk. Middle order of Pakistan has been struggling for many months. Iftikhar Ahmad has scored 179 runs in his last 13 T20 innings, at a poor average of 16.1. But, he will certainly play against India. Azam Khan has proven a liability for the Pakistan team.

Will Rizwan or Usman Khan wear gloves to show exodus to the gigantic wicket keeper batsman? Usman played a good cameo against England in their last T20 international clash. And he exhibited great calibre in 2024 PSL. Shadab Khan played a good innings against the US when the Pak side was tottering at 30 for 3. Injury to Imad Waseem should be cause of concern to Babar because the left arm spinner is quite handy with the willow as well. Pakistan pace battery led by Shaheen, Naseem and Haris can exploit the conditions well. The trio possess the firepower to give goosebumps to Indian batters. Will Amir open the bowling with Shaheen or not? Can he repeat his magic when he had undone Indian top order in ICC champions trophy 2017?

Both the teams are balanced and possess the skill to lift the trophy. For me, it is a 50 - 50 affair. The match between the two teams will be a treat to watch. Drop-in-pitches in Nassau, USA are quite different from subcontinent's pitches, where batters enjoy punishing and tearing bowlers. Uneven bounce might worsen the things for batters, particularly during the first innings. Toss might play a role. Team winning the toss, will definitely choose to bowl first. Let's hope the two sides give us a suspense and entertainment packed super Sunday on June 9. The countdown for the match of the tournament has begun, and everyone is waiting eagerly and anxiously.

ICC must be applauded for expanding the horizon of international cricket. Taking the T20 bonanza to the USA is something of a great feat because that part of the world is better known for baseball, basketball, football, ice hockey, lawn tennis and athletics. The move will certainly promote the game across the globe.

'I'll Have What She's Having'

How And Why We Copy The Choices Of Others

magine you're dining out

at a casual restaurant with some friends. After looking over the menu, you decide to order the steak. But then, after a dinner companion orders a salad for their main course, you declare: "I'll have the sal-

This kind of situation making choices that vou probably otherwise wouldn't make were you alone - probably happens more often than you think in a wide variety of settings, from eating out to shopping and even donating to charity. And it's not just a matter of you suddenly realizing the salad sounds more appetizing.

Prior research has shown people have a tendency to mimic the choices and behaviors of others. But other work suggests people also want to do the exact opposite to signal their uniqueness in a group by making a different choice from others.

As scholars who examine consumer behavior, we wanted to resolve this discrepancy: What makes people more likely to copy others' behavior, and what leads them to do their own thing?

A social signal

We developed a theory

that how and why people match or mimic others' choices depends a lot on the attributes of the thing being selected.

Choices have what we call "ordinal" attributes that can be ranked objectively - such as size or price - as well as "nominal" attributes that are not as easily ranked - such as flavor or shape. We hypothesized that ordinal attributes have more social influence, alerting others to what may be seen as "appropriate" in a given context. Nominal attributes, on the

other hand, would seem to be understood as a reflection of one's personal preferences. So we performed 11 studies

to test our theory.

One scoop or two

In one study conducted with 190 undergraduate students, we told participants that they were on their way to an ice cream parlor with a friend to get a cone. We then told our would-be ice cream consumers that their companion was getting either one scoop of vanilla, one scoop of chocolate, two scoops of vanilla or two scoops of chocolate. We then asked participants what they wanted to order.

We found that people were much more likely to order the same size as their companion

but not the same flavor. The participants seemed to $interpret\, the\, number\, of\, scoops$ the companion ordered as an indication of what's appropriate. For example, ordering two scoops might signal "permission" to indulge or seem the more financially savvy - if less healthy - choice, since it usually costs only marginlike vanilla, you like chocolate

 We also asked participants to rate how important avoiding social discomfort was in their decision. Those who ordered the same number of scoops as their companion rated it as more important

For example, in another experiment, we gave participants US\$1 to buy one of four granola bars from a mock store we set up inside the University of Pittsburgh's Katz/CBA Business Research Center. As the ordinal attribute, we used brand prestige: They could

he had tested out a granola bar, randomly specifying one of the four – without saying anything about how it tasted. We rotated which granola bar the employee mentioned every hour during the five-day experiment.

The choice of chocolate or vanilla, on the other hand, is readily understood as a personal preference and thus signals nothing about which is better or more appropriate. I than those who picked a different amount.

Examining other contexts

In the other studies, we replicated our results using different products, in various settings and with a variety of ordinal and nominal

pick either a more expensive well-known national brand or a cheaper one sold by a grocery store under its own label. Our nominal attribute was chocolate or peanut butter.

Before making the choice, a "store employee" stationed behind the checkout register told participants she or

study, participants tended to choose the brand that the employee said he or she had chosen - whether it was the cheaper or pricier one - but ignored the suggested flavor.

Moving away from food, we also examined influences on charitable donations. In this study, we recruited online participants who were paid for their time. In addition, we gave each participant 50 cents to either keep or donate to charity.

If they chose to donate the money, they could give all of it or half to a charity focused on saving either elephants or polar bears. Before they made their choice, we told them what another participant had supposedly decided to do with their money - randomly based on one of the four possibilities.

The results were the same as in all our other studies, including ones we conducted involving different brands and shapes of pasta and varieties and taste profiles of wine. People matched the ordinal attribute - in this case the amount - but paid little heed to the nominal attribute - the chosen charity – which remained a personal preference.

These kinds of social cues regarding others' choices are everywhere, from face-toface interactions with friends to online tweets or Instagram posts, making it difficult to escape the influence of what others do on our own consumption choices.

And if we believe we're making our companions feel more comfortable while still choosing something we like, what's the harm in that?

Neuroscience can explain why voting is so often driven by emotion

The British electorate has been more volatile than ever in recent years. The elections of 2015 and 2017 saw the highest number of voters switching parties in modern history. And current polling suggests we're about to see more of the same.

Understanding what's happening in people's brains when they are making decisions helps us understand why certain political messages appeal to them and why they might decide to switch parties.

Political scientists talk about Pedersen volatility, named after the distinguished Danish scholar Mogens N. Pedersen. There is a forbidding mathematical equation for this, but it all amounts to the net change within the electoral party system resulting from individual vote transfers.

In plain English, volatility is simply the number of people who change party in an election. In late 1960s Britain, the Pedersen index stood at just over 10%, now it is closer to 40%.

There has been much talk about the increased use of social media and its influence on election outcomes. A recent study by Professor Hanspeter Kreisi, a Swiss election expert, reported that a steady stream of argument and voting cues [are] allowing voters to make enlightened choices that are in line with their preferences.

This might well be true, but a recent study found that while politicians post more on social media during election campaigns, overall the number of posts with policy content is lower not higher. The voting brain

One of the more interesting developments in electoral studies is that we are now able to use social neuroscience methods to understand voting behaviour.

In the past decade, neuroscience has enabled us to identify the parts of the brain that get activated when you watch political adverts. What these results show is that most people are driven by fear and emotion rather than by rational argument in election campaigns.

In practice, this means that voters are more susceptible to messages that stress the negative rather then the positive. Researchers found that negative images and statements about products led to heightened activity in the dorsolateral prefrontal cortex, which is also associated with decision making.

For example, negative information about a brand of cola made subjects more likely to buy the competing brand. However, when this experiments was repeated with political parties rather than soft drinks, the negative effect was three times higher. Negative political advertising works, and we now have the fMRI scans to

prove it

Politics is a bare-knuckle fight, and our brains reflect that. Evolution has conditioned us to be driven by fear when we are under threat. We want to survive above all.

By playing on our fear and anger, those who devise election slogans are producing perhaps deliberately messaging that triggers parts of the brain associated with revenge and pent up rage, including the so-called anterior cingulate cortex (or ACC), deep in the front part of the fissure that separates the two brain-hemispheres. So, if I am furious that Rishi Sunak has not brought NHS waiting lists down, it is likely that the ACC has gone into

verdrive.

Older people who tend to vote in higher numbers are particularly interesting here. This is because as we age, we become more prone to activating the so-called dorsolateral prefrontal cortex an area of the brain associated with caution.

It is unlikely that Rishi Sunak has delved into the finer points of neuropolitics but his strategy is consistent with what we know from social neuroscience. His emphasis on need to stick to the plan and not gamble on the opposition appeals to those with oversensitive dorsolateral prefrontal cortices namely the older voter cohort he most needs to convince.

and their parents led by Allen Career Institute director Brijesh Maheshwari held a protest and tried to take out a candle march but called it off after assurance by the district collector. They demanded that the NEET exam be re-conducted.

There have been calls from several quarters for a re-exam alleging that the grace marks awarded to make up for the loss of time at six exam centres have led to the inflation of marks and tampered with the chances of other candidates.

These centres are from Meghalaya, Bahadurgarh in Haryana, Dantewada and Balodh in Chhattisgarh, Surat in Gujarat and Chandigarh.

The result of the medical entrance exam was announced on June 4 and thereafter aspirants have been alleging multiple issues, including irregularities in the test demanding fresh examination.

Sixty-seven candidates had shared the first rank in the exam including eight from the same centre in Haryana. A record more than 24 lakh candidates had registered for the exam this year.

"A high-powered committee has been set up to review the results of over 1,500 candidates. The four-member panel headed by a former UPSC chairman will submit its recommendations within a week and the results of these candidates might be revised," NTA Director General Subodh Kumar Singh said at a press conference here.

"The awarding of grace marks has not impacted the qualifying criteria of the exam and the review of results of the affected candidates will not impact the admission process," he added.

According to experts, the mark inflation in NEET UG 2024 result is expected to make securing a spot in medical school this year more difficult. Some aspiring students have turned to online platforms to demand the cancellation of the results and a re-examination.

Asked about whether the exam will be re-conducted for certain students, the NTA DG said, it will be decided depending upon the committee's recommendations.

"The idea is to ensure that students who lost time or other students are not at any disadvantage," he said.

Singh denied any paper leak and irregularities in the exam and reiterated that the integrity of the crucial test had not been compromised.

The Congress in Kerala alleged that results have raised concerns about the authenticity of the national exam for medical courses, with many students casting doubt on the procedure.

"The Modi government is directly responsible for this. For the candidates appearing in recruitment exams, then facing several irregularities, getting caught in the labyrinth of paper leaks, is playing with their futures. The BJP has cheated the youth of the country," Congress Chief Mallikarjun Kharge said in a post in Hindi on X on Friday.

"We demand that a high-level investigation should be conducted under the supervision of the Supreme Court so that our talented students appearing in NEET and other exams get justice," he had added.

Tamil Nadu Chief Minister M K Stalin said the trends from the latest NEET results have once again vindicated the DMK on its stand opposing the exam and reiterated that the entrance test goes against social justice and federalism.

The NTA DG reiterated that the increase in cutoff reflects the competitive nature of the examination and the higher performance standards achieved by the candidates this year.

"The number of candidates who appeared in 2023 was 20,38,596 while the number of candidates who appeared in 2024 increased to 23,33,297. The increase in candidates naturally led to an increase in high scorers due to a larger pool of candidates," he said.

Explaining the rationale behind the awarding of grace marks, Singh said, the process has been completed using a formula devised and adopted by the Supreme Court in a 2018 judgement.

"The concerns raised by the candidates through the writ petitions and representations about loss of examination time were ascertained and 1,563 candidates were compensated for the loss of time, and the revised marks of such candidates vary from -20 to 720

marks. Among these, the score of two candidates also happens to be 718 and 719 respectively due to compensatory

marks," the official added.

The NTA had on May 5 claimed that the distribution of wrong question papers at an exam centre in Rajasthan led to some candidates walking out with the papers. The agency had de-

nied any leak of the question paper.

A day later, the NTA had reiterated that the reports claiming question paper leak in the medical entrance exam NEET-UG are "completely baseless and without any ground", and every question paper has been accounted.

Modi Set To Take

Leaders of the BIMSTEC (Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation) countries attended Modi's swearing-in ceremony in 2019 when he became prime minister for the second consecutive term.

Teacher Suspended

In his suspension order issued on Friday, he said the department has taken a serious note of the viral video as the concerned teacher did not resist the entry of the unauthorized person into the premises and instead disseminated confidential information as well as criticized the government policies like 'digital India', school education policies and working of higher authorities in violation of service guidelines.

The teacher was asked to explain his position within two days on June 6 and his reply has been found 'not satisfactory' as well as 'non convincing', the order reads.

Therefore, pending inquiry into the matter, the teacher is placed under suspension with immediate effect and during the suspension period he shall remain attached to Higher Secondary School Chanti.

The order said a two-member committee comprising the principals of Higher Secondary School (girls) Thathri and Sartingal will conduct an in-depth inquiry into the alleged act of 'violation of government instructions' by the suspended teacher and shall furnish their report to this office within a stipulation of 21 days positively with specific recommendations.

The local residents said over 100 local students are enrolled in the school having a staff strength of four teachers, one of whom is not performing his duties for the past four years.

The school was upgraded to middle school over a decade ago and some more class rooms were added to it but were never completed, prompting the management to adjust the children in the two rooms of the old building that are also not repaired for a long time and posing a threat to the lives of the students, they said.

The teacher said they have raised the issue with the Zonal Education Officer several times.

He said one of the teachers is not performing his duties in the school, while another among the rest of the three is looking after the accounts section and only two of them are attending the class. PTI

T20 WC: Spotlight On NY Pitch As Steady India Take On Wounded Pakistan

NEW YORK: A confident and well-adjusted India would look to capitalise on an unpredictable Pakistan's vulnerable state and lack of familiarity with the tricky conditions here when the traditional rivals lock horns in their eagerly-awaited T20 World Cup clash on Sunday.

The marquee game, which is expected to draw the biggest crowd of the tournament so far, will be held at the newly constructed 34,000-seater Nassau County International Cricket Stadium at the Eisenhower Park on the outskirts of

Heading into this high-profile contest, the 22-yard pitch remains a major talking point, having already faced significant criticism for its unpredictability, which the ICC has officially acknowledged.

In the six innings of the three matches hosted at the stadium so far, teams have surpassed the 100-run mark only twice. Some former players have wondered aloud whether the low-scoring conditions would be of any help in selling cricket to the American market through the showpiece.

The four drop-in pitches at the venue, laid in April under the supervision of Adelaide Oval groundsman Damian Hough, are yet to settle down properly.

The uneven bounce of the surface has also raised safety concerns for the batters, especially after Indian skipper Rohit Sharma was hit on his shoulder, forcing him to stop batting during the tournament-opener against Ireland

"I don't know what to expect from the pitch to be honest. We will prepare as if the conditions are going to be like this (for Pakistan game). This is going to be a kind of game where all XI of us will need to contribute," Rohit had said after the game against Ireland.

A day after India's game, the ICC had to release a statement,



addressing the growing concerns surrounding the pitches prepared for the New York-leg of this T20 World Cup.

"The ICC recognise that the pitches used so far at the Nassau County International Cricket Stadium have not Thursday night following their

played as consistently as we would have all wanted," the statement read.

The Pakistan team, however, is yet to acclimatise to the conditions at Nassau Stadium. They arrived in New York on

shocking defeat to tournament debutants USA and took the next day off. As a result, Babar Azam and

However, given Kuldeep's recent form and his favourable match-ups against Pakistani batters, especially Babar, the team management might consider including him.

Spirited Afghans clip Kiwi wings, secure 84-run upset win in T20 World Cup

GEORGETOWN (GUYANA), JUN 8 (PTI) A determined Afghanistan rode on splendid spells from their skipper Rashid Khan and left-arm pacer Fazalhaq Farooqi to stun an under-prepared New Zealand by 84 runs and make a strong case for a Super Eight berth in the T20 World Cup here.

Chasing a tricky 160 at the Providence Stadium here, 2021 runners-up New Zealand were shot out for a lowly 75 in an innings that lasted a mere 15.2 overs with only Glenn Phillips (18) and Matt Henry (12) managing double-digit scores.

The decision to bowl after winning the toss backfired on the Black Caps as the Afghans relied on openers Rahmanullah Gurbaz's 56-ball 84 and Ibrahim Zadran's 44 off 41 to post a reasonably good total of 159/6 in the low-scoring tournament.

Gurbaz was expectedly adjudged player of the match for

The triumph was a reminder of Afghanistan's first big upset win in 2016 when they defeated West Indies by six runs in Nagpur after restricting the eventual winners to 117/8 in their defence of 123/7.

Farooqi, who snared five wickets for nine runs against Uganda, returned figures of 17/4 off his 3.2 overs, including the match-sealing dismissal. Rashid was also lethal as

he collected the prized scalp of Kane Williamson (9 off 13) with his first ball. He finished overall figures of 17/4 off his four overs.

It took Afghanistan to four points from two matches, having earlier beaten Uganda by 125 runs. The West Indies and Uganda occupy the next two spots, while Papua New Guinea and New Zealand are the last two teams whi haven't opened their accounts.

Afghanistan next face PNG on Friday, while NZ will be up against the co-hosts West Indies on Thursday.

"One of the greatest performances from us in T20I cricket against a big team," said Afghan skipper Rashid Khan terming it "great team effort."

"The way Ibrahim and Gurbaz started again... The wicket was not easy. They did not throw away their wickets.

"Great win for Afghanistan and it is a privilege to be leading this side and winning against NZ." Williamson acknowledged that Afghans "outplayed them".

'To get a total like that on a fiddly surface, they kept wickets in hand and played it beautifully. Not good enough from us. Quick turnaround, we have to regroup quickly and onto the next challenge," Williamson said.

Farooqi triggered the New Zealand collapse with the devastating new ball spell.

Anshu Malik Settles For Silver In Budapest

BUDAPEST, JUN 8 (PTI) Indian woman wrestler Anshu Malik could not match the skills of her 21-year-old Chinese rival Kexin Hong in the final, bowing out tamely to settle for a silver in the 57kg category of the Budapest Ranking Series here.

Competing against the No.1 ranked Chinese, Anshu lost 1-12 on technical superiority against the Hangzhou Asian Games bronze medallist in the 53kg category.

India's Antim Panghal had earlier fought hard to settled for a silver in the 53kg category, while star wrestler Vinesh Phogat lost to Jiang Zhu of China 0-5 in the quarterfinals in the 50kg category.

Anshu started with an incredible bout against Anastasia Nichita of Moldova, winning 6-5 on points to secure a place in the semifinal. With Nichita leading 5-4 and just 19 seconds remaining on the clock, Anshu scored a takedown on the edge



to claim a 6-5 lead to win the close contest.

She then overcame the challenge of world champion Zhang Qi 2-1 on point to secure a title showdown with another Chinese.

But Hong proved far too su-perior for the Indian, taking a 4-1 lead in the opening round before asserting her class in the second round and taking an unassailable lead with 11 seconds still remaining on the clock.

India's only male wrestler to qualify for the Paris Olympics, Aman Sehrawat had earlier won a silver on the opening day losing 1-11 on technical superiority to Japan's Rei Higuchi.



Carlsen walked away with prize money of 7,00,000 NOK (Around USD 65,000 reserved for the winner) for ending with 17.5 points in the unique tournament that ensured that each round had a winner either through Classical time control or Armageddon if the game ended in a draw.

Nakamura finished second on 15.5 points despite losing to Praggnanandhaa, who concluded third on 14.5 points.

Praggnanandhaa can be happy with the fact that he defeated the top three ranked players in the world in one of the strongest ever tournaments.

He had beaten Carlsen and Caruana under Classical time control earlier in the tournament and his win against Nakamura ensured that he became the first player ever to beat the top three.

The fourth place went to Alireza Firouzja (13.5 points) who accounted for reigning world champion Ding Liren of China. The Iranian turned Frenchman also won under

the Armageddon, leaving Liren at the bottom of the standings behind Caruana who finished on 10 points for the fifth place in the sixplayers double round-robin tournament.

In the Women's section, Wenjun Ju had no trouble securing the top spot at the expense of compatriot Tingjie Lei. The Chinese won with 19 points in all coming from three wins under Classical time control.

Anna Muzychuk finished second on 16 points, 1.5 points ahead of Lei who in turn was two points clear of R Vaishali. Koneru Humpy on 10 points was a distant fifth ahead of veteran Pia Cramling who tallied eight points in all.

The final round was not devoid of excitement. Carlsen delivers on demand and he did

just that yet again against Fabiano Caruana. After a regulation draw in

the Ruy Lopez as white Carlsen reserved his energy for the final Armageddon and his Queen pawn opening ensured a tangible advantage as the game progressed. The Norwegian won in the

Queen and pawns endgame after 52 moves when his passed pawn in the centre was about to become a new Queen. Praggnanandhaa took his

chances in the middle game arising out of a London system and did not regret as Nakamura was on the backfoot right from the word go. Unleashing a king side attack the Indian romped home in just 31

No Excuses, An Incredibly **Frustrating Performance: Kane Williamson**

PROVIDENCE: New Zealand captain Kane Williamson on Saturday termed his side's 84run defeat against Afghanistan in the ongoing T20 World Cup as "incredibly frustrating" and urged his teammates to move on quickly from the reversal.

New Zealand struggled against Rashid Khan (4/17) and Fazalhaq Farooqi (4/17) while getting bowled out for 75 in 15.2 overs while chasing 160.

"Incredibly frustrating performance. We certainly did prepare to the best of our ability. So, no excuses. For us, it's moving on quickly.

"We know we've got a match in a few days and it's about putting out a better performance," Williamson said in the postmatch press conference.

In their second Group C match, New Zealand will face co-hosts West Indies at Trinidad on June 13.

Williamson said the Kiwis would hit the boardroom soon to find a way to dish out a better performance against the two-time champions.

"We're going to have to sit

down. We are going to have to have a chat and review a little bit and then move on quickly because the tournament is short from here on.

"I mean, it was mentioned we've been here for a long time (in the West Indies), but we knew that when the games started, they'd be coming thick and fast. "So, it's making some small adjustments, and we know

we go to a different venue against a different opposition. So, it's important we prepare for what's in front of us again. We know how strong the West Indies side is," elaborated Williamson. However, the affable Kiwi

did not take anything away from a brilliant Afghan side, which dished out a cohesive performance to outwit his unit. "I mean certainly they're not

the standards that we expect of ourselves. But take nothing away from Afghanistan, they were superb.

"And they've been building as a group for some time now and we're seeing performances like that from them quite regularly," he added.
