

'Family History Could Affect Development Of Siblings Of Children With Autism'

ounger siblings of children with autism could experience more developmental difficulties, especially if they have relatives with conditions such as delayed speech, anxiety or schizophrenia, a study has found. Researchers found that the younger siblings showed more severe difficulties in social communication, a common symptom of the neurodevelopmental disorder autism. Other symptoms could include repetitive behaviours and a heightened sensitivity of senses.

"(Knowledge about) family history of these disorders may improve efforts to predict long-term outcomes in younger siblings

children having at least one elder sibling with autism and assessed their social, cognitive, language and adaptive skills. The children had an average age of about two years and were enrolled between March 2006 and May 2022.

Parents of the 229 children were interviewed for knowing about family history. They were asked if relatives of their children, including grandparents and cousins, were affected neurodevelopmental conditions such as delayed speech requiring therapy or intellectual disability, or by psychiatric ones such as anxiety, depression, bipolar disorder or schizophrenia.

Using statistical methods of analysis, the researchfound an increased



of children with autism and inform about factors contributing to (varied observable traits and behaviours among them)," said senior author Katarzyna Chawarska, a professor of child psychiatry at Yale School of Medicine, USA.

Information about family history could also guide parents and pediatricians in monitoring and supporting the development of infants with risk factors for disorders such as autism, according to Chawarska.

The findings are published in the journal Autism Research.

For the study, the researchers included 229

presence of both kinds of disorders in the immediate and extended family members of the children with autism.

"Among neurodevel-opmental disorders, the most frequently reported condition was speech delay requiring therapy (64 per cent), followed by attention deficit hyperactivity disorder (41 per cent) and intellectual disability (11 per cent)," the authors wrote.

"Among neuropsychiatric disorders, the most common were anxiety disorders (44 per cent), depression (43 per cent), bipolar disorder (17 per cent) and schizophrenia (8 per cent)," they wrote.

Scientists Develop Facial Recognition Tool To Detect Stroke

smartphone new application could come in handy for paramedics as detects within seconds if a patient has suffered a stroke. Developers of the tool, which has an accuracy of 82 per cent, said it uses artificial intelligence (AI) to analyse facial symmetry and muscle movements to detect stroke.

Signs suggesting that an individual has suffered a stroke can include confusion, loss of control over muscle movement, impaired speech and diminished facial expressions, they said.

The research team shared the trial results of the application in a study, which was published in the journal Computer Methods and Programs in Biomedicine.

"One of the key parameters that affects people with stroke is that their facial muscles typically become unilateral, so one side of the face behaves differently from the other side of the face," said lead author Guilherme Camargo de Oliveira from the Royal Melbourne Institute of Technology (RMIT), Australia.

"We've got the (AI) tools and the image processing tools that can detect whether there is any change in the asymmetry of the smile -that is the key to detection in our case," said de Oliveira.

The smartphone tool has an accuracy rating of 82 per

cent for detecting stroke, a success rate that compares favourably to paramedics, according to the researchers.

For the study, the team used video recordings of facial expressions of 14 people who had suffered a stroke and 11 healthy persons. Early detection of stroke

is critical as timely treatment reduces the risk of long-term disability and saves lives, the researchers said. While the newly developed tool would not replace

comprehensive clinical diagnostic tests for stroke, it could help identify people needing treatment much sooner, they said.

"Studies indicate that

nearly 13 per cent of strokes are missed in emergency departments and at community hospitals, while 65 per cent of patients without a documented neurological examination experience undiagnosed stroke," said corresponding author Dinesh Kumar, a professor

at RMIT.

"This rate can be even higher in smaller regional centres. Given that many strokes occur at home and initial care is often provided by first responders in nonideal conditions, there is an urgent need for real-time, user-friendly diagnostic tools," said Kumar.

He said there is a likelihood of a heat wave over the plains of Jammu from June 22.





◆ Justice Prevails: A Stand Against Mob Lynching

The Bharatiya Nyaya Sanhita (BNS) 2023 has introduced a new category of Culpable Homicide that targets the issue of mob lynching with an emphasis on justice, deterrence, and protection of victims. This is a significant step in the Indian criminal justice system, with cases of mob lynching rapidly increasing over the years.

Special Provisions for Mob Lynching Offences

- Special provision unveiled in Section 103(2) addresses offence related to mob lynching, stating that when a group of five or more persons acting in concert commits murder on the grounds of race, caste or community, sex, place of birth, language, personal belief or any other similar ground, each member of such group shall be punished with death or with imprisonment for life as stipulated under 'Punishment for Murder', and shall also be liable to a fine as dee1ned appropriate.
- Similarly, acts of causing serious injury by mob solely on the grounds mentioned in 'mob lynching' provision has been punished strictly in section 117(4).

Israeli Army Says "Hamas Can't Be Eliminated", **Netanyahu Disagrees**

Jerusalem: Israel's top army spokesman said Wednesday that Hamas cannot be eliminated, prompting a knee-jerk reaction



from the government which quickly reiterated it remains committed to the Palestinian terrorist group's destruction.

More than eight months of war, sparked by Hamas's unprecedented October 7 attack on Israel, have failed to oust the Islamist militants from Gaza but have brought widespread devastation.

"To say that we are going to make Hamas disappear is to throw sand in people's eyes. If we don't provide an alternative, in the end, we will have Hamas." Rear Admiral Daniel Hagari told Israel's Channel 13 broadcaster. "Hamas is an ideology, we cannot eliminate an ideology.

His comments were quickly rebuffed by the office of Israeli Prime Minister Benjamin Netanyahu, whose cabinet has stated its Gaza offensive will not end until Hamas

"The political and security cabinet headed by Prime Minister Netanyahu defined as one of the goals of the war the destruction of Hamas' military and governmental capabilities," his office said in a statement.

"The IDF is of course committed to this.

In a separate statement on its Telegram channel, the military clarified that Hagari had addressed Hamas "as an ideology... and his statements were clear and explicit".

"Any other claim is taking the statement out of context."

The October 7 attack that triggered the war resulted in the deaths of 1,194 people in Israel, mostly civilians, according to an AFP tally based on Israeli official figures.

The terrorists also seized 251 hostages. Of these, 116 remain in Gaza, although the army says 41 are dead.

Israel's retaliatory offensive aimed at eliminating Hamas has killed at least 37,396 people in Gaza, also mostly civilians, according to the Hamas-run territory's health ministry.

Cyprus Plays Down Collaboration With Israel After Hezbollah Warning

Cypriot President Nikos Christodoulides responded to a speech made by Hezbollah leader Hassan Nasrallah on 19 June, in which he warned that the Lebanese resistance would "deal with" Cyprus as a target if it chose to open its bases and

in any way reflect what's being attempted, which is to present a picture that Cyprus is involved in military operations," adding that Nicosia has open contact with Lebanon and Iran "through diplomatic means."

A Cypriot government spokesman, Constantinos Letympiotis, said on 20 June that

"Deadly Heat" Made 35 Times More Likely **Due To Global Warming: Scientists**

Washington: Deadly heat that blanketed the United States. Mexico and Central America recently was made 35 times more likely due to global warming, an international network of climate scientists said on Thursday.

The World Weather Attribution (WWA) group of scientists also said that extreme highs witnessed over that region in May and June were four times as likely to occur today as a quarter of a century ago.

The record-breaking heat killed at least 125 people in Mexico and caused thousands more to suffer heat strokes, a potentially fatal condition that occurs when the body's internal cooling mechanisms start to fail.

"We likely do not know the full picture of heat-related deaths, since they are usually only confirmed and reported months after the event, if at all," said WWA, which uses peerreviewed methods to assess links between specific extreme events and global warming.

They said that as the world continues to burn fossil fuels and emit climate-heating greenhouse gases into the atmosphere, millions more people are expected to be exposed to dangerous levels of heat in the future.

This year has been the hottest on record and already large swathes of the world have endured blistering temperatures before the onset of the northern hemisphere summer.

Greece has notched its earliest-ever heatwave, India has suffered a month-long stretch of searing highs, while the United States is dealing with wildfires and scorching conditions.

And in Saudi Arabia, at least 900 people died during the annual hajj pilgrimage, mostly from unforgiving heat with temperatures in Mecca hitting 51.8 degrees Celsius (125 degrees Fahrenheit) on Monday. 'Between life and death'

For its study, WWA analysed the hottest five consecutive days and nights during a "heat dome" that lingered over the southwest United States, Mexico, Guatemala, Belize, El Salvador and Honduras in late May and early June.

The scientists have pioneered ways to use climate models to understand how these types of extreme events have changed in a world that is 1.2 degrees Celsius warmer than in pre-industrial times.

They concluded "that human-induced warming from burning fossil fuels made the five-day maximum temperature event about 1.4 degrees hotter and about 35 times more likely".

WWA warned that if humans continue burning fossil fuels in the near term, these extremes could become more frequent still.

"The additional 1.4C of heat caused by climate change would have been the difference between life and death for many people during May and June," said Karina Izquierdo, urban advisor for the Latin American and Caribbean region at Red Cross Climate Centre.

"As well as reducing emissions, governments and cities need to take steps to become more resilient to heat," she said in a statement.

Heat is the deadliest of all extreme weather but often underestimated, experts say, with children, the elderly and outdoor workers particularly vulnerable.

In Mexico and Central America, the impacts of heat are intensified by poor housing conditions, limited access to cooling services, and for those living in informal settlements.

US reminds Lebanon 'We will back Israeli offensive against Hezbollah'

Beirut: Lebanese leaders this week received a "blunt" warning from US special envoy Amos Hochstein that the White House is ready to support an Israeli offensive in southern Lebanon if a "diplomatic solution" is not found to stop cross-border hostilities with Hezbollah.

The US will stand by Israel and not condemn them publicly if it launches an offensive against Hezbollah," Hochstein told senior officials in Beirut, according to an unnamed senior Arab official who spoke with Middle East Eye (MEE).

During his meetings with caretaker Prime Minister Najib Mikati and Speaker of Parliament Nabih Berri, Hochstein also revealed Israel "anticipates roughly five more weeks of intense fighting in Gaza, after which it will pause its main of fensive across the enclave."

After this, "Israeli offi-

cials intend to turn their full focus to the northern border with the aim of pushing Hezbollah back from the area so the roughly 60,000-96,000 displaced Israelis can return to their homes before the start of school in the fall," Hochstein reportedly warned.

The Israeli-born senior US official also said that the anticipated "lull in Gaza fighting" could allow Hezbollah and Israel to start negotiations and reach a detente "without a ceasefire agreement between Israel and Hamas.

Hochstein's visit to Beirut ended just hours before Hezbollah published unprecedented reconnaissance footage of numerous sensitive sites in Israel's north, namely the port of Haifa and its naval base.

The video immediately prompted Tel Aviv to announce the approval of battle plans for a wider-scale attack on Lebanon.

"NEET Papers Sold For Rs 32 Lakh," Arrested Aspirant Tells Bihar Police

New Delhi/Patna: The National Eligibility-cum-Entrance Test (NEET) 2024 paper leak fiasco saw a fresh twist today with the accused admitting to the police that question papers were arranged for certain candidates a day before the exam for nearly 32 lakh.

The shocking confession came from four persons arrested



by the Bihar Police, including a NEET aspirant named Anurag Yadav whose uncle is a junior engineer in the Danapur Municipal Council, and two others - Nitish Kumar and Amit Anand - the purported masterminds behind the paper leak.

They confessed that the question papers were provided a day before the May 5 exam.

Anurag Yaday told the police that his uncle Sikander Ya davendu arranged the NEET papers for him in advance.

"I was preparing for NEET at the Allen Institute in Kota (Rajasthan). My uncle Sikander Yadavendu called me to Patna and took me to Amit Anand and Nitish Kumar, where I was given some questions and the answer keys for the exam. I was told to memorise the answers. When I sat for the test the next day. I saw the questions were the same as those given to me on May 4. However, after the test, the police arrested me," he said.

Sikander Yadavendu claimed that he was told by Amit Anand and Nitish Kumar about the paper leak before the test.

"Amit and Nitish told me that the NEET question papers would be leaked and would cost about 30-32 lakh. I agreed and told them about four students - Ayush Kumar, Anurag Yadav, Shivanand Kumar, and Abhishek Kumar. On May 4, I took the four to a place where aspirants were already cramming up answers to the questions.

'Out of greed, I asked for 40 lakh from each student instead of the original amount. However, I was later caught by the police," he said, revealing the chain of events leading to the paper leak. Nitish Kumar and Amit Anand, in their statements to the police, admitted their role in the leak and revealed how their collusion with Mr Yadavendu led to their arrest.

Hundreds Died During Haj Pilgrimage In Saudi Arabia Due To Intense Heat

Rivadh: Hundreds of people died during this year's Haj pilgrimage in Saudi Arabia as the faithful faced intense high temperatures at Islamic holy sites in the desert kingdom, officials said on Wednesday as people tried to claim their loved ones' bodies.

Saudi Arabia has not commented on the death toll amid the heat during the pilgrimage, required of every able Muslim once in their life, nor offered any causes for those who died. However, hundreds of people had lined up at the Emergency Complex in the Al-Muaisem neighbourhood in Mecca, trying to get information about their missing family members

One list circulating online suggested at least 550 people died during the five-day Haj.

sociated Press on condition of anonymity to discuss information not released publicly by the government said that the names listed appeared genuine. That medic and another official who also spoke on condition of anonymity said they believed at least 600 bodies were at the facility. The list offered no cause of

Each year, the Haj draws hundreds of thousands of pilgrims from low-income nations, "many of whom have had little, if any, pre-Haj health care", an article in the April edition of the Journal of Infection and Public Health said. Communicable illnesses can spread among the gathered masses, many of whom saved their entire lives for their trips and can be elderly with preexisting health conditions, the paper added. However, the number of

dead this year suggests something caused the number of deaths to swell. Already, several countries have said some of their pilgrims died because of the heat that swept across the holy sites at Mecca, including Jordan and Tunisia.

Temperatures on Tuesday reached 47° Celsius in Mecca and the sacred sites in and around the city, according to the Saudi National Centre for Meteorology.

Others, including many Egyptians, lost track of their loved ones in the heat and the crowds. More than 1.83 million Muslims performed the Haj in 2024, including more than 1.6 million pilgrims from 22 countries, and around 222,000 Saudi citizens and residents, according to the authorities.

Govt Issues Draft Guidelines To Curb Unsolicited Biz Messages, Calls

New Delhi- The Consumer Affairs Ministry on Thursday sought public comments until July 21 on draft guidelines to curb unsolicited and unwanted business communications like promotional calls and text messages.

The guidelines — prepared after consultations with stakeholders, including telecom firms and regulators - define "business communication" as any communication related to goods or services like promotional and service messages but excludes personal communication.

They will apply to all individuals and entities that make or engage others for such communications or benefit from them, the ministry said in a statement.

The draft guidelines classify any business communication as unsolicited and unwanted if it does not comply with the recipient's consent or registered preferences

Other conditions that would make

a communication unauthorised include using unregistered numbers or SMS headers, calling despite recipients opting out, failing to obtain digital consent, not identifying the caller and purpose, and lacking an opt-out

The proposals also bar such communications that violate the telecom regulator Telecom Regulations Authority of India (Trai) rules on commercial messages based on customer preferences. While Trai's 2018 rules have been

effective for registered telemarketers, communications from unregistered marketers using private 10-digit numbers remain unabated, the ministry said.

"Do Not Disturb (DND) registry has been highly effective for registered telemarketers, but the unwarranted communication from unregistered telemarketers and those using 10-digit private numbers remain unabated,' the ministry said.



Need for a Shift in Examinations Landscape

A fresh approach towards the assessment of learning competencies


he relentless pressure to excel in exams drives students to the brink.The fundamental flaw in the existing examination system is that it creates students with mugging minds instead of questioning minds . Most students limit their potential by studying with the aim of securing good marks .The primary purposes of school education are to teach values to students, augment their thinking skills and learning abilities, equip them with knowledge and necessary skills in order to help them move to next stage education, and prepare them to face challenges in life. What it implies is that subjecting students to unhealthy competitions, celebrating the successful few and making other students feel dejected are not the purpose of school education.

Analysis of recently declared results

In the month of June 2024, three major results were declared, be it the NEET, JKBOSE 12th result followed by JKBOSE 10TH result. There has been much ado and chest thumping on the part of coaching institutes, schools and educators across the spectrum and literally social media platforms were flooded with congratulatory messages. Is our current examination system in sync with the holistic assessment of the core competencies? What actually is assessed? is still greater emphasis being given to rote learning which caters the lowest levels of competencies: be it remembering or understanding. What about the higher competencies of the learning pyramid? Are the higher learning competencies such as applying, analyzing, elaborating, evaluating and creating assessed in the existing examination system? In the existing scheme of things, these highest order learning competencies are not assessed to the level they should have been by the existing examination system. If the examination system still demands a student to be pure rote-learner, where he is supposed to do cramming or mug up the content, how we can expect our 21st century modern day learners to be future innovators: to mitigate the daunting challenges of 21st century, to be co-creators of knowledge, effective communicators, inclination towards inculcation of scientific arousal etc. Our examination system still heavily relies on penpaper tests and a student is expected to vomit out the content in the stipulated time, which determines the fate of his career progression.

Survivorship bias Model

As the saying goes, success is never ending, failure is never final but this saying goes for a toss when the mentors, coaching institutes and schools glorify the students who vomit out maximum content in the three hour pen -paper test and emerge out as meritorious .The glorification is not confined to within the four walls of the institution and even the life sized hoardings and banners are installed in public spaces to further add to the miseries of the lot who have not made the cut or have got comparatively less marks. The mentors, coaching institutes and schools never highlight the plight of underperformers or those who have not made it to the selection list and therefore left to God's mercy without any handholding and counseling either from the parents or from faculty members of coaching centres and schools. Lack empathy on part of the parents, tuition centres and schools alleviate stress levels among students already in distress, which at times compels them to commit suicide and it is there in the public domain that innumerable student commit suicide in case they fail to qualify or obtain lower grades. The students even leave their studies in the mid way leading to high dropout rate. The psychological distress children even




Current examination pattern prioritizes competition over comprehension

The modus operandi of existing examination system is such that it prioritizes competition over comprehension fostering a culture of rote learning rather than comprehension. Although NEP 2020 strongly envisages holistic development of the child, be it the physical development, cognitive development, linguistic development, psycho-social wellbeing but right from inception of the academic career of the child, the child is subjected to intense cramming as a means to secure high marks thereby by creating a situation which is intensely competitive and stressful, which seriously compromises his overall wellbeing.

National Curriculum Framework for School education 2023 (NCFSE 2023) has to greater extent streamlined and rationalized the curriculum to accommodate diverse learning needs and interests. The existing examination system therefore must provide space to assess the domain of critical thinking problem solving skills and real world application of knowledge over rote memorization. Infact there is need to introduce modular examination formats that allows students to demonstrate proficiency in individual subjects over an extended period. There needs to be a shift from high stakes, one-sizefits all examinations to a more nuanced assessment framework that values continuous learning and growth and provides opportunities for formative assessment and feedback throughout the learning process to facilitate personalized learning trajectories.

The principal determinant of effective pedagogy is the nature of assessment

The central provision of NEP 2020 is transition from rote memorization to attainment of age-appropriate competencies. The NEP 2020 strongly advocates in shifting from a behavioristic model of teaching –learning to a more engaging model of constructivist approach, where students are supposed to

on prior experiences. Students can meaningfully co-construct knowledge when the teacher will create a conducive learning environment. I am of firm conviction that the type of pedagogy to be employed by the teacher is strongly governed by the nature of the assessment. The transition from chalk and talk pedagogy to a more meaningful and engaging constructivist approach can only be replicated provided the examination system evaluates and assesses the student in 3600 approach: the holistic assessment, wherein the scholastic and no-scholastic domains are equally assessed, which in the longer run can play a pivotal role in meaningful transformation of the individual and thereby contribute positively in society. In contrast, when the examination system is designed and executed in such a way that it largely revolves around assessing the rote learning or mug up of information, the teacher obviously has to align his pedagogy accordingly and thereby becomes a dominant stakeholder in the teaching-learning process, leaving minimal scope for the child to imbibe the skills of creativity, critical thinking , collaboration and communication.

To expect turnaround in the pedagogical domain on part of the teacher, the assessment pattern has take into account the evaluation of all the requisite learning competencies: be it understanding, applying, analyzing, elaborating, evaluating and creating, which will certainly go a long way in stimulating teachers to update their pedagogical skills and shun the traditional approach.

Conclusion

There is a need to invest in comprehensive training programs for educators to deepen their understanding of pedagogical principles and assessment practices. Educators need to be equipped with the tools and the resources to implement learner -centered approaches and cater to diverse student needs effectively. The holistic evaluation criteria need to encompass a broader range of competencies including creativity, collaboration and emotional intelligence. Implementation of diverse and alternative assessment methods, such as portfolios, projects, and presentations to capture the multifaceted nature of student achievement. There must be a transition towards authentic, contextually relevant assessments that reflect real -world challenges and oppor-

Narcissism And The "As-If" Personality

lthough the narcissistic persona is appealing, the façade of illusion and superficiality indicates being prone to alienation from oneself. Reality is fraught with anguish, panic, absence, and void.

Narcissism is the love of an image, but one unrecognizable as oneself. The mirror is distorted both inwards and outwards. A man in analytical treatment commented, "What do I like? What do I want? I want to be desired, but I don't believe I'm desirable. I want excitement, but I can't excite myself with anything that is not taboo. I want to die, I think. I'm selfish and don't really care about anything more than my own comfort, stability, peace, and legacy. And all of this is starting to ring hollow. I am scared and what can I do?" The unanswered questions posed are: "Who am I really?" and "Can I be interested to know you when I do not see myself?"

Much pain is expressed within these words and draws us to the person covered in sparkling appeal but suffering in this ontological insecurity, living half-dead, feeling flawed. How can this paradox exist? This is a perspective about why love is difficult for a narcissist, finding it hard to give and easy to take. The person circles around but does not get into the intimacy, feelings, and emotions of love. Often appearing as a shiny object, adored, and idealized, they need glamourous projections onto them to prevent collapsing into what feels like the void of interiority.

Narcissism has been described as a grandiose sense of self with exhibitionism, needing reassurance of uniqueness while suffering in disturbed relationships. The capacity to kid oneself is huge and arises from the fraudulence the person vaguely fears bursting forth. Living on illusions, the continual re-establishing of these illusions requires much effort and is based on the avoidance of being closely seen and known. This person struggles to establish an integrated sense of "I." Yet, the overriding question within this personality includes, if I am not seen as exceptional, who am I?

From the perspective of Jungian analytical psychology, expanding the symbolism within narcissism moves us further into the depths of the psyche. This approach is oriented to transformation. It is not the pathology to focus upon but rather the search for meaning and increase in consciousness with connection to the unconscious, bringing relationality with others out of the narcissistic singularity and aloneness.

Narcissism brings us to a sensitive and deep reflection on the nature of these wounds and the analytical repair. Hope emerges from the conundrum of those caught in the throes of narcissism, whether it is about themselves, a partner, or the effects of a narcissistic parent. This includes attending to the culture of narcissism while the primary focus is understanding the individual psychological situation. The magnitude of uncertainties and transitions humanity is now undergoing indicates we are in a particularly challenging time to relate and understand others and accept their differences.

The narcissistic approach to life encompasses the "as-if" personality, an imposter type, a person feeling unable, unworthy, hiding in a grandiose tower. The concept of the "as-if" personality reflects a partial engagement while remaining emotionally hidden, mostly to themselves, unable to commit, to find their internal roots or fulfillment. Although often feeling alone and lonely, the narcissist has a creative edge and energy, compensating for the underlying morass of sorrow and disillusionment.

The idealized and illusions are to avoid the real, as it is assumed to be disappointing. Not uncommonly, many remark on negative inner thoughts interfering and critical self-evaluation. This is why they must always be on, persona in place, no sign of any disorder.

The narcissistic tendency towards self-absorption, narrowness, and individual subjectivity can prevent growth and become ossified with the aging process. Isolated within, the narcissist is the prisoner of their own ego. Preserved, suspended in time, can they realize what is happening to them? How can they find a ground of being when this is the very thing they assiduously avoid?

The narcissist feels anxiety and apprehension about life. This is covered over by developing an idealized persona to hide what is considered the fissures underneath, lying like a silent fault in the earth. This is all perplexing when a person appears verbal and pleasant, enchanting, and highly functioning, basking in the limelight. What is unnerving is the yet-to-be-discovered layers behind the veils, mirrors, and empty cheer. Like today's diagnosed narcissist, in the myth, Narcissus sees an idealized likeness, one without warts and blemishes. Narcissus' self-identity is inflated, unrealistic, incomplete, and in denial of the shadow. It also refuses the appeal of others for love or attention. Unable to respond to intimacy, the narcissist seems to want to keep it this wav.

However, given so much popular hype around the impossibility of narcissism, we run the risk of obscuring the urge for transformation embedded in this personality type. The process of Jungian analytical psychology opens a gateway through the agony and loss to find aliveness and love for self and others. We are made of many not one

and this can be interpreted as listening and responding to the voice of Echo reaching out rather than remaining in the singularity of Narcissus. In the original Ancient Greek myth of Narcissus and Echo, Narcissus was absorbed in his reflection, which was most beautiful and desirable, and would see none else. Echo desired him and he refused repeatedly. This is like the modern-day narcissist who only sees themself and regards no other as equal or worthy of attention.

The "as-if" personality is an aspect of narcissism in its selffocus, defenses, and avoidance of the effects of others, ultimately leading to defensive isolation from the world. This leads us to understand more about where each of us fits in denying our own discomfort and how to conquer it and manifest our growth.

Indians' Funds In Swiss Banks Plunge 70% To Hit Four-Year Low Of Rs 9,771 Cr

New Delhi/Zurich- Funds parked by Indian individuals and firms in Swiss banks, including through local branches and other finan-

cial institutions, fell sharply by 70 per cent in 2023 to a four-year low of 1.04 billion Swiss Francs (Rs 9,771 crore), annual data from Switzerland's central bank showed on Thursday.

The decline in aggregate funds of Indian clients with Swiss banks for the second consecutive year, after

hitting a 14-year-high of CHF 3.83 billion in 2021, was largely driven by a sharp plunge in funds held through bonds, securities and various other financial instruments.

Besides, the amount in customer deposit accounts and funds held through other bank branches in India also declined significantly, the data showed.

These are official figures reported by banks to the Swiss National Bank (SNB)

and do not indicate the quantum of the much-debated alleged black money held by Indians in Switzerland. These figures also do not include the money that Indians, NRIs or others might have in Swiss banks in the names of third-

country entities.

The total amount of CHF 1,039.8 million, described by the SNB as 'total liabilities' of Swiss banks or 'amounts due to' their Indian clients at the end of 2023, included CHF 310 million in customer deposits (down from CHF 394 million at 2022-end), CHF 427 million held via other banks (down from CHF 1,110 million), CHF 10 million (down from CHF 24 million) through fiduciaries

or trusts, and CHF 302 million as 'other amounts due to customers in form of bonds, securities and various other financial instruments (down from CHF 1,896 million).

The total amount stood at a record high of nearly 6.5 billion Swiss francs in 2006, after which it has been mostly on a downward path, except for a few years including in 2011, 2013, 2017, 2020 and 2021, as per SNB data.

While all four components had declined during 2019, the year 2020 saw a significant plunge in customer deposits, while there was a surge across

all categories in 2021. During 2022, only the fiduciaries segment saw an increase.

According to the SNB, its data for 'total liabilities' of Swiss banks towards Indian clients takes into account all types of funds of Indian customers at Swiss banks, including deposits from individuals, banks and enterprises. This includes data for branches of Swiss banks in India, as also non-deposit liabilities.

New Varieties From Italy Fetch Good Price, Say Kashmir's Cherry Growers

SRINAGAR: The newly imported cherry varieties from various countries, mainly Italy, are proving to be highly profitable for growers in Kashmir, even as the main traditional varieties await harvesting.

Growers across the valley said that these new varieties are fetching good rates. While some traditional varieties ready at this time are also performing well, the main traditional harvest is yet to commence.

Despite the new varieties not matching the traditional ones in terms of crunch, colour and nutritional value, they are less susceptible to rain damage and therefore fetch better prices, they said, adding that traditional varieties are often damaged by even low-intensity rain, resulting in lower market rates.

Rashid Ahmad, a cherry grower from south Kashmir's Shopian district, said that traditional varieties are frequently damaged by rain, even at low to moderate intensities. In contrast, the new varieties only suffer damage from very heavy rains, he said.

"Traditional varieties tend to ripen simultaneously, disrupting the supply and demand chain and forcing growers to sell at lower rates due to their short shelf life. However, the new varieties ripen at staggered intervals, maintaining a steady supply and demand chain, thus yielding higher profits," he said. Another grower Asif Ahmad

said that among the traditional varieties currently ready for har-



vest is the Siyah variety, along with the new Italian varieties. All are fetching good returns similar to last year, he said, adding, "Cherries are being sold at around Rs 150 per kg, which, though not exceedingly high, is considered a good return.'

Growers said that while traditional varieties are typically harvested from mid-June to the first week of July, the new varieties extend the season to around two months. This prolonged season provides more job opportunities for both local and non-local manual workers.

Peer Muhammad Amin, President of Fruit Mandi Shopian, told KNO that cherry rates are currently favourable. He expressed hope that the trend will continue with the traditional varieties. "This is just the initial stage, and with the peak season of traditional varieties approaching, there is optimism for sustained demand

and good prices," Amin said. A member of the Fruit Growers Association Kashmir said that approximately 85 percent of cherries are traditional, with most still awaiting harvest. The varieties being grown include Makhmali, Siyah, Awal Number, Italy, Jadi, Holland, Double, Mishry, Splendor and Steela.—(KNO)

PM Modi's Remarks On Statehood, Early Assembly Polls **In J&K Evoke Mixed Reactions**

SRINAGAR: Prime Minister Narendra Modi's announcement here on Thursday that assembly elections in Jammu and Kashmir will be held soon and plans are underway to restore its statehood in the near future evoked mixed reactions.

While former Congress leader Ghulam Nabi Azad-led Democratic Progressive Azad Party (DPAP) welcomed Modi's announcement, the main regional forces -- the National Conference (NC) and the People's Democratic Party (PDP)

-- reacted cautiously.
"We welcome PM Modi Ji's statement on conducting elections and restoring statehood in J&K," DPAP chief spokesperson Salman Nizami said in a statement.

He said the recent participation of the people in the Lok Sabha elections indicates that people are "eager for change and are desperately waiting for the elected government".

"This has been a long-standing desire and demand of the people. The government must also ensure peace and the smooth conduct of elections to fulfill the aspirations of the citizens," Nizami added.

NC chief spokesperson Tanvir Sadiq said the Election Commission of India (ECI) must follow the Supreme Court's timeline for the conduct of the assembly polls.

"Just so you know, the ECI must follow the Supreme Court's timeline for elections,



while the government's sole responsibility is to ensure a peaceful election atmosphere," Sadiq said in a post on X.

In December last year, while giving its verdict on a batch of pleas challenging the Centre's August 5, 2019 decision of abrogation of Article 370, the Supreme Court had directed the ECI to conduct elections in Jammu and Kashmir by September 30 this year.

On the assurance of Prime Minister Modi on the restoration of the statehood to J-K, the NC chief spokesperson said the people of the Union Territory (UT) have been hearing it would be restored soon for four years now.

"Regarding statehood, we've heard it will be restored 'soon' over 20 times in four years. Spoiler: 'soon' is still nowhere near," Sadiq said.

PDP chief spokesperson Suhail Bukhari also said the people of J-K have been hearing about the conduct of assembly polls and restoration of statehood for the past few years, but will believe it only when it happens.

"We have been hearing this for the past five years. We

will believe it when it happens. They talk about elections and statehood in a way as if they are doing a favour to us by granting our democratic rights," Bukhari said.

Prime Minister Modi said on Thursday that assembly elections will be held soon in Jammu and Kashmir and plans are underway to restore statehood to the UT in the near future.

In his first visit to the valley after becoming the prime minister for the third consecutive term, Modi emphasised the importance of enabling the people of Jammu and Kashmir to elect their representatives for the assembly.

In his address at a gathering at SKICC 'Empowering Youth, Transforming J&K', he commended the people for their active participation in the Lok Sabha elections and expressed the need for them to choose their local leaders through upcoming assembly elections.

"The people of Jammu and Kashmir participated in Lok Sabha elections in large numbers and broke the record of the past 35 years. You deserve to be felicitated for it...

"Now time has come that the people of Jammu and Kashmir chose their own local representatives. For that, preparations are being made for holding assembly elections," he said.

Furthermore, Modi assured the people that the day was approaching when Jammu and Kashmir would regain its statehood status.

Trip To Kashmir Gets Costlier As Airfare Hikes By Nearly 50 Percent

SRINAGAR: Amid record breaking tourist arrivals, the airlines companies have hiked the airfare from various destinations to Kashmir by more than 40 per cent.

As such, the stakeholders fear it could impact the flow of tourists in the coming months when Kashmir usually remains abuzz with visitors.

A cursory look at the airfare chart by various airline companies suggest that a one way trip from New Delhi to Srinagar costs between Rs 8000-11000 per person.

Normally the same ticket would sell at Rs 4500-Rs 5000 per person.

Similarly, an air ticket from West Bengal, where Kashmir receives maximum tourists during the ongoing season, sells between Rs 13000 to Rs 20000 per person. A return ticket costs between Rs 15000 to Rs 20000 per person.

The airfare has also hiked for other destinations including Maharashtra and Bangalore, which contribute a major proportion of tourist arrivals during the summer season.

A round trip to Kashmir from Maharashtra costs more than Rs 20000 per person. Same is

the case with Bangalore, where round trip to Kashmir has hiked by more than 50 percent.

Tourism players fear it could impact the ongoing summer and autumn seasons during which Kashmir receives a maior chunk of tourists.

It has left them worried as their Kashmir tour packages are getting costlier, hence unaffordble to many aspiring visitors.

"Airfare hikes have always been an issue with Kashmir tourism. It becomes one of the major deterrents to our promotion activities. We have been always requesting the government to curb the menace as we lose a huge chunk of tourists due to the unaffordable air tickets," said President Travel Agents Association of Kashmir Rauf Tramboo.

He said the Kashmir packages have become costlier due to the airfare hike by the airline companies. "Such is the situation that a trip to Dubai or Thailand becomes cheaper than a Kashmir trip. Tourists prefer international trips over Kashmir due to the airfare hike," Tramboo said.

The stakeholders appealed to the government to regulate the airfare for a smooth summer and autumn tourism season in Kashmir—(KNO)

Killing Of 2 Foreign Terrorists 'Major Success' For Security **Forces: Army**

RAFIABAD: Security Forces claimed to have achieved a major success by killing two foreign terrorists in Hadipora, Rafiabad encounter on June 19.

Addressing a press conference at Pohrupet, Commander 7 sector Rashtriya Rifles (RR) Depak said that since the last few days, there were continuous inputs about the presence of terrorists in Sopore's Rafiabad. "On June 19, a specific information was generated by the J&K police about the presence of terrorists in a house at Hadipora, Rafiabad, after which the army, police and CRPF launched a joint operation. After zeroing in the house, two terrorists were eliminated in an encounter," he said. The army officer was flanked by Deputy Inspector General of Police north Kashmir, Vivek Gupta and other officers of police and army.

The two slain terrorists were affiliated with the Lashkar-e-Taiba outfit and have been identified as Usman and Umar. "Usman has been active in Kashmir since 2020," the army officer said.

He said that arms and ammunition in a large quantity was recovered from the site of the encounter.

"The killing of two terrorists is a big success for the security forces. Since the past few weeks, there is a high operational momentum which is bearing good results in the form of elimination of terrorists," he said. "We are enjoying the continuous support of people."

Meanwhile, a statement issued by the army said that over the past few weeks there has been constant information of the movement of a terrorist group in the Sopore-Rafiabad area of Baramulla District, "A specific in telligence was received through IKP that two terrorists were holed up in a house in Hadipura village of Rafiabad area. Consequently, Indian Army, JKP and CRPF launched a joint operation, swiftly cordoning off the area. Following standard procedures, civilians were safely evacuated from adjacent houses and the area was secured. The target house was thoroughly cordoned off and on the search being commenced, terrorists opened fire on the security forces. In the ensuing firefight, two terrorists were neutralized," the statement said.

Yoga Day: Mufti Alleges J&K Employees Being Forced To Take Part, Govt Denies

SRINAGAR: PDP president Mehbooba Mufti on Thursday criticised the Jammu and Kashmir administration for allegedly forcing employees, including pregnant women, to report for the International Yoga Day event at odd hours, saying an occasion for celebration has filled people with dread.

Prime Minister Narendra Modi will lead the main International Yoga Day (IYD) celebrations this year at an event at SKICC here on Friday.

"An occasion for celebration has become one that fills people with dread. A day before Înternational Yoga Day, all govt employees along with school children have been ordered to show up at different venues at ungodly hours.

"Even pregnant employees have not been spared. A pregnant employee was threatened

Wildlife Casual Labourers Protest In Bijbehara, **Demand Fair Wages**

SRINAGAR: Casual laborers of the Wildlife Department protested on Thursday in Bijbehara, demanding wages at par with other casual laborers.

Laborers expressed frustration over receiving meagre wages despite working day and night. They said their earnings amount to only a few hundred rupees, which they receive

The protesters said that casual laborers in other departments receive Rs 9,000 per month. They questioned why the Wildlife Department laborers face such disparity.

"We play a critical role in managing man-animal conflicts and other duties, yet we are not compensated adequately and often face months-long delays in salary disbursement." they said, adding, "If the department continues to treat us this way, how will we survive on a meagre salary of a few hundred rupees, which we often get after several months." The laborers demanded that

the government either disengage them or provide wages comparable to other casual laborers, and ensure they receive Rs 9,000 per month.

Bilal Ahmad, one of the casual laborers, said that many of them have families to support and struggle to manage household expenses and children's school fees with their infrequent and insufficient wages, despite having served the department for over 20

The laborers urged that their files be forwarded to higher authorities to ensure they receive fair compensation. They called for the intervention of Lieutenant Governor Manoj Sinha and other authorities to address their grievances.

All casual laborers in the Wildlife Department are currently on strike and have vowed to continue their protest across Kashmir until their demands are met—(KNO)

Traffic Violation On Kashmir Highway: Rs 3.8 Crore Fine Imposed, 553 Vehicles Seized

SRINAGAR: While addressing media persons at Traffic NHW Headquarter Ramban, DIG Traffic Jammu Zone, Dr Mohd Haseeb Mughal IPS shared that Continuing its drive against Motor Vehicle Act violations, Traffic Police National Highway under the supervision of IGP Traffic J&K have booked 38350 Traffic violators and imposed heavy fine amount of Rs 38523950/- for breaching traffic rules since 1st January 2024 to 31 May 2024.

Besides this, during the period, 553 vehicles were seized. To cause deterrence among Traffic rule violators and to reduce road accidents. 29 FIRs lodged for overloading in PSVs out of which 21 FIRs lodged in District Doda & Kishtwar, 05 FIRs lodged in District Udhampur, 03 FIRs lodged in District Ramban.

Strict action against overloading in goods as well as in PSVs taken, Traffic Police NHW booked 1418 vehicles for overloading in goods vehicles and 10468 traffic violators for causing overload in PSVs.

To maintain lane discipline on National Highway, Traffic Police NHW Ramban booked 800 Traffic violators for overtaking/wrong lane driving during the current year and also booked 326 number of traffic rule violators for dangerous driving/red light jumping.

The officer further informed that to make the general public aware regarding Traffic rules, Traffic Police NHW Ramban conducted 145 Traffic awareness programs at different locations of 05 Districts i.e. Ramban, Udhampur, Reasi, Doda, Kishtwar, and on 03 NHs falling in Traffic NHW Ramban and created awareness among drivers , students , commuters , transport unions/ agents regarding

GROS ISLET: If their authoritative win against the West Indies is a sign, England batters seemed to have found their cloak of invincibility at the right time and they will eye an encore against a formidable South African bowling unit in a Group-2 match of the T20 World Cup Super 8s here on Friday.

England were at their menacing best against the Windies, while handing them a crushing eight-wicket defeat here that has also fired them to the top of the group through a better Net Run Rate — +1.34 against SA's +0.90.

That the winner here will have their one foot in the semifinals of this ICC show-piece will come as an additional motivation.

South Africa, on the other hand, suffered a scare from the USA before they squeezed out an 18-run win in their Super Eight opener.



English opener Phil Salt showed why he is the No. 2 T20I batter in the world when he steered a tricky 181-run chase, mixing caution and aggression en route an unbeaten 87. Salt would once again look to give England an explosive start along with his skipper Jos Buttler, who will be eyeing some runs under his belt.

Buttler, who scored a 42 in

their loss to Australia in the group stage, has not been able to convert his starts with just 91 runs from four innings.

The return to form of Jonny

Bairstow, who struck a crucial 48 not out against the West Indies, will also be a big boost for England.

Bairstow had scored just 46 runs with two single digit dismissals in this tournament.

The challenge for the likes of Kagiso Rabada and Keshav Maharaj will be to prevent the England batters from running away with the match.

The South African duo showed exceptional control and discipline in the middle and death overs to seal a fine win against the USA, who failed to chase 28 runs from the last two overs.

The biggest positive for South Africa is Quinton de Kock rediscovering his form. Following his poor outings with the bat -20, 0, 18 and 10-so far, De Kock smashed a 40-ball 74 against the USA.

England will also have a better idea of the conditions having already played against the West Indies here.

PCB Might Bring Change In Selection Committee: Report

The Pakistan Cricket Board (PCB) is likely to make changes to the seven-member selection committee after the Men in Green's poor performance in the T20 World Cup 2024, according to a report from ESPNCricinfo. "Despite playing so much cricket, no one knows which shot to play and when," Kirsten said, as quoted from Geo News. Pakistan ended their campaign with a three-wicket win over Ireland in Florida on Sunday, a dead rubber after India and USA, from Group A, advanced to the Super 8 stage.

Placed in Group A, Pakistan endured back-to-back defeats against the co-hosts USA and then to their bitter rival, India. They bounced back with two wins on the trot, but it wasn't enough to turn their woeful campaign around and secure a spot in the Super 8. (ANI)

Former India Pacer David Johnson Dies After Falling From 4th Floor

BENGALURU: Former India pacer David Johnson has died after falling from the balcony of his fourth-floor apartment here and an investigation is being conducted to figure out if it is a case of suicide, a police official said on Thursday.

He was 52 and is survived by his wife and two children. As per currently available details, Johnson, who was running a cricket academy near his home, had not been keeping well in recent times.

"We were informed that he had fallen from the fourth floor of his apartment build-



ing. He was taken to a hospital but the doctors declared him brought dead," a Karnataka State Cricket Association (KSCA) official told PTI.

A police official said the death is being investigated.

"It is believed that 52-yearold David Jude Johnson fell from his Apartment in Kanaka Sri Layout in Kothanur giving rise to the suspicion of suicide," a police official said.

In his prime, Johnson, who played two Tests and 39 First-Class matches, was the member of a formidable Karnataka bowling unit that also featured Anil Kumble, Javagal Srinath, Venkatesh Prasad and Dodda Ganesh.

Legendary leg-spinner Anil Kumble condoled his onetime teammate's death.

"Saddened to hear the passing of my cricketing colleague David Johnson. Heartfelt condolences to his family. Gone too soon 'Benny'," Kumble wrote on X.

Laxman To Be With Indian Team In Zimbabwe; Gambhir's Coaching Era Begins Soon

The squad for the Zimbabwe series will be announced later this week, with young IPL performers currently undergoing a camp under Laxman's guidance. Gambhir, favorite to become the head coach of the senior men's team, will likely start mid-July when India travels to Sri Lanka.

India To Play Bangladesh, New Zealand, England In 2024/25

Team India will play against Bangladesh, New Zealand, and England as the Board of Control for Cricket in India (BCCI) announced fixtures for the upcoming international home season of the Men in Blue for 2024-25 on Thursday. BCCI stated that Rohit Sharma's side will play against Bangladesh in a two-match Test series, followed by a three-match T20I series.

The first Test match between India and Bangladesh will be played in Chennai. While Kanpur will host the second long-format match.

Chennai In Race To Host Prestigious World Chess Championship

A two-member team from the International Chess Federation (FIDE) is set to arrive on Friday to inspect potential venues for the World Championship. Chennai, along with Delhi and Singapore, is in the race to host the championship. Delhi's bid comes from the All India Chess Federation (AICF), whereas Chennai's bid is backed by the Sports Development Authority of Tamil Nadu (SDAT).

Serbia Threatens To Quit Euros If UEFA Does Not Punish Croats, Albanians

Serbia soccer officials threatened to quit the European Championship after they were offended by fan chants reportedly heard during the Albania-Croatia match.

The game on Wednesday ended 2-2 in Hamburg. Serbia started its second group match against Slovenia on Thursday afternoon in Munich.

"What happened is scandalous and we will ask UEFA for sanctions, even at the cost of not continuing the competition," Serbia Football Association general secretary Jovan Surbatovic said.

Euro 2024: Plan B For France After Mbappe's Injury

France boasts fearsome strength in depth but remains hugely reliant on Kylian Mbappe for inspiration and is now facing the prospect of being without their injured superstar for at least their next Euro 2024 game against the Netherlands on Friday.

Captain Mbappe is recovering from a broken nose suffered in Monday's 1-0 win over Austria in Düsseldorf in their opening match of the

tournament.

The new Real Madrid signing, who forced the own goal by Maximilian Wöber which decided the game, was badly hurt in a collision with Austrian defender Kevin Danso and had

to be replaced by Olivier Giroud.

The French Football Federation later said Mbappe would not need an operation but did admit he would need to be fitted with a mask before he could return to action.

In any case, the lack of time between matches means the clash with the Dutch in Leipzig is set to come too soon for the 25-year-old. France coach Didier Des-

France coach Didier Deschamps will hope his team can get a positive result, which could seal their last-16 place, meaning Mbappe might also be able to sit out the last Group D game against Poland without it being a problem.

But can Les Bleus beat a strong Netherlands side without arguably the world's most lethal striker?

Mbappe is his country's third-top scorer of all time with 47 goals from 80 caps, behind only Giroud and Thierry Henry.

He has only scored once in France's last six matches, and that was in a pre-tournament friendly against Luxembourg.

However, he had an outsized impact on their performances at the last World Cup, scoring eight goals — half the team's total — including an astonishing hat-trick



in the final against Argentina. France met the Netherlands twice in Euro 2024 qualifying, and

Mbappe scored a brace on each occasion, in a 4-0 win in Paris and a 2-1 victory in Amsterdam.

Above all, it is worth considering how France has done in recent games without the player who

has just ended a prolific sevenyear spell at Paris Saint-Germain. Deschamps' team lost 2-1

in a friendly in Germany last September when Mbappe was left on the bench. They also laboured to a 0-0 draw against Canada in their final pre-tournament friendly when he only appeared as a late substitute.

GIROUD'S CHANCE?

Their goal threat is obviously not the same without Mbappe, even if he has still never scored at the European Championship.

At the last Euros three years ago, Mbappe failed to find the net and missed the crucial spot-kick in a last-16 loss on penalties to Switzerland.

Against Austria, he squandered one golden chance when clean through with just the goalkeeper to beat.

The obvious option for Deschamps when it comes to replacing Mbappe would be to start Giroud, even if the big centreforward is a very different player.

Giroud, who will move to MLS after the tournament, is 37 now and has also been nursing a minor groin injury.

He ended up playing a key role in Qatar, and in similar circumstances — Karim Benzema would have been ahead of him only to pull out injured at the last minute. Another option for Deschamps is to move Marcus Thuram from the left wing to a central role.

Thuram, though, has only scored twice for his country in 20 caps, and one of them came against Gibraltar.

Then there is Randal Kolo Muani, but he appears low on confidence after a difficult season in Mbappe's shadow at PSG.

One thing is for sure, France's performance against Austria — with the returning N'Golo Kante outstanding, shielding an impressive defence — indicated they do at least look solid enough to shut most opponents out as they wait for Mbappe to return.

Pleas For Cancelling NEET 2024; SC Issues Notice To Govt, NTA

New Delhi: The Supreme Court Thursday sought responses from the Centre, the National Testing Agency (NTA) and others on petitions seeking the cancellation of NEET-UG 2024, and a court-monitored probe into the alleged irregularities in the medical entrance exam.

A vacation bench of Justices Vikram Nath and SVN Bhatti also sought responses from the parties on separate pleas filed by the NTA seeking the transfer of some pending petitions from the high courts to the apex court. The bench posted these pleas for

hearing on July 8. One of the petitions, filed by 20 students who appeared in the medical entrance exam, also sought a direction to the NTA and others to conduct the test afresh.

While hearing separate pleas concerning the National Eligibility-cum-Entrance Test (Undergraduate)-2024 examination, the apex court had on June 18 said even if there was "0.001 percent negligence" on the part of anyone in the conduct of the examination, it should be thoroughly dealt

The NTA conducts the all India premedical entrance test.

While hearing separate petitions raising grievances over the NEET-UG 2024, the apex court had last week sought responses from the Centre and the NTA on a plea for a Central Bureau of Investigation (CBI) probe into allegations of question paper leak and other irregularities in the exam.

The examination was held on May 5 across 4,750 centres and around 24 lakh candidates took it.

Notably, the outcry against alleged irregularities in the medical entrance exam NEET grew louder on Thursday with several student groups staging protests and opposition attacking the government saying the paper leaks are expansion of the Vyapam scam and future of candidates who appeared in these exams is being destroyed.

The cancellation of UGC-NET, amid the raging row over NEET, led to questions being raised over National Testing Agency's (NTA) capability to conduct exams of larger magnitude.

The ministry on Wednesday cancelled UGC-NET conducted by the NTA following inputs that the integrity of the examination may have been compromised.

Congress leader Rahul Gandhi held a press conference and launched a

scathing attack on the government over the alleged irregularities in NEET and cancellation of UGC-NET and said Prime Minister Narendra Modi has "psychologically collapsed" post-elections and will struggle to run a government like this.

He said the main reason for paper leaks is that educational institutions have been captured by the BJP and its parent organisation RSS and paper leaks will not stop unless that is reversed.

"It was being said Prime Minister Modi stopped the Ukraine-Russia War and Israel-Gaza war, but he is either not able to stop exam paper leaks or doesn't want to," Gandhi said.

He claimed that during his Bharat Jodo Nyay Yatra, thousands complained about paper leaks.

"There has been an expansion of idea

of Vyapam to rest of country," he said of the recent controversy while referring to the Vyapam examination and recruitment scam in Madhya Pradesh.

"Nothing should be done in arbitrary manner, rules that apply to one paper should apply to another," Gandhi said.

More than two dozen students from different universities and members of various students' groups were detained on Thursday while they were protesting against the cancellation of the UGC-NET examination and irregularities in the NEET.

The students were detained from outside the Ministry of Education as well as the Education Minister Dharmendra Pradhan's residence here in central Delhi. Bihar Deputy Chief Minister Vijay Kumar Sinha claimed the arrested prime accused in the NEET

"paper leak" is linked to officials associated with RJD leader Tejashwi Yadav, and demanded an investigation into it.

Kerala Chief Minister Pinarayi Vijayan urged the Centre to take immediate steps to resolve the crisis in the NTA, saying its "repeated incompetence" in conducting exams such as NEET and the UGC-NET cannot be accepted.

Trinamool Congress MP Saket Gokhale said the examination process in the country has crashed and the lives of students are being destroyed. He accused the NTA of being complicit. Rashtriya Janata Dal (RJD) MP Manoj Jha said the NEET exam should also be

"You had to scrap NET and you must scrap NEET now as there is ample proof that this examination was compromised. And it is time to acknowledge that the NTA is a fraud," he said.

There are 927 bridges (combined length of 13 Km). These bridges include the iconic Chenab Bridge (Overall length 1315 m, Arch span of 467 m and height of 359 m above river bed) which is around 35 metres taller than the Eiffel Tower and is pegged to be the World's highest arch railway bridge.

Burials begin In addition to Egypt, new fatalities were confirmed on Thursday by Pakistan and Indonesia.

Out of around 150,000 pilgrims, Pakistan has so far recorded 58 deaths, a diplomat briefed on the tally told

"I think given the number of people, given the weather, this is just natural," the diplomat said.

Indonesia, which had around 240,000 pilgrims, raised its death toll to 183, according to the ministry of religious affairs, compared with 313 deaths recorded last year.

members have been searching for pilgrims who are still missing. On Wednesday they scoured hospitals and pleaded online for news, fearing the worst during the scorching

temperatures. Two diplomats told AFP on Thursday that Saudi authorities had begun the burial process for dead pilgrims, which involves cleaning up the bodies, putting them in white burial cloth and taking them to be interred in individual graves.

"The burial is done by the Saudi authorities. They have their own system so we just follow that," said one diplomat, who pointed out that his country was working to notify loved ones of the dead as best it could.

The other diplomat said that given the number of fatalities it would be impossible to notify many families ahead of time, especially in Egypt which accounts for so many of the dead.

Saudi Arabia has not provided information on fatalities, though it reported more than 2,700 cases of "heat exhaustion" on Sunday alone. Last year various countries reported

more than 300 deaths during the hajj, mostly Indonesians. The timing of the hajj moves back about 11 days each year in the Gregorian calendar, meaning that next

year it will take place earlier in June,

potentially in cooler conditions. A 2019 study by the journal Geophysical Research Letters said because of climate change, heat stress for hajj pilgrims will exceed the "extreme danger threshold" from 2047 to 2052 and 2079 to 2086, "with increasing frequency and intensity as the century progresses".

Hosting the hajj is a source of prestige for the Saudi royal family, and King Salman's official title includes the words "Custodian of the Two Holy Mosques", in Mecca and Medina.

The hajj has been the scene of a number of stampedes and fires over the years, most recently in 2015 when a stampede during the "stoning the devil" ritual in Mina, near Mecca, killed up to 2,300 people in the event's mostly deadly disaster.

senior Jammu and Kashmir Hajj officer said.

The official said that among the ten deceased includes a Srinagar based couple too.

The situation has sparked outrage and concern among Kashmiri pilgrims who have called the Saudi government incapable of carrying out the pilgrimage.

Speaking to the Kashmir Observer from Saudi Arabia, Dr. Adeel Hussain, a pilgrim from Kashmir highlighted some issues faced by the pilgrims.

"There was non-availability of drinking water at crucial points like the Jamarat Building, even packed water was not available which exacerbated the suffering of the pilgrims," he said.

He alleged the closure of the metro

train at essential times, particularly when pilgrims needed to travel from Muzdalifah to Jamarat, added to the chaos. "The absence of cooling points at Muzdalifah and Jamarat further worsened the situation, leaving many vulnerable to heatstroke," he added.

"The lack of medical staff and ambulances at necessary points like Muzdalifah and Jamarat is another major issue. There is a severe shortage of medical personnel and ambulances, which hindered timely medical assistance to those in need," Dr Hussain said.

He also criticized the non-availability of guiding staff for pilgrims who got separated from their groups and the closure of emergency exit points at Jamarat.

Another point was the mismanagement and the inability to properly manage the crowds were significant concerns. "The security personnel failed to manage the crowds efficiently, leading to chaos. The arrogant behavior of police personnel, especially when pilgrims attempted to take shortcuts to avoid the intense heat, was unacceptable, it was another rea-

son for pilgrims insecurity," he stated. "We saw an elderly woman dying on the roadside but we could not do anything. The security personnel deployed did nothing to save her life. I can't get over what I have seen. Saudi authorities are incapable of managing the situation," Shafiq Mir, a pilgrim

Shafiq further pointed out the lack of special facilities for vulnerable pilgrims, including the elderly and physically challenged individuals, particu-

"There were no special provisions for the most vulnerable pilgrims and the non-availability of translators added to the difficulties of pilgrims, leaving many pilgrims unable to communicate their needs and seek help

While Saudi authorities claim to have implemented measures to address the extreme heat, including shaded areas, water points, and improved healthcare capacity, pilgrims believe these efforts were insufficient in the face of the severe conditions.

Pilgrims Allege

The pilgrims, alleged that they have paid up to 10 lakh rupees each, were promised a hassle-free Hajj experience by Srinagar-based Makka Madina Tour and Travels, in collaboration with Delhi-based Quick Travels.

Parvaiz alleged. "We request the authorities to take strict action against Makka Madina Tour and Travels, and Quick Travels, for their negligence and fraud. We paid hefty amounts for a hassle-free Hajj experience, but were left stranded in Makkah. We don't want others to suffer the same fate.

The pilgrims have demanded cancellation of the license of the tour operator, refund of the package cost and compensation for the inconvenience and hardship caused.
