Russia India's 'All-weather **Friend': PM**

Modi In Moscow, Lauds Putin, Calls For Confluence Over Influence

Prime Minister Moscow: Narendra Modi on Tuesday made a wholehearted endorsement of India's ties with Russia, describing the old ally as India's "all-weather friend" and lauding President Vladimir Putin for strengthening the bilateral relations over the past two decades of his leadership.

Addressing the Indian dias-pora, he said the India-Russia relationship is built on the strong pillar of mutual trust and respect, asserting that their ties were tested time and again only to emerge stronger every time.

Modi's high praise of Russia as an ally and Putin's leadership came amid ongoing efforts by the Western world to isolate the Russian leader over the war in Ukraine.

Prime Minister Modi also made a veiled criticism of the "influence-oriented global order" which endured for decades.

"But, what the world needs right now is confluence not influence and no one can deliver this message better than India which has a strong tradition of worshipping confluences," he said.

He said India is being seen as a strong pillar in the "emerging multipolar world order".

"When it speaks of peace, dialogue and diplomacy, then the whole world listens." Modi has often stressed the need for dialogue and diplomacy to end the war between Russia and Ukraine. Commenting on India's ties

with Russia, he said he has been for decades an admirer of the unique partnership between the two countries.

"On hearing the word Russia, the first word that comes to the mind of every Indian is India's 'sukh-dukh ka saathi' (all-weather friend) and a trusted ally," he said. "No matter how low the temperature dips below zero degrees during | More on P10

Female SRs/PGs Allowed 6 Months Maternity Leave

Srinagar: In a progressive move aimed at enhancing the well being as well as work-life balance of Senior Residents (SRs)/ Tutors and Postgraduate (PG) students, the Health and Medical Education (H&ME) department has ordered one-day weekly-off and 20 days of Casual leaves, including five academic leaves per year for all Senior Residents/ and Postgraduate Tutors Students executing their assignments in Government Medical Colleges of J&K. This significant step has been taken in compliance to National Medical Commission (NMC) and National Board of Education (NBE) norms. As per the order, for Senior Residents/Tutors:, there shall be weekly one-day off (subject to exigencies of work). "In addition, a Senior Resident/ Tutor shall be eligible for Twenty (20) days' Casual Leave. Five (05) days' Academic Leave per year shall be admissible subject to the relevance of the programme to the course" the

off (subject to exigencies work), adding that PG Students shall be eligible for twenty (20) days Casual Leaves and Five (05) days' Academic Leaves per year subject to the relevance of the programme to the course. It adds that Female Post-graduate students shall be allowed Maternity Leave MTP/Abortion Leave as per existing Government rules and regulations while as Male Post-graduate students shall be allowed Paternity Leave as per existing Government rules and regulations. It however reads that this shall be subject to the minimum attendance requirement during the course as per NMC norms. It adds that the period of training shall be extended by same number of days for which Maternity/ Paternity Leave and total excess Casual Leave, over and above minimum attendance requirement, are availed dur-

KASHMIR SIZZLES AGAIN Rain Likely in Coming Days

Srinagar: While there was a slight respite from the heat wave in Jammu and Kashmir, the parts of the Valley recorded a bit rise in the mercury on Tuesday with Srinagar, the summer capital of the Union Territory recording a maximum temperature of 34.2 degree Celsius.

As per the details, besides Srinagar, all the other stations too have recorded a slight rise in the maximum temperature today. Qazigund, a gateway of Kashmir, has recorded a maximum temperature of 32.0 degree Celsius while Pahalgam, a famous tourist destination has recorded a maximum temperature of 28.1 degree Celsius.

In Kupwara, the mercury settled at 34.2 degree Celsius while Kokernag recorded 31.0 degree Celsius. Gulmarg, a famous ski-resort, recorded a maximum temperature of 24.0 degree Celsius.

In the Jammu division, the mercury continued to settle around the normal temperatures with Jammu, the winter capital of the Union Territory, recording a maximum tem-perature of 35.5 degree Celsius.

Banihal recorded 33.0 degree Celsius while Batote, Katra and Bhaderwah recorded a maximum temperature of 28.3 degree Celsius, 32.2 degree Celsius and 35.2 degree Celsius respectively. Moreover, | More on P10

Assembly Polls: BJP Considers Strategic Alliances

Srinagar: Ahead of the highly anticipated assembly elections in Jammu and Kashmir, the Bharatiya Janata Party (BJP) is considering strategic alliances and support for independent candidates to secure a majority and form the government in the erstwhile state.

Speaking to the media on Tuesday, BJP state President Ravinder Raina, stated that the party plans to contest the elections independently but is open to collaborating with like-minded parties and supporting certain independent candidates. This approach aims to consolidate the BJP's vote bank and ensure victory in key constituencies.

"There are some constituencies and areas where independents and like-minded people will be supported by the BJP so that the BJP's vote bank could be utilized for ensuring the victory of that candidate. We want the BJP along with the like-minded candidates to win and we cross the 50 seat mark to form the government," Raina said.

Raina emphasized that the BJP's primary goal is to achieve a majority in the assembly by surpassing the 50-seat threshold. He said that party's election strategies will be tailored to maximize its chances of success, potentially leading to collaborations with independent candidates and like-minded political entities. SC Closes PIL Over Non-**Functional Panels In J&K**

New Delhi: The Supreme Court on Tuesday closed the proceedings on a PIL, which claimed non-functional statutory panels exist in Jammu and Kashmir, after being told by the union Territory administration that these are now func-

tional and the powers of some like the State Human Rights Commission are being exercised by the NHRC. The top court had

earlier issued notices to the Centre on the 2020 PIL, filed by Pune-based lawyer Asim Suhas Sarode, and sought the assistance of Solicitor General Tushar Mehta in deciding it. It was alleged that statu-

tory panels like the state human rights commission were

not functional in the union territory after the abrogation of Article 370 which accorded special status to the erstwhile state.

The PIL alleged seven panels, including the Jammu and Kashmir State Commission for Women, the state commission for persons

Srinagar: Lieutenant Governor of Jammu & Kashmir Union Territory has designated existing courts of district judges and additional district judges as "the Land Acquisition, Rehabilitation and Resettlement Authority" under the central land acquisition law which became applicable to the Union Territory in 2019.

The LG has designated these courts as "the Land Rehabilitation Acquisition. and Resettlement Authorities" in exercise of powers vested with him under "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013."

Under the law, the Authority is vested with powers to resolve disputes relating to land

acquisition, compensation, rehabilitation and resettlement.

According to a notification issued by the Department of Law, Justice and Parliamentary Affairs, all the district judges and additional district judges in each district have been appointed as presiding officers of the concerned Authorities

within their respective jurisdiction for speedy disposal of land disputes related to land acquisition, rehabilitation and resettlement.

J&K Next To Bihar In Corruption. **TII, CMS Blow Whistle**

CRINAGAR - Jammu and Kashmir is in the news for yet anoth-Der wrong reason, that it is India's second most corrupt state, next only to Bihar, while Kerala has emerged as die least corrupt The startling revelation follows a recent survey titled "The India Corruption Study 2005," conducted jointly by the Transparency International India (TII) and die Centre for Media Studies (CMS). The study sampled about 14,500 respondents from over 150 cities and 300 villages across 20 Indian states and covered about a dozen services, including police, judiciary, education and public distribution system. It has placed the state very low at 19th position, just a shade ahead of Bihar. Apparently, die services surveyed may not have included various engineering disciplines, industries and allied sectors, revenue, agriculture and allied fields, education, healthcare, transport and traffic control. In case they were, Jammu and Kashmir should have had die dubious distinction of being die most corrupt state ahead of Bihar. While die alarming report may not have disturbed die sleep of those at die helm. die revelations must certainly not be music "to die state people's ears. By any stretch of imagination, the scenario is greatly disturbing for a place otherwise groaning under the debilitating impact of numerous other misfortunes, natural as well as manmade. Given the tall promises held out by successive rulers to root it out, the disclosure is all die more amazing.

90% Gazans Displaced Amid War With Israel, Says UN

United Nations: UN humanitarians have said 90 per cent of Gazans were displaced, some multiple times, as more evacuations were ordered and poor or no security hampers aid and fuel deliveries.

The UN Office for the Coordination of Humanitarian Affairs (OCHA) said on Monday that the Israeli military instructed on Sunday and Monday tens of thousands of people living in 19 blocs of apartments in Gaza City to

evacuate immediately. On Sunday, some residents were ordered to evacuate to western Gaza City, while the order on Monday included areas that people had fled to a day earlier and instructed them to evacuate to

shelters in Deir al Balah, Xinhua news agency reported. "The two directly affected areas encompass 13 health facilities that were recently functional, including two hospitals, two primary healthcare centres and nine medical points," OCHA

said, adding that 13 out of 36 hospitals in the Gaza Strip are only partially functional. The office said that with nine out of every 10 people estimated to

be displaced in Gaza, new waves of displacement are mainly affecting people who have already been displaced multiple times, only to find themselves forced to flee again under shelling. They were forced to reset their lives repeatedly without any of their belongings or any prospect of finding safety or reliable access to essential services.

"People, especially children, spend long hours queueing to collect water each day," OCHA said.

"Access to emergency health care is also a challenge, particularly given limited communications coverage to contact emergency services. high transportation costs to reach hospitals (\$26 roundtrip) and the long walking distance of at least 3 km to reach the nearest medical point."

In northern Gaza, the aid partners especially highlighted the lack of safe shelters for up to 80,000 IDPs (Internally Displaced Persons) who were forced to hastily flee from Shuja'iyeh and other parts of eastern Gaza City following evacuation orders in late June. Many were found sleeping amid solid waste and rubble, with no mattresses or enough clothing, and some had sought shelter in partially destroyed UN facilities and residential buildings.

The Israeli military designated these same areas as evacuation zones, forcing many of the same families, including young children and the elderly, to go through successive waves of displacement over the past two weeks, the office said.

OCHA said that insecurity, damaged roads, the breakdown of law and order, and access limitations continue to hamper movement along the main humanitarian cargo route between Kerem Shalom crossing and Khan Younis

and Deir al Balah

"This has resulted in critical shortages of fuel and aid commodities to sustain humanitarian operations, in addition to increasing the risk of spoilage and infestation of stranded supplies (especially food) due to extremely high temperatures," the office added.

The humanitarians said the Food Security Sector (FSS) reports that the shortages forced partners to provide reduced food rations in central and southern Gaza in June and undermined their ability to keep bakeries and community kitchens running.

According to OCHA, only seven out of the 18 bakeries supported by humanitarian partners remain operational in Gaza, all in Deir al Balah, and six bakeries already working at partial capacity have now been forced to completely cease operations due to the lack of fuel.

The office said that in the absence of cooking gas and a stable flow of food supplies, community kitchens are also struggling to operate, resulting in a reduced number of cooked meals prepared throughout Gaza.As of the end of June, about 600,000 cooked meals prepared in 190 kitchens were distributed daily to families across the strip, compared to more than 700,000 in the first half of June.

OCHA said it meant that displaced households rely on burning wood and plastic from furniture and waste to cook, exacerbating health risks and environmental hazards.

How Bangladesh's traffickers are targeting Rohingya women at refugee camp

DHAKA: A rising number of Rohingya women in Bangladesh are being targeted by human traffickers who offer them an escape from deteriorating conditions in the world's largest refugee camp.

Nearly 1 million Rohingya people are living in squalid conditions in Bangladesh's Cox's Bazar, which Amnesty International described as 'inhumane" last year. Refugees are not allowed to leave the fenced area and are trapped inside with limited food, water and electricity.

Thousands have been trying to flee the overcrowded Bangladeshi camp in recent years, hoping to seek a better life elsewhere, often with the help of human trafficking networks

"Human trafficking is undoubtedly a problem here. From the government's side, we are trying to combat this," Mohammed Mizanur Rahman, Bangladesh's refugee relief and repatriation commissioner, told Arab News on Tuesday.

"Women and children are being trafficked in many cases, and this is derived from absolute frustration and penniless situations." Some 569 Rohingya — out of

almost 4,500 — died or went missing in 2023 while trying to relocate to another country through deadly sea crossings, often on rickety boats, the highest figure in nine years, according to data from the JN Refugee Agency. Many are taken to Malaysia and

Indonesia, with Jakarta blaming human traffickers for the increasing number of Rohingya entering the country by boat late last year.

Rahman said that many women take the perilous sea journeys "with the aim of getting married to a Rohingya man" who may have relocated to a country in Southeast Asia.

He said: "Most of the Rohingya living in Malaysia are male. They get married to Rohingya girls living in the camps through (contact by) mobile phones. Later, the male sends money to bring the wife to Malaysia."

In such cases, the Rohingya involved would "make contact with the human traffickers" to circumvent their lack of legal documents to travel.

Rahman added: "In this process, sometimes they become successful, and sometimes they end up in abusive situations. Sometimes they die by drowning at sea."

The predominantly Muslim Rohingya people — referred to by the UN as the "world's most persecuted minority" - have faced decades of persecution in Myanmar.

More than 730,000 Rohingva fled to neighboring Bangladesh in 2017 after a brutal crackdown by the Myanmar military, which the UN said amounted to genocide.

The Rohingya in Bangladesh have faced restrictions on movement and work in the years since. forcing them into being idle amid growing uncertainties over their future, dwindling international aid and languishing attempts for a dignified repatriation. Dhaka-based migration expert Asif Munir told Arab News: "There's no permanent solution in sight in the camp-life situation; this has created frustration among the camp population.

Dengue Can Seriously Affect The Brain, Nervous System, Say Doctors

New Delhi: Although dengue is known to cause mild flu-like symptoms, the mosquito-borne viral illness has profound neurological implications that are often overlooked, said experts today.

Amid the monsoon in India, dengue cases have spiralled in various parts of the country, including Karnataka, Kerala, Telangana, Andhra Pradesh, Odisha, Delhi and Maharashtra.

According to the latest data from the Municipal Corporation of Delhi (MCD) there have been

Patients with severe dengue may experience headaches, altered mental status, seizures, and even coma. The virus's neurotropic nature means it can directly infect neural cells, causing damage and inflammation. Furthermore, the immune response triggered by the infection can exacerbate these neurological issues, making management complex.

Dengue is a vector-borne disease transmitted by the bite of an infected Aedes mosquito. It is endemic to more than 100 countries and affects about 400 million people globally every year.

Causing Gaza Children Deaths: UN Experts

Israel's "Targeted Starvation Campaign"

Gaza: UN rights experts on Tuesday accused Israel of carrying out a "targeted starvation campaign" that has resulted in the deaths of children in Gaza.

'We declare that Israel's intentional and targeted starvation campaign against the Palestinian people is a form of genocidal violence and has resulted in famine across all of Gaza," 10 independent United Nations experts said in a statement. The UN has not officially de-

clared a famine in the Gaza Strip. But the experts, including the UN special rapporteur on the right to food Michael Fakhri, insisted there was no denving famine was under way. "Thirty-four Palestinians have died from malnutrition since 7 October, the majority being children," said the experts, who are appointed by the UN Human Rights Council, but who do not speak on behalf of the United Nations.

Their statement was immediately slammed by Israel's mission to the UN in Geneva, which charged that "Mr. Fakhri, and many socalled 'experts' who joined his statement, are as much accustomed to spreading misinformation, as they are to supporting Hamas propaganda and shielding the terrorist organisation from scrutiny".

The UN experts meanwhile listed three children who had recently died "from malnutrition", after a number of others were said to have starved to death in northern Gaza earlier this year.

"Fayez Ataya, who was barely six months old, died on 30 May 2024, and 13-year-old Abdulqader Al-Serhi died on June 1, 2024 at the Al-Aqsa Hospital in Deir Al-Balah," they said.

Nine-year-old Ahmad Abu Reida died just two days later "in the tent sheltering his displaced family in Al-Mawasi, Khan Younis", they said.

"With the death of these children from starvation despite medical treatment in central Gaza, there is no doubt that famine has spread from northern Gaza into central and southern Gaza," they said.

"While primarily known for causing flu-like symptoms, dengue has profound neurological implications that are often overlooked," Dr Praveen Gupta, Principal Director & Chief of Neurology at Fortis Hospital Gurugram. told news agency IANS.

"Neurological manifestations of dengue, though less common, include encephalitis, meningitis, and myelitis. These conditions arise from the virus crossing the blood-brain barrier, leading to inflammation and infection of the brain and spinal cord," he explained.

Dengue fever escalates significantly during the monsoon season due to increased mosquito breeding. During monsoon, stagnant water and higher humidity create ideal conditions for the Aedes mosquito to thrive, leading to a spike in dengue cases.

"Dengue can affect many parts of the human body, including the nervous system. When it affects the nervous system, the presentation will be like a brain fever. Patients could have altered consciousness levels and difficulty in talking, stroke, seizures or fits and could have bleeding in the brain also due to low platelet counts," Dr Srikantha Swamy, Lead Senior Consultant, Neurology, Aster RV Hospital Bengaluru, told news agency IANS.

SRINAGAR: The 52-day Amarnath Yatra has seen a daily increase in the number of pilgrims, with more than 20,000 performing the pilgrimage since it began on June 29 from the twin tracks of Baltal-Sonamarg and Nunwan-Pahalgam.

Officials said the pilgrims who reached the twin base camps of Baltal and Nunwan on Monday left for the holy cave early Tuesday morning, while the yatris who departed from Bhagwati Nagar Yatri Niwas this morning reached their respective base camps by the evening and will leave for the holy cave early Wednesday morning.

Extensive security arrangements have been made this year along the nearly 300 km Jammu-Srinagar highway. at the twin yatra routes, the two base camps, and the cave shrine to ensure a smooth and incident-free yatra.

Over 124 langars (community kitchens) have been set up along both routes, at the transit camps, and at the cave shrine. Over 7,000 sevadars (volunteers) are serving the yatris during this year's Yatra. Helicopter services are also available for

Power Pilferage Dipped In

SRINAGAR: In Kashmir valley, thousands of domestic consumers haven't paid their electricity dues for more than two years, officials said on Tuesday.

Top official of the Power Development Department (PDD) said that domestic or residential consumers in the Kashmir region were the major defaulters.

The official said, "Primarily, domestic or residential consumers are the major defaulters. Out of 11.7 Lakh consumers we have 9.9 are domestic consumers. Out of these consumers, nearly 40 percent are smart and conventional metered consumers. Rest almost 60 percent of consumers are flat rated consumers."

"From the domestic consumers section, we call those defaulters who don't pay electricity bills for three consecutive months and their bill exceeds Rs 12000," he said.

The official further said, "KPDCL disconnect their smart meter connection. For flat rated consumers. we also disconnect them by other ways in accordance to our Standard Operating Procedure (SOP)." "By and large, nearly 91 percent of our consumer base is domestic.

Kathua Ambush: Politicians React With Anguish, Concern

SRINAGAR: President Droupadi Murmu on Tuesday termed the terrorist attack on an Army convoy in Jammu and Kashmir a "cowardly act" and said it deserved condemnation and firm counter-measures.

Five Army personnel were killed and as many injured on Monday when a group of heavily-armed terrorists ambushed a patrolling party in the Badnota area in Kathua district of Jammu and Kashmir.

This terror attack was the fifth in the Jammu region in a month.

In a post on X, Murmu said, "My sympathies are with the families of the bravehearts who laid down their lives in this ongoing war against terror in its all forms. I pray for the speedy recovery of those injured."

"The attack on a convoy of Army personnel in Kathua district of Jammu and Kashmir by terrorists is a cowardly act that deserves condemnation and firm counter-measures. My sympathies are with the families of the bravehearts who laid down their lives in this ongoing war against terror in its all forms. I pray for the speedy recovery of those injured," the



President said.

Defence Minister Rajnath Singh on Tuesday said he was "deeply anguished" over the death of five Army personnel in a terrorist attack in Jammu and Kashmir's Kathua district.

Singh said counter-terror operations are underway and the soldiers are determined to "usher in peace and order" in the region.

"I am deeply anguished at the loss of five of our brave Indian Army soldiers in a terrorist attack in Badnota, Kathua (J&K)," the defence minister said on X.

"My deepest condolences to the bereaved families, the nation stands firm with them in this difficult time. The counter

to those who sustained injuries in this dastardly terror attack," Singh added. The killing of five army sol-

diers in a militant attack in Jammu and Kashmir's Kathua district is alarming, National Conference leader Omar Abdullah said on Tuesday while accusing the union territory's administration of being lax towards the security situation.

The attack took place on Monday when a group of heavily-armed terrorists ambushed a patrolling party in Badnota area in Kathua. A massive search operation is underway to nab the terrorists behind the ambush in which five people were also injured.

"It is very unfortunate. I think no criticism of this attack is strong enough. To lose five brave army soldiers in the line of duty in one attack is something we should all be alarmed by," Abdullah told PTI Videos.

The NC vice president and former chief minister of the erstwhile state of J&K said the administration needs to be more

"We have been saying time and again that militancy is a problem in J&K and you can't wish it away. This government had convinced itself that somehow August 5, 2019 is the solution to all the problems, including violence and terror, but clearly that's not the case," he said referring to the day Article 370 was abrogated and the state downgraded into the union territories of Jammu and Kashmir, and Ladakh.

"I think the administration in I&K needs to be more vigilant, I think they are showing rather lax tendency with regard to the security situation and hopefully attacks like this won't happen again," Abdullah added.

Terror Incidents Show Govt's 'Strategic Failure': Congress

NEW DELHI: The Congress said on Tuesday that Jammu "becoming the centre of terror incidents" reflected the "strategic failure" of the Modi government and demanded that the Centre should take the country into confidence on steps it was taking to deal with the situation.

The opposition party also called for a befitting reply to Pakistan in the wake of the rising terror incidents in Jammu and Kashmir.

The Congress' assertion came a day after five army personnel, including a Junior Commissioned Officer, were killed and as many were injured when heavily armed terrorists ambushed a patrolling party in the remote Machedi area of J&K's Kathua district.

Addressing a press conference at the AICC headquarters here, Congress leader Deepender Hooda said this attack is highly condemnable.

He said the government should suo motu give a statement on the steps it is taking in the wake of the

recent terror attacks in the state. "Even before this, in December 2023, four of our soldiers were martyred in Rajouri. There was an encounter in Kulgam, in which two of our soldiers were martyred.

"There was a terrorist attack in Doda on June 26. On June 9 also, a terrorist attack was carried out on a bus," Hooda said, listing the recent terror attacks in J&K.

Leader of Opposition in Lok Sabha Rahul Gandhi has asserted that the solution to the persistent terror attacks should be strict action, not empty promises, Hooda said.

"Figures show that the number of civilians and security forces personnel martyred in terrorist incidents in the Jammu region has doubled since January 2023," he said.

The centre of terrorist incidents has now shifted from the Kashmir valley to Jammu and this "reflects the strategic failure" of the Modi government, he said.

The Modi government is not serious about the ground situation in Jammu and Kashmir and instead is

more busy presenting its narrative to the country, he alleged.

"Whenever the Modi government introduces any scheme, it links it to terrorism and says that terrorism will be eradicated. When demonetisation took place in the country and the Article 370 was removed from Jammu and Kashmir, even then there was talk of elimination of terrorism. But now the government should think about the situation that has arisen." he said.

Pakistan has reached the brink of becoming a "failed state" and yet it is daring to do this, Hooda said, adding that now it is the time to give a befitting reply to Pakistan.

"As a responsible opposition, we are with the government for the security of the country," he said.

The Congress on Monday condemned the terror attack on Army personnel in Kathua and said no amount of whitewashing, fake claims, hollow boasts and chest-thumping can "erase the fact that the Modi government remains a disaster" for security in the Union Territory.

Assembly Poll Promise

n a fresh indication that the Assembly election in Jammu and Kashmir could be around the corner, BJP chief and Union Minister JP Nadda on Saturday stressed the importance of preparing for the exercise. Addressing an extended working committee meeting of the party's J&K unit at Purkhoo in Jammu, Nadda highlighted the development work undertaken in the region since Prime Minister Narendra Modi came to power.

The BJP's extended working committee adopted a resolution expressing confidence that the party will form the government in the union territory on its own, based on the Lok Sabha election results. The resolution mentioned the party's lead in 29 out of 36 Assembly segments in the Jammu division, indicating a promising outlook for the upcoming elections.

The focus now shifts to ensuring that the Assembly elections are conducted as directed by the Supreme Court, highlighting the importance of adhering to the September deadline to uphold democratic processes in the region.

The Supreme Court has already directed the central government to hold the Legislative Assembly elections by September 30. The completion of delimitation and voter list revisions has set the stage for these elections, with the number of Assembly seats increased from 107 to 114, including 24 for Pakistan-occupied Kashmir. The Jammu and Kashmir Legislative Assembly will now have 90 seats, with the new Vaishno Devi and Katra constituencies in Reasi district among them.

Of these 90 seats, 43 are in the Jammu region and 47 in the Kashmir Valley. Nine seats gave been reserved for Scheduled Castes and seven for Scheduled Tribes, ensuring representation for marginalized communities.

The people of Jammu and Kashmir are also hopeful that the new government will soon restore statehood, as promised by prime minister Narendra Modi during his recent visit to Kashmir. It was on June 19, 2018, that the BJP withdrew support to the J&K coalition government headed by the then Chief Minister Mehbooba Mufti, paving the way for Governor's rule in the then state. Later, former J&K Governor, Satya Pal Malik, dissolved the assembly in November. This was followed by the abrogation of Jammu and Kashmir's special status on August 5, 2019, and the downgrading of the state into a union territory. The position of the Governor was reduced to that of Lieutenant Governor. Over five years have passed since then without assembly elections and any sign of restoration of statehood. Now, there are hopeful signs that these elections will finally be held. The reestablishment of a local government will be a critical step towards selfgovernance and political stability.

As many of us fast during Muharram, we should take this opportunity to make dua and renew our intentions for the year ahead. Muharram is a time of ends, change and new beginnings. We often are afraid of change and uncertainty but it is



important to remember that Allah (SWT) is the best of planners and we should embrace the future with faith in him.

Change itself can be difficult for us to face but it is a reminder that attachment itself can be a challenge for the heart, from matters related to relationships, to money to materials things or even plans we may have for our lives. We should learn to trust in Allahs plans.

What you can do?

1. Fasting expiates sins.

2. Charity: Giving sadaqa especially in the form of spending on the family.

3. History: Many talks and lectures around Muharram will focus on the history of Ashura, it also helps to provide context which in turn can bring you closer to Allah.

4. Acceptance: With change, acceptance is a large part of the journey. Spend time reflecting after Salah on changes that are taking place in your life or looking at concepts like Qadr and Tawaakul which help to understand that our life is in Allah's hands.

5. Reading the Quran: If you are unable to fast, reading a transliteration of the Quran or doing Dhikr in solitude or with a group can really help you to feel the months blessings, remember any gathering for the sake of Allah will also be filled with barakah and the Angels will join you.

Abu Hurairah and Abu Sa`id Al-Khudri (May Allah be pleased with them) reported: The Messenger of Allah (sallallaahu alayhi wa sallam) said:

"When a group of people assemble for the remembrance of Allah, the angels surround them (with their wings), (Allah's) mercy envelops them, Sakinah, or tranquillity descends upon them and Allah makes a mention of them before those who are near Him." [Muslim].

Domestic Air Passenger Traffic Momentum To Continue This Year: Report

MUMBAI -The momentum in air passenger traffic is expected to continue and airlines' net loss is projected to be Rs 3,000-4,000 crore in the year ending March 2025, both trends similar to the previous financial year, a report said on Tuesday.

In June, the domestic air passenger traffic was estimated at 132.8 lakh, around 3.7 per cent lower than seen in May but about 6.3 per cent higher compared to the year-ago period. Click here to connect with us on WhatsApp

Rating agency Icra said the outlook for the country's aviation industry is stable amid the continued recovery in domestic and international air passenger traffic, with a relatively stable cost environment and expectations of the trend continuing in FY2025.

"The momentum in air passenger traffic witnessed in FY2024 is expected to continue into FY2025, though further expansion in yields from the current levels may be limited," it noted.

According to its report, the pace of recovery in industry earnings is likely to be gradual owing to the high fixed-cost nature of the business and the net loss is expected to be Rs 3,000-4,000 crore this fiscal as seen in the previous financial vear.

While mentioning about supply chain issues, Icra said it is estimated that 24-26 per cent of the total fleet of Indian airlines in operations was grounded by March 31, 2024.

"Considering the bulk recall of the engines globally by P&W and other existing issues with the original equipment manufacturer's (OEM's) engines, the testing by P&W is likely to take longer, around 250-300 days.

"This will result in increased operating expenses towards the cost of grounding, increased lease rentals due to additional aircraft being taken on lease to offset the grounded capacity, rising lease rates and lower fuel efficiency (due to replacement by older aircraft taken on spot lease), which will adversely impact an airline's cost structure," the report said. However, healthy yields, high passenger load factor (PLF) and partial compensation available from engine Original Manufacturers

Equipment (OEMs) would help absorb the impact to an extent.

Mcap Of BSE-Listed Firms At Record High Of Rs 451.27 Lakh Cr

MFIN For Limiting Indebtedness Up To Rs 2 Lakh Per Borrower

KOLKATA- Micro-credit indebtedness per borrower should be limited to Rs two lakh, while the number of lenders to a debtor should also be restricted to a maximum of four, MFIN, a selfregulatory organisation of the industry, said on Tuesday. With nearly 80 per cent of

the micro-loans having a tenure of 18 months or more, a limit of Rs two lakh will effectively mean lesser repayment obligation for a borrower, Micro-finance Industry Network



(MFIN) said in a statement.

The industry body also said that assessing a borrower's household income and loan repayment obligations is an important part of underwriting. This ensures that a debtor is "not overstretched and is to honour loan repayments on time".

MFIN also urged credit information companies to improve the quality of data available for underwriting.

The indebtedness is the responsibility of microfinance lenders, said the industry body, adding that it has taken steps to facilitate responsible lending and promote a steady and calibrated sector growth. The microfinance sector serves borrowers below an annual income of Rs three lakh. Supported by conducive regulations, the sector now has a gross loan portfolio of Rs 4.33 lakh crore and covers nearly 7.8 crore borrowers, the industry body said.

Gold Falls By Rs 100 To Rs 73,310 Per 10 G: Silver Rises Rs 180

EW DELHI- Gold prices fell by Rs 100 to Rs 73,310 per 10 grams in the national capital on Tuesday amid weak global cues, according to HDFC Securities.

The precious metal had settled at Rs 73,410 per 10 grams on Monday. However, silver prices jumped by Rs 180 to Rs 94,450 per kg from Rs 94,270 per kg in the previous session.

"Gold prices traded lower ahead of the Fed member speech and US inflation data. The silver prices at domestic as well as global front traded higher tracking strong base metal and risk-on moods," Dilip Parmar, Research Analyst at HDFC Securities, said.

Silver prices are expected to outperform the yellow metal in the near future, Parmar added. On the overseas front, spot gold at Comex traded at USD 2,362 per ounce, down USD 11 per ounce against the previous close.

"With new government and political development in Iran, the US mentioned about some progress regarding the ceasefire talks on Monday weighing on the metal.

"Any update from Israel or elsewhere will be crucial for further volatility in prices," Manav Modi, Senior Analyst, Commodity Research at Motilal Oswal Financial Services Ltd (MOFSL), said.

Traders will also keep an eye on more cues on US interest rates from testimony by Federal Reserve Chair Jerome Powell and key inflation data due through the week, Modi added.

He said he had a special appreciation for "his friend" Putin for steering the India-Russia friendship to greater heights over the last two decades.

As prime minister, he said it was his sixth visit to Russia and the two leaders have met 17 times during this period.

"All these meetings have added to our mutual trust and respect," he said, praising Putin for helping the evacuation of Indian students during the war. He expressed gratitude to the Russian leader and Russian citizens for this.

To the applause from the audience, he announced that India will open two new consulates in Russia to boost travel and trade between the two countries.

Recalling the celebrated Hindi song 'Sar pe lal topi Rusi, phir bhi dil hai Hindustani' picturised on Raj Kapoor, he said it may be an old number but its sentiments remain evergreen.

Mithun also mentioned He Chakraborty, another Indian actor who earned a big following in Russia, as he spoke about the deep cultural ties between the two countries.

Modi said India was undergoing a transformation and the pace of development over the past 10 years has taken the world by surprise. Even the world now acknowledges what he used to say during his poll campaign that the 21st century belongs to India, he added. The fast pace of India's develop-

He said it was in his DNA to challenge all the challenges and India will write a new chapter of global growth in coming years.

Modi said it was exactly a month ago that he took oath as prime minister for the third consecutive term when he had made the resolve to work at thrice the strength and speed to fulfil the aspirations of the country

The Army's elite para-commandos and sniffer dogs joined the search operation while drones and helicopters were also pressed into service for surveillance, officials said.

Amid the telltale signs of the violence, were the two vehicles, parked about 300 metres away from each other. Given the state of the road, officials said they were probably not going at too much speed and came under fire while they were taking a turn.

Villagers also played a crucial role in the operation, joining rescue efforts to evacuate the casualties. There were anti-Pakistan protests in several areas as agitated villagers took to the streets to condemn the terror attack.

"A civil bus passed the road about 10 minutes before the attack. We heard a loud explosion and initially took it as a tyre burst but the subsequent heavy firing made us realise that an encounter has started," Puran Chand Sharma, a villager who runs a shop just a few metres from the scene, told PTI. The heavy firing continued till 5 pm

followed by intermittent firing for another one hour.

"About 12 villagers were at my shop. We hid ourselves inside to avoid getting caught in the crossfire. After the firing stopped, we rushed to help evacuate the casualties," he said.

Vijay Kumar, another local, said this is the first terror incident in the village since cross-border terrorism broke out in Jammu and Kashmir over three decades ago.

"We have not noticed any movement of terrorists in our area having over 100 families," he said. In his view, the terrorists might have reached in the bus that had passed by a short while before bullet fire rang out.

Kathua Senior Superintendent of Police Anayat Ali Choudhary, who reached the spot hours of the incident, is camping at Lawang-Machedi along with other officers to supervise the anti-terrorist operation.

"Efforts are on to track down and neutralise the terrorists. The joint search parties have fanned out from all sides and it is a matter of investigation how the terrorists reached the area," a police official said.

Director General of Police R R Swain is personally overseeing the anti-terrorist operation in the dense forest area, connected to Basantgarh in Udhampur district where several encounters have occurred in the past.

On April 28, a village defence guard was killed in an encounter with terrorists in Panara village of Basantgarh.

According to officials, this route could be used by terrorists to reach the hinterland after they managed to sneak in from across the border.

The Jammu region has been shaken by a series of recent ambushes and terror attacks, particularly in the border districts of Poonch, Rajouri, Doda, and Reasi

On June 9, for instance, terrorists attacked a bus carrying pilgrims from the Shiv Khori temple in Reasi district, claiming the lives of nine persons and niuring 41 others

Uttarakhand's Tehri district in a state of shock.

He was among the five soldiers from Uttarakhand killed in a terror attack on an Army convoy in Jammu and Kashmir's Kathua on Monday. It was the fifth terror attack in the Jammu region within a month.

In Pauri, Rifleman Anuj Negi's mother and wife fell unconscious upon receiving the news of his death. The scene was similar at Havildar Kamal Singh's home who has left behind his mother, wife and two daughters aged eight and four years.

The 32-year-old Singh, who had just completed 10 years in service, had come home in Papadi Naudanu village two-and-a-half months ago to get his youngest daughter admitted to school, a local told PTL

His father Kesar Singh died a few years ago.

Adarsh Negi (25), a farmer's son, was the youngest of the three siblings. He had left his college studies midway to fulfil his dream of serving the country by being in the army.

Dalbir Singh Negi said his son studied up to class 12 at Government Inter College in Piplidhar and then joined Garhwal University to do BSc. He left his studies to join the Garhwal Rifles, he said.

"I spoke to him last on July 7 over the phone. He had come home in February and returned on March 26 to join duty," Dalbir Singh Negi said, fighting back his tears.

In Pauri's Dobariya village, friends and relatives flocked to Anuj Negi's home to console his mother and wife, but in vain.

The only son of his parents, Anuj Negi (26) got married in December last year. He rejoined duty four months after tying the knot, said Subhash Chandra Jakhmola, the gram pradhan of the nearby Jamri village.

After doing his intermediate, Anuj Negi joined the Garhwal Rifles about five years ago and his mother had distributed sweets in the village, Jakhmola said.

Uttarakhand Assembly Speaker and Kotdwar MLA Ritu Khanduri expressed grief over the death of the soldiers and said the country stands with their families.

Khanduri said she is the daughter of an army man and can the pain of the bereaved families. "The armed forces will give a fitting reply to the terror attack," she said.

Chief Minister Pushkar Singh Dhami, Cabinet ministers Premchand Aggarwal and Ganesh Joshi placed a wreath on the coffins of the five martyrs as their mortal remains were brought to the Jolly Grant airport here.

"Five brave soldiers of Uttarakhand martyrdom during the attained cowardly terrorist attack in Kathua, lammu and Kashmir. This is a moment of great pain for all of us," Chief Minister Pushkar Singh Dhami said in a statement.

"Our bravehearts made the supreme sacrifice for their motherland in keepng with the rich military tradition of Uttarakhand," he said, adding their "sacrifice will not go in vain. Terrorists, who are the enemies of humanity and guilty of this cowardly attack, will not be spared at any cost, he said, adding the people who sheltered them will also have to face the consequences. He said the entire state stands with their families in this hour of grief.

A massive search operation was underway on Tuesday to track down the terrorists behind the deadly attack on an Army patrol party in Jammu and Kashmir's Kathua district, as Director General of Police R R Swain flew to the area to oversee the operation on the ground.

The bodies of the five soldiers killed in the attack have been handed over to the Army after postmortem and were airlifted to their homes for last rites. officials said.

Accompanied by ADGP Anand Jain, DGP Swain conducted an aerial survey of the area and reviewed the ongoing operations, they said.

The scope of the search operation has been expanded to encompass large areas in the adjoining districts of Udhampur and Kathua, including Basantgarh, Seoj (a high-altitude area in Udhampur), and the upper reaches of Bani, Daggar, and Kindli in Kathua district.

Special forces of the Indian Army's 'Para' unit have been deployed to conduct surgical operations against the terrorists in specific areas, the officials said.

Ground search teams are being supported by helicopter and UAV surveillance. Additionally, sniffer dogs and metal detectors are being utilized, with a particular focus on dense forest areas in the region.

The officials said that a joint cordon and search operation, involving the Army, police and CRPF, was launched in Machedi, Badnote, Kindli, and Lohai Malhar areas, with a significant area placed under cordon.

The bodies of the five soldiers were airlifted following postmortem examinations conducted at the Sub District Hospital in Billawar, Jammu and Kashmir

Additional Deputy Commissioner of Billawar, Vinay Khosla said that the bodies were handed over to the Army and subsequently airlifted.

He further said that out of eight injured soldiers brought to the Billawar hospital, six were shifted to the Pathankot military hospital by the Army.

The officials indicated that currently three to four groups of terrorists, mostly foreign militants, are active in the region, adding they have observed an increase in the presence of foreign militants in the Kathua-Udhampur-Doda belt and the Poonch-Rajouri-Reasi belt in recent times.

Five Army personnel, including a junior commissioned officer, were killed, and an equal number were injured in the ambush by heavily armed terrorists in the remote Machedi area on Monday.

According to sources, three to four terrorists, mostly foreigners, are believed to have executed the ambush. They appear to be linked to the same group which was involved in Basangarh attack in which village defence guard Mohd Sharief was killed in an encoun-

The law officer said the powers of three commissions out of the seven are being exercised by the central panels and the rest are functional in the union territory.

He also referred to the affidavit of the law, justice and parliamentary affairs department of Jammu and Kashmir in support of his submissions.

"We will close the case," the bench then said.

"It has been submitted that with the passing of the Jammu and Kashmir Reorganisation Bill, now the laws applicable to UTs are made applicable to the union territory of Jammu and Kashmir...moreover, the central government is vested with the power to direct that the central commissions to function as state commissions," the bench said.

It disposed of the PIL, saying that in view of the present position, the plea has become infructuous and no further directions are required to be issued.

In August 2019, the Centre bifurcated Jammu and Kashmir into two Union territories and abrogated the provisions of Article 370 of the Constitution which accorded special status to the erstwhile state.

Blood On Mountains

personnel dead and as many injured, officials said on Tuesday.

A team of National Investigation Agency (NIA) officials has been sent to Kathua in Jammu region to extend all possible support to the police in its investigation, they said and made it clear that the probe agency has not registered a case to investigate the terrorist attack.

Five Army personnel, including a junior commissioned officer, were killed, and as many were injured when a group of heavily armed terrorists ambushed a patrolling party on the rugged Machedi-Kindli-Malhar mountainous road near the Badnota village in Lohai ter with terrorists on April 28 in Panara village.

The attack mirrored a similar pattern to the Bhimbher Gali-Mendhar terror incident involving an Army truck on April 21, 2023, where five soldiers lost their lives. The terrorists initiated firing on the vehicle's wheels, followed by bursts of gunfire targeting its front and left sides.

The sources said that the condition of the road and the slow speed of the truck in the area likely facilitated the attack.

Investigations into the weaponry and ammunition used in the attack are currently ongoing.

In June, security forces had observed movement of a group in the upper reaches of Bani, Daggar, and Kindli areas of Kathua district, leading to subsequent search operations.

The scope of the search operation has been expanded to encompass large areas in the adjoining districts of Udhampur and Kathua, including Basantgarh, Seoj (a high-altitude area in Udhampur), and the upper reaches of Bani, Daggar, and Kindli in Kathua district.

SC Closes PIL

Novak Djokovic Gets Into It With Wimbledon Fans After Reaching Quarterfinals

LONDON: Maybe the Centre Court spectators were saluting Novak Djokovic's opponent by saying his name. Maybe they were booing Djokovic, trying to rattle him. The 24-time Grand Slam champion was sure it was the latter – and he let everyone know he was not happy about it.

Djokovic easily beat 15thseeded Holger Rune 6-3, 6-4, 6-2 in just over two hours Monday night to reach the Wimbledon guarterfinals, then made sure to get a message across to those fans he thought were against him.

Rune's supporters at various tournaments often will stretch out his last name, saying, "Ruuuuuune!" – which sounds rather similar to "Boooooo!" and that happened again Monday.

During his on-court postmatch interview, Djokovic spoke briefly about the match, but then veered into a discussion about the people in the stands

"To all the fans that have respect and that stayed here to-



night: Thank you very much from the bottom of my heart. I appreciate it. And to all those people that have chosen to disrespect the

player - in this case, me - have a goooood night. Gooooood night. Gooooood night. Very gooooood night," he said, stretching out the

"Os" in "good" so they sounded like "boo The interviewer tried to dis-

suade Djokovic from thinking

anyone was trying to taunt him. 'They were. They were. They were. I don't accept it. I know they were cheering for Rune.

But that's an excuse to also boo," Djokovic said.

'Listen, I've been on the tour for more than 20 years. So trust me, I know all the tricks. I know how it works. It's fine. It's fine. It's OK. I focus on the respectful people, that have respect, that paid (for) a ticket to watch tonight – and love tennis. And love tennis. And appreciate the players and the effort that the players put in here."

At his news conference later, Djokovic was asked whether he thinks the All England Club should do something to curb rowdy fan behaviour.

"Look, I don't know what Wimbledon can really do about it. I mean, in those particular moments when it happens, the crowd paid their tickets. They have the right to be there and cheer the way they want to cheer. That's absolutely something they choose - how they behave or how they choose to support the player is really up to them," Djokovic responded.

"Yes, you could argue maybe a chair umpire or whoever can step in in certain moments and calm them down, but there's not much you can do. You're not going to take out the whole section of the crowd or stadium because they're misbehaving or showing disrespect."

Rune – who got off to a terrible start in the match, dropping the first 12 points - didn't make much of it all.

"If you don't know what was happening, probably it sounded like boo,'" he said.

"He was just better than me today," Rune said. "Whether the crowd was this or that, I think it was great support for both players, to be honest."

When the match ended. Djokovic gestured as if he were playing a violin, maybe mockingly indicating he felt bad for anyone in the arena that he had saddened by winning and getting to the quarterfinals at the All England Club for the 15th time.

He has won the championship at Wimbledon seven times and was the runner-up to Carlos Alcaraz last year.

"I played in much more hostile environments, trust me," Djokovic said. "You guys can't touch me." (AP)
