10TH MUHARRAM PROCESSION

Final Call At Right Time: Div Com

Srinagar: Government has been monitoring the situation and that a final call vis-à-vis Ashura (10th Muharram) procession in Srinagar would be taken at the appropriate time, Vijay Kumar Bidhuri, Divisional Commissioner (Div Com) Kashmir, said on Monday.

The Div Com praised the Shia Muslims for their cooperation in ensuring the eighth Muharram procession in Srinagar proceeded smoothly. He said that the government could not have approved the event without the establishment of peace in Kashmir.

Elaborate arrangements, according to the Div Com, were put in place by the administration on the 8th Muharram in Srinagar, in accordance with the directions of the Lieutenant Governor, Manoj Sinha to provide every single facility to the mourners on the occasion.

"Since the peace is evident on the ground in Kashmir, the fact that the 8th Muharram procession in Srinagar transpired peace-fully is something we are happy about and all this happened due to support of the people," the Div Com told the media.

The government is currently monitoring the situation and would make a final decision at the appropriate time, the Div Com said in response to a question on whether the administration will allow the 10th Muharram procession in Srinagar in the same manner as it permitted the 8th Muharram.

Commemorating Battle Of Karbala

Thousands Join 8th Muharram Procession In Srinagar

Srinagar: The Jammu and Kashmir administration permitted the 8th Muharram procession on its traditional route in Srinagar on Monday for the second year in a row, prompting tens of thousands of mourners to commemorate the martyrdom anniversary of Imam Hussain (A.S) in the battle of Karbala.

Large number of Shia mourners assembled in the Guru Bazar locality of the city at the crack of dawn since the district administration had

granted the procession a short window of time to avoid disruptions to the daily routines in the summer capital.

The procession commenced from Guru Bazar at around 6 AM and made its way to Hussaini Hall Dalgate via Shaheed Gunj, Budshah Chowk and Maulana Azad Road with brief pauses.

Elaborate security arrangements were put in place in Srinagar with additional deployment of police and paramilitary forces on roads to ensure the day passes off peacefully.

Officials told Kashmir Observer that the situation

remained peaceful with no untoward incident reported from anywhere in the summer capital.

Notably, two major processions including 8th and 10th Muharram were banned in 1989 following the onset of militancy in Kashmir. Since then, only small mourning rallies and processions were allowed in a few pockets of Srinagar.

An important step forward was the UT administration's approval of the 8th Muharram procession for a second year running. It has been generally appreciated that major Muharram | More on P6

Largest Pro-Gaza Demo In South Asia

Srinagar: In a first for Kashmir's Muharram history, the traditional 8th procession Muharram which commences from Guru Bazar and culminates at Dalgate in Srinagar took an unexpected turn this year, transforming into a massive pro-Palestine rally.

Tens of thousands of mourners who rallied in the city centre carried and waved Palestinian flags alongside the usual Alam Sharief and chanted slogans in support of the oppressed of the world and in denunciation of their tormentors. Mourners said that they

carried the flags 'out of a natural will' to show solidarity with the op-pressed, particularly the people of Gaza.

Authorities, who lifted the ban on 8th Muharram procession after 35 years last year, had this year directed organisers to conclude the procession within a two hours time period starting at 6 in the morning from Guru Bazar and conclude at Dalgate by 8 AM.

Procession did commence at 6 but concluded only in the late afternoon as the entire five kilometre stretch was clogged with people.

Amarnath Yatra Crosses 3 Lakh Mark

Jammu: Over 3 lakh pilgrims have paid obeisance at the Amarnath cave shrine in the south Kashmir Himalayas in the first 16 days of the yatra, surpassing the corresponding period last year, officials said on Monday.

An official said that 14,974 pil-grims visited the shrine for a 'darshan' of the naturally formed ice Shivlingam on Sunday. With this, the total number of pilgrims who have visited the shrine so far this year has climbed to 3,09,977.

Among the 14,974 pilgrims who performed darshan on Sunday were 9,785 males, 3,435 females, 145 children, 230 Sadhus, one Sadhvi, and 1,378 security forces and service providers, he said.

A fresh batch of 4,875 pilgrims left from Bhagawati Nagar Yatri Niwas in Jammu towards the twin base camps of Nunwan Pahalgam in Anantnag district and Baltal Sonamarg in Central Kashmir's Ganderbal district under tight security arrangements in a cavalcade of 162 light and heavy vehicles. The batch included 3,464 men, 1,333 women, 14 children, 57 Sadhus, and 7 Sadhvis.

"Of these, 1,918 pilgrims left for the Baltal base camp at 3:05 AM and 2,957 for the Pahalgam base camp at 3:50 am, from where they will proceed on their further journey to the holy cave," the official said, adding that all these pilgrims reached their respective base camps by this evening, wherefrom they will proceed towards the holy cave early tomorrow morning for darshan. 'Marriage Dead For Years'

Omar's Wife Gets SC Notice Over Divorce Plea

New Delhi: The Supreme Court on Monday sought a response from Payal Abdullah, the estranged wife of Omar Abdullah, on a plea filed by the National Conference leader seeking divorce on grounds of cruelty.

A bench of Justice Sudha Dhulia and Justice Ahsanuddin Amanullah issued a notice to Payal Abdullah and sought her response within six weeks.

At the outset, senior advocate Kapil Sibal, appearing for Omar Abdullah, submitted that the marriage was "dead" as they have been living separately for the past 15 years.

The Delhi High Court on December 12, 2023, dismissed Omar Abdullah's plea seeking divorce, saying there was no merit in his appeal.

The high court had upheld the



2016 family court order refusing to grant a decree of divorce to Omar Abdullah, a former chief minister of the erstwhile state of Jammu and Kashmir.

"We find no infirmity in the view taken by the family court that the allegations of cruelty were vague and unacceptable, that the appellant failed to prove any act which could be termed as an act of cruelty, be it physical or mental, towards him," the high | More on P6

J&K Govt Offers Wild Animals For Adoption

Jammu: Jammu and Kashmir wildlife protection department has initiated a scheme offering animals of endangered species up for adoption at Jambu Zoo in Jammu's Jagti.

Hindustan Times reported the additional director of Jambu Zoo, Anil Atri saying that the way to show your support and care for wild animals. "The practice is in vogue in zoos abroad where they offer wild animals up for adoption to ensure participation of the community in their conservation." he said.

"Since the zoo recently completed a year, we have been mulling to come up with something like this. Jammu has several animal lovers and NGOs who want to contribute their bit but they don't get a suitable platform. Therefore, we decided to offer wild animals at the

zoo up for adoption."

He pointed out the perils of people feeding monkeys and stray animals in the open causing nuisance and social conflicts.

"The government has notified the rates for their adoption. There are 150 animals in the zoo of which 18 species like lion, tiger, leopard, snakes, crocodiles, Himalayan black bear, porcupines and can be adopted," said Atri.

"Besides conservation, we want to bring a sense of belongingness and awareness among the people. Whoever adopts the animal, a plaque containing their particulars and photographs and of the animal as well will be put up outside the enclosure. It will give a sense of satisfaction and serving the animals as well," said Atri.

The department has fixed minimal feed charges to adopt animals at the zoo.

'HOOKING, METER TAMPERING'

Smart Meter Consumers To Face Remote Disconnection: KPDCL

Srinagar: Kashmir Power Distribution Corporation Limited (KPDCL) Monday advised its smart-metered consumers to shun the practice of unauthorized use of electricity by hooking which attracts punitive clauses under the Electricity Act.

During inspection drives, KPDCL has booked a large number of consumers in urban and semi-urban areas of Kashmir Division for bypassing meters and laying unbridled hooks with the sole intention of stealing power.

In a press statement issued, a KPDCL spokesperson stated that reports of hooking have been received from all city Subdivisions



and a few district headquarters where smart meters have been installed. "KPDCL is taking swift action against hooking which begins with remote disconnection of the consumer's electricity supply, followed by recovery of energy consumed illegally," he said, while outlining steps taken by KPDCL for combating power theft.

Some of the smart-metered areas badly affected by hooking include Mominabad, Batmaloo, Tengpora & Alocha Bagh in ESD Huzuribagh, Mini Housing Colony and Rose Enclave in ESD Chanapora, Bemina in ESD Watalkadal, KP Bagh in ESD Sheikh Bagh, Buchwara in ESD Dalgate, Nadroo and Old Baghat in ESD Baghat, the spokesman

said, adding that illegal hooking by consumers has also been reported from KK Moulla, Pather Masjid, Habba Kadal, Rainawari, Khanyar, Hawal, Zakura, Nishat, Anantnag, Baramulla I Sopore I & II Subdivisions.

KPDCL, which has mapped all consumers found involved in hooking, shall also present challan in the Designated Courts under the Electricity Act for imposition of hefty fine on consumers habitual of meter tampering and hooking on bare conductor. "FIRs have also been registered against 35 consumers for tampering and bypassing of smart meters," he added.

"In order to send a concrete proposal to the Ministry of Education (MoE) and to invite the private players to establish the universities, we are holding discussions regularly with all concerned stakeholders and we are seeking

He further said that the policy will be sent to various concerned departments for suggestions and discussions, including Finance, Law, Revenue, Industry, and Planning.

The policy draft, as per official sources, will address crucial issues such as land allotment and obtaining necessary permissions for setting up universities. Once finalized. the draft will be presented for approval at the Administrative Council meeting.



Peaceful Muharram

n a welcome move, the J&K administration under Lieutenant Governor Manoj Sinha once again allowed Muharram processions. The decision is part of a broader outreach to Muslim community by the administration. The authorities ensured extensive arrangements for the procession, including deploying police officers from midnight to ensure security and maintain order.

This year's procession follows the peaceful Muharram of the previous year, when LG Sinha participated in Zuljanah. Wearing a black dress, the LG visited the most volatile part of the city in Srinagar's Bota Kadal area, and offered chaddar to Zuljanah, a procession carried out to recall the martyrdom of the grandson of Prophet Muhammad (SAW), Imam Hussain, during the Battle of Karbala in 680 AD. Sinha was also seen distributing refreshments to the gathering.

In the Valley, Muharram processions are a longstanding tradition. Thousands of mourners gather to participate in these processions, expressing their grief and solidarity for Imam Hussain's sacrifice. The eighth day of Muharram sees one of the most significant processions in Srinagar, commencing at Guru Bazaar and concluding in the Dalgate area. This year, the event witnessed a large turnout of mourners chanting pro-Islam slogans and praising the ultimate sacrifice of Imam Hussain.

Until 2022, Muharram gatherings used to be banned in the Valley since the advent of militancy in 1989. Authorities maintained that the religious gatherings were used for propagating separatist politics and triggering violence. In Srinagar, the vulnerable areas such as Abi Gugar, Lal Chowk, Regal Chowk, Aali Masjid, Shaheed Gunj, Guru Bazaar and Hawal were usually placed under tight security restrictions to foil large gatherings of people. Government justified the extreme measures citing the possibility of violence in the city. This was a stock government explanation for prohibiting the Muharram religious processions over the past three decades. No longer.

In recent years, the situation has changed for the better, although the union territory has yet to experience true peace. And that will require the government to take more steps including political measures to address the underlying sources of discontent. On a positive note, we are already expecting Assembly elections later this year which will give people a stake in the governance of the region. A peaceful Muharram procession is an indication that the Valley is not just normal for holding an electoral exercise but also for the restoration of statehood. Sooner these things happen, the happier people of the UT will be.

From Makkah To Karbala

The month of Zil Hijjah has just passed and the sorrowful month of Muharram has emerged, bringing along with it all its grief, sadness, and mourning as the new year commences. It was in the year 60 A.H. when Imam Hussain (peace be upon him) and his family made the intention to perform Hajj in the sacred Haram. However, just before the commencement of the pilgrimage, he suddenly left Makkah without performing Hajj! This was the time when huge crowds were entering Makkah for Hajj that Imam Hussain was going out of that Holy City with his family and followers. This strange event must have elicited questions in the minds of everyone as to why the grandson of the Holy Prophet (peace be upon him and his progeny) was leaving Makkah just on the eve of Hajj without performing Hajj. Why did he leave Makkah, when he embarked on this spiritual journey in order to complete what is one of the best deeds in Allah's eyes? Why didn't he wait just a fir few days until he finished the necessary rituals of pilgrimage? After all, based on our human judgment, nothing could be more important than the pilgrimage that would deserve interruption or cancellation right?

History tells us that the Imam discovered that some of the followers of Yazid had entered Makkah as pilgrims, with the mission to kill him during the rites of Hajj with the arms they carried under their special pilgrimage dress (the Ehraam). So Imam Hussain shortened the pilgrimage rites and decided to leave. Amidst the vast crowd of people, he stood up and announced in a speech that he was setting out for Iraq, he declared that he would be martyred, asked the Muslims to help him in attaining the goal he had in view, and to offer their lives in the path of God. The next day, he set out with his family and a group of his companions for Iraq. But it was not his own life that he was fearful for; rather, it was the life of Islam that Imam Hussain had his eyes set on! The proof for that is that he knew very well that he would be killed in Karbala and was literally walking towards his own death! So why interrupt his Hajj only to die in another land, if not for a noble reason?

Secondly, Imam Hussain's ultimate aim was to expose Yazid, and the Imam was determined not to give his allegiance to this corrupt oppressor. In this way, the question of why Imam Hussain refused allegiance to Yazid came to the forefront of discussion among all individuals and groups who assembled for Haii as they noticed that Imam Hussain left Makkah without performing the Hajj. If the Imam were to be killed now, it would be assumed that Yazid must have arranged his killing and this is what actually happened. Yazid stands clearly, openly and directly exposed as the perpetrator of the crimes which formed part of that tragedy and his un-Islamic ideas; the beliefs and acts lie exposed to the world. The very people who had been silenced by fear and awe of the murderous tyrants were so moved to the core of their hearts by the tragic events of Karbala that they began picking up courage to express themselves against Yazid. In a very short time, there was a widespread uproar of protests against him and his government. This was possible only because of the superb way in which Imam Hussain carried out his plan of meeting Yazid's violence with the strength of his character.

Actually, it would be an erroneous statement to say that the Imam skipped or canceled his Hajj that year! In fact, Imam Hussain abandoned the ritualistic Hajj to perform the true essence of Hajj, which is embodied in his sacrifice and bloodshed on the plains of Karbala! Quite frankly, many of the ritualistic acts of Hajj symbolize the tragedy of Karbala, most notably the slaughter on the day of Eid al-Adha. Even though we celebrate that day out of gratitude that Allah spared the grief of father and son, Prophets Ibrahim and Isma'il (peace be upon them) from the slaughter

ordered by Him, our moment of joy doesn't last long because it is soon replaced by the Great Slaughter (Dhibh Adheem, as mentioned in 37:104-108 of the Qur'an) which is personified in Hussain ibn Ali. The grief we feel is further intensified as we remember the pain of separation between Imam Hussain and

his son Ali Akbar, which was not spared like that of Isma'il and his father. The 10th of Dhil-Hijjah is only a few weeks away from the 10th of Muharram, reminding us of the true sacrifice that was offered in Karbala one month later!

When we think of Lady Hajra's plight in fetching water for her son Isma'il, we are reminded of Imam Hussain's pain of watching his youngest son, Ali Asghar, die out of thirst as he tries his best to seek water from the enemy by raising his infant in his arms in the hopes of moving their hearts and quenching his son's thirst. Unlike Hajra, whose heart was solaced when a spring of water erupted to save her son's life, Imam Hussain found nothing but a tri-headed arrow to pierce the neck of Ali Asghar! It is narrated that when Lady Hajra saw with her own eyes the marks of the knife on her son's neck, she fainted from that scene; one can only imagine what overwhelming emotions Lady Fatima experienced when she witnessed her son's headless body trampled by the hoofs of the horses after dying in a state of extreme thirst!

As the pilgrims rush to attain the blessings of the holy water of Zamzam, they are to be reminded of that water which Imam Hussain was denied until he died in the state of thirst, when even animals are given a last sip before being slaughtered!

The pilgrims in Hajj wear their clothes of Ehraam for the sake of Allah, and Imam Hussain also wore his clothes of Ehraam for His sake while abandoning the pleasures of this life only for these 'Ehraam' clothes to be drenched in his own pure blood to irrigate the tree of Islam!

The pilgrims stone the symbols of Shaytan numerous times to expel the whisperings of the devil which we are all prone to every second of every day. Hurr ibn Yazid al-Riyahi and Umar ibn Sa'd also experienced whisperings from Shaytan to attain the glory of power. However, Hurr stoned the whisperings of Shaytan and made the right decision to join Imam Hussain, while Umar followed the whisperings and became a Shaytan himself!

the When pilgrims to Mina where the final sacrifice is given, this stage of Hajj symbolizes our intention to sacrifice everything beloved to us for Allah just like the Imam did, and the tents are a reminder of his family's tents which were burned down and destroyed in Karbala after the Great Slaughter!

When the pilgrims visit the Holy Kaaba and circumambulate it, they are reminded of the honor Allah gave Prophet Ibrahim in rebuilding this sacred House of God. They are also to be reminded of the rebuilding of the pure Mohammadan Islam by Imam Hussain when he offered his pure blood to give a jump-start to this Deen, which was on its way to corruption and deviation.

It is important to note that a pilgrim who performs Hajj without recognizing Karbala to be its true essence does not gain the real fruits of his/her pilgrimage. In the words of Dr. Ali Shariati: "Imam Hussain did not complete his Hajj in order to teach the pilgrims that if there is no Imamat and there is not true leadership, if there is no goal, if 'Hussain' is not there and 'Yazid' is there, making Tawaaf around the house of Allah is equal to making Tawaaf around the idol-house." (Hajj)

All the pilgrims stone the Shaytan, all of them wear the robe of Ehraam, and all of them circumambu-

late the Kaaba and walk the distance between Safa and Marwa. But not all who physically stone the Shaytan have truly rid themselves from his temptations. Not all who wear the Ehraam have forbidden themselves from that which Allah has forbidden them. Not all who sacrifice an animal has their offer truly accepted by Allah, and it is only those who sacrifice their souls 'like the blessed companions of Imam Hussain' and exhibit readiness to die for the Imam and the mission he represents, whose offer is accepted by Allah. Not all who raise their voices and call out "La ilaaha illAllah" have truly recognized the essence of *Tawheed*, and it is only by fulfilling the conditions that one has truly pronounced the word of Oneness. As Imam Ali ar-Ridha (peace be upon him) relayed to his companions: The Almighty Allah said, "I surely am the God besides whom there is no god, so worship Me. Whoever comes with the testimony of Tawheed sincerely, he has surely entered My castle: and whoever enters My castle, he shall be protected from My chastisement." When some of the companions expressed excitement from that statement, Imam Ridha immediately added, 'Yes this is true, with its conditions.' This condition is to acknowledge and submit to the Imamat and Wilayat of Imam Hussain and his descendants.

If we recognize the essence of Hajj as being intertwined with the tragedy of Karbala, we can then understand why Allah's mercy encompasses the pilgrims visiting the holy shrine of Imam Hussain on the day of Arafah, even before the pilgrims of Hajj! (Kamil al-Ziyarat) We will then understand why a special Ziyarat is to be recited for Imam Hussain on the day of Arafah, which is one of the most important deeds that one can do. We will then realize that it is not a coincidence that one of the key recommended deeds to be performed on the day of Arafah is to recite the special beautiful supplication of Imam Hussain for the day of Arafah, which speaks volumes of the level of Irfan and wisdom which Imam Hussain possesses as he summarizes to us in concise words the fundamentals of Tawheed. We will then understand why, according to authentic hadith, visiting the holy shrine of Imam Hussain is worth 90 Hajj and 90 Umrah performed by the Holy Prophet himself! It is common knowledge that Hajj is obligatory on all Muslims if and only if they have the means to do so and all the prerequisite requirements are met. However, supporting and treading the path of Imam Hussain is incumbent and obligatory upon every human at all times, whether Muslim or non-Muslim!

Are Job Interviews Failing Us?

magine you're a seasoned chef, tasked with judging a cook-Ling competition. But instead of tasting the dishes, you're only allowed to interview the contestants about their recipes. Sounds absurd, right? Yet this job interviewing process is precisely how we've approached the lion's share of hiring for the past 200 years.

Yet a meta-analysis published this week by Wingate and colleagues (2024) highlights that within a sample of over 30,000 people, job interviews do not in fact predict future job performance. Thus, interviewing someone may not actually help us make better hiring decisions.

In light of this, it's worth asking: How much of our hiring decisions are based on evidence, and how much on subjective impressions? Let's explore why interviews are poor predictors of performance and discuss ways to improve hiring decisions.

The Illusion of Accuracy

Anyone involved in hiring has been there: sitting across from a candidate, convinced we can gauge their potential and predict their performance based on a 60-minute conversation. However, the sobering reality is that interviews only explain about 9 percent of the variance in future job performance.

In other words, 91 percent of what determines how well someone will do in a job is completely missed by the interview process. It's like trying to predict the outcome of a chess match by watching the players set up the board. Interviews are thus not valid tools to assess people's capabilities and the illusion that it is an accurate tool is costing businesses dearly.

The Myth of the Perfect Interview Ouestion

Many of us believe that if we just ask the right questions, we'll uncover the truth about a candidate. We craft behavioral questions, situational judgement scenarios, and technical assessments that we are convinced reveal the perfect person for the job. But research tells a different story.

Whether we're trying to assess behaviors, task-related skills, or interpersonal abilities, interviews show surprisingly low levels of accuracy. Both structured and unstructured interviews fail to predict a candidate's potential performance.

Further, interviews are equally mediocre at predicting both taskspecific skills and broader contextual behaviors. This suggests that the standard interview format may be too blunt an instrument to capture the nuances of diverse job requirements.

Interviews are often seen as a one-size-fits-all tool to assess capability in diverse job roles. But is it really possible to use the same tool to assess a software engineer's coding abilities and a sales representative's client relationship skills?

The Bias Blindspot

Another problem with interviews is that they are heavily influenced by our unconscious biases. Even with structured formats and scoring systems, we're all susceptible to making snap judgments based on factors that have nothing to do with job performance.

candidate's appearance, speaking style, or even how familiar they are to us can unconsciously sway our decisions. Maybe we're swayed by a candidate's charisma, or we feel a connection because they remind us of ourselves. These biases can lead us to make decisions based more on gut feeling rather than objective assessment.

Similarly, the halo effect, where one positive attribute colors our entire impression of a person, is particularly problematic. A

charismatic response to the first question can overshadow later missteps, while a single awkward moment early on can unfairly taint our perception of an otherwise capable candidate.

This effect is so strong that it can overshadow the actual skills and competencies that are crucial for the job. We thus end up hiring people who are great at interviewing but not necessarily great at the

The "Fit" Fallacy

Another pitfall is the overemphasis on cultural fit. While it sounds logical to choose candidates who align with company values and team dynamics, this approach often leads to homogeneity rather than diversity.

When companies prioritize cultural fit, they often end up creating teams that think, act, and look alike. This is because people tend to feel more comfortable around others who share similar backgrounds, interests, and ways of thinking. While this might create a harmonious and easygoing workplace, just fitting in with a group doesn't mean a candidate has the right experience, skills, and abilities to perform well in the role.

When we prioritize fit, we not only risk creating echo chambers

where new ideas and perspectives are rare, but we tend to neglect the actual capacities required for the individual to perform and the organisation to grow. True performance relies on a combination of cultural fit, personal capabilities to perform in the role, and potential to grow. While interviews can evaluate fit, they are particularly weak in predicting potential and performance.

Improving The Hiring Process

So, if interviews aren't the reliable predictors we thought they were, how can we improve our hiring decisions? Here are some evidence-based strategies:

- Diversify assessment tools: Run assessment centers that incorporate a wide array of job simulations, work sample tests, and skills assessments to evaluate candidates based on actual job-related tasks. These methods evaluate candidates based on actual jobrelated tasks, not just their ability to perform well in an artificial interview setting.
- Focus on past performance: Dig deep into a candidate's concrete accomplishments and how they achieved them.
- Structured interviews with flexibility: While completely

problematic, overly rigid ones can miss important nuances. Strike a balance with semistructured interviews that allow for some flexibility while maintaining consistency across candidates. Leverage technology: AI-

unstructured interviews are

- driven assessments can help remove some of the human bias from the equation and provide data-driven insights into a candidate's potential.
- Emphasize cultural contribution, not just fit: Instead of looking for someone who fits your current culture, seek candidates who can positively contribute to and even enhance your organizational

culture. Conclusion

As we stand at the crossroads of tradition and innovation in hiring practices, it's time to ask ourselves: Are we truly seeing the forest, or are we still fixated on a single tree? The next game-changing employee might not be the one who interviews best, but the one whose true potential is waiting to be discovered.

Thousands Join

processions in Kashmir have been allowed to resume after more than thirty years.

In his plea seeking divorce, Omar Abdullah had claimed before the family court that his marriage had broken down irretrievably and he has not enjoyed a conjugal relationship since 2007 and that the couple, married on Sentember 1 1994 was living separately since 2009. The couple has two sons who are staying with their

The petition before the trial court also alleged that Omar Abdullah was subjected to "unreasonable conduct" by Payal Abdullah, causing pain and harassment to the politician.

In August, 2023, a single judge bench of the Delhi High Court had directed Omar Abdullah to pay Rs 1.5 lakh as monthly interim maintenance to his estranged wife.

It had also ordered him to pay Rs 60,000 each on a monthly basis for the education of his two sons who are pursuing law.

The high court's order had come on petitions by Payal Abdullah and the couple's sons against 2018 lower court orders granting her and them interim maintenance of Rs 75,000 and Rs 25,000 till they attained the age of majority, respectively.

The judge had observed that Omar Abdullah has the financial capacity to provide a "decent standard of living to his wife and children" and that he should not abdicate his duties as a

Continuing his attack, Swain alleged that visiting homes of terrorists killed by security forces and expressing sympathy for them in public was "normal".

"While the elimination of new recruits in terrorism was allowed and tacitly encouraged, those who facilitated recruitment and arranged finances were never investigated... SP rank officers were arrested and put in jails alongside terrorists, for crimes they had never committed," he added.

"The drowning of two girls in 2014 was allowed to be hijacked by narrative terrorism who held the valley at ransom, hartals, and rioting for many weeks. A very detailed investigation by the CBI and verified by the AIIMS forensics proved it was an accident," the DGP said, referring to the deaths of two girls who had drowned in a well in Tral in 2014.

Control (LoC) in the Keran Sector of north Kashmir's frontier Kupwara district. A large quantity of arms, ammunition and other war-like stores were recovered from their possession.

During a joint press conference, Commander 268 Infantry Brigade, Keran Sector, Brigadier NR Kulkarni, along with Senior Superintendent of Police (SSP) of the district, Shobhit Saxena, informed the media about the operation.

Brigadier Kulkarni said that for the past few weeks, intelligence inputs indicated that terrorists were trying to infiltrate the LoC along the Keran Sector, intending to carry out sabotage and subversive activities, particularly aiming to disrupt the ongoing Amarnath Yatra.

"On July 12, specific intelligence inputs were provided by their agencies, which were corroborated by the Jammu & Kashmir Police, regarding a group of foreign terrorists likely to infiltrate by leveraging the dense forest cover and thick undergrowth along the nallahs. In response, multiple ambushes were jointly laid by the army, police, and the BSF from the night of July 13 to 14 along the infiltration routes," he said, adding that the area was monitored and kept under surveillance.

Brigadier Kulkarni said that on July 14, around 15:00 hours, heavily armed and well-trained terrorists, equipped with sophisticated weapons, attempted to infiltrate across the LoC, taking advantage of the dense forest cover and poor visibility due to unfavourable weather conditions. "This triggered intense firefights. In the ensuing battle, three hardcore foreign terrorists were neutralised," he said.

Following the gun battle, a thorough search operation was conducted in the area, leading to the recovery of a large quantity of war-like stores, including three AK series rifles along with magazines, four pistols, grenades, and more," Brigadier Kulkarni said, adding, 'This successful intelligence-based operation, named Operation Dhanush II, exemplifies the close synergy between the Indian Army, BSF, and Jammu & Kashmir Police."(KNO)

Purple Revolution: Lavender Cultivation Thrives In J&K

SRINAGAR: The resurgence of lavender cultivation, known as the "Purple Revolution", is currently being witnessed in Jammu & Kashmir. However, this is not a new phenomenon for Kashmir, which produced hundreds of kilograms of lavender around two decades ago.

In an exclusive interview Dr Abdul Sami Shawl, a wellknown scientist formerly in charge of the CSIR Field Station Bonura (formerly CIMAP Field Station Bonura) in Pulwama, explained that lavender was initially introduced to Kashmir in the early 1970s.

He said the initiative was led by Dr Akhtar Hussain, the then Scientist In-charge of the Field Station and founder Director of the Central Institute of Medicinal and Aromatic Plants (CIMAP), Lucknow.

Dr Shawl said that after extensive efforts on varietal improvement, a new variety of lavender was developed and its large-scale cultivation began at the Pulwama Station. "Further genetic improvements led to the introduction of the variety known as B-18. With the propagation of this new variety among farmers, Kashmir used to produce around 700-800 kg of lavender oil," he said, adding that Kashmir is the only temperate zone where even Mediterranean plants can be cultivated.

To promote lavender cultivation among farmers and small producers, the government introduced a buy-back scheme and connected growers with various businesses utilising lavender oil.



"Lavender cultivation was also promoted through a Public-Private (PPP) model, providing entrepreneurs with technical assistance and knowledge sharing for large-scale production," the scientist said. "Distillation facilities at the Field Station were made available to growers under the PPP mode for oil extraction. Some entrepreneurs were also encouraged to cultivate lavender on government land holdings.

In around 2005, then Chief Minister Mufti Mohammad Sayeed, who had a keen interest in lavender, developed a lavender park in Pahalgam. Following the initial success, entrepreneurs like Dr Ghazala and others brought around 2000 kanals of their land under lavender cultivation, Dr Abdul Sami said.

Although lavender was also introduced in Himachal Pradesh, Tamil Nadu, and other northeastern states, excessive rainfall during the flowering period hindered its expansion

in these areas, he added. Currently, Bhaderwah is recognised as the epicentre of the Purple Revolution, with farmers adopting lavender for its increased profitability compared to traditional crops. Since 2009, thousands of rooted lavender plants from the Pulwama Station of CSIR have been taken to Bhaderwah, promoting large-scale cultivation. As a result, more farmers are switching to producing lavender oil and dry flowers.

The CSIR Aroma Mission, an initiative under the Ministry of Science and Technology, has significantly promoted the cultivation of various industrially important aromatic crops, including lavender.

Other crops like rose, rosemary, and clary sage, also targeted under the Aroma Mission have the potential for similar exploitation due to the high market demand for their essential oils and value-added products, Dr Shawl said.

He said the essential oils produced in the valley meet international standards, comparable to those produced in Bulgaria and France, adding that efforts to strengthen market linkages and industry connections are crucial. -(KNO)

BJP Used KP Exodus Issue To Gain Votes: Panun Kashmir ty and will pursue their politi-

JAMMU: Panun Kashmir on Monday criticised the BJP leadership, accusing them of using the issue of exodus of Kashmiri Hindus to blame their opponents and gain Hindu votes across India.

Regarding movement of fruit laden trucks from the valley, the Chief Secretary

stressed on making a comprehensive plan for smooth movement of these vehicles to further reduce the travel time for perishable items. He asked for marking the fruit-laden trucks with specially designed stickers for identification and giving unhindered access to reach the Mandis outside so that the growers don't suffer any losses.

While calling for enhancing level of enforcement especially on the critical stretches of the road, the Chief Secretary told the officers to utilize alternate assets like Mughal Road and Jawahar Tunnel optimally to reduce the traffic congestion on NH-44. He asked them to ensure that oil tankers and other empty trucks moving towards Jammu should be directed to take towards Mughal road. He said that the fruit trucks should have an option to make use of Jawahar tunnel in case there is an apprehension of delay via Quazigund tunnel.

He asked the concerned officers to make use of lean windows optimally by diverting most of the heavy vehicles during the underutilized period. He also asked the NHAI to further improve the overall road surface besides blacktopping of potholed portion near Magarkote and sort out all other minor issues without any undue delay.

PCB Wants Written Proof From BCCI On Gol's **Travel Ban Amid Champions Trophy Concerns**

KARACHI: The Pakistan Cricket Board wants the BCCI to provide written proof of the Indian government's denial of permission in case the team refuses to come here for next year's Champions Trophy citing a travel ban on security grounds, a PCB source has said.

The PCB has already submitted its draft schedule to ICC where all of India's games including a possible semi-final and final has been scheduled in Lahore. The India vs Pakistan marquee match has been scheduled on March 1.

The tournament will start in Karachi on February 19 and conclude with the final in Lahore on March 9. The final will have a reserve day — March 10 in case of inclement weather. A few matches will be held in Rawalpindi too.

If BCCI sources are to be believed, at this point there is no chance of travelling to Pakistan and knowing fully well, the ICC has allocated additional budget for any exigency plan.

"The ICC Management is recommending additional costs just in case it is necessary to play some matches outside Pakistan if such a situation arises later on," the source

LONDON: Roger Federer, Rafael Nadal and Novak Djokovic did not manage to collect four Grand Slam titles before turning 22, the way Carlos Alcaraz has.

None of the members of the so-called Big Three was able to triumph at both the French Open and Wimbledon in a single season before turning 22, the way Alcaraz just did, capped by a 6-2, 6-2, 7-6 (4) win against Djokovic on Sunday in the final at the All England Club for a second consecutive trophy there.

Alcaraz is aware of where many of his achievements particularly with regard to his age — place him in the history of the game. Those are not the milestones that interest him, however. He wants to do more, win more. He wants to reach elite status.

"Get closer to the legends," is the way Alcaraz put it in Spanish on Sunday evening. "That's my objective." The list of what Alcaraz is

His 2022 U.S. Open title made him the first teenager to reach No. 1 in the ATP rankings. His French Open championship last month made him the youngest man with major titles on hard, grass and clay courts. Sunday's victory made him only the third man to win Wimbledon multiple times before turning 22, joining Boris Becker and Bjorn Borg. It also made him the second man in the Open era, which dates to 1968, to start a career 4-0 in Slam finals, joining Federer.

'Well, obviously I've seen, and I've heard, all the stats that I am the 'youngest to win at Roland Garros and Wimbledon the same year' (or) to win whatever. I honestly try not to think about it too much. Obviously it's a really great start of my career, but



I have to keep going. I have to keep building my path," Alcaraz said, between tugs at the shoulders of his white

"At the end of my career, I want to sit at the same table as the big guys. That's my main goal. That's my dream right now," he continued. "It doesn't matter if I already won four Grand Slams at the age of 21. If I (don't) keep going ... it doesn't matter."

It's hard not to appreciate his talent as it stands now.

The forehands struck with such force that crowds gasp. The serves that topped 135 mph (218 kph) against Djokovic. The returns that

produced five winners and 14 break points on Sunday. And that's to say nothing of the speed and on-the-run creativity that turn opponents' apparent point-closing shots into remarkable winners at the other end of the court. "Just overall, the way I felt

on the court today against him, I was inferior," said Djokovic, who only broke Alcaraz once. "That's it. He was a better player. He played every single shot better than I did." Pretty high praise.

Daniil Medvedev, the 2021 U.S. Open champion and fivetime Slam runner-up, also was effusive in his assessment after losing to Alcaraz in the semifinals Friday,

"We all have, a little bit, our preferences: Someone prefers defense; someone prefers counterattack; someone prefers to be super aggressive," Medvedev said. "He can do all

Perhaps. Do not think for a moment that Alcaraz is satisfied. To give one example: He spent extra time working on his serving during the Wimbledon fortnight.

"I have to keep improving everything, I guess," Alcaraz said.

So how far can he go? Seems rather premature to start discussing whether he can approach the Grand Slam totals of Djokovic (24), Nadal (22) or Federer (20).

And yet, given Alcaraz's comment about "the big guys," it did seem appropriate for a reporter to ask how many titles he wants to accumulate.

That drew a wide smile from the Spaniard.

"I don't know what is my limit. I don't want to think about it. I just want to keep enjoying my moment, just to keep dreaming," Alcaraz responded. "So let's see if, at the end of my career, it's going to be 25, 30, 15, four. I don't
