Global Tech Glitch Grounds Flights, Disrupts Banks & Media Worldwide

Wellington: A widespread technology outage grounded flights, knocked banks offline and media outlets off air on Friday in a massive disruption that affected companies and services around the world and highlighted dependence on software from a handful of providers.

The trouble with the update issued by cybersecurity firm CrowdStrike affected customers running Microsoft Windows. It was not the result of hacking or a cyberattack,



according to CrowdStrike, which apologized and said a fix was on the way.

Chaos At Indian Airports

Financial Systems Remained Largely Unaffected

New Delhi: Airport and airline operations across the country were almost crippled on Friday due to a Microsoft outage globally, leading to a com-plete chaos with IndiGo alone cancelling around 200 flights.

In addition to this, hundreds of flights were delayed by a considerable time across airlines' networks due to the outage, which started from 1040 am, according to sources.

As services like bookings, check-in and boarding moved to manual mode, taking longer than expected time and leading to long queues at airports, passengers, including those who were travelling due to some emergency reasons, were seen complaining about the lack of information about their flights and venting out ire on airline

Mischievous Plea Against LG

Former IAS Officer Fined Rs 1 Lakh

The Central Administrative Tribunal's Jammu Bench has imposed a fine of Rs 1 lakh on a former IAS officer for filing a "mischievous and frivolous" plea against the Lieutenant Governor of Jammu and Kashmir and other senior bureaucrats.

The tribunal's judicial member Rajinder Dogra, in the July 16 order, said the application filed by a former IAS officer Kumar Ranchhodbhai Parmar about his service was just to "harass" the Lt Governor Manoj Sinha and other bureaucrats.

The tribunal said this was a service-related matter and instead of impleading the Union and the state governments, Parmar has impleaded Sinha and other authorities by their names.

"It is quite astonishing to note that the applicant, a senior IAS officer with extensive knowledge of the Constitution and its laws, proceeded to file the application seeking relief against the Hon'ble Lieutenant Governor," the tribunal said.

Bangladesh Turmoil

Calls For Evacuation Of Kashmiri Students Grow

Srinagar: The violent protests in Bangladesh where 39 protesters have been killed in the ongoing quota row has sent parents in Kashmir into tizzy even as former chief ministers and a students' association have urged the Government of India for safety of Kashmiri students.

Protests in Bangladesh have erupted over the Bangladesh High Court's decision to reinstate a 30% government job reservation for the descendants of those who had fought the 1971 war of independence against Pakistan.

Hundreds of students from ammu and Kashmir go to Bangladesh every year for studying medical courses, particularly MBBS. These students spend lakhs of rupees on thier studies in the country where medical degrees are comparatively economical than in India and other countries.

The National Conference (NC) and the People's Democratic Party (PDP) on Friday appealed to the external affairs ministry to ensure safe passage and return of Kashmiri students from Bangladesh amid violent protests in the neighbouring country over demands for an end to a quota system in jobs.

"Dear @MEAIndia, please ensure the safe passage and return of Kashmiri students from Bangladesh amidst the ongoing unrest. Parents of these students are extremely worried as there is no or little communication," NC leader and Srinagar Lok Sabha MP Aga Syed Ruhullah Mehdi said in a post on X.

PDP president Mehbooha Mufti, said immediate steps must be taken to bring Kashmiri students back.

Srinagar: Despite witnessing tragedy a few months back, the pivotal Gandbal Bridge in Batwara of Srinagar has missed yet another deadline. Pertinently, the officials had

stated the bridge would be ready for public use by the first week of July. As per the details, the dead-

line for Gandbal Bridge was set as June 30, 2024, but authorities were unable to meet it. On April 16, a pall of gloom descended throughout Kashmir after a boat ferry-

ing 15 people capsized in the

River Ihelum at Gandbal, leav-

ing 8 persons dead, including a father-son duo. On June 22, the Chief Engineer of the R&B department, Sajad Nageeb had also said that Gandbal Bridge was expected to be ready for public

use by the first week of July. In this regard, an official heading the Gandbal Bridge



construction said that the work is ongoing and that from the Batwara side, the work is completed.

"We are continuously working on the bridge, and the work is almost complete on the Barwara side. The delay occurred because there were some problems on the Gandbal side, as people were not allowing us to work properly," he added.

The locals say that construction on the Gandbal-Batwara footbridge began in 2016, but the challenge of completing such a small project appears to be beyond the capabilities of the government.

NGT Team Slams SMC For 'Mishandling' Solid Waste

Agencies

Srinagar: The expert team formed by the National Green Tribunal (NGT) has expressed serious concern over the "mishandling" of solid waste management in Srinagar soon after visiting the Achan landfill site. The team, led by the Regional

Director of the Central Pollution Control Board (CPCB), Dr. Nerender Sharma, inspected the landfill site on Monday and held meetings with different departments and locals about "hazardous" and "unscientific" waste management in Achan. The matter was taken up by Raia Muzaffar Bhat in the NGT

The tribunal, in its May order, had directed this team to suggest remedial measures, including setting up waste processing facilities at zero landfills and submitting the report within eight weeks. The team has only two weeks to submit its report.

Bhat, the petitioner, briefed the team officials about the



problems related to the Achan waste dumping site, like the absence of a waste segregation machine, and untreated leachate flowing into the nearby wetlands and lakes.

"Achan area is dumping site but a mountain of death emanating deadly gases and pumping poisonous leachate in liquid form. This has made the lives of locals living in the radius of 5 kilometers a living hell," he said.

Settle Bills Or Face Blackout!

KPDCL Disconnects Thousands Of Non-Paying Consumers

Srinagar: Kashmir Power Distribution Corporation Limited (KPDCL) has intensified its drive against nonpayment of electricity bills and remotely disconnected thousands of smart-metered consumers.

Similarly, in flat-rated areas, those consumers who haven't paid their pending dues for months together are being physically disconnected, till they clear their bills with KPDCL.

In a press statement issued on Friday, a KPDCL spokesperson stated that fervent appeals have been

made urging consumers to pay their bills on time. He further stated that KPDCL is a Service Provider that needs timely clearance of bills by all categories of consumers for electricity supplied to remain economically viable. While 1,134 smart-me-

tered consumers were disconnected in Electric Division Chanapora on Thursday, electricity supply of 440 consumers in ESD Baramulla I, 240 in ESD Baramulla II and 228 in ESD Qazigund were also snapped.

CrowdStrike Deploys Fix For Issue Causing Global Tech Outage

Cybersecurity firm CrowdStrike has deployed a fix for an issue that triggered a major tech outage that affected industries ranging from airlines to banking to health care worldwide, the company's CEO said on Friday.

Microsoft said separately it had fixed the underlying cause for the outage of its 365 apps and services including Teams and OneDrive, but residual impact was affecting some services.

"This is not a security incident or cyberattack. The issue has been identified, isolated and a fix has been deployed," Crowd-Strike CEO George Kurtz said in a post on social media platform X. The issue stemmed from a

update for Microsoft Windows hosts, Kurtz said, adding Mac and Linux hosts were not impacted by the issue.

Shares of CrowdStrike tumbled nearly 12% in premarket trading, while Microsoft was down 1.4%. A massive IT outage was disrupting operations at companies across multiple industries on Friday, with ma-jor airlines halting flights, some broadcasters off-air and sectors ranging from banking to health care hit by system problems.

"We're deeply sorry for the impact that we've caused to customers, to travellers, to anyone affected by this, including our company," Kurtz told NBC News' "Today" program. "Many of the



6 years On, Multi Crore Smart **Vending Zone Remains Grounded**

SRINAGAR: Almost six years since the Srinagar Municipal Corporation (SMC) announced the smart hawker vendor zone near Khalsa School Srinagar to relocate at least 450 street vendors, the civic body is yet to make it functional.

The designated zones for street vendors are a part of the Smart City project to decongest city streets and provide legitimate means of livelihood to hawkers.

news agency-KNO, has not been able to make the main vendor zone functional despite building smart carts with basic facilities including solar power panels. The ambitious project was an-

nounced in 2018 and a tender worth Rs. 4.84 was issued in March 2020 to set up a smart vending zone near Exhibition Ground. An official told KNO that the initial work on the smart carts was taken

up and completed within a year

only. However, the facility was abandoned soon after. He said the corporation couldn't reach any agreement with the street vendors located at Hari Singh High Street and Jahangir Chowk, thereby

delaying the implementation and wasting the state exchequer. Another official cited some dispute over the land on which the

smart stalls had been built. President of Kashmir Traders and Manufactures Federation (KTMF), Yasin Khan expressed concern over the delay in the vendor zone project and appealed to the government to make it functional at the earliest.


Protesters Set Jail On Fire In Bangladesh, Free "Hundreds" Of Inmates

Dhaka, Bangladesh: Banstudent protesters stormed a prison and freed hundreds of inmates Friday as police struggled to quell unrest, with huge rallies in the capital Dhaka despite a police ban on public gatherings.

This week's unrest has killed at least 64 people, according to an AFP count of victims reported by hospitals, and emerged as an unprecedented threat to Prime Minister Sheikh Hasina's autocratic government after 15 years in office.

Student protesters stormed a jail in the central Bangladeshi district of Narsingdi and freed the facility's inmates before setting the facility on fire, a police officer told AFP on condition of anonymity.

"I don't know the number



That did not stop another round of confrontations between police and protesters around the sprawling megacity of 20 million people, despite an internet shutdown aimed at frustrating the organisation of rallies.

"Our protest will continue," Sarwar Tushar, who joined a march in the capital and sustained minor injuries when it was violently dispersed by police, told AFP.

"We want the immediate resignation of Sheikh Hasina. The government is responsible for the killings.

At least 19 people were killed in the city on Friday, according to a list drawn up by the Dhaka Medical College Hospital and seen by AFP.

Police fire was the cause of more than half of the deaths reported so far this week, based on descriptions given to



of inmates, but it would be in the hundreds," he added.

Dhaka's police force took the drastic step of banning all public gatherings for the day -- a first since protests began -in an effort to forestall another day of violence.

"We've banned all rallies, processions and public gatherings in Dhaka today,' police chief Habibur Rahman told AFP, adding the move was necessary to enAFP by hospital staff.

The capital's police force earlier said protesters had on Thursday torched, vandalised and carried out "destructive activities" on numerous police and government offices.

Among them was the Dhaka headquarters of state broadcaster Bangladesh Television, which remains offline after hundreds of incensed students stormed the premises and set fire to a building.

US-bound Air India Plane Makes Emergency Landing In Russia

NEW DELHI: An Air India airplane flying from Delhi to San Francisco made an emergency landing in Russia after the crew detected a potential issue in the cargo hold area, the airline said on Friday, its second such incident on the route in just over a year.

Many carriers, including US and European Union airlines, avoid Russian airspace following the war in Ukraine, but Air India uses that route, giving it a flying time and cost advantage on US-bound flights.

The Boeing 777 aircraft, carrying 225 passengers and 19 flight crew, made a precautionary landing safely in the Russian region of Siberia at the Krasnoyarsk International Airport, the airline said in a statement.

It added Air India was "concerned about the passengers and staff and are making every

effort possible to operate the ferry flight as soon as possible."

The airport said the flight's crew had been moved to hotels, and passengers were in the international departure area, which angered some of those stranded, according to social media posts.

Mayank Gupta, whose mother was on the flight, wrote on X he was "sad and angry" that her medicines and luggage remained on the airplane.

A passenger said on X that people were struggling to get food and water, posting a photo showing some passengers sleeping on the floor inside the airport area.

In another statement on Friday. Air India said representatives from the Indian consulate in Moscow traveled to Krasnoyarsk overnight and "are working with Russian authorities to allow passengers to move to hotels, which have been on standby throughout the night."

Congress leader Priyanka Gandhi Vadra on Friday slammed the UP government directive asking eateries on the Kanwar Yatra route to display owners' names as an "attack on the Constitution" and demanded the order be withdrawn.

She also sought strict action against the officials who issued the order.

Days after the Muzaffarnagar Police asked all eateries along the Kanwar Yatra route to display their owners' names. the Uttar Pradesh government on Friday extended the controversial order across the state.

A government spokespern said that a formal order is likely to be issued soon.

In a post in Hindi on X, Priyanka Gandhi said, "Our Constitution guarantees every citizen that he will not be discriminated against on the basis of caste, religion, language or any other basis.

"The divisive order to put up name boards of the owners of carts, kiosks and shops in Uttar Pradesh is an attack on our Constitution, our democracy and our shared heritage. The Congress general secretary added, "Creating division in society on the basis of caste and religion is a crime against the Constitution. This order should be withdrawn immediately and strict action should be taken against the officials



who issued it." Senior Superintendent of Police of Muzaffarnagar Abhishek Singh had on Monday said, "Preparations of Sawan month have started in the district. About 240 kilometres of Kanwar Yatra route falls in the district. All eateries, including hotels, dhabas and carts, on the route have been asked to display the names of their proprietors or those working on these shops.' "This has been done to ensure that there should be no confusion among kanwariyas and no law and order situation arises. All are following this voluntarily," he had told reporters. Congress The had

slammed the directive, which police have said is voluntary, as "an assault on India's culture," alleging that it intended to normalise the economic boycott of Muslims. The BJP, which is in power at the Centre and in Uttar Pradesh, has defended the measure, claiming the order is for the fasting Hindus who may want to eat at a pure vegetarian restaurant.

'Israel's Settlement Policy In Occupied Territories Violates International Law'

THE HAGUE: The top United Nations court said Israel's settlement policy in the West Bank and east Jerusalem violates international law, as it delivered a non-binding advisory opinion on the legality of Israel's 57-year occupation of lands sought for a Palestinian state, a ruling that could have more effect on international opinion than it will on Israeli polic

International Court of Justice President Nawaf Salam was expected to take about an hour to read out the full opinion of the panel, which is made up of 15 judges from around the world.

In part of the opinion, he said the panel had found that "the transfer by Israel of settlers to the West Bank and Jerusalem as well as Israel's maintenance of their presence, is contrary to article 49 of the Fourth Geneva Convention." The court also noted with "grave concern" that Israel's settlement policy has been expanding. The court also found that Israel's use of natural resources was "inconsistent" with its obligations under international law as an occupying power.

Friday's hearing against the backdrop of Israel's devastating 10-month military



assault on Gaza, which was triggered by the Hamas-led attacks in southern Israel. In a separate case, the International Court of Justice is considering a South African claim that Israel's campaign in Gaza amounts to genocide, a claim that Israel vehemently denies

Israel captured the West Bank, east Jerusalem and Gaza Strip in the 1967 Mideast war. The Palestinians seek all three areas for an independent state.

Israel considers the West Bank to be disputed territory, whose future should be decided in negotiations, while it has moved population there in settlements to solidify its hold. It has annexed east Jerusalem in a move that is not internationally recognized, while it withdrew from Gaza in 2005 but maintained a blockade of the territory after Hamas took power in 2007. The international community generally considers all three areas to be occupied territory.

At hearings in February, then-Palestinian Foreign Minister Riad Malki accused Israel of apartheid and urged the United Nations' top court to declare that Israel's occupation of lands sought by the Palestinians is illegal and must end immediately and unconditionally for any hope for a two-state future to survive.

UPSC Cracks Down On Probationary IAS Officer Puja Khedkar, Files FIR For Forgery

he Union Public Ser-Commission (UPSC) on Friday took a series of action, including registration of a police case, against probationary IAS officer Puja Khedkar for fraudulently availing attempts in the civil services examination by faking her identity.

The commission has also issued a show cause notice for cancellation of her candidature of the civil services examination-2022 and debarment from future examinations and selections.

Khedkar, a 2023 batch probationary Indian Administrative Service (IAS) officer, is accused of misusing power and privileges, by demanding perks and facilities she was not entitled for,

during her training in Pune District Collectorate in Maharashtra recently.

She is accused of bullying everyone around and of placing a red-blue beacon (indicating high-ranking official) atop a private Audi (a luxury sedan) car used by her that also had 'Maharashtra government' written on it during

After the Pune district collector flagged the matter, Khedkar was transferred to Washim District Collectorate in the Vidarbha region.

She was declared qualified in the civil services examination 2022. Based on the results declared last year by the UPSC. Khedkar was allocated the IAS and her home state Maharashtra as a cadre.

The UPSC has, therefore, initiated a series of actions against her, including criminal prosecution by filing a First Information Report (FIR) with the police authorities and has issued "a show cause notice for cancellation of her candidature of the Civil Services Examination-2022/debarment from future examinations/ selections. in accordance with the Rules of the Civil Services Examination-2022", it said.

MBBS Student Who 'Solved' **NEET-UG Papers Held**

he CBI Friday arrested a first-year MBBS student of Ranchi's Rajendra Institute of Medical Sciences (RIMS) for allegedly being part of a 'solver module' working with an engineer who had stolen the NEET-UG question papers, officials said.

Surabhi Kumari was taken into custody after two days of detailed questioning by the CBI, the officials said.

It is alleged that Kumari was the fifth member of the 'solver module' which was present in Hazaribagh in the morning of May 5, the NEET-UG examination day, to solve the paper stolen by Pankaj Kumar, they said.

Pankaj Kumar alias Aditya, a 2017-batch civil

engineer from the National Institute of Technology Jamshedpur (Jharkhand), who allegedly stole the NEET-UG paper from the NTA trunk in Hazaribagh.

The CBI has so far arrested 16 persons in connection with the NEET-UG cases taken over by it.

The RIMS, an autonomous institute under the Jharkhand government, was approached by the CBI earlier this week for questioning.

Forces Need To Shun Traditional Ways, Says Former DGP

SRINAGAR: The increased terror incidents in Jammu region has called for a revisit the strategy of security forces to deal with terrorists who are no longer staying in habituated areas but are preferring to remain inside forests where they have natural hideouts.

These foreign terrorists have the history of living in forests and they are trained like that to operate in Jammu and Kashmir. For the last few months many

foreign terrorists have entered Jammu region and they have resorted to unprovoked attacks on security forces in different areas including an attack on pilgrims

in Reasi district. But apart from Gundoh, where three terrorists were gunned down for the security forces in a daylong operation on June 26, terrorists continue to remain at large and forces haven't had much success in eliminating them.

Former Director General of Police (DGP) J&K, S.P. Vaid said that the "deep state of Pakistan has changed the strategy and terrorists operating in Jammu region have also come with a changed strategy." "Terrorists have changed their strategy and it is a fact that forces don't get much information about them. They come and attack forces like what happens in mountain warfare and flee from the area without suffering any casualty in the retaliation. No information comes from the public as they don't give any chance to people to collect information about them," he said.

"As terrorists have changed the strategy, forces also need to change and the traditional system will not work. Terrorists will ambush if forces

go around in vehicles on bad roads. Forces have to move on foot and give a surprise element to terrorists. What forces did in Kashmir can't work here and they have to change. Pakistan has given terrorists modern weapons like the M4 carbine of America with night vision which works as sniper and they have Chinese-armour piercing bullets or steel-coated bullets," the former DGP maintained.



he Jammu and Kashmir Public Service Commission (JK-PSC) has been facing intense criticism due to its failure to conduct examinations on time and a series of issues that have adversely affected countless aspiring candidates. These delays and irregularities have not only caused significant frustration among students but have also disrupted their career plans, undermining the credibility of the examination process and contributing to a broader inefficiency in the recruitment system.

Impact of Delays and Irregularities

Candidates preparing for JK-PSC exams invest months of hard work and dedication. However, the persistent uncertainty surrounding the examination schedule leads to a loss of motivation and productivity. These delays have resulted in a considerable backlog in the recruitment process, further straining the already limited job opportunities in the region. The irregularity in the examination schedule not only impacts the candidates' preparation but also their mental well-being, as the lack of a clear timeline creates an environment of continuous uncertainty.

The Age Limit Controversy

Recently, significant changes were introduced by J&K Public Service Commission, particularly concerning the age criteria for candidates. Before 2018, the age limit for general category students for appearing in JKPSC CSE was set at 37 years, which was in line with many other states across India. For instance, states like Punjab, Bihar, and Madhva Pradesh maintained an upper age limit of 37 years, while Harvana, Uttar Pradesh, and Rajasthan extended it to 40 years. This age criterion allowed a fair opportunity for aspirants, even if they faced interruptions or delays in their preparation.

However, the sudden reduction of the age limit to 32 years has created significant challenges for those who had already begun their preparation under the previous age limit. This abrupt change has diminished their chances and fostered a sense of injustice, particularly given the unique challenges faced by aspirants in Jammu and Kashmir. The frequent disruptions in the examination schedule have meant that many candidates, who have invested years in preparation, now find themselves excluded from opportunities due to age restric-



tions

Challenges Unique to Jammu and Kashmir

The distinct circumstances in Jammu and Kashmir, including frequent disruptions and delays in the examination schedule, have profoundly impacted candidates' preparation and attempts. Between 2015 and 2020, the JKPSC conducted only two civil services examinations. This infrequency, compared to the more regular schedules observed in other states and by the UPSC, meant that many candidates had limited opportunities to attempt the exam. Consequently, many candidates reached the age limit before they could fully utilize their permissible attempts.

From 2014 to 2023, JKPSC has conducted only four examinations. In contrast, the UPSC holds its examinations annually, providing candidates with regular opportunities to attempt the exam. The limited number of examinations conducted by JKPSC not only reduced the number of attempts available to candidates but also increased the pressure on those close to or those who have exceeded the age limit.

Comparison with UPSC and Other States

The UPSC has implemented changes to its examination pattern and age limits gradually, allowing candidates to adjust to new requirements. For instance, changes to the UPSC pattern over the years, including the introduction of CSAT and adjustments in the number of papers and subjects, were phased in to

minimize the impact on candidates. The maximum age limit for general category candidates was raised to 32 years, and the number of permissible

attempts was increased to six.

In contrast, JKPSC made sweeping changes to the examination pattern in one go, incorporating entire SRO 103 into a single update. This abrupt shift has not provided candidates with sufficient time to adapt, exacerbating the challenges faced by those who had been preparing under previous rules. The lack of a phased approach in implementing changes has intensified the difficulties for candidates who now face an uneven playing field.

Recommended Solutions

To address the current issues and restore fairness in the examination process, several measures need to be undertaken. Firstly, JKPSC should consider restoring the age limit to 37 years for general category candidates. This adjustment would align JKAS with the standards observed in other states and offer a fair opportunity for all aspirants, accounting for the unique challenges faced by candidates in Jammu and Kashmir.

Moreover, implementing a well-defined examination calendar and adhering to it in a timely manner would significantly benefit candidates. A clear schedule would enable candidates to plan their preparation and attempts more effectively, reducing uncertainty and stress. Consistency in the examination process is crucial

for maintaining candidates' motivation and ensuring a fair competitive environment.

Restoring the age limit to 37 years and allowing a reasonable number of attempts would not only rectify the current discrepancies but also uphold the principles of fairness and opportunity for all candidates. By addressing these issues, the JKPSC can contribute to creating a more equitable and supportive environment for civil service aspirants.

Conclusion

The sudden reduction in the age limit for JKAS aspirants has had a profound impact on many candidates who have been preparing under different assumptions and conditions. Addressing the issues related to age criteria, adherence to examination calendar, and alignment with UPSC standards is essential for creating a more just and supportive framework for civil service examinations. The Jammu and Kashmir Government and JKPSC must take these concerns seriously and implement necessary reforms to ensure a fair and efficient recruitment process that accommodates the unique challenges faced by aspirants in the region.

India Needs A Climate Stack

Society, business, and policymakers need data and models of climate change; building a tool that houses a common understanding can empower all stakeholders

igital public infrastructure (DPI) is a unique Indian innovation: it has revolutionised identity, payments, commerce, credit, among many sectors. The 2023 Economic Survey estimated that DPI could add between 60 and 100 basis points every year to India's economic growth potential.

DPI, as an interoperable, open, and inclusive system, can play a critical role in accelerating digital transformation. It is an infrastructure-based approach to achieve societal goals through an ecosystem (comprising technology, markets, and governance) built in public interest and leveraging private innovation.

Think of the payment apps built on top of the Unified Payments Interface or Know Your Customer applications built on the foundation of Aadhaar. Account aggregators Open Network for Digital Commerce and Open Credit Enablement Network have created the plumbing for financial and commercial transactions. It is now time to harness the versatile power of DPI: India needs a climate stack. The intense heatwave of north India this year or the devastating floods in Sikkim and Assam are only a few examples of climate events that significantly hit human and business activities. Four aspects emerge.

Physical changes: The physical impact of climate change-induced events ripples through

almost all segments of society: agriculture, businesses, homes, health, insurance, etc. The impact is seen in physical aspects like soil, houses, infrastructure, and supply chains.

Business and insurance: Businesses see revenue losses, stalled operations, increasing expenses, or investment requirements. Many areas are becoming uninsurable as insurers and reinsurers are unable to come to a common understanding of what a good model of future losses could look like, at a time when regulatory reporting requirements with respect to climate are increasing.

Public intervention: Governments are being called upon to make global commitments and develop policies to attract investments. This impacts fossil fuel tax revenues and increases climate investment incentives. Governments are now required to invest in resilience and face uninsured expenditure for immediate relief after a crisis.

Time: Climate change events in the short run require quick adaptation measures. In the longer run, citizens and communities must develop a resilient lifestyle, or in extreme cases find new places and ways to live. The short- and long-term impacts feed into each other, requiring high quality data and forecasting.

At its core, a climate stack puts together the many pieces of information that various participants are observing. This information can be historical: weather data like temperature, humidity, precipitation, and significant events, losses, etc.; current: soil conditions, insurance rates, type, fre-

quency, and impact of damage, etc.; future: model-based forecasts of weather events or their impact, or investments planned.

Many data points are already public, produced by authorities or agencies charged with their production and maintenance. Many current data points can be collected via a digital ecosystem of internet-of-things devices, subject to privacy and consent. Similarly, various agencies, largely in the public or academic sphere, are building forwardlooking models on climate impacts. These data and models are being developed independently. Enterprises are integrating aspects pertinent to them to power forecasting and action systems. For example, ITC, along with an ecosystem of partners, has created artificial intelligence-powered models to identify micro and near-term impact of weather patterns that are disseminated to stakeholders (farmers, officers, supply chain participants), with advice on contingent actions

Climate stack, a common platform with standardised vocabulary on climate terms and information, can create a shared language for all participants. It can foster reciprocal data relationships: all participants can receive input and offer data. This will help aggregate and develop learnings. A common understanding can power robust forecasting methodologies.

Unlike in traditional insurance where risks are empirically estimated through long-range data sets, climate risks are based on forecasts. Standard forecasting models can create a common definition and understanding of the risks being underwritten. With short-range and granular forecasting, such a tool can create a dispersed model of interventions.

The stack can also feed into various other initiatives: Gati Shakti in infrastructure, building codes in different locations, health-related digital interventions, or serve as the base for business reporting and supply chain planning. It can become a repository of India's carbon emissions and inventory of its credits. In global negotiations, an open and transparent stack can create further confidence in our interventions to peak and bend our carbon curve to zero. Models and forecasts built on the stack can offer alternative ways to achieving India's 2070 net zero goal.

Just like the DPI ecosystems, building a climate stack will require a grouping of climate stakeholders from engineering, social impact, financing, regulation, etc. to build common standards. It will require the convening power of the government, preferably in a separate entity like it was done for the the unique identification project. Cross-ministerial and cross-sectional support of the society will be required to make this

Unlocking the Potential of Kashmir's Creative Economy

The creative economy moves beyond being just a subset of tourism. The sector in itself has the potential to generate employment opportunities and help Kashmir's economy it

Traditionally, Kashmir's economy has relied primarily on two sectors: agriculture and tourism. These sectors have been the backbone of the economy of the region. Although important, there is another sector that has a lot of potential: the creative economy. The term "creative economy" refers to a sector of the economy that is based on human creativity and innovation. It includes Kashmir's unique art and craft, and is a separate industry that is sometimes misinterpreted as a mere extension of tourism. However, the sector holds immense potential for both economic growth and cultural preservation.

Kashmir's artistic heritage is centuries old, and it's crafts have always been famous worldwide. For instance, one famous art form is Kashmiri papier-mâché, introduced in the 15th century by King Ghiyas-ud-Din Zain-ul-Abideen. This intricate craft involves hand-painting detailed patterns on a papier-mâché base, creating items such as trays, book covers, and decorative boxes. The art form flourished and gained international popularity in the 19th century, especially through the trade in Kashmiri shawls, which were packed in "Karialamdani" hoxes

Similarly, copperware art in Kashmir is another example of the region's rich artisanal skills. This art was introduced after the decline of the Mughal era when Kashmiri metalworkers began creating beautifully carved vessels using "Meenakari", This art form is still found abundantly in the markets of the downtown area of Srinagar, where craftsmen continue to produce stunning copper items such as Kashmiri samovars, trays, lamps and utensils.

Thus, Kashmiri handicrafts are known around the world for their rich history and global recognition. However, the sector still faces significant challenges. Even though Srinagar was designated a UNESCO Creative City for Crafts and Folk Arts in 2021, the sector is struggling. The data from the Handicrafts Department shows a 45 percent decline as shawl exports have de-



creased from Rs 305.90 crore in 2018-19 to Rs 172.53 crore in 2020-21.

Efforts need to be made to promote as well as preserve traditional crafts. Such endeavours should involve providing local artisans with resources — especially virtual — to advertise their skills as well as to sell their products. An important part of such efforts would be access and use of e-commerce platforms to help local crafts reach a global market.

Second, the government can provide subsidies to artisans and small businesses,

helping them upscale their operations without high costs.

The government can also facilitate training programs to introduce new skills and techniques while preserving traditional methods. In this way, old and new techniques will be blended together, resulting in new interpretations of Kashmiri crafts. Lastly, it is important to protect the technique of Kashmiri crafts through intellectual property rights, to maintain the crafts' value and uniqueness.

There are examples of countries that

have made significant investments to develop their creative economies, such as establishing museums, architectural projects, and creating specialized programs and centers. These initiatives help create more jobs but also promote the arts and generate

For instance, the European Union launched the "Creative Europe" program in 2014, which includes the Cultural and Creative Sector Guarantee Facility. This facility supports entrepreneurs by providing insurance and encouraging them to finance cre-

ative businesses that in turn help employ over "12 million people".

On the other hand, in the Middle East, the United Arab Emirates has made significant progress in developing its creative economy. There was an agreement between the government of Abu Dhabi and Paris that led to the establishment of the Louvre Museum Abu Dhabi. The museum regularly holds masterclasses with local Emirati artists in areas such as papermaking, pottery and portraiture, as well as screenings of films by local directors. This highlights how museums can serve as platforms for showcasing and investing in the creative economy.

A similar policy could be adopted by the government to build museums and cultural centers dedicated to Kashmiri art and crafts. Local artisans could be invited to conduct workshops and masterclasses on traditional crafts. This can help preserve these skills and pass them on to younger generations.

The creative economy is more than just a subset of tourism; it is a standalone sector that has the potential to provide substantial employment opportunities and contribute to Kashmir's economic development. Handicrafts from Kashmir, including papermâché, copperware, embroidery, and Pashmina shawls, are in demand worldwide. By promoting traditional crafts, we can boost the economy and preserve the rich history of the region. Each handcrafted item tells a story of Kashmir's past, its people, and their artistic ability.

Therefore, while agriculture and tourism continue to play important roles in Kashmir's economy, the creative sector presents an opportunity for economic growth and cultural preservation. By investing in and promoting this sector, Kashmir can bolster its economic resilience while preserving its artistic heritage. Mysterious of Long Covid are Now Unraveling

Long COVID puzzle pieces are falling into place – the picture is unsettling

Since 2020, the condition known as long COVID-19 has become a widespread disability affecting the health and quality of life of millions of people across the globe and costing economies billions of dollars in reduced productivity of employees and an overall drop in the work force.

The intense scientific effort that long COV-ID sparked has resulted in more than 24,000 scientific publications, making it the most researched health condition in any four years of recorded human history.

Long COVID is a term that describes the constellation of long-term health effectscaused by infection with the SARS-CoV-2 virus. These range from persistent respiratory symptoms, such as shortness of breath, to debilitating fatigue or brain fog that limits people's ability to work, and conditions such as heart failure and diabetes, which are known to last a lifetime.

I am a physician scientist, and I have been deeply immersed in studying long COVID since the early days of the pandemic. I have testified before the U.S. Senate as an expert witness on long COVID, have published extensively on it and was named as one of Time's 100 most influential people in health in 2024 for my research in this area.

Over the first half of 2024, a flurry of reportsand scientific papers on long CO-VID added clarity to this complex condition. These include, in particular, insights into how COVID-19 can still wreak havoc in many organs years after the initial viral infection, as well as emerging evidence on viral persistence and immune dysfunction that last for months or years after initial infection.

How long COVID affects the body A new study that my colleagues and I published in the New England Journal of Medicine on July 17, 2024, shows that the risk of long COVID declined over the course of the pandemic. In 2020, when the ancestral strain of SARS-CoV-2 was dominant and vaccines were not available, about 10.4% of adults who got COVID-19 developed long COVID. By early 2022, when the omicron family of variants predominated, that rate declined to 7.7% among unvaccinated adults and 3.5% of vaccinated adults. In other words, unvaccinated people were more than twice as likely to develop long COVID.

While researchers like me do not yet have concrete numbers for the current rate in mid-2024 due to the time it takes for long COVID cases to be reflected in the data, the flow of new patients into long COVID clinics has been on par with 2022.

We found that the decline was the result of two key drivers: availability of vaccines and changes in the characteristics of the virus – which made the virus less prone to cause severe acute infections and may have reduced its ability to persist in the human body long enough to cause chronic disease.

Despite the decline in risk of developing long COVID, even a 3.5% risk is substantial. New and repeat COVID-19 infections translate into millions of new long COVID cases that add to an already staggering number of people suffering from this condition.

Estimates for the first year of the pandemic suggests that at least 65 million peopleglobally have had long COVID. Along with a group of other leading scientists, my team will soon publish updated estimates of the global burden of long COVID and its impact on the global economy through 2023.

In addition, a major new report by the National Academies of Sciences Engineering and Medicine details all the health effects that constitute long COVID. The report was commissioned by the Social Security Administration to understand the implications of long COVID on its disability benefits.

It concludes that long COVID is a complex chronic condition that can result in more than 200 health effects across multiple body systems. These include new onset or worsening:

ning: Heart disease

Neurologic problems such as cognitive



impairment, strokes and dysautonomia. This is a category of disorders that affect the body's autonomic nervous system – nerves that regulate most of the body's vital mechanisms such as blood pressure, heart rate and temperature.

Post-exertional malaise, a state of severe exhaustion that may happen after even minor activity — often leaving the patient unable to function for hours, days or weeks

Gastrointestinal disorders

Kidney disease metabolic disorders such as diabetes and hyperlipidemia, or a rise in bad cholesterol

Immune dysfunction

Long COVID can affect people across the lifespan from children to older adults and across race and ethnicity and baseline health status. Importantly, more than 90% of people with long COVID had mild COVID-19 infections.

The National Academies report also concluded that long COVID can result in the inability to return to work or school; poor quality of life; diminished ability to perform activities of daily living; and decreased physical and cognitive function for months or years after the initial infection.

The report points out that many health effects of long COVID, such as post-exertional malaise and chronic fatigue, cognitive impairment and autonomic dysfunction, are not currently captured in the Social Security Administration's Listing of Impairments, yet may significantly affect an individual's ability to participate in work or school.

A long road ahead

What's more, health problems resulting from COVID-19 can last years after the initial infection.

A large study published in early 2024 showed that even people who had a mild SARS-CoV-2 infection still experienced new health problems related to COVID-19 in the

third year after the initial infection.

Such findings parallel other research showing that the virus persists in various organ systems for months or years after CO-VID-19 infection. And research is showing that immune responses to the infection are still evident two to three yearsafter a mild infection. Together, these studies may explain why a SARS-CoV-2 infection years ago could still cause new health problems long after the initial infection.

Important progress is also being made in understanding the pathways by which long COVID wreaks havoc on the body. Two preliminary studies from the U.S. and the Netherlands show that when researchers transfer auto-antibodies – antibodies generated by a person's immune system that are directed at their own tissues and organs – from people with long COVID into healthy mice, the animals start to experience long COVID-like symptoms such as muscle weakness and poor balance.

These studies suggest that an abnormal immune response thought to be responsible for the generation of these auto-antibodies may underlie long COVID and that removing these auto-antibodies may hold promise as potential treatments.

An ongoing threat

Despite overwhelming evidence of the wide-ranging risks of COVID-19, a great deal of messaging suggests that it is no longer a threat to the public. Although there is no empirical evidence to back this up, this misinformation has permeated the public narrative.

The data, however, tells a different story. COVID-19 infections continue to outnumber flu cases and lead to more hospitalizationand death than the flu. COVID-19 also leads to more serious long-term health problems. Trivializing COVID-19 as an inconsequential cold or equating it with the flu does not align with reality.

'Siblings Of Autistic Children 20% More Likely To Have Condition'

iblings of children with autism are at a 20 per cent higher chance being diagnosed with the condition, compared to those without the neurodevelopmental disorder, a new research has found.

Other factors such as the sex of the first autistic child and that of the later-born were also found to influence the chances of the disorder recurring within a family.

Autism is marked by repetitive behaviour, along with affected social communication.

"If a family's first autistic child was a girl, they were 50 per cent more likely to have another child with autism than if their first autistic child was a boy," said corresponding author Sally Ozonoff, a professor at the University of California Davis, US.

"This points to genetic differences that increase recurrence likelihood in families who have an autistic daughter," said Ozonoff.

The study, published in the journal Pediatrics, was conducted in 1,600 infants



from across the US, Canada, and the UK, all of them having an elder autistic sibling. The infants were evaluated for autism from the age of six months to three years and data was collected from

2010-2019. "A total of 20.2 per cent of siblings developed autism spectrum disorder, which is not significantly higher than the previously report-

ed rate of 18.7 per cent," the authors wrote, referring to their 2011 study which included 664 children.

Furthermore, the searchers found that if the sibling of an autistic child was a boy, he was nearly twice as likely as a girl to be on the spectrum.

"The familial recurrence rate if the new baby was a boy was 25 per cent, whereas

it was 13 per cent if the new

baby was a girl," said Ozonoff. This is in line with the fact that boys are diagnosed with autism about four times as often as girls in general," the researcher added.

The study also found that a child having multiple autistic siblings is at a higher risk of having the condition (37 per cent), compared to a child having only one autistic sib-

ling (21 per cent).

The findings regarding recurrence of autism in a family should help them plan for and support future children, along with reassuring providers who are counselling and monitoring development, according to Ozonoff.

However, it is critical that the findings be replicated, as that may indicate that there are social factors of health which can lead to higher rates of autism in families, she said.

Therefore, more research is needed, said Ozonoff.

Plant-Based Oils Linked With Lower Heart Disease Risk, Blood Fat Analysis Confirms

Analysing blood fat has helped researchers confirm with "even more certainty" that replacing butter and coconut oil with plant-based fats, such as groundnut and olive oils, can lower risk of metabolic diseases. In their new study, the researchers used lipidomics, which helps analyse fats in the blood, or lipids. They showed that it is possible to measure dietrelated changes and directly link them to the risk of developing heart disease and diabetes. Their findings are published in the journal Nature Medicine.

"Our study confirms with even more certainty the health benefits of a diet high in unsaturated plant fats, such as the Mediterranean diet, and could help provide targeted dietary advice to those who would benefit most from changing their eating habits," said senior author Clemens Wittenbecher, a research leader at Chalmers University of Technology, Sweden.

Mediterranean diet is rich in nuts, fruits and vegetables, along with whole grains and legumes. The dishes are mainly

cooked in olive oil and also include a moderate intake of fish, poultry, dairy and eggs. Red meat and sweets are rarely consumed.

A part of this research, involving 113 participants, was conducted in a diet-related study at the University of Reading, UK.

For 16 weeks, one group consumed a diet high in saturated animal fats, while the other group followed a diet rich in unsaturated plantbased fats. Blood samples were analysed using lipidomics to identify specific lipids reflecting the diets each participant consumed.

'We summarised the effects on blood lipids with a multi-lipid score (MLS). A high MLS indicates a healthy blood fat profile and a high intake of unsaturated plant fat and low intake of saturated animal fat can help achieve such positive MLS levels," said first author Fabian Eichelmann from the German Institute of Human Nutrition Potsdam-Rehbruecke.

The blood fat results were linked with the occurrence of cardiovascular disease and type 2 diabetes, data for which were taken from previous large-scale observational studies.

No Solid Evidence To Suggest Massage Effective For Pain: Researchers

"No high-certainty evidence" that massage is effective in treating pain, despite "hundreds of clinical trials and dozens of previous scientific reviews on the topic", researchers said in

According to the findings, published in The Journal of the American Medical Association (JAMA) Network Open, reviews providing moderate- or high-certainty evidence that massage was superior to other pain therapies, such as opioids, were rare.

Massage therapy involves using hands to manipulate the soft tissues of skin, muscles and ligaments for treating pain, and is usually delivered by certified therapists.

Despite massage therapy's popularity and long history in practice, evidence regarding its benefits remain limited, according to the researchers, including those from the University of California, US.

Analysing 129 reviews published since 2018, they found that of these, only 41 used a formal method to rate the strength of evidence used to show that massage therapy helped relieve painful health conditions in adults.

Of the 41, the authors focused on 17 relating to 13 different health conditions, such as back pain and cancer-related pain.

"Across these reviews, no conclusions were rated as high certainty of evidence," the authors wrote in the study.

While the evidence presented in seven of the 17 reviews were rated as "moderatecertainty," others were rated as "low- or very low-certainty," according to the study.

Evidence of moderate certainty came from reviews showing massage therapy to have "beneficial associations with pain," the

"More high-quality randomised clinical trials are needed to provide a stronger evidence base to assess the effect of massage therapy on pain," they wrote.

'Kashmir Holds A Promising Future For Competitive Exams'

Salman Shahid, an IIT Kharagpur graduate, chose to prioritize education in Kashmir over lucrative corporate roles. Along with other two partners, he established RISE, a private coaching centre in Srinagar, to provide quality JEE coaching to tens of hundreds of students from across the valley. Staffed exclusively by IIT graduates, RISE boasts the highest number of students passing the JEE Advanced, the world's second most difficult exam.
 In a detailed conversation with Farooq Shah, Mr. Salman discusses the challenges they face, their innovative teaching methods, and the holistic support systems that ensure the success and well-being of their students.

Excerpts of the interview.

Could you share your professional background and personal journey? What motivated you to partner with RISE Coaching Centre, particularly focusing on preparing students for the highly competitive JEE exams?

scrambled to deal with the fallout. Thousands of flights were canceled and tens of thousands were delayed around the world, leading to long lines at airports in the U.S., Europe and Asia. Airlines lost access to check-in and booking services in the heart of the summer travel season.

Several local TV stations in the U.S. were prevented from airing the news early Friday, and some state and local governments reported problems at courts, motor vehicles departments, unemployment agencies and other offices.

Affected hospitals had problems with appointment systems, forcing them to suspend patient visits and cancel some surgeries.

Alison Baulos said her 73-year-old father's emergency heart surgery in Paducah, Kentucky was canceled Friday morning because of the tech outage, leaving her family scared and

"So if anything happens, it would be as a result of not having the surgery this morning," Baulos said in an interview. She said her father was waiting at Baptist Hospital to find out what will happen next. A phone message left with the hospital was not immediately returned.

Elsewhere, people experienced minor inconveniences, including trouble ordering ahead at Starbucks, causing long lines to form at some of the coffee chain's stores.

reminder of disturbing vulnerability

Cyber expert James Bore said real harm would be caused. "All of these systems are running the same software," Bore said. "We've made all of these tools so widespread that when things inevitably go wrong — and they will, as we've seen — they go wrong at a huge scale."

The head of Germany's IT security agency, Claudia Plattner, said "we can't expect a very quick solution." A forecast for when exactly all systems will be up and running is difficult, but "it won't be hours," she added.

CrowdStrike said in a recording on its customer service line that the problem was related to "the Falcon sensor," referring to one of its products used to block online attacks. The company says it has 29,000 customers.

In an interview on NBC's "Today Show," CrowdStrike CEO George Kurtz apologized, saying the company was "deeply sorry for the impact that we've caused to customers, to travelers, to anyone affected by this, including our companies.'

"We know what the issue is" and are working to remediate it, Kurtz said.

Shares of the company, which is based in Austin, Texas, fell nearly 10% on Friday. Microsoft's stock price fell more than 3%.

Though the outage's impact could be felt far and wide, the forecasting irm Capital Economics said it was likely to have little impact on the world economy.

Cybersecurity experts said those affected by the outage also needed to be wary of bad actors reaching out claiming they can help. "Attackers will definitely prey on organizations as a result of this," said Gartner analyst Eric Grenier.

Air travel delayed everywhere

Most airlines attributed the problems to their booking systems. Thousands of flights were affected in the U.S. alone, though by late morning on the East Coast airlines said they were beginning to mitigate problems and resume some service.

Airlines and railways in the U.K. experienced long wait times. And airports across Europe suspended landings or halted takeoffs for several hours due to difficulties in checking in passengers.

Saskia Oettinghaus, a member of the German Olympic diving team, was among those stuck at the Berlin

Other athletes and spectators traveling to Paris were delayed, as were their uniforms and accreditations, but Games organizers said disruptions were limited and didn't affect ticketing or the torch relay. Broadcasters go dark, surgeries

delayed

In Australia, national news outlets – including public broadcaster ABC and Sky News Australia — were unable to broadcast on their TV and radio channels for hours. Some news anchors went on air online from dark offices, in front of computers showing blue error screens. Internet and phone providers were also affected.

In the U.S., KSHB-TV in Kansas City, Missouri, aired Scripps News instead of local news until about 5:35 a.m., the stations said on its website. IT teams and engineers worked through the night to resolve the glitch, the station said. Other local stations owned by Scripps reported similar problems, though Scripps spokesman Michael Perry said in an email early Friday that 90% of stations were able to air local

Hospitals in different countries also

reported problems.

Britain's National Health Service

said the outage caused problems at most doctors' offices across England. NHS England said in a statement said the glitch was affecting the appointment and patient record system used across the public health system.

At Mass General Brigham, the largest health care system in Massachusetts, all scheduled non-urgent surgeries, procedures, and medical visits were canceled Friday because of the outage, according to a spokesperson. Emergency departments remained

unavailable for passengers across airports, led to further chaos.

They are doing it manually so obviously it will take time. They are taking about 30-40 minutes to process a passenger's ticket. How will they do it for all, They don't have a reply," said a passenger.

IndiGo has cancelled around 200 flights, however, the number of delayed flights can't be quantified, said

"The Microsoft/CrowdStrike outage has taken down most airports in India. I got my first hand-written boarding pass today," said IndiGo passenger Akshay Kothari in a post on X displaying his manual boarding pass.

According to preliminary data put out by aviation analytics firm Cirium on the global IT disruption in the afternoon, 56 flights were cancelled out of 3,652 flights scheduled from Indian destinations. This does not include inbound flights to India.

Union Civil Aviation Minister Ram Mohan Naidu assured the passengers that the ministry and Airports Authority of India (AAI) are actively managing the situation using manual methods to ensure minimal disruption.

"We have instructed all airlines and airport authorities to keep passengers informed about their flight status and provide necessary assistance," Naidu

Minister of State for Civil Aviation Murlidhar Mohol said the ministry and aviation safety regulator DGCA are

closely monitoring the situation. The minister said that instructions have been issued to private airlines to promptly inform passengers about the disruptions.

The impact was more on passengers flying out of high-density airports like Delhi, Mumbai, Bengaluru and

"A global outage with the Navitaire Departure Control System (DCS) has been affecting operations of some airlines across their network, including BLR Airport since 10:40 IST on July 19, 2024. Indigo, Akasa, and SpiceJet in T1 and Air India Express in T2 are among the impacted airlines," a Bengaluru airport spokesperson said.

Common Use Terminal Equipment (CUTE) and Common Use Self Service (CUSS) systems are also experiencing disruptions the airport operator said adding that in response to this situation, IndiGo, Air India Express, SpiceJet and Akasa have taken proactive measures by initiating manual check-ins to ensure minimal disruption to passengers and flight schedules.

"Due to a major global system outage, all gate screens at DEL (Delhi airport) blank. Flights are being held at the gate. Some gates boarding pax (passengers) and holding on board, some flights holding pax at gate itself, which is better. Seems to be impacting many airports and airlines," Sanjiv Kapoor, executive vice-president (strategies) of Saudia Airlines and former CEO of Jet Airways 2.0, said in a

post on X. Hyderabad's Rajiv Gandhi International Airport saw as many as 23 flights -- 12 departures and 11 arrivals -- including IndiGo's flights to Visakhapatnam, Tirupati, Ahmedabad and Bengaluru

being cancelled. 'We are closely working with all our stakeholders to minimise the inconvenience to our flyers. You may please get in touch with the airline concerned for updates on your flight information. We thank you for your support and un-derstanding," the airport, run by GMR, said in a post

on social media platform X. Earlier in the day, IndiGo said its systems were impacted by the Microsoft outage and during this time, booking, check-in, access to boarding pass, and some flights were impacted.

Services of budget carrier Akasa were also impacted.

"Due to infrastructure issues with our service provider, some of our online services, including booking, check-in and manage booking services will be temporarily unavailable. Currently we are following manual check-in and boarding processes at the airports," Akasa said in a

post on X.

SpiceJet also said that it was experiencing technical challenges with the service provider affecting online services including booking, check-in, and managing booking functionalities.

Other Services Hit In India Microsoft Apps

The users were also unable to access various Microsoft apps and services. Microsoft 365, Microsoft Team, and

Microsoft Azure were among the services that were affected.

Instagram, Amazon According to the outage tracking website Downdetector, some users also complained that they were facing issues while using the following apps: Instagram, Amazon, Gmail, the State Bank of India, ICICI Bank, Bank of India, and HDFC Bank.

Windows users Millions of Windows users globally encountered the Blue Screen of Death, leading to computer shutdowns or restarts. In some instances, computers repeatedly restarted resulting in users losing unsaved data as the screen displayed the message: "Your PC ran into a problem and needs to restart. We're just collecting some error info, and then we'll restart for you.'

Indian Financial Systems Largely

Unaffected The Indian financial and payments systems remained largely unaffected by the Microsoft services outage, though about 10 banks and NBFCs faced minor disruptions which have

either been resolved or are being fixed. The Reserve Bank said it has made an assessment of the impact of this outage on its regulated entities.

"Critical systems of most banks are not in cloud and further, only a few banks are using the CrowdStrike tool. Our assessment shows that only 10 banks and NBFCs had minor disruptions which have either been resolved or are being resolved," RBI said in a statement.

Overall, it said the Indian financial sector in the Reserve Bank's domain remains insulated from the global

Meanwhile, SBI Chairman Dinesh Kumar Khara told PTI that "We (SBI) are all fine". SBI is the country's largest lender and commands nearly 25 per cent market share.

National Payments Corporation of India (NPCI) chief executive Dilip Asbe too said the country's payments architecture, including the widely popular Unified Payments Interface, has been unaffected.

HDFC Bank, the biggest among the private sector lenders, also said that it has not faced any impact of the outage.

"Our systems are unaffected by the global outage. There is no impact on banking operations," said Ramesh Lakshminarayanan, the group head for information technology at HDFC Bank.

Officials at ICICI Bank and Axis Bank also said that their systems were working fine and showing no impact

The RBI said it has issued an advisory to all of its Regulated Entities for taking necessary steps to remain alert and ensure operational resilience and continuity.

A widespread Microsoft outage disrupted flights, banks, media outlets and companies around the world on

due to a recent update received in the product.

The concerned Windows hosts are experiencing a "Blue Screen of Death (BSOD)" related to Falcon Sensor.

"The issues occurred in the latest update of CrowdStrike and the changes have been reverted by the CrowdStrike Team," said the cyber security agency, suggesting steps for customers to miti-

Meanwhile, former Union Minister

Rajeev Chandrasekhar said that he hopes Microsoft will restore its services soon. "Microsoft 365 and Microsoft Suite are used by millions of Indians. Any disruption on this platform disrupts the business and operations of many companies. The government will work with Microsoft to ensure that services are restored as soon as possible," he said.

Mischievous Plea

said it was dismissing the application and imposing a cost of Rs 1 lakh on Parmar to "prevent the filing of such mischievous and frivolous petitions in future".

The fine amount will have to be deposited in the Advocates' Welfare Fund within two weeks, it added.

Advocate Monika Kohli, appearing for Sinha, argued that the impleadment of the Lieutenant Governor of Jammu and Kashmir by name was not permissible in view of Article 361 (4) of the Constitution.

The tribunal, while accepting this contention, said it was not clear how Parmar could claim reliefs related to his service conditions from the authorities in their private capacity.

"It is also seen that the applicant has unnecessarily impleaded the Cabinet Secretary of India and Secretary, DoPT as a party in the O.A. by name, though no allegations have been made by the applicant against them in the application," the order said.

The tribunal said no civil proceedings can be instituted against the Lt Governor, until the expiration of two months next after a notice in writing has been delivered to him, stating the nature of the proceedings, the cause of action therefore, the name, description and place of residence of the party by whom such proceedings are to be instituted and the relief which he claims.

"The applicant has failed to produce any proof or evidence, that such a notice has been made and delivered. Hence, this tribunal is not inclined to grant any relief to the applicant to this extent," it said.

Notably, Commander 268 infantry brigade, Keran sector, Brigadier NR Kulkarni earlier on July 15 said that during the last few weeks, there have been intelligence inputs regarding terrorists trying to infiltrate the LoC along the Keran sector. They intended to carry out sabotage and subversive activities, aiming to disturb normalcy, particularly the ongoing Amarnath Yatra, he said.

Pertinently, security forces earlier on July 15 said they eliminated three hardcore foreign terrorists, who tried to infiltrate the LoC in the Keran sector. They recovered a large quantity of war-like stores, including 3 AK series rifles along with magazines, 4 pistols and a grenade during the searches in the area.



TIFA has put off a decision Γ on a Palestinian bid to suspend Israel from international soccer until after the Paris Olympics, saying both parties had requested more time to submit their positions.

The Palestinian Football Association (PFA) had submitted a proposal to suspend Israel in May over the war in Gaza, with FIFA ordering an urgent legal evaluation and promising to address it at an extraordinary meeting of its council in July.

Soccer's global governing body said on Thursday the legal assessment would now be shared with its council by Aug. 31.

"Following requests for extension from both parties to submit their respective positions, duly granted by



FIFA, more time is needed to conclude this process with due care and completeness," FIFA said on its X account.

The Paris Olympics will be held from July 26-Aug. 11, with group matches for the men's soccer tourna-

ment starting on July 24. Israel qualified for the men's tournament and play Mali, Paraguay and Japan in the group phase.

A report this week by lawyers who specialise in international law called on FIFA to ban Israel for violating several of FIFA's statutes related to human rights and humanitarian objectives.

Since an Oct. 7 cross-border raid by militant group Hamas that Israel says killed more than 1,200 peo-

ple. Israel's Gaza offensive has left more than 38,000 Palestinians dead, according to Gaza health officials. Critics have accused Isra-

el of committing genocide against Palestinians, which Israel denies.

'Joyful, Daring': Paris Promises **Unforgettable Olympics Ceremony**

PARIS: The Paris Olympics' opening ceremony next Friday will be a joyful, daring and atypical show in which artists and athletes together celebrate Paris, France and the Games alongside the river Seine, the ceremony's organisers said.

Unlike for previous Olympics, the Paris 2024 opening ceremony will not take place in a stadium. Instead, dozens of boats will carry thousands of athletes and performers on a 6km route along the Seine.

We know the importance of the opening ceremony for the Olympic Games. It's key for the athletes, it's key for the country which organizes it," Tony Estanguet, the head of the Paris Olympics Organising Committee, told reporters.

'That's why, from the start, we have been very ambitious because we really want this opening ceremony to embody all the ambition of Paris 2024: daring, atypical Games, which shows the best of France."

Details including some of the artists taking part, who will last carry



the torch and light the Olympic cauldron to mark the start of the Games, have been kept secret, and the ceremony's artistic team said they had been rehearsing in private to keep it all under wraps.

But what is known is that there will be a floating parade, departing from Austerlitz bridge, sailing by Notre-Dame de Paris cathedral and arriving near the Eiffel Tower, with the show also using nearby monuments and mixing music, light and

More than 300,000 spectators will be watching from the riverbanks, with hundreds of millions more expected to watch on TV or on social media.

The Olympics will run from July 26 to Aug. 11, while the Paralympics will be held from Aug. 28 to Sept. 8.
