Srinagar: After relaxing temperatures, the mercury has increased yet again across Jammu and Kashmir on Saturday with twin places of the Valley including Qazigund and Kokernag recording heatwave as the maximum temperatures settled above 5 degrees than the normal temperature.

Qazigund and Kokernag recorded heatwave today where the mercury settled at 33.4 degree Celsius and 33.0 degree Celsius respectively.

However, Srinagar, the summer capital of Jammu and Kashmir, witnessed a maximum temperature of 34.4 degree Celsius, which was 4.3 degree above than normal and just 0.2 degrees below than entering into the heat wave.

## **HC Quashes FIR Registered On Trial Court Orders**

Says Court Is Empowered To Proceed Against Offender Under CPC

Srinagar: The High Court of J&K and Ladakh has quashed an FIR ordered to be registered by a trial court for violation of its orders in a civil matter.

Based on an order on February 29 this year by a court in Kupwara in a civil suit regarding immovable property at Trehgam, police had filed the FIR for

commission of offences under erstwhile IPC sections of 188 (violation of an order issued by a public servant), 427 (mischief) and 447 (criminal trespass) on 3 March this year.

"Law is settled that a Court is empowered to take cognizance of disobedience the or breach of an


granted by it and to proceed against the offender for such disobedience or breach under the provisions of Order 39 Rule 2-A

far in joining the emerging Third Front at the Centre. "The final decision will be taken by the executive committee which is meeting on July 17," he said. Criticising the coalition government on the law and order situation, Dr. Abdullah said that all sorts of slogans were being used to fool the public while no attention was being paid to development and the multitude of issues facing the people.

he idea of the article came through after I read the article in this newspaper about the advent of the usage of AI tools to write articles, papers and many other things these days. Having used the tool myself, a straightforward query may come to my mind: Who is the copyright holder of the articles written by AI? ChatGPT, because ChatGPT wrote the output? Or is it OpenAI because this output was produced by their software? Me, Since I created the prompt that produced

For a predetermined period of time, the right owner—a legal person—is granted exclusive rights by intellectual property rights, including copyright and related rights. These rights permit the protection of the work, creation, or innovation and permit the licensing of royalties to be collected. The owner of a right must fulfill the legal requirements in order for it to be awarded. As a signatory to all significant international treaties and accords pertaining to the protection of intellectual property rights, India provides sufficient legal protection for works created by legal entities under the Copyright Law and utilizes the Patent system to safeguard inventions. As a result, the Indian IPR Regime does not need to establish a distinct category of rights for AI and associated technolo-

The Copyright Act of 1957, which protects authors and creators of works, governs copyright in India. The Act specifies authorship according to the kind of work, encompassing sound recordings, cinematographic films, musical compositions, theatrical works, literary works,

Taking a few of them first, the Copyright Act specifies that the author of a literary or theatrical work is the one who really creates the work. The author of literary works created by computers is recognized by the Copyright Act as the person who created the work using a computer. Nevertheless, the Copyright Act is silent on AI-generated works; nevertheless, if we attempt to read the extant provision—Section 2(d)(vi) of the Copyright Act, 1957—we find that "author" is defined as "the person who causes the work to be created.'

This clause can be read liberally to encompass those who give an AI system the information or instructions it needs to produce computer-generated art. The author of a work should be the "first owner" of the copyright, according to the Copyright Act, which also addresses copyright ownership. The person who generates the work by providing input or instructions will be considered the first owner of the copyright for an AI-generated work, as per the aforementioned sections. As a result, these sections recognize the authors of the final content—those who supply data to AI tools or provide them instructions—and their contributions.

#### The Current position of law

So, let us circle back to the question, who really owns the copyright to the content generated by various AI tools?

#### ChatGPT?

Because Indian copyright law requires the person claiming the copyright to be a natural person, ChatGPT cannot be deemed the author. According to Section 17 of the Indian Copyright Act, authors are only individuals. Generally speaking, only individuals are included in the definition of "persons," but organizations like corporations may be granted copyright (Section 18) by an in-

dividual for a finite amount of time upon agreement. According to Section 17, the original copyright of the product will always belong to the human, barring a contract to the contrary. Furthermore, it is obvious that the act's design is human-centric. For instance, the claimant's name, nationality, and address must be included on the copyright registration application.

#### Al developer?

The entirety of the developers' claim would be governed by their "Terms-of-Use" guidelines. Unless a contract specifically states otherwise, a developer who states that they would own the rights to work produced by their AIs will own the copyright for that work. Nevertheless, the "Terms-of-use" for the majority of widely used AIs, such ChatGPT/ BingChat, do not assert copyright over the results produced. It does not seem reasonable, even on the surface, to give developers the right to claim copyright ownership of items created by AI. When someone uses Microsoft Paint to create a painting, the situation is similar in that Microsoft cannot legitimately claim copyright on the output

This is where the intriguing interaction between the law and generative-AI begins. In 1994, the Indian Copyright Act was modified to take into consideration scenarios in which computer-generated artistic creations could occur. The amendment added a new section to the legislation, Section 2(d)(vi), which states clearly that the person who caused the developIndia has the opportunity to set the standard for creative policy development that strikes a balance between the needs of users, artists, and AI developers

ment of computer-generated works is the author of those works.

Since, the "prompt-giver" is the one who is generating the work, one could be tempted to conclude that this clarifies the status of law in India. But merely typing a single line at a prompt does not provide copyright protection for a work. An author is entitled to protection under copyright law if their creative work satisfies the requirements necessary to qualify as a "original" product.

The "sweat of the brow" theory, which holds that an author obtains copyright rights based on basic diligence and effort put in by them, is the lowest bar for awarding copyright protection to the Author (this criterion is not applicable in India). The University of London Press Ltd. v. Tutorial Press Ltd. case, in which a publisher assembled examination materials made available by the University of London, is crucial to comprehending

The university filed a challenge, claiming that it violated the copyright of the professors who invested their time and expertise in writing those articles. The publisher countered that the papers could not be protected by copyright because they were not "original" because they were derived from an already-existing body of information. The court decided that, despite the fact that the paper was developed using pre-existing knowledge, it nonetheless qualifies for copyright protection because some effort

In India, when deciding on the "originality" requirement for India, the Supreme Court took into account several criteria. The Canadian standard was chosen, which stipulates that the piece in question ought to be the result of the author's judgment and talent. Additionally, the use of judgment and skill shouldn't be reduced to the point where it can only be done mechanically. This also restates the argument against protecting an output produced by a single line prompt.

Copyright is deemed to apply too stringently to novelty, and there is no justification for AI-generated works to be subject to a lower bar. Therefore, regardless of whether they were taken from previously existing bodies of knowledge, AI-generated works can satisfy the necessary standard of "originality" in India.

In just a few months, generative AI

has become inescapably ingrained in our daily lives. It will undoubtedly expand more dramatically as a result of recent advancements and the entry of major tech companies like Google and Amazon. Since a large portion of invention and creativity going forward would require AI aid to make chores easier, India's existing policy of not extending copyright protection to any AI-generated material will no longer be possible.

The complex and fascinating landscape that arises from the junction of AI and copyright in India calls for careful regulation and a nuanced understanding. With AI technology developing at a rapid pace, conventional ideas of authorship and intellectual property rights are being challenged by its capacity to produce original work. To ensure that both human creators and AI-generated works are sufficiently protected, India's current legal structure needs to change to meet these difficulties.

At this pivotal moment, India has the opportunity to set the standard for creative policy development that strikes a balance between the needs of users, artists, and AI developers. Not only must current laws be changed, but stakeholders like legislators, legal professionals, technologists, and the creative community must also be encouraged to engage in cooperative discourse.

The ultimate objective should be to establish a legal framework that protects the rights of all parties concerned while promoting innovation. By doing this, India can guarantee that society reaps the greatest benefits from AI while preserving a just and equitable system for the protection of intellectual property. Although the road ahead is difficult, India may successfully negotiate the difficulties of AI and copyright with careful consideration and preemptive action.

## India Must Bring In Innovators

'ndian innovation powers the digital world. India has shipped more software than Saudi Arabia exports oil – worth over \$200 billion in a year. Over 1 million engineers in the US are of Indian origin. Over 10% of the Fortune 500 companies have Indian-origin chief executive officers (CEOs). Eric Garcetti, the US envoy to India, joked that one cannot become a CEO in America unless they are from India. A study of US unicorn founders by Ilva Strebulaev of Stanford Graduate School of Business showed how Indians are the largest proportion of non-US-born founders.

This innovative heft has propelled India to become the third-largest startup ecosystem in the world in terms of capital raised, unicorns, and number of start-ups. Yet, a dirty secret exists in the Indian start-up ecosystem — over half of India's unicorns are not Indian companies, but foreign companies run by Indians. The Flipkart sale to Walmart, which is the largest start-up exit from India, was not of an Indian company. Flipkart was and is still headquartered in Singapore,

though the team and management sit in India. India is at risk of becoming a land of subsidiaries, not start-ups.

The reasons for founders to choose to enter the Indian market though a foreign country are manifold, beginning with incorporating a company where founders run the risk of their company names being rejected for frivolous reasons. Our compliance demands for raising capital are onerous and require multiple forms to be filed and approved, with the choices of securities severely restricted. India is also unique in taxing capital investments as income, a tax colloquially known as angel tax.

Though laundering unaccounted funds is a global issue, no other country has sought this innovation of taxing investments as income. The Foreign Exchange Management Act regulations and enforcement make it impossible to launch global software as a service companies from India, where every credit from a foreign source requires invoices in triplicate before the bank processes the transaction. Even exits as share swaps, the most common exit avenue for start-ups, is taxed in India, despite no cash exchanging hands. India also taxes

eign capital, and investments in start-ups at twice the rate of investments in listed companies. The Economic Survey 2022-23 covers the reasons for flipping in great detail and urges the government to look at remedying these issues.

Despite these frictions, India is still the third-largest start-up ecosystem in the world. The ability of Indian entrepreneurs to build world-class products despite such odds is commendable.

The situation has improved in the last 10 years, with further reforms in tow. India crossing \$2,000 in terms of per capita GDP in 2019 marks an inflection point where spending shifts from sustenance to consumption. This happened in the US in the 1950s, Germany in the 1960s, Japan in the 1970s, and China in the early 2000s. Regulators such as the Securities and Exchange Board of India and International Financial Services Centres Authority (IF-SCA) have created regulated vehicles for pooling capital into private assets such as start-ups, creating an over \$100 billion investing industry through alternative investments funds. This has allowed rupee capital to finally invest in start-ups, though the legislated subordination of private market investing to listed market investing in terms of tax rates and holding periods should be removed. Various committees have been formed to reevaluate our existing laws and rationalise them further. Indian retail investors are pumping close to Rs 19,000 crore monthly as systematic investment plans into the stock market and are lapping up initial public offerings through double-digit oversubscriptions.

Many start-ups that shifted out of India over the last 15 years now wish to come back to the country, but lack a mechanism to do so. PhonePe was unique in paying over \$1 billion in taxes for moving back to India from Singapore, but no other start-ups have the balance sheet to

This is why the scheme mentioned in the "Onshoring Indian innovation to GIFT IFSC" report released in August 2023 is crucial. It lays out a framework based on the scheme to redomicile funds investing in India but based in other countries to shift to GIFT International Financial Services Centre (IFSC) in a tax-free manner. GIFT IFSC has a unified regulator in the form of the IFSCA, allows start-ups to maintain accounts in US dol-


lars, and has a host of tax benefits to attract and retain companies. It forms the perfect landing spot for such flipped startups to come back to India and remain Indian companies.

Digital businesses have blurred geographic boundaries and the extent of the sovereign over digital businesses arises from having these companies domicile in the said country. This is best understood by the US and China, who allow their companies to operate overseas while remaining domiciled in the motherland. Europe is a digital colony as it lacks major tech companies headquartered in its borders. India too runs the risk of this unless it allows for Indian entrepreneurs to redomicile in India and reforms legislation that prompted them to move out in the first place.

Indian entrepreneurs look up to the Start-up Prime Minister to allow them to return to the country and create immense value for India and Indians.

## Kashmir's Theory of Aesthetics and Rasa

ashmir has a long tradition of scholars over centuries continuing to work on aesthetic theory and rasa. It has also been proposed that the count of 36 chapters of the Nāṭya Śāstra was deliberately chosen to conform to the theory of 36 tattvas or elements of reality (25 tattvas as described in the Sankhya system together with the 11 Rudras that represent states of consciousness), which count was later formalized in Kashmir Śaivism. Also note that the bhāṇa, a one-actor play described by Bharata, is still performed in Kashmir by actors called bhand pather (bhana pātra, in Sanskrit).

Manomohan Ghosh,1 the modern translator of the Nāṭya Śāstra, believes that it belongs to the 5th century bce. He bases his assessment on the archaic pre-Pāṇinian features of the language and the fact that Bharata mentions the Arthaśāstra of Bṛhaspati and not that of the 4th century bce Kauṭilya.

It is also noteworthy that there are close connections between Kashmir and South India in the dramatic tradition and the worship of Siva, Pāñcarātra, Tantra, and the arts. A few years ago, when I pointed this out to Vasundharā Filliozat, the art historian who has worked on Karnataka, she said that the inscriptional evidence indicates a continuous movement of teachers from Kashmir to the South and that Kashmir was likely the original source of many of the early Shaivite, Tantric, and Sthāpatya Āgamas. While this is true of the period when scholars were compelled to leave Kashmir due to its unsettled conditions, a migration of teachers from the South to Kashmir in the earlier periods is a distinct possibility.

The Nāṭya Śāstra not only presents the language of creative expression, but is also the world's first book on stagecraft. It is so comprehensive that it lists 108 different postures that can be combined to give the various movements of dance. Bharata's ideas are the key to proper understanding of Indian arts, music, and sculpture. They provide an insight into how different Indian arts are expressions of a celebratory attitude to the universe.

The term nātya is synonymous with drama. According to Bharata, the nātya was created by taking elements from each of the four Vedas: recitation (pāṭhya) from the

Rgveda, song, or melody (gīta) from the Sāmaveda, acting (abhinaya) from the Yajurveda, and sentiments (rasa) from the Atharvaveda. By this synthesis, the Nātya Śāstra became the fifth Veda, meant to take the spirit of the Vedic vision to the common man.

The Nāţya Śāstra classified the diverse arts that are embodied in the classical Indian concept of the drama, including dance, music, poetics, and general aesthetics. Later, the Viṣṇudharmottara Purāṇa of the 4th century ce (compiled during the Karkotas) describes canonical conventions of architecture, iconography, and painting.

Five of the thirty-six chapters of the Nāṭya Śāstra are devoted to music. Bharata speaks of the 22 śrutis of the octave, the seven notes and the number of śrutis in each of them.

He explains how the vīṇā is to be tuned and describes the dhruvapada songs that were part of musical performances.

The concept of rasa, enduring sentiment, lies behind the aesthetics of the Nāṭya Śāstra. The artist, through movement, voice, music, or any other creative act, attempts to evoke them in the listener and the spectator. This evocation helps to plumb the depths of one's experience, thereby facilitating self-knowledge. Love poems are suffused with śringāra rasa in one of two modes: union (sambhoga) and separation (vipralambha) and, of course, they can be joined with other rasas. If love is about the impending sense of loss, it is bound with the deepest emotions related to being.

The ideas of the Nātya Śāstra provide an overarching framework to the Indian theory on sculpture, temple architecture, performance, dance, and storytelling. But unlike other technical śāstras that were written for the scholar, Bharata's work influenced millions directly. For these reasons alone, the Nātya Śāstra is one of the most important books ever written.

# Major IT Outage Points of Vulnerable Global Information Ecosystem

The global information technology outageon July 19, 2024, that paralyzed organizations ranging from airlines to hospitals and even the delivery of uniformsfor the Olympic Games represents a growing concern for cybersecurity professionals, businesses and governments.

The outage is emblematic of the way organizational networks, cloud computing services and the internet are interdependent, and the vulnerabilities this creates. In this case, a faulty automatic update to the widely used Falcon cybersecurity software from CrowdStrike caused PCs running Microsoft's Windows operating system to crash. Unfortunately, many servers and PCs need to be fixed manually, and many of the affected organizations have thousands of them spread around the world.

For Microsoft, the problem was made worsebecause the company released an update to its Azure cloud computing platform at roughly the same time as the CrowdStrike update. Microsoft, CrowdStrike and other companies like Amazon have issued technical work-arounds for customers willing to take matters into their own hands. But for the vast majority of global users, especially companies, this isn't going to be a quick fix.

Modern technology incidents, whether cyberattacks or technical problems, continue to paralyze the world in new and inter-

esting ways. Massive incidents like the CrowdStrike update fault not only create chaos in the business world but disrupt global society itself. The economic losses resulting from such incidents – lost productivity, recovery, disruption to business and individual activities – are likely to be extremely high.

As a former cybersecurity professional and current security researcher, I believe that the world may finally be realizing that modern information-based society is based on a very fragile foundation.

#### THE BIGGER PICTURE

Interestingly, on June 11, 2024, a post on CrowdStrike's own blog seemed to predict this very situation – the global computing ecosystem compromised by one vendor's faulty technology – though they probably didn't expect that their product would be the cause.

Software supply chains have long been a serious cybersecurity concern and potential single point of failure. Companies like CrowdStrike, Microsoft, Apple and others have direct, trusted access into organizations' and individuals' computers. As a result, people have to trust that the companies are not only secure themselves, but that the products and updates they push out are well-tested and robust before they're applied to customers' systems. The SolarWinds incidentof 2019, which involved hacking the software supply chain, may



well be considered a preview of today's CrowdStrike incident.

CrowdStrike CEO George Kurtz said "this is not a security incident or cyberattack" and that "the issue has been identified, isolated and a fix has been deployed." While perhaps true from CrowdStrike's perspective – they were not hacked – it doesn't mean the effects of this incident won't create security problems for customers. It's quite possible that in the short term, organizations may disable

some of their internet security devices to try and get ahead of the problem, but in doing so they may have opened themselves up to criminals penetrat-

ing their networks.

It's also likely that people will be targeted by various scams preying on user panic or ignorance regarding the issue. Overwhelmed users might either take offers of faux assistance that lead to identity theft, or throw away money on bogus solutions to this problem.

#### WHAT TO DO

Organizations and users will need to wait until a fix is available or try to recover on their own if they have the technical ability. After that, I believe there are several things to do and consider as the world recovers from this incident.

Companies will need to ensure that the products and services they use are trustworthy. This means doing due diligence on the vendors of such products for security and resilience. Large organizations typically test any product upgrades and updatesbefore allowing them to be released to their internal users, but for some routine products like security tools, that may not happen.

Governments and companies alike will need to emphasize resilience in designing networks and systems. This means taking steps to avoid creating single points of failure in infrastructure, software and workflows that an adversary could target or a disaster could make worse. It also means knowing whether any of the products organizations depend on are themselves dependent on certain other products or infrastructures to function.

Organizations will need to renew their commitment to best practices in cybersecurity and general IT management. For example, having a robust backup system in place can make recovery from such incidents easier and minimize data loss. Ensuring appropriate policies, procedures, staffing and technical resources is essential.

Problems in the software supply chain like this make it difficult to follow the standard IT recommendation to always keep your systems patched and current. Unfortunately, the costs of not keeping systems regularly updated now have to be weighed against the risks of a situation like this happening again.

# Biden fact-checks Trump's speech, vows to fight on as he prepares to hit campaign trail again

President Joe Biden hit out at Donald Trump on Saturday for his "dark vision" for the country and said he will resume campaign next week to expose his Republican rival's Project 2025 agenda amidst Democrats' calls for him to quit the race.

In a thread of 13 posts on X, Biden, 81, said he had the distinct misfortune of watching Trump's speech, which he fact-checked and tore down the latter's claims one by one, at times, supporting it by what his government did on that issue late on Friday night local time.

Biden, who tested positive for

COVID-19 a few days ago, is in isolation at his home in Delaware. After this week's rest, he is expected to hit the campaign trail next week as he aims to seek re-election.

I'm stuck at home with COVID, so I had the distinct misfortune of watching Donald Trump's speech to the RNC. What the hell was he talking about? Biden started with this post on X while poking fun at the keynote speech of the opposition party's presidential nominee for the November 5 election at the Republican National Convention in Milwaukee on Thursday.

Biden then added 11 other posts each fact-checking issues, including what Trump, 78, did with COVID-19, his claim about Social Security and Medical, tax cuts, inflation, and Project 2025 agenda where Trump wants to throw immigrants into mass detention camps.

The post which said, He praised Hannibal Lecter. Donald, Hannibal Lecter is not real. And he is a cannibal, almost went viral garnering the most retweets and likes among other posts in the thread.

The thread ended with: And if you're with me, pitch in to our campaign and had a poster showing Trump and his running mate J D Vance and a caption: Protect Democracy. Defeat

Meanwhile, in a statement issued by his campaign, Biden said: Donald Trump's dark vision for the future is not who we are as Americans. Together, as a party and as a country, we can and will defeat him at the ballot box.

I look forward to getting back on the campaign trail next week to continue exposing the threat of Donald Trump's Project 2025 agenda while making the case for my own record and the vision that I have for America: one where we save our democracy, protect our rights and freedoms and create opportunity for everyone, he said.

For over 90 minutes, he focused on

his own grievances, with no plan to unite us and no plan to make life better for working people, said the presi-

dent referring to Trump's speech. He avoided mentioning his Project 2025 agenda, but still proudly flaunted the worst of MAGA (Make America Great Again) extremism," Biden said, referring to Trump's mention of immigrants. Americans know exactly where he wants to take this country.

One of the priorities of Project 2025, published by the Heritage Foundation, is to create a roadmap for the first 180 days of the new Trump administration to quickly reorient every federal agency around its conservative vision.

It also aims to recruit and train thousands of people loyal to the conservative movement to fill federal government positions, according to CNN.

The Biden-Harris campaign alleged: Trump is still the same twice-impeached, 34-time convicted felon consumed by revenge and hell-bent on seeking retribution in a second term.

Days after Biden's disastrous performance against Trump in the first presidential debate, Democrats remained split on whether he can beat the former president in November and as of Friday at least 10 Democrats had joined the chorus calling on him to step back.

as per sources, were attended by Director General of Police (DGP) RR Swain, DG BSF, DG CRPF, Heads of Intelligence Agencies and other senior officials of army, CAPFs and J&K Police at Raj Bhavan, Jammu.

The security review meetings in Jammu came close on the heels of the July 16 terrorist ambush in Doda district where five soldiers were killed and as many injured. On July 14, Prime Minister Narendera Modi chaired a meeting of the Cabinet Committee on Security. The meeting was followed by Union Home Minister Amit Shah's another security review where surge in terrorist strikes in Jammu was discussed threadbare.

An official statement said that LG Sinha chaired a high-level meeting with the Army Chief, various heads of security and law enforcement agencies on the security situation in Jammu division at Raj Bhawan, Jammu. "Chief of the Army Staff and the LG asked the Army, CAPFs and the Jammu Kashmir Police to proactively conduct coordinated counter-terrorism operations in Jammu Division," the statement said. "We must launch meticulous and well-planned counter-terrorism operations with greater synergy between all the agencies to wipe out terrorists and those aiding and abetting them." As per the statement, the LG also directed that the security grid should be further strengthened to ensure zero crossborder infiltration.

Earlier, in the meeting held at PHQ Jammu, sources said that the security officials discussed threadbare the modus-operandi of terrorists operating in Jammu, how they managed to sneak in, routes used by them to infiltrate, possibility of new tunnels dug along International Border and routes being used by foreign terrorists to enter Jammu via Punjab

They said that the Army chief stressed on well-coordinated efforts to tackle new terror challenges in the Jammu region while ensuring minimal casualties to security forces, especially the army. In the past 32 months, 41 soldiers have been killed in Jammu alone in a spate of terrorist attacks, triggering a security concern for the grid.

"The meeting focussed on plugging the on erational flaws and intensifying the counter terrorist operations while following a renewed strategy," a source said. "It was also decided to zero in on the terror-ecosystem and terrorist sympathisers strictly. The meeting also evolved a consensus that a close watch must be maintained on the former terrorists and Over Ground Workers (OGWs)."(KNO)

way security forces crushed terrorism in Kashmir, a similar strategy will be adopted in Jammu as well," the LG said, adding that "today all terror outfits in Kashmir are headless.'

chargesheet against all the four accused. The Trial Court in its judgement had observed

that convicts are a menace to the society, they have shown no sympathy to the helpless minor girl who was reading in the middle class and to conceal their evil deeds they had resorted to this drastic and extreme brutal act which resulted in depriving life of a innocent minor girl.

Sessions Court also drew parallels to the "Nirbhaya gang rape and murder case", where not only the adminstration including the police but the political class was shaken and the response was in the form of legislative amendments and setting up of fast track Courts for trying sexual offences.

The Kupwara District Court pronounced its verdict on April 24, 2015, sentencing all the four convicts to death.

Convicts are sentenced to death for offences under section 302/34 and each one for rigorous imprisonment of seven years for an offence punishable under Section 363/34 RPC. The convicts are also sentenced to rigorous imprisonment for 10 years for the offence punishable under Sections 376(G)/34 RPC. They are also sentenced to simple imprisonment of one month for offences punishable under Section 341/34 of RPC. The sentences shall run concurrently," read the verdict.

However, the accused later approached the High Court and filed an appeal challenging the conviction Order passed by Principal Sessions Judge Kupwara.

Speaking to Kashmir Observer, Mubeen Wani, Deputy Advocate General who is representing the Government UT/State said, "Now the case is being taken up regularly on hearing days by the Hon'ble Court. We are defending the case to the best of our capabilities and we expect that the appeal will be decided

#### **HC Quashes FIR**

Order 39 Rule 2-A is quasi criminal and though it has a punitive aspect embodied therein whereunder the offender can be ordered to be detained in the civil prison yet, the person who complains disobedience or breach of order has to clearly make out beyond any doubt that there was an order required to be obeyed by the opposite party and that the said order has been observed in breach or disobeyed," the court said.

It is also a settled position of law, the court said, that the provisions of Order 39 Rule 2-A CPC are to be exercised without there being any element of vindictiveness.

Thus, in presence of the said provisions of Order 39 Rule 2-A .....there was no reason or occasion for the trial court .....to pass the impugned order dated 29.02.2024 directing the registration of FIR against the petitioners (3 persons/ defendants in the civil suit) in the matter for violation of order of injunction passed by the appellate court dated 07.06.2017," the court said, adding, "The said order thus, cannot but be said to have been passed by the trial court without any power and authority."

The court subsequently quashed the trial court order as well as FIR registered based on

"Viewed thus, what has been observed, considered and analyzed ...., the instant petition merits to be allowed. Accordingly the petition is allowed and the impugned order dated 29.02.2024 passed by the court of Sub Judge/ JMIC Kupwara as also the impugned FIR No. 10/2024 dated 03.03.2024 registered with Police Station Trehgam are quashed."

## Power DISCOMS Adds Over 40,000 New Connections In J&K

**SRINAGAR:** The power distribution corporations (DISCOMS) of Jammu and Kashmir have added over 41,000 new connections to their consumer base during a massive drive against illegal connections and power theft in the Union territory this year, officials said.

The maximum number of new connections, nearly 70%, belong to domestic consumers, they said. The other categories include non-domestic commercial, agriculture sector, electric vehicle charging stations, industrial, and government departments.

Currently, there are nearly 20.5 lakh power consumers in J&K with a total agreement load consumption of 4010.52 megawatts

The DISCOMS also delivered nearly 1,900 applications related to name change, ownership change, and category change for power consumers recently, as per official data.

Early this year, the twin corporations of J&K, Kashmir Power Distribution Corporation



Limited (KPDCL) and Jammu Power Distribution Corporation Limited (JPDCL), started a massive drive against power bill defaulters and illegal connections.

The drive resulted in the disconnection of 11,450 consumers for non-payment of dues, with outstanding arrears of Rs 43.26 crore recovered in the Kashmir division alone. KPDCL also intensified action against smart metre tampering, with nearly 600 applications filed for the registration of FIRs.

KPDCL also added 13,719 new connections to its domestic con-

sumer base, increasing the load by 7.5 MW. The new connections include 1,949 in Kulgam, 1,630 in Budgam, and 1,269 in Sopore, among other areas.

Meanwhile, corporations have advised consumers to avoid using crude heating gadgets like heaters and boilers, which have been banned by the government.

The crackdown on power theft is part of the power department's efforts to reduce losses and improve the overall efficiency of the power distribution system in the UT—(KNO).

#### Jal Shakti Dept Appeals People To Use Water Judiciously

**SRINAGAR:** While the protests erupted in Srinagar and elsewhere over the paucity of water amidst the scorching heat in Kashmir, the authorities here have issued an appeal to the general public, urging them to use drinking water judiciously and refrain from unnecessary wastage.

In an appeal to general public, the Executive Engineer, water Works Division, Srinagar has stated that due to increase in temperature in Kashmir valley, the consumption, drawls of water supply have increased considerably, resulting in shortage of water supply in some parts of Srinagar City especially in tail end areas of the city.

"As such, general public is appealed to use the drinking water judiciously and avoid wastages/misuse of water by using it in Lawns, Kitchen-Gardens, washing of vehicles etc," reads the communication.

The communication states that the consumers using direct online boosters are appealed to stop this practice immediately for equitable distribution of water supply in their respective areas.

"This is an offence under Jammu & Kashmir Water Resources Regulation and Management Act 2010 and the department shall be forced to take action against all such offenders", states the communication.



To address grievances related to water scarcity, as per the communication, a provincial control room has been established, operating round the clock to assist with complaints

Designated nodal officers have also been appointed to promptly address genuine concerns regarding water supply.

When contacted, Chief Engineer, Jal Shakti Department, Vivek Kohli said that the situation is not alarming, but the people have been asked to avoid wastages and also using the motors and other gadgets.

About the water scarcity, he said in case the need arises, the department has kept water tankers available in order to ensure adequate water supply to the consumers.

Pertinently, several areas of Kashmir witnessed protests on Friday as the people took to the streets, demanding adequate water supply, claiming that amidst the scorching heat, the people are being pushed to the wall due to inadequate water supply in their areas—(with KNO inputs)

#### Over 100 Hospitalized After Diarrhoea Outbreak In Srigufwara

ANANTNAG: Over one hundred people from Srigufwara area of South Kashmir's Anantnag district were hospitalised after the outbreak of diarrhoea in Trail village, officials said.

Officials said that a large population including elderly people in Trail village of Srigufwara suffered loose motions and vomiting, following which the health teams were immediately dispatched to the area and all the affected people have been admitted to health facilities.

"More than 100 residents were being treated for loose motions and vomiting. Probably unsafe or impure drinking water could be the cause, but test reports are yet to confirm the facts. The Health Department has set up a medical camp in the area," officials said.

Deputy Commissioner (DC) Anantnag, Syeed Fakhruddin Hamid, along with other officials, visited the village today after the outbreak.

Block Medical Officer (BMO), Sallar, Dr. Zahoor Ahmad, said that the number of infected people has reached 100, and all are stable. He said the infected people are being treated at three health facilities, and teams of medicos have been deployed in the village.

Dr. Zahoor said that an awareness camp has been conducted, and teams from Srinagar have also visited the area. "Water test samples have been taken from eight places, and the results will be available soon. The most affected people are from the young and elderly age groups," he added.

"We demand an investigation into why the water reservoir was kept open for two days. The reservoir is polluted, and there is no cleanliness at the site," they alleged.

Sareer Wani, Executive Engineer Jal Shakti Department, Division Bijbehera, told KNO that the reservoir is closed but the filtration point remains open, as it remains in other locations where there is a water supply scheme.

He said the water supply scheme serves water to almost ten villages, but only a single village was affected by the outbreak due to unknown reasons.

### 'Ignoring High BP Pressure Can Increase Risk Of Stroke'

**SRINAGAR:** Ignoring high blood pressure can increase the risk of heart disease, stroke and other serious health conditions, doctors warn, adding that regular screening is essential for managing and monitoring blood pressure.

Medical professionals said that high blood pressure, or hypertension, is often called a "silent killer" because it typically has no symptoms but can lead to life-threatening health problems. They said regular checkups are necessary to detect and manage this condition.

Dr Shahnawaz, a cardiologist at DHSK, said that heart disease and stroke are among the most common complications associated with hypertension. "High blood pressure can damage your arteries, making them less elastic and decreasing the flow of blood and oxygen to your heart, leading to heart-related ailments," he said, adding that increased pressure could cause blood vessels in the brain to burst or become blocked, which results in a stroke.

Dr Iqbal, another physician said that high blood pressure could strain the kidneys and impair their ability to filter waste from the blood effec-



tively. "Hypertension could damage blood vessels in the eyes, leading to vision problems, and limit blood flow to reproductive organs, causing sexual dysfunction," he said.

According to doctors, every third or fourth adult in the region has hypertension, but almost half are unaware of their condition. "This silent killer doesn't show symptoms during illness except for some vague signs attributed to other diseases," they said. "Unfortunately, four out of five hypertensive patients are not keeping their blood pressure under control, which leads to severe consequences like heart attacks, strokes, and kidney failure."

They observed that hypertension is also becoming more common among school-going children due to drastic lifestyle and dietary changes, including sedentary habits, high intake of salt, sugar, and fat, junk food consumption, smoking, substance abuse and stress.

The experts called for adopting an active lifestyle, maintaining a healthy weight, regular exercise, and monitoring blood pressure. They said regular checkups are crucial for detecting and managing high blood pressure early, which can reduce the risk of severe health issues.

The doctors also recommended lifestyle changes such as a healthy diet, regular physical activity, maintaining a healthy weight, limiting alcohol intake and quitting smoking to help manage and prevent high blood pressure—(KNO)

#### District Administration Gears Up To Make Udhampur Plastic Free
