Severe Heatwave **J&K Faces 27% Rainfall Deficit**

Srinagar: Jammu and Kashmir has seen a drastic decline in the precipitation this year so far with figures revealing that since January 01 2024 to July 25, the Union Territory has recorded a deficient rainfall of 27 per cent.

However, as the precipitation this month is still less, the people of Kashmir have been witnessing severe heat wave conditions with Srinagar recording a maximum temperature of 34.5 degree Celsius on Thursday.

The heat wave has tightened its grip in some parts of Kashmir where the mercury has settled above nearly 6 degree Celsius today.

In Srinagar, the mercury has settled at 34.5 degree Celsius, which was 1.1 degree less than yesterday while Kokernag has also recorded 5.4 degree Celsius above than normal temperature as the mercury settled at 32.8 degree Celsius.





Novel Medication More Effective For Patients With Relapsed Blood Cancer

The hematopoietic cell transplant team at Osaka Metropolitan University Graduate School of Medicine has developed a novel technique based on a new drug combination that has shown considerable anti-cancer activity with low toxicity for relapsed/ refractory acute myeloid leukemia (AML) patients.

Furthermore, the precise immunological study demonstrated how a novel medicine increased anti-cancer activity via altering immune cells.

Relapsed/refractory acute myeloid leukemia, also known as blood cancer, has an extremely poor prognosis due to resistance to anticancer medicines and the patient's organ function. Allogeneic hematopoietic cell transplantation is a method of anti-tumour immunotherapy that can have an anti-cancer impact but is associated with substantial toxicity.

It is frequently used for patients who are difficult to treat with chemotherapy but still relapse.

In research published in the Nature-affiliated Blood Cancer Journal, the researchers describe their clinical observational analysis of 12 patients with AML who relapsed following allogeneic hematopoietic cell transplantation and were treated with venetoclax and azacitidine.

Venetoclax, an oral medication approved by the FDA in October 2020 for AML, shows promising results in older, untreated AML patients by inhibiting the BCL-2 protein to promote cancer cell death.

A study by OMU researchers demonstrated significantly better one-year survival rates for the venetoclax combination therapy group (66.7 per cent) compared to a control group (27.3 per cent). Immunological studies revealed that venetoclaxinduced immune cell alterations enhanced anti-tumor activity.

Persisting Heatwave

ashmir is in the grip of an unprecedented heatwave this July. On July 24, Srinagar recorded a temperature of 34.2°C, which was 5.7 degree Celsius above the normal temperature. Interestingly, the maximum temperature in Srinagar and Jammu cities was identical as both the places recorded a day temperature of 35.6 degree Celsius. The north Kashmir district of Kupwara recorded a maximum temperature of 35.0 degree Celsius.

The soaring temperatures have consequences for crops. It could lead to their premature ripening, disrupting their development cycle and adversely affecting both their quality and quantity. Apple growers are particularly concerned, as the excessive heat can hinder color and size development of the fruit, impacting the market value of their produce.

While the heatwave persists, there is little immediate relief in sight. The Meteorological Department has forecast severe heatwave for the next four days and from thereon there is possibility of some rain.

However, despite the heatwave, tourism remains by and large unaffected. with recent months seeing higher inflows compared to the previous year. The fresh data released by the Centre has pegged the tourist numbers visiting the Valley at one crore by June this year.

That said, it hardly detracts from the concern about the creeping climate change. Though global in scale, it affects every region of the world. And as the continuing erratic weather in Kashmir in recent years reveals, the region is increasingly feeling the impact. According to reports and some surveys, many natural streams in various parts of the Valley have run dry in recent years. And the reason for this is the steady depletion of the glaciers. This has not only reduced the discharge in the rivers and streams but also made many water bodies extinct, affecting the irrigation in the Valley. However, such disturbing changes aren't specific to Kashmir only. This is becoming a worldwide phenomenon. There is thus an urgent need for the world to come together and take remedial measures to pre-empt the catastrophe. But it may take decades before the world is able to sufficiently reign in the factors which are contributing to the disruption in the climate. And the places like Kashmir which have little hand in climate change are bearing the brunt of it. As continuing heatwaves show, the world needs to quickly get its act together before it is too late.

Why is Bangladesh Protesting

T has been more than 10 days now since the start of the protests against a government job quota system. Students and youth across the country have been demonstrating against what they see as an unfair policy favouring a certain group – children of "freedom fighters" in the Bangladesh war of independence. But after the government unleashed unprecedented violence, the protests have gone beyond the demand for cancellation of the quota system.

A list of demands by students has been circulated in an underground press release.

1) The prime minister must accept responsibility for the mass killings of students and publicly apologise.

2) The home minister and the road, transport and bridges minister [the latter is also the secretary general of the Awami League], must resign from their [cabinet] positions and the party.

3) Police officers present in the sites where students were killed must be sacked.

4) Vice Chancellors of Dhaka, Jahangirnagar and Rajshahi universities must resign.

5) The police and goons who attacked the students and those who instigated the attacks must be arrested.

6) Families of the killed and injured must be compensated.

7) Bangladesh Chhatra League [BCL, the pro-government student wing, which is, effectively, the government's vigilante force] must be banned from student politics and a student union established.

8) All educational institutions and halls of residences must be reopened.

9) Guarantees must be provided that no academic or administrative harassment of protesters will take place.

That Prime Minister Sheikh Hasina publicly apologises for her disparaging comments about the protesters may seem a minor issue, but will surely be the sticking point.

This prime minister is not the apologising kind, regardless of what she does. Regardless of the allegations that she has rigged elections, regardless of the fact that corruption has been at an all-time high during her tenure, regardless of the fact that more than 100 students and other protesters have been murdered by her goons and the security forces, regardless of the fact that she has deemed all those who oppose her views to be "razakars" (collaborators of the Pakistani occupation army in 1971). There is certainly not anyone in the negotiating camp who would have the temerity to even suggest such a course for the prime minister. There is a Bangla saying, "You only have one head on your neck.' The ministers do the heavy lifting. They control the muscles in the streets and "manage" things when resistance brews. The ministers are high-ups in the party, and apart from the difficulty of finding suitable replacements, discarding them would send out the wrong

message within the party.

Vice chancellors and proctors having to resign is an easy one. These are discardable minions. The perks are attractive and there are many to fill the ranks. The police being dumped is not as easy, as they provide some of the muscle, but "friendly fire" does take place. Compensation is not an is-

sue. State coffers are there to be pillaged and public funds being dispensed at party behest is a common enough practice.

The demand to ban BCL and associated student organisations in Dhaka, Jahangirnagar and Rajshahi universities is a sticking point, as they are the ones who keep the student body in check and are the party cadre called upon when there is any sign of cept the four approved ones, were banned. Not the numerous extrajudicial killings and disappearances and the liturgy of corruption by people in her patronage during her own tenure.

The raid at 2:20 earlier this morning in the flat across the street was also in commando fashion. The video footage is blurry, but one can only see segments of the huge contingent of the Rapid Action Battalion (RAB), heavily armed police and others in plainclothes. They eventually walked out with one person, perhaps an opposition leader.

Armoured personnel carriers prowl the streets. Orders to shoot on sight have not quelled the anger and people are still coming onto the streets despite the curfew. There is the other side of the story. Reports of policemen being lynched and of-

On July 24, the Union Budget 2024-25 outlined various changes impacting gold trading, including adjustments to Short-Term Capital Gains (STCG) and Long-Term Capital Gains (LTCG). A key announcement was the reduction of customs duty on gold and silver from 10% to 6%, resulting in a substantial drop in gold prices.

Presently, gold is trading at around 67,834 on the Multi Commodity Exchange (MCX). Prior to the budget, gold futures hit a record high of 74,777, but following the announcement, prices fell to 67,800, reflecting a decrease of 6,977 (9%) from the peak. Similarly, silver futures on the MCX declined from an all-time high of 98,220 to 82,083, a drop of 16,150 points.

The customs duty reduction aims to enhance domestic value addition in precious metals and bolster the jewelry sector. The Finance Minister stressed that this measure would invigorate local industries and increase their competitiveness. Given that India is the world's second-largest gold consumer after China and imports most of its gold via official channels, this reduction is quite significant. In the fiscal year 2023-24, India imported gold valued at 45.5 billion, up from 35 billion in 2022-23, with major imports from Switzerland, the UAE, and South Africa.

The initial drop in gold prices is expected to be temporary, presenting a potentially good buying opportunity. This customs duty reduction could be a strategic time to invest in gold during price dips through gold ETFs (Exchange-Traded Funds), silver-gold funds, or digital investments via mutual fund gold funds. Disagreeing with Respect

Fostering Respect and Understanding in Communities for Better Community Mental Health

ifferences in opinion, belief, and viewpoint are unavoidable in a world growing more varied and interconnected with every passing day. Conflicting ideas can frequently cause discord, misinterpretation and tension whether they arise in families, businesses, communities, or on social media. In this regard, learning the art of agreeing to disagree can act like a cohesive force for all members of the society. Not only does learning to agree to disagree with respect help to preserve social and communal peace, but it also helps to improve community mental health. The advantages of polite disagreement for both personal and group welfare are discussed in this article together with techniques for handling differences.

The significance of Respectful Disagreement

The capacity to recognize and embrace differences in viewpoints without resentment or animosity is known as respectful disagreement. There are various reasons that make it essential to practice respectful disagreement. Some of them are discussed as below:

1. Promotes compassion and comprehension: When we practice respectful disagreement, we handle opposing perspectives with respect and while doing so, we develop empathy and reduce bias by allowing ourselves to comprehend the viewpoints of others.

2. Reduces Conflict: When we practice respectful disagreement, it naturally reduces the chances of arguments to escalate into enmity or violence which eventually might lead the members of community to turn more harmonious towards each other.

3. Facilitates open discourse: Respectful disagreement helps to create a healthy atmosphere that has a capacity to accept varying perspectives and hence facilitates open discourse which is essential for drafting all-inclusive answers to multifaceted social issues



ing: When we practice respectful disagreements in social settings, it leads to increased tolerance and respect for varied opinions that leads to alleviation of anxiety and hence helps to build a community whose members are mentally healthy.

How to agree to disagree with respect?

1. Practice Active Listening: It involves giving your full attention, trying to understand the other person's perspective and responding considerately to what the other person is intending to say. It requires:

a. Giving full attention: Listen to what the speaker is saying, while reducing any kind of disruption or distraction.

b. Showing that you are trying to understand what is being said: Use of head movements we call Nod or use of sentences such as, "I see" or "I understand" can help the other person feel that you are trying to understand the

c. Reflecting Back: To ensure that we have understood correctly what we heard the other person saying, we can summarize the whole narrative.

In addition to showing that we respect the other person's perspective, active listening also helps to resolve the misunderstandings and builds trust.

2. Maintain a Calm and Re-spectful Tone: The end results of a disagreement will be highly influenced by the tone of one's voice and their body language. Following suggestions need to be kept in mind so that respect is upheld in such situations:

a. Try to maintain composure: Breathe deeply and slowly and try to regulate and handle your emotions especially the negative ones.

b. Use "I" Statements: Rather than using "You should" or "You are" to convey your opinions, use statements like "I feel" or "I think".

using confront Avoid

crossing your arms or pointing your fingers wt the other person with whom you have a disagreement. Instead maintain a body language that is both inviting and calm.

When we maintain a composed and courteous attitude, it helps in diffusing potential conflicts and facilitating a more meaningful dialogue.

3. Seek Common Ground: In order to facilitate bridging of divides and promotion of mutual respect, it is imperative to find a common ground, even if the parties involved have strong disagreements with each other. This involves

a. Finding values that are common between the parties: Figure out the fundamental values that can be agreed upon by all the parties involved.

b. Use agreements as foundation: In order to facilitate further discussions, parties involved can use agreements to build and strengthen the foundation

Points: In order to bring genuineness in one's approach while trying to handle disagreements with the other party, it is important that the parties involved acknowledge and validate each other's viewpoints whenever and wherever possible.

Finding a common ground is a very important aspect of handling disagreements respectfully as it serves as a beginning point for positive communication and collaboration.

4. Agree to Disagree: At times, it happens that despite trying all the different means of finding a common ground and building bridges, it remains impossible to bring resolution to the disagreements and hence accepting that disagreements may still remain there is the only way forward. In such cases:

a. Acknowledge and accept the difference: Recognize that there can be disagreements despite trying all the means of bridging the gaps and that it's have different opinions.

b. Conclude on a Positive **Note:** Even when you couldn't find any means of building a common ground, try to end the conversation on a positive or neutral note, such as, "I understand and appreciate your point of view.'

c. Keep moving ahead: Centre your attention around those dimensions of the relationship that can still be worked upon in order to keep flourishing regardless of the disagreement.

One of the major signs of being emotionally mature and handle disagreements is to accept that certain differences can never be resolved and that it is ok to agree to disagree while maintaining respect and harmony. **5. Educate and Be Educated:**

Promoting the idea of respectful disagreement requires one to educate oneself as well as others about this concept. This involves:

a. Be open to education: Keep learning and educating yourself as well as others about different cultures, beliefs, and perspectives.

b. Share your perspective: Share your perspective with others about what and how you understand the differences in a respectful and informative manner.

c. Promote the art of thinking critically: The art of critical thinking is not a very common occurrence among masses and this lack sometimes leads to quick judgments. Encourage yourself as well as others to evaluate every information you receive from multiple angles in order to reduce bias, prejudice and quick judgments.

Keeping ourselves as well as others updated and educated about varied opinions and perspectives is essential for the community members to engage meaningful conversations so that disagreements are handled respectfully.

Was It Childhood Trauma if I Was Privileged?

ver my last 13 years as a trauma therapist, there has been a question that's surfaced many times from my clients: Was it childhood trauma if I was privileged?

There's a bifurcated thought many of us hold that if we had food, a roof over our heads, toys, and clothes, our experiences—painful as they may have been-don't "count" as childhood trauma because, materially, we had what we needed.

I personally and professionally believe it's critical that we debunk this myth, unpack why and how many of us hold this belief, and understand why holding a more flexible view on childhood trauma existing against the landscape of a privileged past is important.

Moving beyond the historical view of childhood trauma

Historically, the recognition of childhood trauma has predominantly focused on physical abuse and violence.

This narrow perspective can be traced back to early research and societal understandings, which placed emphasis (understandably) on visible, tangible forms of harm and poor adult outcomes (mentally and socially) because of these experiences.

With physical abuse toward children centered in research and social studies-and, of course, it makes sense why it

would be-psychological and emotional aspects of trauma were, until relatively recently, often overlooked, in part due to the challenges in quantifying and assessing nonphysical forms of abuse, and also due to the relatively early stages of this second wave of traumatology work.

But, increasingly, studies have shown that exposure to childhood trauma beyond physical abuse is also associated with adult psychiatric disorders and poor biopsychosocial outcomes, highlighting the long-term consequences of such experiences and validating them.

The evolution of traumainformed care reflects a growing-and, in my opinion, much-needed-understanding of the broad spectrum of childhood trauma, recognizing that trauma can stem from a variety of sources, not just limited to physical violence.

Recent understanding of and dialogue about childhood trauma now accept that emotional abuse, neglect, and exposure to household dysfunction all have profound effects on physical, emotional, developmental, and behavioral health across the lifespan.

But despite these advances in our conversations, research, and the way we deliver trauma-informed care, the previous emphasis on physical abuse has, for many of us, shaped societal attitudes toward childhood trauma, often marginalizing equally damag-



ing effects of emotional and psychological trauma. Bottom line: Many people

still consciously and unconsciously have an internalized, historical view of what "counts" as childhood trauma and fail to see themselves in the term "childhood trauma."

Material privilege can make it harder to see your childhood trauma

On top of internalized hisbeliefs about what torical "counts" as childhood trauma, those who grew up with material comfort may find it even more difficult to see themselves in the term "childhood trauma.'

They might ask themselves questions like:

If I had all the food I needed, a roof over my head, clothes to wear, toys, and even went to private school, does my experience "count" as childhood trauma if I had so much privilege?

Mom and Dad were pillars of the community, and we had the biggest, best home in the neighborhood. I'm not sure what I experienced counts. I shouldn't complain: We went on vacations, we had household help. I wasn't poor. Isn't childhood trauma when you don't have enough food and you were beaten?

The difficulty individuals from privileged backgrounds face in recognizing their own experiences of emotional and mental trauma as "childhood trauma" is multifaceted.

As I mentioned earlier, societal narratives and internalized beliefs about what constitutes trauma often emphasize physical abuse, neglect, or severe economic hardship, overshadowing the impact of

emotional and psychological distress.

This can lead many to have a dismissive attitude toward their suffering, as they might feel that without visible scars or tangible hardships, their experiences do not "count" as trauma.

Material privilege adds an additional layer of fogginess, as it can evoke guilt ("But we had so much!") or diminish the perceived legitimacy of their pain, feeding into a belief that their material advantages should somehow immunize them against psychological harm.

Childhood trauma and material privilege are not mutually exclusive

It is critical to remember that trauma is not defined by the external circumstances that cause it but by the individual's subjective experience of those events.

I cannot stress this enough: Trauma is what happens when an event or series of events subjectively overwhelms the brain and body's ability to cope effectively.

So, this means that one-time events, ongoing stress, and commonly overlooked causes such as deeply disappointing experiences or parental mental cruelty, can all leave lasting effects irrespective of one's socioeconomic status depending on the subjective experience of the person who endured these experiences.

To speak plainly, you can have grown up in a mansion and had nannies, but if your father belittled you daily, telling you what a disappointment you were, rejecting you for failing to live up to his standards, failing to provide you with secure attachment, and causing you to internalize beliefs about your own unworthiness and defectiveness, do you think a closet full of designer kids' clothes would offset those negative impacts? Speaking as a licensed psy-

chotherapist and childhood trauma recovery expert, I'm here to tell you that no, it would not.

What's the point of even asking this question?

When we see ourselves, our stories, and the impact of our past clearly, we're more equipped to legitimize our pain and begin to confront reality (both critical and crucial steps in trauma healing) and seek out the right kind of support and help to begin properly recovering from the impacts of our past.

It's never too late to have a beautiful adulthood, despite our adverse early beginnings. If you need support, find a therapist through the Psychology Today directory. Wildfires prompt California evacuations as crews battle Oregon, Idaho fires stoked by lightning

Wildfires prompted evacuations in Northern California amid a rapidly growing wildfire Thursday, a day after powerful winds and lightning strikes from thunderstorms rattled eastern Oregon and Idaho, cutting power and stoking fires, including one in Oregon that was the largest active blaze in the United States. Another fast-moving wildfire forced thousands to abandon a town in Canada. Evacuations were ordered in

California's Butte and Tehama

counties as crews battled a fire

reported near Chico just before 3 p.m. Wednesday. The blaze, dubbed the Park Fire, quickly spread from about 10 square miles (26 square kilometers) to more than 70 square miles (180 square kilometers) and was only 3% contained early Thursday, according to CAL FIRE. The cause was under investigation.

Fire personnel were focusing on evacuations and defending structures while using bulldozers to build containment lines. No deaths or damage to structures had been reported, CAL FIRE/ Butte County Fire Department said in a late Wednesday update.

J&K Faces 27%

Kupwara in north Kashmir too have recorded 5.1 degree Celsius and 4.0 degree Celsius above than normal temperature respectively as the mercury at the twin places settled at 33.0 degree Celsius and 35.1 degree Celsius respectively.

With this temperature, the heat wave has gripped these places today amidst the forecast of severe heatwave in the Valley for the next three days.

However, Jammu division too has recorded a similar hot and humid weather conditions as according to the details, the mercury in Jammu city has settled at 35.6 degree Celsius while in Katra and Batote, it settled at 31.4 degree Celsius and 28.8 degree Celsius respectively.

However, Jammu and Kashmir overall has recorded deficient rainfall since the inception of this year.

According to the details available, the J&K has recorded a deficient rainfall of 27 per cent till July 25.

In January and February months, a deficient rainfall of 48 per cent was recorded; details shared by a private Weather forecaster reveals, adding that against the normal precipitation of 225.5 mm during the period, 117.1 mm rainfall was recorded only.

However from March to May, the Union Territory has recorded a deficient rainfall of nine percent only. During the period, 300.6 mm rainfall was recorded in J&K against the normal precipitation of 330.0 mm.

However, since June to July 25, a deficient rainfall of 33 per cent has been recorded in Jammu & Kashmir. Overall, there has been a deficiency of 27 per cent rainfall in J&K from January 01 2024 to July 25, 2024.

An Independent Weather Forecaster, Faizan Arif Keng has stated that this year, Western Disturbances have largely avoided Jammu and Kashmir. After a significant deficit in January, some recovery was seen in February, and the region experienced near-normal rainfall from March to May. However, since June, monsoon conditions have been very weak, particularly over the past 20 days, leading to low water levels in streams and rivers, he said.

"The rainfall during this monsoon season in ashmir has primarily been due to Western Disturbances. Despite much of India experiencing normal to excess rainfall, monsoon conditions in Jammu and Kashmir have remained weak. There appears to be an inverse relationship between monsoon rainfall in India and Jammu and Kashmir, especially evident in recent years," he added. Moreover, Director Meteorological department (MeT), Dr Mukhtar Ahmad has predicted the possibility of rainfall from July 29, saying that the ongoing heat wave is expected to end by the end of this month. Nonetheless, the weatherman has also informed that due to the prevailing heat conditions and the deficient rainfall, there has been an impact on the crops as well.(KNO)

But several parts of the country have been placed on Level 4: Jammu and Kashmir, India-Pak border, Manipur and parts of Central and East India.

"Do not travel to: The union territory of Jammu and Kashmir (except the eastern Ladakh region and its capital, Leh) due to terrorism and civil unrest; within 10 km of the India-Pakistan border due to the potential for armed conflict; portions of Central and East India due to terrorism and Manipur due to violence and crime," said the State Department.

In addition, it recommended Americans to reconsider travel to the northeastern states due to terrorism and violence.

"Indian authorities report that rape is one of the fastest growing crimes in India. Violent crime, such as sexual assault, has happened at tourist sites and other locations. Terrorists may attack with little or no warning. They target tourist locations, transportation hubs, markets/shopping malls, and government facilities," the travel advisory said.

The US government has limited ability to provide emergency services to US citizens in rural areas. These areas stretch from eastern Maharashtra and northern Telangana through western West Bengal. The US government employees must get special authorization to travel to these areas, it said. Placing Manipur at "Level 4: Do Not Travel", the State Department said: "Do not travel to Manipur due to the threat of violence and crime. Ongoing ethnic-based civil conflict has resulted in reports of extensive violence and community displacement. Attacks against Indian government targets occur on a regular basis. US government employees traveling in India require prior approval before visiting Manipur.' Similarly, terrorist attacks and violent civil unrest are possible in the union territory of Jammu and Kashmir. "Do not travel to this state (with the exception of visits to the eastern Ladakh region and its capital, Leh). Violence happens sporadically in this area and is common along the Line of Control (LOC) between India and Pakistan. It also occurs in tourist

spots in the Kashmir Valley: Srinagar, Gulmarg, and Pahalgam. The Indian government does not allow foreign tourists to visit certain areas along the LOC," it said.

"India and Pakistan have a strong military presence on both sides of the border. The only official border crossing for non-citizens of India or Pakistan is in Punjab. It is between Attari, India, and Wagah, Pakistan. The border crossing is usually open, but check its current status before you travel. To enter Pakistan, you need a Pakistani visa. Only US citizens residing in India may apply for a Pakistani visa in India. Otherwise, apply for a Pakistani visa in your home country before traveling to India," it said.

Maoist extremist groups, or "Naxalites", are active in a large area of India that spans from eastern Maharashtra and northern Telangana through western West Bengal, the advisory said.

Attacks against officers of the Indian government continue to occur sporadically in the rural parts of Chhattisgarh and Jharkhand that border Telangana, Andhra Pradesh, Maharashtra, Madhya Pradesh, Uttar Pradesh, Bihar, West Bengal, and Odisha. Southwest areas of Odisha are also affected. The Naxalites have carried out many terrorist attacks, targeting local police, paramilitary forces, and government officials, it said.

"Due to the fluid nature of the threat, US government employees are required to obtain permission prior to traveling to most areas in the states of Bihar, Jharkhand, Chhattisgarh, West Bengal, Meghalaya, and Odisha. Permission is not required if employees are traveling only to the capital cities of these states. US government employees also need approval to travel to the eastern region of Maharashtra and the eastern region of Madhya Pradesh," the advisory said.

In addition, Northeastern States has been given - Level 3: Reconsider Travel. "Ethnic insurgent groups occasionally commit acts of violence in parts of the northeast. These incidents include bombings of buses, trains, rail lines, and markets. There have been no recent reports of violence in Assam, Nagaland, Arunachal Pradesh, Mizoram, Sikkim, or Tripura." it said.

"US government employees traveling in India require prior approval before visiting the states of Sikkim, and Arunachal Pradesh, as well as when visiting any areas outside of the capital cities of Assam, Mizoram, Nagaland, Meghalaya, and Tripura," it said. purposes like correction of any particulars in the roll, shifting of residence (within or outside constituency), replacement of EPIC and marking of person with disability and Form 6B could be used for capturing Aadhaar number of the existing electors.

He further added that authorities have said that during these days classes would be conducted in online mode.

Moreover, school authorities of KV from a military containment in Jammu city also confirmed that school has been shut and now classes would be held online for students.

"Dear Parents and Students, We are writing to inform you that due to Administrative Reasons, The School will shift to online classes starting tomorrow until further notice. Thank you for your understanding and cooperation," a message flashed in official groups from the Principal reads.

Last year, authorities shut all schools of the Jammu region, which was operating from inside the cantonment areas a week ahead of the G20 summit in Srinagar.

On July 23, a soldier lost his life in a gunfight with terrorists along the Line of Control (LoC) in Poonch district. Lance Naik Subhash Chander sacrificed his life during a gunfight in the Battal area of Krishna Ghati sector as the Army scuttled an infiltration attempt by a group of terrorists from across the border.



Electricity & Water Supply Scenario Reviewed In J&K

Outstation officers partici-

pated in the meeting through video conferencing. The Chief Secretary enquired

about the status of present water levels in main rivers of Ihelum and Chenab. He also

asked for a comparison about drop in levels from last year due to deficient rainfall which amounts to around 50% this year. He asked for measures to tackle the ongoing heat wave conditions in the UT especially putting an efficient response mechanism in place to address the public complaints.

The Chief Secretary directed the Jal Shakti and Housing & Urban Development departments to ensure an uninterrupted water supply, especially in areas facing drinking water shortages. He called for making assessment of both the machinery and infrastructure in view of the present climatic conditions. He advised for taking both the short and long term measures to augment supply of drinking and irrigation waters as per the requirements on ground.

He directed the Deputy Commissioners to submit regular reports on the status of power and water supply in their respective districts, ensuring continuous monitoring and swift action whenever needed. He asked for establishment of control rooms at the district level for instant resolution of

complaints regarding these essential supplies in their areas.

Indians Eye Double-Digit Medal Haul As Paris Olympics Set For Grand Start

PARIS: Some would be carrying a huge burden of expectations, some others would look to spring a surprise and a few more would be eyeing the perfect closure to their glittering careers as the 117-strong Indian contingent aims for a better-than-before performance in the Olympic Games, starting here on Friday.

India returned from Tokyo with seven medals, and it is only natural that a doubledigit performance is now desired in Paris. Except for wrestlers, who have waded

Whether it was training abroad or getting the best of facilities to sharpen their skills, there was planning in place. But will the hard work, the strategies and the unbridled support translate into medals?

THE BIG PICTURE:

It will be a Herculean task to match the Tokyo figures of seven medals, given that except for reigning Olympic champion Neeraj Chopra, not many are top contend-

 but largely, India's campaign will be driven by the athletes, who will be competing on a stage this grand for the first time.

Then there are the seasoned ones who would be expected to raise their game suitably. Two-time medallist shuttler PV Sind-

hu, tennis player Rohan Bopanna, legendary table tennis player Sharath Kamal and hockey goalkeeper PR Sreejesh are certainly playing their last Olympics.

The hockey team has endured patchy form in the build-up to the Games, the boxers and wrestlers are lacking in real competition time.

The shooters too have notched up mixed results heading into the Olympics.

The track and field athletes, especially Avinash Sable, have done well of late, but compared to their global rivals, their performances don't seem enough to put them in the bracket of medal hopefuls.

India's hopes for podium finishes largely hinge on Neeraj, despite concerns around his adductor niggle, and the inform badminton duo of Chirag Shetty and Satwiksairaj Rankireddy.

Gambhir's First Headache: Pant Or Samson For Sri Lanka T20I Series

COLOMBO: New India head coach Gautam Gambhir will have the onerous task of choosing between Rishabh Pant and Sanju Samson during the three-match T20I series against Sri Lanka starting from Saturday.

While most of the key stars of the T20 World Cup winning side sans the retiring duo of Rohit Sharma and Virat Kohli are in the island nation, the choice between two flamboyant wicketkeeper batters Pant and Samson won't be an easy one.

Worse, even with two slots vacant, one can't fit in both the hardhitting batters. Pant with 171 runs. was the third highest run-getter for India in the T20 World Cup in the Americas but Samson, though was part of the team, didn't get a game. A bilateral series against Sri Lanka, of late, has become a low-stakes affair with the two countries often engaged in inconsequential series, some of which India plays to help other international cricket boards stay afloat. One such series was supposed to be the upcoming one against Sri Lanka but it has assumed greater significance after Gambhir took over as the coach and Hardik Pandya, a sureshot candidate for captaincy, was surpassed by Suryakumar Yadav.

former India opener and a successful franchise-level mentor, will certainly have a broader say in the team composition, something that will be built over two years in the run-up to the next T20 World Cup.

The choice of a keeper-batter in T20Is hasn't exactly been a straight forward one for India, especially during the time Pant was out of action due to a horrific car accident in December 2022.

Ishan Kishan was around for some time before he fell out of favour after leaving the tour of South Africa midway. Samson has featured in some games, so have Jitesh Sharma and Dhruy Jurel in the interim.


Over 250 participants representing various government and private institutions showcased their skills and determination throughout the competitions.

Paris 2024 Olympics Shatter Ticket Sales Records

The Paris 2024 Olympics have set a new benchmark in ticket sales, with organizers announcing that 9.7 million tickets have been sold or allocated. This figure surpasses the previous record held by Atlanta in 1996, which sold 8.3 million tickets.

Grand Slam record-breakers Novak Djokovic and Rafael Nadal were placed on an Olympics secondround collision course in the draw for the Paris Games on Thursday.

Nadal, a singles gold medallist at the 2008 Olympics, is playing in his final Games having also won doubles gold in Rio in 2016 while Djokovic was a bronze medallist in singles in 2008.

Djokovic begins his campaign against Australia's Matthew Ebden. Nadal faces Hungary's Marton Fucsovics in his opener.

As Paris Olympics Kick Off, Gazans Seek Refuge In Football

GAZA: Inspired by the Olympics worlds away in Paris, some Palestinian youths played football against each other at a school sheltering the displaced in the war-torn Gaza Strip -- a rare distraction from devastating Israeli bombardment.

With the world's gaze on competitions in France, there is no glory or prize for the winning team in the tiny enclave that has been decimated by an Israeli offensive launched after the Hamas militants who rule it staged a cross-border raid on Oct. 7.

The players found a trophy they were looking for -- something to give them even a small sense of accomplishment in the chaos of war -- under the rubble.

It was a painful reminder that Gaza could take years to recover from the bloodshed.

"The whole world is watching it (the Olympics) and excited about it. And I wish for the world to look at us, in the Gaza Strip," said Abu Seif, one of the organisers of the Gaza football games where players in red or black compete.

"Nothing is left but (it) was bombed by the Israeli occupation," read a banner held by children standing nearby.

"All our stadiums were destroyed; all our clubs were destroyed. You see the football that we are playing with, a very old ball in the shelter," Abu Seif said.

HEAVY TOLL ON SPORTS

Impoverished Gaza has always had to contend with poor sports facilities and the war has demolished everything from boxing rings to rough, dusty football pitches.

But the spirit of athletes has not been broken even as the death toll of Palestinians hammered by the Israel military campaign has exceeded 39,000, according to Gaza authorities.

"We are trying to hold sports activities in this school. We are trying to change the reality of life that we are in and entertain people and children as



much as possible," said Mustafa Abu Hashish, who is taking part in the tournament.

The world has been focused
on the fighting in Gaza since
Hamas attacked southern Israel, killing 1,200 people and

taking over 250 hostage, according to Israeli tallies.

Aside from trying to find a safe place to hide from the bombing, Palestinians also face a humanitarian crisis with shortages of food, fuel, water and medicine inflicting suffering every day. Gaza's 2.3 million people

Gaza's 2.3 million people live in one of the world's most densely populated places. Palestinians who have moved up and down Gaza in fear say there is nowhere to hide from Israeli airstrikes.

For now, the Gaza football players may be distracted from the airstrikes, shelling and ground invasion. This brief respite may not last if Egyptian, U.S. and Qatari mediators fail to secure a ceasefire after many attempts.

On July 10, an Israeli missile slammed into a tent encampment in southern Gaza just as displaced people had gathered there to watch a football match at a school, eyewitnesses said.

Israel says it goes out of its way to avoid killing civilians.

GAZA DEATH TOLL: HOW MANY PALESTINIANS HAS ISRAEL'S CAMPAIGN KILLED?

Palestinian health authorities say Israel's ground and air campaign in Gaza has killed more than 39,000 people, mostly civilians, and driven most of the enclave's 2.3 million people from their homes. The war began on Oct. 7 when Hamas militants stormed across the border into Israeli communities. Israel says the militants killed more than 1,200 people, mostly civilians, and took 253 into captivity in Gaza.

The official Health Ministry count as of Thursday, July 25, was 39,175 Palestinian dead.

The numbers do not necessarily reflect all victims as many are still missing under the rubble, the Palestinian Health Ministry says. In May it estimated that some 10,000 bodies were uncounted in this way.

The Lancet medical journal published a letter from three academics, opens new tab on July 5 estimating that indirect deaths, caused by factors like disease, might mean the death toll is several times higher than official estimates and possibly above 186,000.

The United Nations regularly cites the ministry's death toll figures, while naming the ministry as the source, and the World Health Organization has voiced full confidence in them.
