8-Week Vegan Diet **Linked To Lower Biological Age, Study Finds**

ew Delhi: Going vegan for eight weeks was found to be linked to lowering of biological age, according to a study published in the iournal BioMed Central (BMC) Medicine.

Researchers looked at the molecular effects of the plant-based diet that abstains from consuming animal food products, such as dairy. The diet largely includes eating fruits and vegetables, along with grains, beans and nuts.

The researchers, including those at Stanford University, US, found that consuming the plantbased diet was related with changes in how a gene expressed itself, or gene behaviour, without changing the DNA itself. Specifically, they looked at DNA methvlation, known to be able to "turn off" or "silence" a gene, thereby not allowing it to express itself.

Higher levels of DNA methylation is associated with a higher biological age. It is one of the epigenetic processes, which affect the behaviour of a gene by altering its environment.

For eight weeks, the team followed 21 pairs of adult identical twins -- one half of each pair consumed an omnivorous diet, including meat, eggs and dairy, while the other consumed

a vegan one. Identical twins share a significant amount of their genetic makeup.

On average, the participants were aged 40 years and had a body mass index (BMI) in the overweight category. About 77 per cent of the group were women.

After eight weeks, the researchers observed a 'younger' heart, liver, inflammatory and metabolic system among the participants consuming the vegan the biological age in the vegan group, the researchers said.

Reacting to the study, Tom Sanders, a professor emeritus of Nutrition and Dietetics at King's College London, and not involved in the study, said that the findings might be favourable for vegans in terms of ageing.

However, the diet can come with micronutrient deficiencies, which often take years to exert harmful

diet. These changes were not seen in those eating the omnivorous diet.

However, the authors cautioned that the extent to which these changes could be attributed to their diets was unclear.

They noted that on average, the individuals on the vegan diet lost two kilograms more compared to those on the omnivorous diet.

The results suggest that the weight loss could have contributed to lowering of effects, Sanders said.

"For example, unless a vegan diet is supplemented with vitamin B12 they develop vitamin B12 deficiencv that causes chronic and often insidious damage to the nervous system," Sanders said.

Long-term studies of vegans also find adverse effects on bone density, probably caused by very low calcium and barely adequate protein intakes. Sanders said

Husband Likely To Be Booked On 'Abetment Of Suicide' Charges

SRINAGAR: The suicidal deaths of a lady and her two minor children, whose dead bodies were recovered from Dal Lake on Saturday last, is expected to lead the police to initiate proceedings under 'abatement of suicide' against the husband of the deceased.

Preliminary investigations have revealed that 'strained' relationship with husband might have 'provoked' the deceased to commit suicide along with her two minor kids in Dal Lake on Saturday last.

The dead bodies of a woman and her two minor children, including a 3-years-old girl and 4-years-old boy were recovered from Dal Lake at Fore-Shore near Eco Park by the po-


lice on July 27 (Saturday).
Identified as 24-years-old Zahida
Begum, wife of Mohammad Hussain Sheikh, according to CCTV analysis, tossed her two minor children, Muhammad Sahil and Nahida Kousar, into the Dal Lake before ending her own life.

The deceased, they said, were hailing from Dugga village of Arnas block in Reasi district and were living in a rented room at Shatta Mohalla Shalimar in Srinagar. The



marital life of the deceased with her husband, according to the preliminary findings, was not cordial, and the two were often engaging in heated arguments.

Police, sources said, have initiated findings under section 174 CrPC at police station Nigeen in this regard, and the husband of the deceased, Mohammad Hussain Sheikh; a laborer has been taken into custody as

Nonetheless, it has been confirmed that the deaths occurred due to suicide and not a murder.

Sources said preliminary investigation into the instant matter has revealed that the deceased's relationship with her husband was strained, which might have forced her to take an extreme step.

They said the police may initiate proceedings under section 306 IPC (abatement of suicide) and section 125 Domestic Violence, against the husband, in case it was found that he was committing cruelty upon her wife, forcing her to com mit a suicide along with her minor

The dead bodies of the deceased woman and her two minor kids were recovered around 6: 30 by the police on Saturday evening.



School Girl Assaulted, Slaughtered In Langate Village

Police suspect criminal assault, hunting three perpetrators

SRINAGAR- In a ghastly incident, a school girl was criminally assaulted by three unknown assailants in the outskirts of Langate on Friday, and then mercilessly slaughtered in a bid to avoid identification (of the criminals). The enormity of the crime sent waves of shock through the area and thousands of people took to the streets in violent demonstrations.

The victim had, as usual, left her home in Batpora this morning for the 4 km trek to the Uqaab Public School in Langate where she studied in class 8. It being Friday, school was over at 1:30 p.m., and she and two

of her friends headed home through what the villagers call, the From what could later be pieced together from her friends account, they were suddenly waylaid by three persons who tried to

grab the victim. The two friends fled from the spot terrified and weeping, and out of fear did not say anything at home about their school-mate. But when pressed by the family of the missing girl, out poured

the story that created alarm in the entire neighbourhood. Search parties made up of the victim's family and their neighbours immediately set out for the track the girls had taken on

their way home, and came across one of her shoes. With fears of the worst mounting, the villagers found the girl's uniform, and shortly after came upon a body hastily hidden beneath clay and bushels of hay.

A villager, Ghulam Muhammad, said that the searchers were shocked to find that the throat of the victim had been slit, and her uniform, school bag, shoes and other belongings had been dumped some distance away from the "grave."

The Handwara police were informed about the gruesome incident, and top officers of the force tried to take custody of the body. But by then the news had reached the village, and a large numbered men and women came out in grief and headed towards the scene of the crime. The huge procession demanded the immediate arrest of the killers.

The Handwara police said that an autopsy would be carried out to find out the motive behind the killing. The police fears that the victim might have been criminally assaulted before being murdered because the body bore marks of violence, and was without any clothes when discovered.

The police said that a liquor bottle and a tumbler were found near the body.

Villagers from Batpora and adjoining areas held up traffic on the roads by pelting stones on passing vehiclea but dispersed late in the evening, when the additional deputy commissioner Handwara, Basheer Ahmad Wani visited the area and assured people of thorough probe into the crime.

Maduro Wins Third Term, Contradicting Exit Polls

CARACASE: Venezuelan President Nicolas Maduro has won a third term with 51 percent of the vote, the country's electoral authority said just after midnight on Monday, despite multiple exit polls which pointed to an opposition win.

The authority said opposition candidate Edmundo Gonzalez won 44 percent of the vote, though the opposition had earlier said it had "reasons to celebrate" and asked supporters to continue moni-



toring vote counts.

Maduro, appearing at the presidential palace before cheering supporters, said his reelection is a triumph of peace and stability and reiterated his campaign trail assertion that Venezuela's electoral system is transparent.

al system is transparent.

A poll from Edison Research, known for its polling of US elections, had predicted in an exit poll that Gonzalez would win 65 percent of the vote, while Maduro would win 31 percent.

Local firm Meganalisis

predicted a 65 percent vote for Gonzalez and just under 14 percent for Maduro.

About 80 percent of ballot boxes have been counted, said national electoral council (CNE) president Elvis Amoroso in a televised statement, adding results had been delayed because of an "aggression" against the electoral data transmission system.

The CNE has asked the attorney general to investigate the "terrorist actions" Amoroso said, adding participation was 59 percent.

The opposition had earlier said voters had chosen a change after 25 years of socialist party rule.

"The results cannot be hidden. The country has peacefully chosen a change," Gonzalez said in a post on X at around 11 p.m. local time, before the results were announced.

Opposition leader Maria Corina Machado reiterated a call for the country's military to uphold the results of the vote.

"A message for the military. The people of Venezuela have spoken: they don't want Maduro," she said earlier on X. "It is time to put yourselves on the right side of history. You have a chance and it's now."

Venezuela's military has always supported Maduro, a 61-year-old former bus driver and foreign minister, and there have been no public signs that leaders of the armed forces are breaking from the government.

Will Action Be Taken Against "Coaching Centre Mafia"? Centre's Reply

New Delhi: The government issued guidelines on the regulation of coaching centers in January this year, Education Minister Dharmendra Pradhan informed Lok Sabha on Monday, even as he evaded a direct reply to a question on the death of three IAS aspirants in Delhi due to flooding.

During the Question Hour, Congress MP KC Venugopal mentioned the death of the three students and said the institute had no approved building.

"Without an approved building, without any facility, some of the coaching centers become mafia... is the government going to take any action?" he said. Mr Venugopal also raised concerns about students' suicides.

Quoting information provided by the ministry in an earlier written reply, he said that between 2018-2022, around 80 students committed suicide in top-ranking institutions like IITs and IIMs, adding that caste discrimination is a major reason behind it. In his response, Mr Pradhan said, "The member has raised a question which is not related to the question put today."

"But I like to assure the House through you, this government is committed to total socio-psychological and mental protection of all students, whether they are studying in a coaching center, in an institution, school education or higher education," he said.

He said exhaustive and detailed guidelines on coaching centers were issued to all states in January, 2024.

"Some states also have regulations, like Rajasthan, Bihar, Goa. They have their own regulations to look into the matter," he said.

"Regarding the protection, this is a socio-psychological issue. We all have to take care. This is not an issue to be dealt with through only allegations and answers," he said.

Three civil services aspirants died on Saturday after the basement of a building housing a coaching centre in central Delhi's Old Rajinder Nagar area was flooded following heavy rains. In his reply to another question, Mr Pradhan dismissed that India was witnessing "braindrain" with students going abroad for higher education. The students who go outside have made the country proud,



45 Killed As Tribal Feud Sparks Sectarian Fighting In Pakistan

ISLAMABAD: At least forty five people have died and over hundred wounded in Pakistan's lawless north-western frontier area where a small tribe is trying to break a seven day long siege imposed by armed groups, some of whom have crossed over from neighbouring Afghanistan, news reports said on Monday.

Official and local sources said that the land dispute between two tribes — Shia Malikhel and Sunni Mangal of Madaki Kali in Boshehra village — turned deadly, spreading over to the whole Kurram district.

The fighting between the two sides began on Wednesday, when a gunman opened fire at a council negotiating a decades-long dispute over farmland, local police official Murtaza Hussain said.

Rival tribes in villages including Boshehra, Malikhel, Dandar, Pewar, Tari Mangal, Muqbal, Kunj Alizai, Nastikot, Para Chamkani, Karman, Khar Kalai, Sangina and Balishkhel joined in and began targeting each others villages with small and medium range weapons including rocket launchers, mortars and small range missiles.

Hospital sources in Kurram

Agency headquarter, Parachinar said that the district hospital had received 31 dead bodies and around

150 injured by Sunday evening.

They said that the casualties might be higher as they were unable to confirm the dead and injured that have received the hospitals in Sadda, as there is no official number available to confirm the overall death toll.

Since the single road linking Parachinar with the rest of the country is closed for almost a week now, there is a serious shortage of essential items, medicines, fuel and other commodities. A resident said over phone that the district hospital of Parachinar was flooded with the injured while the only health facility was running short of life saving medicines.

The trouble erupted after a land feud between rival tribes spilled over into sectarian fighting with both sides using machine guns and mortars.

While no one was wounded in that attack, Hussain said it reignited longstanding religious tensions between the clans who live side-by-side in the district of Kurram on the border with Afghanistan.

"Initially a land dispute, the issue has now escalated into sectarian violence," Hussain told AFP, confirming the conflict "claimed 45 lives" so far.

"The conflict, now in its fifth day, has escalated into a sectarian dispute with the arrival of extremist groups, like those sympathetic to Tehrik-e-Taliban from neighbouring areas," one report said. "All attempts to resolve the conflict have failed."

A government official said the Shia tribe has "suffered most" in the conflict, with 30 of those killed from the tribe.

A police source said both sides were using automatic weapons and mortars in fighting focussed around the town of Parachinar, which had been blockaded by law enforcement.

"Initially the elders of the Sunni-populated areas gathered in the village of Bushehreh and approached the Shia elders of Parachinar to resolve their differences by holding a peace jirga (peace meeting)", according to a report by IWN news agency.

"However the interference and violence by Pakistani-Afghan Takfiri armed groups has turned this land dispute into a deadly sectarian feud", it added. It further said the situation aggravated after several Shia residents, including a child, were abducted and beheaded by the extremist groups.

Fifth Indian Killed Fighting In Ukraine For Russia

New Delhi: Hundreds of Indians are among the thousands of foreign soldiers Moscow is believed to have hired to bolster its forces

An Indian soldier died fighting with Russian forces in Ukraine, one of his relatives said Monday, the fifth confirmed death so far of an Indian citizen in the conflict.

Hundreds of Indians are among the thousands of foreign soldiers Moscow is believed to have hired to bolster its forces, and New Delhi has urged their repatriation.

Prime Minister Narendra Modi met Russian President Vladimir Putin in Moscow this month and was "given assurance" to that effect, India's foreign ministry said.

Ravi Moun, 22, went to Russia in January after he was promised a job in transport by a private recruitment agent, his brother Ajay told AFP by phone.

But he was later given weapons training and forced to join fighting on the frontier with Ukraine in March.

"After losing contact with him, I approached the Indian embassy in Moscow and they informed us that my brother has died," Ajay said, adding the family was asked by the embassy to send DNA samples to identify Moun's body.

Ajay said his brother had returned from the frontier once, but was later taken to fight again.

It was unclear when he had died.

"We lost contact with him after that," Ajay said, adding that his family had appealed for help from Modi to bring Moun's body back.

More than two years since Russia's invasion began, tens of thousands of its soldiers have been killed in Ukraine, and Moscow has been on a global quest for more troops.

India's foreign ministry said last week that the government was still working with Russian authorities to bring back around 50 Indians fighting alongside the Russian army.

Four other Indian soldiers have died so far this year, according to local media reports.

Indian authorities have arrested several people accused of trafficking citizens of the country to fight for the Russian army after promising them non-combatant roles.

Unemployment remains high in India despite rapid economic growth and huge numbers seek work abroad each year.

each year.

That includes thousands who had sought employment in Israel after labor shortages sparked by the war against Palestinian militants in Gaza.

India is a longstanding ally of Russia and has shied away from explicit condemnation of the invasion of Ukraine.

Modi said he had discussed the conflict "openly and in detail" during his meeting with Putin this month, calling for peaceful dialogue and adding that "war cannot solve problems."

50,000 Die Of Snakebite Every Year, Highest In World: BJP MP In Lok Sabha

New Delhi: About 50,000 people lose their lives every year due to snakebite in the country, the highest in the world, BJP MP Rajiv Pratap Rudy said on Monday.

Every year, 30-40 lakh people are bitten by snakes across India, the Saran MP said, raising the issue in the Lok Sabha during a discussion on matters of importance.

"Bihar is the poorest state, enduring both poverty and natural calamities. Across India, 30 to 40 lakh people are bitten by snakes and 50,000 people die, which is the highest in the world," Mr Rudy said, emphasising the alarming mortality rate from snakebite.

He stressed that many deaths could be prevented, pointing to the climate change impact on snakebite incidents that increased at temperatures above 28 degrees Celsius.

Vellore MP M Kathir Anand voiced his concern on the plight of beedi workers, most of whom were women. He demanded an increase in their wages, citing inadequate

central funding.

Anand urged the Centre to consider budget allocations and provide pension for those older than 60, noting the workers' signifi-

cant exposure to dust and other occupational hazards.

Kanyakumari MP Vijay Vasanth called for an increase in the quota of recommendations to 150 per year to better assist people.

He also urged the government to re-evaluate Ayushman Bharat

to ensure that all medical expenses were covered.

"Let us work together to realise the full potential," he said, advocating for improved healthcare coverage.

At a meeting here, the foreign ministers of the Quad countries called for upholding the free and open rules-based international order and respecting the principle of freedom, human rights, democratic values, sovereignty and territorial integrity of nations.

Without directly naming China, the four foreign ministers expressed serious concern over the situation in the East and South China Seas and reiterated the Quad's strong opposition to to change the status quo by force or coercion." The meeting was attended by External Affairs Minister S Jaishankar, US Secretary of State Antony Blinken, Japanese Foreign Minister Yoko Kamikawa and Australia's Penny Wong.

"All countries have a role in contributing to regional peace, stability, and prosperity while seeking a region in which no country dominates and no country is dominated, competition is managed responsibly, and each country is free from coercion in all its forms and can exercise its agency to determine its own future," the minis-

ters said in the statement.

The Quad also vowed to work towards a free, open and prosperous Indo-Pacific, a region that has seen increasing Chinese military muscle-flexing in the

we realist the squares steadfast commitment to a free and open Indo-Pacific, which is inclusive and resilient, and are united in our commitment to upholding the free and open rules-based international order, with its strong support for the principle of freedom, human rights, the rule of law, democratic values, sovereignty and territorial integrity, and peaceful settlement of disputes," the ministers said.

The ministers also referred to increasing Chinese manoeuvres in the South China Sea, especially the "dangerous use" of coast guard and maritime militia vessels.

However, later the Supreme Court stayed his conviction. His membership of Parliament was thus restored, and he also became eligible to contest the 2024 Lok Sabha election.


'Rising Drug Use Leads To Spike In Hepatitis C Cases In Kashmir'

SRINAGAR: The rising use of drugs, particularly heroin, is leading to an increase in Hepatitis C cases in Jammu & Kashmir as approximately three out of four drug users in the region are Hepatitis C positive, recent data indicates.

An official from the Department of Psychiatry at Government Medical College (GMC) Srinagar, said, "We screen every patient for Hepatitis C, Hepatitis B, and HIV. According to hospital-based studies, around 70 percent of drug users have tested positive for Hepatitis C."

The official said that injection drug use is prevalent among drug users, and the most common cause of Hepatitis C in this population is the sharing of needles. "Hepatitis C is a chronic disease and, if left untreated, can lead to chronic liver disease," he said, adding that the treatment requires expensive antiviral medications for 3-6 months, which places an additional burden on the families of drug users.



According to doctors, Hepatitis A is a viral liver disease primarily spread through the ingestion of contaminated food and water or direct contact with an infectious person. Unlike Hepatitis B, Hepatitis A does not cause chronic liver disease and is rarely fatal. However, it can cause debilitating symptoms and lead to acute liver failure, which can be fatal if untreated.

"Hepatitis B is a viral infection that attacks the liver and can cause both acute and chronic disease," doctors explained. "The Hepatitis B virus (HBV) is transmitted through contact with the blood or other body fluids of an infected

person. Chronic Hepatitis B can lead to serious conditions like cirrhosis and liver cancer."

Regarding Hepatitis C, doctors described it as a liver infection caused by the Hepatitis C virus (HCV), a blood-borne virus. They said it is most commonly spread through contact with blood from an infected person. The sharing of needles among drug users is a well-known transmission route for Hepatitis C, exacerbating the suffering of affected individuals and their families, they said.

The doctors warned that without treatment, Hepatitis C can be fatal. The disease often progresses without symptoms, potentially spreading silently to other family members and even being transmitted from an infected mother to her baby.

The doctors reiterated that needle sharing among drug users is the primary cause of Hepatitis C in Kashmir, with almost three out of four drug users affected. There is also a risk of these individuals contracting other infections, such as HIV, they added—(KNO)

"It is sad to see that the killings are being ignored by the international community. People in Parachinar are oppressed just like people in Palestine but no one is raising voice against their killings. Are they sons of a lesser God?" Adeel questioned.

"We are against injustice against anyone regardless of their faith, "he added.

Late night protests also erupted at Budgam, where protestors marched from Imambargah Budgam to Masjid-e-Sahib-e-Zaman, calling for an end to violence against the Shia minority in Pakistan.

The vigil concluded with a prayer for the victims.

Liver Transplant Facility In J&K Need Of The Hour, Say Doctors

SRINAGAR: With an increasing number of liver failure cases and end-stage liver diseases in the valley, doctors here have called for the urgent need for liver transplantation facilities, which are currently unavailable in Jammu & Kashmir.

Doctors expressed concern over the rising incidence of hepatitis and fatty liver disease, which have led many patients to develop chronic liver disease and cirrhosis. They said establishing liver transplant facilities in J&K is crucial.

A doctor, speaking on condition of anonymity, , "The lives of patients suffering from chronic liver disease can be saved, but in Kashmir, they continue to suffer with little hope of survival due to the absence of such facilities. Patients are dying for want of a liver transplant facility here"

The doctor added that there are hundreds of patients who cannot afford to travel outside Jammu & Kashmir for liver



transplants and, as a result, receive no treatment, which leads to inevitable death from progressive liver failure.

"There is a need for population-based screening to determine the extent of these diseases," the doctor continued. "Hepatitis B and C are common causes of cirrhosis or scarring of the liver, which can lead to liver failure and even cancer."

Another doctor said the region is facing an epidemic of hepatitis due to drug abuse, which not only increases the risk for users but also poses a risk to others through blood transfusions.

The doctor further said that cases of Hepatitis B are becoming more prevalent. "Both Hepatitis A and B often present without symptoms, leaving many people unaware of their condition for years," he said.

Unhygienic dental practices in Kashmir, where many clinics use unsterilised or improperly sterilised instruments, were cited as another reason for the high rates of hepatitis infection.

According to doctors, the contributing factors to the rise in liver diseases include alcohol consumption, viral hepatitis and non-alcoholic fatty liver disease.

"Establishing a local liver transplant centre is crucial. This would offer comprehensive care, from pre-transplant evaluation to post-transplant management, thereby significantly improving patient outcomes," they said.

"It is crucial for dental clinics to adhere to strict sterilisation protocols to prevent the transmission of blood-borne viruses, including Hepatitis B and C," they added—(KNO)

KPDCL's Load Revision To Focus More On High Value Consumers In Flat-Rate Areas

SRINAGAR: In order to check power pilferage and bring down losses in unmetered flatrate areas, Kashmir DISCOM is conducting calibrated load rationalization, based on actual electricity usage by the domestic consumers.

Strict directions have also been given to all Electric Subdivisions to carry out door-to-door inspections, focusing particularly on high value consumers, whose agreemented load is significantly lower that actual consumption.

In a press statement issued here today, a Kashmir Power Distribution Corporation Limited (KPDCL) spokesperson stated that under the flagship Revamped Distribution Sector Scheme (RDSS) of Government of India, LT network and smart metering projects are being implemented to bring about a complete turnaround in the power sector, with ultimate goal of providing uninterrupted and affordable power supply to its consumers.

"All 13 packages related to

power supply to its consumers. "All 13 packages related to loss reduction works are in progress in 10 districts of Kashmir Division under which DT substations and LT-AB cables are being laid," he said, while

urging consumers to facilitate the executing agencies in laying of new distribution infrastructure and upgradation of existing infrastructure in a hassle-free manner.

There have been reports where manpower of the executing agencies has been physically assaulted for laying of LT-AB cable and removal of bare conductor. "Complaints of physi-

cal assault have been received from parts of Srinagar city, Ganderbal, Kupwara & Budgam districts," he said, adding these are resolved with active support and facilitation extended by District & Poce administrations.

Heatwave ebbs, may return

ain on Monday brought a momentary relief to the Valley with temperatures dipping a bit from their record highs. Hopefully from hereon, the heatwave may subside. In July, the Valley experienced the highest recorded temperatures. On Sunday, Srinagar city recorded a high of 36.2 degrees Celsius, hottest July day since July 9, 1999, when the mercury had settled at 37 degree Celsius. Historically, the hottest day was recorded on July 10, 1946 when the day temperature rose to 38.3 degree Celsius.

The ongoing heatwave in the Valley and elsewhere in the world, according to environmentalists, owes itself to climate change. And with recurrent heatwaves sweeping the once one of the picturesque regions of the world, the consequences of the changing weather are becoming starker by the day. Agriculture and horticulture have borne the brunt of the water scarcity and drought-like conditions. The potable water supply too has been badly affected due the depleting discharge in river Jhelum, and other major water bodies. Also, this year, Jammu and Kashmir has recorded a 27 percent deficiency in rainfall this year.

Although climate change is a global phenomenon, Kashmir has become its microcosm. It is mirrored in the fragile ecosystem of the region. From erratic weather patterns to heatwaves, Kashmir has been experiencing the same changes as on the global level. The changes are not mere aberrations but harbingers of a dire future if immediate actions are not taken.

For example, one of the victims of climate change has been the Valley's apple and saffron production, which have suffered irreparable damage due to soaring temperatures, causing significant economic repercussions.

On a bigger scale and which has consequences beyond the boundaries of Jammu and Kashmir, the rising temperatures have led to a rapid retreat of glaciers. Over the past six decades, Jammu and Kashmir has seen a staggering 25 percent reduction in glacier size, a trend exacerbated by the looming threat of climate change. If left unchecked, 48 percent of these vital sources of water could vanish by the end of the century.

While the immediate focus is on dealing with the imminent heatwave, it is also essential to recognize the broader implications of such extreme weather events in the context of climate change. The increasing frequency and intensity of heatwaves are a stark reminder of the urgent need to take decisive global action to mitigate the effects of climate change. We also need to recognize its impact on the vulnerable regions like Kashmir. But it may take decades before the world is able to sufficiently reign in the factors which are contributing to the disruption in the climate. As continuing heatwaves show, the world needs to quickly get its act together before it is too late. And at a smaller level in our region, the authorities have to take steps to ensure that our fragile environment is protected from the increasing human encroachment.

25 years After Kargil

Kashmir has changed beyond recognition since the three-month long conflict that nearly brought the two countries to the verge of an all-out war

quarter of a century after the Kargil war, the situation in Kashmir has come a long way. Although militancy survives in one or another form, so much else has altered, not just in Kashmir but also between India and Pakistan. For one, Kashmir street is now silent, sometimes eerily so. There are no longer any anti-New Delhi protests, hartals or stone-throwing. Separatist politics has been all but wound up. What is more, Jamaat-i-Islami is now raring to contest elections. It is true that these changes are more recent and came about following the revocation of J&K's special status in August 2019, but Kargil war holds its own significance in the annals of decades-long Indo-Pak confrontation over Kashmir. It remains the last time Pakistan tried to wrest Kashmir directly by force but things didn't work out according to the plan and it had to retreat within three months into

the conflict General Parvez Musharraf, believed to be the architect of Kargil, took over Pakistan in a subsequent coup which deposed the then prime minister Nawaz Sharif. Although initially he maintained a tough stance on dialogue with India, seeking implementation of the United Nations Resolution on Kashmir, the general's stance changed following 9/11. Overnight shift in the regional geo-strategic scenario forced him to explore pragmatic options for the settlement of disputes with New Delhi. He still made Kashmir a focal issue but was willing to give up his country's historical position on the region for a negotiated settlement of the dispute. His four point proposals envisaged a solution where Kashmiris across LoC would have substantial autonomy in governing their respective parts of the state and be free to trade and travel without a radical change in the border between them. Where he went beyond the scope of autonomy and self rule was in calling for a joint

management of Kashmir by India and Pakistan. What followed was a phase of perhaps the most promising engagement between the two countries, particularly the period through 2003-07, that saw the two countries coming tantalizingly close to pulling off an "out-of-box" Kashmir solution. But the lawyer's agitation followed by Musharraf's unexpected exit in 2008, put an end to this process. Mumbai attack followed in the same year, plunging the relations between the two to a new low.

It was actually Atal Bihari Vajpayee who had begun the promising negotiations with Musharraf, which were later followed up by Manmohan Singh. During this phase, Kashmir witnessed a progressive decline in militancy, an ironic about-turn from the architect of Kargil war. The militant killings went from 961 in 2004 to just 100 in 2013. What is more, it was during this period in 2002 that ceasefire was instituted along the Line of Control. And it was this truce that India and Pakistan reaffirmed in February 2021. In a sense, one feature of the current uneasy calm between the two neighbours harks back to that era.

However, a lot has happened since then. The dynamics that made the engagement possible at the time no longer exist. Several new factors are at play in the regional geo-politics and in the relations between the two countries that have made it increasingly difficult to go back to the formula.

The biggest change that has since taken place is the withdrawal of Article 370, which granted J&K its semi-autonomous position within the Indian Union, and the splitting of the former state into two union territories. This, from New Delhi's point of view, has more or less ended Kashmir as an issue between India and Pakistan. India has now changed its goalpost. It seeks return of the part of Kashmir under the jurisdiction of Pakistan. And it is loath to even resume dialogue with Is-

lamabad except on its own terms. And Pakistan's response to this so far shows that the country is in no position to challenge India's altered stance on Kashmir. While Islamabad may not have reconciled to the constitutional changes in the region it claims, the country has now kind of gotten used to the new state of affairs.

It is now difficult to believe that immediately after the Kargil war, when the peace process between India and Pakistan was in full gear, billboards featuring Musharraf and Manmohan Singh's images were up all around Srinagar. Then it was seen as the right thing to do. Musharraf had made a dedicated effort to seek a lasting peace with India by finding what he then fondly called "out-of-box solution" to Kashmir. He sought to achieve this through unilateral flexibility - subsequently reciprocated by New Delhi only to end up nowhere.

But in all other features, we have moved on from this time. Since then, Pakistan has become a weaker country and has also lost much of its bargaining power on Kashmir. And going by the words of its prime minister Shahbaz Sharif in 2022, Pakistan immediately after withdrawal of Article 370 was bargaining for a plan to freeze the Kashmir issue for 20 years, reportedly in lieu of trade with India. As for New Delhi, it has not given even a remote indication that it was ready for an engagement with Islamabad. Speaking in Kargil on Vijav Divas. prime minister Narendra Modi said that Pakistan had learnt nothing from history and continued to sponsor violence in Kashmir. As was expected, he offered no olive branch.

ON INNOVATION What Makes People Creative

NOWING what motivates people to be creative is essential for any manager, Lteacher, or student concerned with creativity and, ultimately, innovation. So let's take a look at some extremely creative people. What about Leonardo da Vinci, for example, the wellknown 15th-century artist and scientist? He created beautiful paintings as well as nice blueprints for various types of innovations, such as aeroplanes, long before they were built. He is regarded as one of the greatest minds that ever lived. How about Thomas Edison? Among many of his novel inventions, he invented the light bulb and the motion picture camera, both of which were implemented in various products and found to be extremely useful. What about the well-known artist Salvador Dali? He was well-known not only for his beautiful surrealistic paintings, but also for his sculptures and jewellery. What do these individuals have in common? What inspires these creative geniuses? Some argue that creative geniuses are slightly insane, and that it is the madness that drives them to be creative.

Let's take a look at what inspires people to be creative. Teresa Amabile, a Harvard scientist, developed a model that specifies the factors that are important for people to become creative as early as the 1980s. She specified three variables. The first is expertise, which includes technical, procedural, and intellectual knowledge of the domain in which one works. The second factor is motivation, or the willingness to complete a task. Finally, the third factor is creative thinking abilities, which refer to how effectively and imaginatively people can approach problems. According to the Amabile arc, all three of these factors are required for creativity to emerge. So, rather than having just one of them, you need to have all three to some extent in order to be creative.

Let's take a closer look at these three components. When people consider expertise, they frequently believe that there is such a thing as too much knowledge. And perhaps this is true in the sense that some people have been working in a job for too long and have learned so much that they can no longer think outside the box. But, in all honesty, what is far more of a problem is a lack of knowledge. Why is a lack of



knowledge such a problem? For example, if you don't know enough about a subject, you won't know what has been done before, so you might be working on something that isn't novel. You also have no idea where the boundaries in this area are because you have insufficient expertise. So you could be working on something spectacular and not even realise it, and then abandon it because you don't see the value of your idea. Or you're unsure what's feasible. Maybe you're working on a solution that simply doesn't work, and because you don't realise it, you keep working on it for far too long. Finally, you might not know what's useful and come

up with ideas that are completely unrelated. It is therefore difficult to be creative unless you have sufficient knowledge and expertise to speak for these four elements.

Let's take a look at the second aspect of motivation. People frequently distinguish between two types of motivation when discussing motivation: extrinsic motivation and intrinsic motivation. Extrinsic motivation refers to doing a task not because you enjoy it, but because of something you gain from it. Consider the carrot and the stick. Maybe you work because you want money or a promotion, or maybe you work to keep your house from being foreclosed

on because you owe money on it. All of this is an example of extrinsic motivation. You engage in an activity, but you do so in exchange for a reward. There is also intrinsic motivation, which is when you do something simply because you enjoy it and would do it anyway if you didn't get anything out of it other than joy and satisfaction. And we know that intrinsic motivation has some advantages. For instance, if you are more intrinsically motivated, you are more likely to overcome obstacles that arise. You are more willing to overcome them and go the extra mile. You are more willing to continue after a failure, and this is an important aspect of

creativity, failing, failing, failing before you can succeed. Intrinsic motivation increases your willingness to work hard and think about the problem continuously, and all of these factors combine to make intrinsic motivation such an important component of creativity. So, if you want to be creative, it helps to be intrinsically motivated.

Let's take a look at the final aspect of creativity. The final component is called creative thinking skills, and it is all about how adaptable and imaginative you can be when approaching problems. This is difficult because many people live their lives like robots, as if everything is pre-programmed for them, which makes sense because it is very efficient. For example, when we say goodbye to someone, we simply wave and say bye bye. This is something we do automatically. We don't have to consider it. This is also true for many of the things we do. We don't consider them; we just do them. While this is beneficial because it is efficient, it works against you if you want to come up with a creative solution. Being creative may be difficult if you behave like a robot. When you use automatic scripts and schemas from your head, you stop thinking too soon before you find the best solution. You also make far too many assumptions about what is going on. In some ways, it's better to think like a child, like someone who hasn't learned all of these assumptions, all of these automatic scripts and schemas, a person who sees a box and thinks it's more than just a box.

It's a fortress. It's a ship. That kind of thinking, thinking outside of the box, is exactly what it takes to create and be creative. So, let's sum it up. What inspires people to be creative? Is this insane? Perhaps for some, but for others, there are three critical elements. Having enough knowledge, being intrinsically motivated, and having creative thinking skills are all necessary for being creative. Creativity is the generation of novel and useful ideas, while innovation is the successful implementation of these ideas within a company. In other words, every innovation begins with a creative idea, and with the mentioned three elements of creativity, the good news is that everyone has the ability to be creative.

Could Gene Editing Add Power To A 100-Year-Old TB vaccine?

uberculosis dates back more than 9,000 years. It is the most infectious bacterial disease and in 2022, 10.6 million people fell ill with it. Of these, 23 per cent occurred in Africa.

The only vaccine against tuberculosis, the Bacillus Calmette-Guérin (BCG) vaccine, is more than 100 years old and is primarily effective for infants and young children.

Researchers at the University of the Witwatersrand School of Pathology have made a significant breakthrough in vaccine development by gene-editing the BCG to make it more effective.

Microbiologist Bavesh Kana, one of the lead researchers, explains to Nadine Dreyer from The Conversation Africa, the science behind this breakthrough and the potential it holds for other vaccines.

How do vaccines work?

Vaccines primarily work by mimicking dangerous infectious agents. You want your immune system to recognise the vaccine as an "invader" and then mount an immune response to it. But you don't want the invasive agent to make you sick.

To understand how vaccines work, it helps to look at how the immune system works, because vaccines harness the natu-

ral activity of your immune system.


The immune system: There are about 100 trillion bacteria and viruses in the gastrointestinal tract. The proteins and sugars on the surface of bacteria, viruses or other disease-causing pathogens have different shapes to any of the ones in the human body. These markers are pathogen-associated molecular patterns, commonly known as PAMPs. Think of the spikes on coronavirus.

So, your immune system quickly recognises the invaders. And the body fights back with a complex chain of events involving many different types of white blood cells working together.

One type of white blood cell is able to make antibodies to fight the invaders. These antibodies can stick to the proteins or sugars on the bacteria's surface, and this kills the bacteria or disables them. They have to be exactly the right shape, a bit like a key fitting a door. These white blood cells are known as B-cells.

Producing antibodies of the right shape can take several days. By this time there could be billions of disease-causing bacteria in your body.

Once the right cells are activated, they quickly divide and turn into a production line, making masses of antibodies that stick to the invading agents and disable them. Eventually, your body gets rid of all the in-



vaders and you recover.

Antibodies remain in the blood, and some white blood cells may also become memory cells for specific bacteria in case they invade the body again. So with this stored arsenal of tools the immune system will respond quickly to future invasions.

Vaccines: Vaccines work in the same way as the immune system. They contain weakened or dead bacteria or viruses or even just a few proteins or sugars from the surface. This is enough to convince the immune system that a real invader has entered the body.

So the same process takes place as when real bacteria or viruses invade our bodies. except you don't get ill afterwards. Vaccines are engineered to look like pathogens but are made in such a way that they do not make you sick.

When you do encounter the real agent, you have immunological memory, because your body has been exposed to something that looks very similar. And that immunological memory allows you to withstand the infection or even prevent establishment of full infection, or to manage the infection without getting too sick.

How did you go about modifying the TB vaccine?

TB vaccines are very challenging to develop. The bacterium that causes the disease is complex. It is also proficient at evading the human immune system, which is why there is only one vaccine that has been developed against the disease in 100 years.

Our laboratory does a lot of TB research and for a long time we've been interested in the cell wall of these bacteria. We noticed that the cell wall has a small chemical decoration on the surface and that chemical decoration allows the bacteria to hide an important marker (PAMP), called the NOD-1 ligand, from the immune system

Both the tuberculosis and the live bacteria used in the BCG vaccine are able to hide the NOD-1 ligand from the immune system, making it harder for the body to detect them. We thought that modifying the BCG bacterium so it cannot hide this NOD-1 ligand might lead to a new, more ef-

Should You Stretch Before Exercise? After? Never? Here's What To Know

or many people of a certain age, high school gym class began with reaching for their toes. Then, over the years, we were told it was better to stretch after exercise.

It turns out, both those things can be true, but the differing advice has created some confusion.

Stretching can help make you more flexible, improve range of motion in your joints - and feel good. David Behm, who researches human kinetics at Memorial University of Newfoundland in St. John's, Canada, offers this advice on when to stretch and how to do it safely:

It's almost always good to stretch, but it's better if you warm up first, said Behm, author of "The Science and Physiology of Flexibility and Stretching"

He recommends a light aerobic activity such as jogging, walking or cycling for five or 10 minutes.

Follow that with some static stretching, the traditional way of reaching and holding a position (think back to that gym class). You can then do activity-specific dynamic stretching, in which you warm up the muscles with repetitive movements like leg lifts.

Behm says one minute is "the magic number" for how long to do static stretching



per muscle group without fatigue.

Expand your definition of 'stretching' Should you always stretch before exercising? If it's traditional stretching, not necessarily.

The better question, Behm says, is, "Should people increase their range of motion? Should people have better flexibility? And that is yes, because it helps prevent injuries. It helps with health. But you don't have to stretch to achieve that.

Resistance training, for instance, can be an effective form of stretching, he said. Doing a chest press increases range of motion in your deltoids and pecs, whether with barbells, dumbbells or machines, so there is no need to stretch beforehand. Just make sure to start with a small amount of weight to warm up and then add more to train.

"You probably don't have to do extra stretching unless you're a gymnast, a figure skater, or even a golfer who needs a great range of motion through that swing," Behm said.

Nor do you need to stretch first if you're go-

ing for a leisurely run. Simply start with a slow jog to warm up and then increase the pace.

Don't do it if it hurts

After exercise, "light stretching is OK, as long as you don't reach a point where you're feeling pain", Behm said. Since your muscles will be warm by that point, overdoing it makes you more likely to injure yourself.

Foam rollers can help with muscle recovery and have been shown to increases range of motion as well as stretching.

Do some static stretching before sports If you're playing a sport, Behm said,

static stretching beforehand helps reduce muscle and tendon injury. "If you're going to do an explosive move-

ment, change of direction, agility, sprint, any of these explosive activities that involve your muscles and tendons," he said, "you're going to be stronger if you do static stretching". People can especially get in trouble when

whether it's tennis, surfing or any sort of Also, stretch both sides equally. Lacking flexibility on one side also can lead to injury.

Sounds simple. Why all the confusion? Different studies over the years have either encouraged or discouraged stretching before exercise. Behm says that partly because some studies didn't reflect real-life conditions, or were designed with elite athletes in mind, not regular people.

Predicting Space Storms Can Now Be Possible, **Reveals Study**

ecent advancements in space weather forecasting may soon enable scientists to predict the speed and arrival time of coronal mass ejections (CMEs), commonly known as space storms, according to a study led by an Indian-origin researcher.

CMEs are bursts of gas and magnetic fields spewed into space from the solar atmosphere.

It typically takes several days to arrive at Earth and results in a shock wave causing a geomagnetic storm that may disrupt Earth's magnetosphere, compressing it on the day side and extending the night-side magnetic tail.

The team of Aberystwyth University in the UK has discovered that by analysing specific solar regions called 'Active Regions,' they can forecast CMEs more precisely – even before it has fully erupted from the Sun.

These regions have strong magnetic fields where CMEs originate.

They will present these findings at the Royal Astronomical Society's National Astronomy Meeting

By monitoring changes before, during, and after eruptions, they identified the critical height at which the magnetic field becomes unstable, leading to a CME.

"By measuring how the strength of the magnetic field decreases with height, we can determine this critical height," said lead researcher, Harshita Gandhi, a solar physicist at Aberystwyth.

Using the data, they combined it with a geometric model to track CME speed in three dimensions, essential for precise predictions.

"Our findings reveal a strong relationship between the critical height at CME onset and the true CME speed. This insight allows us to predict the CME's speed and, consequently, its arrival time on Earth, even before the CME has fully erupted," Gandhi said.


In the foreword of the Report on Currency and Finance (RCF) for 2023-24, the Governor also said the flagship Unified Payments Interface (UPI) has revolutionised the retail payment experience for end-users, making transactions faster and more convenient.

In the digital currency arena, the Reserve Bank is at the forefront with pilot runs of the erupee, the central bank digital currency (CBDC).

The digital lending ecosystem is becoming vibrant with initiatives such as Open Credit Enablement Network, Open Network for Digital Commerce and the Public Tech Platform for Frictionless Credit.

He said fintechs are collaborating with banks and nonbanking financial companies (NBFCs) as lending service providers. They are also operating platforms to facilitate digital credit. BigTechs are backing payment apps and lending products as third-party service providers.

"Digitalisation in finance is paving the way for next-generation banking; improving access to financial services at affordable costs; and enhancing the impact of direct benefit transfers by effective targeting of beneficiaries in a cost-efficient manner," Das said.



"All these innovations are making financial markets more efficient and integrated," the Governor said.

At the same time, Das said digitalisation also presents challenges related to cybersecurity, data privacy, data bias, vendor and third-party risks, and customer protection.

Govt Says Airlines Sensitised To Exercise Moderation In Pricing Of Air Tickets

NEW DELHI: Airlines have been advised to self-regulate as well as sensitised to exercise moderation in pricing of air tickets, the civil aviation ministry told the Rajya Sabha on Monday.

There have been persisting concerns over high airfares, especially during peak and festival seasons.

Minister of State for Civil Aviation Murlidhar Mohol said the ministry holds consultation with airlines and the representatives are advised to self-regulate and keep passengers' interest in mind while fixing the airfares.

"Airlines have also been sensitised to exercise moderation in pricing and to keep passengers' interest in mind. The airlines have committed to ensure that airfares do not surge during events such as natural disasters, calamities, etc," he said in a written reply.

Under current regulations, airfares are neither established nor regulated by the government after the repeal of the Air Corporation Act in March 1994.

"Globally, most countries have deregulated their aviation sector, i.e., removing gov-

ernment-imposed entry and price restrictions on airlines. Deregulation has led to increased competition between airline carriers, leading to decrease in airfare. As a result of deregulation, entry into the airlines industry for a potential new airline has become easier, resulting in many new airlines entering the market, thus increasing competition," the minister said.

He also added that the direct impact of deregulation is that a passenger in a lower income group can afford to travel by air.

The Directorate General of Civil Aviation (DGCA) has set up a Tariff Monitoring Unit (TMU) that monitors airfares on select domestic sectors on random basis by using airlines websites on monthly basis to ensure that the airlines do not charge airfares outside the range declared by them, Mohol said.

Given the complex dynamics of the Indian aviation industry, the minister said the government is playing the role of a facilitator by creating an enabling environment to support the growth of the sector.

Negotiating Teams To Restart India FTA Talks As Soon As Possible, Says UK

LONDON: The process of getting negotiating teams back in the room will kick-start soon to deliver a Free Trade Agreement (FTA) with India, the UK's newly elected Labour government announced on Monday as it set out its trading priorities.

Business and Trade Secretary Jonathan Reynolds spelt out his department's approach to international trade deals, which he said will put economic growth at the heart of the nego tiations to achieve high-quality pacts that give British businesses access to international markets and boost jobs.

The Department for Business and Trade (DBT) said it also plans to publish a trade strategy which aligns with the government's industrial strategy, enhances economic security and supports net zero ambitions.

"Boosting trade abroad is essential to deliver a strong economy at home. That's why I've wasted no time taking stock of progress and getting ready to press on with trade talks with our international partners," said Reynolds.

"From the Gulf to India, our trade programme is ambitious and plays to the UK's strengths



to give British businesses access to some of the most exciting economies in the world. Our teams will be entering negotiating rooms as soon as possible, laser-focused on creating new opportunities for UK firms so they can support jobs across the country and deliver the growth we desperately need," he said.

India and the UK began negotiating an FTA in January 2022 under the then Conservative Party government and 13 rounds of negotiations have been completed since then to enhance the GBP 38.1 billion a year bilateral partnership. Reynolds has now set the tone for the new Labour government's plans to not only sign off on a deal, but also to carry on the process from where it was left off in the fourteenth round of discussions amid general elections in both countries.

"India, with which the UK is negotiating a Free Trade Agreement and Bilateral Investment Treaty, is projected to be the world's third largest economy by 2027. A trade deal would give UK businesses better access to its burgeoning market of middle-class consumers, projected to grow to over a quarter of a billion consumers by 2050," notes the DBT.

The announcement follows Foreign Secretary David Lammy's visit to India last week to discuss economic and global security.



'Domestic Airlines Reported **427 Technical Faults In** Aircraft This Year'

NEW DELHI: Eight scheduled 427 incidents of technical faults in their planes this year till July 19, according to official

During the period from January 2024 till July 19, as many as 268 flights of scheduled passenger airlines were cancelled.

The data was provided by Minister of State for Civil Aviation Murlidhar Mohol as part of a written reply to the Rajya

Sabha on Monday. In 2024 till July 19, IndiGo saw 46 incidents of technical faults in its aircraft while the count stood at 51 in the case of Alliance Air. SpiceJet and Vistara had 23 and 44 such incidents, respectively.

Air India's Fleet A saw 152 such incidents while Fleet B witnessed 101 such incidents during the January-July 19,

2024 period, as per the data. Fleet A refers to Airbus planes and Fleet B refers to

Fly Big and Akasa Air had 6 and 4 such incidents during the given period. Together, the total number

of incidents of technical faults in planes of these carriers touched 427 during the period under review.

In 2023, they had seen 453 such incidents, lower than 529 witnessed in 2022.

According to the data, the count stood at 515 in 2021, 421 in 2020 and 640 in 2019.

The data showed that Indi-Go cancelled 49 flights due to technical reasons, Alliance Air (45), SpiceJet (22) and Fly Big (27) this year till July 19.

During this period, Air India Fleet A and Fleet B had flight cancellations of 88 and 37, respectively, due to technical

The officer said that on inquiry, it was found that the bank manager was called by a person who impersonated himself as the owner of Aman Motors and said he urgently needed to transfer funds from his corporate Bank account to another account.

The bank manager, under the inducement and false representation, transferred ₹9.50 lakh to the bank account given to him.

Sensex, Nifty Retreat From Record **Highs To Close Flat**

MUMBAI- Benchmark indices Sensex and Nifty hit intra-day record high levels before closing almost flat on Monday due to profit-taking in FMCG and IT shares by cautious investors ahead of the key US Fed interest rate decision later this week.

The 30-share BSE Sensex closed higher by 23.12 points or 0.03 per cent at 81,355.84 -- its all-time closing high -- with 16 of its components advancing and 14 ending lower.

The index opened higher and jumped 575.71 points or 0.70 per cent to hit a new intra-day record peak of 81,908.43 in late morning deals following a decline in US bond yields. However, investors preferred to book profits at record high levels amid high volatility dragging the index lower to close flat.

The NSE Nifty ended marginally up 1.25 points or 0.01 per cent at an all-time closing high of 24,836.10. During the day, it surged 164.9 points or 0.66 per cent to hit a fresh lifetime peak of 24,999.75.

From the Sensex pack, Larsen & Toubro rose the most by 2.77 per cent after it announced bagging new large orders worth Rs 2,500 crore to Rs 5,000 crore.

UltraTech Cement, which announced the acquisition of 32.72 per cent stake in India Cements from promoters and their associates for Rs 3,954 crore, closed up 1.42 per cent. India Cements closed lower by 0.65 per cent.

4 Killed In 'Mysterious'

"Four people sustained critical injuries when a mysterious blast occurred in the Shair colony of Sopore town today afternoon. The injured were shifted to a nearby hospital where doctors declared three of the injured brought dead. The 4th injured person was shifted to SKIMS hospital in Srinagar, but he succumbed to injuries on the way," an official said.

Sopore SP Divya D confirmed the incident saying, "They were unloading the scrap when the blast happened.. Unfortunately, four people died."

The deceased have been identified as Nazir Ahmed, Azam and Adil Mushtaq. All the victims were reported to be Sher Bagh residents. Police said the ages of the deceased are between 20 to 45 years.

A team of forensic experts rushed to the site of the explosion with no immediate information available regarding its exact nature and cause. Police have taken up the investigation.

Preliminary investigations suggest that the explosion may have been caused by an unknown explosive device hidden within the scrap.

A case has been registered at Police Station Amargarh for further investigation.

Superintendent of Police (SP) Sopore, Divya D, said the police are examining all possible angles to ascertain the cause of the explosion. She described the incident as unfortunate.

The explosion has left the entire area in shock, with a sense of grief and disbelief. Residents have been gathering at the homes of the deceased to offer condolences and support to the bereaved families.

'15 Terror Incidents

15 terror incidents in the Jammu region in the last 50 days, resulting in the loss of lives of 10 security personnel, including two officers, as well as nine pilgrims, and injuries to 58 others.

The security situation ahead of Independence Day was assessed at the meeting, which was attended by officials of various security and intelligence agencies, a Jammu and Kashmir Police spokesperson said.

'There is a necessity to reinforce border deployments and secure police and army establishments. There is also a need for offensive operations, alongside preventive measures in other districts," Additional Director General of Police (Jammu Zone) Anand Jain said.

He also stressed on establishing joint checkpoints at vulnerable locations and inter-district boundaries.

Terror incidents have been reported from six of the 10 districts of the Jammu region -- Rajouri, Poonch, Reasi, Kathua, Doda and Udhampur.

During the meeting, chaired by Jain, the officials called for deployment of reinforcements for the border, highway and hinterland security grids. They also stressed on formulation of comprehensive security plans.

The officials provided a detailed assessment of the current risks and potential threats in the region, and also discussed a coordinated approach to address security concerns.

Jain underscored the importance

He said that intermittent rain, occasional sunny weather and cloudy skies would be observed in Kashmir till the

6th of August. After an improvement in weather conditions, MeT Director Kashmir hoped for more relief to people, especially farmers, from rising

temperatures. Falling of rain after a prolonged heat wave brought happiness on the faces of people, who have been praying for an end to the sweltering

temperatures. However, several areas in Srinagar were waterlogged following the rainfall, which commenced in the city around noon.

Gulmarg recorded a precipitation of 30.8 mm while Tral recorded 28.5 mm, the data shared by an Independent Weather Forecaster. Faizan Arif Keng reveals, adding that Amarnath holy cave shrine recorded a rainfall of 7.5mm while Chandanwari has recorded 12.5 mm rainfall.

Besides, the thundershowers across South and Central Kashmir and some parts of north Kashmir have brought the mercury down, which ended the prolonged heat wave in the Valley.

The maximum temperature in J&K recorded a massive dip of nearly 10 degree Celsius with Srinagar recording a maximum temperature of 27.7 degree Celsius.

Qazigund, a gateway of Kashmir, has recorded a maximum temperature of 28.4 degree Celsius while Pahalgam, a famous tourist destination, recorded a maximum temperature of 24.3 degree

Kupwara was the hottest in Kashmir at 32.0 degree Celsius while Kokernag and Gulmarg recorded a maximum temperature of 28.1 degree Celsius and 20.8 degree Celsius.

In Jammu division, the mercury settled at 33.0 degree Celsius while Banihal recorded 29.8 degree Celsius. Batote, Katra and Bhaderwah have recorded a maximum temperature of 28.3 degree Celsius, 30.1 degree Celsius and 29.2 degree Celsius respectively.

Meanwhile, the weatherman here has predicted generally cloudy weathwith intermittent spells of light to moderate rain and thundershower at many places of Kashmir division and widespread places of Jammu division.

Director Meteorological department (MeT), Dr Mukhtar Ahmad said that in the first seven days of August,

generally cloudy with spells of intermittent light to moderate rain and thundershower at many places of Kashmir division and most places of Jammu division.

Court Dismisses Public Prosecutor Ashwani Khajuria representing the ED vehemently opposed the bail plea and said the applicant has indulged in serious offences of money laundering whereby he is the kingpin of the 'gang' indulging in the paper leakage of the government competitive exams against the monetary payments.

"Moreover, in the ongoing investigation under the PMLA, Yadav's monetary, transactions have surfaced relating to smuggling out the paper, arranging the stay of the candidates in 'Karnal', adjustment of the payments received between himself and Anil Kumar (another key accused) and receipt of payments in the bank account of M/s New Global Fumigation Corporation, proprietor Yadav etc are being further investigated," Khajuria

"Besides, the investigation under PMLA is separate and independent and therefore, the proceedings before the trial Court in the CBI case has no effect on the PMLA investigation conducted by the respondent," he argued.

"Having heard and after consideration of material on record in its entirety and to the nature of the allegations and gravity of the accusation and also stage of investigation, to my mind investigating agency must be given sufficient time in conducting analysed and effective investigation,"

"This apprehension of ED finds force upon the submission made by the counsel that the applicant may influence the witnesses and give slip to law hence in light of supra, the present application deserves to be dismissed," she added.

"It is apt to note that the evil of money laundering is a curse and has its diverse effect on the society and its citizens, moreover money laundering is a serious threat not only to financial system of our country but also to global economy at large which is required to be dealt sternly," the court

It said therefore, in light of supra, given the grave and serious allegations against the petitioner, apart from ongoing investigation, this court is not inclined to grant privilege of bail to the applicant.

However, the applicant's case can be considered on its own merit without being prejudiced by this order at a later stage if there is a change in circumstances, it added.

requirement for promotion consideration under Seniority-cum-Selectivity channel and further for non-IBPS Banking Associates qualifying eligibility screening written test (objective type) is an additional requirement upon qualifying which all non-IBPS Banking Associates with more than seven(7) years of service are then to be in the pool of the Banking Associates IBPS with seven(7) plus years of service to be considered for promotion.

Insofar as the Banking Associates having completed three years of service, be it IBPS or non-IBPS and who on the basis of the seniority are not eligible to join 75% pool of Banking Associates covered under Senioritycum-Selectivity channel, are afforded an opportunity of jump/leap promotion upon their participation in a qualifying examination and thereupon to be comparatively assessed on merits on the selection parameters as provided under clause 5.2, the Court further noted.

".....by holding the action of the respondent No.1-the Bank in subjecting non IBPS Banking Associates eligible for consideration under Seniority cum Selectivity promotion channel, to a qualifying written test not meant for them under the Policy, as illegal, arbitrary and discriminatory, this Court directs the respondent No.1-the Bank to consider the petitioners and similarly placed non IBPS Banking Associates with seven (7) plus years of service for promotion as per assessment envisaged under clause 5.2 to the next post with or without subjecting them to a screening written test (objective type) at its discretion given the fact of number of available promotion posts more and the total number of Banking Associates , IBPS and non-IBPS, less, the Bench added.

A toll-free helpline for de-addiction, 14446 is being maintained by the Government for providing primary counseling and immediate assistance to persons seeking help, it reads.

The Minister informed Navchetna Modules, teachers training modules have been developed by the Ministry of Social Justice & Empowerment (MOSJE) for sensitizing students (6th - 11th standard), teachers and parents on drug dependence, related coping strategies and life skills.

will take this seriously, and players will fight tooth and nail to be out

there," he added.

The Test great had ICC CEO Geoff
Allardice for company during the

discussion at India House here.
"You grow up watching the
Olympics, seeing Carl Lewis winning the gold medal, watching the
great athletes perform. You always
want to be part of great events like
this. The environment, the energy

-- it's a dream come true."

Dravid hoped that India would win both the men's and women's gold medals at the LA Games.

"The dream for me to have a fantastic cricket tournament, hopefully Indian men and women winning the gold which would be nice.

"Unfortunately, I won't be able to play, but I will make every effort to be in LA in some capacity or another. If not anything else, I will try to get a media job," joked Dravid, who ended his tenure as India head coach after the recent T20 World Cup triumph in the West Indies.

The men's and women's cricket competitions will run concurrently at the LA Olympics.

As far as Allardice is concerned, he said cricket will be one of the "star attractions" in LA four years from now.

Vandalism Hits Communication Lines In France During 2024 Paris Olympics

PARIS: The French government says multiple telecommunications lines have been hit by acts of vandalism, affecting fiber lines and fixed and mobile phone lines as cities around France are hosting events for the 2024 Paris Olympics.

The scale of the impact is unclear, as is whether it has affected any Olympic activities. The vandalism came after a rson attacks hit train networks around France on Friday, hours before the Olympics opening ceremony.

Marina Ferrari, secretary of state in charge of digital affairs, posted on X that damage in several regions overnight Sunday to Monday affected telecommunications operators. She said that led to localized



impact on access to fiber lines and fixed and mobile telephone lines.

Paris 2024 Olympics organizers would not immediately comment.

A French police official said at least six of France's administrative departments were affected, which include the region

around the Mediterranean

city of Marseille, hosting Olympic soccer and sailing competitions.

Telecom operators Bouygues and Free confirmed their services were affected. French media reports said lines operated by provider SFR also were hit. The parent company of Free said its teams are mobilized to restore services.

A national investigation is underway into last week's train sabotage, which disrupted travel for nearly a million passengers in France as well as people in London and in other neighboring countries. Train traffic had largely resumed by Monday.

French media reported that an extreme-left activist was arrested at a rail facility on Sunday in the Seine-Maritime region of western France. But the Paris prosecutor's office said it was unconnected to what happened Friday and that no one has been arrested so far in the national investigation into the arson attacks.

Novak Djokovic Eases Past Error-Prone Rafael Nadal

PARIS: Serbia's Novak Djokovic overcame a brief bout of nerves in the second set to beat 14-times French Open champion Rafael Nadal 6-1, 6-4 at the Paris Olympics on Monday and move into the third round.

Djokovic, who has won 24 Grand Slam singles titles but is chasing an elusive Olympic gold, left nothing to chance, stretching the 38-year-old with punishing groundstrokes and perfect drop shots, making him look his age as he raced to a 6-1 4-0 lead.

Nadal, who had dominated at this venue like no other player, managed to claw his way back to level 4-4, much to the delight of the home crowd who were ready for a mouthwatering epic encounter between two of the greatest players to have graced the sport on their record-extending 60th encounter.

Despite his second set comeback, Nadal lacked precision and consistency at this level and could do nothing to stop the 37-year-old Djokovic from sealing victory on his first match point with an ace. (Reuters)
