Whereas, vide reference-i, your firm raised various queries from time to time, and PHO J&K responded to all gueries/clarifications.

Whereas, inspite of timely reply to all the queries and clari fications given by PHQ, VGDS failed to submit fabrication drawing and design for up-armouring of backhoc loaders and tractors (05 nr each) within 10 days after generation of contract i.e., 30.01.2024 which was mandatory in terms to clause 12 of buyer added specific ATC of the tender.

Vide referance-iv, PHQ issued a show cause notice to VGDS to explain why the instant tender may not be cancelled and legal proceedings including blacklisting of their firm be not initiated against the firm for not fulfilling the contractual obligations as stipulated in the GeM contract for up-armouring of Backhoc loader and tractor (05 nr each)

Whereas vide reference-v. VGDS submitted reply to the show cause notice to justify their position

Whereas, the reply to the show cause notice submitted by VGDS was carefully examined and it revealed that many reasons/ justifications had been put forth which were not relevant to the show cause notice. It was further revealed that \ GDS has not put forth any concrete reasons/ justification for not providing the fabrication design and drawing for uparmouring of 05 backhoc loaders and 05 tractors. The fabrication design and drawings have not been provided to the JKP till date, inspitc of repeated requests made by JKP to VGDS.

Whereas, vide email dated 12.04.2024, VGDS has submitted various reasons to justify non-execution of contractual obligations and inability to provide a clear timeline for carrying out fabrication of Backhoc Loaders and Tractors (05 nr each) in compliance to GeM contract nr GliMC-511687728933849 dated 30.01.2024 which were found devoid of merit, and in utter violation of GeM contract terms and conditions as mentioned in table-8 below.

## Hezbollah Searching For The **Body Of Commander Targeted** In Israeli Strike In Beirut

BEIRUT: The Lebanese militant group Hezbollah said Wednesday they were still searching for the body of a top commander targeted in an Israeli strike in Beirut.

The Iran-backed group's first comment after the strike targeting Fouad Shukur came hours after his death Tuesday and followed an overnight strike in Tehran that killed Hamas leader Ismail Haniyeh. Hezbollah did not comment about the Hamas leader's death.

Israel claimed late Tuesday that they had killed Shukur, who they said was behind a rocket attack on Majdal Shams in the Israeli-occupied Golan Heights that killed 12 youths

An Israeli drone strike in Beirut's southern suburb of Haret Hreik has targeted Fuad Shukr, head of Iran-backed Hezbollah's military operations room, who is considered the No. 2 in the group. The attack left the targeted

residential building damaged. Hezbollah said civil defense

workers were still searching for his body and others under the rubble of the building Israel struck.

Like most of Hezbollah's military officials, little is known about Shukur, who was also known as Sayed Mohsen. Washington blames him for planning and staging the truck bombing of a Marine Corps barracks in Beirut that killed 241 American service members in 1983. US Treasury Department had offered a \$5 million reward for information about him.

The Lebanese Health Ministry said that at least two children and a woman were killed in the attack, while 74 others were wounded.

The attack, which took place shortly before 8 p.m. local time, came against the backdrop of Israeli threats to deal Hezbollah "a painful blow" after Israeli officials held the group responsible for the bombing of a football stadium in the town of Majdal Shams in the oc-

Hospital. Dozens of ambulances and fire engines rushed to the scene amid the thick dust, broken glass and debris in the surrounding streets, while Hezbollah set up a security cordon around the area.

Residents took to the streets, some in a state of panic believing that the area was being bombed, while hundreds of young Hezbollah supporters chanted slogans in support of the group, threatening Israel with a response.

The Israeli military said 15 projectiles had been fired across the Lebanese border, with impacts in parts of the Upper Galilee region. No injuries were reported.

Israel's Channel 13 was quick to confirm the attack on the southern suburb of Beirut and said that it was carried out by a drone that had fired three missiles

Israeli media published a photo of Shukr and said that "the Israeli army has set a reward of up to \$5 million for information on Fuad Shukr.'

Officials, including the UN's chief coordinator in Lebanon, have stepped up their efforts to prevent a deterioration in the situation.

Israel's Channel 12 quoted an Israeli official as saying that "Israel has no intention of starting a regional war, and the ball is in Hezbollah's court. If it does not respond to the attack, we will not be dragged

into a war. The Israel Broadcasting Authority said: "The decision on the target of the attack on the southern suburb of Beirut was made last Sunday after Benjamin Netanyahu's return from the US.

DUBAI: The assassination of Hamas leader Ismail Haniyeh in the early hours of Wednes day morning in Iran drew regional and global reactions, raising fears of wider escalation in a region shaken by Israel's war in Gaza and a wors-

## World Just Saw Its Hottest Day Ever, Here's How It Was Analysed

n Sunday, July 21, the world had its hottest day on record. Just 24 hours later, that record broke again making last Monday very likely the hottest day in thousands of years.

It may seem improbable for scientists to gauge the world's hottest day given that they don't have temperature monitors in every corner of the world and less than a century of relatively widespread observations. But they've developed a technique that's increasingly useful as the planet heats up. This month's shocking

heat findings, announced by the EU's Copernicus Climate Change Service, are based on "reanalysis," a technique that mixes temperature data and models to provide a global view of the climate. The center creates a nearly real-time picture of the Earth's climate, including temperature, wind and precipitation, for (roughly) every 30-square-kilometer chunk of the planet's surface.

This reanalysis goes back to 1940, and it allows research ers to say with confidence when a record is broken, whether for a day, month or year. Beyond the new daily heat record, the data also shows that 2023 was the hottest year ever recorded and that every calendar month for the past 13 months has been

the hottest on record Though there aren't thermometers in every corner of the world, Copernicus receives a large amount of weather data that it uses to underpin its reanalysis. "We have this constant flow of information coming into the center," says Carlo Buontempo, director of the Climate Change Service, which is part of the European Centre for Medium-Range Weather Fore-

casts (ECMWF). Scientists at the center receive 100 million readings per day about weather conditions from around the world. Observations come from airplanes, satellites, ships, radar and surface-level weather stations - all feeding real-time information about temperature, wind, rain and snow information, as well as other factors like air pollution. This information is fed into a model, known as ERA5, which is already equipped with historic information about the global climate.

There are gaps in these observations because the data sources don't cover every part of the world. Weather conditions like cloudy skies may also reduce the amount of data coming from sources like satellites. To fill these gaps, the scientists take the predictions they have already made, based on the long-term ERA5 model, and test them against the observations. That means a forecast that predicts a particular temperature in a particular place will be tested against all the data researchers receive about the weather in that place and nearby, as well as broader forces like ocean currents and air circulation.

This is done repeatedly while assessing how compatible the prediction is with what's actually been recorded. The model also accounts for any errors in the recorded data, and relies on the laws of physics, including the weather patterns, currents and airflow that govern how the global climate works.

In this way, it's possible to create a complete picture that is as accurate as possible. That's what allows scientists to confidently declare records like when the world experiences the hottest day in human history.

Globally, five weather services - the US's National Oceanic and Atmospheric Administration and NASA, the ECMWF, the China Meteorological Administration, and the Japan Meteorological Agency - carry out continuous appraisals of global temperature using this technique. While their models differ slightly, the five groups have come to similar conclusions about record heat in recent months and years.

"The most difficult period of confrontations is beginning in the region," he wrote on Telegram.

ehran: During Ismail Haniya's last hours in Iran, a close ally of Hamas, he was smiling and clapping at the inauguration ceremony of the new President Masoud Pezeshkian. Photos showed him seated alongside leaders from the Palestinian Islamic Jihad. Lebanese Hezbollah and Ansarallah of Yemen. Iranian media showed him and President Pezeshkian warmly greeting each other. Haniyeh was also shown embracing Ayatollah

Khamenei by TV channels. Later Haniyeh visited a theme park exhibition featuring 'Axis of Resistance' landmarks just hours before his assassination. He was seen alongside Palestinian Islamic Jihad leader Ziad al-Nakhaleh.

The 'Axis of Resistance' is an Iran-led coalition of groups, including Hezbollah, Hamas,

Houthis and allied forces in Syria and Iraq. This coalition aims to counter Western influence, particularly from the US and Israel, in the region. The alliance seeks to counteract what it dubs as aggression and interference by these powers, advocating for a Middle East free from external control. Iran plays a central role in providing significant military aid, training, and funding to other members.

The Iranian media has released a video of Haniyeh's visit, hours before his death. He was seen talking to reporters.

Hamas has blamed Israel for the attack. "This assassination by the Israeli occupation of Brother Haniveh is a grave escalation that aims to break the will of Hamas, senior Hamas official Sami Abu Zuhri said in a statement.

## **MLAs From Party Disagree**

Panaji: Goa BJP MLA Premendra Shet's demand to ban alcohol consumption in the coastal state has found no takers among his colleagues in the legislative assembly.

Speaking in the House on Tuesday, Shet had said, "For 'Viksit Bharat' and 'Viksit Goa', the consumption of alcohol should be banned in Goa. We can produce alcohol in the state and export it to other states, but its consumption in Goa should be banned." To buttress his point, the first-time BJP lawmaker,



representing the Mayem assembly constituency in North Goa, said people die in accidents on roads and also in industrial units mainly due to increasing alcohol consumption in the state.

However, his House colleagues didn't seem convinced with his demand.

Speaking to reporters on Wednesday, BJP woman MLA Delilah Lobo wondered whether Shet wants people to shut down their restaurant businesses.

"Alcohol is also one reason why tourists come here. What shall we do... shall we close down the restaurants?," asked Lobo, who along with her husband Michael Lobo (Calangute MLA). owns a chain of hotels in the coastal belt of North Goa.

AAP MLA Cruz Silva said it is not possible to ban alcohol in Goa. "Accidents are reported on the roads here but Goans are not involved. There are so many restaurants and other businesses that are dependent on the sale of alcohol. Ban on alcohol will affect employment," he said.

BJP MLA Sankalp Amonkar said he was concerned about alcohol abuse and had raised a question in the assembly earlier over de-addiction centres for chronic alcoholic patients in the state, but he didn't agree with Shet's views.

We have seen people getting addicted to alcohol. I have seen that among my friends and a few (of them) lost their lives to this addiction. But it is not possible to ban alcohol in Goa," he said.

## Just 17 Godowns Built For **Agricultural Produce In 23 Years**

SRINAGAR: The Jammu and Kashmir government has built only 17 godowns for farmers and other beneficiaries in the union territory (UT) under the Agricultural Marketing Infrastructure (AMI) scheme since its inception on April 1, 2001, per official data accessed by the news agency–Kashmir News Observer (KNO).

These godowns, or storage infrastructure projects, were built between April 1, 2001 and June 30, 2024 and have a storage capacity of 98,027 MT. The central government also pro-vided a subsidy of Rs 8 crore for warehousing facilities in Jammu and Kashmir under the AMI scheme.

Lack of storage facilities is the major issue facing the farm-ers in J&K, which has about 3.3% of the total geographical area under cultivation and has a foodgrain production of 1.5 million metric tonnes, per the Indian Council for Agriculture Research (ICAR).

The UT is also a major producer of apples, which are cultivated on 1.08 lakh hectares with a production of 1.1 million metric tonnes

Separately, Gujarat built the most godowns (12,376 with a capacity of 60 lakh MT) under the AMI, followed by Madhya Pradesh (8,324 with a capacity of 2.8 crore MT).

Arunachal Pradesh and Goa, on the other hand, fared poorly under the programme, with only one warehouse erected in 23 years with storage capaci-

ties of 945 MT and 299 MT, respectively.

In the last 23 years, the AMI scheme has helped set up 48,512 godowns and warehouses across the country, totaling 93.99 million MT in capacity. A subsidy worth Rs. 4,734.73 crore has also been provided.

The AMI is a sub-scheme of the prestigious Integrated Scheme for Agricultural Marketing (ISAM), under which the Union Ministry of Agriculture and Farmers Welfare assists states and union territories to enhance agricultural marketing infrastructure. It also aims at creating scientific storage capacity and promoting pledge financing to boost the farmer's income. Under the scheme, the Cen-

tre provides subsidies at rates of 25 percent and 33.33 percent on the capital cost of the project based on the category of eligible beneficiaries.

Assistance is available to individuals, farmers, groups of farmers/growers, agri-preneurs, registered farmer-producer organizations (FPOs), cooperatives, state agencies, etc. The scheme is demand-driven. Further, the government has approved a Central Sector Scheme of Financing Facility, viz., the Agriculture Infrastructure Fund (AIF), to provide medium-long-term loan facility for investment in viable projects for post-harvest market infrastructure, including warehousing facilities and community farming assets, through interest subvention

## **West Pak Refugee Families Celebrate Conferment Of Proprietary Rights**

JAMMU: West Pakistan Displaced Persons on Wednesday celebrated the approval of Lieutenant Governor Manoj Sinha led Jammu and Kashmir administration to grant them proprietary rights on state land. The administrative council, which met here under Sinha's

chairmanship on Tuesday accorded sanction to grant proprietary rights on state land in favour of West Pakistani displaced persons along with displaced persons of 1965.

This shall significantly empower thousands of (refugee) families across Jammu region...the decision fulfills demand of all connected families, which have been requesting for ownership rights since the past so many decades," an official spokesman said.

Post J&K Re-organization Act 2019, domicile rights have been conferred by the Centre to the West Pakistan Displaced Persons.

"Vesting of proprietary rights to West Pakistan Displaced Persons on State land would bring them at par with the displaced persons of Pakistan-Occupied J&K and their long pending demand will also be fulfilled," the spokesman said

The administrative council also approved conferment of proprietary rights upon displaced persons of 1965 in respect of state land

The government has always remained committed to provide benefits to the displaced per-



sons of 1965 as has been granted to displaced persons of 1947 and 1971, the spokesman said.

He said the revenue department shall ensure that proper safeguards are built in the operational guidelines to prevent any misuse particularly unauthorized encroachments on the state land.

Pakistan Refugees Action Committee president Laba Ram Gandhi thanked the Lt Governor for the decision and said the news has brought smiles on the faces of the community living in different parts of Jammu for the past over seven decades.

"We are very happy about the development. The land was already with us, some of which was given by the government for our settlement or earned by our people through hardwork. Some two years back, the land was taken away from us and included in state land," Gandhi said.

Gandhi, who led a celebratory rally at Maharaja Hari Singh Park, said the decision of the Lt Governor adminis-

tration came as a big relief to the community which was left disappointed and approached the government for redressal of their grievances.

"With granting of proprietary rights over land, we are now the true citizens of Jammu and Kashmir," he said, adding as per the official records. there were 5,764 families who migrated from West Pakistan into India and settled in Jammu and Kashmir in 1947.

Gandhi said over 46,000 kanals of state land was given to the displaced community, which had always felt discriminated against before the abrogation of Article 370 in 2019.

"Before 2019, we were only eligible to vote in the parliamentary elections and had no say in assembly or local body elections. The time has changed and we have got our genuine rights. We can now vote in panchayat and assembly polls and even put up our candidates," he said.

They distributed sweets and raised slogans in praise of Prime Minister Narendra Modi and Sinha.

Several aspirants said that results of BSC nursing for which around 24000 candidates had applied were declared on 13 June 2023.

They said that since then they have been waiting for counselling to get their college placements. An aspirant Ayyan Ahmad told KNO that exams of many

other courses were held after BSC nursing but counselling for those courses has already been conducted. He said that due to unknown

reasons, authorities have been resorting to dilly dally tactics.

Aspirants said that waiting for a long time is taking a toll on their

#### mental health as by delaying the counseling process they are putting their future in the lurch. 'Many seats are vacant and can be filled through the counseling

process but as of now they haven't done it," they said. They said that the admission process goes under the guidelines

of INC and once the last date is over, then no college provides them admission.

He said that in this process both aspirants and private colleges suffer as colleges can't give admissions after the last dates are over. When last dates are close, authorities conduct a round or two of counselling and most of the students are unable to take admissions anywhere thereby forcing them to lose one year, they added. They said that they have brought these issues into the notice of concerned authorities several times but to no avail. -(KNO)

**Medicines Worth Lakhs Dumped** In Washroom In Gurez Hospital

BANDIPORA: The expired medicines worth lakhs of rupees have been allegedly dumped in washrooms at New Type of Primary Health Center (NTPHC) in Bagtore village of Gurez.

Expired medicines, including Tab. Iron Folic Acid, Tab. Cefuroxime 500, Tab. Folic Acid, and Tab. Acetylcystine was discarded in the hospital washroom to conceal the hospital's wrongdoing.

"We have to suffer for every single tablet here. In Gurez, the women mostly face iron deficiency, but the authorities prefer expiring the medicines instead of providing it to the people," Aijaz Ahmad, a local resident said.

He appealed to the district administration Bandipora and Lieutenant Governor Manoj Sinha to investigate the matter and take action against the doctors, who are found involved in this practice.

In border areas of Kashmir, the people have been demanding better health care facilities for a long while several protests have been witnessed in the past, but according to them, their voices went unheard.



The locals alleged that the shortage of medicines in these border areas forces them to travel 80 km for the want of a normal medicine, but at the same time, the medicines are not provided to the people here, which exposes the seriousness of the administration in ensuring better healthcare facilities.

In Kashmir valley, around 66 percent women are facing anaemic deficiency while a huge number of such women belong to the border areas.

Meanwhile, repeated attempts to contact Block Medical Ôfficer (BMO) Bandipora Dr. Tahira Nazir failed as she didn't receive the phone calls.

However, the Chief Medical Officer (CMOP) Bandipora refused to speak in this regard-(KNO)

### Anantnag Woman Turns **Entrepreneur** With **Beekeeping Venture**

ANANTNAG: A 35-year-old woman is emerging as a successful businesswoman by running a beekeeping venture, providing several quintals of honey each year, and earning a handsome amount annually.

Nusrat Jan, wife of Nazir Ahmad and a resident of the town of Hillar Shahabad in south Kashmir's Anantnag district, was married immediately after passing the tenth grade. However, her determination and continuous effort have propelled her to entrepreneurial success.

At one time, Nusrat never imagined she would start a business, but with passion and the full support of her inlaws, she stepped out of her home and began a beekeeping venture.

"We had been thinking for two years about how to expand the business. Then we got a government loan and bought a processing plant. My husband was already associated with honey bee farming, and it took me seven years to learn all the processes. Now, our business is flourishing." Nusrat said.

Today, under the name "Rahat Organic Honey", several stalls operate in various locations.

Despite numerous challenges, she never gave up and continued her work diligently. Nusrat said that if her husband had not supported her, it would have been difficult to continue. "Initially, I had very few bee-

keeping boxes, but now I have 400 boxes, which provide several quintals of honey each year," she said, adding that to bring more transparency to her business, she installed a filtration machine last year, which led to further growth.

Nusrat believes that working as a woman in Kashmir is particularly challenging because more people discourage rather than encourage. However, the situation is gradually changing, with women showcasing their abilities in various fields, she added.

"With determination and passion, anyone can start a small business. Although beekeeping is a small enterprise, I am satisfied with my work,' she said. "Initially, very few people visited my stalls, but now the number of customers is increasing daily."

Nusrat is also a responsible homemaker. She manages all her household responsibilities and then goes to her factory to oversee her work. "I am managing both my home and my business. Initially, a woman fears stepping into a maledominated field, but there is nothing to worry about. You have to overcome the fear. This work is male-dominated in Kashmir, which I am now handling well," she said.

After installing a filtration plant in Hillar Shahabad, she set up stalls on the Dooru Verinag Road and Anantnag Kokernag Road, which are receiving a good response. –(KNO)

JAMMU: Even though the commuting on Jammu-Srinagar national highway (NH-44) has improved a lot with completion of work on several tunnels and four-lane portions, people will have to wait till end of the year 2026 when the work on the highway will be completed.

With every passing day the road connectivity is being improved and travel time between the two capitals have been reduced to six hours.

The 300-km-long NH-44 is the lifeline of Jammu and Kashmir where everyday thousands of vehicles commute between Srinagar and Jammu and vice-versa. Besides being used by locals of Jammu and Kashmir the NH-44 is being used by security

convoys, tourists, pilgrims and truckers carrying goods thus making it one of the busiest roads in the country. The four-lane road is being built at a cost of Rs 16,000 crore and out of this four-laning of 210 km route has been completed, including 10 tunnels of 21.5 km and several crucial bridges and one Ramban Viaduct.

Officials told KNO that there are still five to six major parts where the work is undergoing and will take some more time to get completed. These areas include Banihal town bypass stretch, Ramsu to Khari-link road stretch and beyond, Khooni Nallah to Digdol tunnel, Digdol to Makarkoot tunnel and one stretch near Ramban town, which are taking some more time. One portion near Dalwas is also under construction and a bridge is being constructed there Agencies

PULWAMA: Despite elapsing ten years, a vital bridge on Romshi rivulet in Rohmoo village of Pulwama district is awaiting completion, thereby leaving the locals to lurch at large.

Locals from Rohmoo area said that the Romshi Bridge got washed out during 2014 floods and since then, the people of this area have been facing hardships as the authorities have failed to complete this bridge till yet.

Mudasir Ahmad, a local resident said that this bridge connects Pulwama district with neighbouring Budgam district and is of vital importance but most of the time, the work on the bridge remains on halt due to which it is incomplete for the last 10 years now.

## **Fresh turmoil** in Gulf

he killing of Hamas political chief Ismail Haniyeh in an alleged airstrike at his residence in Tehran has added fresh fuel to an already explosive situation in the Gulf region. Haniyeh was on a visit to Iran to attend the swearing in of Iran's president Masoud Pezeshkian. The assassination has put the latest Israel-Palestinian confrontation on the road to a dangerous escalation with Israel signalling its readiness to launch a ground assault. So far the war has claimed around 40,000 Palestinian lives, among them women and children. Images of war circulating on the Internet has laid open its grotesqueness and spawned anger and outrage. However the world has mostly watched on as the conflict piles up sufferings for the Palestinians. What has been most tragic is the raft of horrors that have been visited upon the children, around 14,000 have been killed so far. But this has hardly helped draw sufficient global sympathy for the Palestinian cause, at least from the western governments. Instead the west has generally drawn a proportionality between Israeli invasion and the Hamas' October 7 raid.

There has been no commensurate outrage as Israel's military machine has gone on killing Palestinians and driven lakhs out of their homes. This is now a recurrent story. The tragedy is repeated and everytime Israel gets away with it. This is dangerous. For the past 76 years, the Palestinian conflict has been the biggest source of Muslim radicalisation in the world. In a world which has been further shrunk by the new communication technology, the scenes of Palestinian deaths and destruction are triggering shock and outrage at a scale unlike ever before. Haniyeh's killing has created a fraught situation. It is difficult to see how the situation cannot escalation and suck the region into a devastating war. It is tragic that the US as the still sole pre-eminent power in the world has done precious little to stop the conflict. In fact, the US president Joe Biden has, in a sense, egged on Israeli president Netanyahu to pursue his apocalyptic goals. And now the situation has reached a point of almost no return.

This casts a responsibility on the major powers to act fairly and reign in Israel and also take firm steps to resolve the conflict. More than anything else, a resolved Palestine will go a long way to help the cause of Mideast peace and also terrorism at the global level.

# **Is International Law Significant** for Dispute Resolution?

nternational law refers to the body of legislation that governs relations between States. International conflict resolution is the process of controlling or settling disputes between nations so they can each pursue their own objectives, whether they be collective or personal. States are acknowledged as the actors within the legal system by the framework provided by international law. It describes what they have to do to treat people living inside their borders and how they should interact with one other. These duties cover a wide range of topics, including the use of force, behavior during hostilities, immigration and refugee concerns, international criminal activity, disarmament initiatives, and prisoner care.

International law also regulates operations, international space commerce laws, global communication networks, sustainable development strategies for the oceans, and the environment. A treaty is an international agreement signed between States that is subject to international law, regardless of whether it is included in a single document, two or more related instruments. or known by another name. ## **The Illusion of Identity** Why is the modern characterization of identity misleading?

Identity has been both a source of conflict and a source of progress. The very sense of identity gives rise to a feeling of belongingness, which promotes community spirit and progress at large. At the same time, the very sense of identity can give rise to a kind of exclusivity attached to associating with a particular denomination, be it religious, cultural, political, etc.

During the partition of the country, the very negative side of identity manifested in the form of widespread bloodshed, especially in areas along the border, with huge damage borne by each side. Amartya Sen recalls an incident of communal violence when he was 11 years old in 1947. About that time, a Muslim man named Kader Mia had been out in search of work because he had nothing to feed his family. The very sight of the incident, which had taken the life of Kader Mia, was extremely depressing for Amartya Sen, and using that as a conundrum, Amartya Sen decided to write a book called 'Identity and Violence'.

Defining identity is a complex task that needs the best scholarship. However, we have had a lopsided characterization of identity, which has gotten influenced by the west, and there is a need to look at the alternatives to identity in the sense that identity is not a static concept; it changes its nature and form with a change in the culture and the circumstances at large. However, Samuel Huntington is said to have perpetuated a particular sense of identity that is based on the very edifice of civilization, implying that civilization is the epitome of identity. While that may be true, it is limited in its extent in the sense that the thesis has invented the past by trying to paint the west with so-called phrases such as civilization and freedom, which is ahistorical.

On the one hand, we have had the Michael Sandealian view of identity, which says identity is who we are and what we discover and is given. There is, however, both a problem and a merit in the diagnosis, to the extent that the positive of the same approach is basically rec-ognizing a multitude of cultures and sharing a common lifestyle-communitarianism, so to speak. On the other hand, it is limited in its definition of the word identity, which is given in the approach. There is always a tendency for culture to change course, but that is something that is not recognized by this approach, consequently accepting various regressive aspects of society as they are and not being critical about them, as Amartya Sen has argued in his book 'The Argumentative Indian'. Other than this approach, we have had the one by Amartya Sen, which is thought-provoking and needs appreciation

Samuel Huntington, in his book 'The Clash of Civilizations' makes a case for the allegedly superior position of the west, highlighted by its



intellectual sojourn in the form of the Enlightenment, the Industrial Revolution, etc. There is an attempt to define the world community as a federation of various communities identified on the basis of the major classificatory distinction, which is religion, into the Hindu civilization, the western civilization, the Islamic civilization, etc.

After doing the compartmentalization of the world into a band of exclusive identities, there is automatically fuel given to the conflicts that manifest in the form of war against terror, which has always been against a specific community, and trying to set a definite narrative about a specific religion, which is biassed and poised to create chaos among people of socalled distinct identities. Samuel Huntington's argument is somewhat wrong, keeping the seven deadly sins committed by him aside, one of which is maligning Islam, and showing the west in the so-called fatherly position.

With regard to India, his diagnosis of India being a Hindu civilization is misguided for various reasons. We can't really call India a Hindu civilization with a bleak glimpse of the historical past, which is quite contrary to the thesis, so to speak. The argument overlooks the influence of other sects such as Muslims, Sikhs, Buddhists, and Jainism on the Hindu way of life. The said thesis has basically given intellectual fuel to the Hindutva movement, which has based its case on transforming India into a Hindu state, which is ahistorical. It basically overlooks the participatory and plural nature of Indian society, which has been dominated by both Muslim and Hindu rulers. We had Asoka, who had made efforts at organizing various Buddhist councils, the last being at Patliputra, which basically served as a platform where various sects could engage in a discursive space, and he had made sure not to interfere in any religion at that time. We

also had Akbar, who is known for his religious tolerance, who abolished the jizya and made efforts to develop a synthetic religion called Din-e-ilahi by drawing on the best principles of each religion. His commander of the army was Hindu, and his brother Darah Shikoooh had studied extensively the Hindu scriptures. Saying that India has been a Hindu civilization overlooks the interactive role of 125 million Muslims in the making of Hindu culture, etc. We have had Rabindranth Tagore, who said that he was proud of his culture being a confluence of three cultures: Bengali, Muslim, British, etc. With regard to the painting and maligning of Islam, he is misguided too, by miniaturizing Muslims and painting them with negative connotations. His thesis is a simplistic reading of history, underestimating the role of various Muslim scientists, mathematicians, etc. We have had accounts of the Arabs transporting the knowledge of astrology, astronomy, medicine, and mathematics to the whole world. Saying that Islamic civilization has been regressive is biased to the extent that it bases religion as a factor for classifying Muslims, which is solitary and reductionist, as an approach. In the same way, there's always been a simplistic reading of human psychology to indicate that it is selfish, negative, etc.

We can comfortably say that the western scholars adopt an egoist and a passionate approach towards studying everything, which confirms the contention that they are always in ivory towers. Amartya Sen, in his book, comes up with a rather new approach, which is against cultural determinism. He calls identity a matter of choice, juxtaposed to the usual diagnosis of the discovery aspect of identity. Just because one is born in a specific community does not mean that it becomes his natural identity, which implies that the levers of reason have to be applied to critically scrutinize each and every facet of the tradition instead of stumbling and having a conformist kind of attitude. He continuously quotes the example of Akbar, who is said to have said that it is the reason that must triumph over the unquestioned tradition. Amartya Sen, during his childhood, told his grandfather, 'I have no feelings whatsoever for religion. What should I do?" The reply was that it would come naturally with the course of time. However, it did not come, and Sen says that it was because he used the weapon of reason to critically analyze each religion. We had had a partition, the basis for which were allegedly two distinct identities that were said to be exclusive to each other. One surprising fact, however, is that it was VD. Savarkar who gave the call for the two nations before Jinnah's two-nation theory. However, invoking only religious identity was a major fault. It is wrong to characterize the nation into two clear-cut compartmentalized sects, because our other identities include being poor, rural, female, male, community, etc. Why precedence was given to religion is biased. Other identities could have been invoked to develop a sense of unity and bring peace.

However, the argument always runs that religion is a dominant classification by which we categorize people. According to Amartya Sen, there is also the role of reasoning in arriving at the identity a person chooses. It is incumbent upon everyone to use critical arguments to weigh the relative importance of the form of identity, whether precedence is to be given to religion, solidarity, human fellowship, poverty, etc. It is always the case that a man is a mixture of various identities, and attaching a single one is misleading and misguided. I will illustrate it with an example that is supplied by the very simplistic implication of Asian values as opposed to western values. Lee Kuan Yew is the champion of Asian values, especially for the eastern part of Asia, and has supported the prominence of the authoritarian form of government on the basis that it gives a boost to economic growth. What it has done is a simplistic reading given by the West to say that the East is regressive because it supports authori-tarianism. That is too ahistorical, by trying to generalize the Lee thesis to the whole of Asia, or the east, for that matter. For example, the origins of Indian secularism are said to be from the west, which is wrong, as it has had the influence of Akbar and Asoka and is diametrically opposite to the western counterpart of secularism. Asia, in particular, has its history of the civil state, and it is a strong fact that China and India laid the foundations of western globalization by supplying knowledge of astronomy, trade, etc. to the west. We had Alberni, who in the 12th century extensively studied and appraised Indian culture, especially Aryabhatta, Brahmagupta, Ramanujan, etc., who had made huge strides in the scientific discipline.

There is, however, a dichotomy that is al-

ways shown as Eastern values vs. Western values, which is very naive and wrong. So, only the western identity should not be characterized by the so-called fancy phrases as free and civil. A major source of western civilization is the Roman and Greek civilizations, which unfortunately were not truly civil in the conventional sense that everyone was given equal and full citizenship rights, as evident in Aristotle's diagnosis of body polis. However, with the rise of post-colonialism and decolonization, there is an ongoing resistance to modernism, which has always been called a project of the west to perpetuate hegemony over the former colonies, in the form of Neo-imperialism. How much of it is true is really an interesting question. However, there is somehow no credibility in the argument, which even calls for a wholesale protest against the flow of ideas, culture, etc. There is nothing imperialistic about liberty, freedom, or the spread of culture and ideas across the world. The very spread is not detrimental to the welfare of the poor countries, but quite the contrary. Second, just like the flow of ideas from the east to the west from the 10th century onwards supported the flourishing of the west, in the same way, the flow of cutting-edge technologies and ideas from the west to the east will wake them up from the deep slumber of poverty, deprivation, etc. The question is not whether markets are efficient; the question is rather whether the international power system is balanced or imbalanced, in the form of trade restrictions, arms trade, etc.

Globalization as a project has been good, but the institutional mechanism has largely failed. We can conclude by saying that identity does not work in silos; it is always an amalgamation of different identities, which characterizes man and identity at large. Also, there has to be an end to the debate about western superiority, as that is meant to give rise to sectarianism and conflicts. The failure of the UN is a clear indication of the same. There is a pressing need to revisit the kind of identity that the leaders want the world to lock into, which should promote the welfare of everyone, and to look at the world as a kind of collection of people, not a federation of exclusive communities. The very idea of dividing people on exclusive lines leads to both identity disregard, which makes man economic, and consequently conflicts for various resources. It also fits a person into only one identity, which is simplistic and misleading. The idea of debating whether Western values are regressive in nature has taken much of the time of these poor countries, which has led to a failure on their part to delve into various alternatives. The very idea of engaging these countries intensely in this rhetoric is very much a project of the West.

Anand, a writer and senior journalist. The Prohibition of Electronic Cigarettes (Production, Manufacture, Import, Export, Transport, Sale, Distribution, Storage and Advertisement) Act, enacted in 2019, bans all such products, including ecigarettes and vapes.

This law was implemented as India was already the second-largest market for tobacco, attracting many US-based companies looking to tap into the Indian market for vapes and e-cigarettes.

Kanoongo, head of India's child rights body, emphasized that India has a huge young population. Every fifth person is an adolescent (10-19 years), and every third is a young person (10-24 years).

At least two million new people start using tobacco products every year, causing approximately 1.3 million deaths and con-



tributing to more than one per cent of the GDP burden annually in our country.

"Estimates suggest that the ban on these new nicotine products will prevent at least five percent of our young population from becoming addicted to either these nicotine products or both nicotine and tobacco products. This ban has potentially saved at least 24 million young people from addiction, significantly protecting the health and development of our country," he added. Dr Naveen Thacker, President of the International Pediatric Association (IPA), voiced concerns about the tobacco industry's tactics.

"The industry is falsely promoting e-cigarettes and vapes as 'healthy' and harmless alternatives to traditional tobacco, with a relentless focus on targeting the youth. This is a blatant lie. These products are just as harmful, and their deliberate targeting of children is unmistakable," he stated.

Dr Thacker underscored the critical need for heightened awareness among children and parents to prevent the use of these hazardous products among young people. "The industry uses social media and e-commerce platforms to trap young children, leveraging influencers and even experts to lure them.

Their targeting of young people is evident with flavours like bubble gum and sugar candy, being illegally sold in 6,00 enticing varieties. The misconception that they are safer than traditional tobacco must be eradicated," he added.

Dr Sudhanshu Kumar, Associate Professor at the National Law School of India University, Bengaluru, remarked, "The industry consistently argues against such legal provisions, claiming they will reduce government revenue and promote the black market. However, saving lives must take precedence, and this approach is the only effective solution. Many other countries are now striving to follow our lead."

He asserted that stringent regulations are crucial to safeguarding the population from the dangers of e-cigarettes and traditional tobacco products.

"Our commitment to these regulations must remain unwavering," he added.

Dr Pragya Shukla, Head of the Department of Clinical Oncology at Delhi State Cancer Institute and a renowned public health expert, emphasised the importance of countering industry tactics that portray e-cigarettes as healthy and market them to children.

## 'Neurodivergent Children More Likely To Develop Chronic Fatigue As Teen'

Children more likely to be diagnosed with neurodivergence, such as autism or ADHD, are at twice the odds of experiencing chronic disabling fatigue in late teenage, thereby "dramatically" affecting their quality of lives, a study has found. In attention deficit hyperactivity disorder (ADHD), one has shorter attention spans, along with displaying restlessness and impulsive behaviour.

Researchers explained that neurodivergent children often experience heightened stress levels. As a result, the increased inflammation could be contributing to chronic, or persistent, fatigue -- one of the many often seen to co-occur with neurodivergence.

Other conditions can include the chronic pain condition, fibromyalgia, and digestive and gut issues. Fibromyalgia is marked by muscle pain

rodivergent children experience higher levels of loneliness and are more likely to be bullied.

These children are also more vulnerable to pain, owing to differences in their pain perception when compared with the general population, along with malfunctions in the dopamine system, known to be involved in cognition and motivation, the authors said in the study published in the British Medical Journal

#### filled out questionnaires, the responses to which were used for developing an autism or hyperactivity score, respectively. While a higher autism

score indicated more chances of diagnosis, a higher hyperactivity score was indicative of greater behavioural issues, including conduct and emotional ones.

Once the children turned 18, they were asked to complete a questionnaire for assessing their chronic disabling fatigue, involving questions around their energy levels and motivation. The researchers received over 4,500 responses.

Children indicating autistic traits at age seven were about 78 per cent more likely to experience chronic disabling fatigue when they turned 18, while those showing ADHD-like behaviour at age nine were over twice as likely to experience the condition in late teenage, the authors found.

### Study Finds Unique Patterns Like 'Fingerprints' In Brains Of People Born Blind

In people born blind, the primary visual cortex, the brain's region known to process visual information, develops unique patterns different from those in people with sight, researchers said, likening these patterns to an "individual fingerprint." They said that the connectivity in the visual cortices of people who can see did not show such varied changes and were "usually fairly consistent."

"The connectivity pattern in people born blind is more different across people, like an individual fingerprint, and is stable over time -- so much so that the individual person can be identified from the connectivity pattern," said lead author Ella Striem-Amit, an assistant professor of neuroscience at the Georgetown University, US.

The study, published in the Proceedings of the National Academy of Sciences (PNAS), included a small sample of people born blind, who underwent repeated functional MRI scans for over two years. Upon analysing the scans, the researchers found the unique connectivity patterns showed "remarkable stability" over time. "Our study found that these patterns did not change significantly based on the task at hand -- whether participants were localising sounds, identifying shapes, or simply resting. Instead, the connectivity patterns were unique to each individual and remained stable over the two-year study period," said Lenia Amaral, a postdoctoral researcher at the Georgetown University.

The findings suggested that life experiences shape the different ways in which one's brain develops, especially if they grew up without being able to see, the authors said. "Brain plasticity in these cases frees the brain to develop, possibly even for different possible uses for the visual cortex, among different people born blind," Striem-Amit said.

In the last four trading sessions, the BSE benchmark jumped 408.62 points or 0.50 per cent, making investors richer by Rs 5.45 lakh crore.

Investors' wealth climbed Rs 5,45,337.02 crore in the past four days to reach a record high of Rs 4,62,38,008.35 crore (USD 5.52 trillion) on Wednesday.

The irrational exuberance of the retail investors, particularly the newbies who entered market after the Covid crash, will do more harm than good to the overall market in the long run," V K Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said. ## FM Says Budget Balanced, **Takes Care Of All Segments**

NEW DELHI- Finance Minister Nirmala Sitharaman on Wednesday said the Union Budget strikes a fine balance between growth, employment, and fiscal consolidation, and promotes cooperative federalism.

Replying to the discussion on the Union Budget 2024-25 in Rajya Sabha, the minister said the government is on track to achieve the pre-announced fiscal deficit target of 4.5 per cent by 2025-26. Sitharaman, also a former defence minister, said the Agniveer Scheme to recruit people in the age group of 17.5 to 21 years, is aimed at keeping the armed forces fit, young

and battle-ready. The minister, who presented her seventh Union Budget, also said the economic document proposes unflinching support for cooperative federalism.

"I would like to underline that our unflinching commitment to cooperative federalism. The total resources proposed to be transferred to the states in 2024-25 are estimated at Rs 22.91 lakh crore. This actually entails an increase of Rs 2.49 lakh crore over 2023-24," the minister said.

She said capital expenditure is pegged at Rs 11.11 lakh crore.

This is the biggest ever allocation for capital expenditure and it shows increase of about 17 per cent over the RE and provisional actuals of the FY 2023-24," she said, adding that during the Congress-led UPA era, the capex allocation was Rs 13.19 lakh crore between 2004-05 to 2013-14. "Whereas during our tenure from 2014 to 2024, the al-

location for capex has been Rs 43.82 lakh crore from 2014-15 to 2023-24," she said.

The deficit was 5.6 per cent of the GDP in 2023-24. In absolute terms, the government aims to contain the fiscal deficit at Rs 16,85,494 crore during the current fiscal. NEW DELHI- Maruti Suzuki India on Wednesday reported 47 per cent rise in net profit to Rs 3,650 crore for June quarter FY25, riding on the back of cost reduction efforts, favourable commodity prices and foreign exchange gains.

The auto major had logged a net profit of Rs 2,485 crore in April-June FY24. Net sales increased to Rs 33,875 crore in June guarter as compared with Rs 30,845 crore in the year-ago period, according to an exchange filing.

The profit increased on account of cost reduction efforts, favourable commodity prices and foreign exchange gains, it stated.

Addressing an investor conference, Maruti Suzuki India (MSI) Executive Director Corporate Affairs Rahul Bharti said the gains from favourable commodity prices and foreign exchange were partly offset by higher discounts, which rose to an average of Rs 21,700 per vehicle in the first quarter from Rs 14,500 per vehicle in the fourth quarter of last fiscal

The country's largest carmaker said it sold 5,21,868 vehicles during the first quarter, up 5 per cent as compared to the same period previous fiscal. It sold 4,51,308 units in the domestic market in June quarter, an increase of 4 per cent year-on-year.

NEW DELHI- India's smartphone shipments fell two per cent year-on-year in June quarter, hurt by the heatwave and slower demand, as per a report by global research firm Counterpoint that showed Xiaomi reclaimed top spot in volume share and Samsung led in value terms.

Notably, 5G smartphones captured their highest-ever share of 77 per cent in the overall shipments, according to Counterpoint's Monthly India Smartphone Tracker.

Another key takeaway was that India's smartphone market hit its highest ever Q2 value, driven by the ongoing trend of premiumisation.

"India's smartphone shipments fell 2 per cent YoY in Q2 2024 (April-June)," it said. The decline was influenced by

#### Assassination in Iran

United States getting sucked into another Middle East war will be real as Israel cannot effectively defend itself without US coordination and support.

In a statement Iran's supreme leader Ayatollah Sayyid Ali Khamenei said revenge was "our duty" and that Israel had "prepared a harsh punishment for itself" by killing "a dear guest in our home."

Bitter regional rivals, Israel and Iran risked plunging into war earlier this year when Israel hit Iran's embassy in Damascus in April.

Iran retaliated in an unprecedented drone and missile strikes on Israel, but international efforts succeeded in containing that cycle before it spun out of control.

Haniyeh's killing also could prompt Hamas to pull out of negotiations for a cease-fire and hostage release deal in the 10-month-old war in Gaza, which U.S. mediators had said were making progress.

And it could inflame already rising tensions between Israel and Hezbollah, which international diplomats were trying to contain after Israel carried out a rare strike Tuesday evening in the Lebanese capital that it said killed a top Hezbollah commander. Hezbollah has not confirmed if commander Fouad Shukur was killed. The strike killed three women and two children, according to the Lebanese Health Ministry.

There was no immediate reaction from the White House to Haniyeh's death. A key question was whether Israel told the U.S., its top ally, ahead of time.

Iran's Foreign Ministry said that Washington must also bear responsibility for the Israeli strike that killed Hamas leader.

"This terrorist act is not only a flagrant violation of the principles and rules of international law and the United Nations Charter, but also a serious threat to regional and international peace and security," the Iranian Foreign Ministry said in a statement on Wednesday.

"The Islamic Republic of Iran emphasizes the responsibility of the US government as a supporter and accomplice of the Zionist regime in the continuation of the occupation and genocide of the Palestinians, in committing this heinous act of terrorism," the statement added.

U.S. Secretary of State Antony Blinken however denied any knowledge saying, "This is something we were not aware of or involved in."

A top Hamas official, Khalil al-Hayya, told journalists in Iran that whoever replaces Haniyeh will "follow the same vision" regarding negotiations to end the war — and continue in the same policy of resistance against Israel.

International diplomats trying to defuse tensions were alarmed. One Western diplomat, whose country has worked to prevent an Israeli-Hezbollah escalation, said the strikes in Beirut and Tehran have "almost killed" hopes for a Gaza cease-fire and could push the Middle Fast into a repeatedly threatened to escalate into all-out war. Yemen's Houthis and Iraqi and Syrian militias have also fired rockets and drones at Israel and at American bases in the region.

A strike Tuesday night southwest of the Iraqi capital Baghdad killed four members of one Iranian-backed militia, Kataib Hezbollah, which has targeted U.S. bases previously. It accused the U.S. of being behind the strike.

A U.S. defense official said American forces had carried out a "defensive airstrike" against combatants who, "based on recent attacks in Iraq and Syria ... posed a threat to U.S. and coalition forces."

#### Who was Haniyeh?

Haniyeh, 62, was born in a refugee camp near Gaza City, and joined Hamas in the late 1980s during the First Intifada, or uprising. As Hamas grew in power, Haniyeh rose through the ranks – being appointed part of a secret "collective leadership" in 2004. He became political chief of Hamas

in 2017. The following year, he was named a "specially designated global terrorist" by the United States.

Despite that designation – and unlike Hamas' military leadership – Haniyeh travelled globally, meeting with world figures as the political head of the organization.

During the war with Israel in Gaza he has taken a central role in hostage and ceasefire talks between Israel and Hamas.

Earlier this spring, he said Hamas was willing to strike a deal – but it would require Israel withdrawing from Gaza and a guarantee to cease fighting in the enclave permanently, demands that Israel has called "unacceptable."

Earlier, Haniyeh's three sons, Hazem, Amir and Mohammad, were killed on April 10 this year when their car was hit by an Israeli airstrike. Hamas reported that Haniyeh also lost four of his grandchildren – three girls and a boy.

had promised "harsh punishment" for Israel in retaliation for the killing of Hamas's political leader.

"The criminal and terrorist Zionist regime martyred our dear guest in our house and made us bereaved," Ayatollah Khamenei said in a statement on Wednesday, adding that "it also prepared the ground for a harsh punishment for itself."

He said it was Iran's duty to avenge the assassination of Haniyeh, who was in the Iranian capital for the inauguration of President Masoud Pezeshkian.

"We consider it our duty to avenge his blood in this bitter and difficult incident that happened in the territory of the Islamic Republic," Khamenei said, as he offered his condolences to Haniyeh's family and the Palestinian group.

Iran has announced three days of public mourning across the country for Haniyeh.

A funeral ceremony will be held in Iran on Thursday, after which Haniyeh's body will be transferred to Doha, Qatar, Hamas said in a statement on its Telegram channel. Qazigund, a gateway of Kashmir, recorded a maximum temperature of 33.0 degree Celsius, which was 5.0 degree above normal.

Pahalgam and Kokernag, the famous tourist destinations, have recorded a maximum temperature of 30.8 degree Celsius and 32.3 degree Celsius respectively. At both the places, the mercury settled 5.0 degree Celsius and 4.6 degree Celsius above normal.

However, the twin stations including Kupwara and Gulmarg continued to witness respite from the heat wave as the mercury settled at 35.2 degree Celsius and 24.0 degree Celsius respectively.

Jammu division however, didn't witness the heat wave, the data revealed. In Jammu, the mercury settled at 36.2 degree Celsius while in Banihal, it settled at 31.2 degree Celsius.

Batote, Katra and Bhaderwah however recorded a maximum temperature of 29.6 degree Celsius, 33.6 degree Celsius and 33.4 degree Celsius respectively.

Meanwhile, the weatherman has forecasted generally cloudy with spells of intermittent light to moderate rain and thundershower at many places of Kashmir division and most places of Jammu division for the next five days from August 01 to August 05.

Director Meteorological department (MeT), Dr Mukhtar Ahmad told KNO that a spell of rain and thundershower are expected at scattered places on August 06 and August 07 while a spell of rain and thundershowers are expected at isolated places from August 08 to August 10.

In its advisory, the MeT stated that intense showers for a brief period is expected with possibility of flash floods, cloud bursts, landslides, mudslides and shooting stones over vulnerable places of J&K and heavy rain-

fall at few places of Jammu division. Moreover, the recent thundershowers at multiple places and heavy rains at some places have brought some relief and brought respite to the people especially farmers, the officials in the Irrigation and Flood Control (I&FC) said.

"Given the scale and prestige of this institute, which serves Jammu and Kashmir, Ladakh, and parts of Punjab and Himachal Pradesh, the hospital has imported equipment from the USA, Germany, and other countries to provide unparalleled healthcare facilities," he said.

Officials said that AIIMS Jammu is also detailing appointment procedures, available radiodiagnostic services, and operational aspects of a 24x7 diagnostic lab. The lab is equipped with the most advanced 3-Tesla MRI, 128-slice CT, and digital X-ray services, designed to enhance convenience and efficiency for the community, ensuring timely and accurate diagnostics and treatment.

They said the institute has already hired staff, and further recruitment and facility enhancements are underway. All necessary security arrangements have been made on the advice of the Home Ministry. AIIMS Jammu will eventually open approximately 50 departments, including 30 general and 20 super specialities, they added.

Currently, AIIMS Jammu offers an MBBS program lasting 5 years and 6 months, with a total seat capacity of 62, which will increase to 100 once the institute is fully operational.

The AIIMS Jammu Nursing College has admitted 60 candidates for BSc Nursing. The institute also offers 45 Postgraduate seats across Medicine, Surgery, and Dentistry, with Super Specialisation courses (DM/MCh) expected to commence in January 2025.

Officials said that 500 nurses from various states and Union Territories, including Jammu & Kashmir, have undergone specialised training at AIIMS Delhi before joining AIIMS Jammu. Referring to the general budget, she said the capital expenditure in the last 10 years of the Narendra Modi government stood at Rs 43.82 lakh crore, which is compared to Rs 13.19 lakh crore during the decade-ago rule of UPA.

Sitharaman also said the PLI schemes continue to remain attractive for the manufacturing sector.

The budget is an exercise to make India an attractive destination for manufacturing companies, she added. She also said the government is complying with the fiscal deficit trajectory. It will bring down the deficit to below 4.5 per cent by 2025-26 from the targeted 4.9 per cent for the current fiscal.

The finance minister highlighted that for agriculture and allied sectors the budget has allocated Rs 1.52 lakh crore, which is Rs 8,000 crore more than the previous year.

For comparison, in 2013-14, the last year of Congress-led UPA, only Rs 30,000 crore was allocated for agriculture.

The killing of Haniyeh abroad comes as Israel has not had a clear success in killing Hamas' top leadership in Gaza.

Haniyeh left the Gaza Strip in 2019 and had lived in exile in Qatar. Israel has targeted Hamas figures in Lebanon and Syria during the war, but going after Haniyeh in Iran was vastly more sensitive. Israel has operated there in the past: It is suspected of running a years long assassination campaign against Iranian nuclear scientists. In 2020, a top Iranian military nuclear scientist, Mohsen Fakhrizadeh, was killed by a remote-controlled machine gun while traveling in a car outside Tehran.

Iran's powerful Revolutionary Guard warned Israel will face a "harsh and painful response" from Iran and its allies around the region. An influential Iranian parliamentary committee on national security and foreign policy was to hold an emergency meeting on the strike later Wednesday.

Hamas' military wing said in a statement that Haniyeh's assassination "takes the battle to new dimensions and will have major repercussions on the entire region."

Israeli Prime Minister Benjamin Netanyahu has said Israel will continue its devastating campaign in Gaza until Hamas is eliminated. Israel's bombardment and offensives in Gaza have killed more than 39,300 Palestinians and wounded more than 90,900.

After months of pounding, Hamas has shown its fighters can still operate in Gaza and fire volleys of rockets into Israel. But it is unclear if it has the capacity to step up attacks in retaliation over Haniyeh's killing.

Instead, the impact may be regional. Besides a direct retaliation on Israel, Iran could work to increase attacks through its allies, a coalition of Iranian-backed groups known as the "Axis of Resistance," including Hezbollah, Hamas, mainly Shiite militias in Iraq and Syria and the Houthi rebels who control much of Yemen.

As a show of support for Hamas, Hezbollah has been exchanging fire almost daily with Israel across the Israeli-Lebanese border in a simmering but deadly conflict that has

warned that an official declaration of 'agricultural drought' may be imminent if rain does not arrive by next week.

Director of Agriculture Kashmir, Choudhary Mohammad Iqbal expressed concerns about the ongoing dry spell's impact on crops.

"The lack of rainfall is causing severe damage to the crops, and if the situation does not improve soon, the department may be forced to declare an 'agricultural drought' based on the evaluation parameters," he said.

Iqbal said the department is closely monitoring all the parameters, and if it does not rain by next week, it may declare an agricultural drought.

The prolonged dry conditions have raised alarm among farmers and officials alike, with concerns growing over the severe impact on crop growth and overall productivity in the region.

Officials from the Irrigation and Flood Control (I&FC) department said the dry weather has led to a reduction in the water level of the Jhelum River and has affected about 10% of irrigation schemes. They said the overall water capacity of the Jhelum River has decreased by 30% compared to normal levels.

Director Agriculture previously said that while there was some moisture in the ground, the absence of rain in the coming week could negatively affect both paddy and vegetable crops.

Professor Dr Raihana, Chief Scientist with the Faculty of Agriculture at Shere-Kashmir University of Agriculture Science and Technology (SKUAST) of Kashmir, said the prolonged dry spell has caused stress to plants. "The extended dry conditions have led to burning tips on paddy crops and drying leaves on vegetable plants," she said, adding that producing 1 kg of rice requires 3,000 to 5,000 litres of water. do not form the water course thus allowing for subsequent development of segregated lands. This decision is an amplification and simplification of earlier Administrative Council Decision No. 17/01/2022 Dated 29.01.2022 and subsequent Government Order No. 18-JK(Rev) of 2022 dated 04.02.2022 vide which a 3-Tier Committee was empowered to carry out the delineation/demarcation exercise in this regard.

Under the new scheme of things, the procedure has been decentralized, empowering the Deputy Commissioner to carry out delineation based on the District Level Committee's recommendation, regardless of the size of the land involved for State Land. For private lands, the Deputy Commissioner can delineate up to 200 kanals per Khasra on the recommendation of the District Level Committee, while the Divisional Level Committee and Divisional Commissioner can delineate 200-500 kanals per Khasra. All other proposals will be approved by the UT Level Committee.

This decentralized approach will ensure efficient, transparent, and timely delineation. The process will be conducted simultaneously in various districts using modern and scientific technologies like Digital Elevation Model/Digital Terrian Model and Hydrological/Hydraulic Modelling etc. The inspection will focus on areas such as using basements for classes, adherence to fire safety norms, compliance with building by-laws, prevention of overcrowded classrooms, verification of coaching centres operating from residential buildings, and the adequacy of escape routes in buildings, the spokesperson said.

A thorough safety audit of coaching centres, particularly in Srinagar, will be conducted to avert any potential accidents, he added.

Bhat has also constituted committees of officers from relevant departments to assess the compliance of such coaching institutions with safety standards.

The committees have been directed to submit their reports within a reasonable timeframe.

He said that the main feature of this parking system is that it is inherently designed with reasonable and logical tariffs calculated on the basis of dwell time which will make it fair and transparent.

"The system will have time stamping at four designated points within the airport and parking to enhance accountability and ensure accuracy," the statement reads.

It reads that the vehicle will be mapped at entry point and will be allowed a reasonable time of 14 minutes to enter the airport for drop off and pick up of passengers.

"If the vehicle doesn't cross the airport exit within the free time of 14 minutes, it will be charged 15 slab of parking fee of Rs 40. However, there is no free time for commercial vehicles," it reads.

It added that if the vehicle enters the parking area of the airport, the charges will be applicable based on the time spent in parking.

"The permissible free time from parking exit to airport exit will be 5 minutes. Further to enhance convenience and to provide seamless experience, the parking system will be integrated with Fastag technology allowing for quicker exits," it reads.

#### **BOXING: Confident Lovlina** Advances To Quarters; One Win Away From Second **Olympic Medal**


Tokyo Olympics bronze-winner Lovlina Borgohain (75kg) began her quest for a second successive Games medal confidently as she out-punched Norway's Sunniva Hofstad in her opening bout here on Wednesday.

Borgohain prevailed 5-0 in the contest and she is now just one win away from adding to her Tokyo bronze, which was claimed in the



69kg category, and achieve a feat that is unprecedented in Indian boxing.

But her path is not an easy one as she will take on topseeded Chinese Li Qian in the last-eight stage on August 4. A win in this bout would ensure at least a bronze medal for her.



Paris Olympics campaign from the Indian Archery contingent, Deepika Kumari finally showed some fight and promise by securing her place in the the

#### **BADMINTON: PV Sindhu** Storms Into Women's Single **Pre-Quarters**

Two-time Olympic medal-ist PV Sindhu on Wednesday cruised into women's single badminton pre-quarterfinals in the ongoing Paris Olympics 2024. The ace Indian shuttler defeated Estonian opponent Kristin Kuuba 21-5, 21-10 in her second and last Group M match to qualify for the Round of 16.

Sindhu, who had beaten Maldives' Fathimath Abdul Razzag 21-9 21-6 in her first match, topped the group. The winner of each of the 16 groups

qualifies for the round of 16. The Indian ace has previously won a silver medal in the 2016 Rio Games and a bronze in the Tokyo edition.

#### Lakshya Sen Enters Men's Single Badminton Pre-Quarters

Lakshya Sen on Wednesday stormed into the men's badminton singles Round of 16 in the ongoing Paris Olympics 2024. The encounter against Indonesia's Jonathan Christie was considered the most crucial one for Sen but the latter thumped the third-seeded shuttler 21-18, 21-12 to storm into the next round.

The All England defending champions took off with a healthy lead but Sen fought back and had a narrow 11-10 lead going into the break in the first game. The Indian shuttler continued his momentum to register a 21-18 win

The United States, despite having fewer gold medals, tops in overall achievements with 27 medals. India's current standing is at 35th place with 2 bronze medals.

#### **Canada Loses Appeal in FIFA Drone-Spying Scandal**

Canada's bid to overturn a six-point deduction in the Paris Olympics women's soccer tournament ended in failure on Wednesday, as ruled by the Court of Arbitration for Sport (CAS). The panel of three judges confirmed the punishment initially imposed by FIFA.

The scandal erupted when two Canadian assistant coaches were found using drones to spy on New Zealand's practice sessions ahead of the tournament's opening game. Canada can still advance to the quarterfinals with a win against Colombia.

#### **Djokovic Seals Win To Progress to Paris Olympics Quarterfinals**

Novak Djokovic remained comfortably on course for a first Olympic gold medal to add to his record-breaking collection of titles on Wednesday as fellow superstars Rafael Nadal and Carlos Alcaraz aimed for a place in the doubles semi-finals.

Djokovic, who has won three of his 24 Grand Slam titles on the clay courts of Roland Garros, defeated German left-hander Dominik Koepfer 7-5, 6-3 to become the first man to reach four Olympic singles quarter-finals.

## Death Threats Force Argentina's Angel Di Maria To Abandon Rosario Return

**ROSARIO:** Argentinian midfielder Angel Di Maria said death threats against his family in Rosario had forced him to change his mind about returning to his boyhood club Rosario Central.

Di Maria was targeted in what Argentine authorities have previously described as an attempted display of power by criminal organizations in Rosario, which has seen an increase in drug and gang related violence.

The 36-year-old, who retired from international soccer after winning his second Copa America trophy earlier this month, said he had wanted to end his club career in his hometown after leaving Portuguese side Benfica.

Reports of a death threat note thrown into Di Maria's family property surfaced in March and Di Maria said his family had not reported another threat to the police out of fear.

'There was a threat at my sister's business, a box with a pig's head



and a bullet in the forehead, and a note that said that if I returned to (Rosario) Central, the next head was that of my daughter Pia," Di Maria told a television station in Rosario on Tuesday.

"Those months were horrible... we could only sit there and cry each night over not being able to carry out that dream return."

Argentina captain Lionel Messi was also a target of threats last year. Argentina's federal security forces were deployed to Rosario in March and Governor Maximiliano Pullaro said earlier this month that protocols were implemented to ensure the safety of public figures.

"It is disrespectful to talk about security and protocols for me when people from Rosario cannot go out to work, cannot wait for the bus without being robbed or killed for a backpack," Di Maria added.

## France Captain Kylian Mbappe Buys Ligue 2 Club SM Caen

PARIS: France captain Kylian Mbappe has taken over as majority shareholder of Ligue 2 club Caen, Mbappe's company Inter-connected Ventures announced in a statement on Wednesday. The new Real Madrid player, who came close to signing for Caen when he was younger, has acquired 80 percent of the shares through Coalition Capital, the investment entity of Interconnected Ventures, replacing US investment fund Oaktree as majority shareholder. No figure has been released officially but French media reports put the acquisition fee at 15-20 million euros

(\$16-21.6 million). "This transaction marks a significant step in the club's strategic development and reinforces its natural ambition to remain one of the most successful clubs in French football," the club said in a statement.

"This acquisition will provide Caen with additional strategic resources to strengthen its sporting policy, modernise its infrastructure and develop innovative projects."

Mbappe's close friend Ziad Hammoud will take over as chairman of the club.

> "We are determined to create an environment

where young talent can flourish and where the club can defend its identity with strength and ambition," Hammoud said in the press release.

Founded in 1913, Caen finished fifth in the top flight in 1992 and reached the League Cup final in 2005 but have played in France's second tier since 2019.
