Kashmir Reels Under Fresh **Suicide Surge**

Over A Dozen Cases Recorded In A Month



Srinagar: A video of a woman who committed suicide by jumping into river Jhelum is going viral on social media. Many similar videos of people ending their lives by jumping into the water bodies have alarmingly emerged on social media platforms for the last few days.

As per details, last month, the valley recorded 43 drowning cases out of which more than a dozen were suicide attempts, said an official from State Disaster Response Force.

The valley is witnessing a steep rise in suicide cases, even as the experts and religious scholars call for identification and counselling of persons with mental ailments.

Proliferation of Pseudo-Journalists, Unauthorized SM Portals **HC Issues Notice To J&K Govt On Contempt Plea**

Srinagar: The High Court of J&K and Ladakh has issued notice to authorities on a contempt plea filed by an NGO in connection with the mushrooming of news portals without following due procedure of law.

The notice was issued by a division bench of Chief Justice (acting) Tashi Rabstan and Justice Puneet Gupta after hearing counsel for Jammu and Kashmir Peoples Forum, a non-governmental organisation.

In June 2022, the High Court had left it open for the government to take decision with regard to regulating and controlling the social media news channels, networks, pages and portals in Jammu and Kashmir.

Disposing of the Public Interest litigation (PIL) filed



by the Jammu and Kashmir Peoples Forum through its General Secretary M. M. Shuja in 2021, the court had asked the government to consider representation by the NGO with regard to regulating and controlling the social media network and take appropriate action expeditiously.

ECI To Visit J&K From Aug 8-10

Srinagar: In a significant development, a high-level team of the Election Commission of India (ECI) is arriving in Jammu & Kashmir on a three-day visit from August 8 to review preparedness for the much-awaited Assembly polls in the Union Territory.

The Full Commission comprising chief election commissioner Rajiv Kumar and election commissioners Gyanesh Kumar and Dr Sukhbir Singh Sandhu will be visiting the Union Territory from August 8 to hold meetings with political parties and officials to review preparedness for the polls. Additionally, they will also hold discussions with police to review security arrangements for the polls.

The ECI announced its visit to J&K two days after it directed the J&K government to shift officers serving in their home districts and also those who have served in a particular district for three years during the past four years.

Sources said that the pollbody would first hold meetings with political parties after their arrival here on August 8.

'Terrorist Goes Missing From Kashmir'

High Alert Sounded In Jammu

Srinagar: A high alert has been sounded in the Jammu region after Yasir Bhat, a Hizbul Mujahideen terrorist, went missing from his residence in South Kashmir's Kulgam district.

Officials say Bhat, who was out on bail, was involved in a gre-nade attack at the Jammu bus stand in March 2019, which resulted in the death of one civilian and injuries to 28 others. The police are putting up posters of the accused across the city.

HC Summons DC Ganderbal In Criminal Contempt Case Warns Him Of 'Coercive Proceedings' If He Fails To Turn Up

Srinagar: The High Court of J&K and Ladakh on Friday issued notice to Deputy Commissioner Ganderbal on a contempt proceeding initiated against him following a reference by Chief Judicial Magistrate (CJM) of the central Kashmir district.

A Division Bench of Justice Atul Sreedharan and Justice Sanjeev Kumar also directed the Deputy Commissioner to appear in person before it on ensuing Monday (August 5) at 11:00 am "sharp", and warned him of "coercive proceedings" if he failed to turn up in the court.

Last month, a court in Ganderbal issued show-cause notice to Deputy Commissioner Shyambir as to why a reference be not made to the High Court of J&K and Ladakh for initiating contempt proceedings against



him in terms of Contempt of Courts Act.

The court, Sub-judge Ganderbal, passed the order against the Deputy Commissioner for allegedly not complying with its order in a civil suit and attempting to "personally attack" him "by manipulation and fabrication".

"This is a reference made under Section 15(2) of the Contempt of Courts Act 2015 made by the Chief Judicial Magistrate, Ganderbal in Criminal Reference against Deputy Shyambir, Ganderbal, Commissioner, the Division Bench of the High Court said and issued notice to

the "contemnor. Mr Shvambir". "The contemnor shall appear in person before this Court on Monday i.e., 5th August 2024 at 11:00 am sharp," the court said.

Any attempt by him to avoid service of summons or his nonappearance shall be viewed seriously by this Court, the Division Bench said, warning that the Court shall resort to "coercive proceedings" to secure his presence. The Court also requested R. A. Jan, senior counsel, to assist it as an amicus. "His consent be sought by the Registrar Judicial

Over 66 Tons of Drugs Seized In J&K In 3 Yrs: Centre

Srinagar: The union government on Friday informed the Rajya Sabha that as much as 66595 kilograms of drugs under the Narcotics Drugs and Psychotropic Substances (NDPS) Act were seized in the Union Territory of Jammu and Kashmir in the three years.

Replying to a query, Minister of State (MoS) Home Affairs, Nityanand Rai in a written reply informed that in 2020, 26111.483 kg Opium Based Drugs, 1001.316 kg of Cannabis-Based Drugs, 247 kg of Psychotropic Substance, 40890.11 litters of Medicinal Preparations, and 1.554 kg of other drugs were seized in Union Territory.

In 2021, 19930.958 kg Opium Based Drugs, 2066.401 kg of Cannabis-Based Drugs.

Crypto Fraud Case

ED Launches First-Ever Search In Ladakh

Srinagar: In its first ever raids in the Union Territory of Ladakh, the Enforcement Directorate on Friday conducted searches as part of its money laundering probe linked to a cryptocurrency fraud case in which investors lost more than Rs 7 crore worth of deposits, officials said.

The agency's zonal office here raided at least six premises in Leh town of Ladakh, Jammu in J-K and Sonipat in Haryana in the case against A R Mir and others.

Researchers Lay Roadmap For Mitigating Methane Emissions, Call For Urgent Action

Methane emissions, which are rising rapidly, need to be tackled immediately, even as the world is focused on addressing carbon dioxide, which primarily drives climate change, according to a study that outlined a roadmap in the direction.

However, despite methane being the second most potent greenhouse gas, only about two per cent of the global climate finance goes towards cutting its emissions, the largest sources of which are agriculture, fossil fuels and decomposition of landfill waste, the researchers noted.

"The world has been rightly focused on carbon dioxide, which is the largest driver of climate change to date," said Drew Shindell from Duke University, lead author of the study published in the journal 'Frontiers in Science'.

"Methane seemed like something we could leave for later, but the world has warmed very rapidly over the past couple of decades, while we've failed to reduce our CO2 emissions. So that leaves us more desperate for ways to reduce the rate of warming rapidly, which methane can do," said Shindell.

The authors called for immediate action, "following the Global Methane Pledge (GMP) to reduce methane emissions by 30 per cent from their 2020 level by 2030." Launched at the 2021 United Nations Climate Change Conference, or COP26, held in Glasgow, UK, the GMP includes 158 participant countries as of March 2024.

The authors laid out three critical imperatives for action -- "reduce, coordinate and incentivise" -- which could be achieved by sat-



ellite data, reported methane emissions, and knowledge of how various abatement measures interact with market forces.

Foremost, the course needs to be changed and methane emissions be reduced through "stronger policy-led action" targeting all major drivers, along with greatly reducing CO2 emissions rapidly, the authors said.

Secondly, efforts should be coordinated to tackle methane and carbon dioxide emissions, as only cutting carbon dioxide won't stop warming quickly enough, while only cutting methane just delays global heating, they said.

However, the authors added that net zero methane emissions is not the target, owing to abatement challenges for some sources and its short lifetime.

Nevertheless, since methane and CO2 each contribute to warming, slashing methane emissions is important both for its own sake to ensure that trajectories consistent with the 1.5 degrees Celsius- or 2 degrees Celsius-temperature goals of Paris Agreement are feasible and for removing carbon dioxide from the air, the scientists said.

Thirdly, we need to incentivise and enforce methane abatement,

'We show that both technological abatement options and systemic and behavioral choices must be addressed to reduce methane emissions," the authors wrote.

Citing examples of India and China (both non-GMP countries), the study authors said mitigating methane emissions in the fossil sector is both large and low in cost, as are reductions in landfill methane in India.

The results suggested that the two non-GMP countries have the potential to achieve major methane reductions with limited financial burdens, they said.

With every tonne of methane emitted to be estimated to cause USD 470-1700 in damage, the authors described addressing these emissions as a "life-saving, cost-effective measure." If the human health-damaging effects of methane emissions on air pollution are considered, the true cost could be up to USD 7,000 per tonne, they said.

"The most important mitigations are the (options available) across all sectors that aren't too expensive, because we really need to do everything to reach climate targets such as 1.5 or 2 degrees Celsius warming," Shindell said.

"Controlling methane from only one sector wouldn't be enough. We need a broad portfolio of actions," Shindell said, adding that the benefits of methane mitigation nearly always outweighed

The meeting was attended by the Senior Officers of R&B, PHE, NBCC, PDD, UEED besides other stakeholders including local representatives.

Demand For Kulfi, Ice Creams, Lassi Surges In **Srinagar Amid Heatwave**

Srinagar: As Kashmir continues to grapple with scorching heat, the Kulfi sellers, yogurt based drink (Lassi), Ice-cream sellers and juice vendors in Srinagar are witnessing a surge in the sales.

The intense heat has driven locals to seek out refreshing treats, with ice cream carts, juice stalls, Lassi shops and Kulfi sellers bustling with increasing customer footfall activity.

In Srinagar's Bohri Kadal area in downtown, Kulfi sellers are particularly busy on one side of a brief road stretch, serving a frozen creamy brown colour ice cream mixed with long noodles to a steady stream of customers eager to

cool down. Shabir Ahmad, a Srinagar resident while enjoying the ice cream in a bowl told the news agency—KNO that whenever he visits Bohri Kadal or Fateh Kadal, he ensures he cherishes a couple of famous Matt Kulfi howl

"To beat the heat and let it cool, I often come to Bohri Kadal and Fateh Kadal to have Matt Kulfi. I prefer them over cold drinks," he said.

The scene is no different at the Lassi sales points, especially near the DC office in Srinagar and in Koker Bazar, where people form long lines to fetch a glass of the refreshing yogurt-based drink (Lassi).

Touseef Ahmad, a Medical Representative from Srinagar said that he often takes Lassi these days and comes from Karan Nagar to Shaheed Gunj to get relief from blistering hot weather.

Softy and ice cream sellers on the famous residency road in Srinagar too said that they are witnessing a spike in sales, saying most of the consumers prefer shakes and ice creams to beat the heat this summer.

Meanwhile, juice vendors across Srinagar are also experiencing a boom in sales with the majority of them selling a range of juice flavors mixed with basil seeds (Babri Beol).

Notably, these stalls and spike in their sales have emerged in the backdrop of scorching heat with people in need of hydration, who are be ing offered a variety of fresh chilled juices, ice creams and yogurt based drinks.



HMT Industrial Area Waste Water Flows Into Residential Colonies

SICOP Officials Unmoved, Residents Aghast

Srinagar: Residents in low lying areas near Zainakote Industrial Estate are facing a health hazard as SICOP authorities have failed to stop flow of waste water emanating from local units into nearby residential areas.

Residents accused the Small Scale Industries Development Corporation Limited (SICOP), which manages Zainakote Industrial Estate, of willfully ignoring their pleas for redressal of their problem.

Although the Managing Director SICOP and other higherups of the administration were informed about the issue, the aggrieved residents alleged that no measures were taken in this regard so far.

Residents at HMT are now more at risk of health problems as a result of the direct discharge of contaminated water from the Industrial Estate into the residential areas. "We sought assistance from higher-ups, including the Managing Director SICOP, but the issue has not been addressed," Ashfaq Hussain, a resident of Lane No 5. Rose Avenue. told Kashmir Observer.

The authorities, he claimed, have never bothered to visit the

affected area to know the plight of the people, who are more likely to experience serious health issues, in case the polluted water emanating from the Industrial Estate HMT is not blocked forthwith.

"The polluted water from Industrial Estate enters our homes with an unbearable stench, leaving us to wriggle like a fish out nent solution will be chalked out within the next twenty days. Rest the flow has been stopped and the residents face no issues as of now," the official claimed.

Manager Estates, SICOP Bilal Ahmad, admitted there is a problem revealing that the flow has been "internally diverted to some other place" days ago. taken some measures during a meeting chaired by MD SICOP and a strategy vis a vis perma-

inspection instantly to have the first hand appraisal of the situation. But the residents contacted Kashmir Observer late in the night saving no one had visited the area till late in the night. Residents alleged that SICOP has so far taken ad-hoc measures by diverting waste water from one colony to another in order to buy time.

Leave Constitution, Talk Humanitarian: PM

RINAGAR - The prime minister, Atal Bihari Vajpayee, today asked all the militant groups in Jammu and Kashmir to come forward for talks with the Centre. While rejecting the possibility of Pakistan's involvement in the peace process initiated with the Hizbul Mujahideen, he, however, made a significant departure from the oft-imposed rider of holding talks within the, frame work of Indian constitution.

"Our doors are open. I appeal to all militant groups and organisa tions, which believe in peace, to join the centre's efforts for peaceful resolution of the Kashmir issue," Vajpayee told media persons here after leading a delegation of major political parties at Pahalgam

Asked whether Pakistan would be invited to form part of the peace process, Vajpayee said, there is no question of Pakistan's involvement.' Holding Islamabad responsible for the killings, he said the absence of unequivocal condemnation by Pakistan makes it all the more a suspect Pakistan must come clean as its silence on the massacres would further affect the bilateral dialogue process.

Asked whether the talks would be strictly within the framework of the constitution, Vajpayee said, "Leave the constitution. Talks should be held on humanitarian considerations that violence is stopped and no more blood is shed."

To a question whether lapses insecurity led to the killings, he said the government would order an internal inquiry to find out the reasons behind the orgy of violence. Vajpayee was accompanied by union ministers George Fernandes and Mamata Banerjee, Congress President Sonia Gandhi and her party colleague Ghulam Nabi Azad, Mulayam Singh Yadav (Samajwadi Party), Somnath Chatterjee (CPI-M), K Yerran Naidu (TDP) and Kanshi Ram (BSP).Vajpayee, who was accompanied by Jammu and Kashmir governor G.C. Saxena and chief minister Farooq Abdullah, termed as ridiculous allegation by Pakistan about the involvement of Indian security forces in the killing and rejected the possibility of instituting a judicial inquiry on the issue. The involvement of Pakistan-based Lashker-e-Taiba have been proved beyond doubt other than Hizb-ul-Mujahideen being unhappy over the peace process initiated by the centre.

Maintaining that Islamabad must unequivocally condemn the massacres, Vajpayee made it clear that violence and peace talks cannot go together. Nothing can be achieved through killings. He said if General Musharraf continued to maintain silence, then the future of resumption of bilateral parleys would become even more difficult, To a question on the issue of autonomy, Jammu and Kashmir chief minister, who was present the Vajpayee's press conference, said we are talking with the centre on the issue.

Assassination in Tehran and Its Implications

he Political Bureau Chief of Palestinian Hamas, Ismael Haniyeh was assassinated in Tehran, the capital of Iran, on July 31, after he had attended the swearing-in ceremony of Iran's new President Masoud Pezeshkian. He was the chief interlocutor of ceasefire talks, from Hamas side and Israel, which are at war since October 7, 2023, and since then, Israel has killed more than 50,000 Palestinians and has reduced the whole of Gaza and Rafah into rubble. Qatar, Egypt, Russia and China have condemned the killing. India, till August 1, had maintained silence. Nitin Gadkari represented India at the inaugural ceremony in Tehran.

His death is a colossal damage to the reputation of Islamic Revolutionary Guard Corps (IRGC) and a message to the entire Iranian establishment. Iran has blamed Israel for it. His bodyguard Wasim Abu Shaaban was also killed. He was staying in an IRGC facility, the top most Iranian security agency, attached to the President's compound. The attack on such a place is akin to killing someone in a Blair House! The US President Guest House.

Immediately after the killing of Ismael Haniyeh, Israel PM Benjamin Netanyahu, who has just returned from the US, convened a three hours 'security-meeting' and thereafter boasted, in his address to the nation, that Iran's proxies have been given a crushing-blow. He did not name Ismael Haniyeh. Iran is now very deeply embarrassed by such an extraordinary security lapse but will it try to go for a fullscale war with Israel, as Iran's Supreme Leader Ayatullah Sayyid Khamenei has threatened Israel for a 'harsh-punishment'?

Haniyeh's funeral prayers were led by Ayatullah Khamenei and joined by thousands on Tehran streets. The US, however, has denied its role in the killing. Iran had already been nursing the assassination of its last President Ibrahim Raisi, purportedly killed after his helicopter crashed, on May 19, which too is believed to have been the handiwork of an Israeli sabotage?



Now the question is how could Israel do it, that too right in Iran's capital? The hazy details firstly were that a long range, precision missile, was launched from another country, in the early hours, which scripted the death of Haniyeh. But that all has been rubbished as a report in The New York Times on August 1, has informed that a bomb had been fitted in the same room, used quite often by Haniyeh on his visits to Iran. This is to definitely fuel a question if there are moles in the Iranian establishment, working for Israel, which is most likely, as unless there is an insider, a job of this propensity just cannot be possible. Palestinian Islamic Jihad Chief Ziyad Al-Nakhalah, was next door, and remained unhurt. This clearly shows that the target was well planned Haniyeh. The bomb was detonated through a remote.

There is no more room left to disbelieve that Iran had ever been rendered sterile, since way back from 2007, when the Israeli Stuxnetthe cyber malware, was implanted by the Israel intelligence Mossad and US intelligence CIA, through their assets, inside Iran's nuclear weapons programme. There is a whole list of Iran's nuclear scien-

How things would unfold is what the world is watching with bated breath, as one spark is now enough to ignite the whole region into a conflict which has every potential to change into a thirdworld-war

tists to have been killed by Mossad operatives in all these last twenty years, the prime most being Mohsin Fakhrizade, through limpid bombs attached to their cars etc. Only a few years back Israel exfiltrated the whole Iran's nuclear programme, from an extremely well-guarded facility in Central Iran. It is no won-

der, out of these infiltrators, US and Israel are together in a campaign that Iran is only a few weeks behind to become a nuclear state.

It is also to be taken into account that this killing had come only within hours when Israel claimed it had killed Hezbollah's top military commander, Fuad Shukur, in an airstrike on a south Beirut suburb, Lebanon, but surprisingly Israel did own this killing. Fuad Shukur is considered to be number-two in Hezbollah hierarchy and had been a US and Israel target for long. He was wanted by the US FBI for his role in the 1984 Barracks bombing of Beirut, which killed 241 US soldiers. Israel through it also did try to placate the US to seek more of its unstinted support in its war against Palestine. Israel outright 'no claim' for Haniyeh death is also for the fact that he was heading the team of negotiators towards the ceasefire talks over Gaza. Is his death now an end to any further negotiations between Israel-Hamas?

In case there is now to be an Iranian attack on Israel, apart from Iraq, Houthis from Yemen, from Syria and Lebanon and vice-versa from Israel are underway, it cannot be discounted that Iran is sur-

rounded by around 40 US military underground military facilities and bases located in neighboring countries. If a full-blown war is to be spearheaded, Iran will most likely be getting backed by its most trusted friend Russia and also its ally and partner China. Iran's supply of its cost-effective drones to Russia in its war against NATO and US led Ukraine, has won a far greater trust from Russia.

It claims that the Israeli War Ministry ordered the Airfence system produced by Finnish company Sensofusion. The Airfence system uses radio frequency sensors to identify the location of a drone and its operator, and can electronically intercept it either bringing it down or taking control of the drone itself. The system is equipped with a continually updating database of the main commercially-made drones, and provides 10 square kilometers of coverage.

As for Iran, unless there is a 'massive' clean-up in its backyard, such incidents will never stop. It hadn't been that long when on June 23, IRGC Intelligence Chief Hussain Taeb was removed, inform Axios and General Hussain Salami replaced him. But what did he do? Embarrassed Iran to no further ends!

To Preserve Democracy, Tax the Rich

hile there are many ways to measure economic inequality, key metrics consistently show that disparities are getting worse. According to a recent United Nations report, 71% of the world's population now live in countries where inequality has increased.

Pinelopi Koujianou Goldberg points out that the country is facing the same demographic problem as almost all advanced economies.

Unsurprisingly, this includes India and China. A recent paper by Thomas Piketty and his co-authors shows that the income share of the top 1% in India has risen to its highest level since 1922, the earliest data that they have, when the country was still under British colonial rule.

At the same time, global inequality remains extremely high. While billionaire wealth has reached unprecedented levels, the World Bank estimates that 712 million people worldwide survive on less than \$2.15 per day.

Future generations will likely be shocked that we have tolerated such extreme levels of inequality, just as we are horrified by our ancestors' acceptance of slavery. But as David Hume argued in the eighteenth century, moral imperatives ("ought") cannot be derived from objective facts ("is"). In other words, problems like inequality cannot be resolved through science or reason alone. Instead, we must highlight their moral implications to persuade people to act.

Two key aspects of global inequality deserve particular attention. First, economic disparities are set to worsen both within and across countries. As technological advances like artificial intelligence reduce demand for human labor, working-class households around the world could become increasingly impoverished. Meanwhile,



those who own the machines and run the largest corporations are expected to amass unprecedented power and wealth. The United States – home to nearly 38 million people living below the poverty line despite being one of the world's richest countries – provides a glimpse into this bleak future.

Second, extreme inequality poses a mortal threat to democracy, enabling billionaires and moneyed interests to influence elections, capture traditional and social media, and shape public perceptions. Regrettably, judging by social-media chatter and trolling, some of the strongest opposition to progressive taxation and redistributive policies comes from the poorer segments of society, largely owing to misinformation and manipulation.

The toxic combination of extreme inequality and AI-powered misinformation is also a factor fueling pressure on liberal democracies and the rise of authoritarian forces around the world. By enabling a few wealthy individuals to wield disproportionate influence, today's global economy increasingly marginalizes and disenfranchises much of the world's population.

To be sure, misguided attempts to reduce inequality also carry significant risks. For example, trying to achieve perfect egalitarianism would be unwise, because some disparity is necessary to create incentives. Similarly, concentrating all wealth in the hands of the state, as the Soviet Union did, would lead to mismanagement of demand and supply and, ultimately, cronyism.

Instead, what we really need is a progressive tax system that redistributes incomes from the rich to the poor while preserving incentives. Fortunately, there is significant scope for such measures. In my recent book Reason to Be Happy, I propose a tax regime that I call the "accordion tax," which aims to narrow the income gap by taxing high earners and transferring the revenue to those with lower incomes.

While this model essentially functions as a progressive tax system, its strength lies in its micro structure. Beyond a certain point, the super-rich no longer seek to earn more to buy things. Simply put, after the fifth yacht, the sixth is merely a status symbol aimed at outdoing other wealthy individuals.

By taxing all incomes above a certain threshold and transferring this money to those earning below it, governments could reduce inequality without harming incentives. The richest person will remain the richest, and the second-richest person will work just as hard to reach the top. But the incentives of the middle and working classes, whose members work primarily to make ends meet rather than try to surpass their neighbors, will remain intact.

Although the accordion tax could act as a powerful tool for reducing inequality at the national level, today's globalized economy poses significant implementation challenges. If a government taxes high incomes too aggressively, it risks triggering capital flight.

Thus, reducing global inequality requires multilateral agreements. While the US is well-positioned to lead this effort, its ability to do so depends on the outcome of November's presidential election. Vice President Kamala Harris, the presumptive Democratic nominee, offers hope for greater distributive fairness. By contrast, a victory for former President Donald Trump will likely cause inequality to worsen. We can only hope that American voters make the right choice.

Watching Kashmiri Weddings on YouTube With my Grandmother

We can't help but notice how drastically Kashmiri weddings have changed now and how we have incorporated so many alien traditions into them

ver the past few weeks my grandmother and I have developed a new hobby: watching Kashmiri wedding documentaries on Youtube together. Every evening, we sit in the living room with some noon chai, and set up the TV so we can watch the videos. We see the beautifully filmed weddings, and then exchange many comments and reactions. It is something that we enjoy, and brings us closer. But there is a catch: we can't help but notice how drastically Kashmiri weddings have changed now and how we have incorporated so many alien traditions into them. From the choice of music to the attire of the bride and groom, there are so many aspects that have been influenced by other cultures.

Let's start with the choice of music. Bollywood music is used in the majority, if not all, of these

wedding documentaries as the backdrop for the video narration. Songs such as "Mud Ke Na Dekho Dilbaro" from the movie Raazi, "Sajdaa" from My name is Khan, and "Kun Faya Kun" from Rockstar being among the most popular. While there is nothing intrinsically wrong with Bollywood music, I feel that we missed an opportunity to instead use traditional Kashmiri songs. I also do not want to generalize because most weddings still have Kashmiri songs, but perhaps as a result of easy exposure to other cultures, there are a lot more Hindi songs used than in

Another trend is the use of the "phoolon ki chadar", or a canopy of flowers under which brides walk during their entrance, inspired by Pakistani traditions. Similar to this, is the practice of wearing floral garlands during the Malmaenz or Haldi, which is again borrowed from Paki-

stani weddings. While all these are beautiful traditions, they are not originally ours. It shows how we have incorporated new practices from other cultures into our weddings.

Third, and one of the most noticeable changes is in the wedding attire. The traditional Kashmiri dresses are being replaced by heavy lehengas inspired by Indian and Pakistani fashion. In fact, a recent study in 2019 noted how in a Kashmiri wedding around "13.86% of resources are spent on clothes and cosmetics" alone. Many families even hire the best of the "make-up artists" and the bride and groom's wedding dress is often "custom designed by some reputable designer". Although this seems like just a change in clothing, it is actually a significant shift away from persevering our culture by wearing a traditional dress. It reflects a shift in society as a result of global exposure and the desire **ee**

to modernize.

My grandmother often talks about her own wedding when we watch these videos. She talks about how things used to besimpler, and also more rooted in our culture. She mentions how a woman would wear a simple tilla or embroidered pheran on her big day along with traditional jewelry pieces like the "Kasaba," a type of headgear, neckpieces such as "Halqaband" which we hardly see anymore. These items are not just accessories; they are symbols of our history and traditions, and we need to promote them through weddings.

Further, another factor to consider is the huge financial impact of these new trends on wedding budgets. Kashmiri weddings are already very expensive, with research highlighting how around 75% of the Muslim population spends between 8 lakh-20 lakh on a single wedding. The new traditions, such as designer out-

fits and extravagant decor will only increase these costs.

Although it can be argued that weddings evolve with time, I believe it is more important for a small place like Kashmir to preserve its unique wedding practices. Weddings are one of the most vital expressions of a society's culture, so we should not let Kashmiri trends fade and instead it is our responsibility to keep them alive.

While documenting Kashmiri weddings using videos on You-Tube is a great way to preserve our traditions and connect generations, like my grandmother and I, incorporating more Kashmiri wedding traditions and rituals would make it even better. This way, we could help keep our heritage alive and also allow the world to see and experience the beauty of our wedding culture.

Impact of Heat Wave on Children

limate change is raising global temperatures and causing historic heat waves. More countries are facing hotter days more frequently, with more intensity and for longer periods. The heat stress caused by exposure to heat waves can negatively affect health and well-being, especially for infants and young children.

In East Asia and the Pacific, around 243 million children are currently exposed to hotter and longer heatwaves than previous generations, putting their health and their education at risk. Children face significant health and developmental risks, including dehydration, heat exhaustion, and heatstroke, with prolonged exposure to such high temperatures putting children at risk of long team heath issues.

Extreme heat waves can have serious impacts on health in several ways. These events often occur during the summer months and can vary in intensity & duration depending on various factors such as geographic location, climate patterns, & weather conditions.

Higher daily peak temperatures and longer, more intense heat waves are becomingly increasingly frequent globally due to climate change. India too is feeling the impact of climate change in terms of increased instances of heat waves which

are more intense in nature with each passing year, and have a devastating impact on human health thereby increasing the number of heat wave casualties.

Population exposure to heat is increasing due to climate change. Globally, extreme temperature events are observed to be increasing in their frequency, duration, and magnitude. Between 2000 and 2016, the number of people exposed to heatwaves increased by around 125 million.

While the effects of heat may be exacerbated in cities, due to the urban heat island (UHI) effect, the livelihoods and well-being of non-urban communities can also be severely disrupted during and after periods of unusually hot weather.

Heatwaves can burden health and emergency services and also increase strain on water, energy and transportation resulting in power shortages or even blackouts. Food and livelihood security may also be strained if people lose their crops or livestock due to extreme heat.

Cases of heat-related illness are rising with average air temperatures, and experts say almost half of those getting sick are children. The reason is twofold: Children's bodies have more trouble regulating temperature than those of adults, and they rely on adults to help

protect them from overheating. Parents, coaches, and other



caretakers, who can experience the same heat very differently than kids do, may struggle to identify a dangerous situation or catch the early symptoms of heat-related illness in children.

Children are more at-risk during heatwaves as their body weight contains more percentage of water. During heatwaves – Dehydration is quick to occur as the body loses more water than the intake. Since children's sweat glands are not fully developed, this will lead to some trouble in regulating body temperature as compared to adults. Another reason for children being at more

risk during heatwaves is their body size.

Extreme heat poses unique risks at different stages of childhood. For example, babies and young children under age 5 are the most at risk of increased heat-related mortality and morbidity, while adolescents are more likely to experience exertional heat-related injuries.

Extreme heat can have serious effects on children's health, mental well-being, education and even nutrition. Heat stress can lead to heat strokes and diarrhoea caused by dehydration. It can lead to an increased risk of chronic respiratory conditions, organ dysfunction like kidney failure, and chronic is-

sues due to congenital defects.
Heat waves make droughts worse, adding to crop failure and threatening children's access to food and water. Food insecurity caused by heat waves has severe impacts on child nutrition.

Heat waves are linked to lower school attendance. High air temperatures and lower hydration are known to affect children's ability to concentrate. These can impact overall school achievements.

High temperatures are linked

to increases in mental health problems in children and adolescents. Heat can lead to high stress and poor sleep. These in turn can make episodes of depression and post-traumatic stress disorder

more likely to occur.

Our mental health is a fundamental part to our overall health and well-being. As a parent, you play a huge role in supporting your child's mental well-being. Nurturing and loving care build a strong foundation, helping your child to develop the social and emotional skills they need to lead a happy, healthy and fulfilled life.

Heat Waves with longer duration pose more risks for children as they spend more time outdoors than adults for — sports and other activities — putting them at greater risk for heat injury.

Heat-related illnesses occur when exposure to high temperatures and humidity, which can be intensified by physical exertion, overwhelms the body's ability to cool itself. Cases range from mild, like benign heat rashes in infants, to more serious, when the body's core temperature increases. That can lead to life-threatening instances of heatstroke, diagnosed once the body temperature rises above 104 degrees, potentially

causing organ failure.
Experts emphasize that drinking plenty of water, avoiding the outdoors during the hot midday and afternoon hours, and taking it slow when

adjusting to exercise are the most effective ways to avoid getting sick.

Children's bodies take longer to increase sweat production and otherwise acclimatize in a warm environment than adults' do, research shows. Young kids are also more susceptible to dehydration because a larger percentage of their body weight is water.

Population ageing and the growing prevalence of noncommunicable diseases (respiratory and cardiovascular diseases, diabetes, dementia, renal disease and musculoskeletal disease) means that populations are becoming more susceptible to negative heat impacts. Cities are not being designed to minimize the accumulation and generation of urban heat, with a loss of greenspace and inappropriate housing materials (for example, metal roofs) that amplify human exposure to excess heat.

Overall, heat waves pose significant risks to human health and well-being thereby highlighting the importance of taking preventive measures and staying informed during periods of extreme heat. By taking above mentioned preventive measures, you can reduce the risk of heat-related illnesses and stay safe during these times.

He said if addressed the person can be prevented from taking such a drastic step.

"It (suicide) has symptoms and such persons mostly suffer from severe depression due to various reasons including financial issues, domestic violence, relationship failure or even academic pressure. Because of the mental illness, the person is not able to cope up with the stress and they take a life-ending step," he said.

Dr Yasir claimed the increasing suicide rate depicted prevailing mental issues within the society.

Dr Yasir said the suicide case shows multiple warning signs before taking the life-ending step. "The person prefers to spend time in isolation, depressed with connection with society. His or her social media handles too show signs of his mental health," he said.

Dr Yasir said one of the strong reason for recent spikes in suicide can be explained by copycat phenomenon.

"Someone who died because of suicide suddenly is all over news, their whereabouts, situations are discussed, which somewhere can trigger an imitative behaviour in a person who shares a similar situation. Those who are struggling with mental health issues may start having stronger suicidal ideations after listening or seeing reports of suicide," he said.

Dr Yasir said the society particularly the parents and religious scholars can play an important role in combat increasing suicides.

"The religious scholars and leaders have a good influence on people. They can raise awareness and discuss such topics in the backdrop of religion. Similarly, parents and teachers too can counsel the children," he said.

Kashmir's grand mufti Nasir-ul-Islam said that parenting as well as raising mass awareness can prove beneficial in restricting such evils.

"Parenting is the most important aspect here. A parent has to check whether his son or daughter is going through any mental issues. They can sit together and resolve it. Parents have to develop a close connection with a child," he said.

Mufti Nasir ul Islam said the mass awareness can equally restrict the cases of suicide in Kashmir.

"An awareness regarding the consequences of suicide also needs to be spread within the society. Such topics should be discussed so that every person gets educated and restrains from taking such a step even if his life is disturbed," he said. (KNO)

taken place," the court said in a detailed order.

CJI Chandrachud, writing on behalf of the bench, said the information before the court at this stage does not show that the question paper was disseminated widely using social media or the internet, or that the answers were being communicated to students using sophisticated electronic means which may prove difficult to trace.

"The students who were beneficiaries of the leak at Hazaribagh and Patna are capable of being identified. The CBI investigation reveals the number of students who are the beneficiaries of the malpractice at Hazaribagh and Patna at this stage. This leads us to conclude that it is possible to separate the beneficiaries of malpractice or fraud from the honest students. This being the case, the court cannot direct a re-exam," the bench said.

The bench said the purpose of assessing whether the sanctity of the exam has been vitiated at a systemic level was to facilitate and encourage a proportional response.

"If it is possible to separate the tainted candidates from the untainted ones, there would be no justification to cancel the exam. This is because honest candidates would be made to suffer without reason due to the actions of some unscrupulous candidates. It is also important for the response to malpractice to be proportionate. Ordering a re-test would disrupt the academic schedule for the year," it said.

The CJI, in the 63-page detailed order, was also critical of the conduct of

The order said while the various issues the court dealt with do not lead to the conclusion that the integrity of the NEET was vitiated at a systemic level, "the manner in which NTA has organised the exam this year gives rise to serious concerns."

It said a body such as the NTA, which is entrusted with the immense responsibility of conducting highly important competitive exams, cannot afford a misstep, take an incorrect decision, and amend it at a later stage.

"All decisions must be well-considered, with due regard to the importance of the decision. Flipflops are an anathema to fairness," the bench said.

The bench said it is cognizant of the fact that national-level exams with participation of tens of lakhs of students require immense resources, coordination and planning

"But that is precisely the reason for the existence of a body such as NTA. It is no excuse to say that the exam is conducted in myriad centres or that a large number of aspirants appear for the exam. NTA has sufficient resources at its disposal. It has adequate funding, time, and opportunities to organise exams such as the NEET without lapses of the kind that occurred this year," it

The bench flagged multiple lapses on the part of the NTA, including security breach at an examination centre in Hazaribagh in Jharkhand, where the rear door of the strongroom was opened and unauthorised people were permitted to access the question papers, transport of question papers by e-rickshaws and wrong distribution of question papers among candidates.

It said when the results were declared, 67 aspirants had clinched a perfect score of 720/720. After the removal of compensatory marks awarded to them and the conduct of a re-test for 1563 candidates, the number of aspirants who had obtained full marks dropped to 61, and later to 17 following the recomputation of marks due to revision of the answer key, it said.

"The intervention of the Court, reports by the media, and representations by candidates ensured that these changes were made in the interests of fairness and justice. However, the system adopted by NTA should be such that just outcomes are reached even when these external catalysts are not present. The system must be such as to inspire public confidence," the order said.

The top court directed the NTA to ensure that all concerns highlighted by the court in its judgment are addressed and requested the seven-member committee headed by former ISRO chairman K Radhakrishnan to keep these issues in mind while making its recommendations.

Earlier on July 27, the Jammu and Kashmir Police had released sketches of three terrorists responsible for the recent terror attacks in the Doda district, including the ambush that left an army officer and three soldiers dead in the Urarbagi area of Dessa forest on July 16.

The police also announced a reward of 5 lakh for information leading to the capture of each terrorist. The trio, the police said, are moving into the upper reaches of Doda and Dessa.

The remaining AR battalions in Manipur will continue to stay on for the dual roles of counter-insurgency and border-guarding, sources said.

Prime Minister Narendra Modi last month chaired a review meeting to assess the security situation in J&K after a spate of terror attacks. He was given a full overview of the situation at the meeting where National Security Advisor Ajit Doval and Home Minister Amit Shah were present.

Outside of J&K, the AR is among the most experienced counter-insurgency forces, sources said, adding the deployment of AR soldiers will help boost anti-terror ops in J&K.

The AR - 'Sentinels of Northeast' - is under the administrative control of the Home Ministry and operational control of the army. It guards the 1,600-km-long Indo-Myanmar border, of which nearly 400 km is in Manipur, where it also functions as the primary counter-insurgency force making its task a dual-role one.

There are some Border Security Force (BSF) battalions in Manipur, but they are not specifically tasked with guarding the Indo-Myanmar border.

Former AR Director General Lieutenant General PC Nair (retired) on July 27 had termed as "stupid reports" allegations that the AR has been "favouring one community and not the other" in ethnic violence-hit Manipur, where the valley-dominant Meitei community and nearly two dozen tribes known as Kukis - a term given by the British in colonial times - who are dominant in some hill areas of Manipur, have been fighting since May 2023.

Lt General Nair, who retired this week after four decades of service, had said that to call the AR biased towards a particular community was "nothing but rumours" spread by some people with a hidden agenda.

"... From the first day, the Assam Rifle has maintained a neutral stand [in Manipur]. All these narratives that have been coming are agenda-driven. It makes me laugh when I read some of these stupid reports saying the Assam Rifles is favouring one community, not favouring the other. These are nothing but rumours, falsehoods, preposterous," Lt General Nair had said.

Lieutenant General Vikas Lakhera on Thursday took charge as Director General of the AR. He has extensive experience of planning and executing counter-insurgency and counter-terrorist operations in J&K and the northeast region.

He is a recipient of Ati Vishisht Seva Medal, Sena Medal, Chief of Army Staff Commendation Card, and two Army Commander Commendation Cards.

A retired top-ranking army officer said some people with a hidden agenda are spreading disinformation that all of AR is being moved out of Manipur.

"The AR is a professional force and can be deployed anywhere across the country depending on the security needs. The current situation in Jammu and Kashmir is such that AR's role is needed there. The AR is not some district commissioner or official who people can bully or hold protests against to be removed as per their whim," the retired officer, requesting anonymity.

The AR on its website says the force remains deployed in some of the most remote and underdeveloped areas and provides security to locals. It has grown substantially over the years from 17 battalions in 1960 to 46 battalions at present.

administrative secretaries, heads of departments, managing directors or chief executives of public sector undertakings to ensure that all officers or officials working under their administrative control and stationed in Srinagar and Jammu attend the functions.

ED Launches

currency back, and these funds were laundered by the business' promoters to purchase land assets in Jammu.

The money laundering case stems from a March 2020 FIR registered in Leh and some other complaints filed in the Union Territory (UT) of Jammu and Kashmir (J-K) against Mir and Ajay Kumar Choudhary.

Police in Leh in their FIR stated that an inquiry was conducted by a committee formed by the local district magistrate against Mir and his agents who were running the "fake" cryptocurrency business (Emollient Coin Limited) from a office located at the Anjuman Moin-Ul-complex, opposite

SNM Hospital, in Leh.

The committee sealed this office during inquiry on charges of "cheating many innocent individuals by assuring them to double their investment", according to the FIR.

The accused lured people of the UT of Ladakh and some other places to purchase "Emollient Coin" using cash or transferring money into bank accounts, according to Enforcement Directorate (ED) officials.

The depositors were also duped in the name of "Bitcoins" with the assurance of returns up to 40 per cent with a lock-in period of 10 months, the probe agency said.

Investors were dished out a commission of up to seven per cent of the investment made by the people on their reference in the business, thereby forming a multi-level marketing chain, the ED found.

A total of 2,508 people invested Rs 7,34,36,267 in the investment plan offered by Mir and the company (Emollient) floated by him that was incorporated in September 2017 and had its registered office in London. A man, Henry Maxwell, living in the UK capital, was its director.

The company had two promoters in India -- Naresh Gullia and Channi Singh. The company was "deliberately" dissolved in March 2019, and Mir along with Choudhary launched a real estate business and acquired lands in Jammu from the funds generated by the fake cryptocurrency trade, according to the ED.

Over 66 Tons

956.1 liters of Medicinal Preparations, and 184.4 kg of other drugs were seized in Jammu and Kashmir, the MoS informed.

The government of India has taken several measures to coordinate with international agencies and neighbouring countries to deal with cross-border drug trafficking. Some of which are Director General Level Talks being organized with neighbouring countries such as Myanmar, Iran, Bangladesh, Indonesia, Singapore, Afghanistan, Sri Lanka, etc., to resolve various issues on drug trafficking having international implications, he said.

A high-level dedicated group has been created in the National Security Council Secretariat (NSCS) to analyze drug trafficking through maritime routes, challenges, and solutions (Maritime Security Group – NSCS). The Indian Coast Guard has been empowered under the Narcotics Drugs & Psychotropic Substances Act, 1985, for making interdiction of narcotic drugs in coastal and high seas, he said—(KNO)

for initiating contempt proceedings terms of Contempt of Courts Act.

The sub judge has also accused Shymabir of launching an inquiry into land owned by him as "revenge" for the order regarding a land acquisition matter, in which the petitioners (two locals of the Ganderbal district) approached the court saying they were not compensated by the government after it acquired land from them, even though a decree in this regard was issued in their favour in 2022.

In January this year, the court had directed the Deputy Commissioner to compensate the petitioners. In an order dated June 21, the court said that the DC had not acted on the January order, and directed that his and other officials' salaries be withheld.

In the latest order, issued on July 23, the court said that his previous order "didn't go well with Deputy

Commissioner Ganderbal, namely Mr Shyambir, who attempted to personally attack the Presiding Officer (the sub-judge) by scandalising him and weakening him by manipulation and fabrication, and for this purpose, he called a meeting immediately after the order and conspired with some other officers/officials of the district to implicate the Presiding Officer of the court for passing a lawful order against the judgment-debtors".

The court accused Shyambir of launching a vindictive investigation to "implicate" him in a false case. "Out of the steps decided to be taken by the contemnor Deputy Commissioner against the Presiding Officer, one step was to frame the Presiding Officer in any fabricated incident, and if this is not possible, to trace out if there is any property in the name of the judge anywhere," the July 23 order said.

The court said DC Shyambir found out that he had two kanals of land in Ganderbal, and that the DC "misused his official machinery and devoted time in tracing out the documents of the property, which the Presiding Officer lawfully holds". After this, "as a first attack" on the judge, the sub-Judge said a patwari visited his land thrice under the DC's direction. He said the patwari told the caretaker of the land that the DC Shyambir had constituted "a team for demarcation of the land of the judge" as the judge had "passed the order against the Deputy Commissioner and other higher officers".

"The committee constituted for demarcation is clear abuse of the official position as neither the Presiding Officer moved any application for demarcation nor any notice was ever given to the presiding officer for any intended so-called demarcation of land in his possession for the last more than 15 years," the court had noted.

In fact, the court said, there does not exist any dispute at all regarding the land. "The Committee was called to submit a report within two days and most of the members of the committee are from different jurisdictions having no authority to demarcate the land outside their jurisdiction."

In fact, the court said, this committee was constituted by DC to "manipulate the spot position to demonstrate the land purchased and in possession of the Presiding officer (judge) as Khascharai, against the recorded and settled spot position." The committee has been constituted by the Deputy Commissioner-Shyambir with oblique and malafide motives and evil intention in reaction to a lawful order passed by the Presiding Officer, the court said.

"Till the time order was passed, there was no problem with the contemnor as regards the land of the Presiding Officer but after passing of the judicial order in execution petition, the contemnor started misusing his position rendering him liable not only for contempt but criminal proceedings under Prevention of Corruption Act for abuse of the official position for ulterior motives."

The order also said that as the DC may "try to implicate the judge in some false and frivolous", he has been issued a notice to explain why he should not be referred to the High Court for criminal contempt.

"Such an act on the part of the Deputy Commissioner/Contemnor, on the face of it, amounts to criminal contempt as the same is aimed at scandalizing the Judge who passed a judicial order and it has the potential to lower down the authority of this court as the Deputy Commissioner, by abuse of official position, wants to demonstrate the mighty powers he enjoys to lower the authority of the Court," the court said, adding, "Therefore, in the larger interest of the institution and to maintain the public trust, faith and confidence of the people in the independence and sanctity of the judicial institution, this court deems it appropriate to proceed in accordance with The Contempt of Courts Act, 1971.'

Boxer Apologizes For Not Shaking Imane Khelif's Hand After Olympic Fight

PARIS: Italian boxer Angela Carini came to the 2024 Paris Olympics aiming for a medal to honor her late father and coach, who died shortly after she participated in the Tokyo Games three years ago.

But Carini's performance in Paris lasted just 46 seconds Thursday before she abandoned her bout against Algerian opponent Imane Khelif, with a spot of blood on her trunks.

Even though Carini said she wasn't making a political statement about Khelif, who was disqualified from last year's world championships after failing an unspecified gender eligibility test, the move reopened debate about Khelif's status.

Afterward, a still-tearful Carini said she quit because of the pain from Khelif's opening punches, adding that her nose bled afterward.

"My face and nose were hurting," Carini said, according to the Italian sports daily Gazzetta dello Sport. "I couldn't breathe anymore. thought about my family, I looked at my brother in the stands and I went to my corner to retire. ... I've never been hit with such a powerful punch."

Carini added that it wasn't a pre-meditated move. "All this controversy makes me sad," Carini said. "I'm sorry

for my opponent, too. ... If the IOC said she can fight, I respect that decision." Carini was apologetic for not shaking Khelif's hand after

the bout.

"It wasn't something I intended to do," Carini said. "Actually, I want to apologize to her and everyone else. I was angry because my Olympics had gone up in smoke. I don't have anything against Khelif. Actually, if I were to meet her again I would em-



Khelif was disqualified from

the 2023 world championships after failing an unspecified gender eligibility test, and her presence at the Paris Olympics has become a divisive issue.

Khelif is an accomplished amateur who won a silver medal at the International Boxing Association's 2022 world championships. The same governing body disqualified her from last year's championships shortly before her gold-medal match because of what it claimed were elevated levels of testosterone.

The 25-year-old entered the ring at the North Paris Arena to a chorus of cheers, but the crowd was confused by the bout's sudden end. Khelif, who fights again Saturday, didn't speak to reporters.

What happened in Carini's fight against Khelif?

Carini exchanged a few brisk punches before abandoning

occurrence in Olympic boxing. Carini didn't shake Khelif's hand after the referee formally raised it. She cried in the ring after sinking to her knees.

Her actions sparked a discussion far beyond Paris about whether Khelif should have been allowed to compete after failing an unspecified gender eligibility test from the nowbanned International Boxing Association. Italian Premier Giorgia Meloni discussed the issue with IOC president Thomas Bach during a meeting in Paris on Friday.

The IOC has repeatedly defended Khelf's right to compete this week.

"Despite our requests to have certainties and guarantees, both for the safety of our athlete and for the regularity of the competition, they've confirmed that (Khelif) is within these parameters." Italian Olympic Committee president Giovanni Malagò said.
