New Delhi: On the fifth anniversary of the abrogation of Article 370 and Article 35(A), Prime Minister Narendra Modi on Monday described the step as a watershed moment in the nation's history, starting a new era of progress and prosperity in Jammu and Kashmir, and Ladakh.

He said in a post on X, "I assure the people of Jammu and Kashmir, and Ladakh that our government will keep working for them and fulfil their aspirations in the coming times.'

He said the move to scrap these provisions meant that the Constitution of India was implemented in these places in letter and spirit, in line with the vision of the great men and women who made the Constitution, he said.

"With abrogation came security, dignity and opportunity for the women, youth, backward, tribal and

marginalised communities who were deprived of the fruits of development. At the same time, it has ensured that corruption, which plagued Jammu and Kashmir for decades, has been kept at bay," the prime minister said.

The Modi government had on this day in 2019 annulled these articles that gave special rights to the then Jammu and Kashmir state, which was also divided into two Union territories.

### JAMMU ATTACKS **Cloud Of Uncertainty Over J&K Assembly Polls**

Srinagar: Ahead of the visit of the Election Commission (EC) to Jammu and Kashmir from August 8 to 10 to re-view Assembly poll preparations, a cloud of uncertainty hangs over the exercise.

Despite the EC's commitment to adhere to the Supreme Court's September 30 deadline, the escalating violence in Jammu and Kashmir is reportedly forcing a reevaluation of the situation. This is despite the fact that J&K has witnessed all elections since 1989 under the shadow of gun, with much worse violence.

The spate of attacks, particularly in Jammu division, has intensified concerns. According to the Union Home Ministry, there have been 26 militancy related incidents reported in Jammu and Kashmir in 2024, with 10 occurring in the Jammu division alone. These attacks have resulted in the deaths of eleven security personnel and injuries to 20, while 28 militants have been killed.



### **Residents** Complain Of 'Impure' Water Supply In Srinagar Parts

**SRINAGAR:** The residents from various parts of Srinagar Monday complained of getting contaminated water supply since Sunday evening, saying that it has increased risk of various water-borne diseases.

Local news agency-KNO, reported that residents from Bemina, HMT and other areas have been complaining that they were receiving muddy water supply since yesterday evening, making the drinking water unsafe for drinking purposes. "Since yesterday evening,

we have been receiving muddy water from taps. This water is not fit to use for drinking purposes," said a resident from Srinagar's HMT area.

Similar reports were received from Hamdaniya Colony of Bemina, where several residents complained of unclean water supply through the taps.

## **SICOP Flout Norms, HMT Residents Plan To Petition NGT**

SRINAGAR: As the wastewater emanating from the Industrial Estate HMT on the city outskirts flows straight into the residential colonies, the distressed residents Monday threatened to approach the National Green Tribunal (NGT) against the Small-Scale Industries Development Corporation Limited (SICOP) for endangering their life and property.

The residents living around the Industrial Estate HMT allege that the contaminated wastewater emanating from SICOP premises has posed a potential risk to their life and property with the administration despite repeated reminders choosing to ignore their concerns.

The toxic wastewater seeps straight into houses since the residential colonies are located in a lowlying location below the Industrial Estate, leaving the defenseless residents to their fate.

"Our dwellings are invaded by foul-smelling, contaminated wastewater and our children and elderly people would be at the grave risk of developing serious health issues in case the SICOP doesn't take measures to stop the toxic flow into the residential colonies," Abrar Hussain, a resident of Rose Avenue Lane 5, told Kashmir Observer.

Other than making hollow claims that are unrealistic to be fulfilled, Hussain, former Executive Engineer at Power Development Department (PDD) and now chairman Falah-e-Aam Trust said, the SICOP administration has done little to address their genuine concerns despite repeated pleas.

Residents have approached police with written complaints against the erring officials for putting lives of people to danger by sheer dereliction of duty.

"We now intend to move National Green Tribunal (NGT) and bring to their notice SICOPs' illegal diversion of industrial waste water into residential colonies", said Ayaz Ahmad a social activist.

Residents said they will also come on the streets if authorities do not address their grievance on priority.

"Many families have decided to shift to safer locations away from HMT as the wastewater the SICOP emits seeps straight into the residential colonies. For a good two months, no minister or VIP has been available to cut the ribbon to enable the people benefit from its erec-tion. ## **Riots Spread Across UK In Anti-immigrant Protests**

LONDON - British Prime Minister Keir Starmer convened an emergency security meeting Monday after far-right riots fueled by misinformation spread over the weekend and residents across the country awakened to scenes of buildings set on fire and hotels housing asylum-seekers stormed by angry mobs.

Two hotels were targeted Sunday night in what has turned into the worst disorder the United Kingdom has seen in years. Almost 150 people were arrested over the weekend, the U.K.'s National Police Chiefs' Council said.

The violence followed a week of unrest after a stabbing attack that killed three young girls in the northern city of Southport. False claims about the attacker's ethnicity and origin quickly spread online, fueling the outbursts of violence.

Elon Musk, the billionaire tech mogul who owns X, weighed in on the violence.

### United Kingdom. A police officer was also

injured in the clashes at another Holiday Inn hotel in the town of Tamworth, north of Birmingham in the Midlands. Windows were smashed and three Molotov cocktails were used to start fires, Staffordshire Police said. Here too, projectiles were thrown at officers, resulting in one suffering a broken arm, according to the force. No one inside was injured, the police statement added.

In the town of Bolton, in the northwest of England, police were trying to keep rival demonstrators apart, with one group shouting "Allahu Akbar" at anti-immigration protesters, according to the footage shared by the BBC on Sunday.

Anti-immigrant and anti-Muslim groups seized upon the child murders at a Taylor Swift-themed dance class in Southport last Monday as disinformation spread on social media that the suspected attacker was a refugee and radical Islamist.

The rioters could also be seen setting on fire plastic trash trolleys next to the hotel, and hurling planks of wood and profanities at police in riot gear on the scene. Police in South Yorkshire, where Rotherham is located, later said its officers were also targeted with glass bottles and beer cans by a crowd of about 700 people. They added that at least 10 officers were injured in the melee, with one left unconscious following a head injury, although no hotel employees or residents have been reported as hurt. ## **Bangladesh In Turmoil, Sheikh Hasina Escapes To India**

DHAKA: Bangladesh's Prime Minister Sheikh Hasina resigned and fled the country on Monday, ending 15 years in power as thousands of demonstrators defied a nationwide curfew and stormed her official residence.

In a televised address, Bangladesh's military chief, Waker-Uz-Zaman, announced he was assuming control at a "critical time for our country" and confirmed that Hasina left Dhaka for a "place of safety," as local media reported neighboring India as her initial destination.

"I am taking responsibility now and we will go to the president and ask to form an interim government to lead the country in the meantime," he said.

Zaman said the military would stand down and that an investigation would be launched into the deadly crackdowns that fueled outrage against the government.

"Keep faith in the military, we will investigate all the killings and punish the responsible ... I have ordered that no army and police will indulge in any kind of firing," he said. 'Now, the students' duty is to

stay calm and help us ' Hasina had ruled Bangladesh

since 2009 and was elected for a fourth consecutive term in a January vote that was boycotted by her main opponents, sparking concerns over how free and fair the election was

She was forced out by weeks of protests that started peacefully but turned into deadly clashes with security forces, leading to a communications blackout, curfews, and around 300 deaths.

Students were the ones leading earlier protests that began in July to demand reforms to a quota system for government jobs, which the Supreme Court eventually scaled back. But as the rallies turned deadly and authorities attempted to quell the violence with force, the movement escalated into a campaign to oust Hasina.

At least 11,000 people have been arrested in recent weeks, with the unrest leading to closure of schools and universities across the South Asian nation and authorities issuing a shoot-on-sight curfew at one point

Student activists called for a march to Dhaka on Monday in defiance of the latest curfew to press for Hasina's resignation. This comes after nearly 100 people, including over a dozen police officers, were killed the day before following a fresh wave of deadly

clashes across the country.

After the military confirmed Hasina's resignation, thousands of people poured onto the capital's streets in jubilation. Television visuals showed masses storming Hasina's official residence in the capital, pumping fists, making victory signs, and removing furniture and other household items

Hasina, 76, was one of the world's longest ruling female leaders and has played a pivotal role in Bangladesh's politics, a nation of about 170 million people that declared its independence in 1971.

She is the daughter of Sheikh Mujibur Rahman, the country's charismatic founding leader, who was killed in 1975 in a military coup when Hasina was 28. She served as prime minister from 1996 to 2001 and regained power in 2009.

Under her leadership, Bangladesh became one of the fastestgrowing economies in the region, with World Bank estimates showing that more than 25 million people in the country have been lifted out of poverty in the last two decades

But critics say she has grown increasingly autocratic and called her a threat to the country's democracy, with many saving that the recent unrest reflected a broader discontent against her rule

Putin ally holds talks in Iran as Middle East teeters on brink of wider war

OSCOW, Aug 5 - A senior ally of President Vladimir Putin arrived in Tehran on Monday for talks with Iranian leaders including the president and top security officials as the Islamic Republic weighs its response to the killing of a Hamas leader.

Russia has condemned the killing of Ismail Haniyeh, leader of the Palestinian Islamist group Hamas, in Iran last week and called on all parties to refrain from steps that could tip the Middle East into a wider regional war.

## **Flash Floods Wreak Havoc** In Ganderbal's Kangan

GANDERBAL: Flash floods, caused by a cloudburst, have wreaked havoc in the Kangan subdivision of the Ganderbal district, striking several areas, including Cherwan and Kawcherwan, at 12:30 am on Sunday. It caused massive damage to residential houses, agricultural land, vehicles and roads.

The cloudburst led to mudslides in the Cherwan Area along the Srinagar-Leh National Highway, endangering nearby residential areas. The flash floods also damaged roads, water supply lines, and electricity infrastructure, burying several parked vehicles under debris.

Locals said the area experienced a flood-like situation due to the overwhelming water flow.

Residents said that the land had been sinking over the past few days and had alerted the authorities. They said a similar incident happened in 2020, when landslides damaged several residential houses, commercial shops, and agricultural land, which resulted in losses

worth crores of rupees. The Power Canal passing through the upper part of the town became blocked due to the heavy rainfall, exacerbating the situation. As water levels in the canal rose, authorities and residents urgently called for the evacuation of Cherwan, Padabal, and surrounding areas to prevent

widespread flooding. The agricultural sector in the region has also suffered significant losses, with standing crops severely damaged. The torrential rains that lashed the Kangan subdivision late into the night led to the cloudburst and then flooding. Severe damage occurred in the Cherwan, Kullan and Gagangheer areas of Kangan, with Cherwan being particularly hard-hit.

Police and Ganderbal administration officials immediately initiated rescue operations. ADC Ganderbal Gulzar Ahmad,

estimated the damage at Rs 2.20 crore, encompassing government buildings, roads, electrical infrastructure, canals, houses, government walls, water pipes and vehicles.

## **Assembly Elections In J&K Will Be Held In September: Kishan Reddy**

JAMMU: The Assembly elections in Jammu and Kashmir would be held in September, Union Minister G Kishan Reddy said on Monday, urging people in the Union Territory to vote the BJP to power for maintaining the "development tempo" and rooting out terrorism.

He said the activities of Pakistan and its intelligence agency ISI have been largely curtailed in J&K after the abrogation of Article 370 by Prime Minister Narendra Modi-led government on August 5, five years ago and warned the neighbouring country against supporting terrorism in the Union Territory.

Reddy, who is also election in-charge of the BJP in Jammu and Kashmir, was addressing 'Ekatma Mahotsav' rally organised by his party on the fifth anniversary of Article 370 abrogation at the Bana Singh Stadium here in the outskirts of Jammu. BJP national general secretary in-charge J&K Tarun

Chugh and J&K BJP president Ravinder Raina were among the other prominent speakers. "The Assembly elections

will be held in September and we are sure that the people will vote the BJP to power with full majority given the changes which have been brought by the party by revoking Article 370 and extending B R Ambedkar's Constitution to Jammu and Kashmir," the minister said.

Lashing out at opposition parties, especially the Congress and the National Conference, he said they are talking about re-implementing Article 370, which has only brought "death and destruction" to Jammu and Kashmir through Pakistansponsored terrorism.

"People have to decide which government they want in J&K, the one which is talking about article 370 or the BJP-led government which wants to take J&K to new heights of development, peace and prosperity," he said.

Terming the abrogation of

Article 370 a "proud moment" for the country and the people of J&K, he said nobody had ever thought of such a development even as the foundation for it had been laid by Bharatiya Jana Sangh founder Syama Prasad Mukherjee, who laid down his life while opposing the controversial constitutional provision.

"After a long struggle, the people of J&K finally got freedom from Article 370 which led to granting of rights to the women and other deprived sections of society. A new J&K came into being where terrorism, stone-pelting, hoisting of Pakistani flags and insult to the tricolour have become history," he said.

Asking people not to vote for the Congress and the NC, Reddy said if they return to power there is possibility of revival of terrorism and separatism.

Reddy said the BJP is the only party which can ensure peace by not allowing Pakistan and its sponsored terrorists to target Indian citizens.

### **Rooftop Solar Power Plants: HC Junks Challenge To Tender Notice**

Refers To India's Commitment To Several Key International Treaties Aimed At Combating Climate Change

SRINAGAR: Observing that the power of judicial review will not be permitted to protect private interest at the cost of the public interest, the High Court of J&K and Ladakh on Monday rejected plea challenging tender notice issued in June this year by Jammu and Kashmir Energy Development Agency (JAKEDA), seeking e-bids for the supply, installation and commis-sioning of grid connected rooftop solar photovoltaic power plants on Government buildings in the J&K. While dismissing the plea, a bench of Justice Wasim Sadiq Nargal also referred to India commitment to several key international treaties aimed at combating climate change including the United Nations Framework Convention on Climate Change (UNFCCC), ITS Kyoto Protocol (KP) and Paris Agreement (PA) for mitigating greenhouse gas emissions and promoting sustainable develop-

ment. The court said that in alignment with these obligations, a detailed roadmap has been carved out for maximizing energy harvesting from alternate energy sources, particularly, focusing on renewable energy such as solar power.

"This initiative is crucial for meeting both national and international climate goals and ensuring sustainable energy development. These schemes aim to harness solar energy for both residential and Government sectors, thereby significantly contributing to the national and international climate goals," the court said.

Referring to the records, the court said that various meetings were held on the direction of Prime Minister Office (PMO) for saturating the rooftop solar power plants on all Government buildings with a strict deadline for completion of the projects before December, 2025 in respect of large States/UTs and December, 2024 in respect of small States/UTs, respectively.

In this direction, the court said a decision was taken that JAKEDA shall implement a 70 MW Rooftop Solar Projects for covering 8792 Government buildings under the CAPEX mode and, subsequently a tender was issued on 12 June this year on the JK Tenders Portal for the Request for Selection (RFS) of bidders for the supply, installation and commissioning including warranty and Comprehensive Maintenance Contract (CMC) for five years, of Grid-Connected Solar Rooftop Photovoltaic Power Plants on Government buildings in J&K. It is this tender notice which was challenged by the petitioner, among others claiming that arbitrary, discriminatory and unreasonable technical eligibility criteria has been stipulated and that there is lack of transparency in the tender process and the exclusion of local venders, which contradict the principle of equality.

On the other hand, authorities submitted that the tender was issued pursuant to the meeting notice issued by PMO for "Saturation of Rooftop Solar" in UTs. They said the tender document of 70 MW was issued, which has been categorized into five categories (2 KW, 3 KW, 3-10, 10-100 KW and 100-500 KW) for obtaining rates, which is in conformity with the MNRE guidelines and orders.

After hearing both sides, the court reiterated that the power of the judicial review will not be permitted to be invoked to protect the private interest at the cost of the public interest, or to decide a contractual dispute.

"... insofar as the present case is concerned, this Court is of the view that no overwhelming public interest is involved, however, the only interest, if any, is private in nature and the reasons do not compel this Court to interfere in the matter which, if be done will be at the cost of public interest," the court said and found challenge to the tender "ill founded and devoid of any merit."

kh on Monday asked Deputy Commissioner Ganderbal to "strictly" file reply by August 12 to contempt proceedings initiated against him following a reference by Chief Judicial Magistrat (CJM) of the central Kashmir district.

Pursuant to the court's August 2, Deputy Commissioner, Ganderbal Shyambir appeared in person before the Court's division bench of Iustice Atul Sreedharan and Justice Sanjeev Kumar and was subsequently apprised about the reference by the CIM. Ganderbal and the charge leveled against him.

To this, the Deputy Commissioner replied that he has not done it intentionally to "demean" the Court.

"Office is requested to forward the reference made by the learned Judge of the District Judiciary, Ganderbal to the Deputy Commissioner, Ganderbal today itself in order to give him an opportunity to file his reply to the said charge leveled against him by the learned CJM, Ganderbal," the division bench said, adding, "He is expected to file his response on or before the next date of hearing."

On account of the nature of the case, the court underlined that it would like to decide this matter one way or the other as expeditiously as possible and "no further time shall be given to the contemnor (DC Ganderbal) to file his response). Subsequently, the court ordered the listing of the case on August 12.

"On the next date of hearing, Mr. Shyambir, Deputy Commissioner, Ganderbal shall remain personally present," the court added.

Last month, a court in Ganderbal issued show-cause notice to Deputy Commissioner Shyambir as to why a reference be not made to the High Court of J&K and Ladakh for sioner for allegedly not complying with its order in a civil suit and attempting to "personally attack" him "by ma-

nipulation and fabrication". Subsequently, the CJM court made reference under Section 15(2) of the Contempt of Courts Act 2015 in Criminal Reference against Shyambir and issued notice to him for his appearance today.

Last month, the court of Sub-Judge Ganderbal noted that a preliminary enquiry was initiated against the contemnor Mr Shyambir and in the first instance, he was asked to a show-cause as to why a reference be not made to High Court of J&K and La-

dakh for initiating contempt proceedings in terms of Contempt of Courts Act.

The sub judge has also accused Shymabir of launching an inquiry into land owned by him as "revenge" for the order regarding a land acquisition matter, in which the petitioners (two locals of the Ganderbal district) approached the court saying they were not compensated by the government after it acquired land from them, even though a decree in this regard was issued in their favour in 2022.

In January this year, the court had directed the Deputy Commissioner to compensate the petitioners. In an order dated June 21, the court said that the DC had not acted on the January order, and directed that his and other officials' salaries be withheld. In the latest order, issued

on July 23, the court said that his previous order "didn't go well with Deputy Commissioner Ganderbal, namely Mr Shvambir, who attempted to personally attack the Presiding Officer (the sub-judge) by scandalising him and weakening him by manipulation and fabrication, and

The court accused Shyambir of launching a vindictive investigation to "implicate" him in a false case. "Out of the steps decided to be taken by the contemnor Deputy Commissioner against the Presiding Officer, one step was to frame the Presiding Officer in any fabricated incident, and if this is not possible, to trace out if there is any property in the name of the judge anywhere," the July 23

order said. The court said DC Shvambir found out that he had two kanals of land in Ganderbal, and that the DC "misused his official machinery and devoted time in tracing out the documents of the property, which the Presiding Officer lawfully holds". After this, "as a first attack" on the judge, the sub-Judge said a patwari visited his land thrice under the DC's direction. He said the patwari told the caretaker of the land that the DC Shyambir had constituted "a team for demarcation of the land of the judge" as the judge had "passed the order against the Deputy Commissioner and

other higher officers". "The committee constituted for demarcation is clear abuse of the official position as neither the Presiding Officer moved any application for demarcation nor any notice was ever given to the presiding officer for any intended so-called demarcation of land in his possession for the last more than 15 years," the court had noted. In fact, the court said, there

does not exist any dispute at all regarding the land. "The Committee was called to submit a report within two days and most of the members of the committee are from different jurisdictions having no authority to de-

session of the Presiding officer (judge) as Khascharai, against the recorded and settled spot position." The committee has been constituted by the Deputy Commissioner-Shyambir with oblique and malafide motives and evil intention in reaction to a lawful order passed by the Presiding Officer, the court said. "Till the time order was

passed, there was no problem with the contemnor as regards the land of the Presiding Officer but after passing of the judicial order in execution petition, the contemnor started misusing his position rendering him liable not only for contempt but criminal proceedings under Prevention of Corruption Act for abuse of the official position for ulterior motives."

The order also said that as the DC may "try to implicate the judge in some false and frivolous", he has been issued a notice to explain why he should not be referred to the High Court for criminal contempt.

"Such an act on the part of the Deputy Commissioner/Contemnor. on the face of it, amounts to criminal contempt as the same is

aimed at scandalizing the Judge who passed a judicial order and it has the potential to lower down the authority of this court as the Deputy Commissioner, by abuse of official position, wants to demonstrate the mighty powers he enjoys to lower the authority of the Court," the court said, adding, "Therefore, in the larger interest of the institution and to maintain the public trust, faith and confidence of the people in the independence and sanctity of the judicial institution, this court deems it appropriate to proceed in accordance with The Contempt of Courts Act, 1971."

## **Chorus For Polls**

he United Opposition on Saturday staged a protest in Jammu, demanding restoration of J&K's statehood with full powers and withdrawal of powers granted to Lieutenant Governor Manoj Sinha. The All Party United Front (APUF), a Jammu-based grouping of over a dozen opposition political parties and social groups, including senior leaders of Congress, NC, PDP, CPI(M), Shiv Sena (UBT), AAP and Jammu-based parties gathered near the statue of Maharaja Hari Singh at Tawi bridge to press their demand. Congress leader Ravinder Sharma accused the BJP government at the centre of downgrading the Dogra state and snatching "special status, dignity, identity and rights of J&K people". As for as Assembly elections, the preparations are on track. The Election Commission of India is arriving in J&K on August 8-9 to take stock of the situation. Hopefully, this should lead to the announcement of the polls later this year. The Supreme Court last year set a September 2024 deadline for holding the Assembly election. And the union government too has assured the court that it will stick to the deadline. However, recent developments have put the prospect of the exercise in doubt. The renewed spurt in militancy in Jammu division is seen as a threat to the free and fair polls, making a section of security and political opinion to call for their postponement for now.

It is now five years since Jammu and Kashmir lost its special constitutional status and was downgraded into two union territories - Ladakh and J&K. Since, the central government has time and again assured the people of the former state that Assembly elections will follow soon. Not just that, the central government has also promised subsequent restoration of statehood. Both these promises have yet to materialize and there is hope that they will in the near to medium future. For now, we can expect Assembly elections to be held before the September deadline. And there shouldn't be any reason for these polls not to be held. J&K has seen worst phases of violence over the past three decades but despite that elections have been held, just as the recent parliament polls were held without as much as an incident being reported. In 1996, Assembly elections were held amidst a runaway turmoil in the then state. Sor, the current surge in militancy in parts of Jammu region shouldn't be a reason to defer polls. For, it is unlikely that that J&K could be expected to be completely normal in the near future for the Election Commission of India to hold polls. And postponing democracy indefinitely will hardly benefit the cause of peace in the union territory.



## J&K Without Elected Panchayats

FRA implementation and village development have been hit due to the absence of Panchayats since 8 months

s debate on holding of assembly elections in J&K is gaining momentum, nobody is talking about the Panchayat elections. The panchayat elections were supposed to be held by the end of last year as the 5 year term ended in December 2023. Even the term of Urban Local Bodies -ULBs came to an end last year and since then we have neither elected Municipal Corporations nor Councils or Committees in J&K. The absence of these local bodies is not only impacting our governance mechanism but it also undermines democracy as well.

On various occasions in the past, PM Modi and Home Minister Amit Shah have been highlighting the way the Govt of India took initiative to conduct Panchayat and ULB elections in J&K amid violence and militant threats in 2018. A group of elected Panchayat Members from J&K led by Chairman J&K Panchayat Conference Shafiq Mir had even met with PM Modi in presence of National Security Advisor -NSA Ajit Doval in New Delhi around December 2018. BJP's national leadership and those from J&K have been highlighting the role played by Modi Govt in conducting 2018 panchayat and ULB elections when the PDP & NC had boycotted them. But as the term of these PRIs & ULBs came to an end last year, people are unable to understand why the fresh elections have been kept on hold by the same Govt which seemed a great proponent of local self governance.

This is a matter of serious concern and no political party in J&K has seriously highlighted this issue in the last 9 months. The politicians in J&K seem to be more concerned about holding of J&K Assembly elections which indicates that they also don't want to make PRIs and ULBs stronger.

This article particularly focuses on the absence of PRIs and its impact on rural governance, especially how it is impacting the implementation of Forest Rights Act-FRA. I will come up with a separate article on the non-existent elected Urban Local Bodies -ULBs and its impact on development of cities and towns in J&K.

After article 370 abrogation, around 900 central laws were extended to J&K. Out of these laws, around a dozen legislations are quite beneficial for the people of J&K like Right to Education Act (RTE), Right to Information Act (RTI), Prevention of SC ST Atrocities Act, Forest Rights Act, Right to Fair Compensation Act, Consumer Protection Act etc. I have extensively written about these laws in the past.

There are some laws like the Forest Rights Act which cannot be enforced or implemented without holding a Gram Sabha - Halqa Majlis. But who will conduct these village assemblies? There are no elected Sarpanches or Panches and Block Development Officers have been appointed as Panchayat Administrators by Govt in January this year. I had, in fact, written a separate article in March this year, impressed upon the BDOs to conduct Gram Sabha to decide Forest Rights Act related cases. I don't think even a single Gram Sabha has been held on FRA till date in more than 4000 panchayats in J&K from January 2024 to July 2024. Even after court orders the Gram Sabha has not been held for one reason or the other.

**The J&K** Assembly, Panchayat and ULB elections should all be conducted urgently as community of Branwar allege that Ghulam Mohammad Jahara alias Mama Chowdhary and his father late Qadir Bakhsi had forcibly taken control over such a huge chunk of meadows and were allegedly earning money from it as the family takes money from Bakarwals of Rajouri and Poonch for grazing their animals in summer months while as majority of the local Gujjar and other pastoralist communities were deprived of these rights. They claimed that after extension of Forest Rights Act -2006 to J&K post article 370 abrogation, such undemocratic practices ceased to act.

The matter finally landed in court last year and Sub Judge Chadoora had earlier also issued some orders and repeatedly it was ordered that the Gram Sabha must decide the matter. Pertinently under Forest Rights Act 2006 also Gram Sabha is the supreme authority to decide upon the claims filed by local population. The Gram Sabha is the adult population of the village (18 years and above) and 50 % quorum is necessary to decide on the Forest Rights Act (FRA) related cases.

### Case study Branwar Budgam

In February, the Court of Sub Judge Chadoora in Budgam district had ordered that the Gram Sabha decide on the issue of granting of grazing rights to the local population of Branwar and its panchayats in Block Surasyar as mandated under the Forest Rights Act -FRA. The order issued by Civil Judge Senior Division Mr Mir Wajahat had issued directions to the Gram Sabha to consider the rights and preferences of both the parties within 30 days from the date of issuance of the order so that there is equitable distribution of resources. But the order passed on Feb 28th 2024 was not enforced on the ground until July 25th 2024 when the court issued the final verdict.

The same court while pronouncing the final judgment again ordered that a Maha Gram sabha be held to decide granting of grazing rights to the local population of Branwar, Neegu, Jabbad and adjoining villages as mandated under the Scheduled Tribes and Other Traditional Forest Dwellers (Reignition of Rights ) Act also known as Forest Rights Act 2006 -FRA. While disposing of the case titled Ghulam Mohammad Jahara & others v/s Ghulam Qadir Thekrey and others Sub Judge Chadoora (Civil Judge Senior Division) Mir Wajahat on July 25th 2024 ordered that defendants can utilize the 12 designated pasturelands in Doodh Ganga forest range in Budgam until the final call was taken by the Gram Sabha. The order reads as:

"In presence of all parties to the suit it was agreed that all disputes would be settled if a Maha Gram Sabha for all the pastures is conducted under the supervision of an expert lawyer designated by the court, involving all sub division heads of the concerned departments

and in accordance with the law, rules and guidelines issued by the Hon'ble Supreme Court of India. Until Maha Gram sabha is conducted any person enjoying rights recognized by the Forest Department shall continue to do so without interference, until the Maha Gran sabha has the opportunity to deliberate and decide on the rights and preferences regarding this land to avoid any dispute pending decision by Gram Sabha. The defendants are permitted to utilize 12 designated pasturelands till then if permitted by law and officers at the helm of affairs."

### Background of the case

Pertinent to mention that plaintiffs Ghulam Mohammad Jahara alias Mama Chowdhary and others had claimed rights over Chaskani Nad meadow which is spread over an area of approximately 20,000 kanals of land located in Doodh Ganga forest range of Pir Panjaal forest division Budgam. Chowdhary family claims that this land was given to them on a goodwill gesture by the local pastoralist community around 50 years back when Ghulam Qadir Jahara alias Qadir Bakshi who is father of Ghulam Mohammad Jahara ( plaintiff) had prevented Bakerwals of Rajouri to encroach Chaskani Nad meadows. Since then he and his family claimed to have rights over this pastureland. This report has been submitted by the DFO Budgam in Sub Judge Court Chadoora.

The other party Ghulam Qadir Thekrey & others (defendants) who also belong to Gujjar

On June 28th, one of the applicants (plaintiffs) in the case Saifudin Jahara who is brother of Ghulam Mohammad Jahara along with Abul Rashid Jahara alias Hangdar had requested DC Budgam to withhold the Gram Sabha which had to meet on July 1st 2024. The Chief Planning Officer-CPO Budgam had written to concerned Block Development Officer -BDO Surasyar to postpone the Gram Sabha. Since then Gram Sabha also Halqa Majlis hasn't been held. Had the BDO not been the administrator of panchayats this would not have happened.

The officer has to abide by the orders of his seniors but the elected Panchayat won't get such orders at all. Both Saifudin and Rashid as per the local sources are Chairpersons of the Forest Rights Committee-FRC in Branwar and Jabbad panchayat halqas and Gram sabha has the power to change these Chairpersons as well. The people apprehend the decision of gram sabha will go against them and all the locals will get grazing rights plus new Chairpersons for local FRCs would be elected.

### Conclusion

The J&K Assembly, Panchayat and ULB elections should all be conducted urgently as people are suffering a lot. Even the village development plans are not prepared democratically as Gram Sabhas are not held at all. Until fresh panchayat elections are held, the Secretary Rural Development Department & Panchayati Raj Department and all the Deputy Commissioners must issue a circular to Block Development Officers (BDOs) to conduct gram sabha at least once in a week in at least one Panchayat halqa. Lastly, the Maha Gram Sabha to decide grazing rights in Chaskani Nad meadows of Pir Panjal Forest division in Budgam should also be conducted without any delay as soon as possible.

## Why Deadly Protests are Roiling Bangladesh

Prime Minister Sheikh Hasina of Bangladesh resigned on Monday as protests that began as peaceful demonstrations by students grew into a broader movement calling for an end to her increasingly authoritarian leadership of the nation.

Ms. Hasina deployed the police and paramilitary forces against the students late last month, a crackdown that set off broader public anger against her. The protests became increasingly violent as more students as well as other citizens joined, clashing with pro-government supporters and the authorities.

More than 300 people have been killed. After a curfew and communication blackout eased, the revival of the protests over the weekend, in addition to a call by Ms. Hasina's party for its own supporters to take to the streets, plunged Bangladesh into a particularly dangerous phase.

On Monday, the army chief announced the resignation and said an interim government would be formed.

Here's what to know about the protests. What were the protests about?

Students at the University of Dhaka, the country's top institution, started the demonstrations on July 1, and they later spread to other elite universities, and then to the general public. The protests turned violent when some members of student wing of the governing party, the Awami League, began attacking the protesters.

Besides sending the police and paramilitaries into the streets, the government locked down schools and colleges. Officials said they slowed down internet connectivity to stop the spread of rumors and protect citizens, making it harder for protesters to organize and make plans via social media platforms.

The protests were initially about coveted government jobs and who is entitled to them. An old quota system, reinstated recently by the courts, reserves more than



half of those jobs for various groups, including the families of those who fought for independence from Pakistan. The students said that the system is unfair and that most of the positions should be filled based on merit.

In the past couple of weeks, however, the movement grew massively and become centered on calling for accountability for Ms. Hasina's increasingly harsh governance.

How did the protests evolve?

The crackdown in late July, which saw over 200 people killed and 10,000 arrested, temporarily dispersed the protesters. However, the large number of deaths also fueled protesters' anger.

Over the weekend, the tensions spread away from protests and into clashes across the country that appeared difficult to contain. On Saturday at a rally of tens of thousands, protesters called for the resignation of Ms. Hasina, who has been in power for the past 15 years.

In response, Ms. Hasina's Awami League party called on its supporters to join counter protests, and she asked the country's people "to curb anarchists with iron hands." The threat emboldened protesters, who

called for a march on her residence in cen-

tral Dhaka on Monday. The government once again imposed a curfew, effectively shutting the country down.

By midafternoon Monday in Dhaka, what appeared to be conditions for another deadly day of protests had eased. Police officers let protesters cross barricades into the center of the city, and the army said they would make a statement.

Shortly after, the army chief announced that Ms. Hasina had left the country.

What will happen to Bangladesh after her ouster?

Ms. Hasina was among the world's longest-serving female heads of government,

a secular Muslim who fought Islamic militancy, helped lift millions out of poverty and deftly kept both India and China at her side.

Over the past 15 years, Ms. Hasina entrenched her authority and divided Bangladesh, a nation of 170 million people. Those who were loyal were rewarded with patronage, power and impunity. Dissenters were met with crackdowns, endless legal entanglement and imprisonment.

The army has asked the president, who holds a ceremonial role, to form a new government. Bangladesh's army has a history of staging coups and counter coups. But over the past couple decades, the military has taken a less overt role in public affairs, choosing more often to exercise influence from behind the scenes.

## What Are 'Metacrimes' – And **How Can We Stop Them?**

### The Conversation

he Apple Vision Pro is the newest tool for Australians to access threedimensional, immersive online environments, also known as the metaverse.

Released in Australia earlier this month, it allows users to take a (virtual) walk in the savanna from their living room, watch sports matches in an immersive environment, or even buy a house after completing a virtual inspection.

But these new online environments also have the potential to enable new crimes.

Metacrimes are those crimes occurring in the metaverse. They challenge our definitions of crimes in the digital realm, because they do not fit into existing frameworks of reporting and investigating crime.

Our new study tackles this problem by shedding light on the key characteristics of metacrimes. And by understanding these crimes better, we will be better able to fight them.

#### Metaverse, metacrime and cybercrime

The metaverse is a loose term describing a kind of three-dimensional, virtual world that users access via a virtual reality headset.

The 2018 movie 'Ready Player One' provides a good visualisation of what the metaverse might look like. In the movie, people put on special goggles and pick their avatar to enter a massive, interactive digital universe where they can do almost anything.

Our research found crimes committed in the metaverse have commonalities with conventional cybercrime. For example, both involve different kinds of illegal activities happening online or in virtual spaces. As technology gets better, these crimes are also becoming more global and anonymous. This makes it near impossible to catch the perpetrators.

### The unique features of metacrimes

One such feature is immersive VR attacks, which are made to feel real through immersion and spatial presence.

Immersion is created through a number of sensory techniques in the headset, including visual, sound and haptic (touch). This creates a feeling of spatial presence that allows the user to perceive and experience the virtual space as real. This means negative experiences such as sexual violence and harassment also feel real.

Unless you are constantly recording your interactions in the metaverse via your headset, crucial evidence of that unpleasant interaction would not be captured. Some companies have created user controls, such as a safety bubble that can be activated around your avatar. However, we do not yet have sufficient research to know whether these are effective.

Our study argues the impact of metacrimes will also be exacerbated for vulnerable populations, especially children who occupy a large proportion of active metaverse users. Difficulties in verifying children's age online add extra concerns about

person's environment. Manipulation of VR technologies, such as haptic suites that enable users to physically engage with virtual spaces, also enable perpetrators to inflict direct physical harm on users.

This can include inflicting visual vertigo, motion sickness, and neurologic symptoms.

#### Where to from here?

Major tech companies such as Apple, Meta and Microsoft are investing heavily in the metaverse, developing both hardware and software to enhance their platforms.

Research firm Gartner predicted by 2026, 25 per cent of people will spend at least an hour each day in the metaverse for work, shopping, education, social media and entertainment.

This prediction may be not too far away from reality. Australia's eSafety Commissioner's national online safety survey conducted in 2022 found 49 per cent of metaverse users said they had entered the metaverse at least once a month in the last year.

It is therefore urgent that governments and tech companies develop metaverse-specific legal and regulatory frameworks to safeguard immersive virtual environments. National and international legal frameworks will need to account for the new characteristics of metacrime we have identified. Law enforcement will need to upskill in metacrime reporting and investigations.

In the past, companies have talked about using new technologies responsibly ndash; but haven't taken responsibility when their platforms were used for crimes and harms. Instead, tech leaders deploy what researchers are now calling an "artful apology" (for example, "I'm sorry you experienced this on our platform").

But this does nothing tangible to tackle the problem, and metaverse companies should instil clear regulatory frameworks for their virtual environments to make them safe for everyone to inhabit.

Press Trust Of India oing vegan for eight weeks was found to be linked to lowering

of biological age, according to a study published in the journal BioMed Central (BMC) Medicine. Researchers looked at the molecular effects of the plant-based diet that abstains from consuming animal food products, such as dairy. The diet largely includes eating fruits and vegetables, along with grains, beans and nuts.

The researchers, including those at Stanford University, US, found that consuming the plant-based diet was related with changes in how a gene expressed itself, or gene behaviour, without changing the DNA itself. Specifically, they looked at DNA methyla-

tion, known to be able to "turn off" or "silence" a gene, thereby not allowing it to express itself. Higher levels of

DNA methylation is associated with a higher biological age. It is one of the epigenetic processes, which affect the behaviour of a gene by altering its environment.

For eight weeks, the team followed 21 pairs of adult identical twins -- one half of each pair consumed an omnivorous diet. including meat, eggs and dairy, while the other consumed a vegan one. Identical twins share a significant amount of their genetic makeup. On average, the partici-

pants were aged 40 years and had a body mass index (BMI) in the overweight category. About 77 per cent of the group were women.

After eight weeks, the researchers observed a 'younger' heart, liver, inflammatory

### and metabolic system among the participants consuming the vegan diet. These changes were not seen in those eating the omnivorous diet.

However, the authors cautioned that the extent to which these changes could be attributed to their diets was unclear.

They noted that on average, the individuals on the vegan diet lost two kilograms more compared to those on the omnivorous diet.

The results suggest that the weight loss could have contributed to lowering of the biological age in the vegan group, the researchers said.

Reacting to the study, Tom Sanders, a professor emeritus of Nutrition and Dietetics at King's College London, and not in-



volved in the study, said that the findings might be favourable for vegans in terms of ageing.

However, the diet can come with micronutrient deficiencies, which often take years to exert harmful effects. Sanders said.

"For example, unless a vegan diet is supplemented with vitamin B12 they develop vitamin B12 deficiency that causes chronic and often insidious damage to the nervous system," Sanders said.

Long-term studies of vegans also find adverse effects on bone density, probably caused by very low calcium and barely adequate protein intakes, Sanders said.

## Stock Market Carnage Makes Investors Poorer By Rs 15.32 Lakh Cr

NEW DELHI- Stock market investors lost a whopping Rs 15.32 lakh crore on Monday following a crash in Indian equities triggered by a sharp plunge in Japanese and other global markets. The 30-share BSE benchmark plummeted 2,222.55 points or 2.74 per cent to settle at over a month's low of 78,759.40, marking its worst single-day retreat since June 4, 2024. During the day, it tanked 2,686.09 points or 3.31 per cent to 78,295.86.

Following the sharp decline in equities, the market capitalisation of BSE-listed firms dropped by Rs 15,32,796.1 crore to Rs 4,41,84,150.03 crore (USD 5.27 trillion).

"Domestic equity indices came under the grip of global markets carnage as a host of external factors like recession fears in the US on the back of weak jobs data, interest rate hike in Japan leading to impact on Yen-carry trade and a raging Middle East conflict trig-gered massive sell-off across the board," Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.

In Asian markets, Seoul, Tokyo, Shanghai and Hong Kong settled sharply lower.

### Japan's benchmark stock index plunged 12.4 per cent on Monday, compounding a global market rout set off by investor concerns that the US economy could be headed for recession. A report on Friday showing hiring by US employers slowed last month by much more than

expected convulsed financial markets, vanguishing the euphoria that had taken the Nikkei 225 to all-time highs of over 42,000 in recent weeks.

On Monday, the Nikkei closed down 4,451.28 points at 31,458.42. It had dropped 5.8 per cent on Friday, making this its worst two-day decline ever. Its worst single-day rout was a plunge of 3,836 points, or 14.9 per cent, on October 19, 1987, a global markets crash that was dubbed "Black Monday" but proved to be only a temporary setback despite fears it might have augured a worldwide downturn.

"The global market is reeling as bears enter with a cocktail of bad news. The fear of a reverse Yen carry trade, following an interest rate hike in Japan, was the initial catalyst. This was compounded by fears of a recession in the USA after extremely poor jobs data, which spooked market sentiment," said Santosh Meena, Head of Research, Swas**Public Sector Banks' NPAs On** Mudra Loans Fall To 3.4% In 2023-24: Sitharaman

NEW DELHI- Public sector banks' non-performing assets associated with the Mudra loan category have declined to 3.4 per cent in the 2023-24 fiscal, Finance Minister Nirmala Sitharaman said on Monday.

This marks an improvement from 4.77 per cent in 2020-21, 4.89 per cent in 2019-20, and 3.76 per cent in 2018-19, she said in response to a query in the Lok Sabha during the Question Hour.

Sitharaman addressed questions regarding the nonperforming assets (NPA) associated with Mudra loans, highlighting a significant reduction in NPA rates over the past few years.

The finance minister in-formed the House that the NPA for public sector banks on Mudra loans has decreased to 3.4 per cent in the financial year 2023-24. She further said Mudra loan

NPAs in private sector commercial banks fell to 0.95 per cent in 2023-24 from a peak of 1.77 per cent in 2020-21 and 0.67 per cent in 2018-19. Non-performing assets

(NPAs) are loans or advances for which the principal or interest payment remains overdue for 90 days. NPAs are a critical indicator

of the health of the banking sector, as high levels of bad loans indicate a higher risk of default, leading to financial instability. Regarding interest rates

### IndiGo To Introduce Business Class Seats From Mid-November; **Announces Loyalty Programme**

NEW DELHI- IndiGo will introduce business class seats in select flights on 12 domestic routes starting from November 14 and also launch a customer loyalty programme, as the 18-year-old airline seeks to expand business and strengthen global presence.

The announcements, made at an event in the national capital on Monday to mark 18 years of operations, also highlights a pivotal trajectory for the airline.

IndiGo is moving from being just a low-cost carrier to introducing business class seats, offering a loyalty programme and preparing to have widebody A350 planes in 2027. IndiGo CEO Pieter Elbers said

the business class seats will be open for booking from August 6 and added that the business class passengers will be offered curated special meals.

There will be a total of 12 seats in the configuration of 4 seats in 3 rows in the A321 neo planes. These aircraft will have a total of 220 seats -- 12 business and 208 economy class,

according to an official. The seats will be introduced in the select flights from November 14, the official added. The introductory one-way fare for a business class seat

will be starting at Rs 18,018. Elbers said the business class seats will be available on busiest and business routes, and will start with Delhi-Mumbai flights. Currently, Tata Group-



owned Air India, Air India Express and Vistara offer business class seats.

Elbers said the airline is moving to the next level. "If you connect the dots, (there is a) changing Indian market, consumers who are more and more frequently travelling with us, a business product here, an international focus,' he noted.

IndiGo has a domestic market share of nearly 61 per cent and around 975 planes on order. At the end of June, the airline had 382 planes and operates over 2,000 flights daily connecting more than 120 destinations.

The airline, which is focused on cost leadership, will also be launching the customer loyalty programme 'IndiGo BluChip' which will go live in September. IndiGo is describing its business product as 'IndiGoStretch'. "A total of 45 shipsets have been ordered to meet this upgrade, with each A321neo aircraft featuring 12 business class seats and 208 economy class seats.

"Aircraft deliveries are scheduled to begin in Q4 2024, and all business class installations are expected to be completed by the end of 2025," the airline said in a release.

### Govt Collects ₹8,263 Crore GST On **Health Insurance Premium For FY24**

NEW DELHI: Government collects Rs 8,263 cr towards GST on health insurance premium in Financial Year'24 Aug 5

The government has collected Rs 8,263 crore towards GST on health insurance premium in 2023-24 fiscal year, Parliament was informed on Monday. The Minister of State for Finance Pankaj Chaudhary said the government has received representations requesting for exemption or reduction in the rate of GST on life insurance and health insurance.

Since its inception, GST @18 per cent rate is levied on premium paid towards health insurance, the Minister of State said in a written reply in the Lok Sabha. However, certain insurance schemes catering to poor sections of the society and differently-abled, such as Rashtriya Swasthya Bima Yojana (RSBY), Universal Health Insurance Scheme, Jan Arogya Bima Policy and Niramaya Health Insurance Scheme are exempt from Goods and Services Tax (GST). In 2023-24, the GST collection from health insurance premium stood at Rs 8,262.94 crore, while Rs 1,484.36 crore was collected on account of GST on health reinsurance premium. In the 2022-23 fiscal, Rs 7,638



crore GST was mopped up from health insurance premium, and another Rs 963 crore from health reinsurance premium.

In the 2021-22 financial year, GST of Rs 5,354 crore was mobilised from health insurance premium, while Rs 826 crore came in from health reinsurance premium. In reply to a separate question, Chaudhary said after the introduction of GST with effect from July 1 2017 CST is levi-

Regulated Entities (REs) generally use various models as part of their credit management, including for credit appraisal, borrower scoring, pricing, and risk management,

"REs shall put in place a detailed Board approved policy with regard to model risk management framework for all models deployed, covering the entire model life cycle," the draft said. The policy should cover details of governance and oversight aspects commensurate with model materiality; processes around model development or selection; and documentation for models deployed. It should also cover independent vetting / ongoing validation or review processes; change control; and the monitoring and reporting framework including role of internal audit function.

The precious metal settled lower at Rs 72,550 per 10 grams in the previous session on Saturday.

Extending its losses for the third straight day, silver prices tumbled by Rs 1,300 to Rs 84,200 per kg on decreased offtake by coin makers and industrial units, according to the All India Sarafa Association. It had ended at Rs 85,500 per kg in the previous session.

In addition, gold of 99.5 per cent purity increased by Rs 250 to Rs 72,450 per 10 grams from the previous close of Rs 72,200 per 10 grams.

In the international markets, Comex gold is trading at USD 2,461.10 per ounce, down by USD 8.70 from the previous close

"COMEX gold experienced a volatile session, plummeting sharply before recovering as traders assessed a severe stock sell-off and rising Middle East tensions," Dilip Parmar, Research Analyst at HDFC Securities, said.

Silver was also quoted lower at USD 27.47 per ounce in New York

Meanwhile, gold futures plunged Rs 309 or 0.44 per cent to trade at Rs 69,480 per 10 grams on the Multi Commodity Exchange (MCX). The most traded October contract of gold hit an intra-day low of Rs 69,453 per 10 grams.

Further, silver contracts for September delivery declined by Rs 2,719 or 3.3 per cent to Rs 79,774 per kg on the MCX.

## **UPI Transactions Jump 36% To** Rs 60 Lakh Crore In June Quarter

**NEW DELHI-** UPI transactions in the first three months of the current fiscal have grown over 36 per cent to Rs 60 lakh crore, Parliament was informed on Monday.

As per the details of UPI transactions shared by Minister of State for Finance Pankaj Chaudhary in the Lok Sabha, 4,122 crore UPI transactions worth Rs 60 lakh crore took place between April and June in 2024-25.

In the April-June period, 2,762 crore UPI transactions took place, having a value of Rs 44 lakh crore.

For the full fiscal 2023-24, 13,113 crore UPI transactions were made with a value of Rs 200 lakh crore.

In FY23, a total of 8,371 crore UPI transactions took place with a value of Rs 139 lakh crore, while in FY22, there were 4,596 crore transactions involving Rs 84 lakh crore.

Chaudhary further said that a facility of cardless cash deposits



on an inter-operable basis has been extended through UPI.

Presently, this facility has been made available by a select few banks. To ensure the safety and security of cash deposits through UPI, certain conditions have been prescribed, including a customer is permitted to deposit a maximum of Rs 50,000 per transaction using this facility. Banks are permitted to fix a lower limit based on

their risk management policies. National Payments Corporation of India (NPCI) has been advised to prescribe the permissible number of Interoperable Cash Deposit (ICD) transactions for a depositor at the level of Payer PSP or NPCI.

Transaction messages shall capture the details of the depositor and clearly stipulate that it is a cash deposit transaction.

Hearing separate pleas, a single Bench of the court last month had directed the Bank to consider the non IBPS Banking Associates with seven (7) plus years of service for promotion as per assessment envisaged under clause 5.2 (of Policy for Promotion of Workmen (Banking Associates, Assistants, Banking Associates and Banking Attendants) to the next post with or without subjecting them to a screening written test (objective type) at its discretion given the fact of number of available promotion posts are more and the total number of Banking Associates, IBPS and non-IBPS, less.

"The time isn't far away when, through your votes, you will be able to elect your own government in J&K," the PM said in Srinagar on June 20. "The day will come very soon when J&K will become a state again for its bright future."

Since then, the union home minister Amit Shah and the BJP president I P Nadda have held their separate Kashmir meetings, apparently to rally their party for the upcoming polls. While Shah's meeting was held in New Delhi, Nadda flew to Jammu to meet the senior J&K BJP leaders.

However, the delay in announcement of the polls by the Election Commission is sowing doubts in the minds of people that the union government may be interested in yet again deferring the exercise. While a handful of activists of the BJP celebrated in Srinagar, Congress and the People's Democratic Party (PDP) held protests in Jammu, declaring the day a "black day" for the region.

The day was marked by claims of repression from regional party leaders as former chief minister and PDP president Mehbooba Mufti announced on social media that she had been placed under house arrest and called August 5, 2019, a "dark day" for both Jammu and Kashmir and Indian democracy.

"I have been placed under house arrest while the PDP office has been locked," Mehbooba said.

"The day when a semi-autonomous state was disempowered and robbed of everything special," she lamented.

A police truck was placed outside the residence of veteran politician and three-time chief minister Farooq Abdullah at his Gupkar residence.

National Conference leader Omar Abdullah echoed these sentiments, criticising the apparent "double standard" of the government in its treatment of BJP's celebrations and the confinement of dissenting voices.

"This is what passes for democracy and free speech in J&K," he remarked, highlighting the lockdown of opposition leaders while the ruling party celebrated.

Reports indicated that several opposition leaders, including National Conference chief spokesman Tanvir Sadiq, were also under house arrest, with Sadiq denouncing the restrictions as "unwarranted and illegal."

In a statement, the National Conference condemned the government's actions, stating that the house arrests of its leaders represented a blatant suppression of dissent and an effective isolation of the party headquarters in Srinagar.

"This blatant suppression of mainstream democratic activities only serves to showcase the administration's underlying fear and exposes the hollowness of their claims of progress over the past five years," the party said. In Jammu, Congress and PDP rallied

together to demand the restoration

The abrogation of Article 370 in 2019, coupled with the Jammu and Kashmir Reorganisation Act, resulted in the bifurcation of the state into two union territories: Ladakh and Jammu and Kashmir.

Critics continue to point to the lack of an elected assembly and local governance as a significant concern for the region's residents.

People's Conference president Sajad Gani Lone expressed that August 5 would serve as a reminder of the "complete disempowerment of the Kashmiri people," emphasising the absence of local representation in governance.

## **Pakistan Super League Set To Clash With Indian Premier League Next Season**

LAHORE: The Pakistan Super League is set for a clash in dates with the Indian Premier League next season as the PCB has been forced to change the window of its T20 league owing to a busy international schedule.

The PCB has indicated that the PSL could be held between April 10 and May 25 next year. The last edition of the IPL was

held from March 22 to May 26 this year.

The PSL is usually held in the months of February and March every year but with Pakistan hosting a tri-series at home, followed by the Champions Trophy and a tour by the West Indies next year, change in the tournament's schedule is imminent.

The Pakistan team's home and away season begins this



month and will run until April 2025. The PCB on Monday also an-

nounced an overhaul in the monthly retainers of the domestic players, who would be

picked in five elite teams for three new events known as Champions tournaments.

As many as 150 players slotted across five teams would get upgraded salaries in different slabs.

In Category 1, 40 players will receive PKR 550,000 per month whereas in Category 2, 50 players will get PKR 400,000 per month. The Category 3 will have 60 players who will earn PKR 250,000 per month.

In comparison, the 2023-24 season domestic contracts ranged from PKR 50,000-3,00,000, depending on the category.

Additionally, players will benefit from increased match fees as PKR 200,000 will be paid for red-ball cricket, PKR 125.000 for 50-over games and PKR 100,000 for T20 matches.

This marks a significant rise from the previous season's match fees of PKR 80,000 for red-ball and PKR 40,000 for white-ball matches.

## Olympics Security Means Minorities, Others Flagged As Potential Terror Threats

**PARIS:** They are Nabil, Amine, François and more. But they will not be seen around the Paris Olympics, because France's government barred them from getting anywhere close.

French authorities are making unprecedentedly broad use of discretionary powers under an anti-terror law to keep hundreds of people they deem to be potential security threats away from the biggest event modern France has ever organized.

Minorities - largely with backgrounds in former French colonies - are often among those forbidden from leaving their neighbourhoods and required to report daily to police, their lawyers say. Some are alarmed by the sweeping use of what one described as "a terribly dangerous tool."

Some of those now restricted in their movements, with orders that don't require prior approval from judges, include a man who had mental health issues in the past but is now receiving treat-

tice bank worker and business student who believes he's been targeted in part because he's Muslim and his father was born in Morocco, plus a halal food delivery driver who risks losing his job because he is banned from straying far from home during the 2024 Olympics and ensuing Paralympics, their lawyers say. French Interior Minister Ger-

ment. There also is an appren-

ald Darmanin says the restrictions aim to prevent "very dangerous" people from attacking the Games.

Darmanin says he's applied them to more than 500 people this year as part of France's security preparations for the Games and the Olympic torch relay that preceded the July 26 opening ceremony.

Those affected include Amine, the bank apprentice now forbidden from leaving his suburb south of Paris - except to report at 6:30 p.m. daily to a local police station. The France-born 21-year-old has no criminal record and has not been charged



with any crime, he and his lawyer say.

Amine believes French intelligence services have mistaken him for someone else who posted decapitation images and threats against LGBTQ+ people on a video-sharing app. The Associated Press is not identifying Amine by

his full name because he fears potential employers and schools may reject him if they learn that police flagged him as a threat.

"I am not dangerous for France. I am not a terrorist. I am just a student who works to finance his studies," Amine said in an interview at his studio apartment strewn with books and with family photos on the fridge.

Police visited twice in the last four months. They busted down a neighbor's door the first time, seemingly because they had the wrong address, and then seized Amine's phone and computer, which made boning up for his ex-

ams harder, he said. The second time, a month before the Games, was to notify him that he could no longer move around freely.

"If my name was Brian, if I was blond and blue-eyed, the situation would have been different. Except that it is not the case. I am a North African Muslim, and I've been targeted in France," he said.

Fearing terror attacks, French authorities have massively ramped up security for the Games, flooding Paris streets with up to 45,000 police, plus soldiers armed with assault rifles, and tasking intelligence services to identify and neutralize potential threats in advance.

Interior Ministry notes seen by AP say security services foiled several alleged terror plots ahead of the Games, with Olympic soccer matches, an LGBTQ+ night club and France's Jewish community among suspected targets. The ministry's notes also say the Israel-Hamas war has heightened the terror risk in France, which has the largest Muslim and Jewish communi-

ties in Europe.


The anti-terror preventive effort also includes the liberal use of police powers to restrict the movements of people the ministry deems to be potential threats. The measures can only be challenged afterward in court, which some of those affected are now doing - a few successfully.

The powers were part of reinforced anti-terror legislation that sped through both houses of parliament in 2017 when France was still reeling from attacks by al-Qaida and Islamic State gunmen and suicide bombers in 2015.

The attacks killed 147 people including in Paris neighborhoods now teeming with Olympic visitors and outside what is now the Olympic stadium, hosting track and field and rugby sevens.

The anti-terror law empowers France's interior minister to restrict anyone's movements when there are "serious reasons" to believe they're a grave security threat and have terror ties or sympathies.


