

# **Study Uses Music To Trigger Responses In Brains Of Patients Resistant To Depression Treatment**

estern classical music can help activate brains of patients who do not respond to anti-depression The results, published in the journal Cell Reports, could help develop personalised music therapy plans for patients with treatment-resistant depression, in which one's depressive symptoms persist despite taking multiple antidepressants.

According to previous studies, these patients have been observed to have brain processes biased to respond more easily to sad faces, compared to happy faces.

In this study, 13 patients with treatmentresistant depression listened to pieces writ-ten by Mozart and Beethoven among others and the researchers, including those from China's Shanghai Jiao Tong University, studied their brains to understand how music

produced anti-depressant effects. For the purpose of deep-brain stimulation in these patients, the team implanted electrodes and placed them in the 'extended amygdala' circuit. The amygdala plays an important role in one's motivation and emo-



tional behaviour. It is located in the forebrain, which is the brain's largest part and helps with higher thinking processes, such as those involved in reasoning and language. The 'extended amygdala' circuit connects two areas in the forebrain -- the bed nucleus of the stria terminalis (BNST), which plays a role in managing stress and the nucleus accumbens (NAc), which is involved in

experiencing pleasure.

The researchers found that classical music worked as an antidepressant by harmonising activity between the three brain regions the auditory cortex, involved in listening, the BNST (manages stress) and the NAc (helps experience pleasure).

The BNST-NAc circuit, sometimes referred to as part of the 'extended amygdala,' under-

scores the close relationship between this circuit and the amygdala, a central structure in emotional information processing," senior author Bomin Sun, director and professor of the Centre for Functional Neurosurgery at Shanghai Jiao Tong University, said.
"This study reveals that music induces triple-time locking of (brain waves) in the

cortical-BNST-NAc circuit through auditory synchronisation," Sun said.

The synchronisation and the "antidepressant effects" were found to be more signifi-cant in patients having a high appreciation of music, compared to those having a low appreciation of music.

Most of the patients were not familiar with the Western classical pieces used in the study, the authors said.

The results helped the researchers propose personalised music therapy plans that would improve treatment outcomes, they said.

"Our research integrates the fields of neuroscience, psychiatry, and neurosurgery, providing a foundation for any research targeting the interaction between music and emotion. Ultimately, we hope to translate our research findings into clinical practice. developing convenient and effective music therapy tools and applications," Sun said.

# Army Captain, Terrorist Killed In **Doda Encounter**

Jammu: An Army captain and a terrorist were killed in an ongoing operation in the higher reaches of Jammu region's Doda district on Wednesday, officials said.

A civilian was also injured in the encounter that broke out on the eve of Independence Day and is the latest in a series of incidents in the Jammu region that has wit-

nessed a spike in violence of late. This is the fourth encounter in recent days in the Udhampuri-Doda-Kishtwar region of Jammu

Bullets rang out on Wednesday morning in a thickly-forested

area during a cordon-and-search operation (CASO) launched by a joint team of security personnel to track down a group of foreign terrorists hiding in the Shivgarh-Assar belt, the officials said.

Captain Deepak Singh was critically injured during the operations and shifted to a military hospital where he succumbed to his injuries, they added.

"One terrorist has been neutralised in the ongoing operation. One AK 47 has been recovered. Intermittent exchange of firing continues as the operations are ongoing," the Army said in a post on X.

# Kolkata Rape: OPD Services Hit Across Country As **Doctors' Strike Continues**

New Delhi: OPD services in government hospitals of several states across the country remained affected on Tuesday as the resident doctors' strike over the alleged rape and murder of a postgraduate trainee in Kolkata entered its second day, even as the CBI took over the investigation in the case.

The Federation of Resident Doctors' Association (FORDA), which called for a nationwide indefinite strike over the incident. on Tuesday night said it was calling off its strike as Union Health Minister J P Nadda has accepted their demands.

However, the medics at the central government-run AIIMS, the Indira Gandhi Hospital and other resident doctors' associations, including the Federation of All India Medical Associations (FAIMA), said their stir would continue until a central law to nite strike. While all elective services in hospitals across the state have been halted, emergency services will continue uninterrupted, Maharashtra State Association of Residential Doctors (Central-MARD) president Dr Pratik Debaje told PTI.

"From 9 am, we stopped work at all OPDs (out-patient departments), and elective services have been stopped. Now, only emergency services are operational across the state," Dr Debaje said.

Meanwhile, the Calcutta High Court on Tuesday ordered the transfer of probe into the case from the Kolkata Police to the CBI.

While transferring the investigation to the CBI, a division bench presided by Chief Justice T S Sivagnanam also urged agitating doctors to call off their cease-work, maintaining that there is a "pious obligation" on their part to treat patients who come to government

curb attacks on medical personnel is implemented.

A delegation of FORDA met with Mr Nadda at his residence in New Delhi on Tuesday night.

FORDA said the decision to end the strike will be effective from Wednesday morning.

"A key outcome of the meeting was the health minister's agreement to form a committee with FORDA's involvement to work on the Central Protection Act. The ministry has assured that work on this will begin within the next 15 days," the resident doctors' body said in a statement.

In West Bengal, the epicentre of the protest, a widespread agitation by junior doctors crippled state healthcare services, with the functioning of even emergency and outdoor departments coming to a halt in most government hospitals.

Long queues of patients were seen at out-patient departments (OPDs) of all government hospitals since Tuesday morning as senior doctors were substituting their junior counterparts to address the rush.

In the national capital, elective services in government hospitals remained shut on Tuesday due to the ongoing strike.

On Tuesday, resident doctors in Maharashtra joined the indefition, the CBI took over the investigation and a team of the central agency sleuths from Delhi, along with forensic scientists and medical experts, will visit Kolkata on Wednesday, officials said.

The direction was passed in the wake of a petition moved by the victim's parents praying for a court-monitored probe and multiple other PILs seeking probe trans-

The interim order came five days after the gruesome incident that took place at the RG Kar Medical College and Hospital in Kolkata.

The body of the postgraduate trainee with severe injury marks all over was found inside the seminar hall of the state-run hospital's chest department on Friday morning. The preliminary autopsy report suggested she was subjected to violent sexual assault.

Despite the Kolkata Police arresting a civic volunteer named Sanjay Roy in this connection on Saturday, the move failed to silence the clamour of allegations of a botched up investigation and evidence tampering which have now snowballed into an outrage of junior doctors spreading across medical campuses of the state and beyond.



# **US Approves \$20bn Arms Package For Israel Amid Looming Iran Threat**

Washington: The United States has approved another \$20bn in weapons transfers to Israel, despite concerns that Israeli forces are routinely violating international law in Gaza and the occupied West Bank.

Secretary of State Antony Blinken approved the arms sale, which includes fighter jets and missiles, the US Department of State announced on Tuesday.

'The United States is committed to the security of Israel, and it is vital to US national interests to assist Israel to develop and maintain a strong and ready self-defence capability," the State Department said.

The order includes Boeingmade F-15 fighter jets, Advanced Medium-Range Air-to-Air Missiles, or AMRAAMs, 120mm tank ammunition and high explosive mortars and tactical vehicles.

Some of the weapons, including the more than 50 fighter jets, could take years to deliver. Other equipment, such as 33,000 tank shells and 50,000 explosive mortar cartridges, could arrive soon

The US said that the tank shells "will improve Israel's capability to meet current and future enemy threats, strengthen its homeland defence and serve as a deterrent to regional threats".

The announcement came as Israel expects retaliation from Iran and Lebanon-based Hezbollah following the assassinations of high-level Hamas and Hezbollah officials, which have raised concerns over the possibility of a regional war.

The US has said it is working to avoid such an escalation.

President Joe Biden on Tuesday said an Iranian response might be avoided if a ceasefire agreement was reached to end the war in Gaza where Israeli forces have killed nearly 40,000 people, largely women and children, levelled entire neighbourhoods and blocked shipments of humanitarian assistance.

Critics have called on the Biden administration to cut off weapons transfers to Israel, alleging that they make the US complicit in the destruction of Gaza

They also note that the supply of arms is a potential source of leverage, but that the administration has refused to exploit it to secure a ceasefire

Reports that Israeli forces are systematically violating international law and committing abuses such as torture have also failed to stop the flow of weapons, despite requirements under US law that military units credibly accused of gross human rights violations be cut off from support.

Speaking before a meeting of the United Nations Security Council, called on Tuesday to discuss the deadly weekend air strike on a school-turned-shelter in Gaza, IIS ambassador Linda Thomas-Greenfield said her country's goal in the region was to "turn the temperature down".

"That starts with finalising a deal for an immediate ceasefire with hostage release in Gaza. We need to get this over the finish line," she said.

'Pouring gasoline on fire'

Tarek Khalil, a Palestinian human rights activist, told Al Jazeera that the US has the power to force Israel to sign a ceasefire deal in Gaza by withholding weapons.

# "Every Symbol Of India's Ties With Bangladesh Is Being...": Shashi Tharoor

New Delhi: Amid the ongoing violence in Bangladesh, Congress MP Shashi Tharoor said that it is difficult for people in India to be indifferent when every symbol of the country's friendship with Bangladesh is being attacked there.

Pointing to the turmoil in Bangladesh, Mr Tharoor said it is tragic to see what was hailed as a democratic degenerating into anarchy, and violence targeting the minorities and the Hindu minority.

"It's extremely tragic that what was hailed as a democratic, popular revolution has degenerated into anarchy, and violence targeting the minorities and the Hindu minority... We in India must stand with the people of Bangladesh. But it's difficult for us to be indifferent when every symbol of India's friendship with Bangladesh is being attacked, Mr Tharoor told ANI.

He highlighted how sever al institutions were vandalised during the ongoing violence, making it a "very negative" sign for people in India.

Mr Tharoor said, "The statue of the surrender of the Pakistani forces to Indian soldiers has been smashed to bits. The Indian Cultural Centre is destroyed, and a number of institutions are vandalised, including the ISKCON temple. All of these things are very negative signs for people in India. It is not in Bangladesh's interest either to come across in this way.

"They should be saying that this is about the restoration of their democracy, but in the process, you turn against the minorities and in particular one minority, inevitably, that will be noticed and resented in our country and elsewhere..." he added.

Bangladesh is experiencing a volatile political situation, after Sheikh Hasina resigned from the post of Prime Minister on August 5 amid mounting protests. The protests, led mainly by students demanding an end to a quota system for government jobs, evolved into anti-government demonstrations.

# Over 4,000 Lights Installed In Ayodhya's Bhakti Path And Ram Path Stolen, Fir Filed

Ayodhya: As many as 3,800 bamboo and 36 projector lights worth over Rs 50 lakh installed on Bhakti Path and Ram Path, located in a high-security area in Avodhya. were allegedly stolen, according to police.

An FIR was lodged at the Ram Janmabhoomi police station following a complaint on August 9 from a representative of the firm --Yash Enterprises and Krishna Automobiles --which set up the lights under a contract awarded by the Ayodhya Development Authority, police said on Tuesday.

"As many as 6,400 bamboo lights were installed on Rampath and 96 projector lights were in-

stalled on Bhakti Path. Till 19 March, all the lights were there but after an inspection on May 9, it was found that some lights were

"Till now around 3,800 bamboo lights and 36 projector lights have been stolen by some unknown thieves," Shekhar Sharma, a representative of the firm, said in the complaint.

According to the FIR, the firm became aware of the theft in May but filed the complaint on August 9.

The police said that an FIR has been registered in the matter and a probe is on. Ayodhya was refurbished un-

der a major project ahead of the January 22 Ram temple consecration ceremony in the holy city.

Deir Al-Balah, Gaza: When girls complain to Gaza paediatrician Lobna al-Azaiza that they have no comb, she tells them to cut off their hair.

It's not blockade of the territory, ravaged by 10 months of war, means there is little or no shampoo, soap, period products or household cleaning materials.

Waste collection and sewage treatment have also collapsed, and it's easy to see why contagious diseases that thrive on overcrowding and lack of cleanliness such as scabies or fungal infections - are on the rise.

"In the past period, the most common disease we have seen was skin rashes, skin diseases, which

# **Drug Scourge**

rug addiction in Kashmir is an issue that hurtles into an occasional media spotlight but never gets the public and the government attention that it deserves. We only get to hear about the scourge in the form of statistics. Last year in August, the Standing Committee on Social Justice and Empowerment conveyed to the Parliament of India that approximately 13.50 lakh drug abusers are estimated to be in Jammu and Kashmir, with the majority falling within the age range of 18 to 75 years. This is an alarming number and must otherwise prompt an immediate government response with a proper roadmap to address the situation. But that hasn't happened. And we expect that the administration takes the issue seriously and plays a role that is required of it.

Last year, a study found that around 52,000 people alone are using IV Heroin, among whom 34 percent are unmarried. What is more, while a recent study of All India Institute of Medical Sciences (AIIMS) Delhi said that Punjab has 1.2 percent of opiate users, Kashmir study has revealed the percentage at 2.87 percent.

However, it is not difficult to see what is leading the youth towards drugs. The complexity of the crisis lies in its multifaceted origins, where poverty and unemployment play a key role in pushing many young individuals into the clutches of addiction. Another major factor is the political conflict of the past over thirty years which is taking its toll on the youth. According to unemployment figures, jobless rate in Kashmir is 24 percent with unemployment among women at 48.6 percent. There are also a huge number of uneducated and unskilled youth who look forward to no future. The reigning political uncertainty and the humanitarian fallout of the past three decades have only reinforced the sense of hopelessness, leading youth to ease their frustration through drugs.

That said, the dismal state of affairs is no less aided by the easy availability of prescription drugs in the state. As a society, we are always inclined to trace these wrongs to the prevailing political conflict in the region and hence absolve ourselves of the responsibility to collectively play a role in redeeming the situation. We need to step up and face the humongous problem head on. Government, on the other hand, needs to actively engage young people in incomegenerating activities, including sports, to ensure that those who benefit from rehabilitation do not relapse and are embraced by their families and society once they change their ways.

# **The Radical Act of Rest**

# Kashmiri Women, Roles, and Resistance

n a world where women are constantly expected to do it all, have you ever wondered what happens when they just stop and take a breath? What if the most radical act of resistance isn't in the struggle but in the stillness? What if real rebellion happens when women take some moments for themselves without any responsibilities or roles?

#### **Gendered Dichotomy**

Throughout history, leisure for men and women has been greatly influenced by gender roles which result in different experiences altogether. Men. often considered tough and adventurous, tend to pursue leisure activities away from home - for example playing sports or engaging in heated political debates.Women, on the other hand, are often viewed as nurturing, private, and inclined to stay within the home. Their "leisure" is typically woven into their responsibilities, like caring for the family or keeping the household running smoothly.

Historically, there isn't much separation between work and relaxation in the lives of women. Their roles blur the lines between labor and leisure, making those quiet moments of rest feel like a rare luxury

For men, who work outside the home, work and leisure are clearly separated. Of course, economic status influences how people spend their free time but regardless of wealth, men still find ways to carve out time for themselves. For the affluent, it might be a drive or a hobby; for others, it could be as simple as gathering at a local stall for a chat.

#### The Unequal Landscape of Leisure

Leisure is when you can just be yourself without worry about your work or anything else that obliges you. Unfortunately, for many women, such as those in rural India, spare time is something they do not have enough of.


The Time-Use Survey 2019-20 for India states that young working women in rural areas spent almost five hours daily on domestic tasks while urban counterparts spent about two hours forty-five minutes

Thus, for many women, leire isn't a scheduled break: it's something snatched in between daily responsibilities. It might be listening to the radio while cooking or chatting with a friend on the way to work. But for the women of Kashmir, leisure is about more than just choosing how to spend their time. It's about navigating a complex web of societal norms, restrictions, and the shadow of conflict that constantly defines the limits of their freedom.

#### The Confining Norms and **Invisible Boundaries**

The majority of Kashmiri women live by traditional societal norms that limit them to being caregivers and housewives. With this, they hardly get any time to pursue interests or recreations of their choice. Most public spaces in Kashmir are male dominated, and women's participation in leisure is largely confined to their homes. A survey conducted by students of Lady Shri Ram College revealed that most women in Jammu and Kashmir engage in leisure activities like reading, writing, and painting, all within the safety of their homes. Only a small number of respondents participated in sports, and even then, these activities often came to an abrupt end due to reasons such as harassment or the necessity of being accompanied by a male family member. For instance, one of the respondents spoke of how she had to leave sports because of continuous groping in public transport while another explained that going out in Kashmir often required a series of lies, as she was frequently made to stay at home under the guise of safety concerns.

The conflict in the region has only exacerbated this situation, cre-

ating both physical and psychological barriers that restrict women's movement and make the idea of leisure fraught with anxiety. Patriarchal norms further limit their freedom, dictating which forms of leisure are acceptable, often tying them to domestic and societal activities. This leaves very little time for a woman to relax, be creative, or express herself authentically, further marginalizing her and thus denying her the liberative power of leisure.

#### Sufi Shrines: Sanctuaries of Solace and Sisterhood for Kashmiri Women

The visit to a Sufi shrine is one of the very few occasions when an elderly woman of Kashmir gets to leave her house and break the te dium of routine. She finds a rare escape in the peaceful courtyards of these shrines. These sacred spaces, deeply woven into the spiritual fabric of Kashmiri life, represenmuch more than just a place to pray. They are sanctuaries where women come together to breathe,

to connect, and to rejuvenate. Unlike mosques, which are predominantly male spaces, these shrines provide women with a socially acceptable public space where they can gather, socialize, and form emotional and devotional relationships with the saints. Here, they can personalize the relationship with the saints and whisper all their troubles to them, finding solace in the company of people who share similar burdens. Here, it is not very uncommon to find a group of women sitting together in the shade of a tree, sharing their stories, and drawing strength from

one another's stories.

These visits are not just about tradition or seeking blessings. They are about reclaiming a bit of themselves—a space to laugh, cry, and be without the weight of household duties pressing down on them. For many women, these shrines are places where they feel truly at peace—where the noise of everyday life fades, and they shift their focus to spiritual growth and healing. In a world that offers so few spaces for leisure, these shrines become a vital refuge, a place where they can finally exhale and let their souls rest.

#### Leisure Through a Feminist Lens: Reclaiming Identity and Crafting New Narratives

Leisure, often seen as a simple escape from daily responsibilities, holds a deeper, more transformative potential when viewed through a feminist lens. It's not just about taking a break; it is about reclaiming both time and space for self-discovery and self-expression. For most women, leisure is a powerful act of resistance against societal norms that expect them to behave in a cer-

tain way or hold specific roles. One inspiring perspective comes from Surabhi Yadav, the founder of the NGO Sanjhe Sapne. Through her work, Surabhi explores how leisure can be a radical tool for women to redefine themselves beyond the traditional roles of mother, wife, or daughter. Her photo project, Basanti: Women at Leisure, was inspired by observing the often-hidden playful side of her mother and women around her. The project captures women and girls in moments of unguard-

ed joy, dancing and relaxing; it captures them being themselves. These images do not depict rest; they celebrate leisure as a personal right and subtle, powerful form of resistance.

Surabhi argues that while much of today's feminist movement focuses on resisting patriarchy—fighting for equal pay, rights, and recognition—this approach often feels reactive, simply responding to the rules set by men. To her, real power in feminism lies in opening up so many new possibilities to women and creating spaces where women have the choice to explore and define their identities. Within these very words, leisure ceases to become a mere break from life's routine but assumes the role of a path toward self-discovery and empowerment. Leisure time would afford a space within which women could discover themselves beyond defined roles assigned to them, hence changing this resting time into a powerful tool of creating and reclaiming their own narratives.

If one were to introspect into the life of a Kashmiri woman, it would become evident that these moments of leisure are more than just brief escapes from daily responsibilities— they are subtle acts of defiance, quiet rebellions against a world that tries to confine them to narrow roles.

Whether they find peace in the sacred spaces of a Sufi shrine or take a rare moment of rest within their homes, these women are taking back their narratives from just being victims to discovering their own identities, engaging in activities they truly enjoy, and reclaiming their right to prioritize their own well-being.

But as we applaud these acts of quiet defiance before the mountains, we must also remind ourselves: What are we, as a society, doing to make their burdens a little lighter? How do we ensure that the leisure of Kashmiri women is priority and not an afterthought? For too long, our feminist goals have centered on survival—fighting for land, labor, and basic rights. But perhaps true liberation for Kashmiri women means striving for more than just safety and survival. It means reimagining leisure as a fundamental right, a space for selfdiscovery and liberation.

# A Duty & Debt for Every Indian

🔻 very year on August 15, Indians celebrate Independence Day, which is more than just a national holiday. It was a significant day that ushered in a new era of freedom and sovereignty for India, ending British colonial rule. This day is a potent symbol of the sacrifices made by the many freedom warriors who gave their lives to defend the country's freedom. Every Indian observes Independence Day as a serious obligation and a way to show appreciation to their ancestors who bravely battled for the freedom, we take for granted today. This article explores the historical background of India's struggle for independence as well as the ongoing significance of marking Independence Day as a national obligation.

#### **Context of History**

oday, hate is almost pervasive, permeating different forms of media, creating a sense of division and coldness. People express hate for various reasons, often hiding behind their screens to lash out at those who disagree with them. It's challenging not to absorb their anger and rage. However, understanding is a potent tool that can bring warmth and clarity to the chaos. While we can't eradicate hate, with understanding and empathy, we can diminish its intensity, take it less personally, and empower ourselves to make a difference in the impact that hate has.

Research and psychology tell us that hate often stems from mistrust, feelings of powerlessness, or vulnerability. History shows us that hate is frequently tied to issues of power and control. It's a pattern where one group believes it should dominate another, leading to oppression and violence.

Neurosciencealso reveals that the brain regions activated by fear and threat overlap significantly with those activated by feelings of hatred, suggesting that these emotions are closely linked. #### **India's Exports Dip** 1.2% In July To Enter **Negative Zone**

ew Delhi- After remaining in the positive zone for three months, India's exports contracted 1.2 per cent to USD 33.98 billion in July, while the trade deficit widened to USD 23.5 billion.

According to government data, imports rose by about 7.45 per cent to USD 57.48 billion in July due to a jump in the inbound shipments of crude oil, silver and electronic goods.

Crude oil imports rose 17.44 per cent to USD 13.87 billion, while silver imports iumped 439 per cent to USD 165.74 million during the month under review.

The trade deficit, or the gap between imports and exports, was USD 21 billion in June and USD 19.3 billion in July 2023.

Briefing media on data, Commerce Secretary Sunil Barthwal said that going by the current trend, the country's total exports of goods and services will cross last year's figure of USD 778 billion.

He said that one of the reasons for the dip in merchandise exports is the fall in the shipments of petroleum products, which has declined by 22.15 per cent to USD 5.22 billion.

Fall in prices, low demand and increasing domestic consumption have led to a dip in the exports of petroleum products in July.

The other export sectors, which have recorded negative growth during the month. include rice, cashew, oil seeds, marine products, gems and jewellery, chemicals, and cotton yarn/fabrics.

# **Wholesale Inflation Falls To** 3-Month Low Of 2.04% In July **As Food Prices Ease**

ew Delhi- Wholesale inflation fell to a 3-month low of 2.04 per cent in July on decline in prices of food items especially vegetables, government data released on Wednesday showed.

The decline in wholesale price index (WPI) based inflation in July came after it rose for four months in a row till June, when it was 3.36 per cent. It was (-) 1.23 per cent in July last year.

In April wholesale inflation stood at 1.19 per cent.

As per the data, food inflation in July was 3.45 per cent, down from 10.87 per cent in June, mainly due to month-on-month decline in prices of vegetables, cereals, pulses and onion.

Vegetables recorded a deflation of 8.93 per cent in July, against a 38.76 per cent inflation in the previous month.

"Positive rate of inflation in July, 2024 is primarily due to increase in prices of food articles, manufacture of food products, mineral oils, crude petroleum & natural gas, other manufacturing etc," the Commerce and Industry Ministry said in a statement.

The annual rate of inflation of the manufactured Products group increased to 1.58 per cent in July 2024, from 1.43 per cent in June 2024.

Inflation in fuel and power basket rose to 1.72 per cent in July, from 1.03 per cent in the previous month.

ICRA Senior Economist Rahul Agrawal said the core (non-food manufacturing) WPI continued to inch up for the fifth consecutive month, touching a 17-month high of 1.2 per cent in July 2024, even as



the index contracted on a sequential basis for the second consecutive month.

"The near-term outlook for WPI inflation remains benign. As per the data released by the Department of Consumer Affairs, the prices of a majority of food items have dipped on a sequential basis in August 2024 so far, amid a pickup in the monsoon and a healthy progression in kharif sowing.

This is likely to aid in containing the base effect-led uptick in the primary food articles inflation print in the ongoing month. Overall, ICRA expects the WPI inflation to remain unchanged at 2 per cent in August 2024," Agrawal said.

The decline in July WPI was in line with the retail inflation data for the month. Retail inflation fell to a near 5-year low of 3.54 per cent in July, data released earlier this week showed.

Sanjeev Agrawal, President, PHD Chamber of Commerce and Industry said: "Going ahead, we expect the continuous softening

of WPI inflation to reduce the costs of production levels and boost consumption demand in the country.

The Reserve Bank of India (RBI), which mainly takes into account retail inflation while framing the monetary policy, kept the benchmark interest rate or repo rate unchanged for the ninth consecutive time in its August monetary policy review at 6.5 per cent.

The decline in July food inflation would provide a breather to the RBI which had earlier this month said that the interest rate setting monetary policy committee (MPC) cannot ignore persistent high food inflation.

"The MPC (monetary policy committee) may look through high food inflation if it is transitory; but in an environment of persisting high food inflation, as we are experiencing now, the MPC cannot afford to do so," RBI Shaktikanta Das said in his policy review statement.

# **August Heatwave Sets New Records In Kashmir**

**SRINAGAR:** Kashmir is sweltering under an unprecedented heatwave, with temperatures soaring to record-breaking levels this August. According to independent weatherman Faizan Arif, Qazigund, in particular, has experienced its secondhighest August temperature since 1962, reaching a scorching 34.2°C. The all-time high for the region stands at 35.0°C, recorded on August 1, 1990.

Kokernag, too, has shattered its previous temperature record for August, with a blistering 32.7°C recorded on this day. This surpasses the earlier high of 32.5°C set on August 23, 2023. It's worth noting that the Kokernag observatory has been operational since 1978.

Srinagar, the summer capital of Jammu and Kashmir has recorded 5.9 degree above normal temperature where the mercury settled at 35.3 degree Celsius. The weatherman said that for Srinagar, this is the third time in the past 25 years that the city has crossed the 35°C mark in August, with previous instances occurring in 2020 and 2018.

# **Import Influx Of Second Hand** Vehicles To J&K Likely To Reduce

Agencies

SRINAGAR: In a bid to curb the environmental impact due to the older vehicles brought from other states, the Regional Transport Officer (RTO) Kashmir has formally requested the Transport Commissioner Jammu and Kashmir, proposing the introduction of an environmental cess on second hand vehicles older than 10 years at the time of allocation of J&K registration marks.

The letter addressed to J&K's Transport Commissioner as per the RTO Kashmir, comes in light of the rising environmental and infrastructural challenges posed by the influx of second-hand vehicles from neighbouring states.

In a letter, a copy of which with the news agency-Kashmir News Observer (KNO) highlights the alarming increase in older, environmentally detrimental vehicles entering the region, particularly in the cities of Srinagar and Jammu, where traffic congestion and parking

shortages have reached critical levels.

"These older vehicles also contribute disproportionately to environmental pollution. In view of this, it is proposed that the UT may introduce an environmental cess on second hand vehicles older than 10 years at the time of allocation of I&K registration mark," reads the

The RTO as per the letter has pointed out that these secondhand vehicles, often nearing the end of their operational life as defined by their states of origin, are being sold at significantly reduced prices, making Iammu & Kashmir a dumping ground for vehicles that no longer meet the operational standards of other states.

"As you are aware the second-hand vehicles are being imported into Jammu & Kashmir from the neighbouring states. These vehicles, often nearing the end of their operational life as defined by their states of origin, are sold at cheap prices," reads the letter.

Four blood-soaked rucksacks were seized from the site of the encounter, leading officials to initially believe that a total of four terrorists were killed. M-4 carbines were also found, the officials said. However, the death of only one terrorist has been confirmed.

Additional Director General of Police (ADGP) Anand Jain reached the Assar area along with top officers to supervise the operation.

Ahead of his visit to Doda, the ADGP told reporters in Jammu around 2 pm that the operation was still underway. "The operation is going on. Efforts are on," he said.

The Army expressed its deepest condolence on the officer's death and said the force stands with the bereaved family.

All ranks of the White Knight Corps salute the supreme sacrifice of braveheart Captain Deepak Singh, it said.

The terrorists crossed into Doda from a forest area near Patnitop in adiacent Udhampur district after a brief exchange of fire between security forces and the ultras there on Tuesday evening, officials said.

They said the security forces established contact with the terrorists in Udhamnur around 6 nm on Tuesday An encounter broke out about half an hour later and continued intermittently until both sides paused. A cordon was established overnight.

The search was resumed at dawn. At about 7:30 am on Wednesday, there was a renewed exchange of fire in Doda where the terrorists had fled

to, the officials said. Two encounters between security forces and terrorists were reported on Sunday in the remote forest areas of Nownatta in Kishtwar district and

recent months. The security forces across the Union Territory have been placed on high alert ahead of Independence Day. An Army captain was killed and four terrorists were gunned down in an ongoing operation in the higher reaches of Jammu's Doda district today.

The situation in Jammu has become increasingly volatile, with a noticeable uptick in terror attacks. On August 10, two soldiers and a civilian were killed during a gunfight between terrorists and security forces in Anantnag. The region has witnessed attacks on an army convoy in Kathua, skirmishes in Doda and Udhampur, and a failed attack by the Pakistan Border Action Team (BAT) along the Line of Control (LoC) in Kupwara district's Machchal

sector. According to the Ministry of Home Affairs (MHA), 28 people, including civilians and security personnel, were killed in 11 terror-related incidents and 24 counter-terror operations up to July 21 this year.

In the past two months, the frequency of attacks and ambushes has increased, particularly in the southern reaches of Pir Panjal, an area that had been relatively quiet in terms of terrorist activity for some time. Notable among recent incidents was an operation in which two Army officers were killed, and two Pakistani

terrorists, including a Lashkar-e-Taiba sniper and explosives expert, were eliminated. Overall, casualties among security forces have doubled this year compared to the previous three years, with 17 security personnel and an equal number of civilians losing their lives.

A senior official told NDTV that the increased military casualties are a significant concern, which has led to the rationalisation of force deployment in the area with new combinations and strategies. The government, while maintaining a focus on securing the Kashmir Valley, has also recognised the need to bolster security in the Jammu region. This has resulted in the mobilisation of additional forces for deployment in

One of the primary objectives of the government's new security strategy is to plug infiltration routes used by terrorists to enter Jammu and Kashmir. Security audits conducted by various agencies have identified around two dozen sectors along the Line of Control (LoC) in the Valley and the International Border in the Iammu sector where infiltration has been recorded. Terrorists, often with the assistance of local guides, use these routes to cross into Indian territory.

In addition to infiltration by foot, there is also evidence of weapons being smuggled across the border or dropped via drones. To counter this, the government has initiated a project to fence the borders. However, progress has been slow, with only 70 out of 180 kilometres of the border in Jammu having been fenced so far, and floodlighting completed for only 40

Two battalions of the Border Security Force (BSF), comprising 2,000 personnel, have been airlifted from Odisha and deployed in the Samba sector to plug gaps along the Jammu-Punjab border.

Recent intelligence reports suggest that terrorists may target highways, which are vital for troop movements and logistics. To secure these "lifelines," the government has decided to deploy CRPF personnel along with local police to patrol highways and adjacent areas. Drones are also being used to monitor and map these areas for any suspicious activity.

Two heavily armed terrorists had attacked a Central Industrial Security Force (CISF) personnel manned picket just before 4 am on April 22, 2022, near Chaddha camp in the Sunjawan

The 'fidayeen' attackers sprayed a volley of bullets from their assault weapons and lobbed grenades at the picket when a shift change was taking place and CISF personnel onboard a bus had just reached the spot to relieve their colleagues standing guard overnight.

As the bus reached the 'Sunjawan naka', the CISF said, terrorists again started firing at the bus and also used UBGL (under barrel grenade launcher).

Immediately, Patra and Rajesh Kumar got off the bus and positioned themselves for retaliation while the other personnel, under the supervision of Patel, took position in the bus and opened fire on the terrorists, the force said.

Fifty-eight-year-old Patel, hailing from the Satna district of Madhya Pradesh, made the "supreme sacrifice" in the service of the nation, the CISF said.

Due to the valiant response by the CISF personnel, a major terrorist attack was not only averted but the terrorists were contained and eliminated, the force said in a statement.

Personnel of other security forces later killed the two terrorists.

The attack had taken place two days ahead of Modi's visit to Samba in the Jammu region of the Union Territory, his first post the Abrogation of Article 370 in August 2019.

petitioner under Section 3 of the PMLA if ultimately the Court of Chief Judicial Magistrate, Srinagar frames charges for offence/offences, which are specifically mentioned in the schedule of PMLA," the court said.

In July 2017, the CBI filed chargesheet before the CJM Srinagar in the case for charges of criminal conspiracy and criminal breach of trust under the RPC against Farooq Abdullah, the then president of JKCA, Muhammad Saleem Khan, the then general secretary, Ahsan Ahmad Mirza, the then treasurer and Bashir Ahmad Misgar, an executive in the J&K Bank. The ED had later named the same persons in the money-laundering case.

In their plea, Mirza and Gazanffer submitted before the High Court that ED had no jurisdiction over the case and the charge sheets filed against them should be quashed.

The court, after hearing arguments, had reserved the judgement on August 7. The ED was represented by Additional Solicitor General S V Raju through virtual mode.

"Upon completion of investigation, the CBI has filed a charge-sheet against six accused persons including the petitioner for commission of offences under Sections 120-B, 406 and 409 RPC, which is pending consideration before Chief Judicial Magistrate, Srinagar," the court said, adding, "It is not in dispute that Sections 406 and 409 RPC/IPC are not the scheduled offences"

As is the legal position amply clarified by the Supreme Court in Pavana Dibbur's case, the court said, offence or IPC shall not be a scheduled offence unless conspiracy alleged is of committing an offence specifically included in the schedule.

"Viewed thus, the charge-sheet, which is pending trial before the Chief Judicial Magistrate, Srinagar is not in respect of any offence, which is specifically included in the schedule of PMLA".

Going by the charge sheet filed by the CBI, the court said, it is evident that offence of money laundering, as defined under Section 3 of PMLA, is not made out.

"For commission of offence of money laundering under Section 3 of PMLA, it is required to be demonstrated that the accused has directly or indirectly, knowingly or unknowingly involved in any process or activity connected with the proceeds of crime," the court said, adding, "Such activity could be concealment possession, acquisition or use of the proceeds of crime and projecting it as untainted

property." Referring to the instant case, the court said, indisputably, the jurisdictional police, the CBI has not registered any case for commission of any scheduled offence.

"Enquiry by way of complaint before the CJM, Srinagar is also not in respect of any scheduled offence. In the absence of there being any case registered for commission of scheduled offence or any case pending enquiry or trial in respect of scheduled offence, authorities under PMLA have no jurisdiction to register ECIR and launch prosecution for offence of money laundering under Sections 3/4 of PMLA," the court said, adding, "When there is no scheduled offence having been registered or pending enquiry or trial, there are no proceeds of crime and, thus, there is no offence of money laundering under Section 3 of the Act."

The federal probe agency had attached assets belonging to Abdullah and others worth Rs 21.55 crore under three separate orders issued by it in the past.

The agency's case is based on a 2018 charge sheet filed by the CBI against the same accused.

The CBI charge sheet filed alleged "misappropriation" of JKCA funds to the tune of Rs 43.69 crores from grants given by the Board of Control for Cricket in India (BCCI) to promote the sport in the erstwhile state between 2002 and 2011.

The ED had earlier said its probe found that JKCA received Rs 94.06 crore from BCCI in three different bank accounts during financial years 2005-2006 to 2011-2012 (up to December

It had alleged that several other bank accounts were opened in the name of the JKCA into which the funds were transferred. The bank accounts along with the existing bank accounts were later used for laundering JKCA

Last December, the Supreme Court directed the poll panel to hold assembly elections in Jammu and Kashmir by September 30.

The home secretary, the sources said, was "on board" with EC's security assessment of Jammu and Kashmir relating to adequate security for contesting candidates as well as ensuring peaceful conduct of the democratic

He agreed to whatever the EC had sought for ensuring peaceful polls there, they said.

The Union Home Ministry is ready to provide sufficient number of security personnel proposed by EC to ensure the safety of candidates and for holding peaceful polls in the Union Territory, the sources said.

The poll panel on Wednesday afternoon held a detailed review meeting with Bhalla on the security scenario in Jammu and Kashmir.

The sources described the meeting "good" and said the home secretary was on board with the EC's security assessment for holding assembly polls in

The EC flagged the issue of the security of candidates and polling stations while seeking forces for peaceful polls.

The last assembly polls in Jammu and Kashmir in 2014, when Ladakh was its part, were held in five phases. This time too the number of phases could be the same.

The electoral exercise in Jammu and Kashmir is usually spread over a It was not yet clear whether polls

in Jammu and Kashmir will be held along with other states where assembly elections are due or separately.

Last time, Haryana and Maharashtra polls were held together and Jharkhand elections were announced later.

So far the EC has visited J&K and Haryana to assess poll preparedness. It is yet to visit Maharashtra.

The terms of the legislative assemblies of Haryana and Maharashtra end on November 3 and November 26 respectively.

The term of the Jharkhand assembly ends on January 5 next year.

After a record turnout in the Lok Sabha elections in Jammu and Kashmir, CEC Rajiv Kumar had said, "This active participation is a huge positive for assembly elections to be held soon so that the democratic process continues to thrive in the Union Territory.'

Whenever assembly elections are held in Jammu and Kashmir, they will be the first since provisions of Article 370 of the Constitution were abrogated and the erstwhile state was divided into two Union Territories in 2019.

Following a delimitation exercise, the number of assembly seats has gone up from 83 to 90, excluding those allocated to Pakistan-occupied Kashmir.

In a fresh indication that assembly polls in Jammu and Kashmir are imminent, the EC had last month asked the Union Territory administration to transfer out officers posted in their home districts, an exercise it holds ahead of conducting elections.

The Commission has been following a consistent policy that officers directly connected with the conduct of elections in a poll-bound state or Union Territory are not posted in their home districts or places where they have served for a considerably long period.

It is usual for the poll panel to issue instructions related to transfers of officers ahead of Lok Sabha and assembly elections.

Recently, it had ordered the updation of electoral rolls in Jammu and Kashmir and three other states.

In June, it decided to accept applications seeking allotment of 'common symbols' from registered unrecognised parties in the Union Territory.

#### Poll Schedule

Sources disclosed that the commission is now likely to announce the poll schedule on August 20 or 21.

'The elections will commence from the last week of September or the first week of October," they said, adding that the entire election process would be completed by the first week of November

Notably, MHA has expressed its readiness to deploy adequate central paramilitary forces for the polls. "The Commission has been assured that security would be provided as per its assessment," they said, adding that security arrangements in Jammu region, which has witnessed a spurt in militancy in the recent months, also came up for discussion.

Sources disclosed that 600 companies of paramilitary forces are likely to be utilised for election in the Union

The meeting was attended by Union Home Secretary Ajay Bhalla, chief election commissioner and election commissioners Gyanesh Kumar and S Sandhu.

The poll-body held a meeting with the Union Home Secretary after it visited Jammu & Kashmir to assess preparedness for the polls.

After its meeting with political parties and J&K administration, the Election Commission said that it is committed to hold elections at the earliest in J&K and no internal or external forces will be allowed to derail the democratic process.

"We are committed to conducting elections at the earliest. We are sure that people of J&K will give a befitting response to disruptive forces. No internal or external intervention will be allowed to derail the democratic process. We are all prepared for it," said chief election commissioner Rajiv Kumar, who was accompanied by election commissioners Gyanesh Kumar and S.S. Sandhu.(KNO)
