

# LG Admin Approves Key Policies For J&K

### **Confers Land Rights to** Displaced Persons Of PoJK, WP

### **Observer News Service**

Srinagar: Jammu and Kashmir government on Friday conferred proprietary rights over evacuees' land to the displaced persons of PoJK of 1947, 1965, 1971 and West Pakistan displaced persons.

The decision was taken by the Administrative Council which met here under the chairmanship of Jammu and Kashmir Lieutenant Governor Manoj Sinha.

In a landmark decision, the Council approved the proposal for transfer of Evacuees' land conferring proprietary rights to the displaced persons (DPs) of 1947, 1965, 1971 and West

Pakistan Displaced Persons, an official spokesperson said.

He said this decision will confer absolute proprietary rights over Evacuees' land to DPs as already conferred over state land.

As per the decision, the custodian concerned will transfer the land in favour of the DPs in a time-bound manner. Custodian General shall ensure proper safeguards to prevent any misuse particularly unauthorized encroachments on the Evacuees'

land, the spokesperson said. The government has issued directions for time-bound processing of applications giving proprietary rights More on P10

Srinagar: Jammu and Kashmir government on Friday approved cadre review of the JKAS with a view to strengthen the administrative set-up in the union ter-ritory, an official spokesperson said here.

The decision was taken by the Administrative Council which met under the chairmanship of Lieutenant Governor Manoj Sinha.

The review will revise the strength and composition of the Jammu and Kashmir Administrative Service (JKAS) in view of increased complexities and scale of operations as well as changes in work profiles due to new schemes and initiatives after specific recommendations from the Administrative Departments, the spokesperson said.

The revised strength will accommodate 87 new posts, with deletion of 50 posts coupled with creation of 46 posts, he said. The decision will also upgrade 29 posts to ensure adequate administrative experience and

efficiency in disposal of government business, he said. The review will also enable career progression as well as employment avenues for the youth by releasing vacancies

"I was happy to hear I was getting married... I thought my life would become easier," Shamila told AFP after her wedding to a man twice her age in hope of a more prosperous life.

"But I have nothing more. And with the rain, I fear I will have even less, if that is possible."

# **Un Rights Chief Deplores 'Grim Milestone' Of 40,000 Gaza Dead**

GENEVA: The UN human rights chief on Thursday deplored the "grim milestone" of 40,000 Palestinians reported killed in Israel's 10-month assault on Gaza, accusing the country's military of breaking the "rules of war". United Nations High Commissioner for Human Rights Volker Turk blamed Israel for the soaring death toll in the territory.

The health ministry in Gaza said on Thursday that the death toll from the conflict had reached at least 40,005 people, with another 92,401 wounded.

The bloodiest-ever Gaza conflict which broke out more than 10 months ago has taken an appalling human toll. At least 40,005 people have been killed in the besieged

Palestinian territory.

In addition to the deaths in Gaza, attacks by Israeli soldiers and settlers in the occupied West Bank have killed at least another 632 Palestinians, according to the data provided by the Ramallahbased health ministry.

Israeli fire since October has killed 570 people in Lebanon. Hezbollah announced that more than 370 of its fighters have been killed. Fighters from other groups in Lebanon including Hamas and the Hezbollah-allied Amal movement are also included in the total.

The cross-border fire has displaced tens of thousands of people in southern Lebanon and northern Israel. At least 25 Hezbollah fighters have been killed in Israeli strikes in Syria, with seven Iranian Revolutionary Guards killed in a strike on Damascus in April.

Islamabad: Pakistan has confirmed its first monkeypox case of the year after a man who recently returned from Saudi Arabia tested positive for the virus, ARY News reported citing the Ministry of Health.

The 34-year-old male resident of Mardan arrived in Pakistan on August 3 and developed symptoms shortly after arriving in Peshawar and reached out to the hospital for testing.

The diagnosis was confirmed by Khyber Medical University in Peshawar, as per ARY News.

His positive diagnosis was confirmed on August 13, marking the first reported case of monkeypox in Pakistan for 2024.

Health officials have begun contact tracing efforts to identify and monitor in-

dividuals who were in close contact with the patient, including fellow passengers on his flight from Saudi Arabia.

Earlier in 2023, three passengers were diagnosed with monkeypox at Karachi's Jinnah International Airport.

The Director General Health told the media that all three passengers were Pakistani citizens aged between 30 and 45. The passengers have been admitted to the infectious disease hospital.

Monkeypox remains a significant global health issue, with the World Health Organization (WHO) reporting 99,518 cases and 208 deaths across 122 countries. According to ARY News,

the virus, which spreads through close contact, presents with symptoms such as fever, rash, and body aches, typically lasting 2 to 4 weeks. Despite the spread, the WHO notes that 99 per cent of those infected survive.

Washington: Republican US presidential candidate Donald Trump said on Thursday he told Israeli Prime Minister Benjamin Netanvahu during their last meeting in July to quickly end Israel's war in Gaza, but the former president also criticized ceasefire demands. "He knows what he's doing, I

did encourage him to get this over with," Trump told reporters at a press conference on Thursday. "It has to get over with fast. ... Get your victory and get it over with. It has to stop, the killing has to stop."

Trump was referring to his meeting with Netanyahu at his Mar-a-Lago residence in late July, when Netanyahu visited the United States. He also met President Joe Biden and Vice President and Democratic presidential candidate Kamala Harris during his trip.

NEW DELHI: The ease of voting for Kashmiri migrants introduced during the recent Lok Sabha polls will be in place for the Jammu and Kashmir Assembly polls as well, Chief Election Commissioner (CEC) Rajiv Kumar said on Friday.

He also lauded the democratic spirit of the people of Jammu and Kashmir.

Talking about the special arrangements made for the Kashmiri migrants during the Lok Sabha polls, Kumar said those relaxations will continue.

'You may also remember that for Kashmiri migrants, special arrangements were made. We simplified the process, we relaxed Form M and there were some cumbersome processes that required authorization. which were converted to selfattestation," the CEC said at a press conference to announce the Jammu and Kashmir Assembly election.

"We got positive results and the migrants also participated," he added.

Kumar highlighted that the Union Territory witnessed more than 58 per cent voting during the Lok Sabha polls and this record participation of voters was a testament to Jammu and Kashmir's democratic spirit.

The long queues at the polling booths of Jammu and Kashmir were an excellent example of the power of democracy. It was their desire to write a new destiny," he said.

"Everybody wanted to participate, prove a point that we are here in this queue not only to vote but to demonstrate the very strong desire that democracy flourishes in this area," the CEC added.

"The people of Jammu and Kashmir chose the ballot instead of bullets and boycotts," he said.

Kumar pointed out that there was no incident of re-polling and an amount of nearly Rs 100 crore was seized.

Ahead of the Lok Sabha election, the Election Commission (EC) had announced that Kashmiri migrants from Jammu and Udhampur districts of Jammu and Kashmir would no longer be required to fill up "Form M" to vote as the poll panel had ordered changes to the existing voting scheme for the dis-

placed people. Instead, they shall be mapped with special polling stations falling in the zones where they are registered or residing, the commission had said

# WP Refugees To Vote In J&K **Assembly Polls For First Time**

**IAMMU:** With the Election Commission announcing the schedule for the first-ever assembly elections in Jammu and Kashmir after it was reorganized into a Union Territory, West Pakistani refugees -- who will vote for the first time in these elec-

tions -- are gearing up to participate in this democratic process. A meeting of community members is scheduled for next week to strategize for the polls,

marking a historic moment for the refugees who have long awaited the right to vote. The elections will take place in three phases on September

18, September 25 and October 1, with the votes being counted on October 4 Assembly elections are being held in Jammu and Kashmir for

the first time since the abrogation of Article 370, which granted special status to the region, in August 2019.

This is also the first time that West Pakistani refugees, alongside members of the Valmiki Samaj, will have the opportunity to vote in assembly elections in Jammu and Kashmir.

Laba Ram Gandhi, president of the Pakistan Refugees' Action Committee, expressed his en-



thusiasm for the elections.

"This is the first time we will be participating in the assembly elections after more than seven decades of our settlement here," he said

Gandhi emphasized the importance of internal discussions among community members to ensure effective representation in the new assembly

The meeting, expected to take place either on August 20 or August 22, will gather around 200 delegates from across the Jammu region.

The topics of discussion will include potential candidates for support and the possibility of fielding their own candidates. Historically, the community

- primarily consisting of Hindus and Sikhs who migrated from Pakistan in 1947 -- had only been eligible to vote in Lok Sabha elections until the recent changes in their status.

In 2020, they participated in the District Development Council elections for the first time.

# Pradhan Mantri Jan Arogya Yojana (PMJAY) Key Issues to Address in Jammu and Kashmir

he Pradhan Mantri Jan Arogya Yojana (PMJAY), also known as Ayushman Bharat Yojana, stands as one of the most ambitious health insurance initiatives launched by the Government of India. Aimed at providing financial protection to vulnerable and economically weaker sections of society during medical emergencies, the scheme promises to cover over 500 million people with a health insurance coverage of up to 5 lakh per family per year for secondary and tertiary care hospitalization.

While the scheme is envisioned to be a gamechanger in the Indian healthcare landscape, its implementation in the Union Territory (UT) of Jammu and Kashmir reveals several shortcomings. These challenges, if left unaddressed, threaten to undermine the scheme's potential to serve those who need it the most.

### The Aim of the Scheme

The primary objective of PMJAY is to ensure that the economically vulnerable sections of society do not suffer due to the financial burden of healthcare costs. By providing cashless and paperless access to services, the scheme aims to reduce out-of-pocket expenditures for the poor, thereby preventing the economic downfall of families due to medical emergencies. The scheme covers a wide range of services including over 1,500 medical procedures, which are provided through a network of public and private hospitals that have been empanelled under the scheme.

### Shortcomings in Jammu & Kashmir

Despite the comprehensive nature of PMJAY, its implementation in Jammu and Kashmir has faced significant hurdles. A major issue is the reluctance of private hospitals to fully participate in the scheme. Many leading private hospitals in Srinagar, such as Shifa Hospital, Florence Hospital, and Khyber Institute, have not been covering a wide range of surgeries under PMJAY. This reluctance has led to a situation where many poor patients, who hold the Golden Card (a card issued under PMJAY to eligible beneficiaries), are often denied treatment at these private hospitals.

The refusal of these hospitals to provide a full range of services under the scheme severely compromises its effectiveness. Patients who are turned away face significant difficulties in accessing necessary medical care, which directly contradicts the very purpose of the scheme.

### Government Delayed Funding: A Core Issue

The reluctance of private hospitals to fully participate in PMJAY in Jammu and Kashmir can be traced back to delayed payments from the government. According to reports, empanelled private hospitals and dialysis centers in Jammu

and Kashmir do not receive payments on time. This delay has created a financial strain on these hospitals, many of which are already operating on tight budgets.

On 13 august, the Srinagar branch of the Jammu and Kashmir Empanelled Private Dialysis Centres and Hospital Association met with the Deputy Commissioner of Srinagar to request emergency funds, as payments have been pending since March 15. The centres, under the Ayushman Bharat Scheme (AB-PMJAY), have not been paid for services since March 14, 2024, due to a dispute between the State Health Agency and the insurance company. Despite assurances in April that the issue would be resolved by early May, no action has been taken, according to an association spokesperson.

In a letter to the Chief Secretary of Jammu and Kashmir written in the month of June this year the association of empanelled private hospitals expressed their inability to continue providing services under the scheme beyond May 2024 unless payments were released. The letter highlighted that these hospitals had exhausted their funds and could not continue offering services under PMJAY without receiving the due payments. Despite this, these hospitals have continued to provide services, but they have reached a point where sustaining these services without government payments is no longer feasible. aged private hospitals from fully participating in the scheme but have also led to a decline in the quality of services offered under PMJAY. Hospitals that are struggling to manage their finances are less likely to invest in necessary medical infrastructure or hire additional staff, both of which are crucial for providing quality healthcare services.

### Flaws in Empanelment and Coverage

Another significant challenge with the implementation of PMJAY in Jammu and Kashmir is the limited range of surgeries and medical procedures covered under the scheme. While about 133 private hospitals have been empanelled under the scheme, the fact that many crucial surgeries are not covered has reduced the scheme's overall impact. Patients requiring specialized surgeries often find themselves in a situation where their Golden Card is not honored, leaving them with no choice but to either forgo the necessary treatment or bear the expenses out of pocket.

This limitation in coverage not only defeats the purpose of providing financial protection to vulnerable sections but also erodes trust in the scheme. If beneficiaries perceive that the scheme does not cover the treatments they need, they are less likely to rely on it, and the intended benefits of PMJAY will remain unachieved.

### The Way Forward

To ensure the successful implementation of PMJAY in Jammu and Kashmir, several steps need to be taken to address the current shortcomings. The government must prioritize the timely disbursement of funds to empanelled private hospitals. Ensuring that payments are made on time will encourage these hospitals to continue providing services under the scheme and will prevent the financial strain that currently hinders their full participation. Moreover, the government should revisit the list of surgeries and medical procedures covered under PMJAY in Jammu and Kashmir. By expanding the range of treatments covered, the scheme can offer more comprehensive healthcare services to beneficiaries and prevent situations where patients are turned away due to lack of coverage.

The government should work closely with private hospitals to address their concerns and build a stronger partnership. This could involve setting up a more streamlined payment process, offering incentives for hospitals that provide a wider range of services under PMJAY, and ensuring that the administrative burden on these hospitals is minimized. There should be a robust system in place to monitor the implementation of PMJAY in Jammu and Kashmir. Regular audits and reviews can help identify gaps in service delivery and ensure that empanelled hospitals are fulfilling their obligations under the scheme. Additionally, establishing accountability mechanisms for delayed payments can prevent future disruptions in the scheme's implementation.

Efforts should be made to educate the beneficiaries of PMJAY about the scope and limitations of the scheme. Clear communication regarding what is covered under the scheme and the process for accessing services can empower patients and reduce the instances of denied treatment.

#### Tailpiece

The Pradhan Mantri Jan Arogya Yojana has the potential to revolutionize healthcare access for the economically weaker sections of society in India. **E** verything is broken. We know it, but refuse to see it. Maybe now we will. But the rape and murder of a doctor on duty in a government hospital should not have been the event to open our eyes to this.

The facts are stark. This 31-year-old doctor, on the job for 36 hours, was looking for a place to recoup. She found one at her place of work. A seminar hall. There, she was raped and murdered. At night.

Initially, the authorities, including the hospital, sought to pass it off as suicide. The police — true to character as many in Calcutta would agree — thought it fit to launch a murder investigation only after the parents complained. One person was arrested, but forensic tests on the nature of injuries suffered by the woman indicate more than one person is most likely involved. The police probe made little headway, prompting the Calcutta High Court to order an investigation by a central agency. The CBI is now on the job.

Statements issued by the authorities, namely the chief minister and the police, have been tediously predictive. Mamata Banerjee, who oversees both police (home) and health, may have boldly declared the state would seek "the death penalty" for the accused, but subsequent actions of her administration haven't yet inspired confidence about its sincerity in getting to the truth. The principal of the medical college, under whose watch the horrific crime took place, was re-assigned to another college, not put in the dock or slapped a showcause as one would expect. Had it not been for the high court, he would not have been benched. It has come to light that he's some sort of a favourite, having had two prior transfer orders revoked mysteriously.

# RG Kar Rape It Took a Doctor to Die to Tell Us What We Already Know Shantanu Datta

The man who has been arrested, via electronic footprints, is said to be a civic volunteer, a member of this over one lakh-strong band of do-gooders being put together since 2013 under the aegis of the state government. Initially, they were deployed as traffic wardens during festivals. Over the years, this army of youngsters has been co-opted by the police who use them liberally, to collect legitimate fines and illegitimate bribes. Today, civic volunteers are a law unto themselves, pitching in with their services for the ruling party wherever required, at times shedding their all-blue uniform to shore up the numbers at Trinamul rallies. More important, this is not the first time one of them has been linked to an unnatural death.

That explains why the arrested volunteer enjoyed unfettered access at RG Kar, his place of work as a custodian of the law, even if inebriated as he was that night.

It is because of such tell-tale circumstances that protesting students and the Opposition have expressed fears of a cover up. A "Reclaim the Night" clarion call voiced by university students, all girls, has drawn unprecedented support from people of the state. Thousands of women and men, young and old, hit the streets peacefully throughout Bengal to usher in Independence Day with the cry: We want justice. The protest venue at RG Kar Medical College and Hospital was vandalised by goons, reinforcing suspicions of insidious attempts at shielding the culprits.

Across the country doctors have spearheaded protests in solidarity to highlight one of their basic demands, ie, the declaration of hospitals as safe zones and the promulgation of a central law to tackle violence against doctors since the existing 25 state laws haven't yielded any convictions in spite of regular violence against medical practitioners.

Doctors and interns serving in state hospitals in Bengal do so in abominable working conditions. It has been like that for ages. Now a murder on campus has renewed the focus on such institutional lacunae. Not just in Bengal though, authorities have displayed a stubborn resistance to learn from the lessons of the past.

In November, 1973, Aruna Shan-

baug, a junior nurse at King Edward Memorial Hospital in Mumbai, was brutally assaulted by a ward boy, leaving her blind, deaf and paralysed. Shanbaug lived on for 42 years on lifesupport at the hospital, cared for by fellow nurses before she passed away in 2015, her death and debates that ensued thereof spurring an important legislation on euthanasia in the country.

At IIT-Kharagpur, a student's death in October 2022 was attributed to suicide. His parents moved court. Ultimately, his body was exhumed and another autopsy done to reveal he was murdered. Closer home at Jadavpur University, a fresher was thrown out of the balcony of his hostel and killed exactly a year ago. That terrible fallout of ragging blew the lid off a racket in allotment of hostel rooms. Then too, the authorities in Bengal rattled out pious platitudes about right and wrong, about what was and what would be done to ensure no parent would lose a son to vicious bullying.

Today, rumours are rife on why what happened at RG Kar happened. The "inside stories" are too sordid to repeat. But in the prevailing atmosphere of mistrust, these tend to get amplified. After the monstrosity heaped on the medical practitioner at RG Kar, nothing seems right now. The unfixed have remained unfixed. Consider the list of demands the National Medical Commission (NMC) has issued to all medical colleges. It has asked for a "policy to ensure a safe work environment" within college and hospital campuses, specifying, among a host of requirements, that "corridors and campus (es) should be well-lit in the evening for staff to walk safely from one place to other..."

Hang on, but weren't these supposed to be in place already? Evidently not. The state of West Bengal and those who run it had to be told: if it's a dark corridor, please fix some lights. It needed a postgraduate student to be raped and killed in a state-run hospital for the apex medical college regulator to come out with this mind-numbingly prosaic list of dos and don'ts.

Yesterday will remain a devastating memory, a shameful blot. And tomorrow is usually never what it's supposed to be. But it's up to us to change that. The time for "learning from the lessons of the past" is over. We have had 78 years to do so. It is now time to act. Rebuild, step by step, a broken public health system and with it reclaim a civic space that has been polluted and rendered rotten by a total lack of order in all its spheres, be it as basic as safety in the workplace.

Rashid's trip coincided with the apple harvest. On the way to Pahalgam, they stopped in Apple Valley, where they toured orchards and picked fresh apples and walnuts, savoring the region's agricultural charm.

Rashid, who has traveled to over 50 countries, found Kashmir's unique blend of nature and culture, along with its raw, unfiltered beauty, truly remarkable. He described his experience by quoting the

great poet Amir Khusrau: "Words cannot adequately convey the feeling of bliss I experienced from the moment I landed in Kashmir. The majesty of its nature, the richness of its culture, history, and cuisine were only rivaled by the kindness of the Kashmiri people. I am truly blessed to have lived the words: 'Agar firdous baroye zameen ast, hami asto, hami asto hami ast.'"

UAE nationals typically seek a cool getaway from the heat of Dubai and a change of scenery. Popular holiday destinations include Georgia, Turkey, the UK, France, and Switzerland. While Kashmir may not match these places in terms of development and infrastructure, it is notably distinguished by its stunning natural beauty of majestic mountains, rivers, lakes, and treks. Each season offers something unique: majestic ski slopes in winter, blossoms galore in spring with one of Asia's largest tulip gardens, a cool and pleasant golden autumn, and a lush, green landscape perfect for summer trekking.

While Kashmir attracts international tourists from Malaysia, East Asia, and parts of Europe, it has yet to fully cater to visitors from the Middle East and the UAE. Rashid pointed out that, despite the relatively short distance, the journey can be cumbersome due to the need for a layover in Delhi, often turning the trip into a day-long endeavor. He expressed a desire to bring his family over when direct flights become available.

Kashmir saw over 2 million tourists in 2023 (excluding Yatra pilgrims), and 2024 is set to break that record. The UAE's main holidays coincide with the Amarnath Yatra pilgrimage from late June to August, which can restrict movement to main attractions like Pahalgam. Tourists from the UAE could help expand the premium sector of Kashmir's tourism industry. While a few high-end hotels are available, more options that emphasize luxury, health standards, and cleanliness need to be explored. The introduction of glamping, a glamorous twist on traditional camping, has also started in Pahalgam, offering a sophisticated and comfortable retreat experience.

While Kashmir may not cater to highend travel, it stands out as a serene, mountainous destination with breathtaking snowy landscapes in winter. However, several improvements are needed. Enhancing cleanliness is crucial and involves multiple small actions, such as addressing littering and managing horse dung by attaching bags to horses. Improved infrastructure and maintenance, along with better access to tourist spots, are also necessary. Additionally, the inconvenience caused by VIP-related traffic and the need for more professional service standards should be addressed. Very respectfully, Rashid pointed out the issues of chaos, uncleanliness, and disorganization in Kashmir, although he also recognized its potential to become a global tourist hotspot.

When asked for his message to those planning a trip to Kashmir, Rashid said: "If you are looking for a glimpse of paradise on Earth, look no further. It is here."



"When was your last period?" For anyone who menstruates, this is a routine question during any visit to your doctor. Health care providers generally ask this to deermine whether their patient is concerned about a menstrual problem, or a possible pregnancy, or whether menopause is approaching or has occurred. But rarely is the question discussed in the context of exploring menstrual experience as a "vital sign of health" throughout life. In fact, many providers fail to recognize the fundamental role of the menstrual cycle in overall health. Menstrual experiences throughout the reproductive years and beyond can offer critical insights into a person's overall well-being, akin to blood pressure, body temperature and heart rate. We are a medical sociologist and public health researcher who focuses on women's health issues and a professor emerita of psychology who has studied menstrual experiences across the life span and worked to improve menstrual education and body literacy. Although it may seem as though the menstrual cycle's main role is to facilitate pregnancy, this is only part of its purpose. In fact, it is a cornerstone of overall health and well-being thoughout the reproductive years and into the menopausal transition.



### Understanding the menstrual cycle

The menstrual cycle, or period, is a term that describes the sequence of events that occurs in the body that prepares for the possibility of pregnancy each month. It is measured from the time of the first day of menstruation until the first day of your next menstruation.

Although cycles vary, the overall menstrual process is the same for everyone. The menstrual cycle typically lasts about 28 days, but menstrual cycles ranging from 24 to 38 days are usually considered healthy. Cycles that do not regularly fall within this range should be further investigated for any underlying causes.

### The menstrual cycle as a vital sign

Regular menstrual cycles can indicate balanced hormone levels and reproductive health. Regular cycles are associated with better bone density, cardiovascular health and mental well-being.

Irregularities in the menstrual cycle include changes in cycle length, intensity of flow or other negative period-related changes, such as cramping – also called dysmenorrhea – or painful periods, breast tenderness, fatigue or negative mood changes. These irregularities can signal underlying issues such as polycystic ovary syndrome, which can also be a precursor to diabetes, primary ovarian insufficiency or endometriosis.

Irregular menstrual cycles can also lead to osteoperosis or indicate thyroid disease or reproductive organ abnormalities. In turn, these can affect fertility and overall quality of life.

Unusually heavy bleeding might suggest conditions such as fibroids, endometriosis or certain endocrine-related tumors. Absent periods could signal hormonal imbalances or problematic lifestyle factors, such as exercise-induced amenorrhea – meaning lack of periods – or eating disorders such as anorexia and bulimia.

In fact, some female athletes experience a condition called the female athlete triad, in which their training regimen leads to a combination of disordered eating, the absence of a menstrual cycle and loss of bone density. Missed periods, also called amenorrhea, are usually the first sign of trouble. If left unaddressed, they can lead to more serious lifelong conditions such as osteoporosis and infertility.

### Starting the conversation early

Menarche, or a girl's first period, usually occurs around age 12. The Centers for Disease Control and Prevention states that the average age of menarche is 11.9 years old, with some starting as early as 8 years old and others as late as 16. An earlier onset of menstruation can be affected by an interaction of ethnicity, socioeconomic status and being overweight due to an unhealthy diet.

Overall, girls are getting their first periods earlier than in previous decades, although no one knows exactly why.

For this reason, these organizations have urged clinicians to inform parents or caretakers about

what is physically normal about early menstrual experiences. This allows parents and girls to know what to expect and to recognize abnormalities that need to be further explored.

### **Being proactive**

It is critical for anyone who menstruates to know the facts about menstruation throughout their entire life.

Cycle tracking at all ages can help identify symptom patterns, both physical and mental. This is especially important for those approaching menopause and even after menopause.

When you go to the doctor, don't be afraid to ask questions or bring attention to any changes or concerns. Continue the conversation beyond just providing the date of your last period.

## **Study Finds Dramatic Change In Molecule, Microbes At Post-40, Affecting Whole Metabolism**

new study has found that in mid-40s and early 60s, one experiences a dramatic surge or fall in molecules and microbes, significantly affecting heart and immune function, muscles, along with how their body handles alcohol and coffee.

Researchers tracked changes due to ageing in more than 1,35,000 different molecules and microbes in people aged 25 to 75 and found that molecule and microbe counts did

not shift gradually over the years. Risks of age-related diseases such as Alzheimer's disease and cardiovascular conditions are known to rise sharply in older age, compared to a gradual increase for

those aged under 60. Rather, we undergo two periods of rapid change during our life span, averaging around age 44 and age 60, the researchers at Stanford University, US, said. The findings are published in the journal Nature Aging.

"We're not just changing

gradually over time; there are some really dramatic changes. It turns out the mid-40s is a time of dramatic change, as is the early 60s. And that's true no matter what class of molecules you look at," said senior author Michael Snyder, chair of genetics at Stanford University.

Among people in their 40s, the researchers noted changes in count of molecules involved in metabolising alcohol, caffeine and lipids (fats), along with those related to heart disease, skin and muscles.

# Sensex Jumps 1,330 Points **To 2-Week High On Easing US Recession Fears**

MUMBAI: Benchmark Sensex spurted by 1,330 points to close at a twoweek high while Nifty jumped 397 points to settle above the 24,500 level on Friday as easing fears of a recession in the US triggered buying in IT shares amid a sharp global stocks rally.

The 30-share BSE Sensex jumped 1,330.96 points or 1.68 per cent to settle at 80,436.84, marking its best single-day gains in more than two months. During the day, it zoomed 1,412.33 points or 1.78 per cent to 80,518.21

The NSE Nifty surged 397.40 points or 1.65 per cent to close at a twoweek high of 24,541.15. As many as 47 Nifty shares closed in green while three closed in red.

From Sensex firms, Tech Mahindra, Mahindra & Mahindra, Tata Motors, UltraTech Cement, Tata Consultancy Services, HCL Technologies, ICICI Bank and Tata Steel were the biggest gainers.

Sun Pharma emerged as the only laggard.

'The stability of the Japanese Yen has been instrumental in driving a global market recovery. Besides that, the strong US retail sales and a decline in weekly jobless claims have helped alleviate fears of a US recession.



"Further, the market sentiment has improved due to a decrease in US CPI inflation. On the backdrop of these, the Indian IT firms exhibited strong buying interest," said Vinod Nair. Head of Research, Geojit Financial Services.

In Asian markets, Seoul, Tokyo, Shanghai and Hong Kong settled significantly higher. European markets were trading mostly in the green. The US markets ended with sharp gains on Thursday.

"The Indian frontline indices traded significantly higher today, mirroring the positive global market sentiment. The gains in the market were broad-based as the midcap and smallcap indices also moved higher. This upbeat market mood was primarily driven by reduced volatility, which stemmed from increased expectations of a US rate cut in September," Avdhut Bagkar, Technical and Derivatives Analyst, StoxBox, said.

In the broader market, the BSE midcap gauge jumped 1.80 per cent and smallcap index climbed 1.70 per cent.

All indices ended higher. IT index soared 2.72 per cent and realty jumped 2.45 per cent. Teck (2.23 per cent), auto (1.90 per cent), commodities (1.89 per cent), power (1.80 per cent), financial services (1.77 per cent) and consumer discretionary (1.74 per cent) also closed higher.

A total of 2,462 stocks advanced while 1.467 declined and 107 remained unchanged on the BSE.

NEW DELHI: The unemployment rate for people aged 15 years and above in urban areas remained unchanged at 6.6 per cent in the April-June quarter, according to the National Sample Survey Survey (NSSO).



Joblessness, or unemployment rate, is defined as the percentage of unemployed people in the labour force.

The unemployment rate in the June quarter of FY24 was also 6.6 per cent.

The unemployment rate for people aged 15 years and above in the previous January-March quarter of FY24 was 6.7 per cent in urban areas, the 23rd Periodic Labour Force Survey (PLFS) showed.

It also showed that the unemployment rate among females (aged 15 years and above) in urban areas declined to 9 per cent in April-June 2024 from 9.1 per cent in the same quarter a year ago. The rate was 8.5 per cent in January-March, 2024.

Among males, the unemployment rate in urban areas declined to 5.8 per cent in April-June from 5.9 per cent in the same quarter a year ago. The rate was 6.1 per cent in January-March 202.

Labour force participa-

tion rate in Current Weekly Status (CWS) in urban areas for people aged 15 years

and above increased to 50.1 per cent in April-June from 48.8 per cent in the same quarter a year ago. The rate was 50.2 per cent in the January-March 2024. At the all-India level

in the urban areas, a total number of 5,735 FSUs (urban sampling unit curved out from Urban Frame Survey) have been sur-

veyed during April-June 2024. Labour force refers to

the part of the population, which supplies or offers to supply labour for pursuing economic activities for the production of goods and services and, therefore, includes both employed and

unemployed persons. The NSSO launched PLFS in April 2017.

On the basis of PLFS, a quarterly bulletin is brought out giving es-timates of labour force indicators namely unemployment rate, worker population ratio (WPR), labour force participation rate (LFPR), distribution of

workers by broad status in employment and industry of work in CWS. The estimates of unemployed persons in CWS give an average picture of

unemployment in a short span of seven days during the survey period.

In the CWS approach, a person is considered unemployed if he/she did not work even for one hour on any day during the week but sought or was available for work at least for one hour on any day during the period.

### **J&K To Vote**

After suffering reverses in the Lok Sabha polls, including in Haryana, the BJP is keen to regain political momentum by retaining power in the state and putting up a strong show in Jammu and Kashmir, where its strongholds have been traditionally confined to the Jammu division.

The Congress, however, is hoping to continue with its political revival by toppling the BJP from power in Haryana after 10 years and inflicting losses on its rival in the Jammu region where the two parties are the main contestants.

Two regional parties, the National Conference and PDP, have won most of the seats in the Kashmir valley between them in past elections. Both parties are part of the INDIA bloc along with the Congress but all three of them fought separately in the Lok Sabha elections, a scenario likely to persist in the assembly polls too.

In the 2019 polls in Haryana, the BJP had 40 of its 90 seats and formed the government in alliance with the Jananayak Janta Party. In the last assembly in J and K in 2014, the BJP had won 25 of its 87 seats and had joined hands with the PDP to form a government under the leadership of the regional party's leader Mufti Mohammad Sayeed.

Its assembly now has 90 seats following delimitation.

CEC Kumar said assembly elections in Maharashtra, which were held along with Haryana in 2019, will be announced later due to security requirements for Jammu and Kashmir.

He said four elections are due this year and by early next year and since Jammu and Kashmir was not in the picture last time (2019-20) the Commission decided to group two assembly elections together. Besides Jammu and Kashmir

and Haryana, elections are due in Maharashtra, Jharkhand and Delhi.

Kumar said the next set of elections will be announced after the completion of the polls in Jammu and Kashmir and Haryana.

While 24 seats will go to the polls in the first phase in Jammu and Kashmir, elections will be held in 26 seats and 40 seats in the second and third phases respectively.

The seats going to poll in phase-one include Pampore, Tral, Pulwama, Rajpora, Zainapora, Shopian, D.H. Pora, Kulgam, Devsar, Dooru, Kokernag (ST), Anantnag West, Anantnag, Srigufwara – Bijbehara, Shangus - Anantnag East, Pahalgam, Inderwal, Kishtwar, Padder - Nagseni, Bhadarwah, Doda, Doda West, Ramban and Banihal

According to the poll-body, 26 seats would go to the polls in the second phase for which notification would be issued on August 29. The voting in these seats spread over three districts each of central Kashmir and Pir Panchal region and Reasi district would take place on September 25.

The seats going to polls in second phase include Kangan (ST), Ganderbal, Hazratbal, Khanyar, Habbakadal, Lal Chowk, Channapora, Zadibal, Eidgah, Central Shalteng, Budgam, Beerwah, Khansahib, Chrar-i-Sharief, Chadoora, Gulabgarh (ST), Reasi, Shri Mata Vaishno Devi, Kalakote – Sunderbani, Nowshera Raiouri (ST), Budhal (ST), Thannamandi

stock of the poll preparedness recently. You would remember the long queues at polling stations during the Lok Sabha elections, which presented a spectacle of the strength of democracy. They weren't just long queues, they represented the hopes of the people and their desire to script a new future for themselves. Everybody wanted to participate and prove a point that they were in the queue not only to vote but to demonstrate a very strong desire to ensure that democracy flourishes in this area," Kumar said in Hindi.

"This showed that the people not only wanted change but wanted to write their own destinies by being part of the change. This was purely a triumph of ballot over bullet. The three Lok Sabha constituencies in the Valley saw a voter turnout of 51%. The people of the Valley said no to violence and decided to make their voices heard through votes. The people of the Union Territory chose the ballot over bullet and boycott," he added.

The Election Commission said not only had youth made their voices heard at the polling booth, but women had done so too, with the Union Territory seeing a turnout of 56.38% among them.

The Kashmir Valley also reached a new peak in terms of poll participation, seeing a 30-point increase compared to 2019.

The Assembly elections in the UT will be held in three phases, beginning September 18 and ending on October 1, with counting taking place on October 4. First Assembly Elections In 10 Years

In December last year, while delivering its verdict on Article 370, a five-judge Constitutional bench of the Supreme Court had directed the Election Commission to hold Assembly polls in the UT by September 30. It had also asked the Centre to restore statehood at the earliest. The UT has been without an elected government for over six years and the last Assembly elections were held in

December 2014. Jammu and Kashmir has also complet-ed five years as a Union Territory this year. On August 5, 2019, the erstwhile state was bifurcated into two Union Territories and its special status under Article 370 was removed. It has been administered by the lieutenant governor since then.

### **Poll Schedule Going**

against the backdrop of the September 30 deadline set by the Supreme Court to hold the democratic exercise in the union territory.

Addressing a press conference here to announce the schedule for the assembly elections in Jammu and Kashmir and Haryana, he said after the parliamentary polls concluded on June 4. the poll panel waited for the completion of the Amarnath Yatra on August 19. The notification for the first phase in Jammu and Kashmir will be issued on August 20, a day after the Yatra concludes.

Kumar said the Election Commission also had to keep in mind the weather in the union territory.

Voting for the last phase will be held on October 1 and the counting will be held on October 4.

"There is no way one could have gone exactly on the day, which is 19th (August 19). We are not giving even half a day when one could have started. And it is well within time period and it will be finished in time.

"So, it is not a day here and there which

three-phased assembly elections in J-K from September 18 which will be held after a decade, setting the stage for the people of the union territory to elect a government after the scrapping of Article 370 in 2019.

The Election Commission also announced that elections to the 90-member Harvana assembly will be held on October 1 and results for both the polls will be declared on October 4.

The National Conference called on the ECI to "thoroughly investigate this blatant attempt" and to immediately suspend the implementation of these orders.

"Around 150-200 transfers happened abruptly and arbitrarily. The LG administration's behaviour is full of prejudice and bias in favour of the BIP. Our concern is that elections should be conducted free. fair and transparent," Peoples Democratic Party (PDP) leader Iltija Mufti, daughter of PDP president Mehbooba Mufti, said.

Notably, this will be the shortest election in at least the last two decades. The phasing of the J&K election is significant, given that over the last two decades, due to the region's security concerns, polls have consistently been held in at least four phases or more.

In 2002, polls were conducted over four phases in September and October. In 2008, elections were held in seven phases in November and December; and in 2014, they were conducted in five phases.

He said the central government has promised assembly elections after delimitation but the exercise was completed long back.

"People are eagerly waiting for the formation of the popular government and the announcement of the polls reflects the aspirations of the people. We have full faith that people in J&K will take part in elections in a big way and elect their representatives," he said

Senior CPI(M) leader M Y Tarigami also welcomed the announcement of a poll for Iammu and Kashmir.

"It is welcome that after a long time the EC has announced the schedule for elections to the assembly. We also welcome the statement of the EC that it will be a full democratic exercise by ensuring level playing field to all parties and contestants besides sufficient security for candidates and votes as well," Tarigami said.

J&K BJP president Ravinder Raina said "we are highly grateful to ECI for the announcement of assembly elections in 1&K"

However, the party media incharge Pradeep Malhotra said they are fully prepared for the elections and requested the people to take part in the upcoming elections enthusiastically.

The proposed posts span from post of superintendent of police till lower rung posts in the non-gazetted and class-IV cadre.

In another decision, the Administrative Council also approved creation of 30 posts of different categories in the office of State Election Commission, J&K.

The Commission was constituted in October, 2020 with the appointment of First State Election Commissioner. However, till date except for the post of State Election Commissioner, no post/staff have been created and Commission has been functioning with assistance of staff attached from various other departments.

It was considered necessary to create these posts to ensure smooth functioning of the State Election Commission, the spokesman said.

In a separate decision, the Council approved operational guidelines for JK Startup Policy which would give a fillip to enthuse start-up initiatives by youth of Jammu and Kashmir

The Administrative Council in its earlier meeting held on February 19 had approved the said policy.

"For the past five years, the Indian National Congress has been consistently demanding the restoration of full statehood for Jammu and Kashmir and the holding of assembly elections. Jammu and Kashmir is still waiting for full statehood," said Rajya Sabha MP Jairam Ramesh in a post on X (formerly Twitter). Earlier the poll-panel announced that the Jammu and Kashmir Legislative Assembly elections will be held in three phases, beginning September 18, with results to be declared on October 4.

Polling for the first phase will be held on September 18, the second phase on September 25, and the final phase on October 1.

"Recent actions by the central government have further increased the powers of the Lieutenant Governor, effectively reducing the powers of a duly elected state government to a mockery," Ramesh added.

Last month, the Centre granted additional powers to the Lieutenant Governor of Jammu and Kashmir, including decision-making authority over the police, officers from all-India services like the IAS and IPS, and the power to sanction prosecutions in various cases.

These powers were granted to the LG through amendments to the rules under the Jammu and Kashmir Reorganisation Act, 2019. This act facilitated the division of the former state of Jammu and Kashmir into the Union Territories of Jammu and Kashmir and Ladakh, while also abrogating Article 370.

Jammu and Kashmir has been without an elected government since June 2018, when Bharatiya Janata Party (BJP) broke its alliance with Peoples' Democratic Party (PDP) forcing Mehbooba Mufti to resign as chief minister.

Tamil Nadu resident Madhu Jayakumar was the manager of the Vadakara branch of Bank of Maharashtra and he was transferred to their branch at Kochi.

Following the transfer Ershad joined. Even after several days Jayakumar failed to join his new posting and by that time Ershad had found some serious discrepancies in the pledged gold.

According to the findings 26 kilograms of pledged gold was found

to be artificial. The loss to the bank was around 17 crores.

The Police have registered a case. Jayakumar's mobile phone was found to be switched off and he is yet to be traced. What has baffled the police is

how such a big swindle was possible by just one person.

# **China's Driverless** 'Robotaxis': Sci-fi Marvels **Or Safety Concerns?**

Wuhan, China: Turning heads as they cruise past office buildings and malls, driverless taxis are slowly spreading through Chinese cities, prompting both wariness and wonder.

China's tech companies and automakers have poured billions of dollars into self-driving technology in recent years in an effort to catch industry leaders in the United States.

Now the central city of Wuhan boasts one of the world's largest networks of self-driving cars, home to a fleet of over 500 taxis that can be hailed on an app just like regular rides. At one intersection in an industrial area of Wuhan, AFP reporters saw at least five robotaxis passing each other as they navigated regular traffic.

"It looks kind of magical, like a sci-fi movie," a local surnamed Yang told AFP.

But not everyone shares Yang's awe. Debates around safety was sparked in April when a Huaweibacked Aito car was involved in a fatal accident, with the company saying its automatic braking system failed.

A minor collision between a jaywalker and a Wuhan robotaxi last month re-ignited concerns.

Taxi drivers and workers in tra-

ditional ride-hailing companies have also raised fears of being replaced by artificial intelligence -- although the technology is far from fully developed. Five to 500

Wuhan's driverless cabs are part of tech giant Baidu's Apollo Go project, which first received licences to operate in the city in 2022.

Initially, only five robocars ferried passengers around 13 square kilometres (five square miles) of the city of around 14 million.

Baidu says the taxis now operate in a 3,000 square kilometre patch -- more than a third of the total land area of Wuhan, including a small part of the city centre.

In comparison, US leader Waymo says the largest area it covers is 816 square kilometres, in Arizona. When a car reaches its pickup

point, riders scan a QR code with their phones to unlock the vehicle -- with the front seats blocked off over safety concerns.

The fares are currently heavily discounted, with a thirty-minute ride taken by AFP costing just 39 yuan (\$5.43) compared with 64 yuan in a normal taxi.

"They are stealing our rice bowls, so of course we don't like them," Wuhan taxi driver Deng Haibing told AFP, using a popular Chinese term for livelihoods.

### **Google Brings** 'AI Overviews' To **India With Country-First Features**

New Delhi: Tech giant Google has announced to bring its 'AI Overviews' feature to six new countries, including India. In India, the company is rolling out the 'AI Overviews' in English and Hindi and are also introducing popular country-first features that were well-received during its Search Labs experiment.

"It will help you easily switch between English and Hindi results with the language toggle button, and listen to responses with Text-To-Speech by tapping the 'Listen' button," the company said in a blog post.

The six new countries are India, United Kingdom, Japan, Indonesia, Mexico and Brazil, along with local language support in each country.

Hema Budaraju, Senior Director, Product Management, Search, said as part of the testing, "we've seen that Indian users listen to AI Overviews responses more often than other countries"

'We're introducing more ways to check out relevant websites while you search, with a new right-hand link display for AI Overviews on desktop - also accessible on mobile by tapping the site icons on the upper right," Budaraju mentioned.

People who are looking for help with complex topics are engaging more and keep coming back for AI Overviews. Google found that people prefer using Search with AI Overviews, and they find their search results more helpful.

"As we evolve the Search experience with AI Overviews, we remain focused on helping people access information and perspectives from a diverse range of sources," said Budaraju. And when people click from search result pages with AI Overviews, these clicks are higher quality for websites - meaning users are more likely to spend more time on the sites they visit.
