BJP's New List Of Candidates Final

Jammu: Despite resentment shown by some party leaders over selection of candidates for the Jammu and Kashmir Assembly elections, the BJP on Tuesday released its revised list of 29 nominees for the second and third phase, without making any major changes except replacing one contestant.

With the release of the fresh list, the party has so far named the candidates for 45 assembly segments, including nine in the Kashmir Valley where it has not been able to open its account in the past assembly elections.

The Union Territory of Jammu and Kashmir, which has a 90-member assembly, is going to polls in three phases on September 18, 25 and October 1. This will be the first assembly elections in Jammu and Kashmir after it was downgraded to a Union Territory in August 2019 with its special status under Article 370 of the Constitution also revoked.

The BJP has made one change from the now-rescinded list, which was put out on Monday, as it has named former MLA Baldev Raj Sharma from Shri Mata Vaishno Devi seat in place of Rohit Dubey. All other names are the same for the same set of constituencies, announced yesterday before being withdrawn.

Srinagar: As many as 279 candidates have filed their nomination papers across 24 Assembly Constituencies (ACs) of seven districts of Jammu and Kashmir which are going to polling in the first phase of J&K Assembly Election 2024.

Tuesday was the last day of filing nomination papers for the first phase of the Assembly Election scheduled to be held on September 18, 2024.

A statement from the office of Chief Electoral Officer detailed the candidates who have filed their nominations.

A total of 72 candidates have filed their nominations in Anantnag district, followed by 55 in Pulwama district, 41 in Doda district, 32 in Kishtwar district, 28 in Shopian district, 28 in Kulgam district, while 23 candidates have filed nominations in Ramban district.

In Anantnag, several constituencies have



multiple candidates. The Dooru Assembly Segment has 12 candidates, including Gh Ahmad Mir, who is backed by the National Conference-Congress alliance. The Kokernag ST Assembly Segment has 11 candidates, while Anantnag West has 14 candidates, including Ab Majeed Bhat Larmi of NC and Ab Gaffar Sofi of PDP.

'Diabetes Complications Affect Mental Health And Vice-Versa'

has study found a tworelationship between complications due to diabetes, such as heart attack and stroke, and mental health conditions, like anxiety and depression - having any of the problems from the former group increased the risk of one from the latter, and the other way round.

Researchers said that the two-way link could also be "less direct" as both - diabetes complications and mental health conditions shared multiple risk factors, including obesity and problems in controlling blood sugar levels, which increase the chances of developing both sets of disorders.

"Most likely, a combination of direct and indirect effects and shared risk factors drive the association we are seeing," Maya Watanabe, a biostatistician at the Harvard University's School of Public Health, US, and first author of the study published in the journal Diabetes Care, said.

"Diabetes care providers may be able to simultaneously prevent the risk of multiple complica-

Observer News Service rinagar - The principal secretary, revenue, Sonali Kumar, has proceeded on leave following the recent transfers and postings in the state administration.

The high-ranking bureaucrat has been transferred for the seventh time in the changes announced vesterday.

During the two-and-a-half year tenure of the coalition government, Kumar has been shifted six times from her posts.

Before the coalition government came to power, Sonali Kumar had been made the commissioner secretary, education, on May 1, 2002. Soon after the new government took over, she

was transferred to the technical education department as commissioner secretary in November 2003. In February the next year, she was

transferred to industries and commerce, and four months later, in July 2003, to the higher and technical education department After serving on that post for one year, she was

transferred again in July 2004, and made the principal secretary of the forest department. The government shifted her again in April 2005, this time to the health and medical education department.

Yesterday's revamp, which made her the principal secretary of the revenue department, was the sixth time she was transferred in 2-and-a-half years.

Fed up with the repeated transfers and postings. Sonali Kumar, has gone on leave in protest. sources told the KNS. She has asked the government to grant her leave till October.

Election Sans Boycott

he ongoing Assembly elections in Jammu and Kashmir are witnessing a notable absence: there has been no call for a boycott of the exercise from any quarters, just as there wasm't one during the recent parliament election. This marks a significant departure from the norm established since the beginning of the separatist struggle in 1989.

However, the absence of a boycott call does not guarantee a high voter turnout in the Valley elections. The reason is that the poll boycott has become a default response among a significant section of people, particularly in urban areas. It is an over three decade old habit which may not go away easily. In the last election, Kashmir Valley polled 50.86 percent votes in the three parliamentary seats — Srinagar, Baramulla, and Anantnag-Rajouri

Since the early nineties, separatists have championed the boycott of elections, although this trend has seen diminishing returns over the years. The urban areas still witness significant boycotts but the rural areas generally experience higher voter turnout.

The question now arises whether people in cities and towns will vote in large numbers in the absence of a public boycott call. Many may still choose to boycott, but the most may not as the current trend suggests.

Election boycotts have often profoundly impacted the electoral exercise in the Valley. In case of boycott, even a candidate with little political influence could secure victory. Over the past three decades, there have been numerous instances where candidates with minimal support won elections by narrow margins, subsequently assuming prominent government positions.

The ongoing election will be crucial for cities like Srinagar, which have consistently boycotted polls since 1987 Assembly polls which were widely perceived to have been rigged. The city has been in a limbo ever since. Although there have been unprecedented changes in the region in the past five years, such as politicians campaigning deep into Srinagar's interiors, active political participation remains elusive.

But more people are expected in the Assembly election. In recent years, people in the Valley have eagerly waited for the restoration of democracy. They have looked forward to the assumption of power by an elected government, giving them both a sense of involvement in decision making and also enabling them to hold the rulers accountable, something that is not possible under a bureaucratic rule. But a better and a representative elected government can only be formed if people participate in the election in large numbers. And they should.

Waqf Amendment Bill, 2024

A Threat to Religious Autonomy?

he term wagf, in its literal sense, means "to enclose", "to block" or "to fix". In legal definition, it is the permanent dedication of property for pious purposes. Any property, whether movable or immovable, that has been permanently devoted for religious, pious, or charitable purposes as recognized by Islamic law is referred to as waqf property under the Waqf Act, 1995. Such property is dedicated by a Muslim person or group, and after it is proclaimed waqf, it is thought to be irreversibly and eternally in God's possession, with its profits used to support the general welfare or particular religious objectives. The Waqf properties are managed by Mutawallis. According to a report, the Waqf Board manages 8.7 lakh properties, in around 10 lakh acres, with a value of around 1 lakh crores.

Why was Waqf Act, 1995 passed?

In response to the increasing demand for a more complete and stronger legal framework for the administration of waqf properties-which, according to Islamic law, are set aside for charitable, educational, and religious purposes—the Waqf Act, 1995 was passed in India. The administration of waqf properties was beset by corruption, incompetence, and inefficiency prior to the legislation

The Waqf Act, 1995 was passed with the following main ob-

- to offer improved wanf administration and management including for waqf properties and other associated matters. to create and support the efficient operation of State Waqf Boards and the Central Wagf Council, which will also advise the State and Central Governments about the manage

- To appoint an executive officer to the Waqfs, whose performance is not satisfactory and the income is above 5 lakhs
- or above A regulatory/judicial framework related to the disputes of Waqf.

The Waqf Amendment, 2013:

The management and control of waqf properties in India underwent a number of important modifications brought about by the waqf (Amendment) Act, 2013. These are a few of the significant

Council of Central Waqf: The Central Waqf Council was created by the Act to supervise State Waqf Board operations and provide consistency amongst them.

State Waqf Boards: The Act placed a strong emphasis on the establishment of State Waqf Boards in order to efficiently man-age waqf properties at the state level. These boards now have additional authority to file lawsuits to stop encroachment and improper usage of waqf properties.

Audit of Waqf Properties: In order to guarantee openness and

appropriate administration, the amendment required periodical audits of waqf properties.

Dispute Resolution: It established a tribunal to handle disputes pertaining to waqf properties and offered a procedure for resolv Management and Accountability: By establishing rules for the

ent of wagf properties and are used for the appropriate purposes, the Act aimed to increase the accountability of waqf management. Transparency procedures: It instituted procedures, such as the

need to keep public records and make information available to the public, to promote transparency in the management of waqf

Waqf Amendment Bill, 2022:

Presented in the Indian Parliament, the Waqf (Amendment) Bill, 2022, brought about a number of significant updates and improvements to the waqf property administration system. The bill sought to provide better governance and address a number of concerns pertaining to the administration of waqf properties.

A. Enhancement of the Central Waqf Council (CWC): The bill suggested enhancing the Central Waqf Council's responsibilities in order to guarantee better supervision and cooperation between the Central and State waqf boards. The CWC would be able to oversee State waqf boards and guarantee consistency in their operations with more authority.

B. Waqf Tribunal: The National Waqf Tribunal was to be established under the bill in order to settle disputes about wagf properties. In order to address matters involving waqf property management and encroachments, this tribunal would act as a specialized authority.

C. Enhanced Accountability and Transparency: It suggested steps to improve accountability and transparency in the administration of wanf properties, such as mandating frequent reporting and financial audits of the operations and financial statements of waqf boards. The bill contained clauses pertaining to the upkeep and updating of public records pertaining to waqf proper

D. Management and Administration: By establishing more precise rules and regulations for the management of waof properties. the measure sought to simplify the administration of these estates. By establishing stronger administrative and legal frame works, the Waqf (Amendment) Bill, 2022 sought to address longstanding problems with the management of waof holdings and enhance the Waqf Act's overall efficacy.

The Waqf Amendment Bill, 2024

The Waqf Amendment Bill, 2024, poses a significant intrusion on the Muslim community's fundamental rights. The measure threatens the community's right to administer its religious and philanthropic assets by consolidating authority over waqf properties and weakening the independence of traditional

Islamic institutions. The Central Waqf Council and the Board of Auqaf's religious character is upset by the appointment of non-Muslim members, which may jeopardize the administration of waqf properties in line with Islamic law. In addition, the Collector's involvement in validating waqf properties along with the necessary public notice time for land record updates pose bureaucratic obstacles that may cause delays, conflicts, or even the unjust confiscation of wagf holdings.

Concerns against the state's excessive involvement in religious matters are raised by these laws, which violate the community's right to self-governance and religious freedom. Under the pretense of openness and inclusivity, the law runs the risk of undermining the waqf, an ancient Islamic institution, and infringing upon the fundamental rights of the Muslim community

Below mentioned is the comparison between the Waqf Act, 1995 and the proposed amendment bill, 2024. In the form a chart, Central Waqf Council's and the Board of Auqaf's ability to govern waqf properties in accordance with Islamic law by allowing non-Muslim members into historically Islamic organizations. The measure also requires a waqf deed to be executed, moves the registration procedure online, and includes the Collector in the wagt property verification process.

The goal of these modifications is to increase transparency but they run the risk of putting up bureaucratic obstacles that slow down the registration process and cause conflicts over properties that can be mistakenly designated as belonging to the government. Moreover, the wagf boards' autonomy is diminished by the centralization of control brought about by the consolidation of audit tasks under state-approved panels and the Comptroller and Auditor-General of India. This centralization violates the community's right to self-governance and religious freedom along with the additional bureaucratic restrictions.

Concerns over the Waqf Amendment Bill, 2024's potential effects on the Muslim community's fundamental rights are warranted because it would significantly alter the way wanf propdamental rights and set a worrying precedent for the loss of religious freedom by upsetting the management of waqf properties and undermining the autonomy of religious institutions. As such, a thorough reassessment of the bill is necessary to protect and uphold the rights and customs of the Muslim community.

Sustainable Urban Flood Solutions

The Role of Green Infrastructure in Smart Cities

n recent years, we have been witnessing erratic and unforeseen weather activities. Intense, short-duration downpours are responsible for triggering frequent urban flash floods. The situation has further worsened due to rapid urbanization where rainfall is unable to find a way to reach the soil matrix. The lack of permeable ground surfaces, paved roads and streets cause the rainwater to accumulate and lead to frequent urban flash floods. The problem has exacerbated since urban runoff carries sediments and floating garbage, which clogs the stormwater conveyance network.

The Government of India in 2015 started National Smart Cities Mission with the ambitious goal of transforming cities across the country into more citizenfriendly and sustainable environments. Srinagar city is also being developed on the lines of smart city project. The smart city project aims to improve the living standards by various innovative and inclusive solutions. However, the ground reality is that these projects have largely neglected the crucial aspect of sustainable urban development. Instead, many of these "smart cities" are rapidly evolving into concrete jungles, where mere road paving and sewer installation fail to meet the comprehensive criteria of a truly smart and sustainable city. A smart city should embody sustainability, eco-friendliness and a harmonious integration with nature. Addressing the challenges posed by rapid urbanization is critical to mitigating the occurrence of urban floods.

Green infrastructure offers a sustainable, long-term, economical, aesthetically pleasing and environmentally friendly solution to urban floods. It mimics the natural hydrology of an area, captures rainwater where it falls and recharges it into groundwater. The concept of green infrastructure holds the potential to enhance urban sustainability, providing long-term flood prevention, rainwater filtration, and groundwater recharge. Green infrastructure techniques include green roofs, bioretention cells, permeable pavements, bioswales, planter boxes, green



which can serve a specific purpose in urban rainwater management and beautification.

Green Roofs

Green roofs are a modification of traditional roofs which consists of placing a waterproof membrane overlayered by growing media where vegetation is grown. These roofs absorb the rainwater, a part of which is used by plants and returned to the atmosphere via evapotranspiration. They can retain up to 70-90% of the rainfall that falls on them, significantly reducing stormwater runoff and thus reducing the strain on sewer systems during peak flow periods. Green roofs mitigate the urban heat island effect by providing a natural green cover in urban areas, thereby moderating the temperature of the buildings. Beyond these benefits, green roofs surfaces, paved roads and streets cause the rainwater to accumulate and lead to frequent urban flash floods. The problem has exacerbated since urban runoff carries sediments and floating garbage, which clogs the

improved air quality, noise reduction, enhanced biodiversity and overall better health and wellbeing.

Bioretention Cells

Bioretention cells are the artificial imitation of an ideal natural soil system with comparatively higher hydraulic conductivity and significant water quality im-provement potential designed for managing urban stormwater. They are the most widely adopted green infrastructure practices for managing urban stormwater. A typical bioretention cell can infiltrate as much as between 85 to 90% of the annual stormwater runoff, replenishing our groundwater resources. They have been found to be very effective in attenuation of peak rates of stormwater runoff generated by rainfall events of varying intensities. In addition to reducing runoff,

bioretention cells are highly effective in mitigating pollution and enhancing groundwater recharge. Bioretention cells can also be constructed economically using the locally available material and growing native plant species. The cost of construction varies between Rs. 125 to 250 per square foot to 335 to 500 per square foot (Albert Jarrett, 2022).

Permeable Pavements Conventional pavements consist of hard concrete surfaces that prevent water infiltration, leading to the accumulation of stormwater and resulting in flash floods. Permeable pavements, on the other hand, are designed to treat, infiltrate, and replenish groundwater. Permeable pavements include porous asphalt, pervious concrete and permeable interlocking concrete pavers. Permeable pavements aim to restore the hydrological balance of urban paved areas by capturing rainwater and allowing it to slowly infiltrate the ground instead of flowing into stormwater drains. The cost of installation may vary between Rs. 170-335 per square feet depending upon the type of permeable pavements installed (Minnesota Stormwater Manual).

Bioswales are linear shallow landscaped depressions designed for the collection, filtration, infiltration and conveyance of stormwater. The working principle is the same as that of bioretention cells, however unlike bioretention cells which are excavated depression, bioswales are vegetated channels that treat and infiltrate stormwater while conveying the same. Bioswales are best suited for highways and residential road runoff due to their linear nature. They are aesthetically pleasing than the traditional concrete gutters and use native plants and soil mix to absorb and filter stormwater.

Green Streets and Alleys

Green streets and alleys represent an excellent and innovative concept of integrating all green infrastructure practices in the urban infrastructure design process. Bioretention cells, bioswales, permeable pavements and trees can be used together to provide different environmental benefits in an urban ecosystem. The greenery and effective drainage in addition to growing biodiversity provide an excellent space for the local community to walk, play and interact. They turn uninviting alleys and streets into inviting and aesthetically pleasing public spaces bustling with various recreational activi-

Prioritizing green infrastructure not only enhances environmental sustainability but also improves the quality of life in urban areas. By integrating these practices, cities can mitigate environmental impacts and create vibrant, resilient communities that thrive amidst urbanization. It is a need of hour to embrace the concept to create a favorable urban living space for our future generations.

The Great AI Detection Dilemma

Tust who (or what) wrote what? This seems to be a prevailing and resonant question that seems to be focused on author over content.

Recent research has uncovered a significant challenge in this curious authorship debate of artificial intelligence (AI): neither humans nor AI systems are consistently able to detect AI-generated content in online conversations. This finding might have significant implications for digital communication, online trust, and the future of human-AI interaction. Or, on the other hand, it might just be a wild goose chase that drives a wedge between human and AI creativity and productivity.

A New Take on the Turing Test

Researchers conducted a novel experiment, expanding on the classic Turing test. They presented transcripts of conversations between humans and AI to both human participants and AI models, asking them to determine which was which. The results were striking and un-

Displaced human judges (those reading transcripts) performed no better than chance in identifying AI participants. Even more surprisingly, AI models like GPT-3.5 and GPT-4, when tasked with the same identification, showed similarly poor performance. Perhaps most intriguingly, the most advanced AI conversationalist was more likely to be judged as human than actual human participants.

Blurring Lines in the Digital Landscape

These findings suggest that as AI language models become more sophisticated, the line between human- and AI-generated content is becoming in-


creasingly blurred. This has important implications for our digital interactions and raises important questions about the nature of online communication.

As AI systems become more prevalent in digital spaces, it may become increasingly difficult to discern whether we're interacting with humans or machines. This challenge extends beyond mere curiosity—it can strike at the heart of digital trust. How can we verify the source of information or the identity of those we're communicating with in an environment where AI can convincingly mimic human discourse?

The Hunt for Reliable Detection Methods The study also explored various

methods of AI detection, including statistical approaches and the use of AI to detect other AI. While some methods showed promise, they all had significant limitations.

- Statistical Approaches: Statistical methods could identify some patterns in AI-generated text but struggled with more advanced models. As AI language models improve, these statistical signatures become increasingly subtle and difficult to detect reliably.
- Al Detecting Al: Al detectors performed better than chance but still made many errors, especially with more sophisticated AI-generated content. This suggests that even AI, trained specifically for this task, struggles to consistently identify its own kind in conversational settings.
- The Human Element: Interestingly, interactive human interrogators performed better than those reading transcripts, but they still struggled to consistently identify AI participants. This highlights the value



of direct interaction in detecting AI but also underscores the sophistication of modern AI language models.

Does It Really Matter?

As we grapple with the challenges of AI detection, a question emerges: Does it really matter? In an increasingly AI-integrated world, the distinction between human and AI-generated content might become less relevant in many contexts. Consider how we've seamlessly integrated spell-check and autocorrect into our writing processwe rarely pause to consider whether a correctly spelled word is the result of human knowledge or technological assistance. Similarly, as AI becomes more deeply woven into our digital interactions, we might find ourselves focusing less on the origin of the content and

more on its value and relevance. This perspective doesn't negate the importance of transparency in highstakes situations, but it does suggest that in many everyday interactions, the pursuit of distinguishing between human and AI contributions might be unnecessary or even counterproductive. Instead of "chasing the author," we might be better served by developing frameworks to evaluate the quality, ethics, and impact of digital content, regardless of its origin. This shift in focus could lead to more productive discussions about how we can harness the combined potential of human and artificial intelligence to enhance our digital experiences and decision-making processes.

Embracing Complexity

The difficulty in distinguishing between human and AI communication underscores the remarkable progress in AI technology. However, it also highlights the complex challenges we face in an increasingly AI-integrated world. Today, and into the future, it will be crucial to approach these challenges with nuance, balancing the potential benefits of AI with the need for transparency, trust, and human-centered design in our digital ecosystems.

In the end, this research doesn't just reveal our limitations in detecting AI-it opens up new questions about the nature of communication, intelligence, and what it means to be human in a world where machines can convincingly mimic our most distinctive trait: the ability to

One Rupee A Minute AI Voice Bots Help Indian Startups Compete With OpenAI

New Delhi: Earlier this month, executives from Alphabet Inc.'s Google DeepMind, Microsoft Corp. and Meta Platforms Inc. joined tech founders in Bangalore to watch one of India's top AI startups unveil a new product that might change how the world's most populous country uses the technology.

Sarvam AI, often described as India's OpenAI, introduced software for businesses that can interact with customers using spoken voice rather than just text. The technology was developed with data from 10 native Indian languages and priced at a rupee per minute to capture the market. In a video at the event, Vinod Khosla, a billionaire venture capitalist and investor in Sarvam, said, "These voice bots have the potential to reach a billion people.'

India has tried to keep pace with the global artificial intelligence frenzy in the nearly two years since ChatGPT launched, but chatbots have often been limited by a lack of data on many of the country's languages. Many who live in big cities can type prompts to a chatbot in English, but most of India



lacks the language skills to do so. Now, a growing number of startups are betting that voice bots built with local language data can reach a wider swath of India and perhaps even appeal to users in other countries.

In the process, these startups may turn India into a proving ground for what could be the next frontier of generative AI products, albeit one that has raised some safety concerns in other markets. By incorporating AI voice features, tech companies hope to create more dynamic, conversational services that can respond to users verbally in real time and automate certain tasks. In India, that's already playing out across a wide range of consumer and business

applications.

Samsung-backed Gnani AI does millions of voice conversations daily for India's largest banks, insurers and car companies. CoRover AI offers voice bots in 14 Indian languages to the state-owned railway corporation and a regional police force. And Haloocom Technologies' voice bot can speak in five Indian languages to handle customer service tasks and help screen job candidates.

"The world went from digital first to mobile first to AI first, but voice is the most intuitive way to use technology," said Ankush Sabharwal, co-founder and chief executive officer of

CoRover's Ask Disha voice

India's train booking company, IRCTC. The bot can book train tickets and complete payments on a customer's behalf solely via voice. The country needs AI agents that can perform tasks, not just provide information, Sabharwal said.

Gnani offers a bot to help lenders converse with potential customers to figure out their financial needs, collect personal information and determine their eligibility for loans. The startup also works with one of India's largest carmakers, Tata Motors Ltd., to get feedback for the latest car models and sell extended warranties and accessories. Sarvam's voice bots can

handle mixed-language conversations and take actions for customers, such as setting up appointments and facilitating payments. The company has about 50 clients, including Sri Mandir, a devotional app that has more than 10 million downloads on the Android Play Store. Using Sarvam's voice software, Sri Mandir's app can guide people toward specific rituals at different temples and how to ask for various types of

"Try throwing GPT-4 or Claude at Sri Mandir. I can guarantee it won't work," said Vivek Raghavan, co-founder of Sarvam, alluding to cuttingedge AI models from OpenAI and Anthropic. The US companies do not have access to enough spoken Indian language data, he said, including accents that vary from region to region.

Some leading AI companies in the US, including OpenAI, have developed technology that can generate convincing voices but have slow-walked bringing it to market. OpenAI recently warned that users could become emotionally reliant on its voice product and also said it had taken steps to prevent impersonations and generating copyrighted audio. The startup has begun rolling out new voice features to a limited number of users after a delay.

Despite the concerns, India's AI startups are optimistic about the technology. "AI made for specific use cases, languages and audiences is more accurate, less expensive to run and has vastly reduced hallucinations,' said Ganesh Gopalan, co-founder and CEO of Gnani, using a term that refers to AI systems fabricating facts.

Court Convicts Man For Winking At Woman, Holding Her Hand

Mumbai: A court here has convicted a 22-year-old man for outraging the modesty of a woman by winking at her and holding her hand but refused to impose any sentence on him considering his age and the fact that he has no criminal antecedents

Magistrate Aarti Kulkarni observed that while the offence committed by the accused, Mohammed Kaif Fakir, deserves a sentence not less than life imprisonment, considering his age and the fact that he has no criminal antecedents, he should be given the benefit of probation.

The order was passed on August 22.

The court said it couldn't ignore the mental agony and harassment the woman underwent, but imposing a sentence on the accused would affect his future and his image in society.

The court convicted Fakir under section 354 (outraging the modesty of a woman) of the Indian Penal Code (IPC).

The court ordered that Fakir be released after furnishing a bond of Rs 15,000 and directed him to appear before the probation officer as and when

As per the complaint lodged at Byculla police station in south Mumbai in April 2022, the woman had ordered groceries from a local shop, and the accused, who worked at the establishment, came to her house to deliver the same.

The accused asked the woman for a glass of water, and when she was handing it over, he allegedly touched her hand inappropriately and winked at

He touched her hand the second time while handing over the bag of groceries and again winked at her, she alleged.

When the woman raised an alarm, the accused ran away. The woman then told her husband about the incident, and they lodged a police complaint.

The accused claimed that he had touched the woman's hand by mistake and had no intention to outrage her modesty.

The court held that although only the victim and the accused were present at the time of the incident, the evidence and the woman's statement were strong enough to prove the accused's complicity.

A two-time MLA and former minister Chowdhary Zulfikar Ali, who recently joined the BJP after leaving the Apni Party, will contest from Budhal (ST) constituency, former MLA Balwant Singh Mankotia, who joined the BJP in September 2022, was fielded from Chenani, former minister Syed Mushtaq Ahmad Bukhari, who joined the BJP in February this year, was fielded from his stronghold of

Saroori, who has represented the Inderwal seat for four terms, emphasized that he had no differences with the party or its leader over the denial of the ticket.

"I have no differences with Azad. He is my leader. I was compelled by the people to contest elections f Inderwal. They have assured me that we will win this election. I contested elections in 2002, 2008, and 2014 and won each time, thanks to the support of these people," he said.

The DPAP leader said the people of the constituency urged him to contest as an independent candidate. "I am ready to contest. The mandate belongs to the people, not anyone else,"

Saroori lost his deposit in the 2024 parliamentary elections from Kathua-Udhampur seat, which was won for the third time by Union Minister Jitendra Singh.

He served as a three-time MLA from the Inderwal constituency from 2002 to 2018. In 2008, he was appointed as the minister of state for tourism, forests, school education, social welfare, and consumer affairs & public distribution. Saroori was previously associated

with the Congress for a long time but resigned along with Azad in August When asked if he intends to re-

sign from DPAP, he said, "Azad is my leader and will continue to remain my leader.' Saroori emphasized that his focus

Court Convicts Doctor For RTI Application Personation

Likely To Award Sentence Today

SRINAGAR: A court here on Tuesday held a medical officer from Indian Systems of Medicine (ISM) guilty on charges of cheating by personation by filing an application under RTI Act in the name of another person and using the same being a "forged" document to be genuine.

"The prosecution has proved its case beyond any reasonable doubt to the extent that the accused had cheated the officials of department of ISM by pre-tending to be Muzafar Ahmad Ganaie by filing an RTI application in his name and thereby using a forged document as genuine," 2nd Additional Munsiff, Ahtzaz Ahmed, said while convicting Dr Zahoor Ahmad Tantray of Kupwara for offences punishable in terms of RPC sections of 419 (cheating by personation) and 471 (using genuine as genuine a forged document).

The court has posted the case on Wednesday for hearing the arguments on the quantum of sentence to be imposed upon the accused.

The case was filed on 30-10-2013 on the basis a communication received from the then Director, Indian Systems of Medicine, stating that the accused, putting up in a rented accommodation in Bemina Srinagar, was transferred from

to Unani Dispensary Khanaid, Udhampur because of his "misconduct". Also it was reported that the medical officer was harassing the officials of the department by filing the RTI applications using different names so that he could escape from the "departmental enquiry" and could pressurize the officers of the Department.

As per the communication, the department grew suspicious on receipt of chain of RTI applications on "stereotype readymade proforma" filed by impersonating different persons.

The medical officer, as per the communication, had filed one of the applications in the name of Muzaffar Anwar Ganie who happens to be the son of the owner of the house where the doctor was residing.

The department sent a copy of RTI application to Muzaffar Anwar Ganie who on its receipt contacted the department and refused to have sought any such information.

Similarly, the communication said, another RTI application in the name of one Mohammad Ashraf Ganaie was received against the officers who were conducting an inquiry against Dr Zahoor.

The communication alleged that Dr Zahoor actually wanted to escape from the departmental enquiry by harassing and causing distress to the officers and

Authorities Set Up Helpdesk To Reach Out To **Kashmiri Migrant Voters**

IAMMU: As preparations for assembly elections gain momentum in Jammu and Kashmir, the relief and rehabilitation department has established a helpdesk to assist eligible voters from the displaced Kashmiri community residing across the country.

This initiative aims to facilitate smooth polling at special polling stations and through postal ballots, according to officials.

The department has intensified efforts to ensure free and fair elections for Kashmiri migrants, with the Election Commission (EC) setting up 24 special polling stations and a postal ballot scheme for displaced community voters in Jammu, Udhampur, and Delhi, they said.

"A helpdesk has been established in our office and across various zones. Several employees have been deployed to ensure seamless facilitation of migrant polling," Relief and Rehabilitation Commissioner Dr Arvind Karwani told PTI.

Karwani emphasized that the helpdesk is actively addressing



issues faced by migrants, with the goal of enhancing voter facilities ahead of the upcoming assembly elections starting September 18.

"Kashmiri migrant voters opting to vote in person via electronic voting machines (EVMs) will have access to 24 polling stations, including 19 in Jammu, 1 in Udhampur, and 4 in Delhi," he said.

Karwani, who is monitoring the control room for the helpdesk, assured that all necessary arrangements have been made at these polling stations in accordance with EC guidelines.

The EC issued a notification on August 22 outlining the voting options for Kashmiri migrants, offering choices of both in-person voting at

special polling stations and through postal ballots.

"Special polling stations have been set up in Udhampur, Delhi, and Jammu. Alternatively, Kashmiri migrants can opt for postal ballots," he added.

Karwani said the updated electoral rolls, detailing migrant electors in various zones of Jammu and Udhampur mapped to respective special polling stations, will soon be published.

"Corrections or objections will be accepted within a seven-day period", he added.

The 90 assembly constituencies in Jammu and Kashmir are scheduled to go to polls in three phases beginning September 18, with counting of votes slated for October 4.

Patients Hit Streets, Seek Continued Treatment Under Golden Cards

SRINAGAR: Patients, suffering from renal failures and cancer, Tuesday staged a protest in Srinagar and demanded the resumption of free-treatment facilities under Golden cards at empanelled health centres in the valley.

The aggrieved patients said that treatments like dialysis and cancer therapies, provided to them under Golden cards at health centres without any cost, have been stopped after the arising of the payment issue.

"All the dialysis centres and cancer treatment centres run privately, whether in central, south or north Kashmir, have told patients to make payments for their dialysis or cancer ther-

apies from Ist. The officials in private hospitals, which were empanelled to do surgeries or treatments for different ail-



ments under Golden cards, have categorically refused to do so," said one of the protesters. While management of the

private hospitals were asked by patients for the reason of not extending healthcare facilities to them under Golden cards, "they told us (patients) that payments of earlier dialysis and other treatments are pending with the concerned entity, compelling us (hospitals) to ask for your treatments' charges," the protesting patient said.

Other patients said that they were receiving free treatments at the health centres for years and are now left to fend for themselves.

They requested the LG Administration for immediate intervention into the matter so that they could continue to receive free treatments under Golden cards. (CNS)

Bodies Of Two Cloudburst Victims Recovered In Ramban

RAMBAN/JAMMU: Two bodies, including that of a 12-year-old boy, were recovered on Tuesday as rescue operation continued in Jammu and Kashmir's Ramban district to trace five other missing people following a cloudburst, officials said.

The cloudburst occurred in Panchayats Kumate, Dhraman and Halla in Rajgarh tehsil late Monday afternoon, causing flash floods in Tanger and Dadi streams, they said.

Seven people of three different families were reported missing in the flash floods, Tehsildar Rajgarh Major Singh told PTI.

Despite the inclement weather, the rescue team has so far managed to retrieve bodies of two persons -- Yasir Ahmad (20) of Gadgram and Khalid Ahmed Parihar (12) of Suli-Kumate, Singh, who is supervising the rescue operation, said.

He said efforts are underway to locate the remaining five missing people -- Ahmad's mother Naseema Begum (42) and sister Shazia Banoo (6), Parihar's mother Gulshan Begum (42) and sister Seerat Banoo (8), and six-year-old Qazia Banoo of Dungar Dandllah.

The rescue team includes personnel from the State Disaster Response Force (SDRF), local police and volunteers.

Singh said that continuous rain has slowed down the rescue operation, as the rivulets are in spate. It took nearly three hours for the rescuers to reach the affected villages on foot, he added.

At least two government schools at Gadgram and Sonsua, and a couple of other structures also suffered damages, while three parked private vehicles were washed away by the flash floods, the officials said.

Jay Shah Elected Unopposed, Becomes Youngest Ever ICC Chairman

DUBAI: BCCI secretary Jay Shah was elected unopposed as the next ICC chairman here on Tuesday, making him the youngest ever to reach the pinnacle of global cricket administration.

The 35-year-old Shah, who has been the BCCI secretary since 2019, will take over from 62-year-old incumbent Greg Barclay on December 1 after the New Zealander decided against running for a third consecutive term of two years.

Shah, who is the son of Union Home Minister Amit Shah, will relinquish his position in India at the BCCI's Annual General Meeting likely to be held towards the end of next month or in October.

Shah became the fifth Indian after late Jagmohan Dalmiya, Sharad Pawar, N Srinivasan and Shashank Manohar to be elected for the high-profile job.

The Ahmedabad-based administrator, who was the sole nominee for the chairmanship, emphasised his commitment to expanding the global reach and popularity of cricket, especially with its upcoming inclusion in the Los Angeles 2028 Olympics.

"I am humbled by the nomination as the Chair of the International Cricket Council," Shah stated in an ICC release.

He also acknowledged that international cricket stands at a critical juncture and it would be important to balance the coexistence of multiple formats, promote the adoption of advanced technologies, and introduce marquee events to new global markets.

Being a powerful decisionmaker in the richest cricket board of the world, which contributes more than 75 per cent of the revenue for the global



body, Shah's election was never in doubt once he threw his hat in the ring.

It is understood that one among the powerful SENA cricket boards (South Africa, England, New Zealand and Australia) was Shah's proposer and another one of these countries seconded the nomination. And

he remained the lone contender on the last day of nominations.

As per the ICC constitution, there are 17 votes -- 12 full Test playing nations, chairman, deputy chairman, two associate member nominees and one independent female director.

That he is a likely choice was evident when he was ap-

pointed the head of ICC's most powerful sub-committee -- the Finance and Commercial Affairs (F&CA) in 2022.

The timing couldn't have been better for Shah, who would have had to go on a mandatory cooling off period in 2025 for a period of three years till 2028.

The BCCI constitution allows office-bearers to stay in office for a cumulative period of 18 years -- nine in national board and nine in state units.

But at a stretch, a person can remain office-bearer for a period of only six years after which a three-years cooling off period is necessary.

Shah, if all goes well, can have two terms in the ICC and come back to complete his remaining four years in BCCI in 2028 albeit as president of the board.

New Champions League Format Promises Everything Storied Clubs Wanted From UEFA

GENEVA: The new Champions League format this season will see more teams playing more games for more prize money.

On Thursday, UEFA makes the

draw in Monaco for the match

schedule of the new singlestandings league phase that replaces the traditional group stage. The first new Champions League format since 2003 promises more of almost everything that Europe's wealthi-

est and most influential clubs

wanted from UEFA.

There are four more places in a 36-team lineup; at least eight games each instead of six; Champions League games scheduled in January for the first time; a prize money rise of at least 25 per cent to a minimum 2.5 billion euros

(USD 2.8 billion).

There also was more evidence, at UEFA's European Championship this summer, that constant expansion of international competitions is leaving players tired and unable to perform at their best year-round.

The new league phase in European club football's marquee

event will have 144 total games compared to 96 in the group stage last season. The "key aims," UEFA said, is

to "improve competitive balance and sporting interest and in the process increase the number of meaningful matches - matches with something at stake for both sides - throughout the competition."

In the eighth and final round, all 36 teams play on the same Jan. 29 evening to finalize the standings which will decide which eight teams advance directly to the round of 16 - and with what seedings in a tennislike knockout bracket - as well as which 16 go into a new knockout playoff round in February, and which 12 are eliminated.

"We simulated that qualification should be possible with an average of 7.6 points, which means two victories and two draws," said UEFA's head of competitions strategy, Stéphane Anselmo.

WHY CHANGE SUCH A SUCCESSFUL COMPETITION?

Money, mostly, though that's not the only reason.

The Champions League in Eu-

CHAMPIONS

rope has for the past 32 years showcased the highest quality play in world football. It let UEFA steer billions of euros (dollars) of prize money to clubs who pay the highest transfer fees and salaries.

Still, influential officials at the European Club Association (ECA) got bored of the group stage, saying it was too repetitive and lacked drama. They wanted more games against stronger opponents that would be more valued by broadcasters, viewers, and new fans worldwide. Their leverage over UEFA was potentially launching their own breakaway competition.

The road to agreeing to the

format was rocky. A controversial first proposal in 2019, favoring storied clubs, was stopped by a backlash from mid-ranked clubs and domestic leagues.

There was intense turmoil sparked by the failed Super League launch in April 2021 by most of the same club officials who negotiated Champions League reform with UEFA.

Final format approval came in May 2022 - when Real Madrid, Barcelona and Juventus were exiled from the talks and still pursued UEFA in court - and it was broadly what the rebel Super League clubs had negotiated.

WHAT IS THE NEW FORMAT?

Out goes the group-stage format played for 21 seasons where 32 teams were put into eight groups of four teams from a seeded draw. The top two in each group advanced to the round of 16. Groups gave each team six games from September into December, playing each rival once at home and once away.

In comes a single-standings league - 36 teams each playing eight games against eight different opponents through January.

The top eight in the standings go direct to the round of 16 in March. Teams ranked ninth to 24th go into the knockout playoffs in February. The bottom 12 teams are eliminated.

In the playoffs, teams ranked Nos. 9-16 are seeded in the draw to play second legs at home against unseeded teams Nos. 17-24.

WHO GETS THE FOUR EXTRA PLACES?

Two for countries whose teams collectively had the best record in UEFA club competitions in the previous season. That was Italy and Germany so the fifth-placed teams in Serie A and the Bundesliga qualified: Bologna and Borussia Dortmund.

The fifth-ranked national league (based on five years of results in UEFA club competitions) gets a third direct entry. That is currently France and Brest was third in Ligue 1.

An extra place goes to the qualifying rounds path for national champions from lower-ranked countries. They now play for five total qualifying places instead of four last season.

HOW WILL THE DRAW BE DONE?

The 36 teams come out of four seeding pots graded by each team's "UEFA club coefficient" – its ranking by results in five years of European competitions. The top-seeded pot contains recent Champions League winners and beaten finalists, plus Leipzig and Barcelona.

When a team's ball is drawn, its slate of eight opponents — two from each seeding pot, one to play at home and one away — will be allocated by a software program and displayed within seconds.

Match dates will be confirmed Saturday, to avoid city clashes with Europa League and Conference League games being drawn Friday in Monaco. Those lower-tier competitions also are a 36-team single-standings league. Conference League teams play just six games.

BILLION-DOLLAR PRIZE MONEY FUND

Winning the Champions League title in 2023 earned Manchester City 135 million euros (USD 151 million) from UEFA. This season's winner can reach lion), with total competition revenue boosted by selling 189 total games instead of 125. Commercial strategy is man-

150 million euros (USD 168 mil-

aged by a UEFA-ECA joint venture, and new sponsors for the Champions League include a cryptocurrency trading platform and a betting site.

Each of the 36 teams gets a

basic 18.6 million euros (\$20.8 million), then 2.1 million euros (USD 2.35 million) for each game won and 700,000 euros (USD 782,000) per draw.

Each place in the standings is

worth more money with shares of 275,000 euros (USD 307,000) per place: 36 shares, or 9.9 million euros (USD 11 million), goes to the team finishing top in January and a single share to the last-place team.

Bonuses escalate from 11 million euros (USD 12.3 million) per team for advancing to each knockout round.

Another prize fund of 853 million euros (USD 953 million) is allocated based on teams' historical record in UEFA competitions and the value of national and global broadcast deals.
