#### **RG To Campaign For Congress in J&K** Agencies

Srinagar: Amid poll fervor in Jammu and Kashmir, the Indian National Congress (INC) has finalized a list of 120 star campaigners including the Leader of Opposition (LoP) Rahul Gandhi and other top leaders, who will be visiting the Union Territory from next month.

General Secretary of All India Congress Committee (AICC) and party's candidate for Dooru assembly segment, Ghulam Ahmad Mir stated that a total of 120 star campaigners from the party are visiting Jammu and Kashmir after September 07.

He further said that at least 40 star campaigners will be visiting Jammu and Kashmir in each phase, adding that the star campaigners include the Leader of Opposition (LoP) Rahul Gandhi and others, who will be visiting both Jammu as well as Kashmir division.

Srinagar: In accordance with the election schedule issued by Election Commission of India (ECI) for the conduct of Jammu and Kashmir Assembly Elections 2024, the scrutiny of nomination papers for 24 Assembly Constituencies which are going to polling in phase 1st was held on Wednesday, in the office of the respective Returning Officers across seven districts.

During the scrutiny of the nomination papers filed by 279 candidates, candidature of 244 candidates was found valid as per the guidelines of the Election Commission of



India, while nomination papers of 35 candidates, which were found invalid, were rejected. The 35 candidates whose nomination was rejected

#### **ECI Allocates Broadcast Time To Parties**

Srinagar: The Election Commission of India (ECI) on Wednesday allotted 'broadcast time' and 'telecast time' to political parties for campaigning on the All India Radio (AIR) and Doordarshan.

In an order, the poll-body today allotted time to nine national and state parties for campaigning on AIR and Doordarshan.

As per details, a base time of 45 minutes has been allotted to each national party and respective 'recognized state parties' in Jammu & Kashmir on the Doordarshan network and All India Radio network in the

Union Territory. The additional time has been decided on the basis of the poll performance of the party in the last assembly election of Jammu & Kashmir. The last election in Jammu & Kashmir was held in 2014.

frail frame trembles as she sits amidst the squalor, her worn chappals sinking into the damp earth beside the putrid mound of garbage. The fetid stench of rotting waste fills the air, but she doesn't flinch, her senses numbed by the anguish that consumes her. Tear-stained and red-rimmed, her eyes stare into the murky Jhelum waters, hoping her son will surface.

As she sits there, her wails pierce the desolate landscape, echoing off the trees and the half-completed bridge that looms yonder, its unfinished structure a sordid reminder of the life her son will never get to build, its presence a cruel taunt

that deepens her anguish. She rocks back and forth, her grey hair disheveled, her wrinkled hands clasped together in a futile

"Khudaya, my son! My child! Why did you leave?" she laments, her voice cracking with each sob. "What will we do without you? Who cares for us now?" The garbage mound beside her seems to mock her grief, its discarded remnants insinuating at life's fleeting nature. A tattered shoe, a broken toy, a shattered vase - each bear witness to a world that callously marched forward, indifferent to the woman's grief.

A grief that struck the village of Gandbal like thunder on



# **Study Shows Light Exercise Improves Blood Flow To Children's Brain, Improve Cognition**



erforming light-intensity exercises for a short duration was found to have improved the blood flow to children's cerebrum, known to help with cognition, according to a recent study. The study by Japan's Waseda University enrolled 41 healthy children from fifth-grade elementary to third-year junior high school students to find out how short-term, light-intensity exercises affected the blood flow to prefrontal cortex, located in the cerebrum and known to handle cognitive functions.

Researchers focused on exercises that can easily be performed on the spot without special equipment, such as stretching. Most of the exercises were performed while seated, with movements lasting 10 to 20 seconds.

The team used an imaging technique -- functional near-infrared spectroscopy -- to measure changes in blood flow to the brain by looking at concentrations of oxyhaemoglobin (that carries oxygen from the lungs to the tissues) while at rest and during the exercise.

According to the findings published in the Scientific Reports journal, the researchers found a significant increase in oxyhaemoglobin levels in multiple regions of the prefrontal cortex during all



forms of exercise compared to the resting state.

"By combining the types of exercise that easily increase blood flow in the prefrontal cortex identified in this study, it is possible to develop an exercise program that everyone can easily engage in to improve children's executive functions. It may also be used in the future to prevent cognitive decline in adults and the elderly," said Takashi Naito, one of the authors and a doctoral student at Waseda University.

The authors further wrote that the study implies that short-duration, light-intensity exercises, provided that they entail a certain degree of cognitive and/or physical demands, can activate the prefrontal cortex and in-

crease blood flow.

Previous studies have shown that physical exercise improves cognitive function in many ways such as by improving blood flow to the brain, by causing structural changes in the brain and by promoting the forming of new brain cells, or neurons.

However, as children around the world have been shown to insufficiently engage in physical exercise, leading to high levels of sedentary behaviour, the authors said that the study's results offer potential solutions.

The study is a significant step forward in combating sedentary lifestyles and activating brain functions in children, thereby supporting their physical and mental growth, they said.



# Congress Unlikely To Extend Mufti's Tenure

**\***EW DELHI - As the date draws nearer for Jammu and Kashmir Chief Minister Mufti Mohammad Sayeed to hand over the baton to a leader from alliance partner Congress, the party today sought to put an end to all speculation by indicating that the PDP leader would not be asked to continue.

Virtually putting at rest speculation that Congress might not be willing to take over the reins of the government after three years in November as per an agreement between the two coalition partners, a senior leader said the party would suffer if did it.

"It will not go down well in the party," the leader close to J&K affairs said when asked whether the Congress would let Saveed continue for remaining three years of six year term as has been suggested by some reports.

When the two parties forged post-poll alliance to form government in November 2002, they had agreed that one party would lead the coalition for three years and the other for rest of the term.

Congress, with 20 MLAs in the 87-member Assembly, had then allowed junior partner PDP, with 17 MLAs, to lead the alliance in the first phase. The Deputy Chief Minister was from Congress for the first three years and from PDP for the remaining tenure.

Although some sections in the Congress are believed to be inclined to allow Sayeed to continue, the state unit of the Congress strongly disfavours any reunification move.

The state unit feels it was the much-awaited opportunity for the Congress to have its own Chief Minister and it should not be allowed to fizzle away.

On the question of whether the Congress had an appropriate leader to become Chief Minister, the party leader said there would be no problem on this count. The Congress leader, however dismissed possibility of Mohammad Shafi Qureshi or Saifuddin Soz be given the charge as had been reported in some sections of media.

The disadvantage with Soz's candidature is that he has joined the Congress only three years back after being expelled from National Conference. Qureshi also has been out of the party for a long time

# **Polls Apart**

s the Assembly election campaign gains momentum, it is a contest between the old and the still credible regional political order and the new one created out of nowhere in the past five years. And through it all, the BJP looms large over the scene.

The old order is represented by the National Conference and the PDP as well as the Congress party, which is a national party though. The BJP's rise in the former state is a post 2015 phenomenon when for the first time it won 25 of 37 seats from Jammu division in the then Assembly elections. The BJP subsequently formed a coalition government with the PDP which secured 28 seats.

The new order is represented by the Apni Party led by the businessman-turned politician Altaf Bukhari, the DPAP headed by Ghulam Nabi Azad and the People's Conference (PC) of Sajad Lone. Although the PC is an old party, its new avatar owes itself to the political restructuring of the Valley following the abrogation of Article 370 in August 2019.

The ongoing Assembly polls are the first major electoral exercise in which the old and the new political order are face to face. Though the NC looks apparently strong and Mehbooba remains politically very much relevant, the parties have a work on hand to retain their centrality. The NC has got a head start by forging an alliance with the Congress. The PDP feels left out.

The unraveling of the Peoples Alliance for Gupkar Declaration (PAGD), reflects the deep-seated divisions within the ranks of the Valley parties. Originally formed with the lofty goal of advocating for the restoration of Article 370, the PAGD has devolved into little more than a memory, with its constituent parties failing to even convene, let alone pursue their shared objectives. The NC and the PDP, both integral members of the PAGD, have begun charting independent courses driven by their own political calculations - more so, the NC which was the first to go solo in the parliamentary elections in the Valley.

Going forward, the electoral scene looks fragmented, with many parties vying for Assembly seats. Engineer Rashid's Awami Ittehad Party and the surprise entry of the independent candidates affiliated to Jamaat-i-Islami into the fray has added a new dimension to the electoral contest. However, as of now, there is little evidence of any wave in favour of any party, albeit on paper the National Conference looks on a firmer wicket. Things could become clear in the days and weeks to come. Here's wishing the discourse to stay constructive and the situation peaceful.

# Should Government Control School Choice of the Children of Government Employees?

he Jammu and Kashmir government on August 18 said that it is discussing a proposal regarding the enrolment of wards of all government employees in state-run schools. This proposal, currently under review, was submitted by a local organization to the monitoring and grievance cell of the Lieutenant Governor's office. The initiative is a welcoming step towards equitable education and can catalyse systemic reforms in the public education system of Jammu and Kashmir.

#### Some calls in past for such initiative across India:

There have been numerous calls in past across India to make it mandatory for government employees to send their children to government schools from time to time. In 2014 verdict of the Uttar Pradesh High Court, delivered by Justice Sudhir Agarwal, the court directed that all government officials, including those in the judiciary, executive, and public representatives, must send their children to governmentrun primary schools. The court emphasized that if the children of government officials attended these schools, there would be a significant push to enhance infrastructure, tea standards, and overall school management, ultimately benefiting all students. The judgment highlighted the disparity in education quality between private and public schools and sought to reduce this gap by making education a shared concern among all societal segments. Like the judiciary there have been similar calls from legislative and executive. In 2016 Deputy Speaker of Goa Legislative Assembly Vishnu Surya Wagh said that, government should make it compulsory for all its employees and teachers to admit their children to government primary schools (GPS) and not in private primary schools in a bid to improve their standard. Similarly, in 2018, Chief Minister Yogi Adityanath encouraged government teachers to enroll their children in government schools operated by the Uttar Pradesh Basic and Secondary Education Boards. Speaking on Teachers' Day, he stated, "Government teachers should send their children to government schools instead of convent or private institutions. Sending your kids to private schools while being a government school teacher casts doubt on your own capabilities. In 2017, in response to the declining enrollment and closure of government schools, a seven-member committee led by the Karnataka Development Authority (KDA) has advised the Siddaramaiah government to mandate that all government employees and elected representatives enroll their children in government or aided schools. There have been numerous such calls from different quarters, highlighting need of taking such crucial steps to improve the state of education in government schools in India.

The government would need to ensure that public schools are sufficiently upgraded in terms of infrastructure, teaching quality, and extracurricular offerings before the policy is fully implemented. Moreover, the government would need to establish a monitoring mechanism to ensure that the policy, if approved, is

This increased accountability could lead to more effective policy implementation and resource allocation. It could also foster a culture of excellence and high performance in public schools, as the involvement of government employees in the education of their children might lead to the introduction of more innovative and modern teaching practices.

In contrast, unlicensed influencers operate without oversight, leaving their followers vulnerable to advice lacking in scientific validity or clinical relevance. The absence of accountability mechanisms poses risks of unchecked harm, as influencers face minimal consequences for disseminating inaccurate or harmful content. Of course, it should be noted that possessing a degree and license does not immediately absolve individuals of the potential for harm, but this form of gatekeeping is crucial for ensuring that mental health guidance adheres established to ethical standards and evidence-based practices. Licensed professionals are subject to rigorous training, supervision, and accountability measures designed to protect clients and maintain the integrity of mental health practices, which helps to mitigate the risks associated with unregulated and unqualified advice.

Ensuring the information you find online about mental health is helpful and reliable involves

tal health, substance use, trauma experiences, and other issues. According to the World Health Organization (WHO), mental health problems are increasing annually. As many of those who report increased mental health symptoms of depression and anxiety are younger people, it comes as no surprise that many are getting their mental health information on social media (World Health Organization, 2022).

However, alongside legitimate professionals, a concerning trend has emerged: the rise of unlicensed and uncredentialed mental health influencers. A quick search for terms like "anxiety," "depression," "narcissistic abuse support," and even "self-harm" yields hundreds, if not thousands, of unlicensed and uncredentialed coaches and influencers claiming to assist those looking for support. These individuals, while often well-meaning, tend to lack formal qualifications and oversight, posing significant risks by disseminating inaccurate or even harmful advice. Not ironically, research shows that there is a link between an increase in social media use and increased mental health symptoms (Beyari, 2023). Here are some of the risks of unlicensed influencers spreading mental health information on social media:

Lack of qualifications and expertise

One of the primary concerns surrounding unlicensed mental health influencers is their lack of formal qualifications and expertise. Unlike licensed mental health professionals who undergo rigorous education, training, licensure processes, and accountability, influencers may lack the clinical knowledge and skills necessary to provide accurate and evidence-based guidcomplexities of mental health disorders and individualized treatment needs. Research shows that the spread of false or misinformation is a real problem on social media, and this can lead to harm if people unknowingly absorb and follow information that is false (Shearer et al., 2024).

#### Spread of false information and misinterpretation

The unchecked nature of social media allows misinformation to proliferate presented as credible advice influential bv figures. Unlicensed mental health influencers may inadvertently perpetuate myths or misconceptions about mental health conditions, treatments, and recovery processes (Shearer et al., 2024). Such misinformation can undermine public trust in evidence-based practices and deter individuals from seeking appropriate professional help, potentially exacerbating their mental health challenges.

### Ethical concerns and harmful advice

Ethical guidelines and standards of practice are integral to responsible mental health advocacy and support. Licensed professionals adhere to ethical codes that prioritize client welfare, confidentiality, and informed consent.

In contrast, unlicensed influencers may promote unproven treatments, advocate for risky behaviors, or exploit vulnerable individuals seeking guidance. This lack of ethical oversight

Social media platforms provide a global platform where vulnerable populations, including adolescents, individuals in crisis, and those with limited access to mental health resources, seek information and support. An example of this is the Queer teenager who is unable to come

### Undermining trust in mental health professionals

The proliferation of unlicensed mental health influencers can erode public trust in qualified professionals and evidencebased practices. Misinformation propagated online may create skepticism toward established treatments, therapies, and the credibility of licensed practitioners. This skepticism can deter individuals from seeking culturseveral key steps:

#### 1. Check the source.

Is this person/group qualified to make these claims? Check the credentials and qualifications of the individual or organization providing the information. Look for details such as professional affiliations, degrees, certifications, or licenses in mental health fields.

This does not mean that someone needs a degree or a specific amount of letters after their name in order to be educated in a given topic, nor does it mean that those of us with degrees and certifications are exempt from spreading false or misleading information. However, it can give you an idea of the person's background and goals for posting.

#### 2. Check the messaging.

Be cautious of sensationalized or overly simplistic explanations of complex mental health issues, as well as claims of "miracle cures" or quick fixes without scientific backing. For example, be wary of someone who seems set on revenge and who is spreading information about narcissism or similar conditions. This does not mean that they were not victimized, but that their messaging is likely that of one who is in a specific stage of their healing that might not resonate with you.

#### 3. Compare and cross-check.

Cross-check information across multiple reputable sources to ensure consistency and reliability. Look for consensus among experts in the field regarding treatment approaches, symptoms, and outcomes. Do not take only one person's words at face value—if there is validity in their claims, others will be saying similar things.

The incomplete Gandbal-Batwara bridge has become a menacing reminder of the catastrophe with its unfinished design constantly nudging the memory of the local people, twisting the knife in their wounds and persisting them into agony and sorrow of the acutest kind.

Meanwhile, the residents of Samarbugh, Lasjan, a kilometer away from Gandbal, express the fear that their locality is grappling with post the Gandbal tragedy. With their own reliance on a ferryboat service to cross the river, they can't help but feel a sense of shared vulnerability and heightened concern for their safety.

Waseem Magray, a resident of the area, voices his concern.

"The authorities attributed the Gandbal tragedy to a swollen Jhelum due to incessant rains. But the truth is, Kashmir's weather has become increasingly unpredictable, with frequent bursts of torrential rain. The Jhelum swelling is no surprise to us. Our fear is that we'll suffer the same fate as the people of Gandbal."

Magray shares how the Gandbal tragedy has led to a surge in parental anxiety, with many becoming overly cautious and protective of their children. In the wake of this devastating incident, they cannot bear the thought of putting their children's lives at risk, no matter how small the chance, and are therefore taking extra precautions to ensure their safety. The unbearable thought of their children meeting the same fate as the Gandbal children, who lost their lives in the tragic accident, has made them resolute - they can no longer tolerate the deprivation of a bridge and are demanding action to ensure their children's safe passage. Showkat Ahmad Kuchay, another

local markets wear a subdued air, as traders and customers alike are preoccupied with the nagging fear of the unknown. The children too, have grown accustomed to this atmosphere of apprehension, their laughter and play punctuated by the constant fear of an impending danger. Their parents' concerns have grown into their own as they traverse the perilous terrain of their everyday existence, constantly watching over their shoulders and forever wondering as to when calamity may strike.

Er. Rajandar Kumar Gupta, the Superintending Engineer of R&B Circle, Srinagar South, addresses concerns regarding the repeated delays in completing the Gandbal-Batwara bridge, which has missed several deadlines. He explains that the delays were not due to negligence but rather due to a combination of challenging circumstances.

The weather has been unpredictable, which has significantly hindered the progress. The work on this bridge is highly technical, and while officers may set deadlines in response to public demands, it is the laborers and masons who face the real challenges on the ground," Gupta states.

He highlights that logistical difficulties also played a major role in the delays.

"There was no available space to store materials like steel etc. Our workers had to weld every joint and angle iron directly on the bridge, which made the process more timeconsuming and tedious. Even now, as we prepare to lay the slab, we are facing issues. There's no space to unload the necessary materials, and with tippers being restricted during the day, it has become even more difficult to meet the planned schedule."

However, despite these challenges. Gupta expresses optimism about the project's completion.

"According to our current progress, the bridge's completion seems to be just around the corner. We are working diligently to overcome the remaining obstacles, and it looks like the bridge will be open to public use by early September.'

However, he declines to comment on the Samarbugh bridge, stating that it is not under their jurisdiction.

The Gandbal-Batwara or the Samarbugh bridges are not the only ones caught in the quagmire of neglect. Across the length of the Jhelum, numerous bridges were planned, intended to link the two banks of the river for both pedestrians and vehicles, promising to ease transportation, foster economic growth, and unite communities. Yet, many of these bridges, like the afore-mentioned, are languishing in various states of disrepair and their incomplete structures serving as striking symbols of a broader systemic failure. In the past decade, the government announced ambitious plans to construct several bridges over the Jhelum, envisioning them as arteries of progress that would revitalize the region. These bridges were to be lifelines, connecting remote villages with the bustling markets and educational institutions on the opposite bank, reducing the travel time, and enhancing the quality of life for thousands. However, reality has painted a different picture. Out of the numerous bridges planned, only a handful have been completed, and those that stand today often do so in isolation, their counterparts on neighboring stretches of the river remaining incomplete or abandoned. According to official data from the Roads and Building Department (R&B), the construction of over 15 crucial bridges and approximately seven footbridges remains unfinished, despite work having started more than a decade ago. This widespread stagnation reflects a deeper issue within the region's infrastructure development, where numerous projects intended to connect communities and enhance daily life have instead been put on ice, leaving residents stranded and frustrated. Sajad Naqeeb, Chief Engineer of R&B Central Kashmir reveals that the department has launched an initiative aimed at completing the numerous bridges that have been left unfinished assuring that the work on these languishing projects will be completed within the 2024-25 fiscal year. This initiative follows a significant decision made by the Jammu & Kashmir government in 2018 to address the issue of stalled infrastructure projects. To tackle the problem of projects abandoned due to a lack of funds, the government established the Jammu and Kashmir Infrastructure

Development Fund Corporation (JKIDFC). Through this fund, the R&B department identified 622 languishing projects across all districts, approving them at a cost of Rs 1446.73 crore. This strategic move was intended to revive these critical projects, including many of the bridges that have been on the back burner for years, and bring them to completion for the benefit of the local communities.

The Gandbal-Batwara bridge is just one example of a project awaiting action, but it epitomizes a much larger issue-the disconnect between the promises made and the promises kept. Moreover, it illustrates how infrastructure profoundly shapes and impacts human lives.

Basharat Hussain, a volunteer who helped distribute food items with NGO Athwas in the aftermath of the Gandbal tragedy, has borne witness to the anguished wails of those searching for their loved ones. As a father of two himself, Basharat can't fathom the unbearable pain of losing a child. Consumed by outrage at the systemic failures that led to the tragedy, he speaks out with a sense of urgency and conviction.

"The narrative of the incomplete bridges is not just about infrastructure; it's about the broken promises that these structures represent. It's about the gap between the two banks of the Jhelum that remain unbridged, not just by steel and concrete, but by trust and accountability."

Hussain adds "The people have been waiting for years, and with each passing day, the question becomes more urgent: When will the government finally make good on its promises? When will the bridges that were meant to connect, to protect, and to uplift, finally serve their intended purpose?

Among other things, the Gandbal tragedy has imparted a crucial lesson: Infrastructure is beyond concrete projects because it is what connects communities, drives economic growth, and ensures the safety and well-being of the population. When infrastructure projects are left incomplete, they do more than just mar the landscapethey disrupt lives! The roads that should have made travel easier, the bridges that were supposed to bring people closer together, and the schools and hospitals that were meant to serve the community—all become symbols of unfulfilled potential and lost opportunities. Stalled development projects strand communities in a cycle of stagnation, compelling residents to contend with unsafe roads, rely on outdated facilities, or make do without the essential services that they deserve. These projects, intended to be catalysts for progress, instead become barriers that hold people back, limiting access to education, healthcare, and economic opportunities. In the light of the Gandbal tragedy and the broader implications of infrastructure on human lives. Sociologist Dr. Nousheen Fatima observes that the gap between promises and reality goes beyond broken commitments; it is a profound matter of social justice. 'This disparity hits hardest on those who are already marginalized and vulnerable—people who can't afford to wait another year for a bridge to be finished or another decade for a hospital to open," she explains. "For them, infrastructure isn't just about convenience; it's a critical factor that directly shapes their lives and determines their futures."

Similarly, in Pulwama district. nomination papers of 14 candidates were accepted in Pampore AC; 10 candidates in Tral AC; 12 candidates in Pulwama AC; and 10 candidates in Rajpora AC.

In Shopian district, a total of 10 nomination papers were found valid and accepted in Zainapora AC; while nomination papers of 11 candidates have been accepted in Shopian AC.

In Kulgam district, nomination papers of 6 candidates were accepted in DH Pora AC; 10 candidates in Kulgam AC; and 10 candidates in Devsar AC.

Finally, in Anantnag district, a total of 12 nomination papers were found valid and accepted in Dooru AC; 10 candidates in Kokernag (ST) AC; 10 candidates in Anantnag West AC; 13 candidates in Anantnag AC; 3 candidates in Srigufwara-Bijbehara AC; 13 candidates in Shangus-Anantnag East AC; while nomination papers of 6 candidates have been accepted in Pahalgam AC.

As per the Election notification, the candidates can withdraw their nomination by 30 August, 2024 (Friday) before 03:00 pm in the office of the respective Returning Officers.

Kuchay grumbles, "This bridge, for instance, has been 'under construction' for 13 long years", his gaze fixed on the bridge as he recalls thirteen years of broken promises, delayed deadlines, and of lives put on hold.

While showing off his hair, another man gripes, "My entire hair was jet black then. Now, I'm married, my kids are grown up, and I'm going grey, but the bridge remains unfinished."

Just then, a wise-cracking Sardar ji, with a mischievous glint in his eyes, chimes in, his voice dripping with sarcasm, as he breaks into a witty ditty:

Taxes Jaari, jab aati public ki baari. Par jo government ki zimmewari, wo padhti hai unpe bhari!

(Taxes are imposed, when it's the public's turn.

What is the government's responsibility, falls heavily on them!) In the midst of this chaos, a young

girl's voice breaks through the commotion. She stands on the riverbank and ut-

ters a powerful cry for justice. "We shall not be silenced. We shall

not be ignored. We demand a bridge, we demand a future."

For the residents of Gandbal and Samarbugh, infrastructure isn't just about roads and bridges-it's about the peace of mind that comes with knowing that their loved ones are safe. The bridge's incompletion means that daily commutes, simple as they may seem, are fraught with anxiety and fear. Parents, like those in Gandbal, who now live in constant fear of another tragedy, are forced to take extra precautions, altering their daily lives in profound ways. The lack of proper infrastructure has seeped into the very fabric of their lives, affecting their mental health and altering their behavior.

As the days turn into weeks, and the weeks into years, the weight of this uncertainty bears down on the local people, leaving an indelible mark on their collective psyche. The streets of Gandbal and Samarbugh echo with the whispers of worry, as families huddle together, sharing stories of near-misses and narrow escapes. The

Dr. Fatima further notes that infrastructure is about more than just building roads or bridges.

"It is about building better lives and ensuring that every person has access to the opportunities and services that they need to thrive. When infrastructure projects are left incomplete, it is not just the physical structure that remains unfinished but the promise of a better life that is left hanging, just out of reach."

While workers toil on the Gandbal bridge, newspapers lament the missed deadlines, and social media buzzes with debates over the tragedy's haves and have-nots, the old woman still sits by the Gandbal banks from dawn to dusk as a matter of routine, waiting for her son's body to surface. As the sun approaches the horizon, she rises, her joints creaking from age and the stiffness of prolonged sitting. She casts one last glance at the incomplete bridge before turning back toward the village, gasps and whispers a prayer, "May the bridges we build connect not just our lands, but our hearts. May they bring us closer to the lives that we deserve!" With that, she fades into the twilight, leaving behind a river that continues to flow and a bridge that stands unfinished.

# **SEHAT Scheme: HC Allows Govt's Plea Against Insurance Company**

**M** Ahmad SRINAGAR: The High Court of

J&K and Ladakh has temporarily directed IFFCO TOKIO General Insurance Company Limited to continue with the existing arrangement as regards Ayushman BharatPradhan Mantri Jan Arogya Yojana-SEHAT to allow J&K government to provide free of cost Universal Health Coverage to all its residents, including the serving and retired employees and their families. ...petitioner (Union Territo-

ry of J&K) has succeeded to make out a prima facie case for grant of interim measures in terms of Section 9 of the Arbitration Act and since contract between the parties is service of insurance, balance of convenience favours the grant of injunction," a bench of Justice Rajesh Sekhri said while allowing a petition by the government stating therein that the insurance contract between the parties (Government through State Health Agency and IFFCO TOKIO General Insurance Company Limited), is for a period of three years and the Company having already extended the insurance cover for the second year, in terms of clause 9 of the contract, cannot turn around and wriggle out of the contract for the third year extension and "plunge the people of UT into risk and uncertainty."

"The damages, which may be suffered by the State Health Agency, in general, and the beneficiaries of the Scheme, in particular, on account of alleged breach of contract by the insurer, may not be compensated at a future point of time in terms of money or otherwise,' the court said, adding, "Hence, present petition is allowed and respondent (Insurance Company) is temporarily directed to continue with the existing arrangement as per terms and conditions of the contract agreement pending resolution of dispute by the Arbitrator." The government contended

that since the law with respect to insurance is part and parcel of a welfare legislation, "arbitrary" exit notice served by the insurance company was not only against the contractual liabilities, but also against the public health and safety at As noted by the Hantri Jan Arous large

provide free of cost Universal Health Coverage to all its residents, including the serving and retired employees and their families. The Scheme is intended to provide same benefits those were available under Ayushman BharatPradhan Mantri Jan Arogya Yojana ["AB-PMJAY"], a Government of India Scheme, that is providing annual health insurance cover of Rs.5.00 lacs per family on a floater and cashless basis through an established network of health care providers. Pertinently, the Scheme came to be introduced by the Government with the object to reduce catastrophic health expenditure and to improve access to quality health care of the domiciles of UT, the court noted. The eligible beneficiary families, under this Scheme are to be provided the Health Coverage through a network of Empanelled Health Care Providers (EHCPs). The Government decided to implement the Scheme to provide Health insurance to defined categories of families eligible in the UT of Jammu and Kashmir. As a result, bidding process was commenced, through State Health Agency (SHA) by issuing the tender document and the IF-FCO TOKIO General Insurance Company Limited emerged the successful bidder. Consequently, a contract, for maximum period of three years, came to be executed between the parties on 10 March 2022. Since the beneficiary families are to be provided the Health Coverage through a network of EHCPs, the court noted, a separate Tri-

partite Agreement also came to be executed between the parties and EHCPs in terms of clause 6 of the contract. As per the government, con-

tract between the parties is to subsist till 14th of March, 2025, but the Insurance Company vide its letter dated 01.11.2023, served a notice that it was not interested in further renewal of the contract after the expiry of the policy period ending 14.03.2024. In response to the communication, the Chief Executive Officer, SHA, vide communication dated 03.11.2023 requested the company to continue as per the MOU signed between the par-

ties. However, the Insurance company vide communication 16.11.2023 reiterated dated that it has decided not to accord consent for renewal of the contract beyond 14th of March, 2024 and will not issue any new policy cover beyond the existing policy cover period and requested that SHA had enough time to make arrangement so that beneficiaries may not suffer. The CEO, SHA vide communication dated 07.12.2023 again requested Vice President of the company to re-consider its decision, however, the respondent vide communication dated 13.12.2023 informed the CEO that it stand by its decision not to continue. Again the Government through CEO, SHA vide letter dated 28.12.2023 requested Vice President of the Company to adhere to the terms and conditions of the contract in letter and spirit, however, it was conveyed by General Manager of the Company, vide its communication dated 03.01.2024 that Company is only invoking clause 9.1(c)of the Insurance contract. Ultimately, the SHA, by invocation of clause 41.3 of the contract, vide communication No. SHA/ ABPM-JAY/2023-24/5334 dated 19.01.2024 served a notice upon the company, for refer-

ence of dispute to the Arbitral Tribunal with a request to nom-

inate an Arbitrator on its behalf.

reads, "The directors are requested to furnish the complete lists of all erring lecturers (School wise) in whose favour the result of 10+2 examination for the academic session, 2023-24 has been found and reported poor or unsatisfactory in violation of standing norms."

"The requisite details shall be furnished to this department within two days in view of the seriousness of the issue," it reads.

Earlier, in June the School Education Department had attached a principal of Higher Secondary School to the CEO office for poor performance in the recently announced results of 12th standard.

Directorate of School Education Jammu (DSEJ) in an order had said that no students in that Higher Secondary School had qualified the exams. DSEJ had also said that it

had asked all the CEOs of the division to furnish the result report for class 12th to the directorate.

"The CEO Rajouri has reported that zero percent result has been shown by the HSS Behrote Thannamandi wherein a total number of 13 students had appeared-13 in the exams and none of them had cleared it," DSEJ said-(KNO)


