2350 Permissions Given To Parties, Candidates

Srinagar: Upholding the Democratic Principles of Free, Fair and Transparent Elections for the forthcoming Jammu and Kashmir Assembly Election, 73.94% permission requests from the political parties and contesting candidates have been accepted since the electoral process commenced in the Union Territory, the office of the Chief Electoral Officer, J&K said on Tuesday.

A total of 3178 cases of permission requests were received for General Elections to Legislative Assembly in Jammu and Kashmir by various competent authorities, an official statement said, adding that out of these, 2350 permission requests which were completed in all respects were accepted by the Competent Authorities.

Hajj 2025: Application Deadline Extended

Srinagar: Following public demand, the Haj Committee of India (HCoI) on Tuesday extended the deadline for submitting online applications for Hajj 2025 until September 23, 2024.

This extension was announced through a circular issued by the HCol, a copy of which lies with Kashmir Observer.

The circular states that applications for Hajj 2025 were initially invited from August 13, 2024, to September 9, 2024, at 11:59 PM. "Considering popular demand, the Competent Authority in the Ministry of Minority Affairs is pleased to extend the last date for submission of Haj Application Forms (HAF) to September 23, 2024, 11:59 PM," it reads.

Afzal Guru's Brother To Contest From Sopore

Srinagar: Aijaz Ahmed Guru, brother of the parliament attack convict Mohammed Afzal Guru, on Tuesday announced his decision to contest the upcoming assembly elections from the Sopore constituency as an independent candidate.

Afzal Guru was hanged 11 years ago in Delhi's Tihar Jail.

Aijaz said his son's arrest was a key reason for entering the political fray. His son, Shoaib Aijaz Guru, was arrested by Baramulla Police on drug-related charges and booked under the Public Safety Act (PIT NDPS Act) in December 2023. Shoaib is currently lodged in Central

Jail, Kot-Bhalwal, Jammu.

Aijaz expressed concerns over what he claims to be a "fabricated case" against his son and vowed to fight for those similarly arrested under questionable circumstances.

Can Iltija Preserve The Mufti Family's Legacy In Bijbehara?

Srinagar: In the political heartland of Bijbehara, a town steeped in history and renowned for its towering Chinar trees, the battle for one of Jammu and Kashmir's most coveted electoral seats is intensifying.

Iltija Mufti, the third-generation leader of the Mufti family, is campaigning vigorously to retain a seat that has produced two former chief ministers. But the million-dollar question remains: can 37-year-old Iltija secure her grandfather's bastion this time around?

Bijbehara, often referred to as "Chinar Town" due to



its abundance of the majestic trees, is not just a political stronghold — it is the home turf of the Mufti family, a seat that the People's Democratic Party (PDP) has held since 1996.

This time, the contest is shaping up to be a family feud of sorts, with Iltija Mufti representing the PDP, and Dr. Bashir Veeri, son of Abdul Ghani Veeri, standing for the National Conference (NC). JKCA Case: ED Seeks Fresh Charges Against Dr Farooq

Srinagar: The Enforcement Directorate has filed an application before a court in Srinagar seeking addition of two fresh criminal charges against former chief minister Farooq Abdullah and others in the JKCA money laundering case that was quashed by the Jammu and Kashmir High Court last month.

Official sources said the agency recently submitted its plea before the court of Principal District and Sessions Judge praying for addition of IPC sections 411 (dishonestly



receiving stolen property) and 424 (dishonest or fraudulent removal or concealment of property) in the case related to alleged financial irregularities in the Jammu and Kashmir Cricket Association (JKCA).

The move by the federal agency comes after the Jammu and Kashmir High Court quashed its case and charge sheet against Abdullah and some others on August 14 saying the offence of money laundering was not made out.

The high court, however, allowed the ED to "canvass" its case before a local court seeking addition of fresh IPC sections and if it decides to frame charges against Abdullah and five others for any | More on P6

Harmukh-Gangbal Yatra Begins In Ganderbal

Srinagar: The 16th annual Harmukh-Gangbal Yatra—a three-day customary traditional Hindu pilgrimage—began in the central Kashmir's Ganderbal district on Tuesday amidst religious fervor.

Located at an altitude of 14, 500 feet above sea level from the Naranag area of Kangan hamlet in Ganderbal district is revered by Kashmiri Pandits as the abode of Lord Shiva.

After performing a special Puja, a group of pilgrims, mostly Kashmiri Pandits,

headed for Gangbal Lake from the Naranag base camp led by the State Disaster Response Force (SDRF), marking the beginning of the three-day annual Hindu pilgrimage amidst religious fervor.

The Yatra was formally inaugurated by Deputy Commissioner (DC) Shyambir Singh and Senior Superintendent of Police (SSP) Ganderbal Waseem Oadri.

Low-Carb Diets Meet Nutrient Needs: Study

Low-carb diets can meet and sometimes even exceed one's nutrient needs, according to a study that examined the scepticism around the nutritional quality of such diets.

Commonly recommended for diabetic patients to manage their sugar levels, low-carb diets restrict the intake of foods high in carbohydrates or added sugar, including sweets, starches, and refined grains.

While low-carb diets have been shown to provide health benefits, including weight loss, researchers said scepticism remains around the nutritional quality of low-carb diets.

Some argue that cutting down on carbs leads to overconsuming protein or fat and under-consuming essential nutrients, the team, including researchers at the University of Vermont, US, said.

For the study, published in the journal Frontiers in Nutrition, they assessed the nutrient adequacy of three different seven-day low-carb meal plans. Two were ketogenic diets - - one that averaged about 20 grams of net carbs per day, while the other av-



eraged about 40 grams of net carbs per day. The third was a more liberal meal plan that contained an average of around 100 grams of net carbs per day.

"All three low-carbohydrate meal plans exceeded recommendations (US) for vitamins A, C, D, E, K, thiamin, riboflavin, niacin, B6, folate and B12 in males and females in the age group of 31-70 years and exceeded calcium recommendations for adults in the age group of 31-50 years," the authors wrote.

"Our findings suggest that, in addition to their well-established ability to support weight management, lowcarb eating patterns can actually help promote better diet quality and close critical nutrient gaps," co-author Beth Bradley, from the University of Vermont, said.

For certain sub-section of the population — such as younger women requiring higher amounts of iron or older people needing more calcium the low-carb meal plans fall slightly short in a few nutrients, the researchers said. Further, they found that two of three meal plans in the study - those containing 40 grams and 100 grams of net carbohydrates, respectively - also provided more than enough fibre for women aged 31-70 years.

While some low-carb diets are known to be also low on fibre, the researchers said the results do not support the idea.

"The idea that a low-carb diet must also be low in fibre is simply not supported by the data. High-fibre foods are actually an important part of a lowcarb lifestyle, in part because fibre-rich food choices can help lower net carbohydrate intake," Bradley explained. "Non-starchy vegetables, nuts

and seeds, and, in moderation, even higher-carb fruits, starchy vegetables and whole grains can contribute fibre to the diet while keeping overall net carb intake in check, especially in the more liberal low-carb approach," the co-author said. The researchers added that the low-carb meal plans provided more protein than needed to prevent deficiency, with-

out delivering an excessive

amount that could be unsafe.

'Efforts To Conserve 0.7% Of World's Land Could Protect A Third Of Four-Limbed Vertebrates'

Ionserving just 0.7 per cent of the world's land could help protect a third of the threatened four-limbed vertebrate species, including the gharial, a long-snouted and critically endangered crocodile found in the Indian subcontinent, according to a new research. Researchers said that large gains in

conservation can be made by focusing on regions home to exceptional biodiversity and, unique and endangered species, termed 'Evolutionarily Distinct and Globally Endangered (EDGE) spe-

Being evolutionarily distinct indicates how unique a species is, while global endangerment reflects how much at risk of extinction a species is. Species scoring high on both measures are known as EDGE species, and the areas where they are found in more numbers are EDGE Zones, the team, led by researchers at Imperial College London,

The authors mapped the distribution of almost 3,000 EDGE species. Specific areas where richness in EDGE species was found include large parts of Southeast Asia and the Indo-Gangetic plain, the Amazon basin, among others.

The authors, however, found that only 20 per cent of the areas included in the study are under some form of protection, with most areas facing consistent and increasing levels of human pressure. The findings are published in the journal Nature Communications.

Maximum richness in EDGE species was found within an area of less than 100 square kilometres in Madagascar, containing the highest number of EDGE species, along with Mexico and Indone-

"Our research highlights the regions of the world that are of immediate concern. Furthermore, it shows that in protecting just a fraction of the Earth's land surface, huge gains can be made for the preservation of nature," lead author Sebastian Pipins, from Imperial

College London, said.

Pipins said it was crucial to just consider diversity in species for conservation efforts, but also the history of how the species evolved, "to ensure that large and unique branches from the tree of life are not lost."

The researchers found that over 75 per cent of the EDGE species exist within a single country and underlined the critical importance of national leadership to support conservation efforts.

"Three-quarters of the world's most unique animals are able to call only one country home, meaning that action from individual nations will go a long way to protect these incredible species from extinction," co-author Rikki Gumbs, from the Zoological Society of London, said.

Very large areas of Southeast Asia have higher levels of EDGE species, which the researchers said reflects how the looming biodiversity disaster in this region is impacting the highly unique and wide-ranging species found with-

Census Held Up, Div Com Cajoles Union Leader

RINAGAR: The second and final Phase of the census operation in Kashmir, scheduled to begin today, failed to take off with most government employees detailed for the purpose not reporting for duty following militant threat to eliminate those taking part in the exercise.

Director census of Jammu and Kashmir Feroz Ahmad said

he had not received any information about the progress of the operation till 1500 hours, today. He said the operations had begun in Jammu and Ladakh regions. "I can't say if the operation had begun in Kashmir valley. I can't even say that the operation had not begun at all", he told reporters.

However, he said the job of the directorate of census is to

However, he said the job of the directorate of census is to dispatch the material to the concerned wards which has been completed in time. In Srinagar, the material had not been received by the staff in 15 segments, He said the position would become dear in a few days.

Official reports reaching here said the employees did not receive the material and did not take part in the operation.

But officials in the divisional commissioner's office here claimed, that, employee turned up to collect the census mate-

rial in Budgam. Anantnag and Kupwara districts.

"The exact information from all over the Kashmir valley is not known, especially in Srinagar", the officials said adding the director-of census has been summoned to obtain informa-

tion about progress of the operation.

A PTI reporter who visited the directorate of census and other areas in the city found that out of 98 employees in Brain-Nishat in ward number one, only five employees turned up to

receive the material for the area.

Two prominent government employees unions, State Employees Con-ference and Employees and Workers Confederation had directed the staff not to endanger their lives by participating in the operation in view of militants' threat to train their guns on those taking part in the exercise.

Over 22,000 enumerators were trained to conduct the census, to be concluded on September 30, he said adding the first phase was undertaken from May 16 to June 5 this year. House listing with the civic and other amenities available at the household and locality levels was done during the first phase which, however, went off without any problem.

An official handout issued here today said the divisional commissioner had a detailed discussion with the representatives of some employees' organisations and assured them the government would take all possible steps to ensure their security. The statement claimed the representatives informed the divisional commissioner that "they had neither issued any statement to boycott the census duty nor have intention to do so".

A Dramatic Twist

n a potentially game-changing move, the Supreme Court on Tuesday released Awami Ittehad Party chief Engineer Rashid on bail. There was some build up to the release though, with a section of public opinion agog about the widely anticipated development. Now that Rashid's temporary release has come about, the attention has shifted to the ongoing electoral arena in Kashmir Valley, which is likely to change profoundly with his arrival on the scene. Ever since he won parliamentary election from Baramulla early this year garnering over 4.5 lakh votes, Rashid's political profile has become almost equivalent to his competitors in the Valley. He is now seen as a major threat to the political dominance of the National Conference and the PDP. And this seems for real now. Four and a half lakh people who voted for him form a majority across almost 15 of the 18 Assembly constituencies in North Kashmir. Should the momentum his party built in the parliamentary election carry over to the ongoing election, Rashid could potentially sweep North Kashmir, making him a powerful player in the 90-member J&K Assembly. He could also be a challenge in central and South Kashmir, should his party decide to contest from there. During Lok Sabha, elections, Rashid was seen as a politician who stood up to New Delhi following abrogation of Article 370 and chose jail to surrender as others are perceived to have done.

In August 2019, soon after the withdrawal of J&K's special constitutional status, he was arrested by the National Investigation Agency (NIA) in a case of terror funding. The incarceration brought him a wave of sympathy during the parliamentary election when his sons Abrar Rashid and Asrar Rashid mounted a spirited electoral campaign. Rashid's was a wild card entry at a time when the contest seemed to be evenly split between the former chief minister Omar Abdullah and the People's Conference chief Sajjad Lone. They were considered the only serious candidates in the fray in North Kashmir at the time. But Rashid's decision to contest which came late in the day changed everything. The victory has made him a far bigger leader in the Valley than he has been so far. Will he be able to replicate his party's frenzied Lok sabha election campaign in the ongoing Assembly polls? It can be anybody's guess. The general expectation, however, is that he is likely to do so. His release will certainly give his party the headstart it desperately needed. Unlike the Lok Sabha election, the AIP now has many faces contesting the Assembly polls, and some of them do have baggage. Will Rashid be able to retain focus of the campaign on him only? Will he be able to override the baggage of some of his candidates? Will he be able to dispel the creeping suspicions about his own agenda that may haunt his unexpected release? Beside the early public euphoria that may follow his return to Kashmir, his success in the election will depend on how credibly he is able to convince people of his bonafides.

Understanding the Plight of Teachers

Contractual lecturers should not be at the mercy of the colleges where they are easily shown the door at any point of time

'n the heart of our educational system lies an unwavering dedication among teachers, whose commitment extends far beyond the classroom. The dedication of teachers is evident in the countless hours they spend preparing lessons, grading assignments, and participating in professional development etc. Their influence often extends into the lives of students, shaping their values, ambitions, and critical thinking skills. Without any exaggeration, teachers invest deeply in the personal and academic growth of their students.

Despite their critical role, teachers today face a multitude of challenges that complicate their work. There is lack of sufficient funding in many educational institutions. This shortfall results in inadequate resources and outdated facilities, which can easily hinder teachers' ability to deliver highquality education. The workload nowadays for teachers in most of the institutions has also increased dramatically. This extra burden can easily lead to burnout of the worthy teachers, affecting their overall effectiveness as promising teachers. The job security of some teachers remains precarious. Contractual and temporary teachers often face uncertainty about their employment status, which heavily undermines their morale and long-term commitment. Compounding this issue is the disparity in pay between regular and contractual teachers. There is also difference in pay between Govt. sector and private sector teachers. This inequity not only affects the financial stability of educators but also impacts their motivation and performance. Additionally, societal expectations and challenges, further complicate the teaching environment. The situation in Jammu and

Kashmir offers a stark illustration of these broader issues. A recent case has brought to light the struggles of contractual lecturers from the region. One PhD scholar/contractual lecturer has resorted to selling dry fruits on the roadside after facing difficulties securing a stable academic position. This individual's experience reflects a troubling reality: despite years of advanced education, experiences and dedication to the field, many educators in Jammu and Kashmir find themselves without reliable career prospects. The contractual lecturers should not be at the

mercy of the colleges where they point of time. Earlier the yearly contract was little justified and reasonable. The lack of adequate support and recognition for educators in the region highlights a systemic problem that extends beyond individual experiences. The disparity in treatment between regular and contractual teachers is particularly pronounced, with many facing lower pay and job insecurity despite their significant

contributions to education. This inequity creates a demoralizing environment that undermines the commitment and effectiveness of

teaching staff. From the experiences of teachers and the recent case in Jammu and Kashmir, several important lessons emerge. Firstly they (contractual teachers) must also not give up. Life every day is a test and be prepared with positivity. For teachers, maintaining resilience and adaptability is crucial. The ability to navigate adversity and explore alternative career paths, as demonstrated by the said PhD scholar, can offer new opportunities and inspire others. They must not hesitate or feel low in esteem to start small ventures. They can use experiences to turn small into big ventures and be inspirational for others as well. There is nothing great like being a job creator than a job seeker. Moreover, teachers in Jammu and Kashmir should not be just confined to the Union Territory for their livelihood. There are immense opportunities and there is a big world to explore outside the Jammu and Kashmir. Even one must not hesitate to explore options outside the country. But it takes efforts and positivity and those who put in best efforts become successful. Additionally, teachers both regular and nonregular, private or Govt. should address systemic issues and improve working conditions. It can potentially change system into an effective and productive system where every stakeholder will be benefitted.

Erosion Of Respect For Parents

'n a world where familial bonds should ideally embody unconditional love and respect, a distressing video from Nowgam has cast a long shadow over our perceptions of these relationships. The footage, depicting a son violently beating his parents with a slipper, has shocked viewers and ignited a profound introspection about the state of respect within our homes.

The unsettling imagery from Nowgam, a locality that was once seen as a haven of traditional values, portrays a scenario so disturbing that it challenges the very essence of what we consider acceptable behavior towards our parents. This harrowing incident has prompted a broader conversation about the treatment of parents and the erosion of reverence that has historically characterized familial relationships.

For many, like myself, this dis-

tressing video has had a deeply personal impact. Since witnessing the disturbing scene, an overwhelming heaviness has settled in my heart, and I find it difficult to meet my own father's eyes. The contrast between the gentle hands that once comforted me and the brutality displayed in the video is stark and jarring. The sense of betrayal is palpable, not just towards the parents involved in the Nowgam incident, but to all parents who dedicate their lives to nurturing their children.

This situation serves as a stark reminder of how fragile our relationships can be. It underscores a growing disconnect between the expectations we have of our parents and the respect we often afford them. The silent sacrifices made by parents, their unspoken prayers for our well-being, and their endless expressions of love are too often taken for granted. This tragic

event has brought to light how important it is to acknowledge and appreciate the sacrifices made by our parents.

The Nowgam video is not merely an isolated incident; it represents a troubling trend of diminishing respect and empathy towards those who have given us so much. It raises urgent questions about how we, as a society, have arrived at a point where such actions are conceivable, and what can be done to restore the reverence that should be inherent in our relationships with our parents.

In reflecting on my own experiences, I recognize the many moments when I have failed to honor the love and care my father has given me. To my father, and to every parent who has ever felt overlooked or undervalued, I offer my deepest apologies and a heartfelt promise to better acknowledge and appreciate the immeasurable contributions you make to our lives.

The Nowgam incident may be a painful reminder, but it is also an opportunity for all of us to reaffirm our dedication to fostering relationships grounded in respect, gratitude, and love.

While Youth Enjoy 'Reels', 'Real' Fun of Socialising Fading Away

azi Jveerah, a content creator, who has an Instagram page by the name-@jveecaptures, cannot recall her last family gathering with close relatives. She hardly gets to meet her uncles and cousins as she gets more and more squeezed into the vortex of followers' mania.

Zuha(18) is no different. She has become an insomniac and deeply immersed in flipping videos, re-posting, liking and updating her profile picture deep into the night.

As Kashmir's youth struggle with the idea of monetizing their social media accounts on X, Facebook and Instagram through reels, real-life socializing has emerged as a major casualty. What is disturbing is the trend of families and friends now meeting briefly at events for marriage and mourning. Even there people keep clicking and uploading social media content.

"People have started using social media as a coping mechanism. Many of my patients struggling with loneliness, lack of friends and social connections rely on online networks. To combat their isolation, they start mindlessly scrolling on reels for hours together which leads to excessive dopamine rush that can cause addiction and mood disorders. I treat a lot of patients who suffer from emotional anxiety and depression and I advise them to reduce or eliminate their social media use.", said clinical psychologist Wasim Kakroo.

He further added that this reel world, while targeting dopamine, has made the youth more addictive, more impulsive and less patient. In addition many youngsters from Kashmir are engaging in online dating and having anonymous relationships on these apps, where they've no idea who the other person is. This addictive behavior leads to a distorted idea of love, which many of my patients are struggling with be-



cause of social media.

Casual dating is the new normal amongst youngsters, also known as "Gen Z". Tinder being one of the most popular dating apps allows one to connect with potential partners through a swipe-based feature. Users create profiles and swipe right to like or left to pass, if two users swipe right on each other they are matched and can start chatting. This virtual world has made it very difficult for the youngsters to foster deep and meaningful relationships which is only possible after socializing and having face-to-face interactions.

"I have had a front-row seat to how social media affects young people's mental health. I see this impact daily in my own life and the lives of those around me. Recently, my friend posted about landing an impressive internship and jet-setting to exotic destinations. Meanwhile. I'm eshmir's yo

working late into the night, balancing academics and research. Even though I work hard, seeing these idealized snapshots makes me question if I'm doing enough. This constant comparison stirs feelings of inadequacy and insecurity. The young people are creating idealized online personas. They may post pictures that make their life seem more glamorous than it really is, but deep down, they feel frustrated and even depressed by the gap between their online persona and their real self. This dissonance can further erode their self-esteem, making them feel trapped in a digital mask they can't take off.", said Farah Fayaz, a psychology student and a research intern in the field of neuroscience.

A 2022 study published in Pew Research Center surveyed youth globally and found out that on an average, teenagers spend approximately 6 to 7 hours a day online, including social media, gaming, and other activities. This excessive use of the internet among youth can lead to several health problems like sleep disturbances and mental health concerns. Social Media, on the other hand, has promoted numerous unrealistic beauty standards in the past few years which has made the youngsters self-conscious. In the teenage years when they are trying to understand themselves and develop their self image they are more vulnerable to the impact of

unrealistic beauty standards.

There has been a massive rise in social media influencers in the past few years because of the potential for high earnings which has made people lazy thinking that this is anyday better than a 9-5 job. Business Insider's report (2021) highlighted that social media influencers have become a major marketing force, 67%

of brands increased their influencer marketing budgets in the year 2021. The study also noted that Instagram remains the most popular platform for influencers, with 79% of marketers leveraging the platform for influencer collaborations.

Platforms like Instagram, Youtube, Netflix have turned youngsters into couch surfers where they consume online content just by sitting at one place which leads to extended screen time. Due to this increased screen time there has been a drastic reduction in outdoor activities. The University of Exeter came up with a survey in the year 2017 which shows that children's outdoor play has decreased by 60% over the past 40 years. It also revealed that only 31% of children meet the recommended guidelines for physical activity, compared to 50% in the 1970s.

The most vulnerable in this 'Information Superhighway era' are that toddlers are also introduced to these digital gadgets, with parents proudly flaunting their 'superkids' on social media. This will lead to limited face-to-face interactions which can impact the development of skills in the prolonged run.

Ghulam Rasool, a septuagenarian veteran, recalls his childhood when he used to enjoy day-long merry time with his friends and times of learning with elders. "Listening to the words of advice from Buzurgs after early dinner were deeply respected, now no more," he said, adding his 16-year-old grandson hardly gets the time to meet him.

As we see ourselves more and more through the prism of the global village, we need to revive our old-time relationships with our relatives and friends by arranging get-togethers and family outings to rediscover each other naturally. And for that we need to put our phones on airplane mode.

"I feel completely out of control when I am around food that tastes good!"

This is one of the most common things my clients/readers tell me. Does it found familiar?

If you've found yourself caught in the cycle of mindless or binge eating, you're not alone. Many people experience guilt and frustration after episodes of overeating/mindless eating, leading to emotional eating patterns that can feel overwhelming. But what if I told you that the key to breaking this cycle isn't about gaining control, as we have been taught to believe in our diet culture?

Instead, it's about letting go and making conscious choices. Trying to control your eating can be like trying to hold onto a bar of soap in the shower—the tighter you grip, the more it slips away. The harder we strive to resist cravings or impose strict rules, the stronger those impulses can become.

The Why: Trying to control eating often backfires because it activates our instinctive fight-or-flight response, triggering cravings instead of calming them. When we impose strict rules, our brains interpret this as a threat to our freedom, leading to an intensified desire for the very foods we're trying to avoid. This paradox reveals that the more we fight against our cravings, the stronger they become, creating a cycle of resistance that can leave us feeling even more out of control. And, it creates a sense of shame that we aren't acting as we believe we "should." Instead of control, embracing a mindset of curiosity and compassion allows us to explore our relationship with food in a healthier way.

The Answer: Reframe this journey. It's not about restriction; it's about taking charge of your choices with compassion and awareness. Here's how to approach mindful eating and shift your mindset.

Make Conscious Choices vs. Telling Yourself to Gain

Control. Shift your perspective from "I need to control my eating" to "I choose to eat mindfully." Ask yourself what you genuinely want to eat and how it will make you feel. This approach empowers you to enjoy a variety of foods without guilt, fostering a healthier relationship

with what you consume. Change the Scene. Breaking out of the cycle of mindless eating often requires a shift in our environment. When we find ourselves in familiar settings—like the kitchen or living room—our brains can easily slip into old habits and triggers. By consciously changing your surroundings, whether it's stepping outside for a walk, moving to a different room, or even just taking a moment to breathe in a new space, you disrupt that automatic loop. This change can create a pause, giving you the opportunity to reassess your cravings and emotions. By stepping away, you can break the cycle and approach your eating habits with a fresh perspective, allowing for more mindful choices.

3. Pause and Breathe. Before reaching for a snack, ask yourself, "What am I feeling?" This simple act of reflection can help you reconnect with your body's signals.

I. Engage Your Senses. When you decide to eat, fully immerse yourself in the experience. Notice the colors, textures, and aromas of your food. Take small bites and savor each one. This not only enhances your enjoyment but also helps you feel satisfied more quickly.

formalities were rejected, while 241 requests are still under process at the level of various competent authorities to issue the permissions.

"As many as 158 requests are still pending at various levels for want of NOCs etc, while 93 requests were cancelled on the basis of insufficient/incomplete formalities submitted by the applicants in spite of ample time given to them to submit the same," it said.

Detailing the permissions, the statement said that 217 applications were accepted for door to door canvassing, 28 for Helicopter and Helipad, 33 for Loudspeaker permit, 54 for opening of Temporary Party Office, 20 for pamphlet distribution, 1 for permission of video van (DEO Level), 437 for permission to hold meeting and Loud Speaker, 278 for permission to hold meeting without Loud Speaker, 111 for Permit for Street Corner Meeting and Loud Speaker, 66 for Permit to take out Procession and Loud Speaker, 304 for Rally, 88 for displaying banner and flags, 73 for displaying Poster, Hoarding and Unipole, 79 for Vehicle Permit, 32 for Vehicle Permit (Intra District), and 426 for vehicle with loudspeaker permit.

Additionally, 21 permissions were given for One vehicle for complete assembly area for the candidate, 11 seeking One vehicle for complete assembly area for the candidate election agent, and 6 seeking One vehicle per assembly segment for the party/party worker.

Also, 15 applications seeking Vehicle for star campaigners and party office bearers were accepted, along with 10 Vehicle Permission for transport of campaigning/publicity material by recognized political party and 40 Vehicle Permission for within AC.

Further, Chief Electoral Officer, J&K, Pandurang K Pole has urged upon the candidates and political parties participating in the Assembly Elections to utilize the 'Suvidha' application and platform, designed to streamline the application process for various permissions required during election campaigns.

The NIA had filed a charge sheet against several people, including JKLF leader Muhammad Yasin Malik, Pakistan based Lashkar-e-Taiba founder Hafiz Saeed and Hizbul Mujahideen chief Syed Salahuddin, in the case.

Malik was sentenced to life imprisonment by a trial court in 2022 after he pleaded guilty to the charges.

big leader despite being in jail for the last five years, after defeating National Conference vice president Omar Abdullah and Peoples Conference chief Sajad Lone in Lok Sabha polls held in April-May. The voter turnout in the polls was over 58 per cent.

they would 'probably' be left without a 'political representation' in the future, given the bail granted to AIP chief Er Rashid was intended to 'garner votes' for the Bharatiya Janata Party in the upcoming elections.

Er Rashid would be back in Tihar Jail as soon as Assembly elections in J&K are over, according to the NC leader, who will run concurrently from the Budgam and Ganderbal segments of the legislative assembly.

The former chief minister said that Er Rashid's bail was intended to garner votes for BJP rather than allowing him to represent the people of Baramulla in the Lok Sabha or to attend Parliament as a member.

"I was aware that something similar would occur eventually, and I genuinely feel sorry for the people of the Baramulla Lok Sabha seat as their representative has not been granted the bail to represent them in Parliament as an

elected member, but rather to secure votes for the BJP in the assembly elections," Omar told reporters, adding, Er will return to Tihar Jail as soon as the elections conclude.

Omar pleaded with voters not to let their votes be divided in this election the way BJP wants them to sway the outcome of the election in its favor.

"What effect this decision has on voters and how they perceive this development will be clear in the future. While I approached the matter with extreme caution, Mehbooba Mufti Sahiba made it clear that her explanation aligned with what many people were thinking. She claimed that Er Rashid is acting on behalf of the BJP and has also questioned the source of the funding for AIP candidates. Now let's see if AP could answer these queries," he added.

The union Home Minister, according to the NC leader, recently claimed that BJP would form the next previous government in J&K and that they want to do this in alliance with the parties like the AIP and PC, saying if people want to have a BJP government in J&K then let people support these parties.

When asked on how he sees the insults made by Congress leader Vikar Rasool against him and his family during a rally in Banihal, he said, "He is a fool and doesn't know what he says. He doesn't have control over his tongue. However, I'm happy that Congress has taken note of his insulting remarks and denounced it accordingly.'

Abdullah was also asked about jailed cleric Sarjan Barkati contesting against him from the Ganderbal seat, to which he replied, "There is something that jailed persons are going after me alone.

"This is not something ordinary. I can understand it as a coincidence that Rashid contests against me once but then fielding a person on two seats -- had I announced my candidature from Budgam two days before I did, Barkati would have contested from Budgam as well -they are making attempts but I am hopeful that their attempts will fail," he said.

Barkati has filed his nomination from the Beerwah constituency while the National Conference leader is contesting from the Ganderbal and the Budgam seats.

Speaking to reporters after addressing party workers in Chandgam, Pulwama, the People's Democratic Party (PDP) president said, "While many families are not allowed to visit their loved ones in jail, some people are allowed to run election campaigns from behind bars and are even given security protection.'

Mufti alleged that one of her party members was attacked by workers loyal to a jailed person, yet the Election Commission of India (ECI) issued a notice to the PDP candidate instead of taking action against the attacker. "This clearly indicates a biased approach," she said.

Criticising the political environment in Jammu & Kashmir, Mehbooba said the PDP has always been focused on the region's development. "Our party has focused on infrastructure projects such as roads, universities, colleges and AIIMS, as well as job creation initiatives," she said.

The former CM added, "The success of PDF has made other parties nervous, pushing them to seek public apologies and acknowledge their shortcomings. People will vote for PDP as they know the party had taken big developmental projects in a short span of time and provided employment opportunities to thousands of people.

On some former members of the banned Jamaat-e-Islami (JeI) contesting the assembly polls, the PDP president said the "real JeI is suf-

fering" due to the government's actions. "Their schools were shut down, their orchards were occupied, they were banned, their party is being torn apart just like the PDP was

"One person stands up saying he is the candidate of JeI, another says he is the one, but the real JeI is suffering, is in jails. The NIA, the ED are after them, all the agencies

are after them," she said. The former chief minister of the erstwhile state of J-K said the government should revoke the ban on JeI if it wants the outfit to

embrace democracy.
"I want to tell the government in Delhi that if they want JeI to become a part of democracy, that the Kashmir issue be discussed within the ambit of democracy, then they should lift the ban on them, remove the occupation from their lands, and open their schools.

"All this will not work here, threatening with the NIA, threatening with the ED will not work," she added.

Hajj 2025: Application

Applications can be submitted online via the HCoI website, hajcommittee.gov.in, or through the "Haj Suvidha" mobile app, available for both iPhone and Android devices.

The circular also advises applicants to carefully review the Hajj 2025 guidelines before submitting their applications.

In 2024, a total of 7,008 pilgrims from Jammu and Kashmir embarked on the holy journey. Unfortunately, 11 pilgrims from the region tragically passed away due to heat-stroke during the pilgrimage, according to officials.

While some pilgrims expressed concerns over the arrangements, labelling them as "poor", Hajj officials defended the arrangements, saying that facilities were better compared to the previous year, with accommodation within 400 meters of Masjid Nabvi (SAW) in Madinah and an improvement in hotel quality. They said the scorching heat on Arafat day and traffic congestion in the Mashair region posed challenges

during Hajj 2024.

The HCoI has also released a draft of the Hajj 2025 guidelines, including a key modification extending the age limit for companions.

Under the revised policy, companions in the age bracket of 60 to 65 are now eligible to apply for Hajj 2025, provided they are a spouse, sibling, or child of a pilgrim aged 65 or above.

All other companions must still fall within the age group of 18 to 60 years, according to the specified date set by the HCoI. Previously, the policy required companions and "Mehram" (for female pilgrims) accompanying pilgrims aged 65 or above between 18 and 60 years.

The policy also allows repeaters to be companions for lady pilgrims aged 65 or above, including Ladies Without Mehram (LWM), subject to payment of additional charges. Companions for LWM pilgrims must be female and between the ages of 45 to 60 years.

The policy maintains the allocation of Hajj seats, with 70% reserved for the HCoI and 30% allocated to Haj Group Organisers (HGOs).

Sources in PC said that Lone was under pressure from the party workers to fight himself from Kupwara. "His decision to contest from here has boosted the morale of our cadre. We are hopeful of victory. There is a lot of goodwill for our leader in Kupwara district due to big-ticket projects brought by him in his brief stint as minister in J&K government from 2015 to 2018," said a local PC leader.

Sogami, whose grandfather Ghulam Nabi Sogami was a minister, returned to play second innings of politics from his native district of Kupwara in November 2022 when he was appointed as constituency in-charge of Kupwara. Nasir Sogami won the 2008 assembly segment from Amira Kadal assembly segment of Srinagar but lost the next election to Altaf Bukhari by a heavy margin. of the scheduled offences, it shall be open for the ED to register a fresh case and launch prosecution.

The ED, as per the sources, filed this high court-directed application recently stating that the CBI "inadvertently missed/failed to specifically incorporate/mention the said offence under Section 411 and 424 of IPC".

The move comes at a time when assembly polls are being held in J&K and 86-year-old Abdullah's party, National Conference (NC), is in the fray along with other parties. Abdullah is the president of NC.

The ED, in its application, has requested the Srinagar court to frame fresh charges against the accused under the two stated sections saving it (Srinagar court) was vested with wide powers under section 216 of CrPC to "add/ amend" charges and that "this can be exercised in appropriate cases, in the interest of justice". Abdullah has been questioned multiple

times by the agency in the case. The ED had attached assets belonging to Abdullah and others worth Rs 21.55 crore.

The agency's case is based on a 2018 charge sheet filed by the CBI against the same accused. The CBI charge sheet alleged "misappropria-

tion of JKCA funds amounting to Rs 43.69 crore" from grants given by the Board of Control for Cricket in India (BCCI) to promote the sport in the erstwhile state between 2002 and 2011.

The ED had earlier said its probe found that JKCA received Rs 94.06 crore from BCCI in three different bank accounts during financial years 2005-2006 to 2011-2012 (up to December

of the case. The Air Force Station in Srinagar was approached by the local Budgam police station on the subject. We are fully cooperating towards this case," a senior IAF official said.

According to the media report, the female IAF officer detailed harassment, sexual assault, and mental torture over the past two years. The officer has said that at a New Year party at the officers' mess on December 31, 2023, her senior asked if she had received the gift. When she said she had not, the Wing Commander said the gifts were in his room and took her there. When she asked where his family was, he said they were elsewhere.

The flying officer has alleged that her senior forced her into oral sex and molested her. "I repeatedly asked him to stop doing it and tried to resist it in all ways possible. Finally, I pushed him and ran away. He said that he would meet me on Friday again when his family leaves," she has said.

The flying officer said it took her a while to register what happened to her. "I was afraid and didn't know what to do as there were instances before also wherein I was discouraged to report. He visited my office post this incident... He behaved as if nothing happened and there was no sign of remorse in his eyes," she

The woman officer said she reached out to two other women officers and they guided her to file a complaint. "I can't describe (the) mental agony, being an unmarried girl who joined forces and was treated in such (a) heinous manner," she said.

Following her complaint, she said, a Colonelrank officer was ordered to investigate the incident. The Wing Commander was made to sit down with her twice in January this year to record the statements, she has alleged. She has said she objected to the senior officer's presence and later the investigation was closed to "hide mistakes of administration".

She then filed a fresh application to the internal committee and it met two months later. The bias of Stn (Station) authorities to aid the sexual offender was very heart-breaking for me," she has said, alleging that a medical examination was not done till she insisted multiple times.

"IC (internal committee) did not do its job properly as directions had come from higher formation to keep the result as neutral. Everyone was aiding the sexual offender." the flying officer has said.

'I requested for interim relief and requested for leave multiple times but I was denied leave each time," she said, alleging that her requests for a different posting for herself or the Wing Commander were not heeded either.

"I am forced to socialise with these people and attend events with my abuser...While he is enjoying. I am getting harassed in (the) hands of authorities on a daily basis," she has said.

The Internal Committee, she has said, said that it is inconclusive whether the incident happened or not because of the lack of an eyewitness and closed its probe in May. "Isn't it common sense that someone would not do sexual assault in front of a witness?'

The flying officer has complained of "continuous mental harassment" and "social boycott". "My personal communications have been constantly monitored unofficially. The individuals speak with are harassed by the authorities."

The ongoing harassment, she said, has had a severe impact on her mental health. "I am living in constant fear, under 24/7 scrutiny and my social life has been completely disrupted. The harassment has driven me to suicidal thoughts, and I feel utterly helpless. I am unable to carry on with my daily life, and my social interactions are closely monitored and discouraged by authorities. I have endured this torture for too long, and I am at my breaking point," she has said. (with inputs from NDTV)

Several parties including National Conference (NC), Peoples Democratic Party (PDP), Apni Party and Bharatiya Janata Party (BJP) have given chances to the leaders, who will be contesting the assembly elections for the first time.

The NC has given mandate to nearly 11 candidates from Kashmir division, who will be in the fray for the first time-ever.

From the Apni Party, several candidates would be testing water for the first time in the assembly elections.

The party leaders confirmed that Jeelani Kumar, Owais Khan, Owais Ashraf Shah, Muhammad Ashraf Palpori, Munawar Khawaja, Dr Noor-ud-din and Ata Muhammad are the candidates who will be contesting for the

first time from Kashmir division. In PDP, the party chief, Mehbooba Mufti's daughter Iltija Mufti is among the candidates, who will be contesting the assembly polls for the first time.

ED Makes Third Arrest In Money Laundering Case Linked To Narco-Terrorism

SRINAGAR: The Enforcement Directorate said on Tuesday that it has made a fresh arrest in an alleged narco-terrorismlinked money laundering case related to the "funding" of banned terrorist group Hizb-Ul-Mujahideen. Laddi Ram was taken into

custody on Monday and was produced before a special Prevention of Money Laundering Act (PMLA) court in Jammu that sent him to ED custody for four days, the agency said in a statement.

Two others -- Arshad Ahmed Allaie and Fayaz Ahmed Dar -- were arrested by the federal agency in this case

The money laundering case stems from a 2019 FIR and a charge sheet filed by the Jammu and Kashmir Police against the accused on the charge of "operating a narco-terrorism module leading to seizure and identification of drugs and illicit cash".

"A network of collusion with drug smuggling and terrorism was unearthed as part of this investigation. Laddi Ram, as the instrumental person in the narco-terror linkage, received cross-border smuggled drugs from Arshad Ahmed Allaie, and distributed and sold those in Punjab and Jammu and Kashmir," the ED said.

Ram remitted the proceeds of crime in the form of illicit funds via bank transactions to Arshad Ahmed Allaie, it said.

The federal claimed that Allaie routed the funds

into the hands of terrorists linked to Hizb-Ul-Mujahideen for the "sole purpose of subversive activities.'

The transaction profiling of the bank accounts found "huge cash deposits obtained via drug sales, routed through multiple suspected inter-connected transactions, disguising the actual source and nature of funds," the ED added.

Pitch Politics: Iraq-Kuwait Football Match Tests Post-Saddam Ties

BAGHDAD: Thousands of Iraqi football fans were expected in Kuwait on Tuesday for a World Cup qualifier, the first time they have been allowed to attend since former Iraqi dictator Saddam Hussein invaded the emirate 34 years ago.

The busloads of Iraqis rolling over the border for the 7 p.m. (1600 GMT) game illustrated slowlywarming ties two decades after Saddam's fall in the 2003 U.S.-led invasion, though sensitivities remain and match arrangements have sparked some controversy.

"I can't explain how I feel," said Abbas Abdelatif, a middle-aged Iraqi, waiting to board a bus in the southern Iraqi city of Basra that borders Kuwait.

"I haven't seen Kuwait in more than 30 years. There was war and problems but now, God willing, the situation will get better and

at Jaber Al-Ahmad International Stadium in Kuwait City, with Iraq leading Group B of the Asian Football Confederation's qualifying matches for the 2026 World Cup.

Iraq, whose 43 million population is 10 times that of Kuwait, has a history of on-off rivalry with the tiny oil-rich emirate. The two states are building rival

Tyreek Hill's Traffic Stop Shows Interactions With Police Can Be About Survival For Black Men

MIAMI: After his traffic stop in Miami on Sunday, Tyreek Hill said he has received "the talk" about what to do when pulled over by police. He knows to heed the instructions passed down in Black families for generations.

Keep your hands in sight, preferably on the steering wheel. Avoid any sudden movements. Don't talk back to the officer. And above all, follow instructions without error or delay.

On Sunday, body camera video released Monday shows, the star wide receiver for the Miami Dolphins was ordered out of his vehicle by Miami-Dade Police officers, handcuffed and placed face down on a street outside the team's stadium. Hill said he was stopped for speeding and reckless driving before the Dolphins' first game of the season, and his interaction with police captured in a now-viral cellphone video and the body camera foot-

age escalated to the type of



incident that often prompts protests and claims of discriminatory policing, with the prone and handcuffed football star detained by

three police officers, one

on top of Hill with his knee holding the player's wrists against his lower back.

The video released Monday shows an officer dragging Hill out of his McClarand head and then forcing him face first onto the ground after Hill put up the window of his sports car. The officers handcuffed

en sports car by his arm

Hill and one put a knee in the middle of his back

The words "if we tell you to do something, do it," can be heard. The officer who pulled Hill from the car jumped behind him and put a bar hold around Hill's upper chest or neck.

'It happened so fast'

"It happened so fast that it caught me off guard," Hill said in a postgame interview on Sunday.

Hill's traffic stop reflects

a national law enforcement survey that shows that "driving while Black" is likelier to include the threat or use of force than it is for other Americans. For many, Hill's encounter with police drives home a reality that Black men in particular disproportionately experience what he did and, even if the encounter doesn't end in tragedy, it confirms an ongoing need for the talk.
