PM Modi **Pitches India To Chip Makers**

Greater Noida: Prime Minister Narendra Modi on Wednesday said resilience of supply chains is critical for the economy as he made a pitch to boost investments in domestic manufacturing of semiconductors -- the foundation of everything from smartphones to EV and AI.

Speaking at the SEMICON 2024 conference on the outskirts of the national capital, the Prime Minister said the Covid pandemic showed the importance of the supply chain and underscored the need to act to ward off any disruption.

"Whether it was Covid or war, there hasn't been a single industry to remain unaffected by supply chain disruptions," he said.

Stressing the importance of a resilient supply chain, the Prime Minister expressed pride in India's central role in building resilience across sectors, positioning the country as a key player in the global mission to

safeguard supply chains. "Resilience of the supply chain is very important," he said. "India is working to create the same in different sectors of the

economy.' A halt in flights, factory shutdowns in China, and surges in demand for specific products broke supply chains during Covid-19. One of the sectors impacted was chips that form a critical part of every electronic device.

2 Killed In Fresh **Udhampur Encounter**

Jammu: Two terrorists with affiliated Mohammad (JeM) outfit were killed in an ongoing operation in the upper reaches of Basantgarh in Jammu and Kashmir's Udhampur district on Wednesday, officials said.

They said bodies of the two terrorists, believed to be from Pakistan, along with an M-4 carbine, an AK assault rifle, a pistol and large quantity of ammunition and eatables were recovered from the scene.

This was the first successful operation against the terrorists in the dense forest which witnessed over half-a-dozen encounters in the past six months, claiming the lives of a village defence guard on April 28 and a CRPF inspector on August 19.

The officials said one more terrorist is believed to be trapped in Khandara top area and efforts are on to neutralize him.

More reinforcements were rushed and the operation was extended to adjoining Kudwah and Raichak, they said.

The operation was jointly launched by the Army and police in the early hours of the day and the first contact with the terrorists was established at around 12.50 pm, leading to a fierce gunfight, the officials said.

"Two terrorists neutralized in the ongoing operation at Khandara by troops of Rising Star Corps. Operations in progress," the Army said in a post on X.

Congress Chief Announces 4 Guarantees For J&K

Srinagar: Stating that BJP was feeling the heat of Congress-National Conference pre-poll alliance in J&K, Indian National Congress president Malikarjun Kharge Wednesday announced four guarantees for the people of I&K—Rs 5 lakh interest free loan for women, Rs 25 lakh insurance cover for every citizen, due representation of OBCs and rehabilitation of Kashmiri Pandits.

Addressing a press conference in Srinagar, Kharge, who was flanked by J&K Pradesh Congress Committee (J&KPCC) chief Tariq Hameed Karra, said: "Let me tell you that BJP has started to feel the heat of National Conference-Congress alliance in J&K. Now BJP is supporting independent candidates to defeat Congress-NC joint candidates.'

Kharge said that BJP tried its best to break the INDIA block but



failed. "The party is applying the same tactics in Kashmir by trying to divide the vote bank by supporting independent candidates. The BIP will see how Congress-NC will emerge victorious in the upcoming polls," he said.

Kulgam's Electoral Face-Off

Tarigami's Long Standing Hold Tested By Jel Backed Candidate

Srinagar: The Kulgam assembly constituency in south Kashmir is gearing up for an unprecedented electoral battle. The first phase of the elections will take place on September 18, setting the stage for a contest unlike any seen in recent history.

A total of 10 contestants are in the fray for the Kulgam seat, four of which are contesting as independent candidates.

However, political analysts believe that the main contest seems to be between Muhammad Yusuf Tarigami of CPI (M) and Sayar Ahmed Reshi, an independent candidate, who has the backing of banned Jamaat-e-Islami.

Observers say, the four-time MLA and senior CPI (M) leader



Muhammad Yousuf Tarigami, who is consensus candidate of the National Conference-Congress alliance, is facing one of the toughest electoral

battles in his home turf. The Kulgam seat in South Kashmir has been a stronghold of CPI (M), with Mohammad Yousuf Tarigami getting elected since 1996. Some even say it is a battle between Islamists and communists in Kashmir's only Red Island.

On Sunday, Sayar Ahmed Reshi and his supporters stunned everyone in Kashmir by holding an massive rally in Bugam area of Kulgam.

Sayar Ahmed Reshi, a resilent of Kharote village of Kulgam is popularly known as 'Sayar Sir" among the younger generation here for his services in the educational sector. Sayar, who holds M. Phil in political sciences, has worked as a contractual lecturer in Government degree colleges

of Kulgam and Anantnag. Speaking to reporters, Sayar said he chose to enter politics after seeing the terrible condition of Kulgam and accused Tarigami of corruption.

Anantnag: The main Anantnag assembly segment in south Kashmir is set to witness a close contest between four candidates, including one independent who was previously associated with the People's Democratic Party (PDP) and People's Conference (PC).

The four candidates in the running include National Conference-Congress Alliance candidate Peerzada Mohammad Saved. Dr Mehboob Beigh of the PDP, Hilal Ahmad Shah of Apni Party, and independent candidate Peer Mansoor.

Peerzada Mohammad Sayed

Peerzada Mohammad Sayed is a prominent politician from Jammu & Kashmir, affiliated

with the Congress party. He has served as the President of the Jammu & Kashmir Pradesh Congress Committee and has been elected four times as an MLA from the Kokernag constituency. Sayed, who has held several ministries, is contesting elections from another constituency as his own seat is ST-reserved Larnoo. However, the backing of NC makes him a strong contender.

Dr Mehboob Beigh

Dr Mehboob Beigh, son of Mirza Afzal Beigh, was associated with NC for a long time but later joined PDP. Beigh has been elected to the Jammu and Kashmir Legislative Assembly, Legislative Council, and the Indian Parliament multiple times. He has also served as the | More on P6

'Excess Abdominal Fat Linked To Widespread Chronic Pain In Women'

xcess fat around the abdomen is related to more chances of experiencing ✓ widespread chronic pain, especially in women, according to a study. In over 32,000 participants from the UK Biobank dataset, researchers found that women having fat surrounding their abdominal organ, called 'visceral adipose tissue', were twice as likely to experience chronic pain at multiple points in their body. About half the participants were women, aged 55 years on average. Chronic pain is a condition in which pain persists beyond the immediate healing period, fol-lowing an injury or trauma. It can sometimes be widespread, felt in more than one part of the body. The researchers, including those from the University of Tasmania, Australia, also found that women

having higher levels of 'subcutaneous adipose tissue', or the fat right under the skin that can be pinched, were at a 60% increased chance of having widespread chronic pain. The findings are published in the journal Regional Anesthesia and Pain Medicine. While excess fat in obesity is known to be linked to pain in the muscles and bones, researchers said that the relationship between excess visceral and subcutaneous and widespread chronic pain has not been studied.

Among the men studied, those having higher levels of visceral adipose tissue and subcutaneous adipose tissue were found to be at a 34% and a 39% higher chance of having widespread chronic pain, respectively.

The stronger links between fat and chronic pain in women could be a result of how differently fat is distributed compared to men. along with hormonal differences.



The researchers advised that addressing abdominal fat could help reduce chronic pain, particularly if it is widespread

For the study, magnetic resonance imaging (MRI) scans of the abdomen were used for measuring both the types of fat -- visceral

and subcutaneous adipose tissue. The participants also underwent pain assessments, in which they were asked if they had experienced pain in their neck or shoulder, back, hip, knee or 'all over the body' for more than three months. The scans and evaluations were repeated after two years for a smaller group of 638 participants. Being an observational study, the authors could not establish cause-and-effect links. They also acknowledged the study's limitations, including the comparatively smaller size of the participants' sample undergoing repeat tests, and not measuring the severity of pain.

'Abdominal adipose tissue was associated with chronic musculoskeletal pain, suggesting that excessive and ectopic (abnormal) fat depositions may be involved in the pathogenesis of multisite and widespread chronic musculoskeletal pain," the authors wrote.

Robots Can Lie And Deceive Like Humans, Reveals Study

Just like humans, robots can lie and deceive, according to a study that shows how emerging technologies like generative AI can be used to manipulate users. The team from George Ma-

son University in the US aimed to explore "an understudied facet of robot ethics" to understand mistrust towards emerging technologies and their developers. To determine if people can

tolerate lying from robots, the team asked nearly 500 participants to rank and explain various forms of robot deception. "I think we should be con-

cerned about any technology that is capable of withholding the true nature of its capabilities because it could lead to users being manipulated by that technology in ways the user (and perhaps the developer) never intended," said lead author Andres Rosero, a doctoral candidate at the University.



"We've already seen examples of companies using web design principles and artificial intelligence chatbots in ways that are designed to manipulate users towards a certain action. We need regulation to protect ourselves from these harmful deceptions.

The findings, published in the journal Frontiers in Robotics and AI, showed that robots can deceive humans in three scenarios: external state deceptions, hidden state deceptions, and superficial state deceptions.

The robots were used in medical, cleaning and retail work, and were portrayed as lying about the world beyond the robot, a housecleaning robot with an undisclosed camera, and a robot working in a shop.

The participants were asked to approve of the robot's behaviour, its deceptiveness, and if it could be justified. Most participants disapproved of the hidden state deception, which they considered the most deceptive. They also disapproved of the superficial state of deception, where a robot pretended it felt pain. The researchers attributed these deceptions, particularly hidden state deceptions, to robot developers or owners.

They warned that the study should be extended to experiments that can better model real-life reactions, such as videos or short role plays because it was conducted on a limited number of participants, which does not make up for concrete evidence.

How iPhone 16 Is Different From Apple's Recent Releases

ubiquitous iPhone is about to break new ground with a shift into artificial intelligence that will do everything from smartening up its frequently dimwitted assistant Siri to creating customised emojis on the fly.

The new era will dawn on Monday with the unveiling of the hotly anticipated iPhone 16 in a Cupertino, auditorium California, named after Apple cofounder Steve Jobs, who pulled out the first iPhone in 2007 and waved it like a magic wand while predicting it would reshape society. Apple has sold billions of iPhones since then, helping to create about USD 3 trillion in shareholder wealth. But in the past decade, there have been mostly minor upgrades from one model to the next - a factor that has caused people to hold off on buying a new iPhone and led to a recent slump in sales of Apple's

marquee product. The iPhone 16 is generating a bigger buzz because it is the first model to be tailored specifically for AI, a technology that is expected to trigger the biggest revolution in the industry since Jobs thrust Apple into the smartphone market 17 years ago.

The advances included in the iPhone 16 could set up

Apple to be "the gatekeeper of the consumer AI revolution", Wedbush Securities analyst Dan Ives wrote in a research note.

Apple's pivot began three months ago with a preview of its new approach during a developers' conference,

being promoted as "Apple Intelligence". Even so, Apple Intelligence

is similar to the generically named AI already available on Google's Pixel 9 and the Samsung Galaxy S24 released in January. Most of Apple's AI tasks

Since that June conference, competitors such as Samsung and Google have made even more strides in AI. Google even took the unusual step of introducing its latest Pixel phones packed with their own AI magic last month instead of hewing to its traditional October timetable in an effort to upstage Apple's release of the iPhone 16. DD Kashir Runs Into Rough Weather

EW DELHI- The much-hyped Kashir channel of the Doordarshan has run into rough weather. The union ministry of home affairs (MHA) is understood to have declined to foot the bill for running the channel. Even as the channel has allegedly become a money spinner for some Mandi House officials and a handpicked coterie of Kashmiri migrants.

According to reliable sources, the MHA had 'promised' to provide the financial support required to run the channel which was launched, for the third time in June this year, with a big fanfare. Two plane loads brought several Bollywood celebrities besides the union minister of information and broadcasting, Arun Jaitley, with hundreds of ministry officials in tow to grace' the occasion The gala function held at the city's Grand Palace hotel is believed to have cost the exchequer a fabulous Rs two to three crore.

Sources said no new Kashmiri programmes were likely to be produced for the channel. Proposals submitted by Kashmir producers, mostly Kashmiri pandits, were being returned due to non-availability of funds. Sources said 148 proposals, were approved by the Mandi House last month. However, some 'stale' programmes provided gratis by Star, Zee TV Sahara and some other private channels may be telecast from the Kashir channel.

Rashid Stirs Kashmir Politics

he sudden release of Awami Ittehad Party leader Engineer Rashid has stirred things up in the Valley. It is as if a big rock has been hurled into the already choppy waters of Kashmir politics. The ripples generated from the impact are set to radiate outwards. Rashid's combative press conference at Delhi Press Club has already set the ball rolling. It remains to be seen how he is welcomed back into the Valley and how he himself chooses to go about it. If anything, Rashid has always been a maverick and consequently his politics has been dramatic and unpredictable. With his entry, the ongoing election campaign will become only more interesting.

The campaign is already heating up. Prime Minister Narendra Modi is scheduled to visit Jammu and Kashmir twice this month to campaign for BJP candidates ahead of the assembly elections. His first visit is set for September 14, with a second visit planned for September 19. Congress president Mallikarjun Kharge, who addressed a rally at Anantnag on Wednesday, announced five guarantees, if the Congress-NC alliance is voted to power in the Union territory. The guarantees include interest-free loans of Rs 500,000 for women entrepreneurs, Rs 25 lakh health insurance for each household, Rs 3,000 monthly for women heads of families, 11 kg of grains per person through the public distribution system, and the fulfillment of the rehabilitation promise for Kashmiri Pandit migrants made during Manmohan Singh's tenure.

Other parties in the Valley including the National Conference (NC) and the PDP are also expected to up their game. They face a challenging road ahead. The ongoing Assembly polls are the first major electoral exercise in which the old and the new political order are face to face. The outcome will profoundly impact Kashmir's future politics. Though the NC looks strong on paper and Mehbooba Mufti remains politically very much relevant, the parties have a work on hand to retain their centrality. This has become critical after the alliances they were a part of have now decisively come undone.

The PDP has traditionally been dominant in South Kashmir and the NC in central Kashmir with Srinagar city as its core base. And in the north we are witnessing the dramatic emergence of Engineer Rashis's party as a significant player. Whether this new political reality also reflects in the seat tallies of these parties in the future assembly election remains to be seen. For now, the election campaign is becoming more exciting by the day. The coming weeks are set to be packed with a high voltage political drama. Here's hoping that the campaign remains peaceful and the outcome benefits people of the union territory. More so, after what they have gone through over the past five years.

people boycotted these elections. As Srinagar, Budgam and Ganderbal districts in Central Kashmir will go for assembly polls on September 20th, a tough contest between National Conference's Tanvir Sadiq and Peoples Conference's Abid Hussain Ansari is expected. Abid Ansari was elected as MLA from Zadibal during 2014 elections on People's Democratic Party (PDP) ticket. There are some prominent independent candidates in the fray as well like ex-Mayor of Srinagar, Junaid Mattu. PDP has also fielded its candidate Gowhar Ali.

The Returning Officer for Zadibal assembly segment has accepted the candidature of 15 candidates. The nomination papers of four candidates were rejected. There are now eleven candidates in the fray and locals whom this author interacted said that the main fight is between NC & PC candidates. Junaid Mattu who was earlier eyeing on Shia vote bank in Dal Lake area is now eveing on the Bakra votes (the supporters of Mirwaiz Umar Faroog). The Zadibal constituency was considered to be the stronghold of National Conference as Soura area falls under this assembly segment. NC founder Sheikh Mohammad Abdullah belonged to Soura locality of Srinagar and that is why Zadibal was considered to be a high profile assembly constituency. After delimitation, some areas like Kalajandar, Rajr wari, Jogi Lanker and surrounding areas of Dal have also been included in the Zadibal assembly

1972 election

The Zadibal assembly segment was represented by Saleem Anwar Dar, an independent candidate in 1972. This was the time when the National Conference had been pushed to the wall by Congress Govt at centre. Saleem Anwar Dar had secured 6173 votes out of 18692 votes that had been polled. Another independent candidate Aga Syed Afzal Jalali secured second position with 3491 votes. There were around 32,000 registered voters in Zadibal in the 1972 assembly election. Sadiq Ali who was later on elected as MLA of the area from National Conference in 1996 had also contested from Zadibal seat as an independent candidate and had secured 753 votes. Ghulam Nabi Nowshehri a noted fr Jamat e Islami leader was also contesting from this constituency and had secured 650 votes.

1977 election

In the 1977 historical election, which was said to be a transparent election held in Kashmir's history, thesitting MLA of that time, Saleem Anwar Dar, lost to his nearest rival Ghulam Ahmad Shunthoo who was a National Conference (NC) candidate. Shunthoo had secured 23,401 votes while Saleem Anwar who was contesting on Janata Party ticket gave a tough fight to NCs candidate by getting 21,522



fray and polling percentage was recorded as 81.71 %. During the 1977 elections Zadibal had 56400 registered voters out of which 45,392 voted.

Historic 1983 election

In 1983 assembly elections, which were held after the death of Sheikh Mohammad Abdullah in 1982. National Conference can didate Sheikh Abdul Rashid who was a close relative of Sheikh Mohammad Abdullah and Dr Farooq Abdullah got almost 50,000 votes which is a record in Kashmir's electoral history. Sheikh Rashid got 88% of the total votes and the polling percentage was 88.93%. Jahangir Ali Khan, an independent candidate, had secured 4000 votes. Congress and Peoples Conference had also fielded its candidates namely Mohammad Amin Bhat and Mohammad Ashraf in Zadibal in 1983 but they managed to get only 1710 and 545 votes respectively. Jamat-e-Islami had not fielded any candidate from Zadibal area in 1983 assembly elections.

1987 election

During the infamous 1987 assembly elections which are said to have been rigged in many places and was followed by militancy in Kashmir, there were only three candidates in the fray namely Peer Mohammad Shafi (NC), Peer Abdul Rouf (Independent) and A R Wani (Independent). Peer Mohammad Shafi secured 27,316 votes while his nearest rival Peer Abdul Rouf who was the candidate of Muslim United Front (MUF) managed to get 22,121 votes. A R Wani got only 755 votes. The polling percentage in 1987 elections in Zadibal assembly constituency was more than 71%

1996, 2002, 2008 and 2014 elections In 1996, mere 12% votes were

cast during assembly elections and Sadiq Ali became MLA of the Zadibal by getting 2948 votes. His nearest rival Ghulam Hassan Bhat of Janata Dal got 1451 votes.

In 2002, Zadibal had the lowest voter turnout in the assembly elections. A mere 4 % votes were polled as there was a massive boycott call given by Hurriyat and Militant groups. An independent candidate Shahjahan Dar won the elections by securing only 1500 votes. He defeated his nearest rival Sadiq Ali with around 300 votes. Sadiq Ali who is father of present NC candidate Tanvir Sadiq had obtained 1220 votes. PDP which formed the Govt in 2002 with Congress had also fielded a candidate namely A R Wani from Zadibal but he managed to get only 54 votes. BJP , Congress and Panthers party had also fielded their candidates from Zadibal in 2002.

During 2008 assembly elections, Peer Afaq Ahmad became MLA of Zadibal . He is the son of former MLA of Zadibal Peer Mohammad Shafi. The polling percentage in 2008 was 17% and there were around 16 candidates contesting from Zadibal. The sitting MLA in 2008 Shahijahan Dar who had joined PDP secured 3094 votes. Tanvir Sadiq who is

contesting on NC's mandate now was an independent candidate in 2008 elections. He was associated with PDP from 2006 to 2008 and was elected as corporator from

In 2008 assembly polls, Tanvir obtained 2759 votes from Zadibal with a vote share of around 22%. He later on joined National Conference soon after 2008 assembly elections and with the passage of time became a close confidant of Omar Abdullah.

In the 2014 assembly elections, Abid Hussain Ansari, who was associated with PDP at that time, won from Zadibal by securing 7852 votes. His nearest rival Peer Afaq of National Conference got 4849 votes and lost by 3003 votes. There were 14 candidates in the election fray and the polling percentage in 2014 was almost 24%. In 2014, Zadibal had almost 77000 registered voters which is now more than 1.30 lakhs

Scenario after delimitation

After the delimitation exercise, the Shia vote bank has been consolidated in the Zadibal now as all the interior areas of Dal, Ni geen and Anchar lakes have been included with the Zadibal assembly constituency. The Hazratbal shrine area is also part of Zadibal assembly segment which earlier was part of Hazratbal assembly constituency. NC candidate Tanvir Sadiq through his party's manifesto has promised one lakh jobs and development of roads and bridges if elected to power. He has also promised to develop Mir Behri Dal as a tourist village. Former Mayor Junaid Mattu, who was corporator from Mir Behri is now eyeing on both Shia and Sunni votes especially Bakra votes. Sheikh Imran, an independent candidate from Khanyar is helping him with that. Both Junaid and Imran originally hail from downtown Srinagar, but have been living in Ishber and Bagat areas for many decades. Will Junaid manage to get votes from Mir Behri and other Shia pockets of Zadibal along with Sunni Bakra votes? This all will be clear on October 8th when results of J&K assembly elections will be announced.

Conclusion

Zadibal assembly constituency which had once witnessed almost 89% polling in 1983 assembly elections and 71% in 1987 saw a massive shift. Like many other areas of Srinagar, people in this area were boycotting elections. The polling percentage graph came down to mere 4 % in 2002 assembly polls. The local residents whom this author met in many areas of the Shia and Sunni localities of Zadibal told me that people will come out to vote this time in large numbers. It is expected that Zadibal will witness more than 50% polling on September 20th when elections for Srinagar, Ganderbal and Budgam districts will be held.

REMEMBERING Dr. AZIZ HAJINI

A Tribute to a Remarkable Father & Guide

n the fourth death anniversary of Dr. Aziz Hajini, we gather in spirit to honor a man who left an indelible mark on society and in the hearts of those closest to him. Known to the world as a revered administrator, a prolific poet and writer, and a passionate advocate for the preservation of the Kashmiri language, I was fortunate enough to know him as something far more profound, a devoted and loving father.

To many, Dr. Aziz Hajini's legacy is anchored in his literary contributions and cultural leadership. As a key figure in the revival and promotion of Kashmiri, he became an icon in the region, a voice for the heritage that might have otherwise been lost to time. His poetry resonated with the emotions of the people, his essays reflected his deep understanding of culture, and his administrative work especially in the J&K Academy of Art, Culture and Languages for promoting and propagating different languages especially

Yet for all his public achievements, it is his private legacy that I hold most dear. To me, Dr. Aziz Hajini was not just a celebrated figure; he was my father, and his influence on my life is immeasurable.

One memory stands out viv-

idly, a story that exemplifies the depth of his selflessness and the love he carried for his children. I had set my heart on attending the prestigious Film and Television Institute of India (FTII) in Pune and was required to appear for a written test in New Delhi. My father. despite his numerous responsibilities, did not entrust this duty to anyone else. Instead, he accompanied me personally. He cleared his schedule, traveled with me, and waited patiently throughout the day while I sat for the exam.

As I walked out of the examination hall, I saw him there, a man of immense stature, standing among other parents, unassuming and without airs. At that moment, he wasn't Dr. Aziz Hajini, the literary giant. He was simply my father—an embodiment of support and encouragement. His presence that day, in the heart of New Delhi, was a quiet testament to his unswerving belief in my dreams. He taught me then, without saying a word, that no matter how high we climb, family is always our greatest purpose. His lesson of humility and unconditional love still echoes in my heart, and it is a memory I cherish to this day.

For many, it's easy to admire someone for their public accomplishments, but it is in the smaller, private acts of devotion that one's true character is revealed. My father had a



unique ability to balance the weight of his public responsibilities with the tenderness of his role as a parent. His professional success never eclipsed

his commitment to his family. As I reflect on his life, I am reminded of another poignant moment that encapsulates his spirituality and selflessness. My father had an unshakable faith in Allah and a profound reverence for Sufi saints. He found solace and strength in these beliefs, especially during times of hardship. When he was diagnosed with a serious health condition, I took him to the shrine of Habba Sahab RA in Hathlangoo. It was a place

that brought him peace, a sacred space where he sought divine guidance. On our way back, however, he revealed something that has stayed with me ever since. He told me that he had not received a positive spiritual feeling during this visit, and with a calm yet certain tone, he acknowledged

ing this conversation was not his fear of what was to come. but his concern for us-his family. He shared a prayer he had made to Allah during the height of the COVID-19 pandemic. With the world gripped in uncertainty and fear, he, too, was worried for his loved ones. In his prayer, he asked that if any misfortune was destined for his family, may it be redirected to him instead. This self-sacrifice, this willingness to bear the burden of suffering for the sake of his children and loved ones, is the essence of who my father was. His love knew no boundaries. and his care for us transcend-

ed even his own life. In the years since his passing, I often think about that moment. My father faced the end of his life not with despair, but with acceptance and a deep sense of peace, secure in the knowledge that his family would be protected. His faith gave him strength, and his love for us gave him purpose. His passing left a void that can never be filled, but his spirit and legacy remain a guiding light for me and countless oth-

ers whose lives he touched. As I write this, I realize that words will never fully capture the essence of Dr. Aziz Hajini. He was a man of profound intellect, boundless creativ-

ity, and unmatched integrity. But above all, he was a father whose love was the cornerstone of my life. His support, his wisdom, and his faith continue to shape the person I am

On this somber occasion, we remember Dr. Aziz Hajini not only for his contributions to literature, culture, and society but also for the way he lived his life-full of compassion, humility, and grace. He taught me, and all who knew him, that the measure of a person is not in the accolades they receive but in the love they give and the lives they impact.

Though he is no longer physically with us, his presence is felt in every corner of our lives. His spirit lives on in the lessons he imparted, in the poetry he wrote, and in the love he gave. Dr. Aziz Hajini may have left this world, but his legacy is eternal, woven into the fabric of the family he cherished and the community he served.

As we mark this anniversary, I find comfort in knowing that while my father is no longer here to guide me in person, his love continues to light my path. His memory will forever be a source of strength, and his legacy will continue to inspire those who knew him and those who come to learn about the extraordinary life he led.

He went on to state that India of today assures the world, "When the chips are down, you can bet on India.'

"Whether it is mobile manufacturing, electronics, or semiconductors, our focus is clear - we want to build a world that doesn't stop or pause in times of crisis but keeps moving forward," he said.

As the US-China trade war threatens to make chip imports even more expensive, countries around the world are investing aggressively to build domestic supplies of semiconductors - the foundation of everything from smartphones to electric cars and artificial intelligence (AI).

With its semiconductor market expected to touch USD 63 billion by 2026, India has created a Rs 76,000 crore program to woo chipmakers and their suppliers and cut dependence on countries such as Taiwan for imports to meet current requirements.

That programme has drawn nearly Rs 1.5 lakh crore of investment in producing about 70 million chips per

partnering Taiwan's Powerchip Semiconductor Manufacturing Corp to set up India's first chipmaking plant worth Rs 91,526 crore in Gujarat's Dholera. Its unit Tata Semiconductor Assembly and Test Pvt Ltd is also investing Rs 27,120 crore to set up a unit in Assam.

US memory maker Micron Technology Inc is also setting up a Rs 22,516 crore assembly facility in Gujarat, while Adani Group plans to build a chip plant in Maharashtra with Israel's Tower Semiconductor at a cost of Rs 83,947 crore. Also, CG Power is partnering with Japan's Renesas Electronics Corp and Thailand's Stars Microelectronics for a Rs 7,584 crore chip packaging plant in Gujarat.

"India's semiconductor sector is on the brink of a revolution, with breakthrough advancements set to transform the industry," Modi said, adding the country's chip industry is equipped with special diodes where energy flows in both directions.

"Today's India inspires confidence in the world... When the chips are down, you can bet on India," he

Modi said while the country's contribution to the world of designing is 20 per cent, India is creating a semiconductor workforce of 85,000 technicians, engineers and R&D experts.

Explaining that India holds a three-dimensional power - a reformist government, growing manufacturing base and aspirational market which is aware of the technological trends, the Prime Minister said that this base of 3D power is difficult to find elsewhere.

Stating that India is a huge consumer of such chips, he emphasized that the world's finest digital public infrastructure was built upon it. "This small chip is doing big things to ensure last-mile delivery in India.'

Recalling the coronavirus crisis when the strongest banking systems of the world collapsed, Modi said that banks in India were running continuously. "Be it India's UPI, Rupay Card, Digi Locker or Digi Yatra, multiple digital platforms have become a part of the everyday life of the people of India".

To become self-reliant, the Prime Minister said that India is increasing manufacturing in every sector, making green transition on a large scale and the demand for data centers is also increasing. "India is set to play a big role in driving the global semiconductor industry."

Pointing out the numerous steps taken by the government to promote semiconductor manufacturing, Modi highlighted that the government is offering 50 per cent financial support for setting up semiconductor manufacturing facilities, with state governments also playing a key role in this effort.

Because of these policies, he said, India has attracted investments worth more than Rs 1.5 lakh crore in a very short time and many more projects are in the pipeline.

"Our dream is that every device in the world will have an Indian-made chip," he said, adding the government will do whatever it takes to make India a semiconductor powerhouse.

On the progress India has made in the last few years, he said the country is now the second-largest market for 5G handsets globally, just two years after the rollout of 5G.

With India's electronics sector now valued at over USD 150 billion, the Prime Minister outlined a larger goal to grow the country's electronics sector to USD 500 billion and create 6 million jobs by the end of this

He said that this growth will directly benefit India's semiconductor sector. "Our goal is that 100 per cent of electronic manufacturing should happen in India. India will make semiconductor chips and the finished product too."

"Just like Modi's call for nationalism is fake, so is their (INDIA bloc) call for secularism. Both nationalism and secularism are dirty things used by them to bring bad name to real nationalism and secularism,"

Rashid said. "The BJP says that they will restore statehood at right time, our fight is not for statehood. When will that right time come, we have been waiting since

1947," he said. Rashid said he has a message to the BJP that "we do not have any fight with you but do not sacrifice

Kashmiris for your political agenda" "I also have a question for the INDIA bloc. They are not clear on their stance. Modi ii hits from the front while INDIA hits from the back. They weakened Article 370, Modi buried its body," he said.

He said the BJP government was labelling former chief minister Farooq Abdullah as an anti-national whose father Sheikh Abdullah gave Kashmir on a platter to India. "Sheikh Abdullah insulted Mohammed Ali Jinnah (founder of Pakistan) for India. Who can question Farooq Abdullah credentials who openly says Bharat Mata ki jai in Kashmir and has advocated bombing Pakistan".

Challenging the Centre to allow him to speak in Parliament, Rashid said the claims of the BIP that the entire nation was with them on abrogation of Article 370 was destroyed in the recent Lok Sabha elections.

"They (BJP) went asking for at least 370 seats in just concluded parliamentary elections as they wanted the nation to acknowledge what they did in Jammu and Kashmir. The result is in front of your eyes," he

He said five of our Kashmiri daughters including Asiya Andrabi are lodged in Tihar Jail. "They are our Sita. At least you can send them to Kashmir if you want to keep them in prison. If you want to bring hearts closer, is it the way that you can't find space in Kashmir prisons for Kashmiri daughters? It is too

He rejected the claims of the BJP that people were happy after the removal of special status and said "if people would have been happy after abrogation, government would not have to bury separatists like Syed Ali Shah Geelani, Ashraf Sehrai or Altaf Fantoosh in the dead of night and put thousands of people in jail".

Rashid's Release

Omar Abdullah Wednesday said that the Bharatiya Janata Party (BJP) has been using anti-nationalist forces to divide the voters here.

Omar said that the Union Home Minister Amit Shah has been claiming that terrorism will revive if NC and Congress will form the government here, but the facts remains that the Jammu where the terrorism was nowhere in sight during his rule, has come alive again.

"The Union Home Minister should compare the figures. Jammu was free from militancy during NC's rule, but the attacks are being reported every day here, which indicates that the terrorism has already resurfaced in Jammu," he said, adding that the next NC-Congress government will work to eliminate terrorism from Jammu again.

Replying to a query, Omar said that the plans are being formulated by using the anti-nationalist forces to divide the voters.

Meanwhile, Omar described the release of Awami Ittehad Party (AIP) Chief Engineer Rashid ahead of the upcoming elections as "fishy", questioning the Bharatiya Janata Party's intentions.

Speaking to reporters in Kupwara, Omar, according to KNO, expressed disbelief at the BJP's contradictory stance on releasing political figures for campaigning. He compared Rashid's release to the BJP's earlier criticism of Delhi Chief Minister Arvind Kejriwal's campaign-related release.

"When Arvind Kejriwal was allowed to campaign, BJP opposed the move nationwide. But now, they welcome the release of Er Rashid. It's somehow fishy," Omar said, accusing the BJP of double standards.

He warned the people of Kashmir to avoid splitting votes in the upcoming elections, saying such a move could enable the BJP's "conspiracy" to gain power in the region. "If the people of Kashmir let their votes divide, there are chances BJP's conspiracy may succeed. People need to vote wisely," he urged.

Reflecting on past elections, Omar expressed regret over the outcome in Baramulla, where Er Rashid was elected. "The people of Baramulla wasted their votes in the Parliamentary elections. Er Rashid was unable to represent them in Parliament as he remains in jail," he said, referring to the AIP president's limited release for election campaigning.

The former chief minister criticised the decision to release Rashid for just 20 days, claiming it serves only to gather votes. He defended his cooperation with Atal Bihari Vajpayee, praising the former Prime Minister's approach to Jammu and Kashmir.

"I never denied working during Vajpayee's tenure. He talked about Insaniyat, Jumhooriyat and Kashmiriyat, and stood tall without pushing BJP's agenda. We can change friends but not neighbours,"

"Vajpayee Sahab made efforts to open the Srinagar-Muzaffarabad road, which was a positive step," the NC leader added

A four-cornered

Cabinet Minister for Health, Family Welfare, and Medical Education. With the political influence his family, especially his father Afzal Beigh had, Dr Beigh is also a main contender for the seat.

Hilal Ahmad Shah

Hilal Ahmad, who was associated with the Indian National Congress for a long time, joined the Apni Party a few years ago. Shah, who also served as Municipal Corporation Anantnag Chairperson, secured around 11,000 votes against former chief minister Mufti Mohammad Sayed in 2014 and may turn the tables this time.

Peerzada Mansoor Hussain

Peer Mansoor Hussain, a former MLA of the Shangus constituency, is fighting the election as an independent candidate after having been associated with the PDP and Apni Party. Mansoor has a good voter base in the area and can pose tough competition to the other three candidates, who are backed by their respective parties.

The Democratic Progressive Azad Party's (DPAP) Mir Altaf Hussain and BJP's Syed Peerzada Wajahat Hussain can also secure a good share of votes, further dividing the vote share among the main four contenders.

Political analysts believe that the NC-Congress alliance candidate Peerzada Mohammad Saved's nonresidency in the constituency may be a weak factor, but NC candidate Peer Mohammad Hussain's full support could help Sayed win. According to them, Dr Mehboob Beigh's and his father's long representation of the constituency may help Beigh regain the seat.

Analysts add that Hilal Shah, who secured around 11,000 votes against Mufti Mohammad Sayed on a Congress ticket in 2014, can once again attract a good number of votes. Furthermore, Peerzada Mansoor, who represented the Shangus constituency on a PDP ticket in 2014, could leverage the fact that villages formerly part of Shangus are now part of Anantnag, and boost his vote share and help him win.

In the 2014 Jammu and Kashmir Assembly Elections, JKPDP leader Mufti Mohammad Sayeed won the seat with a margin of 6,028 votes. He secured 16,983 votes, with a vote share of 51.20%. He defeated Congress candidate Hilal Ahmad Shah, who garnered 10,955 votes (33.03%). NC candidate Iftikhar Hussain Misger came third with 2,403 votes (7.24%), and BJP candidate Mohd Rafiq Wani was in fourth place with just 1,275 votes (3.84%). A total of 33,200 votes were polled (39.71%).

In the 2008 Jammu and Kashmir Assembly Elections, PDP leader Mufti Sayeed won the seat, polling 12,439 votes with a vote share of 39.49%. NC candidate Mirza Mehboob Beigh got 7,548 votes (23.96%) and was the runner-up. Sayeed defeated Beigh by a margin of 4,891 votes. A total of 31,501 votes were polled (41.23%). Independent candidate Liyaqat Ali Khan came in third with 1,895 votes (6.02%), and another independent candidate, Hilal Ahmad Shah, was in fourth place with 1,683 votes (5.34%).

AC 44-Anantnag contains 61,070 voters (30,645 males, 30,425 females) with 70 polling stations (43 urban and 27 rural). AC 45-Srigufwara-Bijbehara has 1,02,081 voters (50,728 males, 51,353 females) with 125 polling stations (16 urban and 109 rural). Historically, the Anantnag seat was represented

However, Sayar is not the only threat that Tarigami faces. He is also facing Nazir Laway of Peoples Conference. Nazir Laway contested against Tarigami since 2008 and lost in 2014 with just 334 votes, when he was the PDP nominee. Laway was later PDP's nominated Rajya Sabha member, but after 2019, he left PDP and joined PC led by Sajad Lone.

The Peoples Democratic Party has fielded Mohammad Amin Dar from the seat, while the Apni Party's Engineer Mohammad Aqib is also in the fray.

Pertinently, the Kulgam assembly segment has 1,17,322 voters, including 58,477 male and 58,845 female voters, who can exercise the right to vote in 134 polling stations.

Observers say with strong candidates like Tarigami defending the only Red Island in Kashmir and Sayar Ahmed Reshi presenting a formidable challenge backed by his educational and social work credentials, the dynamics have shifted.

"If you elect a government on the balance (with thin majority), the BJP will bring down the government overnight through horse-trading. It happened in my state, Karnataka. They bought 16 persons (MLAs). In Maharashtra, they split Shiv Sena and NCP to form the government. This (BJP government) is a 'thod phod sarkar'," he added.

ACB Exposes 310 Kanals Land Scam By Mafia, Officials

SRINAGAR: While continuing its tirade against the unholy nexus of revenue officers and land mafia, J&K Anti Corruption Bureau (ACB) achieved yet another major success in extracting the land scam, wherein around 310 kanals of Custodian land in Asarwan, Mishriwala and Bhalwal area of Jammu district has been found usurped by the land mafia in connivance with the officers/officials of Custodian, Revenue and Police department.

Earlier, the ACB had unearthed a land scam involving around 210 kanals of Custodian land, in respect of which five FIRs were registered. A statement reads that inputs were received that Custodian land in thousands of Kanal situated at Asarwan, Mishriwala and Bhalwal Jammu, has been fraudulently grabbed by the land grabbers/gangsters in connivance with the Revenue and police officers/officials.

The revenue records have been tempered and land has been sold to various persons, it said. ACB conducted a formal verification wherein it was found that in furtherance of the criminal conspiracy, FORM 3-A (Form Alf) along with power of attorneys (POAs) were obtained from various POK Refugees, alluring them of additional lands and providing them instant money ranging from Rs 5000 to Rs 50,000 by the conduits of land grabbers, and thereafter insertions/ad-

ditions regarding additional chunks of custodian lands were made in the revenue records by the officials/officers of the Revenue and Custodian department, by sheer abuse of their official positions, and these lands were sold by the conduits and attorney holders to various persons including their own gang leaders and members, by resorting to fraudulent means, thereby causing a huge loss to the Govt.

"Owing to the establishment of, prima facie, nexus of the criminal elements/ land grabbers and the Revenue/ Custodian officers/ officials in alienation of Custodian land through fraudulent means, ACB has registered 10 formal case FIRs in PS ACB Central for investigation under the provisions of Prevention of Corruption Act, criminal conspiracy, cheating, forgery and fraud," it said.

During the course of investigation, after obtaining the search warrants from the Ld. Special Judge Anti-Corruption Jammu, search teams comprising ACB officers, Independent Witnesses, Magistrates were dispatched to around twelve locations throughout Jammu and its adjoining areas, the statement said.

"In addition to 10 FIRs registered, verification is still in progress to unearth the remaining usurped custodian land by land mafia in connivance with officers and officials of Revenue, Police and Custodian department," the statement reads.

Tribunal Upholds Ban On 6 J&K Separatist Groups

NEW DELHI: A judicial tribunal of the Delhi High Court has upheld the Centre's ban on two factions of the separatist group Muslim Conference Jammu and Kashmir and four factions of another secessionist organisation, Jammu and Kashmir People's League (JKPL), for threatening India's integrity by promoting, aiding and abetting the secession of Jammu and Kashmir through terrorism.

He maintained that such institutions are least meant for providing theory lessons but chiselling the talent-of-the candidates to turn them into astute professionals well-versed in their respective trades.

Dulloo further maintained that in order to enhance the employability of these pass-outs and to increase the traction of these technical courses among the students, the board should make the examination process strict with focus on imparting market-driven skills to them.

He also advised for taking necessary measures to determine the equivalence of these diplomas given by polytechnic colleges with respect to the mainstream courses offered by the School Education Department. He also asked for making the lateral entry into these courses smooth and hassle-free for the interesting candidates.

The Secretary, BOTE, Shaista Shamim presented the detailed picture of the mandate, working and achievements of the Board. She revealed that the nose dive in seeking admissions in technical education institutions during the past few years had been tackled well by creating awareness in schools here.

She also apprised the meeting about the current trend in seeking of admissions along with that of the courses and colleges in demand. She said that the board offers admissions and conducts examinations for nearly 3500 candidates in 26 polytechnic colleges and 84 ITIs of J&K.

It was further disclosed that during the ensuing and previous academic sessions the admissions reached to about 95% with pass percentage of around 70%.

Regarding the implementation of NEP-2020, it was added that the same was successfully adopted in JKBOTE for all Polytechnics of J&K. It was said that the registration of JKBOTE with National Academic Depository (NAD), DigiLocker and Academic Bank of Credits (ABC) Portal has also been done for the overall benefit of the students.

Regarding the conduct of examinations it was informed that these are held timely with declaration of results as per the examination/academic calendar issued on the commencement of the session. —(KNO)

Manchester United Vows To Improve On & Off Pitch After Fifth Year Of Losses

anchester United's new chief said on Wednesday the club was working towards improving performance on and off the pitch after a fifth consecutive year of net losses following a poor 2023-24 season and heavy investments in the new squad.

The English Premier League soccer club's shares slipped 8% in early U.S. trading as net losses widened to more than 113 million pounds (\$147 million) in the year to June, making it only the second time since its New York listing in 2012 that losses topped 100 million pounds.

United have embarked on a slew of changes since British billionaire Jim Ratcliffe bought a 25% stake in the club and under his stewardship had a busy summer in the transfer market, securing several promising young players.

"We are working towards greater financial



sustainability and making changes to our operations to make them more efficient, to ensure we are directing our resources to enhancing on-pitch performance." newly appoint-

enhancing on-pitch performance," newly appointed CEO Omar Berrada said. "Our clear objective is to return the club to the top of European football." The Premier League

has clamped down on big spending by clubs with its Profitability and Sustainability Rules (PSR) to try to level the playing field and prevent rich owners from spending vast sums on players.

To comply with PSR

To comply with PSR, clubs must rack up no more than 105 million pounds of losses over a three-year period, although investments in infrastructure, academies, charity foun-

dation and women's soccer can be deducted.


United have recorded losses of more than 257 million pounds in the past three years, and more than 370 million pounds over five years. The club said it was committed to and compliant with the PSR, as well as European governing body UEFA's Financial Fair Play Regulations.

United finished eighth in the Premier League last season, their lowest position since the league's inception in 1992. This season has not started any better, with two losses from the first three games.

For fiscal 2025, the club expects an adjusted core profit of 145-160 million pounds and revenues of 650-670 million pounds. It reported adjusted core profit of 147.7 million pounds on record revenues of 661.8 million pounds in fiscal 2024.

The forecast reflects the impact of recent restructuring that included 250 job cuts.

Pogba's Brother, 5 Others To Stand Trial In Extortion Case

brother of World Cup winner Paul Pogba will stand trial with five other men as part of an extortion case that targeted the soccer player two years ago, the Paris prosecutor's office said Tuesday.

A judge ordered the six men to appear before a court following an investigation into whether Pogba was the target of extortion by his brother, Mathias Pogba, and childhood friends, the office said.

The prosecutor's office said Mathias Pogba, 34, was ordered to stand trial "for the offenses of attempted extortion and criminal conspiracy." The court date has not been announced.

The five others — identified by their first names only — allegedly demanded 13 million euros (\$14.3 million) from the France midfielder, and repeatedly intimidated him, claiming he didn't support them after he became an international soccer star. They are accused of extortion and

attempted extortion by using violence, abduction and confinement to facilitate a crime or misdemeanor, as well as criminal conspiracy.

During the investigation, Pogba said he paid 100,000 euros to the organized group including his brother. According to French media reports, the 31-year-old player also told investigators the alleged extortionists wanted to discredit him by claiming he asked a witch doctor to cast a spell on teammate Kylian Mbappé. Pogba denied the allegation.
