#### Israel Attacks Lebanon, 274 Killed

Beirut: The Israeli warplanes conducted extensive airstrikes against towns and villages across Lebanon on Monday leaving 274 people, including 21 children dead and more than a thousand wounded. It is by far the deadliest cross-border escalation since war erupted in Gaza on October 8.

Israel said it hit about 800 Hezbollah sites in south and east Lebanon during the day and carried out a "targeted strike" later in Beirut. A source close to Hezbollah said the strike on the capital targeted a senior commander.

Families from south Lebanon clogged the highways north on Monday, fleeing an expanding Israeli aerial onslaught for an uncertain future with children crammed onto parents' laps, suitcases tied to car roofs and dark smoke rising behind them.

Countless cars, vans and pickup trucks were loaded with belongings and filled with people, sometimes several generations to a vehicle, while other families had fled fast, taking only the bare essentials as bombs rained down from above, Reuters reported.

"The strength and intensity of the bombing are something we haven't witnessed before in all the previous wars," said Abu Hassan Kahoul, on his way to Beirut with his family after two buildings were levelled near the apartment block where he lives.

"Small children don't know what is happening but there's fear in their eyes," he added.

Even in Beirut there was growing alarm, and parents rushed to pull their children from schools as Israel warned of

#### Hajj 2024 **Application Deadline Extended**

Srinagar: The online application submission dates for Hajj 2024 have been extended on Monday.

The date extended to January 15, 2024, is intended to allow more time for pilgrims to submit their applications, provided they possessed machine-readable valid Indian International Passports issued on or before January 15, 2024, and valid at least until January 31, 2025.

A circular issued by the Haj Committee of India (HCoI) reads. "For those interested in applying for Hajj 2025, the registration started on August 13, 2024, and the original deadline was September 9, 2024. However, due to popular demand, the last date for submission of Haj Application Forms has been extended to September 23, 2024, at 11:59 PM."

"Considering popular Competent demand, the Authority in the Ministry of Minority Affairs is pleased to extend the last date of submission of Haj Application Forms (HAF) to 30.09.24 11:59 Hrs," the circular added.

#### **Heat Wave Returns To Kashmir**

Srinagar: Severe heat wave was witnessed yet again in Kashmir parts on Monday with the gateway of Kashmir-Qazigund, recording the highest-ever day temperature in the month of September at 33.2 degree Celsius.

Jammu and Kashmir parts recorded a rise in the maximum as well as the minimum temperatures with Kashmir recording the heat wave and some parts including Srinagar, the summer capital of Jammu and Kashmir, recording severe heat wave today.

Data reveals that Srinagar recorded the maximum temperature of 33.7 degree Celsius, which was 6.7 degrees above normal. In Qazigund, the mercury settled 7.6 de-

grees above normal temperature today, the data reveals, adding that Kokernag recorded a maximum temperature of 31.6 degree Celsius, which was 7.0 degrees above normal. Kupwara in north Kashmir, Pahalgam a famous tourist destination and Gulmarg a ski-resort recorded maximum temperatures of 33.2 degree Celsius, 29.4 degree

## **HC Quashes 2 PSA Detention Orders**

Says Preventive Detention Must Be Authorized By Due Process Of Law

Srinagar: Preventive detention must be authorized by the due process of law, the High Court of J&K and Ladakh has observed while quashing detention orders under Public Safety Act against two detainees.


While quashing PSA detention 8 April 2024 order against a 25-year-old youth, Anjum Khan of Surankote Poonch, a bench of Justice Wasim Sadiq Nargal took a serious note of the "casual approach" of the detaining authority in issuing the detention order "without

supplying the dossier to the detenue and arriving at a subjective satisfaction in absence of any cogent reasons or material."

Instead, the court said, the detaining authority merely placed reliance on two FIRs which have no nexus with the security of the State or public order or any proximity/ live link with the allegation leveled in grounds of detention."

The inability on part of the State's police machinery to take recourse to ordinary criminal law should not be an excuse to invoke the jurisdiction of preventive detention," the court said,

adding, "In the instant case, the relevant provisions in the Indian Penal Code were clearly sufficient to deal with the situation, however the respondents (authorities) have invoked provisions | More on P6

## **Astronomers Can't Agree On How Fast Universe Is Expanding; New Approaches Aiming To Break Impasse**

t is almost 100 years since scientists discovered the universe is expanding. In the decades that followed, the accuracy of the measurements, and interpretations and implications of this discovery, were a source of fierce debate. We now know the universe emerged dramatically from a highly compressed state in an event known as the Big Bang.

Measurements of the present-day expansion rate, known as the Hubble constant or H (pronounced H-naught), have improved considerably since those early days. However, a new debate now grips the astronomy community: two independent measurements of H , which should agree, give different results. This situation has become known as the tension", or Hubble

Numerous conferences, review articles and journal papers have been dedicated to this issue. Some refer to it as a "crisis" for cosmology", requiring a paradigm shift in our understanding of the universe. The expansion of the universe is a key aspect of its history since the Big Bang, so it underpins many other elements of our understanding.
Others view the H ten-

sion simply as a sign that the measurement teams do not fully understand their data and that, with better data, the "crisis" will be resolved. But its solution remains elusive.

two measurement methods at the centre of



this debate are the "distance ladder" and the "cosmic microwave background". The distance ladder is the older of the two, and has been used in various forms since the earliest detection of the universe's expansion.

The first evidence came from pioneering measurements of faint cloud-like objects that we now know to be galaxies outside the Milky Way. American astronomer V.M. Slipher measured the chemical signatures in the light from these objects. Using the technique of spectroscopy to match these signatures with those of known molecules, he found their wavelengths were stretched compared with standard laboratory results.

This stretching of the wavelengths of light from other galaxies, known as "redshift", is caused by the Doppler effect. This phenomenon is also responsible for the pitch of a wailing siren increasing as an emergency vehicle approaches, then decreasing as it passes. In a seminal 1917 article, Slipher announced that almost all the galaxies he'd observed were receding from the Milky Way.

Slipher's data would go on to be used by Edwin Hubble in his famous 1929 study showing that the more distant a galaxy is, the faster it recedes and hence the greater its redshift. The ratio between redshift and distance is the Hubble constant.

Expansion of the universe had already been anticipated by theorists. In the early 1920s, Alexander Friedmann and Georges Lemaître independently realised that Albert Einstein's recently published theory of general relativity could predict an expanding universe, and that the implications of this would be galaxy redshifts that increase with distance.

#### Distance ladder

Distant galaxies are being dragged away from us because of the universe's expansion. Measurements of the Hubble constant rely on determining the connection between the distance of these objects and the speed at which they are

receding. For this reason, the units of H are conventionally "kilometres per second per megaparsec", referring to the speed of an object one megaparsec away (a unit of distance used by astronomers, equivalent to about 3 million light years).

Just as Slipher did a century ago, recession speeds can be readily measured using spectroscopy. However, accurate distance measurements to galaxies are notoriously difficult, so this is where the distance ladder comes in.

The lowest "rung" of the ladder represents objects in the sky that are close enough that we can use direct methods to measure distance - such as the parallax method, where the motion of the Earth around the Sun creates periodic shifts in the angular position of the objects. The subsequent rungs represent measurements of progressively more distant sets of

These are chosen to be objects for which it is easy to measure relative distances but, like a ruler with no numbers on it, their absolute distance must be calibrated. This function is provided by objects on the

lowest rung. Cepheids – bright and massive stars that pulsate - are particularly useful as rungs due to the tight correlation between their pulsation period and brightness, discovered by Henrietta Swan Leavitt in 1908. The most distant rung is usually formed by Type 1a supernovae (explosions that occur when certain stars reach the ends of their lives), which have also provided definitive evidence that the universe's rate of expansion is increasing.

#### Cosmic microwaves

The other measurement method at the centre of the debate is the cosmic microwave background (CMB). This is light emitted when the universe was just a few hundred thousand years old - long before stars or planets had formed. Instead, a hot plasma filled all of space, almost perfectly uniform except for sound waves thought to have their origin at the Big Bang.

The physics of the universe at this time is surprisingly simple, so we can make robust predictions about the properties of these waves. When combined with precision measurements, our mathematical models tell us what the expansion rate of the universe was at this early time. With a model for the subsequent expansion history, we can make an extremely precise prediction of H

## Magic Mushrooms Found To Offer More Long-Term Benefits Than Anti-Depressants

silocybin, the psychedelic drug commonly known as 'magic mushrooms', offers longer-term benefits, compared to standard antidepressants, including overall better well-being, meaning in life and social functioning, a study has found.

Comparing two separate anti-depression treatments -- one involving the psychedelic drug and the other involving a standard SSRI antidepressant escitalopram -- researchers had previously found that after six weeks, depressive symptoms such as sadness and negative emotions had improved to similar

SSRI refers to selective serotonin reuptake inhibitors, a class of drugs commonly used to treat depression and other psychiatric illnesses. These drugs work by increasing serotonin levels in the brain, a chemical that is known to play a positive role in mood, emotion and sleep.

"However, this work shows that psilocybin outperformed escitalopram (SSRI antidepressant) in several measures of well-being, meaning in life, work and social functioning. These results appeared to be maintained over a 6-month follow-up period," lead researcher Tommaso Barba, a PhD candidate from Imperial College London, UK, said.

"In addition, in previous work, we had found that psilocybin also improves sexual drive, in contrast to SSRIs, which tend to lower libido in many patients. So, overall it seems psilocybin might give additional positive mental health benefits," Barba said. The findings are published in the journal eClinicalMedicine. The researchers said that psilocybin may offer an alternative to the fraction of patients who do not respond to SSRI treatment, even though they said this aspect was not tested in this study.

Psilocybin, extracted from psychedelic plants, has been used for centuries across indigenous cultures in the world for inducing ecstasy and spiritual experiences.

However, in medicine, the drug is still experimental and not yet approved for gen-



eral use, first author David Erritzoe, Clinica Director and Deputy Head of the Centre for Psychedelic Research, Imperial College London, said.

"It is administered in highly controlled and protected environments: these precautions are not found in recreational psychedelic use, which is known for having unpredictable and potentially harmful effects, especially for vulnerable people struggling with mental health issues," Erritzoe said.

For the study, the researchers included 59 patients -- 30 were treated with a single dose of psilocybin, while 29 were given a six-week course of escitalopram. The participants were followed for a period of six months and received similar psychological support of around 20 hours in total.

After six months, the authors found that both groups showed significant improvement in depressive symptoms.

However, those given psilocybin were found to report greater improvements in social functioning and psychological connected-

"The greater degree of improvement in the psilocybin therapy arm at follow-up on psychosocial functioning, meaning in life, and psychological connectedness warrant future research," the authors wrote.

The findings are important because improving connectedness and having a greater meaning in life can significantly enhance a person's quality of life and long-term mental health, Erritzoe said.

"The study suggests that psilocybin therapy might be a more holistic treatment option for depression, addressing both the symptoms of depression and overall well-being, Erritzoe added.

### Heat Wave Leads To Water Shortage In Srinagar, Elsewhere

Srinagar: Several parts of Srinagar city as well as South Srinagar, its outskirts, and neighboring areas in Budgam, are grappling with a severe water shortage, leaving residents distressed and worried.

According to the officials, the shortage has been attributed to falling water levels in most reservoirs due to the recent heat wave and fluctuating temperatures. The residents, however, are frustrated with the situation.

Many of them informed the news agency—KNO that several locations of Srinagar, along with parts of Budgam, are affected by the water shortage, leaving them frustrated and worried.

Locals from the affected areas have voiced complaints about the erratic water supply and the unavailability of water tankers.

Sahil, a local from Qamarwari, Srinagar said, "We have been facing this issue for the past few days and the tanker service is

almost non-existent."
A resident from South
Srinagar added, "We have
been facing an acute water

shortage for the past two to three days, and it's affect-

ing our daily lives."

Meanwhile, officials from the Jal Shakti Department, when contacted by KNO, said many reservoirs have experienced a significant drop in water levels, making it difficult to ensure an uninterrupted water supply.

"The change in temperature and a fresh heat wave have impacted the water levels in most of our reservoirs," an official said.

He added, "We have now implemented a scheduled water supply system. Under the implemented schedule, water will be provided to households between 6 AM and 11 AM, with an additional supply from 4 PM to 7 PM, while the remaining time is reserved for the reservoirs to recharge."

Asked about the shortage of tankers, the Jal Shakti Department official continued, "Many of our tankers are currently engaged in preparations for the upcoming assembly elections. The few tankers we have left are being deployed to assist the public, but we understand the concerns.

## Traders Refusing Kashmiri Apple

400 Trucks Lying Unloaded At Azadpur Mandi

RINAGAR-Nearly 400 trucks laden with Kashmiri apple are stranded at the Azadpur mandi in Delhi, as traders refuse to unload them because of their preference for fruit from Himachal Pradesh.

The situation has sent a wave of concern through fruit traders in Kashmir, and the matter has been taken up with the Delhi government. A delegation of the Fruit Growers Association said

that different varieties of apple are being exported in this season and 400 trucks laden with the fruit arrived in the Azadpur mandi in Delhi four days ago.

"Traders in the capital are declining to unload the trucks because preference is being given to fruit from Himachal over that from Kashmir," it said.

The trucks are stranded at the mandi, causing deep concern among the growers community, it said. The stranding of 400 trucks has caused a shortage of vehicles to ferry fruit to outside the state, and as a result freight charges have jumped through the roof, it said.

"Only a few days ago, the freight per carton from Shopyan to Delhi was Rs 40. This had now been hiked to Rs 50," it said. Sources said that the union minister for water resources, Prof Saifuddin Soz, has conveyed his concern by raising the issue with the horticulture department in Delhi after the matter was brought to his notice by fruit traders.

## Pakistan Factor In **Assembly Polls**

akistan has become a major election issue in the ongoing Assembly elections in Jammu and Kashmir with Kashmir-origin parties seeking engagement with it for a resolution of the Kashmir issue and the BJP rebuffing any prospect for it. The home minister Amit Shah has time and again made it clear that India won't talk to Pakistan but to the youth of Kashmir. And this has more or less been a policy of New Delhi towards Islamabad since 2014 when the BJP government took power. Although there have been efforts to kickstart an engagement between the two nations, they have been swiftly aborted after a violent incident either in Kashmir or in other parts of the country which the central government blamed on India. Last such attack which put a complete break on dialogue was on the Pathankot air force base which killed seven soldiers. After that, New Delhi never pursued a dialogue with Pakistan with any seriousness, giving up hope that it could be sustained as the major attacks in India traced to Pakistan keep happening.

The differences between the two countries are now too entrenched and irreconcilable to immediately lead to any engagement. More so, since the abrogation of Article 370 in August 2019, which have sunk the relations between the two neighbours to their lowest. Ever since, Pakistan has sought reversal of the move which India has rejected. India, on the other hand, has asked Pakistan to end support to terrorism in Kashmir, which the latter has denied it has any role in.

The mutual stance ensures that nothing changes on the ground. This position comes across invariably in the statements of the senior BJP leaders, including that of the prime minister Narendra Modi. During his campaign in the Valley, the PM has said that Pakistan is happy about the NC-Congress alliance, as, according to him, the alliance sought restoration of Article 370. The NC and the PDP, on the other hand, have sought dialogue with Pakistan. But the BJP would have none of it. In one of his interviews during the parliamentary election campaign, the PM Modi made it clear that India "shouldn't bother much about Pakistan and whether it changes its approach or not." He added that for the past 10 years he had put a lock on Pakistan being a factor in running India. "Let Pakistan manage two square meals. We don't need to waste our time," he remarked, hinting at Pakistan's dismal

But the defence minister Rajnath Singh, in his election speeches, seems to have kept a door open for engagement with Pakistan. Addressing poll rallies at Kotranka and Sunderbani in support of BJP candidate Choudhary Zulfikar Ali on Sunday, Singh said India was ready to embrace Pakistan and start a process of dialogue with it, provided the neighbouring country gives a guarantee that it will stop promoting terrorism on Indian soil. It may not amount to much as the defence minister has only repeated New Delhi's line on engagement with Pakistan but its framing is more conciliatory. In diplomacy and in geopolitics, the framing isn't accidental but deliberate.

he granting of interim bail to Engineer Rashid from Tihar Jail has generated considerable interest within the political sphere of Jammu and Kashmir. As assembly elections approach, Rashid's reemergence is likely to influence the competitive landscape. The electoral engagement in Kashmir has transformed, with separatists and those previously imprisoned now entering the electoral fray after a decade-long absence. Following the abrogation of Article 370, a political void had been constraining the populace of Jammu and Kashmir, highlighting the need for a new direction in electoral politics.

Rashid's political trajectory showcases his deep-rooted connection with the community and his ability to engage with the electorate. Transitioning from a civil engineer to a two-time MLA representing Langate, he has earned a reputation as a passionate advocate for the rights of the people. His unexpected victory in the 2024 Lok Sabha Elections, where he triumphed over former Chief Minister Omar Abdullah, has solidified his status as a formidable player in the region.

In 1990, Rashid, a typical site supervisor at JKPCC, encountered a harrowing incident involving militants who demanded cement bags from him in an act of extortion. He steadfastly refused their demands, resulting in the militants brutally assaulting him, breaking his bones, and ultimately leaving him for dead by a river. Local residents alerted the managing director of JKPCC about the severely injured site supervisor, who was promptly taken to the hospital. The managing director was deeply moved by Rashid's courageous stand, which led to his promotion to a permanent engineering position at JKPCC. This marked the beginning of the legacy of "Engineer Rashid."

Beginning his political career in 2008, Rashid founded the Awami Ittehad Party in 2013, championing human rights and the restoration of the Power Project managed by Delhi. Throughout his journey, he has made headlines with his controversial remarks, particularly his assertive stance on the Kashmir conflict, which has garnered him substantial public support. Rashid emerged as a beacon of hope for the populace at a time when other leaders lacked the fortitude to hold governments accountable for disruptions to peace. He articulated a vision of peace for the general public, emphasising that it can only be achieved through dialogue, famously stating,

"Peace cannot come from the barrel of a gun."

Rashid's message strikes a powerful chord with the public, infusing his appeal with a significant "sympathy factor." In 2019, during the detention of approximately 6,000 political prisoners, Rashid found himself entangled in a UAPA Terror Funding Case, leading to his imprisonment in Tihar. His subsequent release has ignited speculation, with supporters dismissing any dissenting opinions as "bigotry," especially those hinting at BJP involvement. Critics argue that Rashid serves as a proxy for the BJP in Kashmir, raising questions about whether his release is part of a broader politi-

In contrast, individuals like Waheed Para and Faroog Abdullah continue to navigate their political paths despite facing UAPA charges in recent years. Does this suggest they too are involved in a proxy game?Omar Abdullah aligned with the NDA in 2001 taking on the role of Minister of State for external affairs in Vajpayee's government. Mehbooba Mufti was the first to collaborate with the BJP, establishing a coalition government in 2014. Such historical alliances are crucial to consider.

Despite being incarcerated in Tihar jail, his son successfully rallied public trust and support, securing him a seat in the Lok Sabha elections of 2024 beating Omar Abdullah and

Sajad Gani Lone, two political giants in Kashmir politics. The sentiments and confidence of the public play a pivotal role in Rashid's widespread appeal. His words resonate deeply with the people, inspiring them to raise their hands in solidarity and cheer for their leader. The slogan "Jail ka badla vote se" played a vital role in cultivating public sentiment for incarcerated Rashid.

The victory in Lok Sabha elections invigorated spirits, as it indicates that the populace has embraced the notion of a new political framework spearheaded by the youth. Furthermore, Rashid's humility and his opposition to elite culture have significantly contributed to his public support, ultimately enhancing his political achievements.

It is particularly noteworthy that among all the manifestos for assembly elections 2024, Rashid's stands out for its strong emphasis on human rights and land rights issues. The historical context of 1987, when Sheikh Abdullah earned the title of "Sheikh" by granting land rights to tenants, underscores the significance of land in shaping leadership stature. Rashid's AIP manifesto is built around the principles of Dialogue, Diplomacy, and Self-Determination, offering promising prospects for both landlords and small horticulture entrepreneurs. A key focus of the AIP manifesto is the demilitarisation of Jammu and Kashmir and the cessation of human rights violations.

Rashid's influence transcends mere electoral success. His capacity to bring attention to critical issues, such as alleged human rights abuses, resonates with the populace. AIP's slogan, "Kashmir ki Majboori hai AIP zaroori hai." resonates the same.

Historically, Rashid has attracted the attention of both regional and national political parties during coalition discussions. His capacity to influence the balance in a hung assembly or a divided electoral result renders him either a significant ally or a formidable adversary, contingent upon the situation. The established parties have remained reticent

regarding Rashid's detention, neglecting to express any dissent or concern about his imprisonment. Nevertheless, Rashid will have a decisive influence making him a 'Kingmaker' of this election.

The AIP's capacity to garner votes in crucial regions has established it as a pivotal entity in the fragmented political landscape of Jammu and Kashmir, where no single party typically secures a definitive majority. The party's position frequently attracts the attention of larger political entities, given AIP's influence in rural especially North Kashmir and often underrepresented regions of Kashmir, making its backing essential in coalitionbuilding efforts.

In this election, Rashid is running in alliance with candidates from Jamaat e Islami, thereby securing substantial support. Through this strategy, Rashid aims to enhance his electoral prospects within the already crowded and competitive political environment of Kashmir. Political analysts view this development as a significant achievement for democracy, as separatists, previously distanced from the electoral process, are now participating by contesting elections. The longevity of this collaboration would depend upon the shared goals of AIP and JeI.Rashid has strongly advocated for the JeI agenda being resonating with AIP's agenda both vouching for peaceful Kashmir.

Nonetheless, the timing of Rashid's release has sparked skepticism, with some questioning the underlying motives. Critics suggest that his return could disrupt the political landscape in the Valley, potentially favouring certain parties. There are concerns that his presence might negatively impact the electoral chances of established political factions in north Kashmir. Therefore, the 'Rashid Factor' will play a crucial role: if he does not ascend to the throne himself, Rashid will undoubtedly be a potential Kingmaker.

## Kashmiri Women's Digital Quest for Health Answers Amid Limited Resources

₹atima, a 28-year-old woman ◀ from a rural area in Kashmir, sits nervously in front of her smartphone, her fingers hovering over the screen. She's been experiencing unusual abdominal pain for weeks but hasn't visited a doctor. The nearest hospital is miles away, and the thought of discussing her symptoms with the male doctor makes her uncomfortable. With a deep breath, she types her concerns into a popular Facebook group for Kashmiri women, hoping for advice and support from others who might understand her situ-

This scene depicts a complex intersection of healthcare deficiencies, cultural norms, and technological adaptation. Our recent research into the healthrelated social support sought by Kashmiri women in an online group has unveiled a critical phenomenon in healthcare access and support, shedding light on both the resilience of these communities and the inadequacies in the region's formal healthcare infrastructure. The healthcare scenario for women in Kashmir is challenging, to say the least. Years of instability have led to an underdeveloped healthcare system, with a severe shortage of facilities, equipment, and trained medical professionals. This scarcity is particularly acute in women's healthcare. Many areas lack dedicated women's health clinics, and the number of female healthcare providers is low. As a result, women often find themselves without access to essential services, from routine checkups to specialized care.

Compounding these infrastructural deficiencies are deeply rooted cultural and societal norms that often limit women's autonomy in health-related decisions. In many parts of Kashmir, discussing women's health issues, particularly those related to reproductive health, remains taboo. Women are often expected to prioritize family responsibilities over their own health needs, and the idea of a woman traveling alone to seek medical care can be met with social disapproval. These norms create significant barriers to healthcare access, leaving many women to suffer in silence or seek alterna-



tive sources of support and infor-

It is within this context that online communities have emerged as a crucial lifeline for Kashmiri women. Our study focused on a Facebook group with over 30,000 members, analyzing the health-related social support that take place in this virtual space. The research findings paint a stark picture of the healthcare gaps these women are navigating:

- Prevalence of Informational Support: A striking 86% of messages in the group were seeking informational support, empha-sizing the critical need for accessible health informa-
- Women-Specific Health Concerns: The most common health-related topics for which social support was requested were specifically related to women's health issues- pregnancy, infertility, postpartum care, menstrual issues.

These findings reveal a community that has turned to digital platforms out of necessity, creating a space where women can discuss health concerns openly, These findings reveal a community that has turned to digital platforms out of necessity, creating a space where women can discuss health concerns openly, seek advice, and offer support to one another. This could be due to a lack of comprehensive health education, limited access to healthcare providers, or cultural barriers that prevent open discussions about women's health. The prevalence of queries about pregnancy, infertility, postpartum care and other issues indicates the significant gaps in maternal healthcare services in the region. Women appear to be seeking information and support online for issues that ideally should be addressed by healthcare professionals. This raises concerns about the accessibility and quality of prenatal, postnatal, and reproductive healthcare services in Kashmir. Moreover, the discussions about menstrual issues and general reproductive health highlight the persistent taboos surrounding women's health in the region. The online group seems to provide a safe space for women to discuss topics that may be considered too sensitive or embarrassing to broach in their imme-

diate social circles or even with

healthcare providers. However, the reliance on online support for critical health issues is a double-edged sword. While it provides much-needed support and information, it also raises concerns about the accuracy and completeness of the advice being shared. Misinformation about sensitive health issues like pregnancy or infertility could lead to harmful outcomes. These findings call for urgent action on multiple fronts. There's a clear need for:

- Improved access to women's healthcare services, particularly in the areas of reproductive and maternal health; need for more female healthcare providers and better-equipped medical facilities.
- Comprehensive health education programs that address the specific needs and concerns of women in the region.
- Initiatives to break down cultural taboos surrounding women's health, encouraging more open discussions and timely care-seeking be-
- Development of reliable,

easily accessible sources of health information tailored to the needs of Kashmiri women.

Further, these online communities highlight the need for broader societal changes. The fact that women feel more comfortable discussing health issues anonymously online than seeking care in person points to the persistence of taboos and restrictive norms. Addressing these cultural barriers is crucial for improving women's health outcomes in Kashmir.

As we move forward, it's essential that stakeholders at all levels -policymakers, healthcare providers, NGOs and otherstake action to address the issues highlighted by this research. The women of Kashmir, like Fatima, have demonstrated incredible resilience and ingenuity in the face of significant challenges. Their use of digital platforms to create supportive health communities is interesting, but it should not be seen as a longterm solution to the region's healthcare deficiencies. Instead, it should serve as a catalyst for meaningful change, inspiring efforts to build a healthcare system that truly meets the needs of all women in Kashmir. As researchers and society at large, we have a responsibility to listen to these women's stories, understand their challenges, and work towards solutions that respect their experiences and needs. Only by addressing both the infrastructural gaps in healthcare and the societal norms that restrict women's access to care, can we hope to create a future where no woman has to rely solely on an online forum for her essential health needs.

## Our (Mis)Perceptions of Time

ur perception of time is peculiar. We do not nave an organ that measures time as we have organs for sounds, smells, or images. There are no time hallucinations or time illusions in the way there are visual or auditory ones. (Some have suggested that the whole experience of the passage of time is a grand illusion, but we need not worry about that here.)

The reason we don't talk about time hallucinations and illusions is not that our perception of time is always veridical; rather, it's because when time seems to us to pass faster or more slowly than it really does, we do not call that an illusion. While time passes at a constant rate of one hour per hour, we take it for granted that it doesn't always need to feel that way.

In other words, there is time, and there is our experience of time, and the two need not align. But why?

#### **OVER THE COURSE OF A DAY**

Our perception depends, perhaps most obviously, on the activity we are engaged in and on our state of mind. Time seems to pass very quickly when people are fully absorbed in the task at hand and are in a state that some psychologists have called "flow." It appears to pass more slowly when we are bored, and more quickly when we are worried. Consider a passage from

Thomas Mann's novel The Magic Mountain:

"There is a case of a passage of miners buried and shut off from every possibility of knowing the passage of day and night, who told their rescuers that they had estimated the time they had spent in darkness, flickering between hope and fear, to be some three days. It had actually been ten. Their high state of suspense might, one would think, have made time seem longer than it actually was, whereas it shrank to less than a third of its objective length."

Research offers empirical confirmation that anxiety makes it seem as though time is passing by faster. It seems to slow down when we wait with impatience. (Meditation practitioners may be able to produce in themselves a state of absorption and counteract the impatience.)

There is also the curious phenomenon of time "dilation" or time's "running in slow motion" during a frightening and life-threatening event. The case is a very interesting one and deserves a separate discussion.

Î know someone who experienced this in the course of a bad accident, and he reported that the type of "slowing down" involved is unique and nothing like the slowing down of time due to boredom, as when you wait in line with nothing to do. Rather, it was, he said, a feeling that everything was happening in slow mo-



tion—like viewing a tape of an event at half speed. (Interestingly, this type of experience is sometimes conveyed in movies also-say a character would see a threatening object approaching, and the object would be shown moving at slower than the expected speed.)

#### WHY DOES OUR PERCEPTION OF **TIME CHANGE?**

How and why that happens are good questions, and different answers to them have been proposed. One hypothesis is that we are thinking faster in those situations and that this makes it seem as though time is slowing down. According to another hypothesis, people take in a lot of new memories, and this makes them misremember their own experience.

My own hunch is that our tendency to experience time as slowing down in force majeure circumstances is a protective mechanism which allows us to calm down and act with clarity and without panic. But I leave a fuller treatment of the issue for another occasion.

#### TIME PERCEPTION THROUGHOUT

**OUR LIVES** There is one type of pattern in our perception of time that we see systematically, a pattern that may well be universal: Time seems to pass more

slowly when we are children. It does not matter what activities we are and were engaged in or how interesting or not our childhood was compared to our adulthood: Time seems to pass faster as we age, for everybody. Why?

I wish to suggest that there are three main reasons. The first is that adults do a lot of "mental time travel"—we are always thinking about the past or the future, and the present slips away unnoticed. In his Pensées, Pascal says, similarly:

"Let each of us examine his thoughts; he will find them wholly concerned with the past or the future. We almost never think of the present, and if we do think of it, it is only to see what light it throws on our plans for the future.

There is a good deal to say here about the effect of this tendency on our chance of happiness, but I have discussed this issue elsewhere. The important point for present purposes is that children do not, as a rule, spend time reminiscing or anticipating future events, because they don't have memories that go back a long far, and they have little control over their future or clear idea of what it may hold for them.

The second point is that a year is a much bigger proportion of the life of a child than it is of that of adults. This may matter in the way in which our physical size matters to our perception of the size of other things. A small swimming pool might look like an Olympic-sized one to a preschooler, because it's big compared to her. Similarly, a year in the life of a 6-year-old is 1/6th of the child's life, but in the life of a 60-year-old, it is 1/60th. That matters. We are the measure of all things and from here, of

the size of things. There is a final reason adults and children perceive time differently. A child typically does not have life plans that she thinks she ought to realize before she dies, so there is no rush. She feels little pressure to check items off her bucket list, or realize her potential, or make something of herself. While an overly ambitious parent may think

his kindergartner is behind somehow, no kindergartner feels that way.

A young child is typically waiting with impatience the arrival of adolescence and adulthood, vaguely feeling that she would then be able to make her decisions and carry out plans. An adult, by contrast, is not waiting with impatience for old age and not simply because old age does not sound nearly as fun as young adulthood: An adult often feels behind. Hardly any of us, even the least ambitious, have done everything we wanted to in the time we've already lived. We feel behind on life.

An elderly tailor I used to go to said once that life was like a roll of toilet paper-each rotation is slow at first but gets faster and faster as there is less and less paper left. I knew just what he meant. You probably

What is worse is that thinking about how quickly time is passing takes time. This thought itself-one that children do not have-distracts us from the present and both robs us of the opportunity to make the best of the present and makes it so that the present will fly by unnoticed. Time always passes quickly when there isn't much of it. And there is never a lot of time if we spend much of the time we have fretting about how little

Lebanese Health Minister Firass Abiad said the Israeli strikes that began in the morning killed 274 people, including 21 children and 39 women. He said about 5,000 people had been wounded since Tuesday.

World powers have implored Israel and Hezbollah to pull back from the brink of all-out war, with the focus of violence shifting sharply in recent days from Israel's southern front with Gaza to its northern border with Lebanon.

Abiad said "thousands of families from the targeted areas have been displaced".

The Israeli military also warned people living in the Bekaa valley, in eastern Lebanon, to flee their homes, as it announced it was "broadening" the scope of its strikes.

Explosions around the ancient city of

Explosions around the ancient city of Baalbek in eastern Lebanon triggered flashes of fire and sent smoke billowing into the sky.

Lebanon's official National News Agency (NNA) later reported new "enemy raids targeted the mountain" areas in the Baalbek region and several towns and villages, adding that "the Israeli enemy" launched a strike on the town of Hermel.

Hezbollah fired rockets at military sites near Haifa.

It later said it launched "dozens of rockets" at two Israeli bases "in response to the Israeli enemy's attacks on the south and the Bekaa".

The NNA said Lebanese had received phone

The NNA said Lebanese had received phone messages from Israel telling them to "quickly evacuate".

Hezbollah, a powerful political and military force in Lebanon, has exchanged near-daily fire with Israel in support of besieged people in Gaza.

- Israel changing 'security balance' -

Prime Minister Benjamin Netanyahu said on Monday that Israel was preempting threats and was acting to change the "security balance" in the north.

Hezbollah's deputy chief, Naim Qassem, said Sunday the group was in a "new phase, namely an open reckoning" with Israel, and ready for "all military possibilities".

They spoke after Hezbollah rocket attacks on northern Israel caused damage in the area of Haifa, a major city on Israel's north coast.

On Sunday morning, hundreds of thousands of people in northern Israel fled to their bomb shelters as Hezbollah fired a barrage of rockets across the border.

The attack came after an Israeli air strike in Hezbollah's southern Beirut stronghold on Friday killed its elite Radwan Force commander, Ibrahim Aqil, along with other commanders and civilians.

Last week on Tuesday and Wednesday, coordinated communications device blasts that Hezbollah blamed on Israel killed 39 people and wounded almost 3,000.

Since the cross-border exchanges between Israel and Hezbollah began in October, tens of thousands of people on both sides have fled their homes.

"We sleep and wake up to bombardment... that's what our life has become," said Wafaa Ismail, 60, a housewife from the southern

Lebanese village of Zawtar.

An Israeli military official on Monday outlined the goals of the military operation.

It seeks to "degrade threats" from Hezbollah, push them back from the border, and then to destroy infrastructure built near the frontier

by Hezbollah's Radwan Force, the official said. Lebanese Prime Minister Najib Mikati urged the United Nation and world powers to deter what he called Israel's "plan that aims to destroy Lebanese villages and towns".

- Another Gaza? -US President Joe Biden, whose country is Israel's main ally and weapons supplier, said his administration was "going to do everything

we can to keep a wider war from breaking out". Ahead of the annual General Assembly in New York, UN chief Antonio Guterres warned of Lebanon becoming "another Gaza" and said it was "clear that both sides are not interested in a ceasefire" there.

Speaking at the General Assembly, Masoud Pezeshkian, the recently elected president of Iran -- which backs Hezbollah and Hamas -- accused Israel of seeking "to create this wider conflict".

The UNIFIL peacekeeping force in south Lebanon meanwhile warned that "any further escalation of this dangerous situation could have far-reaching and devastating

The Srinagar district has a total of 7,76,674 registered voters, including 3,87,722 males, 3,88,922 females, and 30 transgender voters across eight Assembly constituencies. A total of 932 polling stations are spread across these constituencies, ensuring that every registered voter has the opportunity to participate in the democratic process.

The Rajouri has 4,92,008 electorates which includes 2,56,215 males, 2,35,786 females, and 7 transgender voters. A comprehensive network of 745 polling stations has been established across the district.

The Budgam District has a total of 5,11,864 voters across its five Assembly constituencies; 2,59,688 male voters, 2,52,163 female voters, and 13 transgender voters. A total of 639 polling stations are spread across the two Assembly constituencies, ensuring that every registered voter has the opportunity to participate in the democratic process.

Poonch District is divided into three Assembly constituencies, with a total of 3,52,330 registered voters; 1,80,584 males and 1,71,746 females. To facilitate the voting process, the Election Commission of India (ECI) has established 483 polling stations across both constituencies.

The Reasi district has registered a total of 2,37,205 voters, including 1,24,359 males, 1,12,843 females, and 3 transgender across its three Assembly constituencies. ECI has established 436 polling stations throughout the district

The Ganderbal district has 2,08,018 registered voters, including 1,04,162 male and 1,03,856 female voters. A comprehensive network of 267 polling stations has been established by the ECI for free, fair and transparent elections. Modi addressed two rallies, one each in Srinagar and Katra in Reasi district, on September 19, while Union Home Minister Amit Shah addressed rallies in Mendhar, Surankote, Thanamandi, Rajouri and Nowshera in the twin border districts of Poonch and Rajouri.

Defence Minister Rajnath Singh also dashed to the two districts in the Jammu region to canvas for the BJP candidates and addressed rallies in Poonch, Budhal and Sunderbani during his daylong tour on Sunday.

Both Shah and Singh addressed rallies in Akhnoor and Sainik colony in Jammu, while BJP president J P Nadda also visited Jammu to attend election-related events.

The star campaigners of the Congress included its president Mallikarjun Kharge and the leader of the opposition in the Lok Sabha Rahul Gandhi.

Gandhi addressed two rallies -- one in the Surankote constituency in Poonch and another in the Central-Shalteng segment in Srinagar -- to pull the curtains on the high-pitched campaign of the Congress.

The BJP also deployed several of its union ministers and senior party functionaries, including Jitendra Singh and G Kishan Reddy for campaigning, while the Congress campaign featured AICC national secretary Sachin Pilot, Alka Lamba and other leaders.

National Conference president Farooq Abdullah extensively campaigned for his party candidates on either side of the Pir Panjal Mountain Range while his son and vice president Omar Abdullah largely focused on the valley seats as he is contesting from Ganderbal and Budgam segments.

Iltija Mufti seems to have taken over the mantle of lead campaigner for the PDP as party president Mehbooba Mufti was not as active as she used to be in earlier elections.

The campaign had its share of emotional moments particularly the cap-removing gesture by Omar Abdullah while seeking support from the people of Ganderbal. The former chief minister impressed upon people that it was not only his dignity that was at stake but of all people.

There were also incidents of the discourse going downhill with some candidates using foul language against their rivals.

Sugra, the daughter of jailed separatist leader Sarjan Ahmad Barkati, was at the receiving end of verbal abuse as she campaigned for her father, contesting from Ganderbal and Beerwah segments.

Although the majority of Kashmiri Pandit population lives in Delhi and NCR areas, a miniscule number of over 600 have registered for

the polling in current assembly elections.

Karwani, who is supervising to facilitate better arrangements and facilities for the displaced community voters, said all arrangements have been made for free and fair polling on Wednesday.

#### **J&K Should Be**

Prime Minister Narendra Modi, saying the INDIA bloc has 'broken his psychology' after the Lok Sabha elections.

"Since Prime Minister Narendra Modi's psychology and confidence stands 'broken', the INDIA Alliance will 'exert a pull' on the centre in case Jammu and Kashmir did not have its constitutional rights restored post assembly elections," Rahul Gandhi said.

"I guarantee you that we will have it restored. In fact, we had hoped for this to happen before

the assembly elections," Rahul said, addressing a mammoth gathering in support of INDIA Alliance candidate and PCC chief Tariq Hameed Karra at central Shalteng constituency.

"Modi used to boast about a 56-inch chest but he is not the same person anymore. His expression has completely changed, as has his attitude. People of India, the Congress and the INDIA Alliance have completely changed his appearance and temperament," added Rahul.

Rahul said that earlier governments in J&K were run by locals and their decisions were meant for "your better future and in your interest".

"Today, outsiders are making decisions for you and your voice is not there in your government. Your government is run from Delhi, orders are coming from Delhi. We want your government to be run from J&K," he told the gathering.

He asked people to feel free to reach out to him to raise any issue in Parliament. "I am always available for you, just give me an order and I am there to help you."

"Farooq sahib talked about hatred in the country. The BJP and RSS are spreading hatred in J&K and other states 24-hours a day. Wherever they go, they pit one brother against another. They have spread hatred in J&K, UP, Bihar, Manipur and across the nation. They only know this thing and nothing else. Their politics is based on hatred," Rahul said.

Hatred cannot be conquered by hatred but love, Rahul said.

The J&K Lieutenant Governor, Manoj Sinha, was also met with harsh criticism by the Congress leader, who did not hold back in calling Sinha an 'outsider', saying he runs J&K without understanding the true meaning of 'progress and development'.

"Not only did he (Modi) steal the democratic rights of the people of J&K, but decisions that they used to make through their elected MLAs on development, education, universities, colleges or health related matters are now made by outsiders. Since he is not a resident of J&K, the (Raja) monarch known as LG is an outsider who is unable to bring about the growth and advancement that the people of J&K desire," the Congress leader said.

"We want J&K's people to elect their leaders, MLAs, form their own government, and begin carrying out development projects on their own and that's why we want statehood in J & K to be restored at the earliest," he added.

In the last 10 years, Modi and the BJP leaders, according to Rahul, have instilled fear throughout the nation by dividing people along linguistic lines, inciting hatred wherever they go, and setting up rivalries amongst siblings and dividing people on regional lines.

"The people of J&K understand that hatred can only be vanquished by love, and not by hatred per se. Hatred is met with love instead of hatred. This is what your history; ideology and culture have taught you. We travelled 4000 km, from Kanyakumari to Kashmir, and wherever the BJP had created a market of hatred, we opened a shop of love there," the Congress leader said.

Since the UTs were generally elevated to the status of states in the past, he claimed, J&K is the only state in India's constitutional history to be demoted to a union territory. "For the first time, a full-fledged state was turned into a UT and your democratic rights were snatched." Referring to the now defunct HMT watch

factory, located at the stone's throw from the venue of the rally, Rahul said the BJP has closed many such factories across the country. "Modi administration waived 16 lakh core

rupee loans of three billionaires and that the poor, farmers, laborers, women, and students in India are not granted the same privileges," he said.

"They only work for a few billionaires; they

shuttered all small and medium-sized firms, monetized the economy, and pushed the GST bill into parliament. As a consequence, youth in India and J&K are unemployed, regardless of their level of education—This is what Modi has given the country, and this is what their politics is based on," he added.

Rahul also mocked PM Modi's lengthy speeches at his Man Ki Baat program, saying that no one is paying attention to him because he doesn't talk enough about (Kam ki Bat) the 'matter of work' which entails tackling inflation, managing unemployment, and providing hope for the future of India and J&K.

of the Public Safety Act to indirectly achieve something which could not be achieved directly by them. i.e. the detention of the petitioner (Anjum)."

Referring to law laid down by the Supreme Court, the Court said that it is of the view that the cases of preventive detention must be authorized by the due process of law.

"Since the detenue (Anjum) was denied of his right of making effective representation as the dossier was not given to the detenue, which is the basic right enshrined under the Constitution, such a violation of fundamental rights amounts to gross violation of personal liberty and right to life," the court said, adding, "Thus, the order impugned which is violative of basic fundamental rights cannot sustain the test of law and is liable to be set aside. Moreover, no compelling reason has been recorded by the detaining authority which could be the basis of detaining the detenue and on this ground also, the impugned order cannot sustain in the eyes of law."

Subsequently, the court quashed the detention order of Anjum and ordered him "to be set at liberty forthwith, if not required in any other case(s)."

Meanwhile, a bench of Justice Rahul Bharti quashed PSA detention order, dated 9 March this year, against a 45-year-old Talib Hussain alias Javied, of Mendhar Poonch.

"The manner in which ...District Magistrate, Poonch responded to the dossier of ...Sr. Superintendent of Police (SSP), Poonch against the petitioner (Talib) is as if the ...District Magistrate, Poonch was made to act blind folded in signing the detention order of the petitioner without his own application of mind at work," the court said, adding, "Even otherwise, FIRs reckoning from 2001 to 2013, with or without any acquittal in favour of the petitioner are, so distant in point of time of reference that a preventive detention order against the petitioner on the reference of the said FIRs could not have been conceived at the very first instance lest that of granting it."

The Court said that it would like to "refresh the mindset of the sponsoring as well as detention order making authority acting in exercise of preventive detention jurisdiction who have the tendency to fall in misconception of their authority and office in subjecting citizen to the preventive detention custody on a pretext which do not fall within the scope of preventive detention jurisdiction but still lead themselves by habit of their casualness and callousness without bearing and exhibiting any sense of constitutionality in seeking and granting preventive detention order/s against person/s at the cost of mocking the Constitution of India which in its Part-III guarantees fundamental right to life and personal liberty in terms of its articles 21 & 22

Subsequently, the court quashed the detention order and ordered Talib's release.

Meanwhile, contesting candidate Manzoor Ahmed expressed gratitude to Jamaat for its support and reiterated his commitment to challenge the ban on the organisation. ### Sugra Barkati's Emotional Campaign Reshapes Political Dynamics In Beerwah

**SRINAGAR:** The aggressive and emotional campaign led by Sugra Barkati in support of her father, incarcerated religious scholar Sarjan Barkati, has surprised many in the Beerwah constituency as she has been drawing large crowds and reshaping the political dynamics. There are 12 candidates con-

testing the election in Beerwah, including National Conference's Shafi Ahmad Wani, Ali Mohammad Dar of Jammu & Kashmir National Panthers Party (Bhim), Ghulam Ahmad Khan of the People's Democratic Party, Showkat Wani of People's Conference, Showkat Hussain Mir of Awami National Conference, and Nisar Dar of the Samajwadi Party. Independent candidates include Nazir Ahmad Khan of the Nationalist Congress Party, Sarjan Ahmad Wagay, Sanjay Parva, Faroog Ganaie, Mir Fanoon Farooq, and Nazir Ahmad Khan.

The Beerwah constituency has a total of 97,604 voters, including 49,709 male voters, 47,891 female voters, and four third-gender voters.

Political analysts have identified the main contest as being between the PDP's Ghulam Ahmad Khan, the NC's Shafi Wani, and DDC Chairperson Nazir Ahmad Khan, who is backed by Engineer Rasheed's Awami Ittehad Party. However, they also note that Sugra Barkati's campaign has gained significant traction. Her emotional speeches and grassroots



engagement have positioned her as a strong contender, potentially disrupting the expected electoral dynamics. Past Election Results

In the 2014 elections, the Beerwah constituency had registered voters, with 69,397 casting their ballots. The Jammu & Kashmir National Conference's Omar Abdullah won the seat, securing 23,717 votes, while the Indian National Congress's Nazir Ahmad Khan came in second with 22,807 votes, losing by a

margin of 910 votes. In the 2008 elections, the constituency had 83,941 electors, with 47,995 valid votes cast. Shafi Ahmad Wani of the PDP emerged victorious with 11,720 votes, narrowly defeating the NC's Ab Majid Matoo, who secured 11,556 votes, by just 164 votes.

In 2002, the Beerwah constituency had 72.976 electors. with 25,583 valid votes. The PDP's Mohd Sarfraz Khan won with 16,886 votes, defeating NC candidate Mohd Amin Banday, who received 4,966 votes, by a margin of 11,920 votes.

In 1996, the constituency had 62,988 electors, and 43,550 valid votes were cast. Aga Syed Mehmood Almosvi of the NC won the seat with 19,456 votes, defeating Janata Dal candidate Sarfaraz Khan, who received 17,798 votes, by a margin of 1,658 votes. In 1987, the constituency had

45,062 electors, with 32,446 valid votes. Syed Ahmad Syed of the NC won with 15,341 votes, while independent candidate Ghulam Mohmad Mir stood second with 10.016 votes, losing by 5,325 votes. In 1983, the constituency

had 40,739 electors, and 22,747 valid votes were cast. Syed Ahmad Saeed of the NC won with 13,879 votes, while Abdul Ahad Magray of the PC came second with 2,903 votes, losing by 10,976 votes.

In 1977, the constituency had 35,225 electors, with 24,563 valid votes. Ahmad Saeed of the NC won the seat with 14,918 votes, defeating Janata Party candidate Syed Ali Shah, who received 7,737 votes, by a margin of 7,181 votes–(KNO)

#### **Can Hakeem Yaseen Retain** Khansahib For The Sixth Time? Agencies

SRINAGAR: The Khansahib Assembly Constituency in central Kashmir's Budgam district is set for a keenly contested political battle between the National Conference (NC) and the Peoples Democratic Front

While the constituency is expected to see a direct contest between PDF chairman Hakeem Yaseen and PDF's Saif-Ud-Din Bhat, the Peoples Democratic Party (PDP) candidate, Manzoor Ahmad Wani, is also anticipated to secure a good share of votes. Besides Yaseen, Bhat and

Wani, seven other candidates are vying for the seat. These include Dr Ali Mohammad Mir of the Bharatiya Janata Party (BJP), Reyaz Ahmad Batana of the Apni Party (AP), Shahnaz Hussain Shah of the Nationalist Congress Party (NCP) and Firdouse Ahmad Shah of the Peoples Conference (PC), along with three independent candidates - Jahangir Sheikh, Syed Basharat and Mudasir Shah.

Hakeem Yaseen has represented the Khansahib constituency multiple times over the past five decades and is considered one of the main contenders for the seat. Political analysts believe the primary competition will be between Hakeem Yaseen and Saif-Ud-Din, who previously contested the last two elections on a PDP

Analysts also suggest that PDP's Manzoor Ahmad Wani could secure a good vote share, given the party's significant support base in the area.

They further note that firsttime voters and those from newly added areas in the constituency could play a crucial role in determining the outcome of the election.

The Khansahib constituency has 94,612 registered voters, including 48,140 male voters, 46,467 female voters, and five third-gender voters.

In the 2014 elections, the Khansahib constituency had a total of 86,041 electors, with 69,828 valid votes cast. Ha-Mohammad Yaseen keem Shah, representing the People's Democratic Front (Secular), won the seat, securing 26,649 votes. PDP candidate Saif-Ud-Din came second with 25,540



votes, losing by 1,109 votes.

In the 2008 elections, the constituency had 72,169 electors, with 53,930 valid votes cast. Hakeem Yaseen won with 22,616 votes, while PDP's Saif-Ud-Din Bhat secured 14,221 votes, losing by 8,395 votes.

In the 2002 elections, there were 60,645 electors, with 30,028 valid votes cast. Hakeem Yaseen, then Independent candidate, won with 20,186 votes, defeating the Jammu and Kashmir National Conference candidate Abdul Gani Naseem, who secured 4.393 votes, by a margin of 15,793 votes.

In the 1996 elections, the constituency had 51,700 electors and 31,448 valid votes cast. The National Conference candidate Abdul Gani Naseem won with 12,785 votes, defeating Janata Dal candidate Nazir Ahmad Khan, who received 6,254 votes, by 6,531 votes.

In 1987, the constituency had 42,869 electors, with 34,526 valid votes cast. Indian National Congress candidate Ghulam Mohammad Mir won with 24,180 votes, while Jammu and Kashmir Peoples Conference candidate Ghulam Qadir War secured 4,166 votes, losing by 20,014 votes.

In 1983, the constituency had 36,282 electors and 23,648 valid votes cast. Hakeem Yaseen, then National Conference candidate, won with 13,737 votes, defeating the Indian National Congress candidate Ghulam Ahmad Barray, who received 4,557 votes, by 9,180 votes.

In 1977, the constituency had 34,359 electors and 21,163 valid votes cast. Hakeem Yaseen, then National Conference candidate, won with 15,647 votes, defeating Janata Party candidate Ghulam Qadir War, who received 3,814 votes, by 11,833 votes.

In 1972, the constituency had 30,831 electors and 18,634 valid votes cast. Indian National Congress candidate Ghulam Qadir War won with 15,998 votes, while independent candidate Ghulam Ahmad Parry secured 2,094 votes, losing by

Javid Hassan Baig (NC)
Baig has also had a promi-

nent political career. He won the Baramulla Assembly seat in 2014 on a PDP ticket, securing 14,418 votes, while his closest competitor from the NC garnered 7.401 votes. In 2018, he briefly rebelled

against the PDP but later rejoined. After being expelled for meeting foreign envoys after the August 2019 revocation of Jammu & Kashmir's special status, Baig switched allegiance to the Jammu and Kashmir Apni Party (JKAP) in 2020. However, his stint with JKAP was shortlived, as he was expelled in January 2024 over allegations of anti-party activities. Baig found a new political home with the National Conference in March 2024, which secured him the party ticket for the Baramulla seat.

A Veteran's Influence: **Muzafar Hussain Baig** The presence of veteran poli-

tician Muzafar Hussain Baig, a two-time MLA and former Deputy Chief Minister of Jammu & Kashmir, adds another layer of intrigue to the Baramulla race. Known for his deeprooted influence in the constituency, Baig is expected to play a significant role in shaping the outcome of the election, even though he is running as an independent candidate.

His involvement could impact both Shoaib Lone and Javid Baig, as he commands considerable respect among voters in the region.

Aside from Shoaib Nabi Lone and Javid Hassan Baig, the Baramulla constituency has attracted a wide array of contenders. Notable candidates include Mohammad Rafique Rather of the PDP, Mir Iqbal Ahmed of Congress and Muzafar Hussain Baig and Touseef Raina as independents—(KNO)

LONDON: The BCCI directing its established players to participate in domestic cricket has been termed "fantastic prioritising" by Lancashire's CEO Daniel Gidney, who accused the English players' agents for facilitating their foray into the lucrative franchise leagues at the expense of the traditional red-ball competition.

Gidney feels these agents threaten the future of the English County Cham-

The BCCI had mandated all international players, except for seniors like Rohit Sharma, Virat Kohli and Jasprit Bumrah, to play in tournaments such as Ranji and Duleep Trophy when they are not busy with national commitments, the move highlighting the board's emphasis on the role of domestic cricket.

This decision by the RCCI found many takers, including Gidney, one of cricket's longest-serving chief executive.

"Imagine a governing body (BCCI) actually saying that out loud ... That was fantastic prioritising," Gidney was quoted as saying by 'The Guardian'.

Calling the agents the main threat to the future of the English County Championship, the Lancashire CEO said they don't care" about the county game.

"We need to have more of an open conversation. Coaches get blamed, administrators get blamed, but if you want to blame anybody, blame agents," Gidney said on the sidelines of a match between Lancashire and Somerset at Old

He added, "I think the game as a whole needs to come together to find a way to support the championship.

"England players don't have to play in the championship, agents don't care about the championship." According to Gidney, increasing the players' remuneration could be of help.

"More prize money would help and I think we need to find a way of paying four or five players a lot more money. Instead of GBP 80,000-90,000 being the top domestic salary, we need to find a way of paying GBP 200k ... and saying part of that deal is that you don't play franchise cricket."

Gidney called for a cap on franchise participation to protect first-class cricket but made it clear that he is not from playing in the T20 leagues. The cap on aa number of T20 leagues that a particular professional plyer

"They have a career – I'm not begrudging their ability to earn money but the balance has tipped ... When the bottom rung of the Hundred is what a rookie would earn in the championship - who among us would turn down earning more money for less work?"

Earlier this year, BCCI secretary Jay Shah had asked all centrally-contracted India players to turn up for matches in domestic cricket and warned that non-participation could lead to severe implications.

The plot was originally allotted to cricketer Sunil Gavaskar in 1988 for setting up an indoor training academy but the cricketer could not utilise it for more than 30 years.

### **Bumrah Arguably The Best Fast Bowler Across Formats: Steve Smith**

NEW DELHI: Seasoned Australian batter Steve Smith has spoken glowingly of Jasprit Bumrah ahead of the Border-Gavaskar Trophy, calling the Indian arguably the best fast bowler across formats.

The five-Test series between India and Australia begins in Perth on November 22. India have won the past two series Down Under. If India are to do a three peat, Bumrah's rare skills will be heavily relied upon in Australia.

'He's a wonderful bowler, whether I face him with the new ball, slightly older ball, or even the old ball. He's got great skills with all of them. He's a great bowler, arguably the best fast bowler across the three formats. It's always going to be a challenge," Smith told Star Sports.

The 35-year-old has been opening for Australia in the past couple of series and is expected to do the same against India.

Smith, a veteran of 109 Tests, is likely to cross the 10,000-run milestone in the high-profile series, having so far made 9685 runs.

Bumrah, on the other hand, has done remarkably well since making his Test debut in January 2018, taking 164 wickets in 37 games at an average of 20.51.
